Bihar ravaged by drugs deluge after liquor ban

While 'banned' alcoholic substance is made available easily by 'peddlers' in form of women and children, what is worrying the elderly generation of the State is the proliferation of drugs in form of gaanja, cocaine, heroin and psychotropic substances

Beggars too are involved in transportation of liquor to in the dry State of Bihar.

What the concerned people term "sukha nasha" has penetrated deeply in villages, rural areas, towns and cities and youths particularly teenagers, college students, daily wagers are hooked to these illegal intoxicating agents taking a toll on the future of Bihar once known as land of Buddha and Mahavira. The liquor ban which came into force almost seven years ago is ruining the health of youths and economy since all brands are from kinds "smuggled"

Country punishing Congress for its sins: Modi

n a veiled attack on Congress leader Sonia Gandhi for choosing the Rajya Sabha, Prime Minister Narendra Modi without naming her on Sunday said those who cannot win an election have taken the Rajya Sabha route to Parliament. Addressing a public meeting in Rajasthan's Jalore, Modi said, "Jo log chunav nahi lad sakte, jeet sakte (those who can't contest and win an election) fled the ground and took the Rajya Sabha route". Jalore will go to the election in

the second phase on April 26. Modi also addressed a rally in Banswara in support of BJP's Mahendrajeet Singh Malviya. Former Congress president Sonia is among the MPs elected to the Rajya Sabha from Rajasthan in February. In a major decision, Sonia vacated her Raebareli seat citing her health condition. The Congress is yet to announce any candidate from Raebareli, and so is the BJP for the seat that will go to the polls on May 20.

Several Congress veterans have not been fielded in this Lok Sabha election, but the party has rejected suggestions Modi said the country is out the country by spreading

Kharge also attacked Prime Minister Narendra Modi, alleging that he insulted President Droupadi Murmu and the tribal community by not inviting her to Ram temple consecration and inauguration of the Parliament building.

Addressing the rally, Sunita asserted that the opposition INDIA bloc will fight against the "dictatorship" of the BJP and win.

They want to kill my husband Arvind Kejriwal. His food is under camera observation; he is denied insulin. My husband Ranchi as part of campaign for is a sugar patient who has been

on insulin for 12 years; he needs 50 units of insulin daily," Sunita said at the Ulgulan Nyay Rally in Ranchi.

"We will fight against dictatorship and win. The gates of jail will break and Arvind Kejriwal and Hemant Soren will come out," she said. Kejriwal was arrested by the Enforcement Directorate (ED) laundering case linked to the now-scrapped Delhi excise policy. He is lodged in Tihar jail. The ED also arrested Soren on the night of January 31 in a money laundering case linked to an alleged land

fraud. Kalpana also read out a message from jail by her husband Hemant Soren. "Arvind Kejriwal and my husband Hemant Soren were jailed just before the elections by forces that were hatching conspiracies against their governments," she alleged.

Reading out her husband's message, she said, "Central agencies such as the ED and CBI are being misused to suppress the opposition's voice but BJP and such forces will be driven out from Iharkhand." Urging the people to show the "exit doors" to the BJP, she claimed that if the party

wins the ongoing elections it would be a "big threat" to tribals. Kalpana Soren is likely to contest the bypoll to the Gandey Assembly seat, which

is slated for May 20.

Bhubaneswar and Cuttack recorded 41 degree each.

There would be no large change in the maximum temperature during the next 24 hours while there would be a gradual fall by 2 to 3 degree during the subsequent three days and a rise by 2 degree to 3 degree thereafter at many places in the districts of the State, said the IMD.

Altogether 115 fire points were reported from the Similipal National Park and Tiger Reserve in Mayurbhanj district till April 20 (Saturday) this year, revealed the Forest

Department on Sunday. All these fire points were extinguished by employees of the department, said Principal Chief Conservator of Forests (Wildlife) Susanta Nanda.

fire points at Similipal were detected and extinguished in time and they could not cause any damage to the flora and

"Till yesterday, Similipal sanctuary had received fire alerts for 115 points this year and all were extinguished by our green soldiers in time before it could cause any damage in scorching heat," said Nanda in a Twitter (X) post.

Earlier, there were media reports that at least 134 fire points were reported from Similipal between March 20 and April 20. The forest fire has caused extensive damage to the Similipal sanctuary and caused troubles for its wildlife, claimed

the media reports. The reports further stated that many wild animals are straying into human settlements due to the forest fire at Similipal.

m With Odisha sizzling under intense heat wave conditions, two persons, including a girl, believably died of sunstroke in two separate incidents in the State on Satur-

Santosh Jena (34) of Osala village under the Korei police limits in Jajpur district was returning home by a motorcycle from the two-wheeler. He was rescued and rushed to the Korei Community Health Centre, from where he was referred to the SCB Medical College Hospital in Cuttack for better treatment.

However, he died while an ambulance was being arranged to shift him to Cuttack.

In another incident, 21year-old Bhubaneswari Das of Kaji Diha under the Madhupatna police limits in Cuttack city fell ill after reacharound noon. She was taken to the SCB Hospital in an ambulance.

She was initially admitted to the heatstroke ward of the hospital and later shifted to an ICU, where she died during treatment.

It was being suspected that the two deaths were incidents of sunstroke. However, confirmation in this regard by any concerned official was yet to be made. The State Government has confirmed one

Some meritorious students, who have secured higher ranks in the examination conducted by the institute, have alleged that they have not been given the opportunity to work with the guides of their choice whereas the candidates with

They have also questioned why the selection and guide allocation to perspective PhD candidates has not been done transparently which is leading to disillusionment among hopeful PhD candidates.

Parties urged for rehab of youths, ecosystem restoration

 Γ he 'Youth4Water India', a campaign initiated by Water Initiatives, WaterAid India and sixty-eight other organisations, released a 23point manifesto for political parties contesting in the general elections urging upon them to commit to special rehabilitation and support programmes for the youth who are most vulnerable to climate change impacts such as sealevel rise and displacement.

This manifesto was prepared based on interviews and focus-group discussions involving 100 youth from Odisha coasts, especially from villages that are facing the wrath of an invading sea, conducted by our volunteers, it was then supported by inputs from experts. Our experience of working with such villages for the last more than three decades also helped strengthen the manifesto," said convenor of Water Initiatives and cofounder - cum - mentor of the 'Youth4Water' campaign Ranjan Panda.

"Odisha is one of the highly vulnerable geographies in the

world when it comes to climate change impacts, and sea-level rise and related impacts could displace thousands of people from more than 300 villages. While many villages are already submerged under the sea, many more are on the verge of being taken over. Putting up a strategy to deal with such a situation has become essential. With this manifesto, we urge upon each political party to support a 'strategy for inclusive rehabilitation of climate displaced communities,' that we have already suggested to the State Government," added Panda, informing, the manifesto's relevance is for the entire

"Besides covering a host of suggested initiatives that can help vulnerable youth get their rightful support from the system, the manifesto also covers provisioning of 'Water, Sanitation and Hygiene' for both the people who choose to stay and the ones who choose to move," said technical specialist - Water at the WaterAid India, Bikash Pati who was also involved in guiding the survey.

"The youth who were covered under the survey have demanded for several layers of protection including employment guarantee with dignified income, health insurance, right to education, and so on. We are sure the political parties will support the manifesto as climate displacement migration have already be-

come a huge area of concern for the policy makers and Odisha is a hotspot in this regard," added Pati.

Dhaneswar Mallick of the Astaranga area, a youth actively involved in the survey, demanded for safe drinking water, safety for girls who are migrating out, involvement of youth in all the eco-resto ration initiatives and provisioning of local employment opportunities for youth who don't want to move out of their native areas.

For Manjulata Swain from Satabhaya area, another youth involved in the survey, safety of girls and equal wage opportunity for them must be the priority of all political parties contesting the elections. She emphasised on the inhuman condition of transport modes which carry migrant workers and suggested better and dignified ways of transport with all basic amenities provided.

YouTuber Monalisa, hubby under ED scanner

For hunting scheduled wild animals

The Enforcement Directorate (ED) will launch a probe against popular YouTuber Monalisa Bhadra of Odisha under the Prevention of Money Laundering Act, 2002.

Monalisa and her husband Badri Narayan Bhadra of Jajpur district were arrested by the Forest Department in March this year for hunting scheduled wild animals in violation of Sections 9 and 39 of Wildlife Protection Act 1972.

The Bhadra couple was accused of displaying scheduled wild animals in their social media accounts for pecuniary

The YouTube account of the Bhadra couple (@Badrinarayan Bhadra) was blocked by the authorities concerned on the basis of the complaint lodged by the Forest Department.

The department had written to the Director of ED to invoke Prevention of Money Laundering Act, 2002 against Monalisa and her husband.

"The accused persons had

millions of subscribers for their YouTube and other social media platforms. It is suspected that they might have received hefty amounts as revenue from YouTube and social media platforms. It is requested to take necessary action as per provisions of Prevention of Money Laundering Act, 2002," said the Principal Chief Conservator of Forests (Wildlife) and Chief Wildlife Warden of Odisha, Susanta Nanda, in his letter to the ED Director.

He had also urged the ED to initiate a probe under the Money Laundering Act against snake rescuer and YouTuber Mirza Mohammad Arif of Bhadrak district in Odisha. The Forest Department had arrested Arif for hunting scheduled wild animals in March this year.

Anthropogenic activities are the primary causes of the warming up of planet Earth, climate change, weather aberrations and such other miseries. The 'dangerous heat wave index' has gone up in a greater pace. Heat waves in India are 30 times more likely than they would be without climate change. Forest fire throughout the world has increased enormously in proportion. In Similipal, a forest of dense canopy, forest fire is menacing. The water storage capacity in 150 major reservoirs in India has been reduced by 31 per cent



However, the speculation was put to an end after BJD declared sitting MLA and Minister Sarada Prasad Nayak as its candidate for Rourkela on April 5.

With Ray getting the ticket from BJP, it is clear that a big fight between BJD and BJP is in the offing. Congress is not in the race and it would struggle to retain the security. So, now the talk in the city is who would make the record by winning for the fourth term in Rourkela as both Nayak and



Sarada Nayak Ray won in 1985, 1990 and 2014 while Navak won from the seat in 2004, 2009 and 2019. The only difference is Navak has been participating in electoral politics since 2000 while Ray after the shameful defeat in 1995 was virtually inactive till 2014. Though he became MLA in 2014 by defeating Navak but before completing the tenure he resigned from the post and primary membership of BJP as his repeated demands for Rourkela were not fulfilled by the Modi

Test Asia is in news, as ever. This time Iran and Israel are in the battlefield. Iran's attack on Israel early Sunday came in response to what it is discussed was an Israeli strike on Iran's Consulate in Syria on April 1. Israel's military chief asserted that his country would respond to the Iranian attack, while world leaders caution against retaliation trying to avoid a spiral of violence. Even, Pope Francis, while speaking to pilgrims in St. Peter's Square, said, Iran's drone missile attack on Israel has given him pain and he is concerned. He urged both Iran and Israel to avoid steps that could feed a spiral violence that risked plunging the West Asia deeper into conflict. He also added that, "No one should threaten the existence of oth-

ers. All nations should stand, instead, for peace, and help Israelies and Palestianians to live in two States, side by side, in safety." He called for ceasefire in Gaza and negotiations to allow humanitarian aid to be provided for its people and to help free Israeli hostages seized by Hamas in its October 7, 2023 attack on Israel.

Enough war, enough attack, enough violence. Yes to dialogue, yes to peace.

As situation unfolds, on

April 18, 2024, the US and UK imposed a new round of sanctions on Iran as concern grows that Tehran's unprecedented attack on Israel could fuel a wider war in West Asia. Treasury Office of Foreign Assets Control targeted 16 people and two entities in Iran that produce engines that power the drones used in April 14 attack. The UK is targeting several Iranian military organizations, individuals and entities involved in Iran's drone and ballistic missile industries. European Union leaders have also vowed to ramp up sanctions as Iran is targeting its drone and missile deliveries to proxies in Gaza, Yemen and Lebanon. EU foreign policy chief,

Josep Borrel, is in favour of strengthening and expanding further sanctions to punish Iran. At the same time, he also expressed his views in no uncertain terms saying that Israel needs to exercise restraint.

"I don't want to exaggerate, but we are on the edge of a war, a regional war in the Middle East, which will be sending shockwaves to the rest of the world, and in particular to Europe. So, stop it," he

As on date, Iran has fired air defence batteries to shoot down three drones over Isfahan, as regional tensions rise. Anonymous US officials have told US media that Israel launched an attack against a site in Iran, but Israel army has yet to comment. Foreign Ministers from Group Seven major democracies called on

Israel and Iran to de- escalate hostilities in West Asia following Israel's retaliatory strikes in Central Iran earlier today, Italian Foreign Minister Antonio Tajani told.

Challenges for Indian Di-

This unprecedented turn of the shadow war into real war between the two power houses in West Asia puts Indian diplomacy to litmus test.

As expressed by Bhopinder Singh, in his article, the enduring ties between India and Iran, in The Pioneer dated, April 19, 2024, "The template of 'strategic independence' (used in the Russian- Ukraine conflict), could be afforded to this conflict which conjoins morality with practicality to take a deliberately mealy- mouthed position that offends none and yet genuinely beseeches peace.'

It is worth reiterating that Indian leadership has spoken to their counterparts in the region such as Saudi Arabia, Iran, Israel, Egypt, Jordan and Palestine expressing concern about the possible escalation of conflict at the time of attack by Hamas in Southern Israel on October 7, 2023. Prime Minister Narendra Modi and Egyptian President Abdel Fattah el-Sisi had also exchanged views over telephone on the matter. On January 25-26, during French President, Emmanuel Macron's visit to India, PM Modi and President Macron expressed grave concerns over the conflict, including the Red Sea.

India has strategic ties with both Iran and Israel for decades. It has been maintaining the balance between the two. If the conflict gets out of hand, it would be difficult for India to maintain an ambivalent position. With Iran, India has close

trade and economic relations.

Iran also plays a key role in India's energy security. From the point of geopolitics, it is the gateway to Central Asia. There are about 5,000 to 10,000 Indians in Iran. About 90 lakh Indians work in the Gulf and West Asian region. Indian Diaspora of that regions is a main source of remittance. Any conflict in that region would pose great risk to Indian communities. Besides, the West Asian region accounts for 80% oil supplies to India. India has been able to minimize the impact of oil prices due to the Russian-Ukraine War by buying Russian oil at a discounted price, but the conflict will have ad-

ing and ever expanding multidimensional ties: trade, technology, defence, security, intelligence sharing and agriculture. Therefore, peace and stability in West Asia is of paramount importance for India. India is also close to the backers of both sides: with US, which is solidly behind Israel,

and with Russia which fully

verse impact on energy prices.

The Sivok-Rangpo Rail Project(SRRP), which will connect Sikkim to the railway network for the first time, has got a major boost with the completion of an 855-metrelong emergency exit tunnel. A 20-metre section of the tunnel runs under National Highway(NH)-10, along the Teesta river, and according to officials, mining through its soft and loose soil was the most challenging part of the whole project as there was a high risk that it might cave in, snapping Sikkim's road connectivity with the rest of the country.

"NH-10 is the only road network that connects Sikkim with other parts of the country. It was a huge challenge for us to mine a tunnel 18 metres below the highway, because the soil is very soft and loose, just like the river sand bed (fine to coarse-grained), with



alternate bands of pebble, cobble and boulders," an official from Ircon International, which is constructing the project, said.

'Mining for only that 20metre distance, which is the width of NH-10 including

the impact areas on both sides along the highway, has been the most challenging moment of the project so far. We completed it successfully, without causing a single millimetre of deformation to the highway," he added.

Railway officials said they used the secant-piling method, rarely used in tunnel mining. After getting it proof-checked by the Indian Institute of Technology (IIT), Ircon officials prepared a case study, explaining the ingenu-

ity of the mining work. The study says, "To provide fool-proof safety to NH-10, it was suggested to prepare a secant pile wall. Secant piles are designed by constructing reinforced concrete piles that interlock with each other and are reinforced with steel rebar. Typically, primary piles are cast in situ, leaving space in between them, and this is followed by secondary piles cut into the primary piles to form a continuous wall of piles." The Sivok-Rangpo Rail Project (SRRP), covering a total length of 44.96 km between Sivok in West Bengal and Ranpo in Sikkim), has 14 tunnels, 22 bridges (13 major, nine minor) and five railway stations - Sivok, Riyang, Teesta Bazar, Melli and Rangpo.

Researchers identify abnormal accumulation of proteins in cells that cause Alzheimer's



 $R^{\text{esearchers} \ \text{from Tokyo}}_{\text{Metropolitan University}}$ have identified how proteins collect abnormally in neurons, a feature of neurodegenerative diseases like Alzheimer's. They used fruit flies to show that depletion of mitochondria in axons can directly lead to protein accumulation.

At the same time, signifi-

cantly high amounts of a protein called eIF2ß were found. Restoring the levels to normal led to a recovery in protein recycling. Such findings promise new treatments for neurodegenerative diseases. Every cell in our bodies is a busy factory, where proteins are constantly being produced and disassembled. Any changes or lapses in either the production or recycling phases can lead to serious illnesses. Neurodegenerative diseases such as Alzheimer's and Amyotrophic Lateral Sclerosis (ALS), for example, are known to be accompanied by an abnormal build-up of proteins in neurons. However, the trigger behind this accumulation remains unknown. A team led by Associate Professor Kanae Ando of Tokyo Metropolitan University have been trying to determine the causes of abnormal protein build-up

flies, a commonly studied model organism that has many key similarities with human physiology. They focused on the presence of mitochondria in axons, the long tendril-like appendages that stretch out of

neurons and form the neces-

signals to be transmitted inside our brains. It is known that the levels of mitochondria in axons can drop with age, and during the progress of neurodegenerative diseases. Now, the team have discovered that the depletion of mitochondria in axons has a direct bearing on protein build-up. They used genetic modification to suppress the production of milton, a key protein in the transport of mitochondria along axons. It was found that this led to abnormal levels of protein building up in fruit fly neu-rons, a result of the breakdown of autophagy, the recycling of proteins in cells.

Through proteomic analysis, they were able to identify a significant upregulation in eIF2ß, a key subunit of the eIF2 protein complex responsible for the initiation of protein production (or translation). The eIF2a subunit was also found to be chemically modified. Both of these issues hamper the healthy action of eIF2.Importantly, by artificially suppressing levels of eIF2ß, the team discovered that they could restore the autophagy that was lost and regain some of the neuron function that was impaired due to axonal mitochondria loss. This not only shows that depletion of mitochondria in axons can cause abnormal protein accumulation, but

The Congress on Sunday alleged that Prime Minister Narendra Modi has caused an "unprecedented decline" in worker wages adjusted for price rise and said that an INDIA coalition Government will return the country to a higher growth trajectory.

Congress general secretary Jairam Ramesh said multiple data sources, including the Modi government's own official statistics, are unanimous in showing the simple fact that workers can buy less today than they could 10 vears ago. A combination of slow wage

growth and back-breaking inflation has caused an unprecedented decline in real wages, he said in a statement. "Labour Bureau's Wage Rate Index (Government Data): Between 2014 and 2023, real wages for labourers have stagnated, with clear declines in real wages in Modi-II," he

Ramesh also pointed out that the Ministry of Agriculture's Agricultural Statistics said that under former prime minister Manmohan Singh, real



wages for agricultural labourers grew at 6.8 per cent each

'Under PM Modi, real wages for agricultural labourers declined by -1.3 per cent each year," he said. "Periodic Labour Force Survey Series (Government Data): Average real earnings over time have stagnated between 2017 and 2022 across all employment types - salaried workers, casual workers, and self-employed workers," he said in a state-

"Stagnant real wages have dragged down consumption growth as revealed by the Consumption Expenditure Survey which showed a decline in rural consumption for the first time in almost 50 years (and which the Modi Sarkar tried to suppress)," he said.

With slowing consumption growth and deepening fear, the private sector no longer has an incentive to invest in the economy, Ramesh argued. "Investment in India has dropped to historic low levels,

threatening our long-term growth: Investment as % of GDP (10-year average) was 33.4% under the UPA but just 28.7% under Modi. FDI as % of GDP rose from 0.8% in 2004 to 1.7% in 2014 under Manmohan Singh's stewardship. It has fallen to just 1.5% of GDP as of 2022," the statement read.

He further pointed out that manufacturing as a percentage of GDP (10-year average) fell from 16.5 per cent in UPA to 14.5 per cent under Modi and the gross fixed capital formation (GFCF) in India, or the total investment in fixed assets, averaged 32 per cent for the 10 years of Manmohan Singh, while the GFCF under Modi has been below 29 per cent for 10 years.

Together, all these factors are dragging down economic growth and causing an unemployment crisis," Ramesh said. In the economy, all good things go together.

The CJI hopes new criminal justice laws will expedite cases lingering on for long years

hief Justice of India (CJI) DY Chandrachud has lauded the enactment of new criminal justice laws, hailing it as a watershed moment for the nation's judicial organ. The judiciary plays a pivotal role in shaping the legal landscape and the CJI's endorsement of the new laws underscores the profound impact these legislative reforms are poised to have on the Indian society. Moreover, the heightened emphasis on victim protection programmes is a crucial development. Iran-Israel: On the brink of war or hype



Iran's attack and Israel's retaliation threaten to reshape the established rules of engagement and have the potential to destabilise the region

ran launched a significant assault on Israel during the night of April 13-14, deploying 300 drones and missiles from its territory towards Israeli territories, including Jerusalem, the Golan Heights and the southern Negev. This bold action marks an unprecedented event since Israel's founding in 1948.

The attack on Israel by Iran was a direct response to an airstrike on the Iranian consulate in Damascus, Syria, on April 1, which Iran accuses Israel of carrying out. This assault resulted in the deaths of sixteen individuals, including two Revolutionary Guards generals. Iran's drone and missile assault on Israel, lasting several hours, has reshaped the established rules of engagement between the two nations and heightened tensions in the West Asia, potentially paving the way for a broader conflict with destabilising effects on the region. The strike on Damascus was viewed as a significant Israeli action against Iranian interests in Syria, surpassing previous incidents. Iran had been issuing warnings of retaliatory actions against Israel following an earlier airstrike that destroyed Iran's consulate in Syria, which was seen as a breach of diplomatic conventions.

Iran justified its actions by citing Article 51 of the UN Charter, following the Israeli attack on the Iranian Embassy in Damascus. The drone attack was interpreted as a message from Tehran to Tel Aviv. Despite refraining from officially declaring it as an "Act of War," Tehran's response aimed to prevent being dragged into a larger conflict while signalling a readiness to retaliate more forcefully to maintain regional deterrence. The targeted strikes on Israel aimed to re-establish Iranian deterrence and highlight a shift in Tehran's approach to risk. By setting new red lines in the conflict with Israel, Iran made it clear that it would take action if Israel's actions against Iran and its allies persisted. While some may perceive the attack as i failure due to Israels successful interception of Iranian drones and ing supplier of military equipmissiles, a more severe strike ment. Trade between India missiles, a more severe strike using precision-guided ballistic missiles could have inflicted approximately \$7.5 billion.



In simpler terms, if Iran truly intended to harm Israel, they would have kept their plans secret and employed more powerful weapons to catch Israel off guard. By providing advance notice and employing less effective tactics, it seems like Iran was issuing a warning rather than seeking to inflict serious damage. It's akin to saying, "If you cross the line, there will be serious consequences in the future."

In a similar fashion, Israel also retaliated with quadcopter strikes with little damage to Iran. A warning for warning if



With power freebies, debt comes calling



The core dilemma persists: How to prevent debt while ensuring universal electricity access? This issue entails policy intricacies and power sector reforms



n an interview, Union Power Minister RK Singh revealed he has been telling States that electricity is not free. "If any State wants to give free power to any category of people, they can go ahead and do so, but you have to pay

Singh's exhortation to the States assumes significance in the backdrop of a spate of announcements by the latter to give free electricity to certain consumers which affect the viability of power distribution companies or discoms (they buy power from generating companies or gencos and supply to the consumers). He argues "like any other commodity, generation and distribution of electricity involves cost and if a State is to provide it for free to a section of consumers, it also needs to have finances to pay the genco. If the genco isn't paid, electricity will not be produced in the

But, there can't be any compromise on the generation of electricity as any shortfall could lead to a stoppage of economic activity. To meet the surge in demand (due to the impending summer), the Union sovernment has invoked the provisions of the Electricity Act (2003) under Section 11asking gas-based gencos and thermal plants based on imported coal to increase generation even if it entails extra cost. That is the reaction to meeting incremental demand. How could it tolerate massive cuts in generation inevitable when gencos are not paid? So, States must ensure that they

When pressurized, the concerned States borrow money to pay the gencos resulting in a debt trap. For instance, in the first two vears of the AAP Government, Puniab borrowed as much as Rs 47,000 crore adding to the already high debt of the State.

How can the States avoid debt trap? The Electricity Act (2003) and the Guidelines issued by the Ministry of Power require the discoms to fix the charge (or tariff) on electricity supplied to consumers in a manner such that the average revenue realization (ARR) from its sale is equal to the average cost of supply (it includes the cost of purchase, transmission and distribution), or ACS. The discoms are

free to decide the modalities of how this is to be ensured subject to approval by the concerned State Electricity Regulatory Commissions (SERCs). Ideally, the discoms should charge

from 'all' consumers a tariff equal to the total cost of supply say Rs 'X' crore divided by the number of units. But, they don't follow this principle. They charge less from certain consumers especially households (HHs) and farmers.

For instance, in Delhi, the tariff applicable to HHs consuming 200 units a month is Rs 3 per unit which is about half of the ACS. Including a plethora of levies adding to 44.6 per cent, the shortfall comes to Rs 4.3 per unit. For HHs consuming between 201 and 400 units, the tariff is Rs 4.5 per unit implying an under-recovery of Rs 1.5 per unit. Including the levies, this comes to

Rs 2.2 per unit. These under-recoveries are crosssubsidized by charging more from inaustries and dusiness establishments for which the tariff can go up to a high of Rs 16 per unit. The low tariff charged from the target consumers (read: HHs consuming up to 400 units a month) is nothing but a freebie given by political parties. But, it goes unnoticed as the State exchequer doesn't have to pay for these under-recoveries. The industries that are made to foot the bill can't even murmur as discom being the sole supplier of electricity, they have no other option.

But, political parties don't want the target HHs to even pay this small tariff. In Delhi, the AAP Government tells discoms not to raise any bill on HHs consuming up to 200 units. Likewise, in Punjab, consumption of up to 300 units a month by an HH is free. This extra under-recovery of Rs 4.3 per unit in Delhi (applicable tariff Rs 3 per unit plus 44.6 per cent levies) has to be reimbursed by the State to the dis-

com. But, most States don't reimburse or do it partially and after considerable delay. This leads to losses of discoms. The availability of free power also

drives people to manipulate their reported consumption. For instance, in Punjab, an HH consuming 900 units a month, gets three meters installed to keep consumption of each under 300 units thereby ensuring zero bills. Reportedly, more than 100,000 meters have been bifurcated or trifurcated enabling even high-end consumers to avail of the free bonanza. As for farmers who are eligible for free power in the State, they report even consumption for running multiple ACs in their homes under farming head thereby avoiding any payment.

over 95 per cent of power consumers in Punjab avail of subsidies, a major portion of which isn't even reimbursed to discoms. Discoms' losses also increase due to AT&C gregate tecnnicai and commercial) losses - a sophisticated nomen-clature for power theft. According to Singh, AT&C's losses used to be high at 27 per cent. In Punjab, reportedly, an overwhelming share of electricity that leaves the generating stations/power dispatch centres remains unaccounted for.

The discoms have funded these losses by borrowings from banks and other financial institutions (FIs) apart from keeping bills pending. At the end of FY 2021-22, their total debt was Rs 620,000 crore. In June 2022, they owed about Rs 1,40,000 crore to Gencos and transmission companies (transcos).

The Center has taken several measures to force discoms to clear their dues. The late payment surcharge (LPS) Rules, implemented in 2022 made it mandatory for discoms to clear their legacy dues as existing on June 3, 2022, in a timebenefit of non-applicability of the LPS after its implementation date. The rules are also provided for timebound clearance of current dues failing, which will attract a power supply cut. This has resulted in legacy dues decreasing from Rs 1,40,000 crore in June 2022 to around Rs 70,000 crore in July 2023 and further down to Rs 40,000 crore cur-

Under the 'Reforms-Linked, Result-Based Scheme for Distribution' (RLRBSD) launched in July 2021, the Centre has undertaken a massive investment of Rs 300,000 crore to improve the reliability and quality of the power supply and enhance the efficiency of discoms. It has compulsory pre-paid and smart metering components to be implemented across the power supply chain, including in about 250 million households. As a result, AT&C losses decreased from 22.32 per cent during 2020-21 to 13.5 per cent during 2022-23.

However, according to the Minister, today power pilferage is 15 per cent. On this much electricity, discoms get 'nil' revenue. On a much larger percentage of power used by target HHs and farmers, the States promise to pay on their behalf. But, they don't pay in full and whatever payment comes, it is delayed. Even for making payments, the States borrow money. And, the vicious cycle continues.

It won't end unless discoms are unshackled from State controls and given the freedom to decide their pricing and distribution policies. If, States want certain HHs and farmers to get power free, let them give the money directly to them. This reform will also pave the way for the deregulation of electricity distribution, more options for consumers to source their needs and a reduction in tariffs.

Israeli strikes on southern Gaza city of Rafah kill 22, mostly children

AP RAFAH (GAZA STRIP)

Israeli strikes on the southern Gaza city of Rafah overnight killed 22 people, including 18 children, health officials said Sunday, as the United States was on track to approve billions of dollars of additional military aid to its close ally.

Israel has carried out near-daily air raids on Rafah, where more than half of Gaza's population of 2.3 million has sought refuge from fighting elsewhere. It has also vowed to expand its ground offensive to the city on the border with Egypt despite international calls for restraint, including from the US.

The House of Representatives approved a \$26 billion aid package on Saturday that includes around \$9 billion in humanitarian assistance for

The first strike killed a man, his wife and their 3-year-old child, according to the nearby Kuwaiti Hospital, which received the bodies. The woman was pregnant and the doctors managed to save the baby, the hospital said.

The second strike killed 17 children and two women, all from the same extended family, according to hospital records. First responders were still searching the rubble. An airstrike in Rafah the night before killed nine people, including six children.

Mohammed al-Beheiri said his daughter, Rasha, and her six children, ranging in age from 18 months to 16 years, were among those killed overnight and into Sunday. Her husband's second wife and their three children were still under the rubble, al-Beheiri said.

The Israel-Hamas war has killed over 34,000 Palestinians, according to local health officials, devastated Gaza's two largest cities and left a swath of destruction across the territory. Around 80% of the population have fled their homes to other parts of the besieged coastal enclave, which experts say is on the brink of famine. The conflict, now in its seventh month, has sparked regional unrest pitting Israel and the US against Iran and allied militant groups across the Middle East. Israel and Iran traded fire directly earlier this month, raising fears of all-out war between the longtime foes. Tensions have also spiked in the Israeli-occupied West Bank.

Israeli troops killed two Palestinians who the military says attacked a checkpoint with a knife and a gun near the southern West Bank town of Hebron early Sunday. The Palestinian Health Ministry said the two killed were 18 and

19 years old, from the same family. No Israeli forces were

wounded, the army said. The Palestinian Red Crescent rescue service meanwhile said it has recovered a total of 14 bodies from an Israeli raid in the Nur Shams urban refugee camp in the West Bank that began late Thursday. Those killed include three militants from the Islamic Jihad group and a 15-year-old boy. The military says it killed 10 militants in the camp and arrested eight suspects. Nine Israeli soldiers and officers were wounded. In a separate incident in the

West Bank, an Israeli man was wounded in an explosion Sunday, the Magen David Adom rescue service said. A video circulating online shows a man approaching a Palestinian flag that had been planted in a field. When he

kicks it, it appears to trigger an explosive device At least 469 Palestinians have been killed by Israeli soldiers

and settlers in the West Bank since the start of the war in Gaza, according to the Palestinian Health Ministry. Most have been killed during Israeli military arrest raids, which often trigger gunbattles, or in violent protests.

The war in Gaza was sparked by an unprecedented Oct 7 raid into southern Israel in which

Hamas and other militants killed around 1,200 people, mostly civilians, and abducted around 250 hostages. Israel says militants are still holding around 100 hostages and the remains of more than 30 oth-

Thousands of Israelis have taken to the streets to call for new elections to replace Prime Minister Benjamin Netanyahu and a deal with Hamas to release the hostages. Netanyahu has vowed to continue the war until Hamas is destroyed and all the hostages are returned. The war has killed at least 34,097 Palestinians and wounded another 76,980, according to the Gaza Health Ministry. The ministry does not differentiate between combatants and civilians in its count but says at least twothirds have been children and women. It also says the real toll is likely higher as many bodies are stuck beneath the rubble left by airstrikes or are in areas that are unreachable for medics. Israel blames Hamas for civilian casualties because the mil-

itants fight in dense, residential neighbourhoods, but the military rarely comments on individual strikes, which often kil women and children. The military says it has killed over 13,000 Hamas fighters, without

Khamenei acknowledges Tehran hit little in attack on Israel

Tran's supreme leader on ■Sunday dismissed any discussion of whether Tehran's unprecedented drone-and-missile attack on Israel hit anything there, a tacit acknowledgment that despite launching a massive assault, few projectiles actually made through to their

Ayatollah Ali Khamenei's comments before senior military leaders didn't not touch on the apparent Israeli retaliatory strike Friday on the central city of Isfahan, even though air defences opened fire and Iran grounded commercial flights across much of the country.

Israel, regional archrivals locked in a shadow war for years, are trying to dial back tensions following a series of escalatory attacks between them as Iśrael's war on Hamas in the Gaza Strip rages on and inflames the wider region.

Khamenei, 85, made the comments in a meeting attended by the top ranks of Iran's regular military, police and paramilitary Revolutionary Guard, a powerful force within its Shiite theocracy. "Debates by the other party

about how many missiles were fired, how many of them hit the target and how many didn't, these are of secondary impor-tance," Khamenei said in remarks aired by state televi-

'The main issue is the emergence of the Iranian nation and Iranian military's will in an important international arena. This is what matters.

Iran launched hundreds of drones, ballistic missiles and overwhelm Israel's air defences in the April 13 attack — the first on Israel by a foreign power since Iraqi dictator Saddam Hussein launched Scud missiles at Israel in the 1991 Gulf War. However, Israeli air defences

and fighter jets, backed by the US, the United Kingdom and neighbouring Jordan, shot down the vast majority of the incoming fire.

Satellite images analysed Saturday by The Associated Press showed the Iranian attack caused only minor damage at the Nevatim air base in southern Israel, including taking a chunk out of a taxiway that Israel quickly repaired.

Iran's attack came in response to a suspected Israeli strike on April 1 targeting a consular building next to the Iranian Embassy in Damascus, Syria, which killed two Guard generals and others.

Tarun Ghulati, the Indian-origin candidate in the race to challenge Sadiq Khan from winning a third term as Mayor of London, has said that the citizens of the UK capital have been let down by all the major political parties and he wants to run London like a "seasoned CEO" which delivers profits for

The Delhi-born businessman believes his investment expertise is what London needs to revive its fortunes as the "global bank of the world" by attracting the investment it needs. The 63-year-old is standing as an Independent candidate among 13 contestants in the fray for the local elections on May 2, when Londoners will vote for their Mayor and also for members of the London Assembly.

'I view London as a unique global city, akin to the 'global bank of the world' where diverse cultures converge to flourish," Ghulati said in a speech this week.

"Às Mayor, I will build London's balance sheet such that it is the premier choice for investment, safeguarding safety and prosperity for all its residents. I will transform and run London effectively and efficiently like a seasoned CEO. London will be a profitable corporate where profitability means the wellbeing of all. You will all be part of the journey. Let's do it for our

London, our home," he said. Safety on the streets of the city is among his other major pri orities, with visible community policing and more officers patrolling on the beat on the agenda

"I would not be a candidate for Mayor if the political candidates were doing what they should be doing. They have let us down. This is all about London and Londoners," he declared. Creating more affordable hous-

ing, minimising council tax, increasing focus on tourism to the UK capital and ensuring free school meals are among some of Ghulati's other focus areas. He claims to have canvassed from borough to borough across London to garner his required signatures to support his mayoral candidature. Ghulati also features in the official mini manifesto booklet, which costs each candidate GBP 10,000.

The winning mayoral candidate will be responsible for all local issues affecting Londoners, from transport and policing to housing and the environment.

¬wo Japanese navy heli-Two Japanese nav, nem copters carrying eight crew members crashed in the Pacific Ocean south of Tokyo during nighttime training in a possi ble collision, leaving one dead while rescuers on Sunday searched for seven others missing, the defence minister said. The two SH-60K choppers from the Maritime Self-Defence Force were carrying four crew each and lost contact late Saturday near Torishima island, about 600 kilometres south of Tokyo, Defense Minister Minoru Kihara told

The cause of the crash was not immediately known, but officials believe the two helicopters "highly likely" collided before crashing into the water, Kihara

The navy chief of staff, Adm. Ryo Sakai, said training involving the SH-60s will be suspended until the cause of the crash is determined and preventive measures are adopted.

Rescuers recovered a flight data recorder, a blade from each helicopter, and fragments believed to be from both choppers in the same area, signs that the two SH-60Ks were flying close to each other, Kihara

Search and rescue efforts for the missing crew were expanded Sunday with the deployment of 12 warships and seven aircraft. Japan coast guard patrol boats and planes also joined the operation. US Ambassador to Japan Rahm Emanuel offered his country's to help with the search and rescue. "We will stand together, side by

side, with our friend and ally, Japan. My thoughts are with the crew members, and their families and friends during this challenging time," he wrote on the social platform X.

The twin-engine, multi-mission helicopters developed by Sikorsky and known as Seahawks were modified and produced in Japan by Mitsubishi Heavy Industries. They were on nighttime antisubmarine training, Kihara said. One lost contact at 10:38 p.m. and sent an automatic emergency signal a minute

Only one distress signal, called an emergency locator transmitter, was heard — another sign the helicopters were near the same place, because their signals use the same frequency and could not be differentiat-

copters.

One helicopter belonged to an air base in Nagasaki, and the other to a base in Tokushima prefecture. Officials were interviewing the pilot of a third aircraft that also participated in Saturday's training, Kihara said. The SH-60K aircraft is usually deployed on destroyers for anti-submarine warfare, but is also used for search and rescue and other missions. Japan has about 70 of the modified heli-

Saturday's training only involved the Japanese navy and was not part of a multinational exercise, defense officials

Japan, under its 2022 security strategy, has been accelerating its military buildup and fortifying deterrence in the southwestern Japanese islands in the Pacific and East China Sea to counter threats from China's increasingly assertive military activities. Japan in recent years has conducted its own extensive naval exercises as well as joint drills with its ally the United States and other part-

Saturday's training was part of routine drills involving warships, submarines and Seahawk helicopters, the Japanese navy chief of staff said. During training, a number of helicopters hover together as they lower sonars into the water to detect submarines.

In 2017, a Japanese navy SH-60J, an earlier generation Seahawk, crashed during nighttime training due to human error, killing three crew. In July 2021, two SH-60s had a minor collision off the southern island of Amamioshima, both suffering blade damage, but causing no injuries.

Following the 2021 collision, the navy introduced a set of preventive measures to ensure enough distance between aircraft. Sakai said Saturday's crash could have been prevented if all safety measures were adequately followed.

In the US, the fatal crash of a MH-60S Seahawk during training off California in 2021 was attributed to mechanical failure from unsuspected damage during maintenance, according to the Navy.

The crash in Japan also comes a year after a Ground Self-Defense Force UH-60 Blackhawk crashed off the southwestern island of Miyako due to an engine output problem known as "rollback," leaving all 10 crew members dead.

seats in by-elections in Pakistan

Polling ended on Sunday for 21 national and provincial seats in the by-elections in Pakistan, which took place amidst tight security and suspension of cellular and internet services in some districts of Punjab and Balochistan to maintain law and order.

According to the Election Commission of Pakistan (ECP), voting began at 8 am and continued without any break until 5 pm with the provision that voters present within the premises of polling stations would be allowed to cast votes even after the expiry of official timing.

It will be followed by counting, while results are expected later tonight.

Despite elaborate security measures taken by authorities to maintain the law and order situation, at least one person was killed and several others injured in clashes during the pólling in Punjab province, according to the police.

"Violent clashes took place in Narowal, Sheikhpura and Rahim Yar Khan in which one person was killed and several injured," the Punjab police

Lahore, a clash took place between the supporters of former prime ministers Imran Khan and Nawaz Sharif outside a polling station.

Punjab Information Minister Azma Bokhari said the victim was a member of Sharif's Pakistan Muslim League-Nawaz (PML-N) who was killed by workers of Khan's Pakistan Tehreek-e-Insaf (PTI)

In the Sheikhupura and Rahim Yar Khan districts of Punjab, at least five workers of the two rival parties suffered bullet injuries during clashes.

Similarly in Lahore, the PTI and PML-N workers scuffled on setting up polling camps. Police arrested four persons, including PTI leader Shabbir Gujjar.

The general elections were held across the country on February 8 to elect representatives for the national assembly and four provincial assemblies. Polls were, however, cancelled for one National Assembly seat, two Punjab Assembly seats and one seat of the Khyber-Pakhtunkhwa Assembly.

Apart from these, candidates who won more than one seat opted for only one after the elections, leaving the ECP to organise by-elections on 21 seats, including five national and 16 provincial assembly seats.

A day earlier, the federal government announced that cellular services would remain temporarily suspended in specific districts of Punjab and Balochistan during the byelections. The suspension request was made by the electoral watchdog.

In a statement, the Pakistan Telecommunication Authority (PTA) said the decision was taken to safeguard the integrity and security of the electoral process.

Social media platform X (for-merly Twitter) has also been shut down in Pakistan since February 17, after a top bureaucrat accused the Chief Election Commissioner Sikandar Sultan Raja and Chief Justice of Pakistan Qazi Faez Isa of being involved in rigging at the behest of the military establishment to install the Shehbaz Sharif government.

By-elections were held on two seats of the National Assembly each in Punjab and Khyber-Pakhtunkhwa and one seat in Sindh, while polling began on 12 seats of the Punjab Assembly and two each of Khyber-Pakhtunkhwa and

Balochistan assemblies.

In Punjab, NA-132 (Kasur) and NA-119 (Lahore) were vacated by Prime Minister Shehbaz Sharif and Chief Minister Marvam Nawaz, while Shehbaz also gave up two of his provincial assembly seats in

The prime minister retained his NA-123 seat in the National Assembly.

Elaborate security measures were taken by authorities to control the law and order situation with the deployment of regular army troops to maintain peace during the day-long process of by-elec-

The ECP had asked the federal government to approve the deployment of Pakistan Army and Civil Armed Forces (CAF) troops to keep peace. The federal government endorsed the move and announced the use of armed forces units as a quick response force.

The Ministry of Interior, in its notification issued on Friday, said the CAF and Pakistan Army units would be used as second and third tiers of security, and they would be available with immediate effect till April 22 in all 21 constituencies.

Live video of man who set himself on fire proves challenging for news organisations

Video cameras stationed outside the Manhattan courthouse where former President Donald Trump is on trial caught the gruesome scene Friday of a man who lit himself on fire and the aftermath as authorities tried to rescue him. CNN, Fox News Channel and

MSNBC were all on the air with reporters talking about the seating of a jury when the incident happened and other news agencies, including The Associated Press, were livestreaming from outside the courthouse. The man, who distributed pamphlets before dousing himself in an accelerant and setting himself on fire, was taken to a hospital where he later died.

Haitians scramble to survive amidst gang violence

AP ■ PORT AU PRINCE (HAITI)

s the sun sets, a burly man Abellows into a megaphone while a curious crowd gathers around him. Next to him is a small cardboard box with several banknotes worth 10 Haitian gourdes — about 7 US

"Everyone give whatever they have!" the man shouts as he grabs the arms and hands of people entering a neighbourhood in the capital of Port-au-Prince that has been targeted by violent gangs.

The community recently voted to buy a metal barricade and install it themselves to try to protect residents from the unrelenting violence that killed or injured more than 2,500 people in Haiti from January to

"Every day I wake up and find

a dead body," said Noune-Carme Manoune, an immigration officer.

Life in Port-au-Prince has become a game of survival, pushing Haitians to new limits as they scramble to stay safe and alive while gangs overwhelm the police and the government remains largely absent. Some are installing metal barricades. Others press hard on the gas while driving near gang-controlled areas. The few who can afford it stockpile water, food, money and medication, supplies of which have dwindled since the main international airport closed in early March. The country's biggest seaport is largely paralysed by marauding gangs.
"People living in the capital are

locked in, they have nowhere to go," Philippe Branchat,

International Organisation for Migration chief in Haiti, said in a recent statement. "The capital is surrounded by armed groups and danger. It is a city under siege.

Phones ping often with alerts reporting gunfire, kidnappings and fatal shootings, and some supermarkets have so many armed guards that they resemble small police stations.

Gang attacks used to occur only in certain areas, but now they can happen anywhere, any time. Staying home does not guarantee safety: One man playing with his daughter at home was shot in the back by a stray bullet. Others have been killed.

Schools and gas stations are shuttered, with fuel on the black market selling for USD 9 a gallon, roughly three times the official price. Banks have

prohibited customers from withdrawing more than USD 100 a day, and checks that used to take three days to clear now take a month or more. Police officers have to wait weeks to be paid.

"Everyone is under stress," said Isidore Gedeon, a 38-year-old musician. "After the prison break, people don't trust anyone. The state doesn't have con-

Gangs that control an estimated 80 per cent of Port-au-Prince launched coordinated attacks on February 29, targeting critical state infrastructure. They set fire to police stations, shot up the airport and stormed into Haiti's two biggest prisons, releasing more than 4,000 inmates.

At the time, Prime Minister Ariel Henry was visiting Kenya to push for the UN-backed deployment of a police force. Henry remains locked out of Haiti, and a transitional presidential council tasked with selecting the country's next prime minister and Cabinet could be sworn in as early as this week. Henry has pledged to resign once a new leader is installed.

Few believe this will end the crisis. It's not only the gangs unleashing violence; Haitians have embraced a vigilante movement known as "bwa kale", that has killed several hundred suspected gang members or their associates.

'There are certain communities I can't go to because everyone is scared of everyone," Gedeon said. "You could be innocent, and you end up dead." More than 95,000 people have fled Port-au-Prince in one month alone.

IMF team to visit Pak next month to negotiate new bailout package

R ussia is currently considering taking the Taliban off its list of terrorist organisations, officials have indicated.

While no final decision has yet been taken, one sign of their increasingly cordial relationship is the Taliban's invitation to an international economic forum being held in Kazan, Russia, in May. The Kremlin has opened up discussions with the Taliban before, and Russia was one of the few nations to accredit a diplomat when the organisation took control of Afghanistan.

But Afghanistan's political and economic crisis and western

Ukraine war mean both sides have something to gain from a stronger relationship. In 1999, the UN security coun-

cil adopted resolution 1267, in which the Taliban was found responsible for "the provision of sanctuary and training for international terrorists". A few months later, Vladimir Putin signed a decree implementing the UN resolution and imposing sanctions against the Taliban.

In 2003, the Russian supreme court recognised the Taliban movement as a terrorist organisation, saying it maintained links with illegal armed forces in Chechnya and tried to seize power in Uzbekistan, Tajikistan

Russia launched a regional initiative in 2017 to negotiate between the Kabul government and the Taliban as an effort to create a peacemaker role for itself.

These negotiations were aimed at offering solutions to the Afghanistan crisis, and were usually held with the participation of China, Iran, Pakistan and central Asian republics. Russia continued to maintain contact with the Taliban, despite labelling them a terror-

ist group. Since taking over control of Afghanistan, no foreign states have recognised the Taliban government. There are few signs yet that many are close to

doing so, partly because of the Taliban's continuing erosion of women's rights and recognition of human rights more generally The Taliban wants interna-

tional sanctions to be withdrawn, to take Afghanistan's UN seat and for frozen assets to be released, which will help the country's economic development. Afghanistan should benefit

economically from developing the important Lapis-Lazuli trade corridor which links Afghanistan to Istanbul and Europe, and Uzbekistan-Afghanistan-Pakis tan railway line, if internation-

al sanctions are withdrawn.

Net collections of income and corporate taxes, which make up for most of the direct taxes, in 2023-24 financial year exceeded the Budget estimates by Rs 1.35 lakh crore (7.40 per cent) and the revised estimates by Rs 13,000

The government had raised the target for direct tax collection in FY24 (April 2023 to March 2024) to Rs 19.45 lakh crore in the interim Budget presented on February 1.

With this, the gross tax collection target as per the revised estimate stood at Rs 34.37 lakh crore for FY24.

Insurance regulator IRDAI abolishes age restriction on health insurance product

This marks a significant departure from the departure conventional constraints that limited individuals comprehensive coverage

By abolishing the maximum age restriction on purchasing health insurance plans, the Insurance Regulatory and Development Authority of India (IRDAI) aims to foster a more inclusive and accessible healthcare ecosystem, ensuring adequate protection against unforeseen medical expenses

As per the earlier guidelines, individuals were allowed to purchase a new insurance policy only till the age of 65. However, with the recent amendment, which has been effective from April 1, anyone, regardless of age, is eligible to buy a new health insurance policy.

In a recent gazette notification, IRDAI said, "insurers shall ensure that they offer health insurance products to cater to all age groups. Insurers may design products specifically for senior citizens, students, children, maternity, and any other group as specified by the Competent Authority. mandated to offer health responsive approach to their policies to individuals with



pre-existing conditions of any kind. Consequently, insurers are prohibited from refusing to issue policies to individuals medical conditions like cancer, heart or renal failure, and AIDS. According to the notification, insurers are allowed to offer premium payment instalments convenience of policyholders.

At least 26 land deals for around 449 acres were closed while 88 land deals for 1,886 acres were struck during the full 2022-23 fiscal These land deals, which were

struck across major tier I, tier II and tier III cities, include outright purchase-sale transactions and partnerships with landlords called Joint Development Agreements (JDAs).

Anarock Chairman Anuj Puri said, "Out of the total land deals in 2023-24, over 83 deals for about 1,135 acres were closed in the top 7 cities alone. "The remaining 18 deals, accounting for over 1,853 acres, were sealed in various tier 2 and 3 cities like Ahmedabad, Ayodhya, Jaipur, Nagpur, Mysuru, Ludhiana,

and Surat.



Against such disturbing background, the Government's top think tank Niti Aayog's has come forward to set up the high-level panel to formulate policies for primary, secondary, and tertiary level hospitals in the country. Spearheaded by Dr RK Dhamija who is also the Director of the Delhi-based Institute of Human Behaviour and Allied Services (IHBAS), the task force has nine members.

Exceptts from the interview: Dr Dhamija, kindly tell us more about the establishment of the National Task Force on Brain Health and its objectives?

Thank you for having me. The World Health Organisation (WHO) in its 75th General Assembly adopted the Inter-sectoral Global Action Plan on epilepsy and other neurological disorders 2022-2031. This provides the vision, goal, guiding principles and strategic objectives with their action areas and targets for member states. India being major economic power is also signatory to this resolution which suggests a range of proposed actions for member states. The task force is in line with WHO resolution as well as in response to the growing challenges posed by neurological disorders, especially in light of the Covid-19 pandemic. Its primary objective is to address the gaps in brain healthcare accessibility and

How do you envision it making an impact?

As I said, the increasing prevalence of neurological disorders and the disparities in healthcare access across different segments of society were significant motivating factors in the establishment of this central task force. The government recognized the urgent need for a coordinated effort to tackle these issues

comprehensively. Through the task force, we aim to recommend actionable steps to strengthen the healthcare system, improve early diagnosis and treatment, and promote neurological health through preventive measures.

Can you elaborate on some of the specific challenges or gaps in brain healthcare that the task force aims to address?

Certainly. One major challenge is the unequal distribution of healthcare resources, particularly in rural and underserved areas. This leads to disparities in access to specialized care and diagnostic facilities for neurological conditions. collaboration with government agencies, healthcare providers, and other stakeholders, we aim to build a more resilient and responsive healthcare system that prioritizes brain health for all. Neurological disorders rank as the leading cause of disability-adjusted life years (DALYs) globally, resulting in approximately 9 million deaths annually. The prevalence of neurological disorders underscores their significant impact, with 1 in 3 individuals expected to experience such conditions during their lifetime. These disorders rank as the foremost cause of disability and the second leading cause of death globally. The WHO's position paper launched on August 9, 2022, provides a detailed framework for understanding brain health and the importance of optimizing brain health for all.

What is the status of brain health in India vis a vis world?

In India, as in many parts of the world, issues related to brain health present significant challenges that require urgent attention. While specific data on the status of brain health in India compared to the rest of the world may vary, neurological disorders are increasingly recognized as a major public health concern in India. Conditions such as stroke, epilepsy, headache disorders, Parkinson's disease, and dementia impose a substantial burden on individuals, families, and healthcare systems.

Moreover, disparities in healthcare access and infrastructure pervasive in India, particularly in rural and underserved areas. Limited availability of specialized professionals, diagnostic facilities, and trained healthcare paramedics pose significant challenges for individuals seeking diagnosis and treatment.

Due to lack of awareness and understanding of neurological disorders among the general population in India, patients are diagnosed late. Also, inadequate treatment, and social stigma further add the burden on affected individuals and their families. Socioeconomic factors such as poverty, limited education, and inadequate access to healthcare services contribute to the burden of neurological disorders in India.

Chemical Sunscreens: These sunscreens use organic compounds like oxybenzone, avobenzone, and octinoxate. They absorb UV radiation, converting it into heat that is then released from the skin. Chemical sunscreens are lightweight and cosmetically elegant, offering a clear, nongreasy feel. But some people may experience irritation due to certain chemical ingredients.

SUNSCREEN SELECTION FOR SKIN TYPE

Normal Skin: Choose a broadspectrum sunscreen with SPF 30 or higher.Look for lightweight, non-greasy formulas and sunscreens with added for extra skin antioxidants nourishment.

Dry Skin: Choose fragrancefree, moisturizing sunscreens. Lotions or creams containing hyaluronic acid or ceramides can provide added hydration.Seek labelled sunscreens "hydrating" or "moisturizing" for more benefit.

Oily Skin: Look for oil-free, noncomedogenic (won't clog pores) sunscreens. Lotions with a matte finish or lightweight gels are ideal for oily skin.Gel-based or mattefinish sunscreens control the extrashine. Ingredients like niacinamide or zinc oxide can also help regulate oil production. Sensitive Skin: The gentlest option for sensitive skin are mineral based sunscreens. Two-time major champion Garbiñe Muguruza Muguruza announced she's retiring from professional tennis at age 30 after an extended time away from the court. "I feel that it is time to retire

and open up a new chapter in my life," the former world No. 1 told a news conference in Madrid on Saturday.

Muguruza beat Serena Williams in the 2016 French Open final and Venus Williams in the 2017 Wimbledon final, making

her the only player to defeat each Williams sister in a Grand Slam title match. The Spanish player earned 10

career titles and was also the runner-up at 2015 Wimbledon and the 2020 Australian Open. She earned nearly \$25 million in prize money - 13th on the all-time list - and finished with a win-loss record of 449-238.

Her last important victory was the 2021 ATP Finals. 'The word retirement' sounds

very harsh to be because I am only 30 years old, but I have achieved so much since I started playing 25 years ago, she said. "I am proud of what I have achieved, for having stuck to reaching my goals even through the tough times."

Muguruza has not played since January 2023. In April that year, she announced she was extending her hiatus from playing and said, "Spending time with my family

and friends (has) really been healthy and amazing." Born in Caracas to a Spanish

father and Venezuelan mother, Muguruza moved to Barcelona when she was a child to continue her tennis training. She became the first Spanish woman to lift a Grand Slam trophy since Arantxa Sánchez Vicario at the 1998 French Open.
