While the BJP manifesto did include the ord "India", the prevalence of "Bharat"

Amid West Asia escalation, **PM says strong Government** need of the hour

Amid the West Asia Prime Minister Narendra Modi on Sunday called for a strong Centre given the prevailing uncertainty and tension on a global scale, particularly in areas of conflict.

"The BJP steadfastly takes bold and challenging decisions in the nation's interest, prioritising the country over the party itself," the Prime Minister said at the party's poll manifesto release, referring to the several conflicts the world was grappling with.

Modi exhorted people to give another mandate to his party to shape India's destiny for the next 1,000 years and the need for a stable Government with full majority was necessary when the world was passing through uncertain times.

India called for immediate de-escalation of the situation after Iran launched dozens of drones and missiles at Israel in a retaliatory attack. New Delhi favoured diplomacy and dialogue to defuse tension.

This appeal came hours after Iran launched drones and missiles at Israel and India said it is concerned over escalating hostilities between

Bansuri ignites Delhi campaign with Sushma Swaraj's spirit

Draped in the saree once worn by her mother, former Foreign Minister Sushma Swaraj, BJP's youngest candidate for the forthcoming Lok Sabha elections in 2024, Bansuri Swaraj, said the scent lingering from it transports her to a comforting embrace, evoking fond memories of her mother's aanchal as she begins the campaign trail.

Bansuri grew up in Delhi and said she is a 'dadi nani ke haathon se khilaya bachcha' (fed with the hands of maternal and paternal grandmothers). "My friends and teachers kept me grounded throughout. Both my parents ensured that I have a very normal upbringing," said Bansuri, who grew up in a family of politicians and lawyers.

The fierce leader, with the oratory skills of her mother, lights up the brightest

when she talks about her 'co-conspirator' and her 'favourite human being in the world'.

Calling her mother's loss irreparable, she said, "I wish my mother was here for my life. No matter what age you lose

your parents, it's never

enough time. And I'll be honest, I don't miss Sushma Swaraj 'the neta'. I miss Sushma Swaraj, the mother. For me, she was always a mom. She was a Minister outside the house." Bansuri shared her mother's anecdote about the combination of sarees and sports shoes. "Meri ma kehti thi agar ek nari saree k neeche sports shoe pehn le, then she means business. (My mother used to say if a woman wears sports shoes beneath a saree, she means business). These sarees that I wear are actually my mother's. It's literally like being wrapped in her 'anchal," she said.

An Oxford educated lawyer, Bansuri marked her 17th year as a litigator. She describes herself as 'innately a lawyer' and 'not a politician'. Opposition says BJP Manifesto a jugglery of words

Several Opposition party Sleaders from Congress, TMC, RJD, Left parties on Sunday dismissed the BJP sto titled Guarantee, asking what the Prime Minister's guarantee means. Congress trashed the BJP's poll manifesto as a "jumla patra" full of rhetoric, with party chief Mallikarjun Kharge saying Prime Minister Narendra Modi's guarantee is a "warranty of jumlas" as he has failed to fulfil his past promises.

The Opposition party also accused Modi of not honouring his promises made on jobs, doubling farmers' income and tackling inflation, and alleged that the Prime Minister is now shifting the goalposts by talking about 2047. The Congress said the BJP manifesto should have been named "maafinama" and Modi should have apologised to farmers, youngsters, poor people and Dalits for not fulfilling the promises made in the last 10 years.

Former Congress chief Rahul Gandhi said, "Two words are missing from the BJP's manifesto and Modi's speech inflation unemployment."

youngsters. This time the youngsters are not going to fall into Modi's trap. Rising food prices cast a pall over festive celebrations

While yet another round of two-month-long election festivities is underway, a sudden surge in the prices of all edible items — groceries, vegetables, fruits — has dampened the household spirit during the ensuing Navratri, Eid, Poila Baishak, Bihu, and Baishaki festivals.

Prices of any green vegetable, be it okra, beans, bottle gourd, or bitter gourd, are not less than ₹100 per kilogram. Even the usually affordable vegetable like cabbage is selling at ₹60 per kilogram,

while potatoes have risen to ₹30 per kilogram and onions to ₹40 per kilogram across the national Capital. During the festive season of Chaitra Navratri, the markets are witnessing a surge in fruit prices, such as banana, apple, and papaya, primarily driven by the increased demand for these fruits. Bananas, being both affordable and nutritious, are the preferred choice for devotees fasting during this period. Bananas, which typically sell at

₹40-50 per dozen, are now priced at ₹70 per dozen. Similarly, prices of apples, oranges, grapes, and papayas have gone up. Apples, once sold at ₹100-120 per

kilogram, now come for ₹150-180, while oranges are priced between ₹80-100 per kilogram, up from ₹30 per kilogram. Grapes, pomegranates, and papayas have also seen notable price increases.

Praveen, a shopper, expressed concern over the price hike, noting that prices surge even before Navratri begins. Wholesale and retail prices have

gone up, with people residing in different cities also facing hardship as India's favourite staple pulse — arhar dal — is burning a hole in the pockets at ₹180 per

 $F_{\text{political footprints left by}}^{\text{ollowing the formidable}}$ Pradesh's former Chief Minister Virbhadra Singh and his MP Singh, wife Pratibha Vikramaditya Singh is poised to inherit the political legacy in Mandi — a constituency deeply entrenched in the state's royal family's history.

In past electoral contests,

once faced a setback. Virbhadra Singh, a stalwart who served as the Chief Minister for six terms, charted his political trajectory from the Mandi parliamentary seat, even holding ministerial positions in Dr Manmohan Singh's administration. Currently, Pratibha is representing the significant

Set to contest from the family's bastion, Vikramaditya on Sunday said that he never get intimidated by challenges and he has the capability to fight and accept every chal-In Rampur, Vikramaditya also expressed

from Mandi, where he will be facing a tough challenge from the Bollywood actress and BJP

candidate Kangna Ranaut. "I have overcome every challenge with the blessings of the deities. With truth and honesty, I believe in serving the people of the State. I want to assure the people of Mandi that, just like I have worked for the development of rural Shimla as its legislator, I will bring a new identity to the Mandi Lok Sabha constituency," said Vikramaditya, a day after his name was announced by the Congress.

Vikramaditya, who is also Cabinet Minister in his gratitude to Congress' top Sukhwinder Singh Sukhu

he would present a new model of development for the country and raise the voice of his region strongly in the Parliament. "My father Virbhadra Singh, and mother Pratibha Singh, have been Members of Parliament from Mandi. They have laid the foundation of development in this area, and I will carry it forward," he added.

Asserting his commitment to holistic development in Himachal Pradesh, Vikramaditya highlighted that he aimed to present his entire vision document to the people of Mandi in the coming days. He underscored that the elections are not about individual

affecting the region. "It is not about specific individuals...It is about contesting on issues,"

he remarked. Vikramaditya's candidature from Mandi, one of the key constituencies in Himachal Pradesh, has generated significant interest among political observers. As the son of veteran politician Virbhadra Singh, he carries forward the political legacy of his family while aiming to carve his own path in state politics.

The connection of Virbhadra Singh family with Mandi parliamentary constituency dates back 57 years. In 1971, Virbhadra Singh contested his first Lok Sabha election from here and secured a record 71.95 per cent of the votes. His opponent Mandhar Lal received only 16.14 per cent of the votes. However, in 1977 elections, he had to face defeat amidst the wave of the Janata Party. In 1980, Virbhadra Singh was elected as the Member of Parliament for the second time

from here. After a gap of 18 years, his wife Pratibha Singh contested the elections from Mandi in 1998. She faced Maheshwar Singh of the BJP, her close relative, in a fiercely contested battle. Unfortunately, Pratibha had to taste defeat. She contested again in 2004, and this time, retaliating against her previous loss, she emerged victorious securing her position as a Member of Parliament for the

In 2009, the baton was passed to her husband, Virbhadra Singh, who contested from Mandi. He won against his opponents, marking his third term as an MP from the constituency.

After assuming the role of Chief Minister, Virbhadra resigned as a Member of Parliament in 2012. In the subsequent by-elections, Pratibha Singh contested for the third time from Mandi. She defeated the then opposition leader Jairam Thakur, and became an MP for the second time. However, in the 2014 elections,

Ramswaroop Sharma of the

November 2021, In Pratibha Singh contested again in a by-election. This marked her fifth electoral battle. Despite the shifting political dynamics, she emerged victorious for the third time. Virbhadra and Pratibha Singh contested a total of nine elections in this parliamentary constituency, securing victory six times.

Now, Vikramaditya Singh, following the footsteps of his parents, is all set to embark on his political journey from the Mandi parliamentary constituency, which spans across 17 assembly segments in six districts of the state.

While Himachal Pradesh

fares comparatively better than some states, the prevalence of mental stress is on an alarming upward trajectory. Uttarakhand reported the highest incidence at 38.6 per cent, followed closely by Sikkim at 31.9 per cent.

Despite ongoing efforts by health service centers and educational institutions to raise awareness and provide support, proactive measures are imperative to stem the rising tide of mental health cases. Various factors contribute to stress, including personal traumas, social isolation, and chronic illnesses.

Moreover, experts highlighted the role of social media and substance abuse in exacerbating mental health issues. They stressed the importance of meaningful interpersonal connections, advocating for faceto-face communication over virtual interactions. Consistent follow-up and adherence to treatment plans are also deemed crucial in effectively managing stress.

As Himachal Pradesh grapples with the multifaceted nature of mental health challenges, concerted efforts are needed to address the root causes and bolster support systems. By fostering a culture of open dialogue, empathy, and proactive intervention, the state can work towards alleviating the burden of mental stress and promoting holistic well-being among its populace.

Ensure farmers receive payment for their crops within 72 hrs of issuance of J-form: Hry CS asks Officers

Haryana Chief Secretary TVSN Prasad on Sunday directed the Administrative Deputy Secretaries, Commissioners of all districts, and officers involved in Rabi crop procurement to ensure that farmers receive payment for their crops within 72 hours of the J-form being issued.

To ensure effective oversight, the Chief Secretary has formed a three-member committee comprising senior IAS officers to monitor, particularly the issuance of J-Forms and payment to farmers.

The Chief Secretary, who reviewed Rabi season's procurement operations with Administrative Secretaries and Deputy Commissioners

in Chandigarh, said that bumper wheat crop this year, leading to the expectation of a higher volume of crops for sale in mandis. Therefore, he directed officers to be fully prepared to ensure that farmers do not face any inconvenience.

Upon receiving feedback from the Deputy Commissioners regarding the arrangements at mandis in their respective districts, he emphasized the need to promptly address any issues that arise. He asked them to seek guidance from their Divisional Commissioners and specially appointed administrative secretaries. Additionally, he urged Administrative Secretaries to conduct regular visits to the Mandis under their

jurisdiction. The Chief Secretary instructed officers to verify the crops registered by farmers on the 'Meri Fasal Mera Byora' portal by the evening of April 15, emphasizing that farmer satisfaction is our top priority. In a dramatic twist set to shake up Punjab's political landscape, the Congress party on Sunday unleashed its first volley of candidates for the June 1 Lok Sabha elections. In a strategic move aimed at bolstering its chances, the grand old party has ditched the conventional playbook, opting instead to field heavyweight contenders in a bid to reclaim lost ground amidst a flurry of high-profile defections. This opening salvo includes a cast of seasoned politicians, including two sitting MPs, a former Chief Minister, and a battle-hardened MLA - injecting a fresh dose of intrigue and anticipation into the electoral

Punjab is poised for a multicornered electoral battle with no major alliances emerging on the horizon. Recognizing the competitive landscape, the Congress is aiming to capitalize on the fragmentation of votes and leverage the popularity of these seasoned politicians to strengthen its electoral standing.

The decision to field heavyweight candidates comes in response to recent setbacks caused by the departure of prominent leaders including sitting MPs Preneet Kaur and Ravneet Singh Bittu. These defections have underscored the need for the Congress to reassess its approach and adopt a more assertive stance in the electoral

In its first list of candidates for Punjab, the Congress has retained two incumbent MPs-Gurjeet Singh Aujla from Amritsar and Dr Amar Singh from Fatehgarh Sahib; while introducing several known politicians in key constituencies. Former Chief Minister Charanjit Singh Channi has been nominated from Jalandhar, marking a significant endorsement of his leadership within the party. The decision to field Channi came after the party denied a ticket to former MP Santokh Chaudhary's family, following his demise during Rahul Gandhi's 'Bharat Jodo Yatra'. Chaudhary's wife, Karamjit Kaur, had contested the by-election but faced defeat to AAP's Sushil Rinku, BJP ticket. Already, Chaurdhary's son and Phillaur MLA Vikramjit Singh Chaudhary has resigned from the post of party's chief whip. Speculations were rife that the Chaudhary family may join AAP, but after SAD's former MLA Pawan Kumar Tinu's joining AAP, it would be interesting to see the Chaudhary family's next move.

In Amritsar, the Congress opted for continuity by choosing Aujla over former Deputy Chief

Minister OP Soni, who hails from the Hindu community. The decision sidelines the claims of Soni, while reaffirming confidence in Auila, who has represented the constituency twice.

Similarly, Bholath MLA Sukhpal Singh Khaira's nomination from Sangrur has captured considerable attention. Khaira, a vocal critic of Chief Minister Bhagwant Mann and the AAP Government, has emerged as a formidable force in Punjab politics. His confrontational stance and unwavering commitment to public service have earned him a dedicated following among the electorate. **Ballot Battle – 2024**

Former MLA Jeet Mohinder Singh Sidhu's nomination from Bathinda further underscored the Congress's emphasis on local face and experienced leadership in the key constituency, known to be Akalis' bastion. Sidhu's deep understanding of local issues and track record of community engagement position him as a strong contender in the electoral fray.

At the same time, the decision marked a departure from the earlier plan of nominating state Congress chief's wife Amrita Warring. Of particular significance is the nomination of former AAP MP Dr Dharamvira Gandhi from Patiala. Dr Gandhi's decision to contest against former Congress stalwart Preneet Kaur represented a significant shift in political dynam-

To counter farmers' protests, BJP launches election committees in all constituencies

In the face of relentless farmer opposition, the Bharatiya Janata Party (BJP) in Punjab has ignited a strategic battle plan. Faced with the farmers' fiery 'Delhi Chalo Andolan', the saffron party's Kisan Morcha has responded with a tactical move — setting up election campaign committees across all 13 Lok Sabha constituencies in the state.

These committees, akin to mini-war rooms, are now poised to navigate the stormy seas of electoral politics, armed with fervent determination and carefully-crafted strategies. This 11-point questionnaire, to be strategically displayed in villages across Punjab and Haryana, highlighted the issues such as road blockades during Delhi march, police violence during protests at Shabhu amd Khanauri borders, justice for victims of the farmer's agitation, implementation of Swaminathan report on MSP, action against Union Minister in Lakhimpur Kheri incident, among others.

The farmers' campaign has already made an impact on BJP candidates, who are facing protests, black flags, and slogans during their campaign trail. Among those facing farmers' ire were former Union Minister Preneet Kaur — BJP candidate from Patiala and the wife of former Chief Minister Capt Amarinder Singh; former bureaucrat Taranjit Singh Sandhu Kaur — BJP candidate from Amritsar; and Sufi singer Hans Raj Hans — BJP candidate from Faridkot.

Further exacerbating the situation, some of the villages had, on its own, enforced a ban on the entry of BJP leaders within their precincts. The ban has been symbolically represented by boards and banners installed in the villages, warning BJP leaders against entry. It read, "Kisaana da dilli jaana

Preneet faces protest at Samana

Samana: BJP candidate from Patiala Preneet Kaur faced massive protests on Sunday as farmers gathered in the Samana sub-division of Patiala district to express their discontent. The incident marks the second time in a week that Preneet has faced opposition from farmers, highlighting the challenges she may encounter during her election campaign in Patiala.

Brandishing black flags and chanting slogans against both Preneet and the BJP, farmers from various unions obstructed the road outside the venue where she was scheduled to address a party event. The demonstration, which aimed to gherao Preneet, occurred as she arrived for the party's Booth Summit to release its Sankalp Patra.

Preneet, a former four-time MP from Patiala representing the Congress party and the wife of Punjab's former Chief Minister Capt Amarinder Singh, recently joined the BJP and secured the party's ticket for the Patiala constituency.

The protest, led by farmer activists from several unions including the Bhartiya Kisan Union (Krantikari) and Kirti Kisan Union, resulted in some activists being detained by the police. However, they were subsequently released after a brief road blockade. BKU (Krantikari) president in Samana block Gurnam Singh criticized Preneet's switch to the BJP, accusing her of betraying the sentiments of the people who had previously voted for her. Patiala police deployed heavy security at the venue to ensure Preneet's safety, allowing her to enter and exit amid tight security measures.

Election-related hoardings, posters, banners must have identity of printer, publisher: Mohali DEO

Mohali: Deputy Commissioner-cum-District Electoral Officer Aashika Jain on Sunday made it clear that election-related hoardings, posters, or banners must have the identity of printer and publisher. Citing the fresh guidelines issued by the Election Commission of India regarding the election-related hoardings on sites controlled or regulated by local self-government or Municipal Authorities, Jain said that the ECI has emphasized that the fundamental imperatives which underwrite the design of R P Act 1951 and the Model Code of Conduct in the cam-

paigning space, in print mode, inter-alia, are the disclosure of identity of the publisher and, thereby his responsibility of the content of the material so published. Similarly, Section 127A of the R P Act 1951 clearly prohibits publishing of election pamphlet or poster without bearing the name and publisher on the face thereof. Section 127 A (3) (b) gives a wide amplitude to the meaning of the phase "election pamphlet or poster", to include "placard or poster". Thus, any noncompliances or obfuscation of this requirement is always to be viewed seriously.

She has advised all municipal authorities or such authorities that are responsible for hoardings, posters, or banners etc for strict compliance of the orders of ECI. Besides, printers and publishers (political parties or candidates or their representatives) have also been asked to adhere to the directions of ECI, in principle.

Childhood abuse takes profound toll on victim health: Study

 $F_{ ext{endured childhood abuse}}^{ ext{or many of us who}}$ or neglect, the scars aren't just emotional — they're physical, lingering long after the traumatic events themselves. While this has been a known fact, it was not yet well understood why this risk persists many decades after the illtreatment first happened.

Now, a new study has validated the profound toll this early-life adversity takes on the health, from brains to bodies of the victim of abuse. Published in the 'Proceedings of the National Academy of Sciences', the study delved into the experiences of over 21,000 adults aged 40-70, including their histories of childhood maltreatment and their current health status.

They analysed this data from the UK Biobank along with their body mass index (BMI), C-reactive protein levels (that reveal signs of inflammation) and their experiences of childhood ill-treatment and By studying brain scans of

adults, the researchers from the University of Cambridge, UK found that there were widespread changes in the brain structure such as increased thickness and reduced volume, associated with obesity, inflammation and repeated trauma stemming from childhood ill-treatment.

These structural changes, therefore suggested physical damage inflicted on the brain cells that affected their functioning, said Professor Edward Bullmore, Department of Psychiatry, University of Cambridge, and author of the study.

"We've long known that childhood maltreatment increases the risk of mental illness. But now, with this deeper understanding of the physical changes it induces in the brain and body, we're



The overall system consisted of the MPATGM, launchers, target acquisition device and a fire control unit. The MPATG weapon system has been field evaluated in different flight configurations several times with an objective of

In agriculture, the BJP promises to continue providing annual financial assistance of Rs 6,000 to farmers, enhance crop insurance through technology and implement periodic increases in the Minimum Support Prices. It also addresses the party's commitment to implementing a uniform civil code, One Nation One Poll initiative, expansion of 5G networks, bolstering national security and abolishing waiting lists for train travel. The main rival Congress' manifesto, on the other hand,

focuses on social welfare, economic reforms and addressing inequality through targeted interventions such as healthcare expansion, agricultural support and a caste census. In contrast, the BJP emphasises national security, infrastructure development and cultural issues, with a lesser emphasis on caste-based policies and regional grievances. Nadda reiterated the commitment to fulfil all promises encapsulated in 'Modi Ki Guarantee', the BJP's slogan for the elections. Responding to the BJP's manifesto, the Congress has criticised it over alleged shortcomings. Party spokesperson Pawan Khera labelled it a 'maafinama' or apology, highlighting unfulfilled promises from previous elections. Supriya Shrinate accused the BJP of misleading the public and ignoring critical issues such as ethnic violence in Manipur and protests in Ladakh. As the mudslinging match between the arch-rivals continues, it is for the people to judge who kept promises and who did not. Manifestos are no commitment and, therefore, not legally binding. Nonetheless, these do spell out a party's ideology and the direction it wants to take the country in. As the campaign gains momentum, the debate over competing policy agendas is likely to intensify, shaping the discourse leading up to the polls. An informed voter would better not judge a party by its manifesto but by its track record.

The recent mudslinging between the TMC and BJP has highlighted a historical narrative concerning the role of the Roy family in the downfall of Bengal's Nawab Siraj-ud-Daula

ith the campaign for the 2024 Lok Sabha elections heating, mudslinging isn't left behind, although one wishes this weren't so. The Trinamool Congress has abused Smt. Amrita Roy, the BJP's KrishnanagarLok Sabha candidate, for belonging to the family of Krishna Chandra Roy, who had sided with the East India Company to take down Bengal's Nawab Siraj-ud-Daula in 1757. The current Rajmata of Krishna Nagar has justified her family's act, saying had they not done so, Sanatana Dharma and Bengali culture under the tyrannical Siraj would have ceased to exist. Moreover, Raja Krishna Chandra Roy, Amrita's forefather wasn't alone; Jagat Seth, Raja Naba Krishna Deb and above all Mir Jafar and many others wanted to see the end of Siraj-ud-Daula. Such was the ill-will he had generated.

What would have been Bengal's fate had these merchant princes not contrived to overthrow Siraj? More than likely, Nadia district and today's West Bengal might have gone to Pakistan and subsequently Bangladesh. Pakistan's first President Iskander Mirza was a direct descendant of Siraj-ud-Daula. The family lived in Murshidabad, but on the morrow of Partition, promptly migrated to Karachi, then Pakistan's capital. Iskander first became defence secretary and then Pakistan's president in March 1956.

To go back to Murshidabad, Siraj-ud-Daula came to the throne in 1756. He soon showed his colours by dismissing his chief minister RaiDurlabh, picked by his grandfather Nawab Alivardi Nawabhumiliated the wealthy state banker Jagat Seth by publicly slapping him in the durbar and threatening him with sunnat, i.e., circumcision (see Plassey to Pakistan by HumayunMirza, son of IskandarMirza). The merchant princes were resentful of the rule by people of Central Asian stock and wanted more say in governance for the local people. However, they lacked the military organisation to effect an over-throw. Come 1757, upon the



in London, Robert Clive arrived from Madras, along with some sailors and soldiers, to teach Siraj-ud-Daula a lasting lesson for humiliating the British at Fort William in Calcutta the previous year. This is where the Black Hole tragedy was perpetrated on the nawab'sorders.

The nawabate's merchant princes saw this as a rare opportunity to do away with this odious regime. British arms and Bengali money as well as contacts would ensure victory. Clive had only about 3,000 men, whereas Siraj-ud-Daula had an army of a lakh, plus a cavalry and elephants. This large army had to be truncated in numbers. Mir Jafar, who commanded half the army of the Nawab, was promised that if he helped to overthrow Siraj-ud-Daula, he would be made the Nawab. Consequently, over half of Siraj's army did not fight. The Battle of Plassey on June 23, 1757, ended the saga of Sirajud-Daula and his life.

At the time we are talking about, there were two cultures in Bengal, namely Bengali and Islamic. Since the 12th centu ry, the region had been slipping out of Bengali influence and had become two-thirds orders of the East India Arabized. The Battle of Plassey

in 1757 was the first decisive setback. After Siraj was defeated and killed and his nawabate erased, Hindus for the first time in many years could celebrate puja openly. A grand Durga Puja was held at the palace of Raja Naba Krishna Deb, where the chief guest was Robert Clive. Imagine if Bengal had remained on the Islamic track, there would have been no historic renaissance for which Bengal is justly renowned and respected. There would have been no Raja Rammohan Roy, no Bankim Chandra Chatterjee, no Rabindranath Tagore, no Ramakrishna Paramhansa and Swami Vivekananda, no Yogi Aurobindo, no Ishwar Chandra Vidyasagar and certainly no Netaji Subhas Chandra Bose. One can only imagine what this region might have become. Gopal Krishna Gokhale, more than a hundred years ago, had famously said "What Bengal thinks today, India thinks tomorrow". But if the likes of Siraj-ud-Daula had continued on the throne, there would not have been a Bengal today. Gandhi did awaken Indians to

Indian Independence Act of 1947 heralding India's independence. After relinquishing office, Atlee came to India and was a guest of the then West Bengal Governor Justice P.B. Chakraborty. During a dinner conversa-tion, Chakraborty asked his guest why the British quit Índia in a hurry in 1947, when there was no immediate cause, with the Quit India movement of 1942 having failed. The former British Prime Minister in reply quoted several reasons, principal among them being the erosion of loyalty to the British Crown among the Indian army, navy and air force, as a result of the action of Subhas Chandra Bose. Atlee's reply to Chakraborty's question on how much the non-violent satyagraha of Gandhi had influenced the British to free India, was "mi-n-i-m-a-l", with emphasis on each letter and a contemptu-

He believed that constitutional morality is not a natural sentiment rather it needs to be cultivated consciously. In contemporary times, it has become a prin-

Unlike other ideals of brotherhood, equality, fairness, non-arbitrariness, etc. which sprung from the need for pre-independent India, constitutional morality had to be injected into the bloodstream of the country. The Judiciary has brought back the discourse on constitutional morality through a slew of judgments in contemporary times. The CJI of India, D.Y. Post Independence may not have found an explicit place in the text but it is embedded in the essence of constitutionalism. It demands morality to be objective based on the prevailing dynamics of society. tional morality over majoritarian or popular morality. Constitutional morality is derived from public morality, however, slightly divorced from it and sifted through constitutional idealism.

The intersectionality of social and religious belief systems entangles it further, for instance, in the Sabarimala judgment, the debate circled between the popular socioreligious belief and the fundamental right of freedom of religion of a class of women (menstruating women) under Article 25 of the Indian Constitution, is a worthy example in this regard. Constitutional morality may also at times be at a crossroads with Jus naturale.

Euthanasia as a practice or the Right to Abortion, both were initially entrenched in belief systems to be against societal morality. It was not until the Supreme Court of India balanced the interests of the right seekers and the opposers, allowing both the above practices in a judicially permissible manner, that it found its acceptance.

SPIRITUAL SOLUTION TO CLIMATE CHANGE

Limiting procreation is perhaps the most significant step towards sustainability



oday the world that we live in, people are-trying to do small, small good things, so that we can conveniently escape away from the fact that there is something humongously evil that we are doing. Most people are habituated towards consumption, it is not consumption per se that is the problem; it is the mad and blind consumption of stuff that is anyway not going to do you any good. That's the problem. So, wisdom or spiritual wisdom is not about the renunciation of consumption altogether. There are signs which clearly show the impact of various activities on climate change. For example: going car-free, avoiding transatlantic flight; choosing green energy; switching from an electric car to car-free; choosing a vegan diet; replacing a typical car with a hybrid; washing clothes in cold water rather than hot water; recycling; hanging dry clothes; upgrading to energy-efficient light bulbs. And the title of the graphic is 'Tonnes of CO2 equivalent saved per year for one person undertaking each action' (Wynes & Nicholas, 2017; Environmental Research Letters, Volume 12, Number 7). But these are 10 activities that are popular where all the do-gooders are busy doing all these ten activities and they walk around with great missionary zeal and even greater missionary pride.

And then there is this huge bar that corresponds to around sixty tonnes of CO2 which comes from doing a single action — which is, having one child. We don't talk about the largest contributor to climate change because this is where our ego lives, this is where the physical and bodily tendencies live. You must be wondering why I am speaking about this thing regarding procreation, regarding having kids. It's because this is the single most important issue facing you and me and the planet



and the millions of species today. This is the one thing that man immediately needs to address at this moment. There is no greater challenge in front of mankind — not the Third World War, not nuclear proliferation, nothing at all. This is the biggest challenge. Can you please either stop or limit having babies? This is the one challenge that nobody wants to talk about. If you can address this, then everything will be addressed. For every urge for development, you will see linkages between body identification, consumption, procreation and followed by devastation. When the global temperatures rise by three degrees or four degrees, all these baby flowers will wilt. Anyway, not too many species of flowers are going to remain to be planted. How much is climate change to blame? It affects at least 10,967 species on the IUCN Red List and projections suggest that if global temperatures increase by 2°C by 2100, about 18 per cent of all species on land will face a high risk of going extinct.

And this cannot be addressed merely by way of litigation. You require a spiritual movement; you require a deeply spiritual consciousness to understand what I am saying and act on what I am pointing to. You cannot limit the number of kids without first putting an end to this bodyidentification. As long as your material body is there, you will continue to consume, you will have to consume. We do not see the linkage between body-identification, consumption, procreation and devastation; we look at them as different things. This urge for development — what do you think, it has nothing to do with the devastation of this planet? What is exactly the definition of development? That which brings pleasure to you; that which brings comfort and convenience to you, right? That's how you define development. In the history of mankind, the time has come when without addressing that root problem, you cannot address any of the problems. And if you do not address the root problem now, there is going to be no tomorrow.

Income inequalities hamper sustainable growth-



While the nation's GDP is poised to surge by 7.6 per cent in the current financial year, concerns loom large over the sluggish pace of private consumption



uring the current financial year, the Indian economy is expected to register a growth of 7.6 per cent in real gross domestic product or GDP. Coming on top of growth of 9.1 per cent during 2021-22 and 7.2 per cent during 2022-23, India's performance is spectacular. Emboldened by this trend and Modi's commitment to pursue economic reforms with greater vigour during its third term, analysts are hoping for growth of above 7 per cent on a sustainable basis. But, there

Private consumption which accounts for as much as 55 per cent of the Indian economy has acted as a major drag. For instance, during FY 2023-24, it is expected to grow by a meagre 3 per cent (even lower than 4.4 per cent as given in the first advance estimate). This is the slowest growth in private consumption since FY 2002-03 when growth was 2.9 per cent. It is impossible to sustain an overall GDP growth of 7-8 per cent in the years to come if the most important component (read: private consumption) is growing at less than half this rate.

What is private consumption?

Apart from essential consumption items such as food, shelter, clothing, education, health etc, it includes spending by people on a host of discretionary items such as consumer durables viz. ACs, refrigerators, washing machines, TVs, automobiles, mobiles and so on. The demand for these goods depends on the 'purchasing power' of the people at large which requires that at least all working-age persons (18 years to 60 years) have adequate incomes. This brings us to another stark reality namely the distribution of income and wealth.

Where does India stand? According to a report 'Time to Care' by Oxfam that came ahead of the Annual Meeting of the World Economic Forum (WEF) held in January 2020 'India's richest one per cent hold more than four times the wealth held by 953 million people who make up for the bottom 70 per cent of the population". It also showed that there were a total of 63 Indian billionaires (billionaire is a term used to describe a person having wealth over US\$ one billion) and their combined total wealth was higher than

Another Oxfam report, "Inequality Kills", released ahead of the WEF meeting held in early 2022, mentioned that the number of Indian billionaires grew to 102 by March 2020 and further to 142 in November 2021. During this period, their wealth increased from Rs 2300,000 crore to Rs 5300,000 crore. At the same time, the income of 84 per cent of households declined and the share of the bot-tom half of the population in national wealth was a mere six per

Meanwhile, a report titled 'Survival of the Richest' released by Oxfam International at the 2023 annual meeting of the WEF in Davos, Switzerland, says that 'the wealthiest one per cent of individuals in India possess over 40 per cent of the nation's total wealth. Juxtapose this with the bottom half of the population getting a mere six per cent of the nation's wealth, we end up with glaring inequalities.

now does it impact demand? Let us look at India's population of around 140 crore and nominal GDP of about Rs 300,00,000 crore. Apply Oxfam percentages to these

The wealthiest one per cent or 1.4 crore individuals have 40 per cent of GDP or Rs 120,00,000 crore whereas a vast 50 per cent of the population or 70 crore individuals have a mere 6 per cent of GDP or Rs 18,00,000 crore. On per per-person basis, those in the wealthiest category have annual purchasing power (PP) of Rs 85 lakh each whereas others in the bottom 50 per cent have a PP of a mere Rs 25,000 each.

Such an income distribution pattern is far from conducive to boosting demand on a sustainable basis. There are inherent limits to how much a wealthy person can buy. On the other hand, if a good portion of the money with him is

distributed among those who are not so blessed (read: the bottom 50 per cent), this would give a big

boost to private consumption. We hear loud voices from various quarters including from industries and businesses asking the Government to formulate policies, reduce taxes even give direct income support. But, there isn't even a whisper of 'why inequalities in income arise in the first place. An analysis of the financials of India's largest companies—those comprising the BSE 500 index gives us some clues.

The profits of corporations included in this index went up from Rs 480,000 crore during FY 2017-18 to more than Rs 1000,000 crore during FY 2021-22 - an increase of over 100 per cent, whereas their revenue growth was only 47 per cent during this period. This means that payments to factors of production other than the owners of capital (read: shareholders) such as to employees/workers, purchase of inputs, interest payments, etc., nave been kept under a tight leash, resulting in a disproportionate boost to profits.

The aggregate dividend paid by these firms increased from Rs 176,000 crore during FY 2017-18 to Rs 302,000 crore during FY 2021-22, which is an increase of 72 per cent. In each of the last five years, they paid at least 30 per cent of aggregate net profit as dividends. Cumulatively, the companies distributed 34 per cent of profits as dividends. This is an unusually high payout ratio even higher than 30 per cent paid by the world's largest companies included in America's S&P 500. Thus, the companies have done little to reinvest the profits

Whether profits, albeit extraordinary, to the company or high dividends to shareholders, they have been paid for or come at the cost

1000,000 crore profits of firms in the BSE 500 index during FY 2021-22 came at the cost of undermining the purchasing power of millions of consumers. If even 50 per cent of this amount or Rs 500,000 crore had remained with the latter, aggregate demand would have gone up manifolds. Likewise, look at the Rs 302,000 crore dividend paid to shareholders during FY 2021-22. An overwhelming share of this went to the promoters and other minority shareholders. If, instead of filling their coffers-the money that merely adds to their cash balances or is spent on a few

discretionary/luxury items-more of it were to be distributed in higher salaries to their employees, particularly at the lower rung, imagine what it would do to demand. Several businesses enjoy pricing power. For instance, those operating in metals such as copper and zinc, or in hydrocarbons like oil and gas, enjoy a natural monopoly. Leveraging this, they charge high prices, resulting in windfall gains for themselves. Enterprises in the chemical, petrochemicals, pharmaceutical and agrochemical sectors have hugely benefited from a pro-

tective policy environment. Over 60 million small and medium enterprises (SMEs) also ape large enterprises when it comes to distributing the wealth generated. Their owners spend the least on payments to workers. To conclude, all businesses are structured to result in the concentration of income in the hands of their owners or those who wield power and influence. Instead of deflecting the ball to the Government, they need to bring about a fundamental change in the way they operate. They need to shed over zealousness for profits, charge less from consumers, distribute more to workers and pay more taxes.

Israel hails 'success' in blocking Iran's unprecedented attack

srael on Sunday hailed its air Israel on Sunuay named and defences in the face of an and the law Iran unprecedented attack by Iran, saying the systems thwarted 99 per cent of the more than 300 drones and missiles launched toward its territory.

Regional tensions were high amid fears of an Israeli counter-strike that could fuel further escalation. US President Joe Biden said he would convene a meeting Sunday of the Group of Seven advanced democracies "to coordinate a united diplomatic response to Iran's brazen attack." The US made clear it would not participate in any offensive action against Iran.

"We don't seek a war with Iran. We're not looking for escalation here," White House national security spokesman John Kirby told NBC.

Iran launched the attack in response to a strike widely blamed on Israel that hit an Iranian consular building in Syria earlier this month and killed two Iranian generals. Israel said Iran launched 170 drones, more than 30 cruise missiles and more than 120 ballistic missiles.

By Sunday morning, Iran said the attack was over, and Israel reopened its airspace. "We will build a regional

from Iran, in the way and at the time that suits us," said a key member of Israel's War Cabinet, Benny Gantz. The two foes have for years been engaged in a shadow war marked by attacks such as the Damascus strike. But Sunday's assault, which set off air-raid sirens across Israel, was the first time Iran has launched a direct military assault on Israel, despite decades of enmity dating back to the country's 1979 Islamic Revolution.

Israel has over the years established — often with the help of the United States — a multilayered air-defence network that includes systems capable of intercepting a variety of threats, including longrange missiles, cruise missiles. drones and short-range rockets.

National Security Council spokesperson Adrienne Watson said in a Saturday statement that "Iran has begun an airborne attack against Israel." She added: "The United States will stand with the people of Israel and support their defense against these threats from Iran.

Biden on Friday said the United States was "devoted" to defending Israel and that "Iran will not succeed." Asked by reporters what his message was for Iran, the president's only reply was: "Don't." He ignored a question about

what would trigger a direct US military response, and when asked how imminent an Iranian attack on Israel was, Biden said he did not want to get into secure information. "but my expectation is sooner than later.'

The US, along with its allies, have sent direct messages to Tehran to warn against further escalating the conflict.

New South Wales Police said that Joel Cauchi, 40, was responsible for the Saturday afternoon attack at the Westfield Shopping Centre in Bondi Junction, in the city's eastern suburbs and not far from the world-famous Bondi Beach.

Assistant Police NSW Commissioner Anthony Cooke told reporters at a media conference on Sunday that Cauchi suffered from yet unspecified mental health issues and police investigators weren't treating the attack as terrorism-related. We are continuing to work

through the profiling of the offender but very clearly to us at this stage, it would appear that this is related to the mental health of the individual involved," Cooke said.

'There is still, to this point... no information we have received, no evidence we have recovered.

Other footage showed a man confronting the attacker on an escalator in the shopping center by holding what appeared to be a metal pole. Inspector Amy Scott, who was

the first emergency responder on the scene, shot and killed Cauchi.

Speaking to reporters on Sunday, Prime Minister Anthony Albanese said the officer was "certainly a hero" whose actions had saved many more lives.

It has increasingly used satellite-guided glid-ing bombs — dropped from planes from a safe distance — and ammunition.

Sudan war: Aid groups warn of mass death from hunger

On a clear night a year ago, a dozen heavily armed fighters broke into Omaima Farouq's house in an upscale neighborhood in the Sudanese capital of Khartoum. At gunpoint, they whipped and slapped the woman, and terrorized her children. Then they expelled them from the fenced two-story house.

"Since then, our life has been ruined," said the 45-year-old schoolteacher. "Everything has changed in this year.

Farouq, who is a widow, and her four children now live in a small village outside the central city of Wad Madani, 136 kilometers (85 miles) southeast of Khartoum. They depend on aid from villagers and philanthropists since international aid groups can't reach the village. Sudan has been torn by war for a year now, ever since

simmering tensions between its military and the notorious paramilitary Rapid Support Forces exploded into street clashes in the capital Khartoum in mid-April 2023. The fighting rapidly spread across the The conflict has been over-

shadowed by the war between Israel and Hamas in Gaza Strip, which since October has caused a massive humanitarian crisis for Palestinians and a threat of famine in the territory. But relief workers warn Sudan is hurtling towards an even larger-scale calamity of starvation, with potential mass death in coming months. Food production and distribution networks have broken down and aid agencies are unable to reach the worst-stricken regions. At the same time, the

conflict has brought wide-

spread reports of atrocities

including killings, displace-

ment and rape, particularly in the area of the capital and the western region of Darfur. Justin Brady, head of the UN

humanitarian coordination office for Sudan, warned that potentially tens or even hundreds of thousands could die in coming months from malnutrition-related causes.

This is going to get very ugly very quickly unless we can overcome both the resource challenges and the access challenges," Brady said. The world, he said, needs to take fast action to pressure the two sides for a stop in fighting and raise funds for the UN humanitarian effort.

But the international community has paid little attention. The UN humanitarian campaign needs some \$2.7 billion this year to get food, heath care and other supplies to 24 million people in Sudan – nearly half its population of 51 million. So far, funders have given only \$145 million, about 5%, according to the humanitarian office, known as OCHA. The "level of international

neglect is shocking," Christos Christou, president of the medical charity Doctors Without Borders, or MSF, said in a recent statement. The situation in fighting on the

ground has been deteriorating. The military, headed by Gen Abdel-Fattah Burhan, and the commanded by Gen Mohammed Hamdan Dagalo, have carved up Khartoum and trade indiscriminate fire at each other. RSF forces have overrun much of Darfur, while Burhan has moved the government and his headquarters to the Red Sea

city of Port Sudan. The situation has been horrific in Darfur, where the RSF and its allies are accused of rampant sexual violence and ethnic attacks on African tribes' areas. The International Criminal

Court said it was investigating fresh allegations of war crimes and crimes against humanity in the region, which was the scene of genocidal war in the 2000s. A series of attacks by the RSF and allied militias on the ethnic African Masalit tribe killed between 10,000 and 15,000 people in Geneina, the capital of West Darfur near the Chad border, according to a report by United Nations experts to the Security Council earlier this year. It said Darfur is experiencing "its worst violence since

With aid groups unable to reach Darfur's camps for displaced people, eight out of every 10 families in the camps eat only one meal a day, said Adam Rijal, the spokesman for the Coordination for Displaced Persons and Refugees in Darfur.

In Kelma camp in South Darfur province, he said an

average of nearly three children die every 12 hours, most due to diseases related to malnutrition. He said the medical center in the camp receives between 14 and 18 cases of malnutrition every day, mostly children and pregnant women.

Not including the Geneina killings, the war has killed at least 14,600 people across Sudan and created the world's largest displacement crisis, according to the United Nations. More than 8 million people have been driven from their homes, fleeing either to safer areas inside Sudan or to neighboring countries.

arkinson's Disease (PD) is one of the most common movement disorders, affecting individuals over the age of 60. The number of PD cases worldwide has significantly increased in the last two decades, with 0.58 million people affected in India alone. This number is expected to rise in the coming decades. PD, along with multiple sclerosis and chronic neurological illnesses, is now recognized as a disability under the recently passed Rights of Persons with Disabilities Act of 2016.

Yet, misconceptions surrounding this condition persist, hindering support and understanding, said Dr. Debasish Chaudhary, Head of Department of Neurology, GB Pant Hospital, Delhi Below are some of the myths surrounding this progressive neurological condition.

MYTH 1: PD is Untreatable

Fact: Although there is no cure, many treatments exist to manage symptoms and improve the quality of life. Medications, therapies like physical or speech therapy, and surgical options like deep brain stimulation can help. With proper management, many individuals can lead active lives.

MYTH 2: PD Affects the Elderly Only.

Fact: Although PD is commonly diagnosed in older adults, it can affect people of any age, including younger adults and children. Early-onset Parkinson's, diagnosed before the age of 50, is significant. Recognizing this variability in the age of onset is crucial for timely diagnosis and intervention.

MYTH 3: PD is Just a Movement Disorder

Fact: While movement difficulties like tremors, stiffness, and slowness are hallmark symptoms, Parkinson's is a complex condition with diverse symptoms. These include cognitive changes, mood swings, sleep problems, and gastrointestinal issues. Understanding this complexity is vital

MYTH 4: PD is Always Hereditary Fact: While genetics can contribute, most cases are sporadic with no clear genetic link. Environmental factors like toxin exposure may also play a role. Recognizing that not all cases are

hereditary, and anyone can be affected, is essential.

MYTH 5: PD is a Death Sentence Fact: While chronic and progressive,

Parkinson's isn't necessarily lifethreatening. With proper care and lifestyle adjustments, many individuals can live decades after diagnosis. Support from healthcare professionals and caregivers is

Tough Fight Which Needs To Be Done Right

It was early 2017. I was buying a bottle of perfume from a Delhi shop, when I noticed something odd. I tried to smell the ittar. But all I drew through my nostrils was a blank. "Is it very mild?," I asked the shopkeeper. "No ma'am," he replied, surprised.
"You cannot smell it at all?" I told him probably I have a blocked nose, but had niggling doubts in my head.

A few months later, the junior doctor at a reputed neurological institute in Bangalore, filling up a long questionnaire, enquired, "can you smell"?

Í was there to confirm my diagnosis as a patient of Parkinson's Disease, the degenerative disorder that causes tremors, rigidity of muscles and movement problems, a few of which I was already experiencing. Doctors in my workplace Delhi and hometown Kolkata had told me I fall in the category of "Early Onset" patients (as PD is common

among the elderly, but I was 39 then). They wanted me to start treatment, but I was hoping to get another opinion.

"No, I cannot smell, is it related to my condition," I asked the doctor. Yes, she said. It is a common symptom.

Of course, though it explains how widespread the effect of PD is, loss of smell is only a minor part of the life-changing issues brought by the disease. Walking, sleeping, working, doing simple everyday chores – it turns simple things into a battle.

years were somehow Initial manageable, but now, after seven years, I am facing a range of problems related to PD, including frequent falls, resultant fear of falling, which is damaging my confidence to go out and freezing - when you are unable to take a step for several seconds while walking. The first years were also easier in terms of keeping the disease under check medication. But now, much of my average day witnesses "offperiods" - when PD symptoms return due to effects of medicine wearing off. Life is increasingly

becoming difficult.
Though there are times of despair, Though there are times of despair, I don't want to give up hope. Yet, amidst despair, hope persists. Sound medical guidance, daily routines, and practices like yoga and meditation provide solace. Support groups offer invaluable camaraderie, despite their scarcity in India Reports of new research. in India. Reports of new research fuel optimism, while options like Deep Brain Stimulation (DBS) surgery loom as potential paths

My takeaway from life after PD? Despite the struggles, kindness abounds. From strangers to healthcare professionals, countless individuals have extended a helping hand along this journey, reminding me that even in the face of adversity, compassion prevails.

YOUNG ONSET PD

Dr Madhukar Bhardwaj, Senior Consultant and HOD, Neurology, Aakash Healthcare, talked about YOPD or Young Onset Parkinson Disease which affects individuals less than 40 years of age.

He said that YOPD usually presents with symptom/symptoms such as one sided hand tremors, slowness, postural imbalance or one sided weakness involving hand and leg. It is important to detect this since it is initially usually taken as stroke or other forms of tremors and goes undetected until a full florid form appears in a few months to years. It usually responds well to dopaminergic drugs, however in my experience the dose requirements increase over a period of time.

"These patients also go on to develop more drug induced adverse effects like dyskinesias and anxiety issues. Detailed history and Neuroimaging is important to rule out mimics. "In rare cases, it may be familial, and careful family tree must be established along with genetic testing (PARKIN gene) if a family member was found to have the symptoms at an early juvenile

IDENTIFYING SYMPTOMS

Dr. Atampreet Singh, Director of the Department of Neurology at Fortis Hospital Greater Noida, emphasized on the importance of recognizing common symptoms associated with PD in elders. These include tremors, muscle stiffness, slowed movement, and balance and coordination difficulties, which can increase the risk of falls. Dr Singh said that while there is no cure for Parkinson's, symptom management is crucial. "Treatment modalities include medications to control dopamine levels, physiotherapy to improve mobility, and, in select cases, surgical interventions such as deep brain stimulation (DBS)."

In fact, some neurologists said that therapy that holds the potential rescue to significantly enhance the quality of life for people grappling with PD.

MANAGEMENT

Dr. Praween Kumar, CEO of Fortis Hospital Greater Noida, underscored the significance of combining medical interventions with positive lifestyle changes. "Individuals with PDs can lead fulfilling and active lives by incorporating consistent physical activity, a well-rounded diet, sufficient rest, stress management, and nurturing social connections. Despite the gravity of the condition, PD should not diminish life quality," pointed out Dr Kumar.

HOPE ON THE HORIZON

IIT-M WORKS ON DBS

The Indian Institute of Technology-Madras (IIT-M) is working on an indigenous prototype of deep brain stimulation (DBS), a pinhole surgery method to place an surgery method to place an implant to control conditions (PD), an under-diagnosed disorder in India. The DBS is a modifiable and reversible procedure with a physical remote to help customize the patient's condition.

The DBS procedure is not complicated and costs around Rs 10 lakh to Rs 20 lakh as the equipment is only available in western countries, and the implant cost is not covered by Chief Minister's Comprehensive Health Insurance Scheme (CMCHIS). IIT-M is developing an indigenous prototype to make this therapy accessible to everyone, but the design may take five to 10 years to complete owing to elaborate safety procedures, said a

Study Uncovers Key Genes Behind Parkinson's in Young Indians

A team of scientists has identified key genes that raise the risk of Parkinson's disease in young Indians.

The team, led by Parkinson's Research Alliance of India (PRAI) and MedGenome, a global genomics company in South Asia, made a comprehensive analysis of rare and common genetic variations in the young Indian population, understanding of the genetic basis of Parkinson's disease.

This also opens the door for a firstever genetic screening in India for the disease in high-risk individuals and affected families, said the team of scientists in the paper published in the prestigious Movement Disorders.

"Parkinson's is not a single gene disease. It can occur due to multiple genetic mutations and multiple gene causes. Knowing what patients with Indian patients will have more impact on understanding and treatment of that," Dr. Prashanth L.K., a specialist in movement disorders from PRAI said.

According to the Global Burden of Disease Study (2018), Parkinson's has doubled across the globe over the past two decades, while India accounts for approximately 10 per cent of the global burden. This translates to nearly 0.58 million patients living with the disease in the country. first-of-its-kind study

conducted in India included 1,000 specialty Movement Disorder enters/Neurology clinics across Dr. Prashanth said the team found a

high probability of non-mutation and Parkinson's mutations are quite common in Indian patients. "We need to work on these genes

further to see how these genes can be important for the occurrence of Parkinson's disease in patients," he

Further, the expert noted that Indian patients carry a lot of BSN gene mutations. The BSN gene primarily affects gait and balance for people and is normally not reported in Parkinson's.


