

A "virtual" confrontation between the Centre and USbased tech giant Apple escalated on Wednesday after the Government agencies issued a 'high risk" warning for users of Apple's iPhones, MacBooks, iPads and Vision Pro headsets highlighting a critical vulnerability, identified in connection to "remote code execution" in various Apple

Emergency Response Team (CERT-In) has issued a high severity warning for users of Apple products in India. The agency has vulnerabilities that could allow hackers to access

information on a user's device. This year a massive controversy erupted after some Opposition leaders claimed that they had received a message from Apple that the users iPhone could become a victim of State sponsored hackers which the Government

rejected and a related probe is underway.

### HC reserves order on plea by Kejriwal

NEW DELHI: The Delhi High Court on Wednesday reserved its verdict on a petition by Chief Minister Arvind Kejriwal challenging arrest by Enforcement Directorate in a money-laundering case linked to the alleged excise policy scam. "I am going to reserve judgement," said Justice Swarana Kanta Sharma after hearing the senior counsel appearing for the AAP leader as well as the agency. The AAP national convener, who arrested by the ED on March 21, questioned the "timing" of his arrest and said it was in contravention of the basic structure Constitution, including free and fair elections and level playing field.

## Cloudy skies likely in Delhi

NEW DELHI: Delhi recorded a minimum temperature of 17.3 degrees Celsius on Wednesday morning, with the weather office predicting light rain in parts of the city.

Gusty winds with a speed of 30-40 kmph are likely in the city and the maximum temperature will touch 35 degrees Celsius. For Thursday, the weather office has forecast generally cloudy skies with the maximum and minimum temperatures likely to settle at 35 and 18 degrees Celsius, respectively. The humidity level was recorded at 63 per cent. The air quality in the city stood in the moderate category with an AQI reading of 155. An AQI between zero and 50 is considered good, 51 and 100 satisfactory, 101 and 200 moderate, 201 and 300 poor, 301 and 400 very poor, and 401 and 500 severe.

# **EC** bolsters border security ahead of Lok Sabha elections

With the first round of Lok Sabha elections due within a fortnight time, the Election Commission (EC) on Wednesday directed the State authorities to initiate strict vigil along international borders like India-China, India-Nepal, India-Pakistan in close coordination with security agencies like Border Security Force (BSF), Assam Rifles (AR), Sashastra Seema Bal (SSB), Indo Tibetan Border Police (ITBP) Coast Guard and intelligence wings of Intelligence Bureau and external intelligence

agency.
The Commission has directed Central agencies to strict vigil along Indo-Myanmar border by Assam Rifles; Indo Nepal Border by SSB especially in areas having porous border with Nepal; Indo-Bangladesh border and western

borders by BSF; Indo-China border by ITBP, and in States with coastal area by Indian Coast Guard. These directions came after the EC meeting with all States/Union Territories (UTs) to review and assess the law and order situation, prevention of illicit activities, seizures and strict vigil across inter-State and borders in the international ongoing Lok Sabha and State Legislative Assemblies polls for a free, fair, peaceful and inducement free elections.

India shares borders with Pakistan, Nepal, Bangladesh and China. Nepal shares a border of over 1,850 km with five Indian States — Sikkim, West Bengal, Bihar, Uttar Pradesh and Bihar, Uttarakhand. Myanmar border shares a border of 1,643 km in length and runs from the tripoint with China in the north to the tripoint with Bangladesh in the said.

Bangladesh shares a 4,096kilometre-long international border, the fifth-longest land border in the world. India and China share a 3,800 km (2,400 mile) border — much of it poorly demarcated - over which they also fought a bloody war in while Pakistan shares 3,323 km. Recent violence and turmoil in Manipur and its ramifications for the conduct of a peaceful election were also addressed, with the EC urging for swift action to assist internally-displaced persons and ensure their participation in the electoral process, the EC said.

The purpose of the combined review was to bring all concerned stakeholders together on the same platform for a seamless coordination and cooperation amongst officials of the neighbouring States/UTs along with central agencies guarding the borders. The commission, in detail, reviewed critical issues pertaining to each State/UT," the EC said in a statement.

The commission has directed SSB to keep strict watch over international borders with Nepal and Bangladesh for any illicit activity, especially before 72 hours of the poll. The poll body has also directed Assam Rifles to hold regular joint security coordination meetings with State Police, Central Armed Police Force "Ensure area familiarisation for newly inducted CAPF companies in coordination with civil administration and establish Joint Check Posts in coordination with State Police," it

# Cooch Behar braces up for Modi, Mamata rallies

Pven as Cooch Behar in North Bengal braced up for two back-to-back rallies of Prime Minister Narendra Modi and Chief Minister Mamata Bassal Minister Mamata Banerjee, another political stalwart from the State Adhir Chowdhury, the Pradesh Congress president, said the Left-Congress was fast coming up as a "third force" in Bengal "offering the people with a third option." Modi is likely to campaign from junior Home Minister Nisith Pramanik at Rash Leela Ground in this small princely town once ruled by the Maharaja of Cooch Behar and the ancestor of Maharani Gayitri Devi who was later married off to a prince of Rajasthan.

This, whereas the Chief Minister's rally will precede that of the Prime Minister's, sources in the administration said



adding Modi's meeting is slated at 3 pm. This is the first rally of the Prime Minister in Bengal after the elections were declared. Cooch Behar has become a prestige constituency and a hotbed TMC-BJP clashes. Both Pramanik and local TMC MLA from Dinhata - a subdivisional town in Cooch Behar and State minister — Udayan Guha have been involved in verbal exchange of words often causing the TMC-BJP clashes even in the presence of the two

Guha has apparently been entrusted by the Chief Minister to win Cooch Behar back for the TMC which has nominated Jagdish Basunia a Rajbangshi candidate and an MLA.

Once a Left stronghold from 1977 to 2009 Cooch Behar was won by the TMC in 2009 and (by-elections). Subsequently it went into the hands of the BJP when Pramanik — who had left the TMC to join the saffron party won the seat in 2019. Meanwhile, PCC president

Wednesday iterated that the Left and the Congress would jointly come up as a third force in Bengal. #### **SDPI** offers support to Congress led **UDF** in Kerala

 $\Gamma$ he Social Democratic Party of India (SDPI), the political outfit launched by the banned Popular Front of Índia, announced on Tuesday that it would offer unconditional support to the Congress-led UDF in the Lok Sabha election.

This was disclosed by Ashraf Moulavi, president of the SDPI while addressing the media on Tuesday. "There was no discussion between the UDF and the SDPI in this regard. Our party is of the view that the Congress is the only political party in India which could take in Hindutva and that is the reason why we took a decision like this," said Moulavi.

He said in the all India level, it is Congress which is leading battle against the Hindutva forces that include the RSS and the BJP. Even the CPI(M), the ruling party in Kerala is a constituent of the Congress-led INDIA alliance in the national level, said the SDPI chief.

The SDPI has emerged as a strong political group despite the ban on PFI. But the party may not be able to score seats on its own if contested separately and chances are that the anti-BJP votes would get split.

The Congress, which was caught in a Catch-22 position following the public announcement by the SDPI, chose not to react to the decision. M M Hassan, the president of the KPCC, told reporters that there was nothing surprising in the SDPI's declaration. "It is for them to take a decision regarding the support to be extended to any political parties. We have not approached them with request to help us," said

iPad Pro 11-inch, iPad Air, iPad, and iPad mini are susceptible if their devices are running iOS and iPadOS versions prior to 17.4.1.

Additionally, iPhone iPhone 8 Plus, iPhone X, iPad 5th generation, iPad Pro 9.7inch, and iPad Pro 12.9-inch 1st generation users are at risk if their devices are not updated to iOS and iPadOS versions 16.7.7 or later.

MacBook users are also urged to update their systems, with macOS Ventura versions prior to 13.6.6 and macOS Sonoma versions prior to 14.4.1 being vulnerable. Moreover, users of the Apple Vision Pro headset should take note of the vulnerability in visionOS versions prior to

# Court reserves verdict on Kejriwal plea against ED arrest

The Delhi High Court on Wednesday reserved its verdict on Chief Minister Arvind Kejriwal's plea seeking immediate release from the custody of the Enforcement Directorate in the liquorgate policy scam case. Justice Swarana Kanta Sharma reserved verdict on Kejriwal's petition challenging his arrest and

subsequent remand to the ED in immunity the case till March 28 after hearing elections. both the sides at length.

During the arguments, Senior advocate Dr Abhishek Manu Singhvi, who appeared for Kejriwal, said, "This case reeks of timing issues which ensures that Kejriwal is unable to participate in democratic activity and to try to disintegrate the AAP before the first vote is cast." During the hearing in the Delhi high court, additional solicitor general (ASG) SV Raju, argued on behalf of ED saying that Kejriwal has "so much influence and has copies of chargesheets, relied and unrelied documents".

The ASG resorted to clever word play using Kejriwal's party name, AAP to argue that everybody has to be treated equally and someone who loots the country cannot claim

'Aam aadmi has to go behind bars if he has committed a crime but because you are a Chief Minister vou can't be arrested? You will loot the country but no one can touch you because the elections are coming?" the ASG asked.

In response to Kejriwal's argument that the arrest was politically motivated in view of the Lok Sabha elections, the ASG said,

'Take a case of terrorist who is also a politician. He blows up army vehicle and says I want to contest elections so you can't touch me? What kind of argument is this," the ASG asked.

He further said that whether the statements made by witnesses against Kejriwal are true or not is a

matter of trial.
"Whether the statements are to be



believed or not to be believed is a matter of trial. The Court cannot substitute itself in the place of the officer. statements of witnesses... there are statements to show that outsiders were involved from the drafting of

submitted.

Notably the ASG also said that a person responsible for the affairs of the party would be liable and his personal role might not be relevant. 'Forget his role, role is not required to be looked at. What is required to be looked at is that he was

responsible for the affairs of the witnesses while "turning company/party."

'We have demonstrated that Arvind Kejriwal was responsible for the affairs of company (AAP) at the time when the offence of money laundering was committed. Tomorrow if we feel that others were also responsible for it, we will make them responsible as well," the ASG said.

Seeking the relief of Kerjiwal's release, senior advocate Abhishek Singhvi contended there was no necessity to arrest the AAP politician in violation of the provisions of the Prevention of Money Laundering Act a year and a half after the probe was initiated by ED in August 2022.

# Home Ministry of five NGOs

Home Ministry has cancelled the registration of five NGOs for alleged violation of various provisions of the Foreign Contribution

Regulation Act (FCRA).
The NGOs whose registrations have been cancelled are CNI Synodical Board of Social Service, Voluntary Health Association of India, Indo-Global Social Service Society, Church's Auxiliary for Social Action, and Evangelical Action, and Evangelical Fellowship of India, it was

With the cancellation of their Foreign Contribution
Regulation Act (FCRA)
registration, these NGOs will
no longer be able to receive foreign contributions nor utilise the existing available

Sources said the home ministry cancelled the FCRA registration of the NGOs for allegedly utilising funds for works that were not in their mandate. The NGOs violated the laws by being involved in activities that are contrary to the provisions of the FCRA,

There were 16,301 NGOs with valid FCRA licences as on July 17, 2023. The Centre has cancelled the FCRA licences of last five years for violation of the law. Óverall, FCRA licences of 20,693 NGOs have been cancelled in the last decade.

According to data disclosed in Parliament last year, Rs 55,741.51 crore was received in



contributions by FCRA-registered associations or NGOs between the 2019-2020 and the 2021-2022 financial years.
The Centre has tightened the

FCRA since 2020 by making several amendments and even cancelling licences of various NGOs, including Rajiv Gandhi Foundation (RGF), Rajiv Gandhi Charitable Trust (RGCT), and Centre for Policy Research (CPR), in the last few years accusing them of violating the law

The FCRA unit of the MHA carried out inspections or audits of at least 335 NGOs and associations registered or granted prior permission under FCRA between 2019 and 2022 to see if foreign funding rules were being followed by them.

The FCRA Act, which was amended in September 2020, barred public servants from receiving foreign funding and every office-bearer of the

The amended law also bars organisations from using more than 20% of foreign funds for administrative purposes. The limit was hitherto 50%

# Two variants of lumpy skin disease virus caused outbreak: Study

distinct virulent I variants of the Lumpy Skin Disease Virus (LSDV) were responsible catastrophic outbreak of lumpy skin disease that swept among the livestock in India, claiming approximately 1,00,000 cows across the country in 2022, scientists from the Bengaluru-based Indian Institute of Science (IISc) have revealed in a study. The outbreak had severely affected India's agricultural sector, leading to staggering economic losses. "It was a calamity in some ways ... a national emergency," said Utpal Tatu, Professor in the Department of Biochemistry, Indian Institute of Science (IISc) who was part of the multi-institutional team that decided to probe the cause of

the outbreak. These variants, characterized by a high number of genetic variations, are associated with increased disease severity, said the study, underscoring the critical role of genomic analysis in understanding and combating emerging infectious diseases affecting livestock.

The study is published in BMC Genomics. A viral infection caused by the Lumpy Skin Disease Virus (LSDV), the disease is transmitted by like flies and mosquitoes. It causes fever and skin nodules, and can be fatal for cattle. There have been two major outbreaks of this disease in India, the first in 2019 and a more severe outbreak in 2022, infecting more than two million cows.

To investigate the current outbreak, the team collected advanced

The genomic analysis revealed two distinct LSDV variants circulating in India, one with a low number of genetic variations and another with a high number of variations, similar to strains from a 2015 Russian outbreak. Kumar noted the surprising finding of highly varied LSDV strains in India, given the generally stable nature of DNA viruses like LSDV. The team identified efficiently. over 1,800 genetic variations, including deletions, insertions, and single-letter changes in DNA. The samples with high variations, however, turned out to be similar to LSDV strains from an outbreak in

explained Ankeet Kumar, from IISc and co-lead author. "Data previous reports of such highly varied LSDV strains in India. was also limited, so we compiled all available global Viruses that have DNA as the LSDV genome sequences to make our analysis robust." genetic material - like LSDV are generally more stable than RNA viruses. Therefore, finding so many genetic variations was quite surprising, and could explain the severity of the disease, he added. The variation was as high as 1,800. #### Air turbulence

Vistara faces flight disruptions due to crew shortage; DGCA demands daily updates

■light operations of Tata Group's Vistara Airlines, which has earned a reputation for its premium services and reliability in the Indian aviation sector, have of late been marred by cancellations and delays. Vistara, a joint venture between Tata Sons and Singapore Airlines, has attributed the disruptions to a shortage of flight crew. Passengers have been left stranded and inconvenienced, with some facing difficulties in rebooking their travel plans at short notice. Vistara's troubles come at a time when the aviation sector is recovering from the impact of the pandemic, with domestic travel demand showing signs of revival. The airline industry has been navigating a delicate balance between scaling up operations to meet growing demand while managing operational constraints and ensuring passenger safety. The escalating perils of global terrorism



#### The recent ISIS-K attack outside Moscow has elicited widespread condemnation and intensified global anxieties surrounding terrorism

he recent ISIS-K (Khorasan) claimed attack outside Moscow, resulting in over 130 deaths and more than 100 injuries, warrants strong condemnation. Khorasan, a splinter unit of ISIS with roots in Iran, Turkmenistan, and Afghanistan, highlights four critical lessons. Firstly, politics, as observed by Thomas Hobbes in 'Leviathan,' remains deeply intertwined with human nature, with greed and fear driving conflicts. Despite global changes, power struggles persist, leading to conflicts like World War I and II. The post-World War II era witnessed the emergence of non-state actors, exacerbated by the Cold War and subsequent conflicts.

Secondly, intervening in internal conflicts, such as Russia's support for Assad against ISIS, can breed enmity and fuel terrorism. Thirdly, while international terror groups may appear subdued, they can resurge with renewed vigour, forming clandestine links in Central Asian Republics. Lastly, any retaliation against ISIS should involve cooperation with neighbouring countries to prevent spillover effects. This attack is reminiscent of past incidents in Russia, such as the 2002 Moscow theatre hostage crisis and the 2004 Caucasus hostage tragedy. The recent attack underscores vulnerabilities in Russia's security apparatus, with terrorists exploiting the ability to choose the time and place of their attacks for maximum media impact. The global criticism of the attack

reflects widespread concern over combating international terrorism. The US, despite geopolitical tensions, has shown commitment to addressing terror threats worldwide. However, trust deficits between major powers hinder cooperation efforts. While Ukraine denies involvement, the Federal Security Agency (FSB) is apprehensive about Ukrainian links to the attack, potentially complicating the ongoing conflict. China's expanding influence in Central Asia further complicates egionai dynamics.

Central Asian Republics (CAR) face increasing terrorism threats, with non-state actors exploiting cultural ties for nefarious purpos-



for multilayered security cooperation and technological innovation to combat terrorism effectively. Despite efforts by intelligence and security agencies, challenges remain in dealing with terrorists driven by religious misinterpretations. The influx of refugees from neighbouring countries adds complexity to the security landscape. Efforts to combat terrorism through collaboration, such as the Samarkand meeting, offer hope for regional stability. However, economic disparities and inconsistent Government policies contribute to vulnerabilities in the region. The presence of international Íslamist terrorist organisations like Hizb Ut-Tahrir poses significant security challenges. Despite anti-terrorist drives, Central Asian states have attempted to export terrorism to conflict zones like Iraq, Afghanistan, and Syria. The recent influx of illegal

migrants and increased terrorist activities have compelled China and Russia to seek cooperation in tackling transnational terrorism. Rise of fundamentalism in Central Asia poses an internationa reality, fueled by disgruntled groups and external influences. Central Asia's strategic importance and rich resources

Russia and CAR require coordinated action and cooperation. Economic transformation hinges on fighting inflation and developing robust anti-terrorism mechanisms. It's crucial to recognise that the issues of law and order differ from those of terrorism, despite often being conflated. Policymakers must understand the diverse security threats facing nations today and adapt strategic policies accordingly. Modern terrorists are highly organised and professional, necessitating a shift towards more vigilant and assertive intelligence, police, and paramilitary networks. Many recommendations from various committees may not align with current realities, especially considering India's struggles with terrorism, naxalism, and insurgency. It's outdated to attribute terrorism solely to societal conditions or structural adjustments. Instead, a thorough analysis of the psychological factors driving terrorism can offer deeper insights and guide effective counterterrorism strategies. Understanding the financial links between terrorism,

organised crime, arms dealers, drug traffickers, and smugglers is crucial. Special forces should be deployed to counter terrorist activities in regions where violence is endemic. Collaborative efforts among nations are essential to develop strategic mechanisms for combating international terrorism, with the United States and India playing pivotal roles. Addressing the multifaceted challenges posed by terrorism demands a nuanced approach that differentiates between law and order issues and acts of terrorism. Policymakers must acknowledge the evolving nature of security threats and adapt strategic policies accordingly. Vigilant and assertive intelligence, police, and paramilitary networks are vital in countering the sophisticated tactics employed by modern terrorists. Understanding the financial networks that sustain terrorism is equally crucial for effective counterterrorism efforts. As terrorism continues to pose a global threat, collaborative efforts among nations are essential. In this endeavour, the US and India can play pivotal roles, leveraging their resources and expertise in the gnt against terrorism.

#### **ADHERE TO DHARMA AND SATYA**

Dharma and Satya have profound implications on our actions and beliefs

hese two words sometimes confuse about what they convey. What is the relationship between these two? Don't they sound similar? They do. Then, there is 'kartavya' (duty). This word also is interlinked with these two. I will try to unravel their mystery in this article. Beginning with their definitions, dharma is what applies to everyone. For example, the nature of fire is to burn and cause it to burn. Similarly, dharma sustains life, virtue and moral duties on the planet Earth. The word Satya simply means facts like the Sun rising in the East. Some examples will shed more light on these two words. Starting with dharma, what is our svadharma or duty (kartavya)?

Lord Krishna has explained that when we are born we have certain qualities due to which we are suitable naturally to do certain activities. (4.13) This is our svadharma, i.e. our dharma. Some children are naturally inclined to play sports, and if allowed to do so excel. This is his dharma by which he entertains others and also earns his livelihood. Arjuna, who was a Kshatriya had a specific dharma due to his birth, which he was supposed to uphold. He spoke about protecting family dharma (values). If not practised, it could have caused many horrible consequences. (1.38-1.45) Svadharma defines an individual's duties.

Dhratarashtra was born blind. Therefore, he was unfit to rule even though he was the elder brother. His younger brother Pandu was enthroned by the king. Upon his untimely death, Dhratarashtra was made a stopgap



king till the eldest son of Pandu gained adulthood. This was a factual position, ie. Satya. Dhratarashtra's lineage was not entitled to be made king. But he refused to accept this fact, which was against dharma even though his eldest son Duryodhana was unfit to be made king. This resulted in the Mahabharata War, and his family was justly punished for trying to undo dharma. Dharma is worth practising for our good. It is meant for everyone to honour; one should follow it as far as feasible. Dharma is supreme; it is above everything. Satya has also many dimensions. It is a fact that all are similar souls. Satva should be used for correct behaviour, i.e. our activities should be based on it. For example, God should be worshipped by one and all. Satya is frequently situational. For example, children should study in school, but once at home should play. It changes or appears to change in our eyes or vis-à-vis our resources. For example, how much to eat? If not so hungry eat less and if quite hungry more. Similarly, if there is scarcity, the use of resources should be restricted. We have to always see what suits us and is appropriate. Our behaviour should match with the prototype in this matter. Truth is also what we perceive. Because we are too small to know the truth in its entirety, reality or essence. Truth can be known from scriptures like the Bhagavad-Geeta. Still, truth is limited; knowledge takes us to the level of humility, to be modest - a high quality.

Now let us turn to the relationship between dharma and Satya. Truth is an instrument; dharma is the system. Truth should always support dharma because truth is the basis of dharma. Earlier, i.e. in Sattvayuga and Treta yuga, truth and dharma were synonymous. Lord Krishna changed it in Dwaparyuga and made dharma superior to truth because truth is not habitually spoken in this yuga. That is the reason Yudishthir was asked to speak the confusing truth - "Ashavathama hatha it; narova kunjarova". Because dharma was at stake. The same rule applies today. We must always go by dharma; truth can be sacrificed for it. Let's, there-

fore, make dharma the basis of all our acts. What is the conclusion? Both dharma and truth are important, but dharma is more important. Truth can be sacrificed for the sake of dharma, but only temporarily, not permanently.

# Curb malpractices within private banks



Reports reveal widespread irregularities and malpractices, including gross misuse of public funds by top management, highlighting the urgent need for banking reforms

everal private banks in India are indulging in massive irregularities and malpractices with some of these irregularities highlighted in the Inspection-Reports of these banks ever since the Supreme Court ordered the Reserve Bank of India (RBI) to make such Inspection-Reports of banks public under the RTI Act. But now even RBI is reluctant to disclose these Inspection Reports public under the RTI Act RBI should remove all confusion by complying original Supreme Court verdict in letter and spirit by making of Inspection Reports of all banks public on the RBI website. Moreover, it should be mandatory for all banks to put their respective Inspection Reports on their websites including all the previous ones. Considering the vast participation of public money in private sector banks, all private sector banks must be under the purview of the RTI Act. Already all employees up to the highest post of CMD are public servants according to section 46A of the Banking Regulation Act. RBI had to impose restrictions on the withdrawal of money for some time on a prominent private sector bank. The former CMD of another prominent private sector Bank is under arrest for serious charges of misappropriation of public money in the Bank. Inspection Reports of private banks revealed under the RTI Act by the Reserve Bank of India (RBI) reveal gross misuse of public money by top management. Another private sector bank is renowned for a large number of Non-Performing Assets (ŇPAs). Heavy fluctuation in share prices of certain private sector banks tends to doubt regarding safety of public money in private sector banks. Deposit Insurance and Credit Guarantee Corporation (a subsidiary of RBI) has to pay a maximum rupees five lakhs from state funds to each depositor of the bank including those in the private sector that collapse due to massive irreg-ularities, which is public funding to declare private sector banks as "publicauthorities" under section 2(h) of RTI Act. An example is the closure of a private PMC Bank in Maharashtra which even caused the fatalities of several depositors. Many banks to boost their business provide excessively secured loans more than the real market value of the mortgaged property even though rules allow only some portion of the assessed value of the property for loan purposes. This can and must be effectively checked by formulating a rule with retrospective effect whereby banks may be required to close the loan account in case the borrower surrenders vacant possession of the mortgaged property unconditionally. Strict action under section 46A of the Banking Regulation Act should be taken against officers sanctioning excessive loans higher than the recovered amount by the sale of a mortgaged property when the concerned bank is already in the advantage of having sufficient margin money. A study may be made if some ban can be imposed on giving loans on self-occupied residential properties because, in case of default, the family of the loan-taker is the sufferer for

fault/default of the loan-taker. It is quite usual that many private banks often get blank papers, loan kits and cheques signed by the borrower and his family members as guarantors to misuse as per their convenience in case of default of loans. Borrowers generally sign such

blank documents without realising the consequences in a hurry to get loans. Erring banks do not give consumer copies of the loan kit to the borrowers who are thus always practically financial slaves of such banks. The system should be that a copy of the duly filled loan kit and cheques may be compulsori-ly sent by Registered Post to the borrowers, guarantors and a specially set-up section of RBI within seven days of loan disbursal to ensure that banks may not be able to misuse any other paper earlier got signed blank in case of default. The same should be applicable for non-banking financial companies (NBFCs).

The rule should be that all bank accounts of Government offices, Public Sector Undertakings (PSUs) and state-run corporations (both central and state Governments) must be compulsorily only in oublic sector banks. Rather their employees should also have their salary accounts in any of the branches of the same public-sector bank for getting salaries through simple bank transfers. Government employees thereafter may shift funds to any bank of their choice. There were serious allegations of favouritism with a particular private bank for having salary accounts of employees of a Government department in Maharashtra because the wife of a heavyweight political ruler was a senior executive in that private bank. Maharashtra has otherwise also the unique facility of having the smallest public-sector bank having a widespread network of branches all over Maharashtra. Bank of Maharashtra was not merged with any larger public-sector bank only to retain its identity as a state-specific bank in Maharashtra state. Governments

both central and state should be duty-bound to promote public sector banks. Using public-sector banks will increase deposits and profitability of public-sector banks and ensure the safety of public money.
RBI bonds issued by the Reserve
Bank of India (RBI) should be

issued only through public-sector banks and companies. Once there was a news item that China Central Bank had tried to raise its stake in HDFC Bank from 8 percent to 1.1 percent with China Central Bank already holding about 17.5 million shares in HDFC Bank. Even though the Indian Government subsequently tightened rules for increasing such stakes by neighbouring companies, the episode developed a feeling of uncertainty amongst investors in RBI bonds made through HDFC Bank. There should be provision tor ones should have a common of auto-renewal in KBI bonds at the interest rate prevailing at the

time of maturity. Frauds are reported through some bank employees misappropriating funds in such inoperative accounts where the amount is large. RBI should direct all banks to inform account holders about their existing balance and to approach banks either to make accounts operative or close these in a time-bound period after which all such balances may be transferred to Depositor-Educative-Awareness-Fund (DEAF). With the private sector dominating the banking sector, public money lying in inoperative accounts must not be retained by banks.

Frequent changes of account numbers by banks should be prevented by making it mandatory for all banks to allot 15-digit account numbers. Confusing and frequently changing account numbers

result in the bouncing of electronic fund transfers. Rather such a 15digit account number should be a unique one with banks being recognised by the first two digits of the account number. Such 15digit account numbers should also be for Public-Provident-Fund (PPF) and Senior Citizens Savings Schemes (SCSS) and other such deposit accounts Government schemes.

Cover-page of pass-books of all banks should compulsorily have all details submitted in account-opening forms including nomineedetails. The inclusion of nominee details on pass-books will allow nominees to claim rights on the death of the account holder by going through left-out important documents including pass-books after the death of the account holder. All banks especially public-secand uniform style of forms used for various banking purposes with provision to download the same after filling on the computer like is a facility available for application forms for passports. Additional facility to email computer-filled forms with necessary enclosures like copies of ID proof, PAN-card etc to the Bank can save huge manhours of bank staff in re-filling all details on the computer apart from eliminating any chance of wrong/incomplete entry in computers. Customers can go to banks just to put signatures on such emailed computer-filled forms. A system should be formulated whereby all requirements like Minimum Balance, interest rates, bank charges and other procedures may be uniform for all public-sector banks. 

# The rise of 'water aunties' and sustainable solutions

#### There is a critical correlation between clean water access, conflict, cooperation and climate change; water for all is imperative

→his year, the theme for World Water Day is 'Water for Peace'. It renews the world's focus on clean, safe, and affordable drinking water and its complex relationship with conflict, cooperation, and climate change. About 2 billion people still lack access to safe water worldwide.

India, too, has been addressing the water needs of its citizens with the promise of tap water in each home, especially in the last decade, where nearly piped water access has reached 75% of India's homes. Communitybased water treatment plants help purify groundwater to serve such civilian needs. Decentralised Safe Water Enterprises (SWEs), popularly called Water ATMs, have

densely populated areas in The Water Aunties

(SWN), through its Water water tankers, and serves local-ATMs called iJal Stations, helps provide safe water access to over 1.3 million people in India across Telangana, Maharashtra and Western Uttar Pradesh. In 2023, consumers bought over 350 million litres of water from its iJal stations, which had an uptime above 98 per cent around the year. Nearly 56 per cent of these 350 Water ATMs are managed and operated by women affectionately called Water Aunties by their communities.

The consumers collect safe water in their 20-litre cans from these iJal Stations. This prevents the scourge of singleuse plastic bottled water, provides freedom and livelihood ities with contamination-free potable water. The stations have proven to

The bodies of six foreign aid workers killed in a series of Israeli strikes were transported out of the Gaza Strip and into Egypt on Wednesday ahead of their repatriation, Egypt's state-run Qahera TV reported.

The deadly strikes have renewed criticism of Israel's conduct in the nearly sixmonthlong war with Hamas, and highlighted the perilous conditions aid workers face in trying to deliver food to the besieged enclave, where experts say nearly a third of the population is on the brink of starva-

The three British citizens, a Polish citizen, an Australian and a Canadian American dual citizen worked for World Central Kitchen, an international charity founded by celebrity chef José Andrés.

Their Palestinian driver was also killed, and his remains were handed over to his family for burial in Gaza.

The strongest earthquake in **⊥** a quarter-century rocked Taiwan during the morning rush hour Wednesday, killing nine people, trapping dozens in quarries and sending some residents scrambling out the windows of damaged buildings. A tsunami warning was triggered but later lifted.

The quake, which also injured hundreds, was centred off the coast of rural, mountainous Hualien County, where some buildings leaned at severe angles, their ground floors

Just over 150 kilometres away in the capital of Taipei, tiles fell from older buildings, and schools evacuated their students to sports fields, equipping them with yellow safety hel-

# Biden and Trump win presidential primaries in four more states

**PTI** ■ WASHINGTON

Us President Joe Biden and his Republican rival and predecessor Donald Trump have easily won their presidential primaries in four more states as they are set for a 2020 rematch in November

On Tuesday, hundreds of delegates were up for grabs in Rhode Island, Connecticut, New York and the crucial battleground state of Wisconsin. Multiple names remained on the presidential ballots in the four states, though neither Trump, 77, nor Biden, 81, faced any major challenger. In all the four states where the primaries were held Tuesday, Trump bagged more than 75 per cent of the votes, while Biden, a Democrat, received more than 80 per cent of the Trump with four wins now has

1,860 delegates. Biden has so



far won 3,030 delegates as against the minimum requirement of 1,968 delegates Biden and Trump have already amassed enough delegates to win their respective nominations. But the turnout could

provide more clues about the election on November 5. Their rematch is expected to mirror the 2020 campaign, though Trump will run this

time under the spectre of 91 felony charges. Their nominations will be confirmed at the Republican

National Convention in

Milwaukee in July and the

Convention in Chicago in Connecticut and Rhode Island

allowed voters to vote "uncommitted" in the primary, while Wisconsin offered a similar option of "uninstructed delegation". There was an effort in Wisconsin on Tuesday by anti-Biden protesters to encourage people in the Democratic primary to pick the "uninstructed" option in opposition to Biden's policies on the Israel-Hamas war.

Pressure has been growing on Biden especially, to push harder for a ceasefire in Gaza, with some states, including Michigan, fostering similar campaigns for residents to submit "uncommitted votes" for the president.

These victories offer insights into base voter enthusiasm for the upcoming 2020 rematch, particularly in Wisconsin, a crucial November battleground. Biden and the Democratic

National Committee have outpaced Trump and the Republicans in fundraising. Biden claimed the largest single-event fundraising record last week when he received USD 26 million at a star-studded New York event. Trump hopes to bring in USD 33 million at a Palm Beach, Florida fundraiser.

Meanwhile, CNN reported that Democrats have been growing increasingly anxious about public polls showing Trump making unprecedented inroads among Black and Hispanic voters. "But there may be rea-sons for Republicans to feel uneasy about these polls too," it said, adding that surveys now consistently show Trump leading President Joe Biden nationally and in almost all of the key

A fire that spread through an Istanbul nightclub during renovations, killing 29 people, was likely caused by welding sparks igniting combustible material, a newspaper reported on Wednesday, citing fire department officials.

The fire engulfed the popular Masquerade nightclub on Tuesday, trapping workers and club employees inside. It left 29 people dead and another person with serious injuries. Authorities have detained nine

people for questioning, including club managers and people in charge of the renovation The club, which was closed for

renovations during the holy month of Ramadan, was located on the ground and basement floors of a 16-story residential building in the Besiktas district on the European side of the city on April 10.

Gov. Davut Gul told reporters that the cause of the fire was under investigation. The government assigned prosecutors and investigators to probe the incident.

The Yeni Safak newspaper, which is close to President Recep Tayyip Erdogan's government, said the fire is believed to have been caused by sparks from a welding machine being used to install sound insulation and decoration material. It reportedly set off an explosion which in turn set other construction material ablaze.

The newspaper cited unidentified fire department officials in its report. The Sabah newspaper published a similar report. Officials have not publicly commented on the fire's cause. HaberTurk television reported

that the area where the renovation work was taking place was like a "labyrinth", making it difficult for the victims to find their way out.

The victims included Gokhan Tevlek, a club DJ, Atanur Aladag, who was employed as a cook, and Akin and Yilmaz Kihri, a father-and-son team of welders, according to Turkish media reports.

Video from the scene showed flames billowing from the side of the building, firefighters dousing an entrance to the club and people carrying a victim on a stretcher toward an ambulance

"After the fire brigade arrived, bodies started to come out of the nightclub," state-run Anadolu quoted witness Sema Soganci as saying. "People were screaming, everything happened so suddenly. The flames were like crazy." "I started to cry, I was nervous," she said.

Another witness, Mehmet Cengiz, told Anadolu, "We saw firefighters entering and coming out all blackened."
The nightclub had a capacity of

4,000 guests, according to its website. The manager of the residential building told reporters on Wednesday that the premise was originally designed as a cinema. Istanbul Mayor Ekrem

Ukraine on Wednesday lowered the military conscription age from 27 to 25 in an effort to replenish its depleted ranks after more than two years of war following Russia's full-scale invasion.The new mobilisation law came into force a day after Ukraine President Volodymyr Zelenskyy signed it. Ukraine's parliament, the Verkhovna Rada, passed it last year.

The World Bank has paint-I ed a grim economic picture of Pakistan in its biannual report, cautioning that over 10 million more people are at risk of descending into poverty in the cash-strapped country. The Washington-based lender's apprehension comes from a sluggish economic growth rate of 1.8 per cent, coupled with soaring inflation, a staggering 26 per cent in the current fiscal year.

The World Bank's biannual Development Pakistan Outlook report painted a grim economic picture, indicating that the country is set to miss almost all major macroeconomic targets. For the next fiscal year too, the World Bank projected a 15 per cent inflation rate. "Inflation is projected to remain elevated at 26 per cent in FY24 due to higher domestic energy prices, with little respite for poor and vulnerable households with depleted savings and lower real incomes," it said.

The World Bank said the fiscal deficit is projected to increase to 8 per cent of GDP or Rs 8.5 trillion in this fiscal year due to higher interest payments, which is far high er than the official target of 6.5 per cent. It said that the deficit will only gradually decline over the medium term as interest payments decrease and fiscal consolidation measures take hold.

As against the IMF target of a primary budget surplus of Rs 400 billion, the World Bank said there will be a primary deficit of 0.1 per cent of GDP in this fiscal year. It has projected the deficit for the next two fiscal years as well. Pakistan's economy is expected to grow by only 1.8 per cent in the current fiscal year ending June 2024, whereas the official target is 3.5 per cent, the World Bank said.

#### Over 3.5 lakh devotees visited first Hindu temple in Abu Dhabi

Over 3.5 lakh devotees visited the first stone Hindu temple in Abu Dhabi within a month of its opening for the public, according to temple authorities. The iconic temple which was inaugurated in February by Prime Minister Narendra Modi was opened for visitors on March 1. "In the first month, there were approximately 350,000 devotees and visitors, 50,000 of whom visited each weekend (Saturday-Sunday). It's important to note that on Mondays the Mandir conducts private prayers and is closed to visitors, meaning the complex was accessible for only 27 out of the 31 days in March," a temple spokesperson told PTI.

"Every evening from Tuesday to Sunday, Ganga aarti is performed at 7.30 pm on the

banks of the Swaminarayan ghat, which has been created using holy water from Ganga and Yamuna transported from India," he added. The grand temple was inaugu-

rated during a dedication ceremony attended by over 5,000 invitees on February 14.

The temple has been built by the BAPS Swaminarayan Sanstha on a 27-acre site in Abu Mureikhah, near Al Rahba off the Dubai-Abu Dhabi Sheikh Zayed Highway, at a cost of around Rs 700 crore. Constructed with 18 lakh

bricks and 1.8 lakh cubic metres of sandstone sourced directly from Rajasthan Abu Dhabi's first Hindu temple has been made in the Nagara style of architecture, just like the Ram Temple in Ayodhya which was inaugurated earlier this

The UAE has three other Hindu temples in Dubai. "Since the temple is little on the

outskirts and in the middle of desert, public bus service from the city has been started for weekends to allow visitors to easily come to the temple, the spokesperson said. During Prime Minister Modi's

two-day visit to the Gulf nation in 2015, the UAE allocated land for constructing a temple in Abu Dhabi. This visit held significant diplomatic importance, as Modi became the first Indian Prime Minister since Indira Gandhi to visit this strategically vital Gulf nation in 34 years. The construction of the temple began in 2019. The UAE has at

least 3.5 million Indians who are part of the Indian workforce in the Gulf. The land for the temple was donated by the UAE government.

The BAPS Hindu Mandir is the largest in all of the Gulf region. Seven spires representing seven emirates of the UAE, carvings

of camels, and national bird falcon, are part of the architecture of the first Hindu stone temple in Abu Dhabi, to give equal representation to the host country. To give equal representation to

the host country, along with animals that occupy an important place in Indian mythology like elephants, camels and lions, the ÛAE's national bird, the falcon, has also been included in the design. Apart from 15 tales from India,

including the Ramayana and Mahabharata, stories from Mayan, Aztec, Egyptian, Arabic, European, Chinese and African civilizations have also been depicted in the temple. While the outer walls of the temple are made using sandstone from India, the interior, made of white Italian marble, is adorned with intricately designed and carved columns

Other Noteworthy architectural elements include two ghumats (domes), 12 samrans (dome-like structures) and 402 pillars. The two ghumats are the "Dome of Peace" and "Dome of Harmony". Over 300 high-tech sensors to

measure temperature and monitor seismic activity, fly ash in the foundation to reduce carbon footprint, 18 million bricks, nano heat resistant tiles and no usage of iron and steel—-the temple has been built using ancient architectural methods clubbed with scientific techniques. It is the first bi-monthly monetary policy of 2024-25. A total of six MPC meetings are scheduled for the fiscal year beginning April 1, 2024. The Reserve Bank of India (RBI) last

hiked the repo rate to 6.5 per cent in February 2023 and since then it has held the rate at the same level in its last six bi-monthly policies.

Experts said the Monetary Policy Committee (MPC) may take cues

from the central banks of some major economies, such as the US and the UK, which are apparently in wait-and-watch mode on interest

Switzerland has become the first major economy to cut interest rates, while Japan, the world's third-largest economy, ended its eight-year period of negative interest rates regime.

## Gold hits new peak of Planters oppose notification to sell 100 per cent tea through auction

n association of tea planters in the north-An association of tea planters in the north-east region has opposed the central government's directive to sell 100 per cent of dust tea and 50 per cent of other grades produced in a calendar year through auction as it will be "detrimental" to the survival of the

In a liberalised and globalised economy, there is "no need for the government to issue a notification to compulsorily sell a certain percentage of tea through a public auction", North East Tea Association Advisor Bidyanand Barkakoty said in a statement on Wednesday. 'The government should not try to regulate one

particular segment of the trade, and in this case, tea producers have no control over the market forces. We earnestly request that the notification should be withdrawn in the best interests of the tea industry, he said.

A gazette notification, Tea (Marketing) Control (Amendment) Order, 2024, issued on February 26, directed that not less than 50 per cent of the total tea manufactured in a calendar year and 100 per cent of dust grades tea manufactured in



a calendar year in units located in Arunachal Pradesh, Assam, Bihar, Himachal Pradesh, Meghalaya, Mizoram, Nagaland, Sikkim, Tripura, Uttarakhand and West Bengal must be sold through public tea auctions but it does not apply to a mini tea factory.

The basic principle of our objection is that since the government cannot guarantee the price realisation and the time taken for sale through auction, it should not intervene but leave it to producers to sell their produce in whatever way they feel comfortable," Barkakoty said.

Tea producers have a "huge risk and responsibility of paying wages to workers on time and also to small tea growers who sell their green leaf to factories", he said.

# IOC sets deadline of early 2025 to keep boxing in Olympics

**AP** ■ LAUSANNE (SWITZERLAND)

The International Olympic Committee on Wednesday said it needs to find a suitable new international boxing body by early next year or risk boxing dropping out of the Games in 2028. The IOC stripped the International Boxing Association of the right to run the Olympic boxing tournaments in Tokyo in 2021 and Paris this year.

On Tuesday, the Court of Arbitration for Sport upheld the IOC's decision to formally de-recognize the IBA, cutting it out of the Olympic movement altogether.

The IOC has long cited concerns about the IBA's governance and the integrity of how boxing matches are refereed and judged. It also accused the IBA's Russian president Umar Kremlev of using "violent and threatening language" about personnel last year.

Because of the universality and high social inclusivity of boxing, the IOC wants it to continue to feature on the program of the Olympic Games," the IOC said Wednesday.

"Unfortunately, this is far from certain for the Olympic Games LA 2028 because, for governance reasons, the IOC is another Olympic boxing
