Apex court gives relief to YouTuber

bserving that everyone who makes allegations on social media cannot be put behind bars, the Supreme Court on Monday restored the bail to a YouTuber who was accused of making derogatory remarks against Tamil Nadu Chief Minister MK Stalin in 2021.

"If before elections we start putting behind bars everyone who makes allegations on YouTube, imagine how many will be jailed?"a bench of justices Abhay S Oka and Ujjal Bhuyan told senior advocate Mukul Rohatgi, appearing for the Tamil Nadu Government, as it set aside the order cancelling A Duraimurugan Sattai's bail.

The Supreme Court said the accused did not misuse his liberty by protesting and expressing his views and also rejected the request of the State Government to impose a condition on Sattai to refrain from making scandalous remarks while on bail.

The court was hearing Sattai's plea challenging an order of the Madras High Court which cancelled his bail as he had made certain derogatory remarks against Stalin in violation of an undertaking given to the court.

While seeking bail in a case, had submitted an



undertaking that he would not pass derogatory remarks against anyone. Sattai was arrested by the police for allegedly making derogatory remarks against Stalin and others but had been granted conditional bail.

The High Court had cancelled the bail on the grounds that Sattai went on to make more allegedly derogatory remarks against Stalin despite providing assurances to the contrary. However, in July 2022, the Supreme Court granted interim bail to Sattai and he has been out on bail since.

Sattai did not misuse his liberty by protesting and expressing his views. Rohatgi responded by saying

the State Government had registered two information reports against the YouTuber in December 2022 and March 2023 for repeated offences.

The top court noted that the allegations in one case pertained to Sattai's pertained participation in a protest against the demolition of the Babri Masjid — in December 1992 — and the second case pertained to a demand made

by Sattai for the release of certain persons in custody. 'We don't think that by

protesting and by expressing his views, it can be said that the appellant has misused the liberty granted to him," the bench said. "Even otherwise we are of the view that the grounds mentioned in the impugned order cannot constitute grounds for cancellation of bail." The top court clarified that the State Government may approach it again for the cancellation of Sattai's bail if such grounds

Opposition knocks on EC gates

Opposition parties, the Congress and the Trinamool Congress (TMC), upped the ante against the BJP-led NDA Government and knocked at the grates of and knocked at the gates of the Election Commission (EC) with their respective

complaints.

TMC leaders were detained by the Delhi Police on Monday while they were holding a dharna outside the EC's office, demanding that the chiefs of CBI, NIA, ED and Income Tax Department be changed.

The Congress moved the EC with six complaints, two of which were directed against Prime Minister Narendra Modi for his remark targeting the party and comparing its Lok Sabha poll manifesto with that of the Muslim League. Modi has said in his election rallies that the Congress'

manifesto for the upcoming general election smacks of the "politics of appeasement" and carries the imprint of the Muslim League, with "every page reeking of breaking India".

Separately a 10-member delegation of TMC announced a dharna after meeting a full bench of the EC to press for their demand. TMC MPs Derek O'Brien, Mohammed Nadimul Haque, Dola Sen, Saket Gokhale and Sagarika Ghose, MLA Vivek Gupta, former MPs Arpita Ghosh,

LG writes to MHA over **AAP Ministers meeting** refusals in Delhi

Delhi Lieutenant Governor (LG) Vinai Kumar Saxena has complained to the Ministry of Home Affairs (MHA) that Ministers of the Delhi Government have refused to meet him in the past few days on the issues related to citizens. He had convened these meetings to ensure smooth governance in the wake of Chief Minister Arvind Kejriwal's arrest and subsequent events.

Giving details, Raj Niwas Secretariat officials said the issues especially pertained public health infrastructure in the city and the impeding Summer Action Plan for water availability. Saxena had asked for a meeting with the Ministers twice on March 29 and April two, they said.

However, Ministers of Delhi Government, especially Health Minister Saurabh Bhardwaj under fire from the Delhi High Court over lack of health infrastructure in the city, instead of solving issues, indulged in public mud-slinging and refused to meet the LG citing lame excuses. Kejriwal was arrested Enforcement Directorate on March 21 in connection with a money-laundering case linked to the now-scrapped Delhi excise

Bhardwaj upon being asked for a meeting on 29.03.2024 sent a text to the LG Secretariat that read, "We wanted agenda for this

meeting with the LG...I do not think meeting can be called without directions of the CM. Please convey." Bharadwaj, however, said the Constitution does not give the LG the power to

Muizzu aide insults India, apologises

Maldivian ormer Minister Mariyam Shiuna has offered "sincerest apologies" for a post on social media reportedly disrespecting the Indian national flag. She is among suspended earlier this year over social media posts targeting the Indian political leadership leading to a diplomatic row.

Shiuna, who has since deleted the said post, clarified on Monday that she did not intend to disrespect India or the country's national flag. She apologised after a controversy over a social media post she made against the Opposition using a symbol that resembled the Ashok Chakra.

"I would like to address a recent social media post of mine that has garnered attention and criticism. I extend my sincerest apologies for any confusion or offense caused by the content of my recent post," Shiuna wrote on X.

"It was brought to my attention that the image used in my response to the Maldivian Opposition party MDP bore a resemblance to the Indian flag. I want to make it clear that this was entirely unintentional, and I

sincerely regret misunderstanding it may have caused," she said.

"Maldives deeply values its relationship and the mutual respect we share with India. In future I will be more vigilant in verifying the content I share to prevent such oversights," the ex-MP added.

She also said the image was meant to take a jibe at the Opposition Maldivian Democratic Party (MDP). Maldives is set to hold parliamentary elections on April 21.

In the deleted post, which targeted the Opposition

MDP's campaign poster, the Opposition party's logo was replaced with what looks like the Ashok Chakra; in the Indian flag, the Navy Blue-coloured Ashok Chakra appears on the white central

band.
"The MDP is heading towards a big slip. The people of Maldives do not want to fall and slip with them," the post read.



INDIA Bloc source of all problems in country: Modi

Likening the Opposition Congress to 'Kadwa Karela' (bitter gourd), Prime Minister Narendra Modi on Monday charged that the grand old party was the "source of all problems in the country" and that the "INDI Alliance" which it was heading had pushed the country into instability.

Kicking off the BJP's campaign for the Lok Sabha polls at Chandrapur in eastern Maharashtra, Modi said: "The Congress is like 'Kadwa Karela' (Bitter gourd). Bitter gourd can never be sweet even if it is mixed with ghee or sugar. This applies to the Congress perfectly. This party can never mend its ways. Owing to its misdeeds, the Congress party has lost public support within the country. Now it has openly started indulging in the game of divide and rule".

Accusing the Congress-led Opposition of indulging in corruption in the past, Modi said: "Through its practice of demanding commission on contract, the Opposition-led government had in the past jeopardised the future of Maĥarashtra. Its leaders would put a break to contracts if they did not receive commissions They stopped or put a break to good projects like the Jalyukta Shivar scheme, irrigation projects. The Congress opposed the Samruddhi Maha marg project. The Opposition leaders also stopped projects like

Picking up from where she had left a day before, Bengal Chief Minister Mamata Banerjee on Monday rained fire on Prime Minister Narendra

on Prime Minister Narendra Modi for promoting a kind of "Guarantee" that guarantees a definite journey to jail. Launching a frontal attack against the Prime Minister for announcing "stronger action against the corrupt people after against the corrupt people after June 4," when the third BJP Government would come to power in the Centre, Banerjee said how his government had turned the entire country into

"I respect the Prime Minister's chair but the tone and tenor of his language that he used from a rally at Jalpaiguri does not behove his high post ... he said that after June 4, he will send everyone to jail," Banerjee said insisting, "his (Prime Minister's) guarantee means sending people to jail ... so much so that they have converted the entire country into

Cocking a snook at the Prime Minister she said "you think that you will terrorise everyone with threat of putting them to jail but no one is afraid of that," adding how Modi moved around with Enforcement Directorate, Central Bureau of Investigation in one pocket and National Investigation Agency and Income Tax Department in the other.

The Prime Minister had told in an election rally at Dhupguri in Jalpaiguri district that he would continue his tirade against the corrupt people as he had promised to rid India of corruption and turn into a fully developed country by 2047 by which it would become a third strongest economic power of the world.

Referring to his hard-hitting speech, Banerjee said that the BJP Government was using the central agencies to suit its political ends. "They (agencies) are your brothers who bring funds for you and showing them you threaten us... you carry ED and CBI in one pocket and NIA and Income Tax in the other," she said.

Banerjee was addressing a rally at Bankura a tribal dominated district of Jangalmahal adjacent to Jharkhand. For the first time raising the issue of the arrest of former Jharkhand Chief Minister Hemanta Soren in an election rally Banerjee asked "why did you arrest Hemanta Soren who is a tribal Chief Minister ... I have spoken to his wife and they are not scared ... my question is who are you threatening ... who is afraid of you ... you will arrest five TMC man ... their wives will come forward to work." Slamming the BJP Government

for arresting her Delhi counterpart Arvind Kejriwal, the TMC supremo asked ""Why did you arrest Arvind Kejriwal? ... what was his fault" adding iust because he did not submit to you ... even after his arrest he is working from jail... not only that he will win from jail and this time with a bigger

Jobs were sold when Mamata was Railway Minister: Arjun

Nursing officer who stood by rape victim reinstated

Abold initiative by Kerala's Own Nirbhaya made the CPI(M) led Government eat humble pie and reinstate a senior nursing officer who stood steadfast with the victim of a gruesome rape.

P B Anitha, senior nursing officer, Kozhikode Medical College Hospital (MCH), who has been suspended from service at the intervention of Veena George, the State's controversial health minister, was reinstated by a special order following widespread demonstration and rallies against the minister's high-handed atti-

Anitha was put under suspension for extending all support to the Nirbhaya, who was brutally raped by a CPI(M) trade union leader while she was undergoing treatment at the Intensive Care Unit of the

According to doctors attending to her, Nirbhaya was in a state of semi-conscious stage in the ICU following a surgery when Saseendran, leader of the CPI(M) led trade union sexuallv assaulted her.

Anitha extended all help to the victim as other staff members of the hospital were reluctant to attend to her lest the perpetrator get annoyed.

Despite Anitha taking care of the victim, she was shunted out from Kozhikode to far away Idukki in order to save the CPI(M) comrade.

Though Anitha got a favourable order from Kerala High Court which ordered that she be posted at MCH Kozhikode itself, the minister was adamant that the senior nursing officer should go and there was no question of any compromise.

Anitha was staging a sit-in in front of the hospital for the last five days demanding justice and the execution of the High Court order.

On Friday evening, the Nirbhaya joined the sit-in to express her solidarity with Anitha. "She was very kind to me and was the only one who offered her shoulders to me. I'll sit with her till she is reinstated here itself," the Nirbhaya, who staged the sit-in with her face covered with black mask told media persons.

Though Veena George, a lateral entry leader to the CPI(M), stood her ground that there was no question of being kind to Anitha, better sense prevailed by Saturday noon and she ordered the directorate of medical education to reinstate Anitha in MCH Kozhikode.It is reported that the move is a fall out of Chief Minister Pinarayi Vijayan's intervention for fear of losing public face during the Lok Sabha polls. On Monday when the Shiv Sena (UBT) candidate

Amol Kirtikar was questioned extensively by the Enforcement Directorate (ED) in the Khichdi scam, expelled former Congress MP Sanjay Nirupam charged that Sena (UBT) leader and spokesperson Sanjay Raut was the kingpin behind the scam.

"The information will be transmitted even when the whale shark travels at maximum speed during storms or cyclones," State Chief Conservator of Forest, K Ramesh added.

than ever before. For instance, eDNA technology allows researchers to detect and identify species by analysing genetic material present in environmental samples such

as water or soil. The Union Environment Ministry has already profiled 270 elephants since August 2022, aiming at ensuring better protection has been completed. DNA profiling is the process where a specific DNA pattern, called a profile, is obtained from a sample of bodily tissue. The DNA profiling will act as the Adhaar card of captive elephants, said an official from the Ministry.

Cases will be filed over shortage of medicines in hospitals: AAP Minister

Delhi Health Minister Saurabh Bharadwaj on Monday announced in the Delhi Assembly that cases will be registered against the chief secretary and the health secretary over the shortage of medicines in State medicines Government run hospitals and dispensaries, The issues of medicine shortage in Delhi government hospitals and dispensaries and the stoppage of free diagnostic tests at mohalla clinics by "some officers concerned" were raised by AAP MLA Rajendra Pal Ġautam motion under Rule 54.

"So, it was a pre-planned conspiracy to stop medicine supplies by obstructing the CPA tender. What will (Chief Minister) Arvind Kejriwal or Saurabh Bharadwaj do if medicines itself are not available at the hospitals and dispensaries?" he said in the

Training his guns at Delhi Lt Governor Vinai Kumar Saxena, Bharadwaj said he wrote to him repeatedly and pointed out that the chief secretary and the health secretary were "misleading me and the Delhi government" by "hiding" the shortage of medicines and sought action against them but no action was taken. DJB scam bigger than Liquorgate: BJP | touching new height

Delhi BJP President Virendra Sachdeva on Monday demanded CBI probe into alleged Delhi Jal Board(DJB) scam and other scams and claimed the DJB scam is bigger than the liquor scam. Delhi Jal Board has become the main center of corruption of the present regime, he said. Stating this, BJP leader said his

party has been saying for a long time that the scam of Delhi Jal Board is bigger than the liquor scam and ruling party leaders have always tried to avoid it. He said the Finance Department of the Delhi Government has informed the Supreme Court that in the last 9 years, there is an amount of Rs. 28,400 crores for which

there is no account. Sachdeva said the game of scams that started in Jal Board since 2013 has reached a point where now the Jal Board is drowned in debts of Rs 73,000 crores and a plan has also been made to cheat the people of Delhi for its repayment.

He said on one hand, Delhi's Water Minister Atishi says that they are not being given money, while on the other hand, the audit of the Jal Board's accounts has not been

done since 2016-17. Atishi should understand that it is illegal to give money to any government department indefinitely without an audit, and

that is why today the situation in the Jal Board has become like a scam, Sachdeva said. Delhi BIP President said the information revealed in the letter written by Atishi on March 9 has exposed many things. According to the information received from the letter, 59% water generates no revenue and there is no transparency on the use of additional 15% water. Today, 74% of water is not

accounted for in the Delhi Jal Board. That is, only 26% of the raw water is generating funds for DJB. Not only this, the accounts of 2021-22 are also missing.Sachdeva said the Kejriwal government recovers its economic losses by increasing the tax charge on the people of Delhi by 5% per year. Therefore, the water infrastructure charge was increased four days ago in the residential areas. In October 16, 2020, the expenditure in 200 square meters was Rs 2,15,200, which has now become Rs 3,44,320. Not only this, commercial property charges have gone up from Rs. 3,28,800 to Rs 5,16,480, Sachdeva said.

He said the reality of the water bill is that in the residential areas, 30 kiloliters of water costs 790 rupees, service charge 219 rupees, and then sewer charge 474 rupees, and both together become 1484 rupees and if we talk about per kilo liter of water, then it is 49 rupees per

Power demand **STAFF REPORTER** ■ NEW DELHI

With the mercury rising in the national Capital, electricity demand is touching new heights. The peak power demand in Delhi is expected to cross the 8,000 MW mark for the first time in the summer of 2024, the BSES and Tata Power said on Monday, asserting that discoms are prepared to meet the record demand.

Last year, the peak power demand was 7438 MW. In a span of about 20 years, this expected peak power demand this year is an increase of around 280 percent over the peak power demand of 2879 MW in 2002.After clocking a record power demand of 7695 MW in 2022, Delhi's peak power demand during the summers of 2024 will break all previous records with the possibility of reaching 8200 MW according to State Load Dispatch Centre (SLDC) data.

Court denies interim bail to BRS leader Kavitha

 $A^{\text{city court on Monday}}$ denied interim bail to BRS leader K Kavitha, arrested in a money laundering case linked to the alleged Liquorgate scam, saying prima facie she not only destroyed evidence but was also instrumental in influencing witnesses and there is every likelihood" of her continuing to do so in case the relief is granted.

Kavitha had approached the court for interim bail, claiming her 16-year-old son has exams and needs her "moral and emotional support". "From the material placed

before this court, it appears that the Applicant not only engaged in destruction of material evidence by formatting her phones before joining the investigation and after being served with notice requiring her to do so, along with her digital devices, which stands established by way of the forensic report in this regard, but also has been



witnesses and there is every likelihood of her continuing to do so in case the relief prayed for is granted to her," Special Judge Kaveri Baweja said.

The judge said Kavitha was stated to be highly educated, and by no standards can be said to a vulnerable woman who could be made a scapegoat for committing the alleged offences. She is undoubtedly a "well-educated" and "wellplaced woman in the society". The material placed before this court in the course of arguments prima facie points

towards her active involvement in commission of the alleged offences as also towards her deliberate act of causing destruction of evidence, besides attempting to influence witnesses of the case," the judge

In response to Kavitha's submission that her husband was busy pursuing litigation on her behalf, the judge said it was not a "convincing reason" for grant of interim bail, and added that "it also appears that so called exam related anxiety of the child does not seem to be his (father's) priority". The judge said there was no

apparent reason as to why close relatives (older sibling, father and maternal aunts, i.E., mausis) cannot provide the requisite moral support to the child during his examinations. The argument that they cannot be a substitute for the mother to address the exam related anxiety of the child is not a compelling reason to grant interim bail, she said.

ndian Institute of Technology **▲**(IIT) Jodhpur researchers have developed a nanosensor that helps in the quick detection of Cytokines, a group of proteins that regulate various cells. This development aims to reduce the mortality rate occurring due to delayed diagnosis and a lack of early warnings, according to a statement here. Moreover, the technology has immense potential to be used as a rapid and point-of-care technique for health monitoring, disease diagnosis, prognosis, and immune response tracking.

Cytokines are one of the many biomarkers of inflammation that are used for diagnosing diseases and tracking their progression. They play an important role in tissue damage repair, cancer development and progression, and modulating immune reactions. This is why they are important for developing precision medicine various conditions like oncology, infectiology and in rheumatological diseases, among others. The work was published by

Bioengineering, Sarvar Singh, Department of Electrical Engineering, Prof. Ajay Agarwal, Head, Department of Electrical Engineering, and Prof. Sushmita Jha, Department of Bioscience and Bioengineering at IIT Jodhpur as a conference proceeding of 2023 IEEE Applied Sensing Conference (APSCON).

Prof. Ajay Agarwal, Department of Electrical Engineering, IIT Jodhpur, said, "This technique which is currently in its development stage has provided exciting and encouraging results for three biomarkers i.e. interleukin-6 (IL-6), interleukin-ß (IL-ß), and TNF-a which are key proinflammatory cytokines, released by inflammatory cells. "As of now, the testing is done for controlled samples, but the team aims to take the technology to clinical trials soon. The group is also using this technique to develop detection and quick diagnosis of Sepsis and Fungal infections."

This novel sensor uses Surface Enhanced Raman Spectroscopy to detect analytes even at low concentrations, is based on semiconductor process technology and works on the principle of Surface Enhanced Raman Scattering

Hence, it makes this technique powerful and capable of detecting trace-level molecules with high precision and selectivity. The most widely used techniques currently for cytokine detection are enzyme-linked immunosorbent assay (ELISA) and polymerase chain reaction (PCR). These methods are reliable but highly time-consuming, requiring trained personnel and a long sample preparation or analysis time of over 6 hours. However, the sensor developed by IIT Jodhpur takes only 30 minutes in comparison and is also cost effective.

The developed sensor, a rapid and selective diagnostic technique, is used in conjunction with AI for quick and accurate data processing and analysis. By getting a faster and more robust diagnosis of a person's autoimmune diseases and bacterial infections, this sensor transform a patient's medical treatment. This way, a patient's disease can be diagnosed and tracked promptly to guide the future course of treating them, said the statement.

Former Union Minister quits BJP, to join Congress

Former Union Minister Birender Singh on Monday said he has quit the BJP and will join the Congress, the move coming almost a month after his son Brijendra Singh joined the grand old party. His wife Prem Lata Singh -- a former BJP MLA from Haryana -also quit the party.

"I have resigned from the primary membership of the BJP and sent my resignation to party chief JP Nadda. My wife, Prem Lata, who was an MLA from 2014-2019, has also quit the party. Tomorrow (Tuesday), we will join the Congress," Birender Singh (78), a prominent political figure in Haryana, told reporters in Delhi.

After quitting the BJP, Birender Singh also met Congress leader Bhupinder Singh Hooda in Delhi. Birender Singh joined the BJP nearly 10 years ago after an over four-decade stint with

After his son joined the Congress on March 10, there was speculation that Birender Singh would follow suit. Birender Singh was Union steel minister in the first gov-

ernment led by Prime Birender Singh said he had Minister Narendra Modi. He also held charge as minister of rural development, Panchayati Raj, and drinking water and sanitation.

During the agitation against the now-repealed farm laws, Birender Singh had extended his support to the farmers. Birender Singh — who also served as a minister in the Congress government led by Hooda in Haryana — is the grandson of Sir Chhotu Ram, considered as a "messiah of farmers".

Asked why he quit the BJP, Birender Singh said he had been with the Congress for 42 years but left to join the saffron party in 2014 due to "certain reasons".

When I joined BJP, I knew the ideology of this party would be different and there would be some differences between the ideologies of the two parties.

Later on, I experienced that there was a wider gap," he said."During my political ple who remained dedicated supporters," said Singh, indicating that this was not recognised by the BJP in the manner it should have been. On the farmers' agitation,

78 per cent birds cannot thrive in modified human dominated environments, says research

A team of researchers has flagged concerns that near-ly 78 per cent of the world's bird species are unable to thrive in highly modified human-dominated environments, underscoring the urgent need for conservation efforts to protect avian biodiversity. This new research comes in the backdrop of the existing statistic that notes that 14 percent of the world's 11,000 bird species are already threat-

ened extinction.Conservation actions targeted towards preserving and restoring habitats for sensitive bird species are crucial to prevent further population declines and safeguard the ecological balance. The study is published in the international science journal Global Ecology Biogeography, and it was a joint effort of researchers from the University of Helsinki (Finland), Aarhus University (Denmark), University of St Andrews (UK), and the Institute for Mediterranean Studies (Spain). "Threatened species, and species with declining populations, are less tolerant to breeding in human-dominated habitats. For example, the Fern Wren, a species occurring only in tropical forests of northeastern Australia, is endangered, has a

declining population and a very

low tolerance to any human pres-

sure," said Emma-Liina

Marjakangas, leader of the study

affiliated at both University of

Helsinki and Aarhus University.

Following the UN's Kunming-Montreal Global Biodiversity Framework, goals have been set to protect 30 per cent of the Earth's land for conservation, but not much of that percentage will be pristine habi-This study enables us to identify species that are particularly sensitive to human activity and need more protected habitats to thrive, for example the Great Snipe in Europe, the Nkulengu

Rail in Africa and the Hume's Lark in Asia. Conservation action to protect or restore habitat can then be targeted towards the species and locations that need it most, explains senior curator Aleksi Lehikoinen from the Finnish Museum of Natural History in Finland. Europe and North America had

higher proportions of human-tolerant bird species than Latin America and África did. Europe has a long history of environmental impacts spanning millennia, which, according to the researchers, may have resulted in historical disappearances of sensitive species and also in a long time frame for the remaining species to adapt to the gradually changing landscapes.

Signalling a potential shift in conflict dynamics, Israel to withdraw troops from south Gaza

fter six months of ongoing conflict and the resultant humanitarian crisis, there are signs that the intensity of the Gaza conflict is on the wane. After the death toll A signs that the lineristy of the daza commet to the daza commet to the mounted to 32,000 and 75,000 people were injured, besides 75 per cent of the population forcibly displaced, Israel has announced the withdrawal of its troops from southern Gaza. Marking a potential turning point in the ongoing strife between Israel and the Hamas, the decision comes amid mounting international pressure to de-escalate the situation. Caught in the crossfire, civilians have borne the major brunt of the bombardment, enduring unimaginable trauma and suffering. As Israel begins troop withdrawal, it is imperative to reflect on the human cost of war and the urgent need for a sustainable resolution. Throughout the conflict, civilians in south Gaza have faced relentless airstrikes, shelling and ground incursions, leading to a staggering loss of lives. The indiscriminate nature of the attacks has left families shattered, homes reduced to rub-



ble and communities torn apart. Even hospitals have not been spared. On the Israeli side, communities near the Gaza border have lived under the constant threat of rocket attacks launched by the Hamas and its sympathiser militant groups. Besides, the war has deepened existing wounds and entrenched animosities on both sides. Decades of unresolved grievances and territorial disputes have fuelled cycles of violence, making it increasingly challenging to break the cycle of conflict and build trust between the sides.

Israel's troop withdrawal decision apparently stems from a confluence of immediate factors, reflecting both internal and external pressures. Among these, two

events have played a significant role in shaping Israel's decision. One, the attack on aid workers on April 1 served as a catalyst for heightened international scrutiny and condemnation. The attack sparked outrage and prompted calls for accountability, amplifying pressure on Israel to reassess its military strategy and prioritise diplomatic solutions. Two, widespread protests against Prime Minister Netanyahu within Israel have added to the domestic pressure for change. The demonstrations, which have been going on for months, reflect growing discontent with Netanyahu's leadership. Meanwhile, Gaza continues to grapple with a severe humanitarian crisis, characterised by widespread poverty, food insecurity and lack of sanitation and healthcare facilities. There is now a glimmer of hope for respite from the bloodshed. However, the road to lasting peace remains fraught with challenges. Both Israel and the Hamas must demonstrate a genuine commitment to dialogue, negotiation and compromise to address the root causes. In addition to diplomatic efforts, the international community has a critical role in supporting peace-building initiatives and providing humanitarian assistance to those affected by the conflict. The withdrawal must be accompanied by sustained efforts to address the grievances of all parties involved and ensure that the cycle of violence is not perpetuated.

They reminisced about drinking canal water during their childhood but now, due to contamination by tourists, they are forced to rely on jaljeevan water for drinking and cooking. Sadly, even this source is under threat due to rapidly receding glaciers, compounded by the influx of tourists who pollute the pris-

he grandparents were in possession of a ten-year visa for their annual trips to Europe and they were undergoing a medical check-up to be insured. An inconsolable mother rang up her sons in England and Holland to communicate that their father was suffering from cancer. The sons to rushed to assuage the emotionally distraught parents. But where is the visa to combat cancer?

The father is currently undergoing chemotherapy and braving radiation therapy. The mother has been impacted psychologically and is a victim of innumerable ailments such as hypertension, high sugar levels, intermittent cough and has become a virtual nervous wreck.

"Why me?" Any patient will ask this question and it is gut-wrenching for the family to break the news. Cancer, also known as a malignant tumour or malignant neoplasm, is a group of diseases involving abnormal growth with the propensity to spread and ingress to other parts of the human body. The sun sign becomes an ailment!

The Geneva-based Union for International Cancer and Control, has around 800 members spread over 155 countries. The body emphatically alludes that early detection of the disease and palliative measures can challenge the sickness. WHO has analysed that there are around 7 lakh cancer deaths in India and around 10 lakh people contract the disease every year. Among women, claim oncologists breast cancer, cervical and ovarian cancer is extremely prevalent. Smoking causes cancers of the larynx and the mouth and hypertension, besides polluting the environment. Secondary smoking is equally debilitating for the passive smoker. WHO argues that cigarettes sold in underdeveloped countries tend to have higher tar content and are less likely to be filtered, potentially increasing the vulnerability of tobacco and smoking-related diseases. An anxious patient prays and hopes that the growth is benign. Sometimes, however, they are misplaced and the tumour is malignant. How is the news to be broken to the patient? It requires enormous skill and dexterity to reveal the truth to the patient and the family since both are under tremendous distress. Dr Ranjana Shrivastava, an oncologist from Australia, belabours that the news should be broken with extreme care, caution and a human touch. Apart from early detection and early cure, a change in lifestyle is fundamental in tackling this lethal disease



Exercise releases endorphins that have an analgesic effect on the human body and mind. India's wealth inequality is rising



The World Inequality Lab report says India's top one per cent of the population holds a staggering 40.1 per cent of the nation's wealth



n a diverse and democratic India, every citizen has an equal opportunity. A major global economic policy debate revolves around the pressing concern of wealth inequality in India. According to a recent research paper titled "Income and Wealth Inequality in India, 1922-2023: The Rise of the Billionaire Raj," released by The World Inequality Lab (WIL) at the Paris School of Economics, the top one percent of India's population held 40.1 percent of the country's wealth in 2022-23, marking one of the highest levels globally.

At the 2023 annual meeting of the World Economic Forum (WEF) in Davos, Switzerland, Oxfam International unequivocally released a report titled 'Survival of the Richest', revealing that the wealthiest one percent of individuals in India possess over 40 percent of the nation's total wealth. These findings have sparked significant concerns about the precision and influence of foreign research agencies' assessments of India's wealth inequality. The specific nature of these findings has had a profound global impact, singling out India's rapidly expanding economy. Clearly, the issue of wealth inequality demands a comprehensive examination and a far-reaching discourse.

The issue of wealth inequality is often discussed at the WEF summit in Davos, where influential individuals from various fields come together to address global challenges. While there may be doubts about the methodology and biases of these reports, they still provide insights for consideration and reflection. An individual's wealth is distinct from the wealth of the corporation they own. Corporate entities have various stakeholders, such as banks, shareholders, and financial agencies, and they also have liabilities. The wealth of a corporation

There is a debate about why corporations' competitive returns on their large investments are being targeted for wealth inequality, and why there is advocacy for wealth and inheritance taxes. Corporations argue that they already pay their fair share of taxes, including Corporate Tax, Goods and Services Tax (GST), Import-Export Duties, and Income Tax. Furthermore, they claim to contribute to the economy by generating employment and fulfilling their corporate social responsibility (CSR).

Some people suggest restructuring the tax system to account for both income and wealth and imposing an additional 2 per cent super tax on the wealthiest individuals to address inequality and promote economic growth and job creation. However, proponents of this idea believe that corporate competitive growth is a natural phenomenon and contributes to the country's GDP growth. The export of goods and services as a percentage of GDP has increased from 6.3 per cent in 1984 to 22.79 per cent in 2022-23. This high growth has led to significant changes in the socioeconomic fabric of civil society. Since liberalisation in the 1990s, the economy has become increasingly globalised. Before 1990, wealth creation in India was minimal, billionaires were rare, and extreme poverty was prevalent. However, today, billionaires are common, and extreme poverty is history. According to Forbes, the number of Indians with a net

wealth exceeding \$1 billion increased from just one in 1991 to 162 in 2022.

Why Corporates Are Being Targeted: It is a common but politically deliberated interpretation that corporations have exacerbated wealth inequality. There is a concern about the irrational international agencies catalysing conflict against Indian corporations, which are major contributors to the country's GDP and significant employers, especially when India ranks as the world's fifth-strongest economy.

It's important to note that existing inequalities based on gender, geography, ethnicity, race, caste, and religion already exist. Further disparities would not only harm negative global public perception, hindering efforts to eradicate poverty. Extreme inequality is not inevitable and is often the result of political misgovernance, but it can be addressed through effective interventions.

When compared to many other countries, India is relatively better off in terms of income and wealth equality. Globally, the top one per cent of the richest individuals have accumulated 46 per cent of the world's wealth over the past two years. According to Credit Suisse's Global Wealth Report-2023, Russia has the highest wealth concentration, with the top one per cent holding 60 percent of national wealth. Brazil's wealthiest one per cent holds 49.6 per cent, and in the USA, the top one percent of households own 33 per cent of the country's

Way Forward: NITI Aayog claims that 25 crore citizens were lifted out of multidimensional poverty between 2013-14 and 2022-23, still around 23 crore belowpoverty-line (BPL) families are there. The government's key task is to uplift the poor, and the sup-port of the corporate is crucial for this. Creating enough well-paying jobs is essential for reducing poverty and inequality. However, much more needs to be done to make India a less unequal coun-

The Government must ensure that every individual has a constitutional right to access resources that can help reduce poverty and inequality. The definition and identification of BPL families in India need to be reconsidered. The government should focus more on pro-poor policies for domestic resource mobilisation.

The latest updates from the World Poverty Clock indicate that extreme poverty in India has dropped to less than 3 per cent. It is imperative to address the perception of wealth inequality in the country, as reported by foreign research agencies. This raises questions about the government's commitment to poverty elimination, despite its much-touted slogan "Sabka Saath, Sabka Vikas."

Trump declines to endorse national abortion ban

Trump said he believes abortion limits should be left to the states, in a video released on Monday declining to endorse a national ban after months of mixed messages and specula-tion. "Many people have asked me what my position is on abortion and abortion rights," Trump said in the video posted on his Truth Social site. "My view is now that we have abortion where everybody wanted it from a legal standpoint, the states will determine by vote or legislation or perhaps both. And whatever they decide must be the law of the land — in this case, the law of the state." Trump, in the video, did not say when in pregnancy he believes abortion should be banned - declining to endorse a national cutoff that would have been used as a cudgel by Democrats ahead of the November election. But Trump's endorsement of the patchwork approach leaves him open to being attached to the



strictest proposed state legislation, which President Joe Biden and his reelection campaign have already been working to do. In the video, Trump again took credit for the US Supreme Court's decision to end Roe v. Wade, saying that he was "proudly the person responsible for the ending" of the constitutional right to an abortion and thanking the conservative justices who overturned it by name. While he again articulated his support for three exceptions cases of rape, incest and when the life of the mother is at risk — he went on to describe

the current legal landscape, in which different states have different restrictions following the court's Dobbs v. Jackson Women's Health Organization ruling on June 24, 2022, which upended the 1973 Roe v. Wade

'Many states will be different. Many will have a different number of weeks or some will have more conservative than others and that's what they will be," he said. "At the end of the day it's all about will of the people. The announcement declining

endorsement of a national bar drew immediate condemnation from SBA Pro-Life America, one of the country's most prominent groups opposed to abortion rights.

We are deeply disappointed in President Trump's position," said the group's president, Marjorie Dannenfelser, in a statement. 'Unborn children and their mothers deserve national protections and national advocacy from the brutality of the abortion industry. The Dobbs decision clearly allows both states and Congress to act." Biden's campaign said Trump was "endorsing every single abortion ban in the states, including abortion bans with no excep-

"And he's bragging about his role in creating this hellscape," campaign spokesperson Ammar Moussa said on X. Trump had suggested last month in a radio interview that he was leaning toward supporting a national abortion ban at around 15 weeks of pregnancy — early in the second trimester.

"The number of weeks now, people are agreeing on 15. And I'm thinking in terms of that," he said on WABC radio. "And it'll come out to something that's very reasonable. But people are really, even hard-liners are agreeing, seems to be, 15 weeks seems to be a number that people are agreeing at."

At the same time, Trump seemed reluctant to embrace a federal ban.

"Everybody agrees — you've heard this for years — all the legal scholars on both sides

agree: It's a state issue. It shouldn't be a federal issue, it's a state issue," he said. Republican-led states have ushered in a wave of new restrictions following the overturning of Roe v. Wade in 2022. More than a dozen GOPcontrolled states have banned abortion outright, while others have outlawed the procedure on increasingly diminishing time-

Other reproductive-related procedures have faced restrictions, including in vitro fertilization, which quickly became a talking point in the campaign after the Alabama Supreme Čourt ruled this year that frozen embryos can be considered children under state law. Trump said he strongly supports IVF availability. Alabama lawmakers and Republican Gov. Kay Ivey agreed to protect IVF providers from legal liability.

Democrats believe the fight over abortion rights helps them at the polls and have outperformed expectations in elections since. Voters in seven states have sided with abortion

rights supporters on ballot measures, and abortion is expected to be on the ballot in more states this year, including Florida, Maryland and New York. Trump had long argued that the Supreme Court's decision overturning Roe gave those who oppose abortion rights "tremendous power to negotiate". He said he wanted to use that leverage to strike a deal that he hoped would "make both sides happy and bring the country "togeth er" — even though the issue is one of the most contentious in American politics, with some opponents viewing abortion as murder and proponents seeing it as a fundamental women's

Trump has tried to thread the needle on abortion throughout

the campaign. He routinely takes credit for appointing the Supreme Court justices who overturned Roe v. Wade, which he has called a "moral and unconstitutional atrocity", and has called himself the "most pro-life president in American history

British, French troops march in joint parades

joined their British counterparts in the famous Changing of the Guard ceremony outside Buckingham Palace for the first time on Monday, marching together in a display of solidarity between Britain and France amid the war in Ukraine.

At a parallel ceremony in Paris, British soldiers wearing tall bearskin hats took part in an unprecedented joint military parade in front of the presidential Elysee Palace, as the French army choir sang the two national anthems, Save the King" and Marseillaise".

The twin events were to celebrate the 120th anniversary of the Entente Cordiale, the 1904 diplomatic agreement between Britain and France that paved the way for their collaboration in both World War I and World War II.In a video message posted on social media on Monday, French President Emmanuel Macron said the alliance serves as a foundation for deepening Anglo-French relations particularly at a time of the return of war.

"Our Entente Cordiale remains as relevant as ever," Macron said. "Faced with the resurgence of war in Europe, we stand together to defend the values we share and to support Ukraine as it defends itself

against its aggressor." British Foreign Secretary David Cameron and his French counterpart, Stephane Sejourne, used a joint opinion piece published on Monday in the Daily Telegraph to urge allies to boost funding for Ukraine.

"It is not for France and Britain alone to solve these challenges. But, together, we can rally others to join us in overcoming them," they wrote. "We must do even more to ensure we defeat Russia

Palestinians returning to Khan Younis

S treams of Palestinians filed into the southern Gaza city of Khan Younis on Monday to salvage what they could from the vast destruction left in the wake of Israel's offensive, a day after the Israeli military announced it was withdrawing troops from the area. Many came back to the Gaza Strip's second-largest city to find their former hometown unrecognisable. With scores of buildings destroyed or damaged, piles of rubble now sit where apartments and businesses once did. Streets have been bulldozed. Schools and hospitals were damaged by the fight-

Israel sent troops to Khan Younis in December, part of its blistering ground offensive that came in response to a Hamasled attack on October 7 into southern Israel. Israeli authorities say 1,200 people, mostly civilians, were killed and roughly 250 people taken

hostage.

The war, now in its seventh month, has killed more than 33,000 Palestinians, mostly

women and children, according to local health authorities, displaced most of the territory's 2.3 million people and left vast swaths of the beleaguered Gaza Strip uninhabitable.

Many areas, especially the city centre, have become unfit for life," said Mahmoud Abdel-Ghani, who fled Khan Younis in December when Israel began its ground invasion of the city. "I found that my house and my neighbours' houses turned to

Israel's withdrawal of troops from Khan Younis signalled the end of a key phase in its war against Hamas and brought Israeli troop levels in the tiny coastal enclave to one of the lowest since the war

Israel said the city was a major Hamas stronghold and says its operation over the past few months killed thousands of militants and inflicted heavy damage to a vast network of tunnels used by Hamas to move weapons and fighters. It also claimed to have found evidence that hostages were held in the city. With no military presence in the city, Hamas could seek to regroup there as it has in other areas where the military has scaled back forces.

The latest Israeli withdrawal also cleared the way for some Palestinians to make their way back to the area to comb through the mountains of debris to try to hold on to any possessions that remained.

Najwa Ayyash, who also was displaced from Khan Younis, said she was unable to reach her family's third floor apartment because the stairs Her brother climbed his

way up through the destruction and pulled down some possessions, including lighter clothes for her children Bassel Abu Nasser, a Khan

Younis resident who fled after an airstrike hit his home in January, said much of the city turned into rubble.

There is no sense of life there," the 37-year-old father of two children said. "They left nothing there." On Sunday, shortly after the military announced it had withdrawn lines of Palestinians could be seeing leaving Khan Younis with scant possessions. By foot and on bicycle, they carried plastic bags and laundry hampers with whatever they could gather back to where they were displaced to. One carried a rolled-up mattress. Another a standing fan. One man used his bike to move plywood.

The city also is likely filled with dangerous unexploded bombs left by the fighting. Israel's military quietly drew down troops in devastated northern Gaza earlier in the war. But it has continued to carry out airstrikes and raids in areas where it says Hamas regrouped, including Gaza's largest hospital, Shifa, leaving what the head of the World Health Organisation called "an empty shell." Israel blames Hamas for the damage, saying it fights from within civilian

Khan Younis' main Nasser Hospital has also been that target of Israeli raids, with troops storming it earlier this year because the military said the remains of hostages were

The precise state of the hospital after the troops' with-drawal was unclear. Video from the hospital showed the emergency building appearing to be intact, but debris was strewn around its interior where thousands of displaced people once sought shelter before being forced to evacuate by the military. Israel says its war aims to destroy Hamas' military and governing capabilities and return the roughly 130 remaining hostages, a quarter of whom Israel says are dead.

Red Sea navy commander hopes for more ships to repel Houthi attacks

The commander of a European Union naval mission in the Red Sea wants to significantly increase its size to better defend against possible attacks by Houthi rebels based in Yemen, as just four warships are patrolling an area twice the size of the 27nation bloc.

The EU mission — dubbed Aspides, from the Greek for "shield" — has escorted 68 ships and repelled 11 attacks since it was established less than two months ago. It only defends civilian vessels and does not take part in any military strikes. The southern part of the Red Sea is deemed a high-risk zone

"Just a single transit of one of our ships between the two larger distances to the area might take about 10 days, and also to cross the high-risk area takes almost two days," Greek navy Rear Admiral Vasilios Gryparis, the commander of the mission, told reporters in

Brussels on Monday. He said the high-risk zone "has seen multiple attacks in the past months" ranging from threats and intimidation to "complex attacks" using "shore, air and sea-based assets, drones and ballistic missiles." No one

has been hurt.

Nineteen of the 27 EU nations are involved in the mission but only four frigates are patrolling.

Iran-backed Houthi rebels, which control much of Yemen's north and west, launched a campaign of drone and missile attacks on shipping in the Red Sea in November. They have also fired missiles toward Israel, although those have largely fallen short or been intercepted.

The attacks have hit maritime trade to Egypt and Europe, with only around half the usual number of ships moving through the area. It's added up to two weeks of transit time for vessels that want to avoid the Suez Canal, hiking transport costs and shipping insurance.

The rebels have described their campaign as an effort to pressure Israel to end its war on Hamas in the Gaza Strip. The ships targeted by the Houthis, however, largely have had little or no connection to Israel, the US or other nations involved in the war.

Their campaign has continued despite more than two months of US-led retaliatory airstrikes. The EU mission also remains

S Korea launches its 2nd military spy satellite

South Korea has launched its second military spy satellite into space, days after North Korea reaffirmed its plan to satellites this year.

The Koreas each launched their first spy satellites last year -North Korea in November and South Korea in December amid heightened animosities They said their satellites would boost their abilities to monitor each other and enhance their own missile attack capabilities. South Korea's second spy satellite was launched from the Kennedy Space Center in Florida on Sunday evening local time, which was Monday morning in Seoul.

South Korea's Defense Ministry said in a statement that the satel lite was successfully separated from a rocket. It said it will check whether the satellite functions properly via its communications with an overseas ground station.

Under a contract with SpaceX, South Korea was to launch five spy satellites by 2025. South Korea's first spy satellite launch

During a key political conference in late December, North Korean leader Kim Jong Un vowed to launch three additional military spy satellite in 2024. The U.N. bans North Korea from conducting a satellite launch, considering it as a disguised test of its longrange missile technology.

US treads carefully in responding to HK's new security law

Washington (AP): The US has denounced Hong Kong's new national security law as a tool to potentially silence dissent both at home and abroad, but so far the action from Washington has been notably muted, disappointing those fighting for the Chinese territory's democracy and freedoms.

Since the law's swift passage on March 19, the US has announced visa restrictions on an unspecified number of unnamed Hong Kong officials but taken no further action. That's a far cry from 2020, when Beijing imposed national security restrictions to end months of unrest on Hong Kong streets. The U.S. responded by hitting the city's highest-ranking officials with sanctions and depriving the territory of its preferential trading status. While the new law, known as Article 23, now expands the Hong Kong government's powers to go after those it accuses of spying and to target dissidents anywhere in the world, Washington has been

The State Department declined to preview or comment on any potential actions but said it is considering all options.

Analysts suggest the Biden administration may not want to rock relations with China in an election year, especially when the impact of the law might take a while to manifest itself and any punitive U.S. measures would be unlikely to bring about meaningful change.

"U.S. policymakers appear resigned to the fact that China's takeover of Hong Kong is, for all intents and purposes, complete and irreversible," said Craig Singleton, senior China fellow at the Foundation for Defense of Democracies, a research institute based in Washington. Millions of spectators along a narrow corridor stretching from Mexico to the US to Canada eagerly awaited Monday's celestial sensation — a total eclipse of the sun - even as forecasters called for clouds. The best weather was expect-

ed at the tail end of the eclipse in Vermont and Maine, as well as New Brunswick Newfoundland. It promised

to be North America's biggest eclipse crowd ever, thanks to the densely populated path and the lure of more than four minutes of midday darkness in Texas and other choice spots. Almost everyone in North America was guaranteed at least a partial eclipse, weather permitting. "Cloud cover is one of the trickier things to forecast," National Weather Service

meteorologist Alexa Maines coast-to-coast eclipse seven explained at Cleveland's Great years ago because the moon Lakes Science Center on Sunday. "At the very least, it won't snow."

The cliff-hanging uncertainty added to the drama. Rain or shine, "it's just about sharing the experience with other people," said Chris Lomas from Gotham, England, who was staying at a sold-out trailer resort outside Dallas, the biggest city in totality's path. For Monday's full eclipse, the moon was due to slip right in front of the sun, entirely blocking it. The resulting twilight, with only the sun's outer atmosphere or corona visible, would be long enough for birds and other animals to fall silent, and for planets, stars and maybe even

a comet to pop out. The out-of-sync darkness lasts up to 4 minutes, 28 seconds. That's almost twice as long as it was during the U.S. pletely out of sight during an (435 kilometers) up.

is closer to Earth. It will be another 21 years before the U.S. sees another total solar eclipse on this scale.

Extending five hours from the first bite out of the sun to the last, Monday's eclipse begins in the Pacific and makes landfall at Mazatlan, Mexico, before moving into Texas, Oklahoma, Arkansas and 12 other U.S. states in the Midwest, Middle Atlantic and New England, and then Canada. Last stop: Newfoundland, with the eclipse ending in the North Atlantic.It will take just 1 hour, 40 minutes for the moon's shadow to race more than 4,000 miles (6,500 kilometers) across the continent.

Russian state news agency Tass said the ministers would "discuss the situation in Ukraine and the Asia-Pacific region, issues of bilateral cooperation and interaction in the international arena", quoting Russian Foreign Ministry spokesperson Maria Zakharova.

China accuses US of deporting its students without valid evidence

hina on Monday accused Cthe US of forcibly deporting Chinese students without any valid evidence and warned of "resolute measures" to safeguard the interests of its nationals. The US has been overstretching the concept of national security and without any valid evidence, arbitrarily cancelled Chinese students' visas, banned them from entering the US and forcibly deported them, Chinese Foreign Ministry spokesperson Mao Ning told a media briefing here. Asked about reports that Chinese students and scholars were interrogated and forcibly deported when entering the US border at the Washington Dulles Airport and the Dallas Airport, Mao said, the US moves inflicted enormous damage on the persons concerned and obstructed people-to-people exchanges between China and the US

"The recent cases show that the US law enforcement personnel are bent on making excuses for deporting Chinese personnel. These are typical cases of selective, discriminatory and politically motivated law enforce-

"China will take resolute measures to safeguard the legitimate and lawful rights and interests of Chinese citizens. The US needs to immediately stop unjustifiably harassing," she said. China's state-run Global Times quoted Chinese Ambassador to the US Xie Feng alleging that dozens of Chinese arriving in the US, including students, were being denied entry every month over the past few months.

Pakistan court directs Imran Khan's counsel to file contempt plea

As the court resumed hearing the matter following a short break, it asked the advocate general why the court order was not implemented. The court also directed the state counsel to respond after contacting the chief commissioner's office, Adiala jail authorities, and other related entities.

Rwanda leader concerned over perceived US ambiguity about genocide victims

 $R^{\text{wandan President Paul}}_{\text{Kagame said on Monday he}}$ was concerned by what he saw as a US failure to characterise the 1994 massacres as a genocide against the country's minority Tutsis.

Kagame told reporters that the issue was an "element of discussion" in talks with former US President Bill Clinton, who led the American delegation to a ceremony Sunday commemorating the 30th anniversary of the genocide in which Hutu extremists slaughtered about 800,000 people, most of them Tutsis, in a government-orchestrated campaign.

Many Rwandans criticised US Secretary of State Antony Blinken for failing to specify

that the genocide targeted the the memory of the victims. US Tutsis when he wrote late Sunday: "We mourn the many thousands of Tutsis, Hutus, Twas, and others whose lives were lost during 100 days of unspeakable violence." Responding to a journalist's

question about Blinken's post on the social platform X, Kagame said he believed he had reached an agreement with US authorities a decade ago for them not to voice any criticism on the genocide anniversary. "Give us that day," he said, adding that criticism over "everything we are thought not to have at all" is unwanted on the genocide anniversary. Rwandan authorities insist any ambiguity on who the genocide victims were is an attempt to

officials did not comment on Monday. President Joe Biden issued a statement on Sunday, saying, "We will never forget the horrors of those 100 days, the pain and loss suffered by the people of Rwanda, or the shared humanity that connects us all, which hate can never overcome.

The question of how to memorialise the genocide stems from allegations that the Rwandan Patriotic Front — the rebel group that stopped the massacres and has ruled Rwanda unchallenged since 1994 carried out its own revenge killings during and after the genocide.

Kagame has previously said that his forces showed restraint. distort history and disrespects He said in a speech Sunday that Rwandans are disgusted by what he described as the hypocrisy of Western nations that failed to stop the genocide. The genocide was ignited when

a plane carrying then-President Juvenal Habvarimana, a Hutu, was shot down over Kigali on April 6, 1994. The Tutsis were blamed for downing the plane and killing the president, and became targets in massacres led by Hutu extremists that lasted over 100 days. Some moderate Hutus who tried to protect members of the Tutsi minority were also killed.

Ás part of week-long commemorations, flags flew at halfstaff and public places across Rwanda were told to keep entertainment quiet.

In February, the US urged Rwanda to withdrawal its troops and missile systems from eastern Congo, for the first time describing the M23 as a Rwanda-backed rebel group. UN experts have said they

had "solid evidence" that members of Rwanda's armed forces were conducting operations there in support of M23, whose rebellion has caused the displacement of hundreds of thousands of people in Congo's North Kivu's province.

Kagame said on Monday that the M23 are fighting for the rights of Congolese Tutsis, with at least 100,000 of them now seeking shelter in Rwanda after fleeing attacks in eastern Congo. 

Conference in Barcelona. Of course, he added banks need to do their own due diligence, assess their risk appetite, and then move forward carefully in this direction

"Going forward, our focus should be on enhancing and widening the participation of Indian players in markets for INRderivatives, both domestically and offshore, while being prudent," the governor said.

He noted that the recent financial market reforms undertaken by the Reserve Bank are aimed at providing a strong bedrock for markets to move to the next trajectory for meeting the growing funding requirements in the economy, providing costeffective hedging options and
