MVA seals Maharashtra seat deal call for trifurcation

After weeks of negotiations that involved exaggerated claims, aggressive posturing, climb-downs compromises, the Opposition Maha Vikas Aghadi (MVA) on Tuesday announced the seat-sharing arrangement reached among its three constituents — Shiv Sena (UBT), Congress and NCP (Sharad Pawar — for all the 48 Lok Sabha constituencies in the State.

Under the seat-sharing arrangement, the Shiv Sena (UBT) has walked away with the lion's share of 21 Lok Sabha seats, the Congress has been allotted 17 seats and the Sharad Pawar-led NCP has settled down for the remaining 10 seats.

Being the pivot of the Opposition front in the State, the Congress has made maximum sacrifices, by giving up the seats of Sangli and Bhiwandi seats to the Shiv Sena (UBT) and the NCP (SP), respectively

At a joint Press conference held at at 'Shivalaya', the Shiv Sena (UBT) office in south Mumbai, NCP (SP) chief Sharad Pawar, Shiv Sena Uddhav leader Thackeray and State Congress Nana Patole president unveiled the seat-sharing arrangement hammered out by them for the Lok Sabha polls to be held in the state in five phases from April 19 to

Ademand to trifurcate Tamil Nadu is getting silent momentum across the State. Though leaders of major political leaders are reluctant to come out in the open asking for the same, the intelligentsia, representatives of trade and industries bodies and farmers have expressed their anguish over the continued indifference of the DMK and the AIADMK to the needs of southern and south west Tamil Nadu.

S Ramadoss, the founder of the Pattali Makkal Katchi, an outfit of the Vanniyar community, is already on record demanding the bifurcation of Tamil Nadu into northern and southern States. "It is always better to have smaller States for administrative convenience. Events in the past have proved that division of larger States into smaller ones hasten up economic and social development," said DR Ramadoss. Northern districts of Tamil Nadu have a Vanniyar considerable population which the doctor hopes would vote for his entity so that he could anoint his son Anbumani as the Chief Minister.

Tamil Nadu has an area of 50,216 sq miles with a population of 7.2 crore GOOGLE MAPS

(according to 2011 census). The State has 38 districts and development of the regions is not in synchronisation with the population or regions, according to Arjun Sampath, founder. Hindu People's Front, an apolitical organisation. "The south west Tamil Nadu consisting of seven districts contributes more than 50 per cent of the State's revenue through industries and farming. But there is no development worth its name in the region, popularly known as Kongunadu." said Arjun Sampath.

According to Arjun Sampath, the Avinashi-Athikadavu drinking water supply-cumirrigation scheme envisaged more than six decades ago is the best proof of Chenna's indifference to the region of seven districts. "The project is yet to materialise as residents and farmers are

struggling for drinking water and irrigation water. The DMK is sore that it does not have any major presence in Kongunadu, a stronghold of the Gaunder community," said Sampath.

Both Arjun Sampath and Jayakumar, an industrialist and cultural activist of Kongunadu told The Pioneer that it was time Kongunadu was liberated from the shackles of the rulers of Chennai.

We have our own culture and heritage and need not be at the mercy of the Dravidian political parties. All major industries and industrialists are from Kongunadu belt and the Centre should initiate measures to form a separate State with Coimbatore as the capital city. The Dravidians are throttling the region by denying it all rights due to it,"

One more Indian student dies in US; 11th so far

25-year-old Indian student who had been missing since last month was found dead in the US city of Cleveland, the second death within a week in the country as the community ensure a grapples with a string of such

This is the eleventh Indian to die in the US this year and the string of Indian-origin students dying in the US continues.

Setback for Kejriwal

In a massive blow to Delhi Chief Minister Arvind Kejriwal and his party AAP which is going to the Lok Sabha polls beginning next week, the Delhi High Court on Tuesday dismissed a plea filed by him, challenging his arrest by the Enforcement Directorate (ED) in a money laundering case stemming from the alleged liquorgate scam case saying there is no contravention of

provisions. Justice Swarana Kanta Sharma upheld his arrest and subsequent remand orders of the trial court, including the order through which Kejriwal was sent to judicial custody, holding that ED was able to place enough material, statements of approvers and the AAP's own candidate stating that Kejriwal was given money for Goa elections.

The High Court order also chastised the Aam Aadmi Party (AAP) national convenor for questioning the timing of his arrest and underlined

investigation against the "classes and masses" cannot be different. The court rebuked Kejriwal for "casting aspersions" on the judicial process with his claim about an approver in the case against him making donations to the BJP through making electoral bonds, saying the law relating to approvers was over 100 years old and not enacted to falsely implicate

the politician. In its 106 pages judgement, Justice Swarana Kanta Sharma said, "... the arrest of petitioner Arvind Kejriwal was not in contravention with the law laid down by the apex court. Similarly, for the reasons recorded in para nos. 115 to 127, the impugned

(MHA) has provided Chief Election Commissioner Rajiv Kumar with a Z-category VIP security cover of armed commandos. This decision, based on a threat perception report, involves deploying approximately 40-45 armed commandos from the Central Reserve Police Force (CRPF) to ensure the safety of Kumar.

The armed commandos will accompany the CEC during his travels across the country. This is one of the rarest instances of a CEC being provided a Central security cover. Former CEC, late T N Seshan, had a Central



currently guarded by a small armed security team drawn from the Delhi Police. According to sources, the decision to upgrade the security cover of Kumar comes after Central security agencies prepared a threat perception report, which recommended robust security measures for him. They did not share the specifics of IB's threat perception report.

Under Z category security protocols, a comprehensive security detail has been deployed. A total of 33 security personnel, including CRPF commandos, have been

Calcutta HC directs CBI probe into another job scam

In yet another embarrassment for the Bengal Government ahead of the general elections, the Calcutta High Court on Tuesday directed the Central Bureau of Investigation to investigate and report within 15 days into alleged irregularities in recruitment of teachers in Darjeeling hills.

The Court's orders came following petitions based on a mysterious letter which referred to the names of a sitting minister and a former minister along with some other government employees, sources said adding the Court found substance in the allegations.

The Court's order came in tandem with Justice Joymalya

"This court wonders as to how the Directorate of Enforcement could have recorded the statement under Section 50 of PMLA of Kejriwal when he did not present himself before the investigating agency for the purpose on nine occasions. BJP seeks Kejriwal resignation after court rejects CM plea against arrest

The BJP on Tuesday seized The Delhi High Court's rejection of Chief Minister Arvind Kejriwal's plea against his arrest by the ED and its critical observations to attack the AAP convener, claiming the movement which began with the Indian Against Corruption stir has now turned into "Kejri Corruption Kranti". The BJP also pushed for the chief minister's resignation, with its Delhi unit president Virendra Sachdeva asking if he is now left with any moral right to continue while he remains under arrest. Addressing a press conference, BJP's national ence, BJP's national spokesperson Sudhanshu Trivedi cited several observations of the high court to slam the Aam Aadmi Party (AAP) and its chief, accusing them of trying to politicise investigation and judicial processes.
Trivedi also cited the court's stand that the law applied equally to all and courts were concerned with constitutional morality and not political morality, apparently referring to the claim by Kejriwal and AAP that he was arrested to jeopardise his party's Lok Sabha poll campaign.

The court's decision has smashed the arrogance of the Aam Aadmi Party, the BJP

that the judge also observed that the material brought by the Enforcement Directorate has shown that Kejriwal "conspired" in the framing of the excise policy and was "involved" in the proceeds of the crime.

The ED can't be directed to carry out the investigation as per the convenience of the person, and there can't be one law for the common man and another for a chief minister, he said, referring to the court's decision. The Delhi High Court on Tuesday rebuked Chief Minister Arvind Kejriwal for "casting aspersions" on the judicial process with his claim about an approver in the money laundering case against him making donations to the BJP through electoral hands against all the same and the same against the same against all the same against a sam toral bonds, saying the law relating to approvers was over 100 years old and not enacted to falsely implicate the AAP leader.

The high court, which rejected Kejriwal's petition challenging his arrest in the money laundering case linked to the alleged Delhi excise policy scam, said it was not concerned with who purchased electoral bonds for whom and that it was only responsible for applying provisions of law to the case before it.

Justice Swarana Kanta Sharma, while dismissing the AAP national convenor's petition against his arrest and subsequent remand in the Enforcement Directorate's (ED) custody, said casting aspersions on the manner of granting pardon or recording statements of approvers amounted to casting aspersions on the judicial process.



In his petition, Kejriwal sought his release on several grounds, including that the statements of approvers Raghav Magunta and Sarath Reddy cannot be

relied upon as the latter even donated to the ruling party through electoral bonds. Aurobindo Pharma purchased electoral bonds worth Rs 5 crore on November 15, 2022, five days after one of its direc-

tors, Reddy, was arrested in the excise case by the ED.According to data released by the Election Commission, the company had bought electoral bonds for a total of Rs 52 crore with more than half of it going to the Bharatiya Janata

"In this court's opinion, who gives tickets for contesting elections to whom or who purchases electoral bonds and for what purpose is not the

concern of this court as this court is required to apply the law and the evidence recorded as it is," the court observed in its judgement.

Asserting that the law of approver was "more than 100 years old" and was not enacted to "falsely implicate the present petitioner", the court said the statements of approvers against the AAP leader would be judged during trial and it cannot hold a mini trial at this stage.

It said the present case was neither the first nor the last in which approvers' statements were recorded and relied upon by the prosecution, and Kejriwal would be free to cross-examine the approvers at the stage of trial.

To doubt and cast aspersions regarding the manner of granting pardon or recording statements of approvers amounts to casting aspersions on the judicial process since granting of pardon or recording of statement of the approver is not the domain of the investigating agency. It is judicial process wherein a judicial officer follows the provisions of CrPC for recording the statement of approver and also granting or not granting pardon," the court said.

Investigation against classes, masses cannot be different: HC

Political considerations are not relevant to the legal process, the Delhi High Court said on Tuesday, as it dis-missed Chief Minister Arvind Kejriwal's petition challenging his arrest in a money laundering case and questioning its timing, holding that an inves-tigation against "classes and masses" cannot be different. Kejriwal, who was arrested by

the ED on March 21 after he skipped nine summonses for his appearance, had argued that the federal anti-money laundering agency could have questioned him through video conference or by sending a questionnaire or quizzed him at his residence. "In this court's opinion, this

contention has to be rejected since the investigating agency under the Indian criminal jurisprudence cannot be directed to conduct the investigation in accordance with convenience or dictates of a person. ...Investigation qua classes and masses cannot be different," Justice Swarana Kanta Sharma said in her verdict.

The investigation, she said, has to take its own course, and if the investigating agency was direct-



ed to visit the house of every such person for probe, the very purpose of investigation would be lost and end in chaos.

'This court would not lay down two different categories of laws — one for the common citizens and the other granting special privilege to be extended by investigating agencies either to a chief minister or any person in power only on the basis of being in public office...The accountability of public figures has to be held through the public," it said.

The court observed that it cannot accept Kejriwal's contention that he was arrested on account of the upcoming Lok Sabha polls, adding that the issue has to be examined only in the context of law, and not the timing.

"In the absence of any malafide intention on part of ED which

accepting this argument would mean that in case the petitioner would have been arrested in October 2023 itself, his arrest would not have been challenged on the ground of malafide since elections were not declared at the time," the court observed.

"Kejriwal also must be aware of the impending Lok Sabha election dates which were likely to be declared in the month of March 2024. He would have known when LS elections will be declared and he would be very busy at that time," it

The court opined said uphold-

ing Kejriwal's stand would mean allowing a person, who delays in presenting himself before the investigating agency, to take advantage of the situation and later plead malafide. "ED was in possession of enough material which had led them to arrest the present accused.. Non-joining probe by Kejriwal was only a contributory factor and not the only factor," it said.

The court clarified the present case was not of a "conflict" between the Centre and the Delhi CM, and it was crucial to focus solely on the legal merits of the case.

March 2024 warmest ever

12 months average temperature reaches new record

The world experienced the warmest March ever due to a combined effect of El Nino and human-caused climate change, making it the 10th consecutive month since June last year to set a new temperature record, the European Union's climate agency said on Tuesday. The Copernicus Climate Change Service (C3S) said the average temperature of 14.14 degrees Celsius in March was 1.68 degrees Celsius higher than the month's average for 1850-1900, the designated preindustrial reference period. It is 0.73 degrees Celsius above the 1991-2020 average for

Globally, 2023 was the warmest year in the 174-year observational record, with the global ture at 1.45 degrees Celsius above the pre-industrial baseline (1850-1900).

The warming may set a new record in 2024 as scientists say El Nino — periodic warming of the ocean surface in the central and eastern tropical Pacific Ocean — typically has the greatest impact on global climate in the second year of its development.

The continuing, albeit weaker, El Nino and predicted abovenormal sea-surface temperatures over much of the global oceans are expected to lead to above-normal temperatures over almost all land areas until May and influence regional rainfall patterns, the World Meteorological Organisation (WMO) said in a March

The India Meteorological Department has also warned of extreme heat during the April-June period when around a billion people are expected to exercise their franchise during the seven-phase general elections, heightening concerns about vulnerability to heat

The Supreme Court said on Tuesday it will hear on April 16 a batch of pleas seeking cross-verification of the votes cast with Voter Verifiable Paper Audit Trail (VVPAT).

The VVPAT is an independent vote verification system which enables an elector to see whether his vote was cast correctly. It generates a paper slip which can be viewed by the voter. It is kept in a sealed cover and can be opened in case of a dispute.

A bench of Justices Sanjiv Khanna and Dipankar Datta, which could not take up the petitions related to Electronic Voting Machines (EVM), said it will consider all pleas in the matter for hearing on next

NIA arrests key accused in ₹700 crore narcotics haul case at Attari



The National Investigation Agency (NIA) arrested Harwinder Singh alias Soshi Pannu, the key accused in the Rs 700 crore worth narcotics haul case, at Punjab's Attari in 2022, an official statement issued on Tuesday said.

The accused, a resident of Naushehra Pannuan in Punjab's Tarn Taran, used to distribute drugs, handle cash and launder drug proceeds through banking as well as hawala channels, as per the NIA investigations.

The NIA has made another major breakthrough in the Attari drug seizure case with the arrest of the key accused found to be actively involved in drug dealing and quality testing besides handling the proceeds of narcotics smuggling, the probe agency said in the statement. With this, the total number of

arrests in the case has gone up to six, it added. The case relates to a major con-



drugs in India through various distributors and channelise the proceeds to foreign-based masterminds. The case came to light following two seizures, totalling 102.784 kgs of heroin drug valuing approximately Rs 700 crore, in April 2022 by the Indian customs, the NIA said. The drugs, which had been concealed in a consignment of Licorice roots (Mulethi), had arrived in India from Afghanistan through Integrated Check Post (ICP) Attari,

Amritsar, it said. The NIA, on taking over the investigation, had found that on spiracy hatched by the internathe directions of Dubai-based Ahmed alias Qazi Abdul Wadood, the heroin consignment was sent into India by Afghanistan-based accused Nazir Ahmed Qani. It was meant for delivery to accused Razi Haider Zaidi in

India for further distribution across the country, the probe agency said. Razi Haider Zaidi and Vipin Mittal were arrested earlier in the case. The proceeds of narcotics

amounting to Rs 1.34 crore were recovered from another coaccused, Amritpal Singh, and frozen under relevant legal provisions. Amritpal Singh was arrested on December 15, 2023, while

attempting to flee the country. Shahid Ahmed alias Qazi Abdul Wadood and Nazir Ahmed Qani are absconding, the NIA said. A chargesheet was filed by the NIA earlier on December 16, 2022, against four accused persons, Shahid Ahmed alias Qazi Abdul Wadood, Nazir Ahmed Qani, Razi Haider Zaidi and Vipin Mittal, it added.

ED arrests one more man in ₹5,000 crore cyber fraud case

The Enforcement Directorate on Tuesday said it has made a fresh arrest in an ongoing money-laundering investigation linked to the alleged duping of common people to the tune of about Rs 5,000 crore through cybercrimes and online gaming.

Punit Kumar aka Puneet Maheshwari was arrested on April 3 from Terminal 3 of the Indira Gandhi International Airport shortly after he arrived from Nepal, the agency said in a statement.

Kumar, a resident of Delhi's Moti Nagar area, is accused of "defrauding" the general public through various cyber fraud schemes, laundering the "proceeds of crime" and siphoning those out of India, it said.

"He devised a distinctive method of defrauding individuals, utilising servers located in the UAE to orchestrate scams, with a parallel system established in India to support the syndicate's operations in the UAE," the agency alleged. The man, the agency alleged,

is "one of the important kingpins" within a syndicate responsible for orchestrating a series of cybercrimes and online gaming schemes across India between 2020-2024, amounting to huge illicit gains of Rs 4,978 crore — all of which has been siphoned abroad.

The accused had been "avoiding" summons issued by the Enforcement Directorate (ED). The central agency last month arrested another accused in the case — Ashish Kakkar — from a hotel in Gurugram. He is lodged in jail under judicial custody at present.

The money-laundering case stems from police FIRs regis-tered in Delhi, Rajasthan, Uttar Pradesh and Haryana, and some others.

The agency said its investiga-tion into cybercrime cases has found that fraudsters use different modus operandi for cheating and generation of proceeds of crime such as investment fraud, part-time job fraud, online shopping fraud and loan fraud, among

Lost chance

Debate continues over whether adequate measures were employed to stave off the Manipur crisis

ddressing the Manipur issue during one of his election rallies, Prime Minister Narendra Modi has asserted that "timely intervention" by both the Centre and the State Government played a crucial role in improving the situation. However, the statement begs a thorough assessment as the crisis resulted in the loss of several lives and property and led to the Opposition's criticism of the two Governments being impervious to the situation. Manipur has lived through various socio-political issues, including ethnic tensions, insurgency and demands for greater autonomy. This has led to a long military presence in the State, much to the consternation of the locals. The latest crisis erupted due to communal clashes and the subsequent violence exacerbated the existing challenges. Modi's assertion of timely intervention implies that the Government actions were prompt and effective in addressing the crisis. Indeed, the intervention of security forces and the deployment of additional troops might have helped restore law and order



to some extent. Moreover, the coordination between the Centre and the State Government in deploying resources and initiating dialogue could have contributed to de-escalating tensions. Both the Centre and the State had the BJP Government, so the coordination was swift. However, ground reality suggests a more nuanced but different picture. The recurring nature of crisis in Manipur indicates underlying systemic issues that require comprehensive solutions; merely addressing the symptoms is unlikely to yield lasting peace.

The Prime Minister is right when he says that action was taken swiftly. Indeed, the Army was called in but what it did is a different story. Reports of alleged excess-

es during the crisis and selective action raised concerns about accountability and the protection of civilian lives. The role of political leadership in fostering inclusive dialogue and addressing the concerns of all stakeholders is paramount in resolving conflicts. While the Government's intervention may have focused on restoring order, the efficacy of broader reconciliation efforts and addressing community grievances remains questionable. Furthermore, the assessment of the Government's response should also consider the rehabilitation and compensation measures. The loss of lives and property entails a moral obligation on the part of the Government to provide adequate support and assistance to the affected individuals. Home Minister Amit Shah did visit the State when it was burning and tried to facilitate dialogue between the warring factions, albeit with limited success. The Prime Minister's on-site absence was conspicuous. With his compelling speeches, he might have helped quell the escalating turmoil. Unfortunately, he chose not to. While Modi's assertion might hold some truth in terms of immediate crisis management, a long-term action plan is missing to date. Sustained efforts towards addressing underlying grievances, promoting dialogue, ensuring accountability and fostering inclusive development are imperative for achieving lasting peace and stability in Manipur.

Iranian 'bogey' in Palestine conflict



Israeli Prime Minister Netanyahu aims to broaden the scope of the conflict by involving Iran, leveraging the negative perceptions of Iranians in the West

or decades, US-Israel has consistently blamed Iran for most of the terror attacks, even when actual participants have hailed from countries and organisations inimical to Iran. For example, the nationalities of the 19 hijackers of the 9/11 attack were 15 from Saudi Arabia, 2 from the United Arab Emirates and 1 each from Egypt and Lebanon. All were non-Iranians or even non-Shias — each from a country then known to be staunch allies of the United States of America. Yet within months of the attacks, then US President George Bush had gone on to coin the phrase 'axis of evil' including the troika of Iran, Iraq and North

Historical and irreconcilable antipathy between a Shia extremist Iran and between Sunni supremacist forces like Osama bin Laden's Al Qaida was always conveniently ignored. The fact that most turf wars (earlier and current), be it in the unforgiving swathes of Afghanistan, Iraq or Syria are played out between sectarian and ideological proxies from either of the two distinct sides, has also been ignored.

A creative and often unconvincing conflation of the two historically-at-war forces by somehow linking with specious details of the so-called Iran 'hand' whenever there was a terror attack on assets and personnel of the 'Western' bloc (read, US-Israel-Sheikhdoms), was always insisted. The fact that Iran and its proxy Shia militias led by the likes of General Qasim Soleimani were at the forefront of taking on forces like ISIL, Al Qaida and other Sunni militias, has been successfully obliterated in larger imagi-

However, while Iran and its cosectarian proxies like Hezbollah in Lebanon or Houthis in Yemen were naturally pitted against the rival Arab/Sunni forces (sovereign or otherwise) — the disproportionate demonising of Iran with its supposed role in terrorism, almost instinctively led to blaming Iran tor all problems whilst overlooking the pernicious role the ignorance of Iranian played by the Sheikhdoms in authorities in the planning of breeding violent forces that were the 7th October attack on to go their way or even rogue e.g., Israel — the difference



Perhaps the only predominantly Sunni militia in the Middle East that has retained a modicum of support from the Iranians has been the Palestinian Hamas — they, have overlooked the sectarian angularity in favour of practicality by accepting Iranian support as the Sheikhdoms had virtually abandoned the Palestinian cause (after legitimising, normalising and formalising relations with Israel) and it was left to Tehran to support a virtually forgotten Hamas which was left to fend for itself. But realistically Iran's leverage on Hamas is not expected to be like the sort of substantial leverage it has on forces like Hezbollah, Houthis et al. Many independent experts have commented on

between 'support' and 'leverage' is key in understanding the Iranian control over Hamas. So, Iran does support Hamas, but it is highly unlikely that it was privy to the attack plans in Israel, as so secret was the operation that not only was the famed Israeli intelligence caught by complete surprise, but so were many of Hamas operatives themselves. Yet much like the instinctive name-calling of Iran as the principal enemy for everything that goes wrong in the Middle East, Israelis left no stone unturned to blame the Iranians, squarely.

In recent times, beyond the rhetorical sabre-rattling by Iran's actual proxy i.e., Hezbollah and the odd firing of rockets and gunfire (not exactly the opening of a front), both Hezbollah and Iranians have confined themselves to verbosity as opposed to any major military action. But the Israelis have way gone

beyond pulverising the Gaza Strip killing an unprecedented 30,000 Gazans, attacking NGO-Aid personnel with impunity and now even hitting the Iranian consulate building in Syria's capital, Damascus. Two senior Iranian commanders of the Quas Force along with at least 9 others have been killed. Most likely these Iranian forces would have been involved in overlooking and supporting operations in the Syrian theatre along with forces of Syrian President, Bashir al Assad (a co-sectarian ally) against forces of disparate militias from the same fount that germinated ISIL, Al Qaida etc., But like in the killing of the legendary Iranian General Suleiman Qasimi, even this time the Israelis insisted on the rote like that they had, "been behind many attacks on Israeli and American assets and had plans for additional attacks".

More likely than not, an

increasingly isolated (externally and internally) Israeli Prime Minister, Benjamin Netanyahu, is seeking to expand the conflict contours by drawing in Iran as the Iranians remain the favourite 'bogey' that elicits negative reactions amongst most Jews and Americans, irrespective of their partisan loyalties. Strangely, it legitimises Netanyahu's disproportionate belligerence and missteps by deflecting blame games from himself by taking on the Iranians, who were not exactly the primary participants. It is an age-old invocation of a formula of convenience and half-truths.



Turkey, Israel engage in trade tit-for-tat

Turkey and Israel announced tit-for-tat trade barriers on Tuesday as relations between them further deteriorated amid the war in Gaza. Turkey, a staunch critic of Israel's military actions in Gaza, first announced that it was restricting exports of 54 types of products to Israel with immediate effect. The products include aluminum, steel, construction products, jet fuel and chemical fertilizers. Responding to the Turkish trade restrictions, Israel said it was preparing a ban on products

from Turkey. The move came a day after Turkish Foreign Minister Hakan Fidan said Israel had barred Turkish military cargo planes from joining an operation to airdrop humanitarian aid to Gaza and vowed to respond with a series of measures against Israel

Gaza and allows aid to flow in without interruptions.

'There is no excuse for Israel to block our attempt to deliver aid by air to starving people of Gaza," Fidan said, in announcing retaliatory steps against

The trade-restricting measures also come as Turkish President Recep Tayyip Erdogan's government is faced with intense pressure at home to halt trade with

Critics accuse the government of engaging in double standards by leveling strong accusations against Israel while continuing lucrative commercial relations. Erdogan, whose ruling party has roots in Turkey's Islamic movement, has been an outspoken critic of Israel's treatment of the Palestinians since coming into office in 2003.

The Turkish leader stepped up

his criticism of Israel following its military actions in Gaza, describing Israel's actions in Gaza as war crimes verging on "genocide" and asserting that the Hamas militant group, considered a terrorist organization by Israel, the United States and European Union, is a group fighting for the liberation of its lands and people

In a post on X, Israeli Foreign Minister Israel Katz said Erdogan was "once again sacrificing the economic interests of the people of Turkey for his support of the Hamas murderers in

In the same post, he said had contacted organizations in the US and asked them to stop investing in Turkey and refrain from importing Turkish goods. Turkish exports to Israel amounted to USD 5.4 billion in 2023, according to the Turkish

Mixed rulings in EU court on climate cases

Europe's highest human Trights court ruled Tuesday that its member nations have an obligation to protect their citizens from the ill effects of climate change, but still threw out a high-profile case brought by six Portuguese youngsters aimed at forcing countries to reduce greenhouse gas emissions. The European Court of Human Rights sided with more than 2,000 Swiss members of Senior Women for Climate Protection, who also sought such measures in a mixed session of judgements in which a French mayor similarly seeking stronger government efforts to combat climate change was also defeated.

Lawyers for all three had hoped the Strasbourg court would find that national governments have a legal duty to make sure global warming is held to 1.5 degrees Celsius (2.7 degrees Fahrenheit) above preindustrial levels, in line with the goals of the Paris climate agreewin against all the countries, so obviously I'm disappointed that this didn't happen," said 19-year-od Sofia Oliveira, one of the Portuguese plaintiffs. "But the most important thing is that the Court has said in the Swiss women's case that governments must cut their emissions more to protect human rights. So, their win is a win for us, too, and a win for everyone!

In a reference to its fundamental Convention of Human Rights, "the court found that Art. 8 of the Convention encompasses a right for individuals to effective protection by the state authorities from the serious adverse effects of climate change on their lives, health, well-being and quality of Judgments from the European

Court of Human Rights set a legal precedent against which future lawsuits would be judged in the Council of Europe's 46 member states.

Although activists have had successes with lawsuits in domestic proceedings, this was the first time an international court ruled on climate change. "This is a turning point," said Corina Heri, an expert in climate change litigation at the University of Zurich. She said Tuesday's decision confirms for the first time that countries have an obligation to protect people from the effects of climate change and will open the door to more legal challenges. Ahead of the ruling, a large crowd gathered in front of the court building to cheer and wave flags, including climate activist Greta Thunberg, who was coming off of multiple arrests during a demonstration in The Hague over the week-

The decisions have "the potential to be a watershed moment in the global fight for a livable future. A victory for any of the three cases would be one of the most significant developments on climate change since the signing of the Paris Agreement", said Gerry Liston, a lawyer with the Global Legal Action Network, which is supporting the Portuguese students.

The European Union, which doesn't include Switzerland, currently has a target to be climate-neutral by 2050. Many governments have said that meeting a 2030 goal would be economically unattainable. The groups were confident that the 17 judges would rule in their favor, but the mixed decision could undermine a previous ruling in the Netherlands. In 2019, the Dutch Supreme Court ordered the government to cut emissions by at least 25% by the end of 2020 from benchmark 1990 levels.

The Urgenda decision, referring to the climate group that brought the case, relied on the European Convention of Human Rights. It could be overturned if Tuesday's decision concludes there is no legal obligation for countries to com-

Germany rejects allegations that it's facilitating acts of genocide in Gaza at UN court

ermany on Tuesday strong-Uly rejected a case brought by Nicaragua at the United Nations' top court accusing Berlin of facilitating breaches of the Geneva Convention and international humanitarian law by providing arms and other support to Israel in its deadly assault on Gaza.

The minute we look closely, Nicaragua's accusations fall apart," Christian Tams, a member of Germany's legal team, told the 16-judge panel at the International Court of Justice. On Monday, Nicaragua urged judges to order a halt to German military aid to Israel, arguing that Berlin's support enables acts of genocide and breaches of international humanitarian law in Gaza.

The head of Germany's legal team, Tania von Uslar-Gleichen, said Nicaragua's claims "have no basis in fact or law. They are dependent on an assessment of conduct by Israel, not a party to these proceedings.

Preliminary hearings held on Monday and Tuesday are focused solely on Nicaragua's request for so-called provisional measures, including a court order for Berlin to halt military and other aid to Israel and reinstate funding to the UN aid agency in Gaza.

Tams said that Germany had licensed only four exports of weapons of war to Israel since October, "three of which concern test or practice equip-

Showing judges a photo of German aid being airdropped over Gaza, Tams added that Berlin continues to provide humanitarian support to Palestinians "every single day under extremely difficult conditions, constructively engaging with international partners.' Biden to meet Japan PM Kishida

Tapanese Prime Minister Fumio Kishida begins a much-anticipated visit to Washington on Tuesday aiming to spotlight shared concerns about provocative Chinese military action in the Pacific and at a rare moment of public difference between the two nations over a Japanese company's plan to buy an iconic US company

Kishida and his wife will stop by the White House Tuesday evening ahead of Wednesday's official visit and formal state dinner as President Joe Biden looks to celebrate a decadeslong ally he sees as the cornerstone of his Indo-Pacific policy. Kishida will be the fifth world leader honored by Biden with a state dinner since he took office in 2021

Ahead of the White House visit, Kishida is set to visit Arlington National Cemetery and stop by the US Chamber of Commerce Tuesday. Biden and Kishida on Wednesday will hold talks and take part in a joint news conference before Biden fetes the Japanese leader



The prime minister has also been invited to address a joint meeting of Congress on Thursday. He will be just the second Japanese leader to address the body; Shinzo Abe gave a speech to Congress in

The visit comes after Biden announced last month that he opposes the planned sale of Pittsburgh-based US Steel to Nippon Steel of Japan, exposing a marked rift in the partnership at the very moment the two leaders aim to reinforce it. Biden argued in announcing his opposition that the U.S. needs to "maintain strong

powered by American steelworkers. Ambassador Rahm Emanuel,

Biden's envoy to Tokyo, sought Monday to downplay the impact of Biden's opposition to the U.S Steel acquisition to the relationship. Emanuel noted that in February the Biden administration approved a plan that would drive billions of dollars in revenue to a U.S.-based subsidiary of the Japanese company Mitsui for crane production in the United States.

"The United States relationship with Japan is a lot deeper and stronger and more significant than a single commercial deal, said Emanuel, the former mayor of Chicago, in a joint appearance at Washington's Center for Strategic and International Studies with Japan's chief envoy to Washington. "As we would say in Chicago, you got to chill." Nippon Steel announced in December that it planned to buy U.S. Steel for \$1.4.1 billion buy U.S. Steel for \$14.1 billion in cash, raising concerns about what the transaction could mean for unionized workers, supply chains and U.S. national security. Shigeo Yamada, Japan's ambassador to Washington, declined to comment on whether Kishida would raise the Nippon-US Steel deal with Biden.

Biden has sought to place greater foreign policy focus on the Pacific even while grappling with the fallout of the Russian invasion of Ukraine and the grinding Israel-Hamas

Last year, Biden brought together Kishida and South Korean President Yoon Suk Yeol at the presidential retreat at Camp David, Maryland, a historic summit between leaders of two countries that have a difficult shared history.

S Korea's president faces major test in parliamentary polls

South Koreans vote Wednesday in a hotly contested parliamentary election that's largely seen as a referendum on conservative President Yoon Suk Yeol and a possible sign of a deepening domestic divide.

Regardless of the results, Yoon will stay in power and his major foreign policy agenda will likely continue. But a failure by his governing People Power Party to restore a parliamentary majority could make him a lame duck for the remaining three years of his single five-year term, experts

Since taking office in 2022, Yoon, a former top prosecutor, has been grappling with low approval ratings and a liberal opposition-controlled parliament that has limited his major policy platforms. Pre-election surveys indicate

that the liberal opposition parties will likely maintain a dominant position in the single-300-member chamber, National Assembly. But many observers say it's still too early to determine who will win the election because many electorates are being closely fought and many moderate voters will make last-minute choices.

"What would matter to the People Power Party is whether it can become the biggest party or the second biggest party, said Choi Jin, director of the Seoul-based Institute of Presidential Leadership. "If his party loses the elections. Yoon will find it difficult to move forward even a single step on state affairs."

Of the 300 seats, 254 are to be elected through direct votes in local districts and the other 46 allotted by the proportion of the votes cast for the parties. Election observers say candidates in about 50 to 55 local districts are in neck-and-neck races. Polling stations will open at 6 a.m. and close at 6 p.m. South Korea has 44 million eligible voters, and about 31% of

In 2019, the two countries held a pair of summit meetings, for one of which Xi travelled to Pyongyang. North Korea and China are

expected to hold a number of exchanges to mark the 75th year since they established of diplomatic ties, according to South Korea's Unification Ministry. North Korean leader Kim Jong Un has been pushing to boost partnerships with China and Russia in a bid to strength his regional footing and join a united front against the United States. Kim traveled to Russia in September for a summit with Russian President Vladimir Putin. Myanmar military begins training for draftees as resistance forces keep pressure on

Ukrainian N-plant occupied by Russia is 'extremely serious'

An explosion caused by an alleged drone attack at Europe's largest nuclear plant in Ukraine on Tuesday posed no direct threat to its safety but underscored the "extremely serious situation" at the facility that repeatedly has been caught in the war's crossfire, the UN's atomic watchdog agency said. The International Atomic Energy Agency said its team was aware of an explosion at a training centre next to the plant. It said it was "informed" the blast was from a drone

The IAEA, announcing the incident on the social platform X, gave no further details but its information presumably came from Russians occupying and running the plant since the early stages of the war.

The Zaporizhzhia Nuclear Power Plant is one of the 10 biggest nuclear plants in the of disinformation tactics. world, and fighting in the southern part of Ukraine where it is located has raised the spectre of a potential nuclear disaster like the one at Chernobyl in 1986, where a reactor exploded and blew deadly radiation across a vast area.

Neither side has in recent months been able to make significant advances along the 1,000-kilometer (620-mile) front line crossing eastern and southern Ukraine. Drones, artillery and missiles have featured heavily in what has become a war of attrition.

Cameron heads to **Washington** for Ukraine talks

Washington (AP): British Foreign Secretary David Cameron is in Washington on Tuesday to press senior Republicans to unlock money for Ukraine, after meeting a skeptical Donald Trump in Florida

Cameron says victory for Ukraine is "vital for American and European security," but the former president and presumptive Republican candidate is a critic of continued US support, and lawmakers aligned with him are holding up an aid package for Kyiv in Congress. The UK's Foreign Office confirmed the meeting and said it's "standard practice" for government ministers to meet allied nations' opposition leaders in election years.

Secretary of State Antony Blinken met in February with UK Labour Party leader Keir Starmer, who is the favourite to become prime minister in an election later this year.

When Cameron was prime minister in 2012, he met the then-Republican presidential candidate Mitt Romney. British officials did not say

how the meeting went. Cameron and Trump have had several notable differences of opinion in the past. Cameron called Trump's pro-

posal during his first presidential campaign to ban Muslims from the US "divisive, stupid

Cameron was British prime minister during the UK's 2016 referendum on whether to leave the European Union — a move he opposed but Trump enthusiastically supported. Cameron resigned after voters narrowly rejected his call to remain in the

Prime Minister Rishi Sunak unexpectedly brought Cameron back into government last year as Britain's top diplomat.

Melbourne (AP): The head of the US Indo-Pacific Command said on Tuesday that he was "very, very concerned" about China's aggression toward Philippine forces near disputed islands in the South China Sea.

The Chinese coast guard has repeatedly clashed with Philippine patrol vessels near the Philippines-occupied Second Thomas Shoal. Last month, several Filipino seamen were injured when a Chinese vessel sideswiped a smaller Philippine vessel and another two Chinese coast guard ships used high-pressure water spray to shatter the Philippine vessel's windscreen. Asked if the submerged reef in the Spratly Islands was the most dangerous flash point in his area of command, US Adm John Aquilino told a forum at the Lowy Institute, a Sydney-based international policy think tank: "I'm very concerned about what's happening at the Second

Thomas Shoal." "I'm very, very concerned about the direction it's going," Aquilino said. "These actions are dangerous, illegal and they are destabilising the region." "What's next and how far are they willing to go in that area?" Aquilino asked.

The United States, Japan, the Philippines and Australia held their first four-way joint exercises in Philippine waters in the South China Sea on Sunday, which they said were intended to uphold freedom of navigation and overflight in a region contested by China. Aquilino said the joint exercise demonstrated the nations' ability to operate safely, effectively and lawfully in the region. "Those types of events and things are exactly what we need to do to demonstrate that strength amongst the like-minded allies and partners and that we will continue to operate anywhere that international law allows," Aquilino said.

Mao said Taiwan is an inalienable part of China's territory and Taiwan's issue is its internal affair, which no external force has the right to intervene. "What is the intention of the US in trying to link the so-called 'trilateral security partnership' submarine plan with the Taiwan question?" Mao asked. China's will to defend its nation-

al sovereignty and territorial integrity is unwavering, and no one should underestimate or misjudge it, she said.

Mao also said the US, the UK. and Australia are not direct parties to the South China Sea dispute and should not intervene in efforts by the relevant parties to resolve the issue through negotiation and consultation. The recent tension in the South China Sea and increased regional confrontation are inseparable from the US actions in roping in its allies, she said, referring to Washington's backing to the Philippines which during the last few months trying to assert its claim over the Second Thomas Shoal in the South China Sea which is strongly resisted by China. The coast guard ships of China and the Philippines jostled to assert their claim over the area.

Pak deploys police and paramilitary forces ahead of Eid al-Fitr

Lahore: Pak authorities have deployed more than 100,000 police and paramilitary forces at mosques and marketplaces across the country ahead of the massive Eid al-Fitr holiday, officials said Tuesday. Eid al-Fitr, which means feast, will be celebrated in Pakistan on Wednesday, subject to sighting of the moon. The three-day holiday marks the end of Ramadan, Islam's holy month of fasting. Though attacks during Eid are rare in Pakistan, Intelligence agencies alerted the Interior Ministry that militants could use the holiday to target civilians, government and military buildings, and compounds housing police, officials said. The country has witnessed a surge in militant attacks in recent years, mostly claimed by Pakistani Taliban and separatists who mainly operate from the southwestern Baluchistan province.

Security was also being beefed up at places where high-profile personalities are expect-

ed to say their Eid prayers.

Taliban spokesperson for the Interior Ministry Abdul Mateen Qani said forces were fully alert to ensure security during Eid al-Fitr in Afghanistan. He said security forces will be including mosques.

In addition, the police chief office in the capital, Kabul, has requested that citizens avoid setting off fireworks or otherwise

disturbing the peace.

Abdullah Khan, a senior defense analyst and managing director of the Islamabad-based Pakistan Institute for Conflict and Security Studies, said he had no specific information about possible attacks, but "militants can hit soft targets, as people in a large number say their Eid prayer at mosques and open

places. On Tuesday, people were shopped as usual at various markets, with women buying bangles, jewelry and clothes for themselves and their children. More than 52,000 police were being deployed at mosques as part of a security plan under which about 8,000 police were sent to sensitive places and markets in the provincial capital Lahore, according to a statement issued by Punjab police.



Securities, said. In international markets, spot gold at Comex was trading at USD 2,350 per ounce, up USD 14 from the previous close.

Traders continue to propel the momentum which aided the gold prices to new highs on a daily basis. Further, the dollar index traded lower and

The PE activity surged with 307 deals amounting to USD 8.1 billion, which is a 51 per cent rise by value and a 10 per cent rise in volumes over the previous quarter. The retail sector led the

She heaved her lowest weight in years at the World Cup recently but Olympic silver-medallist Mirabai Chanu is actually quite chuffed about her performance as she managed it on the back of just one month's training after enduring a challenging injury breakdown.

With only four months to go for the Paris Olympics, Chanu, who was competing in her first tournament since her Asian Games breakdown, finished 12th at the IWF World Cup with a total effort of 184kg (81kg+103kg), a whopping 33kg behind China's Hou Zhihui, who will look to defend her Olympic title.

"I was delighted to be back in competition. Everything is okay now, recovery is good. I'm training at 70 per cent," Chanu told PTI.

After watching her opponents raise the bar by breaking records in the 49kg weight class, Chanu's confidence received a significant boost when she heaved the barbell after just a month of

"It felt very good. After the injury (at Asian Games), I lifted weights after 4-5 months and I got a lot of confidence,"

she said.
"Weightlifting is different, there is always fear as to what will happen. I felt confident that I was able to make a recovery so fast," added Chanu, who is exclusively managed by IOS Sports. An Asian Games medal is the only one

that Chanu, who has a personal best of 88kg in snatch and 119kg in clean and jerk, hasn't been able to get her hands on. She has stood on the podium at the Olympics, World Championships, Commonwealth Games and the Asian Championships.

In the 2022 edition of the continental in Hangzhou but also suffered hip tendonitis, with less than a year to go for the Olympics.

What ensued was a dark and challenging period for the 29-year-old as she could only do upper-body exercises and relied on her mother, who travelled to Patiala, for emotional support. "When we returned from the Asian

Games, the doctor said I need to rest. But even after that, it didn't get okay. I used to feel pain while squatting. Injury always leads to mental disturbance. You keep on thinking what will happen in the future? Will I be able to train?

"I called my family, my mother stayed here with me. That gave me a lot of support. I relaxed my mind and did the exercises that I could in 4-5 months." Chanu's perseverance paid off and she was able to make a relatively quick recovery.

"I only just started training...Hardly one month. Given that, I was able to perform well. But now we know what I have to work on and what needs to be done. Everything is going well and if things continue I will give my best in Paris." Only wrestler Sushil Kumar and shuttler PV Sindhu have won back-toback medals in individual sports for India at the Olympics.

'This time 200kg won't fetch a medal. There will be a tough fight. Plans are in place for a 205kg plus total but

execution needs to be perfect.

"The daily training will determine how the total will be in Paris," chief coach

Vijay Sharma said.

At the Tokyo Games, a total effort of 202kg was enough for Chanu to fetch the silver. But with competition increasing, Sharma reckons a 205kg plus total is the minimum she will have

"We need to work really hard for a medal. Because of the injury, we have to go slow. Every training session is important. We don't want to risk anything by going fast.

"The main training is left. 184kg was an easy task. The most important thing is to go from 184kg to 205kg. A lot of things need to be done.

"We are going slow because we have time if we go fast we can face problems. We need to peak in July-August. Slowly the training load will increase. It will happen, we just need to be injury-free." As far as the coveted 90kg snatch mark goes, both Chanu and Sharma are confident that it will come soon.

Dhoni is known for his no nonsense approach and that is how he discussed the transition with Gaikwad.

"To be honest, not really deep conversation I would say. Just we were practicing and he came and told me all this stuff," Gaikwad said in the post-match press conference after the seven-wicket win over Kolkata Knight Riders here on Monday.

"Even last year, Fleming and I used to discuss captaincy after every game, about how I felt, what changes, bowling changes what I felt we needed to do, this or that. Every game, we had oneon-one conversations so that really helped."

When asked what change had he brought in as skipper, Gaikwad asserted that he believes in continuity.

'Captaincy-wise, I don't want to be a specific kind of character. Just let things flow and keep the culture of CŠK going. The success that we had and the things we have been doing, I don't want to change a single bit of it. "I just want to come here, make

my own decisions and just give as much freedom as possible because that's what has been happening from when I joined CSK. Nothing really changes and I'm enjoying a lot."

Gaikwad's batting as the skipper this season has not been at his usual best but he made an unbeaten 67 against KKR.

When asked if captaincy had compelled him to make some changes to his batting, he said, "Sometimes there are phases where you get good balls. Sometimes there are phases

where you are slightly unlucky. Sometimes there are phases where things don't really fall in shape.

"So, you don't really need to think

on that. I always felt I was in good shape, starting really well, good headspace, so I wasn't really worried. "And captaincy, while batting, is a

totally different approach. Even when I was playing my first game, or the first fifty I scored for CSK, I think (it was a) similar kind of situation.

"We were chasing 140 and I always wanted to stay till the end and make sure I finish the innings so pretty much same. Nothing really changes even though I am captain or not," he said referring to the 138-run target set by KKR.
