was learned Commander Tiwari stayed back in Doha and is likely to return to India soon.

Prime Minister Narendra Modi will be travelling to Doha in Qatar on Wednesday after his visit to the United Emirates Foreign Secretary Vinav Kwatra announced here on Monday, adding that the Prime Minister "personally supervised' developments in the case. "Prime Minister Modi had personally supervised this issue. This (the release) is



also reflects the strength of India-Qatar ties," the Foreign Secretary said.

While speaking to reporters, Kwatra added, "The Prime Minister has personally and constantly supervised all the developments in this case and has never shied away from any initiatives that would ensure the return of Indian nationals back home?

The announcement about Modi's visit to Qatar came a day after the Gulf nation released eight jailed former Indian naval personnel. "We are gratified by Qatar's decision to release the Indians," Kwatra said.

Foreign Secretary mentioned that Modi and Sheikh Tamim bin Hamad Al Thani, the Emir of Qatar, will hold wide-ranging talks to further expand bilateral ties. The Indians returned 46 days after their death sentences, handed down last October. were commuted to jail terms of varying duration.

gratitude, saying, "We are grateful for their return. We deeply appreciate the decision of Qatar's government and the Amir to release them. We are happy to have seven of those Indian nationals back. Nitish survives trust vote Nyay Yatra shifts gears,

The newly formed Nitish Kumar-led NDA Government in Bihar won the trust vote in the State Assembly on Monday, amid a walkout by Mahagathbandhan led by RJD Chief Minister Tejashwi Yadav. In the 243-member Bihar Vidhan Sabha, a total of 129 members voted in favour of the motion of confidence. Deputy Speaker Maheshwar Hazari presided over the session as Speaker Awadh Bihari Chaudhary, a member of the RJD, was removed through resolution. Chaudhary had refused to step down despite his party losing power a fortnight ago. After declaring the motion as passed through a voice vote, Hazari ordered a headcount following a request from Parliamentary Affairs Vijay Minister Kumar Chaudhary, which was seconded by Chief Minister

NDA. Only 112 members voted against the motion. Kumar recently abandoned the Mahagathbandhan, of which the RJD was a key constituent, and returned to

Congress-led Opposition INDIA bloc ally, Rashtriya partner with the NDA, the Congress has decided to cut short their ongoing Bharat Jodo Nyay Yatra in Uttar Pradesh by skipping the western part of the State, which is the stronghold of the Jayant Chaudhary-led RLD.

The RLD has been a long time ally of the Samajwadi Party (SP) and may join hands with the BJP ahead of the Lok Sabha elections. Though there has been a rift within the RLD leaders and their legislators in the UP Assembly, Jayant has already indicated a switch-over after his grandfather, former Prime Minister Chaudhary Charan Singh, was conferred with the Bharat Ratna by the Narendra Modi Government last week. Denying that the sudden shift of the RLD towards the BJP has prompted the Congress to leave the western UP region, Congress said the change in the itinerary of the Bharat Jodo Nyay Yatra is only due to the UP Board examinations. Uttar Pradesh Congress spokesperson Anshu Awasthi said the duration of the yatra



in UP is being reduced in view of the State board examinations for Classes 10 and 12. The yatra was earlier scheduled to remain in Uttar Pradesh from February 16 to February 26 before entering Rajasthan. However, it will now end on February 21 and enter Madhya Pradesh by skipping western UP.

"Setting an example of sensitivity, Rahul Gandhi ji has prioritised public interest on many occasions. Keeping in mind the UP Board examinations starting from February 22, the Bharat Jodo Nyay Yatra will remain in Uttar Pradesh from February 16 to February 21," Awasthi said in a statement issued

"Earlier, Rahul Gandhi had cancelled his rallies in Bengal out of concern for the people the COVID-19 during period," the spokesperson added.

Elaborating on the schedule of the yatra in UP, Awasthi said it will enter the state through Varanasi February 16 and then reach Amethi on February 19 via Bhadohi, Prayagraj, and Pratapgarh.

India emerges as a global wedding destination

After Prime Minister Narendra Modi's Mann Ki Baat appeal for destination weddings within the country, more than 42 lakh weddings are expected to be solemnised this marriage season between January 15 and July 15, incurring an expenditure of Rs 5.5 lakh crore. According to estimates from a traders' body, in Delhi alone, more than four lakh marriages are expected in these six months, which would bring business prosperity worth Rs 1.5 lakh crore. A survey conducted by the research wing of the Confederation of All India

Traders (CAIT) found that

during the wedding season, it is estimated that about five lakh weddings will have an wedding, and 40,000 weddings expenditure of Rs 3 lakh per wedding, while about 10 lakh weddings will cost around Rs 6 lakh each. CAIT national president BC Bhartia revealed that following the Prime Minister's appeal, destination weddings within the country have gained popularity across all types of weddings.

Furthermore, it is projected that 10 lakh weddings will incur expenses of Rs 10 lakh per wedding, followed by 10 lakh weddings with lakh weddings with expenditures of Rs 15 lakhs per wedding. Additionally, 6 lakh

weddings are expected to have

an expenditure of Rs 25 lakh

50 lakh expenditure per wedding, and 40,000 weddings with expenses exceeding Rs 1 crore. Overall, during this sixmonth period, about Rs 5.5 lakh crore will circulate wedding-related through purchases in the markets. Last year, around 35 lakh weddings occurred during the

wedding season ending on December 14, with expenses estimated at Rs 4.25 lakh crore. The traders' body said that banquet halls, hotels, open lawns, community centres, public parks, farmhouses, and various other wedding venues are fully booked across the country, including Delhi. 

This test will be the part of the recruitment rally and will be conducted before the medical tests. Only the candidates clearing this adaptability test will be allowed to proceed

Mushroom girl & her brother arrested for alleged fraud in Pune

The Pune police arrested Mushroom girl Divya Rawat and her brother Raipal Rawat in a fraud case filed against them by a local businessman in Pune. They both were reportedly arrested on February 9. The court in Pune granted two-day custody of both to the police and both can be brought to Dehradun soon, as per the officials.

They informed that the com-

plainant Jitendra Nandkishore Bhakra, an owner of a Punebased consulting firm, had filed a case against Rawat and her brother in Pune on December 27, 2022. Bhakra has reportedly claimed that he was looking for some work for his firm in 2019 when he came in contact with Rawat. According to his claims, Rawat had proposed to him partnership in mushroom production under the reverse migration project of her company, as per the officials. Bhakra claimed that he went to Gujarat with the team for training before starting the

He claimed to have bought some machines there. During this period, it was he who bore the expenses of salary, accommodation and purchase of machines for the team members. The entire project cost about Rs 1.20 crore. Rawat gave him some of this money, which she later took back on some pretext, as per Bhakra's claims, the officials said. They further informed that the victim has claimed that when he asked Rawat for the money in 2022, she registered a case of fraud of Rs 77 lakh against him in Dehradun's Nehru Colony police station. After this, the police called him to Dehradun and arrested him. He got bail after being in jail for three months.

He later got to know via the Right to Information Act that Rawat had filed a case against him on the basis of an affidavit made in Meerut. This affidavit later turned out to be counterfeit. He filed a police complaint against Rawat and her brother in Pune. Rawat was also allegedly demanding Rs 32.5 lakh from him for the settlement of the case registered against him. He reportedly called Rawat to Pune to collect a check of Rs 10 lakh when she and her brother were arrested by the police. The police are investigating the matter, the officials added.



She suggested that individuals should consider meditation, spirituality and Yoga as means to prevent anger. Parents should closely monitor their children's behaviour and seek counselling if any changes are noticed, she added.

Kandwal further said that in light of this incident, she directed the police to take stringent action against

Kandwal also highlighted another incident of the case involving a man engaging in an obscene act with a fiveyear-old girl residing in a neighbouring colony. The victim had gone to Haridwar Kankhal area to receive Prasad. During her conversation with the police officials, she directed them to take stringent action against the accused in this matter. She stated that the police informed her that a case had been registered under the Protection of Children from Sexual Offences (POCSO) Act and other relevant sections and the accused was presented in court from where he was sent to jail.





Siddaramaiah slams arrest of Karnataka farmers heading to Delhi

Karnataka Chief Minister Siddaramaiah on Monday condemned the arrest of farmers from the State in Bhopal when they were on their way to New Delhi to take part in a protest and urged the Madhya Pradesh government to release them immediately.

According to farmers' body Samyukta Kisan Morcha (SKM), around 100 farmers from Karnataka, who were travelling in a train to the national capital to participate in the protest on February 13, were stopped at Bhopal by the state police.

Taking to social media platform 'X', Siddaramaiah said the arrest of Hubballi farmers by the Madhya Pradesh government, as they were heading to New Delhi to take part in the protest, is highly condemnable.

"I demand that the Madhya Pradesh government immediately release all the farmers from our state who have been arrested and allow them to participate in the protest at Jantar



Mantar in Delhi tomorrow. Although it is the government of Madhya Pradesh that has made the arrests, it is clear that the criminal brain behind this act is the central BJP government led by Prime Minister Narendra Modi," he alleged in

The Chief Minister further said that by arresting and intimidating them, the farmers' struggle cannot be suppressed. "Such repression might only lead more farmers to take to the streets, but the struggle of the sons and daughters of the soil will not cease. If the Central government truly cares about

peace and order, it should immediately meet the demands of the farmers and resolve the issue, rather than repressing and brutalizing them to silence," he said.

Terming the BJP as anti-farmer, Siddaramaiah further alleged that whether it's at the Centre or in the states, whenever the BJP comes to power, history bears witness that their first act of aggression is against farmers. "The first time the BJP came to power in Karnataka, farmers asking for fertilizers were ruthlessly shot down by the government led by B S

died due to the violence inflicted on protesting farmers in Delhi and Uttar Pradesh by Narendra Modi's government at the Centre," he alleged in his

post.
"Looking at the current actions of the Narendra Modi government, it seems their main aim is to intimidate the farmers into submission," he charged.

Nainital District Magistrate Vandana Singh said 120 arms licences have been cancelled in Banbhoolpura and the police are trying to trace people who took part in the rioting on February 8 in which police personnel and municipal corporation workers were attacked and a police station set on fire. Six people, including five alleged to be rioters, were killed while 60 people were injured in

the violence, officials said. "Every effort is being made to maintain peace in Haldwani,"

Singh said She added that the situation in all areas of Haldwani, including Banbhoolpura, is now "nor-

mal and under control". Nainital Senior Superintendent of Police (SSP) Prahlad Meena said additional companies of central paramilitary forces have been deployed at sensitive

Reaping discontent

Both the Cong and BIP accuse each other of remembering farmers only for votes; who is true?

he electoral war cry between the BJP and the Congress is getting only shriller: The latest point of contention is which party has done more for the welfare of villagers, farmers and the poor. With the last sitting of the 17th Lok Sabha behind us and the announcement of election dates likely anytime soon, both the sides are sharpening their attack on each other and portraying themselves as the real benefactor of the marginalised classes. It all started with the Congress making a scathing attack on Prime Minister Narendra Modi and his Government, accusing them of neglecting the welfare of rural communities, the impoverished and farmers, except during election season. In his counterattack, the Prime Minister touted the Congress' record on rural development and agricultural reforms. The party remembers farmers only at the time of elections, was Modi's charge. The Congress, one of the principal Opposition forces, has a long history of championing the cause of marginalised sections of society. However, the BJP



has made inroads into its territory and the Congress' grip on its core support base has loosened. To support its stand, the BJP argues that initiatives such as the Pradhan Mantri Kisan Samman Nidhi scheme. which provides direct income support to farmers, demonstrate its commitment to the welfare of rural communities. However, to regain lost ground, the Congress has been vocal in criticising the BJP's farm policies, including the three Bills which were later withdrawn amid huge protests.

With a massive farmers' 'Delhi Chalo' rally scheduled today, the Congress is again accusing Modi of paying lip service to these constituencies while failing to

deliver meaningful change. Though the latest salvo seems timed with the poll dates announcement, the Congress' criticism of the Modi Government's approach to rural and agrarian issues is not new. It has long accused the BJP of pursuing a development agenda that prioritises the urban elite and big business interests over the needs of the rural poor. The Congress leaders have seized upon this discontent to launch a blistering attack on the Government, alleging that the BJP's pro-corporate policies have exacerbated inequality and widened the gap between the rich and the poor; thousands of farmers still commit suicide every year. The parties may accuse each other of ignoring farmer welfare but the fact is that no one has done enough for the farmers. Their demands may again go unheard today; the bitter truth is everyone remembers farmers only for their votes.

Tensions escalate in Bab-el-Mandeb Strait



With recent attacks by Houthi rebels on vessels passing through the strait, the region faces heightened security risks which could disrupt world economy

he Bab-el-Mandeb Strait, a narrow passage linking the Red Sea to the Indian Ocean via the Gulf of Aden, has thrust itself into the international spotlight. Situated on the northern side of the Red Sea lies the renowned Suez Canal, a monumental feat of engineering connecting the Red Sea to the Mediterranean Sea. This vital waterway, spanning approximately 193 kilometres in length and nearly 200 meters in width, serves as a lifeline for global trade and maritime transportation.

However, recent events have cast a shadow over the tranquillity of these waters. The Houthis, a rebel group from Yemen, have launched a series of attacks targeting vessels passing through the Bab-el-Mandeb Strait. These assaults, primarily aimed at ships with ties to Israel, have sparked concerns over maritime security and the free movement of goods through this crucial chokepoint. In response to these escalating tensions, Operation Prosperity Guardian, spearheaded by the United States, was initiated to safeguard the Bab-el-Mandeb and ensure the unimpeded flow of maritime traffic. Over 20 nations have expressed their support for this initiative, underscoring the collective effort to protect this strategic waterway.

The motives behind the Houthi attacks are rooted in geopolitical complexities, with their actions perceived as retaliation against İsrael's military operations in Gaza. Houthi leaders have explicitly stated their intent to target any ship associated with Israel, leading to a spate of attacks on vessels carrying goods to or from the region. The Houthis contend that peace in Gaza is intrinsically linked to stability in the Red Sea, warning of further conflict if hostilities persist.

The significance of the Red Sea extends beyond its immediate vicinity, serving as a conduit for maritime trade connecting Europe to the rest of the world. The Mediterranean Sea, accessed through the Suez Canal, plays a pivotal role in global shipping tion, the blue economy routes, facilitating trade between continents and enabling vital economic exchange. Delink disinvestment from the Budget

There is a need for a paradigm shift in the approach to disinvestment; the Government must detach it from budgetary constraints and tackle legacy issues



n a briefing following the presentation of the interim Budget for the financial year (FY) 2024-25 by the Finance Minister, Nirmala Sitharaman on February 1, 2024, Finance Secretary TV Somanathan stated that the "government no longer views disinvestment - fancy nomenclature for sale of Union government shareholding in central public sector undertakings (CPSUs) - from the perspective of balancing the budget". The statement is out of sync with Sitharaman setting a target of Rs 50,000 crore as proceeds from disinvestment for the FY 2024-25 though it wasn't mentioned in her speech.

If, the government's intent was not to view it as an exercise in balancing the budget as stated by the finance secretary - then, it made no sense to fix a target. Yet, setting a target for boosting non-tax revenue receipts means that it hasn't shed its age-old stance of linking this exercise with the budget. To plan for garnering resources from the sale of government shares in CPSUs is inherently flawed. This is because unlike tax revenue, which can be projected with a degree of certainty based on the existing tax

rate and a reasonable assessment of the growth in nominal GDP, the same cannot said about proceeds from disinvestment. In this case, a lot depends on the market scenario and, in particular, the perception of investors about the company in which share-sale is contemplated. In cases where the strategic sale (it reduces

the government's holding in the CPSU to below 50 per cent or privatization) is mooted, the Government faces a bigger challenge as apart from a favourable market, it needs bidders with deep pockets. The lengthy and cumbersome process of approval and bureaucratic red tape further undermines the chances of its kicking the ball rolling just around the time when the strategic investors are ready to put in their bets.

The Niti Aayog identifies companies for disinvestment which are then considered by the Core Group of Secretaries on Divestment (CGD), a long-drawn process by itself, which takes it to the Alternative Mechanism (AM) - a group of ministers, including finance, road transport & highways, administrative reforms, etc., - for approval. After AM's approval, the Department of Investment and Public

moves a proposal for in-principal approval of the Cabinet Committee on Economic Affairs (CCEA). It is therefore not surprising that the Modi - government has missed its disinvestment targets ever since it

Asset Management (DIPAM)

started the process in 2015-16 with a particular focus on 'strategic' sales. Only during two years viz. 2017-18 and 2018-19, it achieved the target. That was primarily because, in those years, it had conducted two big-ticket sales of its shares from one CPSU to another. During 2017-18, the government sold 51.11 per cent of its shareholding in Hindustan Petroleum Corporation Limited (HPCL) to the Oil and Natural Gas Corporation (ONGC) yielding Rs 37,000 crore. In the following year, it undertook the sale of its 52.63 per cent stake in the Rural Electrification Corporation (REC) to the Power Finance Corporation (PFC) yielding Rs 13,000 crore. But, those sales can't be termed as strategic as the purchaser being another CPSU UNGC/PFC, Government continues to have effective ownership over the divested entity viz. HPCL/REC.

For the current FY, while presenting the budget on February 1, 2023, Sitharaman had set a target of Rs 51,000 crore for proceeds of disinvestment. This has since been revised downwards to Rs 30,000 crore. Against this, as of February 1, 2024, the government has raised only about Rs 12,500 crore, and it is unlikely that even the revised

divestment target will be met. At a fundamental level, disinvestment of the government's shareholding in a PSU is in effect sale of its assets. Therefore, receipts arising therefrom can only be treated as 'capital receipts' (CRs). While preparing the budget, it won't be logical to plan for receipts from this source in the same manner as it is done for revenue receipts (RRs) which are receipts generated from

the day-to-day business activities e.g. dividends on shares held by the government. The government should change the track. It should unequivocally fall in line with what the finance secretary has indicated. It should pursue share sales 'indepen-

dent' of the budget exercise. The government's tax revenue is buoyant (for three years in a row since 2021-22, these have exceeded the BE) and it is getting higher dividends from CPSUs as also higher dividends from the Reserve Bank of India (RBI) and state-run banks. These positive trends should be good enough for managing fiscal deficits. Hence, its budget need not have to depend on proceeds from disinvestment.

The FM has referred to the approach to share sales outlined in her Budget speech for 2021-22. Under it, CPSUs are divided into two broad categories i.e. strategic and non-strategic. The strategic group covers atomic energy, space and defense; transport and telecommunications; power, petroleum, coal and other minerals; and banking, insurance and financial services. The non-strategic category includes all other sectors such as industrial and consumer goods, hotel and tourist services, trading, and mar-

keting. While, the government wants to sell CPSUs in the strategic sector with the caveat that at least one (and a maximum of four) will be retained in the public sector, it will privatize 'all' undertakings in non-strategic sectors. All loss-making undertakings in the latter category will be closed. However, it needs to unshackle the process from a host of legacy issues.

Foremost, the majority ownership and control by the Government for several decades has ingrained in the bureaucrat a feeling of exercising command over the management of the PSU. Although things have improved under the Modi - dispensation (courtesy of its focus on a

'policy-driven state', and increase in transparency'), the basic ingredients remain intact. This mindset has to

Second, even after strategic sales, the government wants to remain in the driver's seat. This is amply reflected in a statement in Sitharaman's budget speech for FY 2019-20. She had stated the intent was to change the existing policy from "directly" holding 51 per cent or above in a CPSU, to one whereby its total holding, "direct" plus "indirect", is maintained at 51 per cent. This stance remains intact.

Third, it remains inclined to use CPSUs for achieving other unrelated objectives. For instance, it uses fertilizer PSUs to ensure adequate availability of this politically sensitive agri-input in every nook and corner of the country. This has come in the way of taking up the strategic sale of nine CPSUs in the fertilizer sector (it falls in the non-strategic category) recommended for sale by the Department of Public Enterprises (DPE) and Niti Aayog Despite, the deregulation of petrol and diesel prices way back in 2010/2014, the government continues to regulate their prices.

For this purpose, it rides piggyback on oil PSUs which control over 90 percent of the total sales. For this reason, the strategic sale of Bharat Petroleum Corporation Limited (BPCL) hasn't happened nearly four years after it was initially mooted in 2019-20.

Fourth, the government wants to use CPSUs to build infrastructure and invest in green transition to meet climate mitigation goals. While the argument is tenable, this doesn't undermine a case for vigorously pursuing strategic sales to maximize asset value besides involving the private sector in achieving climate goals. Modi should remove all legacy obstacles and de-bureaucratize the process of share sale.

Israeli forces rescue 2 hostages in Gaza raid that killed 67

Israeli forces rescued two hostages early Monday, storming a heavily guarded apartment in the Gaza Strip and extracting the captives under fire in a dramatic raid that was a small but symbolically significant success for Israel. The operation killed at least 67 Palestinians, including women and children, according to Palestinian health officials in the beleaguered terri-

tory.
To assist the rescue forces, heavy airstrikes pounded the area near the apartment in Rafah, a city on the southern edge of the Gaza Strip where 1.4 million Palestinians have fled to escape fighting elsewhere in the Israel-Hamas war.

The raid was celebrated in Israel as a victory in the sluggish battle to free the hostages, with more than 100 captives still held by Hamas and other Gaza militants, and briefly lifted the spirits of a nation still

reeling from Hamas' crossborder raid last year.

That means minors make up about 43 per cent of the total number of 28,176 Palestinians killed so far. About 8,400 women were also among those

The plight of the hostages has profoundly shaken Israelis and the government has made freeing the dozens of remaining captives a top aim of its war, along with destroying Hamas' military and governing capabil-

But as the fighting drags on, now in its fifth month, their freedom remains elusive and rifts have emerged in Israel over the best approach to end their

'It's critical to receive EU aid soon'

The head of the UN agency for Palestinian refugees said Monday that it's vital that it receives new European Union funding within weeks because Israel appears to be readying a ground assault on Rafah, where many civilians have taken

The aid agency UNRWA is reeling from allegations that 12 of its 13,000 Gaza staff participated in the October 7 Hamas southern Israel.UNRWA immediately fired the staff, but more than a dozen countries suspended funding worth about USD 440 million, almost half of UNRWA's budget for 2024.

Asked how important it is that UNRWA receive an 82 million euro (USD 88 million) EU payment by the end of UNRWA month,

Commissioner-General Philippe Lazzarini said, "It's absolutely critical." He has previously warned that the agency might be forced to close by the end of the month.

Two UN investigations into Israel's allegations are underway, but the European Commission -- the third biggest donor to UNRWA after the United States and Germany -- has demanded a separate audit and wants to appoint experts to carry it out.

The audit would focus "on the control systems needed to prevent the possible involvement of (UNRWA) staff in terrorist activities," the EU's executive branch said. It also is insisting on "a review of all UNRWA staff" to confirm they had no role in the attacks.

Of the UN agency's 13,000 Gaza staff members, more than 3,000 continue working there. Screening them all within weeks would be impossible and time is of the essence.

The agency has been the main supplier of food, water and shelter during the war in Gaza, where around 85 per cent of the population has been displaced.

Part of the audit would involve a new "pillar assess-ment" of UNRWA. The commission routinely carries out these checks of agencies that it funds to ensure that they're complying with EU standards.

But even the EU's crisis management commissioner, Janez Lenarcic, conceded on Monday that such an assess-ment of UNRWA "has been concluded very recently."

The agency was also included in an audit the commission launched in October, which found that no funds were reaching Hamas.

Dutch court orders Netherlands to stop export of F-35 parts to Israel

The Hague (AP): An appeals court ordered the Dutch government on Monday to halt the export of F-35 fighter jet parts to Israel, citing a clear risk of violations of international law.

A trio of human rights organisations brought a civil suit against the Netherlands in December, arguing authorities needed to reevaluate the export license in light of Israeli military action in the Gaza Strip.

'It is undeniable that there is a clear risk that the exported F-35 parts are used in serious violations of international humanitarian law," Judge Bas Boele said in reading out the ruling, eliciting cheers from several people in the courtroom. The exports must cease within seven days. The decision came as Dutch Prime Minister Mark Rutte travelled to Israel to meet with Prime Minister Benjamin Netanyahu to discuss the conflict. Rutte was also expected to separately meet with Palestinian Prime Minister Mohammad Shtayyeh.
"We are extremely grateful

that there is justice and that the court was willing to speak out on justice," lead lawyer Liesbeth Zegveld told reporters after the hearing. Oxfam Novib, Pax Nederland and The Rights Forum filed the case in December. They argued the continued transfer of the aircraft parts makes the Netherlands complicit in possible war crimes being committed by Israel in its war with

In January, a lower court sided with the government, allowing the Dutch to continue sending US-owned parts stored at a warehouse in the town of Woensdrecht to Israel.

US Defence Secy Austin hospitalised

Washington (AP): US Defence Secretary Lloyd Austin was hospitalised again on Sunday to continues to recover from prostate cancer and has transferred authorities to his deputy, the Pentagon said. Austin was diagnosed with prostate cancer in December and continues to deal with complications from his treatment.

At about 2:20 pm Sunday, he was transported by his security detail to Walter Reed National Military Medical Centre "to be seen for symptoms suggesting an emergent bladder issue", Pentagon Press Secretary Maj Gen. Pat Ryder said in a statement

While Austin initially intended to retain the "functions and duties of his office", at about 5 pm Sunday he transferred those authorities to Deputy Secretary of Defence Kathleen Hicks. As of Sunday evening, he remained hospitalised.

A statement from Walter Reed medical officials late Sunday said Austin was admitted into the critical care unit for supportive care and close monitoring. Dr. John Maddox, the trauma medical director, and Dr. Gregory Chesnut, director of the Centre for Prostate Disease Research of the Murtha Cancer Centre, said while it was unclear at this time how long Austin will remain hospitalised, "the current bladder issue is not expected to change his anticipated full recov-

The chairman of the Joint Chiefs of Staff was notified, as well as the White House and Congress. Austin was scheduled to depart Tuesday for Brussels to hold a meeting of the Ukraine contact group, which he established in 2022 to coordinate military support for Kyiv after Russia's invasion.

The Safety of Rwanda Bill pronounces the country safe, makes it harder for migrants to challenge deportation and allows the British government to ignore injunctions from the European Court of Human Rights that seek to block removals. Parliament's Joint Committee on Human Rights, which has members from both government and opposition parties, said in a report that the bill "openly invites the possibility of the UK breaching inter-

national law" and allows British officials "to act in a manner that is incompatible with human rights standards".

Scottish National Party lawmaker Joanna Cherry, who chairs the committee, said the bill "risks untold damage to the of human rights". "This bill is designed to remove vital safeguards against persecution and human rights abuses, including the fundamental right to access a court," she said. "Hostility to human rights is at its heart and no amendments can salvage it."

The Home Office said the Rwanda plan is a "bold and innovative" solution to a "major global challenge". "Rwanda is clearly a safe country that cares deeply about supporting refugees," it said in a statement. "It hosts more than 135,000 asylum seekers and stands ready to relocate people and help them rebuild their lives."

Under the policy, asylum-seekers who reach the UK in small boats across the English Channel would have their claims processed in Rwanda, and stay there permanently. The plan is key to Prime

Iraq says, US troop drawdown talks depend on peace

 $\Gamma^{ ext{he}}$ Iraqi government met again with the US government on Sunday on how to draw down American troops who have been deployed there for years combating the Islamic State. The two governments had held their first, long-awaited meeting January 27, but those meetings had been put on pause after Iran-backed militants struck a base in Jordan the very next day with a drone that killed three US service members.

In the weeks since, the US has launched multiple retaliatory strikes in Iraq and Syria including a strike last week that killed a high-ranking commander of the powerful Kataib Hezbollah militia who the US said is responsible for "directly planning and participating in attacks" on American troops in the region. Both Iraq and the

US had agreed last August to enter into talks to transition US forces from their long-standing role in assisting Iraq in combating IS. There are approximately 2,500 troops in the country, and their departure will take into account the security situation on the ground, and the capabilities of the Iraqi armed forces, the Iraq government said in a statement on Sunday posted to X, formerly Twitter.

The resumed meetings will continue to chart a path to a new bilateral relationship "as long as nothing disturbs the peace of the talks", Iraq said in its statement.

Iraq has long struggled to balance its ties with the US and Iran, both allies of the Iraqi government but regional archenemies. Since the Israel-Hamas war broke out in the wake of Hamas' October 7 attacks, Iran-aligned groups have struck at US facilities in

Iraq, Syria and Jordan 170 times, prompting retaliatory airstrikes by the US, which blames Kataib Hezbollah for a string of those attacks. The Iraqi government has

angrily condemned US airstrikes against Kataib Hezbollah, which is part of the Popular Mobilization Forces. The Popular Mobilization

Forces, or PMF, are state-sanctioned, mainly Shiite militias, which have grown into a powerful political faction estimated to have the most seats in the Iraqi parliament. But the deaths of three US

"It has been proposed that a PML-N candidate will serve as prime minister for three years and PPP's leader for two years, the source said, adding that it was not yet decided who will get the first term. RBI rules out review of action against Paytm Payments Bank

PTI ■ NEW DELHI

Reserve Bank of India Governor Shaktikanta Das on Monday ruled out any review of the central bank's action against Paytm Payments Bank (PPBL), saying the decision was taken after a comprehensive assessment of the functioning of the lender. Payments

In a major action against (PPBL), RBI, on January 31, directed it to stop accepting deposits or top-ups in any customer accounts, wallets, FASTTags and other instruments after February 29. "At the moment let me say very clearly there is no review of this (PPBL) decision. If your are expecting a review of the decision, let me very clearly say there is (going to be) no

review of the decision," Das the direction follows persistent said at a press conference after the 606th meeting of the Central Board of Directors of the Reserve Bank of India. The meeting was addressed by Finance Minister Nirmala

The governor said any decision against entities regulated by the RBI is taken comprehensive assessment.

While emphasising that RBI is supportive of the fintech sector, Das said it is also committed to protect the interest of customers as well as ensure financial stability.

The central bank is expected to soon issue a set of FAQs (Frequently Asked Questions) on the Paytm matter this week. While announcing the action against PPBL, the RBI had said





Marathon world record holder Kelvin dies in car crash

long-distance running and was a top contender for gold at the Olympics in Paris this year, was killed along with his coach in a car crash in Kenya.

Their vehicle was the only one involved in the crash late Sunday and Kiptum was driving when it veered off a road and into a ditch before hitting a tree, police said. Kiptum was 24 and one of the

most exciting prospects to emerge in road running in years, having broken the world record in only his third appearance in an elite marathon. His record, set at last year's Chicago Marathon, was ratified by international track federation Athletics just last week. World

top athletes after a number have died in road crashes, Marathon world record-holder Kelvin Kiptum, violence cases.

It happened near the town of Kapsabet in western Kenya, in the heart of the high-altitude region that's renowned as a training base for the best distance runners from Kenya and across the world. Kiptum was born and raised in

the area A third person, a 24-year-old woman, was also in the car and was taken to a hospital with serious injuries, police said. Kiptum and Hakizimana died

at the scene. Athletes and family members including Kiptum's father, gathered at the hospital mortuary where the bodies of



Kiptum and his coach were taken. One of the athletes, former women's steeplechase champion Milcah Chemos, struggled to speak while breaking down in tears. "I have no words to explain the loss of Kelvin," she said.

Kenneth Kimaiyo, a friend of Kiptum, said he arrived at the crash scene soon after it happened and Kiptum had been thrown out of the car. Photos showed the silver car with a badly mangled roof and one of the doors flung open. Kiptum was the first man to run the marathon in under 2 hours, 1 minute in an official race when he set the world record of 2:00.35 in Chicago in October, beating the mark of fellow Kenyan and marathon great Eliud Kipchoge.

Kiptum and Kipchoge were expected to provide an enticing all-Kenyan battle for marathon gold in Paris and Kiptum was

due to start his season at the Rotterdam Marathon in April, which would have been his by running the fastest time first event since breaking the ever by a marathon debutant at

World Athletics President Sebastian Coe was one of the first to offer his condolences in a statement on X, formerly Twitter. "We are shocked and deeply saddened to learn of the devastating loss of Kelvin Kiptum and his coach, Gervais Hakizimana," Coe wrote. "On behalf of all World Athletics we send our deepest condolences to their families, friends, teammates and the Kenyan nation.

'It was only earlier this week in Chicago, the place where Kelvin set his extraordinary marathon World Record, that I was able to officially ratify his historic time. An incredible athlete leaving an incredible legacy, we will miss him dearly," Coe wrote.

David Rudisha, Kenya's twotime Olympic champion in the 800 meters, wrote on X that Kiptum's death was "a huge Kiptum had immediate success

The following year, he won the London and Chicago races, two of the most prestigious marathons in the world. He set a new course record at the London Marathon last April and then became the fastest marathoner in the world months later.

While young and new to the circuit, he had already run three of the seven fastest marathon times ever recorded and was seen as a rare talent. But he was also the latest Kenyan star to die in

devastating circumstances. David Lelei, an All-Africa Games silver medalist, died in a car crash in 2010. Marathon runner Francis Kiplagat was among five people who were killed in a crash in 2018. Nicholas Bett, who won gold in the 400 meter hurdles at the 2015 world championships, also died in a car crash in 2018.
