### **Progress in talks amid tension**

The fourth round of talks between the three Union Ministers — Piyush Goel, Munda, and Nityanand Rai — and farmer representatives on Sunday, according to sources, made headway, and both sides are believed to form a committee with maximum participation from the protesters for further negotiations on the crisis.

Till the reports were being filed, the meeting was underway at a hotel in Chandigarh, and sources said in the last two hours of the meeting, the atmosphere was "friendly Sources said the farmers'

representatives, however, had decided not to budge from their demand, while the Government side decided not to come under undue pressure, and a middle path had to be worked upon.

The meeting was amid hundreds of farmers putting at Shambhu and Khanauri at Haryana Punjab borders. The two sides — Ministers and farmer leaders — had met earlier on February 8, 12, and 15, but talks remained inconclusive.

The meeting started at 8.30 pm and continued until late at night, filing the report. Agriculture and Farmer Welfare Minister Arjun Munda and Minister of Commerce and Industry Piyush Goyal went to a hotel Punjab Chief where Secretary Anurag Verma and Director-General of Police Gaurav Yadav were present.

Ahead of the farmers' meeting with three Union ministers, farmer leader Lagiit Singh Dallewal on Jagjit Singh Dallewal on Sunday said the Centre should not dilly-dally and accept the demands of

farmers before the model code of conduct comes into force.

The situation at the Delhi-Haryana borders remained by and large peaceful while tension prevailed at the two border points - Shambhu and Khanauri.

Samyukta The Morcha also decided to gherao the residences of BIP leaders in Punjab for three days starting from Tuesday. Balbir Singh Rajewal, a leader of the Samyukta Kisan Morcha (SKM), an umbrella body of various farmer unions, said they will stage protests in front of the residences of Punjab BJP leaders, including MPs, MLAs, and district MLAs, presidents, from Tuesday to Thursday.

#### **Chhattisgarh** prepares Bill to regulate conversion

RAIPUR: Chhattisgarh is preparing to introduce a Bill to regulate religious conversion. The Bill will be presented in the Chhattisgarh Assembly in the coming days, said sources. While the draft is complete, sources said some amendment be made before its final presentation

in the Vidhan Sabha. Under the proposed legislation, individuals wishing to convert to another religion will be required to fill out a form with personal details at least 60 days in advance and submit it to the District Magistrate. The District Magistrate will then request the police to assess the individual's "real intention, reason, and purpose" for conversion.

#### **Jharkhand gives** go ahead for caste based survey

RANCHI: Jharkhand Chief Minister Champai Soren has given the go-ahead for a caste-based survey in the State on the lines of the recent exercise in neighbouring Bihar, a senior official said on Sunday.

Soren has directed the personnel department to prepare a draft and place it before the Cabinet for

approval.

If everything goes according to plan, the exercise will begin after the Lok Sabha elections, the official said. "Jiski Jitni Sankhya Bhari, Uski Utni Hissedari (bigger the population, bigger the share). Jharkhand is ready," the CM posted on X, indicating the survey.

# Fliers to get baggage clearance in 30 minutes

The Bureau of Civil Aviation Security (BCAS) has directed airlines to ensure that all passengers' baggage is delivered within 30 minutes of a flight landing at an airport.

In a communiqué sent to six airlines — Air India, IndiGo, Akasa, SpiceJet, Vistara, Air India Express Connect, and Air India Express — on February 16, the BCAS asked the airlines to implement the necessary measures to ensure timely baggage delivery by February 26. "However, BCAS has directed the airlines to ensure that the

mandated levels are achieved at all airports they serve," it said. This directive follows concerns about the punctuality of baggage delivery and the receipt of complaints through social media and other channels, where being passengers reported victimised by late baggage delivery

after landing at the airport. These concerns are outlined in Service Quality Requirements of the Operation, Management, and Delivery Agreement (OMDA). The OMDA mandates stipulate that the first bag should arrive at the belt within 10 minutes of engine

arriving within 30 minutes. In an extensive survey conducted across the nation's six major airports, BCAS scrutinised the operations of seven airlines and analysed over 3,600 flight movements along with their baggage delivery processes.

According to regulations, airlines are required to ensure the delivery of passengers' baggage within a timeframe of 10 to 30 minutes following the aircraft's engine shutdown. The review revealed that while performance has improved, it still falls short of the mandated standards. BCAS monitored the shutdown, with the last bag arrival of baggage at the belts of

six major airports in January 2024 under the instructions of Minister Aviation Jyotiraditya Scindia.

Several regular air passengers have expressed frustration with onged their baggage after a long-haul flight, describing it as a tiresome exercise.

As per regulations, "airlines are required to ensure the delivery of passengers' baggage within a timeframe of 10 to 30 minutes following the aircraft's engine

shutdown."
"Since the beginning of the review exercise, the performance of all airlines has been monitored on a weekly basis and has improved but is not in line with the mandates. The mandates require the first baggage to arrive at the baggage belt within 10 minutes of shutting off the aircraft engine and the last bag within 30 minutes of the same,"

the statement said. The BCAS has set a deadline of 10 days for airlines to implement the required measures, with a target date of February 26, 2024. Failure to comply with these directives may result in further regulatory action," a MoCA official said.

The move by BCAS underscores the importance of enhancing passenger experience and operational efficiency within the aviation industry. By prioritising timely baggage delivery, airlines can enhance customer satisfaction and uphold the highest standards of service excellence.

### BJP national convention amends party constitution

The party president is generally elected through organisational polls after a few elections are carried out in at least 50 per cent of its state bodies. The state BJP organisation poll is also contingent upon elections in district bodies and so on.

Sources said when the party is busy preparing for assembly or Lok Sabha elections, it is hard to follow the laid down practice for the internal polls.

Incumbent president J P Nadda is currently on an extended tenure till June 30 in the view of Lok Sabha polls. Though the

# **Buzz over Kamal shift to BJP** sparks turmoil within Congress

A mid speculation that Congress heavyweight Kamal Nath is considering joining BJP along with his son, sitting Congress MP Nakul Nath, a potential split in the grand old party looms large as about half a dozen Madhya Pradesh MLAs loyal to Nath arrived in Delhi on Sunday.

While the party grapples with the situation in MP, where it suffered a significant defeat in recent Assembly polls, trouble is also brewing in Jharkhand after the Champai Soren-led JMM-Congress coalition council of Ministers was formed last week.

Sources in both the BJP and close associates of Nath said they are coordinating a meeting as the ruling party was preoccupied with the two-day national convention

son and is attempting to meet the top leaders of the BJP to facilitate their joining.

Dismissing speculations as rumours, Congress leader Sajjan Singh Verma claimed that Nath spoke to party leader Rahul Gandhi on Sunday afternoon, during which they discussed the Bharat Jodo Nyay Yatra, which will soon enter Madhya Pradesh.

"The veteran leader has not made any decision on leaving the party. The buzz regarding Nath's switch to the BJP has been created by the media. Nath is focused on the caste equations in the State in the upcoming Lok Sabha elections," Verma told the media after claiming to have met Nath at his residence.

Nath, a nine-time Congress MP from Chhindwara and currently an MLA from the member Assembly. seat, is a former Chief On the other hand, a section

following the Congress' dismal performance in the November Assembly polls.

The MLAs who arrived in the national Capital were not answering calls, with some Congress insiders claiming that Nath loyalist and former Minister Lakhan Ghangoriya was also camping with them in Delhi.

This is the second time that the Congress will face a split in MP, as the one led by rebel leader Jyotiraditya Scindia in 2020. Ścindia, who is now a Union Minister in the Modi Government, left Congress due to internal factionalism led by Nath.

Efforts were made by the Nath camp to garner the support of 23 MLAs so that anti-defection laws wouldn't apply to them, according to party insiders. The Congress has 66 seats in the 230-

### Antidepressant use during pregnancy can influence brain development of child: Study

Use of antidepressants during pregnancy can influence a child's brain development and increase the risk of mental health disorders later in life, according to a study, published in Nature Communications. It emphasized the importance of involving healthcare professionals in decision-making regarding individualized care for pregnant women, including discussing antidepressant benefits, side effects, and potential non-pharmacological interventions for postpartum depression.

Led by researchers at the University of Colorado Anschutz Medical Campus, the study focused on fluoxetine, a common component of medications like Prozac and Sarafem used to treat depression and perinatal depression, and its effect on the developing prefrontal cortex. Fluoxetine functions by elevating serotonin levels in the brain, prompting the researchers to investigate serotonin's impact on prefrontal cortex development in fetuses. Lead author Won Chan Oh, assistant professor in the Department of Pharmacology at CU Anschutz, explained that while serotonin's role in brain development is recognized, the specific mechanisms influencing the prefrontal cortex remained unclear. Given the prefrontal cortex's crucial role in high-order cognition, the study aimed to

address this knowledge gap. The research, conducted by Oh and Roberto Ogelman, a neuroscience candidate, revealed that serotonin directly affects nascent and immature excitatory synaptic connections in the prefrontal cortex. Disruption or dysregulation of these connections during early development can contribute to various mental health disorders. Oh emphasized that their study provides experimental evidence of serotonin's direct impact on the developing prefrontal cortex when fluoxetine is taken during pregnancy, highlighting the significance of understanding these processes. To investigate further, the

researchers studied serotonin deficiency and surplus effects on brain development in

They discovered that serotonin not only influences overall brain function but also plays a specific role in shaping individual connections between neurons, crucial for learning and adapta-

The correlation identified in the study holds potential for informing early intervention strategies and developing new therapeutics for neurodevelopmental disorders associated with serotonin dysregula-

The researchers intend to extend their investigation by examining fluoxetine's impact on the developing teenage brain, furthering our understanding of its long-term effects on brain development.



JP Nadda was nominated from Gujarat as the BJP dropped Union ministers Parshottam Rupala and Mansukh Mandaviya, who won the 2018 election from the state. Rupala and Mandaviya are likely to be fielded for the upcoming Lok Sabha polls.

The veteran leader had sought an urgent hearing of his plea in the wake of twin blows suffered by the group led by him and the consequential fear of facing action for possible violations of whip by his MLAs. Sharad had sought urgent hearing in view of the February 15 order of Maharashtra Assembly Speaker

Rahul Narwekar. Narwekar held that the NCP faction led by Ajit Pawar was the real NCP and that the anti-defection provisions in the Constitution cannot be used to stifle internal dis-

Prior to this, the poll panel announced on February 6 that the Ajit faction is the real NCP and also allotted the party's 'clock' symbol to the group. The special Maharashtra assembly session is beginning on February 20. Pawar senior, who founded the NCP with former Lok Sabha speaker Purno Sangma and Tariq Anwar in 1999 after their expulsion from the Congress, filed the petition through lawyer Abhishek Jebaraj. Prior to him, the Ajit faction had filed a caveat in the Supreme Court through advocate Abhikalp Pratap Singh to ensure that no ex-parte order is passed in favour of the Sharad Pawar group if the latter moves the top court.

### MP first to implement safe tourism destination for women scheme

m adhya}$  Pradesh, often referred to as the "Heart of India," boasts a rich cultural heritage, with numerous monuments, intricately carved temples, stupas, forts, and palaces can now also take pride in being the only State in the country to implement the central flagship scheme "Safe Tourism Destination for Women."

This initiative is noteworthy

as other states are yet to step forward to avail the funds allocated from the Nirbhaya Fund aimed at making tourist destinations safe for women. The Union Tourism Ministry revealed this before a Parliamentary panel recently. Taking exception to the states' apathy, the panel, in its report submitted to Parliament early this month, recommended the Ministry to once again take up the matter with all the other states to submit their proposals under the Scheme aimed to ensure womenfriendly tourist hotspots. As per the policy provision, a

proposal is submitted to the Central Ministry of Women and Child Development Department under the Nirbhaya Scheme for funding the project. According to the scheme, the

state has to contribute 40% share of the total budget, with the rest coming from the central fund. The Nirbhaya Fund was set

up with the idea of helping states ensure infrastructure and ambience where women should feel safe and most comfortable while traveling and enjoying tourist destina-

While states are yet to use this fund exclusively meant for women empowerment and safe tourist zones, Madhya Pradesh is in the midst of initiating several steps to ensure employment opportunities for women in the tourism sector. As per officials from the Madhya Pradesh Tourism Board, UN Women, Women and Child Development, Urban Development and Housing Department, and Police Department have joined hands to create a favorable environment for women by training them and creating awareness about their safety. Officials say the Madhya Pradesh Tourism Board has formed 20 clusters across 50 tourist spots in the state to train women in different sectors, giving priority to safe destinations for women. "The Board has already trained more than 4000 women and in 2024 plans are afoot to absorb more of them in the hotel and travel industry. The Committee recom-

mends that the Ministry should expedite its efforts in obtaining the proposals of various states. This is vital for the success of the scheme and for ensuring the safety of women at tourist destinations across the country and will help in increasing the number of tourists, especially women, to safely undertake such visits," said the parliamentary panel led by MP V Vijayasai Reddy.

"It's disheartening that states, despite the availability of funds, are reluctant to utilise them. It's widely recognised that concerns about women's safety in tourist spots hinder their ability to travel inde-

pendently.
Whether journeying alone or in groups, women often experience unease after sunset due to the limited presence of female staff in tourist areas and the inadequate provision of public facilities," lamented Priyadarsini Biswal, a solo traveler from Bhubaneswar.

oncerns of Meghalaya over the Citizenship ✓ (Amendment) Act have been addressed as most areas of the state come under the Schedule, which exempts them from the law, Chief Minister Conrad Sangma has said.

In an interview to PTI, Sangma, who heads the National People's Party (NPP), also stressed on the requirement for the T requirement for the Inner Line Permit (ILP) regime in his state, which will restrict the entry of "outsiders".

Expressing concern over the "spillover effect" in Meghalaya if the Citizenship (Amendment) Act (CAA) is implemented in other states, he said that "we have just requested the Government of India if we can still have the

ILP". "There are enough provisions in the CAA right now to protect us in one way, apart from the cutoff date that they've put and apart from the fact that 99.9 per cent is exempted... All these points are there. But we have still raised our concerns with the Government of India, and we have also asked for the extension of the ILP or any other mechanism that will help us address those concerns," he said.

"We have asked if the nonscheduled areas can also be exempted (from the law)," he

Asked about the CAA, which has faced opposition in the state that shares more than 400-km-long border with Bangladesh, Sangma said their concerns have been addressed as it excludes Schedule 6 areas.



"When the CAA had come out in the first draft, there was no provision of exemption for any state. After we raised the concern, we met the home minister, we met other leaders, then there was a revisit in the entire draft and they came up with a provision

He also mentioned a resolution passed by the state Assembly to extend the ILP to the state.

### UNLF (P) involved in violence in Manipur despite ceasefire: Officials

Security agencies have voiced concerns over the escalating violence in Manipur perpetrated by the banned United National Liberation Front (UNLF) despite the armed group signing a ceasefire agreement with the Union Government last

November, officials said on Sunday. Led by Kh Pambei, the UNLF (P) became on November 29, 2023 the first Meitei armed group in the Imphal Valley to enter into a ceasefire agreement with the government and agreed to renounce violence.

However, officials said the group has failed to disclose the number of its cadres who were supposed to be kept in a secure area, and they have not surrendered their weapons either. Reports also indicate the group's members have been setting up camps in the outskirts of areas predominantly inhabited by the Kuki population with an aim to target the tribal, the officials said. They said that based on the

agencies have observed the UNLF (P) cadres have been in engaging activities against both security forces and the general public.

The officials said the cadres were involved in looting arms ammunition from the 5th India Reserve Battalion (IRB) at Chingarel in Manipur East on February 13. Following this incident, the police arrested six individuals, including two UNLF cadre and the case is now likely to be transferred to the CBI for further investigation.



# The security of Indians abroad is paramount

The recent data revealing a distressing trend of Indian student deaths abroad underscores the pressing need for heightened awareness and intervention

he year 2024 began with a series of tragic incidents involving some Indians living in the USA, starkly highlighting the vulnerability of persons of Indian origin abroad. Recently an IT executive Vivek Taneja, 41, was killed when he tried to save a female colleague from molestation outside a restaurant in Washington. Vivek became the seventh victim of attacks that took place on Indians in America this year. A spate of incidents of death of Indians living in foreign countries has ensued in the recent past. The government of India had recently informed the Parliament that around 403 incidents of death of Indian students living abroad have been reported since 2018 due to various reasons including natural causes, accidents and medical conditions. The data reveals a disheartening scenario for Indians aspiring to go abroad for various purposes as it showed that 91 Indian students died in Canada, 48 in the UK, 40 in Russia, 36 in the US, 35 in Australia, 21 in Ukraine and 20 in Germany, 14 in Cyprus, 10 each in Philippines and Italy and nine each in Qatar, China and Among other factors responsible

for the death of Indians abroad, the crimes and attacks upon Indians have emerged as a major cause of concern. The recent incidents of attacks on Indians in America also raise concerns about the probable escalation of xenophobia and hate crimes against immigrants and minority communities in the United States. The attacks highlight the vulnerability of Indian Americans and other minority groups and underscore the need for increased awareness and intervention if the attacks were prompted by hatred and discrimination. These incidents might also be a reflection of the broader trend of racially motivated violence and anti-Asian hate crimes that witnessed a surge in anti-Asian racism and violence especially during and post the COVID-19 pandemic.

The year 2024 has witnessed many consecutive deaths of Indian or Indian-origin students justice system, and limited

access to quality education and healthcare are probable systemic issues that might require immediate attention. Reports suggest a need for greater awareness and accountability regarding systemic racism, requiring policy reforms and initiatives that promote equity and inclusion as Indian Americans become targets of hate crimes fuelled by racial or ethnic animus resulting in incidents of verbal harassment, vandalism, and physical assaults across the nation.

In cases where individuals are found responsible for crimes against Indian nationals abroad, there is a growing demand for extradition and accountability. legal Extradition of guilty persons to India for trial and punishment is essential to ensure justice and deter future crimes. India and the US had signed an extradition treaty in 1997. This treaty outlines the process for extraditing individuals who commit crimes in one country and flee to the other. While the extradition treaty exists, navigating it is usually complex and time-consuming. Delays occur due to lengthy legal processes, gathering evidence,

ernment has taken up such matters with foreign governments and has constantly expressed its concerns in the past. Indian consulates in the US and elsewhere must enhance the process of providing assistance to Indian citizens, offer guidance on various issues like legal rights, visa concerns, and emergency support

The government must raise

awareness about safety concerns and resources available to Indian citizens in foreign lands, including collaborating with community organizations. The Indian government may also consider collaborating with organizations like SAALT to provide support, resources, and advocacy for Indian communities abroad. Consulates can connect Indian citizens with legal resources and provide guidance on navigating the foreign legal system in case of discrimination or hate crimes. Tragedy in the US underscores the urgent need for multifaceted solutions. The death of Indian or Indian-origin individuals in America serves as a stark reminder of the urgent need for comprehensive measures to address the safety and security of Indian nationals living abroad.

# Farmers' demands are impractical and unrealistic -



The farmers want the Govt to withdraw from the WTO and all Free Trade Agreements, which is next to impossible in a globally interdependent world



fter three years of hibernation, farmers mostly from Punjab are back on the roads with over a dozen demands from the Union Government. If taken on board, these are sure to spell disaster. The foremost demand is securing legal guarantees for the Minimum Support Price (MSP) of their agricultural produce.

MSP is a "minimum price" for any crop that the government considers as remunerative for farmers and hence deserving of "support". Put into practice in the 1960s under an 'executive order', it was meant to assure farmers that they get at least MSP from selling their produce; that distress sale is avoided. It fixes MSP for 23 crops grown in Kharif and Rabi seasons based on the recommendations of the Commission for Agricultural Costs and Prices (CACP) - a body under the Ministry of Agriculture & Farmers

The agencies of the government, such as the Food Corporation of India (FCI), buy wheat, rice/paddy, and coarse cereals, from farmers at the MSP. The quantities thus procured are meant for giving to over 800 million beneficiaries under the National Food security Act (NFSA). At present, the ben eficiaries are getting their eligible quota for free. The entire cost of purchase, handling and distribution is borne by the government

The state agencies such as the National Agricultural Cooperative Marketing Federation of India Ltd (NAFED) also purchase other crops such as pulses and oilseeds. Apart from providing support to farmers, this helps maintain the stability of prices for consumers. However, not all crops for which MSP is announced are purchased. The MSP is not backed by any law. But, farmers want a legal guarantee for it. They would want it for all 23 crops for which MSP is currently fixed. The demand could be extended to cover all crops; in fact the entire agricultural produce.

Today, the bulk of farmers' produce is picked up by private traders, processors, aggregators, exporters etc even as government agencies buy only a small portion (over one-third in the case of paddy and wheat and a tiny fraction for other crops). When there is a law on MSP requiring that

no purchase can be made at a price less than this minimum, they will all be scared of buying from farmers. Who will take the risk of landing in

The farmers would wish that the Central government direct all the private entities to purchase their crops at MSP. Such an order would be reminiscent of the control and license Raj that existed prior to liberalization and reform initiated in 1991, perhaps even worse than that. This is a preposterous idea. The farmers can't obviously allow their crops to rot in the fields. So, they would expect the government/agencies to pick up their entire produce albeit at MSP -pointing at the 'legal guarantee'. This too is next to impossible.

Even if the purchase by government/agencies is restricted to 23 crops for which MSP is currently fixed, the Centre will have to spend at least Rs 10,00,000 crore which is equivalent to its capital expenditure (this is mainly on building infrastructure) and will consume over 45 per cent of its tax revenue. And, if it were to buy all of the farmers' agriproduce, that would require around Rs 40,00,000 crore out of its annual budget of Rs 45,00,000 crore (2023-24). That leaves a small Rs 5,00,000 crore for all others including defence, security, law and order, wages and salaries, infrastructure,

The interest payments at around Rs 10,80,000 crore (2023-24) on the Union government's outstanding debt alone are more than double this amount. Mammoth sums are spent on subsidies for agri- inputs such as fertilizers, irrigation, seeds, credit etc. The farmers want this to continue as these help them reduce production costs. With no money left after paying MSP, all this support would cease.

the wherewithal to carry out purchases on such a monumental scale. The state agencies don't have the infrastructure to handle and store even the 'limited' quantities currently procured by them leading to huge wastages. One shudder at the very thought of their having to buy the entire agri-produce. What would the state agencies do with this

They can't hang on to it forever. The stock has to be offloaded to private trade sooner rather than later. This will entail huge losses due to sales at below MSP and the cost of handling and carrying it as long as they hold. These losses will have to be paid from the taxpayer's money. And, don't forget India will be taken to task by the World Trade Organization (WTO) as the produce picked up by private traders could find its way to the international market distorting trade.

Assured purchase of the bulk of paddy and wheat offered for sale by Punjab and Haryana farmers de racto, has led to indiscriminate growing of these crops to the point of excessive use of chemical fertilisers, deterioration of soil quality, depletion of groundwater and serious environmental problems. To alleviate these, there is a dire need for crop diversification. But, providing a legal guarantee will ensure that it is business as usual; in fact, the trend will aggravate.

From the perspective of consumers also, legal backing for MSP is a bad omen. In view of a sizeable chunk of the crop produce not coming to the market (inevitable when there is no purchase/sale by private entities), there would be acute shortage resulting in an 'astronomical' rise in food prices and inflation. In such a scenario, no measure fiscal or monetary aimed at reining in price rise would work.

Agreements). In a globally inter-dependent world where India depends 'substantially' and 'inevitably' on international trade and investment to sustain the momentum of its economic activities, withdrawal from these global platforms that set the multilateral rules of trade is unthinkable. During 2022-23, India exported agri-products worth Rs 435,000 crore (US\$ 53 billion) and that goes to help farmers. They use chemical fertilizers which are mostly imported. If, India gets out of these trade agreements, none other than the farmers will be hit.

Apart from having free access to electricity for farming operations, Punjab farmers camouflage high household consumption (including ACs/coolers etc) under use for farming. To prevent

misuse, the Centre has proposed reforms such as the installation of smart meters and direct transfer of subsidy by the state government to farmers' accounts instead of the current system of asking power distribution companies or discoms, in short, to supply free of charge and latter claiming reimbursement from the former.

### Cleaning the Ganga: A troubling tale of neglect and impending disaster

#### With sewage and industrial toxins contaminating its waters, the Ganga, again faces an urgent call to action

¬he Ganges River, often called 'Ma Ganga,' by devout Hindus holds profound significance in Hindu culture, believed to have divine origins according to sacred texts. However, despite its revered status, the Ganges faces a dire threat contamination. It's not just a river; it's a lifeline, yet its waters are woefully polluted, threatening the health and well-being of millions.

India's population explosion, coupled with rapid urbanization and industrialization, has turned the Ganges into a dumping ground for toxins, sewage, and industrial waste. The consequences are dire: water unfit even for basic activities like bathing, let alone consumption. The situation is particularly dire in areas like and other industries adding upper reaches, all demanding



Kanpur and Varanasi, where human activities directly contribute to pollution levels. The scale of pollution is staggering, with reports indicating severe contamination along the river's course. Sewage treatment facilities are inadequate, leading to a massive discharge of untreated waste into the Ganges. Industrial pollution compounds the issue, with tanneries, distilleries,

toxic pollutants to the river. The relentless expansion of population, coupled with the ever-improving living standards and rapid industrial and urban growth, has laid bare the vulnerability of our water resources, with rivers bearing the brunt of this degradation. The illustrious Ganges, despite its revered status, is not immune to this onslaught. The decline in water quality directly affects communities, with certain stretches of the Ganges now deemed unsuitable even for basic activities like bathing. Compounding this issue are the looming threats of global climate change, the melting of glaciers affecting the Ganges' flow, and the adverse impacts of infrastructure projects in its

response.

Kanpur, situated in Uttar Pradesh, emerges as a poignant example of this pollution crisis. As one of the most densely populated cities in the state, its residents engage in daily activities like washing clothes, bathing, and even relieving themselves directly into water bodies, exacerbating pollution levels. Following closely behind is Varanasi, another significant contributor to Ganges pollu-

A damning report revealed that 37 out of the 41 locations along the river were plagued by moderate to severe pollution levels. Astonishingly, only the water at the Haridwar Barrage managed to meet drinking water standards, cleanliness amidst a sea of contamination. This stark reality underscores the urgent preserve and restore the Ganges' pristine waters.

Within the Ganga basin, an astonishing 12,000 million litres per day (MLD) of sewage is generated, yet the current treatment capacity stands at a mere 4,000 mld. This glaring disparity results in approximately 3,000 mld of untreated sewage being discharged directly into the Ganges from towns categorized as Class I and II along its banks. Despite efforts, only around 1,000 mld of treatment capacity has been established to date.

The industrial sector also plays a significant role in pol-

a comprehensive and urgent making it a rare beacon of for roughly 20% of the overall pollution volume. However, due to the toxic and nonbiodegradable nature of indusneed for concerted efforts to trial waste, its impact is disproportionately severe.

Tanneries in Kanpur, along with distilleries, paper mills, and sugar mills in the Kosi, Ramganga, and Kali river catchments, collectively add to the pollution burden, affecting water sources relied upon by an estimated 600 million people. Despite efforts to monitor and control pollution, the majority of locations along the river still fail to meet even basic water quality standards. The situation demands urgent action. The Namami Gange program, initiated by the Indian government, represents a significant step towards luting the Ganges, accounting cleaning up the river. With bil-

lions of dollars allocated to sewage treatment facilities and sewer line construction, it aims to address the root causes of pollution and restore the Ganges to its pristine state.

The success of the Namami Gange program hinges on effective implementation and sustained efforts to combat pollution. Thus far, the Namami Gange program has incurred expenditures exceeding 328 billion rupees (\$3.77 billion), earmarking funds for the establishment of over 170 new sewage facilities and laying down approximately 5,211 kilometres of sewer lines-an expanse equivalent to crossing the Atlantic Ocean. This initiative stands as an intriguing litmus test in the worldwide endeavour to purify our water bodies. Indeed, if the challenge

of cleansing a river held sacred by hundreds of millions proves insurmountable, what prospects remain for tackling similar tasks elsewhere?

The Ganges is not just India's river; it's a symbol of hope and spirituality for millions worldwide. Its cleansing is not just a matter of environmental conservation but also a moral imperative. As the world grapples with the consequences of pollution and climate change, the fate of the Ganges serves as a litmus test for our collective commitment to protecting our planet's precious resources. If we fail to clean the Ganges, what hope do we have for the rest of our rivers and seas?

### Thai ex-PM Shinawatra gets parole

Thailand's former Prime 1 Minister Thaksin Shinawatra, the Southeast Asian nation's most controversial politician for more than two decades, was released on parole early Sunday from a Bangkok hospital where he spent six months serving time for corruption-related offences. The telecoms billionaire was toppled in a 2006 coup but voluntarily returned from selfexile to Thailand in August last year and reported to prison to begin serving an eight-year sentence. Critics charged that the 74-year-old Thaksin's early release reeked of a deal that short-circuited justice for political reasons.

Current Prime Minister Srettha Thavisin, a leading member of the ruling Thaksin-backed Pheu Thai party, expressed congratulations to his predecessor. Thaksin was seen wearing a neck brace, a sling on his right arm and a surgical mask inside one of the cars in a convoy that left the Police General Hospital just before sunrise. He was accompanied by his two daughters on his way to his residence in western Bangkok. "Thaksin is still believed to wield huge influence, and will still manoeuvre for sure, he will conduct the music behind the scenes," Thitinan Pongsudhirak, a political science professor at Bangkok's Chulalongkorn University, said. "But Pheu Thai has less power than they used to and we'll have to see how he does it." After his return from exile, Thaksin was moved almost immediately to the hospital on grounds of ill health and about a week later, King Maha Vajiralongkorn reduced his sentence to a sin-

gle year. The former leader had won unprecedented electoral support but also influential enemies among Thailand's traditional royalist ruling class during his time in office in 2001-2006. He was accused of corruption and abuse of power as well as disrespect for the monarchy when the military removed him from power in 2006. Thailand's conservative elite, including the army, regarded his popu larity and brash populist politics as a threat to the royal institution, which they see as a linchpin of Thai society. Even after his ouster, Thaksin's supporters and opponents had continued their struggle for power with violent street fighting, election battles, confrontations in the courts and another coup in 2014 that ousted a government that had been formed by Thaksin's sister.

Last year's elections brought change when the progressive Move Forward party unexpectedly finished first, the first time since 2001 that a Thaksin-backed party failed to top the polls. Move Forward's proposals for reforms to the monarchy and the military resonated with large numbers of younger voters, weary of the armybacked governments that had held power since a 2014 coup. Move Forward was stymied when the military-appointed Senate refused to approve its candidate for prime minister, paving the way for Pheu Thai to form a coalition government including parties linked with the military.

Pheu Thai also softened its longstanding anti-military line and reform proposals it promised during the election campaign. Critics charged the deal included a soft landing for Thaksin upon his return

### Over 400 detained as Russia mourns Navalny's death

Over 400 people were detained in Russia while paying tribute to opposition leader Alexei Navalny, who died at a remote Arctic penal colony, a prominent rights group reported.

The sudden death of

Navalny, 47, was a crushing blow to many Russians, who had pinned their hopes for the future on President Vladimir Putin's fiercest foe. Navalny remained vocal in his unrelenting criticism of the Kremlin even after surviving a nerve agent poisoning and receiving multiple prison The news reverberated

across the globe, and hundreds of people in dozens of Russian cities streamed to ad-hoc memorials and monuments to victims of political repressions with flowers and candles on Friday and Saturday to pay a tribute to the politician. În over a dozen cities, police detained 401 people by Saturday night, according to

ered with cameras in the colony. Every step he took was filmed from all angles all these years. Each employee has a video recorder. In two days, there has been not a single video leaked or published. There is no room for uncertainty here," Navalny's closest ally and strategist Leonid Volkov said Sunday. A note handed to Navalny's mother stated that he died at 2:17 pm Friday, according to Yarmysh. Prison officials told his mother when she arrived at the penal colony Saturday that her son had perished from "sudden death syndrome," Ivan Zhdanov, the director of Navalny's Anti-Corruption Foundation, wrote on X, formerly known as Twitter. Russia's Federal Penitentiary Service reported that Navalny

became unconscious at the penal colony in the town of Kharp, in the Yamalo-Nenets region about 1,900 km (1,200 miles) northeast of Moscow. An ambulance arrived, but he couldn't be revived, the service said, adding that the cause of death is still "being estab-

Navalny had been jailed since January 2021, when he returned to Moscow after recuperating in Germany from nerve agent poisoning he blamed on the Kremlin. He has received three prison terms since his arrest, on a number of charges he has rejected as politically motivated. After the last verdict that handed him a 19-year term, Navalny said he understood he was "serving a life sentence, which is measured by the length of my life or the length of life of this regime". Hours after Navalny's death was reported, his wife, Yulia Navalnaya, made a dramatic appearance at the Munich Security Conference.

### S to block another cease-fire resolution at UN

Israeli strikes across Gaza killed at least 18 people overnight and into Sunday, according to medics and witnesses, as the United States said it would veto another draft UN cease-fire resolution.

The US, Israel's top ally, instead hopes to broker a ceasefire agreement and hostage release between Israel and Hamas, and envisions a wider resolution of the Israeli-Palestinian conflict. Israeli Prime Minister Benjamin Netanyahu has pushed back, calling Hamas' demands "delusional" and rejecting US and international calls for a pathway to Palestinian statehood Netanyahu has vowed to continue the offensive until "total victory" over Hamas and to expand it to Gaza's southernmost town of Rafah, where more than half the enclave's population of 2.3 million Palestinians have sought refuge from fighting elsewhere. An airstrike in Rafah

overnight killed six people, including a woman and three children, and another strike killed five men in the southern city of Khan Younis, the main target of the offensive over the past two months. Associated Press journalists saw the bodies arrive at a hospital in Rafah. In Gaza City, which was isolated, largely evacuated and suffered widespread destruction in the initial weeks of the war, an airstrike flattened a family home, killing seven people, including three women, according to Sayed al-Afifi, a relative of the deceased.

The Israeli military rarely comments on individual strikes and blames civilian casualties on Hamas because the militants operate in dense residential

### Trump hawks branded shoes day after \$ 355 mn ruling against him

s he closes in on the ARepublican presidential nomination, former President Donald Trump made a highly unusual stop on Saturday, hawking new Trump-branded sneakers at "Sneaker Con," a gathering that bills itself as the "The Greatest Sneaker Show on Earth.

Trump was met with loud boos as well as cheers at the Philadelphia Convention Center as he introduced what he called the first official Trump footwear.

The shoes, gold lame high tops with an American flag detail on the back, are being sold as "Never Surrender High-Tops" for USD 399 on a new website that also sells Trump-branded "Victory47" cologne and perfume for USD 99 a bottle. He'd be the 47th

president if elected again. The website says it has no



paign, though Trump campaign officials promoted the

appearance in online posts. On Friday, a judge in New York ordered Trump to pay a whopping USD 355 million in penalties, finding that the former president lied about his wealth for years, scheming to dupe banks, insurers, and

others by inflating his wealth on financial statements.

That penalty came after Trump was ordered to pay USD 83.3 million to the writer E. Jean Carroll for damaging her reputation after she accused him of sexual assault. With interest payments, Trump's legal debts might now exceed a half-billion dollars — an amount it is unclear he can afford to pay.

A huge landslide engulfed Tuesday the Anagold Madencilik company's Copler mine in the town of Ilic in Turkiye's mountainous Erzincan province, trapping the workers under tons of rubble, and becoming a potential environmental disaster. The landslide involved a mound of soil extracted from the mine, Interior Minister Ali Yerlikaya previously said. Cengiz Demirci, Turkiye director and senior vice president of operations at the Denverbased SSR Mining Inc., Anagold's parent company, was detained on Sunday morning. Earlier this week, authorities also detained eight other Copler mine employees as part of the investigation into the disaster, six of whom were formally arrested. Hundreds of search and rescue personnel are still looking for the workers who have been missing for six days so far.

Turkiye's Environment Ministry announced Saturday it was cancelling Anagold's environmental permit and license.

Experts warned the landslide could be an environmental hazard as the soil was laced with dangerous substances, including cyanide, used in gold extraction. They said it may affect the nearby Euphrates River which stretches across Turkiye, Syria and Iraq. The ministry had closed down a stream leading to the river to prevent water pollution. In 2020, the same mine

was shut down following a cyanide leak into the Euphrates, roughly 3 kilometres away. It reopened two years later after the company was fined and a cleanup operation completed. Shares at SSR Mining plummeted over 50 per cent in the wake of Tuesday's disaster. Turkiye has a poor mine safety record. In 2022, an explosion at the Amasra coal mine on the Black Sea coast killed 41 workers. The country's worst mining disaster took place in 2014 at a coal mine in the municipality of Soma, in western Turkiye, where 301 people were killed.

### Pakistan EC forms panel to probe rigging allegations Imran Khan's party demands judicial probe

Pakistan's election commission has formed a high-level committee to probe the explosive allegations levelled by a senior bureaucrat that widespread rigging aided by the judiciary and the top election body happened against jailed former prime minister Imran Khan's party in the garrison city of Rawalpindi.

Rawalpindi Former Commissioner Liaquat Ali Chattha on Saturday alleged that the candidates who were "losing" the elections "were made to win" in the city. He claimed that 13 candidates from Rawalpindi were forcefully declared winners. His remarks came amidst jailed former prime minister Khan's Pakistan Tehreek-e-Insaf (PTI) party began nationwide protests against alleged rigging and stealing of its mandate in the February 8 elections.

"I am taking the responsibility for all this wrongdoing and telling you that the chief election commissioner and the chief justice are also completely involved in this," he was quoted as saying by the Dawn newspaper. Chattha resigned from his office after "accepting responsibility" for the manipulation of poll results. The Election Commission of Pakistan (ECP) has strongly rejected the allegations Chattha has made against the chief election commissioner. It held



an emergency meeting to discuss the commissioner's allegations and formed a high-level committee to probe the allegations. Chief Election Commissioner Sikandar Sultan Raja attended the meeting via

In light of the committee's report, the election regulator would decide whether or not the commissioner be tried for contempt. The high-level committee will record the statements of the relevant district returning officers and returning officers and submit its report to the ECP within three days. newly-appointed Rawalpindi Commissioner, Saif Anwar Jappa, rejected all the accusations made by the former commissioner regarding irreg-ularities in the February 8 general elections. He clarified that

the commissioner's role in the polls was only for coordination. Emphasising the fairness and accuracy of the recent elections, the District Returning Officer (DRO) for Rawalpindi assured that the elections were conducted with complete transparency and without any external pressure on them.

He alleged that efforts were made to keep the party out of the electoral arena when people, responding to 71-year-old PTI leader Khan's call, went to the polling stations in huge num-"We had won 180 seats in the National Assembly, 42 seats in Khyber Pakhtunkhwa assembly, 115 in Punjab, 16 in Sindh, and four in Balochistan assembly," he said. Gohar added that the PTI had been given one seat in Balochistan, and three were due. "In Sindh, we did not get a single seat, they are all due. In

Punjab, around 50 seats are due," he said.

Addressing the press conference, the party's candidate for prime minister, Omar Ayub Khan, said that the PTI would form governments in the centre and the provinces. He said that a judicial inquiry should be conducted involving indepen-dent judges. "And those who have been named by the Rawalpindi commissioner should not be a part of this inquiry," Ayub added.

Earlier in the day, a PTI spokesperson demanded that Chief Election Commissioner Raja and Chief Justice Isa tender their resignations following the revelations by Chattha.

Meanwhile, the ECP has launched a probe following the allegations by Chattha, who has now been transferred to the Services and General Administration Department (SGAD) in Lahore. The government has also appointed Anwar Jappa as the new commissioner of Rawalpindi Division, which comprises the districts of Rawalpindi, Attock, Jehlum,

Chakwal and Talagang.

The division is popularly known as the 'marshal belt' as the country's military draws its main strength from these districts. Earlier in the day, the party held its parliamentary committee meeting, during which party leader Ali Muhammad Khan told reporters that it was deprived of its symbol, and most of the leaders were in jail at the time of the elections, but people cast votes in favour of PTI.

"Today, we hear a voice from the same place [Rawalpindi] where we were deprived of our mandate. Commissioner Rawalpindi has given proof in our favour. We have been deprived of 80 seats," he said. He said that on Friday, he, along with Sardar Latif Khosa, had a meeting with party founder Khan, who is in jail. "Imran Khan told us that he will forgive all the personalities just like the Holy Prophet Muhammad did after Fatah Makkah. He also gave the example of Nelson Mandela and said that he would not take revenge

on anyone," Ali said. Meanwhile, the PPP has demanded an inquiry into the allegations. However, the Pakistan Muslim League-Nawaz (PML-N) has raised questions about the mental status of Chattha. PML-N leader Rana Sanaullah, while talking to Dunya News, said that Chattha seemed to be a psycho, and that is why he claimed that he tried to commit suicide. Pakistan Peoples Party (PPP) Secretary, Information, Faisal Karim Kundi, in a video statement, said

Even after the passage of more than a week, the ECP is yet to notify the victory of most of the independent candidates who have won National Assembly (NA) seats in the general elections. The PTI's two main rivals appear on course to form a coalition government after former prime minister Nawaz Sharif's PML-N and Bilawal Bhutto-Zardari's PPP formed a post-poll alliance last week.

change PPP's minds on the issue of ministries before discussing the constitutional offices. The latter has so far refused to budge.

A PPP office-bearer, privy to the talk on government formation, told the Dawn newspaper that the party has decided to seek the posts of National Assembly (NA) speaker and Senate chairman. But the PML-N appears reluctant and wants to keep the NA speaker's office with it, the PPP leader added.

The PPP has sought top offices in both houses of Parliament as the party feared that under the PML-N, parliament "would not be able to gain its lost prestige".

Sources in the PPP claimed that so far, the party had not finalised the names for the top constitutional and parliamentary offices. They said that besides the present NA speaker, Raja Pervez Ashraf, who is expected to retain the post, exprime minister Yousuf Raza Gilani, who won the NA seat from Multan, also desires the post. The PPP has also asked the PML-N for support in Senate elections for the seat that Gilani would vacate if he is nominated as NA speaker, according to party sources.

Gilani could also be considered for the Senate chairman, but it all depended on the outcome of the ongoing negotiations between the committees. The other issue, the sources said, under discussion was the allocation of development funds for provinces. They said the PPP wanted

assurance from PML-N leadership that it would release development funds to provinces, particularly Sindh, without any hindrance. According to reports, the PPP has asked PML-N to give it "some space" in Punjab as a precursor to any support in the government formation.

The Chinese coast guard's Fujian division will regularly monitor the waters off the southern coast of the city of Xiamen a few kilometers from Kinmen

and China regularly sail that

stretch of water which has seen a rise in tensions as the number of Chinese vessels including sand dredgers and fishing boats — have notably increased in the area. ### **UK extends visas for Ukrainians**

The UK government on I Sunday extended its visa scheme for war-hit Ukrainians who sought refuge in the country in the wake of the Russia-Ukraine conflict, allowing an additional 18-month stay on their current terms. The Home Office said that from early 2025, all those in the UK under one of the Ukraine visa schemes will be able to apply to stay here for an additional 18 months and continue to have the same rights to access work, benefits, healthcare, and education throughout their stay. This will mean those who

came on the first visas under one of the Ukraine visa schemes could now stay in the UK until September 2026. "This new visa extension scheme provides certainty and

the UK on their future as this war continues, and we will continue to provide a safe haven for those fleeing the conflict," said Tom Pursglove, UK Minister for Legal Migration and the Border.

"Almost two years on from the start of this brutal war, over 200,000 Ukrainians and their family members have arrived in Britain. Families across the country have opened their homes and their hearts to the people of Ukraine, showing extraordinary generosity, including offering shelter to those fleeing from the horrors of war," he said.

He said the move shows that the UK and its allies stand in solidarity with Ukraine and 'unequivocally condemns [Russian President] Putin's unprovoked, premeditated and

### **Power consumption** grows in April, **January this fiscal**

India's power consumption increased 7.5 per cent on-year to 1354.97 billion units (BU) in the April-January period of this financial year, indicating an uptick in economic activities across the country.

Power consumption in the country has increased to 1354.97 billion units (BU) in the April-January period of this financial year, from 1259.49 BU in the April-January period of fiscal 2022-23, according to government data.

was 1505 91 BU entire fiscal year of 2022-23, the data showed.

Experts believe the 7.5 per cent growth in power consumption in the country clearly shows a perk up in economic activities in the first 10 months of this fiscal year.They said power consumption grew in August, September and October, mainly due to humid weather conditions, and a pick-up in industrial activities ahead of the

festive season. Experts are predicting a steady power consumption growth due to improvement in economic activities and cold wave conditions in February. They are of the view that India will have a steady growth in power consumption as well as demand during the current

fiscal year. The National Statistical Office has pegged Indian economic growth at 7.3 per

cent in 2023-24 over and above the provisional growth rate of 7.2 per cent during the last financial year in its first advance estimates released earlier in

Power consumption in January rose 5.4 per cent to 133.18 BU, compared to 126.30 BU, the data showed. The peak power demand met -- the highest supply in a day -- rose to 222.32 GW in January 2024. The peak power supply stood at 210.72 GW in January 2023 and 192.18 GW in January

Experts said that power demand improved January as mercury fell sharply in the month, especially in North India. The cold wave resulted in increased use of heating

equipment like heaters, blowers and geysers which led to increase of power demand as well as consumption. The power ministry had

estimated the country's electricity demand to touch GW during the summer in 2023.

The demand did not reach the projected level in April-July due to unseasonal rains. The peak supply, however, touched a new high of 224.1 GW in June before dropping to 209.03 GW in July. Peak demand touched 238.82 GW in August. In September 2023, it was 243.27 GW. The peak demand was 222.16 GW in October, 204.77 GW in

### **Hybrid mutual** funds gather steam

Hybrid mutual fund schemes have been gaining popularity among investors, attracting Rs 20,634 crore in January, marking a 37 per cent surge from the previous month, largely due to their appeal as an alternative investment option post-change in taxation laws for debt funds. With this, total inflow in the category reached Rs 1.21 lakh crore in the April-January period of the current financial year (FY24). However, hybrid schemes

However, hybrid schemes saw outflow in the same period of the preceding financial year.

Hybrid funds are mutual fund schemes that typically invest in a combination of equity and debt securities categories such as gold.

The category has been attracting regular inflows since April 2023, after a change in taxation for debt funds that kicked off in the same month. Before that, the segment saw a net withdrawal of Rs 12,372 crore in March last year. According to the latest data with the Association of Mutual Funds in India (Amfi), hybrid schemes witnessed an inflow of Rs 20,637 crore in January,

December. The two categories of hybrid funds that attracted most funds during the month under review are arbitrage and multi-asset funds allocation funds.

Out of the Rs 20,637 crore inflow in hybrid funds in January, arbitrage funds witnessed an inflow of Rs 10,608 crore, while for multiasset allocation funds it was Rs 7,080 crore.

Moreover, around 50 per cent to 70 per cent of the allocation in the hybrid category has been going towards arbitrage funds in the last six months.

'The main reason for the increase in flows in this category is that they are being looked at as an alternative post-change in tax laws.

'Currently, arbitrage funds are sitting at a spread of around 8 per cent making it an attractive investment opportunity, especially on a post-tax basis," Feroze Azeez, Deputy CEO, Anand Rathi Wealth Ltd, said. Besides, the multi-asset category, offering easy diversification, has become the investors' choice. In terms of folios, the segment added 3.36 lakh hybrid folios in the month under review, taking the total to 1.31 crore, representing a share of 7.7 per cent on the total folios of 16.95 crore. #### Zee alleges Star India of violation of agreement on ICC T 2024 to 2027 for the Indian execution

Zee Entertainment Enterprises has alleged that Star India has not acted in accordance with the agreement between them over the sharing of the TV broadcast rights of ICC cricket matches and has sought a refund of Rs 68.54 crore from the Walt Disneyowned firm.

2022, Zee In August, Entertainment Enterprises had entered into an Alliance Agreement with Star India for sub-license of broadcasting rights of ICC Men's and Under 19 international matches from 2024 to 2027.

Star India has "failed to obtain necessary approvals, execution of necessary documentation

agreement" and believes that it has "by its conduct breached" the agreement, Zee Entertainment Enterprises Ltd (ZEEL) said in the financial statement of its latest December quarter results last week. The Alliance Agreement was

subject to certain conditions such as submission of financial commitment, provision of bank guarantee and ICC approval for sublicensing from International Cricket Council

"Till date, the company has accrued Rs 72.14 crore for bank guarantee commission and interest expenses for its share of bank guarantee and deposit as per the Alliance Agreement," ZEEL said. During the quarter ended December 31, 2023 and

subsequently, Star has sent letters to ZEEL through its legal counsel alleging breach of the Alliance Agreement on account of non-payment of dues for the rights in relation to first installment of the commission and deposit

rights fee aggregating to USD 203.56 million (Rs 1,693.42 crore).

Along with this, Star India also sought Rs 17 crore for payment for bank guarantee interest, ZEEL added.

"Based on the legal advice, the management believes that has not acted in accordance with the Alliance Agreement, and has failed to

The management also believes that Star by its conduct has "breached the Alliance Agreement and is in default of the terms thereof consequently, contract stands repudiated," it added. Based on the available information and legal advice, the management believes that the company has strong and valid grounds to defend any claims," it said.

# Indian women clinch historic gold

Anmol Kharb yet again performed when it mattered, winning the decisive fifth rubber to lead the Indian women to a historic Badminton Asia Championships title with a tight 3-2 victory over a depleted Thailand, here Sunday.

The young sprightly group of Indian women's team, led by seasoned PV Sindhu, defied all expectations to come up trumps two-time medallists Thailand.

"I'm very happy that we bagged the gold medal because this is the the gold medal because this is the first time India are winning the gold at the Badminton Asia Team Championships," Anmol said after the match.

"It is a big thing because history has been scripted here. Yesterday (after the semifinal win) it went crazy in India because beating powerhouses like Japan and China was such a big thing. Today, it will be full-on celebration in India and in the team as well.

"I wanted to play my 100 per cent but there was no pressure on me at all. We were confident of winning the fifth match."

It is the first-ever major title for Indian women in team championships and provides a big boost to the side ahead of the Uber Cup, which is set to be held in Chengdu, China from April 28 to May 5. India had won two



medals in the past with the men's team claiming bronze medals in the 2016 and 2020 editions.

Though like most of the teams in the competition, Thailand were not at full strength, they still had higher-ranked players in their

Thailand were without their top two singles players -- world No. 13 Ratchanok Intanon and Pornpawee Chochuwong, who is ranked 16th in the world.

Two-time Olympic medallist Sindhu provided India a confident start, riding on her power and placement to outclass world number 17 Supanida

Katethong 21-12, 21-12 in the first singles and hand India a 1-0

World No. 23 Treesa Jolly and Gayatri Gopichand then dished out another gritty performance to shock the world number 10 pair of Jongkolphan Kititharakul and Rawinda Pra Jongjai 21-16, 18-21, 21-16 to put India in the driver's seat.

Playing the second singles against world ranked 18 Busanan Ongbamrungphan, expectations were high from Ashmita Chaliha after her stunning win against former world champion Nozomi Okuhara on Saturday.

The Indian, who had defeated Busanan during the Singapore Open in 2022, stayed in the match till 14-14 in the second game but a string of unforced errors thereafter cost Ashmita dearly as she went down 11-21, 14-21 against her experienced

Young Shruti Mishra and Priya Konjengbam, the senior national champions, then lost 11-21, 9-21 to the world number 13 combination of Benyapa Aimsaard and Nuntakarn combination Aimsaard to leave the tie evenly poised at 2-2. Anmol then shouldered the

responsibility of taking India through once again, producing a dominating 21-14, 21-9 victory over world number 45 Pornpicha Choeikeewong in the deciding third singles.

"It's a big achievement at 17 years old. Now I have to train harder to beat tougher opponents," she

Soon after the win, the entire squad got into a huddle to lift Anmol, celebrating the magnificent win at the Setia City Convention Centre.

"It is a great moment for Indian badminton. I give a lot of credit to these youngsters. They displayed great spirit, they were supporting each other and the atmosphere was just like it was when India won the Thomas Cup. So this is a special moment for India," former India coach Vimal Kumar told PTI.

# India hammer England by 434 runs in third Test

🕶 ashasvi Jaiswal's sensational double hundred found harmonious co-existence with the stunning craftiness of five-wicket man Ravindra Jadeja as ruthless India demolished wasteful England by a record 434 runs on the fourth day of the third Test here on Sunday.

England resisted their desire to play 'Bazball' but the Indian bowlers led by Jadeja (5/41) were an irresistible force, as they hustled out the tourists for 122 in their second innings while chasing an improbable 557-run target. India, now, lead the five-match

This was also India's biggest win in Test cricket in terms of runs, bettering the previous 372-run win over New Zealand at the Wankhede Stadium in 2021.

Jaiswal's unbeaten 214 off 236 balls, in which he equalled the highest number of sixes (12) in a Test innings, was the cornerstone of India's second innings total of 430 for four declared, which gave them a massive lead of 556 runs earlier in the day.

It was also a perfect platform for Jadeja to weave his magic as England's claims of fancying themselves in big chases through an aggressive approach came to

The knock combined with his hundred in the previous Test might have brought him considerable time and confidence. But none shone as bright as Jaiswal. Having notched up his overall third century and second of the series, Jaiswal continued with his red-hot form to become the first player to hit 20 sixes in a series with two more matches left. Jaiswal's six-hitting spree so far has resulted in India bettering their own record of most sixes (48) in a series. The left-handed opener also entered record books to join Pakistan legend Wasim Akram for most sixes (12) for any batter in a Test innings, while resetting the same statistical high for India.

Jaiswal joined Vinod Kambli and Virat Kohli as only the third Indian ever to have scored two consecutive double centuries in as many games, while becoming the seventh Indian ever to have scored in excess of 200 in the second essay

of a Test.

In the process, the 22-year-old Jaiswal also breached the 500-run mark in only the third Test of this series, reaching 545 runs in six innings at an average of 109 with two tons and a fifty.

In fact, Jaiswal is now the leading run-scorer in the current cycle of ICC World Test Championship (WTC), going past Australias Usman Khawaja with 861 runs in seven Tests at 71.75, studded with three centuries and two fifties. But Sarfaraz too gave a shining


