INDIA MOVING FROM ADVERSITY TO VICTORY: MODI

rndia has become a nation moving towards victory from adversity, said Prime Minister Narendra Modi on Monday during the foundation stone laying ceremony of Shri Kalki Dham in Sambhal.

He congratulated Uttar Pradesh Chief Minister Yogi Adityanath for his resolve to develop the State into a \$1-trillion economy, saying that the country will progress only when every State moves forward with big dreams and resolutions like that of UP. Speaking at the inauguration of

the fourth edition of the Ground Breaking Ceremony (GBC@IV) organised at Indira Gandhi Pratishthan here, Prime Minister Modi said, "I have full faith in the power of UP and the hard work of the double engine government. I congratulate Yogi ji. Every Indian is proud that UP has decided to become a trillion-dollar economy. My advice to all the political parties of the country would be to leave politics and learn from UP and then enter the field with a similar resolve.

The PM launched more than 14,000 projects worth more than Rs 10 lakh crore on the occasion. He also watched glimpses of the changing Uttar Pradesh through films screened at the event.

The Prime Minister said the Shri Kalki Dham temple complex, spanning five acre, will take five

vears to complete. It will be constructed using the pink stones of Bansi Pahadpur, similar to the ones used in the Somnath Temple and the Ram Temple in Ayodhya. The temple's spire will be 108 feet high, without the use of steel or iron. It will house ten sanctums, each dedicated to one of Lord Vishnu's avatars. Modi proclaimed the dawn of a new

era, signifying the shift in the rail is running here. A large wheel of time. Emphasising that it is a time of

infinite opportunities for industries in UP, the Prime Minister said, "Exports from UP have doubled in the last few years. UP is the State with the highest number of expressways and international airports in the country. The country's first rapid

network of Western and Eastern Dedicated Freight Corridors passes through UP. The river network is also being used for cargo ships. Transportation has become cheaper."

The Prime Minister pointed out that seven years ago such a favourable environment for investments and creation of jobs

was unimaginable because of a high crime rate, riots and snatchings, etc, across the State. Today investment worth billions of rupees is coming into Uttar Pradesh. Work is starting on thousands of projects in Uttar Pradesh. These industries are going to change the face of UP. In the last seven years, a red carpet culture has replaced the red tape culture," he asserted.

The Prime Minister said crime rate had dropped significantly in Uttar Pradesh and business culture had flourished with building of trust in the State's capabilities. "There is optimism among all investors who have come here, which is a very positive sign. The double engine Government has shown that if one has the intention to bring about change, no one can stop it from happening," he said.

The Prime Minister said there is unprecedented positivity about India all over the world. Referring to the visit to Qatar and the UAE, Modi said every country was confident about India's development. "The whole world is considering India as a guarantee of better returns. It is often seen that when elections are near, people avoid investments. But, even that belief has fallen apart in Uttar Pradesh today with investors around the world reposing their trust in the government's policies and stability," he added.

Farmers divided over Centre's MSP offer

Hours after holding the fourth round of talks with the Centre, a faction of farmer representatives on Monday said they would mull over the government's proposal to give the guarantee on buying five crops at the minimum support price (MSP) and the Delhi Chalo march shall be put on hold till February 21.

However, another faction led by farmer leader Jagjit Singh Dallewal rejected the proposal, saying, "What we are saying is not a new demand. That was a commitment to us by the Government. We had tried to draw the attention of Government towards those commitments again and again. But the Government showed no seriousness to date..."

panel comprising Agriculture and Farmer Welfare Minister Arjun Munda, Minister of Commerce and Industry Piyush Goyal, and Minister of State for Home Affairs Nityanand Rai on Sunday proposed the buying of pulses, maize, and cotton crops by government agencies at the MSP for five years after entering into an agreement with farmers.

The NCW chairman, who visited river islands of Sandeshkhali to enquire into the alleged reports of mass rape by men of local TMC strongmen Sheikh Shahjahan, Shibu Hajra and Uttam Sardar, said after taking a round of the interior areas, "What I saw is shocking... even after the women being shamed in mass scale no action is taken and when they go to the police their complaint is not recorded... I am convinced that the incidents do not reflect the situation in Sandeshkhali alone but the entire Bengal."

'The women of Sandeshkhali have been harassed... They are scared and the situation here is bad. Women are crying in front of me. I don't think anything will happen here without the President Rule... Today I have copies of 18 complaints, including two rapes and serious molestation ... I will submit a report to the President of India accordingly," Sharma, who escorted two of the victims, to the Sandeshkhali Police Station, said. In an apparent reference to Mamata's Sunday comment that a mountain was being made out of a molehill at Sandeshkhali, Sharma said the CM should visit the area

Kejriwal defies ED summons for sixth time

 $D_{\text{AAP}}^{\text{elhi Chief Minister and}} \text{ Arvind}$ Kejriwal, for the sixth time, skipped the Enforcement Directorate's summons that asked him to appear before it with the Delhi Excise Policy

Terming the summons as "illegal", the AAP said the ED should wait for the court's decision instead of serving the summons on Kejriwal. The agency had earlier this month approached a city court after the Delhi Chief Minister defied its five summonses.

Later, informing the media at the Delhi Assembly, Kejriwal said, "We are replying (to the ED) as per the law. Now, the ED has filed a case in the court and they should wait for the decision of the court before issuing any fresh summons," he said.

Meanwhile, sources in the ED said the agency has filed a complaint under section 174 of the IPC against Kejriwal for allegedly intentionally disobeying the first three summons issued to him.

'The court has taken cognisance of the same, thereby the court has prima facie accepted that Kejriwal has committed an offense for which he is liable to be

prosecuted. The question in front of the court is not about the validity of the summons but the alleged illegal act on the part of Kejriwal of intentionally disobeying the three summons," sources said. AAP leadership, including Kejriwal, has alleged that the BJP intends to arrest him to topple his Government in Delhi and dismantle the party. Delhi BJP president Virendra Sachdeva claimed that even the court has acknowledged the legality of the ED summonses to Kejriwal and insisted that he should cooperate in the

investigation.

"According to Article 174 of the IPC, the court acknowledges the summons by the ED. Kejriwal calling it illegal constitutes contempt of court... The issue with him is that he is not able to accept the fact that he was involved in the scam. Investigation agencies are doing their job, and soon Kejriwal will have to unveil the truth in front of the people. The probe agencies are doing their job, and he will also be behind bars like Manish Sisodia and Sanjay Singh," Sachdeva said.

in the state.
Being held amid the ongoing fast-unto-death by Shivba Sanghatana leader Manoj Jarange-Patil, the special session - given the enormity of the task on hand -- may extend up to two days.

At the beginning of the session, Maharashtra Governor Ramesh Bais will address a joint sitting of both the houses of the Maharashtra Legislature. Later on both the Houses will take up condolence resolutions.

In the debate on the proposed legislation on Maratha reservations that will follow, both the Houses of the State Legislature will deliberate on a report submitted by the MSBCC on the social and educational backwardness of the Maratha community. Maratha community. Based on a survey covering 2.5

Based on that report, the state government had extended reservation to Marathas. However, the decision taken by the state government failed to pass the test in the Supreme Court, as the reservations crossed the 50 per cent cap fixed by the apex court.

Scientists developing

Scientists have developed a saliva test that screens for breast cancer, which is showing promising results in experimental testing, according to a study published Tuesday. The new hand-held device detects breast cancer biomarkers from a tiny sample of spit, say researchers from the University of Florida and National Yang Ming Chiao Tung University in Taiwan, who published their findings in the Journal of Vacuum Science & Technology

The development of non-invasive, cost-effective, and easily accessible screening tools is of paramount importance given that breast cancer remains a significant global health concern, with early detection being crucial for successful treatment outcomes. Traditional screening methods such as mammography and biopsy can be invasive, expensive, and inaccessible to many populations.

ducting breast cancer screening in communities or hospitals, said Hsiao-Hsuan Wan, a UF doctoral student in the Department of Chemical Engineering and the study's

excellent choice because it is portable — about the size of your hand — and reusable. The testing time is under five seconds per sample, which makes it highly efficient." The new tool works by placing

a saliva sample on a test strip, which is treated with specific antibodies that respond to cancer biomarkers. Electrical impulses are sent to contact points on the biosensor device. Signals are measured and translated into digital information about how much biomarker is present. The results are quick and easy to interpret, Wan


Serious Constitutional crisis in city, officers refusing to work due to 'threat': Kejriwal

Delhi Chief Minister Arvind Kejriwal on Monday said a "serious constitutional crisis" has arisen in the national capital as officers are saying they will not work because of alleged "threats and pressure" from the BJP. This problem stems from Delhi not enjoying full state-hood and the real power lies with the central government, which is led by a different party, and "that other party does not want that the elected government," ment (of Delhi) does its work", he said during his address in the Delhi Assembly.

Kejriwal also said the one-time settlement scheme to rectify water bills is being "obstructed" by some officers. The chief minister alleged that the officers are being threatened to block the one-time settlement scheme for correcting water bills because of pressure from the

Kejriwal also claimed the officers' unwillingness to work has led to a "serious constitutional crisis" in Delhi.

He appealed to Lt Governor Vinai Kumar Saxena to call the officers for clearance of the scheme and added that 10.50 lakh families will benefit from this "good scheme". Kejriwal said a large percentage of Delhi's population is a "victim of erroneous, inflated bills".



We introduced a scheme to solve the problems of the people of Delhi -- a one-time settlement scheme.'

The chief minister said his government works for the people, and mocked the opposition BJP by claiming that they had 'overlooked" the issues of the people and were reduced to three or eight seats in the assembly. Thousands of crores in revenue have "got locked" in this scheme, he said.

This scheme is so good, it was passed last June and should have been implemented immediately. It's been eight months but these officers have "refused to do it", he claimed. "Today, the situation is that this scheme has to be brought to the Cabinet. It will get implemented if the Cabinet approves it. For this, the (Delhi) finance secretary has to give his comments," Kejriwal said. The finance secretary, however, has written that he won't give comments, the chief minister alleged. When the Delhi urban development secretary was asked about it, he said he was "awaiting comments" from the finance secretary, Kejriwal added.

"A senior bureaucrat even shed a tear, saying it's 'a matter of our jobs, we are being threatened',' Kejriwal alleged. "When I asked who was threatening them, he said, 'higher-ups'. You know what higher-ups mean ... If they pass this scheme for the people of Delhi, then they shall be suspended ... Why (do) they keep fighting for the Services (department), as their intentions are wrong," he said.

The chief minister claimed that officers are being threatened that they will be suspended or fired or sent to jail or central agencies will be "set after them". 'À serious constitutional crisis has arisen (here) as officers will not work. If they do this, how will the government run? Can it run for even two days? Does it behove the Centre and the BJP that an elected government has been brought to such a state?" Kejriwal asked.

'And, who all are behind it? The BJP is behind it. "It is indeed dubious that the capital of the country tops the list of tax evasion amongst all states and Union Territories, with the one on the second place behind Delhi, by as much as Rs 827 crore. This is a serious matter in which the possibility of collusion of officials in a huge loss to the public

Delhi ranked third, trailing behind Maharashtra (926) and Rajasthan (507), in terms of the number of counterfeit GST firms identified by authorities during this period.

Mahabharat 2.0

LS polls a battle between Modi's development agenda and INDIA bloc's dynastic corruption, says Shah

- choes of the ancient *Mahabharat* have begun to reverberate as the nation approaches the general elections. The recent statements by Home Minister Amit Shah, the BJP's chief poll strategist, have delineated contrasting narratives between Prime Minister Narendra Modi's vision of development and the alleged corruption within INDIA, the Opposition alliance. Shah recently likened the current political scenario to the epic Mahabharat, where virtue clashes with vice and honesty with deceit. He positioned Modi as the modern-day Arjun, leading a crusade for progress and national unity, while contrasting the INDIA bloc as a conglomeration of seven dynastic parties (among others) embroiled in the quagmire of corruption. Central to Shah's narrative is Modi steering the nation towards a promising future; the BJP has already championed initiatives aimed at economic growth, infrastructure development and social welfare, presenting India as a global powerhouse. However, Shah's portrayal of the Opposition bloc



is in stark contrast: Allegations of corruption, nepotism and governance failure cast a shadow over the credibility and integrity of these parties. Shah's narrative underscores the moral dichotomy between Modi's righteous leadership and the Opposition's purported moral bankruptcy. The juxtaposition of Modi's developmental agenda with the perceived shortcomings of the INDIA bloc sets the stage for a high-stakes political showdown.

Beyond pure rhetoric, however, lies the complex reality of Indian democracy where power dynamics, socio-economic disparities and regional identities intersect to shape the electoral landscape. However,

by its own doing, the INDIA bloc is an imploding edifice and it is getting tattered each passing day. The NCP has split in Maharashtra, the AAP has said no to any truck with the Congress in Punjab and literally mocked the 'grand old party' in the Capital by making it a single-seat offer. The blow-hot, blow-cold relationship between the Congress and the ruling TMC, especially after the Sandeshkhali shame hit the headlines, means that Mamata Banerjee would not accommodate the former in Bengal though Rahul Gandhi insists otherwise. While Modi's leadership enjoys widespread support, the Opposition's critique of his policies and governance should not be written off yet. There can be no two opinions about a politician praising his leader sky high but tarring the entire Opposition with the same black brush is not a pertinent thing to do in politics. Moreover, the portrayal of the Opposition as a monolithic entity driven solely by dynastic ambitions oversimplifies the diverse tapestry of Indian politics. As voters weigh competing visions, they are confronted with choices that echo the timeless dilemma of choosing the right set of leaders. Let us face it: The Lok Sabha elections are not a battle of right versus wrong, but the outcome will definitely determine the trajectory and destiny of the nation.

The implications of the Supreme Court ruling



As the ruling BJP and other parties grapple with the fallout of the Supreme Court ruling on Electoral Bonds, it may have far-reaching implications for Indian democracy

ndian elections are intricate and complex events that involve millions of voters and multiple political parties. These parties rely heavily on contributions from individuals and corporations to finance their campaigns, as funding is crucial. A lot of black money also circulates during elections. When Narendra Modi became the Prime Minister of India in 2014, he promised to prevent using illegal money in politics. Three years later, in 2017, he introduced Electoral Bonds that he claimed would increase transparency in political funding. However, some people challenged the secrecy clause and violation of fundamental rights in Court. Recently, the Supreme Court declared anonymous political donations to be invalid. This decision could make it difficult for their campaigns before the 2024

The Apex Court ruled that "Electoral Bonds" violate citizens' right to access Government information and violate Article 19(1)(a) of the Constitution. "Information about the funding of political parties is essential for effectively exercising the choice of Chief Chandrachud stressed, emphasising the importance of open governance. The Governmentowned State Bank of India has been ordered to stop issuing these bonds and provide details to the Election Commission of India. A group of five judges made this decision. This is not good news for most

parties, particularly the ruling BJP. Besides the BJP, some other political parties also benefited from the bonds. Judges examined whether the Electoral Bond scheme broke constitutional rules, stopped voters from getting vital information, allowed secret donations while protecting donors' privacy, and threatened democratic processes. Previously, political parties were required to disclose the identities of donors who contributed more than 20,000 rupees. However, electoral bonds allow political arties to report the money received without revealing the donors' identities. These bonds have a range of 1,000 to 10 million rupees.



People must know if political funding is transparent or not. One of the main criticisms is that it's hard to trace where the money comes from when buying these bonds, making it challenging to identify the source of the funds. According to recent ADR data, from 2017 and 2022, the total amount donated by corporations during this period was ₹3,299.85 crore. The BJP received the most significant share of this amount, with a total of ₹3,299.85. The Congress party received ₹406.45 crore, the Nationalist Congress Party (NCP) received ₹109.5 crore, the Communist Party of India (Marxist) (CPI-M) received ₹29.1 crore, and the All India Trinamool Congress (AITC) received ₹49.7 crore through Electoral Bonds.

ADR's report claims that withholding information about political contributions is unreasonable. Taxpayers should know where political parties get their funding. The lack of transparency raises accountability questions. Taxpayers' money is spent printing bonds, and SBI profits from their sales.

accountability. Taxpayers' money is used to print bonds, and SBI profits from their sale are deemed unfair. The public and opposition parties must be aware of the source of these donations, although the Government can access donor details from SBI. In Parliament, the Government disregarded warnings from major central agencies and opposition Members of Parliament and launched the Electoral Bond Scheme. The Bonds bill was passed as a money bill.

Earlier, the Ministry of Law emphasised that the bond

scheme should comply with

the Representation of Peoples

Act 1951. The ECI also opposed it. The Election Commission has registered 2,858 political parties, but only a tiny percentage, just 2.17%, are currently recognised. Some parties may never participate in elections, while others may be involved in money laundering activities. During the 2019 elections, political parties received a recordbreaking amount of ₹2,760.20 crore in anonymous donaions through Electoral Bonds. This was the highest amount

received in 2017-18 and 2018-

19. From 2017-18 to 2020-21,

19 political parties redeemed

Electoral Bonds worth approximately ₹6.5 thousand crores. The spending on the last six Lok Sabha elections increased almost six-fold, from ₹9,000 to over ₹55,000 crore in 2019. From 2018 to March 2022, the BJP received 57% of donations, while Congress only got 10%. It is expected that the Government would honour the highest Court's ruling, unlike on earlier occasions. The Court has delivered its verdict, and now it must be put into action.

The Bharatiya Janata Party (BJP) has reservations about donor confidentiality and retrospective disclosure. They claim that the court order will not affect their chances in the upcoming April-May elections as they aim to secure a third term for PM Modi. To prevent the influence of money in elections in the future, we need regulations for donations, spending limits, public funding, and disclosure. The Government is exploring options for Electoral reform. We have many reports that can help us make better decisions, so we need to look at them again. We must make changes to improve the election system.

Declare wildlife as national property

The primary culprit behind human-animal clashes is human-induced encroachments and habitat destruction

nimal conflicts have been on the rise in many parts of the country in recent times. The main culprit behind this is the human-induced encroachments and destruction of habitats. In the region surrounding the Western Ghats, especially in the Wayanad and Idukki regions in Kerala, there have been rampant animal attacks taking human lives in recent times. Every time when there is an attack from wild animals, conflict arises between the forest departments and the public. Most of the time, the forest department catches the wild animals and rehabilitates them in deep forests surrounding the state borders between Tamil Nadu and Karnataka. If the forest department cannot protect either wildlife or human lives, what is the duty of forest officials?The culprit of all wildlife attacks is human beings themselves. We often forget the scientific fact that we are one among the thousands of other animals inhabiting this planet and act as if we are superior beings. All our developmental activities and policy decisions are made in an



anthropogenic-centric manner. In this, we have neither empathy nor concern towards our fellow species. This is the root cause of all animal conflicts.Animals often establish territories rather than borders in the human sense. These territories serve various purposes, such as mating, foraging, or defending resources. They may mark these territories through scent marking, vocalisations, or physical boundaries like fences or natural landmarks. While these territories may overlap with those of other animals, they're not always fixed or as clearly defined as human borders. Wildlife populations are dynamic and can fluctuate based on various factors such as food availability, climate conditions, and predation pressure. Designating fixed borders for them would not account for these fluctuations and could lead to mismatches between habitat

availability and population sizes. Attempting to designate fixed borders for them would be impractical and not align with their natural behaviour. When they roam in the forest, these animals never check whether they have crossed Kerala, Karnataka or Tamil Nadu. Instead of designating borders, conservation efforts focus on preserving and restoring habitat connectivity, protecting key wildlife corridors, and implementing measures to mitigate human-wildlife conflicts. The whole wildlife area should be protected as national property, and all state forest departments should function in unison. There should be frequent interactions between forest officials of neighbouring states for proper tracking of wild animal movements. They should also evolve mechanisms to provide enough food to animals in their range, They can construct artificial water reservoirs and food resources inside forests for wild animals to feed. When these animals get enough food materials, they may not venture into human dwellings. Involving

local communities in conser-

vation efforts fosters a sense of ownership and responsibility for wildlife protection. It also provides opportunities for alternative livelihoods, such as eco-tourism or sustainable agriculture, that are compatible with wildlife conservation. Protecting and preserving natural habitats ensures that wildlife populations have sufficient space and resources to thrive without direct competition or conflict with humans. The forest department should also implement early warning systems using technology such as sensor-triggered alarms, camera traps, or drones that can alert forest officials and local communities to the presence of elephants or tigers in the vicinity. Over the years, animals have evolved to a level where they know how to evade humans' protective measures, like electric fences, trenches, or deterrents like chilli smoke. Only a good researcher focusing on animal behaviour could evolve mechanisms to tackle this.

Western involvement in conflicts like Ukraine serves as a stark reminder of waning efforts and increasing apathy amidst grim realities


merican conservative journalist Tucker Carlson demonstrated somewhat compelling journalism in his recent interview with Russian President Putin, despite facing severe criticism from proponents of weapons and ideological bravado for Ukraine. In the face of such opposition, Carlson courageously unveiled the hypocrisy surrounding freedom of expression and other noble ethics purportedly championed by Western values, revealing them to be nothing but a hollow dream. During his discourse at the World Government Summit in Dubai this week, subsequent to his interview with Putin, Carlson astutely highlighted a crucial analogy, likening superpowers to responsible fathers. Just as a father intervenes to halt his children's squabbles, irrespective of the underlying causes, so too should a super-power prioritise peacekeeping over politi-cal posturing. Regretably, the prevailing sentiment among US political elites, along with their most trusted friends in Europe, seems indifferent to advocating true power in the global arena.

Despite the contentious nature of the interview, it provided a vital platform for gaining authentic insight into the conflict in Ukraine from the Russian perspective. Putin, appearing rational and contemplative, articulated his stance with a measure of credibility. While some of his claims may have raised eyebrows, his demeanour served to underscore the legitimacy of his position to the American audience. Recognising his role as a patriot working in the interest of Russia, we must interpret his assertions within this context, recognising his commitment to his nation's welfare. However, as noted by geopolitical forecaster George Friedman, Putin's rhetoric serves a strategic purpose, aimed at influencing both domestic and international audiences. His communication strategy prioritises persuasion over absolute truth, leveraging carefully crafted narratives to exert pressure on other governments.

In the wake of Russia's military operations in Ukraine, it becomes increasingly evident that mere factional unification without a mutually acceptable mediator is a futile endeavour. The West, regrettably, has yet to grasp the underlying causes of the conflict, opting instead to pursue narrow political agendas. Resorting to sanctions as the primary tool against Putin reflects a myopic approach devoid of meaningful intervention strategies. Can we truly cite any instance where sanctions have catalysed positive change? On the contrary, they inflict untold suffering on innocent populations without addressing socio-economic issues, perpetuating human suffering rather than alleviating it.

In our recent history, we've witnessed the ebb and flow of nations, with empires rising and falling, borders shifting, and new "demilitarisation and denazification," we're witnessing the grim spectre of partition casting its shadow over this once-sovereign nation.

'Over 29k Palestinians killed in Israel-Hamas war

More than 29,000 Palestinians have been killed in the Gaza Strip since the start of the Israel-Hamas war, the territory's Health Ministry said on Monday, marking another grim mile-stone in the deadliest round of violence in the history of the Israeli-Palestinian conflict. Israeli Prime Minister Benjamin Netanyahu has vowed to continue the offensive until "total victory" against Hamas, raising fears that troops will soon move into the southernmost town of Rafah on the Egyptian border, where over half of Gaza's 2.3 million people have sought refuge from fighting elsewhere. The United States, Israel's top ally, says it is still working with mediators Egypt and Qatar to try to broker another cease-fire and hostage release agreement. But those efforts appear to have stalled in recent days, and Netanyahu angered Qatar, which has hosted Hamas leaders, by calling on it to pressure the militant group.

The Health Ministry said

107 bodies were brought to hospitals in the last 24 hours. That brings the total number of fatalities to 29,092 since the start of the war.

The ministry does not distinguish between civilians and combatants in its records, but says around two-thirds of those killed were women and children. More than 69,000 Palestinians have been wounded, overwhelming the territory's hospitals, less than half of which are even partially func-

The Health Ministry is part of the Hamas-run government in Gaza but maintains detailed records of casualties. Its figures from previous wars in Gaza have largely matched those of UN agencies, independent experts and even Israel's

The war began when Hamas-led militants stormed into southern Israel from Gaza on October 7, killing some 1,200 people, mostly civilians, and taking around 250 hostage.

More than 100 captives were released during a weeklong cease-fire in November in exchange for 240 Palestinians imprisoned by Israel.

attack by launching one of the deadliest and most destructive military campaigns in recent history on the besieged enclave, which has been ruled by Hamas since 2007. Israel says it has killed over 10,000 Palestinian militants, without providing evidence. The military says it tries to avoid harming civilians and blames the high death toll on Hamas because the militant group fights in dense residential neighbourhoods. The military says 236 of its soldiers have been killed since the start of the ground offensive in late October. The war, which shows no sign of ending, has driven around 80 per cent of the Palestinians in Gaza from their homes and has left a quarter of the population starving, according to UN officials.

On Sunday, Benny Gantz, retired general and a member of Netanyahu's three-man War Cabinet, warned that the offensive would expand to Rafah if the hostages are not freed by the start of the Muslim holy month of Ramadan, which is expected to begin around March 10. The month of dawn-to-dusk fasting is often a time of heightened tensions in the region.

Israel has said it is devel oping plans to evacuate civilians from Rafah, but it's not clear where they would go in the devastated territory, large areas of which have been flat-tened. Egypt has sealed the border and warned that any mass influx of Palestinians could threaten its decades-old peace treaty with Israel.

The United States says it is still pushing for a truce and hostage-release, and that it would veto a UN Security Council resolution calling for an immediate cease-fire because it conflicts with those efforts. Hamas has said it won't release all of the remaining hostages until Israel ends the war and withdraws from Gaza. It is also demanding the release of hundreds of Palestinian prisoners, including top mili-

Netanyahu has rejected those demands, calling them "delusional." In a speech before American Jewish leaders on Sunday, he said pressure should be applied on Qatar, which played a key role in mediating last year's ceasefire and hostage release deal. "Qatar can press Hamas as no

Palestine accuses Israel of apartheid

Diplomat asks UN court to declare its occupation illegal

 $T^{\text{he Palestinian foreign minister on Monday accused}} \\ \text{Israel of apartheid and urged}$ the United Nations' top court to declare that Israel's occupation of lands sought for a Palestinian state is illegal and must end immediately and unconditionally for any hope for a two-state future to survive. The remarks came at historic hearings into the legality of Israel's 57-year occupation. The case opened against the backdrop of the Israel-Hamas war, which immediately became a focal point of the day — even though the hearings were meant to centre on Israel's open-ended control over the occupied West Bank, the Gaza Strip and annexed east

Palestinian Foreign Affairs Minister Riyad al-Maliki told the International Court of Justice that "2.3 million Palestinians in Gaza, half of them children, are besieged and bombed, killed and maimed, starved and displaced."

"More than 3.5 million Palestinians in the West Bank, including in Jerusalem, are subjected to colonisation of their territory and racist vio-lence that enables it," he added.

International law expert Paul Reichler, representing the

the policies of Israel's govern-ment "are aligned to an unprecedented extent with the goals of the Israeli settler movement to expand long term control over the occupied West Bank, including East Jerusalem, and in practice to further integrate those areas within the territory" of Israel.

The hearings follow a request by the UN General

Assembly for a non-binding advisory opinion into Israel's policies in the occupied territories. Judges will likely take months to issue an opinion.

Israel's representatives were not scheduled to speak but submitted a five-page letter to the court last July that was published after Monday's hearing. In the letter, Israel said that the questions put to the court are prejudiced and "fail to recognise Israel's right and duty to protect its citizens," address Israeli security concerns or acknowledge Israel-Palestinians agreements to negotiate issues, including "the permanent sta-tus of the territory, security arrangements, settlements, and borders."

"While the request made to the Court seeks to portray it as such, the Israeli-Palestinian conflict is not a cartoon narrative of villain and victim in

which there are no Israeli rights and no Palestinian obligations," "Entertaining such a falsehood can only push the parties further apart rather than help create conditions to bring them closer together." Prime Minister Benjamin

Netanyahu said in a statement on Monday that Israel does not recognise the legitimacy of the hearings at the International Court of Justice about Israel's occupation of Palestinian territories. "The discussion at The Hague is part of the Palestinian attempt to dictate the results of the political agreement without negotiations," he said. In court, al-Maliki cited the right to selfdetermination enshrined in the UN charter as he told judges that "for decades, the Palestinian people have been denied this right and have endured both colonialism and apartheid." The Palestinians argue that Israel, by annexing large swaths of occupied land, has violated the prohibition on territorial conquest and the Palestinians' right to self-determination, and has imposed a system of racial discrimination and apartheid. "This occupation is annexation and supremacist in nature," al-Maliki said and appealed to the court to uphold the Palestinian right to self-determination and

tion is illegal and must end immediately, totally and unconditionally."

After the hearing, al-Maliki said that the court's opinion could increase chances for peace. "This ruling could help both Palestinians and Israelis to finally live side by side in peace, mutual security and dignity," he told reporters.

An unprecedented 51 countries and three international organizations will address the court in the coming days.

Palestinians and leading rights groups argue that the ccupation goes far beyond defensive measures. They say it has morphed into an apartheid system, bolstered by settlement building on occupied lands, that gives Palestinians second-class status and is designed to maintain Jewish hegemony from the Jordan River to the Mediterranean Sea. Israel rejects any accusation of

Israel captured the West Bank, east Jerusalem and the Gaza Strip in the 1967 Mideast

The Palestinians seek all three areas for an independent state. Israel considers the West Bank to be disputed territory, whose future should be decided in negotiations.



Attack by Houthi

The ship targeted in the Houthi attack on Sunday reported sustaining damage after "an explosion in close proximity to the vessel," the British military's United Kingdom Maritime Trade Operations centre reported.

Dubbed Aspides, Greek for "shield," the mission will be run out of Larissa in central Greece – home to the Hellenic Air Force and a NATO headquarters — under the command of Greek Commodore Vasilios

The Iranian-backed Houthis have waged a persistent campaign of drone and missile attacks on commercial ships over Israel's offensive in Gaza against Hamas which began in October.

Aan unconfirmed number of bystanders were killed in a gunbattle between warring tribes in Papua New Guinea, police said Monday. A tribe, their allies and mercenaries were on their way to attack a neighboring tribe when they were ambushed Sunday in Enga province in the South Pacific nation's remote highlands, Royal Papua New Guinea Constabulary Acting Superintendent George Kakas

Police Commissioner David Manning later described the clash as a "gunbattle between warring tribes". An unconfirmed number of villagers also were killed. Ursula von der Leyen seeking 2nd term as head of EU's Commission

ermany's Ursula von der Leyen will seek a second term as head of the European Union's powerful Commission in a move that could make her the most significant politician representing the bloc's 450 million citizens in a over a generation. Following five years of leading the 27-nation bloc through multiple crises, including the COVID-19 pandemic and the first two years of Russia's war in Ukraine, the 65year-old was put forward by her German Christian Democratic Union party and will only need a further rubber stamp when the party's European umbrella group meets early next month in Bucharest.

The party's leader, Friedrich Merz, said on Monday in Berlin that his German party "unanimously chose Ursula von der Leyen" to be the candidate to stay in her post. She also stands a good chance of extending her reign over the executive Commission since the Christian Democrat-dominated European People's Party is expected to remain the biggest in the legislature following the June 6-9 European elections. She flaunted her progressive credentials early on by pushing through a Green Deal that put



the bloc at the forefront in the global fight against climate change and amounted to a sea change in EU policy. However, with Europe's political mood shifting recently to the right, von der Leyen acknowledged the changes.

The world is totally different compared to five years ago," she said in her acceptance speech. She was among the most outspoken defenders of Israel since the war erupted with the October 7 Hamas attack on Israel — even as international outrage over the Israeli offensive is growing. Her green credentials also have been sorely dented as she appeared to side with farmers during the past weeks of relentless farming protests through-out the bloc. There has been no wavering though when it comes

to Ukraine, and she has staunchly defended President Volodymyr Zelenskyy as his nation faces two years of Russia's aggression. Beyond pushing for sanctions against Russia, she has equally worked to get financial aid to Kyiv and fought to open EU membership talks with Ukraine.

Overall, it has turned the physician and mother of seven into the most prominent EU Commission president since Frenchman Jacques Delors dur-

ing the 1990s. Even if the EPP emerges from the elections as the biggest party, it does not give her an automatic right to extend her posting. The leaders of the 27 member states must approve her, and it is part of a mix of decisions on EU top post, from EU foreign policy chief to parliament president.

After protracted haggling over such posts five years ago von der Leyen herself came out of the blue to claim the position after receiving critical support of French President Emmanuel Macron. With the continuing war in Ukraine and the possible election of Donald Trump as US president in November, EU leaders will unlikely be prone to experiment too much with the helm of the

Fighting back tears, Yulia Navalnaya accused Russian President Vladimir Putin of killing her husband in the remote prison and vowed to punish him and other alleged perpetrators. She also slammed the authorities, saying they were refusing to hand over the body to Navalny's mother to cover-up his alleged killing, and referred to his alleged earlier poisoning with a Soviet-era

Russian authorities said that the cause for Navalny's death Friday at age 47 is still unknown. He had been jailed since January 2021, when he

perating in Germany from poisoning with a Novichok-type nerve agent that he blamed on the Kremlin. He received three prison terms since his arrest, on a number of charges he has rejected as politically motivat-"They are cowardly and meanly hiding his body, refus-ing to give it to his mother and lving miserably while waiting for the trace of another Putin's Novichok to disappear,"

She urged Russians to rally behind her "to share not only the grief and endless pain that has enveloped and gripped us, but also my rage."

Navalnava said.

"Rage, anger, hatred for those who dared to kill our future," she said. "I address you with the words of Alexey, in which I really believe: It's not a shame to do little, it's a shame to do nothing. It's a shame to let yourself be intimidated."

Navalnaya urged all those who mourn Navalny to unite to fulfil his dream of a "beautiful

Russia of the future" so that "the unimaginable sacrifice" he made would not have been in vain. "The main thing that we can do for Alexei and ourselves is to keep fighting," she said. "Stronger, more fiercely and valiantly that we did before. We all need to get together in one strong fist and strike that mad regime, Putin, his cronies, bandits in epaulets, thieves and killers who mutilated our country.

Navalny's spokesperson Kira Yarmysh said that the Investigative Committee, the country's top criminal investigation agency, informed Lyudmila Navalnaya that the cause of her son's death remained unknown and that the official probe had been extended. "They lie, buy time for themselves and do not even hide it," Yarmysh posted on X, formerly Twitter.

Many world leaders blamed President Vladimir Putin and his government for Navalny's death. On Monday,

EU foreign policy chief Josep Borrell said the bloc was mulling sanctions against Russia. He noted the responsibility for Navalny's death lies with "Putin himself, but we can go down to the institutional structure of the penitentiary system in Russia," to track down those involved and impose asset freezes and trav-

was there, Yarmysh said. Asked when Navalny's body could be handed over to his family, Peskov responded that the Kremlin was not involved in those proceedings, adding that the official probe was contin-

Navalny's ally Ivan
Zhdanov denounced the Russian authorities as "lackeys and liars." "It's clear what they are doing now — covering up the traces of their crime," he wrote on Monday. Navalny's death has

deprived the Russian opposition of its most well-known and inspiring politician less than a month before an election that is all but certain to give Putin another six years in power. It dealt a devastating blow to many Russians, who had seen Navalny as a hope for political change following his unrelenting criticism of the Kremlin.

Nearly 300 people have been detained by police in Russia as they streamed to ad-

ments to victims of political repression with flowers and candles to pay tribute to Navalny, according to OVD-Info, a group that monitors political arrests. The US and British ambassadors also mourned Navalny's death at a memorial in Moscow.

Authorities cordoned off some of the memorials across the country and were removing flowers at night, but they kept appearing. Over 50,000 people have submitted requests to the Russian government asking for Navalny's remains to be handed over to his relatives, OVD-Info said.

Russia's Penitentiary Service reported that Navalny felt sick after a walk on Friday and became unconscious at the penal colony in the town of Kharp, in the Yamalo-Nenets region about 1,900 kilometres northeast of Moscow. An ambulance arrived, but he couldn't be revived, the service said, adding

"being established." Some Russian media claimed that Navalny's body bore bruises, possibly caused by medics' attempts to resuscitate him. The reports couldn't be independently confirmed.

'Govt will scuttle illegal efforts to impeach Muizzu'

Accusing the Opposition of trying to illegally over-throw Maldivian President Mohamed Muizzu's government in less than 100 days in power, a senior minister has said the administration would not allow them to do so unless they cut "every vein in our

The comments by Minister of Islamic Affairs Mohamed Shaheem Ali Saeed came on Sunday as he was accompanying Muizzu on his first trip to Addu, the second-largest urban area in the Maldives in terms of population. Pro-China Muizzu, 45, defeated Indiafriendly incumbent Ibrahim Mohamed Solih in the presidential runoff held in September last year.

Saeed alleged that the government is facing challenges from inside and out, and were being bombarded with the relentless spread of misinfor-mation and baseless rumours, The Edition reported. He said that it is the responsibility of the Opposition to hold the govern-

ment accountable. However, he said, it is not part of holding a government throw a government elected by the people just as it has begun, in a manner that will ultimately cause the most harm to the people themselves.

'They have turned this into a game, it is of great concern that they have gone to the point where they are discussing impeaching a President elected by the people of this country," he said. "They cannot illegally overthrow this government, God willing. They cannot turn this into a sort of twisted game and impeach the President, God willing. They can only do so by first cutting every nerve in our throats, God willing. There is no other way of achieving that," Shaheem asserted.

Japan hosts conference to support Ukraine reconstruction

Japanese Prime Minister Fumio Kishida on Monday pledged his country's long-term engagement in Ukraine's reconstruction, calling it a future investment, as Japan stressed its commitment to supporting the war-torn country ahead of the two-year anniversary of Russia's invasion.

In his keynote speech at a conference Japan co-organized with the Ukrainian government and business organizations, Kishida said Japanese public and private cooperation will be a long-term partnership based on inclusivity, humanitarianism as well as technology and knowledge. More than 50 cooperation deals were signed by Japanese and Ukrainian government agencies and companies.

Kishida stressed the importance of investment across industries for the future of that country's development and ensuring that the support caters to Ukraine's needs. Support for Ukraine's reconstruction is about "investing in the future," Kishida said. "The war in Ukraine is still going on at this very moment and the situation is not easy. The promotion of economic reconstruction, however, is not only an investment for the future of Ukraine but also investing in Japan

Ukraine's Prime Minister Denys Shmyhal, who heads headed his country's delegation of more than 100 people, expressed thanks for the encouragement and said that "today is the new start of cooperation between the two countries." He said "Ukraine is not just rebuilding, we are generating new rules of the game, new approaches," he said. All eyes are on Ukraine, and "dictators and potential invaders" are also turning their eyes to see how Russia's violation of the international law is seen and how the world will

About 300 people and 80 companies are to attend from the two countries, Japanese officials have said. Russia 'crushes' last pocket of resistance in Avdiivka

last pocket of resistance at the eastern Ukraine city's huge coke plant, the Russian military said Monday, after the sheer weight of its troop numbers and greater firepower drove out Kyiv's forces. Moscow officials announced on Saturday said they had taken control of Avdiivka. Ukrainian forces confirmed pulling out of the bombed-out city in what amounted to a triumph for the Kremlin even though the fourmonth battle was costly. The victory was a morale boost for Russia, days ahead of the twoyear anniversary of its fullscale invasion of its neighbour on Feb. 24 2022. For Ukraine, the loss underscored its reliance on the supply of Western weapons and ammunition, as hold-ups have left it short of provisions and handicapped in the fight.

Thai prosecutors said ▲ Monday that further investigation is needed to decide whether to bring former Prime Minister Thaksin Shinawatra to trial for defaming the monarchy, just a day after he was freed from a prison sentence on other charges he was serving in a hospital.

Thaksin was released on parole Sunday from the hospital in Bangkok where he spent six months serving time for corruption-related offenses. He had been in self-imposed exile since 2008, but returned to Thailand in August last year to begin serving an eight-year sentence. On his return, he was moved almost immediately from prison to the hospital on grounds of ill health, and about a week after that King Maha Vajiralongkorn reduced his sentence to a single year.

Thaksin was granted parole earlier this month because of - he is 74 - and ill health, leaving him free for the remainder of his one-year sentence. Thaksin was briefly detained Sunday by police from the Technology Crime Suppression Division as he left Bangkok's Police General Hospital but was allowed temporary release to return home as it was not a working day for the prosecutor's office, Prayuth Bejraguna, a spokesperson for the Office of the Attorney General, said at a news conference on Monday.

The attorney general's office had announced earlier this month it had revived an investigation into whether Thaksin almost nine years ago violated the law against defaming the monarch, a crime punishable by up to 15 years in prison. Thaksin was originally charged in 2016 with violat-

ing the law for remarks he made to journalists when he was in Seoul, South Korea, a year before that, but the investigation could proceed only after he was presented with the charge in person in the hospital last month, officials said. Prayuth said Thaksin

reported to the attorney general's office on Monday for the charge, also known as lese majeste, and he was granted release on bail by posting a 500,000 baht (\$13,900) bond without conditions beyond those of his parole. The conditions include travel restrictions and reporting himself every month for the remainder of his sentence. Prayuth said the attorney general has taken into consideration Thaksin's statement in his own defense and decided to order a further investigation of his case. He was

Court slams Kakar for non-appearance in missing Baloch students case

The caretaker prime minister should not go to Karachi for the next hearing, but appear before the court, the IHC judge was quoted as saying by Geo News. No one is above the law here," he said, adding that the premier was summoned because he was "accountable". The IHC summoned Kakar again, adjourning the hearing till February 28.

Garros tennis complex. The IOC said Sunday it wrote to Olympic officials in Philippines explaining the age limit for boxers of 40 will be upheld. The IOC now oversees Olympic boxing after de-recognising the International Boxing Association governing body.
The age limit for Olympic boxing was raised to 40 from 34 in 2013 - a move that would have let Pacquiao try to compete at the 2016 Rio de Janeiro Olympics. He chose


