⊣he Supreme Court on Tuesday declared defeated AAP-Congress alliance candidate Kuldeep Kumar the Mayor of Chandigarh after overturning the result of the controversial poll where the BJP nominee had emerged an unlikely winner, in an unprecedented order to set right an attempt

court said the result declared by the returning officer, a returning officer Anil Masih, nominated Councillor, was clearly contrary to law.

A bench headed by Chief Justice DY Chandrachud said before the court that he had in such a case, the top court was duty bound, particularly in the context of its jurisdiction under Article 142 plenary power under Article of the Constitution, to ensure 142 of the Constitution to do that the process of electoral of the Constitution, to ensure

democracy is not allowed to be thwarted by subterfuge. The bench, also comprising Justices JB Pardiwala and

Manoj Misra, said the court must step in where exceptional situations develop to ensure that the basic electoral mandate of democracy is preserved. "We accordingly order and direct that the result of the election as declared by the presiding officer (Masih) stands quashed and set aside. The netitioner (Kumar) declared to be the validly elected candidate for election as Mayor of the Chandigarh Municipal Corporation," the bench ruled.

The SC said in each of the eight ballot papers, which were invalidated by Masih, the votes were duly cast in favour of Kumar.

The Congress hailed the Supreme Court decision on the "farcical election", saying it saved democracy from the fangs of an "autocratic BJP" that resorted to dirty election manipulation. Congress president Mallikarjun Kharge said the "institutional sabotage" is only the "tip of the iceberg in Modi-Shah's devious conspiracy to trample democracy".

Delhi braces up for fresh **Farmer assault on Centre**

The borders surrounding Delhi are poised for renewed tensions from Wednesday as protesting farmers have rejected the Government's proposal for a five-year contract on the purchase of maize, cotton, and three types of pulses at the existing minimum support prices.

The possibility of chaos akin to the earlier disruptions on key entry points to Delhi looms large, with farmer groups from Noida and Greater Noida announcing plans to march to the Capital on Friday, demanding developed plots increased compensation for their acquired land. After rejecting the five-point

out-of-the-box formula for the minimum support prices, farmers' leader Sarwan Singh Pandher on Tuesday urged the Centre to convene one-day Parliament session and bring MSP legislation on guarantee. He announced that they would be heading to Delhi on Wednesday.

His statement came a day after the farmer leaders participating in the "Delhi Chalo" agitation rejected the Centre's proposal for procuring pulses, maize, and cotton at the MSP by government agencies for five

years, saying it was not in former favour of farmers.

Meanwhile, the Punjab and Haryana High Court also criticised protesting farmers camping at Shambhu border with hundreds of tractors and said tractor trolleys cannot be used on highways. The bench of Acting Chief Justice GS Sandhawalia and Justice Lapita Banerji also questioned the Punjab Government for allowing the assembly of farmers in such large numbers.

In a related development,

Punjab Minister and BJP leader Amarinder Singh met Prime Minister Narendra Modi and discussed a host of issues related to farmers. Singh said in a post on X, "Had a detailed meeting with Hon'ble PM Shri Narendra Modi ji on wide-ranging issues related to Punjab, including the issues concerning the farmers."

Meanwhile, the Ministry of Electronics and Information Technology (Meity) ordered blocking of 177 social media

the farmers' protests on Monday to maintain "public order," which include 35 Facebook links, 35 Facebook accounts, 14 Instagram accounts, 42 Twitter accounts, accounts, 49 Twitter links, 1 Snapchat account, and 1 Reddit account. While orders to Facebook and Twitter (now X) are commonplace, this is the first blocking order issued to Snap.

The protesting farmers on Tuesday received support from Congress leader Rahul Gandhi, who claimed that "lies" are being spread that the MSP guarantee is not under feasible government's budget. In a post in Hindi on X, Rahul claimed that ever since the Congress resolved to provide legal guarantee for MSP, "Modi's propaganda and media machinery friendly to him have spread a barrage of lies on MSP. Lie — It is not feasible to provide legal guarantee for MSP in the budget government of India."

According to CRISIL, giving MSP to farmers in 2022-23 would have resulted in an additional burden of Rs 21,000 crore on the government, which is only 0.4 per cent of the total budget, Rahul said in his

Maharashtra reaches out to Maratha Community

Mamata writes to PM AAP hails SC order on on Aadhaar deactivation

Bengal Chief Minister Mamata Banerjee has written a letter to Prime Minister Narendra Modi drawing his attention to alleged reports that the Aadhaar cards of a number of people in Bengal had been deactivated.

Referring to how the people were getting letters from the Centre that their Adhaar cards were being deactivated, Banerjee wanted to know as to why such incidents were taking

Saying that she had received a number of representations from the citizens about their Adhaar cards being cancelled causing "chaos and hue and cry among the residents," Banerjee said, "I would like to know from you the causes for such a move. Is it just for the sake of depriving the eligible beneficiaries or to create a panic situation among the people at large just before the Lok Sabha elections.

The Chief Minister had earlier claimed that the BJP-led Centre was 'deactivating'

She earlier said that though the Adhaar cards were being deactivated her Government would create new cards for the victims so that they were not deprived of the government schemes.

The BJP however hit back saying such allegations were wild and no such initiative had been taken from the Centre. "Everyone's Adhaar is safe and if there is some glitches then that will be taken care of by

tonight ... I am speaking to the right authorities," Bengal BJP president Sukanto Majumdar said. The Unique Identification Authority of India (UIDAI) too clarified that no Adhaar card was being deactivated. "In the course of activities undertaken to keep the Aadhaar database updated, intimations are issued from time to time to Aadhaar number holders. In this connection, it is clarified that no Aadhaar number has been cancelled," it said.

Terming it a big victory for democracy, the Aam Aadmi Party (AAP) on Tuesday hailed the Supreme Court order on Chandigarh mayor elections, which declared the party's candidate Kuldeep Kumar as the winner and demanded that BJP leaders apologise to the country for its "dishonesty" during the elec-Terming the decision historic,

AAP convener and Delhi Chief Minister Arvind Kejriwal at a press conference said that this was big victory for the Indian National Developmental Inclusive Alliance (INDIA). "The message of this poll is that if INDIA bloc parties remain united and work strategically, they can defeat the BJP," he said. "We thank the Supreme Court...dictatorship is going on in the country...democracy is being trampled upon, all institutions are being trampled upon. In such times, this ruling by the SC is very important for democracy and to save democracy. It's a very important decision," said Kejriwal. Hitting out at the BJP, Kejriwal said if it can "steal" eight votes out of 36 in the Chandigarh mayoral polls, what will it do in



the upcoming elections in which 90 crore votes will be polled. "Thank you SC for saving democracy in these difficult times," he said in a post on X earlier Tuesday.

"Those who say BJP can't be defeated... BJP can be defeated with unity, good planning and strategy and diligence. This election result (Chandigarh mayor polls) has proved that.It's a victory for the people of Chandigarh. It's a victory for the whole country. Entire nation saw how the BJP stole this election," he added further. In a separate press conference, AAP spokesperson and Delhi Minister Saurabh Bharadwaj said the Supreme Court's order has exposed the BJP and shown it the mirror. And it' leaders should apologise to the country if they have any shame left.

"It is a matter of grave concern that if the BJP and its central government can do such open stealing and dishonesty in such a small poll, what would they do in other elections where there are no microphones and CCTV cameras," Bharadwaj

The BJP won the Chandigarh mayoral polls on January 30 defeating the comfortably placed AAP-Congress alliance candidate after the returning officer declared as invalid eight votes of the coalition partners, drawing accusations of tampering with ballots. Manoj Sonkar of the BJP defeated Kuldeep Kumar after polling 16 votes against his rival's 12 to bag the mayor's post. Sonkar, however, resigned subsequently, while three AAP councillors defected to the BJP.

Aglobal team of researchers from Australia, the USA, UK, France, Korea, and the George Institute India has collaborated to develop SONG-LP, a tool to assess life participation of individuals who have undergone kidney transplants. Kidney failure often severely limits patients' ability to engage in daily activities, making kidney transplantation a crucial treatment option, as it offers freedom from many of these restrictions.

This tool, developed through a consensus workshop involving 249 adult recipients from 20 countries, measures engagement in leisure, family, work, and social activities.

This questionnaire serves as a core patient-reported outcome



measure, specifically designed to evaluate the ability of kidney transplant recipients to engage in various aspects of life, including leisure, family, work, and social activities.

The questionnaire itself is userfriendly, featuring a scale from 0 (never) to 4 (always) for participants to rate their engage-ment in each aspect of life. The

We hope that clinicians and researchers around the world including in India will use it to improve the quality of care so that it becomes more patient-centred and informs patient-relevant research.'

The team aims to conduct future research to include a more diverse group of kidney transplant recipients, ranging from those facing health issues

to those in good health. This will help determine whether the observed high levels of life participation are consistent across the entire kidney transplant recipient community or if they apply more to specific. Chronic kidney disease (CKD) is a growing global public health problem in terms of mortality, disability, and financial costs. Globally, around 13 per cent of the general population have some form of

A significant proportion of patients with CKD progress to end stage renal disease. Currently, renal dialysis and kidney transplantation are the only two types of treatment available for patients with end stage renal disease. Globally, the number of dialysis patients is projected to increase to 4.9 million by 2030.

Subsequently, a five-judge bench of the Supreme court had in April 2023 refused to re-examine the apex court's order of May 2021 by which it had declared a Maharashtra law to grant reservation to Marathas "unconstitutional". In a related development, Shivba Sanghatana leader Manoj Jarange-Patil, whose fast-unto-death agitation had prompted government to introduce the Maratha reservation Bill in the State Legislature, refused to call off his 11-day-old agitation, by saying that the passed legislation amounted to the "betrayal to the Maratha community", since the quota should have been provided under the Other Backward Classes (OBC) category and not separate. Jarange-Patil has called a meeting of the representatives

of Maratha community at noon on Wednesday to decide on his future course of action. Earlier, Chief Minister Eknath Shinde said that his government had all been committed to reservations to the Maratha community. "All of us have similar views on the Maratha reservation. With the cooperation of you all, we could do it. I kept my promise which I made to the Maratha community. I thank all my colleagues including my both deputy chief ministers and other ministers. Jaishankar: Buying oil SC: AAP from Russia stabilises global energy market

External Affairs Minister S Jaishankar has defended procuring oil from Russia and said following the Ukraine conflict India's energy suppliers in the Middle-East gave priority to provide petroleum products to Europe that paid higher prices. New Delhi did not have any option but to procure Russian crude oil which in turn stabilised the global energy market, he

Making these points in an interview to German economic daily Handelsblatt, Jaishankar also suggested that India was open to play the role of a mediator to end the Russia-Ukraine conflict if approached, but at the same time, said New Delhi does not believe that it should initiate anything in this direction on its own.

He asserted that just as India does not expect Europe to have a view of China that is identical to New Delhi's, Europe should understand that India cannot have a view of Russia that is identical to the European one.

The external affairs minister said India has had a "stable" and "very friendly" relationship with Russia, and that Moscow never hurt New Delhi's interests. "We, on the other hand, had a politically and militarily much more difficult relationship with China, for example," he said.

St Stephens suspends unruly students on campus, revokes it later

In an email addressed to stu-dents and their parents, Stephen's College principal John Varghese clarified that there will be no suspension with regard to attendance for the morning assembly. "On Saturday, 17th February 2024 an email was sent from my office. It was a miscommunication, incorrectly worded and my sincere apolo-

gies for that. I was also not event even though small porcopied on that email, a practice which is normally followed when I instruct my office to communicate, in written mode, on my behalf. Let me therefore set right the matter through this email," the email by Varghese

The principal also stated that the morning assembly held in the college is an old tradition and not organised as a religious exercise while pointing that small portions from several religious and philosophical texts are read out during the assem-

Every college has its unique set of practices and traditions, and Stephen's College is no different. The morning assembly in College is an old tradition of the College. It is not a religious tions from several religious and philosophical texts are read out," he wrote in the email. He added that students, espe-

cially those studying in first year, are expected to attend the morning assembly to "understand the history, traditions and practices" of the college. Varghese also said the email was addressed to parents of students to keep them informed about the performance of their wards "Parents are important stakeholders in the broad-based, wholesome education that College provides, and it is in this spirit that parents were addressed in the incorrectly

email. My apologies for that," he wrote, while adding that the col-



lege will continue to engage with parents of students for their wel-

Varghese further asked parents who were not able to meet him to fix an appointment with his office to discuss the matter

"Students are encouraged to attend the morning assembly and parents will continue to be kept informed of the performance of their wards," he said. Earlier in the day, teachers and students raised concern over suspension of first year students

and an email barring them from attending second semester examination for not attending morning assembly at the college. The students said their parents were asked to meet the principal over the issue failing which the students were barred from sitting for the exam.

The students had said setting up an appointment was not fea-sible for many "since their par-ents do not live in Delhi-NCR and, hence, it wasn't possible for them to travel all the way to Delhi at short notice due to prior commitments, scheduling issues, and financial issues".

'Regrettably, due to non-compliance with the request, I inform you that the students will not be allowed to sit for the upcoming examination as consequences of the suspension," the email sent to the students' parents and guardians read. The students claimed that their attempts to fix appointments without their guardians were also rejected. The move drew flak from all quarters including teachers from the college who said it was against university rules to "force" students to take part in a religious activity.

The teacher had also demanded disciplinary action against the person concerned who sent the email.

Sanjeev Grewal, head of the college's economics department, said in an email dated February 20 (Tuesday) to Principal Varghese, "I am quite shocked to know that a large number of students have been suspended from college and it has been threatened that they will also be

debarred from appearing in the examinations. In my opinion, students can be debarred from appearing in the examinations only on the grounds explicitly stated in the university rules and regulations. To the best of my knowledge, the shortage of attendance in the morning college assembly is not a ground for debarring students from appearing in the examinations."

The morning assembly is a

convention specific to St. Stephen's College and is not recognized by the university (not to talk of it being a requirement for appearing in the examinations), nor does the failure to attend morning assembly, in my humble opinion, constitute a legitimate ground for suspension from the college, the HOD

AAP MLAs protest against stalling of one time water bill settlement

AAP MLAs trooped into the Well of the Delhi Assembly and protested against the stalling of the one-time settlement scheme for rectifying water bills, leading the speaker to adjourn the House for the day on Tuesday. Meanwhile, Leader of Opposition in Delhi Assembly Ramvir Singh Bidhuri claimed that he was misbehaved by AAP MLAs during the House proceeding on Tuesday. There were 198 such communities and many of them were targeted during the colo-nial rule as they had raised their voices against the unjust rule, the AAP MLA said. "Today in Delhi there are 29 such communities. I appeal to you (the House), and the chief minister (Arvind Kejriwal) to implement the recommendations of the Idate Commission in Delhi so that such communities can be brought into the mainstream and get the due benefits," Lal said

This is as per the commitment of the Delhi Development Authority (DDA) to develop world class infrastructure along with green space and beautify the Dwarka sub city. West Delhi MP Parvesh Sahib Singh and South Delhi MP Ramesh Bidhuri, and other senior officials of the DDA were also pre-

completed by DDA at the cost of Rs 300 crore. The SWC 2 has capacity of 7 MLD and SWC 5 has 9.5 MLD capacity to treat sewage. The rejuvenation of storm water channels 2 and 5 to address the issue of drainage system, provide green space, add to the public amenities and beautify the Dwarka sub-city. SWC2 and SWC5 Channels pass through many sectors (8, 9, 20, 23, 19, 24 and Sectors 3, 13, 14, 16) of Dwarka before merging with Najafgarh drain which further falls into River Yamuna. SWC2 has length of 5.2 Km and SWC5 has a length of 3.8 Km. Over the past few years, these channels have been subjected to discharge of adjoining colonies and other areas lacking sewerage facilities. The channels became open sewers and resulted in inhospitable situations in the nearby areas.

To address these pollution issues and boost the overall environmental wellbeing, DDA executed this project to rejuvenate the channels by sewerage interception and treatment along with area development of adjacent green buffer zones and open areas. The channels to act as greenways connecting metro stations to the residential areas and major public areas like Golf Course, Bharat Vandana Park, sports complex etc. along the entire length of 9 km and also incorporate a solar arcade consisting of 44 domestic waste waters from nos. of solar flower with the capacity to generate 203KWp

The US is engaged with India on the issue of alleged failed plot to kill a Sikh separatist and it is looking forward to the findings of the high-level committee appointed by New Delhi to probe the matter, US Deputy Secretary of State Richard Verma said on Tuesday. In December, Washington said

it thwarted an alleged plot hatched by an Indian agent to kill Sikh separatist Gurpatwant Singh Pannun on American soil. India has already constituted a probe committee to investigate the allegations.

"On the issue that was raised, look, we raised our concerns with the government of India. There is a committee of inquiry looking into the matter and we will stay engaged with the government and look forward to their findings and they've taken it very seriously. And we're grateful for that,'

The former US Ambassador to India was responding to a question at an interactive session organised by the Observer

Delving into various geo-political challenges, he also lauded the Indian Navy's role in strategic waters in view of attacking Houthi militants attacking various commercial vessels in the Red Sea.

We appreciate everything India has been doing in the Red Sea with its Navy and the incredible support that they have provided. I am grateful to all of our US military partners or other coalition partners," he said.

In the last few weeks, the Indian Navy extended assistance to a number of merchant vessels in the Arabian Sea following attacks on them. India has not joined any coalition including the one backed by the US in view of the security situation in the Red Sea. Verma said the US-India rela-

tions are "surging forward at a pace and scale that many of us could not have predicted only a few years ago". He also suggested that the

cooperation under the Quad framework is not to contain China and that the overarching goal is to ensure a peaceful Indo-Pacific region.



More broadly, that stands on its own and I think it sends a very powerful message around the world, he said, adding the threats in the Indo-Pacific are

The threats we face are real, but building our collective capabilities, increasing our sharing of information and improving maritime domain awareness and interoperability, for example, will ensure India continues to be a provider of net security across the Indo Pacific region and beyond," Verma said.

And the US will continue to be a Pacific power for the decades ahead," he said, adding that Washington's work on protecting, preserving and strengthening democracy will

tant in view of the rise of autocratic and authoritarian leaders and movements that seek to undermine the rules based order, he said in comments seen as an oblique reference to leadership of China and Russia.

"This includes continuing to strengthen a global rules based order, architecture, ensuring we bridge divides on income inequality and battling miss disinformation. and Democracy must continue to

deliver for our peoples," he On US-China rivalry, Verma

said, "We are engaged intensively in strategic competition with China; cooperating where we can, but competing aggressively to protect the rules based (global) order." He also noted that former US

presidents Harry S Truman, Dwight Eisenhower and John F Kennedy were all committed to seeing a strong US-India relationship. The senior American official said before Kennedy became President in 1961, as a Senator said the fate of Asia rests with India.

Following the Chinese attack

Kennedy committed thousands of tonnes of ammunition, and even provided significant logistics and intelligence support to New Delhi. "He was committed to India's

success and its defence. And then yes, somewhat rapidly and for reasons that I think are too complex to cover today in the short amount of time we have, India and the United States went their separate ways for nearly 25 years," he said. Verma said "We lost a generation of cooperation and the important lessons are to be learned from that period so that we don't repeat the mis-

takes of the past. He said President Bill Clinton's visit to India in 2000 marked the launch of "full scale partnership" between the two

Dispel myths surrounding new criminal laws: UGC

 $T_{\text{Commission (UGC) has directed universities and}}^{\text{he University Grants}}$ Higher Education Institutions (HEIs) across the country to publicise the new criminal laws and dispel "myths" surround-

Among the "myths" cited by the UGC are that the new laws "threaten" individual freedom and aim to establish a "police state", that sedition provisions have been retained under 'Deshdroh' and that these legislations enable "police torture". UGC Secretary Manish Joshi said, "The Higher Educational Institutions have been requested to publicise the Bharatiya Nyaya Sanhita, 2023 around the themes contained in the flyers and by carrying out campaigns by way of displays through standees, distributing flyers and organizing



seminars and talks by lawyers, judges both serving and retired and their respective faculties in

The HEIs have also been asked to share the details of the activities undertaken to the Ministry of Education for sending them to Home Ministry, he added. The Bharatiya Sakshya Sanhita, 2023, The Bharatiya Nagarik Suraksha Sanhita Bill, 2023, and The Bharatiya Nyaya Sanhita, 2023 were passed by both Houses of Parliament during the Winter Session. They were enacted into law after they got assent from President Droupadi Murmu. They will respectively replace Indian Evidence Act, 1872, the Criminal Procedure Code, 1973 and the Indian Penal Code (IPC).

In its flyers, the UGC has mentioned the following "myths": "The new criminal laws threaten individual freedom, aim to establish a police state; (they) are mere repackaging of existing draconian provisions; the extension of custody from 15 to 90 days in the new criminal laws is a shocking provision enabling police torture; sedition is gone, but appears as 'Deshdroh' in Bharatiya Nyaya Sanhita 2023 and harsh punishment in hitand-run cases under Bharatiya

Nyaya Sanhita 2023". While 20 new offences have been added in the (BNS), 19 provisions that existed in IPC have been deleted. In 33 offences the punishment of imprisonment has been increased, in 83 the punishment of fine has been enhanced, while in 23 the mandatory minimum punishment has been introduced and in six offences the punishment of 'community service' has been introduced.

The major changes proposed in the new criminal laws include

introduction of definition of child; inclusion of transgender in the definition of 'gender'; inclusion of electronic and digital records in the definition of document and widening of the definition of 'movable to include property of every

description. New chapters on offence against woman and child and 'inchoate offences' (attempt, abetment and conspiracy) have been introduced while beggary has been introduced as a form of exploitation for trafficking. New offences like organised crime, terrorist act, petty organised crime, hit-and-run, mob lynching, hiring child to commit offence, sexual exploitation of woman by deceitful means, snatching, abetment outside India, acts endangering the sovereignty, integrity and unity of India, publication of false or fake news etc have been intro-

Rights panel serves notice on DGCA over death of old man denied wheelchair at airport

 ■ Rights Commission (NHRČ) has sent a notice to the Directorate General of Civil Aviation (DGCA) over reports that an 80-year-old man died at the Mumbai airport after he was refused a wheelchair despite prior request to an airline and forced to walk.

Reportedly, the US-based Indian-origin man collapsed after walking for about 1.5 km on the way to the immigration area, the NHRC said in a statement. He was walking alongside his wife, who was in a wheelchair.

The elderly couple was travelling from New York to India, the rights panel said, quoting the report. The NHRC said it "has taken

request to the airline." The Commission observed that the content of the media report, if true, raises a serious issue of violation of human rights of the victim. It has asked the DGCA for a

detail report in four weeks. It should include the status of compensation if any, provided to the next of kin of the deceased, the statement said. The Commission said it would also like to know the steps taken or proposed to be taken to ensure that such incidents do not recur.

Locking horns

Protesting farmers reject Government's offer on MSP, 'Delhi Chalo' march to resume today

gitating farmers intend to intensify their 'Delhi Chalo' protest from Wednesday as their negotiations with the Government remain deadlocked. With both sides adamant On their respective positions, it seems unlikely that the stalemate will end in a hurry despite several rounds of dialogue. Foremost among the farmers' demand is the insistence on legal assurances for a minimum support price (MSP) across all crops, coupled with open-ended procurement of 23 key crops under MSP. Additionally, they seek complete debt waiver for both farmers and farm labourers, along with a reversal of policies perceived as detrimental to their interests. Central to their demands is the implementation of crop prices in line with the recommendations of the Dr MS Swaminathan Commission's report. Farmers are pushing for pensions to be extended to both farmers and farm hands, as well as a waiver on any increase in electricity tariffs. They also seek nationwide enforcement of the Land Acquisition Act of 2013. The demands extend



to the realm of international trade, with calls for India's withdrawal from the World Trade Organisation (WTO) and a freeze on all Free Trade Agreements (FTAs). One may agree or disagree with their demands but these are not unconstitutional.

The latest development in the saga has the farmers rejecting the Government's MSP offer, signalling the resumption of the 'Delhi Chalo' march. The offer, which was made in the midst of ongoing negotiations, failed to meet the farmers' expectations. The MSP offer, though presented as a goodwill gesture by the Government, was perceived by farmers as insufficient and lacking concrete assurances. Despite assurances

from the Government side regarding the continuation of MSP, farmers remain sceptical that the lack of legal guarantees and deregulation could eventually lead to the dismantling of the MSP system. The 'Delhi Chalo' march posturing goes back to 2020, when thousands of farmers from various States converged on the outskirts of Delhi to protest against the farm laws. The march garnered widespread support and attention, both nationally and internationally, highlighting the gravity of the issues. The decision to resume the march underscores the farmers' plan to continue their struggle; it is also a flashback of farmers' siege of the Capital not very long ago. The Government seems to have made the Capital a fortress which, however, does not augur well for a democratic system. Dialogue, not confrontation, should be the way forward. The farmers must respect the law of the land while the Government should try to assuage their anger. It would be prudent to accept some, if not all, farmer demands so that a conducive atmosphere is built for the talks to continue in a congenial atmosphere. As the protest enters a new phase, it is imperative for both sides to engage in constructive dialogue to find a viable solution to the impasse. It is a call to action for all stakeholders to prioritise the nation's interests and work towards a fair and equitable resolution.

India is on the right track in Nepal



Prachanda's adept balancing act and strategic positioning continue to shape the trajectory of Nepal's political future, with implications that extend beyond its borders

rime Minister Pushpa (Prachanda) has completed 13 months of his third term, by far the most successful in leading Nepal with the Maoist party with just 32 seats. A seasoned and balanced Nepali journalist billed Prachanda's tenure as 'firm, polished and people-oriented'. About the power-sharing formula that has become a staple in coalition politics, his assessment was different from that of a senior Nepali Congress parliamentarian who, out of the three options - two-one-two; two and a half and two and a half; and Prachanda doing full five years while not favouring the first option, was hugely critical of it. So was the journalist.

The figures indicate the number of years of premiership. The first set relates to Prachanda and Deuba doing two years each while Madhav Nepal would get one year. The second is minus Madhav Nepal. Astutely, Prachanda, while firing salvos at NC, indicating their alliance has not been rewarding for his party, is also suggesting that the option is open of returning to the CPN (UML) fold, a homecoming for which Chinese leaders will give their right arm and a contingency India will Encroachments are reported dread. China exported USD1.7bn worth of goods in 2022 while it imported USD5.11 mn and has just reopened some border trade posts. Protests were launched in the first week of February about BRI and the Chinesebuilt Pokhara airport. ELECTORAL BONDS NO LONGER VALID

Sir — The Supreme Court (SC) has declared the Electoral Bond (EB) Scheme unconstitutional and upheld the citizens' right to know, as enshrined in the Constitution and the Right to Information Act. The BJP government had concealed the details of the EBs through shrewd legislative manoeuvring. The Representation of the People Act was amended to exclude the EBs from the mandatory reporting requirements, as well as the IT Act and the Companies Act to ensure total secrecy. Bizarrely enough, the Government argued in the SC that "citizens do not have a right to know the funding of political parties.

UIC Law Review published the scholarly work of Conrad Foreman, "Money in Politics: Campaign Finance and its Influence over the Political Process and Public Policy" (2018). He wrote, "Beyond being competitive in the race, fundraising superiority correlates with victories: the better-funded candidate tends to win Congressional races. Between 2010 and Bal Govind | Noida 2016, candidates who outspent their

opponents won ninety per cent of House elections." He further wrote, "After winning their seats, it would only be natural for legislators to consider how their decisions as lawmakers might affect their campaign donors..." and how legislation tends to favour the interests of big business and wealthy individuals over average Americans. In September 2017, the Australia Institute published a report titled, The Tip of the Iceberg: Political Donations from the Mining Industry, which looked at patterns of political donations declared by the mining industry during the 10 years to 2016. The report found that "Donations correlate with the election cycle, timelines on project approvals, and debates on key industry policies such as the mining tax and carbon price." Nonetheless, the specifics of corporate funding of political parties are fully disclosed in these

When we shed body consciousness and identify ourselves as a soul, truth prevails





South Africa accuses Israel of apartheid against Palestinians

South Africa argued at the United Nations' top court on Tuesday that Israel is responsible for apartheid against the Palestinians and that Israel's occupation of land sought for a Palestinian state is "inherently and fundamentally illegal." Israel rejects such claims. The South African representatives were speaking on the second day of hearings at the International Court of Justice into a request by the General Assembly for a non-binding advisory opinion on the legality of Israel's policies in the occupied territories.

"South Africa bears a special obligation, both to its own people and the international community, to ensure that wherever the egregious and offensive practices of apartheid occur, these must be called out for what they are and brought to an immediate end," the country's ambassador to the Netherlands, Vusimuzi Madonsela, told the panel of 15 international judges.

Israel rejects accusations of apartheid and usually dismisses UN bodies and international tribunals as unfair and biased against it. Assange starts legal battle to avoid extradition to US on spy charges

Tulian Assange's lawyers began their final UK legal challenge Tuesday to stop the WikiLeaks founder from being sent to the United States to face spying charges, arguing that his actions had exposed serious criminal actions by US authorities that were "of obvious and" important public interest". Assange himself was not in court. Judge Victoria Sharp said he was granted permission to come from Belmarsh Prison but had chosen not to attend. Assange's lawyer, Edward Fitzgerald, said he was unwell.

The 52-year-old has been fighting extradition for more than a decade, including seven years in self-exile in the Ecuadorian Embassy in London and the last five years in a high-security prison.

Dozens of supporters holding "Free Julian Assange" signs and chanting "there is only one



decision - no extradition" held a noisy protest outside the High Court in London, where Assange's attorneys will ask two High Court judges to grant a new appeal hearing, his last legal roll of the dice in Britain.

"He is being prosecuted for engaging in ordinary journalistic practice of obtaining and publishing classified information, information that is both true and of obvious and important public interest,"

In written submissions, the lawyer said that "Julian Assange and Wikileaks were responsible for the exposure of criminality on the part of the US government on an unprecedented scale." Fitzgerald also said there is a "real risk he will suffer a flagrant denial of justice" if sent to the US. If the judges rule against Assange, he can ask the European Court of Human Rights to block his extradition — though supporters worry he could be put on a plane to the US before that happens. Supporters plan to demonstrate outside the neo-Gothic court building on both days and march to Prime Minister Rishi Sunak's Downing Street office at the end of the hearing.

Judges Victoria Sharp and Jeremy Johnson could deliver a verdict at the end of the twoday hearing on Wednesday, but they're more likely to take

"This hearing marks the beginning of the end of the extradition case, as any grounds rejected by these judges cannot be further appealed in the UK - bringing Assange dangerously close to extradition," the press freedom group Reporters Without Borders said. Assange, an Australian citizen, has been indicted on 17 charges of espionage and one charge of computer misuse over his website's publication of classified US documents.

US prosecutors say he helped US Army intelligence analyst Chelsea Manning steal diplomatic cables and military files that WikiLeaks later published, putting lives at risk. To his supporters, Assange is a secrecy-busting journalist who exposed US military wrongdoing in Iraq and Afghanistan and is entitled to First Amendment protections.

Italy again prosecutes Egypt officials

Rome (AP): Four high-level Egyptian security officials went on trial in absentia before a Rome court on Tuesday, accused in the 2016 abduction, torture and slaying of an Italian doctoral student in Cairo. The parents of the slain student Giulio Regeni, Paola and Giulio Regeni, were on hand for the opening court session and posed outside the tribunal with a banner "Truth for Giulio

Regeni's body was found on a highway days after he disappeared in the Egyptian capital on January 25, 2016.

He was in Cairo to research union activities among street vendors as part of his doctoral thesis.

His mother has said his body was so mutilated by torture that she was only able to recognise the tip of his nose when she viewed it.

Hungary's parliament on ratifying Sweden's bid to join NATO could come as early as Monday, according to a senior member of the country's governing Fidesz party. It would bring an end to more than 18 months of delays by the nationalist government that have frustrated Hungary's allies. In a letter on Tuesday to the speaker of the parliament, the head of the Fidesz caucus, Máté Kocsis, requested that a vote be scheduled for the opening day of the spring session, which begins on Monday. Kocsis wrote that Fidesz, which has repeatedly blocked a vote on the matter, will opt to support Sweden's bid to join the trans-Atlantic military alliance. Hungary is the only one of NATO's 31 existing members not to have ratified Sweden's

admitting a new country to the military alliance requires unanimous approval. On Sunday, a bipartisan

group of US senators visited Hungary and announced they would submit a joint resolution to Congress condemning alleged democratic backsliding in the country and urging Prime Minister Viktor Orbán to move forward on approving Sweden's accession as soon as Sen. Chris Murphy, a

Imran's party demands CEC's resignation

Islamabad (PTI): Jailed former Pakistan prime minister Imran Khan's party on Tuesday reiterated its demand for Chief Election Commissioner Sikandar Sultan Raja's immediate resignation for failing to hold "free and fair" elections after allegations of massive poll rigging emerged. The 71year-old former cricketerturned-politician's Pakistan Tehreek-e-Insaf (PTI) party demanded the CEC's resignation, asserting that he had "no right to stay in the position for a single day," the Dawn newspaper reported.

"After meeting Khan sahib today, the PTI demands that the ČEC resign.

He has no right to stay in the position for a single day," Barrister Gohar Khan said outside Rawalpindi's Adiala Jail, where the PTI founder has been jailed.

Gohar Khan demanded the immediate resignation of the CEC, saying that he failed to hold elections in a free, fair and transparent manner,

according to the report.

He also demanded that all the inquiries into poll dis-crepancies be impartial and without any interference. "We want the election results to be in accordance with the mandate of the public," Gohar Khan was quoted as saying in the report.

On Saturday, Rawalpindi Commissioner Liaquat Ali Chattha, in a bombshell press conference, alleged that he oversaw the rigging to deprive Khan's PTI party of 13 seats, which were given to candidates who were "losing" the elections

Anti-terror bill needs national referendum unless amended, says SL court

Colombo (PTI): Sri Lanka's Supreme Court on Tuesday ruled that the proposed anti-terrorism bill would need a national referendum to be passed unless amendments recommended by it for some clauses are incorporated into it. The apex court's determination on the constitutionality of the bill was read out in Parliament on Tuesday morning by Deputy Speaker Ajith Rajapaksa. Rajapaksa, reading the apex court's order, said eight clauses in the bill had been "deemed inconsistent" with the Constitution. Therefore, it needs a two-thirds majority and in some cases needs to be approved by a referendum to become law, he said. If amended in line with the top court's recommendations, the bill can be adopted with a simple majority in the 225-member

Parliament, Rajapaksa added. Over 30 petitions had been filed against the controversial bill in the Supreme Court to verify its constitutionality. The bill, gazetted in March 2023, sought to replace the muchmaligned Prevention of Terrorism Act (PTA) 1979.

The PTA, had come under fire from international human rights groups for its draconian

Money sought for Ukraine would be spent in US, says Joe Biden

A t a bustling construction site outside of Dallas, there are hopes that Congress can finally pass nearly USD 95 billion in foreign aid including funding for Ukraine — because factory jobs in the United States depend on that money. Aerospace and defence company General Dynamics' new factory in the Dallas suburb of Mesquite is expected to initially employ 150 people to produce munitions. Set to open in June, construction is nearing completion, with newly planted trees and shrubs already in place at the complex overlooking one of the area's busiest interstates.

"We want to increase our wages and increase our skill levels and job opportunities," said Kim Buttram, Mesquite's director of economic development, who added that the factory is expected to have over 300 jobs when it's at full production. As House Republicans to pass

The Democratic president is openly channelling Franklin Delano Roosevelt and resurrecting the World War II-era concept that America is the "arsenal of democracy." His sales pitch to the public is that his foreign policy is also about jobs for the US middle class. But Biden is brushing up against opposition from former President Donald Trump, the Republican

Trump opposes the US package to help Ukraine and has openly expressed a willingness to let Russia invade NATO allies who do not spend enough of their own budgets on defence. Johnson has refused to bring the foreign aid bill up for a vote because it also lacks provisions to secure the US southern border where immigrants are crossing illegally. But he previously rejected a bipartisan Senate bill that did provide funding to address immigration challenges, saying that the border measures would not solve the problem in the way that he

Thousands of debtors resolving their cases before admission under insolvency law: IBBI

PTI ■ NEW DELHI

Over 27,500 applications for resolution process against corporate debtors have been withdrawn before admission, regulator IBBI emphasising that the credible threat of the insolvency law ownership of debtors might change has changed the behaviour of debtors.

These Corporate Debtors (CDs) had an underlying default of Rs 9.74 lakh crore. Insolvency Bankruptcy Code (IBC), introduced in December 2016, provides for a timebound and market-linked resolution of stressed assets. The credible threat of the Code, that a CD may change hands, has changed the debtors. behaviour of Thousands of debtors are resolving distress in early stages of distress.

"They are resolving when default is imminent, on receipt of a notice for repayment but before filing an application, after filing application but before its resolution plans, 1,124 admission, and even after through appeal or review or admission of the application,



and making best effort to avoid consequences of the resolution process," the IBBI said in its latest newsletter.

The Insolvency and Bankruptcy Board of India (IBBI) is a key institution in implementing the IBC. According to the newsletter,

27,514 applications for initiation of CIRPs (Corporate Insolvency Resolution Process) of CDs having underlying default of Rs 9,74 lakh crore were withdrawn before their admission till October 2023. Till December 2023, IBC has helped in rescuing 3,050 CDs -- 891 were through settlement, and 1,035 through withdrawal.

The resolved CDs resulted in realisation of around 32 per cent, as against the admitted claims and more than 169 per cent compared to the liquidation value.

Creditors have realised Rs 3.21 lakh crore under the resolution plans December 31 last year. The fair value and liquidation

value of the assets available with these CDs, when they entered the CIRP, was estimated at Rs 2.97 lakh crore and Rs 1.90 lakh crore, respectively, as against the total claims of the creditors worth Rs 10.07 lakh crore, the IBBI said.

As many as 2,376 CDs have been referred for liquidation.

"Till December 2023, 830 CDs have been completely liquidated. These 830 CDs together had outstanding claims of Rs 1.83 lakh crore but the assets valued at Rs 0.09 lakh crore," the newsletter said.

In his message in the newsletter, IBBI Chairperson Ravi Mital said that while the CD is reorganised during CIRP, the insolvency resolution process for the PGs (Personal Guarantors) prioritises debt restructuring. This is the opportunity the IBC affords over outright bankruptcy, with bankruptcy serving as a last resort should the debtor's repayment plan falter, he said and stressed that "by cooperating in the process and submitting a repayment plan for approval creditors, debtors can effectively discharge their debt liabilities instead of initiation of their bankruptcy process". It is seen that CIRP proceedings are often delayed due to excessive litigation. The debtors' attempt to prolong the admission or the resolution process leads to erosion in CD's value, he

He was later disqualified for lane infringement and a late night 'appeal' by the Athletics Federation of India (AFI) was also rejected.

"Yes, it was ruled that Gulveer committed lane infringement. Of course, AFI protested but the protest was rejected," a coach, who is with the team, told PTI.



"The jury said they have enough evidence to conclude that Gulveer made lane infringement."

Various clauses of technical rules 17.2 and 17.3 provides for how an athlete can commit lane infringement and under what circumstances he or she may not be disqualified. Technical Rule 17.2.3 says: "In all races run in lanes (or any part of a race run in lanes), each athlete shall keep within their allocated lane from start to finish and, when running on a bend, shall not step or run on or inside the left-hand lane line or in the case of the inside lane, the kerb or line marking the border of the inside of the track.


IPL set for March 22 start

Back-to-back heavy defeats against India have compelled England captain Ben Stokes to consider an early return to bowling with head coach Brendon Brendon coach McCullum admitting that although it's a good sign, they don't want the all-rounder to push himself unnecessarily.

Stokes, who is still recovering from a knee surgery, hasn't bowled since the second Ashes Test in June last year. "Well, it's good that he's actually getting into a state where he thinks he might bowl," McCullum was quoted as saying by ESPNCricinfo on Monday.

"But Ben is clever; he's really clever as well. He won't bowl unless he thinks he's legitimately able to bowl. The problem would be if he starts getting into a spall or definition. getting into a spell and then he can't get out of the spell. So we'll see what unfolds.

"If he does get that bit between his teeth, then let's see where the danger lies there and try and pull him away from it. But it's a good sign," McCullum added.

Ahead of the Rajkot Test, Stokes had said he "pinky promised" his physiotherapist he won't be bowling in the ongoing series. But when asked if he will be reprising his all-rounder's role after the 434-run defeat in the third Test on Sunday, Stokes said, "I'm not saying yes, I'm not saying no".
"Me being me, I'm always

very optimistic about most things. That will be a more detailed chat with the medical team about what workload I have done to pass me off as not being a massive

During the Rajkot Test, Stokes had even trained at 100 per cent intensity and conceded that he felt pretty good. "I managed to bowl at 100 per cent in one of the warm-up days here which made me feel pretty good. I felt like I could have bowled in the game but that would have been stupid."

After winning the series opener by 28 runs, England fell to a 106-run defeat followed by one of their worst losses in Pailett to 2.2 losses in Rajkot to go 2-1 down in the series with matches left in Ranchi and Dharamsala.
