Commission expected to announce the dates for the Lok Sabha elections after March 13. As part of the ongoing preparations for the General Elections and concurrent Assembly polls in select States, the Chief Election Commissioner is currently engaged in successive visits to these regions.

States like Andhra Pradesh, Arunachal Pradesh, Odisha, and Sikkim are gearing up for simultaneous Lok Sabha and State Assembly polls.

In 2014, the Election Commission announced the schedule for the nine-phased Lok Sabha elections on March 5, and the results were

declared on May 16. In 2019, the poll panel announced the seven-phase Lok Sabha elections on March 10, and the results were declared on May 23.

Sources indicate that senior officials of the Election Commission of India are actively engaged in regular meetings with the Chief Electoral Officers (CEOs) of different States to address potential issues ahead of the elections. The focus is on practical challenges such as the transportation Electronic Voting Machines (EVMs), the deployment of security personnel, and maintaining vigilance along state borders.

Also, sources mentioned that the Central Board of Secondary Examination

India's first and only

examination will end on March 13, freeing up many teachers and school buildings for election duties. A team from the EC is also expected to visit Jammu & Kashmir on March 13.

Commissioner Rajiv Kumar will meet representatives from as many as nine political parties, including the Dravidian majors, to discuss issues regarding conducting the poll. He will hold a review meeting with the district collector and superintendents of police. The CEC will also meet with the CEOs of Tamil Nadu, Karnataka, and Kerala, as well as officials from enforcement agencies, before wrapping up his meetings with the Tamil Nadu Chief Secretary and the State DGP.

Earlier, a team from the EC reviewed preparations with the Chief Electoral Officer of Bihar, the State police chief, and other agencies including Excise Department, DRI, ED, I-T, Forest Department, Postal Department, among others. During the meeting, the EC said that enforcement agencies have been instructed to take strict action against the use of money power during elections.

LMC budget passed amid uproar | Case registered in paper leak

₹2,865-cr income, ₹2864.68-cr expenditure proposed

The LMC House passed the budget of nagar nigam and that of Jal Kal department for 2024-2025 amidst uproarious scenes on Friday. Mayor Sushma Kharakwal adjourned the House until February 28, stating that various issues raised would be taken up for discussion.

The passed budget includes a proposed income of Rs 2,865 crore and an expenditure of Rs 2864.68 crore, with revenue sources ranging from taxes to fines and parking contracts.

In terms of expenditure, allocations have been made for various areas including park maintenance, school funding, road cutting, and traffic arrangements, with spending updates provided till December

Corporators from the opposition parties staged a walkout due to no increase in the Ward Development Fund despite their longstanding request. Previously, a majority of corporators voiced concerns about the Chennai-based company selected for garbage collection, questioning why it was assigned two-thirds of the wards while the rest remained under nagar nigam. Allegations of the company being tainted were also raised, along with criticism of the sewage work.

Issues regarding the supply of dirty drinking water in wards led to a dramatic gesture



water to the Jal Sansthan general manager, insisting he drink it himself, which he did.

Briefing mediapersons after the session, Mayor Kharakwal and Municipal Commissioner Inderjit Singh highlighted initiatives such as mandatory allocation percentages for development funds and increased oversight on departmental road construc-

Kharakwal said 50 per cent of any development funds will be mandatorily used for development works, 15 per cent for parks, 20 per cent for lights, 10

per cent for vending zones, and per cent for patch works in the wards

She said the highest budget of any nagar nigam in the state is that of LMC and that she has formed a committee to look into how other municipal corporations spend their

The mayor further said that any department would have to take an NOC from Nagar Nigam for road construction in LMC wards.

The municipal commissioner said they would be charging taxes from the 116 enemy properties in Lucknow. the financial year 2023-2024 till December 2023 was Rs 240.2 crore, including Rs 33.1 crore from zone 1, Rs 12.16 crore from zone 2, Rs 33.8 crore from zone 3, Rs 62.3 crore from zone 4, Rs 14.7 crore from zone 5, Rs 19.15 crore from zone 6, Rs 26.25 crore from zone 7, and Rs 38.57 crore from zone 8.

The income generated from taxes on vehicles for the year 2023-2024 till December , 2023 was Rs 4.55 lakh.

As far as expenditures are concerned, a sum of Rs 200 lakh has been earmarked for running and monitoring of parkings. Till December 2023, a sum of Rs 14.94 lakhs has been spent in this area.

An executive engineer, speaking on condition of anonymity, said that notices would be served on non-genuine dwellers, informing them to remove their belongings before their houses and shops were bulldozed.

Car stolen by | 70% of kidney donors at trio on pretext of taking lift

A car was stolen by three men on the pretext of tak-ing a lift in Sushant Golf City police station area on Thursday night. As per reports, Vivek Singh of Krishna Nagar was going towards Ayodhya road from Mohanlalganj around 11 pm when the trio asked for a lift. Vivek allowed them in and then drove towards his destination. On the way, one of them asked Vivek to stop the car as he wanted to attend nature's call

The other two stayed back while I also got down to relieve myself. In the meantime, the one who had asked me to stop the car hurriedly sat in the vehicle and the trio sped off in no he stated

Seventy per cent of donors in the kidney transplant pro-gramme at Dr Ram Manohar Lohia Institute of Medical Sciences (RMLIMS) are females, with the majority being mothers of patients.

Head of the nephrology department Dr Abhilash Chandra pointed out that while most kidney recipients are males, the donors are predominantly females. He highlighted a bias towards females, possibly due to familial pressure or their non-earning status.

Dr Chandra emphasised that during counselling, they provide options without gender bias, offering information on success rates based on various donor relationships. He influence of societal and economic factors on female donors' decisions.

Regarding the programme's progress, he mentioned a steady rate of 3-4 transplants per month since its inception six-and-a-half years ago, totalling around 170 transplants. He outlined the challenges, including the absence of deceased donor transplants, which they aim to promote to alleviate the burden on live donor transplants.

Dr Chandra stressed on the need for increased awareness and effort from both healthcare professionals and potential donors to facilitate deceased donor transplantation.

He highlighted the high immediate success rate of over 90 per cent post-transplant at

one year. However, he noted a potential loss of 20 to 30 percent of kidneys within five years due to various factors.

At the end of five years, we are likely to lose 20 to 30 per cent of the kidneys for various reasons such as infection, renal disease which occurs after transplant or any reaction," he said.

He added that director Dr Soniya Nityanand had plans of setting up one centre which would cater to all transplants being done across all departments.

Three children burnt alive in Bareilly; CM mourns deaths

In a tragic incident in Nawada Bilsandi hamlet of Faridpur area of Bareilly, a hut caught fire on Friday afternoon in which three children were burnt alive while a girl suffered serious burns. She has been admitted to the hospital.

After receiving the information, the police reached the spot along with the district magistrate and the senior the officers also visited the hospital and directed the doctors to make all efforts to save the life of the girl.

Meanwhile, Chief Minister Yogi Adityanath took cognisance of the fire accident in Bareilly and expressed condolences to the bereaved families of the deceased children.

The chief minister also instructed the district administration officials to provide the injured proper treatment. He also wished for the speedy recovery of the injured.

According to information, Ramdas lives in the village Nawada Bilsandi. Straw was kept on the roof of his house and somehow it caught fire on Friday afternoon. The burning straw fell on the hut below in which some children were playing hide and seek. Four children were hiding in the hut. Within no time the entire hut caught fire and children were trapped inside.

On hearing the screams of the children, the family members and the neighbours ran to the hut and they somehow extinguished the fire, but by

then all four children were badly burnt. Of these, three children died on the spot. All three deceased were cousins. The fourth child,

Neetu (6), daughter of Amitabh, was immediately taken to the hospital where her condition is said to be critical.

Those who died in the mishap were identified as Privarshi (5) daughter of

Priyanshi (5), daughter of Bhim; Naina (5), daughter of Arjun and injured Neetu's sis-As soon as the information

was received, DM Ravindra Kumar and SSP Ghule Sushil Chandrabhan reached the village with the force. They claimed that the

affected families have been assured of all possible help.

At the same time, instructions have been given to investigate the incident. The DM said that three children died due to fire in the hut while a girl suffered burn injuries.

Meanwhile, in another incident, a child was killed while seven others were injured after a huge fire broke out at the Ramnagaria fair Farrukhabad city on the intervening night of Thursday and Friday, police said.

As many as 40 makeshift huts where pilgrims were staying were engulfed in the inferno. The fire was brought under control after three hours, officials said. According to eyewitnesses, the fire initially started in one hut and quickly spread to nearby structures. Cooking cylinders began to explode in the fire hindering efforts to extinguish it.

along with superintendent of police reached the site to take stock of the situation and asked officials to ensure proper treat-

ment for the injured. Satya Prakash, officer incharge of the fair, confirmed that the fire was contained, but the exact cause was yet to be determined.

Preliminary investigations suggest that the fire may have originated from a cooking incia cooking gas cylinder and sub-

sequent spread of the fire. Local authorities have assured a thorough inquiry into the incident to prevent similar tragedies in the future.

HC to continue hearing plea challenging maintainability suit on February 29

Prayagraj (PTI): The Allahabad High Court on Friday fixed February 29 as the next date of hearing on a plea regarding the maintainability of a suit seeking the removal of the Shahi Idgah mosque in Mathura, which it claims was built on a 13.37-acre land of the Katra Keshav Deo

After hearing the submissions of the parties on Friday, Justice Mayank Kumar Jain fixed February 29 as the next date of hearing in the matter.

The counsel for the Muslim side to the dispute, Taslima Aziz Ahmadi, submitted before the court through a video-conference that a compromise was arrived at between the Srikrishna Janam Sewa Sangh and the Shahi Idgah Masjid Committee in 1968, and the land on which the masjid stands

was given to the latter. She said the compromise was affirmed by a court order passed in 1974 and contended that the present suit is in violation of the said compromise and the court order and thus, not maintainable. Earlier, Ahmadi had argued that the suit is not maintainable as it is barred by the provisions of the Waqf Act as well as the Places of Worship Act, 1991. She had said the mosque,

which is a waqf property, stands on the disputed site, adding that since the dispute is related to a waqf property, the jurisdiction to hear the matter is only with the waqf tribunal and a civil court has no such jurisdiction. In May last year, the high court transferred all 15 cases related the Sri Krishna Janmabhoomi-Shahi Idgah masjid dispute to itself.

The Health department is continuously making efforts to reduce the rate of blindness and visual impairment in the district. For this purpose, under the National Blindness and Visual Defect Control Programme, people suffering from eye-related problems are being provided testing, treatment and medical facilities. From April 2023 till now, 43,068 cataract patients have been identified and treated in the district.

Chief Medical Officer (CMO) Dr Sandeen Chaudhary said there is a need to pay special attention to blindness in children. The main reasons for this were said to be eye infections, Vitamin A deficiency, malnutrition and eye injuries. Along with this, the problem of cataract is being seen more in the elderly, for this the CMO has appealed that the families of children and elderly people should take better care of their

health, do regular exercise, eat a balanced, healthy and nutri-tious diet. "Elderly people should not smoke, avoid the use of gutka, tobacco and khaini, it affects the nervous system", he added.

ACMO and Nodal Officer of the programme Dr Sanjay Rai said that under the National Blindness and Visual Impairment Programme, all the people of rural and urban areas are being given the benefit of this scheme. From April 2023 till now, cataract operation of 43,068 patients was done through government hospitals, private hospitals and voluntary organisations of the district. Dr Rai said apart from this, about 2,800 school children have been identified and provided free spectacles through the Rashtriya Bal Swashtya Karyakram (RBSK) from April 2023 till now. Along with this, free spectacles were provided to about 1,800 elderly people identified at community and primary health centres (CHCs and PHCs).

Under the Pradhan Mantri TB-Mukt Bharat Abhiyan and National Tuberculosis Eradication Programme (NTEP), a health camp for TB-Mukt Panchayat Abhiyan was organised in Bhidur village of Cholapur block here on Friday. The work of TB free Panchayat campaign is being conducted continuously in all the eight blocks of Varanasi.

persons with symptoms of TB (potential patients) must get tested. He appealed to all supporting organisations to give full emphasis to screening, testing, diagnosis and complete treatment in all the gram pan-

He appealed to all to make people aware in the community by coordinating with ASHA-Ánganwadi workers, including gram pradhan, community health officer (CHO) and panchayat assistant. Under the leadership of Dayashankar Yadav, gram pradhan of Bhidur village, continuous work is being done regarding TB free panchayat. He said TB screening is being done in the village by the Health department team. Persons with possible symptoms are being referred for testing for TB. for testing for TB.



Jaishankar cautions against China mind games

As tension persists at the Line of Actual Control (LAC) for the last three years, External Affairs Minister S Jaishankar on Friday here cautioned against Beijing's "mind game" to restrict India-China issues under the bilateral framework and said New Delhi must not forgo its rights to harness other factors in the world to get better terms on an "equilibrium" in the relations. He said arriving at an equilibrium and maintaining it is going to be one of the "biggest challenges" for India-China ties even as he asserted that the immediate issue at hand was Beijing's departure from laid down norms triggering the border row in eastern Ladakh.

Making this point in an interactive session at the Raisina Dialogue, Jaishankar cautioned against China's "mind game" to restrict the

Talking for early discharge of Indians working as Russian Army support staff, says MEA

Amid reports that some Indians are working as support staff for Russian forces in the ongoing Ukraine conflict zone, India on Friday said it was in touch with Moscow for early "discharge" of Indians working as support staff to the Russian Army, and urged its nationals to stay away from the conflict zone in Ukraine.

The comments by Ministry of External Affairs (MEA) Spokesperson Randhir Jaiswal came following a report that some Indians are working as support staff to the Russian Army in the conflict zone. "We are aware that a few Indian nationals have signed up for support jobs with the Russian Army," Jaiswal said.

He said the Indian embassy in Moscow has regularly taken up this matter with the relevant Russian authorities for their "early discharge".

"We urge all Indian nationals to exercise due caution and stav away from this conflict," he said.

This reaction came after reports indicated that dozens of Indians were allegedly duped into military service in Russia. The unsuspecting Indians were promised support jobs but were ultimately enlisted in the Russian army, receiving misleading translations of documents and undergoing military training against their initial understanding.

'We are aware that a few Indian nationals have signed up for support jobs with the Russian army. The Indian Embassy has regularly taken up this matter with the relevant Russian authorities for their early discharge. We urge all Indian nationals to exercise due caution and stay away from this conflict," said Jaiswal.

The family of one of the men, Sufiyan from Hyderabad, along with All India Majlis-E-

Ittehadul Muslimeen (AIMIM) leader Asaduddin Owaisi, on Wednesdy sought the intervention of the Centre and the External Affairs ministry to secure the safe evacuation of the trapped Indian nationals and take stringent action against the fraudulent agents responsible.

Jaishankar's comments came days after he said India has had "stable" and "very friendly" relationship with Russia, and that Moscow never hurt New Delhi's interests.

In an interactive session at the Raisina Dialogue here on Friday, Jaishankar, replying to a question on Moscow's growing proximity with Beijing, said it makes sense to give Russia multiple options and that railroading it into a single option and criticising it for that would be like a self-fulfilling



prophecy. "I think it makes sense to give Russia multiple options. If we railroad Russia into a single option and say that's really bad because that's the outcome, then you are making it a self-fulfilling prophecy," he

"Today it is important for other countries, especially in Asia to engage Russia," Jaishankar said.

"Russia is a power with an

enormous tradition of statecraft. Such powers would never put themselves into a single relationship of an overwhelming nature. It would go against their grain," he said.

The external affairs minister was asked to comment on intensification of ties between Russia and China and whether India was uncomfortable with it. "What's happened today with Russia essentially is that a lot of doors have been shut to

Russia and the West. We know the reasons why. Russia is turning more to Asia or to parts of the world which are not West." he said. The external affairs minister suggested that policies of the West are bringing Russia and China closer.

"It's kind of funny -- on the one hand you have people who set policies (and) bring the two together and then you say beware of them coming together," he said. Jaishankar's comments came

days after he said India has had a "stable" and "very friendly" relationship with Russia, and that Moscow never hurt New Delhi's interests. The ties between India and Russia remained strong notwithstanding the ongoing Ukraine conflict.

India's import of Russian crude oil has gone up significantly despite increasing disquiet over it in many Western countries. In his remarks,

ers get modern grain storage facilities at the block level through PACS, which will strengthen food security, and empower the farmers by enabling them to realize bet-

ter crop prices. The monumental project which has been approved with a financial outlay of more than Rs 2,500 crore, is supported by NABARD and

spearheaded by the National Cooperative Development Corporation (NCDC), an autonomous financial institution for cooperatives in the

country. The scheme is being implemented through convergence of various existing schemes like the Agriculture Infrastructure Fund (AIF), Agriculture Marketing

However, the synthetic antibody developed by the research team targets a conserved region in the core of a major toxin called the three-finger toxin (3FTx) present in elapid venom. Despite variations among 3FTxs produced by different elapid species, the antibody strongly binds to various

strongly to various 3FTxs, including those from the Taiwanese banded krait, monocled cobra from Eastern India, and black mamba from sub-Saharan Africa. Animal experiments demonstrated the efficacy of

an antibody capable of binding

the synthetic antibody, with mice injected with the toxinantibody mixture surviving beyond the 24-hour observation window and appearing completely healthy. In India, Karnataka govern-

Religious apartheid

Karnataka's proposal to tax several Hindu temples smacks of discrimination

■ n a move reminiscent of the historically partisan practice of jizya, the Congress Government in Karnataka has proposed a plan to collect funds from Hindu temples as a form of tax. Understandably, the move has sparked a controversy and reignited debates over the treatment of Hindu places of worship and whether these are being unfairly targeted. While some argue that the move is a necessary step to ensure the upkeep of Hindu religious institutions and support the livelihoods of the priests involved, others see it as discriminatory and belonging to a regressive era when non-Muslims were subjected to jizya, a special tax. While the proposed tax is not explicitly religious in nature, its resemblance to jizya has not gone unnoticed and critics view it as a form of economic discrimination. One of the primary concerns raised by the move's opponents is the selective targeting of Hindu places of worship as similar demands are not being made of other religious institutions, such as mosques or churches. This asymmetry has led



to accusations of bias and favouritism on the part of the Government. If the aim is to genuinely improve facilities at religious places, it should be even-handed and not selective. Our Constitution is clear about religious freedom and equality and all Governments across the country must comply with that. Arguing that it is a matter of fiscal responsibility, however, the tax proponents point to the vast wealth accumulated by some temples. They reason that it is only fair for these temples to contribute to the broader welfare of society. Additionally, they contend that the funds collected will be used for the benefit of the community, including the preservation of cultural heritage and the support of reli-

gious practitioners. The proposal has sparked widespread outrage among certain segments of the Hindu population, which sees it as an encroachment on their religious freedoms and an attempt to undermine their heritage.

For many Hindus, temples are not just places of worship but symbols of their cultural identity. Any attempt to impose financial burdens on these institutions is viewed as an attack on their way of life. Moreover, the Government's involvement in the financial affairs of temples raises broader questions about the separation of religion and State. By exerting control over the finances of Hindu religious institutions, the Govt risks overstepping its boundaries. In this light, it is essential for the policymakers to tread carefully and consider the implications of their actions. While temple maintenance and priest welfare are undoubtedly important issues, these must be addressed in a manner that respects the rights and sensitivities of all citizens. Ultimately, the debate over the temple tax in Karnataka raises fundamental questions about religious freedom and the role of the State in religious affairs. Meanwhile, it is crucial for all stakeholders to engage in constructive dialogue and seek solutions upholding the principles of fairness; only then can we ensure that our society remains true to its values of pluralism and tolerance.

The boycott at Doha

The Taliban's obscurantist mindset and their harbouring of terrorist organisations pose a serious threat to Muslim countries

iven the obscurantist and misogynistic mindset of the Taliban, it is hardly surprising that they boycotted the conference, hosted by the United Nations, to discuss the humanitarian crisis facing Afghanistan, and cooperation on the human rights issue. They spurned the UN's invitation say ing that they would attend only if they alone were officially representing Afghanistan, as inclusion of other groups would jeopardise progress. This exclusivist mindset, which reflects their intolerance of the existence of any organisation that does not share their obscurantist Islamist worldview, and does not owe allegiance to them, is at the core of their rejection of democracy, and advocacy of an Islamist theocracy manifest in their designation of Afghanistan as an Islamic Emirate, run according to the diktats of mullahs.

The Taliban are unlikely to have realised that they have shot themselves in the foot by boycotting the conference held in Doha on February 18 and 19 under the chairmanship of the UN secretary-general, Antonio Gutteres. Besides the special envoys of 25 countries, members of Afghanistan's civil society and women's groups, it was attended by representatives of the European Union (EU), Shanghai Cooperation Organisation (SCO) and Organisation of Islamic Cooperation (OIC).

By not attending the conference, the Taliban have only perpetuated their isolation in the world. They obviously do not seem to mind that since humanitarian assistance continues to come in for the sake of the country's people suffering from natural disasters like floods and earthquakes as well as the violence stalking the country. The OIC's role was outlined by Ambassador Tarig Ali Bakheet, special envoy of organisation's secretary-general. During his interventions, Bakheet recalled his organisation's commitment to support Afghanistan and engage in a constructive that could be adopted by leg-dialogue with the country's de islative bodies and human facto authorities [Taliban] "on rights organizations in memissues and topics included in the relevant resolutions of the [OIC's] eties when considering the

Council of Foreign Ministers. In this regard, he reviewed OIC efforts in providing humanitarian assistance, sending scholars delegations, and holding a conference on women's rights in Islam hosted by the Kingdom of Saudi

Ambassador Bakheet was referring to the international conference on "Women in Status Empowerment" (November 6 to 8, 2023), organised by the OIC's general secretariat and hosted by Saudi Arabia. It included in its Final Declaration 20 recommendations highlighting the rights that Islam gave to women and the status of women in Islam. These also addressed the challenges and opportunities pertaining to the realisation of women's rights and enhancement of their role across all fields and at all levels of soci-

The conference also produced 'The Jeddah Document on Women's Rights in Islam" which, as stated by OIC's secretary-general, Hissein Brahim Taha, in his address at the conference's closing session, would serve as an intellectual and practical reference document ber states and all Muslim soci-

rights of Muslim women. It will be submitted for adoption at the forthcoming Islamic Summit, scheduled to be held in Gambia at the end of this year, and subsequently presented to all relevant international fora. He hoped that those doubting Islam's fairness toward women would consider women's rights as set out in this document, and not on the basis some isolated social practices in some Muslim societies that in no way reflect the sublime vision and universality of

Islam and its teachings. Taha's not-so-veiled rejection of the Taliban's views on women's rights in the last sentence above, will not please the mullah's running Afghanistan. Nor will they be amused by his affirmation that women's empowerment issues would remain high among the OIC's priorities, and that the OIC would launch and support numerous efforts and initiatives to elevate the status of women in Muslim societies. Taha's words carry a special significance as he spoke in Saudi Arabia where, under the leadership of the crown prince, Mohammed bin Salman al Saud, significant steps have been taken to improve women's position. Women can now attend sporting events, need not wear the abayah, a long, loose-fitting, garment covering the entire body,

except the face, hands and feet, in public, and can get driving licenses and can go to work, study or run errands without male escorts. While women demanding more freedom are treated harshly and much more remains to be done, the gains have been considerable compared to the situation ear-

One can be certain that the Taliban would not change their views. Bigots dig their heels deeper and deeper the more people reject their creed. If the OIC and the Muslim countries are serious about women's rights, they must work out tough economic and political sanctions that would compel the Taliban to change their policies in this regard. They must also take measures to compel the Taliban to act against terrorist outfits like a Tehreek-e-Taliban Pakistan (TTP) and Islamic State of Khorasan Province (ISKP) active in Afghanistan. The former is targeting Pakistan and the latter Iran. Given, however, their obscurantist creed, and determination to impose their version of sharia law globally, there is no reason why they will not strike other countries in future, particularly the Muslim ones they con sider as apostatic.

THE STRESS BEHIND THE **TEACHING PROFESSION**

Teachers have alarming rates of burnout and attrition worldwide



nollege degrees, good education and satisfying jobs are all things that people generally strive for. Teaching is one of the most visceral jobs most people will ever experience. Teachers since ages have proven to be vital because they shape the lives of students and help them develop the knowledge and skills they need to succeed in the world.

It is interesting to note that many people today believe the stereotype that teaching is a stress-free job. It is the only profession that gets summers and weekends off. Moreover, it is typically a job that people only do because they cannot do anything else. The adage those who can, do; those who can't, teach is widely believed. However, the reality is that there is a great amount of stress associated with this type of pro-

There is no denying the fact that the teaching profession is emotionally, physically and mentally exhausting. Many teachers across the world are experiencing teacher shortages. As per the latest survey, it was found that almost 50% of the new teachers who join with super excitement, passion and a dream to take on the world quit within the first five years of teaching, which begs the question: why do so many of them leave after going through years of college for this profession? Without enough teacher, one cannot successfully educate their children. Moreover, the most disturbing part is that the education system relies on massive amounts of unpaid labour. According to the Bill and Melinda Gates Foundation, the average teacher works for 52.5 hours a week, over 30% more than they are contracted for. Multiple surveys declare uncertainty, workload, negative perception about the job, concern for others' wellbeing, health struggles and playing multiple roles have hampered school teachers' mental health and well-being.



Not only this, research also indicates that burnout contributes to high attrition rates among educators. Making teachers work beyond their contracted hours and not paying for it; giving them five hours or less per week to plan for 30 hours of instructions, grading and providing feedback on assignments for almost 200 students on an average, analysing data, contacting parents, attending meetings, preparing teaching materials, expecting teachers to implement new initiatives, programs and practices without proper training, completing administrative tasks, expecting teachers to differentiate and individualise instructions for a class with 30+ students and above all blaming teachers for all educationrelated issues despite not including teachers in decision making of education-related issues prove out to be a few reasons for teacher burnout. The constant turnover rate of teachers, lack of interest in teaching and lack of commitment to the profession continue to be a major concern for school systems all over the nation. Stress has become a common characteristic of teachers and with the increased amount of accountability, teachers play a significant role in students and schools resulting in poor classroom engagement and ultimately low student achieve-

To be an effective educator, all teachers need to maintain their psychological well-being. For an ordinary human being not related to this profession, a teacher is a person who is working around 1800 hours a year, whereas in reality, they are the ones who are working around 2300 hours a year on average which shows that approximately 550 hours are unpaid working.

Remember, the teachers cannot effectively accomplish all necessary tasks only during their contract hours. The growing concern is the psychological well-being of teachers not only at the school level but also at the college level.

Farmers demand MSP protection



The imperative need for a legislation-backed MSP grows ever more urgent, promising stability and prosperity for the backbone of India's economy

he resurgence of protests by farmers has brought attention to their longstanding struggle for sustainable profitability in the agricultural sector. Although their demands are diverse, their primary request is for a legal guarantee for MSP (Minimum Support Prices). Farmers believe that the government has not shown genuine interest in effectively implementing MSP, which has led to distrust, frustration, and the need for a legal guarantee. These issues have forced them to leave their homes and farms and take to the highways in protest, resulting in the death of three farmers a couple of injuries, and disruption of normalcy that has affected the commuters and business activities

In September 2020, the government introduced three controversial farm laws that were met with widespread protests and demands for their repeal. While the laws were eventually repealed in November 2021, there has been no interim report from the Committee on MSP formed to address farmers' concerns. This delay in decision-making perpetuates uncertainties in the agricultural sector and undermines the effectiveness of the present MSP as a stabilizing force.

MSP was introduced in 1966-67 to ensure food security amid food scarcity. Despite broad political support for a legal guarantee for MSP, successive governments have failed to formalize this issue, leaving the agricultural sector in a state of uncertainty. However, it is high time to address the weakening of the decades-old MSP policy, remove the complexities surrounding its legislation, and recognise the potential benefits of legalising MSP to fuel the wholesome growth of the agriculture sector, which is the country's lifeline. The Modi government has demonstrated its commendable ability to revamp decadesold mechanisms with various robust reforms such as the amendments to Indian Penal Codes and the abrogation of Article 370 in Kashmir, and now they must take bold steps to address this pressing

Why farmers asking for legal guarantee: The MSP is an administered advisory price for 23 crops and is determined annually by the Commission for Agricultural Costs and Prices (CACP) as a key government intervention to insulate farmers from price volatility when the market prices fall below the MSP as well as of consumers against corrupt manipulative market inflation and maintains food security. It has been in existence in India for more than five decades. Why, then, are farmers asking for a legal guarantee? Only 6% of farmers benefit from MSP, and it procures just 11% of total agricultural output in the country, according to the latest available NITI Aayog data.

Over 90 % of crops are sold at prices that are 20-30% lower than the declared MSP, leading to average losses of Rs 20,000 per acre and about Rs 10 lakh crore annually for farmers. A study by the Indian Council for Research on International Economic Relations and the Organization for Economic Cooperation and Development found that Indian farmers have been suffering losses since 2000 due to ineffective policies. The report revealed that Indian farmers lost Rs 45 lakh crore during 2000-2017 due to low prices.

Misconceptions in legalising: The legalisation of MSP has been hindered by exag-



necessary amendments are needed in the Agricultural Produce & Livestock Market Committee (APMC) Act by incorporating a clause that 'auction of farm produce in APMC's markets is legally not permitted below the declared MSP prices. The apprehensions on the operation of MSP legal guarantee are that most of the sales of farm produce are not in APMCs, and traders may boycott the purchases of farm produce. The government does not have physical and economic resources to purchase, store, and market the procured intervention is necessary only when market prices fall below MSP, and it does not require the procurement of the entire marketable surplus.

The potential boycott of farm produce in places MSP legal regimes by the traders is an irrational argument because the commodity's supply is tight against the demand for farm produce. First, this was also evident from the fact that the government could manage to procure only 26 million tonnes of wheat at MSP against the target of 44.4 million tonnes fixed for the 2023 season. Second, the government's expenditure on procurement and imports of farm produce like edible oil and pulses, and on procurement of food grains on MSP in 2022-23, has already surpassed Rs 5 lakh crore and Rs 2.28 lakh crore, respectively.

Claims that the MSP legal guar-

India are baseless. According to government estimates, the MSP values of the total production of the 23 crops worked out to be around Rs 17 lakh crore, and some studies worked out to be around Rs 10 lakh crore. Furthermore, only 70% of the farm produce comes to markets as a marketable surplus, and farmers' families consume the rest for household purposes. The MSP legal guarantee will cost the government about Rs 5 lakh crore if traders or big corporations engaged in processing boycott the APMC's markets, which is an unlikely scenario. It is time to dismiss the misconceptions surrounding the legalisation of MSP and focus on the merits of providing a legal guarantee for MSP. Merits of legalising MSP: Farming is inherently risky, influenced by factors such as weather conditions, pest attacks, and market dynamics. By establishing a legally binding framework farm produce, which is an irrational argument. Government crops, will mitigate the current can pave the way for a more challenges and safeguard farmers from unpredictable fluctuations

in the prices of their produce. However, the government has proposed buying cotton, maize, tur, urad and Masur for five years directly from the farmers at the MSP without any quantitative limit. Notably, these crops are grown outside Punjab and Haryana, the home states of the protesting farmers. From this, can it infer that small pulses growing farmers all over the country stand to benefit? Legalising MSP for a wider variety of crops ensures that the benefits of price stability are not limited to specific segments of the farming community.

Small and marginal farmers cultivating diverse crops can access the protective shield of MSP, contributing to inclusive agricultural growth, and playing a pivotal role in ensuring food security for the

nation by maintaining a stable production environment for key staples, contributing to the overall food security of the country.

A legal framework enables the government to conduct strategic operations in domestic and interna-tional markets. By selling procured produce at minimal markups during times of higher market prices, the government can manage inflation surges, ensuring price stability for consumers.

MSP reduces the vulnerability of farmers to market fluctuations, ensuring a minimum income for their produce. Farmers can navigate uncertainties more confidently, knowing that the govern-ment is legally bound to intervene when market prices fall below the MSP. A guaranteed MSP leads to increased rural income. This, in turn, stimulates the rural economy by boosting demand for goods and services, creating a positive ripple effect in various sectors.

Sayani's influence extended far beyond the confines of the studio, earning him a place in the hearts and minds of millions

n the melodic realm of post-independence, India Lemerged a captivating voice that transcended mere broadcasting to become a cherished companion for countless listeners for almost four decades. With the resounding greeting, "Namaskar bhaiyon aur behno, main aapka dost Ameen Sayani bol raha hoon," Ameen Sayani forged an indelible connection through the airwaves, beckoning listeners to join him on a journey of music and camaraderie. This golden voice of radio passed into eternity on February 21, 2024, in

Mumbai. He was 91. His voice, emanating from vintage radio sets, possessed a captivating charm, diverging from the seriousness of his

Geetmala transcended borders, captivating audiences across Asia and East Africa

and fostering unity through Hindi film melodies. With 90 million listeners, it has evolved into a cherished tradition, binding families over enchanting tunes. They were not merely a fleet-

ing waltz through the sonic realms; it was a timeless symphony, a melody that lingered in the hearts of generations. With the gentle caress of nostalgia, it continued its melodious journey, spanning the years from 1952 to 1994, a testament to its enduring charm and universal appeal. And like a phoenix rising from the ashes of bygone eras, it experienced resurgences in the dawn of new millennia, revivals in 2000-2001 and 2001-2003, each breathing new life into its hallowed

Beyond the airwaves, Ameen Sayani's unparalleled contribution as a voiceover artist echoes through the annals of time, with over 54,000 radio programmes and approximately 19,000 jingles to his credit — a testament to his lasting impact on the hearts and minds of a nation.

Bhajan Samrat, Anup Jalota while sharing his thoughts with me on hearing the news of Ameen Sahab's demise said that he was one of the pioneers in the field of entertainment in broadcasting media and the texture of his voice captivated many people. "Today many of the anchors try to copy his texture and finesse", he said, adding, "It was almost a miracle that any song that Ameen Sahab would announce in his Binaca Geetmala, would go on to become a hit. Phrases like on my soul. It was truly a mag-"Aawaz ke duniya ke doston", and "Bhaiyon aur Beheno" were introduced by him which people are using today and trying to establish themselves. He was very mild in his behav-"Listening to Ameen Sayani's

iour and very gentle. iconic radio show, 'Binaca Geet Mala,' with my siblings was a cherished ritual in our household," reminisces Dr Sumitra Guha, a renowned classical vocalist and recipient of the Sangeet Natak Akademy award. "The mesmerising voice of Ameen Sayani filled our hearts with joy, as we eagerly awaited the melodious tunes of legendary playback singers like Lata Mangeshkar. His captivating narration and the golden era of Bollywood music left an indelible mark

ical time, enhanced by the charm of our beloved host." Writer, social activist and President of the Guild of Services, Meera Khanna shares her memories of growing up listening to Ameen Sayani. She says, "With the passing away of Ameen Sayani it is as if a precious memory of childhood has slipped away. The 'Binaca Geetmala' which he hosted in his amazing voice was an integral part of a childhood when television had not invaded homes. Gathered around the radio or with the transistor stuck to the ear Ameen Savani invited vou to float on the melody or foot tap to the rhythm of the most popular Hindi film songs. Thus, every week Ameen Sayani was the friend who vis-

ited with a bouquet of melody rhythm and poetry. Millions in this country will remember with the nostalgia of the times when pleasures were simple and radio hosts made you feel good about our world".

Smita Vats, Founder and President of ITIHAAS (Indian Traditions Heritage and Society) kept it simple when she said, "My memories are just of his voice... diction, and metre while reading and talking. All lost now, as no one

speaks well these days." Throughout his illustrious career spanning decades, Sayani epitomised innovation and authenticity. Amidst evolving media landscapes, he championed radio's timeless ability to unite communities. Beyond the airwaves, Sayani's magnetic charisma

Veteran journalist and author, Khushwant Singh eloquently captured Sayani's significance, saying, "Ameen Sayani wasn't just a radio presenter; he was a storyteller whose voice painted vivid images in the minds of his listeners." Sandeshkhali: Mass protest spreads like wildfire to neighbouring villages

Even as Sandeshkhali unrest betrayed all the signs of drifting characteristically towards Nandigram movement that catapulted Mamata Banerjee to power in 2011, the mass protest continued in the North 24 Parganas block this time spreading like wild fire to neighbouring villages.

On Friday there were new areas of violence at Belmajur and Tebhaga More where hundreds of villagers blocked roads and burnt wood blocks after being attacked by the armed men of Sheikh Shahjahan. Subsequent to their resistance the police resorted to mild lath-charge and arrested several agitators which further ignited the matter when the women in great numbers blocked the roads and jostled with the

The situation deteriorated soon after Director General and Additional Director General of Police Rajeev Kumar and Supratim Sarkar



left the area assuring justice to the villagers, sources said.

'Their senior officers assured us that all the houses that were ransacked and destroyed by the men of Shahjahan would be restored in a couple of days should there prevail peace ... but after they left the island the police swooped down on us arresting our men indiscriminately ... so how do we rely on the police ... we are poor people and Shahjahan and his men have literally looted us of our lands and honour for the past one decade ... instead of arresting

them the police are torturing us .. now we have no fear . are ready to see the end of it all, the women fumed.

The police had clamped Section 144 of CrPC in several villages of Sandeshkhali.

Sandeshkhali hit the national headlines on January 5 when the goons of Shahjahan a TMC strongman and a district board member --- close to jailed Food Minister Jyotipriya Mallick --- attacked and injured a team of Enforcement Directorate when they went to search his house in connection to the Rs 10,000 crore ration

ground thereafter Sandeshkhali erupted with the locals, gheraoing the police station demanding their usurped lands and seeking justice for their women who had been sexually assaulted for years. Subsequently two hench-

men of Shahjahan Shibu Hajra and Uttam Sardar, both district board members were arrested. However former CPI(M) MLA Nirapada Sardar too was arrested on charges of inciting the locals against the government.

Meanwhile, the TMC leadership in Kolkata continued to blame the BJP and the Left for fishing in troubled waters even as State minister Shashi Panja on Friday said, "the BJP and the CPI(M) may try their best to incite the poor gullible people but they will not succeed because the anger of the people is not against the government policies but some local leaders who are being taken care of ... the people will continue to love and vote for Mamata Banerjee.'

NSA not being invoked against agitating farmers: Police

The Haryana Police has initiated proceedings to seize the assets of farmers who have damaged public property during their 'Dilli Chalo' protest march. Hours after announcing that action would be taken under the National Security Act (NSA), 1980 against farmer leaders who are protesting along the state's border with Punjab, the Haryana Police on Friday morning said the NSA will not be invoked against them. Officers added that the police had not yet invoked NSA against the farm leaders and had only initiated the process for the same. In a statement Friday morning, Inspector General of Police (Ambala) Sibash Kabiraj said, This is to clarify to all concerned that the matter of invoking provisions of the National Security Act on a few farm union leaders in Ambala district has been reconsidered and it has been decided that the

The Samyukta Kisan Morcha (SKM) observed a "black day" on Friday and burnt effigies of

BJP leaders in protest against the Haryana Police's action against agitating farmers camping at two of the state's border points. The Bharti Kisan Union (Ekta Ugrahan), which is a part of the SKM, said it held demonstrations at 47 places in 17 Punjab districts in protest against Singh's death.

Friday refused the cremation of Shubhkaran Singh who died amid clashes between Haryana Police and Punjab farmers on Wednesday, saying the last rite will not be perform till the Punjab government registers a case against those responsible it. Punjab Chief Minister Bhagwant Mann on Friday announced a compensation of Rs 1 crore and a government job for the sister of farmer Shubhkaran Singh who died at the Khanauri border point. Before Shukaran's death, a 73 year old farmer, part of the same agitation, had earlier died

In a statement, the Harvana Police said that it would move

to recover damages through the seizure of properties and bank accounts of protesters. The damage caused to properties was being assessed, it said. In a statement, police said continuous efforts were being made by the farmers to break the barricades put up at the Punjab-Haryana border and impair law and order by pelting stones at the police.Before the farmers had kicked off their protest on February 13, the Haryana Police had sent notices to the unions threatening to seize their assets if they damaged public property during their agitation.

The notice said that if public property was damaged during the protests, bank accounts would be frozen and assets seized to compensate for the

The police had initially said it would take action against the protesting farmer leaders under the National Security Act (NSA), 1980. The order was later revoked.A press release issued by the Ambala Police stated there had been persistent efforts by farmers to dismantle the barriers erected at the Shambhu border as part of the 'Dilli Chalo' march

The police reported incidents of protesters throwing stones at officials, destruction of public and government property, and attempts to disrupt peace and order. The press release also highlighted concerns over the use of social media platforms such as Facebook, WhatsApp, Telegram, and Instagram by some farm leaders to spread provocative content aimed at disturbing harmony.

The Police has also used tear gas to disperse Haryana farmers heading towards Khanauri on Punjab's border with the state where farmers, mostly from Punjab, have been camping since last week after their 'Delhi Chalo' march was halted by security forces.A few protesters threw stones at police personnel when farmers from Kheri Chopta village were stopped from going to Khanauri. ECI allots Man blowing | STF busts fake call centre duping people, 8 held

STAFF REPORTER ■ NEW DELHI

A fake call centre duping people on the pretext of providing loans was busted here and eight people, including a woman who was running the operation, were arrested, officials of the Uttar Pradesh Special Task Force (STF) said. They said the gang had been operating from a rented office space in the industrial area of sector 63 in Noida for the past six months and is estimated to have duped over 300 people of crores of rupees.

"Eight accused, including the gang's mastermind, have been arrested from Noida for involvement in duping people on the pretext of getting them an online loan from India Bulls Consumer Finance using forged documents that were sent to loan-seekers through Whatsapp," the STF said in a statement. The gang was bust-ed by the Lucknow unit of the STF under the supervision of Additional Superintendent of Police Vishal Vikram Singh on Thursday.

The STF seized five mobile phones, 17 ATM/credit cards, three laptops, two tablets, 13 pre-activated SIM cards, 13 accounting registers, 75 fake documents and data of more than one lakh customers from the call centre, the officials



The forged documents included ID cards issued in the name of India Bulls, loan approval letters and loan confirmation letters, the statement said, adding that loan-seekers were duped in the name of charges for registration, processing fees, GST and insurance against loans among others.

Those arrested have been identified as the gang's mastermind Chhaya Singh, Priya Shukla, Aanchal Chaudhary, Sulekha, Ankit Singh, Vijendra Pratap Singh, Archana Prajapati and

Shivani Thakur, according to the statement. An FIR has been lodged in the case at the local Sector 63 police station in Noida under Indian Penal Code sections 419, 420 (related to cheating), 467, 468, 471 (all related to forgery) and provisions of the Information Technology Act and an investigation is underway, it added.

The method includes the preparation of shafts in areas with high population density and adjoining utilities like various pipelines, electrical installations, and other infrastructure projects such as Metro and highways.

The tunnel will be a single tube tunnel to accommodate twin tracks for both up and down tracks. Thirty-nine equipment rooms will also be constructed adjoining the tunnel location as part of the package.

To construct this tunnel with a diameter of 13.1 metres, Tunnel Boring Machines (TBMs) with a cutter head of 13.6 meters in diameter will be used. Usually, 5-6 meter diameter cutter heads are used for urban tunnels used in Mass Transit Rapid Systems (MRTS) such as the Metro system. Three Tunnel Boring Machines will be used to create about 16 km of the tunnel portion, and the remaining 5 km will be

constructed using the New

Austrian Tunnelling Method (NATM).

This tunnel will be about 25 to 57 metres deep from ground level, with the deepest construction point being 114

metres below the Parsik Hill. Vaishnaw asserted that the high-speed line will usher in economic growth.

The bullet train corridor will have 'limited stop' and 'all stop' services. While the limited-stop trains will cover the distance between Mumbai and Ahmedabad in just two hours, the other service will take about 2 hours and 45 minutes. Netanyahu seeks open-ended control in Gaza

Israel seeks open-ended control over security and civilian affairs in the Gaza Strip, according to a long-awaited postwar plan by Prime Minister Benjamin Netanyahu. It was swiftly rejected Friday by Palestinian leaders and runs counter to Washington's vision for the war-ravaged enclave.

Prime Minister Benjamin Netanyahu presented the twopage document to his security Cabinet late Thursday for approval. Deep disagreements over Gaza's future have led to increasingly public friction between Israel and the United States, its closest ally. The Biden administration seeks eventual Palestinian governance in Gaza and the Israeli-occupied West Bank as a precursor to Palestinian statehood, an outcome vehemently opposed by Netanyahu and his right-wing government. Netanyahu's plan envisions hand-picked

tering the territory. Separately, cease-fire efforts appeared to gain traction, with mediators to present a new proposal at an expected high-level meeting this weekend in Paris. The US, Egypt and Qatar have been struggling for weeks to find a formula that could halt Israel's devastating offensive in Gaza, but now face an unofficial deadline as the Muslim holy month of Ramadan approaches. In Gaza, Israeli airstrikes in the centre and south of the territory killed at least 68 Palestinians, including children and women, overnight and into Friday, health officials and an Associated Press journalist said. Another 24 bodies remained trapped under the rubble. Fidaa Ashour, whose sister was killed in a strike early Friday in the city of Rafah in southern Gaza, said "the world does not feel what we are enduring." The statement released early Friday by Hamas did not say whether Haniyeh's talks with Egyptian intelligence chief Abbas Kamel about ways of ending the war, a hostage deal and the flow of aid to Gaza were successful or led to a breakthrough The talks in Cairo came ahead of a high-level meeting expected over the weekend in Paris where international mediators will present a new proposal The United States, Egypt and Qatar have been struggling for weeks to find a formula that could halt Israel's devastating offensive in Gaza, but now face an unofficial deadline as the Muslim holy month of Ramadan approaches.

Trump's lawyers call for dismissal of classified documents case

AP WASHINGTON

Former President Donald Trump urged a Florida judge to dismiss the criminal case charging him with illegally retaining classified documents, claiming in part that presidential immunity protects him from prosecution even as that sweeping argument has so far in failed in federal appeals courts in a separate case.

In one of a slew of motions attacking the case brought by special counsel Jack Smith, Trump's lawyers late on Thursday echoed arguments that were roundly rejected by a federal appeals court this month in his 2020 election interference case Washington. Trump has asked the US Supreme Court to intervene in that case as the Republican presidential primary front-runner seeks to delay the trial until after the November election. Trump's lawyers wrote that the classified



documents charges turn on his alleged decision to designate the papers as "personal" records under the Presidential Records Act, and argued that he cannot be prosecuted since that was an "official act" made while he was still in the White House. Washington's federal appeals court in its decision this month was unsparing in its repudiation of Trump's novel claim that former presidents enjoy absolute immunity for actions that fall within their official job duties.

But Trump's lawyers argued that the appeals court's decision was wrong, telling US District Judge Aileen Cannon she should not follow the court's "poorly reasoned decision" in the classified documents case.

In other court filings late Thursday, Trump's lawyers argued that Attorney General Merrick Garland's appointment of special counsel Smith to investigate the former president was "unlawful" and grounds for dismissing the documents case. They also are attacking the law Trump is accused of violating as "unconstitutionally vague" as applied in his case.

The case accuses Trump of illegally hoarding classified documents at his Mar-a-Lago estate and obstructing government efforts to retrieve them. A June 2023 indictment charging him with dozens of felony counts alleges investigators found boxes of sensitive docu-

ments recklessly stored at Mara-Lago in spaces including a ballroom, a bathroom and shower, his bedroom and a storage room.

Prosecutors have said the documents he stowed, refused to return and in some cases showed to visitors risked jeopardizing not only relations with foreign nations but also the safety of troops and confidential sources. They've also accused Trump of asking a staffer to delete camera footage at his Florida estate in an effort to obstruct the federal investigation into his records.

The case is currently scheduled to go to trial in May, but Judge Cannon has pushed back multiple other deadlines and signaled an openness to revisiting the trial date during a pivotal pretrial conference set for March. Rape, sexual violence in Sudan's ongoing conflict may amount to war crimes: New UN report

T he UN human rights office said in a new report on Friday that scores of people, including children, have been subjected to rape and other forms of sexual violence in the ongoinng conflict in Sudan, assaults that may amount to war crimes. Sudan plunged into chaos in mid-April when clashes erupted in the capital, Khartoum, between rival Sudanese forces — the country's military, led by Gen. Abdel Fattah Burhan, and a paramilitary faction known as the Rapid Support Forces, under the command of Gen.

Mohammed Hamdan Dagalo. The fighting quickly spread across the African country, especially urban areas but also the restive western Darfur region, and has so far killed at least 12,000 people and sent over 8 million fleeing their homes, the report said.

The protesters then posed with their tractors on a bridge over the Seine River with the Eiffel Tower in the background.

The latest protest comes three weeks after farmers lifted roadblocks around Paris and elsewhere in the country after the government offered over 400 million euros (USD 433 million) to address their grievances over low earnings, heavy regulation and what they describe as unfair competi

ISIS bride loses appeal to regain British citizenship

Shamima Begum, the London-born Bangladeshiorigin woman, who fled the UK as a 15-year-old schoolgirl to join the Íslamic State (ISÍS) terrorist network, on Friday lost yet another legal bid to regain her British citizenship and return to the UK from Syria. Previously in 2022, the UK Supreme Court upheld the decision to bar the now 24vear-old from returning to the UK. After a series of legal battles, Begum lost a challenge at the Special Immigration Appeals Commission (SIAC) in February last year and then took her case to the Court of Appeal. However, the appeal judges unanimously agreed with the special tribunal's decision and turned down the appeal. "Ms Begum may well

NPCI to help Paytm UPI users migrate to banks

The Reserve Bank has asked the National Payments Corporation of India (NPCI) to examine the possibility of migrating Paytm Payments Bank customers using the UPI handle '@paytm' to 4-5 other banks, in a bid to prevent any disruptions in the payment ecosystem.

On Friday, the central bank came out with additional steps for the benefit of customers, wallet holders and merchants who are availing banking services from Paytm Payments Bank, which has been barred from accepting deposits and credits after March 15, 2024.

As per the website of Paytm Payments Bank (PPBL), it has 30 crore wallets and 3 crore bank customers.

umbrella NPCI, organisation for operating retail payments and settlement systems in India, is an initiative of RBI and Indian Banks Association (IBA) for creating a payment and settlement infrastructure in India.

As the PPBL cannot accept further credits into its customer accounts and wallets after March 15, 2024, certain additional steps have become necessary to ensure seamless digital payments by UPI customers using '@paytm' handle operated by the bank, and minimise concentration risk in the UPI system by having multiple payment app providers, the RBI said in a statement.

"NPCI has been advised by the RBI to examine the request of One97 Communication Ltd (OCL) to become a Third-Party Application Provider (TPAP) for UPI channel for continued UPI operation of the Paytm app, as per the norms," it said.
One97 Communications

Ltd (OCL), which owns the Paytm brand, holds a 49 per cent stake in PPBL.

RBI further said that in the event of NPCI granting TPAP

status to OCL, it may be stipulated that '@paytm' handles are to be migrated in a seamless manner from PPBL to a set of newly identified banks to avoid any disruption.

"No new users are to be added by the said TPAP until all the existing users are migrated satisfactorily to a new handle," it added.

"For seamless migration of @paytm' handle to other banks, NPCI may facilitate certification of 4-5 banks as Payment Service Provider Banks with demonstrated capabilities to process high volume UPI transactions. This is in line NPCI norms for with minimising concentration risk," RBI said.

Also, for the merchants using PayTM QR Codes, OCL may open the settlement accounts with one or more PSP Banks (other than Paytm Payments Bank), the Reserve Bank said. It further said the migration of UPI handles is applicable only to such customers and merchants who have a UPI handle '@Paytm' For others who have a UPI address or handle other than '@Paytm', no action is required to be taken by them.

RBI again asked the customers, whose underlying account/ wallet is currently with Paytm Payments Bank, to make an alternative arrangement with other banks



But Root decided to drop anchor after that, reverting to his natural style of playing the waiting game. The move got him and England the desired results as he struck his first century in 15 innings.

With the sun playing hide and seek during the fag end of the day, the Yorkshire man hit

the three-figure mark for the 31st time in his Test career, striking a classy cover-drive off Akash Deep. 
