Modi Bridges Ancient and Modern India



Prime Minister Narendra Modi on Sunday inaugurated 'Sudarshan Setu', the country's longest cable-stayed bridge of 2.32 km, on the Arabian sea connecting Beyt Dwarka island to mainland Okha in Gujarat's Devbhumi Dwarka district. Modi began his day by offering prayers at Lord Sri Krishna temple at Beyt Dwarka. He later inaugurated the four-lane cable-stayed bridge called the 'Sudarshan Setu', which boasts a unique design, featuring a footpath adorned with verses from Srimad Bhagavad Gita and images of Lord Krishna on both sides. The 2.32 km bridge, including 900 metres of central double span cable-stayed portion and a 2.45 km long approach road, has been constructed at a cost of ₹979 crore, as per an official release

Modi urges first time voters to cast ballots in large numbers

As the country prepares for general elections, Prime Minister Narendra Modi urged first-time voters on Sunday to cast their ballots in record numbers, emphasising that their maiden vote should be for

the country.
In the 110th episode of Mann Ki Baat, Modi announced that the monthly broadcast would not air for the next three months, adhering to political ethics ahead of the Lok Sabha

With the general elections expected in April-May, the PM said the possibility of the Model Code of Conduct (MCC) being enforced in March, similar to 2019, hinting at the upcoming

election schedule month.

MCC guidelines mandate that Governments refrain from using official events or public-funded platforms for activities that may favor the ruling party. Modi highlighted the

success of the programme in maintaining independence from Government influence over its 110 episodes, emphasising its dedication to the collective strength and

achievements of the country. "Mann Ki Baat is a programme "of the people, for the people, and by the people," Modi said.

"However, in line with

political ethics, 'Mann Ki Baat' will not be broadcast for the next three months during the Lok Sabha elections," he said

"When we reconvene, it will be the 111th episode," Modi added, noting the significance of the number.

He encouraged first-time voters to participate in large numbers, declaring that the 18th Lok Sabha would symbolise their aspirations. As citizens become eligible to vote at 18, Modi urged youth not only to engage in political activities but also to stay informed about debates and discussions during this

The services suspended in Ambala, Kurukshetra, Kaithal, Jind, Hisar, Fatehabad, and Sirsa on February 11, and the suspension was extended on February 13, 15, 17, 19, 20, 21, 23, and 24. Officials said no fresh order has been issued to extend the suspension of mobile services in the seven districts.

A senior Delhi Police officer said they are removing a portion of the barrier from Point A to Point B for the commuters. "The deployment of police and paramilitary forces will ensure strict vigil round the clock. Force deployment will stay in place. Vehicle movement will not be

allowed for now," he said. On Sunday, the city police removed two huge cement barriers for those commuters who walk towards Delhi using a small passage at the Singhu and Tikri borders.

↑ mid a disturbing surge in Ahuman-animal conflicts nationwide, the Udanti Sitanadi Tiger Reserve in Chhattisgarh offers a glimmer of hope with no reported loss of human life due to wild animal attacks in the past year. Udanti and Sitanadi are two wildlife sanctuaries combined, covering a total area of 1842.54 square kilometres. It was declared a tiger reserve back in 2009.

Officials from the tiger reserve have attributed zero humananimal conflict to proactive measures implemented to mitigate such incidents and ensure the safety of both humans and wildlife. They also credited this positive scenario to leveraging cutting-edge



technology, an AI-based app, 'Chhattisgarh Elephant Tracking and Alert', which, they said, has played a crucial role in preventing

human-elephant conflicts by promptly alerting people about elephant movements. explained that this

groundbreaking app has revolutionised the management of human-elephant conflicts by leveraging real-time data and analytics to promptly alert local communities about elephant movements, thereby reducing the risk of potential encounters and minimising conflict situations.

successful implementation of technology has not only enhanced public safety but has also contributed significantly to fostering coexistence between humans and elephants within the reserve's vicinity.

In addition to technological interventions, the tireless efforts of the anti-poaching team have played a pivotal role in safeguarding the integrity of the reserve, resulting in the arrest of 120 poachers in the past year.

These efforts have not only helped protect vulnerable species but ĥave also contributed to maintaining the ecological balance within the reserve.

Through concerted efforts,

encroachments on approximately 650 hectares within the reserve have been effectively removed, creating a safer environment for wildlife and local both communities. By preserving vital habitats and preventing wildlife from encroaching into nearby villages, these initiatives have been instrumental in minimising conflicts and promoting harmonious coexistence, said the officials. Despite commendable achievements, challenges persist, and humanwildlife conflicts continue to pose significant threats nationwide.

Banned SIMI member held after 22 years manhunt

The Delhi Police has arrested a 47-year-old member of Students' Islamic Movement of India (SIMI) who also allegedly edited a magazine of the banned organisation indoctrinating many gullible youths.

According to the police, Hanif Sheikh was declared a proclaimed offender in 2002 and has been absconding for the last 22 years. He

was nabbed on February 22 from Bhusawal in Jalgaon district Maharashtra where he was a teacher in an Urdu school under a different identity, they said.

Deputy Commissioner of

Police (Special Cell) Alok Kumar claimed that Hanif was the most notorious and wanted SIMI terrorist who had played pivotal roles in various activities of the proscribed organisation across the country. Police said the SIMI magazine that Hanif Sheikh edited had his name printed as Haneef Hudai. This was the only lead available with the police, making it difficult to trace him. they said. Á case of sedition and under the

Unlawful Activities (Prevention) Act (UAPA) was registered against him in 2001 at New Friends Colony police station in the national Capital. Continued on Page 9

2 die in mishap involving car securing CM cavalcade route by employer, aides

Yogi meets injured, announces compensation

Two of the 15 people, including police personnel who were injured when a police jeep met with an accident while securing the route for Chief Minister Yogi Adityanath's cav-alcade in Arjunganj on Saturday evening, succumbed late in the night.

According spokesman of media cell, commissioner of police (Lucknow), the deceased were identified as Neelam Devi (35) and her neighbour's daughter Priya (14) of Arjunganj. Both had gone to the market to purchase vegetables when the mishap occurred. Priya was a Class VII student of a private school. The spokesman said others were undergoing treatment.

Neelam succumbed to injuries at the trauma centre late Saturday night. She is survived by husband Vinay Kumar, and two children -Aniket & Ayush. Aniket is a Class V student and Ayush is a Class III student.

Santosh, father of Priya who succumbed to head injuries, demanded compensation of Rs 50 lakh, a job for a family member and accommodation from the government.



Neelam's brother Rahul has also demanded an ex gratia from the government.

Thirteen others are undergoing treatment at the two hospitals. Doctors said the condition of Vijay Kushwaha and Khalid Azam was critical. Battling blood clots in the

Yogi directed the doctors at KGMŬ to ensure no negligence in the treatment of patients and take special care of their diet.

The chief minister also interacted with their relatives, and assured them that the best possible treatment was being provided to patients. He told them to inform the hospital administration immediately in case of any problem so that it could be resolved promptly.

He also announced a compensation of Rs 2 lakh each for the families of the deceased and expressed grief. He also announced a financial aid of Rs 50,000 each to the families of the injured.

According to police sources, the accident occurred when the speeding jeep hit a vehicle parked on the roadside while trying to avoid an animal that suddenly came before it.

They said the local police' jeep was at least a kilometre ahead of the cavalcade.

"A police jeep travelling ahead of the convoy of the Chief Minister met with an accident in Arjunganj market area on Saturday evening. 13 persons were injured," Lucknow Police Commissioner SB Shiradkar said.

The DCP also claimed that the love affair between Abhinav and Gita went awry after which Abhinav and his employees — Arjun, Shivam and Kamal Kishore — killed

Earlier, upon finding Geeta's mobile number switched off on February 22, her son called her Yogita, who lived in the office itself along with Geeta, told him that she would be reaching Hardoi, her native home.

When she did not reach there, Neeraj visited Om Plaza which houses the office of the company, but found it locked. He tried calling Abhinav, but in vain. Later, Neeraj requested the Om Plaza manager for the CCTV footage.
When he checked the

footage, he spotted Geeta entering the office there on February 21 night. However, she was not seen coming out. In another footage, Abhinav and others, including Yogita, were seen coming out of the office along with some goods.

Neeraj somehow managed to talk to Abhinav, who told him that he had shifted the company's office. About Geeta, he told Neeraj that she had taken some money in advance from him and left for Hardoi.

Neeraj alleged that the incharge of the local police outpost did not help him even though he showed him the CCTV footage and asked him to round up and interrogate

In his confession, Abhinav confessed to have strangled

Geeta to death over a monetary dispute on February 21 night. He disclosed that he, along with his aides, took the body to Pratap Nagar crossing at Beniganj-Neemsar border in Hardoi and dumped the body into the Gomti river after tying

it to a sack filled with maurang.


The accused said he hid the body inside the box of a sofa which he took out from the office in a bid to pull wool over the police's eyes

He said he had shifted his office from Hardoi to Indira Nagar under Ghazipur police station last year. Abhinav said he lived in Gomti Nagar while Geeta and Yogita stayed in the office itself in Om Plaza.

Meanwhile, a youth was killed in a road mishap while his brother-in-law was injured in Gosainganj on Sunday morning.

As per reports, Jitendra Kumar (25) of Jahangirpur, along with his brother-in-law, was returning home from Katra locality in the area on a motorcycle when a speeding roadways bus knocked the bike from behind near a dhaba. Jitendra fell down and was run over by the bus. He died on the spot. His brother-in-law was admitted to a hospital. The errant driver sped off the scene. Police registered a case on the complaint given by the deceased's father.

Loader driver hangs self

He was later informed by villagers that his son's body was hanging from a tree in the orchard. He was a bachelor. Police sent the body for autopsy and started further investigations. The police said it was not clear why Saroj took

Every year during the mon-soon, the city faces the problem of waterlogging in several areas. In a bid to overcome this issue, Lucknow Nagar Nigam is developing a master plan for the city's drainage system for the first time. The municipal corpo ration has already issued a tender for the selection of a consultant, aiming for a comprehensive, exhaustive, and problemoriented master plan.

Providing details, chief engineer Mahesh Verma said,

"We are considering the entire municipal limit area for the drainage master plan. We will execute the plan based on available funds." He emphasised the importance of having a detailed drainage plan to determine the flow direction of drains within the municipal limits.

The detailed project report (DPR) will provide all drain details, including those sloping towards other drains. We have initiated the consultant selection process for DPR preparation. After the DPR is ready, we will execute it based on fund avail-

ability and inundation urgency," he explained.

Verma highlighted the problem of waterlogging in low-lying areas like Patel Nagar and Faizullahganj, sensitive to flooding. "Our goal is to make the city flood-resilient through the drainage master plan," he stated. He mentioned that once the DPR is completed, areas will be selected based on waterlogging severity. "If inundation persists for more than one day in certain areas, they will be prioritised for intervention," he added. Asked about the absence

of a master plan for drainage in the past, he explained, "Urbanisation and ongoing constructions on private lands necessitate plan modifications. Hence, a comprehensive master plan was not developed until now." Verma said that the new plan would be exhaustive, incorporating stakeholders' opinions, including the public and relevant departments.

"This will transform the

city's infrastructure," he said, noting that the state government has allocated budget provisions for the next financial year.

Verma pointed that waterlogging affects both static and floating populations, estimating around 60 lakh people are

impacted in the municipal and surrounding areas. The drainage plan will also encompass the renovation of pumping stations in the city. "Without this, we cannot proceed. Due to the city's topography, natural drainage is inadequate, necessitating pumping stations. After the plan is finalised, we will likely need to increase the number and capacity of pumping stations," he added.

While interacting with Sunita Devi, known as Drone Didi' from Sitapur, the prime minister enquired about her family and experiences. Sunita told the prime minister that she has studied up to BA and has a family consisting of her mother, husband and two children and farming is the source of their livelihood.

Sunita disclosed that she received training for operating drones at the Phulpur IFFCO company in Allahabad and saw a drone for the first time at the Sitapur Agriculture Science Centre.

On being asked by Prime Minister Modi whether she went through theoretical training first followed by practical, the 'Drone Didi'

answered in the affirmative, adding that her training started from the second day.

"First, we were taught about different parts of the drone and how to operate it. tests were taken, and then practical sessions were conducted. We were taught how to fly the drone and how to

control it," she stated. Mentioning difficulties faced during the rainy season when the crops are growing with increased risk of pests, Sunita stated that a drone can immensely help in such a situation in spraying pesticides while standing on the ridge. Emphasising the need for exercising caution, she added that so far she had sprayed

pesticides on 35 acres of land. In response to the prime minister's question, Sunita shared that farmers are very happy with this innovation, as it is effective and saves time. 'They only need to come and show us their fields. The spraying can be completed in just half an hour. Many people also come to see the

drone." she remarked.

Prime Minister Modi said, "My mission is to make 'Lakhpati Didi'. Sisters from all over the country are listening, and today, Drone Didi is

"Thousands of my fellow sisters need to come forward and become Drone Didis. If thousands of women join me, I will feel that I am not alone in this endeavour.

Prime Minister Modi congratulated Sunita, stating that 'NAMO Drone Didi' is becoming a significant means to modernise agriculture in the country.

In the programme, Prime Minister Modi further mentioned that two days ago, he was in Varanasi, where he witnessed a spectacular photo exhibition. LDA set to expand jurisdiction

Lucknow Development Authority is set to expand its jurisdiction to address the current issue of a depleted land bank and to facilitate the overall development of the outskirts, according to an official press release issued on Sunday. The expansion is expected to take effect possibly from July 1 this year.

Chief Minister Yogi Adityanath, during a press conference at his official residence on Saturday, had proposed the establishment of a State Capital Regional Development Authority, modeled after the National Capital Region (NCR), to ensure comprehensive development.

This initiative draws inspi-

ration from the significant development observed in and around the national capital.

According to government Divisional sources, Commissioner Roshan Jacob, who is also the ex-officio chairperson of LDA, and Vice-Chairman Indramani Tripathi have been informed about the expansion and asked to provide their suggestions for its effective implementation.

The announcement also stated that two prominent tehsils of the district, Bakshika-Talab and Sarojininagar, along with Gosainganj, would be included in the new setup.

Currently, the land bank is diminishing rapidly due to encroachment.

In response to the issue of land grabbing, Tripathi acknowledged that public land had been illegally occupied or obtained through fraudulent means. However, he assured that LDA was actively working

with police to reclaim its land. In the past year and a half the LDA enforcement squad has reclaimed public land worth Rs 1,000 crore, with plans to recover more in the

Similarly, employment increased at a compound annual growth rate (CÂGR) 4.7 per cent from 2016 to 2020 in UP. compared to India's 6.6 per cent which rose to 6.8 per cent. After the pandemic, in the financial year 2022, 14 per cent growth was witnessed in employment compared to 2021, with the share also increasing from 7.1 per cent to 7.6 per cent.

As for gross value added (GVA), there has been a 7 per cent growth from the financial year 2016 to 2020, with the share in India increasing from 5.1 per cent to 5.7 per cent. The Uttar Pradesh government is contemplating to enlist the support of corporate to enlarge the state's corporate social responsibility (CSR) reserves for socioeconomic development.

The state government will soon organise a 'UP CSR Summit' to script a new chapter in the process of collaborative socioeconomic development. The state is counting on its large

consumer market and growing heft to impress the private sector to loosen their CSR purse strings. The core idea of CSR lies in the ancient ideology of collectivism. During the pandemic, the nation witnessed a demonstration of the country's collective strength.

Uttar Pradesh is among the top five states who corner most of the CSR funds from companies. Others on the list are Maharashtra, Karnataka, Gujarat and Tamil Nadu. Section 135 of the Companies Act, 2013 mandates certain companies to allocate 2 per cent of their average profits from the preceding three financial years towards activities.

the contribution of leading private sector companies Vedanta Group, HCL, NCL, Reliance Foundation, Shiv Nadar Foundation, ITC Limited and NTPC in a large scale through CSR funds. In 2022-23, UP collected about

Rs 1,500 crore in its CSR corpus, and it was used in projects pertaining to women and child development, education, vocational education and skill development, etc. In 2014-15, UP garnered only

about Rs 148 crore in its CSR corpus, that grew to Rs 435 crore in 2017-18. In 2021-22, UP saw a CSR spending of Rs 1,321 crore that surged to around Rs 1,500 crore in 2022-23.

The cumulative CSR spent in India is estimated to be more than Rs 2 trillion. Even though UP has witnessed a sustained increase in its CSF kitty, the amount collected is small compared to its geographical size and population base.

Climate change poses challenges for water, sanitation services

Lucknow (PNS): Climate change presents significant new challenges for water and sanitation services across the region, emphasised Debashish Das Gupta from the Indian Institute of Management, Lucknow (IIML) during a technical workshop on Command area development through micro irrigation' held in the city.

Speaking on 'Climate resilience and water management', Das Gupta stated, "Climate resilience is about successfully coping with and managing the impacts of climate change while preventing those impacts from growing worse. A climate-resilient society will be low-carbon and equipped to deal with the realities of a warmer world."

He emphasised the imperative of reducing heat-trapping emissions driving climate change while adapting to unavoidable changes in ways that promote equity and justice.

Increasing threats of floods, droughts, increased temperatures, wildfires, storm surges, and loss of glaciers pose risks to infrastructure and auxiliary services, disrupting access to water and sanitation and deteriorating water quality, thus endangering human health," Das Gupta added.

Highlighting flooding and drought as the most significant climate threats to water and sanitation services, Das Gupta noted their anticipated escalation with global heating.

Shades of grey

Do political parties really mean to fulfil poll promises, or is it mere rhetoric to befool voters?

very election season, political parties can be seen letting loose a long litany of promises — some really genuine, but mostly mere pleasing-to-the-ears rhetoric. These campaign pledges, called poll manifestos or electoral promises or even 'jumlas', are tailormade to meet local voters' aspirations that season. However, a critical question looms: Is it really feasible for the parties to fulfil these promises? This discourse has gained fresh attention following the Chief Election Commissioner's (CEC) statement emphasising the voters' right to know if these promises can be delivered. The CEC's stance underscores the need for transparency and accountability in the electoral process, with the hope that it will prompt political actors to make promises more responsibly. At the heart of this debate lies a complex interplay of political dynamics, economic constraints, administrative capabilities and societal expectations. While political parties often design their agenda with the intention of securing electoral victory, the practicality of



implementing poll promises after getting elected is subject to numerous challenges; mainly the inherent uncertainty and volatility of governance. The political discourse is ever-evolving and parties have to adjust to it, often going back on what they themselves might have vociferously advocated. Besides unforeseen events, economic fluctuations and global dynamics also make it difficult to fulfil poll promises.

What may seem feasible during an election campaign could swiftly become untenable in the face of emerging challenges. The way out? At best, the parties can just declare: "It is our intention; conditions apply." Such an honest declaration does not at least sound as if it

were a done deal. Interestingly, even voters know that certain promises are undeliverable but then they do not have much choice, especially since the rival party is also tomtomming schemes that cannot be fulfilled. Of course there are unforeseen, serious challenges to genuinely-made pledges but the problem arises when misleading or false promises are deliberately made to capture votes. Worse, the parties know they can get away with it as there are no punitive damages yet for this practice. It is imperative for political parties to adopt a more responsible approach. Instead of succumbing to populist rhetoric, they should prioritise honesty, realism and evidence-based policymaking. Transparency also plays a crucial role in fostering accountability. Voters have the right to be informed not only about the promises made but also about the rationale behind them and the strategy for implementation. Also, robust mechanisms for monitoring and evaluation should be established to track progress and hold Governments accountable for their party's commitments. Then there is a need for greater public awareness to ensure that electoral promises are scrutinised rigorously. Citizens must actively participate in the democratic process, holding elected representatives accountable for their actions. Those deliberately making false promises must be punished through the ballot box.

Amid concerns over rising debt and geopolitical tensions, the resilience of Pakistan's political fabric faces its sternest test yet



akistan has not given a fractured mandate, on paper, it may seem fractured however the call people have taken is clear. How this new coalition Government would tackle the rising debt crisis would also be interesting to see. Revamping India's intelligence network

There is a pressing need for reforms within India's intelligence framework, addressing coordination deficits and accountability lapses

The imperative for a comprehensive overhaul of India's intelligence framework becomes apparent when considering the existence of 14 intelligence agencies, each with varying and occasionally overlapping responsibilities. These agencies have come into being in response to strategic shifts and past shortcomings. In the aftermath of the 1962 conflict with China, the Directorate General of Security (DGS) was established within the Intelligence Bureau (IB). Subsequently, following the 1965 war with Pakistan, external intelligence was segregated into a distinct entity, the Research and Analysis Wing (R&AW), which also birthed the Special Bureau aimed at enhancing organisational effectiveness. After the 1999 Kargil conflict, the Defence Intelligence Agency (DIA) and the National Technical Research Organisation (NTRO) were instituted. However, persistent issues

stem from the lack of coordination among these agencies. The absence of a Director of National Intelligence or a Coordinating Minister exacerbates this problem.



The intelligence apparatus, entrenched in the colonial-era police structure, grapples with adapting to contemporary challenges. The Intelligence Bureau (IB), primarily oriented towards domestic and political affairs, encounters limitations in counterintelligence endeavours. Despite initiatives like the Multi-Agency Centre (MAC), cooperation deficiencies persist. In 2001, a Group of Ministers proposed elevating the IB to the status of the premier Counter-Terrorism agency, culminating in the establishment of MAC and Subsidiary MACs for intelligence amalgamation. Externally, the R&AW, responsible for external intelligence gathering, confronts challenges such as excessive reliance on TECHINT and insufficient development of human intel-

ligence (HUMINT).

While the establishment of the National Technical Research Organisation (NTRO) and the Defence Intelligence Agency (DIA) aimed to address technological aspects, issues like overlapping mandates and coordination gaps have arisen. Reform is imperative, commencing with the delineation of contemporary challenges, specialisations, and oversight mechanisms

Concerning oversight, India lacks effective mechanisms for its intelligence agencies. Suggestions include appointing individuals well-versed in operational modalities at a macro level or establishing a National Intelligence Board for monitoring. Apex-level management necessitates enhancement, possibly through the appointment of a full-time intelligence adviser or a Director of National Intelligence under the NSA or

Coordination and tasking, particularly between the Centre and states, remain deficient, necessitating legislative attention. The Intelligence Cycle requires refinement, with a clear demarcation between collection and analy-

sis. Personnel issues. intelligence Human (HUMINT) and technical intelligence (TECHINT) pose distinct challenges. While big data analysis is nascent, considerations regarding privacy and legislative authorization for extensive data scrutiny are paramount. The dearth of skilled manpower for HUMINT is a significant concern, and bolstering military expertise within intelligence agencies is imperative. Although inspired by the ideology of the 5 Eyes, I4C, under the Ministry of Home Affairs, has not been effectively operationalized in the realm of digital warfare. Effectiveness in counter-terrorism and counter-insurgency remains a pressing concern. Failures to establish the National Counter-terrorism Centre (NCTC) and inter-agency conflicts underscore the need for a robust system. Ensuring successful prosecutions following counter-terrorism arrests is pivotal. (The writer is an eminent

The Indian education system stands at a crossroads, poised between recognition and realisation of its inherent potential



ooking back from the transition point to the third millennium, it could indeed be interesting—and revealing—as to what was the most encouraging achievement in the pivotal sector of education! The most mentioned of the responses to the query from seasoned academics and scholars, as well as the policymakers who had contributed to policy formulation and implementa-tion for three-four decades, referred to the change in social responses from various strata of society.

The most serious impediment was ignorance of the value of education in the lives of the individual and the family. One wonders whether anything more could be expected from a society seriously emaciated for centuries, and subjected to live their lives in abject misery! Social structures that practised exclusion, seriously flawed assumptions on the role of women and its relationship to female literacy, and the excruciating hold of the clergy in deprecating the education of girls were indeed serious handicaps before all those who were assigned to implement the constitutional directive of providing free and compulsory education to all children till they achieve fourteen years of age!

The widely prevalent practice of early marriage, child labour, compulsions to earn daily bread, and the need for extra hands in farms and fields, were also prominent factors that severely impeded the process of enrolment in schools. It may be tough for the millennials to visualise a situation that for decades together, girls' education in India suffered for want of toilets for girls in schools. This is one area that remained neglected all along.

Some academics and scholars—adherents of negativity included—would like to criticise all that has been done and achieved during this period. Those who are, ideologically unconstrained and capable of taking an objective analytical view express concern about certain aspects that are essential ingredients total the personality development of any individual.

every policy and programme, but current education practices get ignored in schools and even certain well-reputed institutions. Moral and ethical aspects of education, education in human values, and similar expressions are regular parts of every education initiative.

We also have the legacy of Mahatma Gandhi, who could say "My life is my message"! How many of our present-day leaders—political leaders—could say that with inner conviction and confidence? There are still the old guards and young ones who took Gandhi, Rajendra Prasad, Rajagopalachari, Karpuri Thakur, LK Advani, Narendra Modi, and the like as their role models.

The impact of amendments to criminal codes on national policing

The implications of amendments to three criminal codes on civil liberties and the integrity of the legal process remain subject to ongoing debate and scrutiny

Darliament has passed three criminal codes, among which the Bharatiya Nagarik Suraksha Sanhita (BNSS) seeks to amend the Code of Criminal Procedure, 1973 (CrPC). There is one provision in BNSS that seeks to increase the number of days within which police custody (PC) can be sought. When someone is in police custody, it means they are held by the police in a lockup at the station. On the other hand, judicial custody means they are held in a central jail. The investigating agency gets 24 hours to investigate if they are not able to complete the investigation within that bracket, they must get permission from the magistrate, who can grant custody of the accused for up to 60/90 days,



depending on the seriousness

However, within this timeframe of 60/90 days, the magistrate is restricted to granting PC for the initial 15 days from the date of arrest, beyond which only judicial custody can be granted. This 15-day limit was extensively discussed in the Anupam Kulkarni v. CBI case, where the Supreme Court ruled that an accused cannot be held in PC beyond

15 days from the date of arrest and PC in total can be for a maximum of 15 days, which means that PC could be granted by the magistrate in parts for the first 15 days or as a


Understanding the new law

According to Section 187 of the BNSS, the PC can be granted within the first 40 days (for less serious offences) or 60 days (for more serious offences) after the accused is arrested. The change implies that the prescribed 15-day period of custody can now be split into shorter periods of custody sought over 40 days for offences punishable up to 10 years or 60 days for other offences. This represents a departure from the current practice under Section 167 of

the CrPC, where PC can only

be obtained within the initial 15 days. Consequently, concerns have been raised regarding the Government's rationale behind this change, particularly considering the act's aim to prioritise a people-centric criminal justice system. However, further arguments necessitate the examination of two significant cases. Judgements that led to a para-

dox: First, in the case of Vikas Mishra v. CBI, where the CBI wanted more time to question Vikas Mishra, who was accused of corruption and conspiracy. Despite being in custody for seven days, he was hospitalised and later released on bail. The CBI argued that they couldn't interrogate him properly during this time. However, Vikas's lawyers cited the court's ruling that said PC



beyond 15 days from the arrest date is not allowed. Nonetheless, the court granted custody to the police and noted that every accused person must respect the investigation and court proceedings and went on to mention that these ways of hindering the pursuit of justice would not be tolerated.

Second, in the case of Senthil

Balaji v. The State, the Supreme Court decided that the maximum 15 days PC period can be split into shorter periods over the entire investigation, which can last either 60 or 90 days as against the general rule of granting PC in first 15 days, it also questioned its judgement of Anupam Kulkarni and further, said that this interpretation needs to

reviewed by a larger bench. By analysing the two judgements passed last year we can conclude that there is a growing inclination towards favouring the investigating agency. Despite the accused attempting to avoid initial PC in the first case due to medical reasons, it's essential to recognise that the accused might exploit the 15-day bar by taking the excuse of loopholes on grounds of a medical emergency.

However, the second case sets a precedent keeping the investigation process at the heart of the criminal justice system which poses a potential series of inconsistencies. Therefore, Section 187 of the BNSS aims to definitively resolve the existing confusion and prevent future inconsistencies regard-

ing the timeline within which PC can be sought and sets the limit of 40/60 days. It seeks to find a middle path

where the civil liberties of the accused are not exploited as the maximum number of days for which the PC can be granted is still 15 days which now can be granted in parts in 40/60 days and also favours investigating agencies by granting a reasonable time for custodial interrogation, which is crucial for uncovering the truth as denying the investigating agency the opportunity for further interrogation gives an advantage to the accused to disrupted the legal

"But in just 10 days, seven new AIIMS were either inaugurated or their foundation stones laid. That's why I am saying that we are developing the country many times faster than what happened in the last six to

seven decades and are dedicating it at the feet of the citi-

zens," he said. In the past, people from different states used to get tired seeking AIIMS in their areas from the Union government, whereas today modern hospitals and medical facilities like AIIMS are opening one after the other, he said.

Asserting that he had fulfilled his guarantee of setting up a large number of AIIMS, Modi said his government had approved 10 AIIMS in the last

Modi launches AIMS in five States PM to lay foundation stone of 553 Amrit Bharat railway stations

Prime Minister Narendra Modi will on Monday lay the foundation stone for the redevelopment of 553 railway stations under the Amrit Bharat scheme which includes improving facilities by developing rooftop plazas and city centres at stations.

The prime minister will also lay the foundation stone of nearly 1,500 road overbridges and underbridges across different states during a function that will be conducted virtually at more than 2,000 railway stations and function sites, officials said. The prime minister will join the function via videoconferencing.

Modi will also inaugurate the Gomti Nagar station in Uttar Pradesh which has been redeveloped at a cost of around Rs 385 crores, they said. "To cater to the increased future passenger footfall, this station has segregated arrival and departure facilities. It integrates both sides of the city. This centrally air-conditioned station has modern passenger

amenities like air concourse, congestion-free circulation, food courts and ample parking space in upper and lower basement," a statement from the prime minister's office said.

The Amrit Bharat stations, pread across 27 states and Union Territories, will be redeveloped at a cost of over Rs 19,000 crores. These stations will act as 'city centres' integrating both sides of a city and will boast of modern passenger amenities such as roof plazas, beautiful landscaping, intermodal connectivity, a modern facade, kids' play area, kiosks

and food courts, it said. The stations will be redeveloped as environment and Divyang-friendly and the design of these buildings will be inspired by local culture, heritage and architecture, it said. The prime minister will also lay the foundation stone, inaugurate and dedicate to the nation 1,500 overbridges and underpasses. These will be spread across 24 states and Union

These projects will reduce congestion, enhance safety and connectivity, and improve the capacity, and efficiency of rail

these projects is around Rs

21,520 crores.

India to add 18 more nuclear power reactors

India will add 18 more nuclear power reactors with a cumulative capacity to generate 13,800 MWe of electricity, taking the total share of atomic power in the energy mix to 22,480 MWe by 2031-32. This was announced by the Nuclear Power Corporation of India Limited (NPCIL) after Prime Minister Narendra Modi dedicated two home-built 700 MW nuclear power reactors at Kakrapar in

Presently, the NPCIL operates 24 reactors with a total capacity of 8,180 MWe. The prime minister dedicated units 3 & 4 of Kakrapar Atomic Power Station (KAPS 3 & 4) to the nation on February

KAPS-4 was connected to the western power grid on February 20, two days ahead of PM Modi's visit to Kakrapar. KAPS 3 & 4 (2 X 700 MW) are the

largest indigenous Pressurised Heavy Water Reactors (PHWR) with advanced safety features comparable to the best in the world, the NPCIL said.

"These reactors have been designed, constructed, commissioned, and operated by NPCIL, with the supply of equipment and execution of contracts by Indian industries/ companies, reflecting the true spirit of Atmanirbhar Bharat," the



NPCIL said. The prime minister said the role of nuclear power in electricity generation is going to increase in the 21st century and it was a matter of pride that India is Atmanirbhar in this advanced tech-

Modi also visited the Kakrapar Atomic Power Station and took a tour of the Control Room on the occasion.

Four nuclear power plants of 1,000 MWe each are being built at Kudankulam in Tamil Nadu with Russian assistance.

Four 700 MWe home-built PHWRs are coming up at Rawatbhata (RAPS 7 & 8) in Rajasthan and Gorakhpur (GHAVP 1 & 2) in Harvana.

Ten 700 MWe PHWRs have been sanctioned to be built at GHAVP 3 & 4 at Gorakhpur in Haryana, Kaiga Generating Station 5 & 6 near Karwar in Karnataka Chutka in Madhya Pradesh (CMPAPP 1 & 2) and four power units at Mahi Banswara in Rajasthan (MBRAPP 1, 2, 3

SC to hear Kejriwal plea against HC order upholding summons in defamation case

The Supreme Court is scheduled to hear on Monday a plea by Chief Minister Arvind Kejriwal challenging a Delhi High Court order which upheld summons issued to him as an accused in a criminal defamation case for retweeting an allegedly defamatory video circulated by YouTuber Dhruv Rathee in May 2018.

A bench of Justices Sanjiv Khanna and Dipankar Datta is likely to hear the matter.

In its judgement dated February 5, 2024, the high court had said that reposting alleged libelous content wil attract defamation law.

The high court had said a sense of responsibility has to be attached while retweeting content about which one does not have knowledge and added that retweeting of defamatory content must invite penal, civil as well as tort action if the person retweeting it does not attach a disclaimer.

CBFC regional office in Chandigarh soon, says Anurag

India, Japan begin two weeks military exercise in Rajasthan

In an effort to further **⊥**strengthen ties between the two countries, India and Japan on Sunday commenced a twoweek military exercise in Rajasthan's Mahajan field firing range to foster deeper cooperation in confronting common security challenges.

The exercise 'Dharma Guardian' between the Indian Army and the Japan Ground Self Defence Force is being conducted under the broad framework of India-Japan strategic cooperation, officials said. It is an annual exercise and conducted alternatively in India and Japan. The contingent of both sides comprises 40 personnel each.

"The aim of the exercise is to foster military cooperation and enhance combined capabilities to execute joint operations," the Indian Army said.

The exercise will focus on "high degree of physical fitness, joint planning, joint tactical drills and basics of special arms skills'

"Tactical drills to be practiced during the exercise will include establishing of temporary operating base, creating an intelligence, surveillance and reconnaissance grid, setting up mobile vehicle check post, executing cordon and search operations in a hostile village and heliborne operations," the Army said in a statement.

An exhibition of weapons and equipment will also be organised to showcase the 'Atmanirbhar Bharat' initiative and the growing defence industrial capability of the country,

Lt General Togashi Yuichi, the Commanding General, Eastern Army, Japan Ground Self Defence Force, is also scheduled to visit India during the exercise

'Exercise 'Dharma Guardian' will enable the two sides to share their best practices in tactics, techniques and procedures of conducting tactical operations," the Army

"The exercise will also facilitate developing inter-operability, bonhomie and camaraderie between troops of both the sides. This will enhance the level of defence cooperation, further fostering bilateral relations between the two friendly nations," it said.

Scientists develop tool to diagnose inflammatory disease

 $S_{ ext{tool}}^{ ext{cientists}}$ have developed a tool to rapidly and inexpensively diagnose sarcoidosis, a chronic inflammatory disease marked by the growth of tiny lumps called granulomas in the lungs and other organs in the

The tool, which uses a simple blood test, could allow for selective use of more invasive diagnostic tests often used to identify the disease. The find-ings were published in the American Journal of Respiratory and Critical Care Medicine. The research is supported by the National Institutes of Health.

"Currently, diagnosing sarcoidosis isn't a straightforward process, and requires tissue removal and testing with additional screenings to rule out other diseases, such as tuberculosis or lung cancer," said James Kiley, Director of the Division of Lung Diseases at the National Heart, Lung, and Blood Institute, part of NIH. "Using a blood test will help diagnose faster, particularly in those organs that are more challenging to biopsy and with less harm to the patient."

Though the exact cause of sarcoidosis is unknown, researchers suspect it is an immune disorder triggered by a group of specific antigens, which are generally foreign

DIAGNOSIS SARCOIDOSIS substances that incite an

immune response in the body. Cutaneous sarcoidosis in

India is 10 per cent; however, ACCESS study in the USA reported a higher prevalence of 15.9 per cent. Lofgren and Heerfordt syndromes are considered diagnostic for sar-

coidosis (ATS guidelines 2020) but these were not seen in any of the patients in a study in India and none had parotid involvement. Concerningly, the disease may be adding to the development of drug resistance in strains of tuberculosis

In the United States, an estimated 8-11 people per 100,000 are affected by sarcoidosis each year, according to previous

To identify antigens and determine which might be linked to sarcoidosis, scientists collected lung fluid samples and blood cells from patients with pulmonary sarcoidosis, then extracted the genetic material. Using a combination of molecular techniques, the researchers homed in on two newly described disease-specific antigen biomarkers that only bind to the antibodies of sarcoidosis positive patients.

They next designed a highly specific blood test, which only requires a small amount of

blood, to determine if they could accurately detect sarcoidosis. To verify the test, researchers compared blood samples from 386 people, which included patients with sarcoidosis, patients with tuberculosis, patients with lung cancer, and healthy individuals. The researchers confirmed that their test was able to differentiate patients who had sarcoidosis from those with other

respiratory diseases.
"More testing needs to be completed before this screening method is ready for clinical use, but it's possible that could be a reality within a few years," said Lobelia Samavati of Wavne State University and senior author on the study.

Trump triumphs over Haley in South Carolina

Donald Trump secured a resounding win over his Indian-American rival Nikki Haley in her backyard in South Carolina in the Republican primary, enabling the former US president to move closer to clinching a third straight presidential nomination from his party in 2024.

Refusing to give up, Haley, 52, a two-time former governor of South Carolina on Saturday vowed to take the fight to the Super Tuesday states on March 5 when Republican primaries are scheduled to be held in 21 US states. Trump, 77, has now won every contest that counted for Republican delegates, adding to his previous wins in Iowa New Hampshire, Nevada and the US Virgin Islands.

The South Carolina primary race was called mere minutes after polls closed. After results were counted, US media outlets said Haley received 39.5 per cent

of the vote in the Palmetto State while Trump 59.8 per cent, giving the former president 44 delegates and just three to the former South Carolina state

A candidate needs 1,215 delegates to bag the party's nomination in the November 5, 2024 presidential election. So far, Trump has won 102 delegates while Haley, the only major contender to the Republican frontrunner, has just 17 delegates.

'This was a little sooner than we anticipated, and an even bigger win than we anticipated," Trump told a crowd at his election night watch party in Columbia shortly after being projected the winner.

Saturday's result now places the onus on Haley, who continued in her concession speech to insist she has no plans to drop out of the race – a move that she said would leave the Republican voters in the upcoming prima-

Manhattan residential building kills Indian journo

New York (PTI): A 27-year-old Indian national, who worked as a journalist here, tragically lost his life in a "devastating" fire caused by a lithium-ion battery in an apartment building in Manhattan. Fazil Khan was killed in the fire that broke out in a six-story residential building at 2 St. Nicholas Place in Harlem, Manhattan that left about 17 other people injured.

The New York City Fire Department said that its marshals have determined that the "devastating" fire was caused by a lithium-ion battery.

Khan is a journalist with New York-based media company The Hechinger Report, which is focused on innovation and inequality in education.

The Consulate General of India in New York expressed condolences on Khan's death and said it is extending all possible assistance to repatriate his mortal remains to his family in India. "Saddened to learn about the death of 27-year old Indian national Fazil Kȟan in an unfortunate fire incident in Harlem, NY," the Consulate said in a post on X Saturday.

"Legitimate protests hijacked by extremists to promote and glorify terrorism, elected representatives verbally threatened and physically, mitic tropes beamed onto our own Parliament building," he said, with reference to an offensive projection on the Palace of Westminster recently.

"And in Parliament this week a very dangerous signal was sent that this sort of intimidation works. It is toxic for our society and our politics and is an affront to the liberties and values we hold dear here in Britain," he said of the scenes of chaos in the Commons last week over a Gaza ceasefire

While he did not make a reference to it specifically, his intervention came soon after the governing Conservatives suspended party MP Lee Anderson after he claimed during an interview that Pakistani-origin London Mayor Sadiq Khan was under the control of "Islamists".



The Opposition had demanded action over the remarks, which Labour Leader Keir Starmer branded as a "racist and Islamophobic out-

"This isn't just embarrassing for the Conservative Party, it emboldens the worst forces in our politics," said Starmer.

Isludge left by the tires of massive tractors in western Belgium's industrial farmlands that drew the attention of biological engineer Ineke Maes. The slime was destructive algae, the result of the excess of chemicals used by farmers to boost their crops, but at a high cost to nature. Maes had hoped the European Union's environmental policies would start to make a fundamental difference by improving exhausted soils.

In recent weeks, some of those tractors moved off the land and onto the roads, blocking major cities and economic lifelines from Warsaw to Madrid and from Athens to Brussels. Farmers were demanding the reversal of some of the most progressive measures in the world to counter climate change and protect biodiversity, arguing their livelihoods and strangling them with red tape. And the impact has been

stunning.

The farmers' protests affected the daily lives of people across the 27-nation bloc, costing businesses tens of millions of euros in transportation delays. The disruption triggered knee jerk reactions from politicians at national and EU level: they committed to rolling back policies, some of them vears in the making, on everything from the use of pesticides to limiting the amount of manure that could be spread on fields. So far, we have not decided anything as far as this matter is concerned," ICAI President Ranjeet Kumar Agarwal told PTI in an interview.

 $T^{he \ number \ of \ merger \ and}_{acquisition \ (M\&A) \ deals}_{during \ 2023 \ dropped \ by \ 10}$ per cent on an annual basis to 793, said a PwC India report on Sunday.

However, the total disclosed deal value for M&A declined much steeper at 38 per cent during the year, according to the report titled 'Deals at a glance'.

The report further observed that PE (Private Equity) investments totalled USD 36 billion, marking a substantial 36 per cent drop from 2022.

Despite this decline, the average investment size per deal increased to USD 46 million from USD 42 million in 2022, reflecting a potential shift towards opportunities. While

early-stage investments were 53 per cent ess compared to that in 2022 the report said, these along growth-stage with investments continued to make up the major share, constituting around 73 per cent of fundings in 2023. On the other hand, buyouts demonstrated resilience with only a 5 per cent decline compared to 2022. ICC suspends Hasaranga for two matches, Gurbaz fined match fees

The ICC has suspended Sri Lanka ▲ captain Wanindu Hasaranga for two matches and docked a fine of 15 per cent on the match fee of Afghanistan wicketkeeper-batter Rahmanullah Gurbaz for breaching its Code of Conduct during the

third T20I in Dambulla. The global governing body said in a release that Hasaranga has been banned after the spin bowling all-rounder accumulated a total of five demerit points within a 24-month period, which includes his latest breach of the ICC Code of Conduct.

"Sri Lanka's T20I skipper and second-ranked T20I bowler on the ICC Men's Player Rankings, Wanindu Hasaranga, has been presented with a two-match suspension after his total demerit points reached five within a 24month period following his latest breach of the ICC Code of Conduct, for which he received a 50 per cent fine and three demerit points," the ICC said in a statement. The incident involving Hasaranga took place towards the end of the third and final T20I on Wednesday when he approached the on-field umpire Lyndon Hanibal to criticise a decision

of breaching the article 2.13 of the being adjudged a no-ball. ICC Code of Conduct for Players Hasaranga was thus found guilty and Player Support Personnel. The

article relates to "personal abuse of a Player, Player Support Personnel, Umpire or Match Referee during an International Match".

With Hasaranga accumulating five demerit points, it converts to two suspension points, the ICC "This means he will either get a ban for one Test match or two ODIs or T20Is, whichever comes first, for the player or player support personnel. Consequently, Hasaranga will be suspended from participating in Sri Lanka's first two T20Is against Bangladesh next

month," the ICC said. **Gurbaz penalised** Afghanistan batter Gurbaz too

was penalised for breaching Level 1 of the ICC Code of Conduct in the same match for having violated the article 2.4 of the code, which concerns "disobeying an Umpire's instruction during International Match".

This has resulted in one demerit point being added to Gurbaz's disciplinary record, which marks his second such offence in a 24-month period and the player accumulating two demerit points.

"The sanction was imposed on Rahmanullah for altering the grip of his bat on the field despite repeated warnings against doing so," the ICC said.

The ICC added that both the players have admitted to the offences and have accepted the sanction proposed by Chris Broad from the elite panel of match referees. "The charges were brought forth by on-field umpires Lyndon Hannibal and Raveendra Wimalasiri, third umpire Ruchira Palliyaguruge, and fourth umpire Ranmore Martinez," the ICC said. Sri Lanka won the series 2-1
