KAMAL DRAWS IN KAMAL, **CONGRESS WILTS**

n an interesting political development, Kamal Nath, one of the remaining tallest leaders of the Congress owing allegiance to the Nehru-Gandhi legacy, is all set to join the BJP along with his son Nakul, a sitting Congress MP, in a couple of days. Sources said both Kamal and Nakul have scheduled a meeting with BJP functionaries. functionaries on Sunday evening as the ruling party leaders are busy in the two-day national convention being held in the national capital. The grand old party's latest and

biggest jolt in a fortnight comes after the exodus by Ashok Chavan, who joined the BJP, and Milind Deora, who switched sides to Shiv Sena; the duo had also been rewarded with Rajya Sabha berths a day earlier.

Several-time Union Minister, Chief Minister, and holder of prominent party positions since the late 1970s, Kamal will share the saffron cadre with his onceupon-a-time bête noire Union Minister Jyotiraditya Scindia, as the former was responsible for undermining the Maharaja's foothold in Madhya Pradesh, ultimately leading to the fall of the last Congress-led Kamal Nath Government after Scindia quit

Kamal Nath, the sitting MLA from the Chhindwara seat, was removed as MP Congress chief in the wake of the Congress' crushing defeat at the hands of the BJP in the last Assembly elections

He is said to be disgruntled over not getting a Rajya Sabha berth, and also Rahul Gandhi has been late last year.

Though speculation about Kamal Nath's shift has been going on for the last few days, they got a fresh boost on Friday when Madhya Pradesh BJP president VD Sharma said Nath and his son are welcome in the BJP if they are unhappy with Congress' decision to boycott the Ram Mandir consecration event held in Ayodhya.

"Kamal Nath and his son are welcome in BJP if they are unhappy with their party's decision to boycott the Ram Temple inauguration last month and if they want to join the saffron party to serve the country and society under the leadership of PM Narendra Modi," Sharma told reporters in Bhopal. However, Nath's colleague in the party and former Madhya Pradesh chief minister Digvijaya Singh rubbished the rumours and dubbed them a "media creation." Nath stood behind the Congress like a rock during the bad patch when the government led by him was toppled by Jyotiraditya Scindia after joining the BJP in March 2020. Nath and Digvijay have the best rapport with the Gandhis, and Singh said that Kamal Nath, who started his political innings with the Nehru-Gandhi family, could never leave the party.

Jharia Division introduces environmentally friendly Paste Filling Technology for Mine Safety

he Jharia Division of Tata Steel recently commissioned an environment friendly Paste Filling Pilot Plant with a capacity of 10 M3/h to fill voids using self-levelling flowable paste made from fly ash, cement, and additives.

The Plant was inaugurated by D B Sundara Ramam, Vice President, Raw Materials, Tata Steel, in the presence of Sanjay Rajoria, General Manager, Jharia Division, Tata Steel, and Dr. Prashant, Senior Principal Scientist, CSIR-CIMFR at Digwadih Colliery of the company. This marks the first in India where Tata Steel is exploring this technology for coal mine void

Filling unapproachable coal voids poses a significant challenge for coal miners, leading to safety concerns in and around underground collieries.

Unlike the current sand slurry backfilling method that leads to borehole choking, segregation, and heaping issues during filling of unapproach-able coal voids, the paste filling tech-nology achieves higher efficiency through its self-leveling and conthrough its sent-tevening and controlled spreading of cemented fly ash paste. The paste of different composition and flow properties will be pumped into the empty voids below the railway line at Digwadih Colliery. The success of this trial will pave the way for the development of mobile setups to fill voids of more than 1 km in length at the current site, and potential applications at production and

This technology not only offers an environmentally friendly alternative to river sand for mine backfilling but also aims to enhance safety in unapproachable voids beneath railway lines, highways, and permanent struc-

tures, situated above underground collieries. Developed through collaboration between Tata Steel, CSIR-Central Institute of Mining and Fuel Research (CSIR-CIFMR) and IIT-Kharagpur, this technology shows promising prospects for future applications.

ight Congress MLAs today d left for Delhi to meet AICC Ifunctionaries after the same faces for ministerial positions were repeated in the State government in the swearing ceremony held on February 16. Before leaving, these MLAs met the JMM Leader and Minister in the State Government, Basant Soren at Hotel Raso in Ranchi. After this meeting which lasted for about half an hour, the Congress MLAs reached the airport and left for Delhi.

Before leaving for Delhi, Congress' Mahagama MLA, Deepika Pandey Singh said that all the MLAs are united and have informed the Congress High Command about their demands High Command about their demands. She said that some solution will definitely be found to remove the displeasure of the MLAs. She further said that

remain in Delhi. At the same time, she refused to say anything on the question of withdrawal of support. On the question of one post and one leader, she said that all these things have been placed before the high command. Whatever instructions come from the party, we will follow it.

Bermo MLA Anup Singh said that all the MLAs are going to Delhi to meet the high command leaders. He said that there is resentment but it is still difficult to tell for what reasons. On the question of Basant Soren reaching Raso Hotel, he said that meeting Basant is not an inexplicable incident.

He belongs to a family that is an important part of the coalition government. He said that we know two families, the Congress family and the Soren family. He said that the coalition government is running on the basis of this so it becomes necessary to meet him. He said that whatever problem there is, he will put it before the high command.

MLA Irfan Ansari said that all the MLAs will meet the high command in Delhi. He said that whatever instructions they get from the high command, they will be able to share the same information with the media. Police suspect witchcraft practice

In a tragic incident in Jharkhand's West Singhbhum distrisct, four individuals were brutally murdered in Tunguwasa Tola of Nurda village, accused of witchcraft. The victims included a woman, two children aged eight months and one and a half years, and a man. The bod-ies were callously thrown on the tracks between Kendposi and Talaburu railway stations, shocking local residents who discovered them on a Saturday

Upon police arrival, initial suspicions of suicide were dispelled when the woman's brother-in-law identified the victims. The bodies, found in a mutilated condition due to a passing train, were tied in

sacks before being discarded on the tracks. The identity of one male victim remains unknown. This heinous crime highlights the grave consequences of baseless accusations related to witchcraft, shedding light on the urgent need for awareness and intervention to prevent such tragedies in the

The victims, suspected to be from a single family, included a 28-yearold woman, a 30-year-old man, a one-year-old baby boy, and a twoand-a-half-year-old baby girl.

The bodies of the children were found together, while the bodies of the adults were discovered separately, approximately two kilometers apart. The cause of death remains uncertain, with authorities yet to determine whether it was a case of multiple suicides, an accident, or a gruesome mass

"We responded immediately to the scene after being alerted by a train driver. The bodies have been shifted to the Chakradharpur sub-divisional hospital for postmortem examina-



Taking proactive steps to I enhance surveillance of drugs and cosmetics sold in the market, the Central Drugs Standard Control Organisation (CDSCO) has asked drug inspectors across States to maintain a centralised monthly list of spurious and "not-sostandard quality (NSQ)" drugs, to be published on its website so that they can be promptly recalled and public awareness raised to prevent their further

In its guidelines issued recently, the CDSCO's noted that the current list of NSQ and spurious drugs is not regularly updated, and crucial informa-

These guidelines aim to cover a wide variety of products and

The CDSCO emphasized the importance of collecting sufficient samples and promptly forwarding them to laboratories for testing. By addressing gaps in surveillance and implementing robust sampling protocols, the CDSCO aims to enhance consumer confidence and protect against the risks posed by sub-

Railways to start train service between Banihal, Sangaldan


The Indian Railways will start the much awaited 'dream' train services on the Banihal-Khari-Sumber-Sangaldan section, a 48.1segment of the country's most ambitious Udhampur Srinagar-Baramulla Rail Link project, on February 20. Sources in the Ministry of railways said the Prime Minister Narendra Modi is likely to inaugurate the section by virtually flagging off a train from Sangaldan.

The Udhampur-Srinagar Baramulla Rail Link (USBRL) project is one of the most ambitious Himalayan railway projects post Independence and with this direct train service between Srinagar with Kanyakumari is not a distant dream now.

The USBRL project seeks to integrate the Kashmir Valley with the Jammu region and the national rail network, spanning a total length of 272 kilometres out of which 161 kilometres have already been commissioned.

According to the railways, the Banihal-Khari-Sumber-Sangaldan section, which was constructed at a cost of Rs 15,863 crore, is ready for operation and the existing train services from Baramulla to Banihal will now be extended up to Sangaldan, a town near the district headquarters of Ramban.

Tt features 16 bridges -- 11 major ones, four minor ones



and one road overbridge. More than 90 per cent of this section is in tunnels, with a total of 11 tunnels covering 43.37 kilometres, including the country's longest transportation tunnel, T-50, stretching 12.77 kilometres in the Khari-Sumber section," a senior official associated with the project said.

"Spanning the challenging terrain of the Pir Panjal ranges, the USBRL aims at establishing an all-weather, comfortable and economically-feasible transportation network, connecting remote Himalayan areas with the rest of the country.

For safety and rescue, there are three escape tunnels with a combined length of 30.1 kilometres. Additionally, the section includes 30 curves spanning 23.72 kilometres. To further enhance passenger safety and comfort, several advanced features have been incorporated, such as ballastless tracks and canted

Railways)," explained a project director of the railways. Besides, CCTV monitoring and state-of-the-art tunnelsafety technology, including ventilation and firefighting systems, are some of the other added safety features.

So far as electrification is concerned, the Baramulla-Srinagar-Banihal-Sangaldan section of the USBRL project, which spans 185.66 RKM (route kilometres) and serves 19 railway stations, is complete, the sources said.

Constructed for Rs 470.23 crore, with electrification, it is possible to operate the stateof-the-art Vande Bharat trains in the section.

Other noteworthy features include 25-KV OHE inside the longest operational tunnel (tunnel T-80 in the Banihal-Quazigund section), specialised equipment for highaltitude operations and 132/33-KV traction substations at altitudes exceeding 1,600 MSL," added the offi-

Cotton candy under FSSAI scanner over toxic chemicals

 $F^{\text{luffy texture, vibrant colors, and sweet flavor made}}$ Cotton Candy, also called 'Buddhi ke Baal'a popular choice among young ones country, but it has now come under the scanner of the Food Safety Standard Authority India (FSSAI) following reports of detection of cancer causing chemicals recently in Tamil Nadu which has now banned its sale. Puducherry was the first State to prohibit the sale of Cotton candy. More States may follow the suit as sources in the top food regulator body soon all the food inspectors across the States will be asked to pick the samples to test its content.

They said that the laboratory test results on Cotton candy that were seized by state health officials during the crackdown in Chennai Marina Beach and Besant Nagar beaches when it was being sold last week showed that they contain Rhodamine-B, a cancer-causing chemical.

It has raised alarms among the authorities, highlighting the importance of ensuring the safety and quality of such treats to protect the health of children who enjoy them. The test results showed that it has a chemical called 'Rhodamine B'that was used in matches and incense sticks. The harmful chemicals were mixed to produce vivid pink



clothes, which can lead to liver failure, the officials said. A chemical compound, Rhodamine B, also known as RhB, according to the National Institutes of Health (NIH.gov) after entering the body with food, has a distributed effect on cells and

tissues. Prolonged consumption of RhB-contaminated food can cause cancer or liver damage. Its presence in excess can lead to poisoninglike conditions.

The officials said that they are taking steps to address these concerns and safeguard the well-being of young consumers, emphasizing the need for vigilance in monitoring food products aimed at

"The presence of such harmful substances underscores the importance of stringent food safety regulations and underscores the need for

toring to ensure the wellbeing of consumers," said the official.

A few weeks ago, the Puducherry government also banned its sale.

Tamilisai Soundararajan, Lieutenant Governor of Puducherry had taken to her personal Instagram handle to urge people not to buy cotton candy, particularly for kids, as it contains toxic chemicals.

"People should be aware that food items having colour additives must not be given to children," she said in the video. Cotton candy is also called 'fairy floss'and 'Buddhi Ke Baal'is made from sugar syrup, then spun through a small hole, which are collected on a stick and is then served as a cotton candy. Made in different colours, this dish is eaten with great taste and is said to be very

Navalny's mother is still waiting for his body

lexei Navalny's spokesperson confirmed Saturday that the Russian opposition leader had died at a remote Arctic penal colony and said he was "murdered," but it is unclear where his

An official note handed to Navalny's mother stated that he died at 2:17 pm local time Friday, Kira Yarmysh said. She added that an employee of the prison colony said that Navalny's body was taken to the nearby city of Salekhard as part of a probe into his death. She demanded that his body be handed over to his family.

When a lawyer and Navalny's mother visited the morgue in Salekhard, it was closed, Navalny's team said, writing on their Telegram channel. The lawyer called the morgue and was told that Navalny's body is not there, his team said.
"We demand that Alexey Navalny's

body be handed over to his family immediately," Yarmysh wrote on X, previously Twitter. The cause and the circumstances of Navalny's death Friday remain largely

Russia's Federal Penitentiary Service reported that Navalny felt sick after a walk and became unconscious at the penal colony in the town of Kharp, in the Yamalo-Nenets region about 1,900 kilometres (1,200 miles) northeast of Moscow. An ambulance arrived, but he couldn't be revived. The cause of death is still "being established," it said.

Maria Pevchikh, head of the board of Navalny's Anti-Corruption Foundation, said that the opposition leader would "live on forever in millions of hearts."

"Navalny was murdered. We still don't know how we'll keep on living, but together, we'll think of something," she wrote on X.

Arrests continued Saturday after more than 100 people were detained in various Russian cities Friday when they came to lay flowers in memory of Navalny at memorials to the victims of Soviet-era purges, according to OVD-Info, a group that monitors political repression in



The tributes were removed overnight, but people continued trickling in with flowers on Saturday. In Moscow, a large group of people chanted "shame" as police dragged a screaming woman from

the crowd, video shared on social media

More than 10 people were detained at a memorial in St Petersburg, including a priest who came to conduct a service for

In other cities across the country, police cordoned off some of the memorials and officers were taking pictures of those who came and writing down their personal data in a clear intimidation

Navalny had been jailed since January 2021, when he returned to Moscow to face certain arrest after recuperating in Germany from nerve agent poisoning he blamed on the Kremlin. He was later convicted three times, saying each case was politically motivated, and received a sentence of 19 years for extremism.

After the last verdict, Navalny said he

understood he was "serving a life sentence, which is measured by the length of my life or the length of life of this regime."

The news of Navalny's death comes

less than a month before an election that will give President Vladimir Putin another six years in power.

It shows "that the sentence in Russia now for opposition is not merely imprisonment, but death," said Nigel Gould-Davies, a former British ambassador to

Belarus and senior fellow for Russia & Eurasia at the International Institute for Strategic Studies in London.

Hours after Navalny's death was reported, his wife, Yulia Navalnaya, made a dramatic appearance at a security conference in Germany where many world

leaders had gathered. She said she was unsure if she could believe the news from official Russian sources, "but if this is true, I want Putin and everyone around Putin, Putin's friends, his government to know that they will bear responsibility for what they did to our country, to my family and to my

US President Joe Biden said Washington doesn't know exactly what happened, "but there is no doubt that the death of Navalny was a consequence of something Putin and his thugs did."

The Kremlin bristled at the outpouring of anger from world leaders, with Putin's spokesman Dmitry Peskov saying as "inadmissible and outrageous," noting that medics haven't issued their verdict on the cause of Navalny's death.

Ukraine withdrawing from Avdiivka

Ukraine's military chief said early Saturday that he's withdrawing troops from the city of Avdiivka in eastern Ukraine, where outnumbered defenders have battled a Russian assault for four months.

The timing is critical as Russia is looking for a morale boost ahead of the second anniversary on Feb 24 of Moscow's full-scale invasion of Ukraine and the March presidential election in Russia.

In a short statement posted on Facebook, Ukrainian commander Col Gen Oleksandr Syrskyi said he had made the decision to avoid encirclement and "preserve the lives and health of servicemen".

The commander-in-chief added that troops were moving to "more favourable lines".

"Our soldiers performed their military duty with dignity, did everything possible to destroy the best Russian military units, inflicted significant losses on the enemy in terms of manpower and equipment.

'We are taking measures to stabilise the situation and maintain our positions," the statement read. The withdrawal came a day after Ukrainian President Volodymyr Zelenskyy on Friday made another trip to western Europe, hoping to press his country's Western allies to keep providing military support.

It was Syrskyi's first major test since being appointed as Ukraine's new army chief last

In his previous position as commander of Ukraine's ground forces, he faced criticism for holding on to the city of Bakhmut for nine months, a siege that became the war's longest and bloodiest battle and cost Ukraine dearly, but also served to sap

In recent days, reports emerged that Ukrainian troops in Avdiika faced a deteriorating situation.

Rodion Kudriashov, deputy

Brigade, said Friday that Ukrainian troops were still holding out against the onslaught of about 15,000 Russian soldiers, but he expected the situation would "soon become critical".

"The enemy is trying to penetrate our defence and in some places to bypass our positions," he told The Associated

The 3rd Brigade said on its social media account Friday that its soldiers were at the huge Avdiivka Coke Plant. Russian warplanes have been dropping about 60 bombs a day, relentlessly shelling the area and launch ing assaults with armour and infantry, the brigade said.

A video showed dense black smoke over the factory, said to be caused by burning fuel oil reservoirs. The post said: "Poisonous smog spreads all over the plant."

Russian media reported the Kremlin's forces were making extensive use of plane-launched glide bombs, which fly at a shallower angle, to batter Ukrainian

White House national security spokesman John Kirby said on Thursday that Russian forces were beginning to overwhelm Ukrainian defences in the eastern city. He said Avdiivka is at risk of falling to Russia, a development he blamed "in very large part" on the fact that Ukrainian forces are running out of artillery ammunition.

The United States is Ukraine's biggest single supporter but some \$60 billion for Kyiv is being held up by political disagreements among American lawmakers.

Heavily fortified with a web of tunnels and concrete fortifications, Avdiivka lies in the northern suburbs of Donetsk, a city in a region of the same name that Russian forces partially occupy. Capturing Avdiivka could be a timely boost for Moscow and serve as a possible springboard for Russia to drive deeper into the region. Fewer than 1,000 people remain in the city, according to the Donetsk regional governor,

Pakistan's CEC, Chief Justice involved in poll-rigging, alleges bureaucrat

senior Pakistani bureaucrat Asenior Pakistain butters Asenior Pakistain butters and Saturday alleged that the chief election commissioner and the chief justice were involved in poll-rigging in the recent election as he resigned from his post, taking the "responsibility for all this wrongdoing".

Rawalpindi Former Commissioner Liaquat Ali Chattha's remarks came amidst jailed former prime minister İmran Khan's Pakistan Tehreek-e-Insaf (PTI) party began nationwide protests against alleged rigging and stealing of its mandate in the February 8 elections.

Speaking to reporters at the Rawalpindi Cricket Stadium, Chattha said the candidates who were "losing" the elections "were made to win".

"I am taking the responsi-bility for all this wrongdoing and telling you that the chief election commissioner and the chief justice are also completely involved in this," he was quoted as saying by the Dawn newspaper.

Chattha resigned from his office after "accepting responsibility" for manipulation of poll results, it said.

He said "stabbing the country in its back does not let" him sleep.
"I should be punished for

the injustice I have done and others who were involved in this injustice should also be punished," Chattha said. The former bureaucrat said

there was "pressure" on him to the extent that he contemplated suicide but then resolved to present matters before the pub"It is my request to the entire bureaucracy to not do anything wrong for all these politicians," he said. Election The

Commission of Pakistan (ECP) has strongly rejected the allegations Chattha has made against the chief election commissioner.

In a press statement, it said, "The Election Commission of Pakistan strongly rejects the allegations levelled by the Commissioner Rawalpindi on the chief election commissioner or the election commission and no official of the election commission never issued any instructions regarding changing the election results to the Commissioner Rawalpindi.

"Neither is the commissioner of any division ever appointed as a District

Returning Officer, Returning Officer or Presiding Officer nor do they ever play a direct role in the conduct of elections."

However, it said that the matter would be investigated. Punjab's caretaker Chief Minister Mohsin Naqvi has also ordered an "impartial probe" into the allegations

made by Chattha. Taking notice of the claims in a statement, he directed that a "high-level committee" be constituted to conduct an inquiry into the matter.

"An independent inquiry of the allegations will be held," Naqvi asserted, adding that the facts will be brought forward. Following Chatta's press conference, police reached the venue and arrested him. He has been shifted to an unknown location by the security offi-

Sunak urges Conservatives to come together to beat Opp

 $B_{\text{Sunak on Saturday made a}}^{\text{ritish Prime Minister Rishi}}$ direct appeal to voters to stick with his plan to turn things Conservative family to come together to beat the Opposition Labour Party in a general election later this year. Writing in 'The Daily Telegraph' a day after bruising double defeats in by-elections that saw the governing Conservatives lose two of parliamentary strongholds, the 43year-old British Indian leader reiterated a previous claim that the results were down to voter apathy and low turnout.

Sunak urged the electorate to back him and support his party in the general election because by then he expects his plan for the country will be delivering the goals he had set out. "The Conservative family must come together to defeat Labour and country," Sunak wrote. "I know that the last year has

not been easy. I understand why people feel exhausted with politics. I get why people choose to out in a by-election that won't change the government," he said and added, "But later this year, we will have a general election that will decide who governs our country. I am confident that by then we will have made more progress that the plan will be delivering the security and opportunity that people crave."

This direct plea to the voters comes amid some tough political times for the British Prime Minister, who is under pressure from within his party to change course before it is too late.

Drawing a clear divide between his leadership and that being proposed by Labour Leader Keir Starmer, Sunak asserted that his opponent had no



plan and would take the country

He said: "A vote for anyone other than the Conservatives will just help Starmer. The reason we will stick to the plan and the reason I, unlike Keir Starmer, am willing to make difficult decisions to address the long-term problems our country faces is because a strong economy is the bedrock upon which a successful country is built. "The choice at the election later this year will be between this Conservative vision for Britain and a Labour Party that would just take us back to square

one." He sought to spotlight some of his successes, such as halving inflation since he took charge in October 2022 and lowering taxes, even as he admitted that progress on his other migration and cutting National Health Service (NHS) waiting lists has been slow. "Delivering the change our country needs means taking difficult long-term decisions and sticking to the plan. Keir Starmer and the Labour Party can't say what they would do because they do not have a plan ... But it's not just the fact that Labour doesn't have a plan for the economy that threatens our progress. They would also make life more expensive and more burdensome for business," he cautioned. The strong by-election impact of the far-right Reform UK, formerly Brexit Party, has led to the right wing of his party pushing Sunak to get tougher on issues such as immigration.

Power Grid unfazed by proposed **O&M** norms changes by CERC

PTI ■ KOLKATA

 $P_{(\text{POWERGRID})}^{\text{ower Grid Corporation}}$ "no impact" from proposed changes in Operation & Maintenance (O&M) charges norms by Central Electricity Regulatory Commission (CERC), a top company official said.

The official said the company was in discussion with the regulator.

Draft regulations suggest altering the prior 75:25 (substation vs transmission line) O&M cost distribution to 65:35 ratio, increasing transmission line charges while decreasing substation charges.

Chairman and Managing Director Ravindra Kumar Tyagi claimed "net impact is almost zero," with overall O&M charges maintained.

"They have added one more element, 'reactor'. Earlier, we were not incurring any O&M charges for reactors. Now, reactor charges have been added per MVAR (Mega Volt-Ampere Reactive), similar to transformer charges per MVA capacity, such as Rs 20 lakh or so per

MVA. Therefore, those charges have been added. The net impact is negligible almost zero, we are going to receive the same O&M charges as before", he told investors in an analyst call. Speaking regarding Return on Equity (ROE), proposed norms suggest existing assets at 15.5 per cent and setting 15 per cent for new projects after April 1, 2024, he said discussions were on with the Central Electricity Regulatory Commission (ĆERČ) and power grid was optimistic that final norms won't adversely affect the company's revenue or profitability.

The company was aiming to cross capex of Rs 10,000 crore in the current fiscal. "Our capex in Q3, on a consolidated basis is Rs 3,444 crore, and for nine months it is Rs 7,690 crore. We are hopeful that this capex will be almost Rs 10,000 crore plus," he said. Power Grid's consolidated during income December 2023 quarter was Rs 11,820 crore. During the quarter, net profit rose 10

As many as 5,454 housing units were registered in January 2023 across the Hyderabad residential market, which includes four districts namely Hyderabad, Medchal-Malkajgiri, Rangareddy and Sangareddy. The data covers transactions of both primary (first sale) and secondary (resale) markets.

As per the data compiled by real estate consultant Knight Frank India, the total value of properties registered during January stood at Rs 3,279 crore, which is 24 per cent higher year-on-year, indicating a movement towards sale of higher value homes.

In January 2024, 47 per cent housing properties registrations were in the price range of Rs 25-50 lakhs.

INDIAN WOMEN ENTER MAIDEN FINAL

India kept alive hopes of winning a first-ever gold in Badminton Asia Team Championships after the women shuttlers progressed to their maiden final with a 3-2 win over two-time former champions Japan in a thrilling semifinal here on Saturday.

The world No. 23 pair of Treesa Jolly and Gayatri Gopichand, world No. 53 Ashmita Chaliha and 17-year-old Anmol Kharb registered stunning wins in the first doubles and second and deciding singles to take India through to the summit clash. India will face Thailand in the final on Sunday.

India had won two bronze medals in men's team event in the 2016 and 2020 editions.

Though Japan were without their world No. 4 Akane Yamaguchi, the world No. 7 pair of Yuki Fukushima and Sayaka Hirota and world No. 8 combination of Matsumoto and Wakana Nagahara, they were still a formidable side, making it tough for India.

Returning from a long injury layoff, Sindhu had enjoyed wins against China's Han Yue and Hong Kong's Lo Sin Yan Happy but she couldn't produce her best against the left-handed Aya Ohori, going down 13-21, 20-22 in the first

Tiger Woods withdraws from Riviera

Tiger Woods returned to the PGA Tour and lasted only 24 holes, withdrawing Friday from the Genesis Invitational with flulike symptoms and dehydration after hitting his tee shot on the seventh hole at Riviera.

Rob McNamara, his longtime associate and vice president of TGR Ventures, said Woods felt flu symptoms Thursday night that worsened when he woke

up. "He had a little bit of a fever and was better during the warm-up, but then when he got out there and was walking and playing, he started feeling dizzy," McNamara told a PGA Tour official. "Ultimately, the saying he potentially some type of flu and that he was dehydrated. He's been treated with an IV bag and he's doing much, much better, and he'll be released on his own here soon." Woods left Riviera about two hours after he withdrew, sitting in the front seat of a red SUV as it departed.

He was 1-over par for the round — 2 over for the tournament — and projected just outside the cut when he asked for a cart and was driven off the course by a rules official. He has been walking slowly and looked drained of energy playing the front nine.

"He obviously wasn't himself, just didn't look right. Saw that before the round started," said Gary Woodland, who played in the same group with Woods along with Justin Thomas. "Obviously, everything's better with him there and for him for his first tournament back and he couldn't come out and finish the way he wanted to, that sucks for all of us."

Woodland said he noticed Woods being quieter than normal, though they all were



cut. "I feel bad for him. He wasn't right," Woodland said. "He definitely was trying to fight through it and I hope he's all right."

The 48-year-old Woods still managed to create quite a spectacle at Riviera.

An ambulance and a ladder truck from the Los Angeles Fire Department were parked outside the clubhouse, presumably waiting for Woods. PGA Tour officials said IV fluid bags were needed and there were none at Riviera, so the paramedics had to deliver them.

Photographers and media crowded near the ambulance next to a 6-foot high hedge raised cameras and mobile phones when there was movement, except the trucks were leaving without Woods. On the golf course, there was a steady stream of spectators headed for the exit. Woodland and Thomas approached the ninth green surrounded by only a few hundred fans.

Woods had not played an official event since the Masters last April, withdrawing in the

trying to make sure they were middle of the rain-delayed unofficial Hero World Challenge in December against a 20-man field with no cut, and 36-hole Championship with his son, Charlie.

Woods now has played six official tournaments since returning from a February 2021 car crash in Los Angeles that shattered bones in his right leg. He has pulled out of three of them - the 2022 PGA Championship after 54 holes, the 2023 Masters when he didn't return Sunday morning to complete the third round. Woods had said he hoped to play one tournament a month through the major season. He had said Thursday he was experiencing back spasms, which led to his shank on the final hole when he started the

tournament with a 72. Along with playing, Woods is the tournament host of the Genesis Invitational that is run by his TGR foundation.

His week in Los Angeles began with plenty of hype - the launch of his new apparel line with TaylorMade Golf and his first PGA Tour start of the year.

YASHASVI ROCKS ENGLAND, INDIA IN CONTROL Ashwin out of 3rd Test as mother ill

ashasvi Jaiswal's dream season just got better as he singlehandedly seized the initiative from England with a sizzling century, putting India in complete control at the end of third day's play in the third Test. Jaiswal's (104 retired hurt off 133 balls) second ton of the was beautifully complemented by Shubman Gill (65 batting, 120 balls), who curbed his natural aggression as India ended the day at 196 for 2 in 51 available overs.

The left-handed opener, who will be torch-bearer of Indian batting for the next decade, scored his third Test hundred in only seventh Test appearance before the blazing blade was brought to a halt by back spasms that forced him to

The Jaiswal-Gill pair added 155 runs in quick time with the former giving the English team a test of its own medicine with nine fours and five sixes, the best being the imperious pull off Jimmy Anderson.

The overall lead swelled to 322 by stumps, after Indian bowlers made a splendid comeback, getting last five England wickets for only 29 runs with visitors being bowled out for 319.

Mohammed Siraj (4/84 in 21.1 overs) was brilliant with his yorkers to tail-enders while Kuldeep Yadav (2/77 in 18 overs) compensated brilliantly for Ravichandran Ashwin's unfortunate withdrawal with two quick wickets in the morning session.



However it was Joe Root's indiscreet reverse ramp off Jasprit Bumrah which Jaiswal pouched with less than a second's reaction time that turned the tables.

"That shot was not on and it became a turning point," Siraj said at post-match press conference.

Rohit Sharma's captaincy was spot-on and the manner in which he tweaked Jasprit Bumrah's field position at longon to get Ben Stokes dismissed off Ravindra Jadeja (2/51) spoke volumes about his

On Sunday, India would be

looking to take a lead of at least 425 if not 450 and have at least 125 overs to bowl out England. With no Ashwin available, India would need a cushion of more overs on a deck that is still good for batting.

JAISWAL JAZZ: Jaiswal's onslaught continued despite England frenetically changing their bowling and fielding plans but none worked enough to stop the Indian opener. Having spotted a vacant offside field, Jaiswal brought out two reverse sweeps off Rehan Ahmed for fours.

However, his charge was halted only after England brought

back Mark Wood for a shortball ploy yet again in the game

with a packed leg side field. Unfazed with England's deployments, Jaiswal dealt in singles once into his 90s and brought up his third century of fledgling career with a four off

Wood. However, the left-handed opener had to retired hurt close to the end of the play for being unable to deal with back

Jaiswal not only took the wind out of England's aspirations but also consolidated India's grip on the contest, having lost Rohit Sharma (19) cheaply in the second session.

At the other end, Gill put behind the disappointment of the first-innings duck with a fifth half-century, countering England's ploy of a packed onside field with up to six fielders placed and Wood bowling into his body.

India's task was to preserve wickets and build their lead, given the amount of time left in the game and surface here being benign so far.

Additionally, Rohit's early dismissal with their overall lead not being big enough would have provided some concerns but all that was banished by the pair of Jaiswal and Gill with their unbeaten 155-run stand for the second

RIPPER: Kuldeep, who was hit for plenty by Ben Duckett on second day, found his mojo, bowling splendidly through the first session of the day which kept a leash on England, while also accounting for Jonny Bairstow with an unplayable delivery.

Bairstow moved deep into the crease but was pinned in front of the wickets with one that turned sharply into him from outside the off.

Bumrah then accounted for Root (18) for the ninth time in 21 innings, as former skipper's shocking dismissal - a reverse ramp to second slip - once again exposed the bizarreness of the ultra aggressive approach.

Having struggled to score freely in the first session, England resorted to go all-out post lunch but the ploy backfired horrendously.

Jadeja had Stokes (41) caught by Bumrah who was placed a bit straighter at long-on, forcing the batter to adjust his stroke. Jadeja also had Tom Hartley stumped for his second wicket

For Ben Foakes, a delivery from Siraj slowed a little bit off the surface for an easy grab for Rohit at mid-on.

The India pacer wasted no time in cleaning up tail-enders Ahmed and Anderson to bring up a four-for, with England rolling over for 319 from 290/5

necessary assistance to Ashwin and will keep the lines of communication open to offer support as needed. Team India appreciates the understanding and empathy of the fans and media during this sensitive period."

India will play the remainder of the third Test with 10 men and four specialist bowlers. It is understood that Ashwin might not be available for the remaining two Test matches in Ranchi (Feb 25-29) and Dharamsala (March 7-11).

FARMERS' AGITATION



Shooters sweat over Olympic selection trials in Patiala

national Olympic trials later this month in Patiala in the wake of the farmers' agitation and the restrictions imposed on interstate travel.

The National Rifle Association of India (NRAI) has convened two meetings but they have not yet altered the venue or the dates for the third selection trials because of several issues, including a "packed calendar" the impending "announcement of the general elections". The scores in the selection trials, to be held at the Moti Bagh Gun Club Ranges in Patiala from February 25 to March 2, "will be considered for selection of teams for Paris Olympic Games", an NRAI statement had said on January 22. Several shotgun shooters PTI spoke to said carrying arms and ammunition by road will be a nightmare. Besides, airfares to Chandigarh have gone through the roof because borders have been sealed due to the farmers' agitation.

NRAI secretary-general Sultan Singh when asked if the federation will be able to organise the trials in Patiala given the circumstances said, That is a very difficult question. But do we have an option, considering the (shooting) calendar, elections...
I'm running against the wall." On whether the trials could be

shifted to the Jagatpura range in Jaipur or the Karni Singh range in Delhi, he said the Tughlakabad range would be an issue because of the upcoming Para Shooting World Cup from March 6-15. The Para Shooting World Cup at the Karni Singh Ranges has 24 Paris Paralympic quota places up for grabs and 500 shooters from 52 countries are competing.

"If I shift it (trials) anywhere else, then the northern people have a problem going to south (India) and south people have problem going to north India). Shooters in Chandigarh will then ask, 'how do we reach Jaipur," said Singh.

"Besides, when the NRAI talks about shooters from the south, that is only a miniscule number and they also mostly reside and train in Delhi. Most of the shotgun shooters are from Delhi and adjoining areas. So where is the problem to shift the venue," he said.

Another shooter said, the code of conduct that might come into force once the general elections are announced does not apply to sports shooters. "We are exempted fro are exempted from depositing our weapons we use

for sports purposes. I have never heard of shooting sports activity getting affected due the code of conduct," he added. A trap shooter added that the

Para World Cup commences on March 6 at the Karni Singh range here, while the Olympic selection trials conclude in Patiala on March 2.

'Why can't we have the trials in Delhi itself where there are far better lodging and boarding facilities and our trials will end much before the Para World Cup begins," he said.

In addition, people with chronic conditions such as diabetes, HIV, or asthma are also at increased risk The elderly are also more likely to develop fungal infections, as are young children and infants. In some cases, fungal infections can spread from person to person, particularly in healthcare settings. In addition, extreme weather events such as hurricanes and floods can create conditions that are ideal for fungal growth and spread.

Take the case of Athlete's Foot, caused by the fungus Trichophyton. It typically manifests as itchy, red, and cracked skin between the toes and on the soles of the feet, says Dr Richa Chaudhary, Consultant Dermatologist, Skin & Hair by Dr Gangwani Clinic, Paschim Vihar, Delhi. "Superficial fungal

infections, often affecting the skin, hair, and nails, are common yet manageable dermatological conditions. 'Athlete's foot is a prevalent and contagious condition, scientifically termed tinea pedis, primarily targets the feet. It thrives in warm and damp environments such as locker rooms, swimming pools, common showers.

"The hallmark symptoms of athlete's foot encompass itching, burning sensations, and the development of red, scaly patches between the toes or on the soles. In severe cases, there can be cracking of skin or appearance of itchy pusfilled blisters, delay in the healing of the cracked skin leading to discomfort and pain. The infection can also spread to the toenails, causing thickening and discoloration.

"Maintaining proper foot steroids for long durations hygiene/avoiding shared personal items, such as other towels and shoes, regularly moisture-wicking materials, and allowing shoes to air out between uses significantly reduce risk of contracting the fungus," says the doctor.

In extreme cases, persistent or severe infection it is essential to seek professional medical advice

CHILDHOOD CANCER EARLY DETECTION IS KEY

Childhood cancer, while crare (affecting about 50,000 children in India annually), requires specialized, multidisciplinary approach to achieve both good cancer outcomes and a high quality of life. There are some misconceptions when it comes to cancers in children versus cancer in adults. It is important to understand that childhood cancer is unique and quite different in behaviour and response to treatment. Their cancers respond well to treatment and when diagnosed early are highly curable. Conditions like Acute Lymphoblastic leukaemia and lymphomas have excellent cure rates.

No doubt, in a world where children are bombarded with advertisements promoting unhealthy foods, the WHO-UNICEF toolkit stands as a beacon of hope. Crafted through a collaborative effort between the World Health Organization (WHO) and the United Nations Children's Fund (UNICEF), this toolkit represents a concerted effort to protect the health and wellbeing of the youngest members of our society.

The document suggests practical strategies and evidence-based recommendations, providing a roadmap for enacting meaningful change. These enacting policies are not merely

According to a recent study, obesity affects 380 million children and adolescents worldwide. Low and middleincome countries are the most affected worldwide. If current trends persist, India will contribute approximately 11% of the global burden of child obesity by 2030. India faces a triple burden of malnutrition, wasting, micronutrient deficiencies along with an increase in childhood overweight and The latest National Family

Health Survey (NFHS-5, conducted in 2019-21), found that 3.4% of children under five are now overweight compared with 2.1% in 2015-The numbers may seem small,

Can Iran control its proxy Houthis?

Amid escalating tensions in West Asia, the dynamics between Iran, Houthis, and international powers have profound implications. As conflicts rage from Gaza to Yemen, the interplay of geopolitical interests, regional alliances, and economic stakes underscores the complexities of the situation and its far-reaching consequences

Since the war in Gaza has escalated, Houthis are retaliating by burning and commercial shipments connecting Europe and Asia in the Indian Ocean. Houthis have asserted that their response sends a clear message: Palestinians are not alone, and they will take revenge on Israel. At the same time, the Western world, led by the United States and supported by twenty other countries, has sent a stern warning to Houthis and Iran, saying that blocking, attacking, and burning commercial ships violates international laws and adversely affects the economies of Asia and Europe. The US' reaction is also about preserving its prestige as the global police, which has been declining over the past decade. However, its unconditional support for Israel's actions in Gaza, in response to Hamas's terrorist activity on October 7

last year, has yielded little officially acknowledges that Gaza has been devastated, resulting in the death of thousands of Palestinians, mostly women and children. Israeli actions have failed to achieve their central objective of destroying Hamas as a terrorist organisation. However, the transformation of Gaza into a battleground has brought shame upon humanity. The recent declaration at the International Court of Justice has further embarrassed American leadership and its continual support of Israel. The US' frequent use of veto power has rendered the UN Security Council's status irrelevant. The pursuit of peace and security seems distant, especially with the from taking sides. ongoing Russian invasion of Ukraine overshadowing it. Israel's relentless actions in further have undermined the legitimacy of

the United Nations. The

American leadership bears



The military actions against the Houthis carry multiple implications, with the most prominent being perceived as the United States and Israel's confrontation with Iran. For Iranians, proxies such as Hezbollah, and Hamas, Houthis across the Arab world symbolise an axis of resistance and represent a deeply ingrained belief that any coercive structure will face retaliation, framing it as a battle against "oppressors." the crisis, India's engagement with Iran and China's official request for Iran to restrain the Houthis signify more than just a clash between the US, Israel, Iran, and Russia. The global economy and the disruptions to the supply chain, amid conflicts ranging from Ukraine to Gaza, have significant implications for countries that have refrained

The brief summary of Houthis' actions in the Gulf of Aden has been both impactful and exasperating. The ongoing crossfire has failed to dissuade Houthis, despite Yemen enduring a decade-

long civil war since the Arab uprising, resulting in the loss of millions of lives. While last year's reconciliation between Saudis and Iranians temporarily curbed Houthi aggression, their recent actions carry far-reaching repercussions, posing threats to the national interests and security of numerous countries.

The larger question now remains: can Iran stop the Houthis, and will they heed Tehran's calls? The fact is, Houthi actions have been perceived collectively as İranian manoeuvers using proxies against the US and Israel. The decline of US power in the region and the rise of Iranian proxies have emboldened Iran to pursue its goals. The strategic planning behind Hamas's actions on October 7 suggests that Tehran and Iran's de facto leader, Khamenei, discontented with Abraham Accords and the normalisation between Israel and Arab countries. The Palestinian pretext has played into Iran's hands. Iran now asserts itself as more powerful and accepted by the larger

Arab world, which similarly

attacks go beyond the traditional calculus of Iranian proxy actions against the US. The crisis runs much deeper than the typical narrative suggesting that Iran controls similarly to Hezbollah and even Hamas. The relationship between Iran and Houthis is complex and thorough reevaluation of both parties. Iran has two centres of power, with a theocratic regime under Ayatollah Khamenei wielding more influence than President Raisi. The Iranian Revolutionary Guards, which train and oversee proxies, operate primarily under authority. Khamenei's Similarly, Houthis function more as strategic allies than conventional proxies. While Iranian proxies supervised, supported, and influenced by Khamenei's IRGC. Houthis pursue agendas beyond Tehran's control, including those beyond Khamenei's influence. It is undeniable that Houthis have received support from Iran and the IRGC, but their dependence on them is less significant compared to

opposes

normalization.

However, the recent Houthi

Hamas and Hezbollah Houthis are the product of civil wars and cycles of violence, positioning themselves as rulers of a divided Yemen. Their response extends beyond Israel's actions in Gaza; the more the US-led axis bombs Sana'a, the more Houthis will grow like a phoenix. They have three major objectives, some aligned with Iran and some differing. With the ongoing horror inflicted by Israel in Gaza and US-led actions in Yemen, Houthis are gaining legitimacy in the region and beyond, attracting radicalised new recruits and sending a message to the larger Arab world that their cause is a holy war. Secondly, Houthis seek official recognition akin to the Taliban in Afghanistan; their belligerence has garnered global attention, and any move towards normalisation will likely occur through dialogue, similar to the Doha Agreement, which would grant them political legitimacy. Despite the peace agreement brokered by China with Saudi Arabia, Houthis have ceased firing missiles into Saudi territory, and Saudi efforts to defeat them have been unsuccessful. However, the Tehran-Houthi alliance transcends mere Shia narratives, despite historical and ideological ties with Iran. Houthis aspire to establish a civil state rather than adhere to a theocratic regime, and they are open to integrating Yemen's Sunni population. Additionally, Houthis' war economy does not solely rely on Tehran for economic support, contrary to popular belief. Instead, it thrives on various illicit activities in the Bab-el-Mandeb including ransom, looting, and the mobilisation of oil money, amounting to an estimated \$2 billion. The Houthis' strategic partnership with Iran serves Iran's chokepoint strategy to sustain its economy, with Iran controlling the Persian Gulf and utilising the Bab-el-Mandeb route to supply arms to Hamas and support Houthis' control over the area. However, beyond this arrangement, the Houthis sustain themselves through their own means, including potential arms supplies from North Korea. Lastly, Houthis

Houthis have claimed that they only target ships flagged by the US and its allies, but the international commercial industry is more intricate and risky. These risks translate increased including higher insurance premiums for commercial ships. Moreover, many shipping companies do not fly flags of specific countries, undermining the distinctions Houthis have been claiming. The world is unprepared for an alternative route due to the costs involved. particularly as economies are already strained by the conflict in Ukraine. India and China have approached Tehran to rein in Houthis, whose actions disrupt trade between Europe and Asia, accounting for over 40 per cent of global trade. The stakes of the situation are greater than they may initially appear, and while Tehran stands to gain strategically, it cannot risk disrupting its relations with China, India, and beyond. The challenge lies with the centres of power in Tehran, which have tended to prioritise ideology over pragmatism in foreign policy decisions. Ultimately, the decision rests with Khamenei as to how far Houthis will be allowed to proceed and whether they will acquiesce on all fronts. Responses may Houthis may temporarily halt their actions but are unlikely to cease until they achieve their objectives, which align with those of Iran but are more akin to a strategic partnership than a mere proxy relationship. 









