This plan includes organising free travel to Ayodhya, distributing akshat (sacred rice) to households to invite them to the holy town, and arranging booth-level programmes to connect with new voters. During the meeting, the akshat distribution programme and the arrangement for taking people to Ayodhya post the consecration event were also reviewed.

Volunteers of the RSS and its affiliates embarked on a 15-

day nationwide door-to-door public outreach programme Monday, encouraging people join consecration ceremony at the Ram temple in Ayodhya by offering prayers at temples in their neighborhoods.

"The BJP leadership has given a clear message that workers across all booths must provide all required assistance to those who want to visit the Ram temple," another BJP leader said, adding, "BJP workers have been instructed to celebrate January 22 like

Diwali. The party has instructed the Union Railway Minister to ensure the smooth travel of 35 trains to and from Ayodhya. He has also been asked to ensure that 430 places are connected to Ayodhya from across the map of India.

With an impending crisis looming large over essential commodities due to a nationwide truckers' strike against the new criminal code, which mandates that hit-and-run cases by truck or commercial drivers can attract up to 10 years in jail and a fine of ₹7 lakh, the Centre initiated talks with truckers' associations on Tuesday.

Sources indicated that the Government appealed to transporters to resume their services immediately, and the transporters have agreed. "We had a discussion with representatives of the All India Motor Transport Congress. The government wants to clarify that the new rule has not been implemented yet. We want to state that, before implementing Bharatiya Nyaya Sanhita 106/2, we will Bharatiya have a discussion with representatives, and only then will we take a decision," said Union Home Secretary Ajay Bhalla in a statement

after the meeting. It was reported that the pan-India All India Motor Transport Congress has not vet issued a nationwide strike call in support of the demand seeking the withdrawal of the

Various truckers' associations have raised concerns about of the hefty legitimacy Alongside cab penalty. drivers and commercial vehicle operators, they are questioning how they would manage to pay such a substantial fine in the event of an accident. The Congress has expressed

support for the truckers' protest against the stricter punishments for hit-andrun cases. They argue that the potential misuse of the legislation could lead to an "extortionist network" and "organised corruption."

A Central Government official dismissed the new provisions. Protests were concerns of protesting held in many States on the truckers as "misrepresented" concerns of protesting

and clarified the provisions regarding hit-and-run cases would apply solely to drivers attempting to escape after an accident without informing

the police. Addressing these concerns, a senior government functionary stated that a driver who accidentally hits a person and promptly informs the police or takes the victim to the nearest hospital would not be prosecuted under the stringent provisions of the recently enacted Bharatiya Nyaya Sanhita (BNS).

In Patna, tires were set ablaze, and roads were blocked as truck operators voiced their opposition to the new law. They questioned who would provide for their families if they were to stay in jail for 10

### **Privileges panel** to examine MPs suspension

 $T^{\text{he Privileges Committee of the}}_{\text{Lok Sabha will convene next}}$ week to examine the suspension of House during the Winter Session due to unruly behaviour. Chaired by BJP member Sunil Kumar Singh, the Committee will meet on January 12 to record oral evidence from the suspended Congress members - K Jayakumar, Abdul Khaleque, and Vijayakumar Vijay Vasanth. They were suspended for creating "grave disorder in the House" on December 18.

During the Winter Session of Parliament, 100 Lok Sabha members from the Opposition were suspended for bringing placards and raising slogans, demanding a statement from Home Minister Amit Shah regarding the breach of Parliament

security. 97 members suspended for the remainder of the Winter Session, the case of Singh, Khaleque, and Vijayakumar who had reached the presiding officer's chair - was referred to the Privileges Committee. The suspension of these three members will continue until the Committee submits its report to the Lok Sabha Speaker.

In the Rajya Sabha, 46 members were suspended during the Winter Session, including 11 members whose case was referred to the Privileges Committee. The panel, chaired by Deputy Chairman Harivansh, is yet to convene a examine the suspension of the 11 members referred to it. Opposition members Jebi Mather Hisham, L Hanumanthaiah, Neeraj Dangi, Rajmani Patel, Kumar Ketkar, G C Chandrashekhar (all Congress); Binoy Viswam and Sandosh Kumar P. (both CPI), M Mohamed Abdulla (DMK), John Brittas and A A Rahim (both CPI-M) were suspended till the House "has the benefit of the Report of the Committee of Privilege"

TMC Rajya Sabha member Derek O'Brien said the Centre wants Opposition members to behave like BJP MPs Ramesh Bidhuri and Brij Bhushan Sharan Singh — both of whom are facing allegations of misconduct — as 14 Opposition MPs continue to remain suspended from Parliament.

## Release caste survey details for public scrutiny, SC asks Bihar

The Supreme Court on Tuesday asked the Bihar Government to put in the public domain the break-up of the caste survey data to enable those aggrieved to challenge the findings.

A bench of Justices Sanjiv Khanna and Dipankar Datta refused to grant any interim relief to the petitioners who have challenged the caste survey and the Patna High Court order upholding the Bihar Government's decision to conduct such an exercise.

'There is no question of interim relief as they (the government) have a high court order in their favour. Now that the data has been put in public domain, there are two-three aspects which remain. First is the legal issue, correctness of the high court judgment and legality of such an

exercise," the bench said Senior advocate Raju Ramachandaran, appearing for the petitioners, said since the survey data is out, the authorities have started implementing it in the interim and raised the reservation for SCs, STs, Other Backward Classes, Extremely Backward Classes, and Economically Weaker Sections (EWS) to a total of 75 per cent from the existing 50 per cent. The bench said this issue needs to be heard at length.

"As far as increasing the reservation is concerned, you have to challenge it before the high court," the bench told Ramachandaran, who said it has already been contested before the high court. Ramachandaran said the issue is important, and since the State is acting upon matter be listed next week so that the petitioners can argue for interim relief. What interim relief? They (the Bihar government) have a high court judgement in their favour," the SC said. Senior advocate Shyam Divan, appearing for the Bihar Government, said the data, including the break-up, has been put in the public domain and anyone can see it on the designated website.

Justice Khanna said, "What I am more worried about is the availability of break-up of data. To what extent the government can withhold the data. You see, the entire break-up of data should be in the public domain so that anyone can challenge the inference drawn from it. Unless it is in the public domain, they cannot challenge it.'

The BJP, the main Opposition party in Bihar, has accused the Nitish Kumar Government of irregularities in conducting the caste survey and called

the data collected "fake' The bench then asked Divan to file a report on the caste survey and posted the matter for further hearing on February 5. On October 6, 2023, the top court had questioned the Bihar Government as to why it published its caste survey data. It had, however, refused to restrain the state government from making public further data, and said it may examine if the State has the power to conduct such an exercise.

## Chilling trends in Delhi, day temperature plunges

 $D_{\text{on Tuesday morning as the}}^{\text{elhi woke up to chilly weather}}$ maximum temperature consistently dropped below the season's normal due to icy northwesterly winds sweeping through the city, resulting in cold day conditions in Delhi.

The maximum temperature settled at 17 degrees Celsius, two notches below the normal, while the minimum temperature at the Safdarjung observatory was recorded at 10.1 degrees Celsius on Tuesday. The Ridge area in Delhi experienced a temperature of 8.4 degrees Celsius, Palam at 8.2 degrees Celsius, Lodhi Road at 9.2 degrees Celsius, and Mayur

Vihar at 10.3 degrees Celsius. According to the India Meteorological Department, a cyclonic circulation over northwest UP and Haryana is causing alternating waves of warm and cold winds to blow into Delhi. The visibility dipped to 500 metres at Safdarjung in the morning, as reported by the IMD. The 24-hour average Air Quality Index (AQI) stood at 340 at 4 pm. According to IMD officials, a cyclonic circulation northwest Uttar Pradesh (UP) and Haryana is causing alternate waves of warm and cold winds to blow towards Delhi. There are no signs of the prevailing cold wave loosening its grip on the national

wave conditions will persist and may even extend to some parts of central India between January 5

'The minimum temperatures are in the range of 6-9 degrees Celsius over most parts of Punjab, Haryana, Chandigarh, Delhi, West Uttar Pradesh, and Rajasthan, and in the range of 10-12 degrees Celsius over north Pradesh, Madhya Bihar, Jharkhand, West Bengal, Sikkim, and north Chhattisgarh. These temperatures are above normal by 2-4 degrees Celsius over many parts of Punjab, Haryana, Chandigarh, Delhi, Madhya Pradesh, Chhattisgarh, and Pradesh, Chhattisgarh Gujarat," the IMD stated. Fog conditions were observed at

Uttarakhand, Rajasthan, and Madhya Pradesh. Dense fog was reported in isolated pockets of Punjab, and moderate fog in isolated pockets of Haryana, Sub-Himalayan West Bengal, and Sikkim," read a post on the IMD's official handle on X. "Visibility at 8.30 am in Varanasi was 25, Jhansi 200, Pantnagar 25,

8.30 am, with very dense fog in

isolated pockets of Uttar Pradesh,

### Milk supplies badly hit in Mumbai as truckers strike enters second day



Mumbaikars began to feel the pinch of the truckers' flash strike against the new penal law on hit-and-run road mishaps on Tuesday, as large sections of them went without milk after thousands of trucks carrying chilled milk failed to reach the metropolis from different parts of Maharashtra and neighbouring states like Gujarat and Madhya Pradesh. As the strike entered the second day, lakhs of Mumbaikars had to make do without their morning cup of coffee, while children went without their daily share of milk after the retailers either failed to deliver the creamy milk or deliv-

ered it long after 10 am. Mumbai receives chilled milk supplies in insulated tankers from districts like Satara, Sangli, Kolhapur and Nashik in Maharashtra, Indore and, Dewas from Madhya Pradesh and Anand, Banaskantha, Surat and Mehsana from

Mumbai receives around 50 to 60 lakh litres of chilled milk per day, of which 60 percent s cow milk and the rest is buffalo milk."The milk distribution in Mumbai was affected today as thousands of Mumbai-bound trucks are either stranded midway or have not picked up the milk

consignment for the point of origin ," Chandan Hausilasingh Singh of the Mumbai Milk Producers Association (MMPA) said. Apart from chilled milk, Mumbaikars consume another 4 lakh litres of fresh buffalo milk, which is more expensive and creamier. Most people prefer cow milk t0 buffalo milk because it is cheaper. According to Chandan Singh, each of the insulated milk-tankers has a capacity of transporting 20 tonnes of milk to its destinations, from where it is unloaded into mini-tankers with a capacity of two-three tonnes for dis-

## Will penalise States if MGNREGA workers not linked to ABPS: Minister

Union Rural Development Minister Giriraj Singh on Tuesday slammed the Congress for its criticism of making Aadhaar mandatory for payments under MGN REGA, and said "we will penalise states not workers" if they are not yet linked with the Aadhaar-Based Payment System (ABPS). A day after the ABPS was

made mandatory for the rural scheme, Singh said several deadlines were given for linking. He also dismissed former rural development minister Jairam Ramesh's allegations that the union government is "weaponizing technology", especially the Aadhaar against the poor.

The ABPS has been made mandatory to ensure transparency, the minister said. According to data provided by the Rural Development Ministry, as on January 2 there are around 14.32 crore active workers under the MGNREGS of whom 14.08 crore (98.31 per cent) have been Aadhaar-seeded.

he Federation of Resident Doctors Association (FORDA), a medical association in the country, has drawn the Government's attention to the acute shortage of regular faculty members in medical colleges and health institutions and has urged it to take steps to fill the posts with regular faculty members instead of banking on the contractual and adhoc staff. In a meeting with Union Health Minister Mansukh Mandaviya on the FORDA pointed out that there has been a significant shortage of vacancies for regular posts in key clinical branches such as orthopaedics, medicine, and surgery.

These positions are typically filled through the Union Public Service Commission (UPSC) process. Alarmingly, this shortage has been ongoing for up to

four years, they said. Earlier in a letter to the Minister, they flagged concern that as a result of the persistent shortage of regular faculty members, medical institutions have increasingly turned to contractual and ad hoc recruitment practices.

## **UGC** launches Annual **Capacity Building** Plan for employees

The University Grants Commission (UGC) has become the first autonomous organisation to have launched an annual capacity building plan after the Centre established the Capacity Building Commission in 2021, according to officials. The annual capacity building plan (ACBP) was officially

launched on Tuesday by UGC chairman M Jagadesh Kumar in the presence of R HR, Capacity Building Commission.

"UGC is the first autonomous organisation to have initiated planning for the capacity building of its employees in collaboration with CBC. The ACBP is a comprehensive plan outlining interventions essential for enhancing individual officials' competencies and the overall capacity of UGC.

"The plan is derived from a robust capacity need assessment exercise that was done with UGC officials and staff over a period of six months starting from March, 2023," Kumar said.

The UGC chief explained that



the idea is to build, develop and enhance the abilities, talents, competencies, efficiency and ees to increase their capacity to serve the higher education system in India. Through the initiative, UGC employees will be trained in four key areas behavioral, functional, domain and technology competencies. Behavioral competencies will help the UGC staff take up bigger roles than what they normally perform. Functional competencies will help the UGC staff perform better in administration, procurement and financial management. Enhancing domain competencies help them perform better in specialised fields such as policy making or project management.

### Woman employees can now nominate their children for pension in precedence over husband: Centre

woman employee can now Anominate her child or children for family pension in precedence over her husband in case of marital discord, the

Centre said on Tuesday. Rule 50 of the Central Civil Services (Pension) Rules, 2021 allows the grant of family pension following the death of a government servant or retired government servant.

If a deceased government servant or pensioner is survived by a spouse, family pension is first granted to the spouse. Other family members become eligible for family pension, on their turn, only after the spouse of the deceased government servant/pensioner becomes ineligible for family pension or dies, according to the rules. The Department of Pension and Pensioners' Welfare (DoPPW) has now amended the rules and allowed a woman

employee to nominate her child/children over her husband for the family pension. The amendment allows disbursement of family pension of a female government servant to an eligible child in precedence to her husband, in all cases where she has filed a divorce petition or a petition under the Protection of Women from Domestic Violence Act or cases under Indian Penal Code, DoPPW Secretary V Srinivas

Vote pooling and swapping were the strategies effectively utilized by the anti-BJP forces in Punjab, HP, Telangana and Karnataka. "The unprecedented influx of certain disgruntled leaders from these parties to the BJP camp speaks a lot about the setback suffered by the latter in these elections. It was an act of subversion," said Sebastian.

He said that the BJP leadership wholeheartedly welcomed these persons. Prof Sebastian pointed out

with facts and figures the vote pooling by AAP, Third Front and the Left to the Congress that led to the BJP's debacle. "Many Congress leaders infiltrated into the BJP after the 2019 Lok Sabha polls. They succeeded in getting assembly seats at the cost of long-time workers of the BJP and this led to resentment among BJP activists. The party hoppers succeeded in creating sabotage from inside," said Sebastian.

Saxena, who has already adopted five villages — Qutabgarh, Jaunti, Daurala, Rawta and Nizampur — said, all villages will be developed on the similar lines by the DDA with the help of Rs 800 crore transferred to the agency recently.



₹480 crore of Village Development fund that has already been sanctioned for carrying out development works in 180 villages.

Saxena exhorted the villagers to identify the specific problems concerning their villagers and the tentative solutions so that they could be incorporated while finalizing the plan of action for each village. Saxena announced that he will

be staying overnight in identified villages of the City to get a first-hand account of the problems faced by the residence there.

Starting this month, District Magistrates will also visit and stay in the identified villages, hold consultations with the villagers and accordingly finalize the development works in the villages. This, he said, is in line with the dictum of 'Government Doorsteps".

While interacting with him, a number of village representatives rued that despite a lapse of several decades, their villages lacked even basic amenities like sewer network, roads, parks, schools, hospitals and clean drinking water among others. ## ED conducts fresh searches in money laundering case against Amanatullah

 $T_{\begin{array}{c} \text{Directorate (ED) on} \\ \text{Tuesday undertook fresh} \end{array}}$ searches at about four-five premises in the national Capital as part of a money laundering probe against AAP MLA Amanatullah Khan lipled to allers discontinuous and the allers discontin linked to alleged irregularities in recruitment of staff for the Delhi Waqf Board, official sources said.

The raids are being carried out under the provisions of the Prevention of Money Laundering Act (PMLA), the sources said. About four-five premises are being covered by the ED officials, they said.

The agency had in October raided the premises of the 49year-old legislator who represents the Okhla constituency in the Delhi assembly. It had also arrested three of his alleged associates in this case in November.

The ED had alleged that Khan acquired "huge proceeds of crime" in cash from illegal recruitment of staff in the Delhi Waqf Board and invested these for purchasing



of his associates.

'The searches (in October) were conducted in the case related to illegal recruitment of staff in Delhi Waqf Board and illegal personal gains by way of unfairly leasing out of Waqf Board properties during the chairmanship of the board by Amantullah Khan during 2018-2022," the agency had claimed in a statement.

It said a CBI FIR and three Delhi Police complaints formed the basis of the ED action against the Aam Aadmi Party (AAP) MLA. Khan, the ED said, "acquired

## City Government to create industrial hub at Rani Khera

n a move to promote industry, the Arvind Kejriwal Government is planning to create an industrial hub on 147 acres of land in Rani Khera in the national capital. Delhi Chief Minister Arvind Kejriwal on Tuesday gave his assent to this proposal. After receiving approval from the Chief Minister, the file has now been sent to the Lieutenant Governor. Upon receiving approval from the LG, further action will com-

The land for the industrial hub is being acquired from the Delhi Development Authority (DDA). This industrial hub will be entirely eco-friendly. Service industries like IT, (Information Technology Enabled Services),

and research will be established here. It is expected that there will be several clusters where multilevel buildings will be constructed. According to a press state-

ment, issued by the AAP government, the government will provide land at concessional



rates for setting up industries, and upon its development, this place could provide direct and indirect employment to thousands of people.

The responsibility for developing the new industrial hub in Rani Khera has been entrusted to the Delhi State Industrial and Infrastructure Development Corporation (DSIIDC) by the Delhi government. The government says that all modern amenities will be made available in this industrial hub. During its development, attention will be paid to all fundamental aspects. Both people from Delhi and outside will be able to acquire land at concessional rates for setting up industries here. Since it will be an entirely environmentfriendly industrial centre, land allocation will prioritize industries that do not cause any pollution. Therefore, this place will promote industries largely associated with the service sector," the AAP government said.

The industrial hub in Rani Khera will cater to the needs of service industries like IT, ITES, and research. The aim of developing the industrial hub is to promote business and transform Delhi into a manufacturing centre. Industries to be set up in the industrial hub will have to strictly adhere to pollution standards. Its development will be done in two phases. A smart integrated IT park will be developed here, comprising several building blocks that will be entirely pollutionfree. Industries such as IT, ITES, media, biotechnology, research, and innovation hubs will be established here. Approving the proposal, Kejriwal has emphasized completing the development of the industrial hub within the set time frame, directing the departments concerned to take necessary measures.

## 24 lakh liquor bottles sold on New Year eve, 18 per cent more than last year

Delhi recorded sales of 24 lakh liquor bottles on New Year's Eve, registering a nearly 18 per cent on-year growth from the corresponding date in 2022.

According to official Excise department data, 3,99,60,509 (3.99 crore) liquor bottles were sold in December 2022 through a network of 520 shops. In December 2023, 4,97,80,240 (4.97 crore) bottles were sold from 635 vends.

According to the data, 24,00,726 (24 lakh) liquor bottles were sold on New Year's Eve (December 31) -- the highest single-day sales during December 2023. December 31, 2022, witnessed sales of 20,30,664 (20.30 lakh) bottles -- also the highest single-day sales figure for that month.

The second highest sales in December 2023 were recorded on Christmas Eve (December 24) when 19,42,717 (19.42 lakh) bottles were sold. On the same day in 2022, the data showed that 14,69,357 (14.69



lakh) bottles were sold.

The data also showed that 17,79,379 (17.79 lakh) liquor bottles were sold on December 30, 2023, against 14,66,353 (14.66 lakh) on the same day in

In 2023, the lowest sales were recorded on December 5 when 12,84,222 (12.84 lakh) bottles were sold against 13,81,531 (13.81 lakh) on the same day in

In 2022, the lowest sales were seen on December 4, with 9,03,835 (9.03 lakh) bottles sold. Sales of liquor bottles breached the 10-lakh every

### JNU rolls out online appraisal system for faculty members

awaharlal Nehru University has rolled out an online application system for filing of appraisal forms for its faculty members in a bid to ease out the process of promotions in the university, a varsity official said on Tuesday.

With this, JNU has become the first central university to adopt online Annual Performance Appraisal Report (APAR) in the country for its faculty members, the varsity claimed. "This system will benefit the teaching staff at the university by completely digitising the appraisal form submission system, and help in paperless record keeping and upkeep," a senior JNU official told PTI. "We have rolled out e-APAR as part of our digital initiatives," he added.

The Jawaharlal Nehru University Teachers' Association (JNUTA) has opposed the move saying that will make promotions "unnecessarily complicated" by adding a layer of "bureaucracy" to the process.

## Government grants permission to 32 more shops to operate 24 hours

Ament opportunities, along with enhancing economic activ ities within the national capital, Chief Minister Arvind Kejriwal on Tuesday granted permission for 32 more shops and commercial establishments to operate 24 hours. The Labour Department of Delhi government had proposed the plan to the Chief Minister regarding the operation of these establishments for 24 hours. These commercial establishments belong to the categories of commercial, retail trade or business, provision

stores. The government said that all these establishments must strictly adhere to the provisions and rules of the Delhi Shops and Establishments Act of 1954. The government will keep strict watch over them to ensure that no violation of the rules takes place. The proposal has now been sent to the Lieutenant Governor (LG) for final approval.

It further said that compliance with Sections 14, 15, and 16 of the Delhi Shops and



Establishments Act, 1954 is mandatory for these shops and commercial establishments. For instance, during summers, women employees will not be permitted to work in any establishment between 9 PM to 7 AM, and during winter between 8 PM to 8 AM. Shops must be open and closed within specified times, and violation of this might lead to the closure of the commercial establishment. An additional 15 minutes will be allowed to open the shop if customers are waiting. Different areas may have different timings for opening or closing shops, and owners will have to adhere to those timings. Under the Delhi Shops and

Establishments Act of 1954, the Delhi Labour Department received 52 applications to operate shops for 24 hours. The department thoroughly examined these applications and documents. Of these, 20 applications did not meet the requirements and were not considered. However, all 32 applications meeting the criteria were approved.

It is noteworthy that in the past few years, there has been a significant increase in the number of permissions granted for the operation of 24-hour shops and commercial establishments within Delhi. The Chief Minister periodically approves commercial establishments that meet the criteria. Now, approval has been granted for 32 more establishments, bringing the total to

## Rules of CAA to be notified much before Lok Sabha polls

Rules for the Citizenship (Amendment) Act of 2019 will be notified "much before" the announcement of the Lok Sabha elections, a senior Government functionary said

on Tuesday. Under the CAA brought in by the Narendra Modi government, Indian nationality will be granted to persecuted non-Muslim migrants -- Hindus, Sikhs, Jains, Buddhists, Parsis and Christians -- from Bangladesh, Pakistan and Afghanistan who had come to India till December 31, 2014. There were massive protests in some parts of the country after the CAA was passed by Parliament in December 2019 and received the presidential assent subsequently.

"We are going to issue the rules for the CAA soon. Once the rules are issued, the law can be implemented and those eligible can be granted Indian citizenship," the functionary said.

Delayed by more than four years, rules for the CAA are a must for its implementation. Asked whether the rules will be notified before the announcement of the next Lok Sabha elections that are likely to be held in April-May, the functionary said, "Yes, much before



"The rules are ready and the online portal is also in place and the entire process will be online. The applicants will have to declare the year when they entered India without travel documents. No document will be sought from the applicants," the functionary said.

On December 27, Union Home Minister Amit Shah had said that no one can stop the implementation of the CAA as it is the law of the land and accused West Bengal Chief Minister Mamata Banerjee of misleading people on the issue. Addressing a party meeting in Kolkata, Shah said it was the BJP's commitment to implement the

## India should deal with China on basis of realism: Jaishankar

External Affairs Minister S Jaishankar on Tuesday said India should deal with China on the basis of realism and not on romanticism of the Nehruvian era adding "the Modi government has been has been very much more and in conformity with a strain of realism, which originated from Sardar Patel."

India should engage with China with mutual respect, sensitivity, and interest and the approach should be grounded on realism, he said touching upon the difference in opinion between India's first Home Minister and Deputy Prime Minister Sardar Vallabhai Patel and then Prime Minister Jawaharlal Nehru on

"I argue for dealing with China from a basis of realism — that strain of realism, which I feel - strains all the way from Sardar Patel to Narendra Modi," said Jaishankar. "I would say that the Modi Government has been very much more and in conformity with a strain of realism, which originated from Sardar Patel," Jaishankar told ANI in an interview.

"Even when it came, for example to the UN Security Council seat, it's not my case that we should have necessarily taken the seat, it's a different debate,

but to say that we should first let China — China's interest should come first, it's a very peculiar statement to make," he

"It takes two hands to clap. I pose the issue in this manner if you look at the last 75+ years of our foreign policy, they have a strain of realism about China and have a strain of idealism, romanticism, non-realism. It begins right from day one, there is a sharp difference of opinion — how to respond to China between Nehru and Sardar Patel," the external affairs minister said.

He said India is focusing on how to expand its relationships with nations across the world, and responded to the criticism over his recent Russian visit in Western media by asserting that every nation has its values and interests. He was speaking to the ANI in connection with the launch of his new book 'Why Bharat Matters', which he presented to Prime Minister Narendra Modi last week.

In his interview, Jaishankar also touched upon issues like relationship Pakistan, Canada and Russia and the country's role in the global space.

Describing India's relationship with Russia as "important and steady," Jaishankar asserted that the ties with Moscow have proven beneficial for New Delhi. He emphasized the need for India to approach thoughtfully while dealing with other

Replying to the Western media's criticism over his visit to Russia and the camaraderie between Prime Minister Modi and Russian President Putin, Jaishankar said, "If people can't read me, that means my mind games are working. But the answer is honestly I see no reason that people should take any, you know what was happening we have always maintained that the Russia relationship is a very important one, very steady one.

Notably, India has maintained a neutral stance on the conflict between Russia and Ukraine, advocating for dialogue and diplomacy to resolve the issues. During a meeting with President Putin in Samarkand in 2021, Prime Minister Modi emphasized, "This is not an era of war."

Earlier in December, Jaishankar travelled to Russia for a five-day visit and met President Putin Russian Foreign Minister Sergey Lavrov and Russian Deputy Prime Minister M Denis Manturov.

Speaking about India-Russia ties, Jaishankar said "I think I must have been reacting to how I was asked that particular question and I know that is not your intent. For us, Russia is a very valued partner. It's a very time-tested partner. It's a relationship from which both India and Russia have benefited enormously and my presence here today and the fact you know all the developments that I have pointed out including our growing trade, investments, our military-technical cooperation, our connectivity projects. I think all of this will give you a good sense of the importance and the value that

we attach to the relationship."

Hitherto restricted to a few regions, reports of Covid cases have now started trickling from various pockets covering Ladakh to Northeastern States in the country amid rise in its mutant strain JN.1 virus which crossed 250 mark to touch

WHO advice calling for adequate precautions given that JN.1 strain spreads fast even as it said that it's not much lethal. On Tuesday, the country reported over 573 covid cases. A total of 263 cases of COVID-19 sub-variant JN.1 have been detected in the country so far, with about half of them recorded in Kerala, according to the INSACOG's data updated on Tuesday. Ten states and Union territo-

ries have so far detected the presence of the JN.1 sub-variant of the virus.

These states are Kerala (133), Goa (51), Gujarat (34), Delhi (16), Karnataka (eight), Maharashtra (nine), Rajasthan (five), Tamil Nadu (four), Telangana (two) and Odisha (one), according to the Indian SARS-CoV-2 Genomics Consortium (INSACOG). The Centre has asked the States and Union territories to maintain a constant vigil amid an uptick in the number of Covid cases and the detection of the JN.1 sub-

variant in the country India has recorded 573 new coronavirus infections, while the active cases stood at 4,565. according to the data released

by the Health ministry on Tuesday. COVID-19 cases have been steadily rising in India since the last month when the number of cases spiked especially in Kerala. Two new Covid-19 cases were The rise in cases comes amid reported in Gurugram on Monday, according to the dis-

Anil Kakodkar, Chancellor, Homi Bhabha National Institute and Chairman, Department of Atomic Energy (DAE), hailed the scientific contributions made by RRI in pushing further the frontiers of

knowledge. In his address, he noted the role of research-led industries that are driving the country's economy.

"Today, the bigger driver is research-led industries, where frontier research penetrates into industrial operations. ### **Gujarat to procure tranquiliser** guns, cages in view of leopard attack incidents

**PTI** ■ AHMEDABAD

The Gujarat forest department on Tuesday decided to buy more tranquiliser guns and cages as a precautionary measure in view of the incidents of leopards attacking human beings in the state, the government said.

During the 23rd meeting of the Gujarat government's State Board for Wildlife (SBWL) held during the day under the chairmanship of Chief Minister Bhupendra Patel, forest officials informed board members that the process has been initiated to procure adequate quantities tranquiliser guns so that violent leopards can be controlled during mananimal conflicts.

Principal Chief Conservator (Wildlife), Forest Nityanand Shrivastava, made a detailed presentation on the issue of man-animal conflicts during the meeting, the state government said in a release. Since the density of population is high in south

Gujarat and leopards are spotted close to human settlements many times, the forest department has decided to buy at least 10 cages for each taluka of south Gujarat to trap leopards posing a threat to

human beings, it said. Moreover, the CM was also informed that the movement and behaviour of leopards are being closely monitored using motion-activated trap cameras and radio collars. The senior official informed the board that five leopards have already been radiocollared to track their movements.

## Dispute over drug money behind Manipur firing

The toll in the incident increased to four after one more person succumbed to injuries, while two other critically injured persons were undergoing treatment at the ICU of an Imphal-based hospital, they said. The incident was seen as the

fallout of a dispute over money collected through illegal drug trade, the officials Giving details of the incident,

the officials said that some cadres of the banned People's Liberation Army (PLA) arrived at the house of one person, who has several narcotics cases pending against him. Within minutes, around

1,000 people gathered outside



the residence of the suspected narcotic dealer at Lilong Chingjao village, 15 km from Thoubal headquarters and chased away the PLA cadres.

On the run, the PLA cadres opened indiscriminate fire on the locals, killing four and injuring some others. The Revolutionary People's

Front (RPF), the political People's of the wing Liberation Army (PĹA), issued a statement claiming

that the gunmen belonged to the outfit and they were holding an internal inquiry into the incident. Both the organisations are banned under the stringent Unlawful Activities (Prevention) Act. After the incident, police held an inter-faith meeting in the presence of civil society leaders and Lilong MLA

Abdul Nasir to ease tension in the area. Manipur Chief Minister N Biren Singh also assured that the culprits will be arrested and punished as per the law. The chief minister visited Raj Medicity hospital where the injured were being treated.

After his visit, Singh posted on X, "We strongly condemn all forms of violence, and the government launched mass combing operations to nab the culprits and the culprit will be punished according to the law. No one is above the law." Additional security forces have been deployed in the area and vehicular patrolling has been increased to prevent any untoward incident, he

#### MGNREGA payments go fully digital via Aadhaar but logistical concerns remain

The Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) is all set for an upgrade. The popular scheme, enacted on August 25, 2005, which came into effect on February 2, 2006, is a social welfare programme that guarantees 100 days of employment per year to rural households. In a significant move towards digitisation, MGNREGA wage payments have transitioned entirely to a digital platform, utilising Aadhaar authentication. Despite its noble objectives, MGNREGA has faced challenges related to reported leakages and instances of corruption. Leakages refer to the diversion or misallocation of funds intended for the programme, leading to inefficiencies. Various reports have highlighted issues such as ghost workers, fake job cards and irregularities in implementation. Addressing these reported leakages was crucial to maintaining the integrity and impact of the programme in alleviating poverty and promoting sustainable livelihoods in rural areas, leading to its upgrade in a fully digital for-



mat. The latest shift towards digital payments is part of the Modi Government's broader agenda to promote a cashless economy and increase transparency in welfare schemes. The primary focus of this digital transformation is the authentication of MGNREGA workers using their Aadhaar details. Aadhaar, India's unique identification system, incorporates biometric and demographic information, providing a secure and verifiable means of identification.

By linking MGNREGA payments to Aadhaar, the Government aims to eliminate leakages, reduce corruption and ensure that the wages reach the intended beneficiaries directly and promptly. The digital trail

allows authorities to monitor payments in real-time, ensuring accountability. The move to Aadhaar-based payments streamlines the disbursal of wages, ensuring that funds reach the workers' bank accounts directly. This eliminates intermediaries and minimises delays. With the Aadhaar authentication system, the Government aims to plug leaks in the system, preventing funds from being misused or siphoned off. However, the transition may not be smooth as many issues on the implementation front may arise. Linking MGNREGA payments to Aadhaar raises privacy concerns as the unique identification system involves the collection of sensitive biometric and personal information. The potential misuse of this data has been a significant point of contention. Another concern voiced by the Opposition is the risk of excluding eligible workers who may not possess Aadhaar cards or face authentication issues. This could lead to the denial of rightful employment benefits to those who need them the most. Besides, the digital divide in rural areas, where internet connectivity and technological literacy may be limited, is going to be a challenge. Having said that, the digitisation of MGNREGA wage payments through Aadhaar is a bold step towards modernising India's welfare schemes. It remains to be seen how the Government responds to the concerns raised by the Opposition and civil society.

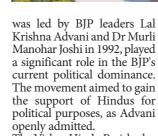

he grand Ram Temple in Ayodhya is all dressed up for the inauguration of the Ram temple on January 22 by Prime Minister Narendra Modi. It is fulfilling a longstanding dream of the BJP and the Sangh Parivar. A Hindu mob destroyed the Babri Masjid in 1992, claiming it was built on an ancient Hindu temple site in Lord Ram's birthplace. The communal conflict ended when the Supreme Court decided the disputed area belonged to the Hindus in 2019.

The fact that Muslims have abided by the rule of law and accepted the SC verdict in the spirit of closure is laudable. The Uttar Pradesh Sunni Central Waqf Board was offered five acres of land in Dhannipur village Ayodhya, where they could build a mosque. However, Reuters has reported that the city's sizeable Muslim community of an estimated 350,000 said they are not reaping the benefits of the reported boom.

The Ram temple story is more political than religious. On November 9, 1989, the Vishva Hindu Parishad (VHP) performed the Shilanyas ceremony. On August 5, 2019, Prime Minister Modi laid a 40 kg silver brick to mark the beginning of the construction of the Ram Temple in Ayodhya. Ayodhya is a city of great cultural, religious, and political significance. The Temple's construction is a victory for the BJP, the Rashtriya Swayamsevak Sangh, which led the movement and Modi, whose political career has coincided with the rise of Hindu nationalists.

The intense fight by BJP leaders L.K Advani and Dr Murli Manohoar Joshi cannot be underrated. The inauguration of the Ram Temple holds great importance in the BJP's campaign for the 2024 elections. The Modi government has fulfilled two of its poll promises. They are -constructing the Ram Temple and revoking Article 370 which granted special status to Jammu and Kashmir, impiementing a uniform civil code is the third core issue that needs to be addressed. The Ram Janmabhoomi move-



The Vishva Hindu Parishad, a front organization of the Sangh, led the Ayodhya agitation to construct the Ram temple. The Sangh believes building the Temple is crucial to establishing Hindu Rashtra. In 1992, a Hindu mob demolished the Babri mosque located on the disputed site. This resulted in widespread riots throughout the country. It led to the deaths of approximately 2,000 people, mostly Muslims.

In 2019, the Supreme Court ruled that the disputed Babri Masjid site belonged to Hindu groups. Just four years later, Prime Minister Narendra Modi's team completed the construction of a temple at the site. The Sangh Parivar could use this event to boost community pride. The BJP plans to promote the Temple's mes sage and symbol. Finally, the Ram temple propaganda could weaken the Opposition ment, which started in 1989 and campaign. Before the inaugu-

Seven new temples will be built within the Temple to honour seven significant figures from Ramayana. These figures include Maharishi Valmiki and Shabri from the Dalit community, Nishad Raj from the fishing community, Acharya Vashisht from the Brahmin community, Rishi Vishwamitra from the Rajput community, and Ahalya and Agastyamuni, who are revered by various castes and communities.

The Ayodhya movement had a social impact. The Mandal Commission report, implemented by the VP Singh government, consolidated the OBC vote behind parties that advocated social justice. It combined both the Mandal and Kamandal movements. The current political dominance of the BJP cannot be solely attributed to the Ram temple issue. From 1991 to 2009, their vote snare future for the people of this remained around 20%. city. However, under the leadership of Modi in 2014, the BJP's vote

share increased to over 30%,

and it secured a majority in Lok Sabha after 30 years.

This percentage rose further in 2019. With the construction of the Ram Temple, the BJP may gain more Hindu votes in 2024. After the death of Rajiv Gandhi, the Congress party distanced itself from the Ram Mandir issue, while the BJP consolidated the Hindu community. The party is confused about whether to adopt a soft Hindutva which may cost it Muslim support. Muslims have begun to support care-based and secular organisations like the Samajwadi Party, Rashtriya Janata Dal, and Bahujan

Samaj Party. The decision of the Supreme Court brings an end to the longstanding conflict and paves the way for peace and development in Ayodhya. With the Centre and state government's commitment to the area, it is expected that Ayodhya will soon be equipped with modern facilities, which will significantly benefit its inhabitants. This progress will lead to a brighter

In the Union Budget for 2023-2024, the Centre has earmarked Rs 600 crore for the 'Samudrayaan' Deep

Sir - The Indian Space Research Organisation (ISRO) on Monday ushered in 2024 with the successful launch of its first X-Ray Polarimeter Satellite that would offer insights into black holes in space, making the country only the second to experiment with such celestial objects. Among the payloads that piggybacked the space agency's everreliable Polar Satellite Launch Vehicle (PSLV), one was made by women, prompting ISRO to call it an inspiration for the country.

Apart from its capability of timing and spectroscopy-based observations, the insights derived from X-ray polarisation measurements on celestial objects like black holes, neutron stars and active galactic nuclei hold the potential to significantly improve the understanding of their physics.

The mission is poised to play a pivotal role in building expertise in X-ray polarimetry in India, providing a foundation for future advancements and fostering a collaborative network within the astronomy community as well this mission marks a major value-addition to the scientific fraternity.

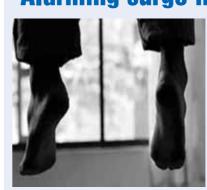

### THE INDIAN PHILOSOPHY **OF HEDONISM**

For Charvaka, pleasure is the penultimate goal of human life

narvaka, also known as Lokayata, is an ancient school of Indian philosophy that originated around the 6th century BCE. Charvaka, often referred to as Charvaka Darshan, is a materialistic and atheistic philosophy that challenges many of the prevailing ideas within the Indian philosophical tradition. This school of thought is characterised by its rejection of supernatural entities, religious rituals, and metaphysical concepts, focusing instead on empirical evidence and sensory perception as the basis for understanding the world.

#### **Historical Context:**

Charvaka emerged during a time when various philosophical schools in India were engaged in intense debates about the nature of reality, the self, and the ultimate purpose of life. The founders of Charvaka were likely influenced by the socio-political and economic changes of the time, which led them to question the validity of traditional religious and metaphysical beliefs.

#### **Core Tenets of Charvaka Darshan:**

Materialism: Charvaka is fundamentally materialistic, asserting that the only reality is the physical world. It denies the existence of any supernatural entities, including gods, and dismisses the idea of an afterlife. Egoism and Hedonism: The pursuit of pleasure (kama) and the avoidance of pain are central to Charvaka's ethics. The philosophy advocates for a hedonistic approach to life, where individuals seek personal enjoyment and well-being.

Materialist Ethics: Charvaka rejects the idea of dharma, the moral and ethical duties prescribed by Hinduism and other Indian philosophies. Instead, it proposes a pragmatic ethic based on personal well-being and the pursuit of pleasure. This has been a point of contention with other philosophical schools that emphasise moral responsibilities.

#### **Criticisms and Influence:**

While Charvaka Darshan presented a bold departure from the prevailing philosophical norms of its time, it faced significant criticism from other schools of thought, particularly the orthodox Brahmanical traditions and later Hindu philosophies. Critics accused Charvaka of promoting a self-indulgent and morally lax lifestyle.

Despite its marginalization and relative obscurity over the centuries, Charvaka has left a lasting impact on Indian philosophical discourse. Its emphasis on empirical evidence, scepticism, and materialism has found echoes in later philosophical traditions and even modern scientific thought. In contemporary discussions on rationalism and scepticism, Charvaka's emphasis on critical inquiry and reliance on observable phenomena continues to be relevant. While it may not have gained widespread acceptance in its time, its influence has endured, contributing to the diversity of thought within the broader philosophical landscape. Charvaka's commitment to empirical observation and rejection of dogma remains a reminder of the importance of critical thinking and questioning in the pursuit of knowledge.

## New mechanism to ensure utilisation of funds



The new mechanism would regulate the release of funds to the states and track their use, thereby preventing idling

he Union government executes a plethora of welfare programs aimed at providing basic and necessary amenities and upliftment of the most disadvantaged members of society. It does so mainly through "Central Schemes" (CS) which are fully funded and implemented by it. A total of 740 CS schemes are currently under implementation. During FY2022-23, the CS spending was Rs 1208,000 crore In addition, there are "Centrally Sponsored Schemes" (CSS) designed to supplement the efforts of the states in achieving various socioeconomic goals and implementing national priorities. These are funded by the central government and the states in varying proportions viz. 90:10, 60:40, 50:50 and so on depending on the scheme. These schemes are implemented by the states. During FY2022-23, the spending on a total of 50 CSSs was Rs 412,000 crore

Put together, the total expenditure of the Centre on CS and CSS schemes during FY2022-23 was Rs 1620,000 crore. It was 41 per cent of the total Budget spending of Rs 3940,000 crore during the FY. It is, therefore, imperative that the money is used judiciously. At one level, the government needs to be extremely circumspect in identifying the beneficiaries based on a rational criterion and removing any scope for fictitious claimants. At another level, efficient cash management and technology-based transparent delivery mechanisms hold the key to the efficient utilization of funds.

Since 2022-23, Modi – government has come up with innovative ideas to achieve these goals. At the outset, let us take stock of the arrangements before the FY 2022-

Under a large number of fragmented banking arrangements, the central government transferred funds to the implementing agencies (IAs) based on a tentative assessment of their spending requirement. This resulted in inefficient cash management, which often left certain IAs short of funds, while others were sitting on idle money. Consequently, the government was forced to resort to short-term borrowing (albeit for agencies facing shortfall), which imposed an additional interest

For CSS schemes, the Centre transferred funds to state treasuries, and states in turn transferred these along with their shares (for instance, under a scheme requiring fund sharing on a 60:40 basis, out of say Rs 100/- Rs 40 has to be contributed by the state) to the IAs. However, many states delay the transfer of central funds as well as their shares to the agency accounts, causing the funds to lie idle.

Moreover, the states are generally prone to divert the funds for other uses to meet pressing expenditure commitments in those areas or simply use the money to show a better picture of their overall budgetary position. The very fact of funds (read: money transferred by the Centre) being available in their treasury makes them fiscally imprudent. That implementation of the Scheme for which the funds were meant gets hamstrung, doesn't seem to bother them.

To deal with the anomaly of funds remaining idle with certain IAs even as other agencies face shortages, in FY 2022-23, the Centre moved to a Treasury Single Account (TSA) with close to 200 autonomous bodies receiving funds

through this account maintained with the Reserve Bank of India (RBI). Similarly, two other accounts - a central nodal agency system (CNAS) for central schemes and a single nodal agency (SNA) model for CSSs were opened. Under the new arrangement, each

state is required to identify and designate a SNA account for every scheme. All funds for that state in a particular scheme are credited to this bank account, and all expenses are made by IAs from this account only. The Centre promptly releases funds through these accounts with minimum float allowed meaning only a quarter of the money is released with the rest to be given only after evidence of using the earlier 75 percent is given. Further, year-end release is avoided.

Furthermore, in June 2022, the Finance Minister, Nirmala Sitharaman launched a SNA dashboard under the Public Financial Management System (PFMS). The dashboard depicts the release of funds made to different states by ministries, further releases made by state treasuries to the SNA accounts, expenditures reported by the agencies, interest paid by banks to SNA accounts etc. in intelligible, informative and visually appealing graphics.

The new mechanism thus regulates the release of funds to the states and tracks their use including at the level of IAs thereby preventing idling. Further, because the funds go to a dedicated SNA account of a scheme, it nips in the bud any chances of the State

diverting funds. As for the outcome, according to the RBI, the number of accounts for CSS schemes has fallen from a whopping 1800,000 to 3,300. Besides, the Centre saved around Rs 10,000 crore in interest during FY 2022-23.

But, these savings are a pittance of 0.9 per cent of the annual interest payments by the Centre Rs 1080,000 crore (FY 2023-24). Moreover, given that at any given point in time, as much as Rs 150,000 - 200,000 crore of central funds lies with state treasuries/IAs, there remains tremendous scope for garnering more savings by eliminating the free float.

How can this be achieved The Centre intends to roll out a new mechanism. This will require each state IA to maintain an account with the RBI for each scheme. Instead of releasing any money to the IA, the Centre will

issue an authorisation as per the sharing pattern to the RBI for the scheme. The state concerned will also give a similar authorization to the RBI. When the actual payment need arises, the state will move the payment file to the Centre, which will pass it on to the RBI. The RBI,

which already has the authorization, would release the amount to the agency from the Consolidated Fund of India (CFI) first and then from the State Consolidated Fund (SCF). The advantage of this arrangement is: that since the funds don't need to be parked either with the state treasuries or

won't lie idle in these accounts while having already moved out of the CFI.

Apart from the resultant savings in interest, the idea of 'fund release only when the need arises' helps the Centre in another way. Consider this: during FY2022-23, the CSS spending was Rs 412,000 crore as against the budget estimate (BE) of Rs 452,000 crore. Even then, there were Rs 180,000 crore central funds unspent from the releases of FY2022-23. Had the proposed mechanism been in place, the Centre could have restricted the allocation to Rs 232,000 crore (412,000 - 180,000) thereby improving the fiscal position for that year.

The new mechanism would also help states save money to the extent that their contribution to the IAs is released from SCF only when the demand arises. The states will also be spared the penal interest @7 per cent the Centre charges – under the existing dispensation - on the number of days of delay beyond 30 days in the transfer of its share to the SNA account.

The Centre has already rolled out a pilot scheme for Jal Jeevan Mission with three states Rajasthan, Karnataka and Odisha. After running the pilot, it intends to roll out the scheme pan India. To conclude, 'fund release just when the need arises' is a brilliant idea. The government should pursue its logical culmination with beneficial effects on the finances of the Centre and states.

⊣he latest UN climate summit, COP 28, delivered only partially. It was held in a state whose economy is heavily dependent on oil and gas-the United Arab Emirates. The text represents a significant regression from previous versions, as this version deliberately kept the language vague. It spoke about how it will "reduce both consumption and production by 2050". it has dropped explicit language on phasing out fossil fuels and instead used vague language to 'reduce both consumption and



production' by 2050 Was it that the president of the summit, who is also the head of the Abu Dhabi National Oil Company, played a role in diluting the earlier commitment? Or is it the collective wisdom of developing nations to gradually transition from fossil fuels rather than phasing them out? Can we phase out fossil fuels within a decade or so or is it a mere facade of the and developing countries are

developed nations? Has the importance of fossil fuels gone down in the last two years? Is humanity serious about environment conservation? Is the world concerned about climate change? The answer to all these questions has not been answered by the text of COP

## Japan earthquake toll rises to 55 | Fighting in southern Gaza city

A series of powerful earth-quakes that hit western Japan have left at least 55 people dead and damaged thou-sands of buildings, vehicles and boats. Damage was so great that it could not immediately be assessed. Japanese media reports said tens of thousands of homes were destroyed. Government spokesperson Yoshimasa Hayashi said 17 people were seriously injured and gave a slightly lower death toll, saying he was aware of the prefecture's tally.

Water, power and cell phone service were still down in some areas. Residents expressed sorrow about their uncertain futures.

## Turkiye detains 33 suspected of spying for Israel AP ANKARA with its t

Turkish authorities have detained 33 people suspected of spying for Israel, Turkiye's state-run news agency reported on Tuesday. Authorities were still searching for 13 others believed to have links to Israel's Mossad security service, the Anadolu Agency reported.

## Sunak declares success in meeting asylum target

**B**ritish Prime Minister Rishi Sunak on Tuesday declared he had met his target to clear the country's "legacy" asylum backlog by the end of 2023 and also bucked the trend across Europe by cutting down arrivals of illegal migrants via small boats by 36 per cent. The UK Home Office said that 112,000 asylum cases were processed in the past year, which exceeded Sunak's initial target of 92,000 applications pending at the end of 2022. It claimed that fundamental changes to the decisionmaking process and boosting efficiency resulted in the highest annual number of "substantive" asylum decisions in a year since 2002."I am determined to end the burden of illegal migration on the British people. That is why we have taken action to stop the boats, return hotels to their local communities, and deter those wanting to come here illegally from doing so," said Sunak in a statement to mark the start of 2024, a general election year for the

"By clearing the legacy asylum backlog, deciding more than 112,000 cases, we are saving the taxpayer millions of pounds in expensive hotel costs, reducing strain on public services and ensuring the most vulnerable receive the right support. But we cannot be complacent, which is why I am focused on delivering on my commitment to stop the boats and get flights off the ground to Rwanda," he said.

The Rwanda plan involves asylum seekers being flown out to the east African country while their applications are processed, with the controversial measure to go through its parliamentary process in the coming weeks."While illegal entries across Europe are going up, the number of people coming into the UK illegally is going down. This is a significant achievement, but the job is far



from over," said UK Home Secretary James Cleverly.

"I will continue to do every thing possible to stop the boats. No people smuggler will be safe, we will work with law enforcepartners Governments across the world

who want to tackle this threat and ensure that British taxpay er money is not wasted on people trying to abuse our generosity," he said.

The UK government claims it stepped up processing, deploying an additional 1,200 caseworkers, meeting the target caseworkers and tripling productivity to ensure more illegal migrants are returned to their country of origin, quicker.

All cases in the so-called "legacy backlog" have now reportedly been reviewed, with 86,800 décisions made. In one four-week period from November 20 to December 17, 2023, there were 20,481 initial asylum decisions made, this is more than the number of asylum decisions made in the entirety of 2021.

However, the Opposition Labour Party hit back at these claims to accuse the government of "misleading" the public. "The asylum backlog has rocketed to 165,000 under the Tories - eight times higher than when Labour left office - and no slicing or renaming the figures can disguise that fact," said Labour's shadow immigration minister Stephen Kinnock.

## Planes collide, catch fire at Japan's busy Haneda airport, killing five

A passenger plane and a Japanese coast guard aircraft collided on the runway at Tokyo's Haneda Airport on Tuesday and burst into flames, with five people on the smaller plane killed, officials said. All 379 people on Japan Airlines flight JAL-516 got out safely before the plane was engulfed in flames, Transport Minister Tetsuo Saito confirmed. The pilot of the coast guard plane escaped but the five crew members died, Saito said. Tuesday's accident was the

first time one of the Airbus A350, among the industry's newest large passenger planes, was severely damaged. It entered commercial service in 2015. The Japan Airlines A350 had flown from Shin Chitose airport near the city of Sapporo, the transport minister said. Coast guard spokesperson Yoshinori

## **Israel's SC strikes down Netanyahu** govt's judicial overhaul initiative

The Israeli Supreme Court's I landmark decision nullifying a controversial law passed by Parliament in 2023 received mixed reactions on Tuesday even as the media said the "wise thing" for the government, already fighting a major war against Hamas militants in Gaza, would be to "let go and move

The July 2023 law passed by Knesset, the Israeli parliament, had eliminated the reasonableness clause, part of the iudicial overhaul, that many criticised would have weakened the judiciary, giving the executive "unreasonable" powers, which would have threatened the basic democratic nature of the Israeli State. The "reasonableness" law

was part of a wider series of judi-

cial reforms introduced by the government led by 74-year-old Prime Minister Benjamin Netanyahu.

Late on Monday evening, all 15 Supreme Court justices participated in the decision with the ruling passed by a razor-thin 8-7 majority, reminiscent in many ways of the divided population on the evocative issue which saw the largest demonstrations in the country right till the outbreak of the war on October 7 following the unprecedented attack by Hamas militants.

Israel lacks a written constitution and has been governed since its independence based on a certain set of Basic Laws.

## Ramaswamy reiterates pledge to withdraw from state ballots

▼ndian-American Republican presidential candidate Vivek Ramaswamy has urged his rivals to follow him and withdraw from the ballots of the US states of Maine and Colorado which disqualified the party's frontrunner Donald Trump from contesting this year's race for the White House.

Maine and Colorado disqualified the 77-year-old former president from the presidency this year in the states because of his role in the attack on the US Capitol in 2021. Trump's disqualification was

based on the Constitution's 14th Amendment, which says officials who take an oath to support the US Constitution are banned from future office if they "engaged in insurrection."

In an interview with a news channel on Monday, the 38year-old biotech entrepreneur said his goal was to "nullify" the



two states that have removed Trump from their ballots by boycotting their elections.

Trump, who is facing several legal hurdles ahead of the November 5, 2024 Presidential election, is currently the frontrunner among the Republican Party candidates.

"If they're (the states) going to behave in that unconstitu-

tional way, the Republican candidates can actually stop this

form of election interference," Ramaswamy was quoted as

saying by The Hill newspaper. "I said I would remove my name from those ballots, and I called on the other Republicans in the race to do the same thing," he said.

Pointing out that the other Republican candidates are now "sidestepping" the issue and have been "radio silent" on it,

Ramaswamy said, "If every Republican removes themselves, that nullifies Maine, and it nullifies Colorado if they remove a candidate unconstitutionally from that

I think it's unconstitutional, and we need to stand on principle, so my position is clear," he said.

#### Cold spell in Finland, Sweden sends temp below minus 40 22 F) in several locations in northern

Helsinki (AP): Finland and Sweden recorded their coldest temperatures of the winter on Tuesday when thermometers plummeted as low as minus 40 degrees Celsius (minus 40 Fahrenheit) as a cold spell grips the Nordic region.

Cold and snow disrupted transportation throughout the region, including in Norway where a major highway in the south was closed due to the weather and ferry lines suspended operations. Swedish train operators said the cold snap caused substantial problems for rail traffic in the Arctic north.

Nikkaluokta, a small village inhabited by indigenous Sami people in northern Sweden, recorded a temperature of minus 41.6 degrees C (minus 42.8 F) early Tuesday, Swedish public broadcaster SVT

"It's the coldest temperature we have had so far this winter, and it will continue to be quite cold weather in the north," SVT meteorologist Nils Holmqvist said.

The Swedish Meteorological and Hydrological Institute reported temperatures of minus 30 degrees Celsius (minus Sweden, and issued a warning for snow and wind for central and southern Sweden. Its second-highest warning applies from midnight into Wednesday. In neighbouring Finland, this winter's

cold record was recorded in the northwestern town of Ylivieska where temperatures fell to minus 37.8 degrees Celsius (minus 36 F) early Tuesday, and forecasters said temperatures would be lower than minus 40 degrees Celsius in parts of the nation through the week.

Temperatures in the Finnish capital, Helsinki, were expected to hover between minus 15 and minus 20 degrees Celsius (around zero F). In the southern Norway town of Arendal, officials said schools would be closed Wednesday because it wasn't possible to clear the sidewalks in time for children to get to school. Several ferry companies throughout the region cancelled crossings, including those from southern Norway to Denmark where a key bridge was closed to vehicles with light trailers because of strong winds, Danish officials

South Korea's tough-speaking liberal opposition leader, Lee Jae-myung, was stabbed in the neck by an unidentified knife-wielding man during a visit on Tuesday to the south-eastern city of Busan, police said. Lee, 59, the head of the main opposition Democratic main opposition Democratic Party, was airlifted to a Seoul hospital for surgery after receiving emergency treatment in Busan. Police and emergency officials earlier said he was conscious after the attack and wasn't in critical condition, but his exact status was unknown.

The attack happened as Lee walked through a crowd of journalists and others after a tour of the proposed site of a attacker approached Lee, saying he wanted to get his autothe left side of his neck with a knife, senior Busan police officer Sohn Jae-han said in a televised briefing.

Sohn said Democratic Party officials near Lee quickly subdued the attacker before police officers detained him. He said 41 police officers had been deployed to the area for crowd control and traffic management. TV footage showed Lee, his eyes closed, lying on the ground as a person pressed a handkerchief to his neck to stop the bleeding. A witness, Jin Jeong-hwa, told YTN television that Lee had bled a lot. Videos circulated on social media showed the suspect, wearing a paper crown reading "I'm Lee Jae-myung," being chased and tackled by several people, apparently including plainclothes police officers.

Sohn said the suspect, aged about 67, told investigators that he bought the 18-centimetre knife online. He said police are investigating the motive for the attack. 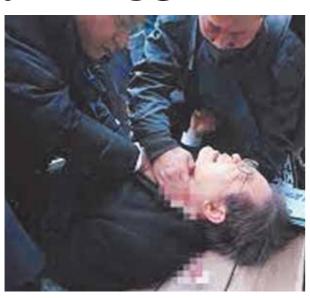

Dakistan's Supreme Court Pon Tuesday adjourned the hearing until Thursday in a key case that would settle the issue of lifetime disqualification of some leading politicians, including former prime ministers Nawaz Sharif and Imran Khan. The verdict will determine once and for all the controversy around the period of disqualification under Article 62(1)(f) of the Constitution and the Elections Act 2017.

A 2018 judgment by a five-member bench of the apex court had declared that disqualification under Article 62(1)(f) was for life but changes made in the Elections Act 2017 on June 26, 2023, by a coalition government led by Pakistan Muslim League-Nawaz (PML-N) restricted it to a five-year term only. A sevenmember bench, headed by Chief Justice Qazi Faez Isa,

said that some people were trying to create the impression that the court wanted to give benefit to some "individual or group" through this case. "We are just trying to settle an issue of law," he stated. Most of the arguments were in favour of nullifying the concept of the lifelong ban and limiting it to a five-year term. However, the chief justice said that he also wanted to hear arguments in support of lifelong disqualification and asked the lawyers to come forward.

Later, he adjourned the hearing until January 4 with the remarks that the court would like to wind up the case and settle the legal controversy over the length of disqualification. Sharif, the former prime minister and also a frontrunner for the fourth term in the February 8 general elections, was disqualified in the Panama Papers case in

who was disqualified in the Toshakhana case last year, also was hit by the same law.

However, Sharif got a kind of relief when his party-led government amended the election laws last year to limit the disqualification to five years which allowed him to file nomination papers for the upcoming elections. However, the controversy was not over as his candidature has been challenged as the interpretation of Article 62 (1) (f) clashed with the changes made in the Elections Act 2017.

The outcome of the hearing would decide the future for both Sharif and Khan as well as many other politicians. The 74-year-old Sharif's case was final until the period of disqualification was reduced. However, 71-year-old Khan's disqualification has not attained finality and his appeal against it is still pending.

Incarcerated Khan's nomination papers for the February 8 general elections were rejected on December 30 based on disqualification due to his conviction in the offence of "moral turpitude" in a corruption case and other reasons, a government official had reasoned.

Earlier, the issue came into the focus of the Supreme Court last month during the hearing of a petition of a politician from Dera Ghazi Khan, Badshah Khan Qaisarani, who was disqualified for producing a fake graduation degree.

During the hearing, the chief justice had remarked that the Supreme Court verdict on lifetime disqualification and the amendments made to the Elections Act, 2017 could not co-exist. He further stated that discrepancies in the apex court's interpretation and the law could result in "confusion" in the upcoming general

#### 'Pak likely to get \$700 mn from IMF as next tranche of bailout this month

Islamabad, Jan 2 (PTI) Cashstrapped Pakistan is expected to get USD 700 million as the next tranche of the bailout from the IMF as the Executive Board of the global lender meets on January 11, according to a media report on Tuesday.
The board of the

Washington-based International Monetary Fund is set to deliberate and potentially grant final approval for the disbursement of the next USD 700 million tranche for Pakistan under the existing USD 3 billion Stand-By Arrangement (SBA), the Dawn newspaper reported. According to the IMF Executive Board calendar, upcoming meetings are scheduled for January 8, 10 and 11, with Pakistan's case slated for discussion on the last day. The current IMF programme, amounting to USD 3 billion, is expected to conclude in the second week of April, with approximately USD 1.8 billion remaining undisbursed. The initial tranche of USD 1.2 billion was released in

In November 2023, a Staff Level Agreement was reached between the IMF staff and Pakistani authorities regarding the first review under Pakistan's SBA. This agreement is contingent upon approval by the IMF's Executive Board. Despite expectations for board approval in December, it seems the process has been scheduled for January 11.

This development holds significance for Pakistan's economic landscape as the disbursement of the next tranche could provide much-needed financial support. The outcome of the upcoming meeting will shape the trajectory of the ongoing economic cooperation between Pakistan and the MF. "Discussions between the IMF staff and the authorities on policies to strengthen macroeconomic stability in the coming year continue, and important progress has been made over the FY23 budget," the

The IMF also updated economic projections and data for Pakistan, depicting a challenging outlook for the country in 2024. According to the IMF's latest figures, the projected real GDP for the year is anticipated to experience a contraction of 0.5 per cent, in distinguishing potential indicating potential economic headwinds. Simultaneously, the projection for the Consumer Price Index in 2024 shows a significant increase.

### Militants kill 6 barbers from **Punjab** in **Pak's Khyber Pakhtunkhwa**

Peshawar (PTI): Unidentified militants shot and killed six barbers from Pakistan's Punjab province after abducting them from the restive northwest region, police said. The incident took place in the Mir Ali area of the North Waziristan district of the Khyber Pakhtunkhwa province bordering Afghanistan, ARY News reported on Tuesday.

The victims, who were from the Punjab province, ran barber shops in the local bazaar, police said, adding that they were abducted a day earlier and their bodies were recovered on Tuesday. However, no one immediately claimed responsibility for the killings. Police have launched a search to arrest the culprits who shot and killed the six barbers. The latest incident from North Waziristan came after five labourers were killed in the same province by unidenti-fied militants while they were in their tents.

The gruesome act took place at a time when the province wrestled with a worsening law and order situation due to the rising terrorism at a time when the much-awaited just over a month away.

## HC reserves verdict on ECP plea against restoration of PTI's symbol

High Court in Pakistan on A High Court in Pakistan on Tuesday reserved its ver-dict on review pleas filed by the Election Commission of Pakistan against its decision to suspend the electoral body's declaration of the Pakistan Tehreek-e-Insaf party's organisational polls as "void" and the re-vocation of its electoral symbol - a cricket bat.

Jailed prime minister Imran Khan's party faces uncertainty over its electoral symbol as the Election Commission of Pakistan (ECP) last month rejected PTI's intra-party elections and deprived the party of its cricket bat symbol. Barrister Gohar Khan was elected as the party's new chairman in the internal elections in December.

The party challenged the verdict in the Peshawar High Court which on December 26 suspended the ECP's declaration of the PTI's intra-party polls as unconstitutional as well as the subsequent revocation of the party's iconic symbol. The election commission challenged the high court verdict. During the hearing presided over by Justice Ejaz Khan on Tuesday, the ECP's counsel contended that the election commission sought a

At the outset, Justice Khan inquired if the Supreme Court had passed orders that directives issued by a high court applied to the entire country,

"Absolutely. The Supreme Court suspended the Lahore High Court's decision regarding returning officers," the lawyer replied. He elaborated that the judgment was suspended under a unilateral decision. "The second point is that the interim relief and final plea are the same," he

At one point, the judge asked where the petitioner in the case was to which the ECP counsel said he was unaware. Justice Khan said that he

could not issue an order in the case as it was fixed before a division bench on January 9. However, the ECP lawyer said he only wanted the court to withdraw the PHC order, adding that arguments would be presented before the division bench. Subsequently, the court reserved its verdict, the

newspaper reported. On Monday, PTI chairman Barrister Khan said that his party will participate in the general elections even without getting the cricket 'bat' as its electoral symbol.

Khan made the remarks ists in Islamabad where he attacked military installations.

### Russia launches fresh drone strikes on **Ukraine after promising retaliation**

**Kyiv (AP):** Russia launched a fresh drone assault on Ukraine on Saturday night, after promising that strikes on the Russian border city of Belgorod earlier in the day "would not go unpunished". The Ukrainian Air Force said Sunday that it had shot down 21 of 49 drones launched by Russian forces overnight.

### Norms eased for shifting of used IT hardware goods from SEZs to domestic tariff areas

PTI ■ NEW DELHI

The government has relaxed curbs for shifting of used IT hardware goods like laptops and desktops by a company in special economic zones (SEZs) to outside these duty freeenclaves or domestic tariff areas. SEZs are treated as deemed foreign territory for customs laws and bringing goods from these zones into the domestic tariff area (DTA) or domestic market is tantamount to imports.

In general, a company from DTA needs a licence for imports of these goods from SEZs.

Easing these curbs, Directorate General of Foreign Trade (DGFT) in a notification has said that used IT assets (laptops, desktops, monitors, printers) can be moved from SEZ by a company to DTA without a license for the purposes of further use in their DTA operations "onlv".

However, these equipment should have been used in SEZ units for two years and should not be older than five years from the date of manufacturing.

"Import policy of used IT assets (laptops, desktops, monitors, printers) from SEZ to DTA has been notified," DGFT said. It added that in cases where a unit is closing down its operations in SEZ, and relocating to

the DTA, the import of these items is allowed without a licence subject to a condition that those products should not be older than five years from the

date of manufacturing. If a SEZ unit has second hand/used/old condition equipment and is being used for less than two years, they can not be shifted to DTA. "Import of any used IT assets which do not fulfil" these criteria "shall be subject to licence for restricted import," it said adding these relaxations will be applicable on the condition that no exemption

ulatory requirements, that is Compulsory Registration Order (CRO), Restriction of Hazar-dous Substances (RoHS), and WPC (wireless planning and coordination) import licence. ## **Grapplers seek UWW help** in resolving wrestling crisis

everal international medal-winning Swrestlers from different states have approached the world governing body UWW, requesting its intervention for restoration of the suspended WFI and cused Bairang Punia and Sakshi Malik of orchestrating a "fake agitation".

The three wrestlers had led a protest against former WFI chief Brij Bhushan Sharan Singh, alleging that he has sex-ually exploited women wrestlers and sought his arrest.

The matter is being heard by a Delhi court and Brij Bhushan is out on bail. The National camps have not been held for a long time due to the ongoing tussle between the elite wrestlers and the BJP MP. An ad-hoc panel ran the sport till recently but was brought back to handle day-to-day affairs of the sports body after the newly-elected body was suspended by the Sports Ministry.

"I would like to inform you that due to fake agitation of three wrestlers, the wrestling in India has been destroyed. I am a woman wrestler but I did not face any sexual demand from the previous president," wrote an Asian Games and CWG medal-winning wrestler.

"I thought after the election of WFI, this controversy will be over but these three wrestlers are trying to damage wrestling in India. Being a woman wrestler, I personally contacted many women wrestlers but no one corroborated the version of these wrestlers.

"My humble request to UWW is to interfere in the matter and a permanent Federation may please be established in India otherwise wrestling will be destroyed," the Arjuna awardee added It may be mentioned that United World



Wrestling (UWW) had suspended the WFI on August 24 for not holding elections on time and Indian wrestlers had to compete as neutral athletes at the World Championships last year. A junior wrestler from Maharashtra, in

her letter to UWW President Nenad Lalovic, wrote how their careers have been stalled in the absence of junior national championships.

"Since two years, there is no sub junior and junior competition, the wrestlers are not getting the chance to show their talent as there are only three senior players (creating controversy) and on top of that due to politics, a big crisis has come..... Please give justice to Indian wrestlers by activating Wrestling Federation of India," the wrestler wrote. The newly elected body WFI had announced immediately after the polls that U15 and U20 Nationals will be held in the last week of December in Gonda, UP but due to WFI suspension, the competitions could not be held.

Interestingly, the minor who filed a sexual harassment complaint against Brij Bhushan before withdrawing it, also wrote to the UWW admitting that her father filed a fake complaint against the former WFI boss.

## Hermoso testifies in sexual assault case after kiss at Women World Cup final

The Spanish player kissed on the lips by the soccer president at the Women's World Cup final appeared in court on Tuesday to testify in the sexual assault case against

the former official. Jenni Hermoso was at the Madrid court to give her version of the kiss by Luis Rubiales following Spain's victory over England in the final in Sydney in August.

The incident sparked outrage across the soccer world and ignited one of the worst crises

in the history of the sport in Spain. It also led to a boycott of the national team by the World Cup-winning players, and to the eventual resignation of Rubiales despite his denial of wrongdoing and his allegation, that the kiss was consensual.

Hermoso was expected to reiterate in court her allegations that the kiss was unwanted and Rubiales and his staff tried to pressure her and her family to downplay the incident that tarnished Spain's first Women's World Cup title.

The testimony was expected behind close doors. Spanish media said Hermoso asked the judge to keep her court appearance as private as possible. She arrived wearing a grey coat and waved to journalists before entering the court through one of its main entrances along with her lawvers

Spanish state prosecutors accused Rubiales of sexual assault and coercion, alleging he tried to convince Hermoso and her relatives to publicly downplay the kiss.

The judge is also hearing tes-



timony from other World Cup-winning players, coaches and federation officials, before deciding whether to start a trial.

Rubiales previously denied wrongdoing to the judge who imposed a restraining order on him not to contact Hermoso.

The 33-year-old Hermoso, the record scorer for Spain's women's team, said last year she received threats in the fallout from the kiss, though she did not elaborate.

Hermoso became somewhat of a celebrity in Spain after

coming forward to denounce the kiss and help promote a "Me Too" movement in the country. She was one of the New Year's Eve presenters on public television on Saturday, calling for a 2024 with more equality.

## ODI defeat by 190 runs **AUSTRALIA COMPLETE 3-0 WHITEWASH**

**PTI** MUMBAI

India produced an abject bat-ting display after a poor show with the ball to suffer a 190-run loss, their third heaviest defeat, in the third and final ODI as a rampant Australia completed a 3-0 series whitewash here on

Tuesday. Having conceded the highest total ever of 338/7 recorded by any opposition against them, India's frailties with the bat came to the fore as they were shot out for 148 in 32.4 overs. None of the Indian batters, who had put up a strong fight in the second ODI here at the a dent in the opposition's march to a 10th consecutive win in away bilateral games.

For Australia, it is their ninth series win against India and fifth in the opponent's backyard.

Australia have beaten India in India 3-0 in 2018, 3-0 in 2012 and 4-0 in 1984. India have also suffered 0-3 whitewash in 2006 and 0-5 clean sweep in 2008 in Australia

India were rocked twice in the powerplay when Megan Schutt (2/23) cleaned up Yastika Bhatia (6) and then Smriti Mandhana (29) played one straight down the throat of Kim Garth at deep extra cover.

India's plight deepened when skipper Harmanpreet Kaur (3) was dismissed for her third single-digit score in a row.

Looking to sweep Georgia Wareham (3/21), Harmanpreet was beaten by Beth Mooney's anticipation to quickly move on her left from the first slip to complete the dismissal.

Richa Ghosh (19), coming off a superb 96 in the second ODI, played on to her wickets off Wareham with the Australian leg-spinner once again snaf-fling crucial wickets.

India's hopes to take the game deep then suffered a body blow in the 20th over when their most consistent batter in the series Jemimah Rodrigues (25) smashed one straight to Alana King at short midwicket off Ashleigh Gardner.

But the highlight for Australia in the second innings was Phoebe Litchfield's stunning one-handed catch. She flew on her right to complete a diving effort at cover, to dismiss Amanjot Kaur

(3) off King. King (2/21) then produced the ball of the series when she bamboozled Pooja Vastrakar (14) to get one turning from leg stump to hit the top of off. Annabel

Sutherland also chipped in with a measly 3-0-9-2.

Earlier, Litchfield continued her rich vein of form with a magnificent century as Australia Women flayed India.

Litchfield cracked as many as 16 fours and a six to make 119 off 125 balls and put on a record 189-run stand for the first wicket with Alyssa Healy, who also cashed in on the opportunity with an 85-ball 82 (4x4s, 3x6s). Australia were relentless with the bat from the word go and despite Shreyanka Patil's 3/57, the visitors made merry on a placid wicket that proved to be a bat-

ting haven. stand is now the highest for any wicket among all the visiting sides in India in the 50-overs format, bettering South Africans Lizelle Lee and Laura Wolvaardt's 169-run partnership for the first wicket in 2021. Having possibly missed out on making tons in each of the first two ODIs with scores of 78 and 63, Litchfield showcased her rich arsenal of strokes all around the park to flatten India.

Litchfield, however, was also lucky when Deepti Sharma could not hold onto a tough diving catch to her left, off Amanjot Kaur (10-0-70-2) in the 19th over, when the batter was on 62. If it was any consolation, Deepti had Litchfield caught by Harmanpreet and with that the right-arm spinner became only the fourth Indian to have taken 100 wickets in one-day cricket. Patil was the most successful Indian bowlers with 3 for 57 in her 10-over spell, with her twin strikes in the 36th over providing some respite on a tough day out. Patil trapped Mooney (3) and Tahlia McGrath (0) legbefore on consecutive deliveries to peg Australia back, albeit momentarily, as the visitors'

aggressive approach again brought them back on top. Gardner's 27-ball 30 with four fours, Sutherland's 21-ball 23 (2x4s, 1x6s) and late fireworks yet again from King — 26 not out off 14 balls, three sixes, one four — helped Australia better their own record.

King took 19 runs off Vastrakar's final over as Australia bettered their own record for highestever total against India in ODIs. Australia had made 332/7 in March 2018 at Vadodara.

## Australia PM praises Khawaja for showing courage amid stand off with ICC

ustralia's Prime Minister Anthony Australias Printe Iviniotea Albanese has praised Usman Khawaja's courage amid his stand-off with the ICC after expressing solidarity with the victims of the conflict between Palestine and Israel. The ICC has barred the Australian opener from displaying messages of equality and freedom, specifically a dove logo and an olive branch on his shoes, during the Test series against Pakistan.

The decision was based on the international regulation that prohibits players from showcasing personal messages on their uni-

But his act has won him an admirer in the country's premier who touched upon Khawaja's gesture during an address to the Australian and Pakistan teams ahead of the Sydney Test.

"Î'd like to congratulate (Khawaja) for the courage he has shown standing up for human values," Albanese said.



"He has shown courage, and the fact that the team has backed him in is a great thing." "When Ussie and Dave (David Warner) go out, it will be a very special moment, when you walk on to the SCG," Albanese added. The SCG Test will mark the last time Khawaja and Warner will be walking out together to open the innings with the latter retiring from the traditional format after the match beginning on Wednesday.

Last week, Australian captain Pat Cummins had come in support of his teammate, saying the opener's attempt to bring to the fore

Cricket's global governing body, the ICC, had rejected Khawaja's application to have a sticker showing a black dove holding an olive branch on his bat and shoes during the Boxing Day Test against Pakistan.

We really support Uzzy. He's standing up for what he believes and I think he's done it really respectfully," Cummins had said on the eve of the second Test at the MCG, which Australia won to wrap up the series. "As I said last week, 'All lives are equal', I don't think that's very offensive and I'd say the same about the dove," Cummins had
