Amid speculation about his possible arrest by the Enforcement Directorate following his repeated refusal to appear before them, AAP convener and Delhi Chief Minister Arvind Kejriwal alleged on Thursday that the ED's repeated summons in the alleged liquor scam, just before the upcoming Lok Sabha poll, are an attempt to hinder his campaigning. This is despite the ongoing two-year investigation into the matter. The Delhi CM emphasised that his honesty is his biggest asset, and the BJP wants to tarnish his honesty with fake cases. AAP convener issued a video amid message intense speculation that he would be arrested in connection with

the alleged liquor scam. "For the last two years, you have heard the words 'sharab ghotala' several times. There have been multiple raids in connection, but agencies didn't find a single rupee. Where did the money go? Did it just vanish into thin air? The truth is there has been no corruption," Kejriwal said in a video message a day after skipping the third summons of the ED.

Meanwhile, the AAP also announced that Kejriwal will leave for a three-day tour of Gujarat on Saturday in view

of the upcoming Lok Sabha polls. ÂAP sources said Kejriwal's Gujarat visit was part of a tour related to the upcoming Lok Sabha elections. Jan Sabhas and party events are on the AAP convener's agenda, said sources, adding that the AAP convener will address public meetings and party workers

during his election tour. The announcement came a day after Kejriwal skipped the third summons issued to him by the ED for questioning related to the alleged excise scam. Notably, many AAP leaders, including Delhi leaders, including Delhi Ministers Atishi, Saurabh Bharadwaj, and Rajya Sabha MP Sandeep Pathak, late on Wednesday, cited sources and said that the ED is likely to raid and arrest their chief. Several AAP workers also

gathered outside Kejriwal's residence this morning, anticipating ED action. On the other hand, the ED has declined the claim and termed the reports of raids at Arvind Kejriwal's residence as 'nothing but rumors.' Officials said they are examining the letter and will summon

Kejriwal once again. "Many AAP leaders have been falsely implicated in this connection, and they are languishing in jail while there is no evidence against them. Now, the BJP wants to arrest me. My biggest strength is my honesty. They want to defame me, hurt my image with false accusations," Kejriwal said. Speaking on the summons, Kejriwal mentioned that his lawyers told him that the

Trouble for AAP as Mohalla Clinics face CBI probe

Delhi Lieutenant Governor Vinai Kumar Saxena on Thursday

ghost patients at Mohalla Clinics in Delhi to the CBI. According to the allegations, fake pathology and radiology tests wer cond non-existent patients at Mohalla Clinics, aiming to make illegal payments to private labs in the guise of referrals as part of the purported scam. This development follows Saxena's recent directive for a CBI probe into the alleged supply of drugs to Delhi government hospitals that failed "quality standard tests." The impact assessment report from the Delhi Government Health Department has revealed concerning findings. In 11,657 records from these seven Mohalla Clinics, patients' mobile numbers were listed as 'zero.' Furthermore, in 8,251 cases, the mobile number column was left

numbers were entered **'**9999999999'. Officials also identified 400 entries with non-existent mobile numbers starting with 1-5, and 999 cases where the same mobile number was associated with 15 or more patients. The report raised questions about the legitimacy of prescriptions, as doctors marked attendance through pre-recorded videos. An official queried, "Who prescribed these tests

According to the enquiry report shared by the LG's office, fake and non-existent mobile numbers were used to register patients and for subsequent lab tests supposedly done on them. Duplication of mobile numbers was also allegedly noticed.

"The data has clearly revealed that fake lab tests were carried out at these Mohalla Clinics, warranting further inquiry," said an official from the LG's office. The alleged scam came to light in September 2023 when it was observed that some doctors and staff at seven Mohalla Clinics in South-West, Shahdara, and North-East districts were marking fraudulently attendance through pre-recorded videos.

The Delhi Government initiated a facility to provide 450 types of medical tests for free to impoverished patients at Mohalla Clinics across the city starting from

January 1 of the previous year.


Modi's Island Odyssey in Lakshadweep

Winter of discontent in Delhi as mercury dips

The national capital has been experiencing wintry mornings and nights since New Year's eve, causing people to shiver both at home and in workplaces. Icy winds and a heavy fog in the higher altitudes have kept the city in the grip of winter. A day after recording its lowest daytime temperature of the season, Delhiites woke up to yet another cold and grey morning, with the maximum temperature recorded at 12.5 degrees Celsius — seven notches below the season's normal at the Safdarjung Observatory station Thursday. This is a record low for the season, leading to foggy and cold day-like conditions?

The recorded minimum temperature was around 7.7 degrees Celsius, just one notch above the normal. With the upcoming days, the on Friday, both the maximum and minimum temperatures are likely to settle around 13 and 6 degrees Celsius, respectively.

Safdarjung, weather station, reported a visibility of 500 metres at 8:30 am, with the minimum temperature recorded at 7.7 degrees Celsius, slightly above

According to the India Meteorological Department (IMD) data, Palam recorded a maximum temperature of 11.4 degrees Celsius, nearly seven notches below the

minimum temperature stood at 7.5 degrees Celsius. The Ridge recorded a maximum temperature of 12 degrees Celsius, approximately five notches below the normal. In temperature was recorded at 12 degrees Celsius. "The first 10 days of January

are typically considered the coldest, but this year, it is relatively warmer compared to the previous year," said Kuldeep Srivastava, scientist and head of the Regional Weather Forecasting Centre. The decline in the maximum temperature has led to bitter in Delhi, with the minimum temperature already around 7 degrees Celsius. A meteorological "cold day" is declared when the maximum temperature is 4.5 degrees below normal, minimum and the temperature is below 10 degrees Celsius. The peak

temperature usually occurs between 3 pm and 4 pm. The three-hour readings recorded by the IMD indicate ambient temperatures in the low double digits (10-11 degrees Celsius) for most parts of the day between 8:30 am and 5:30 pm, except for some hours between 2:30 pm and 5:30 pm.

The normal maximum temperature for Delhi at this time is around 17.3 degrees Celsius, and the normal minimum is 6-7 degrees Celsius," said IMD officials. The weather department has issued a vellow alert for "cold day" conditions in some areas

Shah launches tur dal procurement portal

Union Cooperation Minister Amit Shah on Cooperation Thursday launched a tur dal procurement portal through which farmers can register and sell their produce to NAFED and NCCF at a minimum support price or market price, saying that the move aims to make India self-reliant in pulses by 2027.

It may be noted that the tur dal procurement portal comes at a time when the domestic tur output in the 2023-24 kharif season is anticipated to be lower for the second straight year in view of fall in acreage and the central nodal agencies hope to procure maximum quantity for maintaining sufficient buffer and keep a lid on retail inflation ahead of general

After the launch, Shah said before the sowing operation, tur farmers can register on the portal to sell their produce to NAFED and NCCF at minimum support price (MSP).

A similar facility will be unveiled in future for urad and masoor farmers as well as maize farmers, he said. The minister also transferred

via Direct Benefit Transfer (DBT) about Rs 68 lakh to 25 farmers registered with

The National Agricultural Cooperative Marketing Federation of India Ltd (NAFED) and the National Cooperative Consumers' Federation of India (NCCF) are two central nodal agencies that undertake pulses pro-curement on behalf of the government for maintaining a buffer stock. They also buy pulses under the Price Support Scheme when the rates fall below the MSP.

The registered tur farmers will have an option to sell either to NAFED/NCCF or in the open

Suppose the open market price of tur remains higher than the MSP at the time of harvesting, in that case an average rate will be arrived through a formula, he said, adding that the payment will be done through

Noting that more farmers were not taking up pulses farming in the country because prices were not assured, he said that with procurement via the portal, the initiative will bring a major reform in the agriculture sector and help achieve selfreliance in pulses production. Tur will be procured from farmers and it is Prime Minister Narendra Modi's guarantee," he added.

Tur production had touched a record of 4.87 million tonnes in 2016-17 kharif season and in the consecutive years the output fell and reached as low as 3.31 million tonnes in 2022-

As per the initial estimate of the agriculture ministry, tur output is pegged at 3.42 million tonnes for 2023-24 kharif sea-

Nearly four months after the Bombay High Court dismissed two phone tapping cases against her, the Maharashtra Government on Thursday appointed senior IPS officer Rashmi Shukla as the new State Director-General of Police (DGP), the first-ever woman to occupy the coveted post. An IPS officer of 1998 batch, Shukla replaces Rajnish Sheth, who retired on December 31, as the new DGP of the state.

Shukla, who is currently the Director-General of Seema Sashastra Dal, had earlier worked as the Director of the State Intelligence Department (SID) and held other prestigious state and central postings.

EC revises proforma for symbol allocation to RUPPs

The Election Commission I on Thursday said it has revised the proforma to allot common symbols to registered unrecognised political parties, which have submitted contribution reports and audited annual accounts for the last three financial years.

As per the EC, the Registered Unrecognised Political Parties (RUPPs) will also have to submit election expenditure statements of the party for the last two elections if it has contested any. The RUPPs were earlier giving these details separately, officials said, adding these details are now being made part of the format of application for common sym-

"Accordingly, the Commission has revised the proforma of application for Common Symbol Allotment under the provisions of Para 10 B of the Election Symbols (Reservation & Allotment) Order, 1968," the poll body said in a state-

The EC said the party seeking common symbol allotment from January 11 has to furnish a declaration, duly signed and notarised as per Annexure III.

Several flight operations were delayed at Delhi airport while 26 trains were delayed in arrival by three to eight hours due to low visibility amid foggy conditions. In light of the prevailing cold weather conditions, administrations in Uttar Pradesh's Noida and Greater Noida ordered schools to remain shut for students up to Class 8 till January 6. The 24-hour average Air

Quality Index (AQI) recorded at 4 pm on Thursday was 377, which stands in the "very poor" category.According to the Central Pollution Control Board (CPCB) data, the Air Quality Index was recorded at 377 in RK Puram on Thursday morning, 312 in Lodhi Road, 377 ITO area and 387 in the

IGI Airport area. Anand Vihar plummeted to the 'severe' category with PM2.5 at 428 and PM10 at 433, as per the Central Pollution Control Board (CPCB). The AQI at ITO also remained in 'severe' category with PM2.5 reaching at 447 and PM10 at 403. The

Carbon Monoxide (CO) was recorded at 79, in the 'satisfactory' category.

The particulate matter PM2.5 at Punjabi Bagh also reached 441 while PM10 was at 407, both in the 'severe' category. The air quality at Jahangirpuri Meanwhile, the air quality at air quality monitoring station also entered into 'severe' category with PM2.5 at 466 and PM10 444. The CO also reached at 101 or 'moderate'. The PM2.5 at Okhla Phase-II was recorded at 411 and PM10 at 405 both in the 'severe' category. The CO was at 106, at

the 'moderate' levels. At Mundka the AQI remained in the 'severe' category with PM2.5 at 401 and PM10 at 303, in the 'very poor' category. At Bawana, the air quality was

Dense to very dense fog shrouds Punjab, Haryana, Delhi, North Rajasthan, North Madhya Pradesh, Uttar Pradesh, and even parts of Bihar and

This relentless mist not only disrupts visibility but also triggers biting cold days, and even severe cold day, conditions across the region. While minimum temperatures

remain surprisingly above normal, day temperatures in

Punjab and parts of Haryana have nosedived significantly below average. This stark contrast paints a picture of an unusually chilly North India, where residents shiver despite relatively warmer nights. According to the weather

department, over the next two days, no significant change in weather is expected in east

In Central India, minimum temperatures are likely to rise by 2-3 degrees Celsius over the next three days, with no significant change thereafter.

What is even more reprehensible is the fact that the targeted population of these services at the MohallaClinics, are the poorest of the poor who have no recourse to any other means than the ones being provided by the government," he said. In August 2023, it came to the notice of the Department that some Doctors/Staff of AAMC (Aam Aadmi Mohalla Clinic) posted in Shahdara, North-East & South-West District resorted to unethical practice to mark their attendance fraudulently on 3 tablet module by pre-recorded video, thereby violating the MoU & ToR

regarding patient services.
The patients were consulted and medicines were disbursed to them in the absence of the Doctorby the empaneled staff who were not competent and not authorised to do so thereby endangering the lives of the patient.

În September 2023 immediate action was taken against these staffs and they were de-empaneled. Also FIRs were registered against them.

In October 2023 in continuation of this action, a review of sample of lab testing data (retrieved from both diagnos-

A random analysis of lab data for 3 months - July to Sept. 2023 in Metropolis and Agilus Lab ManagementInformation System (LMIS) was carried out and it was observed that even during the period when the now de-empaneled Doctors were marking their attendance fraudulently through pre-recorded videos the lab tests are being recommended, meaning thereby that lab tests was being recommended without presence of treating doctor, which is clear violation of SOPs laid down.

Also it was found that a single mobile number (which is an important detail for identifying each patient visiting health facility for lab test) is occurring again and again (duplication) for many patients with different names. The data suggest that lab tests could have been entered which need to be enquired.

Hizbul ultra with ₹10 lakh bounty held

In a significant development, the Delhi Police Special Cell arrested Javed Ahmed Mattoo (32), a prominent Hizbul Mujahideen terrorist, on Thursday in the national Vapital. Mattoo, who was A++ terrorist, captured with a 9 MM star pistol, magazine, six live cartridges and a stolen car. He was wanted in 11 terror attacks in Jammu and Kashmir and was among the top 10 targets in the Valley on the list of security agencies. He was carrying a reward of Rs 10 lakh on his head. He was wanted in connection with multiple terror-related incidents in Jammu

The arrest was made following a successful search operation conducted by the National Investigation Agency (NIA), as confirmed by the Delhi Police

With the coordination of Special Cell of Delhi Police and central agencies, Javed Mattoo. an A++ category terrorist who has a bounty of Rs10 lakh on him, was arrested today...After taking him into police custody remand, we will further action against him," Special Commissioner of Delhi Police HGS Dhaliwal said. He added that Mattoo was found travelling on the DND in a stolen vehicle and that a pistol was recovered from him at the time of the arrest. The police, said Dhaliwal, had been tracking Mattoo from Delhi's Nizamuddin. He also said that though Mattoo concealed his identity and was leading a "camouflaged" life, he "maintained contact with his associ-

According to the police, Mattoo went underground after getting



injured in an exchange of fire with security forces in Jammu and Kashmir. He then fled to Nepal on the instructions of Pakistan's spy agency ISI. A few days ago, the Delhi Police received information that Mattoo would be coming to Delhi-NCR to collect arms and ammunition. Acting on the tip-off, sources keeping tabs on sleeper cells and weapon suppliers were activated. The

Mattoo's Pakistan-based handler would be coordinating the delivery of arms and ammunition, and he would carry out terror strikes in Jammu and Kashmir.

Mattoo, a resident of Sopore in Jammu and Kashmir, had also visited Pakistan on several occasions.

According to the police, Mattoo was part of a seven-member module of the Hizbul Mujahideen. While four of the module's members had died during gunfights with security forces in separate incidents, two are still working from Pakistan, Dhaliwal said.

Mattoo's involvement in various terrorist activities in the Jammu and Kashmir region had made him a high-priority target for law enforcement agencies.

Requesting anonymity, anoth-

er officer said Abdul Mazid Zargar, a resident of Sopore, was among Matoo's associates. Currently, Zargar is in Pakistan and he is involved in cross-border smuggling, the officer said. "Abdul Qayum Nazar was the operational in-charge of the terrorist module. He was killed in an encounter in Jammu and

Kashmir," the officer said. Tariq Ahmed Lone, another associate of Matoo, was a Pakistan-trained terrorist. Lone fell to death after he jumped from a bridge when he was surrounded by security forces, the officer added.

The officer said Imtiyaz Kundu, also Matoo's associate, fled to Pakistan in 2016. His name has surfaced in several cases in Kashmir, the officer said. Mehraj Halwai and Pakistantrained terrorist Wasim Guru, also linked to Matoo, were

killed in an encounter by secu-

Kashmir, the officer said. In 2010, Dhaliwal said, Matoo

along with his associates had killed Head Constable Mohammad Yusuf outside the Sopore police station. Matoo along with four others had in 2010 also launched an attack on the residence of the

Sopore superintendent of police. They were armed with AK-47s and had lobbed grenades at the residence, he saidIn 2012, Matoo suffered a bullet injury during another attack on the police station. Due to the injury, he faced problems while walking, police

Real face of Kejriwal stands exposed: BJP

The BJP on Thursday attacked Delhi Chief Minister Arvind Kejriwal, saying his "real face" stands exposed after Lt Governor Vinai Kumar Saxena recommended a CBI probe into alleged fake lab tests and ghost patients in the AAP Government's mohalla clinics. Reacting to AAP's charge that the BJP wants to arrest Arvind Kejriwal to prevent him from campaigning in the Lok Sabha elections, BJP said the Delhi chief minister has been behaving like a fugitive. In what could be seen as yet another setback for the AAP ahead of the Lok Sabha elections, Saxena ordered a Central Bureau of Investigation (CBI) probe into allegations of fake diagnostic tests prescribed by the Kejriwal government-run Aam Aadmi Mohalla Clinics to benefit private labs. The development comes days after Saxena ordered a CBI probe into the alleged supply of drugs that had failed "quality standard tests" to Delhi government run bespitals. ment-run hospitals.

Referring to Kejriwal skipping the ED summons over the chief Virendra Sachdeva called AAP 'choron ki baraat' (a procession of thieves) and said Kejriwal has been behaving

like a fugitive. "Since morning I have been watching the 'Choron ki Baraat' (procession of thieves) making noise and mourning for Kejriwal. When you did corruption what happened that time? You (Kejriwal) are running away from the investigation agency. You have been called three times by ED but you did not go there. Now you are mourning that you can be arrested. Delhi CM it's your responsibility to follow the rules but you are not following that," he said.

"There was only a liquor scam so far, now there is a medical scam. And its self-claimed Bharat Ratna, who claims to be outright honest, has done it (scam)," Sudhanshu Trivedi,

the BJP's national spokesperson, said during a press conference at the party headquarters in the national capital. "Amid all the drama from Vipassana meditation to poll

campaigns, the character of an outright honest (leader) is ruined completely" with the Lt Governor recommending the CBI probe, Trivedi charged. "It has become very clear that you first set up a mohalla clinic, initially started ordinary tests and then made arrangements for big tests, and eventually outsourced all these things to a private entity. It is somewhat like what had happened in the liquor scam," he added. Attacking Kejriwal, the BJP leader said this is a "moral issue" and not a technical one. 'Tens of thousands of tests were recommended prima facie to ghost patients (at ring to a note written by the Lt Governor on the alleged scam.

"That's why they used to oppose Aadhaar also so that there is no possibility of any complications (in continuing with the alleged irregularities)," the BJP leader alleged. Trivedi demanded that Kejriwal reply on the allegations, saying the Delhi chief minister is running scared of the probe agency because he knows he cannot face its ques-

Leader of Opposition in Delhi Assembly, Ramvir Singh Bidhuri slammed the Kejriwal saying the Delhi Chief Minister should cooperate with the probe agency. "Kejriwal has no right to remain in office. He should resign immediately because his government has become a breeding ground for scams, with new scandals emerging daily.

Israeli Embassy blast: Police write to Jamia for CCTV footage STAFF REPORTER NEW DELHI the suspect mo

Days after a blast near the Israeli Embassy, the Delhi Police has written to the Jamia Millia Islamia (JMI) to provide the CCTV footage from the cameras installed at the walls of sources, police suspect that one of the persons who visited the blast site at the Prithviraj Road two hours prior to the incident had come from Jamia Nagar in Southeast Delhi. He had taken an auto-rickshaw nearby the Jamia metro station. "The letter was written to the university as multiple CCTV cameras are installed at the walls of the university. These cameras are faced towards the Okhla Road from where one of the suspects in the blast took the auto-rickshaw," a police officer said.

The accused, who is yet to be identified, is believed to be the prime suspect who planted the bomb near the Israeli embassy on December 26, the officer added. Police have already questioned the auto-rickshaw driver, sources said.



Findings showed that the percentage of hospitalised Covid-19 patients admitted to during the Omicron BA.5 period continued to experience more in-hospital deaths than adults hospitalised with

The association with increased in-hospital death was strongest among adults aged 18-49 years; there was no significant difference in deaths between patients with Covid-19 and influenza among older

"The epidemiology of Covid-19 continues to evolve. Our data suggest that from the Delta-predominant period to the Omicron BA.5-predominant period, the severity of patients hospitalised with Covid-19 generally decreased," said Noah Kojima, from the CDC's Influenza Division in Georgia.

The study included 5,777 and 2,363 eligible adults hospitalised for Covid and flu, respectively. Amid the Delta variant-predominant period 1,632 were hospitalised, compared with 1,451 during the Omicron BA.5 period (June to September 2022).

During the 2011-22 respiratory virus season, 2,363 people were hospitalised for flu. Although there was a decline in the severity of COVID-19 hospitalisation during the study period, overall severity during later Omicron sublin-eage periods (BA.2 and BA.5) was generally similar.

Continued monitoring of severity trends is warranted as new variants circulate and population-level immunity changes, the team said. The reduced disease severity amid Omicron BA.5 predominance is likely multifactorial, including increased population-level SARS-CoV-2 immunity from vaccination and previous infection, broader availability of effective drugs, and refined clinical management strate-

Researchers identify enzyme responsible for yellow hue in urine

m scientists\ identified\ uro-}$ bilin as the yellow pigment in urine, but they didn't know what was responsible for the urobilin's production. Now, researchers at the University of Maryland and National Institutes of Health have found that the microbial enzyme bilirubin reductase is responsible for giving urine its yellow hue.

This unraveling of the enzyme could help researchers learn more about gut health, inflam-matory bowel disease and jaundice. "It's remarkable that an everyday biological phenomenon went unexplained for so long, and our team is excited to be able to explain it," Brantley Hall, an assistant professor in the University of Maryland's Department of Cell Biology and Molecular Genetics, said in a news statement.

Urine is a combination of water, electrolytes and waste that your kidneys filter out from your blood. It turns out urine's color is connected to the body's red blood cells, researchers said. As red blood cells degrade, a bright orange pigment called bilirubin is produced. The pigment is typically secreted into the gut, where it can then be excreted or partially reabsorbed. Once the bilirubin arrives in your gut, the microorganisms in your intestines can convert the bilirubin into other molecules, the study found.

"Gut microbes encode the enzyme bilirubin reductase that converts bilirubin into a colorless byproduct called urobilinogen," Hall, the study's lead author, said. "Urobilinogen then spontaneously degrades into a molecule called urobilin, which is responsible for the yellow color we are all

familiar with. The study authors said that before their research, scientists thought there were multiple enzymes involved, rather than a single enzyme.

Modi, Shah to attend conference of DGPs, IGPs in Jaipur on January 5, 7

Implementation of the three criminal laws enacted recently, activities of pro-Khalistani groups and terror attacks in Jammu and Kashmir are among the key issues to be discussed at a three-day conference of DGPs and IGPs in Jaipur beginning January 5, officials said on Thursday. Prime Minister Narendra Modi

will interact with the country's top police officers before addressing them at a formal session while Union Home Minister Amit Shah will be present throughout the conference that will span several sessions. Issues to be handled during the general elections, cyber crime, Maoists' problem, and interstate police coordination are some of the other major topics expected to be discussed during the meeting, a Union Home Ministry(MHA) official said. About 250 officers in the rank of Director General of Police (DGP) and Inspector General of Police (IGP) will physically attend the conference at the Rajasthan International Centre in Jaipur while more than 200 others are likely to participate

Many officers have been tasked with delivering presentations on specific subjects such as counterterrorism, online fraud, cross-border terrorism in Jammu and Kashmir, activities of pro-Khalistani groups and Left wing extremism among others, the MHA official said. There will be detailed deliberations on how to face all these emerging internal security challenges. Modi will attend conference on January 6-7, his

office said. A statement by the Prime Minister's Office said another key agenda of the conference is deliberations on the road map for implementation of the new criminal laws.

Further, the conference will also deliberate on futuristic themes in policing and security like the challenges posed by new technologies such as AI, Deepfake etc. And ways to



deal with them, it said. The conference also provides an opportunity to identify tangible action points and monitor their progress, which is also presented before the prime minister every year.

The conference is the culmination of extensive deliberations involving police and intelligence officers from district, state and national levels on identified themes, the statement said. Best practices from states and Union territories under each of the themes will be presented at the conference so that states can learn from each other, it said.

Since 2014, the prime minister has taken a keen interest in the DGP conference, it added.

Free flowing thematic discussions over breakfast, lunch and dinner have also been planned in this year's conference. This will provide an opportunity to senior police officials to share their views and recommendations on key policing and internal security issues affecting the country to the prime min-

Till 2013, the annual meet was held in New Delhi. The following year, after the Modi government came to power, it was decided to hold the event, organised by the MHA and the Intelligence Bureau, outside the national capital.

Accordingly, it was first held in Guwahati in 2014, Rann of Kutch in 2015, the National Police Academy in Hyderabad in 2016, the BSF Academy at Tekanpur in 2017, Pune in

In 2020, the meet was held virtually during the Covid pan-

demic and in hybrid mode in Lucknow in 2021. The conference was held in New Delhi in January 2023.

The number of business sessions and topics have increased significantly, with a focus on improving policing in the service of the people.

Before 2014, the deliberations largely focused on national security matters. Since 2014, these conferences have a twin focus on national security as well as core policing issues, including prevention and detection of crime, community policing, law and order and improving the police's image, among others, another official

Earlier, the conference was Delhi-centric with officers coming together only for the meet. Residing on the same premises over two to three days has served to build a heightened sense of unity among officers of all cadres and organisations since 2014, the

official added. Direct interaction of the police's top brass with the head of government has resulted in a convergence of views on crucial challenges faced by the country and the emergence of doable recommendations, the official further said.

In the past few years, the topics have been selected after detailed discussions with the highest echelons of the police

Once selected, several interactions on presentations are held before committees of DGPs to encourage participation and incorporate ideas from the field and from younger officers.

Congress renames Rahul led yatra as Bharat Jodo Nyay Yatra

Rahul Gandhi-led Manipur-Mumbai yatra starting on January 14 as the Bharat Jodo Nyay Yatra, which will travel through 100 Lok Sabha segments in 15 states including Arunachal Pradesh, and asserted it will prove to be as "transformative" as his earlier cross-country

Congress chief spokesman Jairam Ramesh said the party is inviting all leaders of the Indian National Inclusive Developmental Alliance (INDIA) bloc to join the yatra anywhere along its route.

The yatra's route was finalised at a nearly threehour meeting Congress president Mallikarjun Kharge chaired with general secretaries, state in-charges, state unit chiefs and Congress Legislature Party leaders at the AICC headquarters here, Ramesh said at AICC press con-

According to the route released by the party, the yatra would stay the longest period in Uttar Pradesh, covering 1,074 km in 11 days. It would pass through the politically-vital areas of Amethi, Rae Bareli, Varanasi and Prayagraj. Ramesh said the Bharat Jodo Nyay Yatra

would traverse 6,713 km in buses and on foot. The yatra will cover 110 districts, 100 Lok Sabha seats and 337 assembly segments in 66 days, starting January 14 from Imphal.

He asserted that the Bharat Jodo Nyay Yatra would prove to be as impactful and transformative as the earlier Bharat Jodo Yatra from Kanyakumari to Kashmir.

Explaining the reason for the renaming the yatra from the earlier Bharat Nyay Yatra, Ramesh said all members who attended the meeting including Kharge were of the unanimous view that the success of the Bharat Jodo Yatra had led to it becoming a brand in its own right and had gotten embedded in the minds of the people and that its value should not be lost.

"The 'Nyay' idea comes from the first line of the preamble of the Indian Constitution which secures for all its citizens justice -- social, economic and political," Ramesh said.

Then comes liberty, equality and fraternity and all these are all inter-related principles, he said. During the Bharat Jodo Yatra, Rahul Gandhi had raised three big issues of rising inequality, growing social polarisation and increasing political tyranny and authoritarianism, and the way out of this is to ensure justice for the people, Ramesh said.
"The idea of justice is the idea of the yatra but

because we had a yatra which proved to be transformative of Indian politics, everyone was unanimous that we should combine the two... Nyay is the objective of the yatra," he said. Ramesh also pointed out that though earlier it was announced that the yatra would cover 14 states, they also had Arunachal Pradesh in mind but there were some logistical and security



issues, which have now been sorted out. So, the yatra would now cover 15 states, including Arunachal Pradesh, he added. Giving details of the yatra and its route, Ramesh said it will begin on January 14 from Imphal and will be in Manipur for a day, covering 107 km and four districts.

Then it will enter Nagaland and cover 257 km and five districts in two days before traversing 833 km and 17 districts in Assam in eight days, Ramesh said

The yatra will then move to Arunachal Pradesh and Meghalaya for a day each.

According to the route map, the yatra in West Bengal will be for five days, covering 523 km and seven districts, and in Bihar for four days, covering 425 km and seven districts.

In Jharkhand, the yatra will cover 804 km and 13 districts in eight days, Ramesh said. It will travel through four days in Odisha, covering 341 km and four districts and in Chhattisgarh for five days, covering 536 km and seven districts. Ramesh said the east to west yatra will be of maximum time in Uttar Pradesh for 11 days, covering 1,074 km and 20 districts. In Madhya Pradesh the yatra will cover 698 km and nine districts in seven days and two districts in Rajasthan for a single day.

The yatra will cover five days each in Gujarat and Maharashtra, traversing 445 km and 479 km respectively.

The Bharat Jodo Nyay Yatra would conclude in Mumbai on March 20 or 21, Ramesh said. Asked whether AAP leaders would also be invited to join the yatra, Ramesh said all INDIA bloc leaders would be invited to join the yatra at various points of the yatra and asserted that AAP was part of the coalition.

Hospitals, blood banks can only charge processing fees for blood: DCGI

A sserting that 'blood is not for sale,' the top drug regulator, Drugs Controller General of India (DCGI) has made it clear to the hospitals and blood banks that they can charge only processing fees for blood. They have been prohibited from charging any other fees.

The move aims to check the practice of overcharging for blood by the hospitals and blood banks. In a communication to all states and UT drugs controllers cum licensing authorities, the DCGI stated that the decision was taken in view of the opinion that "blood is not for sale" Referring to the 62nd meeting

of the Drugs Consultative Committee held on September 26, 2023, the DCGI in the letter on December 26 said, "It was recommended with respect of agenda No. 18 of ATR point 3, for overcharging of blood, it was opined that blood is not for sale, it is only for supply and only processing cost may be charged by the blood centre." The revised guidelines stipulate that only processing fees can be charged for blood or blood components which ranges between Rs 250 to 1,550 for

blood or blood components. The DCGI has asked states and UT drug controllers to direct all blood centres under their jurisdiction to adhere to the revised guidelines.

According to official sources, per unit of blood in case of no blood donation is priced between Rs 3,000 to Rs 8,000 by private hospitals. In cases of blood shortage or rare blood groups, the charges may go up

Bloodshed and unrest in West Asia are not a good omen for world peace

he worst fears about the war spilling over in West Asia are coming true. The region is always simmering, marked by conflicts, regional power struggles and religionrelated intricacies. The politically unstable land is now a virtual warzone with key players such as Israel and the Hamas in Gaza and Hezbollah in Lebanon disrupting peace. Apprehensions that Israel's war in Gaza could spread across came true as twin explosions have ripped Iran, claiming more than 100 lives following a strike in Lebanon that killed the Hamas's deputy leader. More than 200 other people were wounded when the blasts, about 15 minutes apart, struck mourners commemorating slain Revolutionary Guards Gen Qasem Soleimani. Israel and Iran have long been bitter enemies. Violence involving Iran-backed groups in Lebanon, Iraq, Syria and Yemen has spiked during the Gaza war. There have been repeated, deadly exchanges of fire across the Lebanon-Israel border, attacks on ships in the Red Sea area vital for global trade, and strikes against



US-led coalition forces in Iraq and Syria. In a nutshell, West Asia is on fire. Lebanon's Iran-backed armed group Hezbollah blamed foe Israel for the strike in its Shiite Muslim stronghold of southern Beirut. This could escalate the war as Hezbollah has vowed that the killing of Aruri would not go unpunished. Lebanon, situated at the crossroads of West Asia, has been a focal point for geopolitical manoeuvring.

Hezbollah, a Shiite militant group with political and military influence, has emerged as a significant player in the region. Backed by Iran, its involvement in the Syrian civil war and ongoing tensions with Israel add a layer of complexity to the regional dynamics. The group's

ability to exert influence beyond Lebanon's borders raises questions about the balance of power in the region. Iran, a major player in West Asia, has experienced a series of mysterious explosions, adding a new dimension to the regional unrest. Economic woes, international sanctions and domestic discontent contribute to the complex political landscape within Iran. The repercussions of these events are not limited to the country's borders. The Israel-Gaza conflict exacerbates tensions, Hezbollah's influence introduces an element of sectarianism, and the mysterious blasts in Iran raise concerns about internal stability. International actors, including the United Nations and other global powers, may intensify efforts to mediate conflicts and promote diplomatic solutions. A renewed focus on dialogue and negotiation could pave the way for regional stability. The emerging politics in West Asia, shaped by the Israel-Gaza conflict, Hezbollah's influence and the Iran incidents, present a complex and volatile scenario. As global attention remains focused on the region, international actors must engage in diplomatic efforts, promote dialogue and address the root causes of conflicts. Only through a comprehensive and cooperative approach can these nations hope to achieve lasting stability and foster a more peaceful future.

The second Nakba: Palestinians are paying the price

The humanitarian crisis is getting worse with each passing day in Gaza. The clamour for ceasefire grows as civilians bear the brunt

¬he Israel-Hamas conflict, which began with a sudden attack on October 7 by Hamas resulting in the death of 1,200 Israeli civilians, the Israeli army continues its bombardment of civilian areas, including refugee camps in Gaza. This has led to 85% of the 2.3 million Gazans leaving their homes. Despite this, the Israeli Prime Minister has pledged to prolong the war until Hamas is eliminated. According to the Gaza Health Ministry, the conflict has resulted in approximately 21,507 deaths and 55,915 injuries since October 7.

Hamas, identified as an Islamic terrorist group supported by Iran and other regional actors, is the target of Israel's military action. However, critics argue that Israel's approach is causing significant harm to the Palestinian civilian population, infrastructure, environment, and biodiversity, even as it claims to be targeting only Hamas.

The Israeli army and political leadership are directing their anger towards those they believe allowed Hamas to operate in Gaza after the ini-



tial attack on October 9. While Palestinians may or may not sympathize with Hamas, it is argued that they should not be held accountable for the attack. The UN Secretary-General contextualizes the situation, stating that the Palestinian people have endured 56 years of occupation, with their land consumed by settlements and marred by violence.

The involvement of the Palestinian population in the conflict is largely involuntary, and they find themselves caught in the crossfire. The Israeli forces show no discrimination in their attacks, impacting permanent Palestinian residents who had to flee to Southern Gaza for refuge. The ongoing war sees the Israeli army targeting hostages, assaulting journalists and photographers, and obstructing UN humanitarian aid, exacerbating shortages

and electricity in the region. The indiscriminate approach to targeting both terrorists and civilians has led to deaths, disease, and displacement among the Palestinian population

Israel's confidence and unyielding stance are attributed to unwavering support from the US, which has vetoed UN resolutions for an immediate ceasefire and provided military assistance without congressional approval. The US administration justifies these actions by citing the urgency of Israel's

defensive needs. Accusations of "genocidal acts against the Palestinian people in Gaza" have prompted South Africa to approach the International Court of Justice. The British ambassador to the UN warns of a humanitarian catastrophe if the conflict continues, despite the UK joining the US in vetoing a UN ceasefire resolution. Most other countries, including India, advocate for a peaceful resolution of the conflict. Despite international calls for a ceasefire, Israel rejects them, with Prime Minister Netanyahu asserting of food, water, medicines, that the war will continue

until its conclusion. The US remains firm in its support, emphasiing its commitment

steadfast support for Israel stems more from geopolitical interests and the arms trade than a genuine commitment to Israel's well-being or a two-state solution. Concerns are raised about the potential escalation of the conflict into a regional, multi-front war involving proxy forces sup-ported by Lebanon, Syria, and Iran. To prevent further escalation, advocates for humanistic values and peace call for the cessation of hostilities, a ceasefire, and a commitment to the two-state solution as the only path to sustainable peace. The UN Secretary-General emphasises that the grievances of the Palestinian people should not justify the horrific attacks by Hamas, and these attacks should not result in the collective punishment of the Palestinian population.

INDIA AND RUSSIA GET CLOSE; THE US FROWNS

India sided with Russia in the Ukraine war despite the US pressure

The upcoming Vibrant Gujarat summit will see the highest delegation participation from Russia including from its far east. It was no surprise that the external affairs minister spent the last week of 2023 meeting senior leaders in Russia. In the two years since Russian troops stormed into Ukraine, laying claim over several parts, there has been a huge shift in geopolitics and the way India is viewed by Western powers. India was at the receiving end of severe criticism from the West and its close ally US, as it had expanded its energy purchase from Russia, which is facing sanctions. One of the first visits the external affairs minister took nearly two years back after the war broke in Ukraine, was to Washington. India patiently stood its ground on buying Russian oil and not openly condemning the war. It helped India maintain relatively stable oil prices at home when the West was going through oil-pumped

The astute diplomatic path paid off and, slowly the criticism evaporated, as the West saw merit in India buying oil from a pool different from theirs, thus cooling off prices for them. A clever phrase by PM Modi during the G20 summit declaration in 2022, that "It is not an era of war", was widely accepted across the board.



The Indian Prime Minister meanwhile met US President Biden a couple of times on multilateral platforms and topped it up with a state visit to Washington in 2023. India knows that for it to succeed in a world of competitive economic interests and politics, the US is its best bet. India managed to sign several crucial long-range bilateral cooperation agreements with the US while expanding the relationship from a defence to a technology partnership. The regular conversations between top leaders of India and the US, and the frank explanations provided to the policymakers in the US ensured that the minor glitches, if any, were sorted. It is in this context that the Indo-Russian relationship has to be viewed, which is perhaps the most stable bilateral for almost four decades. During a joint press conference with FM Sergei Lavrov of Russia, External affairs minister S Jaishankar noted, "We appreciated the fact that our trade is at an all-time high. We crossed \$50 billion turnover last year.

We expect to exceed that this year. And what is important is that this trade is more balanced. It is sustainable, and it provides for fair market access...We are today, in our trade, energy, fertilizers, and coking coal are very big components of that. We discussed mutual investments, and the need to progress on a bilateral investment treaty. We spoke about railways yesterday, about industrial zone infrastructure. We have agreed that the negotiations between India and the Eurasian Economic Union for a free trade agreement will be resumed in the second half of January this year. On energy, as I mentioned, we have today a very substantial relationship, both in terms of Indian investments in Russia and in oil and gas, which we are seeking to expand. As also in nuclear; yesterday we signed two important amendments, which will take the Kudankulam nuclear power project forward.

We also spoke about connectivity; connectivity from western India through the International North-South Transport Corridor. Also connectivity from eastern India, from Chennai to Vladivostok and the polar route." The statement sets out a roadmap for the bilateral going in for the long term. In the recent past, Russia has moved closer to China and has been on opposite sides of India's US geo-political worldview. India-China bilateral relations are in a deep freeze post the military escalations by the latter. Going into 2024 with the US and India the two largest democracies facing elections, these long-standing bilateral relationships would be widely discussed during campaigns. The Russia visit was an exercise to reiterate the importance of long-term friendships.

Unemployment: Overseas jobs is a viable solution



Given the huge labour requirement in the developed countries, India could explore job opportunities for Indians there to solve its unemployment problem

nemployment has become a major concern in recent times, especially with the widening gap between a country's economic growth and employment generation. The latest Periodic Labour Force Survey (PLFS) for 2022-23 has revealed interesting trends, resulting in a six-year low unemployment rate of 3.2%. However, despite the declining unemployment rate, the general perception is that the employment situation in the country is not positive. As such, there is a need to explore opportunities to deploy the workforce in developed countries, which could be the perfect solution to tackle the unemployment problem in the country.

India has a unique opportunity to export its young workforce and become a significant part of the workforce in developed countries. Developed nations are currently experiencing a shortage of workers, and India can leverage this opportunity by sending its surplus young workforce to these countries. To facilitate this, the Indian government has signed 17 Mobility and Migration Partnership Agreements (MMPA) with countries like Australia, Austria, France, Finland, Germany, Italy, Japan, and the UK. Additionally, agreements are underway with the Netherlands, Greece, Denmark, Switzerland, South Korea, and Taiwan to facilitate the free movement of the work-

India's economy currently ranks 5th in the world and is expected to become the 3rd largest in the future. However, there is a need to improve the relationship between the country's economic growth and employment generation, as the demographic dividend is not being fully utilized. It is concerning to note that while there are 13 million active job seekers on the Union Ministry of Labour and Employment's portal, the total number of vacancies in both private and government sectors is only 2.20 lakh.

India is the only country where the supply of young workforce is growing faster than demand. Every year, a massive 12 million young people become employ-able. This sets India apart from developed countries like the USA, Japan, and Germany which have middle-aged or elderly workforces and are facing a severe shortage of young workforce. With a young population (below 35 years) set to grow from 62% to 68% by 2030, India has an incredible opportunity to leverage its workforce and meet the demands of developed nations.

Developed countries are facing a serious shortage of workforce, leading to a rise in labour costs and inflation. While they try to keep their manufacturing and service sectors going with new technologies like Artificial Intelligence (AI) and the Internet of Things (IoT), it's important to note that this approach has its limitations. However, India has a young and abundant workforce that is motivated by a growing working-age population. Therefore, developed nations are considering India's workforce as they seek to hire skilled workers and keep the costs of their goods and services low.

SA: The latest data unequivocally shows that the USA still has three million open jobs, and it's a fact that there are not enough workers to fill them. The US Chamber of Commerce's reports paint a clear picture of countless job openings

across industries such as transportation, healthcare and social assistance, hospitality and food sectors, manufacturing, wholesale, and retail trade. According to the survey findings of the US Chamber of Commerce, nearly one in five Americans have altered their livelihood in the last three years. Among them, 17% have retired, 19% have transitioned to become homemakers, and 14% are now working part-time. Additionally, it's alarming that almost a quarter (24%) of respondents say that government aid packages during the pandemic have disincentivized them from actively seeking work. It's worth noting that younger respondents, aged 25-34, are prioritizing personal growth over job hunting right now. Shockingly, 26% of those surveyed say that they're more focused on acquiring new skills, education, or training before re-entering the job market. EUROPEAN UNION: The situa-

tion is quite alarming in Europe. The current labour shortage in Europe is a staggering 14.3 million workers. Shockingly, the European Commission predicts that the EU's workforce will shrink by 96 million workers by 2030. This potentially catastrophic workforce crunch could lead to a loss of \$1.323 trillion in unrealized annual revenue over the next six years. Despite previous strictness on

immigration policies, in the current scenario, the Greek Parliament has now approved an amendment that allows illegal migrants to receive three-year residency and work permits for specific job sectors. As a result, Greece has requested up to 10,000 farm workers from India to address their labour shortage. A significant number of workers from Punjab have already been employed in farming, factory, or construction work there.

TAIWAN: India and Taiwan are expected to sign an employment mobility agreement in February 2024. Taiwan plans to recruit up to 100,000 Indian workers for various roles in industries such as factories, farms, and hospitals. This move is due to Taiwan's ageing population, which is expected to make up over 20% of the population by 2025. To sustain its \$790 billion economy, Taiwan is seeking Indian workers and is offering pay parity and insurance benefits

to attract them. JAPAN: Japan, being the third largest manufacturing nation in the world, is facing an imminent and severe shortage of workforce. This situation is likely to have an enormous impact on Japan's ability to retain its position as a top manufacturing hub. It's been predicted that by 2030, Japan may lose out on a staggering \$194.61

scarcity of labour.

GERMANY: Germany is expected to face a significant impact on its manufacturing output due to a labour shortage, following Japan. As a leading manufacturing hub, Germany is currently experiencing a shortage of 2.4 million workers, with the situation expected to worsen. By 2030, it is estimated that Germany's unrealised revenue will increase to \$77.93 billion if the labour shortage reaches 10 million.

The need of the hour: Ministry of External Affairs' Overseas Employment Division and Skill India International Centres (SIICs) are expected to take an active role in offering immigration assistance and postplacement support.

To equip the workforce with standardization and certification of skill courses that align with International Occupational Standards, SIICs must work effectively. It is important to utilize the interconnected ecosystem fully to scale up the prospective hires of more workforce and not leave any opportunity unexplored.

Located some 200 km from Leh, Aryan Valley, historically referred to as the DhaHanu region, is a distinct area comprising five villages - Dha, Hanu, Beema, Garkhon and Darchikspread across Leh and Kargil district. The tribe is largely dependent on agricul-

jewellery, ranging from INR10000 to 70000 in value. The male attire is completed with a flower-adorned hat and Lanba Puma shoes for warmth Aryan women showcase their

allure in traditional dresses such as Stodcha (wool-made) and Lokpa (goat skin). Adorned with expensive gold and silver jewellery, including hats embellished with flowers like the ShokloMentok (Lampion flower) from their gardens, Aryan women also wear LanbaiPubu shoes. Festivals play a pivotal role in Aryan culture, with celebrations like the great harvest festival, Apricot blossoming, ChopoS rubla, and Losar featuring traditional dances and



officially recognized as the Dardi-Aryan language. Notably, Hanu is the sole village not using this local lan-guage but rather opting for Ladakhi. Elders from Hanu village share a tale of when a king forbade the use of the native language. In contrast, the villages of Dha, Garkhon,

Recognizing the importance of preserving their cultural heritage, Aryan villagers are committed to fostering the learning and teaching of their language and traditions. The community has urged

Led by former prime minister Khalida Zia, the Bangladesh Nationalist Party (BNP) is boycotting the general election on Sunday. It is demanding an interim nonparty neutral government to hold the election. The demand was rejected by the government headed by Prime Minister Hasina, who is heading the ruling Awami League.

BNP Joint Senior Secretary General Ruhul Kabir Rizvi announced the general strike at a press conference on Thursday. "The 48-hour hartal will be observed from 6 am on January 6, to 6 am on January 8," Rizvi said in a virtual press conference as last-minute preparations were underway for the 12th general elections.

The strike calls for the

"resignation of the illegal government, establishment of a non-party neutral government and release of all party leaders and activists from prison," he said. The BNP aims to garner support for its non-cooperation movement against the Awami Party-led dispensation through the strike. It has urged people not to pay taxes and utility bills to press its demand for a nonelection oversight by amending the country's Constitution.

Imam shot dead outside New Jersey mosque

ANew Jersey imam was gunned down outside his mosque before dawn on Wednesday, leaving authorities hunting for a shooter and saying they have found no evidence yet that an anti-Muslim bias played a part in the shooting. Imam Hassan Sharif was in his car when he was shot more than once at about 6 am near the Masjid-Muhammad Mosque in Newark, the state's largest city, Essex County Prosecutor Ted Stephens said at a news conference. He was taken to a nearby hospital but died in the after-

"I know that in light of global events and with a rise in bias directed at many communities state — particularly the Muslim in New Jersey right now who are feeling a heightened sense of fear or anxiety at the news of this slaying," Attorney General Matt Platkin said. Despite that, Platkin said law enforcement has stepped up outreach to houses of worship, particularly Jewish and Muslim ones, explicitly acknowledging the tensions unfolding in many parts of the world amid the fighting in Gaza since the October 7, 2023 Hamas attack on Israel.

imam at the local mosque for five years, Newark Public Safety Director Fritz Fragé said. He remembered the imam as a leader in the interfaith community who worked to keep the city safe. Taliban arrest women for 'bad hijab' and recommending they wear

The Taliban have arrested women in the Afghan capital for wearing "bad hijab," a spokesman at the country's Vice and Virtue Ministry said on Thursday. It's the first official confirmation of a crackdown on women who don't follow the dress code imposed by the Taliban since they returned to power in 2021 and has echoes with neighbouring Iran, which has enforced mandatory hijab for decades.

The development is the latest blow to Afghan women and girls, who are already reeling from bans on education, employment and access to public spaces. The spokesman from the Vice and Virtue Ministry, Abdul Ghafar Farooq, didn't say how many women have been arrested or what constitutes bad hijab.

In May 2022, the Taliban issued a decree calling for women to only show their eyes

the head-to-toe burqa, similar to restrictions during the Taliban's previous rule between 1996 and 2001. Farooq said the women were arrested three days ago. In voice notes to The Associated Press, he said the ministry has heard complaints about women's lack of correct hijab in the capital and provinces for almost two-and-

Ministry officials made recommendations to women and advised them to follow the dress code. Female police officers were sent to arrest the women after they failed to follow the advice, he added.

"These are the few limited women who spread bad hijab in Islamic society," he said. "They violated Islamic values and rituals, and encouraged society and other respected sisters to go for bad hijab." Police will refer the matter to iudicial authorities or the women will be released on

"In every province, those who go without hijab will be arrested," he warned. The arrests come less than a week after the UN Security Council called for a special envoy to engage with the Taliban, especially on gender and human

Pak court rescinds disqualification for convicts under anti-graft laws

Islamabad (PTI): A high court in Pakistan on Thursday restored 10-year disqualification for a convict under the anti-corruption laws by rescinding its earlier ruling to reduce it to five years, ending confusion over the length of disqualification following changes made in the election laws for public office holders.

The decision is likely to have an impact on various cases filed by politicians, including two former prime ministers, Imran Khan and Nawaz Sharif, ahead of the February 8 general elections.

The National Accountability Ordinance (NAO) of 1999 provided 10year disqualification for a person convicted of corruption but a single bench of the Islamabad High Court (IHC) reduced it to five years while hearing a case following the amendments made in the election laws in April last year. The changes made by the previous government headed by Shehbaz Sharif, the younger brother of Nawaz Sharif, mandated a maximum five-year period of disqualification, apparently providing relief to every convict. The National Accountability Bureau (NAB) on July 25 last year challenged the IHC single-bench order limiting the disqualification to five from 10 years as provided in the NAO.

An IHC division bench comprising Justice Mohsin Akhtar Kayani and Justice Saman Rafat Imtiaz, hearing the NAB appeal, rejected the single bench verdict and ordered to restore section 15 (disqualification to contest elections or to hold public office) of the NAO, which specifies a 10-year disqualification for convicts from seeking or from being elected, chosen, appointed or nominated" as public office holders. The restoration of original disqualification can possibly hit former premier Imran Khan who is facing cases of corruption.

His face hidden under a humble straw hat, the man stood silent, watching several helmeted rescue workers carefully lift his wife's body from the rubble, wrapped in blue plastic on a stretcher. He wiped his weary face with a rag. His eyes were red. This scene in the city of Suzu was tragically repeated across Ishikawa Prefecture and nearby regions on the western coastline of Japan after Monday's 7.6 magnitude temblor that decimated houses, twisted and scarred roads and scattered boats like toys in the waters, and prompted tsunami

The death toll stood at 81 people as of Thursday. Ishikawa officials said 47 of those who died were in the city of Wajima and 23 were in Suzu. The 11 others were reported in five neighbouring towns. More than 330 people have been injured, at least 25 seriously Those reported missing ballooned from 15 to 79 overnight, including a 13-year-old boy. Officials initially said 80 were missing but corrected the number later. What exacerbated matters was people visiting to ring in the new year with their loved ones when the quake hit.

Trump asks SC to overturn Colorado ruling US warns Houthis to cease

Former President Donald Trump on Wednesday asked the US Supreme Court to overturn a ruling barring him from the Colorado ballot, setting up a high-stakes showdown over whether a constitutional provision prohibiting those who "engaged in insur-rection" will end his political

Trump appealed a 4-3 ruling in December by the Colorado Supreme Court that marked the first time in history that Section 3 of the 14th Amendment was used to bar a presidential contender from the ballot. The court found that Trump's role in the Jan. 6, 2021, attack on the U.S. Capitol disqualified him under the clause.

The provision has been used so sparingly in American history that the US Supreme Court has never ruled on it.

Wednesday's development came a day after Trump's legal team filed an appeal against a ruling by Maine's Democratic Secretary of State, Shenna Bellows, that Trump was ineligible to appear on that state's ballot over his role in the Capitol attack. Both the Colorado Supreme Court and



the Maine secretary of state's rulings are on hold until the appeals play out.

Trump's critics have filed dozens of lawsuits seeking to disqualify him in multiple states. He lost Colorado by 13 percentage points in 2020 and does not need to win the state to gain either the Republican presidential nomination or the presidency. But the Colorado ruling has the potential to prompt courts or secretaries of state to remove him from the ballot in other, must-win states.

None had succeeded until a slim majority of Colorado's seven justices — all appointed by Democratic governors ruled last month against Trump. Critics warned that it court could not simply declare that the Jan. 6 attack was an "insurrection" without a judicial process.

The Colorado Supreme Court decision would unconstitutionally disenfranchise millions of voters in Colorado and likely be used as a template to disenfranchise tens of millions of voters nationwide," Trump's lawyers wrote in their appeal to the nation's highest court, noting that Maine has already followed Colorado's

Trump's new appeal to the US Supreme Court also follows one from Colorado's Republican Party. Legal observers expect the high court will take the case because it concerns unsettled constitutional issues that go to the heart of the way the country is

All the parties to the case have urged the court to move quickly. Trump's lawyers on Wednesday asked the court to overturn the ruling without even hearing oral arguments. The lawyers representing the Colorado plaintiffs have urged oral arguments but also seek a vastly accelerated schedule, calling for a resolution by next

Sean Grimsley, an attorney for the plaintiffs seeking to disqualify Trump in Colorado, said late last month on a legal podcast called "Law, disrupted" that he hopes the nation's highest court hurries once it accepts the case, as he expects it will.

"We have a primary coming up on Super Tuesday and we need to know the answer," Grimsley said.

The Colorado high court upheld a finding by a district court judge that Jan. 6 was an "insurrection" incited by Trump. It agreed with the petitioners, six Republican and unaffiliated Colorado voters whose lawsuit was funded by a Washington-based liberal group, that Trump clearly violated the provision. Because of that, the court ruled he is disqualified just as plainly as if he to meet the Constitution's minimum age requirement for the presidency of 35 years.

In doing so, the state high court reversed a ruling by the lower court judge that said it wasn't clear that Section 3 was meant to apply to the president. That's one of many issues the nation's highest court

Additional ones include whether states such as Colorado can determine who is covered by Section 3, whether congressional action is needed to create a process to bar people from office, whether Jan. 6 met the legal definition of insurrection and whether Trump was simply engaging in First Amendment activity that day or is responsible for the violent attack, which was intended to halt certification of Democrat Joe Biden's victory. Trump held a rally before the Capitol attack, telling his supporters that "if you don't fight like hell, you're not going to have a country anymore." Six of the US Supreme Court's nine justices appointed Republicans, and three by

Trump himself. The Colorado ruling cited a prior decision by Neil Gorsuch, one of Trump's appointees to the high court, when he was a federal judge in Colorado. That ruling determined that the state had a legitimate interest in removing from the presidential ballot a naturalized US citizen who was ineligible for the office because he was born in

attacks on Red Sea vessels

AP WASHINGTON

The United States and 12 allies issued what amounted to a final warning to Houthi rebels on Wednesday to cease their attacks on vessels in the Red Sea or face potential targeted military action. The Yemen-based militants have carried out at least 23 attacks in response to the Israel-Hamas war in Gaza since December 19. A senior Biden administration official declined to detail rules of possible engagement if the attacks continue, but underscored that the Iranian-backed Houthis should "not anticipate another warning" from the US and its allies.

The official, who spoke on the condition of anonymity under ground rules set by the White House, spoke soon after the countries issued a joint statement earlier Wednesday condemning the attacks and underscoring that international patience was strained.

The statement was signed by the United States, Australia, Bahrain, Belgium, Canada, Denmark, Germany, Italy, Japan, Netherlands, New Zealand, Singapore and the United Kingdom. Separately, the US called on the United Nations Security Council on Wednesday to take action against the Houthis and warned their financier Iran that it has a choice to make about continuing to provide support to the rebels. "Let our message now be clear: we call for the immedi-

ate end of these illegal attacks and release of unlawfully detained vessels and crews," the countries said. "The Houthis will bear the responsibility of the consequences should they continue to threaten lives, the global economy, and free flow of commerce in the region's critical waterways."

For weeks, the Houthis have claimed attacks on ships in the Red Sea that they say are either linked to Israel or heading to Israeli ports. They say their attacks aim to end the Israeli air-and-ground offensive in the Gaza Strip that was triggered by the Palestinian militant group Hamas' October attack in southern Israel. However, the links to the ships targeted in the rebel assaults have grown more tenuous as the attacks continue. The attacks have targeted commercial shipping vessels transiting through the critical Bab el-Mandeb Strait that links markets in Asia and Europe since the October 7 attack by Hamas and Israel's subsequent war against the militant group in

The US and its allies have formed Operation Prosperity Guardian to protect ship traf-fic, and currently, warships from the United States, France and the United Kingdom are patrolling the area. On Sunday, US helicopters opened fire on Houthi rebels after they attacked a cargo ship in the Red Sea, killing several of them.

The US Navy helicopters

returned fire in self-defence, sinking three of the four boats and killing the people on board while the fourth boat fled the area, the US Central Command said. The Houthis acknowledged that 10 of their fighters were killed in the confrontation and warned of consequences.

US ships in recent weeks have shot down waves of Houthi ballistic missiles and one-way explosive drones.

President Joe Biden has sought to keep the three-month war between Israel and Hamas from escalating into a broader regional conflict. But the official stressed that the US and its allies would respond similarly to such malign action that has impacts on global commerce

anywhere around the globe. "As the President has made clear, the United States does not seek conflict with any nation or actor in the Middle East, nor do we want to see the war between Israel and Hamas widen in the region," White House National Security Council spokesman John Kirby said. "But neither will we shrink from the task of defending ourselves, our interests, our partners, or the free flow of international commerce." The official said any potential action against the Houthis will be done in a "very smart way that does not potentially draw us in deep to a situation" with Iran and its proxy groups

At the UN, US deputy ambassador Christopher Lu said that without Iranian support, the Houthis "would struggle to effectively track and strike commercial vessels navigating shipping lanes through the Red Sea and Gulf of Aden".

Lanka to deploy naval vessel in Red Sea

Colombo (PTI): President Ranil Wickremesinghe has announced that Sri Lanka will provide a Navy vessel to fight attacks by Houthi rebels on merchant ships in the Red Sea, joining countries like India in protecting the levy like India in protecting the key waterway for global trade. The Iran-backed Houthi rebels have launched more than 20 attacks on merchant ships in recent weeks, claiming to take revenge against Israel for its military campaign against Palestinian terror group Hamas in Gaza. These attacks have sharply raised goods costs between Asia and Europe.

Addressing an award ceremony here on Wednesday, Wickremesinghe, who holds the defence ministry portfolio, noted that merchant shipping was hit by Houthi attacks at the Red Sea and said if the ships were to be diverted and re-routed around South Africa, the voyages would become much more expensive.

This could create (an) escalation of the cost of goods. "So we have agreed to send a Naval vessel to combat Houthi attacks in the Red Sea," he said.

The Houthis, who control most of Yemen, are currently in solidarity with Palestine because of the ongoing Israeli-Hamas conflict in Gaza. The Houthi attacks centred on the Red Sea's Bab al-Mandeb southern chokepoint have disrupted shipping in a waterway that carries about 12 per cent of global trade, according to the Times of Israel news-

The rebel group will continue their attacks until more aid enters the Gaza Strip, where Israel is at war with the ruling Hamas terror group following its devastating Öctober 7 attack that killed over 1,200 people in Israel, the report said.

Last month, an Indianflagged crude oil tanker was among two vessels that came under drone attacks by the Houthi rebels in the Southern Red Sea, according to the US Central Command. Indian Navy on Wednesday said its ships and aircraft remain "mission deployed" for maintaining enhanced surveillance and undertaking maritime security

Iran suspects attack carried out by suicide **bombers**

Dubai (AP): Investigators believe suicide bombers likely carried out an attack on a com memoration for an Iranian general slain in a 2020 US drone strike, state media reported on Thursday, as Iran grappled with its worst militant attack in decades and as the wider Mideast remains on edge. The report by the state-run IRNA news agency quoted an unnamed "informed source." Wednesday's attack in Kerman killed at least 84 people and wounded another 284. It targeted a ceremony honoring Revolutionary Guard Gen. Qassem Soleimani, held as an icon by supporters of the country's theocracy and viewed by the US military as a deadly foe who aided militants who killed

American troops in Iraq.

No group has yet to claim responsibility for the attack. The IRNA report quoted the official as saying that surveillance footoge from the route to the footage from the route to the commemoration at Kerman's Matryrs Cemetery clearly showed a male suicide bomber detonating explosives. The official said the second blast "probbomber, though it hadn't been determined beyond doubt.

UK statistics watchdog 'looking into' Rishi Sunak's asylum backlog claim

m he}$ UK's statistics watchdog on Thursday said that it is "looking into" the government's recent announcement that it had met Prime Minister Rishi Sunak's target to clear the country's asylum backlog by the end of 2023, a claim strongly contested by the Opposition.

Earlier this week, the UK Home Office said that 112,000 asylum cases were processed in the past year, which exceeded Sunak's initial target of 92,000 applications pending at the

However, the Opposition Labour Party had contested this and accused the government of "misleading" the public. It has now emerged that a formal complaint is likely to have been raised with the Office for Statistics Regulation (OSR),



which independently monitors the use of official statistics. "The Office for Statistics

Regulation confirmed it is looking into the government announcement about the asylum backlog," said a spokesperson for OSR.

While the OSR can ask for additional information from the Home Office, it does not have the power to compel data to be provided. It can, however, withdraw the high quality "kitemark" it provides the Home Office with reference to their statistics released over the course of the year. In a statement from

Tuesday, the Home Office claimed that fundamental changes to the decision-making process and boosting efficiency resulted in the highest annual number of "substantive" asylum decisions in a year since 2002. It cited the use of stepped up processing, deploying an additional 1,200 caseworkers, meeting the target to double the number of asylum caseworkers and tripling productivity to ensure more illegal migrants are returned to their

country of origin quicker. All cases in the so-called "legacy backlog" were said to have been reviewed, with 86,800 decisions made. In one

November 20 to December 17, 2023, there were 20,481 initial asylum decisions made, this is more than the number of asylum decisions made in the entirety of 2021, the Home Office statement said.

Around 4,537 claims from the so-called legacy backlog still needed a decision but Sunak's spokesperson at 10 Downing Street said that since these had been reviewed, the government considers them as The government describes

these as complex cases, typically involving "asylum seekers presenting as children - where age verification is taking place; those with serious medical issues; or those with suspected past convictions, where checks may reveal criminality that

UK junior docs' strike enters second day

London (PTI) :The health service in England is facing its second day of strikes by junior doctors on Thursday as an Indian-origin medic, also a senior office bearer of their union, urging the government to make a "credible" pay offer so the six-day industrial action can be called off.

With over 1.2 million appointments already rescheduled since industrial action began, Dr Vivek Trivedi, cochair of the British Medical Association (BMA) Junior Doctors Committee, told the BBC that they are willing to negotiate to end the longest strike in the history of the National Health Service (NHS).

"We strike again today. Tag @BMA_JuniorDocs in all your posts and we'll keep sharing!," the official X handle of the British Medical Association (BMA) Junior Doctors posted early Thursday morning along

the hashtag #PayRestoration. The X post also provided a link which had guidance (for their units across the country) on strike action. Among the other things, the link to the website also has 'Our aims', which lists three main demands of the junior doctors in the NHS in England taking strike action in 2023 and 2024.

Apart from the demand to "achieve full pay restoration to reverse the steep decline in pay faced by junior doctors since 2008/9", the Junior Doctors also want the government to "agree on a mechanism with the Government to prevent any future declines against the cost of living and inflation" and "reform the DDRB (Doctors' and Dentists' Review Body) process so pay increases can be recommended independently and fairly to safeguard the recruitment and retention of junior doctors?

Airstrike in Baghdad kills | Extreme cold leaves Iran-backed militia leader | many without power

n airstrike on the logisti-An airstrike on the logistical support headquarters of an Iran-backed militia in central Baghdad on Thursday killed a high-ranking militia commander, militia officials said. Thursday's strike comes amid mounting regional tensions fuelled by Israel-Hamas war and fears that it could spill over into surrounding coun-

The Popular Mobilization Force - a coalition of militias that is nominally under the control of the Iraqi military announced in a statement that its deputy head of operations in Baghdad, Mushtaq Taleb al-Saidi, or "Abu Taqwa," had been killed "as a result of brutal American aggression."

It was not immediately clear who had carried out the strike. Officials with the US military and embassy in



Baghdad did not immediately respond to requests for comment.

The strike killed two people and wounded five, according to two militia officials who spoke on condition of anonymity because they were not authorised to speak pub-

One of the officials said al-Saidi was driving into the garage of the headquarters affiliated with the al-Nujaba militia, one of the members of the PMF, along with another militia official when the car was hit, killing both.

Heavy security was deployed around the location of the strike on Baghdad's Palestine Street, and Associated Press journalists were not allowed to approach the targeted building. Iraqi war planes could be seen flying overhead.

Israel-Hamas war on October 7, a group of Iranian-backed militias calling itself the Islamic Resistance in Iraq has carried out more than 100 attacks on bases housing US troops in Iraq and Syria.

The group has said the attacks are in retaliation for Washington's support of Israel in the war against Hamas that has killed more than 20,000 people in Gaza, and that they aim to push US forces out of

in Nordic countries

Copenhagen (AP): Extremely cold temperatures compounded by gale-force winds and snow wreaked havoc across the Nordic region on Thursday, leaving thousands without power while others braved the cold for hours stuck in their cars along clogged highways.

Heavy rains in Germany, France and the Netherlands again caused floods in regions that have seen persistent flooding in the last two weeks. One death was reported in France.

The deep freeze disrupted transportation throughout the Nordic region amid reports of traffic chaos following closures of sections of highways and major roads. Problems with rail service have also been reported.

Electricity was cut to some 4,000 homes in Arctic Sweden where temperatures plummeted to minus 38 degrees Celsius (minus 36.4 degrees Fahrenheit), according to Swedish public radio. In the southern part of the country, motorists were stuck in their cars or evacuated to a nearby sporting complex where they spent the night. In neighbouring Denmark, police urged motorists to avoid unnecessary trips as wind and snow battered the northern and western parts of the country. In Finnish Lapland, the municipality of Enontekio, near the border with Norway and Sweden, recorded the country's lowest temperature this winter on Thursday (minus 44.5 degrees F).

US judge attacked by defendant in courtroom

A Nevada judge was Aattacked on Wednesday by a defendant in a felony battery case who leaped over a defence table and the judge's bench, landing atop her and sparking a bloody brawl involving court officials and attorneys, officials and witnesses said.In a violent scene captured by courtroom video, Clark County District Judge Mary Kay Holthus fell back from her seat against a wall and suffered some injuries but was not hospitalised, courthouse officials said.

A courtroom marshal was also injured as he came to the judge's aid and was hospitalised for treatment of a bleeding gash on his forehead and a dislocated shoulder, according to the officials and witnesses. The attack occurred about 11 am at the Regional Justice Centre in Las Vegas.

The defendant, Deobra Delone Redden, 30, was wrestled to the floor behind the judge's bench by several court and jail officers and courtroom staff members including some who are seen throwing punches.

He was arrested and jailed at the Clark County Detention Centre, where records showed he faces multiple new felony charges, including battery on a protected person — referring to the judge and court officers

"It happened so fast it was hard to know what to do," said Richard Scow, the chief county district attorney who pros-

ecuted Redden on a case that stemmed from an arrest last year on allegations that Redden attacked a person with a baseball bat. Redden's defence attorney, Caesar Almase, did not respond to later telephone and email messages seeking comment. Redden was not in cus-

tody when he arrived at court on Wednesday. He wore a white shirt and dark pants as he stood next to Almase, asking the judge for leniency while describing himself as "a person who never stops trying to do the right thing no matter how hard it is".

"I am not a rebellious person," he told the judge, later adding that he does not think he should be sent to prison. "But if it is appropriate for you then you have to do what you have to do." As the judge made it clear

she intended to put him behind bars, and the court marshal moved to handcuff him, Redden yelled expletives and charged forward amid screams from people who had been sitting with

Redden in the courtroom

audience. Records showed that Redden, a Las Vegas resident, was evaluated and found mentally competent to stand trial before pleading guilty in November to a reduced charge of attempted battery causing substantial bodily harm. He previously served prison time in Nevada on a domestic battery conviction,

state records show. Holthus, a career prosecutor with more than 27 years of courthouse experience, was elected to the state court bench in 2018 and again in 2022.

In a statement, court spokeswoman Mary Ann Price said officials were "reviewing all our protocols and will do whatever is necessary to protect the judiciary, the public and our employ-







INDIA RECORD HISTORIC VICTORY IN CAPE TOWN

asprit Bumrah, India's priceless fast bowling mean machine, produced a hostile spell to guide India to a serieslevelling seven-wicket victory against South Africa in the shortest game ever played in Test

Bumrah (6/61 in 13.5 overs), the master practitioner of fast bowling, knocked the stuffing out of South Africa's middle-order in a menacing morning spell though Aiden Markram (106 off 103 balls) fought like a lone ranger on a burning deck to take South Africa to 176 in 36.5 overs at stroke of lunch on day two. A target of 79 even on the toughest of tracks wasn't exactly a tall order and young Yashasvi Jaiswal (28) threw his bat around before skipper Rohit Sharma (16 not out) completed the formalities in the company of Shreyas Iyer (4 not out off 6) in just 12

This was India's first victory at Newlands in seven attempts and one that would be remembered for the hostility exhibited by two Indian fast bowlers Bumrah and Mohammed Siraj, who produced a career-best sixwicket haul to bowl out South Africa for 55 in the first innings. ICC amends stumping, concussion substitute rules

The International Cricket Council (ICC) has effected a notable change in playing conditions, as per which the umpires henceforth will only assess the side-on replays for stumping without considering the caught-behind scenario during the Decision Review System (DRS) referrals.
The modification has come

into effect on December 12, 2023 and accordingly if a team wants to refer to caught-behind in the process of a stumping, it will now have to exercise a DRS option for the caught-behind appeal separately. In the series against India early

last year, Australian wicketkeeper, Alex Carey widely used review for caught-behind after a stumping without exhausting the team's DRS option. Now, the appeal for stumping will only display images from

umpires will only consider them as they will not inspect for a snick. "The change confines a stumping review to only check for stumped, therefore preventing the fielding team a free review for other modes of dis-

The ICC has also brought in more clarity in concussion replacement rule. Now, the substitute player will not be permitted to bowl if the replaced player was suspended from bowling at the time of the concussion.

Similarly, the global governing body also has limited to four minutes the time set for on field injury assessment and treatment.

Along with these ICC rule changes, the BCCI has also decided to continue the 'Dead Ball' and two bouncers per over rules that it implemented during last year's Syed Mushtaq Ali Trophy and Vijay Hazare Trophy in the Ranji Trophy beginning on Friday.

The 41-time champions' last Ranji triumph came in the 2015-16 season and since then they have struggled to maintain their supremacy in the domestic cirThey will hope that Rahane, an astute leader and tactician, can change their fortunes this time. Similarly, Karnataka's Mayank Agarwal, who was the highest run-getter the previous season with 990 runs, will want another massive season under his belt. At some stage, an opening slot could open in the Indian team, currently filled by captain Rohit Sharma and the young Yashasvi Jaiswal, and Agarwal would not want to miss that chance.

There are some serious contenders for the opening slot such as Bengal's Abhimanyu Easwaran, who is currently in South Africa as a replacement for the injured Ruturaj Gaikwad. So, Easwaran will not be playing
