

Security tightened in Delhi ahead of praan pratishthaa

Delhi Police is making adequate security arrangements, including using drones, across the national Capital ahead of the "praan pratishthaa" ceremony at the Ram temple in Ayodhya on January 22 and the Republic Day celebrations.

"Security has been beefed up across the national capital ahead of praan pratishthaa and the Republic Day. Our forces are already taking out flag march in several sensitive areas identified by the department," a senior police officer said.

The officer added the Delhi Police is "keeping an extra vigil in those sensitive areas" and "using drones to monitor

More than 8,000 police personnel have already been deployed in Delhi for the January 26 parade across the national capital.

The night patrolling staffers, who have been directed to check hotels, guest houses and dharamshalas, are checking security measures in place at these facilities, particularly near the railway stations and interstate bus terminals, and their records to know who are visit-



ing the national capital and for

what purpose.

"Different markets of Delhi like Chandni Chowk, Sadar Bazaar, Chawri Bazaar, Khari Baoli, Kashmiri Gate, Naya Bazaar, Connaught Place, Lajpat Nagar, Sarojini Nagar, Bhagirath Place, Kinari Bazaar and several other big or small markets are making their arrangements for January 22," the police officer said.

"Several temples like Prachin Hanuman Mandir, Jhandewalan Mandir, Birla Mandir and Kalka Ji temple will celebrate praan pratishthaa. We are also expecting high footfall and additional security forces will be deployed to maintain law and order situation," he added.

Action is being taken against

anyone found to be violating rules under Section 188 (disobedience to order duly promulgated by public servant) of the Indian Penal Code (IPC), police said.

Another senior police officer said the "Ministry of Home Affairs has issued directions for verification of tenants and servants, border checking, security of vital installations, malls and markets, and patrolling in areas drawing heavy footfalls".

"Those who are not following the orders, we are taking strict action against them and registering the FIR," he added. The police said that they used drones to monitor the sensitive areas of the northeast district on Tuesday, adding a flag march was taken out on

Airspace restrictions imposed for 11 days from January 19

Airspace restrictions will be in place in the national capital for 11 days starting from January 19, in connection with the Republic Day preparations and celebrations, according to an official. The restrictions, which will be in force till January 29, will not impact scheduled flights.
Landing or take-off of non-scheduled flights of scheduled

airlines, and chartered flights will not be permitted from 10 am to 1.15 pm during the January 19-25 period, the official said on Tuesday.

As per the NOTAM issued by the Airports Authority of India (AAI), these restrictions will be in force from 6 am to 9 pm during the period from January 26

Generally, a NOTAM (Notice to Airmen) is a notice with information that is essential to personnel involved in flight operations.

3 new district court complexes approved

The Arvind Kejriwal government's Expenditure Finance Committee (EFC) has approved three new district court complexes in Rohini Sector-26, Shastri Park and Karkardooma. After the completion of these three projects, Delhi's District Court will witness an increase of 200 courtrooms. Sharing about the projects, Finance Minister Atishi said keeping the convenience of judges, lawyers, and citizens in mind, these three projects will incorporate better public facilities.

The 11-storey new District Court Complex in Rohini Sector-26 will feature 100 new courtrooms and 270 lawyer chambers, along with modern facilities. The complex will consist of 3 basements, a ground floor, and two 11-storev building blocks. It will house 100 courtrooms and 270 lawyer chambers. The total cost of this project is estimated to be Rs 714.19 crore.

Additionally, a new District Court Complex in Shastri Park will include 48 courtrooms and 175 lawyer stations. The total cost for this project is estimated to be Rs 184.91 crores. The third project involves constructing an additional court block near the existing court in Karkardooma. This new court block will have 50 new courtmated to be Rs 199.39 crores.

The Finance Minister said currently, there is a considerable backlog of pending cases on



judges and courts nationwide, leading to unnecessary delays in case resolutions. "In this context, the commitment of the Kejriwal government to provide sufficient judicial infrastructure in the capital is crucial. The government's dedication to building 200 new courtrooms in Delhi in this direction proves to be highly significant in strengthening the judicial system.

"These three projects are highly significant in the direction of enhancing Delhi's judicial infrastructure, and their completion will greatly aid in the swift resolution of legal matters," Atishi said.

She also said that the Kejriwal government is actively working on a war footing to address the shortage of courtrooms in Delhi's district in this direction. Keeping the convenience of judges, lawyers, and citizens in mind, these three projects will incorporate better public facilities.

In a breather to the Paan Masala manufacturers, the country's top food regulator, Food Safety and Standard Authority of India (FSSAI) has extended the deadline for the third time in a row to them to comply with the provision of bigger health warnings on pan masala packets.

The manufactures are now provided a timeline up till May 1, 2024, instead of November 1, 2023, to comply with the requirement of the warning statement that 'Chewing of pan masala is injurious to health' must cover half i.e. 50%

Contrary to the last two extensions since May 1, 2023 when

The move comes in the wake of representations received from various associations, federations, and industry stakehold-ers, who have sought additional time to comply with the specified amendment as per Schedule II of the Food Safety and Standards (Labelling and Display) Second Amendment Regulations, 2022, said the Apex food regulator.

LG okays Delhi forensic laboratory posts restructuring

Kumar Saxena has approved the restructuring of Scientific, Ministerial, Information Technology and Accounts Cadre posts in the Forensic Science Laboratory (FSL), in the national capital. The restructuring of the FSL Delhi cadre will be at par with the cadre structure of Directorate of Forensic Science Services (DFSS), Ministry of Home Affairs, Government of

According to a Press statement by Raj Niwas the exercise for restructuring of the cadre which was carried out at the LG's insistence with an aim of meeting the laboratory's requirements, has resulted in the creation of 420 additional posts and abolition/surrender of 144 posts of various categories, which had become redundant.

Further, as per directions issued by Saxena, a separate file is being submitted to the Administrative Reforms and IT Department in respect of 80 posts of Junior Scientific Officer and 10 posts of Data Entry Operators

The proposal relating to creation/abolition of various posts of Scientific, Ministerial, IT and Accounts Cadre posts in FSL, Delhi was submitted by FSL/Home Department, GNCTD in pursuance of meeting dated 23.11.2022 held

Residents are advised to store sufficient water, and water tankers will be available on request, it said in a notice.

'Due to installation of flowmeter in South Delhi rising main at Sonia Vihar WTP and other maintenance works, the water supply in South Delhi main from Sonia Vihar Water Treatment Plant shall remain affected for 16 hours. The water supply will not be available on January 18 from 10 am to morning of January 19," the notice said.

The DJB said water supply will be affected in Kallash Nagar, Sarai Kale Khan, Jal Vihar, Lajpat Nagar, Moolchand Hospital, Greater Kailash, Vasant Kunj, Devli, Ambedkar Nagar, Okhla, Kalkaji and Govindpuri.

(APMC) Giving details, Rai said, "The board has given the green signal to a budget of Rs 544.80 crore for the development of mandis. For the financial year 2024-25, the board has allocated approximately Rs 225.96 crore to APMC, Azadpur; Rs 20.07 crore to Fruit & Vegetables Market, Ghazipur; Rs 21.27 crore to FP & EMC Ghazipur; Rs 8.63 crore to Flower Market; Rs 21.77 crore to APMC Keshopur; Rs 31.36 crore to APMC, Narela; Rs 5.36 crore to APMC, Najafgarh and Rs 210.40 crore to DAMB."

National Green Tribunal (NGT) has imposed a cost of Rs 15,000 on the Delhi forest department for the non-submission of a proper report by a panel formed earlier to find the factual position regarding the alleged violations of green norms at Chief Minister Arvind Kejriwal's residence. The NGT also directed the Delhi government and its public works department (PWD) to pay a cost of Rs 10,000 each for not submitting their reports according to the tribunal's earlier directions.

The NGT was hearing a petition that alleged the raising of permanent and semi-permanent constructions and the



felling of more than 20 trees for developing structures at 6, Flag Staff Road (the chief minister's residence) and 45-47, Rajpur Road (properties adjoining it).

In May last year, the tribunal formed a joint committee for ascertaining the factual position. The committee comprised the chief secretary and principal secretary (environ-

Long Covid patients at higher risk of digestive diseases: Study

m f}$ you had or suffer from long Covid-19, chances are you have a higher risk for digestive diseases, for at least up to one year, says a study published in the journal BMC Medicine.

It has shown that people who suffered both severe and mild Covid-19 infections suffered from digestive diseases like gastrointestinal (GI) dysfunc-

tion, peptic ulcers, gastroe-

sophageal reflux disease

(GERD), gallbladder disease,

nonalcoholic liver disease, and pancreatic disease. Our study provides insights

into the association between Covid-19 and the long-term risk of digestive system disorders. Covid-19 patients are at a higher risk of developing digestive diseases," said the researchers in the paper.

"The risks exhibited a stepwise escalation with the severity of COVID-19, were noted in cases of reinfection, and persisted even after 1-year follow-up. This highlights the need to understand the varying risks of

digestive outcomes in Covid-19 patients over time, particularly those who experienced reinfection, and develop appropriate follow-up strategies," they added.

In the study, the team from Southern Medical University in China and the University of California Los Angeles, US, compared rates of digestive diseases among Covid survivors 30 or more days after infection (112,311), a contemporary comparison group (359,671), and a pre-Covid group (370,979) in the UK.

PRAAN PRATISHTHAA OF RAM BEGINS

The installation of the new statue of Ram Lalla in the revered Ram Temple in Ayodhya has entered a significant phase with the initiation of Praan Pratishthaa rituals starting on Tuesday. The sacred ceremonies will continue over the next seven days, culminating on January 22.

The commencement of the Karmakuti puja took place at the construction site of Lord Ram Lalla's idol at 1 pm on

Tuesday. Prior to this, a thorough cleanliness drive was carried out in the Ram Janmabhoomi complex, and the temple itself was cleansed with water from the holy Sarvu River.

While earlier reports hinted at Prime Minister Narendra Modi being the main Yajmaan during the Praan Pratistha, individuals involved with the ceremony clarified that PM Modi will play a symbolic role rather than being the main host. Pandit Ganeshwar Dravid, determined the auspicious participate

time for Praan Pratisthaa, Pandit Laxmikant Dixit, the officiant of the Praan Pratishthaa in the Ram temple, and Swami Ramvinay Das, the general secretary of Shrimath Trust of Ramanand sect, shared insights into the hosting arrangements.

All three affirmed that Shri Ram Janmabhoomi Trust member Anil Mishra and his wife will be the chief hosts (Yajman) for the seven-day ritual, overseeing resolutions, atonement, and worship of who Lord Ganesha. They will also

consecration of Ram Lalla's life. According to them, the decision stems from the belief that only a householder can be the primary host for the Ram Lalla Praan Pratishthaa ritual, hence the selection of Anil Mishra and his wife. Ganeshwar Shastri Dravid

clarified that only a householder, accompanied by his wife, can participate in the Praan Pratishthaa and puja for the entire duration of seven days. Therefore, PM Modi will witness the main ritual in the sanctum sanctorum but will not be the main host. This

decision follows the pattern set during the foundation stone-laying ceremony of the Ram Mandir in 2020, where Ravindra Narayan Singh and his wife were the hosts. Pandit Venkatraman Ghanpathy, trustee of Srikashi Vishwanath Temple and a scholar involved in the Ram Mandir Praan Pratistha, added that Prime Minister Modi's role will primarily involve his presence in the sanctum sanctorum on January 22, participating in specific rituals.

The remaining puja will be conducted by trustee Anil Mishra and his wife. "Despite PM Modi's role being svmbolic, the strict observance of Yama Niyama will be followed for a full 11 days, including eating fruits once a day," he said. Meanwhile, Ram temple chief priest Acharya Satyendra Das said that the "anushthan" has started and will continue until January 22, the day of the consecration ceremony. Eleven priests are performing the rituals, invoking all the "devis and devtas".

There are 121 "acharyas" who are conducting the rituals, Ganeshwar Shastri Dravid is overseeing, coordinating, and directing all proceedings of the "anushthan". The principal "acharya" will be Laxmikant Dixit of Kashi. The Ram temple "Praan Pratishthaa" will begin at 12:20 pm on January 22.



In an order, it said those directives "do not apply to online courses intended to be pursued by government servants on iGoT Karmayogi".

Kavitha skips ED questioning in Delhi excise policy case: Officials

 $B^{\text{RS leader Kavitha K did not}}_{\text{appear before the}}$ Enforcement Directorate (ED) on Tuesday for a fresh round of questioning in connection with a money-laundering case linked to the Delhi excise policy, officials said. The 45-year-old daughter of

former Telangana chief minisunderstood to have communicated her decision not to comply with the ED summons to the investigating officer through an email.

Her lawyer, Nitesh Rana, said that "there is a Supreme Court order that has said that the ED cannot summon Kavitha in this case". However, ED sources have said that the BRS leader had obtained a temporary relief from the apex court last year and it is not valid now.

The federal agency might issue a fresh summons to her. The



decision in this context soon. Kavitha K or Kavitha Kalvakuntla was questioned thrice last year in connection with the case and the ED had recorded her statement under the Prevention of Money Laundering Act (PMLA).

Centre sets up tribunal to assess if Tehreek Hurriyat in Jammu and Kashmir is unlawful

The Centre on Tuesday set up a tribunal consisting of a Delhi High Court judge to adjudicate if there is sufficient ground for declaring pro-Pakistan separatist Tehreek-e-Hurriyat, Jammu and Kashmir, as an unlawful association.

The Jammu and Kashmirbased group, founded by Ali Shah Geelani, was declared outlawed by the government on December 31 under the Unlawful Activities (Prevention) Act, 1967, for five years.

In a notification, the Union Home Ministry said exercising the powers conferred by subsection (1) of section 5 read with sub-section (1) of section 4 of the Unlawful Activities (Prevention) Act, 1967, (37 of 1967), the Central government constituted the Unlawful Activities (Prevention) Tribunal consisting of Justice Sachin



dicating whether or not there is sufficient cause for declaring the Tehreek-e-Hurriyat (TeH), Jammu and Kashmir, as an unlawful association. The organisation was declared

banned as it has been fomenting terrorism and spreading anti-India propaganda in the Union territory.

While imposing the ban on the separatist amalgam, the Union Home Ministry had said it is known for its involvement in fomenting terrorism and antisecessionist activities in Jammu and Kashmir. The TeH's objective is to separate Jammu and Kashmir from India and establish Islamic rule in Jammu and Kashmir. The ministry said the leaders and members of the TeH have been involved in raising funds through various sources, including Pakistan and its proxy organisations, for perpetrating unlawful activities, including supporting terrorist activities and sustained stone-pelting on

the security forces in Jammu

and Kashmir.

The ministry said the TeH and its members by their activities show sheer disrespect towards the constitutional authority and constitutional set up of the country. The TeH members are also pay-

ing tributes to the terrorists, who were killed in encounters with the security forces and its members have been involved in supporting terrorist activities with an intent to create a reign of terendangering the security and public order of the state, the notification said.

Challenges mount for INDIA bloc as likely partners choose to go it alone and seat-sharing woes persist

he INDIA bloc, a potential alliance aimed at consolidating the Opposition forces and taking on the BJP in the Lok Sabha elections, is facing setbacks one after the other. The latest hiccup comes with BSP supremo and former UP Chief Minister Mayawati's decision not to be part of the conglomeration. This puts the very basis of the alliance at risk as it defeats the main purpose of preventing the split of Opposition votes. Mayawati's decision could seriously jeopardise the INDIA bloc's chances in Uttar Pradesh, which sends the largest number of MPs to the Lok Sabha. Another stumbling block for the INDIA bloc comes from within its ranks, as the West Bengal unit of the Congress has advised its central leadership against aligning with the Trinamool Congress (TMC). This internal discord poses a significant challenge to the alliance's goal of presenting a united and formidable challenge to the BJP. The TMC had earlier offered two seats to Congress, which was



frowned upon by the larger party. But this is not all: It is nothing compared to the seat-sharing arrangements that are yet to be stitched up. While regional parties are crucial to secure votes in their respective strongholds, they are often reluctant to cede too many seats to the Congress. The Congress, seeking to re-establish itself as the main political force, is eager to secure a substantial number of seats. However, convincing regional players to relinquish their claims in favour of the Congress poses a complex challenge that requires delicate negotiation and compromise. The reluctance of regional parties to concede more

seats to Congress stems from a variety of factors. Many satraps fear that a disproportionate allocation of seats could weaken their own political standing and bargaining power. To put things in perspective, the problems that the INDIA bloc faces today were all on the cards when it all began. The Opposition managed to cobble up an alliance of the opposition parties who were ideologically separated and at cross-purpose with each other in the electoral matrix. The only common factor was their resolve to defeat the BJP. But as time progressed, the leaders realised that even if the BJP were defeated, they would also get marginalised if they do not assert themselves now. This notion is at the bottom of the INDIA bloc's woes. It can only be resolved if the regional parties agree to dilute their egos and compromise their party standing in their respective States, a tall order indeed. The Congress party, on the other hand, is grappling with its own share of problems as its leaders are deserting it. Overcoming these challenges will require strategic leadership, adept negotiation skills and a commitment to placing collective interests above individual ambitions. The ability of the INDIA bloc to surmount these obstacles will ultimately determine its effectiveness in the general elections.

Heed electoral math to win LS elections



Emulating successful coalitions like the Janata Party, United Front and National Front could prove advantageous for the opposition parties in the forthcoming elections

responsibilities have increased with the decision of the INDIA bloc to name Congress President Mallikharjun Kharge as the President. Bihar Chief Minister Nitish Kumar has declined the post of convenor. Forming partnerships before elections is relatively easy, but the real challenge lies in agreeing on seats. How difficult is seat-sharing for the INDIA Bloc, and can the Opposition overcome the obstacles before the polls?

The Congress party is leading a coalition of 26 partners to find a solution that satisfies everyone. They have decided to nominate a single candidate to contest against the Bharatiya Janata Party to prevent the opposition vote from being divided. However, the Congress-led coalition finds itself in a difficult position as most regional parties are bargaining hard for more seats, which could only come at the cost of the Congress party's interests. Mallikarjun Kharge has instructed the Party to initiate talks with other allied leaders to address this dilemma. It indicates that the Congress was prepared to contest in fewer seats, this time to accommodate the partners. The Congress party had formed alliances with other political parties in several states before the elections. It joined with DMK in Tamil Nadu, RJD. JD (U) in Bihar, and JMM. in Jharkhand. Although these alliances continue, the Congress knows that seat-sharing will be challenging in certain states, particularly Delhi, Punjab, West Bengal, and Uttar Pradesh. The Congress party is currently trying to strike a balance between meeting the needs of their Party and their allies. It faces the challenge of maintaining positive relationships with its regional partners. The Congress's local units differ with the top leadership about giving away seats to partners. Seeing the reality, Kharge has directed the Party's alliance committee to put in extra efforts to accommodate allies. He has also reached out to opposition leaders to coordinate with the INDIA Bloc.



against non-BJP parties in Andhra Pradesh, Kerala, Odisha, and Telangana. The Congress will share space with the CPI (M) in West Bengal and Tripura. In the past, Congress wielded significant political power in Delhi and Punjab. However, the Aam Aadmi Party (AAP) has emerged as a strong contender against Congress' dominance, as it now holds power in both states. While the Congress aims for four seats in Delhi and seven in Punjab, the ruling AAP. The party seeks a larger share of seats.

Additionally, the AAP plans to contest in other states like Goa, Haryana, and Gujarat. The Chief Minister of West Bengal, Mamata Banerjee, will be in control of her state. Meanwhile, in Jharkhand, the Congress, Jnarknana Mukti Morcha (JMM), and Rashtriya Janata Dal (RJD) are aiming to secure The Congress will fight against a larger share of seats than the BJP directly in 13 states and their partners in the INDIA

They formed alliances in some states and contested in fewer seats, such as nine in Bihar, seven in Jharkhand, 21 in Karnataka, 25 in Maharashtra, and nine in Tamil Nadu. However, they contested in 70 out of 80 seats in Uttar Pradesh.

Congress has less chance of defeating the BJP on its own. It will not contest the 272 seats required to form the government independently but may contest 255 seats, the lowest ever. Its best-case scenario is to win 125 seats. As a key player, the Congress should focus on directly challenging the B.J.P. in over 190 seats, with strong leaders fielded from constituencies. The Party needs to strengthen the booth committees at the ground

FLIGHTS DISRUPTED

Sir — In the last two days, Delhi's Indira Gandhi International (ÍGI) Airport has experienced significant disruptions, with nearly 600 flights delayed and 76 cancelled owing to dense fog and poor visibility. This has caused a ripple effect across airports in the country. As per sources, the primary reason for the chaos is the limited operational capacity of the airport's runways. Currently, Delhi airport has only one Category-III Instrument Landing System (CAT III ILS)-equipped runway designed for operations in low visibility. The second runway, 28/10, is undergoing re-carpeting, making it temporarily unusable. This has led to a heavy reliance on a single runway, 29/11, which is equipped to manage operations when visibility drops below 200 m.The runway constraints have led to delayed arrivals and departures. On 14 January, departures were halted until 11.00 am owing to visibility below the minimum level of 125 m. Flights faced considerable delays, with some waiting for over two hours to be assigned parking bays for de-boarding. Airline officials argue for a change in the departure sequence assignment. They suggest assigning the sequence based on the scheduled time of departure rather than boarding status. This could streamline the process during disruptions caused by weather conditions.

MSMEs need cost institutional credit



Government action is needed to enhance global competitiveness and credit access for MSMEs. Schemes like Merchant Credit Card can be helpful



he Micro, Small and Medium Enterprises (MSMEs) are critical to unlocking the potential of India envisioned under the 'Make In India' campaign. This sector not only serves the purpose of 'Atma Nirbharta' but also paves the way for overall production, employment generation, and untapped export opportunities. Despite being the bulwark of the Indian economy, the vulnerable MSME sector is troubled by its financial constraints, owing to constant working capital expenditure and inaccessibility to mainstream finance. The Parliamentary Standing Committee

on Finance, in its report titled 'Strengthening Credit Flows to the MSME Sector, exposes the fact that less than 40% of MSMEs avail credit from formal financial systems, and therefore depend on costly and unreliable credit. The credit gap in the MSME sector is estimated to be around Rs 20-25 lakh crore, with an addressable credit demand of about Rs 37 lakh crore and an existing mainstream supply of only Rs 15 lakh

The MSME sector consistently contributes around 30% share of India's GDP, 45% to its manufacturing output, and 48% to exports, while generating employment for 11 crore people out of 6.34 crore MSMEs. Almost 99% of the MSMEs are represented by micro-enterprises, and less than 1% are categorized under small and medium segments. Despite the latest amendments, the institutional credit does not match the investment requirements of micro-enterprises, which are business entities with investments of up to Rs 1 crore and turnover of up to Rs 5 crore. It is high time that the government takes decisive action to strengthen and support the

Accessing capital remains one of the biggest challenges for micro and small enterprises that aspire to grow. In recognition of this, the RBI has designated MSMEs as a priority sector and directed banks to allocate 40% of the Adjusted Net Bank Credit (ANBC) to priority sectors, including MSMEs. The guidelines also require banks to allocate 7.5% of the ANBC to micro-enterprises. However, a study by the RBI has found that most banks do not go beyond 25% for MSME credit 25% for MSME credit.

Consistent regulatory obligations have a compounding effect on firm growth. While both NSE and BSE have introduced dedicated exchanges for MSMEs, out of the 6.34 crore MSMEs in India, onl 342 are listed on the BSE SMÉ exchange. This is because firms still prefer to avoid the capital markets. Listed SMEs need to comply with SEBI, RBI, and Companies Act regulations, which can be a high regulatory burden and compliance cost. What is needed is an ecosystem for MSMEs to thrive with less regulatory compliance costs, lower funding costs and the ability to scale.

The government needs to implement steps to ensure not only the survival but also the growth of vital MSMEs in India to save critical livelihoods and generate employment. The Indian MSME sector sources 84% of its working capital requirements from informal financiers, sometimes even at a higher rate of interest. Formal lenders prioritize the quality, reliability, and continuity of their

borrowers, whereas MSMEs assess their financial accessibility based on the parameters of need, availability, and speed of credit disbursal. As a result, informal moneylenders exploit the difference

between the expectations of for-mal lenders and MSMEs, which contributes to MSMEs' unwillingness towards formalization. The implementation of GST has been a measure to bring maximum enterprises under the formal umbrella. But even today, out of the 6.34 crore MSMEs in India, only about 1.1 crore are registered with the Goods and Services Tax regime. This lack of formalisation among MSMEs has resulted in their credit requirements being largely unmet due to limited availability and access to data. The Parliamentary Standing Committee on Finance has recommended several measures that can help in the formalisation and growth of the MSME sector. One of the recommendations is to link PAN- Udyog Aadhaar-GST identification numbers to curb the informal sector. It also suggested that providing working capital to MSMEs based on GST invoices can boost formalisation, including GST registration of businesses.

MSMEs are facing trust issues from banks. Merely 10% of the loans disbursal are collateralfree, while 90 % are collateralbacked. As the committee also proposed creating a digital ecosystem and adopting an account aggregator framework to secure digital financial data and

enable low-cost, instant digital lending to MSMEs. This can replace physical collateral with secure access to GST invoices. Furthermore, the committee recommended that lending to the MSME sector should shift to cash-flow-based lending. In this system, loan requirements are assessed based on actual revenue generation and repayment capacities, rather than physical assets as collateral.

The Way Forward: The MSME sector faces inherent complexities that cannot be overlooked. To make MSMEs globally competitive and improve credit access for them, the parliamentary finance committee recommended that tne government snould intro duce a Merchant Credit Card (MCC) scheme for traders and a Vyapar Credit Card (VCC) for micro-units.

These schemes could be similar to the Kisan Credit Card scheme with interest subvention, which is still awaited. However, it is high time for the government to announce the scheme in the upcoming budget to facilitate institutional credit accessibility for the MSME sector and address the problematic areas that hinder financial accessibility in this

Donald Trump triumphs in Iowa caucus

Donald Trump scripted a decisive victory in the Iowa caucus, cementing his status as the frontrunner for the 2024 Republican presidential nomination, a contest that also saw Indian-American entrepreneur Vivek Ramaswamy ending his bid and backing the former US president.

Iowa is the first of the state-by-state contests where Republican Party voters pick their candidate who will almost certainly face Joe Biden, a Democrat, in the November 5 presidential election.

Despite facing a number of legal challenges, Trump, 77, won the Iowa caucuses in a landslide with Governor Ron DeSantis of Florida securing a critical but distant second-place finish in the contest that took place amidst blistering cold.

Trump won 51 per cent of the votes, an unprecedented margin, kickstarting his bid to win his party's third consecutive presidential nomination.

Trump's victory was the largest margin in the history of Iowa's Republican presidential caucuses, easily surpassing the previous winning margin of 12.8 per cent set in 1988 by the late Senator Bob Dole.

With about 94 per cent of the results that have been the results that have been recorded, CNN reported that Trump will receive 20 of Iowa's 40 delegates. DeSantis is estimated to get eight delegates, Haley to get seven delegates and Ramaswamy will receive two delegates. There are 3 delegates unallocated.

There are a total of 2,429 delegates up for grabs in the Republican primary season. A candidate needs the backing of at least 1,215 delegates to win the nomination. Thanking "the great people

Speaking to reporters after his speech, Ramaswamy said he had expected to draw more first-time caucusgoers, "and that proved too difficult to actually translate into meaningful results."

He said he had not been anticipating earlier today that he would be dropping out, and said he was "a little surprised by what happened tonight." Standing alongside his wife and his son Karthik, Ramaswamy said he will appear at a rally in New Hampshire with Donald Trump tomorrow. He was previously scheduled to hold several of his own events in the Granite State the day after the caucuses, the New York Times reported. Haley, who finished third in the Iowa caucuses, has said that she is the only Republican candidate who could take on frontrunner Donald Trump and incumbent President Joe Biden and avert a "Trump-Biden nightmare".

UK Prime Minister Rishi Sunak faces rebellion from senior lawmakers in his Conservative Party over his stalled plan to send asylum-seekers on a one-way trip to Rwanda a controversial and Rwanda, a controversial and expensive policy that the British leader has made central to his attempt to win an election this

To do that he needs to unite his fractious party, which trails far behind the Labour opposition in opinion polls. But the liberal and authoritarian wings of the Conservatives — always uneasy allies — are at loggerheads over the Rwanda plan. Moderates worry the policy is too extreme, while many on the party's powerful right wing think it doesn't go far enough.

In a blow to Sunak, two deputy chairmen of the Conservative Party say they will vote to toughen up the government's flagship Safety of Rwanda Bill in the House of Commons on Tuesday. Lee Anderson and Brendan Clarke-Smith announced they will back amendments seeking to close down asylum-seekers' avenues of appeal against deportation to Rwanda. "I want this legislation to the back and the seekers' are the seekers' and the seekers' are the se to be as strong as possible," Clarke-Smith wrote on X, formerly known as Twitter.

More than 60 Tory lawmakers, including former Prime Minister Boris Johnson, support amendments to toughen the legislation, and some say they will vote against the bill as a whole if it is not strengthened. Along with opposition party votes, that might be enough to kill the legislation. That would be a major blow to Sunak's

moderates, meanwhile, worry the bill already flirts with break-

ing international law and say they will oppose it if it gets any tougher. Those concerns were underscored by the United Nations' refugee agency, which said on Monday that, even with the treaty and new legislation, the Rwanda plan "is not compatible with international refugee law" refugee law."

Sunak has made the Rwanda policy central to his pledge to "stop the boats" bringing unauthorised migrants to the UK across the English Channel from France. More than 29,000 people made the perilous journey in 2023, down from 42,000 the year before. Five people died on the weekend while trying to launch a boat from northern France in the dark and winter cold.

London and Kigali made a deal almost two years ago under which migrants who reach Britain across the Channel would be sent to Rwanda, where they would stay permanently. Britain has paid Rwanda at least 240 million pounds (USD 305 million) under the agreement, but no one has yet been sent to the East African coun-

The plan has been criticised as inhumane and unworkable by human rights groups and challenged in British courts. In November the UK Supreme Court ruled the policy is illegal because Rwanda isn't a safe country for refugees.

In response to the court ruling, Britain and Rwanda signed a treaty pledging to strengthen protections for migrants. Sunak's government argues that the treaty allows it to pass a law declaring Rwanda a safe destination. If approved by Parliament, the law would allow the government to "disapply" sections of UK human rights law when it comes to Rwandarelated asylum claims and make it harder to challenge the deportations in court. If the bill is passed by the House of Commons on Wednesday, it will go to the House of Lords, Parliament's upper chamber, where it faces more opposition.

The raid marks the latest seizure by the US Navy and its allies of weapon shipments bound for the rebels, who have launched a series of attacks now threatening global trade in the Red Sea and Gulf of Aden over Israel's war on Hamas in the Gaza Strip. a type used by the Houthis and Iran. The US Navy ultimately sunk the ship carrying the weapons after deeming it unsafe, Central Command said. The ship's 14 crew have been detained. The Houthis have not acknowledged the seizure and Iran's mission to the United Nations did not immediately respond to a request for comment.

A United Nations resolution bans arms transfers to Yemen's Iranian-backed Houthi rebels. Tehran has long denied arming the rebels, despite physical evidence, numerous seizures and experts tying the weapons back to Iran.Since November, the Houthis have repeatedly targeted ships in the Red Sea, saying they were avenging Israel's offensive in Gaza against Hamas. But they have frequently targeted vessels with tenuous or no clear links a key route for global trade.

Malta-flagged bulk carrier hit by missile in Red Sea

Jerusalem (AP): A Maltaflagged bulk carrier sustained damage from a missile fired at it in the Red Sea on Tuesday, Greek officials said. Though no group immediately claimed responsibility for the attack, suspicion immediately fell on Yemen's Houthi rebels. 8 die, 100 missing in Nigeria boat accident

Abuja (AP): Eight passengers were confirmed dead and an estimated 100 were missing after their overloaded boat capsized in north-central Nigeria, the emergency services said on Tuesday. It is the latest in a series of deadly boat accidents that increasingly point to regulatory failures.

The passengers were being conveyed from Niger state's Borgu district to a market in the neighbouring Kebbi state on Monday afternoon when the boat overturned in the Niger River, according to Niger State Emergency Management Agency spokesman İbrahim Audu."The boat was overloaded so the strong wind

affected them," Audu said. He said the boat's capacity is 00 passengers but it was estimated to be carrying a much higher number, in addition to bags of grain, making it difficult to control when it began to sink. Villagers were helping local divers and emergency officials to search for the missing passengers, many of whom were women, Audu said. He could not say how many people had survived.

Boat disasters have become rampant in remote communities across Nigeria, where locals desperate to get their farm products to market end up overcrowded in locally made boats in the absence of good and accessible roads. There is no record of the total death toll in these accidents, though there have been at least five involving at least 100 passengers each in the past seven months.

Ukrainian President Volodymyr Zelenskyy huddled with corporate executives and world leaders in a frenzied first full day of the World Economic Forum's annual meeting in the Swiss ski resort of Davos, where top officials from the United States, European Union, China, the Middle East and beyond spoke Tuesday about tackling conflict and embracing technology like artificial intelligence.

Zelenskyy is endeavoring to keep his country's long and largely stalemated defense against Russia on the minds of political leaders, just as Israel's war with Hamas, which passed the 100-day mark this week, has siphoned off much of the world's attention and sparked concerns about a wider conflict in the Middle East.

It is important that you stand with us, I thank you for your support. It is very important to be here, to boost investment in Ukraine and support our economy," Zelenskyy said at an invitation-only "CEOs for Ukraine" session, according to his office.

It is Zelenskyy's first trip to Davos as president after speaking by video in previous years, and — while surrounded by a large security contingent — he's drawing the attention of media and others trying to grab a word from him.

Conversations with the prime ministers of Qatar and Jordan will bookend the day's most visible events, with speeches by Chinese Premier Li Qiang, Commission President Ursula von der Leyen and US national security adviser Jake Sullivan in between.

Qatar's prime minister, Sheikh Mohammed bin Abdulrahman Al Thani, said the concentration on the attacks on ships in the Red Sea by Yemen's Houthi rebels - which have spurred retaliatory strikes by the ÛS and Britain - was "focusing on the symptoms and not treating the real issue" of Israel's war on Hamas. Davos (PTI): Chinese Premier Li Qiang on Tuesday said his country is committed to the cause of multilateralism and further opening up of its economy as well as sharing of market opportunities with the world. In a special address at the World Economic Forum Annual Meeting 2024 here, he reaffirmed China's commitment to ensuring a business-friendly environment for international cooperation.

He called for tighter multilateral coordination of macroeconomic policy, international cooperation on green development and better North-South

Li also offered an optimistic prognosis for China's macroeconomic health and assurances on pro-business policies to multinational companies. Addressing the theme of 'Rebuilding Trust' of the WEF annual meeting, Li listed five proposals to address the trust deficit in the global macroeconomy.

These included better international coordination of macroeconomic policy; more industrial specialization among countries in order to stabilize supply chains; more open international exchange of scientific and technological know-how; enhanced international collaboration on green development and addressing climate change; and better North-South cooper-

Premier Li said the theme, rebuilding trust, of this meeting echoes with people's concerns. "It was trust that paved the way for economic development over the past decade. The foundation of trust has eroded and lack of trust is coming in the way of global development.

"It is essential that we discard prejudices and work towards removing trust deficit," he said. On China's recent economic performance, Li said that the country's contribution to global growth has remained steady at about 30 per cent, and that its scientific and technological talent pool remains the world's largest. "Looking at the broader

picture, we are now advancing Chinese modernization on all fronts through high-quality development," Li said.

Bangkok (AP): Former Thai last year, and after being wel-Prime Minister Thaksin comed by supporters at Shinawatra is serving a prison Bangkok's airport was taken of wrongdoing in office, but he shouldn't be called an inmate, the country's Correction Department declared Tuesday.

It was responding to critics

who charge that Thaksin, a billionaire populist and unofficial patron of the political party that returned to power last year, is being given special treatment while he serves his sentence in a private room in a state hospital instead of in a prison cell.

Thaksin, 74, was ousted in a 2006 military coup after being accused of corruption, abuse of power and disrespecting the monarchy. He fled into exile in 2008 ahead of a trial on corruption charges, declaring that he was being prosecuted for polit-

He returned to Thailand

serving an eight-year term for a series of convictions.

Less than a day later, he was transferred from prison to the Police General Hospital. Corrections Department officials said he had high blood pressure and low oxygen, suffered from insomnia and felt tightness in his chest, and that doctors recommended he be transferred to avoid life-threatening risks. His return to Thailand came the same day that the Pheu Thai party — the latest incarnation of the party that he originally led to power in 2001, and for which he is considered the de facto leader won a parliamentary vote to form a new government.

The previous government was heavily influenced by the military, which continued its hostility to Thaksin and his allies long after ousting him in

About a week after Thaksin's return, King Maha Vajiralongkorn reduced his eight-year sentence to a single year. He will be able to apply for parole after serving one-third of his amended sentence, or four

Global cooperation needed to curb climate crisis: WEF

Climate crisis may lead to USD 12.5 trillion economic losses and 14.5 million deaths worldwide by 2050, a new World Economic Forum analysis warned on Tuesday. But, there is still time for global stakeholders to take decisive and strategic action to counter these forecasts and mitigate the health impacts of climate change globally, it said. The report, Quantifying the Impact of Climate Change on Human Health, developed in collaboration with Oliver Wyman, was released at the World Economic Forum Annual Meeting 2024.

It analysed the climate crisis through a new lens by providing a detailed picture of the indirect impact climate change will have on human health, the global economy and healthcare systems around the world.

'While there has been much discussion about the impact of climate change on nature and the global economy, some of the most pressing consequences of the Earth's rising temperatures will be on human health and the global healthcare system," said Shyam

Bishen, Head of the Centre for mated USD 7.1 trillion by 2050 Health and Healthcare and due to the loss in productivity.

Committee at the WEF. "Recent progress will be lost unless critical emission reduction and mitigation measures are improved, and decisive global action is taken to build climate resilient and adaptable health systems," he added. The analysis is based on scenarios developed by the Intergovernmental Panel on Climate Change (IPCC) on the most likely trajectory for the planet's rising average temperature, 2.5 degrees to 2.9 degrees Celsius over pre-industrial levels.

The report analysed six major climate-driven event categories as key multi-pronged drivers of negative health impacts - floods, droughts, heat waves, tropical storms, wildfires and rising sea levels.

Floods were found to pose the highest acute risk of climate-induced mortality, accounting for 8.5 million deaths by 2050.

Droughts, indirectly linked to extreme heat, are the secondhighest cause of mortality, with an anticipated 3.2 million deaths. Heat waves take the highest economic toll at an esti-

to air pollution, caused by fine particulate and ozone pollution, are expected to be the largest contributor to premature death, with almost 9 million deaths a year.

Climate change will also trigger a catastrophic rise across several climate-sensitive disease outcomes, including vector-borne disease, which will likely impact previously less affected regions, such as Europe and the United States, the WEF said. By 2050, an additional 500

million people may be at risk of exposure to vector-borne diseases, the report finds.

The climate crisis is a health crisis, and it is driving a vicious cycle of disease, economic devastation and suffer ing. It is clear from this report that we are still to understand the full impact," said Vanessa Kerry, CEO of Seed Global Health and WHO Special Envoy for Climate Change and Health. "If we fail to act, not only will the death toll be staggering, but we also risk losing progress made over decades to improve health outcomes around the world.

States borrowing cost begins to ease; falls 7 bps

ower supplies for the sec-Lond consecutive week finally led to the coupons on state debt to fall from the twoyear high at the latest auction held on Tuesday, and the weighted average cut-off eased by 7 bps to 7.65 per cent.

For the past two weeks, despite poor supplies states were forced to offer very high returns, which had touched 7.72 per cent last week, the highest in the past two years. Nine states raised Rs 19,200 crore by selling state government securities on Tuesday, 32 per cent lower than the amount indicated for this week in the auction calendar. Following this and the dip in the core-CPI inflation, the weighted average cut-off dipped to 7.65 per cent from a high 7.72 per cent last week, despite the weighted average tenor increasing to 16 years from 11, Icra Ratings chief economist Aditi Nayar said in a note. Moreover, she said the spread

between the cut-off of the 10year state bonds and the 10year benchmark G-sec yield declined to 50 bps from 54 bps last week.

Hospitality, travel sector players want infrastructure status for hotel industry

Hospitality and travel sector players on Tuesday demanded infrastructure status for the hotel industry besides measures such as tax exemption on LTA annually to boost domestic tourism ahead of the Union Budget.

They also recommended removal of the current TDS levied on automated bookings for internal or closed user groups such as business travel platforms and reducing the total number of licenses required to establish a hotel. "A full-blown infrastructure status for the hotel sector and further rationalisation of the Goods and Services Tax (GST) and a Central single window clearance for hotel projects are some of the major expectations from the Budget 2024," Roseate Hotels & Resorts CEO Kush Kapoor said in a statement.

The industry has been clamouring for infrastructure status for decades. The status will enable hotel projects to have easy access to cheaper debt that is at par with projects in other industries. A reduced capital cost will have a bearing on both timely completion of projects



and their overall financial health, he added.

SOTC Travel Managing Director Vishal Suri said albeit interim, the Union Budget offers a significant opportunity as a growth accelerator for the travel and tourism sector, which is "a valuable contributor to the country's GDP and a powerful employment

Calling for a multi-pronged approach, he asked the government to "remove the deterrent to technology in the form of the current TDS that is levied on automated bookings (self-booking tools) for internal/closed user groups such as our business travel platforms".

Insurance sector premium income to double by FY34 to around USD 450 billion: Report

PTI MUMBAI

The domestic insurance sector is on course to log in over 7 per cent annual growth over the next decade and the premium income is likely to double to around USD 450 billion by financial year 2033-34, an industry report said on Tuesday.

The total premium income will more than double over the next decade (2024-34) from the present USD 224 billion, and insurance penetration will increase from 3.8 per cent currently to 4.5 per cent by FY34, Swiss Re Institute said in a report.

The report further said over the next five years (2024-28), the total insurance premium income of domestic insurer are likely to grow 7.1 per cent annually in real terms, which is well above the global average growth of 2.4 per cent, 5.1 per cent in emerging markets and 1.7 per cent in advanced markets, the report

The more than double of the global average growth of the domestic industry is on the back of a resilient domestic economy which will remain the fastest growing large GDP for the next five years, along with the rising awareness about the need for insurance and the very low penetration now along with the

low insurance-to-GDP ratio of 3.3 per cent, which will also increase to 4.5 per cent, the

report said. Growth will continue to be led by life market which currently accounts for about three quarters of total insurance premium income at USD 163 billion and is forecast to grow at an annual average of 6.7 per cent during FY24-28, while non-life premium, including health, is expected to expand by an average of 8.3 per cent from USD 61 billion in FY24, the report said.

The report also flagged the low risk protection citing the rising incidences of natural calamities such as earthquakes, floods, cyclones, drought and wildfires, with regular frequencies and said with an average annual economic loss (loss to insurance companies in terms payout) of USD 8 billion over the past decade.

As much as 93 per cent in the country is uninsured, it added. The report said if the Bhuj quake were to have happened now, the economic loss would have been USD 30-40 billion, as against USD 100 million then (given the larger size of the economy now) and the actual insured loss would have been USD 4 billion, as against USD 4 million

TCS aims to train entire staff with Gen Al skills

ountry's largest IT ser-Vices exporter TCS will train its entire staff of over 5 lakh software engineers on the upcoming Generative Artificial Intelligence (AI) opportunity, as per a senior official.

As a business opportunity, Gen AI is in its "early days" right now and the use cases are smaller right now, head of the company's recently created 'AI.Cloud' unit Siva Ganesan told PTI.

The company, which had disclosed a few months ago about being engaged in 250 generative AI powered projects, is also using the intelligence gleaned from Gen Al for making its ongoing work for clients faster, he added.

"So it's probably smaller use cases right now. It is a matter of time before the huge transformation that we also talk about that supplements assets and augment come by. NAGAL STUNS WORLD NUMBER 27 TO ENTER AUSTRALIAN OPEN

umit Nagal returned to the big stage in grand style, pulling off one of the biggest victories of his career by stunning world number 27 Alexander Bublik of Kazakhstan in straight sets to breeze into the Australian Open second round, here Tuesday.

Someone who was denied a regional wild card opportunity by the AITA for his refusal to play Davis Cup, Nagal came through qualifiers and sent packing 31st seed Bublik 6-4 6-27-6(5) in a gruelling match that lasted two hours and 38 minutes. Nagal, ranked 137 in the world, is playing in a Grand Slam main draw for the first time since 2021 Australian Open when he had lost 2-6 5-7 3-6 to Lithuania's Ricardas Berankis in the opening round.

Nagal's victory was first by an Indian against a seeded player in



a Grand Slam main draw in 35 vears. The last time it happened was way back in 1989 when Ramesh Krishnan shocked Swede Mats Wilander. the then world number one and defending champion at the Australian Open.

In the 2020 US Open, Nagal had lost to second seed and eventual champion Dominic Thiem 6-3, 6-3, 6-2 in the second round. The 26-year-old will next play China's Juncheng Shang, ranked 140, on Thursday. If he happens to win the second round, there

is potential third round clash with world No. 2 Carlos Alcaraz of Spain.

By wining the first round, Nagal has ensured that he will pocket at least AUD 120,000 in addition to the AUD 65,000 for his three wins in the qualifying stage.

WFI seeks suspension of revocation through dialogue

Puts legal challenge on hold

The Wrestling Federation of India (WFI) on Tuesday decided that it will seek a dialogue with the Sports Ministry for revocation of its suspension, saving it does not want a clash with the government and the legal options will be explored only if talks fail.

The WFI had earlier said it will knock the doors of judiciary to get the suspension revoked but had a change of mind at its Executive Council (EC) meeting, which was chaired by President Sanjay Singh and attended by 12 other elected

members Secretary General Prem Chand Lochab and Senior Vice were the only absentees

"We do not want a clash with the government. We are not moving court as of today. We will seek time from the ministry and a delegation will try and speak with the government," Sanjay Singh told PTI after the meeting

Asked if he won't get time from the ministry, he said, "First we have to try. We want to know what we need to do to get the suspension lifted. Like UWW had set certain conditions when it had suspended. The ground was not holding elections. The government has suspended us but there is no clarity how it will be lifted.

"Earlier also we had written to the ministry but we did not get President Devender Kadian a reply. We will approach min-

India, Afghanistan T20 clash today

ith the series already in the bag, India will be eager to perfect their freshly-baked T20 template as a team and hope that skipper Robit Sharma's bat finally fires Rohit Sharma's bat finally fires when they face Afghanistan in the third and last match of the rubber here on Wednesday.

This will be India's final T20 game ahead of the World Cup in June, and the team management wouldn't want any drop in intensity that was displayed during victories at Mohali and Indore. India's identical six-wicket wins were marked by an ultra-aggressive mindset from ball one that saw them chasing down 159 in 17.3 overs and 173 in 15.4 overs respectively.

It was a clear deviation from their earlier approach of building the momentum for a final flourish in T20s. None showed this intent more brightly than Shivam Dube and Virat Kohli.

Kohli was playing a T20I for India after 14 months at Indore, but he creamed a 16-ball 29 at a strike rate of 181. The most noteworthy feature of his little yet significant innings was the way he handled Afghan spinner Mujeeb-ur-Rahman, whom he carted for 18 runs off seven balls, striking against him at a rate of 257. Kohli has always been a bit of a slow-mover against spin but there was no trepidation this time and he showed commendable alacrity to contribute his two cents to a transformed approach. Dube reappeared in the Indian blue after a gap of three years when he was selected for the T20 series against Ireland at Malahide, Dublin, last year. But after playing in the subsequent Asian Games. Dube could not find a spot in the series against Australia and South

However, the scattered appearances did not prevent Dube from following the path set by

They would hope for a good effort from opener Rahmanullah Gurbaz after two mediocre outings, as his salvos up the order go a long way in Afghans setting or chasing a target. The smooth pitch at the Chinnaswamy Stadium and its shorter boundaries offer him a fine chance to be among runs. A victory against India will also boost Afghanistan's confidence ahead of a packed away calendar consisting of fixtures against Sri Lanka and Ireland.

Arshdeep banks on new ball experience to ace T20 test

Arshdeep Singh's chaotic journey in T20Is will reach its culmination point at the Chinnaswamy Stadium during the third match against Afghanistan on Wednesday, and he is banking on the recent experience of bowling with new-ball to ace the latest test of his skills.

Arshdeep took four wickets from as many matches against the Aussies last year, but in each of those matches he conceded 41, 46, 44 and 40 runs in four overs

Bangladesh all-rounder Nasir Hossain was on Tuesday banned from all cricket for two years, with six months of that suspended, after he accepted three charges of breaching the Emirates Cricket Board's Corruption Code. Hossain, who was charged by

the ICC (in its capacity as the Designated Anti-Corruption Official under the ECB Code) in September 2023, admitted to three charges

Charge No. 1 relates to "Breach of Article 2.4.3 of the Code, in that he failed to disclose to the Designated Anti-Corruption Official (without unnecessary delay) the receipt of a gift that was offered to him that had a value of over US\$750, namely the gift of a new iPhone 12, said the ICC in a statement. He also "failed to disclose to the

received to engage in Corrupt Conduct via the new iPhone

"Charge No. 3 - Breach of Article 2.4.6 of the Code, in that he failed or refused, without compelling justification, to co-operate with the Designated Anti-Corruption Official's investigation in relation to possible Corrupt Conduct under the Code, including (without limitation) failing to provide accurately and completely any information and/or documentation requested by the Designated Anti-Corruption Official (whether as part of a formal Demand pursuant to Article 4.3 or otherwise) as part of such investigation?

As per the statement, the 32year-old admitted to the charges and has agreed to the sanction.

"Subject to him satisfying the conditions in respect of the suspended part of the sanction, he will be free to resume international cricket on 7 April 2025," the ICC added.
