'JUSTICE' IN TSPSC APPOINTMENTS:

IS IT POLITICAL OR SOCIAL? The Telangana government, by reconstituting the Telangana State Public Service Commission (TSPSC) board in fulfillment of the Congress' election promise, seems to have just scratched the surface when it comes to doing 'social justice' in respect of the appointments. Discerning circles see it as more of 'political rehabilitation' of a few officials. Although former Director-General of Police Mahender Reddy's appointment as Chairman is not being questioned, the whispers in the corridors of power are centered on how caste particulars of the members were released to the media to put out the intended message. Not many knew that Anita Rajenderan hails from the BC-B (Goud) community. Yarrabadi Rammohan Rao, one of the members, is from Andhra. A native of Nandigama in Krishna district, he had been allocated to AP. Rammohan Rao was one of the 214 people who had elected to serve Telangana State in the aftermath of bifurcation. Another member, Palavai Rajani Kumari, joined the Congress just before the elections. A government employee, she was handpicked by the Telugu Desam Party, a little bird told us. Bureaucratic circles are abuzz on how her appointment drew Chief Minister Revanth Reddy's 'special interest'.

LINE-UP OF OFFICIALS TO FIX KTR?

These days when officials are in the dock, the first question that arises in eager bureaucratic circles is: 'Will the mud stick on former minister KT Rama Rao?' Anti-Corruption Bureau (ACB) sleuths have reportedly exposed disproportionate assets amounting to over Rs 100 crore allegedly amassed by Shiva Balakrishna, Secretary of the Telangana State Real Estate Regulatory Authority and former director of the Hyderabad Metropolitan Development Authority . Almost everyone in the know believes that this was done to also throw mud at KTR. The state government has already questioned principal secretary Arvind Kumar for alleged violation of rules in releasing the initial outlay for the Formula E race. Bureaucratic circles are wondering who could be the other officers in line for making it easy for the government to get back

ADMINISTRATION IS 'SHAKEN, NOT STIRRED'

The administration in Telangana, to use James Bond's celebrated phrase indicating

how prefers his cocktails, is 'shaken, not stirred'. Another rejig, which is likely post Lok Sabha polls, may see the administration stirred. For, several officers have been continuing in the posts for a long time. They, n particular, are on tenterhooks. An official from this once privileged lot shared that the new government and ministers are perhaps in the process of de-briefing, trying to know from the horse's mouth the untoward and juicy things that may have happened over the past 10 years. "Eventually everyone will be moved", a Minister had remarked quite revealingly some time back. So, ultimately there won't be any long-standing officer at all. Moreover, in the present dispensation, a lot depends on the ministers' individual preferences -- whom they want and who should leave -- and not just the CM alone like in the previous regime.

TALK, NO NEED TO RECOMMEND IN WRITING

In the Police Department, which is unobtrusively policed by political masters, transfers of inspectors typically happen at the behest of powerful politicos with accompanying letters of recommendation or followup phone calls to the higher authorities concerned. Things at the core are no different under the new Congress government. Like in the past, MLAs are still behind the movements of inspectors. The only difference now is that the MLAs are asked not to give letters, but to follow up only with oral instructions. Since supersensitive cops had sensed regime change much before the Assembly polls, let alone the announcement of final tally, some of the ambitious cops used their chance to go tough on then BRS MLAs. They are expecting rewarding posts now.

AT THE LORD'S DISPOSAL

One has to be a gem among officials to successfully implement the Andhra Pradesh government's Navaratnalu Pedalandariki Illu scheme. They have to face adamantine walls of difficulties to have their way, be it pooling lands or identifying beneficiairies. Still, Dr Lakshmisha, as MD of the AP State Housing Corporation Limited, managed to build in time around five lakh houses that were inaugurated by Chief Minister Jagan Mohan Reddy in Samarlakota some time back. No wonder, in Sunday's reshuffle, Dr K Lakshmisha was elevated as the District Collector, Tirupati, putting him, so to speak, at the disposal of Lord Venkateswara. -Yours truly


Man commits suicide at **NIMS** hospital

Autonagar residents protest chemical pollution by TSIIC, IALA

PNS HYDERABAD

The residents of Autonagar in Hayatnagar staged a protest against Telangana State Industrial Infrastructure Corporation (TSIIC) and Industrial Area Local Authority (IALA) for generating chemical pollution which is harmful to the environment on Sunday

The Harina Vanasthali National Park is now marred by a 15-acre chemical lake due to an illegal pipeline laid by the TSIIC and the IALA two years ago. This man-made ecological disaster has led to the demise of 5,000 trees, over 500 blackbucks and cheetal deers, the disappearance of numerous bird species and groundwater pollution affecting 10 nearby colonies and 25,000+ residents facing respiratory risks due to toxic chemicals.

Despite ongoing protests and efforts to raise awareness, the negligence of authorities has exacerbated the crisis. The chemical lake, formed due to the release of industrial effluents mixed with chemicals from various units in the Autonagar area, has proven to be a severe threat to the ecosys-



tem and public health.

The recent construction of a sewage treatment plant by TSIIC, seemingly as a resolution, has fallen short of expectations. The STP, built in August 2023, is only processing 20 per cent of the chemical water, while the remaining pollutants continue to be diverted into the forest.

In response to the escalating crisis, a meeting was held on December 18, 2022, involving representatives from affected colonies, founders of Dha3R NGO, and officials from PCB, TSIIC, GHMC, and the Forest

Department. The outcome of the meeting resulted in GHMC and PCB issuing a notice to TSIIC for the construction of a 100KLD sewage treatment plant (STP) within the next three months.

Unfortunately, the STP has proven ineffective, and the problem persists. The STP is not able to remove chemicals from water. An effluent treatment plant (ETP) would have been a correct solution.

Vinay Vangala, a social activist said, "We have been facing this issue for over two years. Despite venting our envi-

ronmental issues to the officials concerned, they are not taking any action to curb this issue.' The community has come

together for a protest rally in a collective effort to address the Autonagar chemical smell issue. Also, notable environ-mental NGOs such as Hyderabad Cycling Revolution, Visva Sustainable Foundation, Dhruvansh Foundation, Techieride, **VWOLFS** Foundation, Animal Warriors Conservation Society and local colony associations have joined this critical mission showcasing

their dedication to the cause.



DCA raids unlicenced drug store, seize stock worth Rs 1.2 lakh

Drugs Control Administration officials raided a medical shop at Jangammet, Falaknuma on Sunday which was running illegally without a drug licence and seized huge stocks of medicines worth Rs 1.20 lakh. K Achutha Reddy was running the medical shop illegally.

Businessman loses Rs 1 cr in a fake trade investment site

A 47-year-old Hyderabad resident Naresh (name changed) has lost Rs 1.01 crore in a fake trade investment site, after he invested the money. He realised that they were cheating on him, when they asked for 10 per cent tax. Then, he filed a complaint on Sunday with Cyberabad police.

He joined using a link from WhatsApp group "Kuroto Capital Fund" on the suggestion of three unknown people. He downloaded and logged in

a website 'Kuroto capital.com, which seems to be an investing trading platform like other brokers. They told him that the platform is for only institutional market trading which will allow him to buy IPO stocks without any limit and stocks which are having upper circuits.

Believing that platform, he had invested Rs 1,01,00,000 to accounts given by them. The fake website shows all the transactions, share details as it's really happening. After a few transactions he tried to withdraw the amount. But the site was showing that Naresh should pay 10 per cent tax to them to withdraw the amount. He got doubts on Saturday about the site and searched in Google about the Kuroto Capital. Then Naresh realised that he was cheated by them. The fraudsters are still asking him that he must pay the tax amount in five days, or they will freeze the account and the amount will not be given. After receiving the complaint, police registered a case under c 420 IPC and Sec 66-D of IT Act 2000-

Education Ministry clarifies on draft UGC guidelines

The Ministry of Education (MoE) on Sunday clarified that no reserved posts can be dereserved after draft guidelines by the University Grants Commission (UGC) proposed that any vacancy reserved for SC, ST and OBC candidates can be declared unreserved if enough candidates from these categories are not available

The 'Guidelines Implementation of the Reservation Policy of the Government of India in Higher Education Institutes (HEIs) are in the public domain for feedback from stakeholders.

The draft guidelines have been receiving backlash from several quarters. The Congress alleged there is a "conspiracy" to end reservation given to SCs, STs and OBCs in posts in higher education institutions and that the Modi government is only doing "politics of symbolism" on



the issues of Dalits, backward classes and tribals.

The JNU Students' Union (JNUSU) also staged a protest against it and burnt an effigy of UGC Chairman M Jagadesh Kumar.

ENRICHING BRAIN CONNECTIONS

Writing by hand better than typing on keyboard

Students learn more and remember better when taking handwritten notes than using a keyboard as brain connectivity patterns were found to be far more elaborate while writing than typing on a keyboard, a new research has found.

Researchers said the findings suggested that the precisely controlled hand movements when writing with a pen helped obtain visual and movement information that contributed extensively to the brain's connectivity patterns, known to be crucial for memory formation and learning. "There is some evidence that students learn more and remember better when taking handwritten lecture notes, while using a com-



puter with a keyboard may be more practical when writing a long text or essay," said Audrey van der Meer, a brain researcher at the Norwegian University of Science and Technology and co-author of the study published in the journal Frontiers in Psychology

For the study, the researchers recorded the electrical activity of the brains of 36 university

students, who were repeatedly prompted to either write or type a word that appeared on a screen. When writing, they used a digital pen to write in cursive directly on a touchscreen. When typing they used

a single finger to press keys on a keyboard. The researchers found that the connectivity between different brain regions

increased when participants

they typed. On the contrary, the researchers found that repeating the simple movement of hitting a key with the same finger was less stimulating for the brain. "This also explains why children who have learned to write and read on a tablet, can have difficulty differentiating between letters that are mirror images of each other, such as 'b' and 'd'. They literally haven't felt with their bodies what it feels like to produce those letters," said van der Meer.

Even though the study participants used digital pens for handwriting, the researchers said the results are expected to be the same when using a real

pen on paper. "We have shown that the differences in brain activity are

related to the careful forming of the letters when writing by hand while making more use of the senses," explained van der Meer. The findings demonstrated the need to give students an opportunity to use pens, rather than having them type during class, they said.

Guidelines to ensure that students receive at least a minimum of handwriting instruction could be an adequate step, they said.

However, the team also cautioned that it was important to keep up with continuously developing technological advances, which they said included an awareness of which way of writing - handwriting or typing - was advantageous under what kind of circumstances.

very battle must end, so must every dispute. Killings are more easily forgotten than the destruction of buildings. But when a residence of the divine is destroyed, it is unforgettable. For a Hindu, a mandir is a residence of God. The reason is that an elevated human soul either meets the divine or obtains a glimpse of Him as Ramakrishna Paramahansa did. This is very different from a synagogue, church or mosque, all of which are merely prayer halls. Their respective faiths and adherents do not consider them to be residences of the divine.

January 22, 2024 is now behind us. It has been an epoch-making day, led by the man who made it possible. The Prime Minister's consecration of Shri Ram Lalla at Ayodhya marked the return of Lord Rama to his abode on earth after 500 years of not only waiting, but ceaseless struggle and sacrifices. Ever since Mughal invader Babar's henchman Mir Baqi destroyed the original temple at Ayodhya in 1528 AD, Hindus never gave up the struggle to reclaim the birthplace of Rama. The history of battles waged by the Hindu faithful is a long one, but December 6, 1992 was the day when the edifice known as Babri Masjid was sent to the dust. But, as our Prime Minister has said, now is perhaps the time for reconciliation.

The Somnath Temple at PrabhasPatan near Veraval (Gujarat) was destroyed by the Turkic marauder Mahmud of Ghazni in 1026 A.D. Even after a thousand years later, the devilish crime has not faded from Hindu memory. Thereafter, of course, several thousand temples have been demolished or desecrated. By European traditions and the way they have conducted their politics, the dispute over these desecrations and loss caused hould have been settled before New Delhi agreed to part with the share of pre-1947 India's assets to Pakistan at the time of Partition. Unfortunately, nothing was done. Instead, more temples were destroyed even in the Kashmir Valley, where India ruled.



temples can be divided into two categories. Until the period of the Lodi Sultanate, which began from 1451 onwards, and the spread of its rule over certain regions of northern India, Islamic invaders intruding into the country were not accompanied or followed by their architects. The pre-Lodi Muslim sultans therefore, converted temples into mosques readily by smashing the edifice along with the moortis (idols) inside the sanctum sanctorum, and replacing them with mehrabs (a niche in a mosque, which indicates the qibla, the direction of the Kaaba in Mecca) to face Mecca and a minbar (pulpit) of steps, whereupon the imam stands every Friday to deliver his khutba (Islamic

is the Dhai Din kaJhopra, which stands at about a furlong's distance from the popular Ajmer Sharif dargah. The odd name signifies that this particular conversion was effected within sixty hours of the desecration of the original Hindu place of worship, because ShahbuddinGhori was in a

hurry to pray on his return journey via Ajmer. His slave QutbuddinAibak obediently had the conversion executed within two and a half days for his master and badshah to pray when he returned. The erstwhile temple had actually been a complex of three temples, which were promptly combined and converted into a mosque-like edifice. It is therefore, even now, in a condition to be reconverted into a temple, almost equal-

ly quickly. There would be about 200 to 300 such converted and reconvertible edifices. They could be returned to Hindu institutions, while the thousands of recycled ones could be left alone, as a gesture for the process of reconciliation. These were the temples that were broken down almost to the plinth level and reconstructed with the debris being utilized in such reconstruction. The reconstruction using the same debris was done in Islamic style. These

are present in the country by the thousands, with 3,000 of them having been catalogued after being identified either with documentary evidence and/or epigraphs.

These latter structures could be left alone with an apology for having reduced them to such a state, along with an undertaking that such criminal acts shall not be repeated. An undertaking must also be given that the restored temples handed over o Hindu institutions and bodies will be given away irrevocably, and no claim on them whatsoever shall ever be made in the future.

Other issues too, will inevitably come up. As part of the process of reconciliation, issues such as the uniform civil code-which are part of the Constitution of India, but as a Directive Principle-should be dealt with suitably. So also should the issue of the outdated and debilitating waqf, called a "dead hand" by a former chancellor A.A.A. Fyzee. The intention must be to not keep pending any ongoing irritant between the two communities. Let peace and goodwill prevail.

Historical factors at play in Israel-Palestine conflict -



This conflict finds its roots in history that spans over a century when the Zionist movement, advocating for the establishment of a Jewish homeland, gained momentum

he past 114 day-long Israel-Palestine war has an immedi-ate as well as a long historical context: the immediate context of the war is the Hamas attack killing 1200 and taking 120 Israeli civilians as hostages on October 7 last year; while its long history begins with the proposal to establish the Jewish homeland, Israel, in this region after their dispersion from European countries. During the first world-war, the proposal gets impetus and the 'conflict' becomes intense with the British promising Jews to help them set up the Jewish homeland in Palestine after the collapse of Ottoman Empire for their influence on the US to support the postwar policies of the Britain. The conception and claim of homeland by the Jews dispersed from Europe on the same swathes of land where a mix of Muslim, Jew, and Christian population is already in place holding their identity as Arabs of Palestinians generates a 'conflict' of Jewish-Israeli nationalism pitted against the Palestinian-Arabic nationalism.

The 'conflict' gains intensity at the revelation of the three self-contradictory agreements made by the British authorities during this time for their own imperialist interests treating the region as 'terra nullius' or 'booty of the war': these agreements are famous as the 'Hussein-McMahon Correspondence' (1915-1916),

McMahon Correspondence' (1915-1916), the 'Sykes-Picot Agreement' (1916) and the 'Balfour Declaration' (1917).

The 'Hussain-McMahon Correspondence' promised Arabs the independence of Palestine in exchange for their support for the British against the Ottoman (Uthman) Empire in the First World War, yet, on the other hand, in contradiction the 'Balfour Declaration', promised the lews their 'homeland' in the promised the Jews their 'homeland' in the Palestine. But after the war, using 'Sykes-Picot Agreement' between the British and the French, the British took Palestine region under their 'Authority' securing a safe access to India through the Suez Canal and the Persian Gulf but deepening the conflict between Israel and Palestine.

The Palestine region remained under the British Authority until 1948 and between 1917- 1948, emigration of Jews in Palestine and the Israel-Palestine conflict swelled in parallel. In 1930, the Arabs launched a revolt against the British colonial rule in Palestine and its policy of Jewish resettlement here, which resulted in a plan to partition Palestine into the Jewish and Arab states leaving Jerusalem under international administration. The Jewish leaders accepted but the Arab states and the Palestinians rejected the propos-

On the other hand, during the Second World War, the Jewish Holocaust campaign in Germany and some other European countries left the Jews homeless. In August 1945, by the American President, Truman's appeal to the British Prime Minister, Attlee, to settle 100,000 Nazi Holocaust victims in Palestine, America also joined the powers that would determine the future of Palestine, though neither America nor Britain offered them refuge in America or Britain. The Arabs sympathized with the displaced Jews, but opposed the creation of Israel on the Palestinian territories. America and Britain continued to orient their policy on Palestine to their convenience.

Tired of the Second World War and directly dealing with the civil war in

Palestine, the British government ended its Authority over Palestine at midnight on 14 May, 1948 leaving the Jewish-Arab factions fighting each other during the civil war. On the same day the Jewish leadership in Palestine announced the establishment of the State of Israel. The birth of Israel from a violent war caused the displacement of approximately 700,000 Palestinian-Arabs. It is called by the Jews the 'War of Independence' but by the Palestinians as the 'Nakba' meaning 'destruction and desolation'. Since then Palestine has been a land of 'conflicts', 'battles' and third party 'peace agreements' HOLOCAUST The current 'Israel- Palestinian war' building on more than 100 years of conflict and internecine battles for their 'homelands' in the same geographical territories is guided by the right-wing nationalism on both sides, with the external third party players consistently present to fulfil their (neo)colonial interests. In the 2023-24 Israel-Palestine war, Israel and Hamas or Palestine are the parties directly in conflict, and much of the discussion about the war is usually focused on 'who of the immediate players in the war is more culpable' and 'who of the two has a stronger claim for its "homeland' in the same region, while the role of third parties in the war remains elusive.

One breed of third party players is of those coerced into war and circumscribed by their regional geographical, cultural and historical existence; they are affected by what happens in the region. But there is another breed of third

party extra-regional powers in the war whose presence is guided by their geo-political and economic interests; they act as catalysts to turn the 'conflict' into a 'war' and choose between 'right' and 'left' to their convenience. To understand the multifaceted politics of the Israeli-Palestinian war, it is also important to describe the role of these catalyst forces at work behind

By vetoing the UN proposal for 'immediate ceasefire' America and Britain have helped the war to inflame and by sanctioning the sale of weapons and ammunition not be pressured to leave Gaza. twice America has fuelled the war and encouraged the rightwing Israeli government passion for displacement of Palestinian population.In the name of eliminating Hamas and their bases, the indiscriminate heavy bombardment by Israel, with the unflinching support and encouragement by the US, has led to the mass destruction of ordinary Palestinian civilians. Israel's current war against Hamas is in reality a war against Palestinians. The Israel-Palestine war of 2023-24 is the worst not only because the majority of the dead are civilians but also because it is being fought like a genocide. The right-wing Israeli government, led by Israeli Prime Minister Netanyahu, wants complete Israeli control in Palestine and does not recognize any role for the Palestinian Authority. They may not hold a PhD degree or a professional degree, but their knowledge and scientific skills are more force. than those of a trained scienIn the recent list of 110 Padma Shri awardees, it was announced that 34 were such ordinary people, of whom more than one-third are tribals or those who have worked for tribal welfare. The prominent unsung heroes include Parbati Baruah, fondly known as "Hathi ki Pari," a female elephant trainer from

Goalparahas, Assam. Defying

deep-rooted stereotypes, Baruah has devoted four decades to addressing humanelephant conflicts. Her scientific methodology has supported three state governments in effectively managing and capturing troublesome tuskers, illustrating the effectiveness of challenging conventional norms.

The farming community is doing yeoman service for the nation and humanity. It's appreciable that many farmers found a place on this year's Padma list. Sathyanarayana Beleri, the rice farmer from Kasaragod, conserves 650 traditional rice varieties on his farm without any sophisticated infrastructure, which even ICAR institutions don't do. Other farmers who were recognised include Sarbeswar

from Chirang, Assam; K Chellammal, an Organic farmer from Andaman; Yanung Jamoh Lego from Arunachal Pradesh and Sanjay Anant Patil of Goa. Many people who work in nature conservation, folk arts and craftmanship have also been recognised.

The knowledge these exceptional people garnered was passed down through generations orally and is not documented properly. The knowledge is shared only among the close family members. In most cases, the second generation shifts away from the traditional workforce, moving toward more lucrative urban jobs. In the long run, if there are no takers for this traditional knowledge, it will become

extinct, as happened to the Indian Knowledge system. Modi government's initiative to recognise such people is a futuristic vision to preserve the remnants of still-prevailing Indian knowledge. This will revive interest in their community to carry forward the great work their forefathers have been doing. Recognition through a coveted award like Padma Shri will also provide them respect from other members of the society. The government has fostered a sense of self-confidence and admiration for one's work by making the Padma award accessible to the common man.

Centre, industry & experts to discuss trade regime

Top central government officials, industry leaders and international experts will gather here on January 30 to deliberate on India's export control systems for sensitive goods and technologies and global best practices in the sector, an official said.

The official said that the 'National Conference on Strategic Trade Controls' seeks to showcase India's prowess in export control systems, facilitate a dialogue between government authorities and industry leaders on the sector, and address emerging risks associated with the export of sensitive goods and technologies.

There are specific laws and regulations with regard to strategic trade or export controls. These help manage the flow of dual-use goods, services and technologies across national borders.

These regulations primarily focus on controlling the export

of SCOMET items in order to balance the country's commercial and security considerations.

Special Chemicals, Organisms, Materials, Equipment and Technologies (SCOMET) items are dualuse goods.

Dual Use implies the usage of these goods and technologies in military applications or its use in nuclear, chemical or biological weapons of mass destruction (WMD), along with their civilian or industrial applications.

The conference would focus on issues like showcasing India's export control system; preventing the proliferation of Weapons of Mass Destruction (WMD) and their delivery systems by strengthening the export control system; and facilitating dialogue between the government authorities and industry stakeholders.

Besides, it aims at assessing and mitigating emerging risks

sensitive technologies; increasing awareness and understanding of export controls; gathering feedback from the industry and learning best practices of other countries; and fostering international collaboration and showcase enforcement efforts, the official said.

The Directorate General of Foreign Trade (DGFT) in partnership with the Ministry of External Affairs is organizing the conference.

"It is the first such nationallevel conference of its kind which will focus on India's strategic trade control(SCOMET/export control) system and International best practices, for the export of dual-use goods and technologies," the official added.

The primary objectives of strategic trade or export controls are to prevent the proliferation of WMD and their delivery systems, as well as the uncontrolled transfer of conventional arms / military items.

India's gas demand to rise 6% in 2024: IEA

India's natural gas demand is expected to rise by 6 per cent in 2024 with a rise in consumption in fertiliser units, power generation and industrial sectors, according to the International Energy Agency

Following the 7 per cent year-on-year decline observed in 2022, India's primary gas supply rose by 5 per cent in 2023, with growth primarily driven by the petrochemical, power generation, refinery and industrial sectors. "Natural gas demand in India is expected to increase by 6 per cent in 2024, mainly supported by higher gas use in industry (including in the fertiliser sector) and stronger gas burn in the power sector amid the development of its national pipeline grid and city gas infrastructure," IEA said Gas Market Report

released last week. India's natural gas demand had risen to 64 billion cubic meters in 2023.

Liquefied natural gas (LNG) imports rose by 7 per cent on



the year to 29 billion cubic meters last year, with import dependency at 44 per cent of the nation's natural gas consumption. Domestic production was up 6 per cent on the year to 35 billion cubic meters on the back of a rise in output from Reliance Industries' KG-D6 block.

"We expect India to increase its LNG imports in 2024 by 7 per cent, fuelled by demand from the power and fertiliser sectors, as the country plans to stop importing urea by 2025, IEA said

Natural gas extracted from below surface and seabeds is used to make fertiliser, generate electricity, convert into CNG to run automobiles, piped to households for cooking purposes and used as fuel and feedstock in industries.

India's domestic production is insufficient to meet demand and so the fuel is imported as LNG in cryo-

Red Sea trade route woes may hurt manufacturing

Longer disruptions at the crucial Red Sea trade route may hurt manufacturing lines of some sectors like electronics, automobiles, chemicals, consumer goods and machinery, economic think tank GTRI said on

Sunday. The Global Trade Research Initiative (GTRI) said companies relying on just-in-time manufacturing processes can be particularly vulnerable as they maintain low inventory levels and depend on the timely arrival of components

and finished products. Few industries where production will be impacted due to disruptions in global value chains include electronics, automotive, machinery,

chemicals, pharmaceuticals, plastics, textiles, and consumer goods, it added.

Components and finished products are often shipped through the Suez Canal to reach different markets, and disruptions can lead to delays in manufacturing and increased costs, it said.

Due to the attacks by Houthi rebels on commercial ships, the movement of goods from the Red Sea, the world's busiest shipping route, has disrupted the global supply chains as vessels have to take long routes for exports and imports.

The immediate ripple effects are seen in increased freight costs, mandatory war risk insurance, and signifi-

cant delays due to rerouting. "The adverse impact will



multiply if the disruption continues beyond a few more weeks as it will impact not only trade but local productions of many industries, which rely on just-in-time procurement/import of inputs through the global value chains spanning both

Europe and Asia," GTRI co-

founder Ajay Srivastava said. He said that average container spot rates have more than doubled since early

December 2023. Basmati rice exporters face freight costs soaring to USD 2,000 per 20-tonne container for destinations around the Red Sea, marking a 233 per

cent increase, Srivastava

Similarly, he said, the other sectors which have faced issues include life-saving drugs, textiles, diesel, ATF, and steel.

Exporters have also expressed apprehensions that if the crisis continues, it will hurt the country's trade. Mumbai-based exporter

SK Saraf said the time is right for India to consider building a big domestic shipping company, as, at present, "we are completely dependent on foreign shippers".

Reports have linked the increased attack by Yemenbased Houthis on commercial ships with the Israel-Hamas war in October last

Houthi group has been

using drones and rockets on ships, which are transporting goods through the strait of Bab al-Mandab, which is a crucial shipping route connecting the Mediterranean

Sea to the Indian Ocean. The strait, vital for 30 per cent of global container traffic, has seen increased tensions with various incidents in 2023, including attacks and military manoeuvres by

regional and global powers. India is heavily reliant on this route for trade and energy imports and due to the disruptions, exporters here have to diversify their trade routes.

Strikes have been continuing for many years but escalated this year sharply, with militants now using anti-ship ballistic missiles.

431 infra projects showed cost overrun of Rs 4.82L cr in Dec

As many as 431 infrastructure projects, each entailing an investment of Rs 150 crore or more, were hit by cost overrun of more than Rs 4.82 lakh crore in December 2023, an

official report stated. According to the Ministry of Statistics and Programme Implementation (MoSPI), which monitors infrastructure projects worth Rs 150 crore and above, out of 1,820 projects, 431 reported cost overrun and 848 projects were delayed.

"Total original cost of implementation of the 1,820 projects was Rs 25,87,066.08 crore and their anticipated completion cost is likely to be Rs 30,69,595.88 crore, which reflects overall cost overruns of Rs 4,82,529.80 crore (18.65 per cent of original cost),"

the ministry's latest report for December 2023 said. According to the report,

the expenditure incurred on these projects till December 2023 is Rs 16,26,813.80 crore, which is 53 per cent of the anticipated cost of the projects. However, it stated that the number of delayed projects

decreased to 638, if delay is calculated on the basis of the latest schedule of completion. Further, it said that for 298 projects neither the year of commissioning nor the tentative gestation period has been reported. Out of the 848 delayed pro-

iects, 202 have overall delays in the range of 1-12 months, 200 have been delayed for 13-24 months, 323 projects for 25-60 months, and 123 projects have been delayed for more than 60 months



Hseih, Elise win Australian Open women doubles

Hseih Su-wei of Taiwan has become the second-oldest woman to win a Grand Slam doubles title after teaming with Elise Mertens of Belgium on Sunday to win the Australian Open women's doubles.

The second-seeded pairing of Hseih and Mertens beat 11th seeded Jelena Ostapenko of Latvia and Lyudmyla Kichenok of Ukraine 6-1 7-5 in Sunday's final. It was Hseih's seventh Grand Slam women's doubles title and Mertens' fourth, their second together. Hsieh follows Rohan Bopanna of India who became the oldest men's champion when he won

with Matthew Ebden of Australia.

American Lisa Raymond was eight days older than Hseih when she won the 2011 US Open women's doubles. Martina Navratilova was 49 when she won the mixed doubles at the 2006 U.S. Open with Bob Bryan.

Hseih has the benefit of being coached by Australian Paul McNamee who won six Grand Slam doubles titles, including two Australian Opens and was the Australian Open chief executive until 2006. She already had taken out the mixed doubles at the current tournament with Jan Zielinski



Mertens won the Wimbledon title with Hseih in 2021 and won the Australian Open title the same year with Aryna Sabalenka, who won her second straight singles title in Melbourne on Saturday. She also won the U.S. Open women's doubles in 2019. Mertens will return to the No.

1 WTA doubles ranking on Monday, a position she first held in May, 2021. She has spent 28 weeks in the top ranking spot.

Hseih and Mertens needed only 1 hour, 33 minutes on Rod Laver Arena on Sunday to pad their already impressive Grand Slam resumes. They took the first set in just over half and hour. The second set was much tighter as Mertens lost her serve in the opening game. She recovered to serve for the championship at 5-3

but was broken again.
Finally, Hseih and Mertens took the match when they broke Kichenok in the 12th game. Mertens leapt into the air in delight; Hseih was more reserved.

They make a formidable combination, Mertens with the stronger serve, Hseih with skillful touches around the net and flat, strong groundstrokes.

Matthieu Pavon became the first player to win a PGA Tour event under the French flag since World War II when he made an 8-foot putt on No. 18 at Torrey Pines South on Saturday for a dramatic birdie and a oneshot victory in the Farmers

Insurance Open. He raised his arms in celebration and shouted before hugging caddie Mark Sherwood after the putt rolled in as the municipal gem high above the Pacific Ocean glowed under the late-afternoon

he almost quit golf 10 years ago because of the yips.
"It is big for our country,"

the 31-year-old PGA Tour rookie said. "I hope it will inspire a lot

of people, because coming from an amateur player which is 800 in the world to a PGA Tour winner is pretty big. "I still can't believe it," said

Pavon, who grew up playing soccer - his dad was a professional player before switching to golf.

games. final-round 3-Pavon's under 69 put him at 13 under, one stroke better than Nicolai Hojgaard. Pavon was two shots ahead of Stephan Jaeger, who led after the second and third rounds, and Nicolai Hojgaard and Nate Lashley. French-American Martin Trainer won his first PGA Tour event at the 2019 Puerto Rico Open, an

alternate event, while representing the United States. He later switched his nationality to France.

Pavon took the lead on the 12th hole, built the advantage to two strokes and then missed a 3-foot putt on the par-4 17th for a bogey that cut his lead to one stroke.

His only birdie on the back nine saved him from a playoff.

He appeared to be in trouble on the par-5, 541-yard 18th when his drive landed in a sand trap, about 4 inches from the front lip. His second shot went 103 yards into the left rough, Pavon glowed, too. He said which was high because of heavy rain Monday, with 145 yards to the hole. He responded with a brilliant third shot within 8 feet.

After watching Hojgaard's 300-yard drive down the middle of the fairway, "I was like, OK, it's going to be spicy now. I might have to do a birdie or something special," Pavon said.

After ending up in the trap and then not getting back to the fairway, he and discussed Sherwood whether he should lay up or go for it.

I was like, Listen, like the lie doesn't look too bad, I feel like I can do it.' He said 'OK, but it's your call.'

"It's my call. And I was so pumped at that time, I know I had the energy to lift that ball up on the green. I kind of aimed to the middle of the green knowing the face would close a little bit because it's quite deep and thick. That ball came out like a butterfly and it really feed the slope on the green. That was the right time to prove I have the guts to finish that tournament and I did it so I'm so happy about that last

The organisers said participants will be provided top-class tented accommodations equipped with electricity supply, warm food and hygienic toilets.

Tawang is also a historic and picturesque town, known for its stunning landscapes and its spiritual heritage. His Holiness the Sixth Dalai Lama Tsangyang Gyatso was born here. The town is also home to one of Asia's oldest monasteries founded in 1680.

India lose to Netherlands, finish runners up

India lost 2-7 to the Netherlands in the final to finish runners-up at the FIH Hockey5s Women's World Cup here.

Jyoti Chhatri (20th minute) and Rutuja Dadaso Pisal (23rd) scored for India in the summit clash on Saturday. Janneke van de Venne (2nd, 14th), Bente van der Veldt (4th, 8th) and Lana Kalse (11th, 27th) struck a brace each for the Netherlands, while Sosha Benninga (13th)

was the other goal-getter.

For their exemplary performance in the FIH Hockey5s Women's World Cup, Hockey India has announced a cash award of Rs 3 lakh for each player and Rs 1.5 lakh each for the support staff. Both the teams probed for their chances after the



start and it wasn't long before the Netherlands found an opening. Janneke van de Venne took a

long-range shot which deflected off the Indian goalkeeper Rajani Etimarpu into the goal to hand Netherlands the lead. Moments later, Bente van der

Xavi will not continue at Barcelona after this season

Vavi Hernández won't Acontinue as Barcelona's coach after this season, saying he can't get the team out of a slump. Xavi announced his decision on Saturday, minutes after Barcelona lost to Villarreal 5-3 in the Spanish league, leaving it 10 points adrift of leader Real Madrid. "I would like to announce that on June 30 I will cease being the coach of Barça," Xavi said. "As a Barcelona fan, I can't

allow this situation to continue, we need a change of

course and of dynamics." Xavi said he made the decision "several days ago," and although the hard defeat to Villarreal set the scene for him to announce the decision, he "would have made" it soon enough. He said he hoped this decision will decrease the stress and tension his team is enduring.
"The feeling of being the coach of Barcelona is cruel, it is unpleasant, you feel like you don't get the respect you deserve," Xavi said.

"It wears you down, affects your mental health, your emotions, up to the point that



you say you can't go on. My loved ones know that." Xavi returned to Barcelona as

the coach in November 2021 with his only experience a stint in Qatar. He has a contract through the end of next season. The 44-year-old Xavi led

Barcelona to the Spanish Super Cup title and the Spanish league title last season, the club's first trophies since the exit of Lionel Messi. The club mortgaged its future to help him do that by signing players like Robert Lewandowski. But Barcelona has struggled

this season and has shown severe signs of suffering a collapse this month.

Barcelona saw its best two chances of getting a title in this campaign evaporate recently. Xavi's side exited the Copa del Rey quarterfinals after losing in extra time at Athletic Bilbao 4-2 on Wednesday, a loss that came two weeks after Barcelona was dismantled by Real Madrid in the Spanish Super After the Villarreal debacle

Xavi said his players' lacked the "maturity" to know how to hold onto leads, and after the Bilbao loss he also underscored that he was playing with several young players. But that seemed at odds with the fact that his starting side was led with veterans like Lewandowski, Ilkay Gundogan and players in their prime like Pedri González and Frenkie de Jong. Barcelona is set to play Napoli

in the Champions League round of 16 next month. Xavi said he was still motivated to lead the team at what is no doubt a long-shot bid at ending his stint with a European Cup.

In one of the wildest games of the season on Saturday, more pressure on beleaguered Villarreal was up 2-0 then Barcelona roared back with three goals in a 12-minute span to lead 3-2 in the 72nd minute. But Barcelona's defense again let it down and new Villarreal arrival Goncalo Guedes leveled on a counterattack in the 84th. Striker Alexander Sorloth, who also set up two goals, then found the winner in stoppage time and José Morales added to Barcelona's misery.

Barcelona was trying to bounce back in La Liga from

manager Xavi Hernandez to turn things around. Real Madrid rallied to win at Las Palmas 2-1 without top scorer Jude Bellingham and reclaim the league lead. It opened up a 10-point gap over

Barcelona in third. "This is a huge blow," Xavi said. "We lost this game because of our mistakes. Today is difficult to digest for me as a coach but also for my players, who are all feeling really bad.

which was to turn it around, and we even had more chances

paying a heavy price for our mistakes this season." WHERE'S THE DEFENSE? Gerard Moreno opened the scoring near halftime from a pass by Sorloth. Former Barcelona youth player Ilias Akhomach took full advantage of horrible control by João

Barcelona then looked close to sealing it with a fourth goal to score, but that was when our problems started. The Norway striker put Villarreal back in front after Barcelona failed to clear the ball from its area.
