

# Amend Budget, render justice

O TG demands Centre, passes resolution against neglect of the state OCM Revanth decides to boycott NITI Aayog meeting

The Telangana Government passed a resolution in the Assembly on Wednesday protesting against the Centre's 'discrimination' in allocating funds to the state in the Union

The resolution highlights the Centre's neglect of promises made in the AP Reorganization Act, impacting the state's development. Expressing strong protest and unhappiness over the Centre's bias against Telangana, the Assembly adopted a resolution appealing to the Centre to render justice to Telangana by amending the budget proposals.

As a mark of protest against the injustice in fund allocation and the 'violation' of Telangana's rights, Chief Minister Revanth said that they would boycott the NITI Aayog meeting sched-

The TG Assembly calls on the Centre to amend the budget to ensure justice for Telangana. The resolution states that India is a union of states as per the Constitution written by Dr BR Ambedkar and it is the responsibility of the Centre to ensure the holistic development of all states in the country.

The Centre has forsaken this fed-

eral spirit, and Telangana has been treated unfairly in the Union Budget. The resolution accuses the Centre of adopting an indifferent attitude towards Telangana. The resolution also notes that the Union Government is responsible for taking steps for the sustainable

However, the

resolution states that the Centre has completely ignored these pleas and has 'discriminated' against Telangana in budget allocations.

Chief Minister Revanth Reddy, speaking in the Legislative Assembly, criticized the Centre's 'discriminatory' practices. He said that he had met the Prime Minister thrice and Central ministers 18 times to safeguard the constitutional rights of the state and to request funds for Telangana, but the Centre did not

# Six guarantees to get infusion of funds

Cong govt's first budget today may focus on farmers

**PNS** ■ HYDERABAD

The Congress government in Telangana will present its first fullfledged budget on Thursday. The government is expected to make substantial allocations for implementing its six guarantees.

The Cabinet meeting chaired by Chief Minister Revanth Reddy will approve the budget on Thursday morning. Sources said that there will be allocation for waiving farm loans, Rythu Bandhu and Rythu Bhima.

The waiving of farm loans needs Rs 31,000 crore. In the vote-onaccount budget, the government had earmarked Rs 15,000 crore for the Rythu Bharosa scheme. Under this scheme, which has not been launched so far Rs 15,000 will be provided to farmers as investment support for every acre annually.

The Telangana government has devised a route map to speed up the construction of irrigation projects and the allotment for that is around Rs 11,000 crore.

There will be emphasis on skill development. Sources said the Chief Minister wanted to set up a temporary Skills University immediately and there is a collaboration agreement with Tata to improve ITIs.

Finance portfolio, will be making Budget proposals in accordance with the government's priorities.

Official sources said the size of the budget may not be very different from the Rs 2.75 lakh crore proposed in the vote-on-account budget presented early this year.
On February 10 Deputy CM

Vikramarka presented a vote-onaccount Budget of Rs 2.75 lakh crore for 2024-25, down from the Rs 2.90 lakh crore in the previous financial year.He had pegged the revenue and capital expenditure at Rs 2.01 lakh crore and Rs 29,669 crore respectively. In FY24, they were at Rs 2.11 lakh crore and Rs 37,525 crore respectively. While revenue expenditure in the full budget may remain unchanged, capital expenditure is likely to be hiked.

For the first time in the history of the Telangana State Road Transport Corporation (TGSRTC), the recruitment to various posts in the corporation would be handled by state recruitment boards.

Of the 3035 posts, there are 2000 posts of drivers, 743 of labourers, 114 Deputy Superintendent (Mechanic), 84 Deputy Superintendents (Traffic), 25 Depot Manager/Assistant Traffic Manager, 23 Assistant Engineers (Civil), 15 Assistant Mechanical Engineers, 11 Section Officers (Civil), 7 Medical Officers (General) and 7 Medical Officers (Specialist).

Athat he had enjoyed for nearly that he quarter century, Odisha's former chief minister Naveen Patnaik has drawn up a shadow cabinet, thus adopting a novel approach that is worthy of emulation by any opposition party for that matter.

Any government may at times adopt certain policies that are against the interests of the public. Such anti-people policies are adopted often to get political mileage or satiate patrons of the ruling parties at the cost of community assets and government land.

Government lands are to be protected forever by rulers in the interests of generations to come. Statesmanship is needed for present-day rulers, most of whom lack foresight. Instead of merely sitting in the

Opposition ranks following their defeat, political parties can form a shadow cabinet by appointing as its 'minister' a legislator

for every department. This 'minister' works only to check the functioning of that particular department with view to ensure flawlessness in overall governance of the nittygritty of the administration.

The concept of a shadow cabinet, which involves members having no executive power but who share responsibility to scrutinise the policies and actions of the government, may be new to India. Still, it can be tried and implemented effectively. It requires understanding among various sections of people, whose progress is linked to a responsive government. The shadow cabinet is formed only to

The shadow cabinet will keep tabs on the functioning of every department. This will make ruling party attentive to public needs. Due to such close watch, there may even be an opportunity for the ruling party to take cues from the a single review relating to shadow cabinet for effective administration.

Given a shadow cabinet, there may no lethargic attitude on the part of ministers in the government with regard to the handling of any of the portfolios allotted to them. There would be scope for plugging loopholes in the functioning of various departments.

For example, many ministers in the erstwhile cabinets of both Telugu states of Andhra Pradesh and Telangana had made verbal attacks on political opponents despite neglecting their duties. Some of the ministers did not maintain decorum in public life so much so that some of the legislators of the ruling parties declined to follow them while criticizing their opponents. Those ministers did not hold their departments. People rejected such ministers in the recent elections, with regime change in both the Telugu states. They were fed up with the attitude of those erring ministers.

Such objectionable behaviour of ministers would not have been possible had there been a shadow cabinet to find faults in the right manner. Every department in the government would have constantly monitored its functioning. The shadow cabinet is intended to work like a watchdog over the functioning of the government in all its affairs. It can unearth aspects relating to improper governance by virtue of its close watch. This means that the government will have chance to correct itself, should

there be deviations. Coming back to Naveen, he has enough legislators to form a shadow cabinet as BJD secured one-third seats in the House. Likewise, in Telangana, the Bharat Rastra Samiti (BRS) can afford to form a shadow cabinet to play the role of a watchdog, given its strength in the legislative Assembly. But the situation is different in Andhra Pradesh, where the opposition party does not even have the status of principal opposition. YSRCP has only 11 seats in the House, most of them are novices to the legislature. This precludes their ability to perform as members of the shadow cabinet even otherwise.

Members of the opposition parties should expose the misdeeds and misgovernance of the ruling party through a shadow cabinet. It would help strengthen democracy in the

The Bombardier CRJ-200 aircraft of Saurya Airlines, carrying 19 people, including two crew members and technical staff of the airline, was bound for Pokhara International Airport for regular maintenance service when the accident occurred at 11.11 am (local time).

"Shortly after takeoff from runway 02, the aircraft veered off to the right and crashed on the east side of the runway," said a statement issued

by the Civil Aviation Authority of Nepal. It said rescue operations were initiated

immediately and fire was brought under control. "One injured person (Captain Manish Ratna Shakya) was rescued and taken to the hospital, and 18 People were found dead," it added. The deceased were identified as co-pilot S Katuwal, the employees of Saurya Airlines and a Yemeni national (Aref Reda). Manu Rai Sharma a technician of the airline his wife Priza Khatiwada and their four-year-old son Adhi Rai Sharma, were among the deceased.

# TG govt gave Rs 2,000 cr to TGSRTC: Min Ponnam

Minister for Transport Ponnam Prabhakar said that the government paid Rs 2,000 crore to the TGSRTC out of Rs 2,400 crore liable under the Mahalakshmi scheme.

While replying to Siddipet MLA T Harish Rao in the Assembly, Ponnam Prabhakar said, "Since January 9, when the Mahalakshmi scheme was launched, around 70 crore women have travelled in the State. We bought new buses after Congress came into power but did they buy new buses during the last 10 years?"

TGSRTC is getting out from the operation losses to profits. 'We have given 21 PRC, due to which the government is spending Rs 35 crore more." ie Minister added.

"We have paid Rs 80 crore out of Rs 280 crore towards pending bonds to the corporation and will release the pending amount soon. These amounts have been pending since 2013. ### TG govt urged to come up with sustainable alternatives

Environmental activists and members of Kapra Lake Revival Group urged the State government to come up with sustainable alternatives for idol-making and immersion, with Ganesh Chaturdhi fast approaching.

The environmental enthusiasts pointed out that there are 74 artificial ponds in the Hyderabad Greater Municipal Corporation (GHMC) limits but the ground reality is that instead of immersing the Plaster of Paris (PoP) idols in the artificial ponds, every year majority of the idols are immersed in lakes.

As per data by the Directorate of Enforcement Vigilance and Disaster Management (EVDM), around 96,218 idols were immersed within the GHMC limits during the 11 days of the festival last year. data on how many of these idols were immersed in artificial ponds and lakes.

"Even this year we would face the same hardship, despite the High Court banning making and immersion of PoP idols, the idol-makers have started making idols. If those idols are immersed in the lakes instead of artificial ponds, the lake's condition will deteriorate. In this regard, the State government has not yet taken a decision to curb PoP idols," they

Manognya Reddy, a member of Kapra lake Revival Group, said, "As every year, we have witnessed that PoP idols are immersed in lakes rather than artificial ponds. This year it would be better if the government comes up with proper norms, that PoP idols should be immersed in the artificial ponds and not in the water bodies as it deteriorates the lake condition. The government should encourage idols-makers to encourage home immer-

The indiscriminate sale of several drugs with habit-forming tendencies, primarily classified under Schedule H1 and Schedule X of the drugs rules, was verified during the raids. Meanwhile, the DCA raid-

ed a medical store in Medchal and seized illegally manufactured medicines worth Rs 96

The DCA, in coordination with the officials of the Shameerpet zone and the Prohibition and Excise Department, during the raid, seized large stocks of bulk drugs of various categories, including anticancer, antiviral, antifungal, anticoagulants, antidepressants, which were illegally manufactured.

They requested the CM to address traffic congestion around KBR Park, which requires a broader, more comprehensive study. Simply widening roads and constructing flyovers will likely increase traffic as this has been studied and documented by traffic experts worldwide.
"Reinstate the eco-sensitive

zone to its original 35 meters around KBR Park and declare the entire walkway as an ecosensitive zone. Beyond 35 meters, a regulation zone of at least 10 Km can be declared, as provided by the Central ESZ Notification", they

"Withdraw all proposals, tenders, and projects related to roads, flyovers, tunnels, multilevel parkings and bridges around KBR Park immediately" letter mentioned.

# Vision loss linked to cognitive decline among elderly: Study

A study conducted by the LV Prasad Eye Institute has revealed that vision loss impacts cognitive decline among the elderly. It further revealed that one in four persons suffers from cognitive impairment. Those with vision loss are four times more likely to face cognitive decline as compared to those who don't have vision loss. The study further found that older persons who had worse

vision were more likely to be cognitively impaired. Similarly, cognitive impairment affected one out of every four individuals with near vision impairment. While less than 30% of elderly with mild vision impairment had cognitive impairment, this percentage steadily increases as vision impairment worsens. The study included 15 people with blindness and 60% of them

exhibited measurable signs of cognitive decline. Similarly, mental decline

higher prevalence of cognitive impairment, and this study found that women were twice likely to be cognitively impaired than men. Severe forms of cognitive impairment leads to dementia. The study's results suggest that addressing vision loss may be essential to arresting dementia and other forms of

public health researcher at LVPEI, said, "The results exhibit a strong association between vision loss and cognitive loss. While more and more elderly are living in homes for the aged, we have very little evidence-based policy interventions that can help improve their lives and conserve their quality of life. A pair of glasses or safe cataract surgery can go a long way in helping the elderly live independent and fulfilling lives in their sunset



# Trust deficit between farmers, govt, says SC

Proposes panel to talk to protesters at Shambhu border

PNS NEW DELHI

Observing that there is a trust deficit between farmers and the central government, the Supreme Court on Wednesday proposed the constitution of an independent committee comprising eminent persons to reach out to the protesters at Shambhu border and address their demands, includ-

ing a legal guarantee of MSP.
The top court directed the Punjab and Haryana governments to suggest the names of suitable individuals for the committee and submit a proposal for removal of barricades on the national highway while ordering a status quo on the border for a week.

A three-judge bench headed by Justice Surya Kant said there is a need for a "neutral umpire" who can inspire confidence between farmers and the government.



"You have to take some steps to reach out to farmers. Why would they otherwise want to come to Delhi? You are sending Ministers from here and despite their best intentions there is trust deficit," the bench also comprising Justices Dipankar

Datta and Ujjal Bhuyan said. "Let appropriate instructions be taken within a week. Till then let parties maintain

status quo at the site to prevent flaring up of the situation at the Shambhu border," the bench said while posting the

matter after a week. The top court was hearing the Haryana government's plea challenging the high court order asking it to remove within a week the barricades at the Shambhu border near Ambala where protesting farmers have been

camping since February 13. During the hearing, Solicitor General Tushar Mehta submitted that earlier the roads were blocked against the three agricultural laws and now they have new demands.

The top court said the Centre has to examine the demands of the farmers as a welfare state.

"Some demands may be genuine, others may not be acceptable," the bench said. The apex court remarked

that the state cannot keep the

highway blocked all round Mehta submitted that over 500-600 tanks, which have been modified as "armoured

Highlighting transparency and compliance of all laid down guidelines of recruitment process, Railway Minister Ashwini Vaishnaw said the Railway Recruitment Board examinations are quite technical in nature entailing large scale mobilisation of men and resources and training of manpower.

"Railway overcame all these challenges and successfully conducted the recruitment in a transparent manner following all laid down guidelines. No instance of paper leakage or similar malpractice has occurred during the entire process," Vaishnaw said in a written reply in Lok Sabha to questions raised by DMK MP Kalanidhi Veeraswamy.

Veeraswamy wanted to know the number of vacant posts in the Railways and steps taken by the government to fill

"Occurrence and filling up of vacancies are a continuous

process in Indian Railways

considering its size, spatial

distribution and criticality of operation," Vaishnaw said.

He added, "Adequate and suitable manpower is provided to cater to the regular operations, changes in technology, mechanisations and innovative practices. The vacancies are filled up primarily by placement of indents by Railways with Recruitment agencies as per operational and technological requirements."

According to the railway minister, after easing of restrictions imposed on account of COVID 19, two major examinations involving more than

been conducted successfully. "Computer Based Test (CBT) exam for more than 1.26 crore candidates was conducted in 7 phases from 28.12.2020 to 31.07.2021 in 133 shifts in 68 days across 211 cities and 726 centres, Vaishnaw said.

"Similarly, CBT was conducted for more than 1.1 crore candidates in 5 phases from 17.08.2022 to 11.10.2022 in 99 shifts in 33 days across 191 cities and 551 centres. Based on these exams, 1,30,581 candidates have been recruited in railways," he added.

Drawing a comparison of recruitment done in Indian Railways during 2004-2014 vis-a-vis during 2014–2024, Vaishnaw said 4.11 lakh recruitment were done between 2004-14 while between 2014-24, 5.02 lakh recruitment took place.

Union Budget 2024-25 in the Rajya Sabha, the senior Congress leader also asked if the proposed employmentlinked incentive (ELI) has been mooted as the existing production-linked incentive (PLI) schemes have failed to generate employment while mocking Finance Minister Nirmala Sitharaman for lifting ideas from the Congress manifesto for the ELI scheme.

He said the finance minister in her Budget speech "dismissed the subject in just ten words".

"Is inf subject (that) you can deal with it casually and dismiss it in ten words?" he asked, arguing that in the interiors and hinterland of India, "inflation is much higher" than data collected mostly from towns and villages that are along national and state highways and dis-



trict roads.

### BJP to hold 'day-and-night' dharna in Karnataka **Assembly, Council over MUDA 'scam**

The BJP in Karnataka on Wednesday announced that it would stage "day-and-night" dharna in both Legislative Assembly and Council over not allowing discussion regarding the alleged fraudulent allotment of sites to land losers by Mysuru Urban Development Authority (MUDA), which involves plots given to Chief Minister Siddaramaiah's wife.

The opposition was not allowed to discuss the issue in both the Houses today. The legislature session is slated to end on Friday.

Assembly Speaker U T Khader rejected the opposi-



tion's adjournment motion notice on the matter.

While the ruling Congress, citing rules, urged the Speaker not to allow discussion on the issue, the opposition BJP, claiming that a needle of suspicion is pointing to the family of the "most important person" of the state, demanded that it be allowed.

The opposition also alleged a political motive behind formation of the inquiry commission to probe the matter and said it was aimed at denying the House an opportunity to debate the issue.

"After hearing both sides, as the adjournment notice that the opposition has given is not an urgent matter and as an inquiry commission has been constituted under a retired judge to probe the charges, also as the matter is also not of immediate occurrence, it has been rejected," the Speaker

## Budget giving backdoor entry to farm laws: SKM

Samyukt Kisan Morcha on Wednesday said the Union Budget will lead to the corporatisation of agriculture and alleged that it also provides for a "backdoor entry" to the provisions of the three farm laws, which were repealed nearly two years ago.

Addressing a virtual press conference, Samyukt Kisan Morcha (SKM) leaders said the budget, presented by Finance Minister Nirmala Sitharaman, did not have any provisions for improving the situation of farmers, and they will burn copies of the Budget as a protest.

"There is nothing for farmers in the Budget. It is the same as last year...," Bharatiya Kisan Union leader Rakesh Tikait said. Stating that the SKM is not opposed to any states getting funds, he said while Bihar has been given financial packages, the agriculture sector has been ignored, and there are no provisions for creating a strong "mandi" system in the

Ashish Mittal of the All India Kisan Maha Sabha (AIKMS) pointed out that the announcement related to natural farming in the Budget may lead to a decline in production, as happened in the case of Sri Lanka.

"They are going to train one crore farmers for natural farming. The problem is it will lead to a reduction in production. A similar move in Sri Lanka had led to the food crisis there," he added. Jai Kisan Andolan leader

Avik Saha said the Budget was trying to provide a "backdoor entry" to the provisions of farm laws. "Farmers are almost invisi-

ble in the Budget. It is trying to give a backdoor entry to the

farm laws," he noted. In a statement issued after the press conference, SKM said the Budget will lead to the corporatisation of agriculture at the cost of farmers and workers, and usurp the rights of state governments, violating the basic concept of the federal character of the Constitution of India.

# Anxiety in older adults may triple risk of dementia

People with anxiety could be at three times the risk of developing dementia compared to those without anxiety, according to a

People aged 60-70 years with chronic (persistent) anxiety were found to be more likely to develop the mental condition in which memory and decisionmaking are impaired, affecting daily activities, according to the study published in the Journal of the American


Geriatrics Society. Researchers, including those from the University of Newcastle, UK, said that people whose anxiety was resolved did

not have a higher dementia risk compared to those who never

Therefore, the researchers suggested that successfully resolving anxieties could help mitigate risk of developing dementia.

"The findings suggest that anxiety may be a new risk factor to target in the prevention of dementia and also indicate that treating anxiety may reduce this risk," Kay Khaing from the University of Newcastle and corresponding author of the study said.

Previous studies examining links between anxiety and dementia have largely measured anxiety at the start,



ementia risk, they said. For the study, the researchers

included more than 2,000 indi-

viduals with an average age of 76 years, of whom close to 450 (21 per cent) had anxiety to begin with. The group was followed for over 10 years.

During an intermediate follow-up after five years, the participants were deemed to have 'chronic anxiety' if anxiety persisted and 'new onset anxiety' if they developed it.

Anxiety was measured using the Kessler Psychological Distress Scale (K10), a 10-item questionnaire used as a brief

screen to identify distress levels. Those with chronic anxiety and those who developed anxiety during the study had 2.8 and 3.2 times higher risks of having dementia, respectively, the authors found. The average time taken for dementia diagnosis from the study's start was

10 years, they said. "Chronic and new anxiety were associated with increased risk of all-cause dementia, and this association was significant

the authors wrote.

They also found that anxiety resolved at follow-up lowered dementia risk levels down to those in people who never had

anxiety. "These results suggest that timely management of anxiety may be a viable strategy in reducing the risk of dementia,' the authors wrote.

Possible processes through which anxiety can heighten dementia risk can include inflammation, cell death, along with higher chances of such individuals engaging in unhealthy behaviours, such as physical inactivity and smoking, they said

# **Balancing growth with populism**

Though the budget 2024 is growth-centric, it has populist overtones and addresses concerns of NDA allies

inance Minister Nirmala Sitharaman presented the first Union Budget for Modi 3.0 government on July 23, 2024, aiming to bolster India's economic growth while addressing social equity and the interests of the NDA allies. This budget is an exercise in balancing economic growth with political dividends. This budget outlines allocations for infrastructure, green energy initiatives, and the digital economy, reflecting a comprehensive approach to development. The Union Budget 2024-25 focuses on macroeconomic growth and fiscal stability but offers limited welfare for the poor, relying on effective policy implementation for success. While the fiscal deficit has improved to 4.9% of GDP, significant disparities persist, with increased capital expenditure intended to boost private investment but widening rural-urban and income divides. The budget maintains a similar outlay as the interim budget, prioritising agriculture, rural development, housing, and MSMEs to create jobs. New measures include direct payments for first-time



employees and incentives for employers to increase hiring. The budget does not adequately address rising inflation, which stands at 5.08%. To support manufacturing, the government has introduced initiatives like the Credit Guarantee Scheme for MSMEs and increased Mudra Loan limits, along with developing industrial parks enhancing agricultural practices through Digital Public Infrastructure (DPI) and increasing support for natural farming. Despite these efforts, the success of the budget depends on effective implementation and addressing broader economic chal-

The Union Budget 2024 outlines a comprehensive plan to deal with the rising unemployment by increasing the skill set of the youth. It plans to provide skills to 20 lakh youth over five years. As part of this initiative, 1,000 Industrial Training Institutes will be upgraded into hub and spoke arrangements with a focus on outcome orientation. The course content and design will be aligned with the skill needs of the industry. The budget's positives include the significant investment in infrastructure, expected to create jobs and stimulate economic growth. However, the budget also presents challenges. The ambitious spending plans may widen the fiscal deficit, posing challenges to macroeconomic stability and inflation control. Effective implementation of the proposed schemes and projects remains a critical concern, given historical delays and inefficiencies. The 2024 budget reflects a populist approach, aimed at addressing the concerns of its allies — Nitish Kumar and Chandrababu Naidu and has generously allocated funds for their states. The BJP has learned from its performance in the recent Lok Sabha elections, where it faced criticism for not adequately addressing issues like rural distress, job creation, and social equity. By focusing on infrastructure development, rural welfare, and social sector spending, the budget seeks to win back the support of these crucial demographics.

# The unfulfilled promise of Ram Rajya



### The budget skips pressing issues

Following the cancellation of its licence, the cooperative bank ceases to carry on banking business, with effect from the close of business on July 24, 2024. In a statement, the Reserve Bank of India (RBI) said the Registrar of Cooperative Societies, Assam has also been requested to issue an order for winding up the bank and appoint a liquidator. Giving reason for the cancellation of the licence, RBI said the lender does not have adequate capital and earning prospects. "The bank with its present financial position

would be unable to pay its present depositors in full," it said adding that continuance of the bank is prejudicial to the interests of its depositors. On liquidation, every depositor would be entitled to receive insurance claim amount of his/her deposits up to Rs 5 lakh from Deposit Insurance and Credit Guarantee Corporation (DICGC).

"The objective is to give a voice to the industry, which is often misrepresented despite its significant economic contribution," he states. The restaurant industry contributes 2% to the restaurant industry contributes 2% to the GDP and GST revenue of the country and it indirectly supports numerous jobs through delivery services and other asso-ciated sectors. NRAI Hyderabad has launched several initiatives, including the first-ever Indian Food Services Report (IFSR) for Hyderabad, highlighting the

industry's impact.
Under his leadership, NRAI Hyderabad has focused on engaging with stakeholders and consumers to improve the restaurant industry. They organised the first-ever Indian Restaurant Conclave in Hyderabad

# THE RINGS OF POWER INTRODUCES NEW CHARACTERS

Together, they created the famous Doors of Durin, on the west side of Khazad-dum. Owain Arthur, who returns as Prince Durin IV of the kingdom of Khazad-dûm, said, "He's weaving in and out of the action throughout the season. He's only mentioned in Tolkien's appendices and he's described as a great craftsman. J.D. Payne and Patrick McKay had little to go on, but I think we have successfuly turned this footnote into a flesh-andblood character. As well as being this fantastic architect, we see in season 2 that he's an adviser as well. He's the right-hand man of King Durin." Speaking about his character as Narvi, Eldon said, "Narvi has an interesting journey in season 2, as the king increasingly falls under the power of the rings. These rings are getting under his skin; he's becoming less logical and showing signs of madness. So Narvi has to make a very difficult choice about whether he

obeys his natural instinct, which is to be loyal and to follow the king's wishes, or to abandon that very basic requirement of his life and instead show more loyalty to Khazad-dûm. # Indian women team's mantra has been to take one game at a time: Deepti

Cenior player Deepti Sharma Said India's mantra in the Women's T20 Asia Cup has been to take one game at a time as conditions haven't really changed from the last time the team played here.

India marched into the semifinals with a thumping 82-run win over Nepal on Tuesday after fireworks with the bat from Shafali Verma (81 off 48 balls) and Deepti's impressive 3/13 with the ball.

India amassed 178 for 3 after batting first and then restricted Nepal to a paltry 98 for 9 in their 20 overs.

"From the first game we are

pretty confident about each (match) and every situation and the condition as well. We are looking forward to semi-final as well," Deepti told the media after the match.

She said not much has changed in terms of the nature of the pitches and conditions in Sri Lanka from the team's previous tour to the island nation in June 2022.

"Nothing (has) changed, just keep it very simple and just focus for another match. I played (here) last time also and yeah, nothing changed," she said. "We (are) only backing ourselves and you know, conditions are really (the)

The right-arm off-spinner is topping the bowling charts with eight wickets in three matches and she credited her success to her readiness to bowl in all situations.

"I (am) always ready to bowl in any kind of situation. I like to take the challenges from the front. (It's) nothing, just (that) I'm enjoying each and every match, plan accordingly and what we discussed in the meeting, I just apply myself," she said.

"If we win the toss, it's (a) positive (approach) from the upfront. As a batting unit also, we are doing really well from the game one and we finished also well," she added.



### Ollie Pope reckons England can make 600 Test runs in a day's play

Ollie Pope reckons England can breach the 600-run mark inside a day's play in Test cricket while ruling out any let up to their ultra aggressive 'Bazball' approach with the bat. England hold the record for the most runs scored in a day when they piled up 588 for 6 on the second day of the Manchester Test against India in 1936, and Pope believes the current side under Ben Stokes can eclipse that.

"Sometimes we might score 280 to 300 in a day but that's OK and probably because we're reading situations. There might also be a day where we go and get 500 to 600 at some point in the future as well. And that's a cool thing to have," Pope was quoting as saying by 'BBC Sport'.

In December 2022, England smashed 506 runs on the opening day of the first Test against Pakistan in Rawalpindi. England are currently 2-0 up in

the three-match Test series against the West Indies after they followed up a victory by an innings at Lord's with a comprehensive 241-run win at Trent Bridge, Nottingham last week.

The third and final Test starts

on Friday at Edgbaston. The win in Nottingham was the first time England scored 400-plus in both innings of a Test match with totals of 416 and 425. Pope (121 in first innings) was one of three England centurions in the second Test alongside Joe Root and Harry Brook.

Pope said there might be times England batters will have to "manage the game a little bit more" but that their attacking Bazball style under coach Brendon McCullum and captain Stokes has now become second nature.

'I got asked on day one at Trent Bridge 'do you get told to play like that?'. No, we don't. It's just our natural games and the way we go about it," Pope said.



Human excellence is often closely linked to human fortitude and Olympics is the prime example of it.

The Paris Games, starting on Friday, will be a gathering of 10,500 athletes, 117 of them from India, competing for a mere 329 medals.

Needless to say, talent alone won't decide who finishes on the podium. It will also boil down to the mind and how one can discipline it to cope with the grandeur and pressure of the big moments.

Visualisation, blocking out the noise and being focussed are among the techniques that are often talked about but are they as easy to implement in a competitive environment?

There is a lot of pressure (already) in sports and when you compete at the Olympics, you have to be someone who has gone through a lot of highs and lows as well," explains Dr Divya Jain, a sports psychologist with Fortis Healthcare. "In sports, you're confronted with winning and losing on a day-to-day basis, so it's not about winning every time; it's about how you recover, how quickly you bounce back from a mistake." she said while explaining the difference between Olympians

and other athletes. "There is public scrutiny, staying away from family, the noise of the Games... All of these are aspects that athletes have to cope with at a psychological level," she added. For the next few weeks athletes will try to be at the peak of their form. To do that, they have trained physically and



mentally but the medal winners will be those who are a tad more tenacious and focussed than the rest.

"Not only do they have their own high expectations, but they also carry the hopes of their entire country and scrutiny of a global audience," says Keerthana Swaminathan, a sports psychologist and president of the Indian Sport

Psychologists Association. "Being away from families, friends and home is a part of sportspersons' lives but in Olympics, with all eyes on them, it could lead to further

stress and anxiety.
"Olympians often have to deal with extensive travel and long periods away from family and friends, which can be really isolating. This combination can take a serious toll on their mental health, making it crucial for them to have strong support systems and access to mental health resources," she

adds. And to ensure that Indian athletes have calmer minds, the a first of its kind specialised medical team is accompanying the contingent, featuring wellness specialists, and a sleep scientist among the regular

"Representing and competing for one's country can instil a deep sense of responsibility and pride but that also adds an additional layer of pressure as athletes at the Olympics often feel that they are competing for national glory," says Dr Nanaki J Chadha, a Sport and Performance Psychologist.

Dealing with distractions is something that every athlete needs to learn since focussing on the 'here and now' goes a

"It's also about being able to harness that pressure because it's natural for anyone to be in a high-stress situation, to have certain responses to that pressure. Your heart rate may increase, muscle tension may change, your rhythm may change," explains Dr Divya

"So you need to train yourself to work through that pressure and also to harness that pressure to help do better, actually become stronger, (to) have more explosive movement, recognising that that's the body we are preparing, rather than clearing that kind of competition situation," she explains. That mental health is a crucial

aspect of an athlete's overall

competitive preparedness has been stressed quite often by India's first individual Olympic gold-medallist Abhinav Bindra. Bindra has often tlaked about his own struggles before

the Beijing top finish.

WHAT SEPARATES AN
OLYMPIC MEDALLIST FROM OTHERS?: "Medallists have an extraordinary ability to maintain unshakeable focus and concentration, even in the most intense situations," Keerthana says,

"They can block out distractions - whether it's the noise of the crowd, the pressure of the moment, or the actions of their competitors and stay entirely present in their performance she adds. It is something that Bindra and some of other top Indian sportspersons have also often pointed out. Being flexible to last-minute changes and self-assurance are also an important aspect.

'They trust in their training, abilities and preparation, which helps them take risks when necessary and push their limits without fear of failure. This self-assurance also acts as a buffer against the pressure and expectations they face, enabling them to perform at their peak," Keerthana says. The winners also tend to remain focussed for the entirety of the competition, says Dr Nanaki.

"Medalists often possess superior mental resilience, allowing them to perform under pressure and that also helps them recover quickly setbacks. from throughout the competition, the ability to maintain focus and concentration is extremely



### For TT great Sharath Kamal, running into Roger Federer tops favourite Olympic memories

From lunching alongside tennis icon Roger Federer to taking a set off Chinese legend Ma Long, India's flagbearer for Paris Olympics, Achanta Sharath Kamal, on Wednesday recalled the most memorable moments from his five appearances at the Games so far.

The 42-year-old table tennis legend helped the Indian men's team qualify for the first time in history and is believed to be set for his final appearance at the Games.

multiple-time Commonwealth Games goldmedallist believes that qualifying as a team could become the catalyst of growth for table tennis in India.

For someone who has a huge bank of memories from the Olympics having made his first appearance in 2004, Sharath recalled running into Federer at a dining hall in his debut Games.

"One day I was just out for lunch and as I was entering from this side, there was another person coming from another person coming from the other side with a tennis bag and hair let loose. I feel like I have seen him somewhere. I couldn't recognise who he was with his hair let loose," he said in a release from Ultimate Table Tennis.

Tennis. "We pass each other -- we actually cross paths -- (and) he goes to give his bag at the baggage keeping area. I walk in, take my plate looking at what to eat and it suddenly strikes me. Man, it's Roger Federer!"

Sharath said he was rather shy at that time but nonetheless searched for the Swiss ace. "He was sitting at one of the tables all by himself. I went as close as possible. I didn't want to get in his place but still got close and I was eating (on the same table)," he continued.
"Suddenly, a guy comes in with a reverse hat and shorts and they are clapping hands. I look at him and it's Andy

Roddick," Sharath recalled.

With the Tokyo Olympics postponed by one year during

to the COVID-19 pandemic. Sharath recalled facing difficulties in training and yet he was able to make a dent in Long's march to the gold medal.

# New Zealand Olympic soccer team complains after Canadian team drone flown over its training session

New Zealand says it has complained to the International Olympic Committee's integrity unit after a drone flown over a New Zealand women's soccer team training session was found to be operated by a member of the Canadian team's support staff.

Defending Olympic champion Canada and New Zealand meet in their opening match at the Olympic tournament on Thursday. The drone incident occurred earlier this week, the New Zealand Olympic Committee said Wednesday.

"Team support members immediately reported the incident to police leading to

the drone operator, who has been identified as a support staff member of the wider Canadian Women's football team, to be detained," the NZOC said in a statement.

'The NZOC has formally lodged the incident with the IOC integrity unit and has asked Canada for a full review." The Canadian Olympic Committee has



apologized to the NZOC and New Zealand Football.
