The chiefs of CISF, BSF and CRPF on Thursday said 10 per cent posts of soldiers will be reserved in their respective forces for former Agniveers in line with a

decision by the Union home ministry.
The remarks by CISF Director General
Nina Singh, her BSF counterpart Nitin
Agrawal and CRPF Director General Anish Dayal Singh came amid fresh spotlight on the Agnipath recruitment scheme for short-term induction of personnel in the Army, Navy and the Air

"The Union Home Ministry has taken an important decision regarding the recruitment of ex-Agniveers. Accordingly, the CISF is also preparing the process of the recruitment of ex-Agniveer," Singh

said.
The chief of the Central Industrial Security
Force (CISF) said 10 per cent jobs will be
reserved for ex-Agniveers in all future
appointments of constables.
"In physical tests also, they will be given
exemption along with the relaxation on the
age. In the first year the age relaxation is
for five five years and in the subsequent
year, the age relaxation will be three years,"

INLD, BSP join hands for Haryana election battle

The Indian National Lok Dal (INLD) has decided to again join hands with its former ally Bahujan Samaj Party (BSP) for the Haryana Assembly polls due later this year, the leaders of the two parties announced on Thursday. Alliance leaders have also decided to project INDL leader Abhay Chautala as its chief ministerial face.

Under the arrangement, out of 90 Assembly seats in Haryana, the BSP will contest 37 seats leaving the rest for its senior partner in Haryana, where the ruling BJP is eyeing to come to power for third time in a row.

Addressing a joint Press conference with the BSP at Nayagaon on the outskirts of Chandigarh, Chautala asserted that the alliance is not based on any selfish interests, but has been formed keeping in mind people's feelings.

"In Haryana, we have decided to jointly fight the upcoming Assembly elections. Today, the feeling of common people is to oust from power the BJP, which is looting the state, and keep the Congress party at bay, which looted the state for 10 years earlier," Chautala said.
BSP national coordinator Akash Anand

said recently BSP supremo Mayawati and Chautala held a detailed meeting regarding firming up of the alliance. "In that meeting, it had been decided that out of 90 assembly seats in Haryana, the BSP will contest on 37 seats while the rest will be fought by the INLD," he said. Anand said if alliance comes to power in the State, Chautala will be made the Chief Minister.

PUC certificate charges increased in Delhi

The Delhi Government has increased the pollution under control (PUC) certificate charges for petrol, CNG and diesel vehicles after a gap of about 13 years, Transport Minister Kailash Gahlot said on Thursday.

The charges for petrol, CNG or LPG (including bio fuel) two and three wheelers has been increased from ₹60 to ₹80 and for four wheelers from ₹80 to ₹110, he said in a statement. Gahlot said the charges of PUC certificates for diesel vehicles has been revised from ₹100 to ₹140.

The new rates will be effective as soon as it is notified by the Government, he said.

The Delhi Government is committed to maintaining the city's air quality and ensuring that all vehicles meet the required pollution standards,

he said.

It was a long-pending demand of the Delhi Petrol Dealers Association to keep up with the rising costs of pollution checking services, the Minister said.

"Considering the request from the Delhi Petrol Dealers Association and the fact that pollution checking rates have not been revised since 2011, the Delhi Government has announced increasing the rates for pollution checking of vehicles in Delhi," he said. This revision is necessary to ensure that pollution checking stations can continue to operate efficiently and provide quality services to the public, he added.

Chemicals used for WMD seized in Tamil Nadu

Security agencies in Chennai made a major breakthrough by seizing chemical consignment used in the production of Weapons of Mass Destruction and Delivery System which has been banned in India under the provisions of Customs Act 1962 and (Prohibition of Unlawful Activities) Act 2005. The Ortho-Chloro chemical Benzylidene Malononitrile weighed 2,560 kgs and stored in 103 drums of 2.5 kgs each was seized from Kattupalli Port near Chennai from a Karachibound ship sailing from Shanghai Port. Education Minister's NEET assurance PIONEER NEWS SERVICE

A mid a raging row over alleged irregularities in the conduct of the medical entrance exam this year, Education Minister Dharmendra Pradhan
Thursday met some aspirants at his residence in the national Capital.

According to sources, the students raised issues like the uncertainty prevailing over the fate of the exam which was conducted in May, the delay in the counselling process and ultimately the academic calendar. While there have been demand for a retest from several quarters, the Education Ministry has maintained the incidents of paper leak were localised, and by cancelling the exam it can jeopardise the careers of lakhs of candidates who cleared the test fairly. The matter has also reached the Supreme Court, which on Thursday adjourned till July 18 the hearing on the clutch of petitions seeking that exam be cancelled and the test be reconducted. The petitioners have also sought a probe into the alleged malpractices.

Besides, the CBI on Thursday arrested one of the alleged kingpins in the NEET-UG paper leak case who was on the run ever since the crackdown on irregularities in the entrance exam began, officials said. Rockey alias Rakesh Ranjan, who hails from Nalanda, and is said to be a relative of mastermind Sanjeev

The Ministry has informed the Supreme Court that a data analytics of the results of NEET-UG 2024 was conducted by IIT Madras which found there was neither any indication of "mass malpractice" nor a localised set of candidates benefiting from it and scoring abnormally high marks.

assumes significance in view of the observations made by the top court on July 8 that it may order a re-test if there were large-scale malpractices in holding the exam. The matter is being investigated by the CBI. Over 23.33 lakh students had taken the test on May 5 at 4,750 centres in 571 cities, including in 14 cities overseas. The Centre and the NTA, in their

earlier affidavits filed in the apex court, had said that scrapping the would

"counterproductive" "seriously jeopardise" lakhs of honest candidates in the absence of any proof of large-scale breach of confidentiality. The National Eligibility-cum-Entrance Test-Undergraduate (NEET-UG) is conducted by the NTA for admissions to MBBS, BDS, AYUSH and other related courses in Government and private institutions across the country.

The CBI had been trailing Rockey since the case came to the agency. His run came to an end on Thursday morning when he was arrested by the agency, they said. The agency produced him before a Special Court in Patna which has remanded him to 10 days of CBI custody, they said. Supreme Court summons State Chief Secretaries

The Supreme Court on Thursday summoned the Chief and Finance Secretaries of 16 States for non-compliance of the Second National Judicial Pay Commission recommendations on the payment of arrears of pension and other retirement benefits to the judicial officers.

Expressing strong displeasure over non-compliance of the SNJPC's recommendations, a bench of Chief Justice DY Chandrachud and justices JB Pardiwala and Manoj Misra said, "We know how to extract compliance now. If we just say that the Chief Secretary will be present if the affidavit is not filed then it will not be filed.



"We are not sending them to jail but let them be here and then an affidavit will be submitted. Let they be personally present now," the bench said.

Though seven opportunities have been granted to the states, it appears that full compliance has not been affected and several states are in default, it said.

Temples welcome women entrepreneurs ARCHANA JYOTI ■ NEW DELHI

Temples across India are blooming green with innovative waste management initiatives focusing on recycling of floral offerings into eco-friendly products such as compost, natural dyes, incense sticks, and more, thus protecting Mother Nature and creating job opportunities, particularly for women.

For instance, at much-revered Ujjain's Mahalakaleshwar Temple, 5-6 tonnes of daily flower waste are transformed into eco-friendly products while at Mumbai's famous Siddhivinayak Temple, floral waste is being turned into natural dyes.

Similarly, the Tirupati Municipal Corporation upcycles over 6 tonnes of waste daily from the Tirupati temple, employing 150

early this year, the Ayodhya Municipal Corporation too has embarked on a similar plan to recycle flowers offered in the temples of Ayodhya Dham. The move aims not only to

maintain the cleanliness of the temple premises but also to create job opportunities for women through the production of incense

through the production of meetics sticks and gulaal.
Vishal Singh, vice-chairperson of Ayodhya Development Authority (ADA) said, "The idea is to check floral waste from being dumped into rivers and other bodies of water that has been the cause for choking and polluting, leading to environmental degradation."

As disposal of flowers in rivers, oceans, etc. leads to water pollution as well as affects the living organisms present in the waters, there has been increasing demand for the concept of "Green Temples" to be integrated into national policies, transforming these religious spaces into eco-friendly hubs, said an official from the Union Environment Ministry. He said encouraging the use of digital offerings or biodegradable materials instead of traditional flowers can effectively reduce floral waste.

Lauding such initiatives that have encouraged women entrepreneurs in green businesses, such as organic farming, eco-friendly product manufacturing, and sustainable fashion, Heera Lal, Special Secretary, Irrigation Department, Uttar Pradesh, said, "This not only promotes economic empowerment but also contributes to environmental sustainability."

Cybercrimes on rise in state capital

In a daring act, cyber fraudsters duped former Chief Secretary of Uttar Pradesh, Alok Ranjan of USD 383 using his credit card for online purchases. The former chief secretary discovered the fraud when he received a transaction message. After getting the credit card blocked, he filed a case at Gomti Nagar police station.

Ranjan, who lives in Vivek Khand, said that he received a call around 12 noon on July 8 regarding an outstanding bill on his SBI credit card. The caller introduced himself as an SBI employee, claiming that there was an outstanding amount of Rs 1.9 lakh on the credit card and even mentioned the card number.

"When the caller told me the wrong credit card number, I interrupted him. The caller then asked me to press 9 on my mobile. I pressed 9 after being convinced by his words. Later,

the caller said that I should contact the bank, and the call got disconnected. At 6:30 pm, I received a transaction message on my mobile," he said. He found out that his credit card had been debited for USD 383 (about INR 32,000). He then lodged a complained by calling the SBI customer care. The police said that the accused made online purchases using the former chief secretary's credit card. The police said they were tracking down the accused with the help of the cyber cell.

After retiring from the post of chief secretary, Ranjan joined the Samajwadi Party as a political strategist. He is counted among the close associates of SP chief Akhilesh Yadav. His current role as a political strate-gist involves collecting data and gathering information to highlight flaws in government policies. Ranjan also prepared the SP's

Meanwhile, in a recent case of cybercrime, a woman was defrauded of over Rs 13 lakh by unidentified accused posing as a CBI officer. SDM suspended for negligence in public work

Lucknow (PNS): Close on the heels of suspension of five officers, including the sub-divisional magistrate and naib tehsildar in Firozabad, Chief Minister Yogi Adityanath, on Thursday, ordered suspension of SDM Vikas Yadav of Naraini, Banda.

Vikas Yadav has been suspended for negligence, super-visory indifference and misconduct in matters of public interest. He has been found incapable of fulfilling his official duties properly and is also accused of tarnishing the government's image. During his suspension, Vikas

Yadav will be attached to the Lucknow office of the deputy district magistrate and secretary, Revenue Board, Uttar Pradesh.

During his suspension, Vikas Yadav will receive only half his salary and will be deprived of all benefits, including dearness allowance. He will face a departmental inquiry, and a charge-sheet will be filed against him.

It is noteworthy that the Yogi government recently took action in Firozabad's Sirsaganj tehsil, where land was sold illegally and suspiciously allotted to close associates.

Following Chief Minister Yogi Adityanath's directives, the deputy district magistrate, naib tehsildar, revenue inspector, lekhpal, and peshkar were suspended, and the district magistrate was instructed to register an FIR and initiate departmental action against them.

Govt to offer free training in French, Spanish, German

Man stabs younger brother to death

allegedly stabbed his younger brother to death during a brawl in Saadatganj. The family rushed the injured youth to KGMU Trauma Centre in critical condition, but he succumbed to injuries during treatment. Upon receiving information about the incident, police reached the scene and sent the

body for autopsy. According to the police, Bablu's son Faisal (19) and his elder brother Ikhlaq, who live near Hasanganj Bavli Chowki in Saadatganj police station area. had a quarrel late on Wednesday night. Ikhlaq stabbed Faisal in the stomach, causing serious injuries.

The family took Faisal to the KGMU Trauma Centre, where he died later. On receiving information about the incident, the local police inspected

the scene and collected evidence. Faisal's mother Parveen told the police that Ikhlaq and Faisal came home drunk late on Wednesday night and started arguing. Atisha tried to intervene, but Ikhlaq started beating

In an attempt to stop Ikhlaq, Faisal hit him on the back with a stone. Enraged, Ikhlaq went to the kitchen, grabbed a knife, and stabbed Faisal in the stomach before fleeing the scene. A neighbour, Javed, said that when people heard screams from the house, they gathered and informed the police about the incident. Faisal was admitted to the hospital in critical condition but he could not survive.

According to the Saadatganj police, there was an ongoing dispute between Faisal, a daily wage earner, and his brother.

The accused, Ikhlaq, has been taken into custody and is being questioned. Further action will be taken based on the postmortem report and investigation into the family's allegations. Meanwhile, a man allegedly killed the son of a woman he had neem living with for the last one year in Thakurganj police

station area. As per reports, the accused, Monu Mishra of Dilaram Baradari in the area, was staying with the woman, identified by police as Kajal, who is married and had a son named Prince (6) from her first husband. On Thursday, the couple fought over some issue. At that time, Prince was playing near them. Monu allegedly beat him first, then lifted him up and threw him down. The boy suffered serious injuries, to which he succumbed later.

Pucca Pul closed for heavy traffic

With Pucca Pul having been identified among 83 bridges in the state as not fit for heavy vehicular traffic, the movement of such vehicles has been restricted. A PWD official said that a height gate has been installed to stop the movement of heavy vehicles, although smaller vehicles are still allowed.

He mentioned that major repair work on the bridge had been carried out recently. 'This restriction on heavy vehicles was prompted by concerns raised over bridges more than 50 years old following the collapse of bridges in Bihar," he

The official assured that people would not face any significant inconvenience because there is another bridge available for commuters in the adjoining area. He further stated that an assessment conducted last year by an agency from Roorkee recommended

closing the bridge for heavy traffic. "No strong enforce-ment was made earlier to stop the heavy traffic, but now it is being effectively implemented," he added. A Traffic department official

confirmed that traffic personnel have been deployed at Pucca Pul to enforce the restriction on heavy vehicles. This bridge, over a hundred years old, has an interesting history. Well-known historian PK Ghosh provided details about the bridge, saying, "It was built by Nawab Asaf-ud-Daula around 1784 and was known as Pucca Pul because it was a stone bridge, likely constructed to facilitate travel between the trans-Gomti and cis-Gomti areas. There was a significant cantonment of the East India Company where Aliganj exists today, and the bridge was crucial for commuting from this side to the other side of Chowk." Ghosh also pointed out that in 1911, the British raised a

Haider, has been demolished, but Pucca Pul still stands," he Roshan Taqui, another wellknown historian, explained that the bridge was also called the stone bridge and played a significant role in connecting other districts of the state with Lucknow.

"It was the first stone bridge constructed in the city, hence called Pucca Pul. It was important during the 1857 revolt as it facilitated the movement of both Indian and East India Company forces since there was no other bridge over the Gomti. A bridge constructed near Chhattar Manzil was destroyed by Indian forces," he

Recalling a notable incident at Pucca Pul, Taqui said that on March 8, 1858, British forces piers of the bridge, which was completed and named after Lord Hardinge. He emphasised that this bridge is very strong. "Another bridge, built on the Gomti river by Ghaziattempting to cross from trans-Gomti to cis-Gomti encountered an old woman sitting in the middle of the bridge. "The British officers initially decided to leave her. ed by his son Nasir-ud-Din but a soldier warned them. Upon searching her, they discovered she was carrying an ignition point connected to gunpowder at the bottom of the bridge. The woman was executed by the soldiers," he recounted.

Taqui emphasised the importance of protecting and conserving heritage monuments like Pucca Pul. "An iron bridge at Daliganj, made from spare parts of the Iron Bridge over the Thames, was demolished, although its piers can still be seen. Similarly, Pucca Pul is significant and could be preserved by constructing two bridges on either side to accommodate current traffic needs," he suggested.

Distributes relief materials to victims

Chief Minister Yogi Adityanath conducted an aerial survey of the floodaffected areas in Shravasti and Balrampur on Thursday.

During the survey, he gathered detailed information from officials regarding the extent of the floods and directed them to expedite the delivery of relief materials to those affected.

Following the aerial survey, the chief minister visited the flood-affected areas on the ground. He interacted with children and women impacted by the disaster and oversaw the distribution of relief materials to those in need.

In a gesture of support, the chief minister handed out cheques of Rs 4 lakh each to families who had lost their loved ones due to the floods. In recognition of their efforts, the chief minister honored

Armed Provincial Constabulary personnel who helped evacuate flood victims to the safe zones, presenting them with certificates of appreciation. He also announced special rewards and cash prizes for their bravery and service. State Minister Śwatantra Dev Singh and other local public representatives were also present during the chief minister's visit, supporting the ongoing relief and rehabilitation efforts in the flood-affected regions.

The chief minister conducted an aerial survey of all the flood-affected villages in Ikauna tehsil of Shravasti to assess the flood situation there with the officials. Devi Patan Divisional Commissioner Shashi Bhushan Sushil and Shravasti District Magistrate Ajay Kumar Dwivedi informed the chief minister that the floods were caused in the district by the sudden release of water from Nepal following heavy rainfall in that country. Currently, the water level is gradually decreasing. Following this, Chief Minister

Yogi inspected the Lakshmanpur Kothi Rapti inspected

Barrage on the ground. There, he met with each of the 11 victims rescued from the floods and enquired about their wellbeing. During his visit, the chief minister interacted affectionately with the children present there and distributed candies and biscuits to them.

He honoured Rekha Devi who provided timely and accurate information without panic, and Ram Ujagar, who guided the PAC jawans, and five PAC jawans who gave information about the people trapped in the floods by giving them certificates. He also announced cash rewards for them. He also handed out cheques of Rs 4

lakh each to four families who lost loved ones in the disaster. In his address to the flood victims, Chief Minister Yogi stated that immediate assistance is being provided to the families of farmers and sharecroppers who lost their lives due to various disasters, including humanwildlife conflict, snake bites, and lightning strikes.

He mentioned that currently 12 districts in the state are affected by floods, impacting 633 villages across 33 tehsils, with a total affected population of approximately 17.97 lakh, including over 18,000 cattle. More than 1.45 lakh hectares of agricultural land have also been

affected, he added. Meanwhile, over 923 flood outposts have been established to monitor the flood situation and relief efforts. Additionally, more than 1,033 flood shelters have been set up to house the flood-

affected people. In Shravasti alone, 116 villages are either fully or partially affected by floods. The soil erosion situation is critical in 15 villages, affecting a population of 76,000 and over 23,000 hectares of agricultural land. The chief minister emphasised that the state government is conducting relief operations with full force, which is why the loss of life and property has been minimal despite the ongoing flood crisis. He held a meeting with officials and directed them to survey the flood-damaged crops and provide immediate compensation, along with other necessary instructions. While talking to the families affected by the flood disaster, Chief Minister Yogi stated that the government stands with them in this time of crisis and that they need not worry about anything. "The state government is trying to help you in every possible way. Our effort is to ensure you don't face any problems," he remarked. He mentioned that around 50,000 people and more than 32,000 hectares of agricultural land are affected by the floods in Balrampur. For relief work, boats have been arranged by the NDRF, SDRF and PAC Flood Units along with the administration. Instructions have been given to provide under houses Mukhyamantri Awas Yojana to those whose houses have been damaged by the floods.

Its primary goal is to boost indigenous defence manufacturing, with a special emphasis on micro, small and medium enterprises (MSMEs) and startups, effectively addressing the current defi-ciencies in defence testing infrastructure.

These three DTI schemes, initiated by the Defence Ministry under the Uttar Pradesh Defence Industrial Corridor, will be implemented by UPEI-DA. MIDHANI (Mishra Dhatu Nigam Limited), a key

partner in India's space missions, will establish a mechanical and material testing facility in Lucknow with an investment exceeding Rs 40 crore. Bharat Electronics Limited (BEL) will invest over Rs 31 crore in a communication testing facility at the Indian Institute of Technology, Kanpur.

At the same time, Hindustan Aeronautics Limited (HAL) will set up an Unmanned Aircraft System (UAS) testing facility at the same location. These schemes will operate through a special purpose vehicle (SPV) managed by a five-member team.

UPEIDA officials say the DTIS will play a crucial role in India's self-reliance initiative. It will boost the Make in India programme in the defence sector and foster indigenous defence production, thereby reducing the country's reliance on imported military equip-

Emphasis on eliminating possible sources of mosquito breeding

In view of the possibility of spread of mosquito-borne diseases, especially dengue and malaria, the Health department has issued an advisory for effective control and action, emphasising on eliminating the possible sources of mosquito breeding. For this anti-larva spraying, fogging and oil balls are being used. Chief Medical Officer (CMO) Dr Sandeep Chaudhary said a special communicable disease control campaign is being run in the district from July 1. Under it various activities are being carried out in rural and urban areas. The CMO informed that 20 beds each equipped with mosquito nets have been reserved for dengue patients in Shri Shiv Prasad Gupta (SSPG) Divisional Hospital Kabirchaura, Pt Deen Dayal Upadhya (DDU) Hospital

Apart from this, 10 beds each have been reserved at urban and rural level community health centres (CHCs) and five beds each at primary health centres (PHCs).

He said instructions have been given to compulsorily display the admission, discharge and platelet protocol of dengue patients in the wards of these hospitals and health centres. Dr Chaudhary said in view of the possible spread of dengue during the rainy season, some private doctors create an atmosphere of fear among the relatives of the patient by creating unnecessary demand for platelets.

In this regard, according to him, the managers of all private hospitals were instructed that whenever they send a demand for platelets to the blood bank, they should send it along with the forms related to the current clinical condition of the patients and platelet count. "The names and signatures of

(SVM) Hospital Bhelupur. the registered doctors must be mentioned on the platelet requisitions. Platelets should be requisitioned as per the platelet protocol and not unnecessarilv". he said.

> He said as dengue mosquito breeds in clean and stagnant water so empty and clean household water storage containers should be covered on a weekly basis and water should not be allowed to accumulate in pots or any other utensils, coconut shells, tyres kept on the roof of the house. MILESTONE: Kanpur Metro has completed the work of installing the third rail system in the 'Up-Line' of the Chunniganj-Nayaganj section of Corridor-1 (IIT-Naubasta) on Wednesday. This marks the readiness of the approximately 14 km long metro route from IIT to Nayaganj on its 'up-line'. The metro authorities are poised to energize this system within the next day or two, transforming the traction line into a live operational segment. Concurrently, efforts to instal the third rail on the 'Down-Line' are advancing swiftly, in tandem with ongoing track construction.

The third rail system installed parallel to the track, provides power for Kanpur Metro trains using 750-volt DC electricity, replacing the conventional OHE (overhead equipment) system. This setup offers reduced maintenance since it runs alongside the track, eliminating risks such as power interruptions from external factors like kite flying. Moreover, the system's design ensures that no visible electrical wires mar the city's aesthetic infrastructure, enhancing its visual appeal.

Managing Director of Uttar Metro Pradesh Corporation Limited, Sushil Kumar, remarked on the significant progress of the Kanpur Metro project, stating, "The track construction work in the underground section of Kanpur Metro is progressing rapidly. Concurrently, we achieved a major milestone with the completion of third rail installation on the 'up-line' up to Nayaganj. The Kanpur Metro team's commendable speed in construction is noteworthy. Once track construction on both lines is complete, the route from IIT to Nayaganj will be fully prepared for a trial run. New method for detecting adulterants in milk developed

team of researchers from Ateam of researchers from the Banaras Hindu University (BHU) and Sikkim University has developed a new, cost-effective and homebased method for detecting adulterants in milk using the evaporation process and machine learning algorithm. The method is useful in ensuring the strength and quality of milk and public health. The method has been developed by Tapan Parsian, a research scholar, under the supervision of Dr Archana Tiwari, Department of Physics, in collaboration with Dr Ajay Tripathi, Sikkim University. The evaporation process is a phenomenon in which when a drop is left to evaporate on a surface the suspended particles in the drop move towards the edges and leave behind a ringlike pattern on the surface. Different types of suspended particles form their own unique evaporated ring patterns. These evaporated ring patterns act as fingerprints for identifying the substance. To validate the method, syn-

thetic milk was prepared in the lab by mixing appropriate amounts of detergent, ordinary vegetable oil, urea and tap water to create a mixture that resembled real milk. This synthetic milk was then mixed with real milk in varying quantities. The evaporated ring pat-terns of the synthetic milk were then analysed. During the analysis, several signs were identified in the evaporated ring patterns that reveal the quality of the milk.

Boost to desi defence production: 7 projects awarded to private firms

n an effort to give a boost to self-reliance in defence manufacturing, India's premier defence research organisation DRDO has awarded seven new projects to private entities to develop key military assets including underwater launched unmanned aerial vehicle and long-range remotely operated systems.

The projects were cleared under the defence ministry's Technology Development Fund scheme to boost domestic defence manufacturing, Defence Ministry said here on Thursday.

The project for underwaterlaunched unmanned aerial vehicles is aimed at developing versatile marine battlefield accessories which can be deployed in multiple combat roles, officials said.

The objective is part of a larger framework of intelligence, surveillance and reconnaissance (ISR) and maritime domain awareness (MDA), they said. The project has been awarded to Sagar Defence Engineering Pvt Ltd, Pune, according to the defence ministry. The other projects are development of ice detection sensor for aircraft, manufacturing of radar signal processor, long-range remotelyoperated vehicles for detection and neutralisation of underwater objects.

The long-range remotely-oper ated vehicles will be dual-use systems that will enable detection, classification, localisation and neutralisation of underwater objects while keeping the key assets away from the suspected operational area, the ministry said.

The work has been awarded to a start-up, IROV Technologies Pvt Ltd, Kochi.The other projects are development of radar signal processor with active antenna array simulator, development of Indian regional navigation satellite system-based timing acquisition and dissemination system and indigenous scenario and sensor simulation toolkit.

The toolkit project involves development of an indigenous system for simulator training of pilots in realistic scenarios. This will help in full mission planning and large force engagement, the ministry said. The project has been awarded to start-up, Oxygen 2 Innovation Pvt Ltd, Noida.

"Providing impetus to Aatmanirbharta, Defence Research and Development Organisation (DRDO) has

awarded seven new projects to industries under the Technology Development Fund scheme for various requirements of the armed forces and aerospace and defence sectors," the ministry said. "These project sanctions are a testimony to the continuing endeavour of DRDO in nurturing Industries, especially MSMEs & start-ups, in defence and aerospace domains," it said.

CBI likely to file chargesheet in UGC-NET paper leak case

The CBI has informally conveyed its

findings to the government and is likely to file a charge sheet against the youth, they said.

Alarming rise in number of women going missing

 $B_{\text{approximately }13.13\ lakh}^{\text{etween }2019\ \text{and }2022\text{,}}$ women were reported missing in India-a staggering statistic disclosed by the NCRB that highlights the grave challenges faced by women, especially in rural areas. This pressing issue was discussed threadbare during the recent 'Missing Women and Girls' summit organized recently by the National Human Rights Commission



The 2024 NATO summit concluded with pledges to support Ukraine and strengthen defence preparedness

eventy-five years ago, 12 nations gathered in Washington, DC to sign the North Atlantic Treaty, better known as NATO aiming to safeguard their collective defence amid the rise of communism under Soviet Union. This year, 32 NATO Allies convened once more in Washington, DC to make critical decisions on ensuring the protection of the member countries. In these 75 years a lot has changed. The Soviet Union does not exist and the Warsaw Pact has been disbanded. But NATO is alive and taking on new challenges in the emerging world order. The 2024 NATO Summit concluded after three days of high-level discussions and strategic deliberations among the member states. Basically, a product of cold war era, NATO has been pivotal in addressing pressing global security challenges, reaffirming commitments to collective defence, and exploring new avenues of cooperation among the member states. One of the primary focuses of the summit was of course reinforcing NATO's collective defence posture. In response to



escalating tensions and conflicts in various parts of the world, NATO leaders agreed to bolster their military capabilities and readiness. This includes increased defence spending by member states, the deployment of additional troops to Eastern Europe, and the enhancement of cyber defence mechanisms.NATO members reaffirmed their commitment to expanding partnerships beyond its traditional geographical boundaries.

The summit saw increased engagement with nonmember countries, emphasising the importance of global security cooperation. Key partners, including Japan, South Korea, Australia, and New Zealand, participated in discussions on shared security concerns

and collaborative initiatives. In the new world order China and Russia have emerged a formidable player in the world arena. The ongoing conflict in Ukraine remained a critical issue at the summit. NATO reiterated its unwavering support for Ukraine's sovereignty and territorial integrity. NATO has remained steadfast in its support to Ukraine and has supported Ukraine's war efforts but just about avoiding direct confrontation with Russia and widening the scope of war. PM MODI'S **STRATEGIC VISIT**

PM Modi's visit to Russia underscores the importance of Russia in India's foreign policy

his week marked several high-profile meetings amongst senior leaders around the globe, discussing primarily various conflicts and possible outcomes. PM Narendra Modi, in his first state visit during his third stint, visited Russia and Austria. The State visit by the India PM was the first since the Ukraine war and underscores the primacy of Russia in India's state of affairs. Meanwhile, all North Atlantic Treaty Organisation (NATO) leaders assembled in Washington DC to discuss global geopolitics. Ukraine and the Middel East featured prominently in all the discussions, even though the flavours were significantly differ-

The India-Russia joint statement following President Putin and PM Modis' bilateral meetings read "The Sides highlighted the imperative of peaceful resolution of the conflict around Ukraine through dialogue and diplomacy including engagement between both parties. They noted with appreciation relevant proposals of mediation and good offices aimed at peaceful resolution of the conflict by international law and based on the UN Charter in its entirety and totality. "Earlier, PM Modi during one of the televised speeches of the two leaders told his Russian counterpart "peace is of utmost importance" and solution to Ukraine could not be found on the battlefield. He expressed serious concern regarding the bombing of a children's hospital in Kyiv and said "When innocent children are murdered, one sees them die, the heart pains and that pain is unbearable." Ukrainian President Volodymyr Zelenskyy, with whom PM Modi has had several telephone calls in the past, called the Russia state visit by India "a blow to peace efforts."

NATO Secretary General, Mr Stoltenberg in the run-up to the NATO summit said "Allies will agree a financial pledge for Ukraine", and that he also expects more immediate military support to Ukraine." Ukraine is moving closer to NATO ". The close relationship with NATO was one of the reasons Russia came marching into Ukraine. It was a tightrope walk for PM Modi, in Russia, given the relatively new strategic relationships, he has developed in his last decade of being at the helm, crucial among them being the India-US partnership. It would be worth mentioning that



In the wake of the war in Ukraine, India has not yet verbally criticised Russia, for its aggression and has also stayed away from multilateral resolutions against Moscow. In the first few months, of Russia's attack on Ukraine, several US top leaders had criticised India's stance regarding the war, and even a threat of sanctions was discussed.

However, with deft diplomatic efforts made by both long-term partners, the high-decibel criticism was restricted to closed-door meetings. PM Modi's state visit to Russia opened some of the past heartburn regarding Ukraine in Washington. US State Department spokesperson Mattew Miller said "US has raised concerns with India regarding its relationship with Russia". He added "We would urge India, as we do any country when it engages with Russia, to make clear that any resolution to the conflict in Ukraine needs to be one that respects the UN charter, that respects Ukraine's territorial integrity," This comes at a time when the US has been seen to be one of the most important allies of India in the recent past.

Interestingly President Putin upon re-election chose to visit Beijing in one of his first official trips and followed it with a bilateral last week, on the sidelines of the SCO summit in Kazakhstan. China and Russia have mutually agreed to be friends without any limitations, and are widely seen as challengers to what they allege as the US-led democratic order. India and China are on an extremely rough patch due to the military aggression on India's borders. India managed to walk the tight rope for now, but at some point of time it will have to balance it out with more actionable statements on world conflicts.

Canal breach in National Capital

Amid a rupture in the Munak canal, which supplies around 36.7 per cent of water (719 cusecs) from Haryana to Delhi, residential colonies in Bawana in the national Capital turned into a river on Thursday, wreaking havoc in the daily lives of the people and stranding residents in their houses. A breach in the Carrier Lined Channel (CLC) of the canal, part of the Western Yamuna Canal, led to water entering the J, K, and L blocks of the colony in northwest Delhi early Thursday, causing significant inconvenience and concern for the locals.

Videos on social media reflect the gravity of the situation with the residents trying to wade through knee-deep flooding and even

area expressed frustrations over the sudden flooding bringing their lives to halt. Shailesh Kumar, a resident of JJ block, said he was unable to go to his work and blamed the Delhi Government for not doing enough for them. "We have informed all the concerned departments, including the National Disaster Response Force (NDRF), Flood Control Department, Public Welfare Department, and the Municipal Corporation of Delhi (MCD), at midnight after the canal overflowed," a police official said.

Taking serious note of the situation, Delhi Lieutenant Governor Vinai Kumar Saxena expressed concerns over the breach of a branch of Munak Canal and instructed the Chief Chief Secretary Naresh Kumar to take the matter up with State Water Minister Atishi and

"The breach in the Munak Canal underlines the absence of adequate maintenance of the Canal, which should have been undertaken by Delhi Jal Board (DJB) through Irrigation Harvana Department from time to time," a letter by the Principal Secretary to the LG read.

An official of the Delhi Development Authority (DDA) said, "A report was received regarding the damage in the lining of Western Yamuna Canal being maintained by Haryana Irrigation
Department (HID) near Bawana in the early morning of June 11. This has resulted

in flooding in the adjoining areas of Bawana JJ Colony." Informing that the field staff have been rushed to the site for taking immediate remedial measures, he said, 'Water is being drained by temporarily puncturing the waist deep water in parts of Flood Control Department existing storm water drain, the area. Residents of the Minister Saurabh Bharadwaj. coordinated with NDRF,

MCD, SDM Narela, DJB, public representatives and local residents for providing relief from this situation. Resources such as JCB, Dewatering pump, drinking water tanker and mobile toilet have also been deployed at the location by DĎA.

The Agnipath scheme provides for recruiting youths between the age bracket of 17-and-half years and 21 for four years with a provision to retain 25 percent of them for 15 more years. Several opposition parties including the Congress have been targeting the government over the scheme wondering what will happen to 75 percent of the Agniveers after their four-year tenure ends as only 25 per cent of the total recruits will be retained for 15 years.

Various central government agencies and departments have already announced plans to recruit former Agniveers.

"They got four years of experience. They are fully disciplined and trained personnel. This is very good for the BSF as we are getting trained soldiers. After short training, they will be deployed along the border," said Border Security Force director general Agrawal.

He said all the security forces will be benefitted by recruiting

former Agniveers.

"We are waiting for them to be deployed after giving conversion training, they will be deployed. 10 percent of the total vacancies will be reserved for them," he said. There will be age relaxation for them as well. The first batch

Though the vessel was taken into control by the Customs Department at Kattupalli on 8 May 2024, the investigating agencies could complete the probe and identify the chemical only during the last few days. The consignment was seized

by the Customs Department as it was found that the substance figured under the export control list SCOMET. Though officials of the ship told the security agencies that the chemical was for producing tear gas and riot control agents, the Indian officials were not convinced as there were reports that Pakistan and China were working on an offensive chemical and biological warfare program.

An Australian investigator Anthony Clan had reported in 2020 itself that China and Pakistan have entered into a deal to expand biowarfare capabilities ʻincluding running several research projects related to deadly

agent anthrax'. Clan had said in his report that China's Wuhan Institute of Virology (the epicenter of the dreaded Covid-19 virus) and Pakistan's Defense

Technology Science Organization (DESTO), an exclusive military establishment developing biological and chemical warfare against India in addition to manufacturing high-tech weapons and engineering to be used against India have entered into a strategic partnership to develop emerging infectious diseases and biological control of transmitted diseases.

"The chief and finance secretaries have to be personally present. Failing compliance, the court will be constrained to initiate contempt," it said.

otherwise contribute to environmental pollution, is transformed through sustainable practices into various marketable items. These include natural dyes for textiles, contributing to the fashion industry's sustainable efforts.

182 temples in Tiruchi, Thanjavur, Perambalur and Karur districts in Tamil Nadu are being converted into organic manure and used in the respective temple gardens under the ITC Mission 'Sunehra Kal' Green Temple Initiative.

According to a study, the amount of floral waste produced in the religious institutions and homes in India increases during Floral waste generated in festival and wedding

seasons. Dumping it directly in landfills along with other waste such as plastic and construction debris may delay degradation.

Without sufficient exposure to air, the waste can take up to 30 years to decompose, and in the process release harmful greenhouse gases including methane. With Hyderabad's population growing, the city's limited landfills are overflowing, as per the research.

S Korea to deploy laser weapons to intercept North Korean drones

South Korea said Thursday it begin deploying laser weapons systems designed to intercept North Korean drones, which have caused security concerns in the South in recent years.

South Korea's Defense Acquisition Program Administration said that it will deploy at least one anti-air laser weapons system called "Block-I" by the end of this year and more in coming years.

An agency statement said the "Block-I" system is capable of launching precision attacks on small incoming drones and multi-copters. It said the system, developed by local company Hanwha Aerospace, costs just 2,000 won (about \$1.50) per shot."We face North Korea on our doorstep and its drones pose present threats to us, so that's why we've been aiming to build and

cope with them," an agency official said, requesting anonymity because he wasn't authorized to speak to media on the issue. He said that other countries like

the United States and Israel are ahead of South Korea in laser weapons technology, but their primary focus has been on higher-powered laser guns that can shoot down incoming ballistic missiles. South Korea also hopes to develop such anti-missile laser weapons, which its defense procurement agency called "a game changer" in future combat environments

The "Block-I" system is meant to hit circuit boards and other equipment in enemy drones to make them malfunction and crash on the ground. Tests of the weapons system in 2022-2023 were successful and proved its credibility, the official said. Some experts questioned the technol-

Lee Illwoo, an expert with the Korea Defense Network in South Korea, doubts how effectively South Korea can use its laser weapons since its anti-air radar systems aren't advanced enough to detect North Korean drones

He said the range of a laser weapon is relatively short, so high-power microwave weapons would be better when enemy drones are flown in large numbers simultaneously. Jung Chang Wook, head of the Korea Defense Study Forum think tank in Seoul, said South Korea is likely about five years away from acquiring a functioning laser weapon that can shoot down the drones used by North Korea. North Korea has periodically flown drones across its heavily fortified border with South Korea for several years, in what observers have called tests of South Korean readiness. In

accused the North of sending drones across the border for the first time in five years. South Korea fired warning shots and launched fighter jets and heli-copters but failed to shoot down any of the drones.In a key political meeting in December 2023, North Korean leader Kim Jong Un vowed to introduce various types of unmanned combat equipment such as attack drones for 2024. Foreign experts say Kim likely regards drones as a cheap yet effective method to trigger security jitters and an internal divide in South Korea. Animosities between the two Koreas, split along the world's most heavily fortified border, have deepened in recent months,

Yemen Houthi rebels fire Iranian missile at Norwegian-flagged ship

Yemen's Houthi rebels likely fired an Iranian-made anti-ship cruise missile at a Norwegian-flagged tanker in the Red Sea in December, an assault that now provides a public, evidence-based link between the ongoing rebel campaign against shipping and Tehran, the US mil-

A report by the US Defence Intelligence Agency released Wednesday linked the attack on the Strinda, which set the vessel ablaze, to Tehran, the Houthi's main backer in Yemen's nearly decadelong war. The findings correspond with those of a Norway-based insurers group that also examined debris found on the Strinda. It comes as the Houthis continue their monthslong campaign of attacks over the Israel-Hamas war, targeting ships in the Red Sea corridor, disrupting the USD 1 trillion flow of goods passing through it annually while also sparking the most intense combat the US Navy has seen since World War II.

Iran's mission to the United Nations, responding to questions from The the Houthis despite the reports.

"We are aware that (the Houthis) have significantly developed their military capabilities relying on their very own sources," the mission said. "The prolonged war against them is the primary factor behind the expansion of their military prowess."

The Strinda was coming from Malaysia and was bound for the Suez Canal and then on to Italy with a cargo of palm oil when it was struck by a missile December 11. The attack sparked a major fire on board that the crew later extinguished

The Noor was reverse engineered by Iran from the Chinese C-802 anti-ship missile, which Iran purchased from Beijing and began testing in 1996 before transfers stopped over a US pressure cam-

paign. The Iranian version is believed to have a range of up to 170 kilometres, with an upgraded version called the Qader having a range up to 300 kilometres. The Houthis have a look-alike missile to the Qader called the Al-Mandeb 2 with a similar range.

Γhe Norwegian Shipowners' Mutual War Risks Insurance Association, known by the acronym DNK, also examined the debris following the Strinda attack. The association assessed it was "highly likely" the vessel had been hit by a C-802 or Noor anti-ship cruise missile.

Oil tanker held by Iran heads toward international waters

An oil tanker held by Iran for over a year after being seized was sailing Thursday toward international waters, tracking data showed. The Marshall Islands-flagged

tanker Advantage Sweet trav-eled toward the Strait of Hormuz, where it was seized in April 2023 by Iran's navy while carrying \$50 million worth of oil from Kuwait for Chevron Corp. That's according to tracking data analyzed by The Associated Press. by The Associated Press. Iran did not acknowledge

Iran did not acknowledge the ship's departure. It came after an Iranian court on Thursday ordered the U.S. government to pay over \$6.7 billion in compensation over a Swedish company stopping its supply of special dressings and bandages for those afflicted by a rare skin disorafflicted by a rare skin disor-der after Washington imposed sanctions on the Islamic Republic. Iran's gov-ernment initially said it

seized the Advantage Sweet because it hit another vessel, something not supported by any evidence. Then Iranian officials linked the Advantage Sweet's seizure to the court case that was decided Thursday.

A report by the state-run IRNA news agency described the \$6.7 billion order as being filed on behalf of 300 plaintiffs, including family members of victims and those physically and emotionally damaged. Witnesses told French television they saw smoke emanating from the spire just after midday, and recalled a devastating fire in 2019 at Notre Dame Cathedral in Paris that toppled its spire and collapsed its

Rouen's 12th century cathedral, which is considered to be a Gothic masterpiece, is widely beloved, not least because of a series of paintings by impressionist Claude Monet capturing its asymmetrical western facade. It is also the tallest church in France, and among the tallest

cathedrals in the entire world – and renowned for its three towers, each constructed in a different style. Mayor Nicolas Mayer-Rossignol first posted on the social media platform X around midday that "the beginning of a fire is under-

way on the spire of the cathedral of Rouen." Less than 90 minutes later, Stephane Gouezec, of the Seine-Maritime firefighters, said the source of the blaze had been located — some 120 metres high — and the fire contained. Crews were working to ensure there were no remaining "hot spots," he

But he told reporters the risk of the flames spreading was low because the fire was in an area where there was mostly metal. Gouezec said construction workers were the first to notice the fire and alerted authorities

added.

British Indian MPs swear oath on 'Bhagavad Gita, Gutka & Bible

Newly elected Indian-origin MPs to the House of Commons have been pledging their allegiance to the British Crown as a symbol of loyalty to the country, choosing to swear on holy texts or to affirm their oath during the first week of a new Parliament.

A new copy of the 'Bhagavad Gita' presented to Speaker Lindsay Hoyle by Shailesh Vara, former Conservative Party member of Parliament who lost his Cambridgeshire seat in last week's general election, featured early on as Rishi Sunak was among the first British Indian MPs to take his oath as Leader of the Opposition on Tuesday.

Holding the text in his right hand, the former prime minis-ter read out the customary text: "I swear by Almighty God that I will be faithful and bear true allegiance to His Majesty King

Charles his heirs and succes- ly presented the holy text blessed. Wilson sors, according to law. So help

me God." First-time MP Kanishka Naravan, who is the first Indianorigin member of Parliament to represent Wales in the Westminster Parliament after winning the Vale of Glamorgan seat for Labour, also chose the 'Gita' for his oath, as did new Tory MP from Leicester Shivani

Bob Blackman, a Tory veteran who represents Harrow East in London and has chaired the All Party Parliamentary Group (APPG) for British Hindus, chose to hold both the 'Gita' and the 'King James Bible' for his

oath-taking ceremony. "This 'Bhagavad Gita' has been specially blessed in a temple in India and will be used by Hindu MPs entering Parliament fol-lowing this General Election and those who will enter in the generations to come," said Shailesh Vara, when he recentat the Mayapur temple head-quarters of the International for Krishna Society Consciousness (ISKCON).

Some of the British Sikh MPs such as Tan Dhesi and firsttimers Gurinder Singh Josan, Harpreet Uppal, Satvir Kaur and Warinder Singh Juss chose to swear their oath to the Sikh scriptures but without holding any text in their hands.

Preet Kaur Gill, with her head covered with a red scarf, chose to hold the cloth-wrapped 'Sundar Gutka' prayer book during her swearing.in.

Sojan Joseph, the mental health nurse from Kerala who has been elected Labour MP from Ashford in Kent, chose the 'New Testament' biblical text to swear his oath.

Meanwhile, the 'King James Bible' was chosen by re-elected Conservatives Priti Patel and Claire Coutinho, as well as Liberal Democrat Munira

MPs can opt for a non-religious

affirmation, as did the two new Independent MPs with their roots in India, Shockat Adam and Iqbal Mahmood, along with many others including Tory MP Gagan Mohindra and Labour's Lisa Nandy and Seema Malhotra. First-timers like Tory MP Dr

Neil Shastri-Hunt and Labour's Jeevun Sandher and Sonia Kumar also chose to affirm their pledge of allegiance.

The affirmation reads: "I do solemnly, sincerely, and truly declare and affirm, that I will be faithful and bear true allegiance to His Majesty King Charles, his heirs and successors, according to law."

All elected MPs, including 29 of Indian heritage, have been queuing up in the Commons chamber since Tuesday to complete this protocol before they can officially take their seats in Parliament.

US Coast Guard patrol spots Chinese naval ships off Alaska island

Guard cutter on routine patrol in the Bering Sea came across several Chinese military ships in international waters but within the US exclusive economic zone. officials said Wednesday. The crew detected three ves-

sels approximately 124 miles (200 kilometers) north of the Amchitka Pass in the Aleutian Islands, the Coast Guard said in a statement. A short time later, a helicopter aircrew from Coast Guard Åir Station Kodiak spotted a fourth ship approximately 84 miles (135 kilometers) north of the Amukta Pass. All four of the People's Republic of China vessels were "transiting in international waters but still inside the US Exclusive Economic Zone," which extends 200 nautical miles (370 kilometers) from the U.S. shoreline, the statement said. "The Chinese naval presence operated in accordance with international rules and norms," said Rear

nchorage (AP): A US Coast Adm. Megan Dean, Seventeenth Coast Guard District comman-

"We met presence with presence to ensure there were no disruptions to US interests in the maritime environment around Alaska." U.S. Coast Guard Cutter Kimball is a 418foot (127-meter) ship based in Honolulu.

This wasn't the first time Chinese naval ships have sailed near Alaska waters. In September 2022, the Kimball spotted guided missile cruiser from China in the Bering Sea. And in Sept. 2021, Coast Guard cutters in the Bering Sea and North Pacific Ocean encountered Chinese ships, about 50 miles (80 kilometers) off the Aleutian Islands. The US military routinely conducts what it calls freedom of navigation operations in disputed waters in Asia that China claims as its own, deploying Navy ships to sail through waterways such as the South China Sea.

UK mulls tighter crossbow laws after 3 women killed in attack

Aman suspected of killing the wife and daughters of a BBC radio sports commentator with a crossbow was being treated in a hospital Thursday after being found injured in a cemetery some 15 miles (22 kilometers) from the scene of the crimes. Police had spent almost a day hunting for Kyle Clifford after the attack on Carol Hunt, 61, and her daughters Hannah, 28 and Louise, 25 at their home in Bushey, northwest of London. Police and ambulance crews called to the suburban cul-de-sac on Tuesday evening tried to save them, but they were pronounced dead at the scene.

After a frantic search across a swath of London's northern fringe, Clifford, 26, was found Wednesday in the Enfield area of north London, near his home. Footage from Sky News showed the suspect being carried on a stretcher out of Lavender Hill

Cemetery. Armed police officers, forensic personnel and ambulance staff had massed around the cemetery through the day.Police did not say how he was injured, but stressed that they had not fired any shots. They said Clifford has not yet been arrested. Following extensive inquiries,

the suspect has been located and nobody else is being sought in connection with the investigation at this time," said Detective Inspector Justine Jenkins from Bedfordshire,

Cambridgeshire and Hertfordshire Major Crime Unit. Police did not say how or whether Clifford was connected to the women, but said they believed the attack was targeted. British media reported that Clifford was an ex-boyfriend of one of the victims. Jenkins said the investigation was moving "at pace" and that formal identification of the victims had yet to take place.The BBC confirmed

the victims were the family of its sports commentator John Hunt. Hunt is the main racing commentator for BBC 5 Live, the corporation's main news and sports radio channel. His voice is known to millions through his coverage of the world famous Grand National and The Derby. Shocked neighbors came late Wednesday to lay flowers near the scene of the attack.

They were the loveliest, gentlest family," said Su Kehinde, who lives nearby. "They were the meekest human beings. They did not deserve this. They were beautiful souls."

Sizzling heatwave in parts of southern & central Europe prompts alerts

Weather alerts, forest fires, melting pavement in cities: A sizzling heat wave has sent temperatures in parts of central and southern Europe soaring toward 40 degrees Celsius (104 Fahrenheit) in some places. From Italy to Romania, authorities warned people to be cautious, drive carefully if going on holiday, drink plenty of water and avoid going out during the hottest hours of the day.Italian authorities declared a red weather alert in seven cities on Thursday, mostly in the central parts of the country but also the capital Rome and Trieste in the northeast. The heat conditions are aggravated by humidity and could affect healthy people as well as those with health conditions, authorities warned. Similar warnings were issued in neighboring Croatia and further east and south.

Croatia's main tourism resort, the southern Adriatic Sea town of Dubrovnik, recorded 28 degrees Celsius (82.4 Fahrenheit) at dawn, signalling there won't be relief when the sun goes down. Forest fires have been report-

ed this week in Albania, near the border with Greece, as well as in Bosnia and Italy. Meteorologists said temperatures were even higher than

officially reported in big cities where sizzling concrete radiates the heat above the ground and the asphalt softens under one's feet. "It was impossible to breathe yesterday," said Antonela Spicanovic, from the Montenegrin capital of Podgorica, where temperatures reached 39C (102F) on Wednesday. The city seemed deserted with many of its residents staying indoors or heading for the Adriatic Sea coast or the mountains. "I spend my

days in the apartment, under

the air conditioning," said Đorde Stanišic, an electrical engineer also from Podgorica. "It's hell outside." Mendim Rugova, a meteorol-

ogist from neighboring Kosovo, said temperatures in the country have risen on average by 2.5 degrees since the 1980s. He said the current heat wave could last

until the end of July.
"In the region we could see temperatures above 40C, in parts of Albania, Northern Macedonia, in Greece and also in parts of Serbia," he predict-

In Czechia's capital of Prague, where temperatures reached 34C Wednesday before drop-ping slightly Thursday, the city zoo delivered ten tons of ice to provide much-needed relief for the animals.

The ice was strategically placed around the zoo Wednesday creating cool spots where animals could find refuge from unusually high temperatures.

In the Romanian capital Bucharest, street thermometers showed 42C (107F) on Tuesday and Wednesday though the official measurements were a few degrees lower. Neighboring Serbia reported record temperatures so far this summer, with thermostats at 35C (95F) Thursday morning in the north of the country. In the capital Belgrade, doctors reported treating people who collapsed, felt dizzy or complained of headaches due to the

Serbian authorities have said that the use of air conditioning led to huge power consumption similar to levels normally seen in winter, when many in the Balkan country use electricity for heating. During a previous heat wave last month, Montenegro, Bosnia, Croatia and Albania faced a major power outage amid the overload and a collapse of a regional distribution line.

Woman who swept to sea while swimming at beach rescued Tokyo (AP): A Chinese

woman who was swept out to sea while swimming at a Japanese beach was rescued 37 hours later after drifting in a swimming ring more than 80 kilometers (50 miles) in the Pacific Ocean, officials said Thursday. Japan's coast guard launched a search for the woman, identified only as a Chinese national in her 20s, after receiving a call Monday night from her friend saying she had disappeared while swimming at Shimoda, about 200 kilometers (125 miles) southwest of Tokyo. The woman was spotted by a cargo ship early Wednesday, about 36 hours after she disappeared, off the southern tip of Boso Peninsula, the coast guard said. The cargo ship asked a passing LPG tanker, the Kakuwa Maru No. 8, to help.

South Koreas KONEPS is the largest such platform in the world. GeM stands at the second position. It is followed by Singapore's GeBIZ. He added that the procurement by central ministries including CPSFs ministries including CPSEs surpassed Rs 1 lakh crore

milestone in this period with ministries of coal, defence and petroleum and gas emerging as the top procurers in this

quarter. "Of this Rs 1 lakh crore, CPSEs share accounted for more than Rs 91,000 crore," Singh said, adding during the first quarter, services segment has been the prime mover. Services buying crossed Rs

Services buying crossed Rs 80,500 during the quarter. In 2023-24, the procurement from this portal had crossed Rs 4 lakh crore.

Talking about the initiatives of the portal, Singh said that carrying forward its vision of reaching out to the last mile sellers and with an aim to further simplify public

procurement, they are planning to roll out 'GeM SAHAYĂK' programme which aims at creating a pan-India network of 6,000-7,000 trained and certified

Auto component industry to see moderate growth this fiscal: ICRA

The Red Sea crisis is likely to impact the margins of the auto component industry over the next few quarters amid higher container rates and shipping time, credit ratings agency ICRA said on Thursday, projecting moderate growth for the industry this fiscal.

Close to two-thirds of the auto component exports are made to North America and Europe, and one-third of the imports is made from these regions, as

per the ratings agency.
"The disruption along the Red Sea route has resulted in a surge in container rates by 2-3 times in YTD (year-to-date) this calendar year compared to CY2023, while shipping time has also increased by around two weeks," ICRA said. The operating margins are set

for a year-on-year improvement of around 50 basis-points in FY2025, benefitting from better operating leverage, higher content per vehicle, and value additions, while remaining exposed to any sharp volatility in commodity prices and foreign exchange rates, it said. Also, the industry's liquidity position, according to ICRA, remains remains comfortable, especially across tier-I players supported by stable cash flows and earnings. ICRA said it expects the growth in revenues of the Indica out a support of the Indian auto component industry to ease to 5-7 per cent this fiscal, from the highs of around 14 per cent in FY 2023-

PARIS IS MY FOURTH AND PROBABLY LAST OLYMPICS: MANPREET

He has no plans to retire anytime soon but former Indian men's hockey team captain Manpreet Singh very well knows that the Paris Games will be his fourth and last Olympics, and wants to give his best one last time at the world's biggest sporting extravaganza.

Manpreet, 32, was the captain of the Indian team that broke a 41-year-old Olympic medal drought in Tokyo by bagging the bronze

Besides, he has been a member of the team that won 2014 and 2022 Asian Games gold medals.

medals.
"I never thought that I would be able to play four Olympics. It is every player's dream to play in the Olympics and win medals. I consider myself very lucky that this is my fourth Olympics," Manpreet told PTI Bhasha

Bhasha.
"I am going to Paris thinking as if it is my last Olympics and I have to give my best. I haven't thought about quitting the game yet and my complete focus is on the Paris Games," the experienced midfielder, who made his debut for India in 2011 at the age of just 19 in 2011 at the age of just 19,

But the journey from Mithapur village in Jalandhar to Paris has not been a smooth sailing for Manpreet. He had to fight poverty, false allegations and witness mother's struggles to make a mark in his career.

After the Tokyo Olympics, Manpreet had to endure the worst phase of his career when

levelled serious allegations against him.

Marijne accused that Manpreet asked a player to underperform so that his friends could get in the team during 2018 Commonwealth Games, an allegation which both the men and women's teams jointly denied, stating that the Dutchman did so to publicise his book.

"That was the most difficult phase for me. I could never even think of such things. I was broken and lost faith in everyone. I told (PR) Sreejesh with whom I share everything. with whom I share everything. My mother also encouraged me to keep playing to fulfil my father's dream and my whole team supported me," said Manpreet. "In bad times, the support of the family and team is very important because at that time the player finds himself very lonely. When the team stands together it gives a team stands together, it gives a lot of encouragement and also helps in making a comeback. We have also seen Hardik Pandya making a great comeback recently."

"When I look back now, it seems like a dream. I come from a humble background where we have seen struggles for the basic needs.

"Father used to work as a carpenter in Dubai but had returned from there due to medical reasons. My mother struggled a lot and both my brothers also played hockey but they left due to financial problems," said Manpreet, who was the flag-bearer of the Indian contingent at Tokyo



Olympics along with boxing legend MC Mary Kom. Manpreet is no longer captain

of the side with Harmanpreet Singh taking over the responsibility, but the star mid-fielder knows his role in the team as one of the senior-most member.

"Even if I am not the captain now, it does not make any difference. Every player has his own role in hockey. The effort is to take everyone along. Being a senior, we have to inspire the youngsters," he said. Manpreet, who idolises Pargat Singh, who too hails from Mithapur, said they followed the same process which they did during Tokyo in terms of preparation for Paris Games.
"Before the Tokyo Olympics,

we spent maximum time together due to COVID that resulted in excellent team bonding. We will continue the same because 11 players are the same who were in Tokyo. We are sharing our experiences with the five debutants," he with the five debutants," he said. "Our pool is tough and we cannot take any team lightly. New Zealand has defeated us in the World Cup and Ireland."

With a late goal fit for a king, England reaches another Euro final by beating Netherlands 2-1

European Championship final after its latest dramatic, come-from-behind win that even took King Charles III on a roller coaster ride.

Ollie Watkins, who came on one watkins, who came on for captain Harry Kane in a bold call by England coach Gareth Southgate, scored in the first minute of stoppage time to earn England a 2-1 win over the Netherlands on

Wednesday and a shot at Spain in the title match.

In the knockout stage at Euro 2024, England has scored a stoppage-time equalizer before edging past Slovakia in the last 16 and needed a penalty-shootout to see off Switzerland quarterfinals.

The English are keeping their supporters back home on the edge of their seats as the men's team moves closer to a first title since the 1966 World Cup and that includes its monarch.

"If I may encourage you to secure victory before the need for any last minute wondergoals or another penalties drama, I am sure the stresses on the nation's collective heart rate and blood pressure would be greatly alleviated!" the king said in a congratulatory message soon after the game in Dortmund.

Watkins' goal was fit for a king. He had only made one previous appearance at Euro 2024 - as a substitute in the



group game against Denmark so it was a surprise when he was introduced by Southgate in the 80th minute in England's biggest match so far. The gamble paid off.

Fed by another substitute in Cole Palmer, Watkins took a touch with his back to goal just inside the area and, from a tight angle, smashed a fierce shot into the bottom corner.
"Unbelievable - I've been waiting for that moment for weeks," said Watkins, the Aston Villa striker who was the fourth-equal top scorer in the Premier League last season. "It's taken a lot of hard work to

get to where I am today. I got the opportunity and took it with both hands.'

It was painful for Netherlands coach Ronald Koeman.

"I had a feeling toward the end of the match that maybe we could score," Koeman said, "and for sure in extra time I'd have put money on us."

England will play Lamine Yamal and Spain in Sunday's final in Berlin. It will be the nation's first title match on foreign soil, having won the World Cup in 1966 and lost to Italy in the Euro 2020 final both times at Wembley

"It's going to be unbelievably tough - a really difficult game, Kane said of the title match, with Spain widely regarded as the best team at the tournament. "One more game

to make history." The sea of orange in the giant South Stand at Dortmund's Westfalenstadion fell silent for the first time after Watkins' late goal. It housed the most vocal of the Dutch supporters who dominated the city center before marching in their thousands to the stadium ahead of the game. Police reported three separate clashes between fans from both

It gave the occasion the feeling of a home match for the Dutch and England was up against it even more after the 21-yearold Xavi Simons became the second youngest scorer for the Netherlands at a Euros.

Saint-Germain The Paris midfielder dispossessed Declan Rice about 40 meters (vards) out, drove forward and unleashed a shot into the far corner from outside the area. Uruguay stays in Charlotte to meet Canada in Saturday night's thirdplace match.



"No -- two World Cups in a row," Starc was quoted as saying by Sydney Morning Herald on Willow Talk podcast when quizzed about his omission and whether he was amused by the decision.

"Just the match-up, they (team management) saw previous management) saw previous games on that ground in St Vincent with spin playing a part and obviously Ash (Ashton) and the left-armer enticing them to make a change," he added.



Trailblazing Indian shuttler Saina Nehwal feels she would have perhaps excelled more as a sportsperson if she had picked a tennis racquet instead of playing badminton. Nehwal has an impressive resume as a badminton player. Not only she became the first Indian woman shuttler to be ranked No. 1 in the world, she was the first woman athlete from the country to win an Olympic medal.

"Sometimes I feel that it would have been good if my parents had put me in tennis," Saina said during her "Her Story-My Story" talk at the Rashtrapati Bhawan.

"There is more money and I had more strength I think. I could have done better in tennis than badminton," she

added.

While Saina has inspired many to take up badminton, the 34year-old herself didn't have anyone to look up to when she picked the racquet at the age of

"When I started, I didn't have any role models to look up to. No one to look up to and say 'I want to be world number one or be an Olympic medallist,' I hadn't seen anyone do that in badminton before me," Saina said.

Mumbai City FC on Thursday announced roping in Greek striker Nikolaos Karelis ahead of the upcoming Indian Super League season.

The 32-year-old, also known as Nikos Karelis, is set for his maiden stint in India. He began his youth career with Ergotelis and made his senior professional debut with them in 2007.

Karelis has played for seven more clubs including stints in Russia (Amkar Perm), Belgium (Genk), England (Brentford)

Netherlands (ADO Den Haag). Mumbai City FC will be his eighth club.

Karelis has netted 103 goals in 361 professional matches along with 29 assists, while his best performance at a club came for Panathinaikos, for whom he scored 36 goals in 114 competitive games.
The 2014-15 season was his

standout when Karelis scored 19 goals in 50 contests.

He won the Greek Cup with Panathinaikos in 2013-14. Later, he also won two titles with the Greek club PAOK in 2018-19 (Super League Greece and Greek Cup).

Karelis was last associated with



another Greek Panetolikos, where he was adjudged its player of the season in 2022-23.

"The team has achieved significant success over the past few years, and I am eager to contribute to its continued success in the upcoming season," Karelis said in a release.

Medvedev, who is seeded No. 5 and defeated No. 1 Jannik Sinner in the quarterfinals, won the 2021 U.S. Open but is just 1-5 in major finals. The other match Friday will be

No. 2 Novak Djokovic, who has won seven of his men'srecord 24 championships Wimbledon, against No. 25 Lorenzo Musetti, making his

debut in a major semifinal. "Against him, you are

probably more stressed, because he's probably the best



player ever - or one of the best players ever," said the 22-yearold Musetti, who beat Taylor Fritz in five sets on Wednesday, while Djokovic got the day off because his foe, Alex de Minaur, withdrew

with an injured hip.
"You walk on court with a different mentality," said Musetti, whose 1-5 record against Djokovic includes a five-set loss at this year's French Open that ended at after 3 a.M. "If I play in a certain way, I could have my shot in the next round."

Alcaraz vs. Medvedev is a rematch from last year's semifinals, when Alcaraz won in straight sets before getting past Djokovic in the final. It also offers a contrast between a talented attacker (Alcaraz) and a consummate defender (Medvedev). "The most difficult thing about facing Daniil, or the

most special thing about him, is he can reach every ball," Alcaraz said. "Well, he is like a wall. Every ball bounces back. Asked what Alcaraz's best quality is, Medvedev began this way: "To be honest, everything.

That sounds like an exaggeration. Might not be.

"That's where it's tough to play against him, because you know whatever shot you hit, he can hit a winner from there. So you try to make his life difficult. You try to hit the shot as good as you can. Maybe he goes for it and he cannot make it," said Medvedev, who has won just two of their previous six encounters.
