Still grappling with NEET controversy, the cancellation of UGC-NET exams on Wednesday has brought serious troubles for Narendra Modi Government which has just started its third tenure and a Special Session of the Parliament scheduled next

With the ruling NDA on shaky numbers, Opposition leaders on Thursday launched an attack on the National Testing Agency (NTA) and accused the agency as well as the Union Government of destroying the future of students who appeared for these exams. They said the matter will be raised in Special Session of the Parliament next

Setback to parties as Patna HC scraps Bihar Govt's quota hike

The court declared null and void the Bihar Reservation of Vacancies in Posts and Services (for Scheduled Caste, Scheduled Tribes and Other Backward Classes) Amendment Act, 2023 and the Bihar (in admission in Educational Institutions)
Reservation (Amendment) Act, 2023 as ultra vires the Constitution and violative of equality clause under Articles 14, 15 and 16 of the statute. Meanwhile, the coalition Government-led by Nitish Kumar has decided to challenge the Patna High Court order in the Supreme Court. education. 'We, hence, set aside the Bihar Reservation of Vacancies in Posts and Services (for Scheduled Caste, Scheduled Tribes and Other Backward Classes) Amendment Act, 2023 and the Reservation (in Admission to Educational Institutions) Amendment Act, 2023 as ultra vires the Constitution and violative of the equality clause under Articles 14, 15 and 16. The writ petitions are allowed leaving the parties to suffer their respective costs," the bench said in its 87-page verdict. Reacting to the development,

Dance of death in heat-hit Delhi

With a severe heatwave sweeping vast swathes of the country, the National Capital has seen a huge upsurge in mortalities caused by sunstrokes and other heat-related ailments. As many as more than 210 succumbed to the heat fury not seen in decades in Delhi or elsewhere in the

country. Of the 210 dead in Delhi, 192 were homeless people who have been bearing the brunt of the extreme heat in the city. A total of 22 fatalities caused by suspected heatrelated illnesses have been recorded at the Ram Manohar Lohia Safdarjung hospitals in the last 24 hours.

The Centre for Holistic Development (CHD), an NGO working for the homeless, claimed that deaths of 192 homeless people due to extreme heat were recorded in Delhi

Though Delhiites have got some relief from the searing heat thanks to a mild dust storm and light rainfall causing a slight fall in the

39 killed in **Tamil Nadu** hooch tragedy

The death Kallakurichi liquor tragedy reached 39 by Thursday evening and more consumed the spurious liquor have been admitted to hospitals in the district. According to doctors in these hospitals, the death toll is likely to go up as the condition of many is reportedly serious.

Religare bid to block open offer draws fire from Sebi

Markets watchdog Sebi has non-banking financial company Religare Enterprises (REL) to seek statutory approvals from regulatory authorities for blocking an open offer by Dabur India promoter Burman family before July 12. The Burman group accused

Religare's board and its Chairperson Rashmi Saluja of obstructing the open offer. Meanwhile, Religare argued that the Burman family was not 'fit and proper' to undertake the acquisition. Sebi said that the NBFC did not

show any evidence that the Burman group suffers from such alleged infirmities. Expressing dissatisfaction over the Religare board's attempt to block the open offer, Sebi in its interim order said that Religare has "acted in an

apparently hostile manner". Sebi has ordered Religare to apply for approval to the Reserve Bank of India (RBI), Insurance Regulatory and Development Authority of India (IRDAÎ), besides Sebi. In response to the latest crore.

development, spokesperson said, "As per Sebi's advisory the company will apply for the fit and proper status of the acquirers (Burman Group) for the open offer to the concerned regulators including the RBI.

In its order, Sebi noted that Burman Group (MB Finmart, Puran Associates, VIC Enterprises and Milky Investment & Trading Company) were public Religare shareholders Enterprises with 21.54 per cent shares in the company before September 25, 2023.

On September 25, 2023, they orders through JM placed Financial Services Limited to purchase up to 5.27 per cent more which would increased their total shareholding to over 25 per cent.

This triggered the requirement to make an open offer to all shareholders under Sebi rules. The public announcement of this offer was made on September 25, 2023, stating that they intended to buy up to 26 per cent of the company's expanded voting share capital at Rs 235 per share, totalling Rs 2,115.99

Veiled woman robs ornaments from jewellery shop

hahjahanabad police have booked a veiled woman for robbery of gold and silver ornaments in Noor Mahal area in broad daylight on Thursday; accused robbed by throwing chilli powder in victim's eyes to commit the crime.

The crime was committed by a woman wearing a burqa (veil). Chilli was thrown in the eyes of the victim. Chilli was also stuffed in her mouth so that she could not scream.

After pushing her on the floor, the accused woman snatched two gold bangles and a gold ring worn by the victim. The accused woman fled after committing the crime in just two and a half minutes. The police are investigating the matter.

SHO of Shahjahanabad police UPS Chauhan said that Rizwana Hussain (63) lives in Ali Apartment Noor Mahal.

Her husband is a manager in Silver Line Hospital. The woman was alone in the house on Thursday afternoon. Her son had also gone to work. The accused rang the doorbell of the flat. As soon as the woman opened the gate, the accused woman entered the house. She threw chilli in the eyes of the victim. The chilli also went into the woman's mouth. Due to this, she could not make noise. After this, the accused woman intimidated the woman and fled with her jewellery. The cost of the jewellery and how much it was has not been revealed yet. We are investigating the matter, after which we will take further action.

Rizwana's husband Athar Hussain said that his wife usually stays alone in the house during the afternoon. On Thursday afternoon at 12:45, someone rang the doorbell of their second floor flat. When the wife opened the gate, a woman was standing in front. She immediately threw chilli powder in the wife's eyes. To prevent her from making noise, the woman also forcibly stuffed chilli powder in the wife's mouth

After this, the accused woman took off two bracelets and a gold ring worn by the wife. When she protested, she threatened to kill her. After committing the crime within just two and a half minutes, the accused woman escaped.

The accused woman was wearing a burqa while entering the house. While returning, she took off the burqa. The woman had already brought a polythene in her hand. The footage has been captured in the CCTV cameras in the accused woman's apartment. Immediately after the incident, the wife called me and informed me. Based on the description, the police are searching for the accused. The Ali Apartment in Noor Mahal where the incident took place has more than two dozen flats. Old Dadda Mian lives on the ground floor of the building who is responsible for guarding

the building. He said that at the time of the incident, he was present in his flat located on the ground floor. There are 28 flats in the apartment. Hundreds of people visit the houses of the people living in this apartment located in the middle of a dense settlement every day due to Eid.

I did not even know when the woman in the burqa committed the crime. Two flats in the neighbourhood of the place where the incident took place are vacant. The police said that a family lives in the flat in front. They said that they did not hear any noise. The incident came to light when Rizwana's husband

As per the intention of Chief Minister Dr. Mohan Yadav, Madhya Pradesh Police is taking prompt action towards banning the slaughter of cows and open sale of meat and illegal transportation in the state. On the instructions of the Police Headquarters, the police in every district activated its intelligence system and took prompt action by identifying the transport route as a surveillance, which has yielded remarkable results.

After assuming office, Chief Minister Dr. Mohan Yadav, during a meeting held at the Police Headquarters in December 2023, the police were instructed to take strict Burhanpur, Ujjain, Ratlam,

action against illegal transportation of cows in the state. In line with these instructions, the police have registered a total of 575 cases related to illegal cows in the last 6 months. In these cases, 1121 criminals have been arrested and 7524 cows have been freed. In this action, 342 vehicles transporting illegally have also been seized so far.

It was necessary for the police to keep an eye on illegal transportation at a confidential level. Therefore, the Police Headquarters prepared an action plan by doing a thorough analysis of the trends and routes of illegal transportation of cows in the last 10 years.

On the basis of which it became clear to the police that the border districts of the south and west of MP like Balaghat, Seoni, Chhindwara, Khargone, Barwani,

Neemuch etc. are most affected by the illegal transportation of cows.

The police are taking prompt and careful action in all these areas. It has also been learned that many times the criminals who illegally transport cows try to take out the cows from the main roads through the forest and village's unpaved path, special attention is also being paid to this and in many cases the accused were caught from these places.

It is worth noting that on June 11, 2024, all the collectors and SPs of the state were directed by Chief Minister Dr. Yadav during video conferencing to take special action on illegal transportation of cows. In compliance with these instructions, the police ensured strict action on illegal transportation of cows by running a special campaign in the entire state from 13 to 20 June 2024 last week. During this campaign, 70 cases of illegal transportation of cows were registered in the entire state. In this, action was taken against 124 accused and 38 vehicles were seized and

528 animals were freed. Under the Madhya Pradesh Cow Slaughter Prohibition Act, illegal transportation of beef and cows is banned in Madhya Pradesh. Defining beef and cows in the Act, their slaughter and illegal transportation has been prohibited. Similarly, slaughter of cows is also prohibited under the Madhya Pradesh Krishak Pashu Parikshan Act.

The Prevention of Cruelty to Animals Act also prohibits beating, excessive riding, loading and causing any kind of pain or torture to any animal. Recently, the district officials were specially informed and trained regarding the provi-



SC stays HC proceedings in NEET

The Supreme Court on Thursday decided to examine pleas questioning the Centre's appointment of National Testing Agency (NTA) chairman Professor Pradeep Kumar Joshi to the high-powered committee which recommended a re-test for 1,563 undergraduate National Eligibility-cum-Entrance Test (NEET-UG) candidates who were given grace marks. The Supreme Court has issued

notices to the Centre, the National Testing Agency (NTA) and others on petitions, including those seeking the scrapping of NEET-UG 2024 exam and a court-monitored probe into the alleged irregularities in the medical entrance test. The top court also stayed further proceedings on some pleas on NEET (Undergraduate)-2024 examination pending before different high courts in the country.

A vacation bench of Justices Vikram Nath and SVN Bhatti issued notices to the parties seeking their responses on four separate pleas filed by the NTA seeking transfer of some pending petitions, including those concerning alleged paper leak, from the high courts to the

It said the meeting identified new proposals for furthering the trilateral cooperation, including under the framework of the Indo Pacific Oceans Initiative (IPOI) and the Indian Ocean Rim Association (IORA) mecha-

The move reignites the contentious debate over the reliability of EVMs, despite the Supreme Court's recent dismissal of such claims as "unfounded."

However, since the Apex Court had allowed candidates who finished second or third to request verification of EVMs for a fee, candidates across eight parliamentary seats in six States, covering 92 polling stations, are now demanding a thorough investigation into the micro-controller chips embedded in the



machines. Notable applicants include Sujav Vikhe-Patil (BIP) from Ahmednagar, Maharashtra, and candidates from YSRCP and DMDK.

As per the rule, candidates must pay Rs 47,200 per EVM set for verification, which includes costs set by manufacturers (BEL and ECIL) and administrative expenses. The EC is responsible for communicating requests to manufacturers and has outlined a

process for verifying the EVMs, with a technical Standard Operating Procedure (SOP) to be issued later.Similar requests have been made for EVM verification following assembly elections in Andhra Pradesh, Odisha, Sikkim, and Arunachal Pradesh. This process aims to maintain transparency and integrity in the electoral system, addressing candidates' concerns about the election results.

Vikhe-Patil had lost to Nilesh Lanke of NCP (Sharad Pawar) faction. A YSRCP and a DMDK candidate too have applied for the verification, according to data shared by the poll panel. Candidates who come second or third and seek verification of the EVMs will have to pay Rs 47,200 per EVM set, according to the SOP issued by the EČ on June 1.

As per the SOP, the cost submitted by manufacturers BEL and ECIL to carry out EVM 'check and verification" is Rs 40,000 (plus 18 per cent GST) per set of EVM.

"In addition to the cost incurred by the manufacturers, there are also administrative costs like cost of labour to shift the units, CCTV coverage, electricity charges, videography costs and various other operational costs at the district election officer level, the document said.

Pacifying farmers

Cabinet approves MSP for 14 Kharif season crops amid rising farmer unrest, but is it enough?

■ n one of its first major decisions, the Modi Government has decided to assuage the farmers by increasing the Minimum Support Price (MSP). The Union Cabinet has approved the MSP for 14 Kharif season crops. This decision reflects the Government's attempt to ensure that farmers receive fair and remunerative prices for their produce, thereby helping them cope with rising input costs and inflation. Whether the farmers would welcome it, is doubtful. But it would indeed be some relief for the farmers. The approved MSP rates for Kharif crops indicate a substantial increase over the previous year. For instance, the MSP for paddy, the staple Kharif crop, has been raised by Rs100 per quintal, setting the new price at Rs 2,180 for the common variety and Rs 2,200 for the Grade A variety. Similarly, the MSP for maize has been increased by Rs 75 per quintal to Rs 2,130. These adjustments are part of a broader effort to cover a range of crops including cereals like rice and maize, pulses such as moong



and tur and oilseeds like soybeans and groundnuts. The recent surge in farmer protests underscores the presence of deeper systemic issues that extend beyond mere price support. High input costs, inadequate procurement infrastructure, mounting debt and the impacts of climate change are among the key factors driving farmer dissatisfaction. Many farmers struggle to access the benefits of the MSP due to insufficient procurement mechanisms and delays in payments. Moreover, the cost of essential inputs like seeds, fertiliser and pesticides has escalated, diminishing the net gains from the increased MSP. The pervasive issue of debt, compounded by crop failures

and unpredictable market prices, further exacerbates the financial instability of farmers. These factors underscore the need for interventions that go beyond MSP hikes to address the underlying challenges faced by farmers. While the MSP increase is a positive step, it alone is unlikely to resolve the multifaceted issues confronting the agricultural sector. Comprehensive reforms are essential to ensure sustainable improvements in the livelihoods of farmers. To achieve this, the Government must consider a holistic approach that includes enhancing agricultural infrastructure, improving access to credit and providing insurance against crop failures. Encouraging crop diversification and improving market access can also help mitigate risks associated with price volatility and reduce farmers' reliance on a few staple crops. Strengthening procurement systems to ensure timely procurement and fair pricing is crucial to making the MSP more effective. The Cabinet's approval of increased MSP for 14 Kharif crops, though inadequate, is a welcome development that reflects the Government's recognition of the pressing challenges faced by the agricultural sector. A concerted effort to implement systemic reforms alongside fair pricing mechanisms is essential for the advancement of India's farmers and the agricultural sector as a whole...

The devastating wildfires highlight a pressing environmental crisis compounded by human negligence and systemic failures



aging wildlife fires in Uttarakhand have made headlines during the last month. These forest fires are a grim environmental reality and also a reflection of human faults in a society riddled with romanticism and unbridled freedom. Adding to this the situation of indiscipline and scant respect for the law, the disconcerting picture is complete. The incidents of resource-destroying wildlife forest fires in the green hilly State of Uttarakhand are due to three factors as obliquely indicated above. These are — faulty living paradigms resulting in environmental pollution, a growing culture of unrestrained freedom among the youth and a weak administrative system that is unable to enforce existing laws. Global warming due mainly to the huge use of hydrocarbon aviation fuels is the big reason for wild forest fires the likes of which are regularly observed in Australia and the USA. The forest fires of Uttarakhand were quite similar to the fires in these countries. The naturally growing Chir Pine trees in this state are stated to be susceptible to fires. However, the triggering cause of the fire is atmospheric warming due to vehicular and

Uttarakhand has a vast belt of pollution causing the pharmaceutical industry of the modern allopathic school which makes extensive use of chemical raw materials. The other cause is mischief-mongering by delinquent youngsters as evident from the news that 3 persons hailing from Bihar were arrested for setting forest tracts in Uttarakhand's Chamoli district on fire to get more social media views. Finally, flagrant violation of environmental protection laws of the land through illegal tree felling and construction practices consti-

Benefits of integrating offline and online channels

As offline and online channels converge, businesses must adapt to ensure a seamless customer journey across all touchpoints

xpertise in channel management-as indeed in other fields-can often be self-referential. The conversations on universal principles for the management of the offline channel typically have little or no intersection with those for the online channel. While a number of these principles-developed in their silos-are indeed extremely useful, the consumer is (still) a person. Even in B2B businesses, the key decision-maker is a person or a group of persons.

It is the 'people-ness' of these people (consumers, customers) that creates a case for thinking. integrated Consistency of what a brand is saying is important essentially because of the muchcited phenomenon of short attention spans. However, consistency is not sufficientcondition to get some of the scarce attention that's essential at the very top of the funnel (attention-> interest-> decision-> action, or AIDA, the old marketing reliable). For instance, the individual seeking a new smartphone is probably going to visit a big retail outlet, where they might interact with a brand repre-

sentative and try out a demo unit. They might come across an Instagram post highlighting a new model. If this person is inclined towards gathering information and may have also read some reviews online and watched a YouTube influencer comparing different models. A few years ago, the number of people who have both offline and online dimensions in their purchase decision might have been very small, but this cohort is quite salient now. The challenging aspect in this customer journey is that the last A in AIDA, 'action' (purchase) might happen offline or online. Therefore, segregated structures for offline and online channels are not sustainable in the long term. It is clearly in the

brand's interest that offline

"telling the same story." Whether this story is of a new feature or a new colour, whether it be a story told in a YouTube video or by an indemonstrator. store Integration of offline and online channels is, therefore,

essential for a coherent conversation with the consumer. No smart manager starts with making a case for unintegrated offline and online channels. This situation arises because of some recurring,

largely structural issues. The offline channel is often managed through a command-and-control structure that has evolved over decades, while the online channel is relatively more nascent. Companies taking the latter lightly is of course rarely the case now but there's still much to learn about its dynamics. The narrative of D2C (directto-consumer) models being unviable that has set in among many minds after the boom and bust in the fortunes of D2C startups may delay integration efforts, but will not

stop the growth in the salience of online channels. Managerial specialisation is another reason for offline and online channels are, and online channels not being

integrated. Individuals who have acquired expertise through experience on offline channels are not necessarily the ones best suited to build or develop online channels, but with time this will change. Online and offline channels sometimes end up being unintegrated because of the list (or checklist) approach to channel execution. In this approach channel management is essentially a set of activities to be completed in a particular order. While the list approach is a hallmark of the manager who is strong at execution, it is not ideal for capturing strategic thinking. The choice of a metaphor that represents strategic thinking is essential for the integration of offline and online channels. Interconnected funnels might be a good, safe choice of metaphor in case a manager is struggling to find the ideal one for her context. Structural adjustments and

readjustments will continue to happen, but integrated channel thinking is inevitable, because of its direct impact on customer experience.

G7 SUMMIT AND THE GLOBAL SOUTH

The Summit acknowledged the critical role of the Global South

he recent G7 meeting held in picturesque Apulia, Italy, had several pointers on the recent geopolitical shifts and changing equations between some of the most powerful nations in the world. Yes, the meme-worthy, Pictures of Stares, Namaskars and Parachute Landings, kept the social media alive and brought energy to an otherwise, boring round of meetings and dinners of world leaders, discussing topics of shared interest, the underlining points were not missed.

First, the clear focus of the meeting, as highlighted in the joint communique was Ukraine to send some tough messages to China and other parties working covertly with Russia. In a not-so-veiled message and directly naming China the Joint Statement read "We will continue taking measures against actors in China and third countries that materially support Russia's war machine, including financial institutions, consistent with our legal systems and other entities in China that facilitate Russia's acquisition of items for its defense industrial base. We reiterate that entities, including financial institutions, that facilitate Russia's acquisition of items or equipment for its defense industrial base are supporting actions that undermine the territorial integrity, sovereignty and independence of Ukraine. Accordingly, we will impose restrictive measures consistent with our legal systems to prevent abuse and restrict access to our financial systems for targeted individuals and entities in third countries, including Chinese entities, that engage in this activity. "The message to China was, don't keep playing with fire, as one day, it may singe you. It may be worth mentioning that the US has undertaken several export control measures to prevent the transfer of hightech equipment to China, which have dual-purpose utilities, i.e. can be used for making precision weapons as well as cyber surveillance tools. China was the only large economy, (not so direct a party to the Russia-Ukraine war), which was absent from the G7 summit.

Recently Chinese President Xi Jinping undertook a tour of several European countries to ease the tariff-related issues, imposed by several European nations, against Chinese electrical vehicles. While some nations in Europe are committed to the US-led vision of hard measures on China, several others are on the fringe, tilting towards China.



Meanwhile, this G7 summit, in a backhanded compliment of sorts, for Prime Minister Narendra Modi's vision of inclusion of Global South countries in world affairs, reiterated the importance of African nations and pledged several measures to boost the economic prosperity of the region. The Joint Statement Stated "We endorse African countries' call for greater voice in international bodies and welcome the AU's participation in the G20 as a permanent member and the creation of a third Chair for sub-Saharan Africa at the IMF Executive Board in November. We reiterate our support for the G20 Compact with Africa, as a tool to increase private sector investments, promote structural reforms and local entrepreneurship support and enhance cooperation, including in the energy sector." PM Modi who was also in Apulia, as a special invitee, in his brief outreach session addressed highlighted the preeminence of Global South countries. He said "The countries of the Global South are bearing the brunt of global uncertainties and tensions. India has considered it its responsibility to place the priorities and concerns of the countries of the Global South on the world stage. We have given high priority to Africa in these efforts. We are proud that the G-20, under India's chairmanship, made the African Union a permanent member. India has been contributing to the economic and social development, stability and security of all African countries and will continue to do so.

A new world order with multiple voices opining on global matters, at a time when existing political structures are being challenged domestically, was one clear message from the G7 meeting in Italy.

The unseen burden of women's unpaid labour



Globally, women spend significant time on unpaid care work, limiting their participation in the labour market and affecting economic stability



n the early 60s when Canadian short story writer, Alice Munro, who died recently, earned some success, a newspaper ran a piece on her, which had a condescending headline the 'housewife who finds time to write short stories'. The banter fell through Alice and she went on to win a Nobel in literature in 2013. While another Nobel winner in Economics in 2023, Claudia Goldin, explained in her research that a woman's vocation is not always guided by her choice, but, more often by the 'long-standing societal trends', which build a 'cult of domesticity' around her, idealising her role as an unpaid caregiver.

Not surprising that women spend almost 76.2 per cent of total hours, three times more than men, on unpaid care work (ILO). Of all regions, the Pacific and Asia present the worst scenario, with men performing the lowest share of unpaid care work (1 hour and 4 minutes). In 2018, 606 million working-age women ressed disappointment that they failed to enter the labour market because of the burden of unpaid care work, which was the case for only 41 million men. In terms of monetary value, women's unpaid work may exceed up to 40 per cent of GDP in some countries (ILO). Social scientists contend that child-bearing, as well as the age and number of children, more than marriage, impede women's entry into the labour market.

Women (aged 25-54) face a wide disparity in labour force participation rate (LFPR), which remains only 61.4 per cent, as against men's 90.6 per cent (World Bank, 2022). While, in the lone women households, with at least one child under 6, economic compulsion lifts women's LFPR to about 65.8 per cent, but, it goes down to 48.7 per cent, when mothers live with a partner and a young child, as the 'male breadwinner' syndrome prevails (UNWomen).

Notwithstanding, the 'breadwinner moms' also bear a heavier load at home,

even if they out-earn their husbands' (Pew Research Centre). While, the 'motherhood penalty' is very much persistent in the USA (Harvard, 23). 'Moms were six times less likely than nonmothers and 3.35 times less likely than child-free men to be recommended for a hire...and are 114 per cent more likely than dads to take a career pause(Mom Project, US, a career-resource platform for working mothers). 'If a kid is sick,.... it's going to be the woman to take time off, because they are paid less, which makes more economic sense' (PNAS,

While, a report by the British trade union association TUC, said that 'men do not face a penalty as parents at all, rather, fathers who work full time, experience a wage bonus, when they have children, earning 22 per cent more. The disparity arises not because mothers actually become less productive employees, or fathers work harder becoming parents, but, because employers expect them to be so, indicating a clear-cut culture bias about gender and work', said Michelle Budig, a sociology professor, University of Massachusetts,

Her research further revealed that on average, men's earnings increased by more than 6 per cent when they had children, if they lived with them, while, women's decreased by 4 per cent for each child they had (National Longitudinal Survey of Youth, US, 1979 to 2006).

In India, childbirth impacts women's entry into the labour market, but, differently, in the context of urban and rural. A study, collecting the Life History

States of Karnataka and Rajasthan, suggested that motherhood may not be accompanied by a penalty in terms of labour market participation for rural women because of the predominance of informal and flexible employment, which are more conducive for childcare responsibilities than work in an urban more formalised

setting(Gautham 2021). The analysis of data from the Employment-Unemployment Schedule (EUS) of the NSS from 2004 to 2012 revealed that rural motherhood wage penalties are close to zero, whereas, urban women pay a large penalty of about 18 per cent of total wages and highly educated women, or women in regular or salaried wage work, incur a larger wage penalty after motherhood than their less educated or casual wage counterparts (Wilde et al. 2010). However, first-time fathers, both rural and urban, experience no negative wage effects following the birth of children.

The lack of childcare facilities is one of the most significant impediments to gender equality in job markets (UNWomen). A macro-econometric analysis of childcare policies in 18 OECD countries (1980-2007) commented that measures like high levels of employment protection and longer paid leave are crucial for the survival of working mothers (Thévenon, 2013). In 2016, an analytical study (ITUC) in seven high-income OECD countries, appraised that an investment of two per cent of GDP in the care industry, could create nearly 13 million new jobs in the US, 3.5 million in Japan, nearly 2 million in Germany, 1.5 million in the

Australia and nearly 120,000 in Denmark and boost women's employment rate by 3.3 to 8.2 percentage points, as against men's 1.4 to 4.0 percentage points. Subsequently, similar research (ITUC) in emerging economies such as Brazil, Costa Rica, China (People's Republic), India, Indonesia and South Africa, also substantiated that the same amount of investment in the health and care sector would bolster nearly 24 million new jobs would in China, 11 million in India, nearly 2.8 million in Indonesia, 4.2 million in Brazil and over 400,000 in South Africa and 63,000 in Costa Rica.

While, the ILO's recent global Care at Work' report exhorted that to reducing the gender gap in employment by 7 percentage points and the monthly earnings gap to 1.8 per cent by 2035, a sustainable annual investment of over \$204 billion, an average of 5.8 per cent of GDP per country, should be invested for universal childcare and long-term care services. While, feminist economists (Elson et al.) and proponents of the Purple Economy (Ilkkaracan), vouched for recognising care as 'an indispensable component of human well-being' and called for a 'caring and gender equal economic and social order, by sharing caregiving responsibilities between the State and households and women and men.

It is high time now that the world fulfils its SDG 2030 commitments and ensures women's economic justice and equality, with appropriate policy formulations and resource allocations.

UGC set to revolutionise higher education in India

The University Grants Commission has introduced a transformative policy that is expected to align India with global educational practices

he University Grants Commission (UGC) in its recent decision has allowed Higher Education Institutions (HEIs), which offer programs in regular mode, to admit students twice a year, from the coming academic year. This option would be made available only in those HEIs that intend to increase their student intake and offer new programmes in emerging areas. Earlier, the UGC had decided in its 571st commission held on 25 July 2023 to permit biannual admissions under Open and Distance Learning (ODL) and Online modes in January and July during an academic year. Last year, after the UGC had permitted two cycle admissions in a year for ODL and Online modes, in addition to

a total of 19,73,056 students who were enrolled in July 2022, an additional 4,28,854 students joined in January 2023 in these programs. That means, nearly half a million students benefited from this decision. It also shows the dearth of seats and the craving for Degrees.

This policy decision will benefit several students who especially intend to go abroad for

In India, many scholars pursue a doctorate for the sake of procuring a PhD degree after post-graduation. Whereas, in European countries like Germany, students while pursuing their secondary education develop the flare for a particular vocational course and practice it on grounds. After a while, they return to learn more about that particular profession through higher studies. No doubt, many of them do their PhD in plumbing or automobiles and add value to their profession.

In countries like Germany, education is a lifelong learning process and addresses the Government agencies, acade-

ever-changing demands of the labour market. The learning is procured through adult education, professional development, recognising prior experience, flexible learning pathways and providing opportunities for seniors to pursue personal interests. The ongoing learning and training is imparted through Evening classes, Workshops, Vocational courses and Non-formal educational programs tailored to adults seeking to acquire new skills or qualifications.

These educational opportunities are provided by diverse entities, including municipal and private institutions, religious organisations, trade unions, industry and commerce chambers, associations, political parties, businesses,

mies, family education centres, vocational schools, as well as media outlets like radio and

television. In India, the recently introduced vocational degree courses like BVoc and MVoc have failed to take off and get the desired results as expected. The adult mindset is different here, as they prefer a white-collar job. But the reality is different. One of the ITI pass out in the AC stream, Mr Khatri, an entrepreneur was recently awarded for his turnover of over Rs 10 crore per year. It is not the Degrees, but the determination and expertise in their profession, that makes a person successful.

In most of the developed countries like the USA, Canada, Australia, the UK and Germany, college students while pursuing their higher studies work and earn. The literacy campaign and the efforts to bring back the school dropouts in India have yielded good results. The missing link is the flare for a particular vocational course, handson training, experience in the respective field and the confidence to be of their own. A change in the mindset of senior secondary-level students towards their career perspective can make a difference. Adopting the worldwide model of universities is good, but engaging them after this biannual mode of education is what the policymakers need to ponder upon. (The writer is a former editor

Putin signs deals with Vietnam Defendant in Vatican trial takes case to UN,

Russian President Vladimir Putin signed a series of deals with his Vietnamese counterpart To Lam on Thursday, during a state visit that comes as Moscow is seeking to bolster ties in Asia to offset growing international isolation over its military actions in Ukraine. The two signed agreements to further cooperation on education, science and technology, oil and gas exploration and health. They also agreed to work on a roadmap for a nuclear science and technolo-

gy centre in Vietnam. Following the talks, Putin said that the two countries share an interest in "developing a reliable security architecture" in the Asia-Pacific Region based on not using force and peacefully settling disputes with no room for "closed military-political blocs".

This was echoed by Vietnam's new President To Lam, who said they seek to further "further cooperate in defense and security to cope with non-traditional security challenges" while implementing energy projects and expanding investments. He also congratulated Putin on his re-election and praised Russia's "domestic political stability".

The agreements between Russia and Vietnam were not as substantial as an agreement Putin signed with North Korean leader Kim Jong Un the previous day, pledging mutual aid in the event of invasion said Nigel Gould-Davies, a senior fellow for Russia and Eurasia with the International Institute for Strategic Studies in London, and a former British ambassador to Belarus

Putin arrived in Hanoi early Thursday morning from North Korea, where he and North Korean leader Kim Jong Un signed an agreement that pledges mutual aid in the event of war. The strategic pact that could mark the strongest connection between Moscow and Pyongyang since the end of the Cold War comes as both face escalating standoffs with the

Putin also met Vietnam's most politician,

Secretary Nguyen Phu Trong, as well as Prime Minister Pham Minh Chinh, according to the official Vietnam News Agency. He is also scheduled to meet parliamentary chief Tran Thanh Man. Putin drove to Vietnam's Presidential Palace on Thursday afternoon, where he was greeted by school children waving Russian and Vietnamese flags. There, he shook hands with and embraced Lam before a bilateral meeting and a joint briefing to the media.

Russia is keen to maintain "close and effective cooperation" in energy, industry, technology, education, security and trade, Russian Ambassador to Vietnam Gennady S. Bezdetko said on Wednesday, according to Vietnamese official media. The trip has resulted in a sharp rebuke from the US Embassy in

Much has changed since Putin's last visit to Vietnam in 2017. Russia now faces a raft of USled sanctions for its invasion of Ukraine. In 2023, the International Criminal Court in Hague issued an arrest warrant for Putin for war crimes. The Kremlin rejected it as "null and void", stressing that Moscow doesn't recognize the court's jurisdiction.

Putin's recent visits to China and now North Korea and

Vietnam are attempts to "break the international isolation", said Nguyen Khac Giang, an analyst at Singapore's ISEAS-Yusof

Ishak Institute. The US and its allies have expressed growing concerns over a possible arms arrangement in which Pyongyang provides Moscow with badly need ed munitions for its use in Ukraine, in exchange for economic assistance and technology transfers that could enhance the threat posed by Kim's nuclear weapons and missile programme. Both countries deny accusations of weapons transfers, which would violate multiple UN Security Council sanctions that Russia previously endorsed Meanwhile, Russia is important to Vietnam for two reasons, Giang said: It is the biggest supplier of military equipment to the Southeast Asian nation, and Russian oil exploration technologies help maintain its

tested South China Sea. 'Russia is signalling that it is not isolated in Asia despite the Ukraine war, and Vietnam is reinforcing a key traditional relationship even as it also diversifies ties with newer partsaid Prashanth Parameswaran, a fellow with the Wilson Centre's Asia

It is unlikely that Vietnam will supplying significant quantities of weapons to Russia, because that would risk progress the country has made with NATO members on military equip-ment, particularly the US, which has donated naval patrol vessels and is in talks to supply aircraft, said Ridzwan Rahmat a Singapore-based analyst with the defense intelligence company Janes. "There is progress that you wouldn't have imagined just 10 years ago," he said. "So

would imagine Vietnam wouldn't want to take a risk, inviting the wrath of Western countries by supplying the Russians." Hanoi and Moscow have had diplomatic relations since 1950, and this year marks 30 years of a treaty establishing "friendly relations" between Vietnam and Russia.

Evidence of this long relationship and its influence can be seen in Vietnamese cities like the capital, where the many Soviet-style apartment blocks are now dwarfed by skyscrapers and a statue of Vladimir Lenin, the founder of the Soviet Union, stands in a park where kids skateboard every evening. Many of the Communist Party's top leadership in Vietnam studied in Soviet universities, including party chief Trong.

accuses pope of violating his rights

One of the defendants in the Vatican's big financial trial has filed a formal complaint with the United Nations, alleging that Pope Francis violated his human rights by authorising wide-ranging surveillance during the investigation. A lawyer for Raffaele Mincione,

a London-based financier, submitted a complaint last week to the UN Office of the High Commissioner for Human Rights via a special procedure that allows individuals or groups to provide the UN with information about alleged rights violations in countries or institutions.

The Vatican on Thursday rejected the claim, saying the investigation followed all relevant laws and international agreements and that no surveillance was ordered for Mincione.



The filing marks the latest and highest-profile complaint about the Vatican trial, highlighting the peculiarity of the Vatican's criminal justice system and its seeming incompatibility with European and democratic norms. The Vatican is an absolute monarchy where the pope wields supreme legislative, executive and judicial power. The trial, which opened in 2021 and ended in December, focused on the Holy See's money-losing 350 million euro

erty but also included other tangents. Vatican prosecutors alleged brokers and Vatican officials fleeced the Holy See of tens of millions of euros in fees and commissions, and then extorted the Holy See for 15 million euros (\$16.5 million) to cede control of the property. The trial ended in December

with convictions for nine of the 10 defendants, including Mincione and a once-powerful cardinal, Angelo Becciu. The court's motivations for the sentence still haven't been published, but both Vatican prosecutors and the nine convicted defendants have announced appeals. Mincione's complaint to the UN focused on the role of the pope during the investigation, an area that was flagged as problematic by defense lawyers during the trial and external experts in its aftermath.

The complaint cited four secret executive decrees Francis signed in 2019 and 2020 that gave Vatican prosecutors wideranging powers to investigate, including via unchecked wiretapping and to deviate from existing laws. The decrees only came to light right before trial, were never officially published, provided no rationale or timeframe for the surveillance, or oversight of the wiretapping by an independent judge.

The chief prosecutor argued Francis' decrees provided unspecified "guarantees" for the suspects, and the judges rejected the defense motions at the time that claimed they violated the fundamental right to a fair trial. In a somewhat convoluted decision, the judges ruled that no violation of the principle of legality had occurred since Francis had

Romania pres withdraws from race for NATO chief

Brussels (AP): Romania's president has withdrawn from the race to become NATO's next secretary general, leaving outgoing Dutch Prime Minister Mark Rutte all but certain to head the world's biggest military organisation from October. The office of President Klaus Iohannis said in a statement that Romania's security council has backed Rutte's

It also said that Iohannis had informed NATO late last week that he intended to pull out.His withdrawal removes the last real hurdle Rutte might face. It should allow NATO to put on a show of unity and demonstrate solidarity with war-ravaged Ukraine when US President Joe Biden and his counterparts meet in Washington on July 9-11 to mark NATO's 75th birthday.

Duterte resigning from Marcos' Cabinet as alliance flounders

Philippines Vice President Sara Duterte is resigning from her posts of education secretary and head of an anti-insurgency body, as her whirlwind alliance with President Ferdinand Marcos Ir. unravelled over key differences, including efforts to arrest a religious leader accused of child abuses and Manila's handling of escalating territorial disputes with Beijing.
Duterte will remain the vice

president. Her resignation from the other posts she had in Marcos' Cabinet was accepted by the president and takes effect July 19, Communications Secretary Cheloy Garafil said in a statement on Wednesday

Duterte, 46, did not cite any reason for her resignation, Garafil said, but there have been open political hostilities between her father, former President Rodrigo Duterte, and Marcos. She ran as the vice-presidential running mate of Marcos, the son and

namesake of an ousted dictator, under a hastily forged unity ticket and won with huge margins in 2022. The alliance of the scions of two authoritarian leaders combined the voting power of their families' political strongholds but compounded worries of human rights activists. The alliance, however, rapidly faced political headwinds. Early this year, the former president accused Marcos' legislative

allies of plotting to amend the constitution to lift term limits and warned that could lead to him being ousted by a public uprising like his father, the late dictator Ferdinand Marcos, in 1986. He also accused Marcos of being a drug addict.

Marcos laughed off the allegations and claimed his predecessor was using fentanyl, a powerful opioid.

Is Earth really getting too hot for people to survive?

Fort Collins (US)My parents said the planet is getting too hot for people to live here. They called it climate change. What does that mean? - Joseph, age 12, Boise, Idaho.

Many countries have seen extremely hot weather lately, but in most of the inhabited world, it's never going to get "too hot for people to live here," especially in relatively dry climates.

When it's hot outside in dry places, most of the time our bodies can cool off by evaporating water and heat from our skin as sweat.

However, there are places where it occasionally gets dangerously hot and humid, especially where hot deserts are right next to the warm ocean. When the air is humid, sweat doesn't evaporate as quickly, so sweating doesn't cool us the way it does in drier environ-

In parts of the Middle East,

Pakistan and India, summer heat waves can combine with humid air that blows in off the sea, and this combination can be truly deadly. Hundreds of millions of people live in those regions, most without access to indoor air conditioning. Scientists like me use a "wet

bulb thermometer" to get a better sense of this risk. A wet bulb thermometer allows water to evaporate by blowing ambient air over a damp cloth. If the wet bulb temperature is over 95 F (35 C), and even at lower levels, the human body won't be able to let enough heat out. Prolonged exposure to such combined heat and humidity

can be fatal. During a severe heat wave in 2023, wet bulb temperatures were very high over the lower Mississippi Valley, though they didn't reach fatal levels. In Delhi, India, where air temperatures were over 120 degree

several days in May 2024, the wet bulb temperatures came close, and several people died from suspected heatstroke in the hot and humid weather. In conditions like that, everyone has to take precautions.

IS IT CLIMATE CHANGE?

When people burn carbon whether it's coal in a power plant or gasoline in a vehicle it creates carbon dioxide (CO2). This invisible gas builds up in the atmosphere and traps the Sun's warmth near the Earth's surface. The result is what we mean by

"climate change." Every bit of coal, oil or gas that

ever gets burned adds a little bit more to the temperature. As temperatures rise, dangerously hot and humid weather has begun to spread to more places. Areas of the US Gulf Coast in Louisiana and Texas are increasingly at risk of danger-Fahrenheit (49 Celsius) for ous hot and humid conditions

in summer, as are heavily irrigated areas of the desert Southwest where water sprayed over farm fields adds moisture to the atmosphere.

Climate change causes a lot more problems than just hot, sweaty weather. Hot air evaporates a lot more

water, so crops, forests and landscapes in some areas dry out, which makes them more susceptible to wildfire. Each Celsius degree of warming can cause a sixfold increase in wildfire over parts of the western U.S.

Warming also makes ocean water expand, which can flood coastal regions. Rising sea levels threaten to displace as many as 2 billion people by 2100. All of these impacts mean that climate change threatens the

global economy. Continuing to burn coal, oil and gas could cut global incomes by about 25% by the end of the century,

according to one estimate.

Anew mutual-defence pact signed by Russian President Vladimir Putin and North Korean leader Kim Jong Un commits each country to come to the other's aid if attacked. Just what the threshold for such assistance would be is currently unclear maybe deliberately so, to deter other countries from putting it to the test. Putin initially told Russian media that the partnership provides for "mutual assistance in the event of aggression against one of the parties", while North Korea's state-run Korean Central News Agency later reported that the pact's Article 4 called for assistance "in the event that either of the parties is invaded and pushed into a state of war".

If the pact is triggered, the countries' obligations are also vague, with KCNA reporting that if one is attacked the other must deploy "all means at its disposal without delay" to provide "military and other assistance". Experts note that the language is almost identical to that of a previous mutual defense pact from 1961 between the Soviet Union and North Korea, which was never put to the test.

Such pacts are not uncommon and are rarely invoked, while often being touted as a means of deterring aggression, though the agreement between the two unpredictable and autocratic leaders of nuclear nations immediately raised concerns globally.

The United States has many similar treaty obligations with other Asian nations, not to mention through NATO's Article 5 provision, which says that an attack on a member of the alliance is to be considered an attack against all of its members. The only time NATO's Article 5 has been invoked has been to come to the defence of the US after the September 11, 2001, attacks. Russia also has mutual defense pacts with several post-Soviet states through its Collective Security Treaty Organisation

Kazakhstan. China has only one mutual defense agreement, and it's also with North Korea, formally known as the Democratic People's Republic of Korea.

In addition to its NATO obligations, the US also has mutual defence agreements with multiple Central, South American and Caribbean nations under the 1947 Rio Treaty.

The US does not have a mutual defense pact with Taiwan and adheres to a so-called One China policy, in which it recognizes only Beijing as the government of China but allows informal relations and defence ties with Taiwan.

China maintains that self-governing Taiwan is a part of its territory and has not ruled out taking the island by force if necessary. The US has left it intentionally vague how it would respond if Taiwan were to be invaded by China, pursuing a policy known as "strategic ambiguity"

At the same time, US President Joe Biden has said on several occasions that the US would respond militarily if China invaded Taiwan. US Secretary of Defence Lloyd

Austin said earlier this month, however, that war with China was neither imminent nor unavoidable, stressing the need for continued dialogue.

Russia hammers power grid in Ukraine again

Kyiv's drones target enemy oil depots

Russia resumed its aerial pounding of Ukraine's power grid and Kyiv's forces again targeted Russian oil facilities with cross-border drone strikes, seeking to curb each other's ability to fight in a war that is now in its third year, officials said on Thursday.

With no major changes reported along the 1,000-kilometer (600-mile) front line, where a recent push by the Kremlin's forces in eastern and northeastern Ukraine has made only incremental gains, both sides in the war have taken aim at distant infrastructure targets. In its seventh major attack on

Ukrainian power plants since Moscow intensified energy infrastructure attacks three months ago, Russia fired nine missiles and 27 Shahed drones at energy facilities and critical infrastructure in central and eastern Ukraine, the Ukrainian air force said. Air defences intercepted all the drones and five cruise missiles, it said. The attack hit power structures

Donetsk, Dnipropetrovsk, Kyiv and Vinnytsia regions of Ukraine, causing "extensive damage", according to national power company Ukrenergo. Seven workers were injured, it said. Ukrenergo announced extended blackouts across the country despite electricity imports and help with emergency supplies from European countries. Private energy company DTEK said one of its power plants was hit in the overnight attack but did not specify its location. Three company employees were injured and the plant's equipment was severely damaged, DTEK said on

social media. Among the most damaging recent strikes on Ukraine's energy supply were an April barrage that damaged Kyiv's largest thermal power plant and a massive attack on May 8 that targeted power generation and transmission facilities in several regions. Rolling blackouts have affected Ukrainian households and industry.

The Russian Defence Ministry said in a statement that the strikes aimed at Ukrainian

Treason trial of Russian American woman opens amid tensions

The trial of a Russian American dual citizen whom Russia accuses of treason opened on Thursday amid rising tensions between Washington and Moscow that have included the arrests of two American journalists.

The trial is being held behind closed doors in Yekaterinburg, in the same court that next week is to begin hearing the case of Evan Gershkovich, a Wall Street Journal reporter who was arrested in March 2023 and charged with espionage. The defendant was identified by Russian authorities as Los Angeles resident Ksenia Karelina, although US media reports frequently use the surname Khavana, the last

Karelina was born in Yekaterinburg and was arrested in February while visiting family. Russia's main domestic security agency, the Federal Security Service, charges that Karelina raised money for a Ukrainian organization that was providing weapons, ammunition and other supplies to the Ukrainian military. Her boyfriend has said she made a single donation of about \$50 to a Ukrainian organization, according to media reports. Karelina faces a sentence of 20

years in prison if convicted. Almost all Russian criminal cases that make it to court end in convictions. Gershkovich, the highest-profile American behind bars in Russia, is accused of gathering secret information

from a tank factory in Yekaterinburg's region. His employers deny the allegation, and the US State Department has declared him to be wrong fully detained. 35 Pakistanis among over 900 died during Haj in S Arabia

Aamong more than 900 people from around the world who died during this year's Haj pilgrimage in Saudi Arabia marked by searing heat, the government has confirmed.

Pakistan's Ministry of Religious Affairs said on Wednesday that Haj was challenging this year due to extreme heat and harsh weather conditions, with temperatures reaching 50 degrees Centigrade. Saudi state TV said temperatures on Monday rose as high as 51.8 degrees Celsius at the Grand Mosque in Makkah.

The Director General of Pakistan's Haj Mission, Abdul Wahab Soomro, said on Wednesday that as of June 18, a total of 35 Pakistani casualties had been reported.

This includes 20 in Makkah, six in Madina, four in Mina, three in Arafat and two in Muzdalifah, the Dawn newspaper quoted Soomro as say-

IVIAnwar Ibrahim on Thursday rejected the notion that China's dominance is to be feared, calling China a "true friend" at the end of Premier Li Qiang's visit to mark 50 years of diplomatic ties between their countries.

While the leaders raised some contentious bilateral issues Anwar said they discussed them as "equal partners, as trusted friends." He didn't give details but likely referred to the prickly issue of overlapping territorial claims in the South China Sea.

"People say, well, Malaysia is a growing economy. Don't let China abuse its privilege and extort from the country. I said no. To the contrary, we want to benefit from one another, we want to learn from one another and we want to profit from this engagement," Anwar told some 200 business leaders at a luncheon attended by Li. Anwar said he rebuked the

"incessant propaganda that we

should cast aspersions and fear the dominance of China economically, militarily, technolog-

'We do not. We in Malaysia, having a neutral stance, have the resolve to work with all countries and with China," he said. "We see Premier Li Qiang as a friend that would work together with us." Li, the first Chinese premier to visit Malaysia since 2015, flew in for a three-day visit on Tuesday on the last leg of a regional tour. Li, China's No. 2 leader after

President Xi Jinping, was also the first Chinese premier to visit New Zealand and then Australia in seven years.

The two leaders on Wednesday agreed that China and other claimant countries in Southeast Asia should tackle the South China Sea dispute "independently and properly" through dialogue and cooperation, and via bilateral settlement. No details were given but the statement came amid concerns the dispute could escalate tensions between the US and China.

'Minority families in Khyber Pakhtunkhwa migrating due to worsening security situation'

Many families of minorities in Pakistan's restive Khyber Pakhtunkhwa province have migrated to other parts of the country or abroad due to the worsening security situation, according to a religious scholar and Hindu rights activist.

Haroon Sarabdiyal of the Pakistan Hindu Mandir Management Committee said that Hindu, Sikh and Christian families mostly shifted to the provinces of Punjab and Sindh while some moved to foreign countries. The worsening law and order situation in the province has forced the Hindu and Sikh traders to leave their ancestral homes for a peaceful living elsewhere, he said.

Most Hindus and Sikhs from tribal areas, Peshawar, Swat and some mountainous areas left their ancestral areas, Sarabdiyal said. Many Sikh families also left Mohallah Jogan Shah, one of the oldest

Peshawar, due to an increase in incidents of target killings in the province over the last few years. The locality, situated near Dabgari, is home to a historic gurdwara and a community school of Sikhs. There were around 6,000 Sikhs who

lived in Mohallah Jogan Shah. This is the area where our ancestors lived and we have maintained our culture, traditions and our own educational system," said 50-year-old Pardeep Singh. Bhai Joga Singh Khalsa Dharmic School and Guru Angad Dev Jee Khalsa Dharmic School both impart religious as well as secular education, with a deep focus on Sikh culture in Mohallah Jogan Shah. President Joe Biden was set to sign the Tibet policy bill adopted by both the US Senate and the House of Representatives. The bill awaits Biden's signature to make it into law. The bill seeks to counter

China's narrative about its control over Tibet and promote dialogue between the Chinese government and the Tibetan spiritual leader the Dalai Lama, who is based in India since he fled the Himalayan region in 1959. On Tuesday, Beijing urged Biden not to sign the



'resolute measures".

On the US delegation's visit to Dharamsala and its talks with the Dalai Lama, Lin said, "We urge the US to clearly see the sensitivity and importance of Xizang-related issues and earnestly respect China's core interests on its comments on Xizang, refrain from any forms with the Dalai group and stop sending out to the world wrong signals He also criticised the reported

remarks by the Tibet government-in-exile that it is going to use the new Tibet legislation passed by the US Senate and Congress to try to force China to come to the negotiating table and urge other countries to put pressure on Beijing to hold talks with it. The so-called Tibet govern-

ment-in-exile is an out-and-out separatist political group and an illegal organisation in total violation of China's constitution and laws. It is not recognised by any country," Lin said. After the US Congressional talks with the Dalai Lama, McCaul said on Wednesday that the Tibetans have the right to selfdetermination and should be allowed to practise their religion freely.

At a felicitation ceremony held after the seven US Congress members met the Tibetan leader, McCaul said the delegation had defied a warning from the Chinese Communist Party.

'The Tibetan people possess a distant religion, culture and historic identity and they should have a say in their own future. You should be able to freely practise your religion and that is why we are here today in defiance of the CCF (Communist Party of China) warning," he said.

"Our delegation received a letter from the CCP warning us not to come here. They repeated their false claim that Tibet is part of China since the 13th century but we did not let the CCP intimidate us and we are here today," he said at the

Sensex, Nifty scale fresh record high levels on robust FII inflows

Benchmark equity indices Sensex and Nifty soared to new lifetime highs on Thursday, fuelled by intense buying in market heavyweights Reliance, IČICI Bank and HDFC Bank amid a recent surge in foreign capital inflows.

Besides, stable global crude prices extended support to capital markets amid investors looking for fresh triggers, traders said. Rallying for the sixth straight session, the 30-share BSE Sensex climbed 141.34 points or 0.18 per cent to settle at a new closing peak of 77,478.93. During the day, it surged 305.5 points or 0.39 per cent to 77,643.09. As many as 2,282 stocks advanced while 1,571 declined and 128 remained unchanged on the BSE.

The BSE benchmark has jumped 1,022.34 points or 1.33 per cent in the last six days. The NSE Nifty rose 51 points or 0.22 per cent to settle at its fresh closing high of 23,567. Intra-day, it soared 108 points or 0.45 per cent to 23,624.

"FIIs have been net buyers in Indian equities for the last three days and have bought Rs 12,600 crore, which includes a few large block deals. On the domestic front, the market is consolidating with a positive bias amid strong FII flows and

healthy macros. Also, an expectation of a growth-focused budget is aiding sentiments and is likely to lead to sector-specific action," said Siddhartha Khemka, Head - Retail Research, Motilal Oswal Financial

India's tech startup funding at USD 4.1 bn in H1

FIU slaps ₹18.82 cr penalty on crypto exchange Binance

The Financial Intelligence Unit has slapped a penalty of Rs 18.82 crore on one of the world's largest crypto exchange Binance for alleged contravention of the country's anti-money laundering law.

The federal agency issued an order Thursday charging the exchange with "dereliction of duty" as a reporting entity, with its operations that of a Virtual Digital Asset Service Provider, under Prevention of Money Laundering Act (PMLA). The summary order accessed

by PTI said Binance was first issued a notice in December last year since it operated in India and provided services to Indian clients.

Binance had not registered as a reporting entity with FIU, as required under the PMLA. It did it in May this year after the Union government banned its URLs in India and was issued a notice, along with eight other crypto firms, by the the FIU, a senior officer said.

The exchange has not commented on the penalty

"After considering the written and oral submissions of Binance, the Director, FIU-IND, based on the material available on record, found that the charges against Binance substantiated.

'Consequently, the Director FIU-IND vide order dated 19th June, 2024 in exercise of powers under Section 13 PMLA, imposed a total penalty of Rs. 18,82,00,000 on Binance...," the order said.

The exchange has been charged under Section 12 (1) of the PMLA which mandates a reporting entity to maintain a record of all transactions and timely furnish it to the FIU. The order said the FIU has

issued "specific directions" to Binance for ensuring diligent compliance obligations outlined in Chapter IV of the PMLA, in conjunction with the PMLA Maintenance of Record Rules (PMLA Rules) of 2005 for prevention of money laundering activities and combating the financing of

North Indian tea output may be hit by 60 million kgs till June

The North Indian tea industry is facing a production shortfall of 60 million kgs till June of the current crop year over the corresponding period last year due to adverse weather conditions, according to an estimate by a tea body

The loss of the first and second flush crops, which produce the highest quality teas of the year, will undoubtedly impact the producers' revenue and may push tea prices higher, officials say.

The states of Assam and West Bengal, which comprise the North Indian tea industry, are experiencing a precarious situation. Excessive heat coupled with a rain deficit in May, followed by excess rainfall and a lack of sunshine, has severely

impacted production. Tea Association of India (TAI) president Sandeep Singhania estimated that the combined crop loss is estimated to be 60 million kgs



Huge fan of Bumrah, don't want thing be changed in his unorthodox action: Ambrose

BARBADOS),

urtly Ambrose is a huge fan of Jasprit Bumrah and the Indian spearhead's struggles with stress fractures in the past, the Caribbean legend would not want to change anything in his unorthodox action as he feels every fast bowler takes the field with a risk of getting injured.

Bumrah, arguably the best all-format pacer in the game right now, has had his fair share of back problems and underwent a surgery in March last year. After a long rehab, Bumrah made a comeback ahead of the ODI World Cup in India in November and he has not looked back since

The 30-year-old can get wickets in a T20 at any stage of the game and in the longest format, he has the ability to strike with both the new and the old ball, more so when it is reversing

In a telephonic interview with PTI, Ambrose said Bumrah should not change a thing unless he sustains a serious injury.

"What I can tell you something about Jasprit Bumrah, I'm a big fan. Right from ever since I saw him the first time. He's so unconventional but highly



effective. And that's what I like about him. When you look at traditional fast bowlers, you wouldn't look at Bumrah, he's so unorthodox

"He has done a great job for India and still doing a great job in all formats. I met him a couple of years ago when India played in Antigua. He's someone I've always enjoyed watching because he's so different," said Ambrose who is involved with promoting the ongoing T20 World Cup here.

Bumrah's open-chested action does put pressure on his back but Ambrose believes every fast bowler has to deal with risks like that. "From my little experience, there are no two bowlers who are exactly alike. Bowlers may have similarities but they are never exactly alike and we all have our different styles everyone is different.

"In terms of his longevity, in terms of injuries, (for) every fast bowler, there is always risk of being

injured. But at the same time you can't go out there thinking that way. "You've got to go out there and do the job to the best of your ability and whatever happens, happens. The only way he should change is if he, may be, sustains a serious injury or has to re-model his action or something," said the 60-year-old who played 98 Tests for the West Indies taking 405

Ambrose, who troubled the world's best batters with the extra

bounce he created because of his 6"7' frame, also doesn't believe that the stress on Bumrah's back is only because of his action.

"I've never been through it (stress fracture). So it would be unfair for me to even try to say what to do. I will leave that for the medical expert. I don't think Bumrah's stress comes totally from his action.

'You can look at Ian Bishop, he had a perfect action and he also had stress fracture," reasoned the cricketer from Antigua.

It's a mismatch on paper title-favourites title-favourites Australia would be wary of slipping on the proverbial banana peel that Bangladesh can be when the two teams clash in their Super Eight, Group 1, match of the T20 World Cup here on Friday.

Australia, champions of the 2021 edition of the tournament, will be mindful of the dangers of taking Bangladesh lightly.

The supremely confident team from Down Under was humbled 1-4 by the South Asians in a T20 İnternational series in 2021, and any laxity can be severely punished in conditions here that have close resemblance to the

sub-continent. Australian From perspective, it might bring increased onus on leg-spinner Adam Zampa and part-timers such as Glenn Maxwell and Travis Head. Keeping in mind the inherent slowness of the pitch here, the Aussies might also mull retaining left-arm spinner Ashton Agar, who is a handy bat too, from their last group match against Scotland.

But irrespective of the conditions or nature of the Australia's real strength lies in its pacers --Pat Cummins, Mitchell Starc and Josh Hazlewood -- who

are persistently nagging. Cummins and Hazlewood are set to return for this match after sitting out of the Scotland game.

The Aussies have also received a boost as captain Mitchell Marsh has declared himself fit to bowl in the Super Eight stage.



"I'll be available to bowl. With the line-up that we've got, I don't really necessarily see a need for me to bowl.
"But I think it's really

important in this format to have options and we're blessed with plenty of those,' said Marsh in the pre-match press conference.
