

NEET ROW

Supreme Court refuses to defer counselling; 1,563 students to take exam again

PNS NEW DELHI

The Supreme Court Friday refused to defer the NEET-UG counselling process, scheduled to kick off on July 6, saying it is not an "open and shut" exercise, even as the political pot kept boiling over the controversy-ridden exam with the opposition attacking the Centre over alleged paper leak and other irregularities.

The National Testing Agency (NTA), under fire over the lapses in the conduct of NEET and UGC-NET, is gearing up to conduct on Sunday a retest for the medical entrance exam for 1,563 candidates who were earlier awarded grace marks to make up for the loss of time at six centres.







Responding to KTR's tweet questioning the government's stance, Revanth vehemently opposed any privatisation attempts arguing they would be 'detrimental' to the state. KTR's tweet that sparked the

debate said: "Revanth Garu, as the TPCC president and MP, in 2021, you had asked the Centre to stop the auction of coal blocks and transfer the four coal blocks to SCCL. Now, as Chief Minister, to the absolute dismay of the people of Telangana, you have sent your Deputy CM to participate in the auctions that you and the Congress had opposed vociferously earlier. Can you explain the reasons for this change of heart and compulsions (if any) that led to this? Do you not agree that the auctioning of Telangana's coal blocks will pave the way for the eventual privatisation of SCCL under



the guise of disinvestment? Why is your government not questioning the Centre on the direct allocations of mines (exempting from auctioning) to PSUs in Gujarat and Orissa by the NDA admin? Why is a Télangana PSU not being given

the same treatment?"

The high court said it was reserving the order for 2-3 days as it wanted to go through the entire records. It also issued notice to Kejriwal seeking his response on ED's plea challenging the trial court's June 20 order by which he was granted bail.

It listed the plea for hearing on July 10.The ED's lawyer mentioned for an urgent listing its petition challenging the trial court's bail order which was passed late Thursday evening.

Additional Solicitor General (ASG) S V Raju, representing the ED, contended that the trial court's order was "perverse", "onesided" and "wrong-sided" and that the findings were based on irrelevant facts.

The relevant facts, he claimed, were not considered by the special judge.

"Material facts were not considered by the trial court. There cannot be a better case for cancellation of bail than this one. There cannot be greater perversity than this," he argued.

In the next five years, eight underground mines and three open-cast mines would be closed. In another five years, that is, by 2032, another five underground coal mines and another six open-cast mines would also be shut. By 2037-38, another five mines would

be closed, Bhatti said. At this rate, the SCCL with 39 mines and 40,000 workers would come down to eight mines and 800 employees in the next 15 years. A situation would come when SCCL would have to shut down. As Telangana leaders we cannot imagine that, Bhatti said.

He urged Union Minister Kishan Reddy to use his good offices and talk to the Prime Minister.

"If required along with Chief Minister Revanth Reddy we can send an all-party delegation to appeal to the Prime Minister," he said. "We hope that as a son of Telangana, Kishan would do justice to SCCL," he added.

The 4,000 MW Yadadri Thermal Power plant to be inaugurated soon, another

4000 MW NTPC plant and the 800 MW power plant being constructed by SCCL would require about 24 million tonnes of coal. New coal blocks would have to be allotted to SCCL to produce this much coal, he said.

Bhatti said that after the formation of the Congress admin in the state, he had met former Coal Minister Prahlad Joshi personally and had requested him to allot new coal blocks and give permission to use Thaticherla Block-2.

The coal blocks in Sathupalli Block-3 and Koyagudem Block-3 allotted to private companies through auction did not start work. Thus as per law those allotments should be cancelled and they must be allotted to SCCL. Then SCCL would immediately start excavation there, Bhatti said. The SCCL with its 135-year history is the first public sector coal mining company in the country but because of the coal block auction policy, it is facing a critical situation now. At such a time Kishan assuming charge as the Union Coal Minister gave hope for SCCL.

BRS MLA linked to Rs 300 cr money laundering scandal: ED

Directorate Enforcement (ED), Hyderabad Zonal Office, executed search operations at 10 locations on Thursday in and around Hyderabad as part of an ongoing investigation into a money laundering case involving M/s Santhosh Sand and Granite Supply, Patancheru. The raids were conducted under the pro-visions of the Prevention of Money Laundering Act (PMLA), 2002, targeting premises associated with the firm's proprietor, Gudem Madhusudan Reddy, BRS MLA Gudem Mahipal Reddy, and others.

ED's investigation was prompted by FIRs filed by the Telangana Police against M/s Santhosh Sand & Granite Supply, alleging unauthorised excavation and transportation of significant quantities of building stone and road metal. The firm stands accused of illegally excavating 11,98,743 cubic meters within its permitted quarry area and an additional 10,11,672 cubic meters on encroached government land measuring 4.37 hectares. This activity allegedly resulted in illicit proceeds amount ing to approximately Rs. 300 crore, while also evading royalty payments totaling Rs. 39.08 crore owed to the gov-

ernment. According to ED officials, proceeds from the illegal sales were deliberately concealed



from banking transactions and accounting records, with suspicions that transactions were conducted primarily in cash. The investigation further uncovered evidence suggesting that the laundered proceeds were reinvested in real estate and other undisclosed activi-



NEET: Malice extends beyond a flawed exam

lans do go awry. Who could say this better than Moḋi Sarkar 3.0? Prime Minister Narendra Modi had planned a blitzkrieg of the first 100 days of good governance. It doesn't seem to be happening as of now. First the number of BJP members elected to Lok Sabha did not sufficiently pile up, forcing a toned-down deportment of the Government.

Worse has been the marks manipulation controversy generated around the results declared by National Testing Agency (NTA) of the National Eligibility-cum-Entrance Test (NEET) for admission to the undergraduate courses in the medical colleges across the country. The Supreme Court on June 18 told the Union Government and the NTA to ensure that even '0.001 per cent negligence' in conducting the NEET-UG 2024 exams be looked into with all seriousness considering the immense labour that the candidates have put in for preparing the nationwide examination. Thankfully, we have a mature leader like Dharmendra Pradhan as Union Education Minister, who is expected to steer through the crisis and not a Smriti Irani or a Ramesh Pokhriyal Nishank camping at the Shastri Bhawan, the seat of the Ministry of Education. Pradhan has so far shown the patience and perseverance in handling this gargantuanlike crisis.

The mess around NEET is much deeper than just the alleged malpractice in the conduct of the examination and the manipulation of marks. It's a question of the very high financial and emotional stakes involved, given the limited number of the seats available in the medical colleges.

Over 15 lakh students appear for the NEET annually to fight over about 83,000 seats available. Less than half of these seats are available in the Government-run colleges. More than half of the seats in these colleges are allotted under various quotas. Thus, many deserving candidates are unable to secure admission to Government colleges.

The fees in the private medical colleges in India are unbelievably

Thus the medical college market in countries like China, Ukraine, Russia Kyrgyzstan. Here the cost of education at the best is less than half of what the private medical colleges charge. No wonder if there is COVID happening in China, war happening in central Asia or hooliganism in Kyrgyzstan, miserable State of the Indian students makes news.

The problems of these students don't end here. Even on the successful completion of the course, an uncertain future awaits them. The medical degrees obtained from foreign universities must be recognised by the National Medical Commission of India (NMCI). Even if the college is recognised, the medical graduates need to clear the Foreign Medical Graduates (FMGE) con-Examination ducted by NMCI to practice in India. The pass rate for FMGE is relatively low.

This shortage of seats explains the repeated noise of corruption around the medical entrance tests for several years

WOMEN AND UNPAID WORK Madam — Apropos the news story "The Unseen Burden of Women's Unpaid Labour," published on June 21, this is my response. The early 60s saw Canadian writer Alice Munro dismissed as a mere 'housewife who finds time to write short stories." Munro's eventual Nobel Prize in 2013 underscored the absurdity of this condescension. Economist Claudia Goldin's research reveals that women's careers are often constrained by societal expectations that idealise their roles as unpaid caregivers. This has tangible impacts: women global-

ly spend 76.2 per cent of their time on unpaid care work, three times more than men. In regions like the Pacific and Asia,

men contribute the least. The burden of unpaid care work keeps 606 million working-age women out of the labour market, compared to just 41 million men. This disparity is reflected in economic metrics; for example, women's unpaid work could be worth up to 40 per cent of GDP in some countries. Additionally, the "motherhood penalty" persists, reducing women's career prospects and earnings. Conversely, men often receive a wage bonus upon becoming fathers. To bridge this gap, significant investments in childcare and care industries are crucial. Research shows that such investments could create millions of jobs and significantly boost women's employment rates. India faces a severe groundwater crisis



The groundwater clock is ticking towards day zero. India needs a combination of strategy and investment to safeguard and revitalise the same



ccording to the India Water Portal, India uses 25 per cent of all groundwater extracted globally, ahead of the USA and China. Nearly 70 per cent of the water supply in Indian agri-culture today is groundwater. For a resource that is under such heavy use, India still lacks a contingency plan when it comes to dealing with groundwater depletion and over-exploitation. Predictably, the writing on the wall is becoming increasingly clear. On June 19th, 2024 the Central Ground Water Board (CGWB) dropped the shocking news that Delhi has already extracted 99 per cent of its available groundwater. The latest CGWB report revealed decline in both annual recharge and available groundwater for extraction in the city. According to the CGWB's findings, Delhi's net annual groundwater recharge in 2023 was measured at 0.38 billion cubic meters (bcm), with only 0.34 bcm available for extraction. Shockingly, nearly all accessible groundwater has already been extracted, totalling 99.1 per cent. The concerning aspect here is the increased rate of extraction despite reduced groundwater recharge. These trying conditions come at a time when Delhi is already reeling under the

worst heatwave in the last 120 years which has claimed 192 lives so far. Śadly the issue of water distressed cities is becoming a worrying trend across India. Bangalore hit rock bottom earlier this year with over 500 million litres of water deficit daily with over 7000 borewells running dry. Coupled with abnormally harsh summers the water scarcity conditions can not only take a toll on human lives but also bring the urban economy to a grinding halt.

Experts have opined that the city harvests only 10 per cent of the rainwater while the rest 90 per cent drains away wasted. Conditions such as these point towards the unfortunate reality of hyped concepts that receive very little implementation. The Government must try and understand the latent potential of RWH and ensure that not only residential but commercial properties across India implement RWH and the same must be enforceable by law.

However conventional remedial measures may still not be able to rein in the runaway groundwater scarcity problem. Since the scale of the problem has risen, the Government must explore invest-

gies to bolster the efforts to revive and boost the groundwater table in India. Efficient farming technologies that rely less on water for instance can make a huge differ-

Investments in precision agritechnology for the usage of groundwater for irrigation are an ideal solution for providing optimal water usage. This saves water compared to traditional flooding methods which increases output while conserving resources and

Similarly, App-driven water meters that automatically regulate extraction and smart groundwater pressure sensors that maintain critical and minimum water levels can all help alleviate the burdens weighing on groundwater. With water scarcity spreading region-wise across India and with a rapidly increasing water use the structural imbalance between water supply and demand continues to widen. Therefore it is time that the Governments in association corporate under corporate social responsibility schemes (CSR) must increase capital expenditure on smart technologies that can actively provide solutions to water scarcity and water quality issues besides improving sustainability of water resources.

The groundwater clock is ticking towards day zero. India needs a combination of strategy and investment to safeguard and revitalise the same.

Get InvITs under purview of bankruptcy law: SBI MD

Infrastructure investment trusts (InvITs) are enjoying immunity from insolvency proceedings and should be brought under the Insolvency and Bankruptcy Code, a top official from SBI said on Friday.

Ashwini Kumar Tewari, the managing director of the bank, said lenders need the assurance of being able to recover their dues from InvITs in case of a default and added that they are in touch with the Reserve Bank and the government on the same.

"We need to bring these trusts, which are bankruptcy remote, within the purview of the IBC because that will go a long way in giving us the assurance that this is like any other asset, Tewari said, addressing an NBFC event organized by industry lobby Assocham here.

He elaborated that at present, the primary responsibility of an InvIT or a special purpose vehicle under it is towards the trust holders and there are "gaps"

which need to be filled.

"This space needs clarification; this space needs assurance to the lenders that in case there is a (legal) testing of default etc, it will

be the same as any other lending that they do within this space (infrastructure)," he said.

Tewari mentioned that banks also lack the power to change

a key feature under the IBC provisions and has already been invoked in the past.

He also made it clear that SBI is "very bullish" on the InvITs space because it takes away the long-term risk from the bank after a project is completed, and also because it provides steady flow of cash to pension funds and other investors.

The IBC was promulgated in December 2019 while InvIT saw the maiden listing in 2017.

Meanwhile, Tewari also questioned the need for a non-banking financial company (NBFC) to have a long list of lenders, and pitched for consortium arrangements in the same

"We feel that if there are so many banks involved, each with a smaller share and yet the overall credit size is large, the only conclusion which can be drawn is the follow-up, and the control mechanism on the portfolio then is so much lesser. And that is something we are not very comfortable with," he said.

The seven-member GoM has been tasked with suggesting required rate rationalisation and correction of inverted duty structure with an objective of simplifying the rate structure, reviewing the GST

This is the second time that the GST rate rationalisation panel was reconstituted.

The GoM was originally set up in September 2021, under then Karnataka Chief Minister Basavaraj Bommai. Under his chairmanship, the panel had submitted an interim report to the GST Council in June 2022, proposing changes in tax rates for some goods and services to rationalise the levy.

Following the change in government in Karnataka after the assembly elections in May last year, Byre Gowda became the revenue minister. The rate rationalisation panel was then year, making UP Finance Minister Khanna as the con-

At the interbank foreign exchange, the local unit opened at 83.60 and touched the intra-day high of 83.49 against the greenback. The currency hit the session's lowest level of 83.63 but finally settled at 83.55 against the dollar, registering a gain of 6 paise from its previous close.

On Thursday, the rupee had plunged 17 paise to hit its over two-month low level of 83.61 against the dollar. The domestic currency recorded its previous lowest closing level of 83.61 on April 16 this year.

Anuj Choudhary, Research nalyst at Sharekl Paribas, said the rupee appreciated on favourable macroeconomic data and reports of intervention by the Reserve Bank of India (RBI). "However, weak domestic markets and a strong US dollar capped sharp gains.

...FII inflows and any further intervention by RBÍ may support the rupee at lower levels. Traders may take cues from PMI and existing home sales data from the US. USD-INR spot price is expected to trade in a range of Rs 83.20 to Rs 84," Choudhary added.

Born in Rajasthan and brought up in Jaipur, she's an old soul who loves architecture, forts, and palaces. The Jaipur native shares,

Talking about having apprehensions for the city, she expressed that people may struggle with language and food depending on an individual, but she did not face much resistance In these regards. The differences between her hometown and this city are quite huge, but she also enlightens. "They are entirely different! From food, culture, language, size, and festivals, almost everything is different. I experienced the 'Ganesh Nimajjanam' for the first time in Hyderabad."

She has many fond memories in HITEC City, and sharing one of them with us, she says, "My fondest memories of this place have to be relishing Hyderabadi tea at 4 in the morning, rescuing my first puppy, translocation of 80 trees by our organisation, and much

Living without her family around, she has given her entire life to science. However, she shares, "My career took shape in Hyderabad. SHEZRAY HUSAIN FELT STUCK

ctress Shezray Husain of *Gunaah* fame rarely saw actresses that resembled her on television in Western media while growing up in the United States. She found it difficult to properly empathise with characters in South Asian cinema, even though she was raised abroad.

The Chicago native recalls, "I felt stuck in a gray area, neither fully westernised nor fully desi. It made

me yearn for a depiction that more closely matched my experiences and identity. I didn't completely see the effects of this lack of representation until much later in life—not only on myself but on countless others who were unable to identify with the media they were exposed to."

Even though she struggled with this lack of representation, the aspiring actress started taking acting classes in her academic years. She refined her skills by going to American acting and improv classes. The actress claims that her background as a theatrical actress has aided her in landing movie parts. "I feel that emphasising preparation and rehearsal is a very helpful theatre method. Weeks of practice are dedicated to truly exploring our characters and their relationships, grasping the subtleties of the script and honing our performances in the theatre. I've applied this same commitment to my on-screen work, frequently devoting hours to character research, script analysis, and scene practice until they seem natural."

She was cast in the Disney+ Hotstar series *Gunaah*, and the former music video sensation had to go through multiple rounds of tryouts when she had to fully inhabit the nuanced persona of Divya, the main character's NRI sister. The rising star's difficult acting journey had only just started, even if she had finally landed the part. Shezray couldn't speak Hindi fluently because she was raised in the United States, which was essential for the part. "Being able to think in Hindi was more difficult than just being able to speak it. I have been practicing my Hindi and Urdu language abilities over the years and I feel comfortable enough to play a real Indian character on TV. Though I think it will take a lifetime to become fluent in another language, I think I am getting quite close."

The Bollywood rookie's tenacity did not end there. She was channelling her own personality into Divya during the filming. She was able to structure herself in the role and relate to the character as a result. She was able to relate to Divya's opti-

jokes and anecdotes to each other.
Shezray claims that despite her recent success, she still experiences setbacks. "My experience in the entertainment industry has been a wild ride that has profoundly shaped who I am. Rejection is a common companion in this industry due to its intense competition. But with each setback, I've learned to pick myself up and keep moving forward, stronger and more determined than before."

Fans may be a great source of encouragement, particularly during trying times. "After a long day on the *Gunaah* set, I had an encounter that truly stuck with me. I was worn out from shooting for 12-13 hours, but as I made my way back to my vanity trailer, I noticed some admirers were obligingly waiting for a picture. Even though the hours were lengthy, their enthusiasm and encouragement made me feel better. Even though it was a tiny gesture. it meant the world to me."

"Being a South Asian-American actress navigating two distinct industries can be quite a balancing act, but it's also incredibly fulfilling," the Gunaah star says. "It's like having the best of both worlds because I have the privilege of connecting with audiences from two different cultural backgrounds, drawing from my experiences growing up in a household that cherished both Western and South Asian traditions." She hopes to honour her roots in both South Asia and the United States as her career in film continues.

Shezray's ultimate goal is to shatter barriers in the two film sectors. "I want to contribute to breaking through preconceptions and developing the stories that are portrayed in our dynamic film industry. I think we can promote more tolerance and empathy in our sector by accepting our diversity and honouring our common humanity."



dhe ever-present tension of their over a decadeof their over a decade-long big-stage rivalry would make for an engrossing sub-plot when an undefeated India takes on a faltering Bangladesh, both teams desperately hoping for their batting stars to strike form in the Super Eights clash of the T20 World Cup here on Saturday.

The overall head-to-head record is overwhelmingly in India's favour but Bangladesh have been known to be plucky and Rohit Sharma and his men would be wary of that.

The two South Asian neighbours have also been locked in some off-field drama in the past with Bangladesh often expressing its misgivings with India's financial might in the sport.

At the ongoing World Cup though, there is no doubt that India are as mighty a cricketing power to be a serious title

contender. The Men in Blue produced a professional performance against Afghanistan in their against Afghanistan in their opening Super Eights match.
With only a travel day separating their remaining two games, they would be hoping that the players, who have not performed as per expectations so far, deliver the goods.

Top of that list would be the opening pair of Virat Kohli and

Rohit Sharma, both of whom have got starts but have not been able to turn them into defining knocks. They have made a conscious effort to force the pace but have ended with minimal returns.

Another under-pressure team member is left-hander Shivam Dube, who was picked in the World Cup squad to hammer sixes in the middle and death overs.

However, the IPL form that helped him seal a World Cup berth has deserted him and he is yet to come to the party. The southpaw did make an

unbeaten 31 against the USA in a group league game but it was Suryakumar Yadav's effort that made the difference ultimately. Another failure might force the team management to consider Sanju Samson in the middle order.

The biggest positive in the batting department in the Afghanistan game was Hardik Pandya's cameo. The allrounder is known for his brutal hitting and that was on display on Thursday.

On the bowling front, India are spinner Kuldeep Yadav.

The wickets in the Caribbean have provided enough help for the spinners, prompting India to play three at the Kensington



The combination is likely to continue here with Kuldeep retaining his place at the expense of Mohammed Siraj. "Playing three left-arm spinners, I feel there is an advantage. There are three leftarm spinners out of which we

have two finger spinners and

one wrist spinner," said Axar Patel after the Afghanistan game.

The combination of the three of us is very good. We have a good team. We communicate well. Like whoever comes to bowl first, we communicate what is working and what is

not. I think that is very important when you bowl as a unit," he added.

India's sole aim in the Caribbean is to win the trophy and a solid performance against Bangladesh will be another step forward in that context. A tougher battle awaits against Australia on June 24.

Bangladesh, who have struggled with their batting throughout the tournament, find themselves in a must win situation after the loss to Australia.

The lack of power-hitters is

hurting them and there is no quick fix to that problem. The under-performance of opener Litton Das and Tanzid Khan compounded also has Bangladesh's woes.

"It's very important for the toporder to get runs like we did hopefully the bowlers will continue their form. Looking for a good show against India in our next match," Bangladesh captain Najmul Shanto said after the loss to Australia here

on Friday. Both Shanto (41) and Towhid Hridoy (40) did well but the rest of the line-up was not quite up to it.

They will need to find a way to tackle Bumrah, who has been sensational thus far, taking eight wickets at an unparalleled economy rate of 3.46 runs per

The pacers, led by Mustafizur Rahman, have done alright but leg-spinner Rishad Hossain needs more support in the spin department.

title at home alive.


