

# LS SESSION TO SEE FIREWORKS CBI gets cracking in NEET case

he first Session of the 18th Lok Sabha starting Monday is all set to begin on a stormy note given the reduced strength of the ruling BJP in the Lower House and an emboldened Congress with double the number of MPs it had in the previous two Houses. Above all, the Parliament Session comes in the backdrop of a series of exams paper leaks providing enough ammo to an equally strengthened combined Opposition determined to corner Narendra Modi 3.0 Government.

The Opposition is also set to take up the issue of railway safety with a major accident in West Bengal with casualties a week ago. The Congress and other Opposition members have been demanding the resignation of Education Minister Dharmendra Pradhan and Rail Minister Ashwani Vaishnaw.

As scheduled, the Lok Sabha will see oath-taking by the newly-elected members followed by election of the Lok Sabha Speaker on June 26 and President Droupadi Murmu's address to joint sitting of both the Houses on June 27.

The row over appointment of BJP leader and seven-term member Bhartruhari Mahtab as the Pro-tem Speaker is likely to cast shadow over the session. The move has drawn flak from the opposition, which alleged that the claim of Congress member K Suresh to the post was overlooked by the Government.

Parliamentary Affairs Minister Kiren Rijiju asserted that Mahtab has had seven uninterrupted terms as Lok Sabha member, making him eligible for the post, while Suresh lost



elections in 1998 and 2004 which makes his current term as the fourth straight one in the lower house.

Earlier, he was elected to the Lok Sabha in 1989, 1991, 1996 and 1999. On Monday, Murmu will administer the oath to Mahtab as the Pro-tem Speaker of the Lok Sabha at the Rashtrapati Bhawan. Mahtab will then reach Parliament House and call the Lok Sabha to order at 11 am.

The proceedings will begin with members observing a moment of silence on the occasion of the first sitting of the 18th Lok Sabha. This will be followed by Lok Sabha Secretary General Utpal Kumar Singh placing on the table of the House the list of the members elected to the Lower House.

Minister Narendra Modi, the leader of the Lok Sabha, to take oath as member of the House.

The Pro-tem Speaker will then administer oath to the panel of chairpersons appointed by the President to assist him in carrying out the proceedings of the House till the election of the Speaker on June 26.
The President has appointed

Kodikunnil Suresh (Congress), T R Baalu (DMK), Radha Mohan Singh and Faggan Singh Kulaste (both BJP) and Sudip Bandyopadhyay (TMC) to assist Mahtab in administering the oath/affirmation to the newly elected members of the Lok Sabha.

After the panel of chairpersons, the Pro-tem Speaker will administer the oath/affirmation as Lok Sabha Mahtab will then call upon Prime members to the Council of Ministers.

The members from States, in alphabetical order, will take oath or make affirmation over the next two

The election to the post of Lok Sabha Speaker will take place on Wednesday and the Prime Minister will introduce his Council of Ministers to the House soon after.

The President is scheduled to address the joint sitting of both Houses of Parliament on June 27. The debate on the Motion of Thanks to the President's Address will begin on June 28. The Prime Minister is expected to respond to the debate on July 2 or 3.

Both the Houses are expected to go into a brief recess and re-assemble on July 22 for the presentation of the

teams that are en route to Godhra and Patna, where cases of question paper leaks have been registered by police The CBI had already registered three cases to probe alleged irregularities in NEET exams conducted in 2018, 2021 and 2022 by NTA and this is the fourth FIR, registered on June 23, to probe allegations of irregularities in 2024 NEET exam against unidentified persons on a reference from the Union Education Ministry. Police in Bihar's Nawada arrested four persons in connection with alleged attack on CBI team probing UGC-NET leak case,

said officials. Facing flak over alleged discrepancies in competitive exams, the Centre on Saturday shunted out National Testing Agency (NTA) Director General Subodh Singh and handed over the probe into irregularities in medical entrance exam NEET-UG to the CBI to conduct a

#### Keiriwal knocks SC door over stay on bail

Pelhi Chief Minister Arvind Kejriwal on Sunday moved the Supreme Court seeking urgent hearing against Delhi High Court stay on his bail order in the excise policy case. Earlier, the Chief Minister was granted bail in the alleged excise policy case in a Delhi court. But the High Court stayed the bail till it gives its order on a plea filed by the Enforcement birectorate (ED)

challenging his bail.
Kejriwal, who is currently lodged in Tihar Jail, in his petition said the High Court has stayed the bail order ignoring the established legal process and tradition. In this regard, the basic principles of justice and bail established in the country have also been violated.

"The manner adopted by the HC in staying the bail order is contrary to the said clear dicta of law laid down by this court and would violate the basic fundamental threshold on which the bail jurisprudence is premised in our country,"

the petition stated.

## Mayawati reinstates nephew as political heir, coordinator

A mid mounting pressure for reinstating Akash Anand and giving him some assign-Bahujan Samai Party chief Mayawati on Sunday once again announced her nephew her political successor and also appointed him as the national coordinator of the party.

The appointment of Akash Anand is seen as a major development after the worstever defeat of the BSP in the recent Lok Sabha elections in which the party once again failed to open its account, the same performance it witnessed in 2014 but with much higher percentage of

The BSP supremo and former Chief Minister of Uttar Pradesh, Mayawati, took the decision to reinstate Akash Anand during a meeting called to review the party's defeat in the 2024 Lok Sabha elections. All the district-level office-bearers, senior party leaders and workers of the state attended the crucial meeting called in Lucknow on Sunday. The meeting mainly focused on why the party could not win even a single seat in the general election in the country. Discussions were also held on how things could improve in the 2027 UP assembly elections. Party leaders and officials from across the country, including BSP coordinators and district presidents in Uttar Pradesh,

attended the meeting. Akash

Anand, who also attended the meeting with his father Anand Kumar and BSP general secretary Satish Chandra Mishra, touched the feet of his aunt Mayawati and sought her blessings before the meeting started. Mishra, who prepared a report on the reasons for the party's defeat, handed it over to Mayawati for further necessary action. Akash Anand was first made the national coordinator to set up Mayawati's organisation and campaign for the elections and after this, on December 10, 2023, the BSP supremo made her him successor.Akash started active politics and campaigned vigorously in the

political Anand Lok Sabha elections, but in the midst of the polls, on May 7, 2024, Mayawati removed him

not only from the post of party's national coordinator, but also as her successor. He was also described as politically immature. Earlier on Saturday, Akash Anand was made the party's star campaigner for the by-election to be held in Uttarakhand. Assembly by-elections are going to be held in Punjab and Uttarakhand. The BSP released a list of its 13 star campaigners for the bypolls in which the name of BSP chief Mayawati is at number one and the name of Akash Anand is at number two. Responding to the question from a media person, DGP said to dismantle the terrorist ecosystem in the Union Territory we are considering invoking the Enemies Agents Act. would serve as a deterrent discouraging locals not to support foreign terrorists.

According to the latest assessment reports around 35-40 foreign terrorists are active in the region south of Pir Panjal in the frontier districts of Rajouri and Poonch.

These terrorists are mostly camping inside safe hideouts in small groups of two to three terrorists and executing terror plots at the behest of their handlers sitting across Pakistan. Official sources revealed during the high-level security review meetings these measures were discussed in the backdrop of increase in terror strikes

across the Jammu region.
Following these directions, the security forces have further intensified anti-terrorist operations to neutralise these foreign terrorists. Additional troops have been mobilised on ground zero to beef up security ahead of the Amarnath yatra starting from June 29.

# Two CoBRA personnel martyred in IED blast triggered by Naxals

Two personnel of the Central Reserve Police Force's jungle warfare unit CoBRA were improvised explosive device (IED) in Chhattisgah's Sukma district on Sunday, police said. The Naxal blast took place around 3 pm near Timmapuram village between Silger and Tekalgudem camps of security forces, over 400 km from the State Capital Raipur, a senior police official said.

An advance party of the 201st unit of Commando Battalion for Resolute Action (CoBRA) launched patrolling from Silger camp under Jagargunda police station limits as a part of its Road Opening Party duty towards Tekalgudem,



he said. The security personnel were on motorcycles while their luggage and rations were being ferried in the ill-fated truck, he said.

"Naxalites triggered an IED blast targeting the truck that claimed the lives of constable Shailendra (29), a resident of Uttar Pradesh, and driver Vishnu R (35) hailing from Kerala. The truck did not have any other occupant," he said. After being alerted about the blast, more forces were rushed to the spot and the bodies were evacuated from the forest, while a search operation continues there, he said.

Expressing grief over the incident, Chhattisgarh Chief Minister Vishnu Deo Sai said in a message on X that the martyrdom of jawans will not go in vain. "Received the sad news of the demise of 2 CoBRA soldiers in an IED blast triggered by Naxalites in Sukma district. I pray to God to rest the departed soul in peace and to give strength to their families,"

#### Shah mulls steps to save people from flood fury

# **BJP** leader, suspended

senior traffic sub-inspector Awas place under suspension on Sunday after BJP state spokesman Rakesh Tripathi accused him of misbehaving with him and his family during a vehicle checking drive for hooters, black film, and flags in Krishnanagar. The suspension followed a written complaint from Tripathi to senior police officials.

The DCP (traffic) confirmed the suspension of Ashutosh Tripathi and stated that the matter was being investigated by an ACP rank officer. He noted that the action was taken after the allegations were found to be prima facie true.

In his complaint, Tripathi stated that he had returned from Srinagar with his family on Saturday evening. "Around 6:30 in the evening, near Amausi airport, my car was stopped by

TSI Ashutosh Tripathi for he alleged. checking," Tripathi said. He added that he had all the necessary documents for the vehicle and introduced himself as a BJP functionary.

"My car was surrounded by four policemen, one of whom started recording a video that included my family members. opposed this action," he alleged.

Tripathi further claimed that the TSI became angry and warned him against further objections. The TSI allegedly told Tripathi that being a BJP leader did not exempt him from cooperating with the videography process.

Tripathi's car was then moved to the side of the road. He stat-

ed that his wife was unwell and requested the TSI to let them go, but the latter did not listen. The TSI pulled my driver out of the car and asked me to get out as well while misbehaving,"

The policemen proceeded to thoroughly check the car, including the bonnet, trunk, and interior. Tripathi claimed that after seeing the pass on the vehicle, the TSI accused it of being fake. When Tripathi protested and mentioned that he would complain to senior officials, the TSI allegedly responded rudely, telling him to leave immediately.
Tripathi called the UP DGP to

report the TSI's behaviour and informed senior party leaders about the incident. He also submitted a written complaint to the DCP (traffic).
An official statement from the

# A sub-registrar office no stranger to controversies!

The sub-registrar office of Mohanlalganj is no stranger to controversies. It first courted a row a decade ago when fraudsters sold land belonging to former Madhya Pradesh Chief Minister Shyamacharan Shukla. Even now, police have no clue about the accused, who continue to remain at large. Since then, numerous cases of

land registration fraud have emerged, keeping the sub-registrar office at the center of controversy. The increasing incidents of fraud have posed a significant challenge to the

Mohanlalganj police.
Despite strenuous efforts, they have not been able to track down the fraudster who sold Shukla's land by impersonating him. Although the police possess photographs of the fraudster, they have yet to make any arrest.

Sources indicate that the case has been put on the back burner, with no recent updates on the investigation. The land mafia became active after land prices in the area surged due to the state government's development projects and the con-struction of national highways and overbridges.
A substantial number of land

dispute cases between farmers and builders or realtors are pending in court because the police have been unable to assist the complainants.

According to sources, a network of fraudsters and clerks in the registry department is active in the area. These fraudsters use a set of witnesses who vouch for the identity of an impersonator posing as the land seller. The buyer purchases the land at a low price,

On September 29, 2022, Gajraj, a resident of Patwakheda, filed an FIR against some accused for selling his land

fraudulently. On October 6, 2022, Bhagwandin, a resident of Raibhan Kheda, filed a complaint about the fraudulent sale of his land. On October 23, 2022,

after her mother's death,

Madhulata reported a case

rendering it disputed. Eventually, with police and middlemen's intervention, the original owner is forced to sell the land at a nominal price. This network also targets land owned by controversial realtors or those who are incarcerated. This new modus operandi is

On April 2, 2013, six years after his death, a fraudster posing as him executed a sale deed for over 21 bighas (6 biswas) of land. Following a complaint, the district administration and registration department investigated on the CM office's orders, revealing the fraud. On June 6, 2013, Shyamacharan's manager filed an FIR against unknown fraudsters at the Mohanlalganj police station. However, the investigation has

Recently, a group of fraudsters defrauded Amitabh Srivastava, previously involved in the Shine City real estate scandal while he was in Varanasi jail. The accused fraudulently registered his land to a resident of Chinhat at the Mohanlalganj sub-registrar office. The scheme involved using Srivastava's fake identity while he was imprisoned. The sale deed was purportedly signed during his detention in Varanasi jail. According to records at the registry office, alleged fraudster Srivastava signed the sale deed in favour of Pankaj Mishra on August 24, 2022. The deed falsely claimed Srivastava was identified by witnesses Vipin Yadav from Sarai Karora (Lucknow), and Gyan Prakash Awasthi from Gonda. The signing supposedly occurred in the presence of sub-registrar officials.

claimed the life of a tractor driver on Sunday. Earlier, social media was flooded with comments on a viral video showing two tractors tied together at the rear with an iron chain, pulling against each other to demonstrate the vehicles' strength and the drivers' skills. Towards the end of the video,

The tractors, tied with an iron chain, were pulling against each other when one of the tractors overturns, causing Neeraj to fall and get trapped as the front end of the vehicle lifted and rotated suddenly.

# Council school teachers to digitally record attendance

A s part of ongoing effort to make the council schools of Uttar Pradesh digitally active, the Yogi Adityanath government has issued instructions to digitise all 12 types of registers in the schools across the state, along with providing facility for digital marking of attendance for both teachers and students. Under this, both students and teachers will be required to mark their attendance using a face recognition system on tablets. This process will be implemented across the state starting July 15. It is noteworthy that the Yogi government has been emphasising the digitisation of all types of work in council schools for quite some time. As part of this effort, a digital module has been prepared on the Prerna Portal to digitise all 12 types of registers in these schools. Additionally, tablets and SIM cards have been provided to schools for digital attendance.

education officers to fill all registers of council schools digitally. Attendance, admissions, classroom-wise student attendance, mid-day meals, distribution of integrated free materials, stock, incomeexpenditure and cheque issues, meetings, inspections, correspondence, child census, and library and sports registers have been digitised. new module named Digital Registers has been developed on the Prerna Portal for simplified registration and technology-based digital usage.

The digital format of the registers has been prepared following the physical registers currently being used.

Accordingly, all entries will now be recorded on the digital and the format of the second of the digital and the second of the digital and the second of the s tal platform. The teacher attendance register is included among the 12 digital registers. Consequently, all working teachers and staff in the school will have to digitally record their attendance daily from arrival to departure. According to the directives, all teachers will mark their attendance from 7:45 am to 8:00

September 30. From October 1 to March 31, attendance will be marked from 8:45 am to 9:00 am upon arrival and from 3:15 pm to 3:30 pm upon departure. Attendance will not be valid after the stipulated time. The department has provided 2,09,863 tablets for the use of teachers in council primary/composite schools. # Yogi government sets target to plant 35 crore saplings

To expand UP's green cover

With collective support and effort, the Yogi Adityanath government plans to plant 350 million saplings this year to expand Uttar Pradesh's green areas. The goal is to increase the state's green cover from 9 per cent to 15 per cent by 2026-27 with public cooperation.

Additionally, specific targets have been set for all departments and divisions in the

state-wide campaign. The Yogi government has also directed proper preparations to ensure the availability of high quality saplings for all stakeholders. As in the previous year,

this year preparations have begun for a safe plantation and the achievement of the target. The goal is to plant 350 million saplings, with specific targets assigned to various departments: 140 million for Forest, Environment, and Climate Change, 125.9 million for Rural Development, 25 million for Agriculture, 15.5 million for Horticulture, 12.8 million for Panchayati Raj, 10.6 million for Revenue, 3.5 million for Urban Development, 1.8 million for Higher Education, 1.4 million for Silk, 1.3 million each for Public Works, Railways and Water Power, 1.2 million for Basic Education, 1.1 million for Health, 900,000 for Industry,

800,000 each for Industrial

Development and Secondary Education, 700,000 each for

Home and Animal Husbandry,

600,000 each for Energy and

Cooperation, 500,000 each for Development, Housing Defence and Technical Education, and 300,000 each for Labour and Transport.

Under the campaign, saplings will be planted in all 18 divisions. Targets for all have been fixed. Lucknow division has been given the target of planting the maximum number of saplings. Four crore saplings will be planted in the Lucknow division. 3.13 crore in Kanpur division, 2.76 crore in Chitrakoot division, 2.58 crore in Jhansi division, 2.27 crore in Mirzapur, 2.20 crore in Avodhva, 1.95 crore Devipatan, 1.89 crore in Prayagraj, 1.87 crore in Bareilly, 1.78 crore in Varanasi, 1.76

# Regular practice of yoga improves lives of filariasis patients in UP

PNS LUCKNOW

The Yogi Adityanath government is running various campaigns across Uttar Pradesh to achieve the ambitious goal of eradicating filariasis from the state by 2027. Remarkably, the government has made significant strides in combating filariasis through yoga while the lives of filariasis patients have significantly improved through regular yoga and exercise. Under the instructions of CM Yogi Adityanath and the guidance of the Health department, supporting organisations are working to reintegrate filariasis patients, who have long been isolated from society, back into the main-stream. As part of this initiative, an Institute of Applied Dermatology (IAD) centre has been established at the Regional Avurveda Research Institute in Indiranagar, Lucknow. Here, filariasis patients are taught

care methods, yoga and pranayama. Many members of the Filaria Network and Patient Support Group have improved their quality of life by learning proper care techniques. Explaining the relationship between yoga, exercise, and managing swelling in filariasisaffected limbs, Sandeep Kumar, a yoga consultant at the Institute of Applied Dermatology, stated that the treatment protocol includes subtle exercises, yoga postures (asanas), breathing exercises (pranayam), hand gestures (mudra), and relaxation poses (shavasana). Patients practice regular yoga and exercise for 14 days alongside getting treat-ment, which improves their of Applied Dermatology, high-lighted that filariasis affects the lymphatic system, causing fluid buildup and swelling in the limbs. In such cases, yoga and exercise help reduce swelling and

assist the lymphatic system in functioning properly. It is important to note that this infection, which spreads due to the bite of Culex mosquito, can take five to fifteen years to appear as filariasis. There is no effective cure, so prevention is crucial. Filariasis elimination focuses on two main points: the Mass Drug Administration (MDA/IDA) programme and Morbidity Management and Disability Prevention (MMDP). Under MMDP, the Health department, with the help of partner organisations, trains filariasis patients on how to properly wash and clean affected areas, reduce swelling, and prevent disease progression through yoga and

This training has helped reduce swelling in affected areas and has given patients confidence that with a little effort, they can avoid risks, perform daily tasks independently, and lead active lives.Ganga Prasad, a 55-year-old resident of Chhatha Meel on Sitapur Road, Lucknow, shared that both his legs have been affected by filariasis for the past 10-12 years. "Due to this, I had to close my shop and my children's education was disrupted. Despite extensive treatment, I found no relief. However, after joining the network, I learned to exercise at least twice a day, wash and clean the affected areas, and received treatment at the IAD centre. Now, I feel much lighter in my legs and entire body and more comfortable," he said.imilarly, Sudha Devi, a 34-year-old network member from Kanpur, mentioned that daily exercise has almost eliminated the swelling in her legs. Eleven months ago, during training by a community health officer, she started practising yoga and exercise and has continued daily since then. She also takes care of cleaning her legs. The biggest benefit is that she can now easily wear the anklet she couldn't wear last year and can manage household chores with ease.

#### Govt plans to increase power generation

The Uttar Pradesh government is gearing up to meet the rapidly rising demand of electricity in the state. By end of this fiscal 2024-25, investment of over Rs 10 lakh crore will materialis, thus making the state self-reliant in electricity generation. The government generation. The government plans to increase power gener-ation by approximately 5,255 MW through 10 new thermal power plants over the next three years. Additionally, by 2030, the expansion of three existing units in the state will add 5,120 MW of additional power generation capacity. The 10 new thermal power sta-

tions which are expected to be commissioned in the state include 660 MW Obra C Unit-2 by September this year, 660 MW Jawaharpur Unit-2 by July this year, 561 MW Ghatampur Unit-1 by July 2024, 660 MW Panki Unit by July 2024, 561 MW Ghatampur Unit-2 by December 2024, 561 MW Ghatampur Unit-3 by March 2025, 396 MW Khurja STPP Unit-1 and 396 MW Unit-2 by May 2025, 400 MW Singrauli Stage-3 Unit-1 by August 2027 and 400 MW Singrauli Stage-3 Unit-2 by August 2027.

With the commissioning of all these power stations, an additional 5255 MW of electricity will be produced in the state. The Yogi Adityanath government aims to boost the state's power generation capacity by 5120 MW by 2030.

## Keen contest expected in **UP** assembly bypolls

PNS LUCKNOW

Akeen contest is likely in the by-elections to 10 assembly seats which have fallen vacant following election of the sitting MLAs to Lok Sabha. The INDIA bloc, comprising Samajwadi Party and Congress in Uttar Pradesh, made significant gains at the cost of the ruling Bharatiya Janata Party by winning 43 Lok Sabha seats in the state. This has put the ruling BJP under tremendous pressure to retain and also regain the lost ground. The bypolls schedule is yet to be announced by the Election Commission of India. However, the SP and Congress have announced that they will contest the assembly bypolls together under the INDIA bloc. The ruling BJP-led National Democratic Alliance has also begun its preparations. The assembly seats fell vacant

after nine MLAs, including SP chief Akhilesh Yadav, were elected to the Lok Sabha while SP MLA from Sisamau Irfan Solanki of Kanpur was disqualified after he was sentenced to jail in a criminal case. UP Assembly's Special Secretary Brajbhushan Dubey said that information about the vacancy on 10 seats had been sent to the ECI. "As per the procedure, by-elections can be held on these seats within six months," he said. Five of these assembly seats were won by the SP in 2022 while one seat was bagged by the Rashtriya Lok Dal which was then in alliance with the SP. Three seats were won by the BJP and one seat by BJP ally

NISHAD Party. While the by-

election results will be numerically inconsequential for the BIP in the state assembly where it has a comfortable majority, they will impact the morale of both sides as any further losses to the BJP will help the opposition SP and Congress to further cement their gains. While the SP and the Congress have expressed confidence that they will continue their winning streak, the BJP is also preparing to do "something special" in the by-elections to increase its "credibility", according to leaders.

The BJP and its allies had won 73 Lok Sabha seats in UP in 2014 and 64 seats in 2019. In the 2022 UP assembly elections, the BJP won a total of 273 seats with its allies. Presently, in the 403-member Uttar Pradesh Legislative Assembly, the BJP has 249 MLAs, its ally Apna Dal (S) has 13, RD has eight, Suheldev Bhartiya Samaj Party has six and Nirbal Indian Shoshit Hamara Aam Dal (NISHAD) has five members.The main opposition SP has 103 members and Congress has two. #### KVC records remarkable increase in income



On this basis, the police identified the masked man, caught hold of him and when questioned strictly he confessed his crime. The footage made it clear that around 11.30 am on June 20, a young man wearing a white shirt and black pants with a towel wrapped around his face entered Kusumlata's

house. After staying inside for about five minutes, he came out

again. After a while he opened the door of the house, went inside again and stayed there for about 50 minutes. On Thursday Kusumlata Srivastava (70) was found dead in her house in Kasari Masari area under Dhoomanganj police station. She was bleeding from her head and was murdered by hitting with a rod. When the maid came to prepare dinner at 7 pm, she started screaming on finding the woman dead. The household items were also scattered. Kusumlata lived with her son Saurabh Srivastava in Anandapuram Colony. Her husband Satish Srivastava had died. Elder son Prashant lives outside the city. Saurabh who lives with her works in a company and comes home at night. When the maid came in the evening, she found Kusumlata's body in the room.

The trade pact provides for numerous benefits, including the elimination and reduction of tariffs, fostering an open trade environment, and enhanced market access for service providers across various sectors.

The UAE is also among the top four investors in India in terms of foreign direct investments in 2022-23. About 3.5 million strong and vibrant Indian community forms the largest expatriate group in the UAE.

While the skin bank housed in its Department of Plastic and Reconstructive Surgery was formally inaugurated on June 18 by DGMS (Army) Lt Gen Arindam Chatteriee, it had received its first skin donation on May 29, a senior official said. This donor, a woman, was the mother of army personnel and had died at the AHRR, another official

This skin bank is the first in the AFMS. In fact there are very few centres in the country which have a skin bank. Basically, it is for severe burns. Skin has to be replaced, otherwise infection can prove fatal, said Lt Gen Nilakantan. "It is very important to cover the exposed area and some-



times adequate skin may not be available with the same patient. So, we may have to take skin from somebody else and use it for an initial period until the base skin comes

As part of our organ donation system, we have an Armed Forces Organ Retrieval System, it's called AORTA (Army Organ Retrieval and Transplant Authority), and various organ donations are

organised, and this is the latest where skin donation is also part of our.... And, it's a licenced skin bank," he said. The AHRR Commandant said it is hoped that treatment of serious burn injuries will be augmented with this skin

This bank will serve as a centralised hub for the collection, processing, storage and dis-tribution of skin grafts, pro-viding a "critical resource" for military medical centres

across the country.

By establishing this facility, the armed forces are ensuring that the personnel and their families have access to the most advanced skin replacement therapies.

The visiting mediapersons were later also taken around some of its key departments, which have cutting-edge medical equipment such as hightech simulator for eye surgery.

# Children with chronic skin diseases face emotional trauma

Naveen Rawal, a 15-year-old struggling with acne, says in a choked voice, "Having acne made me feel like everyone is staring at my face. I try to cover it up with makeup, but kids at school still make fun of me. It made me not want to go out or be seen by anyone."

Similarly, 12-year-old Jagat, who battles eczema, shares, "My skin always looks red from itching. People think I have something contagious and avoid sitting next to me in the class. Sometimes, I feel really lonely because no one wants to be my friend."

Nine-year-old Rema, coping with alopecia, questions why she looks different from her peers, saying, "I don't have any lower quality of life, increased of

school call me names like 'baldy' and laugh at me. It makes me not want to take off my hat or go to school." These testimonies reflect the

emotional and social challenges besides bullying and stigmatisation children with chronic skin diseases such as acne, alopecia, eczema, psoriasis, and vitiligo often face affecting their self-esteem and social interactions. This has been pointed out by a study IAMÁ published in Dermatology. In general, girls reported more stigma than boys. The study said over 73 per cent of participants reported experiencing stigma related to their condition. This stigma was strongly linked to

hair on my head. Kids at anxiety, and depression among affected children.

The study covered 1671 children, 58 per cent of them girls, with mean age being about 14 years. About 56 per cent of the children selfreported high disease visibility, while 50.5% reported moderate disease severity.

The general burden of skin disease is sometimes difficult for people to appreciate, and even as dermatologists, we don't always know how to ask questions about quality of life or how our perception correlates with the lived experience of patients and their caregivers," said study author Michele Ramien, MD, Clinical Associate Professor of Pediatric Dermatology at the University Calgary, Pediatric



Dermatologist at Alberta Children's Hospital in Calgary, Alberta, Canada, and President of the Canadian Dermatology Association.

This study clearly shows, with validated instruments and tools, that there is a big burden and stigma associated with skin disease, and the experience of stigma is real," she said. "It's something we need to work on asking about more and addressing with patients." The study was conducted at 32 pediatric dermatology centers in Canada and the United States between 2018 and 2021, using the Patient-Reported Outcomes Measurement Instrumentation System Stigma-Skin to examine the links between disease visibili-

ty and severity and mental

health and quality of life. Nearly three quarters of children with skin disorders reported some amount of stigma. Stigma scores correlated strongly with reduced quality of life, depression, anxiety, and poor peer relationships.

În addition, about 29% of parents said they were aware of their child being bullied, primarily at school, which was strongly associated with stig-

In general, girls reported more stigma than boys, and children with hyperhidrosis and hidradenitis suppurativa were more likely to have higher depression and anxiety scores. "Some conditions didn't have as much perceived stigma as we had thought, such as atopic dermatitis, while others had more than we thought, such as excessive sweating," Ramien

'That speaks to the disconnect in physician perceptions and serves as a reminder to ask children and families about their experience - and to find the best way to do that without making it burdensome or stigmatizing."

When physicians ask about mental health challenges and quality of life, they may be better able to refer children and families to the care they need. For instance, specialized dermatology treatment may help decrease the severity and visibility of the skin condition, and mental health resources may help reduce stigma, false beliefs, and internalized perwww.dailypioneer.com

## Friend in need

Both India and Bangladesh stand to beneficially feed off each other with the new tranche of agreements

ew Delhi and Dhaka have signed a comprehensive bunch of collaborations that includes pledging to begin negotiations on a Comprehensive Economic Partnership Agreement (CEPA), deciding to launch a medical e-visa facility for Bangladeshis and agreeing to send a technical team to discuss the Teesta river watersharing, besides announcing the opening of an Assistant High Commission in Rangpur. Additional goodies in the bouquet include new train and bus services, export of 40 MW power to Bangladesh via the Indian grid, an inland container depot at Sirajganj and 350 training slots for Bangladeshi police officers. For India, four major imperatives have significantly driven the nation's increased strategic engagement with Bangladesh: Improving the country's economic standing, attending to the healthcare requirements of Bangladeshis, increasing India's presence in the region and attempting to counter China's increasing influence in Bangladesh. In office since 2008 and earlier heartily praised for



leading her country's economic and social development, Bangladesh's Prime Minister Sheikh Hasina is now facing difficulties in post-pandemic recovery. Her plan to use the bilateral relationship to address these issues includes the outreach to New Delhi in a major way. It makes sense that New Delhi is responding to her advances with a bit more warmth than usual this time, in part because of Beijing's looming shadow in the background. Prime Minister Narendra Modi and Bangladesh PM Sheikh Hasina deepened their partnership with a "futuristic vision" for transformative cooperation during the latter's two-day visit to India from June 21.

India holds a special place in Bangladesh's history, particularly owing to the 1971 Liberation War wherein India played a key role. However, relations between the nations became tense during military rule in the mid-1970s, marred by anti-India sentiment. But the shared history has helped forge a strong bond, with Modi's tenure since 2014 giving a new fillip to bilateral ties. Earlier, a significant shift occurred in 1996, when Hasina took over as the Prime Minister for the first time; since then, bilateral relations have steadily improved. Since 2019, the two leaders have met on 10 occasions, ushering in an era of remarkable transformation and strengthening bonds. Prime Minister Hasina, who began her fourth consecutive term in January 2024, joined six other world leaders at Modi's swearing-in ceremony on June 9, 2024. However, challenges persist, such as border management, illegal migration, the National Register of Citizens, Rohingya and river water sharing, necessitating ongoing dialogue. Bangladesh has established an island for the persecuted Rohingyas and seeks India's help in persuading Myanmar to repatriate the displaced minorities. The Modi-Hasina partnership has the potential to further cement India-Bangladesh relations, navigating these challenges and leveraging their shared vision for mutual prosperity.

Naidu's comeback will redefine Andhra's future

After being sidelined for over two decades, Naidu's resurgence signals a major shift in the State's politics and sets the stage for a renewed focus on development

he recent swearing-in of Nara Chandrababu Naidu as Andhra Pradesh's Minister was a significant event for Naidu personally, his Party and Indian politics. Prime Minister Narendra Modi and other top BJP leaders witnessed the 74-year-old politician taking the oath for the fourth time, marking a significant political comeback.

Despite being marginalised in State and national politics for over two decades, Naidu is grateful for his new role. He has once again proven that one should never underestimate a politician until they are out of the game.

The triumphant return of Naidu as the Chief Minister, along with the emergence of his Party, Telugu Desam, as the second largest roup in the current NDA Government, signifies a shift in power dynamics,

A year ago, Babu's predecessor, Jagan Mohan Reddy, was comfortably placed to win another term. Then, because the opposition was divided. Pawan Kalyan was not with the TDP and the BJP was still deciding whether to let the TDP join the NDA coalition again. Babu was accused of corruption and TDP workers felt disheartened.

Several factors contributed to Naidu's comeback. Apart from the anti-incumbency sentiment, the caste coalition of Pawan Kalyan's Janasena, the BJP and the TDP played a crucial role. Naidu has been a survivor. He started his political career as a junior minister in 1978 and has since held various positions in the Telugu Desam Party (TDP). He has served as the Chief Minister of Andhra Pradesh multiple times, overseeing significant development projects and facing controversies. Throughout it all, Naidu kept up his unwavering spirit. Naidu has announced that the 2024 election will be his last, a move intended to emotionally appeal to voters while grooming his son Lokesh as his successor. This strategic deci-

sion could significantly impact the Naidu dynasty's future in Andhra Pradesh politics. At first, Babu stayed in the

shadows of his father-in-law and Telugu Desam chief N.T. Rama Rao, but eventually became Indispensable. Gujral and later Vajpayee Governments, signifying that no party was untouchable.

other parts of the State. In his fourth term, Naidu should avail the opportunity to bring back the importance of Andhra Pradesh, once the country's rice bowl. Naidu's top priority is securing addi-tional funds for Andhra Pradesh, which is a crucial step towards the State's development. Naidu's vision for Andhra Pradesh's development includes reviving long pending irrigation projects like the Polavaram project to boost the State's agricultural sector. With his Party's support, Naidu is determined to maximise the State's resources and drive development.

We are not negotiating on the composition of the Narendra Modi cabinet when it comes to State interests," was his response to a question about the TDP securing only one cabinet minister and one Minister of State in the Modi cabinet. However, they still

hope to secure more positions during the next expansion. The second important task is to build the Andhra Pradesh State capital, Amaravati. His predecessor, Jagan Mohan Reddy, suspended this ambitious project during his two terms. Now that Babu is back in charge, he aims to complete Amaravati. he will put pressure on the Centre to secure funds for building capital, various new projects and his six welfare schemes. Being a showman, he would like to project Amaravathi as a model capital. The State is facing a severe financial crisis. There is a significant shortage of funds, with a total debt of around Rs 14 lakh crores, including Rs 12 lakh crore borrowed from various sources and pending bills of Rs 1.5 lakh crore.

During his four decades of political career, Naidu, aged 74, has proved himself a survivor. He was much ahead of his time in his first and second terms. He projected himself as a forward-thinking, pro-technology and tech-savvy Chief Minister. The atmosphere is excellent, as Naidu has the comfort of a kingmaker. Being part of the Modi Government gives him a chance to share power. He has no opposition in the Assembly, with YSRCP reduced to just 11 seats.

The TDP needs to address the issue of reservations for Muslims. This topic could lead to conflicts with the BJP. Naidu's positive relationship with Modi is expected to last a year, after which they could pressure the Government on this issue. Additionally, the TDP must resolve the corruption case as Naidu is currently out on bail. His conduct in his fourth term is crucial for his future and that of his son Lokesh.

eading is essential for those who seek to rise above the ordinary. There is no warmer feeling than reading your favourite book on a rainy day, covered in a cozy blanket with a cup of coffee in hand. The smell of fresh books, hiding pieces of an old love such as dry flowers, old photographs and hazy letters as bookmarks for books as they say have and will always be eternal gifts. In a world hustling and bursting with technological advancements every now and then, the way everyone engages with literature has undergone a significant transformation. The traditional means of reading a book have found themselves in tug-of-war with their digital and audio counterparts. Moreover, the production of physical books involves various materials and processes, including ink, chemicals and packaging materials, which can generate waste and pollution. E-books do not involve these manufacturing processes, thereby reducing the environmental footprint associated with production and waste disposal. While reading e-books requires electronic devices that consume energy, the environmental impact can be mitigated by using energy-efficient devices, renewable energy sources for charging and by considering the longer lifespan and potential reuse of electronic devices compared to physical books



But what depresses the most is when these e-books are available on devices such as a tablet or a phone resulting in the biggest sources of distraction and thereby reducing the focused reading time. Moreover such devices also offer multimedia enhancements (like videos or interactive elements), which can either enhance or distract from the reading experience, depending on individual preferences. Some people prefer the tactile experience of physical books.

Several research and studies reflect a complex interplay of factors influencing the preference for e-books versus physical books. Physical books tend to offer better comprehension, retention and a more comfortable reading experience, while e-books provide convenience, portability and cost efficiency. The choice between the two often depends on the specific needs and preferences of the reader. Instead of immersing oneself in a book, social media browsing encourages quick, fragmented reading of short posts or articles, which can ultimately diminish the habit of sustained, deep reading. The immediate gratification and constant novelty of social media can make reading books seem less appealing or rewarding by comparison.

Even when attempting to read, the temptation to check social media notifications or browse feeds can interrupt concentration and disrupt the

It's important to note that the environmental impact of e-books versus physical books can vary depending on factors such as the energy efficiency of devices used, the source of electricity and how frequently devices are replaced but what matters is that the user also recognise the unique benefits of physical books, leading to a balanced approach where both formats coexist in their reading habits.

# Centralised testing faces credibility crisis



High costs, allegations of corruption and systemic inefficiencies underscore the need for a comprehensive overhaul of the 'One Nation, One Test' policy



he country needs to go back to drawing board on centralising entrance tests as the big ones - JEE, NEET, CUET and UGC-NET - are having far too many glitches and questions raised on the National Testing Agency (NTA). The NEET scam and NET cancellation

have shocked the youth and raises questions on credibility of the testing agency. Let the country note that within 48 hours of NEET results, four students took their own lives. Should not the country rethink on the One Nation-One Test? The tests are designed to make coaching redun-

Few have an idea of the cost of one NEET - National Eligibility-cum-Entrance (Undergraduate) Test, previously called Pre-Medical Exam. It costs over Rs 400 crore borne by the parents of 2406079 candidates registered for the 2024 exam at the rate of Rs 1700 fee per applicant. The system does not say how much is the profit for NTA. It is common knowledge that no entrance fee is fully spent. Should it not be considered as a tax on the unemployed knowledge seekers! There are approximately 108,915 MBBS seats available across 706 medical colleges for NEET 2024. Around 55,000 of these seats are in Government medical colleges; the rest are in private medical colleges. One wonders why private colleges are included which have a devious fee structure backed by severe capitation fees. The quality of faculty is also questionable. Of course, even newly set-up many State medical colleges too have such issues. Many even do not have a cardiologist or neurologist.

Add the cost of coaching, travelling and other expenses, together to cost quite a few hundred crores more, big drain on the economy plus parental and societal stress. The Kota coaching system has an estimated business of Rs 600 crore. There are reports that the UGC-NET having nine lakh aspirants was cancelled as there was paper leak. Each question paper was sold for Rs 5,000 for transfer

# TMC to take battle to **BJP camp over NEET-NET**

Cornered by the BJP in Bengal on the TET (teachers' eligibility test) issue the Trinamool Congress has decided to take the battle back to the enemy camp by launching a counter attack on the NET issue (national eligibility test). Accordingly the party is all set to strongly raise in Parliament the alleged scam that took place in the NEET-UG and NET exams involving more than 35 lakh aspirants. For this the TMC is likely to coordinate with all opposition outfits including the Congress Party, inside sources said.

"What has taken place in the NEET and NET exams is a matter of grave concern ... it is a big big scam and has to be dealt with strongly ... we will raise the issue strongly in parliament and go to the end of it," senior TMC parliamentarian Sudip Bandopadhyay said a day before the new Lok Sabha meets on Monday.

National Eligibility-cum-Entrance Test Undergraduate (NEET-UG) is conducted every year to select candidates for medical courses. The students



who qualify NEET get the opportunity to secure a seat at any Medical colleges in any State. On the other hand joint CSIR UGC-NET is conducted to determine the eligibility of aspirants for the Junior Research Fellowship (JRF), Assistant Professor positions, and PhD admissions in accordance with the eligibility criteria laid down by the University Grants Commission. # Netanyahu reiterates claim of US withholding arms despite denial

Tsraeli Prime Minister Benjamin Netanyahu told his Cabinet on Sunday that there had been a "dramatic drop" in US weapons deliverdrop" in US weapons deliveries for Israel's war effort in Gaza, doubling down on a claim that the Biden administration has denied and underscoring the growing strains between the two allies.

Netanyahu told his Cabinet that the drop had occurred four months ago.

occurred four months ago, without specifying which weapons, saying only that "certain items arrived sporadically but the munitions at large remained behind."

The spat highlights how high tensions have surged between Israel and Washington over the war in Gaza, particularly surrounding the Israeli military's conduct in the beleaguered territory and the harm to civilian life there. President Joe Biden has delayed delivering

certain heavy bombs since May over those concerns, but his administration fought back last week against Netanyahu's charges that other shipments had also been affected.

Netanyahu told the Cabinet that he was driven to release a video in English last week after weeks of unsuccessful pleas with American officials to speed up deliveries. He said a resolution appeared close.

"In light of what I have heard over the past day, I hope and believe that this matter will be solved soon," he said, without elaborating.

Netanyahu's video last week sparked an uproar among critics in Israel and was met with denial and confusion from White House officials. White House national security spokesman John Kirby said the U.S. was "perplexed" by Netanyahu's claims. White House press secretary Karine Jean-Pierre To take a tougher line against

### 'New military offensive against terrorism to be discussed in Pakistan Parliament'

Pakistan Defence Minister Khawaja Asif on Sunday announced to consult the parliament over the issue of a fresh military offensive against terrorists after former prime min-ister Imran Khan's party demanded that any new operation should be discussed in the highest forum. The decision to launch 'Azm-e-Istehkam' operation was taken on Saturday at the apex committee meeting of the National Action Plan, a strategy approved in 2014 to eliminate militancy from the country.

A day after the plan was announced, lawmakers from the Pakistan Tehreek-i-Insaf (PTI) said the matter should have been discussed in Parliament which was the highest forum to decide about any new operation. The Minister first criticised the PTI by say-

ing that the party's chief minister of Khyber Pakhtunkhwa (KP) was present in the meeting when the decision was taken, but later also announced that the matter would be placed before the parliament.

"We will also bring this issue to the (Parliament) House where debate will be held on this topic. If they have any objection, when this issue comes to this House, then they can also speak on it," he said. Khawaja also accused the PTI of siding with terrorists.

"They (PTI) are standing with the terrorists by protesting here today. They are protesting against the martyrs of the Pakistan Army and the army that is still making sacrifices against terrorism," he said. He also said that the PTI leadership had not backed off from the May 9 stance when the party supporters attacked military installations, as he lambasted the party for changing its stance to serve its interests. Earlier, speaking to the media outside Parliament House, PTI chief Gohar Khan demanded that only parliament was empowered to take a decision

on military operations.
"It is our demand that if there is any operation — whether intelligence-based or fullfledged or in certain districts or villages or tehsils — it is necessary to take this Parliament into confidence," he said, adding that no matter how empowered a committee was, it could not supersede Parliament.

#### Philippines stands firm after clash with Chinese Coast Guard, aims to avoid war

The Chinese government said China calls its own offshore territory, a claim long rejected by rival claimant governments and international arbitrators.

The violent confrontation sparked condemnation and alarm from the US, the European Union, Japan, Australia and other Western and Asian nations, while China and the Philippines blamed each other for instigating it. Marcos's key advisers said Friday that his administration has no plan to invoke the country's mutual defence treaty with the United States."We are not in the business to instigate wars," Marcos told Filipino forces. "In defending the nation, we stay true to our Filipino nature that we would like to settle all these issues peacefully."

#### **Drone likely launched** by Houthi rebels hits ship in Red Sea

**Dubai (AP) :** An aerial drone likely launched by Yemen's Houthi rebels struck and damaged a vessel in the Red Sea on Sunday, officials said, the latest attack by the group targeting the vital maritime corridor.

The attack comes as the US has sent the USS Dwight D. Eisenhower back home after an eight-month deployment that saw it lead the American response to the Houthi assaults. Those attacks have seen shipping drastically drop through the route crucial to Asian, Middle East and European markets in a campaign the Houthis say will continue as long as the Israel-Hamas war in the Gaza Strip rages on.

The drone attack happened around dawn off the coast of the rebel-held port city of Hodeida, the British military's United Kingdom Maritime Trade Operations center said. It said the vessel sustained damage but its mariners on board "were reported safe." It did not elaborate on the extent of the damage, but said an investigation was ongoing.

Floodwaters forced people out of their homes in parts of Iowa, the result of weeks of rain, while much of the United States longed for relief Saturday from yet another round of extraordinary heat.

Sirens blared at 2 am in Rock Valley, Iowa, population 4,200, where people in hundreds of homes were told to get out as the Rock River could no longer take rain that has slammed the region. The city lacked running water because wells were unusable. Mayor Kevin Van Otterloo said a state helicopter was on its way to help but was called off when boats were able to reach stranded residents. "We've had so much rain here," he said. "We had 4 inches last night in an hour and a half time. Our ground just cannot take anvmore."

Gov. Kim Reynolds declared a disaster for 21 counties in northern Iowa, including Sioux County, which includes Rock

Valley. In drone video posted by the local sheriff, no streets were visible, just roofs and treetops poking above the water. In South Dakota, Gov. Kristi Noem declared an emergency after the southeastern part of the state received heavy rainfall. The town of Canton, 30 miles (48 kilometres) southeast of Sioux Falls, has received 18 inches (45.72 centimetres) of rain. Several highways were closed, including a key stretch of Interstate 29 south of Sioux Falls that later reopened. Sioux Falls, the state's largest city, had more than 7 inches (17.7 centimetres) of rain in three days. "Even though the rain is slowing down, we need to keep vigilant," said Noem. "The worst

of the flooding along our rivers will be Monday and Tuesday." Elsewhere in the US, the miserable grip of heat and humidity continued. The National Weather Service said roughly 15 million people were under a heat warning — the highest level of alert — while another

90 million were under a heat advisory. Millions across the country have had their lives disrupted by stretches of unusually high temperatures. Last year the US experienced the most heat waves since 1936, experts said. An AP analysis of data from the Centres for Disease Control and Prevention found that excessive heat contributed to more than 2,300 deaths, the highest in 45 years of records. Temperatures around 100 degrees Fahrenheit (37.8 degrees Celsius) were predicted for Washington, D.C., and Richmond, Virginia, while Philadelphia; Newark, New Jersey; Columbus, Ohio; and Detroit were bracing for the high 90s.

Heat-related hospital visits in New York state lately were 500 per cent higher than on the average June day, according to the Department of Health. We still have this prolonged heat wave across portions of the Ohio Valley and into the

Northeast," weather service meteorologist Marc Chenard said. "We get a little bit of relief by early in the week, at least in the eastern US, the Northeast, but in general above-normal temperatures are going to cover a large portion of the country even into next week." ### Taxpayers can amend sales return form before GST payment

GST taxpayers will now have the option to amend outward supply or sales return form GSTR-1 before payment of taxes for a month or quarter.

The GST Council in its meeting on Saturday had recommended providing a new optional facility by way of Form GSTR-1A to facilitate taxpayers to amend the details in Form GSTR-1 for a tax period and/or to declare additional details.

GSTR-1A will, however, have to be filed before filing of return in GSTR-3B for the said tax period.

said tax period.

This will facilitate the taxpayer to add any particulars of supply of the current tax period missed out in reporting in form GSTR-1 of the said tax period or to amend any particulars already declared in GSTR-1 of the current tax period (including those declared in IFE for the those declared in IFF, for the first and second months of a quarter, if any, for quarterly taxpayers), to ensure that



correct liability is autopopulated in GSTR-3B. Currently, GST taxpayers file

outward supply return GSTR
-1 by the 11th day of the subsequent month. Taxpayers with an annual turnover of up to Rs 5 crore can file GSTR-1 quarterly within the 13th day of the end of the quarter. Shardul Amarchand

The research involved 85 patients with heart failure, aged 30 to 70 years, who were divided into a yoga group (40 patients) and a control group (45 patients). All participants continued their standard heart failure medications. Participants in the yoga group received supervised sessions focusing on pranayama (yogic breathwork), meditation, and relaxation techniques. They continued home practice weekly, under guidance, for 50 minutes. Echocardiography measured heart structure and function at baseline, six months, and one

ventricular ejection fraction, right ventricular function, blood pressure, heart rate, and symptom burden.

The yoga group demonstrated significant improvements in all measured parameters compared to the control group. This included better heart function, reduced symptoms, and improved daily activity capability.

Dr. Singh concluded that yoga can

complement standard medical treatments for heart failure, providing long-term benefits in managing symptoms and improving quality of life.
YOGA NIDRA FOR SLEEP

AND COGNITIVE HEALTH Published in PLOS ONE, the study led by Karuna Datta examined the effects of yoga nidra

#### **NEW SAFETY MEASURES FOR TOPIRAMATE**

The UK's Medicines and Healthcare Products Regulatory Agency (MHRA) has implemented new safety measures for topiramate (sold under the brand name

Topamax) following a comprehensive safety review triggered by recent European studies. These studies highlighted increased risks associated with the use of topiramate during pregnancy, including a 2 to 3 times higher likelihood of intellectual disability, autism spectrum disorders, and attention deficit hyperactivity disorder in children born to mothers who used the drug during pregnancy. Based on recommendations from the Commission on Human Medicines (CHM), the MHRA now advises that topiramate should not be prescribed for treating epilepsy during pregnancy unless there are no suitable alternative treatments available. This caution extends previous guidance that already restricted its use during pregnancy for migraine due to known risks of birth defects.

Monday.

A third straight win for India will not only make them the group toppers and send them to the semifinals, it will also substantially threaten chances Australia's

progressing through to the semi-finals following the loss unexpected to Afghanistan in Saint Vincent on Saturday night.

Following the reverse against Afghanistan, Australia don't have the destiny in their own hands and will be keenly tracking Rashid Khan's team final game against Bangladesh on Monday night.

India, who have had to endure heartbreaking defeats at the

hands of Australia in major ICC events, would like to see a pre-mature exit of their strong

On fine-tuning their game ahead of the knockouts, India don't need to do much having ticked all boxes in their backwins to-back against Afghanistan and Bangladesh. Both Rohit and Virat Kohli played innings of substance against Afghanistan, while Shivam Dube, who had not

been able to perform his role, answered his critics with a crucial knock. Number three Rishabh Pant has been getting dismissed off reverse hit often and it is something he would like to

correct. The biggest positive for India in this tournament has been the all-round effort of Hardik Pandya, who has now come to the party with the bat to complement his incisive spells. Kuldeep Yadav has taken little

time to come up with matchwining contributions and he would be relied on for wickets in the middle overs.

With the team playing three Super 8 games with as many days of travel in between, the management will be tempted to rotate players but is unlikely to do so.

India, who arrived in Saint Lucia on Saturday night, chose not to train ahead of the Australia game considering the hectic travel involved. It will only be the second day

game at the Darren Sammy Cricket Stadium. The day nighters have produced highscores here but in the previous game at the venue, England were not able to chase 164 in a day game against South Africa. It has been the best batting strip of the competition but sun beating down on the pitch through the day is likely to aid the slower bowlers.

Australia, on the other hand,



have plenty to worry about going into the game. It was a flop batting show against Afghanistan and unusually Mitchell Marsh's team had a forgettable night in the field as

Having logged only 88 runs in six games at a strike rate of 111, Marsh needs to lead from the front against India.

In terms of match ups, it will be interesting to see how Kohli fares against leg-spinner Adam Zampa, who has had the better of the Indian superstar on

multiple occasions.

Australia played the extra spinner in Ashton Agar instead of Mitchell Starc against Afghanistan but that could change against India.

"It was an off-night for us in the field, and we own that. We'll be back next game. It

Hosts West Indies will need their all-round firepower for taming a ram-paging South Africa in their must-win final Super Eight clash to seal the semi-final berth at the T20 World Cup here. After their only loss in six games to England in their opening Super 8 game, WI regrouped to smash co-hosts USA by nine wickets.

For WI, a win will see them through to the last-four, while a loss will bring it down to net run-rate and that too only if USA beat England in the other group

South Africa, who have won all their six games so far, are sitting at the top of the table but they too are not yet guaranteed a spot in the semifinal and will need a win seal the position.

A loss will again leave their fate on the other result and NRR.

However, both teams will have the advantage of knowing the exact scenario before they head into the match.

West Indies had failed to rotate strike against England but they quickly addressed the issue, producing a domi-nant show against USA led by Shai Hope's belligerent 39-ball 82.

South Africa, on the other hand, haven't looked dominant so far despite an all-win

record. It has always been tight wins even against minnows like the US and Nepal. The positive thing is that Aiden Markram's team has always found a way

to come out trumps.
"If you look at previous World Cups, the small moments we haven't really won. And it's good to see that I think all the games have come really close and we found a way, so it's building the character within the team," Keshav Maharaj said. "And I think it prepares us for obviously certain opportunities that we could get and crossing over the line in those small moments are things that we've never done before. So, it's good to see us getting into

For SA, Quinton de Kock and Reeza Hendricks have done the heavy lifting, while Anrich Nortje and Keshav Maharaj have been their standout bowler.

De Kock's big-hitting in the powerplay made the difference in their last match against England and WI has to find a way to stop him.

WI has some quality spinners in Akeal Hosein, Gudakesh Motie and Chase and a lot will depend on them as how they contain the middle-order, led by David Miller.

WI will also take inspiration from their 3-0 sweep of South Africa ahead of the tournament although it came against a second-string side. South Africa, on the other hand, have an overwhelming 3-1 record against the West Indies in T20 World Cups.

# Afghanistan shock Australia by 21 runs in Super 8s match of T20 World Cup

A fghanistan pulled off an upset of epic proportions with a shock 21-run win over mighty Australia in T20 World Cup with Gulbadin Naib's four-wicket haul upending Pat Cummins' hat-trick to produce one of most memorable days in Afghan cricket.

Using the slower balls smartly on a difficult batting wicket, Afghanistan defended their total of 148 for six for their first-ever win over Australia in international

Australia were all out for 127 in 19.2 overs in the Super Eight contest and they are now staring at early elimination from the World Cup. Australia now must win their match against India on Monday and also hope that Afghanistan lose to Bangladesh in their next

Afghanistan Rahmanullah Gurbaz (60) and Ibrahim Zadran (51) forged a 118-run partnership setting up base for a challenging total but Pat Cummins registered his second successive hat-trick spread across two overs to restrict Afghanistan to a manageable total. Australia were reduced to 32 for 3 in the powerplay but Glenn Maxwell slammed a 41-ball 59 to somewhat resurrect the chase. However Naib's timely strikes proved crucial in toppling the 2021 champions.

Afghanistan exacted revenge for their defeat in Mumbai during the ODI World Cup. Maxwell had snatched victory from Aghans at that time and on Saturday too he threatened to deny them but Naib's brilliance ensured them the

"It's massive win for us as a team and as a nation. Great feeling. It's something we missed in last two years. Really happy with the win and super proud of the guys,"
Afghanistan skipper Rashid Khan
said at the post-match presentation.

The way Gulbadin bowled today the experience he has, it came good today. The way Nabi started the wicket of Warner - was also pleasing to see. It's so important for us back home and around the world. I'm sure they're proud and would've enjoyed the game," he added.

The result has opened up the Group 1 as both Australia and Afghanistan now have one win each with one match to go, while India sit atop the table with two



wins from as many games. Defending 149 on a spin-friendly wicket, Afghanistan had the perfect start as Naveen-ul-Haq perfect start as Naveen-ur-rad picked up two early wickets with the new ball to peg Australia back. First Naveen cleaned up Travis Head for a duck with a fuller delivery and then he deceived the skipper Mitch Marsh with a slower delivery as he holed out to Nabi. Maxwell eased the pressure with two fours off Azmatullah but Nabi removed David Warner (3), who went for a slog sweep only to find Noor Ahmad as Australia scored the lowest Powerplay score of 33

Maxwell, who had tormented Afghanistan during the ODI World Cup last year, continued to find the boundaries as he clattered spinner Nangeyalia Kharote for a four and a six.

Naib then struck twice to give Afghanistan hope as he surprised Marcus Stoinis with a bouncer. The batter top-edged it to find Gurbaz. He next trapped Tim David as Australia slipped to 85 for 5 in the 13th over. Maxwell slammed a six off Rashid Khan and Naib in 12th and 13th

overs to keep Australia's chase on track.

Naib returned to pick his most

prized cap, dismissing the dangerous Maxwell in the 15th over and then Rashid removed Matthew Wade as their chase fell apart.

Naib next knocked off the stumps of Cummins, while Naveen claimed his third victim by removing Azmatullah Ashton ended proceedings by dismissing Josh Hazlewood.

Earlier, Gurbaz and Ibrahim notched up their third century stand of this T20 World Cup with a 118-run partnership.
The duo capitalised on their

chances as Australia had to wait till the 16th over for their first breakthrough.

Gurbaz slammed four maximums and as many fours in his 49-ball stay, while Zadran hit six boundaries during his 48-ball knock.

Stoinis got rid of Gurbaz with an off-cutter, while in the next over, Adam Zampa cleaned up Azmatullah Omarzai with a slider. Looking for big hits, Afghanistan lost wickets there after with Cummins dismissing Rashid Khan, Karim Janat and Gulbadin Naib to became the first player to pick up two hat-tricks in T20 World Cups.

#### **JORDAN, BUTTLER POWER ENGLAND** PAST USA, INTO CEMIEINAI C

Pacer Chris Jordan grabbed a sensational hat-trick in his birthplace before captain Jos Buttler's blitzkrieg as England stormed into the semifinals of the T20 World Cup with a 10-wicket mauling of USA here on Sunday.

Making a comeback in place of Mark Wood, Jordan (4/10) mopped up the USA tail by claiming four wickets in five balls, including the hat-trick, in the 19th over as the Americans folded for 115 in 18.5

Buttler then blazed away to a 38-ball 83 not out as England completed the chase in 9.4 overs to become the first team to make the semifinals of the showniece.

During his scintillating knock, Buttler smashed seven sixes and six fours, including hitting five maximums in a Harmeet Singh over to leave the USA bowling bruised and battered.

Earlier, the 35-year-old Jordan, who was born and grew up in Christ Church, Barbados, began the penultimate over dismissing a well-

set Corey Anderson for 29 with a low full toss.

After surviving the next ball, Ali Khan found his off stump knocked over before Jordan went on to dismiss Nosthush Kenjige and Saurabh Netravalkar off successive deliveries to pick the first hat-trick for England in T20Is. Jordan had figures of 4/10 from his

2.5 overs.

Jordan also became only the second bowler in T20 World Cup history to pick four wickets in a single over. Curtis Campher of Ireland was the first to pick four wickets in a single over against the Netherlands during the 2021 edition in Abu Dhabi. It was Sam Curran (2/13) who

triggered the collapse by dismissing Harmeet Singh (21; 17b) in the final delivery of the previous over as USA suffered a stunning collapse, losing five wickets in six balls for no run. Earlier, Adil Rashid took a miserly 2/13 in four overs.
Andries Gous flicked Reece Topley

towards fine leg for a six but two balls later, hit the ball straight to Phil Salt at deep square leg while attempting a similar shot.

USA faced some nervous moments in the day's second over as Steven Taylor survived a run out after giving up hope of returning back to the crease in time. It would have been over for him if Liam Livingstone's throw had hit the stumps. At the other end, Nitish Kumar top-edged a fast delivery from Jofra Archer that flew over deep third man for a maximum.
