# LS SESSION TO SEE FIREWORKS CBI gets cracking in NEET case

**¬**he first Session of the 18th Lok Sabha starting Monday is all set to begin on a stormy note given the reduced strength of the ruling BJP in the Lower House and an embold-ened Congress with double the number of MPs it had in the previous two Houses. Above all, the Parliament Session comes in the backdrop of a series of exams paper leaks providing enough ammo to an equally strengthened combined Opposition determined to corner Narendra Modi 3.0 Government.

The Opposition is also set to take up the issue of railway safety with a major accident in West Bengal with casualties a week ago. The Congress and other Opposition members have been demanding the resignation of Education Minister Dharmendra Pradhan and Rail Minister Ashwani

As scheduled, the Lok Sabha will see oath-taking by the newly-elected members followed by election of the Lok Sabha Speaker on June 26 and President Droupadi Murmu's address to joint sitting of both the Houses on June 27.

The row over appointment of BJP leader and seven-term member Bhartruhari Mahtab as the Pro-tem Speaker is likely to cast shadow over the session. The move has drawn flak from the opposition, which alleged that the claim of Congress member K Suresh to the post was overlooked by the Government.

Parliamentary Affairs Minister Kiren Rijiju asserted that Mahtab has had seven uninterrupted terms as Lok Sabha member, making him eligible for the post, while Suresh lost



elections in 1998 and 2004 which makes his current term as the fourth straight one in the lower house.

Earlier, he was elected to the Lok Sabha in 1989, 1991, 1996 and 1999. On Monday, Murmu will administer the oath to Mahtab as the Pro-tem Speaker of the Lok Sabha at the Rashtrapati Bhawan. Mahtab will then reach Parliament House and call the Lok Sabha to order at 11 am.

The proceedings will begin with members observing a moment of silence on the occasion of the first sitting of the 18th Lok Sabha. This will be followed by Lok Sabha Secretary General Utpal Kumar Singh placing on the table of the House the list of the members elected to the Lower House.

Mahtab will then call upon Prime

Minister Narendra Modi, the leader of the Lok Sabha, to take oath as member of the House.

The Pro-tem Speaker will then

administer oath to the panel of chairpersons appointed by the President to assist him in carrying out the proceedings of the House till the election of the Speaker on June 26. The President has appointed Kodikunnil Suresh (Congress), T R Baalu (DMK), Radha Mohan Singh and Faggan Singh Kulaste (both BJP) and Sudip Bandyopadhyay (TMC) to assist Mahtab in administering the oath/affirmation to the newly elected

After the panel of chairpersons, the Pro-tem Speaker will administer the oath/affirmation as Lok Sabha members to the Council of Ministers.

The election to the post of Lok Sabha Speaker will take place on Wednesday and the Prime Minister will introduce his Council of Ministers to the House soon after

The President is scheduled to address the joint sitting of both Houses of Parliament on June 27. The debate on the Motion of Thanks to the President's Address will begin on June 28. The Prime Minister is expected to respond to the debate on July 2 or 3.

Both the Houses are expected to go into a brief recess and re-assemble on July 22 for the presentation of the

he Central Bureau of Tine Central Investigation (CBI) has registered an FIR in connection with alleged irregularities in the conduct of the medical entrance exam — National Eligibility Cum Entrance Test-UG — held on May 5, following a complaint from the Education Ministry. It is taking steps to take over probes/FIRs of other States in the matter. Giving top priority to the case, the CBI has formed special teams that are en route to Godhra and Patna, where cases of question paper leaks have been registered by police The CBI had already registered three cases to probe alleged irregularities in NEET exams conducted in 2018 2021 and 2022 by NTA and this is the fourth FIR, registered on June 23, to probe allegations of irregularities in 2024 NEET exam against unidentified persons on a reference from the Union Education Ministry. Police in Bihar's Nawada arrested four persons in connection with alleged attack on CBI team probing UGC-NET leak case, said officials.

Facing flak over alleged discrepancies in competitive exams, the Centre on Saturday shunted out National Testing (NTA) Director Agency General Subodh Singh and handed over the probe into irregularities in medical entrance exam NEET-UG to the CBI to conduct a comprehensive investigation demanding the exam be

into the entire gamut of irregularities, alleged including conspiracy, cheating, impersonation, of breach trust, and destruction of evidence by candidates, institutes, and middlemen, including attempted irregularities.

There were allegations of irregularities, including cheating, impersonation and other malpractices after the results of the NEET-UG 2024 was declared on June 4 — days before schedule. Student protests have been raging across the country since, amplified by the Opposition, and the matter has snowballed into a huge political row.

The students have been

rescheduled for everyone and not the 1,500-odd students who received grace marks. This, however, has not been accepted by the Government and the re-test for 1,563 candidates, who had initially received grace marks, held on Sunday. As many as 813 of the 1,563 candidates who were earlier awarded grace marks in NEET-UG appeared for a retest on Sunday, officials said. The allegations in the FIR state that the NEET(UG) 2024 examination was conducted by the National Testing Agency (NTA) on 5th May 2024 at 4,750 centres in 571 cities, including 14 cities abroad, with over 23 lakh candidates appearing for the examination.

## Kejriwal knocks SC door over stay on bail

Delhi Chief Minister Arvind Kejriwal on Sunday moved the Supreme Court seeking urgent hearing against Delhi High Court stay on his bail order in the excise policy case. Earlier, the Chief Minister was granted bail in the alleged excise policy case in a Delhi court. But the High Court stayed the bail till it gives its order on a plea filed by the Enforcement Directorate (ED) challenging his bail.

Kejriwal, who is currently lodged in Tihar Jail, in his petition said the High Court has stayed the bail order ignoring the established legal process and tradition. In this regard, the basic principles of justice and bail established in the country have also been violated.

"The manner adopted by the HC in staying the bail order is contrary to the said clear dicta of law laid down by this court and would violate the basic fundamental threshold on which the bail jurisprudence is premised in our country, the petition stated.

## **Shah mulls steps to save** people from flood fury

As floods and heavy rains ravage Northeast India, Union Home Minister Amit Shah on Sunday called for a series of comprehensive strate-Approach' to address the escalating crisis, particularly the recurring flood threats posed by the Brahmaputra River. Key measures include the

creation of at least 50 large ponds to store excess water, leveraging satellite imagery for enhanced flood management, upgrading flood forecasting systems. These

initiatives are part of a broader to mitigate the devastating impacts of floods and improve the region's resilience. During the review meeting on

management with officials from the IMD, CWC, NDMA and the National Disaster Response Force, the Minister emphasised the integration of natural drainage systems into infrastructure designs, better handling of Glacial Lake Outburst Floods (GLOF), and the enhancement of community awareness and preparedness programmes.

Emphasising the role of advanced technology, Shah advocated for the optimum use of satellite imagery from the Indian Space Research Organisation (ISRO).

This would aid in effective flood and water management by providing accurate and



preparedness to deal with floods that affect various parts of the country during the monsoon, in New Delhi, on Sunday. Union Minister of Jal Shakti C R Paatil and Union MoS for Home Affairs Nitvanand Rai are also seen

timely data on water levels and flood risks, he told the officials, as per the statement

issued here. Recurring flooding of the Brahmaputra is a major issue particularly for Assam and the Northeastern region in general as it claims scores of lives and inundates thousands of hectares every year.

This year too many people have been killed, hundreds rendered homeless and communication lines and road networks snapped in Sikkim and Arunachal Pradesh which witnessed cloudburst on Sunday. Tamil Nadu, Kerala, and Jammu and Kashmir have also witnessed flooding in recent years.

During the meeting, the Minister said under the

leadership of Prime Minister Modi, India's Narendra Disaster Management is moving forward with a 'Zero Casualty Approach'.

The Minister also highlighted the importance of upgrading the forecast system for river water levels. This included modernising the equipment used in flood forecasting to improve the accuracy and reliability of flood predictions, thereby facilitating better preparedness and response.

also reviewed preparations to deal with Glacial Lake Outburst Floods, which have caused significant damage in regions like Sikkim and Uttarakhand in the past few years and are now becoming a recurring feature.



## **People aiding ultras to be tried** under Enemy Agents Act in JK

 $B_{\text{forces deployed on the counter-ter-rorism grid, Lieutenant Governor}}^{\text{good on the security}}$ Manoj Sinha on Sunday directed them to hunt down the terrorists and those harbouring them.

Echoing similar sentiments, Director General of Jammu and Kashmir police RR Swain claimed terrorism in Jammu will be wiped out in the next three months. He said people who are harbouring foreign terrorists will be tried under the Enemy Agents Act which is a much harsher law than the

Responding to the question from a media person, DGP said to dismantle the terrorist ecosystem in the Union Territory we are considering invoking the Enemies Agents Act. According to him, the stringent law permits life imprisonment or the death penalty for those found aiding or abetting Pakistani terrorists. The DGP hoped the decisive action

would serve as a deterrent discouraging locals not to support foreign terrorists.

According to the latest assessment reports around 35-40 foreign terrorists are active in the region south of Pir Panjal in the frontier districts of Rajouri and Poonch.

These terrorists are mostly camping inside safe hideouts in small groups of two to three terrorists and executing terror plots at the behest of their handlers sitting across Pakistan. Official sources revealed during the high-level security review meetings these measures were discussed in the backdrop of increase in terror strikes

across the Jammu region.
Following these directions, the security forces have further intensified anti-terrorist operations to neutralise these foreign terrorists. Additional troops have been mobilised on ground zero to beef up security ahead of the Amarnath yatra starting from June 29.

# Two CoBRA personnel martyred in IED blast triggered by Naxals

wo personnel of the Central Reserve Police Force's jungle warfare unit CoBRA were killed after Naxalites blew up a truck with an improvised explosive device (IED) in Chhattisgah's Sukma district on Sunday, police Javal blact took place around Timmapuram village between Silger and Tekalgudem camps of security forces, over 400 km from the State Capital Raipur, a senior police

official said. An advance party of the 201st unit of Commando Battalion for Resolute Action (CoBRA) had patrolling launched from Silger camp under Jagargunda police station limits as part of its Road Opening Party duty towards Tekalgudem,



he said. The security personnel were on motorcycles while their luggage and rations were being ferried in the ill-fated truck, he said

"Naxalites triggered an IED blast targeting the truck that claimed the lives of constable Shailendra (29), a resident of Uttar Pradesh, and driver Vishnu R (35) hailing from Kerala. The truck did not have any other occupant," he said. After being alerted about the blast, more forces were rushed to the spot and the bodies were evacuated from the forest, while a search operation continues there, he said.

Expressing grief over the incident, Chhattisgarh Chief Minister Vishnu Deo Sai said in a message on X that the martyrdom of jawans will not go in vain. "Received the sad news of the demise of 2 CoBRA soldiers in an IED blast triggered by Naxalites in Sukma district. I pray to God to rest the departed soul in peace and to give strength to their families,"



The current visit of Nancy Pelosi to Dharamshala, wherefrom the Tibetan gov ernment-in-exile has been working since 1959 has brought back the Tibetan question on the centre stage of international politics. Tibet like Taiwan is a flash point of international dispute in this part of the world involving China. The difference between the two is that Taiwan is a standalone case and it's supporters do not have a direct contact with the borders of either Taiwan or China. In the case of Tibet, a powerful country like India has a border contact with it. The Chinese occupation of Tibet has India with China. It is a historical fact that Tibet was a buffer state between India and China and it was culturally close to India because of

China is not a neighbour of India because of geographical compulsion, our because of our political folly committed in 1949 when we accepted the Chinese claim over Tibet and thereafter the One China Policy. The USA did not realise the gravity of the development then or did not interfere in the matter possibly because of the emergence of the communist USSR as a superpower in the bipolar world order that emerged after the second world war. Our leader Nehruji, too, had a fascination for socialism and a natural soft corner for the USSR and China which led to this

political misjudgement. The USA was not fully secure and self-confident till 1970 as it always felt threatened by the USSR. The US led West decided to use China as a bulwark against the USSR and it granted China a permanent seat at the UN Security Council. China became a blue eyed boy of the West and the western technology and market were transferred to China to make it powerful. China became the factory of the world as well as a source of serious threat to the global hegemony of the West. The post-corona world saw a paradigm shift in the global world order. China went down and so did the US led West. Russia survived this pandemic largely successfula new power in this period. It handled corona almost successfully, made vaccines and saved its economy.

All these developments had a deep and profound impact on the Tibetan issue. I personally believe that Nehruji had a realization that accepting the Chinese claim over Tibet was a mistake. That's why he allowed His Highness Dalai Lama and his supporters to come to India. He granted them not only political refuge but also allowed them to form a Tibetan government in exile and thereby keeping the embers alive to be stoked and flared up as and when the situation became favorable. That moment of history has arrived. The visit of Nancy Pelosi is unprecedented and it has taken China and the world by surprise. This is simply a matter of speculation and diplomatic judgment as to what transpired backstage between India and the US that led to this development. It is also certain that China has been caught off guard. As the two great democracies of the world, it is our duty to take up the cause of Tibet. ## HAZARIBAGH'S SCHOOL IN SPOTLIGHT FOR MEDICAL ENTRANCE PAPER LEAK

Hazaribagh has come under the spotlight for its connection to the last high-profile paper leak cases, raising concerns about its role as a weak link exploited by the paper leak mafia from Bihar. In a fresh development in the NEET paper leak, Bihar Police's Economic Offences Unit (EOUEOU on Sunday reached Oasis school in Hazaribagh and questioned the management regarding the leaked question papers

According to sources within the Economic Offences Unit (EOU) of Bihar Police, Hazaribagh's Oasis School was involved in the NEET paper leak where a question paper was found tampered with. The evidence of tampering was submitted in a report to the Union Education Ministry, prompting it to involve the National Testing



Agency (NTA) and eventually escalate the matter to the CBI for further investigation

Meanwhile, NTA has sent the original question paper of the medical entrance examination to the EOU. The original question paper was needed to check the booklet number of the burnt question paper found on May 5 and send it to FSL.

Shabbir Ahmed is the chairman of Oasis School from where the paper is sus-

pected to have leaked. The principal is Ehsanul Haque, who is also the city coordinator of CBSE. Being the city coordinator of CBSE, Haque covers all centres in four districts in Jharkhand

Koderma and Ramgarh where the education body conducts exams. The EOU has found the role of the Oasis school suspicious in the paper leak case

Sources said that the

question paper was leaked from Hazaribagh's Oasis School. Earlier on June 22, the EOU team reached the school and questioned the school management and teachers. The booklet number 6136488 whose question reached belonged to this school.

Meanwhile, EOU is also looking for 10 PG doctors the Patna-Ranchi Medical College, as they are accused of solving the question paper. The latest development

comes after the EOU detained six more people, including a wanted prime suspect Chintu from Deoghar. EOU conducted the operation with the Jharkhand Police and brought the arrested to Patna. They were detained from a house near AIIMS-Deoghar in Devipur police station area on Friday night. The arrested suspects were Chintu alias Baldeo Kumar, Paramjit Singh alias Bittu, Panku Kumar, Kaju alias Prashant Kumar, Ajit Kumar, and Rajiv Kumar alias Karu.

The NTA conducted NEET-UG on May 5 with around 24 lakh candidates participating. The results were announced on June 4, but they were followed by allegations of question paper leaks in states such as Bihar, besides other irregularities. It is worth mentioning that on May 5, the day of the NEET examination, Bihar police raided Khemnichak and found a burnt question paper and recovered booklet num-

The booklet belonged to exam centre in Hazaribagh. Police traced the source of the question paper Jharkhand's Hazaribagh and other places.

## Met department issue safety advice from lightening and thunderstorm golf carts, open structures,

Thunderstorms and lightning are one of the major meteorological hazards affecting large parts of India which causes death of people and animals as well as property damage. In the last 20 years, on an average, about 2500 people have lost their lives due to thunderstorms and lightning. Keeping this in mind, the Meteorological Department has issued a safety advice from lightening and thunderstorm.

On e should check the weather forecast before starting any outdoor activity. In case of thunderstorms and lightning, stay indoors for 30 minutes. When there is thunder, take shelter and stay inside a safe place or building. Avoid metal structures and constructions with metal sheets. Safe shelters include homes, offices, shopping centers and hard-top vehicles with closed windows.

Get off elevated areas such as hills or dunes, mountain or peaks and ridges immediately. In case of being trapped in an open area, act quickly and get out of the danger area and take shelter in a nearby safe place. Take shelter in a low-lying area and ensure that the chosen location is not prone to flooding. Immediately move out and stay away from ponds, lakes and other water bodies. Stay away from all utility lines and objects conducting electricity such as telephone, electricity, metal fences, overhead wires, rail road tracks, windmills, etc. Stay away from trees and hills.

If some is in a group during thunderstorm and lightning, maintain adequate distance to reduce the risk rubber-soled shoes and car tyres do not provide protection from lightning.

One should not go out of the house during adverse weather, especially for working in the agricultural field, grazing cattle, fishing and boating or for general travel. Take shelter under small and dwarf trees if someone is in a forest area during lightning. Keep a distance from electricity or telephone poles, wire fences, machinery and others. Never use mobile phones and iron-rod umbrellas during lightning.

If some one is in indoor one should keep monitoring local media for updates and warning instructions from communication various channels. Stay indoors and avoid traveling if possible. Stay away from doors, windows, porches and concrete floors, fireplace stoves, bathtubs or any other electrical conductors. Unplug electrical/electronic devices such as computers, laptops, gaming systems, washers, dryers, stoves or anything connected to an electrical outlet, as main power supply may during a lightning storm. Keep windows and doors closed and secure objects outside someone home. On should make sure children and pets stay inside and remove tree logs or any other debris that may fly and cause an accident.

Someone should do not use electrical and electronic devices including corded phones or any metal wires and bars. Avoid using corded phones and other electrical devices that may conduct electricity however, it is safe to use cordless phones during a storm with lightning and thunder. One should avoid open vehicles such as con-

vertibles, motorcycles and

spaces such as porches, playgrounds such as golf courses, parks and playgrounds, ponds, lakes, swimming pools

If one is travelling then one should check the weather forecast before outdoor activities and if there is a thunderstorm forecast or warning, postpone travel or outdoor activities. Avoid open vehicles such as convertibles, motorcycles and golf carts. Avoid open spaces such as golf courses, parks, playgrounds, ponds, lakes, swimming pools and beaches during thunderstorms and lightning. Get off bicycles, motorcycles or farm vehicles immediately which may attract lightning.

If someone is boating or swimming, get to the ground as soon as possible and take shelter in a safe place. Stay inside the vehicle until help arrives or the storm has passed, as the metal roof will provide protection. During thunderstorms and lightning, windows should be up and the vehicle should be parked away from trees and power lines. Get out of the forested area and move to a clear field. There is a possibility of forest fire. When someone become lightening victim then one should provide first aid to lightning victims before medical professionals arrive which can save lives. It is safe to touch a lightning victim. Lightning victims do not have any electrical charge and can be handled safely. Check the victim to see if he is breathing and if his heart is beating. The best place to check for a pulse is the carotid artery which is found on the neck just below the jaw. If the victim is not breathing, immediately start mouth-to-mouth resuscitation. If the victim has no pulse, start cardiac compressions and CPR.

One should check the lightning survivor for loss of vision and hearing and broken bones, which can lead to paralysis or major bleeding complications. Be alert and aware of the constant danger of lightning strikes for both victim and rescuer. If the area where the victim is located is a high-risk area, try to move the victim to a safe place immediately.



## Army hospital infrastructure expansion plan set in motion

The state-of-the-art Army Hospital (Research & Referral) here has set the wheels in motion for a significant expansion in its infrastructure with three new medical centres for oncology, ophthalmology and orthopaedic and joint replacement set to come up in its sprawling campus here in the next one to two years

Lt Gen Ajith Nilakantan, Commandant, Army Hospital (R&R), said this during an interaction with a group of mediapersons on the AHRR premises on Saturday.

The 1200-bed hospital is a "quaternary" facility and provides treatment largely to the patients referred to it from tertiary or similar-level hospitals, he said. With its campus in Delhi spread over 256 acres, it is the apex medical institute of the Armed Forces Medical Services (AFMS).

"No hospital can be updated and remain relevant if it doesn't expand and keep in touch with the latest advances in technology and facilities.

That is why we have recently started the construction of a full-fledged oncology (can-cer) centre with all the latest facilities, an ophthalmology (eye) centre is being con-structed and also an orthopaedic and joint replacement centre also being constructed," the AHRR commandant said. "We hope that in the coming one to two years these will be ready," he added. The three new centres once completed will give a boost to the medical infrastructure and services offered by the hospital, which has been located at its current campus here since

The AHRR had recently announced the opening of a skin bank facility, a first-of-itskind facility to be established within the AFMS.

While the skin bank housed in its Department of Plastic and Reconstructive Surgery was formally inaugurated on June 18 by DGMS (Army) Lt Gen Arindam Chatterjee, it had received its first skin donation on May 29, a senior official said. This donor, a woman, was the mother of army personnel and had died at the AHRR, another official

This skin bank is the first in the AFMS. In fact there are very few centres in the country which have a skin bank. Basically, it is for severe burns. Skin has to be replaced, otherwise infection can prove fatal, said Lt Gen Nilakantan. "It is very important to cover the exposed area and some-



times adequate skin may not be available with the same patient. So, we may have to take skin from somebody else and use it for an initial period until the base skin comes

As part of our organ donation system, we have an Armed Forces Organ Retrieval System, it's called AORTA (Army Organ Retrieval and Transplant Authority), and various organ donations are

est where skin donation is also part of our.... And, it's a licenced skin bank," he said. The AHRR Commandant said it is hoped that treatment of serious burn injuries will be augmented with this skin

This bank will serve as a centralised hub for the collection, processing, storage and dis-tribution of skin grafts, providing a "critical resource" for military medical centres across the country. By establishing this facility, the

armed forces are ensuring that the personnel and their families have access to the most advanced skin replacement therapies.

The visiting mediapersons were later also taken around some of its key departments, which have cutting-edge medical equipment such as hightech simulator for eye surgery. Some of the mediapersons also interacted with the patients, who have recently undergone liver or heart transplant procedures at this hospital. Nilakantan said the AHRR has

"all the broad specialities, and all the super specialties, and altogether we have 35 departments, including specialities and super specialties departments".

"We have about 300 doctors, and 300 nursing officers. Also, we have a large number of outsourced paramedical staff, almost 1,000... Besides, 300 defence civilian," he said in response to a query.

Asked what has been some of the lessons for the hospital from the COVID-19 pandemic, he said, firstly, "we had the advantage that we went for vaccination of frontline workers and our people were immunised (against Covid) at

And, with that confidence, at most of the hospitals in the

AFMS, "we endeavoured to make sure that while we treated Covid, we also did not stop treatment of other diseases", the Commandant said. "This has been our endeav-

our. I can say it with pride that we did succeed to a large extent, including this hospital. Work here could be carried on to the fullest possible extent, with treatment of patients having other diseases as well," he asserted. 'Today, we can look back and

say that probably that is the way to get the whole infrastructure, medical establishment to work, in case we face similar situation in future. We were quite fully functional except for a brief period. Now, we are wiser, and next time it happens, we will be

## Children with chronic skin diseases face emotional trauma

Naveen Rawal, a 15-year-old struggling with acne, says in a choked voice, "Having acne made me feel like everyone is staring at my face. I try to cover it up with makeup, but kids at school still make fun of me. It made me not want to go out or be seen by anyone."

Similarly, 12-year-old Jagat, who battles eczema, shares, "My skin always looks red from itching. People think I have something contagious and avoid sitting next to me in the class. Sometimes, I feel really lonely because no one wants to be my friend."

Nine-year-old Rema, coping with alopecia, questions why she looks different from her peers, saying, "I don't have any hair on my head. Kids at school call me names like 'baldy' and laugh at me. It makes me not want to take off my hat or go to school." These testimonies reflect the

emotional and social challenges besides bullying and stigmatisation children with chronic skin diseases such as acne, alopecia, eczema, psoriasis, and vitiligo often face affecting their self-esteem and social interactions. This has been pointed out by a study published in JAMA Dermatology. In general, girls reported more stigma than boys. The study said over 73 per cent of participants reported experiencing stigma related to their condition. This stigma was strongly linked to lower quality of life, increased

anxiety, and depression among affected children.

The study covered 1671 children, 58 per cent of them girls, with mean age being about 14 years. About 56 per cent of the children selfreported high disease visibility, while 50.5% reported moderate disease severity.

'The general burden of skin disease is sometimes difficult for people to appreciate, and even as dermatologists, we don't always know how to ask questions about quality of life or how our perception correlates with the lived experience of patients and their caregivers," said study author Michele Ramien, MD, Clinical Associate Professor of Pediatric Dermatology at the University Calgary, Pediatric



Dermatologist at Alberta Children's Hospital in Calgary, Alberta, Canada, and President of the Canadian Dermatology Association.

'This study clearly shows, with validated instruments and tools, that there is a big burden and stigma associated with skin disease, and the experience of stigma is real," she said. "It's something we need to work on asking about more and addressing with patients." The study was conducted at 32 pediatric dermatology centers in Canada and the United States between 2018 and 2021, using the Patient-Reported Outcomes Measurement Instrumentation System Stigma-Skin to examine the links between disease visibility and severity and mental

health and quality of life. Nearly three quarters of children with skin disorders reported some amount of stigma. Stigma scores correlated strongly with reduced quality of life, depression, anxiety, and poor peer relationships.

În addition, about 29% of parents said they were aware of their child being bullied, pri-marily at school, which was strongly associated with stig-

In general, girls reported more stigma than boys, and children with hyperhidrosis and hidradenitis suppurativa were more likely to have higher depression and anxiety scores. "Some conditions didn't have

we had thought, such as atopic

dermatitis, while others had

more than we thought, such as excessive sweating," Ramien "That speaks to the disconnect

in physician perceptions and serves as a reminder to ask children and families about their experience - and to find the best way to do that without making it burdensome or stigmatizing."
When physicians ask about mental health challenges and

quality of life, they may be better able to refer children and families to the care they need. For instance, specialized dermatology treatment may help decrease the severity and visibility of the skin condition, and mental health resources may help reduce stigma, false beliefs, and internalized per-

Space agency ISRO on Sunday said it has achieved a third consecutive success in the Reusable Launch Vehicle Landing Experiment demonstrating

The third and final test in the series of Landing Experiment (LEX-03) was conducted at 07:10 1ST at the Aeronautical Test Range (ATR) Chitradurga, Karnataka.

Following the success of the RLV LEX-01 and LEX-02 missions, ISRO in a release said, RLV LEX-03 re-Mahendra Singh paid their tribute to Mookerjee. demonstrated



landing autonomous capability of the RLV under more challenging release conditions (cross range of 500 m against 150 m for LEX-02) and more severe wind conditions.

The winged vehicle, named 'Pushpak, was released from an Indian Air Force Chinook Helicopter at an altitude of 4.5 km "from a release point 4.5 km away from the runway. Pushpak autonomously executed cross-range correction manoeuvres. approached the runway and performed precise horizontal landing at the runway centreline," it said. Due to this vehicle's low liftto-drag ratio aerodynamic configuration, the landing velocity exceeded 320 kmph, compared to 260 kmph for a commercial aircraft and 280 kmph for a typical fighter aircraft, it added.

ISRO said, after touchdown, the vehicle velocity was reduced to nearly 100 kmph using its brake parachute, after which the landing gear brakes employed deceleration and stop on the runway. During this ground roll phase, Pushpak utilises its rudder and nose wheel steering system autonomously maintain a stable and precise ground roll along the runway, it said.

## Friend in need

Both India and Bangladesh stand to beneficially feed off each other with the new tranche of agreements

ew Delhi and Dhaka have signed a comprehensive bunch of collaborations that includes pledging to begin negotiations on a Comprehensive Economic Partnership Agreement (CEPA), deciding to launch a medical e-visa facility for Bangladeshis and agreeing to send a technical team to discuss the Teesta river watersharing, besides announcing the opening of an Assistant High Commission in Rangpur. Additional goodies in the bouquet include new train and bus services, export of 40 MW power to Bangladesh via the Indian grid, an inland container depot at Sirajganj and 350 training slots for Bangladeshi police officers. For India, four major imperatives have significantly driven the nation's increased strategic engagement with Bangladesh: Improving the country's economic standing, attending to the healthcare requirements of Bangladeshis, increasing India's presence in the region and attempting to counter China's increasing influence in Bangladesh. In office since 2008 and earlier heartily praised for



leading her country's economic and social development, Bangladesh's Prime Minister Sheikh Hasina is now facing difficulties in post-pandemic recovery. Her plan to use the bilateral relationship to address these issues includes the outreach to New Delhi in a major way. It makes sense that New Delhi is responding to her advances with a bit more warmth than usual this time, in part because of Beijing's looming shadow in the background. Prime Minister Narendra Modi and Bangladesh PM Sheikh Hasina deepened their partnership with a "futuristic vision" for transformative cooperation during the latter's two-day visit to India from June 21.

India holds a special place in Bangladesh's history, particularly owing to the 1971 Liberation War wherein India played a key role. However, relations between the nations became tense during military rule in the mid-1970s, marred by anti-India sentiment. But the shared history has helped forge a strong bond, with Modi's tenure since 2014 giving a new fillip to bilateral ties. Earlier, a significant shift occurred in 1996, when Hasina took over as the Prime Minister for the first time; since then, bilateral relations have steadily improved. Since 2019, the two leaders have met on 10 occasions, ushering in an era of remarkable transformation and strengthening bonds. Prime Minister Hasina, who began her fourth consecutive term in January 2024, joined six other world leaders at Modi's swearing-in ceremony on June 9, 2024. However, challenges persist, such as border management, illegal migration, the National Register of Citizens, Rohingya and river water sharing, necessitating ongoing dialogue. Bangladesh has established an island for the persecuted Rohingyas and seeks India's help in persuading Myanmar to repatriate the displaced minorities. The Modi-Hasina partnership has the potential to further cement India-Bangladesh relations, navigating these challenges and leveraging their shared vision for mutual prosperity.


Despite being marginalised in State and national politics for over two decades, Naidu is grateful for his new role. He has once again proven that one should never underestimate a politician until they are out of the game.

Moreover, e-books provide an environmentally friendly access when compared to physical books, as they reduce the demand for paper, which significantly reduces the demand for wood pulp from trees and transportation from printing facilities to distribution centres and then to bookstores or directly to consumers. Moreover, the production of physical books involves various materials and processes, including ink, chemicals and packaging materials, which can generate waste and pollution. E-books do not involve these manufacturing processes, thereby reducing the environmental footprint associated with production and waste disposal. While reading e-books requires electronic devices that consume energy, the environmental impact can be mitigated by using energy-efficient devices, renewable energy sources for charging and by considering the longer lifespan and potential reuse of electronic devices compared to physical books.



But what depresses the most is when these e-books are available on devices such as a tablet or a phone resulting in the biggest sources of distraction and thereby reducing the focused reading time. Moreover such devices also offer multimedia enhancements (like videos or interactive elements), which can either enhance or distract from the reading experience, depending on individual preferences. Some people prefer the tactile experience of physical books.

Several research and studies reflect a complex interplay of factors influencing the preference for e-books versus physical books. Physical books tend to offer better comprehension, retention and a more comfortable reading experience, while e-books provide convenience, portability and cost efficiency. The choice between the two often depends on the specific needs and preferences of the reader. Instead of immersing oneself in a book, social media browsing encourages guick, fragmented reading of short posts or articles, which can ultimately diminish the habit of sustained, deep reading. The immediate gratification and constant novelty of social media can make reading books seem less appealing or rewarding by comparison.

Even when attempting to read, the temptation to check social media notifications or browse feeds can interrupt concentration and disrupt the reading experience

It's important to note that the environmental impact of e-books versus physical books can vary depending on factors such as the energy efficiency of devices used, the source of electricity and how frequently devices are replaced but what matters is that the user also recognise the unique benefits of physical books, leading to a balanced approach where both formats coexist in their reading habits.

There's no better way to learn, evolve and relax than reading books.

High costs, allegations of corruption and systemic inefficiencies underscore the need for a comprehensive overhaul of the 'One Nation, One Test' policy



he country needs to go back to drawing board on centralising entrance tests as the big ones - JEE, NEET, CUET and UGC-NET - are having far too many glitches and questions raised on the

National Testing Agency (NTA).
The NEET scam and NET cancellation have shocked the youth and raises questions are as a little of the state of the st tions on credibility of the testing agency. Let the country note that within 48 hours of NEET results, four students took their own lives. Should not the country rethink on the One Nation-One Test? The tests are designed to make coaching redun-

Few have an idea of the cost of one NEET National Eligibility-cum-Entrance (Undergraduate) Test, previously called Pre-Medical Exam. It costs over Rs 400 crore borne by the parents of 2406079 candidates registered for the 2024 exam at the rate of Rs 1700 fee per applicant. The system does not say how much is the profit for NTA. It is common knowledge that no entrance fee is fully spent. Should it not be considered as a tax on the unemployed knowledge seekers!

There are approximately 108,915 MBBS seats available across 706 medical colleges for NEET 2024. Around 55,000 of these seats are in Government medical colleges; the rest are in private medical colleges. One wonders why private colleges are included which have a devious fee structure backed by severe capitation fees. The quality of faculty is also questionable. Of course, even newly set-up many State medical colleges too have such issues. Many even do not have a cardiologist or neurologist.

Add the cost of coaching, travelling and other expenses, together to cost quite a few hundred crores more, big drain on the economy plus parental and societal stress. The Kota coaching system has an estimated business of Rs 600 crore. There are reports that the UGC-NET having nine lakh aspirants was cancelled as there was paper leak. to the students' Telegram app. For NEET Rs 30-35 lakh per student was charged as alleged by a student witness, who got the paper with its answers a day before. It's possibly one of the biggest scams that spanned from Vadodara and Godhra to Patna and where not! It has sparked countrywide protests. No wonder the moves against generation of black money has not succeeded. Add to this the various recruitments stalled for scams, 13 in UP, many in West Bengal and the worst known VYAPAM in Madhya Pradesh. The irregularities are thriving with the highest jobless numbers.

The NEET scam got exposed and how parents paid Rs 66 lakhs and more. Eight students from the same examination centre in Haryana who secured all-India rank (AIR) 62 to 69, had largely similar roll numbers. A paper scam in Gujarat, featured a Vadodara-based coaching centre and at least 16 students who each paid Rs 10 lakh to pass the exam. Fresh accusations arose when news reports of a paper leak emerged only days after conduction of the competitive exam. A Godhra school teacher is accused of the NEET exam cheating scandal, Rs 7 lakh were found in his car, while cheques worth 2.50 crore were found from the office of the director of the coaching centre. Reportedly, this money was given by the students.

against any nexus found between paper setter and coaching institutes. It has rattled everyone. The reality is the NTA does not have competence to hold the examinations as many professional autonomous institutions have been doing for decades. None could raise a finger against any of them, including the All India Institute of Medical Science. They also selected students with proper aptitude. An issue that has cropped up now with many of the national institutions with CUET in particular.

The only action against weeks after the NEET fiasco has been the cancellation of the examination for grace mark students. The NTA appears to be loosely controlled organisation. The tests are gateway to careers and future professional excellence. If it is mired with malpractices and money power, the future of the nation is at stake. Would those adapting devious methods could ever have ethical bindings! The implementation is shoddy. The NTA does not conduct the tests on its own. Implementers are largely burgeoning private sector 'service providers', ÎT companies and emerging outsourcing infra organisations for conducting such mammoth tests. The competence of NTA for ensuring cyber-security at thousands of centres is doubtful.

Even invigilators and other staff are hired casually leaving the system vulnerable to attacks, pilferage and compromise. The suspicion over the countrywide coaching organisations calls for rethink on the composition of the tests. Are they giving instructions or have it emerged as the most money-minting

try do away with this organised malpractice? The examinations need to be tailored in a way that students do not need any coach-

National convenor of Sanskriti Utthan Nyas Devendra Singh has demanded cancellation of the NEET test. The Shiksha Bachao Andolan founded by Dinanath Batra and Atul Kothari also wants the test cancelled.

Too much centralisation could be breeding irregularities. It is a diverse country with diverse State boards, languages and systems. Apart each genre of professional institutions has varied needs for selections. The previous systems of selections by many professional institutions, organised by themselves have rarely raised an eyebrow.

The NTA needs structural

reforms. Conducting professionai examinations are challenge Minister for Education Dharmendra Pradhan says, "We will take the final call". The entire university system cribs over CUET — Central University Entrance Test. It forces students to take a test even for subjects, which are not in demand. The huge numbers have put off academic calendars for the past few years. Let universities conduct their own admissions as before to rid the system of over centralisation, delays and trauma to the students and their families.

The academics must put their heads together to have least of central admission examinations and more decentralised process not only to keep the process sanitised but also put India on the world map for its education, that such compromised systems sully.

## Netanyahu reiterates claim of US withholding arms despite denial

sraeli Prime Minister Israeli Filme Manual Benjamin Netanyahu told his Cabinet on Sunday that there had been a "dramatic drop" in US weapons deliveries for Israel's war effort in Gaza, doubling down on a claim that the Biden administration has denied and underscoring the growing strains between the two allies.

Netanyahu told his Cabinet that the drop had occurred four months ago, without specifying which weapons, saying only that "certain items arrived sporadically but the munitions at large remained behind."

The spat highlights how

high tensions have surged between Israel Washington over the war in Gaza, particularly surrounding the Israeli military's conduct in the beleaguered territory and the harm to civilian life there. President Joe Biden has delayed delivering

certain heavy bombs since May over those concerns, but his administration fought back last week against Netanyahu's charges that other shipments had also been affected.

Netanyahu told the Cabinet that he was driven to release a video in English last week after weeks of unsuccessful pleas with American officials to speed up deliveries. He said a resolution appeared close.

"In light of what I have heard over the past day, I hope and believe that this matter will be solved soon," he said, without elaborating.

Netanyahu's video last week sparked an uproar among critics in Israel and was met with denial and confusion from White House officials. White House national security spokesman John Kirby said the U.S. was "perplexed" by Netanyahu's claims. White House press secretary Karine Jean-Pierre

said, "We generally do not know what he's talking

His remarks came hours after Israeli Defense Minister Yoav Gallant traveled to Washington for meetings with senior officials. A statement from Gallant's office said he would discuss "maintaining Israel's qualitative edge in the region" but made no mention of the weapons

The war in Gaza, which was sparked by Hamas' Oct. attack on southern Israel, has tested the US-Israel relationship like never before. While the US has staunchly supported Israel's aims of freeing hostages taken into Gaza and defeating Hamas, it has grown increasingly concerned over the rising Palestinian death toll and the humanitarian crisis created by the war.

Biden has felt pressure from progressive Democrats to take a tougher line against

Israel, and he has sharpened his warnings to Netanyahu over military tactics in the Gaza Strip. But after threatening to impose a more sweeping ban on arms transfers over an assault on Rafah, the administration has avoided any suggestion that Israel's expanding push into the southern Gaza city has crossed a red line.During an election year, Biden is also facing critics on the right who say he has moderated his support for an essential Mideast ally.For Netanyahu, the growing daylight with the US also poses political risks and opportunities. His critics see the public spats as the result of a leader prepared to wreck important alliances and tarnish Israel's image in the world for political gain. ready to come to Lebanon to join with the militant Hezbollah group in its battle with Israel if the simmering conflict escalates into a full-blown war, officials with Iranbacked factions and analysts say.

Almost daily exchanges of fire have occurred along Lebanon's frontier with northern Israel since fighters from the Hamas-controlled Gaza Strip staged a bloody assault on southern Israel in early October that set off a war in Gaza. The situation to the north worsened this month after an Israeli airstrike killed a senior Hezbollah military commander in southern Lebanon. Hezbollah retaliated by firing hundreds of rockets and explosive drones into northern Israel.

Israeli officials have threatened a military offensive in Lebanon if there is no negotiated end to push Hezbollah away from the border.

Over the past decade, Iran-backed fighters from Lebanon, Iraq, Afghanistan favour of Syrian President Bashar Assad. Officials from Iran-backed groups say they could also join together again against Hezbollah leader Hassan Nasrallah said

in a speech Wednesday that militant leaders from Iran, Iraq, Syria, Yemen and other countries have previously offered to send tens of thousands of fighters to help Hezbollah, but he said the group already has more than 100,000 fighters.

We told them, thank you, but we are overwhelmed by the numbers we have," Nasrallah said

Nasrallah said the battle in its current form is using only a portion of Hezbollah's manpower, an apparent reference to the specialised fighters who fire missiles and

But that could change in the event of an all-out war. Nasrallah hinted at that possibility in a speech in 2017 in which he said fighters from Iran, Iraq, Yemen, Afghanistan and Pakistan "will be partners" of such a war.

Officials from Lebanese and Iraqi groups backed by Iran say Iran-backed fighters from around the region will join in if war erupts on the the Lebanon-Israel border. Thousands of such fighters are already deployed in Syria and could easily slip through the porous and unmarked bor-

Some of the groups have already staged attacks on Israel and its allies since the Israel-Hamas war started October 7. The groups from the so-called "axis of resistance" say they are using a "unity of arenas strategy" and they will only stop fighting when Israel ends its offensive in Gaza against their ally, Hamas.



Labour Party in all pre-election opinion polls, after his director of campaigns, Tony Lee, and his Tory MP candidate wife, Laura Saunders, were named earlier in the election date betting investiga-

It followed reports of Sunak's close protection officer being arrested by the Metropolitan Police on suspicion of misconduct over placing an election date bet and Sunak's parliamentary aide, Tory MP candidate Craig Williams, also under investigation.

While betting is legal in the UK, any bets placed with the advantage of insider information could fall within the purview of illegality. "There are multiple investigations happening. It's right they're allowed to proceed. They're independent and necessarily confidential," Sunak told

## 'New military offensive against terrorism to be discussed in Pakistan Parliament'

Pakistan Defence Minister Khawaja Asif on Sunday announced to consult the parliament over the issue of a fresh military offensive against terrorists after former prime minister Imran Khan's party demanded that any new operation should be discussed in the highest forum. The decision to launch 'Azm-e-Istehkam' operation was taken on Saturday at the apex committee meeting of the National Action Plan, a strategy approved in 2014 to eliminate militancy from the country.

A day after the plan was announced, lawmakers from the Pakistan Tehreek-i-Insaf (PTI) said the matter should have been discussed in Parliament which was the highest forum to decide about any new operation. The Minister first criticised the PTI by say-

ing that the party's chief minister of Khyber Pakhtunkhwa (KP) was present in the meeting when the decision was taken, but later also announced that the matter would be placed before the parliament.
"We will also bring this issue to

the (Parliament) House where debate will be held on this topic. If they have any objection, when this issue comes to this House, then they can also speak on it," he said. Khawaja also accused the PTI of siding with terrorists. 'They (PTI) are standing with

the terrorists by protesting here today. They are protesting against the martyrs of the Pakistan Army and the army that is still making sacrifices against terrorism," he said. He also said that the PTI leadership had not backed off from the May 9 stance when the party supporters attacked military installations, as he lambasted the party for changing its stance to serve its interests. Earlier, speaking to the media outside Parliament House, PTI chief Gohar Khan demanded that only parliament was empowered to take a decision

on military operations.
"It is our demand that if there is any operation - whether intelligence-based or fullfledged or in certain districts or villages or tehsils — it is necessary to take this Parliament into confidence," he said, adding that no matter how empowered a committee was, it could not supersede Parliament.

Former speaker and PTI leader Asad Qaiser repeated the same demand

'I simply demand that if any decision has been taken about operation, then it be brought before Parliament and Parliament be taken into con-

## Philippines stands firm after clash with Chinese Coast Guard, aims to avoid war

The president of the Philippines said Sunday his country would not yield to "any foreign power" after Chinese sonnel and damaged at least two military boats with machetes, axes and hammers in a clash in the disputed South China Sea, but added the Philippines would never instigate a war. President Ferdinand Marcos Jr. flew with his top generals and defence chief to the western island province of Palawan, which faces the South China Sea, to meet and award medals to navy personnel who came under assault by the Chinese coast guard Monday as they attempted to deliver food and other supplies to an outpost on the hotly contested Second Thomas Shoal. Videos and pictures of the chaotic face-off made public by the military showed Chinese coast guard personnel hitting a Philippine navy boat with a wooden bar and seizing a bag while blaring sirens and using blinding strobe lights. The Chinese government said

that its coast guard had to take action after Filipino forces defied warnings not to stray into what China calls its own offshore territory, a claim long rejected by rival claimant governments and

The violent confrontation sparked condemnation and alarm from the US, the European Union, Japan, Australia and other Western and Asian nations, while China and the Philippines blamed each other for instigating it. Marcos's key advisers said Friday that his administration has no plan to invoke the country's mutual defence treaty with the United States."We are not in the business to instigate wars," Marcos told Filipino forces. "In defending the nation, we stay true to our Filipino nature that we would like to settle all these issues peacefully."

In Monday's face-off at the shoal, Marcos said "we made a conscious and deliberate choice to remain in the path of peace." The Filipino navy special operations group personnel who came under attack used only their bare hands to push back the Chinese,

some of whom pointed knives at them, said Philippine military chief Gen. Romeo Brawner Jr.

## One more victim dies day after Arkansas grocery store shooting

**Little Rock (AP):** Police said a fourth victim has died a day after a shooter opened fire at an Arkansas grocery store, wounding nine others and riddling cars with bullet holes as bled for cover.

The person died Saturday evening, Arkansas state police said in a statement, listing a total of 14 people as hit by gunfire: "11 civilians, two law enforcement officers and the suspect.

The dead were identified as Shirley Taylor, 62, Callie Weems, 23, Roy Sturgis, 50, and Ellen Shrum, 81 — "all civilians," according to the statement.

The wounded range in age between 20 and 65, police said. Four were still hospitalised, including a woman who was in critical condition.

The wounded agents were identified as Fordyce Police Officer James Johnson, 31, who was released from a hospital Saturday evening, and Stuttgart Police Officer John Hudson, 24, whose injuries

Her response: "Stay tuned." But since making that comment in March, after she and Donald Trump voted in Florida's primary, Melania Trump has largely refrained from public appearances. The few exceptions have included a couple of fundraisers in April and their son's high school graduation. The former first lady noticeably did not accompany the presumptive Republican presidential nominee on any of the days of his more than month-

Sirens blared at 2 am in Rock Valley, Iowa, population 4,200, where people in hundreds of homes were told to get out as the Rock River could no longer take rain that has slammed the region. The city lacked running water because wells were unusable. Mayor Kevin Van Otterloo said a state helicopter was on its way to help but was called off when boats were able to reach stranded residents. "We've had so much rain here," he said. "We had 4 inches last night in an hour and a half time. Our ground just cannot take anymore.'

Gov. Kim Reynolds declared a disaster for 21 counties in northern Iowa, including Sioux County, which includes Rock

Valley. In drone video posted by the local sheriff, no streets were visible, just roofs and treetops poking above the water. In South Dakota, Gov. Kristi Noem declared an emergency after the southeastern part of the state received heavy rainfall. The town of Canton, 30 miles (48 kilometres) southeast of Sioux Falls, has received 18 inches (45.72 centimetres) of rain. Several highways were closed, including a key stretch of Interstate 29 south of Sioux Falls that later reopened. Sioux Falls, the state's largest city, had more than 7 inches (17.7 centimetres) of rain in three days. "Even though the rain is slowing down, we need to keep vigilant," said Noem. "The worst of the flooding along our rivers will be Monday and Tuesday." Elsewhere in the US, the mis-

## PTI-backed SIC not entitled to reserved seats'

PTI ISLAMABAD

ailed former prime minister Imran Khan's party-backed Sunni Ittehad Council is not eligible for reserved seats as the party does not allow non-Muslims to be a part of it, Pakistan's election commission has said in a response submitted to the Supreme Court, according to media reports.

The Election Commission of Pakistan (ECP) on Saturday filed a reply before the Supreme Court to the Sunni Ittehad Council (SIC) plea against the rejection of its claim on reserved seats for women and minorities in the national and provincial assemblies after the general election.

The ECP said that reserved seats cannot be allocated to the SIC, which is backed by 71vear-old Khan's Pakistan Tehreek-e-Insaf (PTI), as the party failed to submit the list of nominees for the reserved seats by the deadline of December 24, Geo News reported.

The top polls body added that as per the SIC constitution, a non-Muslim person cannot be a part of the party, which is unconstitutional.

"According to the constitution of the SIC, a non-Muslim cannot become a member of the party. The provision against the

inclusion of non-Muslims in the constitution of SIC is unconstitutional. The SIC is not entitled to reserved seats for women and minorities," the election watchdog said.

It added that the independent candidates joined the SIC after the elections, after which the ECP gave the majority 4-1 verdict of not allocating the reserved seats to the party, and later the Peshawar High Court (PHC) upheld the ruling. "SIC is not eligible for the reserved seats. There is nothing wrong with the ECP and the PHC's decision of not giving reserved seats to SIC. The decision is in line with the laws and Constitution," the ECP said, according to the report. There are 70 reserved seats in the National Assembly and another 156 in the four provincial assemblies, and the SIC was

 $A^{ ext{China-backed pipeline that}}$  would make Niger an oilexporting country is being threatened by an internal security crisis and a diplomatic dispute with neighbouring Benin, both as a result of last year's coup that toppled the West African nation's democratic government.

The 1,930-kilometer (1,200mile) pipeline runs from Niger's Chinese-built Agadem oil field to the port of Cotonou in Benin. It was designed to help the oil-rich but landlocked Niger achieve an almost fivefold increase in oil production through a USD 400 million deal signed in April with China's state-run national

petroleum company. But it has been stalled by several challenges, including the diplomatic disagreement with Benin that led to the pipeline's closure last week. There also has been an attack this week by the local Patriotic Liberation Front rebel group, which claimed to have disabled a part of the pipeline and is threatening more attacks if the USD 400 million deal with China isn't cancelled.

Mahmoud, a former rebel leader, took up arms after Niger's junta came to power, posing further security threats to the country, which is already struggling with a deadly security crisis.

Analysts say the crises could further hurt Niger, one of the world's poorest countries which funds most of its budget with now-withheld external support in the aftermath of the coup. ## 23 held for tourist's lynching in Pak's Swat

**D**akistan police have arrested more than 20 people for alleged involvement in the lynching of a tourist in the pic-turesque town of Swat for allegedly desecrating the Quran, media reports said here on Sunday. Muhammad Ismail, a 40-year-old resident of Sialkot in Punjab province, was gunned down by an enraged mob which dragged him through the town and later hanged him in full public view in Madyan tehsil of Swat district in Khyber Pakhtunkhwa province on Thursday. The mob had also set the Madyan police station

Ismail was accused of having burnt the pages of Islam's holy book. Five police personnel and 11 locals were injured in the incident. Police arrested 23 people for alleged involvement in Ismail's lynching and the arson attack on the Madyan police station, Geo News reported.

Those arrested were shifted to an undisclosed location while

others involved in the incident, police said.

Members of the mob had been identified, and "efforts for their arrest are underway," the report said, quoting Swat District Police Officer (DPO) Syed Zaman Shah.

He said that two first information reports (FIR) had also been registered under the charges of blasphemy and damaging state property, respectively. He added that the suspect was reportedly a drug addict and had been booked in a case of domestic violence on his mother's complaint.

On Saturday, Pakistan's Planning Minister Ahsan Iqbal condemned the lynching, lamenting how religion is being weaponised to justify "street justice" and "vigilantism." "We must take notice of this

incident as our nation is on the brink. We have now reached a point where we are using religion to justify mob violence and street justice, flagrantly violating the Constitution, the law and the state," Iqbal said.

Colombo (PTI) Sri Lankan Foreign Minister Ali Sabry has hailed the decision of the UK government to continue to maintain the LTTE under the proscribed list, saying that the move will thwart every plan of the former armed group to revive itself in the island nation.

In a post on the social media platform X, Sabry said that the Liberation Tigers of Tamil Eelam's (LTTE) international network's approach and strategy is to get foreign governments to deproscribd it so that they could revive the group once again. The decision by the UK authorities to carry on with Sri Lanka's LTTE under the proscribed list has thwarted the group's plans to revive them in Sri Lanka, Sabry said in his post on X.

## Ukrainian attack leaves 4 With its new pact with N Korea, Russia raises stakes with West dead in Russia, Crimea

Russian authorities said four people died in Ukrainian drone and missile attacks on Sunday, a day after Russia's bombing of Ukraine's second largest city of Kharkiv killed three people and left dozens in hospitals. Three people including two children — were killed by falling debris when five Ukrainian missiles were shot down in Sevastopol, a port city in Russia-annexed Crimea, said Mikhail Razvozhayev, the city's Moscow-installed governor. Close to a hundred people were injured, he said. One person was killed and three injured in Russia's Belgorod region, bordering Ukraine, when three Ukrainian drones attacked the city of Grayvoron, regional Gov. Vvacheslav Gladkov said. Air defenses overnight shot

down 33 Ukrainian drones over Russia's western Bryansk Smolensk, Lipetsk and Tula regions, the Russian Ministry of Defense said Sunday. No casualties or damage were reported The attacks came after Russia struck Kharkiv on Saturday afternoon with four aerial bombs, hitting a five-story residential building and killing three people. Regional Gov. Oleh Syniehubov said that 41 people were still being treated for injuries on Sunday.

In a video address following the attack, Ukrainian President Volodymyr Zelenskyy urged Ukraine's partners to bolster its air defenses. "Modern air defense systems for Ukraine such as Patriots, accelerated training of our pilots for F-16s, and most importantly, sufficient range for our weapons are truly necessary," he said.

Behind the smiles, the balloons and the red-carpet pageantry of President Vladimir Putin's visit to North Korea last week, a strong signal came through: In the spiralling confrontation with the US and its allies over Ukraine, the Russian leader is willing to challenge Western interests like never before. The pact that he signed with

North Korean leader Kim Jong Un envisions mutual military assistance between Moscow and Pyongyang if either is attacked. Putin announced for the first time that Russia could provide weapons to the isolated country, a move that could destabilise the Korean Peninsula and reverberate far beyond. He described the potential arms shipments as a response to NATO allies providing

Ukraine with longer-range weapons to attack Russia. He bluntly declared that Moscow has nothing to lose and is prepared to go "to the end" to achieve its goals in Ukraine. Putin's moves added to con-

cerns in Washington and Seoul about what they see as an alliance in which North Korea provides Moscow with badly needed munitions for its war in Ukraine in exchange for economic assistance and technology transfers that would enhance the threat posed by Kim's nuclear weapons and

missile programme. The new agreement with Pyongyang marked the strongest link between Moscow and Pyongyang since the end of the Cold War. Kim said it raised bilateral relations to the level of an alliance, while Putin was more cautious, noting the pledge of mutual military assistance mirrored a

1961 treaty between the Soviet Union and North Korea. That agreement was discarded after the Soviet collapse and replaced with a weaker one in 2000 when Putin first visited Pyongyang.

Stephen Sestanovich, senior fellow at the Council on Foreign Relations noted that when Soviet leader Nikita Khrushchev signed the deal with Pyongyang in 1961, he also tested the world's biggest nuclear bomb, built the Berlin Wall and probably started thinking about moves that led to the Cuban missile crisis in 1962. "The question for Western policymakers now is whether Putin is becoming reckless. comparably Sestanovich said in a commentary. "His language in North Korea — where he denounced the United States as a world-wide 'neocolonialist dictatorship' — might make you think

so." South Korea responded by declaring it would consider sending arms to Ukraine in a major policy change for Seoul, which so far only has sent humanitarian assistance to Kyiv under a longstanding policy of not supplying weapons to countries engaged in conflict.

Putin insisted Seoul has nothing to worry about, since the new pact only envisions military assistance in case of aggression and should act as a deterrent to prevent a conflict. He strongly warned South Korea against providing lethal weapons to Ukraine, saying it would be a "very big mistake." "If that happens, then we will also make corresponding decisions that will hardly please the current leadership of South Korea," he said. Asked whether North Korean troops could fight alongside Russian forces in Ukraine under the pact,

Putin said there was no need for that.

in the neighbouring countries. When exchange shops in La Paz ran dry last year, Bolivians waited in line all night outside the Central Bank to get hard currency.

It's a striking contrast to Bolivia's boom at the turn of the 21st century. Buoyed by a windfall of export revenue, Morales' government pulled the poverty rate down to 15 per cent, expanded the middle class and built up sprawling cities and roads.

Trouble began in 2014 when commodity prices plunged and the government dipped into its currency reserves to sustain spending. Then it drew on its gold reserves and even sold its lollar bonds locally.

'We ate up the savings and now we are scraping the pot," said Gonzalo Chávez, economics professor at Bolivia's Catholic University. With the government forking out USD 2 billion a year to import heavily subsidized gasoline in an effort to

quell public discontent, the squeeze has tightened. The Fitch rating agency in February downgraded Bolivia's debt deeper into junk territory, assigning it a CCC rating. And the fight over MAS is

exacerbating economic woes. Morales' allies in Bolivia's Congress have consistently thwarted Arce's attempts to take on debt that would relieve the pressure. Bolivia sits on a treasure trove of lithium, but lawmakers won't give Arce approval to let foreign companies extract it.

Arce calls the gridlock an "economic boycott" aimed at subverting his presidency. Seeking to ease investor fears, Finance Minister Marcelo Montenegro denies there is any crisis. But the long lines of frustrated motorists outside gas stations suggest otherwise. In recent days, angry truckers have blocked roads and burned tires. "Arce has dismantled our social organisations while abandoning his management of the economy," said Jorge Cucho, an Indigenous leader and activist. "Prices have increased by 70 per cent. Our salaries are no longer enough to go to the

The tensions tearing at MAS offer Bolivia's opposition its first real shot at power since Morales won an unprecedented electoral majority in 2005. Centrist and conservative politicians have jumped into the field. But the opposition is fractured and its legitimacy is in question, with dozens of its politicians behind bars.

## New home supply falls 13 per cent in April-June as builders launch fewer projects due to polls: PropEquity

Fresh supply of housing units is estimated to decline 13 per cent during this quarter across nine major cities with builders launching less number of projects because of the general election, according to real estate data analytic firm PropEquity.

PropEquity data shows that new housing supply in April-June is estimated to fall to 97,331 units across nine major cities as against 1,11,657 units in the year-ago period.

Pune and Hyderabad are witnessing fewer launches during this quarter while the new supply in Delhi-NCR has almost doubled.

Samir Jasuja, Chief Executive Officer & Managing Director of PropEquity, attributed the fall in new supply of housing units to the Lok Sabha election which took place in this quarter.

The new supply is 7 per cent lower from the January-March quarter of this calendar year, he added.

GSTR-1A will, however, have to be filed before filing of return in GSTR-3B for the said tax period.

This will facilitate the taxpayer to add any particulars of supply of the current tax period missed out in reporting in form GSTR-1 of the said tax period or to amend any particulars already declared in GSTR-1 of the current tax period (including those declared in IFF, for the first and second months of a quarter, if any, for quarterly

Currently, GST taxpayers file outward supply return GSTR -1 by the 11th day of the subsequent month. Taxpayers with an annual turnover of up to Rs 5 crore can file GSTR-1 quarterly within the 13th day of the end of the quarter.



No doubt, from increased psychological stress to the risk of sunburn, peak summer weather poses specific concerns for people with vitiligo. #### **NEW SAFETY MEASURES FOR TOPIRAMATE**

The UK's Medicines and Healthcare Products Regulatory Agency (MHRA) has implemented new safety measures for topiramate (sold under the brand name

Topamax) following a comprehensive safety review triggered by recent European studies. These studies highlighted increased risks associated with the use of topiramate during pregnancy, including a 2 to 3 times higher likelihood of intellectual disability, autism spectrum disorders, and attention deficit hyperactivity disorder in children born to mothers who used the drug during pregnancy. Based on recommendations from the Commission on Human Medicines (CHM), the MHRA now advises that topiramate should not be prescribed for treating epilepsy during pregnancy unless there are no suitable alternative treatments available. This caution extends previous guidance that already restricted its use during pregnancy for migraine due to known risks of birth defects.

A fghanistan pulled on an upper for epic proportions with a shock 21-run win over mighty Australia in T20 World Cup with a shock 21-run win over highly four-wicket haul fghanistan pulled off an upset Gulbadin Naib's four-wicket haul upending Pat Cummins' hat-trick to produce one of most memorable days in Afghan

Using the slower balls smartly on a difficult batting wicket, Afghanistan defended their total of 148 for six for their first-ever win over Australia in international

Australia were all out for 127 in 19.2 overs in the Super Eight contest and they are now staring at early elimination from the World Cup. Australia now must win their match against India on Monday and also hope that Afghanistan lose to Bangladesh in their next match.

Afghanistan Rahmanullah Gurbaz (60) and Ibrahim Zadran (51) forged a 118run partnership setting up base for a challenging total but Pat Cummins registered his second successive hat-trick spread across two overs to restrict Afghanistan to a manageable total. Australia were reduced to 32 for 3

Maxwell slammed a 41-ball 59 to somewhat resurrect the chase. However Naib's timely strikes proved crucial in toppling the 2021 champions.

Afghanistan exacted revenge for their defeat in Mumbai during the ODI World Cup. Maxwell had snatched victory from Aghans at that time and on Saturday too he threatened to deny them but Naib's brilliance ensured them the "It's massive win for us as a team

and as a nation. Great feeling. It's something we missed in last two years. Really happy with the win and super proud of the guys," Afghanistan skipper Rashid Khan post-match presentation.
