#### Chimps found to 'seek out' plants...

Chimpanzees sought out and ate medicinal plants to treat their injuries, according to a study. While wild chimpanzees are known to consume a variety of plant matter, researchers said it can be hard to figure out if they intentionally seek out medicinal plants to heal their ailments, or "nassively" consume plants that happen to be medicinal. The study is published in the journal PLoS ONE. At the Budongo Central Forest Reserve in Uganda, the researchers, including those at the University of Oxford, UK, observed the behaviours and health of 51 wild chimpanzees, belonging to two habituated communities. The researchers observed a male chimpanzee with an injured hand seek out and eat the leaves of a fern, which may,,,

## CM, Dy CM guide Speaker to his chair

Senior TDP leader Chintakayala Avvanna Patrudu was unanimously elected as Speaker of the Andhra Pradesh Legislative Assembly on Saturday. As Ayyanna Patrudu was the only nomination received, Pro-tem Speaker G Butchaiah Chowdary announced his unanimous election for the post.

Legislators of Telugu Desam Party (TDP) and its alliance partners Jana Sena and Bharatiya Janata Party (BJP) hailed Ayyanna Patrudu's election with the thumping of desks. Chief Minister N Chandrababu Naidu, Deputy Chief Minister Pawan Kalyan and some senior ministers guided Ayyanna Patrudu to the chair and congratulated him.

The Speaker was elected on the second day of the first Assembly

session following the formation of the government by the National Democratic Alliance (NDA). Leaders of NDA had Friday submitted nomination papers to the Secretary General of the Assembly, PPK Ramacharyulu on behalf of Ayyanna Patrudu.

Patrudu was elected from Narsipatnam Assembly constituency in Anakapalle for a seventh term in the recent elections. He is the third Speaker of the Andhra Pradesh Assembly after bifurcation. A key leader of backward classes from north-coastal Andhra Pradesh, Patrudu had also served as MP from Anakapalle (1996-98).

The Speaker began his political career with the TDP after it was floated by legendary actor NT

# Under-construction YSRCP central office razed **HC orders ignored:**

The Mangalagiri Tadepalli Municipal Corporation (MTMC) demolished the under-construction building of the YSR Congress Party (YSRCP) central office in Tadepalli.

Former chief minister Y.S. Jagan Mohan Reddy had controversially allocated 2 acres of irrigation land in survey number 202/A1 in Tadepalli, within the Amaravati capital area, for the party office. Allegations surfaced that Jagan Mohan Reddy planned to occupy an additional 15 acres by establishing the party office on these 2 acres.

It has now been clarified that the Irrigation Department did not grant clearance for these 2 acres to be handed over to the YSRCP. Neither the Capital Region Development Authority (CRDA), the MTMC, nor Revenue officials transferred the Irrigation Neither the Capital Region Developmen Authority (CRDA), the MTMC, nor Revenue officials transferred the Irrigation Department's land to the then-ruling party.

Department's land to the then-ruling party. Moreover, it was revealed that the YSRCP did not apply for the necessary clearances to construct the party office and had begun construction unlawfully. Upon learning of these violations, the general secretary of the Guntur district unit of the Telugu Desam Party (TDP) complained to the Commissioners of the CRDA and MTMC, demanding action against the illegal occupation of the land.

As a result, MTMC officials, acting on the complaint, supervised the demolition of the unauthorised YSRCP construction.

## Panel set up to reform exams

Amid a row over irregularities in competitive exams NEET and NET, the education ministry on Saturday notified a seven-member panel headed by former ISRO chief K Radhakrishnan

to ensure transparent, smooth and fair conduct of examinations through the National Testing Agency (NTA).

"Transparent, tamper-free and zero-error examinations are a commitment. Setting up of the high-level committee of experts is the first of a series of steps to improve the efficiency of the examination process, put an end to all possible malpractices, strengthen data security protocols and overhaul and reform the NTA," Union Education Minister Dharmendra Pradhan said.

"Students' interests and their bright future will always be our government's top priority," he added.

Former Assistant Advocate General Ponnavolu Sudhakar Reddy has clarified that while the Capital Region Development Authority (CRDA) issued the Provisional Order to the YSRCP on June 15, the order was prepared on June 10.

Speaking to the media in Hyderabad on Saturday, Reddy explained that legal arguments were presented in court on June 21, resulting in the High Court instructing officials to comply with its directives.

Reddy further noted that during its tenure from 2014 to 2019, the TDP had enacted GO 340, which allocated land for political parties to establish their offices. Emphasising continuity in law despite changes in government, he stated that th tion has similarly allocated land to the YSRCP for their office, citing GO provisions.

Regarding recent developments, Reddy highlighted a dispute wherein the Telangana Minorities Commission (TMMC) issued an order to dismantle a structure within seven days, a decision challenged by the YSRCP through an urgent court petition.

"We informed the court that demolition was imminent, asserting that under prevailing law, structures cannot be demolished until Confirmation Orders are issued," Reddy asserted, expressing dissatisfaction with the administration's handling of the matter.

"We were assured due process would be followed, but unfortunately, that commitment was not upheld," he added.

#### Diarrhoea outbreak leaves 1 dead, 30 ill in Nandyala

Tragedy struck Chabolu village in Jupadu mandal as one person succumbed to suspected diarrhoea, while 30 others, including children, fell ill.

Official reports indicate that around 30 villagers, including 12 children, experienced vomiting and diarrhoea symptoms after reportedly consuming contaminated water. They have been admitted to the government general hospital in Nandikotkur for treatment.

Regrettably, Nadipi Naganna (28) lost his life during treatment.

Family members and villagers have alleged that they have been forced to consume contaminated water due to the authorities' failure to repair drainage systems. They claim that heavy rains have leading to sewage contaminating the village's drinking water supply.

# Amarnath flays govt's actions

In response to the Greater Visakĥapatnam Municipal Corporation (GVMC)'s notice declaring the YSR Congress Party (YSRCP) office at Chinagadili Endada illegal, former minister Gudivada Amarnath strongly criticised the Andhra Pradesh coalition government, accusing it of undermining constitutional princi-

Amarnath also expressed deep disappointment over the turmoil within the new administration

just 20 days into its term. He argued that this situation undermines the patience advocated by party leader YS Jagan, who had initially suggested six months before making judgments about the new government. He assured the media that the constructions at both the Visakhapatnam and Anakapalli offices complied with

all relevant regulations. Comparing party offices to temples, Amarnath urged the people of Andhra Pradesh to stay government's actions, stressing the importance of adhering to democratic principles and ensuring fair governance.

The GVMC's Town Planning Officer for Zone-II reported that the YSRCP office was allegedly built without the necessary permits from the Visakhapatnam Metropolitan

Development (VMRDA). According to GVMC regulations, operating an office in this area without VMRDA approval is illegal. The YSRCP has been given a week to explain, failing which immediate action will be taken. This controversy has intensi-

fied following the recent change in the state government, bringing additional scrutiny to M. Sai Saran, who applied for the construction online. The Janasena party

raised alarms about various buildings in the Visakhapatnam district being constructed without proper permits, demanding their demolition. As the political landscape in Andhra Pradesh heats up, citizens are left to grapple with the implications of these developments on the state's democratic fabric.

officials bypassed established rules to secure this prime land, developed by VMRDA, under Government Order No. 759. YCP district president Karanam Dharmasri applied to the GVMC planning department to construct a lavish party office

but did not pay the required fees, leaving the plan unapproved. Legally, building on government-leased land requires fees totalling around Rs. 17 lakhs, covering gram panchayat charges, permit fees, greenery enhancement charges, DPMS user charges, and labour cess charges.

Despite these requirements, YCP leaders commenced construction, nearing completion without approval while a local court case contested the land allocation. Ramky Infra Company, owned by a YSRCP Rajya Sabha member, has undertaken the construction. Villagers from Kothuru,

Narsingaraopeta, Portu Colony, Sirasapalli, and Subrahmanya Colony have fiercely opposed the unauthorized project,

demanding its immediate halt. GVMC ACP Ramakrishna confirmed to 'The Pioneer' that the building plan remains unapproved due to non-payment of fees. Former MLA Pila Govinda Satyanarayana lodged complaints with authorities, highlighting the misuse of valuable government land. Frustrated by the lack of response, locals filed a case in the High Court in June 2023, advocating for the land to be used for a community Kalyana Mandapam instead.

In a follow-up notice on June 1, the TDP said the civic body said there was neither a response from YSRCP to the show cause notice nor any effort to regularise it and no consent was taken from

# GVMC intensifies bid to combat seasonal diseases

Commissioner CM Saikanth of Greater Visakhapatnam Municipal Corporation (GVMC) has underscored the need for a resolute campaign to shield the city from the scourge of diarrheal and seasonal diseases. Aligned with the nationwide "Stop Diarrhea" campaign launched by the Central Government, Commissioner Verma convened a review meeting with senior officials to prioritize the swift implementation of preemptive measures mandated by state directives

Commissioner Varma highlighted the importance of the two-month statewide public awareness campaign 'Stop Diarrhea', initiated by the state government. He emphasised the urgent necessity to prevent diseases such as malaria and dengue, especially with the approaching monsoon season. Engineering officials were



instructed to expedite the desilting of drains, aiming for 1,019 km of major and 2,890 km of minor drainage networks. Stressing the pivotal role of coordinated efforts among Zonal Commissioners, Engineering, and Public Health Departments within city limits, the commissioner detailed immediate action plans to address rainwater accumulation in critical areas such as corridors, highways, and coastal roads.

Furthermore, the commissioner directed supervising engineers to swiftly identify drinking water pipes passing

through sewage canals and culverts within three days, implementing measures to prevent leaks. Additionally, cleaning of water tanks across zones (246 ELSR, GLSR), rigorous water quality testing, and chlorine level checks in the water supply to colonies by secretariat volunteers were prioritized. Engineering teams were also assigned the task of clearing silt from 682 km of underground drainage systems on main and

internal roads. Chief Medical Officer Dr Naresh Kumar took charge of identifying high-risk garbage accumulation sites, overseeing improvements in public and social toilet hygiene, and conducting a comprehensive evaluation. Deputy Project Officer, UGD MVD Phaniram, received instructions to mobilize secretariat volunteers in identifying and monitoring vulnerable children under five years old, susceptible to diar-

# AP facing shortage of organ donors

PNS VISAKHAPATNAM

A critical shortage of organ donors in Andhra Pradesh has created a backlog in the state's transplant program, with 3,697 patients currently This situation highlights the limitations faced by the Jeevandan programme, a comprehensive organ transplant initiative launched by the Andhra Pradesh government. The significant disparity between the high demand for organs and their limited availability translates into lengthy wait times for patients. This shortage isn't merely inconvenient; it presents a dire health crisis, with many patients suc-cumbing to their illnesses due to the lack of a timely transplant.

Dr. K. Rambabu, the program coordinator for Jeevandan, revealed concerning data to The Pioneer. The figures indicate a substantial need for kidney transplants (2,508 patients), followed by liver transplants (1,111 patients). Additionally, 65 patients require heart transplants, and 13 await lung trans-



plants. Data from Jeevandan paints a worrying picture – a significant increase in the number of individuals across the state suffering from organ failure, particularly among younger demographics. Dr. Rambabu stated, "Nearly half of those requiring transplants are under 40 years old." He attributes this concerning trend to unhealthy lifestyle choices, including poor diet, alcohol consumption, and smoking, which contribute to organ damage in young individuals. These patients, after exhausting other treatment options, are left with the critical need for organ transplants.

The limited number of organ donors compared to the vast pool of patients in need further exacerbates the crisis. Dr. Rambabu explained the two primary methods of organ donation: deceased donation (cadaveric) and living donation. While both methods are crucial, the supply of organs continues to fall short of the ever-increasing demand.

As the number of patients waiting for transplants continues to climb, the Jeevandan program stands as a vital lifeline for those in need. However, the urgent call for more organ donors cannot be



## DC reviews 'Stop diarrhoea' programme preparedness

Additionally, he directed officials to conduct thorough biological analyses of water samples and monitor private RO water plants to maintain water quality standards. In light of potential health risks, he advised residents to boil water before consumption.

# Will TDP govt be able to revitalise tribal welfare?

In a bold initiative aimed at prioritizing tribal welfare, the Integrated Tribal Development Agencies (ITDAs) are poised for a sweeping revitalization under the TDP coalition government. This move follows years of neglect and mismanagement during the previous YCP administration, which left tribal communities in Parvathipuram Seethampet reeling from substantial setbacks.

During the YCP government's tenure, ITDAs experienced a precipitous decline in operational efficacy. Critical funds earmarked for tribal development were diverted, severely hampering the agencies' ability to meet even the most basic needs of the community. A glaring failure during the YCP regime was the gross neglect of mandatory ITDA governing body meetings. These assemblies are crucial for addressing local issues and driving forward developmental initiatives. Shockingly, in the past half-decade, only two such meetings were convened in Seethampeta Parvathipuram—far below the required frequency. This significant oversight severely impeded progress and perpetuated a cycle of underdevelopment in tribal regions.

The adverse impacts of the YCP's fiscal policies extended beyond mere neglect. Drastic funding cuts decimated critical sectors central to tribal livelihoods, such as agriculture and horticulture. Subsidies for loans and agricultural equipment were abruptly terminated, stalling progress across multiple departments and exacerbating economic disparities within tribal communities.

Compounding these issues, essential services provided by ITDAs, including hostels for pregnant tribal women and transportation for healthcare personnel, faced chronic delays and operational challenges. These failures underscored the administration's disregard for the basic needs of tribal populations, leaving crucial health and welfare services in disarray.

With the recent change in administration, however, district residents are now cautiously optimistic about the future of ITDAs. Minister of Tribal Affairs, Gummidi Sandhyarani, a respected native of Manyam district, has pledged a comprehensive revival of these vital agencies. Plans are already in motion to reinstate regular governing meetings Parvathipuram Seethampet, signaling a renewed commitment to addressing longstanding trib-

al issues head-on. Minister Sandhyarani affirmed, "We are steadfast in our mission to restore the effectiveness of ITDAs and ensure holistic development for tribal communities." Her proactive stance marks a definitive departure from past inertia, promising a new era of accountability and empowerment in tribal governance.

# Fear grips AP coast as fishing boat fires rise

The azure waters off the coast of Andhra Pradesh, once a thriving source of livelihood for generations of fishermen, have become shrouded in an unsettling fear. Over the past year, a series of fire incidents involving fishing boats, culminating in a devastating blaze that ravaged over 40 vessels in Visakhapatnam harbour, has highlighted the precarious working conditions of these seafarers. Despite these harrowing episodes, a disturbing number of vessels in the state remain ill-equipped with basic life-saving and fire-fighting apparatus. fire-related accidents



Andhra Pradesh boasts a fleet of over 2,500 mechanized fishing boats, each capable of storing more than 5,000 litres of fuel. Within Vizag fishing harbour alone, around 700 boats are docked. Regulatory mandates insist these vessels be outfitted with navigational, life-saving, and fire-fighting equipment. However, a significant proportion of these boats

sail without essential safety gear such as portable fire extinguishers, power or hand-operated pumps, and fireman's axes.

"We are urging the authorities to intervene," pleads Vasupalli Janaki Ram, president of the AP Mechanised Fishing Boat Operator's Association. He emphasizes the urgent need for a comprehensive solution.

# Take steps to curb outbreak of dengue diarrhoea, officials told

West Godavari District Collector Sumit Kumar has directed the officials to take precautionary steps to contain the outbreak of dengue and diarrhoea in the district.

Collector Sumit Kumar held a meeting with the officials of the RWs, MPDO, EOPRD and Panchayat Raj through video conference on Saturday and reviewed the steps being taken to curb the seasonal disease. Speaking on the occasion, the District Collector said that the OHSR tanks should be cleaned regularly once every 15 days and the Panchayat Secretary should hand over the certificate.

He also told the officials to monitor whether drinking water samples are tested in the relevant lab and instructed the officials to take steps to repair the OHRS tank staircase panels, adding that small animals like birds may fall into the tank.

The Collector said that the tank cleaning tablets are available for cleaning the tanks and Rs 20,000 should be given to the MPDOs for cleaning the tanks in the mandal. It is pointed out that chlorination with bleaching causes other

problems. "The MPDO, EV PRD and Panchayat Secretaries were directed to monitor sanitation every day. There is a lack of panchayat secretaries' supervision resulting in all roads looking like a garbage dumping yard in all villages, the

Collector expressed anger. The Panchayat Secretaries and EO PRD should identify the areas where garbage is accumulating and take steps to move it.

Collector Sumit Kumar said that if the leakages of drinking water pipes are not stopped, the drinking water would be contaminated leading to the outbreak of diarrhea.

Steps should be taken to stop the leakages immediately, he ordered the officials and directed the MPDO to take immediate action in this regard as the people of the suburbs are suffering from irrigation water shortage due to the pumping of water by motors in the Mogalthur area.

If there are leakages in the pipelines, there is a scope for water contamination and the leakages must be plugged immediately, the Collector instructed the officials. From July 1 to August 31 campaign programmes on diarrhea control should be conducted and awareness among people about diarrhea control should also be created, he told the officials.

Steps should also be taken to provide treatment if people suf-fer from diarrhoea. If diarrhoea cases are registered in the government hospital or private hospitals, the data should be examined and action should be taken immediately. # Govt, opposition face-off on protem Speaker issue

Ahead of the first session of the 18th Lok Sabha, the NDA government and the INDIA bloc sparred on the issue of Pro-tem Speaker with Parliamentary Affairs Minister Kiren Rijiju accusing the Congress of resorting to lies and the opposition threatening to refuse to join the panel of chairpersons in the House.

President Droupadi Murmu had appointed BJP leader and seven-term member Bhartruhari Mahtab as the Pro-tem Speaker of the Lok Sabha, who is tasked with administering the oath and affirmation to the newly-elected members of the lower house and preside over the election of the Speaker.

The President had also named five senior members - "K Suresh (Congress), T R Baalu (DMK), Radha Mohan Singh and Faggan Singh Kulaste (both BJP) and Sudip Bandyopadhyay (TMC) to assist Mahtab in the process that will take place over the first three days of the Lok Sabha Session commencing on June 24.

The Congress had alleged that the government has violated procedures and conven-



tions and ignored the right of eight-term member Suresh to the post of the pro-tem Speaker, a claim dismissed as "misleading" by Rijiju.

On Saturday, opposition sources said Suresh, Baalu and Bandyopadhyay may not join the panel of chairpersons to assist pro-tem Speaker Mahtab in administering the oath to the newly elected members of the Lok Sabha.

Rijiju had asserted that Mahtab was the senior-most in the House as he was elected for seven uninterrupted terms to the Lok Sabha, while Suresh, though a eight-term member, was not a member in 1998 and

Suresh had said his claim to the post of pro-tem speaker Minister Narendra Modi ji's mantra of Sabka Saath Sabka Vikas," he said.

Earlier, Congress leader K C Venugopal had described the overlooking of Suresh's claim to the Pro-tem Speaker post as an attempt at "destroying parliamentary norms".

"I have said this before and say this now, the battle for saving our democracy and constitution isn't over yet," Shiv Sena leader Aditya Thackeray said in a post on X.

#### UAPA tribunal confirms ban on Tehreek-e-Hurriyat

A tribunal set up under the Unlawful Activities (Prevention) Act (UAPA) on Saturday confirmed the Centre's decision to impose a five-year ban on the Muslim (Masarat Alam faction) and Tehreek-e-Hurriyat, Jammu and Kashmir.

The one-member tribunal of Delhi High Court judge Sachin Datta was constituted under the stringent anti-terror law in January to assess whether there was "sufficient cause" behind the imposition of the ban.

Upholding the ban, the tribunal held the two organisations were carrying out secessionist activities in the valley with help from across merger of Jammu and Kashmir with Pakistan and establish Islamic rule in the Union Territory. The tribunal also upheld the Centre's contention that the organisations were acting on behalf of Pakistan-based terrorist organisations such as Lashkare-Taiba (LeT) and Hizbul Mujahideen, and were giving constant on ground support for carrying out militant operations in the valley.

The FTI-TTP is similar to the Global Entry Program offered by the United States that allows expedited clearance for pre-approved, lowrisk travellers upon arrival at select US airports, officials said.

The home minister said the initiative will provide

more facilities for the Indian nationals and OCI passengers coming from other countries.

The launch of the programme is one of the key agendas set for "Viksit Bharat by 2047" and reflects the Narendra Modi government's commitment to enhance travel convenience and efficiency for everyone, he added.

Shah said the facility will be available free of cost for all passengers.

The FTI-TTP will be launched at 21 major airports in the country.

In the first phase, along with the Delhi airport, it will be launched at seven major airports -- Mumbai, Chennai, Kolkata, Bengaluru, Hyderabad, Kochi and Ahmedabad.

It is designed for faster, smoother and safer immigration clearance for international travellers.

"Earlier the Bills had been bulldozed through the Standing Committee on Home Affairs without detailed interactions with stakeholders across the country and completely ignoring the written and very detailed dissent notes of a number of MPs belonging to different political parties, including the Indian National Congress, who were members of the Standing Committee," he said.

Ramesh said the three new laws are to come into effect from July 1, 2024, and the Congress is of the firm opinion that the date should be deferred to enable a thorough review and re-examination of the laws by the reconstituted Standing Committee on Home Affairs

#### Expects retail prices to ease with normal monsoon

PNS NEW DELHI

The government has bought nearly 71,000 tonnes of onion so far this year for buffer stock, out of the total target of procuring 5 lakh tonnes for price stabilisation and it expects retail prices to ease with the progress of monsoon over most parts of the country.

According to data compiled by the department of consumer affairs, the all-India average onion retail prices stood at Rs 38.67 per kg on Friday, while the modal price was Rs 40 per kg. Till June 20th, the Centre has procured

70,987 tonnes of onion, as against 74,071 tonnes procured in the same period last year, a senior official in the department of consumer affairs said.

"The pace of onion procurement for price stabilisation buffer this year is largey comparable with last year, despite about 20 per cent decline in estimated rabi production," the official said, adding that

the government is on course to achieve tar-



geted procurement of 5 lakh tonnes for price stabilisation.

The government will exercise the option of holding or releasing onions from the buffer in order to maintain stability in prices of onion, the official said. The procurement price is a dynamic

one, linked to prevailing market prices. The increase in prices of onion is on account of a shortfall in production in 2023-24 by about 20 per cent each in Kharif, late Kharif and Rabi, over the previous year due to less rains in major producing areas, the offi-

To control prices, the government has been taking measures in a graded manner, from August last year starting with export duty of 40 per cent, followed by Minimum Export Price (MEP) of USD 800 per tonne in October, 2024 and imposition of export prohibition from

December 8, 2023 These measures have helped in maintaining domestic availabil-

ity of onion at reasonably stable prices. Export prohibition had been lifted from May 4, 2024 with MEP of USD 550 per tonne and 40 per cent export duty in view of substantial stability observed in major mandis like Lasalgaon, in Maharashtra and the prospect of good Kharif production on the back of abovenormal monsoon prediction this year.

The prolonged and extreme heatwave condition currently prevailing over large parts of the country has impacted.

#### CNG price in Delhi, adjoining cities hiked by Re 1 per kg

CNG price in Delhi and adjoining cities was on Saturday hiked by Re 1 per kg following a drop in the supply of subsidised input natural

Indraprastha Gas Ltd, the firm that retails CNG automobiles and piped cooking gas to households in Delhi and adjoining cities, announced the hike in rates on its website.

In New Delhi, CNG will now cost Rs 75.09 per kg, up from the previous rate of Rs 74.09. In Noida, Greater Noida, and Ghaziabad, the price has increased to Rs 79.70 per kg from Rs 78.70 per kg. There, however, was no

change in piped cooking gas

IGL did not give reasons for the increase but sources said the hike was warranted because the firm now has to buy more imported gas follow-

Natural gas pumped out of the ground and seabed is turned into CNG for running automobiles. But supplies from ONGC's domestic fields have not kept pace with the CNG demand.

Gas from ONGC fields make up for 66-67 per cent of CNG demand of IGL. The rest has to be imported.

Domestic gas supplies are prioritized for piped cooking gas purposes and so there is no hike in that segment, sources said

However, there has been no change in CNG prices in Gurugram, as it is serviced by

a different company.

Other city gas retailers have so far not announced any change in prices.



At the end of Nakamise-d?ri is the temple itself. The 55m-high five storey Pagoda is a sight to behold. Walk to the eastern

edge of the temple complex.

Here you will see Asakusa

Jinja, a shrine built in honour of the brothers who discovered the Kannon statue that inspired the construction of Sens?-ji. Immerse yourself in a vibrant

atmosphere adorned with colorful hanging lanterns. Have a look at various temples and then walk towards Nakamise bustling market that offers a delightful array of traditional Japanese snacks and souvenirs. And yes, don't forget to make a wish at the famous Senso-ji Thunder Gate!

The shrine occupies only a small fraction of the sprawling forested grounds, which contain some 120,000 trees collected from all over Japan. Of this, only the strolling garden Meiji-jing? Gyoen is accessible to the public. It is said that The Meiji emperor himself designed the iris garden here to please the empress and the garden is at its best when the irises bloom

Ceremony If you are not exhausted after lunch, I suggest attend a beautiful tea ceremony at Happo-en. Where on earth you will get to immerse in a real Zen garden in the heart of Tokyo? 

The critical nature of water is further underscored by its finite availability and the essential roles it plays in maintaining ecosystems, supporting economic activities, and ensuring human health and wellbeing.

rise and climate change intensifies, the pressure on our water resources is mounting, highlighting the urgent need for sustainable management and conservation practices. The significance of water cannot be overstated; it is the lifeblood of our planet, making the stewardship of this precious resource a paramount concern for all.

Securing water resources is paramount because, unlike energy, there are no alternative sources for water. It is an imperative that transcends environmental and geopolitical boundaries. We are often guided by the same motivations and methodologies in water related matters like we do for energy. However, unlike energy, which could benefit from a diverse array of alternative sources, water remains singular in its indispensability and irreplaceability. Energy resources can be substituted, green sources for fossil fuel, solar for coal, nuclear power for thermal power and so on. The situation is quite different when it comes to water.

The total volume of water present on planet earth is constant. If we discount the amount of water contained in meteors, water does not come to this planet in any significant form. Our exorbitant exploitation of this natural reserve is making water ratio available for human diminish alarmingly.

Alternative energy resources like wind energy, solar energy, have become quite reliable alternatives to the traditional fossil fuels. These alternative energy sources do provide pollution free and sustainable means for the planet's energy needs. We can use ethanol for petrol or mixture of both and it still works. In contrast, water has no such alternatives. These renewable sources are diverse and abundant, enabling a flexible and resilient energy supply system. There is no renewable or alternative water that can replace the freshwater required for drinking, sanitation, agriculture, and industrial

processes. This stark difference underscores the critical nature of water and the imperative to manage While advancements in technology

have enabled us to harness the power



of the sun and wind, the same cannot be said for creating new sources of water. Thus, the focus must be on conserving and efficiently managing the water we have, ensuring its availability for future

generations. The absence of viable substitutes for water underscores the urgency of safeguarding our existing supplies through comprehensive, integrated approach encompassing the demand side and also the supply sides of the equation. Ensuring water security involves not only protecting the quality and quantity of freshwater sources but also includes improvements and in the water supply, transmission, sanitation infrastructure to withstand the impacts of climate change and population growth. This requires coordinated efforts at all levels of governance to commit and deploy far reaching policy reforms, technological innovations, and community engagement.

The stakes are high, as the failure to secure water resources could lead to severe social, economic, and environmental consequences. Let's convince ourselves and decide to call water not as water resource but water reserves.

According to a US geological survey the total water reserves on this planet is 1.36 billion kms. Out of this only 2.5 per cent is freshwater and out of that 0.3 per cent is liquid while the rest is frozen in glaciers and poles. Scarcity of water is actually scarcity of access to water reserves, which is pervasive. As per UN estimates around two billion people suffer from some form of water stress. This number is only going to increase in near future.

In the Middle East and North Africa, the annual per capita water availability is less than 500 cubic meters, far below the threshold for water access. Similarly, in Sub-Saharan Africa, recurrent droughts exacerbate the already limited access to safe drinking water, affecting both rural and urban populations.

The world's most populous countries, India and Chinaface significant challenges due to the over-extraction of groundwater depletion and water reserve contamination. In Chennai, the situation turned dire in 2019 when the city's reservoirs dried up, leading to a severe drought. This crisis was exacerbated by delayed monsoons and overdependence on groundwater, prompting emergency measures like water tankers and rationing. Bengaluru's crisis this year in April needs no reminder. The local impacts of water reserve access are profound and varied, affecting communities in different ways depending on their geographic, economic, and social contexts. In regions like California in the United States, prolonged droughts have led to severe water restrictions, affecting agricultural productivity and leading to economic

In India, the state of Maharashtra has experienced recurrent droughts, leading to crop failures and driving rural-tourban migration as farmers seek alternative livelihoods. These local impacts highlight the interconnectedness of water scarcity with other critical issues such as food security, economic stability, and social cohesion.

Overuse and mismanagement of water reserves are primary drivers of water scarcity. In agriculture, inefficient irrigation practices lead to significant water wastage. For example, traditional flood irrigation methods can lose up to 50 per cent of water to evaporation and runoff. Transitioning to more efficient methods, such as drip irrigation, can substantially reduce water use while maintaining crop yields. In industry, water is often used in large quantities for processes such as cooling, cleaning, and manufacturing. Without proper recycling and reuse strategies, this water is discharged as waste, contributing to the depletion of local water reserve sources. Household mismanagement also plays a role, with excessive water use for

activities such as lawn watering, car washing, and inefficient fixtures leading to unnecessary wastage. Addressing these issues requires a multifaceted approach that includes technological innovation, regulatory measures, and public awareness campaigns to promote more sustainable water use practices

across all sectors. Climate change has a profound impact on global water cycles, exacerbating water reserve access scarcity and contributing to the depletion of freshwater reserves. Rising temperatures lead to increased evaporation rates, reducing the availability of surface water in lakes, rivers, and reservoirs. There may be increased rainfall and flooding which sometime increases the chances of contamination of water supplies and infrastructure damage. The variability and unpredictability of climate change's effects on water availability necessitate adaptive management strategies that can respond to these changing conditions. This includes enhancing water storage infrastructure, improving water use efficiency, and developing robust monitoring and forecasting systems to better manage water resources in a changing climate.

In many developing countries, inadequate sanitation infrastructure exacerbates the problem, leading to widespread contamination of drinking water reserves. Addressing water pollution requires stringent regulatory measures to control industrial emissions, promote sustainable agricultural practices, and improve waste management systems. Further, increasing the expenditure in water treatment methods may help mitigate the problem. Public awareness and education campaigns are also crucial

in promoting responsible behaviour and reducing pollution at the reserve source. The health and well-being of communities depend on the availability of clean and safe water, making the

prevention and mitigation of water reserve pollution which is a critical component of water reserve

management. Thus, the call to action is clear: we must prioritize water reserves as a central pillar of sustainable development. Efficient water reserves management is key to tackling the problem. We have to ensure sustainable use of water resources. In agriculture, the adoption of advanced irrigation techniques, such as drip-irrigation and sprinkler based systems, can significantly reduce water use while maintaining or even improving crop yields. These new and innovative technologies deliver water directly to the plant roots and reducing the overall need for water.

In the industrial sector, recycled water supply in-plant reuse policy may substantially decrease water consumption. By treating and reusing wastewater within industrial processes, companies can reduce their reliance on freshwater sources and lower their environmental impact. Household watersaving technologies, such as low-flow fixtures, dual-flush toilets, and rainwater harvesting systems, can also contribute to significant water savings. Encouraging the widespread adoption of these technologies requires supportive policies, financial incentives, and public awareness campaigns. By implementing efficient water management practices across all sectors, we can reduce water wastage, enhance water security, and promote sustainable development. All individuals, industries, and governments need to act collectively and urgently to protect and manage our water reserves. The right time to get together and respond to the call for action is right now. The water we save today is the water we generate for tomorrow.

## What the 3.2 million-year-old Lucy fossil reveals about nudity and shame

Fifty years ago, scientists discovered a nearly complete fossilized skull and hundreds of pieces of bone of a 3.2-million-year-old female specimen of the genus Australopithecus afarensis, often described as "the mother of us all." During a celebration "Lucy," after the Beatles song "Lucy in the Sky with Diamonds."

Though Lucy has solved some evolutionary riddles, her appearance remains an ancestral secret. Popular renderings dress her in thick, reddish-brown fur, with her face, hands, feet and breasts peeking out of denser thickets. This hairy picture of Lucy, it turns out, might be wrong.

Technological advancements in genetic analysis suggest that Lucy may have been naked, or at least much more thinly veiled.

According to the coevolutionary tale of humans and their lice, our immediate ancestors lost most of their body fur 3 to 4 million years ago and did not don clothing until 83,000 to 170,000 years ago.

That means that for over 2.5 million years, early humans and their ancestors were simply naked. As a philosopher, I'm interested in how modern culture influences representations of the past. And the way Lucy has been

The loss of body hair in early humans was likely influenced by a combination of factors, including thermoregulation, delayed physiological development, attracting sexual partners and warding off parasites.

Both areas of research - of when and why hominins shed their body hair and when and why they eventually got dressed emphasize the sheer size of the brain, which takes years to nurture and requires a dispro-

anaging gestational diabetes in the earlier stages of preg-Inancy could help prevent complications and improve delivery outcomes, according to researchers. Among the most common preg-

nancy complication around the world, gestational diabetes cases are on the rise and becoming more complex because of increasing obesity, said the authors of a new series published in The Lancet journal.

The international team of All India Institute of Medical Sciences, said that the condition affects one in about seven pregnancies globally and is typically tested for and treated late into the second or third trimester.

If left untreated, gestational diabetes can lead to high blood pressure, increased risk of caesarean sections, mental health conditions, and complications for the baby at delivery, they said. The authors added that the pregnancy-related condition could also increase the chances of the mother developing health complications later in life, such as type 2 diabetes and cardiovascular disease.

Evidence suggests that the reasons for developing gestational diabetes can exist prior to pregnancy and that metabolic changes, such as those in glucose and blood pressure, can be

detected in early pregnancy (before 14 weeks), according to the authors.

Therefore, they have called for urgently bringing in strategies, including testing and diagnosing earlier, to prevent and manage gestational diabetes. This could reduce pregnancy and delivery complications, along with lowering the risk of women developing other health con-

ditions later in life, they said. "(Gestational diabetes) is a tremendous public health challenge. Women who experience it need support from the medical community, policymakers, and society as a whole to ensure they can effectively access proper treatment, reduce the stigma associated with (the condition), and improve their overall pregnancy

experience," said series author Dr. Yashdeep Gupta of the All India Institute of Medical Sciences.

The authors found that 30-70 per cent of women having gestational betes experience b cose from early stages of their pregnancy - 20 weeks or sooner. These women were also found to have worse outcomes, compared to those developing the condition in later stages of their pregnancy.

In studies where gestational diabetes was not managed effectively, the authors found these women to be at higher risks of premature delivery (51 per cent), birthing of bigger babies (57 per cent) and caesarean delivery (16 per cent).

Further, women with gestational diabetes were found to be at a 10-fold higher risk of developing type 2 diabetes later in life compared to those not experiencing the pregnancyrelated condition, and could possibly be accompanied by hypertension, fatty liver and an increased risk of heart disease.

# Chimps found to 'seek out' plants to heal injuries, infections: Study

himpanzees sought out and ate medicinal plants to treat I their injuries, according to a

study.
While wild chimpanzees are known to consume a variety of plant matter, researchers said it can be hard to figure out if they intentionally seek out medicinal plants to heal their ailments, or "passively" consume plants that happen to be

The study is published in the journal PLoS ONE.

At the Budongo Central Forest Reserve in Uganda, the researchers, including those at the University of Oxford, UK, observed the behaviours and health of 51 wild chimpanzees, belonging to two habituated communities.

The researchers observed a male chimpanzee with an injured hand seek out and eat the leaves of a fern, which may have helped to reduce pain and swelling. They also recorded another chimpanzee with a parasitic infection consuming the

The team also tested the plant extracts of tree and herb species in

Bark and resin from the East African mahogany tree (Khaya anthotheca) and leaves from a fern (Christella parasitica) were found to exhibit potent anti-inflammato-

The results suggested that chim-panzees looked for and ate specific plants for their medicinal effects, and the study was one of the first to document evidence of this kind, the authors said.

The medicinal plants growing in Budongo Central Forest Reserve could also be helpful for the development of new drugs to address the challenges of antibiotic-resistant bacteria and chronic inflammatory diseases, the authors said.

The findings demonstrated how watching and learning from our primate cousins may fast-track the discovery of novel medicines, along with emphasising the importance of protecting our forest pharmacies, they said.



#### Water emergency halts tourist arrivals at Italy's popular Capri island

prompted the mayor of Capri — one of Italy's most popular islands — to order a halt to the arrival of tourists on Saturday, in a crisis that has deprived some areas of any

water supply.
Without a water supply, it is impossible to guarantee essential services to "thousands of people" who travel to the island daily during the tourist season, Mayor Paolo Falco said. "The health and hygiene situation is explosive, we have taken our countermeasures and activated the crisis unit and issued a restrictive order," the mayor's order said.

The emergency was

caused by a failure in the mainland's water system that provides vital supplies to the world-known island. At the moment water is

still supplied to most of the island, but some isolated areas of the upper municipality of Anacapri are already dry. Only local reservoirs supply the network, which in the absence of supplies from the mainland risks being run out. Meanwhile, tanks are

expected to reach the island to support essential services, pending the restoration of full supply.

The Mayor's order was

notified shortly after 0900 a.m. causing an immediate stop to ticket sales.
