Apart masterminding the attack on the ED team, Shahjahan, a Trinamool Congress leader and district board member of North 24 Parganas, is also charged with mass landgrabbing and alleged sexual assault on women in Sandeshkhali and neighbouring riverine islands of the district.

# **BJP suggests names of Lok Sabha Contestants**

From External Affairs Minister S Jaishankar to Sushma Swaraj's daughter Bansuri Swaraj, and Bollywood actor Akshay Kumar to Prime Minister Narendra Modi, were among the names that circulated in the BJP's Central Election Committee (CEC) meeting on Thursday as the party convened to release its first list of candidates upcoming Lok Sabha elections.

Sources said the meeting discussed the seats lost in the 2019 General Elections and the margins of victory and defeat to decide on the various sets of names proposed by the ruling party. Prior to the CEC meeting, a five-hour-long session was held at the Prime Minister's residence at 7 Lok Kalyan Marg, attended by Union Home Minister Amit Shah and the party's national president JP Nadda.

As per the first list to be released Modi will be the obvious contestant from his term Varanasi constituency, Union Home Minister Amit Shah from Gandhi Nagar, Rajnath Singh from Lucknow, Smriti Irani from Amethi, while former Madhya Pradesh Chief Minister Shivraj Singh Chouhan from Vidisha, Union Minister Kiren Rijiju from Arunachal West, Arjun Ram Meghwal from Bikaner, the States of Punjab, Andhra Gaiendra Sekhawat from Pradesh, Tamil Nadu has Jodhpur, Sambit Patra from

## India's infrastructure friendly GDP Soars to 8.4 per cent

**T**ndia's growth economic accelerated to 8.4 per cent in the October-December quarter of this fiscal, mainly due to double-digit growth in manufacturing and good showing by mining & quarrying and construction sectors.

The GDP (gross domestic product) growth was 4.3 per cent in the October-December 2022 quarter, according to the data released by the National Statistical Office (NSO) on Thursday.

The manufacturing sector's output, as per the gross value added in the third quarter of this fiscal, grew by 11.6 per cent compared to a contraction of 4.8 per cent in the year-ago period.

Mining and quarrying grew at 7.5 per cent in the third quarter, up from 1.4 per cent a year ago. The construction sector kept the growth momentum at 9.5 per cent against the same growth rate in the year-ago period.

However, the output of the farm sector declined by 0.8 per cent during the quarter compared to a growth of 5.2 per cent a year ago. The national accounts data showed electricity, gas, water supply, and other utility services segment has grown by 9 per cent year-on-year

against an 8.7 per cent rise. The GVA growth in the services sector — trade, hotel, transport, communication and services related to broadcasting — was 6.7 per cent during the third quarter against 9.2 per cent.

Financial, real estate and professional services grew by 7 per cent in the third quarter over 7.7 rate of 10.1 per cent, it stated.

#### India expands footprint in Indian Ocean region

Tndia and Mauritius are natural I partners in the maritime domain to combat traditional and nontraditional challenges in the Indian Ocean region, Prime Minister Narendra Modi said on Thursday after virtually inaugurating a new airstrip, a jetty and six community development projects in the island nation.

The India-assisted projects in Agalega island of Mauritius are seen as significant as they are expected to boost connectivity as well as maritime security and surveillance in the strategic waters in the region.

After inaugurating the projects along with Mauritian Prime Minister Pravind Jugnauth, Modi

announced that Mauritius will be the first country to join India's Jan Aushadhi scheme, which is an initiative aimed at providing quality medicines at affordable

În his remarks, Modi flagged concerns over challenges in the Indian Ocean region and said India and Mauritius are "natural partners" in the maritime domain to deal with them.

"Many traditional and nontraditional challenges are emerging in the Indian Ocean Region. All these challenges affect our economy. India and Mauritius are natural partners in the field of maritime security to deal with the challenges," he said at the virtual

### Three-day spell of rain and snowfall likely to start today

After a brief spell of clear weather a three-day spell of rain and snowfall is forecast in the State from Friday. The State meteorological centre has issued a yellow warning (Watch) regarding heavy rain/heavy snowfall (3,500 metres and above) likely to occur at isolated places in Uttarkashi, Rudraprayag, Chamoli, Bageshwar and Pithoragarh districts today. Thunderstorms accompanied with lightning/hail/ gusty wind (30-40 kmph) are likely to occur at isolated places in the State. The meteorological centre has further forecast that light to moderate rain/thunderstorms/snowfall are likely to occur at

Bageshwar and Pithoragarh districts and at many places in remaining mountainous districts. Very light to light rain/thunderstorms are likely to occur at a few places in the plain districts while snowfall is likely to occur at places situated at altitudes of 3,000 metres and above.

Dehradun is likely to witness a partly to generally cloudy sky with one or two spells of light to moderate rain/thunderstorm accom-

lightning/hail/gusty wind (30-40 kmph) likely to occur in some areas towards night/early morning. The maximum and minimum

temperatures are likely to be about 29 degrees Celsius and 11 degrees Celsius respectively. Meanwhile, State meteorological centre director Bikram Singh said that the rain and snowfall activity is expected to peak on Saturday and decrease but continue on Sunday.

Moed is the son of Abdul Malik who is accused of instigating the Haldwani riot on February 8. The police have so far arrested 84 accused for their alleged connection with the violence. The Nainital senior superintendent of police Prahlad Narayan Meena informed the media here on Thursday that six police teams were formed to arrest the wanted accused. They raided all possible hideouts in Delhi, Gujarat, Bihar, Maharashtra and Uttar Pradesh, among other places. One of the teams finally arrested Moed in Delhi on Thursday. Meena said that

them. The police also found several illegal weapons and cartridges besides the fuel that was allegedly used for arson during the violence. It will be recalled that the riot broke out after the authorities demolished a madarsa and namaz site constructed illegally on government land. The land was encroached upon by Malik and the police claim he is the primary accused in the case. After hiding in several States to evade arrest, he was finally nabbed by the police on February 24. ### Son of Haldwani riot's | FIR filed against lab operator for fraudulent Covid tests during Kumbh Mela

The Dehradun senior su-**▲** perintendent of police Ajai Singh registered an FIR against a lab operator in connection with fake rapid antigen and RTPCR tests to detect Covid-19 during the Kumbh Mela 2021 held in Haridwar. He informed that the Enforcement Directorate (ED) had registered a case in Haridwar Kotwali in 2021 against three pathology labs that were allegedly involved in conducting fake rapid antigen and RTPCR tests during Kumbh Mela. The ED conducted an investigation under the Prevention of Money Laundering

Act (PMLA) and found that the government paid Rs 84.57 lakh to a lab located in Dehradun's Patelnagar area to conduct the tests. However, when the authorities checked the data of the said lab on the portal of the Indian Council of Medical Research (ICMR), they found that these tests conducted by the lab appeared to be fake, Singh said. The data showed that many patients were tested on different dates and had different addresses but their registered mobile numbers were the same. The ED sent the said report to the SSP to investigate

the matter and act accordingly. Considering this, Singh instructed the in- charge of the Patelnagar police station to conduct a preliminary investigation and take necessary action. He said that the police found in the primary investigation that the entries made in the said lab were fake. Considering this, the SSP filed an FIR against the operator of the lab under sections 120 B, 420, 467,468 and 471 of the Indian Penal Code in the Patelnagar police station. It is an ongoing investigation and the authorities will take further action accordingly, Singh added.

### Death of minor girl in **Dehradun rocks Assembly**

The death of a minor girl under suspicious circumstances in the Race Course area of Dehradun rocked the proceedings on the fourth day of the budget session of Vidhan Sabha on Thursday. Demanding discussions on the subject, the Congress members staged a walkout from the

The Congress MLAs raised the issue after visiting the house where the death occurred and meeting the parents of the deceased. The leader of the opposition (LoP) Yashpal Arya intervened in the ongoing discussion on the budget 2024-25 in the house and raised the issue of the death of the girl. He said that the parents of the minor girl are very poor and had come to Dehradun from Bihar for livelihood. Arya said that the incident reflects the pathetic law and order situation in the State. He said that during discussion on the law and order situation on Tuesday the government had claimed that the law enforcement agencies are working efficiently but the unfortunate incident has exposed the claim of the government. Chakrata MLA Pritam Singh said that the victim was a minor and her body had bruises which raises suspicion that she was tortured. He said that the incident occurred in a posh area near the police lines and MLA hostel. Singh demanded that a fair inquiry should be ordered in this case. The BJP MLA from Dharampur, Vinod Chamoli said the death of the minor girl is very unfortunate and a sensitive case. He said that the post mortem will clear the air around the cause of the death of the minor and demanded that the guilty should not be spared. In his response the Prevention Act

Prem Chand Agarwal said that the post mortem of the deceased is being done. He assured the house that strict action will be taken in the case and the guilty will be punished. Not satisfied with the reply of the government, the Congress members marched to the well of the house and staged a walkout as a mark of their protest. Meanwhile the speaker Ritu Khanduri directed the government to present a detailed report on the death of the minor in Dehradun. The Parliamentary Affairs minister will present the report in the house on Friday. The proceedings of the fourth day started with the Congress members demanding discussion under rule 310 on the issue of unemployment. The speaker rejected the request following which the Congress legislators wanted that the speaker should allow discussion on unemployment under the rule 58. However the speaker also rejected this demand of the Congress citing that discussion

#### 7,670 child beggars rescued under operation Mukti

He said that the State had adopted the Uttar Pradesh Prohibition of Beggary Act in the year 2017 which bans beggary in the State. He said that the State has only one Bhikshuk Grah (shelter for beggars) at Roshnabad in Haridwar district and it has a capacity to keep only 200 beggars. The minister accepted that begging is a social menace. The BJP MLA Munna Singh Chauhan said that there is a possibility that some organised begging gang is operating in the State.

#### All vacant posts of doctors in Health dept to be filled in March: Minister

The Health minister Dhan Singh Rawat told the house on the fourth day of the budget session that all the vacant posts of the medical officers (MOs) in the State health services will be filled in the month of March this year. The minister said that at present 277 posts of MOs are vacant in the health services of the State. He said that to overcome the shortage of specialist doctors the Health department has started a 'you quote we pay' scheme in which the government is offering a salary as high as Rs five lakh per month to the specialist doctors. In response to a question by Pratapnagar MLA Vikram Singh Negi who raised the issue of death of two pregnant women who were referred from the Community Health Centre (CHC) at Chaund to the district hospital in Bauradi, the Health minister said that an inquiry has been ordered in the unfortunate incident and assured that strict action will be taken on those responsible for showing negligence in the case. In response to a question by the Congress MLA Mamta Rakesh, the minister said that 955 posts of Block Resource Person (BRP) and Cluster Resource Person (CRP) in the Education department will be filled by outsourcing. He said that these posts have so far been manned by the that these posts have so far been mainted by the teachers appointed on deputation which hinders the studies in the schools of their posting. Rawat said that the National Education Policy (NEP) 2020 clearly mentions that the teachers should not be deputed in any of the non-teaching works. He informed the house that the Education department will soon appoint 2,364 workers to the vacant class IV posts in the schools of the State. These workers will be appointed by an outsourcing agency, he said.

### Minor girl dies under suspicious circumstances in Doon

PNS DEHRADUN

Aminor girl died under suspicious circumstances on Thursday morning . She worked as a house help in a house in Dehradun's Race Course area. The home owners claimed that the victim tried to commit suicide in the morning after which they took her to the hospital where doctors declared her as brought dead, the Dehradun senior superintendent of police Ajai Singh said.

The victim was a teenager who hailed from Bihar and purportedly worked as a fulltime house help. Her parents are labourers who live in the Dharampur area which she used to visit occasionally. The victim's family members and several people gathered around the house in the afternoon after learning of her death. They accused the owners of killing the girl. Some neighbours have also claimed that the owners used to physically abuse her. Some people also raised ruckus at the spot and allegedly damaged parts of the house.

The police stated that they received the information about the girl after she was declared dead by doctors.
"The victim's employers stated that they were shifting their things from the first floor to the second floor when they noticed they had not seen the victim for a long time. On going upstairs, they found her hanging from a noose tied to the ceiling in the bathroom. The police gathered all evidence from the spot and found that CCTV footage showed the girl going into the bathroom with a stool.

The post-mortem report also showed suicidal hanging as the cause of death," the SSP

said. Many people also claimed that the victim's body had several bruises and wounds and also suspected a sexual assault. However, Singh stated that no such claims were proved to be true in the post-mortem

However, he said that it was disturbing that a young girl had to commit suicide. It is a serious matter of concern and the police will investigate the matter from every angle to find out what prompted her to go to such extreme lengths. He said that the police also detained the victim's employers after her parents registered a case of murder against them. The police will also act against them under relevant acts for employing a minor against the ant-child labour law. The investigation is ongoing, he

### Indian scientists develop wound dressing material with banana fibers

Scientists at the Institute of Advanced Study in Science and Technology (IASST), under the Department of Science and Technology (DST), have developed an innovative cost-effective wound dressing material using banana fibers, a byproduct of the extensive banana farming industry in the country.

Led by Prof. Devasish Chowdhury and Prof. (Retd) Rajlakshmi Devi, along with research scholar Mridusmita Barman, the team has repurposed banana pseudostems, typically discarded as agricultural waste, to create an eco-friendly wound dressing solution. By combining banana fibers with biopolymers such as chitosan and guar gum, the researchers engineered a versatile patch with superior mechanical strength and antioxidant prop-

# Protection bund coming up along IB for safety of border farmers in JK: IG BSF

Encouraging border tresidents to cultivate their land ahead of border fence, a top BSF officer on Thursday said the Home Ministry has approved a plan for the construction of a protection bund along the International Border for the safety of farmers and it will be completed within next five

Ínspector General of Border Security Force (BSF), Jammu frontier, D K Boora was speaking at a function organised at Chamliyal village near the zero line in Samba district to hand over a cheque of Rs 3 lakh to a villager who helped in the recovery of a grounded Pakistani drone in January.

Samba Senior Superintendent of Police Vinay Kumar and other prominent people attended the function.

'We want the farmers to tend their land ahead of the border fence as the BSF is there for your protection. We will provide you with all the assistance and if you are concerned that you won't be able to cultivate your produce, we will not allow such a situation to develop in the first place," the BSF officer

Boora, however, said in case the farmers on the Indian side are not able to reap their produce, the BSF will not allow the other side to cultivate as well.

He said the home ministry has already approved a proposal for the construction of a protection bund along the IB for the safety of the farmers working in their fields ahead

of the border fence.
"The protection bund will be completed within the next four to five years, depending on the availability of the funds. After the completion of the protection bund, you can carry out your work easily without any threat (from the enemy)," he said.

Boora said there are rules in place while moving ahead of the border fence and "we need to follow those rules. BSF is deployed on the borders in J-K, Punjab, Rajasthan, Gujarat, West Bengal, Assam, Meghalaya, Tripura and Mizoram and all these areas are protected by border fences and the rules are the same everywhere." Boora said the central

government has announced many schemes for the development of border villages and the impact of these schemes will be visible on the ground in the next five

Highlighting the importance of border residents in safeguarding the country, border security is incomplete without the cooperation of the border population.

"We are proud of our border population in Jammu region who are nationalist by core," he said, adding that in neighbouring Punjab, drug smuggling from across the border is a major challenge.

"The drugs are coming by drones and other means in Punjab because there are some elements who are promoting the business. When our own people are involved in such criminal activities, it becomes difficult (for the law enforcing agencies to tackle the

situation)," he said, adding that when the border residents are nationalists, the entire focus of the border guarding forces remains on the front rather than looking

Highlighting the cooperation of the border residents in securing the borders of the country, he said Dass had done a very good job for which he was rewarded. SSP Sharma said the police headquarters had announced rewards to anyone sharing

information regarding anti-national activities and Dass was handed over the cheque of Rs 3 lakh for helping in the recovery of enemy drones in January this year. He said there is also a reward of Rs 5 lakh for anyone who locates the trans-border

Both TMC and BJP rush forth to claim credit for fugitive Sheikh Shahjahan's arrest after 55 days

The arrest of Trinamool Congress strongman Sheikh Shahjahan, who was wanted for the Sandeshkhali infamy involving the charges of gang rape and landgrab, is likely to further muddy political waters in West Bengal and intensify the bitter war of words between the Mamata Banerjee-led State Government and the BJP. On the run for 55 days following a mob attack on Enforcement Directorate officers during a raid at his house on January 5 in a ration scam case, Sheikh was finally taken into custody within 24 hours of the Calcutta High Court stating that the CBI, ED or State police could arrest him. However, the delayed development has opened a can of worms in political circles. While the ruling TMC maintains that Sheikh was apprehended now since the High Court had cleared the ambiguity on a stay on his arrest, the Opposition BJP claims that the accused was being shielded by the police and his arrest was "scripted" because of the "intense pressure brought on the Government by us". As the drama



unfolds in West Bengal, one thing remains clear: Sheikh's arrest has ignited a firestorm, with both the main players vying for supremacy in the State's everevolving political milieu. While the development has sent shockwaves across the State, the political manoeuvrings have understandably quickened as both the TMC and BJP seek to capitalise on the situation, especially since the Lok Sabha elections are very much in sight, and Sandeshkhali and its aftermath could be a game changer for both parties. For the TMC, it presents an opportunity to reaffirm its commitment to combating corruption and upholding the rule of law. The party has wasted no time in touting the arrest as a testament to its dedication to clean governance and accountability.

On the other hand, the BJP has seized upon the arrest as evidence of its growing influence in West Bengal's political arena. The party sees it as vindication of its anti-corruption stance and validation of its claims of rampant corruption within the TMC-led Government. However, under the surface lies a deeper struggle for supremacy in the State's tumultuous political arena. The fierce battle for electoral dominance has only intensified with Sheikh's arrest, with each party seeking to leverage the situation to bolster its poll prospects. However, amid the political grandstanding, it is important not to lose sight of the broader implications of the fugitive strongman's arrest. Beyond being a mere pawn in the State's political underbelly, Sheikh's case underscores the pervasive issue of corruption that continues to plague governance in West Bengal. His arrest serves as a stark reminder of the challenges facing the State in its quest for clean and transparent governance, irrespective of political affiliations. Amid the cacophony of competing claims and counterclaims, the true test lies in the ability of Bengal's political class to address the underlying issues of corruption and criminalisation of politics, which continue to undermine the State's progress and development.

# LK Advani: A Ratna of Bharat



From attacking pseudo-secularism to pan-India moderation, it was as if Advani had given up his yesterday for the sake of the BJP's and the country's tomorrow

he biggest sacrifice Lal Krishna Advani made was to distance himself from the culmination of the Babri edifice at Ayodhya. Understandably, the Hindu public was disappointed; Advani's followers were heartbroken. Many of them went to the extent of alleging that he had let down the cause. For a conscientious leader, this was like cutting his nose and throwing it away. During the spring of 1991, Advani told me that it was Ayodhya that had made him a national figure. Until his leading the Rathyatra from Somnath to hopefully reach the birthplace of Shri Ramchandra—which was intercepted by Lalu Prasad Yadav at Samastipur in 1990-Advani was merely a senior party apparatchik

It was his taking up the cause of the Ramjanmabhoomi that catapulted him to the gallery of national figures. When, therefore, Advani spoke to the press saying that December 6, 1992, was the darkest day of his life, he knew what he was throwing away. Soon thereafter, accompanied by friends, I called on him at the Irrigation Department's guest house near Jhansi, where he along with a few other senior BJP leaders had been kept under house arrest, following the demolition of the Babri edifice on that fateful day of December 6 that year. Advani told me that after seeing my letter published in the Pioneer, wherein I had in rejoinder to his remark written that "There have been darker days", he knew I had come to protest against his statement. It took him quite a while before he came around to believing my denial. He was right to the extent that I continued to hold the view (which I of course, still do) that the Babri edifice was a baggage of dacoity and had to be confis-

Advani then went on to explain: Whatever my explanation, I had to realise that party unity, regardless of anything else, was our uppermost duty. Atalji (Vajpayee) vas our seniormost leader, and no party member should differ with him publicly on such a matter of policy. Should party members flagrantly violate their party's

commitment made to the Supreme Court, that the edifice would be safe? Its future was for the court to decide. First, who then would ever again have faith in the word of a BJP leader?

Secondly, the opposing parties would go to town saying that the BJP was a party ridden with factions. Its top leader does not believe in masjidhunting while one of its chief ministers practices the exact

Thirdly, an upright party is a united party, and we are known as a party with a difference. Becoming a factionridden party is not the difference between our aspirations. Fourthly, discipline has been our hallmark. Did the karsevaks at Ayodhya behave in a disciplined way, by going against the leader-ship and demolishing a place of worship of another community?

In April 1998, I became the party's Member of the Rajya Sabha through a bye-election. Among members generally, it seemed that interest in Ayoanya naa wanea. 1 ne case lay in court without active hearings. When I thought of the vanished edifice, I did wonder whether at that rate

the Congress with a clever leader might just snatch the issue out of the BJP's hands and use it for electoral benefit. How popular the issue was kept becoming clear over and over again. Meanwhile, many more pil-

grims continued to visit the holy city.One day in July 1999, Advani called me to his room in Parliament House for a chat over toast and coffee. He opened up by showering praise on Vajpayee's tactful leadership of a coalition of so many parties with so many different political ideologies ranging from the Shiv Sena on the one hand to the DMK on the other. There was no doubt that

Vajpayee was running a complex government very successfully. Advani was full of praise for his leadership. If there is to be another leader in the future, he should have the wide acceptance and loyalty that Atalji commanded. That is what a diverse country like ours needs, Advani opined. All of us in our party should give up small differences and think of large policy issues. Automatically, such a leader and his party would attract votes as well as an ongoing folHe went on to say that India's future lies in the integrity of politics.Rather than recommending any shift towards moderation or 'soft secularism', Advani stressed the unity of thought, policy and leadership. By implication, he was asking for a united party under a broadminded leader. He was repeatedly emphatic about parties rather than the

Even dynastic parties are not free of factions and breakups, and it is the BJP alone that has admirably avoided going that way. It seemed as though he wanted to give up all he had stood for earlier and espouse a new cause, not only for the BJP but for the sake of the country.

As I knew him, I can state that this was no mere shift but a sacrifice. From his eloquence of attacking pseudo-secularism to pan-India moderation, it was as if Advani had given up his yesterday for the sake of the BJP's and the country's tomorrow. It could not have been easy for him, but that is what he is.

### **DOMESTIC POLITICS AMID GLOBAL AGENDA**

India advocates for a balanced voice in shaping a multilateral world order

s elections draw closer, Prime Minister Narendra Modi has been frequenting India's south more than championing the causes of the global south across available diplomatic platforms. One reason is that his party seems to have a weaker presence down south. Earlier, as a strategic choice, PM Modi chose to inaugurate a Hindu temple in a Muslim country during his last foreign trip in the current tenure. Even as he did so, statements regarding continuity of policies and outlook were subtly delivered when PM Modi confidently told his audience that he already has invitations from several foreign governments for the middle and latter part of 2024, indicating confidence in his potential third term.

A third term for Modi would have wider ramifications for a whole bunch of issues, not to mention foreign policy, given India's rising economic clout and confidence, making it a significant player in global affairs. India is expected to be the third-largest economy after the US and China in PM Modi's next term, which, besides putting a couple of stars on the shoulder, will also mean a heavy lift of responsibilities

One of the significant achievements for Mr. Modi, particularly during his second term, has been uplifting the India-US relationship and situating it in the Indo-Pacific context. While the India-US bilateral is by far at its strongest ever in history, the two nations have managed to work through several plurilateral platforms, the most important being the QUAD (a grouping of the US, India, Australia, and Japan), each having significant stakes and interests in the Indo-Pacific, while also wary of the dragon in the region, never stopping short of using any overt or covert means to push its assertive agenda.



While some of the world's finest diplomats, policymakers, and think tanks were deliberating on global issues last week, EAM Jaishankar found some time to speak to a whole bunch of policy strategists on the relevance of QUAD and the way forward. EAM highlighted the changing nature of India's foreign policy outlook over the last decade when he mentioned "remarkable changes in India's bilateral relationships with its three Quad partners. With the US, we put behind ideological hesitations of history. With Japan, we gave longstanding goodwill much more practical shape. And with Australia, we actually made a real beginning in seriousness." Even though there hasn't been a QUAD leaders summit since May last year, backroom meetings between foreign ministers from the member countries to discuss issues of regional and global importance haven't taken a backseat. Given the political compulsions, it might be difficult for India to host the QUAD leaders summit this year, as it will be too close to the US elections by the time the new Indian government is in place. However, the significant targets India aims to achieve through the QUAD group, as highlighted by EAM, namely, "it reflects the growth of a multipolar order. Two, it is a post-alliance and post-Cold War thinking. Three, it is against spheres of influence. Four, it expresses the democratizing of the global space and a collaborative, not unilateral, approach. And five, it is a statement that in this day and age, others cannot have a veto on our choices," shall remain in focus. It is this message of continuity of policies that the Indian government is highlighting to the domestic and international audience at a time when instability is the norm for most, including powerful nations in the world.

India has effectively managed the QUAD as a non-military arrangement, unlike NATO, with shared interests of all members in the region. Mr. Jaishankar highlighted in his address, "Among Quad countries, there is a growing comfort in working with each other given the strong consensus we have in our strategic outlooks. India's bilateral partnerships with each of these three Quad countries have also transformed in recent years." The message is clear: India will continue to push for a multilateral world order with a fair share of voice on international forums.

# Protests stress need for climate-smart agriculture-



There is a pressing need for proactive measures aimed at protecting both farmer livelihoods and national food security



he ongoing farmer protests that began on February 13th have already claimed five lives and resulted in Delhi bearing the brunt of economic losses to the tune of 300 crores as nearly five lakh traders who did regular business in Delhi from adjoining states suspended their businesses given the unrest. Since 2020, farmer protests have unfortunately assumed a regular frequency not only in Delhi and Punjab but across India. According to consultancy firm Verisk Maplecroft estimates, India has accounted for the biggest global share of farmer protests in the past three

The farmer protests 2.0 again highlight the fault lines in India's agricultural viability and this time the farmers are demanding conclusive government action. The protesting farmers want a firm minimum support price (MSP) that is backed by a legal guarantee for all crops. Another demand is to implement the recommendations of the MS Swaminathan committee on agriculture which will enable increasing MSP to 50 per cent above the weighted average cost of proauction. Other demands include better sugar cane prices and a pension of Rs 10,000 a month for every farmer above the age of

The government is engaged in feverish negotiations with the farmer unions to break the impasse. However, a breakthrough achieved may be short-lived, as the government would have only successfully attended to the symptoms and not to the problem itself. India's agri sector contributes only 15 per cent to the GDP but engages 58 per cent workforce. This lopsided proportion is made worse by the fact that 85 per cent of the farmers operate in less than five acres of land half of which in many parts of India may be dry and barren. This translates to low yields, low earnings and high debt and when combined with increasing challenges of climate change on agriculture, the problem assumes a much larger and

ominous proportion. Climate change whether it is unseasonal rain, hailstorms, floods, or drought, India's agri-sector has seen it all. The lingering uncertainty due to environmental issues

keeps the farmers on their toes leading to income insecurity and mounting debt. An example is the casualty in the current protests of a marginal farmer whose 8-acre agri-cultural land had 8 lacs of debt on it, making it virtually impossible for the farmer to pay it off and continue with another crop. Climate change-driven issues such as these have made the farmers demand an MSP law to act as a safety net for the time, effort and risk they invest in

The perennial shortage of water resources is the first symptom of climate change's impact on the agri sector. According to Rainfed Atlas, it is estimated that between 52% and 55% of the farming community have no means of irrigation and are dependent on rain-fed agriculture. But due to climate change temperatures are spiralling and rainfall has become more erratic, with longer dry spells resulting in droughts and shorter periods of more intense rainfall causing floods. This results in a domino effect whereby crop yield is adversely impacted while high Co2 levels cause low nutritional value of crops. This translates to low marketability of the produce therefore causing financial distress

and rising debt for the farmers. The impact of climate change on the agri-sector and the sluggish government response in managing its fallout has come as a double whammy for the farmer community. The lack of robust insulation measures that seek to protect the sector from the vagaries of climate extremities is now having a telling impact on productivity. The cereal crop productivity of most cereals is slated to decrease due to an increase in temperature and CO2 levels, and the decrease in water availability. According to estimates, there will be a projected loss of 10-40% in crop production by 2100 if no climate change adaptation measures are taken. A one-degree Celsius increase in temperature may reduce yields of major food crops by 3-7%. Given these troubling projections, the government must extricate the agrisector from the clutches of climate change. This alone can ensure the best interests of farmers, safeguard national food security and protect livelihoods.

An audit of the agri-sector at the micro-level is essential to identify and remove processes that are detrimental to natural resources. This will ensure weeding out of inefficient water-intensive practices and allow optimal use of the precious resource. Similarly, best farming practices need to be promoted across the sector to ensure climate change adaptation and mitigation in the sector. For example, the raisedbed planting of wheat in the Indo-Gangetic plains enables 20-25% savings in irrigation water and also helps in reduced herbicide use. Measures such as these combined with water accounting methodolo gies can build long-term sustainabil-ity, efficiency and resilience of the agri-sector besides immensely benefiting the marginal farmers.

The government must also initiate climate-smart agriculture strate-gies which aim at adapting agriculture to climate change. This can be done by implementing technologies that help farmers plan crops by considering the climate specifics of their area through easy-to-use apps on their smartphones. This can be done by prioritising botanical research to develop crop species that are more tolerant to water deficiencies and extreme temperatures. Additionally, ecologists can evolve effective soil management methods that reduce the depletion of topsoil, promote carbon sequestration, and reduce chemical application. Advanced farm irrigation technologies can also help proper water saturation levels in the soil, prevent water flooding,

and help avoid top-soil runoff. The government must focus on specially developed software solutions

for agriculture that can help in realtime monitoring of the crops and allow farmers to accurately calculate the required inputs, which reduces costs in the short term and protects nature in the long term. Technology-assisted cover crops for instance can not only help prevent soil erosion, and promote water retention and nitrogen fixation but also serve as organic manure for fodder. Smart agrisoftware can help farmers implement differentiated applications of fertilisers which can help decrease soil pollution and increase crop nutrient levels. The software can also have in-built weather-related tools that provide timely alerts of extremities, elaborate weather forecasts to schedule farming events and enable prediction of general climate change tendencies by analysing historical weather data.

Currently, the agri-sector prob-lems and farmer grievances are dealt with on a reactive basis; this is evident in the form of chronic farmer agitations that come back every year. The government must realise that a lasting solution is only possible if actual problems, including the impact of climate change on agriculture, are addressed with the participation of all stakeholders of the sector. The collaboration of farmers, policymakers, environmentalists, botanical scientists and technology experts can help chalk out longterm strategies and solutions and ensure a robust agri-sector that is resilient against climate change onslaughts. Farmer protests are a symptom of climate change's impact on agriculture. Protecting the sector from adverse impacts will automatically ensure farmer well-being and prosperity.

### **Israeli forces fire on crowd** waiting for aid, 100 killed

Palestinian deaths in Gaza pass 30k

Israeli troops fired on a crowd of Palestinians waiting for aid in Gaza City on Thursday, witnesses said. More than 100 people were killed, bringing the death toll since the start of the Israel-Hamas war to more than 30,000, according to health officials. Hospital officials initially reported an Israeli strike on the crowd, but witnesses later said Israeli troops opened fire as people pulled flour and canned goods off of trucks.

Israeli officials acknowl-

edged that troops opened fire, saying they did so after the crowd approached in a threatening way. The officials insisted on anonymity to give details about what happened, after the military said in a statement that "dozens were killed and injured from pushing, trampling and being run over by the trucks". Gaza City and the surrounding areas in the enclave's north were the first targets of Israel's air, sea ground offensive, launched in response to Hamas' Oct 7 attack. The area has suffered widespread devastation and has been largely isolated during the conflict. Trucks carrying food reached northern Gaza this week, the first major aid delivery to the area in a month, officials said

### UK descending into mob rule: Sunak Critics accuse him of undermining protest rights

Prime Minister Rishi Sunak said Britain is descending into "mob rule" because of the pressures created by protests against the Israel-Hamas war words criticised as alarmist by a human rights group. Sunak told a meeting of police leaders on Wednesday that there was a "pattern of increasingly violent and intimidatory behaviour" that's intended to "shout down free debate and stop elected representatives doing their job".

"There is a growing con-sensus that mob rule is replacing democratic rule," he said, according to a transcript released by the prime minister's office. "And we've got to collec-tively, all of us, change that urgently. Tom Southerden of

Amnesty International said Thursday that talk of mob rule wildly exaggerates the issue and risks delegitimising the rights of peaceful protest." Mass protests have drawn hundreds of thousands of people to central London almost weekly to call for a cease-fire in a conflict that has killed more than 30,000 Palestinians, according to the Gaza Health Ministry in the Hamas-run territory. Israel says Hamas killed 1,200 Israelis, mostly civilians, and abducted roughly 250, in the Oct. 7

The protests have been overwhelmingly peaceful, though there have been dozens

Sunak calls on police chiefs to get tough on 'mob' protests

London (PTI): British Prime Minister Rishi Sunak has called on the country's police chiefs to use the full spectrum of their powers to ensure that protests are not allowed to descend into

The British Indian leader was speaking after a meeting at 10 Downing Street on Wednesday during which ministers and senior police chiefs agreed to sign up to a new "democratic policing proto-

It comes in the wake of rowing security concerns for British MPs and some violent incidents during large-scale marches on the streets of the UK in protest over the raging Israel-Hamas conflict.

of arrests over signs and chants allegedly supporting Hamas, a banned organisation in Britain. Jewish organisations and many lawmakers say the mass marches have created an intimidating atmosphere for Jewish Londoners — though members of the Jewish community have been among those on procease-fire marches.

Divisions over the conflict in Gaza have convulsed British



politics, with some lawmakers saying they fear for their safety after receiving threats over their positions on the war. Reports of both antisemitic and anti-Muslim abuse in Britain have soared since Hamas' Oct 7 attack on Israel, which triggered Israel's invasion of Gaza. A debate last week in the House of Commons on whether to call for a cease-fire descended into chaos amid allegations the speaker of the house had bent parliamentary rules in response to pressure from pro-Palestinian activists.

During the debate, protesters projected "From the river to the sea, Palestine will be free" a slogan some see as calling for the destruction of Israel onto Parliament's Big Ben clocktower. On Saturday, Sunak suspended Conservative law maker Lee Anderson from the

party for saying London Mayor Sadiq Khan, who is Muslim, was controlled by Islamists and had allowed them to take charge of the city.
Pro-Palestinian demon-

strators protested at the house of a Conservative lawmaker earlier this month, while environmental activists have targeted Sunak's family home in northern England.

The prime minister met police chiefs after announcing a 31-million-pound (\$40-million) fund to step up security for lawmakers after politicians reported threats and intimidation connected to the war.

At Wednesday's meeting, the government told police chiefs that protests at politi-cians' homes "should generally be cosidered to be intimidatory." Sunak told officers to take a "robust approach...to protect our democratic processes from intimidation, disruption, from subversion

British lawmakers have a tradition of meeting regularly with constituents in their local communities, but security has been tightened after several attacks in the last decade.

In 2016, Labour lawmaker Jo Cox was killed by a far-right extremist, and Conservative David Amess was murdered in 2021 by an attacker inspired by the Islamic State group. Sunak's comments follow several years of increasingly stringent restrictions on peaceful protest by the Conservative government.

It has passed new laws to

defined "public nuisance," punishable by up to 10 years in prison, and giving police more powers to restrict protests judged to be disruptive. Hundreds of environmental activists have been arrested and sometimes jailed for blocking roads and other nonviolent

#### **White House: Biden** doing everything to improve visa process

US President Joe Biden is doing everything he can to improve the process related to the sought-after H-1B visa, Green Card backlog and other issues related to the country's issues related to the country's legal immigration system, the White House has said.

The H-1B visa is a nonimmigrant visa that allows US companies to employ foreign workers in speciality occupations that require theoretical or technical expertise.

Technology companies depend on it to hire tens of thousands of employees each year from countries like India

"One of the steps, if we look at the H-1B visa process, we have taken action to improve that and the process and backlog for lawful permawho are eligible to become US citizens," White House Press Secretary Karine Jean-Pierre told reporters at her daily news conference on Wednesday.

A Green Card, known officially as a Permanent Resident Card, is a document issued to immigrants to the US as evidence that the bearer has been granted the privilege of residing permanently.

Jean-Pierre was responding to questions about the feeling among a section of Indian Americans that the president is not putting as much effort into addressing the woes of legal immigrants as he is doing for illegal immigrants.

Biden heads to the southern border with Mexico in Texas on Thursday."Just last month, for example, as a part of our efforts to strengthen the integrity of our immigration system and reduce the potential for fraud, the Department of Homeland Security published a final rule relating to H 1B visa," Jean-Pierre said.

"So, the changes promote fairer and more equitable outcomes and, so, we will continue our work to improve the system within our authorities and that has certainly been a priority," she said and added that the administration takes that "very seriously" and is continuing to do everything that it can to improve the visa process.

The US Citizenship and Immigration Services (USCIS) has announced the launch of myUSCIS organisational accounts that will allow multiple people within an organisation, as well as their legal representatives, to collaborate on and prepare H-1B registrations, H-1B petitions and any associated Form I-907, Request for Premium Processing Service.

 $P^{akistan's\ newly-elected\ law-}_{makers\ were\ sworn\ in\ on}$  Thursday during Parliament's maiden session after President Dr Arif Alvi summoned the National Assembly after delaying the process for several days. The National Assembly was summoned after Alvi's initial refusal due to differences with the caretaker government over the issue of former prime minister Imran Khan's partybacked candidates being allotted the reserved seats.

The opening session of the 16th Parliament, headed by the outgoing Speaker of the previous Parliament, Raja Pervaiz Ashraf, began after a delay of more than an hour. Ashraf administered the oath to the newly-elected lawmakers amidst unruly scenes as 71vear-old Khan's Pakistan Tehreek-e-Insaf (PTI)-backed lawmakers chanted slogans against alleged vote rigging in the February 8 general elections. After the oath-taking, the lawmakers signed the register roll of the National Assembly to officially become members.

The new oath-taking law-makers included the Pakistan Muslim League-Nawaz (PML-N) supremo Nawaz Sharif, PML-N President Shehbaz Sharif, Pakistan Peoples Party (PPP) Co-chairman Asif Zardari and PPP Chairman Bilawal Bhutto-Zardari.

Early on Thursday, Alvi approved a move from the caretaker parliamentary affairs ministry to summon the newly-elected National Assembly's first session on February 29, according to a statement posted by the president's X account.

"Subject to some reservations, President Dr Arif Alvi has summoned to convene the National Assembly on February 29 in exercise of the powers conferred by Article 54(1) of the Constitution of the Islamic Republic of Pakistan, the statement said.

It said that the president accorded his approval keeping in view "the mandate and implications of the timeline given in Article 91 (2) and sub-

On Monday, Alvi, a close aide of jailed former prime minister Imran Khan and a former senior member of his party, rejected a move from the caretaker parliamentary affairs ministry to summon the National Assembly's first session, maintaining that all reserved seats be allocated before its summoning.

Winning independent candidates of former-cricketerturned-politician Khan's PTI joined the rightwing Sunni

Ittehad Council (SIC) to receive the party's share of reserved seats for women and minorities in the national and provincial assemblies. Candidates of the PTI fought as independents after the party could not directly participate in the February 8 elections due to the non-allotment of its iconic electoral

symbol - the cricket bat. A five-member bench of the Election Commission of Pakistan began the open hearing on the SIC's plea seeking allocation of reserved seats and the counter-pleas filed against it earlier this week.

The House was already meeting at 10 am on Thursday as National Assembly outgoing Speaker Ashraf decided to convene the lower house of parliament session after Alvi's denial.

Alvi's statement said that returning the move for a National Assembly session was very much in accordance with the provisions of Article 48(1)" of the Constitution.

"It is not understood on what grounds it has been taken as a partisan act, though it was also aimed at the completion of the National Assembly in accordance with Article 51 of the Constitution," it said. Alvi's decision not to summon the session was heavily criticised by the PML-N and the PPP parties, whose leaders on Tuesday warned that it might lead to "legal consequences".

The PTI had alleged massive rigging in the election and vowed to raise their voice inside and outside the

'Sending Western troops to Ukraine risks global N-conflict'

Russian President Vladimir Putin vowed on Thursday to fulfil Moscow's goals in Ukraine and sternly warned the West against deeper involvement in the fighting, saying that such a move is fraught with the

risk of a global nuclear conflict. Putin's warning came in a state-of-the-nation address ahead of next month's election he's all but certain to win, underlining his readiness to protect Russian gains in Ukraine. In an apparent reference to French President Emmanuel Macron's statement earlier this week that the future deployment of Western ground troops to Ukraine should not be "ruled out", Putin warned that it would lead to "tragic" consequences for the countries

Putin noted that while accusing Russia of plans tp attack NATO allies in Europe, Western allies were "selecting targets for striking our territory and selecting the most efficient as they think striking assets and talking about the

who decide to do that.

contingent to Ukraine".

'We remember the fate of those who sent their troop contingents to the territory of our country," the Russian leader said. "Now the consequences for the potential invaders will be far more tragic.

Speaking before an audience of lawmakers and top officials, Putin said the West should keep in mind that "we also have the weapons that can strike targets on their territory, and what they are now suggesting and scaring the world with, all that raises the real threat of a nuclear conflict that will mean the destruction of our civilisation".

'Don't they understand it?" he said, alleging that Western leaders are playing with options of deeper involvement in the conflict, as in a simulation. "Those people haven't been through any tough challenges and they have forgotten what war means."

The strong statement followed earlier warnings from Putin, who has issued frequent reminders of Russia's nuclear might since he sent troops into Ukraine in February 2022 as he sought to discourage the West from expanding its military support for Kyiv.

Putin emphasised that Russia's nuclear forces are in "full readiness," saying that the military has deployed potent new weapons, some of them tested on the battlefield in Ukraine. The Kremlin leader said they include the new Sarmat heavy intercontinental ballistic missile that has entered service with Russian nuclear forces, along with the Burevestnik atomic-powered cruise missile and the Poseidon atomic-powered, nucleararmed drone, which are completing their tests.

He added that the Kinzhal and Zircon hypersonic missiles have proven their efficacy on the battlefield in Ukraine. At the same time, he rejected Western leaders' statements about the threat of a Russian attack on NATO allies in Europe as "ravings" and again dismissed Washington's claim that Moscow was pondering the deployment of space-based

nuclear weapons. Putin charged that the US allegations were part of a ploy to draw Russia into talks on nuclear arms control on American terms even as Washington continues its efforts to deliver a "strategic defeat" to Moscow in

Ukraine. "Ahead of the US election, they just want to show their citizens, as well as others, that they continue to rule the world," he said, "It won't work,"

In his speech that focused heavily on economic and social issues ahead of the March 15-17 presidential vote, Putin argued that Russia was "defending its sovereignty and security and protecting our compatriots" in Ukraine, charging that the Russian forces have the upper hand in the fighting. He hailed Russian soldiers and honoured those who were killed in fighting with a moment of silence.

Putin has repeatedly said that he sent troops into Ukraine in February 2022 to protect Russian interests and prevent Ukraine from posing a major security threat to Russia by

allies have denounced it as an unprovoked act of aggression. The Russian leader has repeatedly signalled a desire to negotiate an end to the fighting but warned that Russia will hold onto its gains.

Putin, 71, who is running as an independent candidate in the March 15-17 presidential election, relies on the tight control over Russia's political system that he has established during 24 years in power. Prominent critics who could challenge him have either been imprisoned or are living abroad, while most independent media have been banned, meaning that Putin's reelection is all but assured. He faces token opposition from three other candidates nominated by Kremlin-friendly parties represented in parliament.

Russia's best-known oppo sition leader Alexei Navalny, whose attempt to run against Putin in 2018 was rejected, died suddenly in an Arctic prison colony earlier this month, while serving a 19-year sentence on extremism charges.

#### Russian rocket successfully puts Iranian satellite into orbit

Moscow (AP): A Russian rocket on Thursday successfully put an Iranian satellite into orbit, a launch that underlined increasingly close cooperation between Moscow and Tehran. Russia's state-run Roscosmos corporation said that a Soyuz rocket blasted off from the Vostochny launch facility in the country's far east to carry the Iranian satellite and 18 Russian satellites into orbit. The Iranian state TV said the 110-kg (242-pound) satellite has three cameras to take images for environmental, agricultural and other purposes. Iran's state TV said the satellite will be put into orbit around the North and South Poles, synchronised to be in the same fixed position relative to the Sun, and will be fully functional after a calibration of its systems. Thursday's launch comes after Russia put into

### Kishida vows no more fundraising parties

Tapan's beleaguered prime minister renewed his apology over his governing party's corruption scandal, promising to not hold any more parties himself as leader during a political ethics committee Thursday. Fumio Kishida has fought against plummeting support ratings since his governing party's corruption scandal rocked the government. The scandal, considered the biggest in decades, centres on political funds raised through party event tickets bought by individuals, companies and organisations. It led to 10 people — lawmakers and their aides — being indicted in January

While Kishida himself is not the focus of the scandal and was not even invited to the hearing, the surprise announcement of his personal appearance broke a deadlock between the opposition lawmakers and his governing party Wednesday

when the five implicated attendants refused to go public, holding up a hearing. Kishida expressed a "sense of crisis" that the deadlock on the hearing would further deepen the public's distrust in politics. The ruling Liberal

Democratic Party's resistance to have a fully open session fuelled public criticism that Kishida's party is taking the corruption lightly and trying to hide something. Kishida's action could

help ease criticisms that he was too slow and lax in addressing the public's distrust and taking anti-corrup-tion measures. In his opening statement, Kishida renewed his apology for triggering public distrust in politics, and promised to take leadership in reforming his party, saying seniority-based tradition, lack of compliance and a sense of privilege among lawmakers need to be removed if they were part of the problem.

PML-N lawver Azam Nazeer Tarar said the SIC did not participate in the general elections. The ECP wrote a letter to all political parties about the implementation of election rules, but the Council replied that their party did not field any candidates Tarar said, "The Section

104 clearly states that whoever is participating in the elections, under Section 104, must have a priority list for reserved seats. If a political party has been rejected by the people, then how can independent members go and ask for reserved seats." The ECP bench reserved its verdict on the petition after hearing the arguments of the parties.

# Cabinet nod to ₹1.26 lakh crore chip making units

PTI ■ NEW DELHI

⊣he Union Cabinet on Thursday approved setting up three semiconductor-making units by firms, including Tata Group and Japan's Renesas, at an investment of Rs 1.26 lakh crore as part of an attempt to cut India's dependence on imports to meet requirements of chips.

The units which will make chips for sectors including defence, automobiles and telecommunications, will begin construction within the next 100 days, Telecom Minister Ashwini Vaishnaw told


reporters after the cabinet meeting. The three units will be set up under the 'Development of Semiconductors and Display Manufacturing Ecosystem' programme that provides government support of up to Rs 76,000 crore.

Tata Electronics Pvt Ltd will set up a semiconductor fab in partnership with Taiwan's Powerchip Semiconductor Manufacturing Corp at Dholera in

Gujarat. The plant will have a capacity to produce 50,000 wafers per month and will involve an investment of Rs 91,000 crore. Tata Semiconductor Assembly and Test Pvt Ltd (TSAT) will set up a semiconductor unit in Morigaon, Assam, at an investment of Rs 27,000 crore. CG Power in partnership with Renesas Electronics Corp and Stars Microelectronics of Thailand will set up a unit in Sanand in Gujarat at an investment of Rs 7,600 crore.

In June last year, the Cabinet approved a proposal of Micron for setting up a semiconductor unit in Sanand, Gujarat. The approvals are part of the Modi government's ambitions to make India a chipmaker for the world and cutting reliance on countries like Taiwan.

Vaishnaw said the Tata plant at Dholera will produce high-performance compute chips with 28 nm technology for electric vehicles (EV), telecom, defence, automotive, consumer electronics, display and power electronics.



48 million per day for automotive, electric vehicles, consumer electronics, telecom, and mobile phones. The CG power semiconductor unit will manufacture 15 million chips for consumer, industrial, automotive and power applications.

"Within a very short time, India's semiconductor mission has achieved four big successes. With these units, the semiconductor ecosystem will established in India. India already has deep capabilities in chip design. With these units, our country will develop capabilities in chip fabrication. Advanced packaging technologies will be indigenously developed in India with today's announcement," he said adding the three units will generate direct employment of 20,000 advanced technology jobs and about 60,000 indirect

## Sebi bans entities for manipulative trades in V Marc India

Sebi on Thursday barred 12 entities, including promoter of V Marc India Ltd, from the securities market for engaging in a fraudulent scheme to manipulate volumes and price of the company's shares.

Additionally, the regulator impounded wrongful gains of Rs 6.38 crore made by some of the entities from the manipulative scheme, according to an interim order. This case primarily deals with

India Ltd, listed on NSE's SME and company management, along with connected parties. In its order, Sebi, prima facie, found that V Marc's promoter and MD Vikas Garg and Sandeep Kumar Srivastava, former Whole Time Director

of the company-- engaged the services of Prijesh Kurani to 'operate the market'. It further noted that Kurani, in

fraudulent and manipulative turn, in addition to using his trading in the scrip of V Marc own and his connected entities' trading accounts, segment, prima facie engaged accounts of persons orchestrated by the promoter connected to Garg to connected to Garg to manipulate the scrip. Further, Garg and the company management channelled funds through their connected entities to Kurani for executing the fraudulent scheme.

The alleged fraudulent scheme was set in motion as soon as the scrip was listed on April 8, 2021. "The impact of this alleged fraudulent scheme is

evident in the manner volumes surged and prices increased after which most of the entities -- PV Manipulators-- as well as the IPO subscribers - exited fully. The shares offloaded were purchased by public shareholders leading to the increase in their numbers as well," Sebi said.

Accordingly, Sebi has restrained 12 entities "from buying, selling or dealing in the securities market or associating themselves with the securities market, either

directly or indirectly, in any manner whatsoever until further orders". Apart from the other entities barred by Sebi are -- Sudhir Gupta, Dharini Kurani, Rekha Kurani, Surbhi Aggarwal, Vinod Vilas Sable, Seema Garg, Madhu Srivastava, Jai Kishorr Singhal and Seema Agarwal.

Sebi's examination which covered the period from April 9-30, 2021, was aided by data obtained from the mobile

#### **FDI** inflows decline in April, **December 2023**

 $F^{\text{oreign direct investment}}_{(\text{FDI}) \text{ inflows in India}}$ declined 13 per cent to USD 32.03 billion in April-December 2023, dragged down by lower infusion in computer hardware and software, telecom, auto, and pharma sectors, according to the latest government data.

FDI inflows stood at USD 36.74 billion during the corresponding nine months of the preceding fiscal.

Inflows during the October-December quarter of the current fiscal, however, rose by 18 per cent to USD 11.6 billion as against USD 9.83 billion during the same quarter of 2022-23.

The total FDI — which includes equity inflows, reinvested earnings and other capital — declined by about 7 per cent to USD 51.5 billion during the period under review against USD 55.27 billion in April-December 2022, the data from the Department for Promotion of Industry and Internal Trade (DPIIT) showed.

During the nine-month period of this fiscal, FDI equity inflows decreased from major countries, including Singapore, the US, the UK, Cyprus and the Investments significantly from the Cayman Islands and Cyprus to USD 215 million and USD 796 million, respectively, during April-December 2023 as against the two comparative figures of USD 624 million and USD 1.15

### Protect investors in small, midcap schemes: Sebi to mutual funds

Capital markets regulator Sebi has asked mutual fund houses to put in place a framework to safeguard investors, who invested in smallcap and midcap schemes, amid a "froth building up" in these categories. Also, the regulator has

suggested steps such as restrictions on inflows in these segments, portfolio rebalancing, and laying guidelines to safeguard investors from the firstadvantage redeeming investors.

This came in the backdrop of strong flow in the small and midcap schemes of mutual funds over the last few

In a communication to Association of Mutual Funds in India (AMFI) on Tuesday, Sebi asked the industry body to inform trustees of all the mutual fund houses to frame a policy to protect the interest of investors of smallcap and



midcap schemes.

"In the context of the froth building up in the small and mid-cap segments of the market and the continuing flows in the small and midcap schemes of mutual funds, trustees, in consultation with unitholder committees of the AMCs shall ensure that a policy is put in place to protect the interest of all investors," the regulator said.

The market regulator said that "appropriate" and "proactive measures" should taken by Asset Management Ćompanies (AMCs) and fund managers to protect investors.

"The Union Cabinet, chaired by Prime Minister Narendra Modi, has approved PM-Surya Ghar: Muft Bijli Yojana with a total outlay of Rs 75,021 crore for installing rooftop solar and providing free electricity

### **Even Rohit, Kohli** should play domestic cricket when free: Kirti

Member of the 1983 World Cup-winning team Kirti Azad on Thursday backed the BCCI's directive for cricketers to play Ranji Trophy, saying it's a good move and the rule should be applicable to every India team player, including Rohit Sharma and Virat Kohli. The out-of-favour duo of

Ishan Kishan and Shreyas Iyer were excluded from the list of were excluded from the list of centrally-contracted players after they ignored the directive to play Ranji Trophy. "It (directive) is a very good move. Everybody should be playing Ranji Trophy cricket, but currently the emphasis is on the IPL. It is good, it is entertaining but the real cricket is the (five) days' cricket Playing in domestic cricket. Playing in domestic cricket is good, it keeps you in touch.

But whenever you are free, even if you're a Rohit Sharma or a Virat Kohli, you should go back and play domestic cricket for the state. That (state) gave you the opportunity to be a player, get selected and then play for the country.

He felt that penalising just Ishan and Iyer wasn't right. "Just to penalise the two is not

correct, I think everybody should be penalised. Everybody should be seen with the same mirror," Azad told PTI Video. Azad declined to comment

on whether this was the potential end of the road for İshan and Iyer after their names were excluded from the list of centrallycontracted players.

'My question is, are they playing enough domestic cricket? They are playing T20

cricket, nowadays and every other state has a T20 cricket league. Back in the days when we were starting our careers, players like Bishan Singh Bedi, Madan Lal, Surinder Mohinder Amarnath, Amarnath, Chetan Chauhan, Sunil Gavaskar, Sandeep Patil, Karsan Ghavri played alongside youngsters like me and Ravi Shastri.
"All these senior Test team

players would play for their sides, would play for the pride of their state which seems missing in the youngsters nowadays," he added.

He questioned why India players had issues playing domestic cricket while England cricketers willingly played county cricket when not in the national side. "Look at county cricket; there

are 20-plus counties and there are numerous three-day and four-day games along with T20 cricket, but every player is involved there. If a player is left out of the Test squad, then he returns to play for his county.

'So why can't we have our players playing those domestic matches, that's the big question," he added.

He praised players like Dhruv Jurel and Sarfaraz Khan for finding the balance between T20 cricket for their IPL teams and playing Ranji Trophy.

"There are players like Jurel, Sarfaraz who do play T20 cricket but, at the end of the day, are also representing their states in the Ranji trophy. # Smith pushes for rule reform

Australian batting star Steve Smith has said that the cricketing authorities should urgently address the issue of pacers bowling persistently bouncers to a leg side field, as it restricts a batter's ability to hit the ball "anywhere in front of the wicket".

The former Australia just one or two such deliveries, after which he should be warned or the delivery be called a wide.

"I think there could be some slight rule changes in terms of balls going down the leg side when you set that field. "You really can't hit the ball anywhere in front of the wicket really, and I feel like it is almost like when a (left-arm) spinner comes over the wicket and they get the warning down the leg side and then they start getting 'wided," Smith was quoted as saying by Sydney Morning Herald.

"If you're bowling balls consistently in that area down leg, it should be a similar ruling to the spinner if that makes sense. Basically bowl one or two, then get a warning and then get wides called," he added.

Smith, who made a 31 in Australia's first innings on the opening day of the Test here as Australia ended day one at 279/9, added that if the ball is drifting too much down leg, it's impossible for a batter to

play any kind of stroke. "To have those catchers (fielders) there in position, it can be challenging for sure. The only thing I'd like to see is if you get too much down leg, you can't captain, who is playing the opening Test against New Zealand here, added a there.
