
The last meeting of the Council of Ministers of the current Lok Sabha, led by Prime Minister Narendra Modi Sunday, chaired brainstorming session on the vision document for 'Viksit Bharat 2047' at Sushma Swaraj Bhawan. "Go and win. See you soon," Modi told in the last meeting of the Council of Ministers of the current term.

Confident of returning to power post the General Elections in the next couple of months, Modi and his Ministers worked out a 100day agenda for "immediate steps for quick implementation after the formation of the new Government in May". Government sources said the

Ministers discussed a detailed action plan for the next five years. The meeting came a day after the BIP released the first list of its candidates on 195 seats across 16 States, with the next set of lists due in the next couple of days. Several Ministries articulated their ideas in the meeting, which was called after an initiative by the PM personally to understand the vision of his council of Ministers based on which he is to form the next team if voted back, Government sources said.

The roadmap for Viksit Bharat is the result of more than two years of intensive preparation by all the Central Government Ministries and departments.

"It involved a whole of Government approach involving all Ministries and wide-ranging



State consultations with Governments, academia, industry bodies, civil society, scientific organisations, and mobilisation of youth for seeking their ideas, suggestions, and inputs. More than 2,700 meetings, workshops, and seminars were held at various levels. Suggestions of more than 20 lakh youth were received," Government officials said.

The roadmap for Viksit Bharat has a comprehensive blueprint with clearly articulated national vision, aspirations, goals, and action points. Its goals include areas like economic growth, SDGs, ease of living, ease of doing business, infrastructure, social welfare, etc," the sources said. Several Ministries articulated their ideas in the meeting, which

is likely to be the last such get-together before the Lok Sabha polls are announced.

The Prime Minister has been convening meetings of the entire Council of Ministers periodically to discuss key policy and governance issues. However, this particular meeting has assumed political significance in light of the upcoming Lok Sabha the upcoming Lok

elections, expected to be held in April-May. While the Election Commission

is intensively preparing for the polls, likely to be announced early next week, Modi has a tightly packed schedule. He is expected to attend 29 programmes spread across 12 States and Union Territories over the next 10 days. Continued on Page 2

s winter starts to recede in Amost parts of India, rain and hailstorm have gripped several regions, with the Indian Meteorological Department (IMD) predicting thunderstorms and light to moderate rainfall over the next few days in several States due to formation of western disturbance.

An avalanche hit a village in Himachal Pradesh's Lahaul and Spiti district in the wee hours of Sunday, obstructing the flow of Chenab and triggering an alert in the adjoining area.

Heavy snow and rainfall in Himachal Pradesh in the past two days have triggered over half a dozen avalanches and landslides, leading to closure of over 500 roads, including five



national highways. So far no casualty has been reported in any of the avalanches.

As many as six persons died in separate lightning strike incidents in Uttar Pradesh and separate Haryana as rain and hailstorms lashed parts here.

Flow of Chenab river was obstructed following an avalanche at Dara Waterfall near Jasrat village in Lahaul and Spiti

The district, located at a high altitude, reported heavy snowfall in the past 24 hours.

"Intense spell of rainfall/snowfall is likely to continue over Himachal Pradesh & Uttarakhand and moderate thunderstorm/hailstorm activity over East Uttar Pradesh, Bihar & Sikkim on today and significant decrease thereafter.

This is the time of year when expatriate Malayalees visit their hometowns to partake in the Pooram festivities in their villages. The two indispensable elements of these Poorams are caparisoned elephants and Panchavadyam/Thayambaka, a fusion of percussion instru-

As the Pooram season gains momentum, a debate ensues among Pooram enthusiasts and animal rights activists regarding the cruelty inflicted upon elephants. There was a time when festivals in Aarattupuzha and Thrissur featured hundreds of elephants adorned with Alavattam, Venchamaram, and umbrellas

ments played by more than a However, as the number of domesticated elephants has decreased, the hiring of elephants for Pooram has become a costly proposition. "There are just 500 domesti-

cated elephants in Kerala as owners of the pachyderms are finding it difficult to rear elephants. Kerala is in need of more elephants as the Forest Department has stopped trapping elephants from forests," said Rameshan, an elephant lover based in Palakkadu, whose tea shop is dotted with of varying colours and shapes. pictures of hundreds of ele-



phants. Rameshan says there can be no temple festivals without elephants.

"It is a tradition dating back to hundreds of years," said Ramesh.

V K Venkitachalam, chair-man, Heritage Anoimal Task Force, is waging a battle against deploying elephants for temple festivals. "The cruelty meted out to these elephants by their mahouts and owners put human beings to hang their heads in shame.

scorching sun. There is no hard and fast rule that temple festivals should have elephants," said Venkitachalam. He pointed out that three to four tuskers were killed while they were being tranquilised and called for a probe into the affair.

The daily rent for an elephant to be paraded in the Pooram varies from ₹1,00,000 to ₹1,50,000/. This is in addition to the transportation charge as there are rules that the tuskers should be ferried in trucks

hief Minister Yogi Adityanath, on Sunday, said that a good government's priority was to serve people. He praised Prime Minister Narendra Modi's leadership, stating that the double-engine government focuses on both development and the welfare of the poor, ensuring prosperity along with security, livelihood and respect for faith.

The chief minister performed the bhoomi-pujan and laid the foundation stone of the first veterinary science college of eastern Uttar Pradesh at Tal Nador, Gorakhpur. The construction of this college, to be built on 80 acres, will cost around Rs 350 crore.

Addressing the gathering, Chief Minister Yogi said in the previous governments, people were troubled by goons and mafia and only a few benefited from the schemes, while the majority of the public kept watching helplessly.

He emphasised that under the current government, everyone was benefiting from the schemes without any discrim-

The chief minister mentioned that under the leadership of Prime Minister Modi, the strength of the new India is resonating worldwide. "Such a government has never been seen before, and it is essential to understand this and support the Modi government once again in the upcoming Lok



Sabha elections, realising the slogan of 'Abki Baar, Chaar Sau Paar," he stated.

Parents of missing seaman seek PM intervention for son return

Aggrieved parents of the Amissing Seaman Sahil Verma, hailing from Jammu Sunday made a passionate appeal to the Prime Minister, Defence Minister, and Home Minister to ensure the safe return of their missing son.

This appeal was made by the parents a day after the Western Naval Command of the Indian Navy made public that a Naval Board of Inquiry had been ordered for detailed investigations to ascertain the whereabouts of the missing Seaman Sahil Verma.

Worried family members also demanded a CBI probe into the circumstances leading to his "mysterious disappearance" at sea from an Indian naval ship while on deployment.

On Saturday, the Western Naval Command posted a message on its official handle on X, "In an unfortunate incident, Sahil Verma, Seaman II, has



been reported missing at sea from (an) Indian Naval Ship while on deployment since February 27, 2024. The Navy immediately launched a massive search operation with ships and aircraft, which is continu-

In Jammu, the family members are struggling to receive realtime information in the absence of any direct liaison with the senior officers of the Western Naval Command. On Sunday, father Subash

Chander and mother Rama Kumari — who live in the Ghou Manhasan area of Jammu - sought direct intervention from Prime Minister Narendra Modi, Defence

Minister Rajnath Singh, Home Minister Amit Shah and Jammu and Kashmir Lt Governor Manoj Sinha to ensure the safe return of their missing son.

"It is astonishing that a soldier went missing from his naval ship and is not traceable. I have been told that the CCTV cameras installed on the ship did not find anyone falling into the sea. Then where is my son?" Chander said at his residence on the outskirts of the city. Referring to the information

shared by the superior officers so far Chander said, "We got a call on February 29 informing that our son went missing on board the ship two days before that ... we last talked to him on Sunday (February 25) and nothing is known (about) what happened to him." We want the government to

hand over the case to the CBI Bureau Investigation) for a thorough probe. He was on duty and is missing," he added.

12 names announced by BJP in Kerala

Though the current situa-I tion in the State and the strong anti-incumbency wave against the CPI(M) led Kerala Government favourable for forces opposed to the Marxists, the names of 12 BJP candidates announced on Saturday evening has dampened the spirit of the Hindutva party activists and supporters.

NH 44 closed due to damaged road near Panthyal

PNS JAMMU

The National Highway connecting the Union Territory of Jammu Kashmir with the rest of India suffered damages near Panthyal after a major portion of 5 tunnel was washed away during the fresh spell of heavy rains in the region.

The vulnerable road patch witnessed a similar episode in July 2023, a few months after the T-5 tunnel was thrown open for vehicular movement giving relief to the hapless commuters tired of maneuvering their vehicles through the makeshift tunnel to prevent getting hit by shooting stones. The traffic police department Sunday while posting the latest image of the road condition advised commuters to avoid traveling on the National Highway -44 due to a damaged road near Panthyal.

The road clearing operations were also going on along several patches near Nachlana, Dalwas due to landslides and shooting

Traffic on the National Highway was not allowed for the second consecutive day on Sunday, owing to landslides, mudslides and shooting stones. The multiple landslides triggered by incessant rains between Banihal and Ramban led the highway to be blocked since Saturday. However, with the improvement of the weather, NHAI has stepped up efforts to ensure the early opening of the arterial road.

LG approves draft uniform policy for inter departmental allotment of land

Delhi Lieutenant Governor Vinai Kumar Saxena has approved a draft uniform policy for inter- departmental allotment of land including Subordinate Departments/Autonomous Bodies/Boards. The draft policy assumes significance as there was no uniform policy to deal with the inter-departmental allotment of govern-ment land, which led to inordinate delays extending up to years in the execution of critical projects, even as files to this effect kept shuffling between departments/agencies. The policy is now formulated with the approval of the LG and shall come in force with immediate

"The policy inter alia, deals with the rates at which land shall be allotted, depending upon the nature of the allotment. If the allotment is for public utility it would be free of cost, provided the allotting agency had got the land in question, free of cost. In cases where the allotting agency got the land in question, at some cost i.e by way of acquisition, the rate will be based on no

Highlighting the pressing need for concerted efforts to address the challenges associated with cancer care in India, experts here have urged the government to prioritise the classification of the disease as a notifiable disease and to work towards improving access to comprehensive care and treatment facilities nationwide.

This move, they argue, would ensure accurate reporting of incidence and enable effective follow-up measures, the argued.

Indrani Kaushal, Joint Secretary, Union Health Ministry underscored the gravity of the situation, citing projections from a study conducted by the Indian Council of Medical Research (ICMR). According to the study, India is projected to witness 15.33 lakh new cancer cases annually, with an estimated mortality rate of around 8 lakh.

Speaking at the 'Federation of Indian Chambers of Commerce & Industry (FICCI) Roundtable for the Eastern Region, Kaushal highlighted Odisha as one of the top 12 states contributing significantly to the country's cancer incidence.

The experts also drew attention to the inadequate infrastructure for cancer care in India, noting that 85% of districts in the four Eastern states lack comprehensive cancer care centers.

Only 20% of cancer patients in the country have access to radiotherapy, a crucial treatment modality. Raj Gore, the co-lead of the

Care and CEO of Healthcare Global Enterprises Limited (HCG), emphasized the urgent need for more comprehensive cancer care centers across the nation. He noted that less than 30% of districts in India have access to such facilities, highlighting the magnitude of the problem. "Our task is cut out, and the magnitude of the problem is

far greater than many realise," stated Gore.
"Our focus should not only be on raising awareness and pre-

vention but also on ensuring better patient outcomes through timely and complete treatment of patients," he Gore stressed the importance

of not only raising awareness and prevention efforts but also ensuring better patient outcomes through timely and complete treatment. Additionally, the experts called for enhanced grassroots-level prevention and awareness programs, along with training initiatives for healthcare workers such as Auxiliary Nurse Midwives (ANMs).

The formation of the FICCI Task Force on Cancer Care represents a concerted effort to tackle these challenges head-on. "Our focus should not only

be on raising awareness and prevention but also on ensuring better patient outcomes through timely and complete treatment of patients.

This encompasses improving access to comprehensive cancer care centres and mitigating the additional financial burden on patients and their families," added Gore.

Classify cancer as notifiable | NDRF enhances rescuers skills to ensure dignity of the dead

 $T_{\text{dated to save lives during}}^{\text{he NDRF, which is man-}}$ disasters, has now taken upon itself to train its rescuers and dogs in specialised skills for correct identification of the dead and ensure their dignity. The federal contingency force is working on new areas of victim identification forensics and training of cadaver dogs, NDRF Director General (DG) Atul Karwal told PTI during an interaction.

The DG said a new 'victim identification' capsule has been added to the NDRF's existing module on deceased management that is imparted to the personnel as a part of the basic 'first responder course'.

As part of this module, the National Disaster Response Force (NDRF) rescuers are trained on how to recover and take care of the bodies during accidents and disasters, ensure respect to the mortal remains which may be rotten or broken into pieces, how to put them together and place them in body bags and precautions to be taken so that there is no spread of an epidemic.

"We are shortly going to start a victim identification course from what we learnt during the Balasore rail accident...This is forensic science. When we recovered bodies in Balasore, we later found that the exact location of the recovery was not marked.

'What should have been done is that if we are recovering a body from bogie X, we should put a tag or mark there so that later you can match it with the railway reservation chart or the passenger manifest and ensure that the person is identified swiftly and correctly," Karwal

This course will also train our



rescuers in gaining skills that will enable them to help the local administration and medical staff in taking biometrics and DNA samples of victims in time so that down the line, identification of the deceased is possible, he said.

Karwal said. Dog breeds like the Belgian Malinois, Labrador etc are being tried and this is another avenue which can be explored hereafter, the DG said. Cadaver dogs are trained to pick the odour of the dead inside an earthquake-hit building or any such disaster site. Karwal said a "holistic" review of the training, equipment and the physical and mental capacity of the NDRF personnel has also been undertaken.

We completed a training needs analysis (TNA) along with the experts of the IIM Rohtak, he

A similar TNA was conducted for the Indian Police Service (IPS) trainees at the Sardar Vallabhbhai Patel National Police Academy in Hyderabad when Karwal headed it as its director.

IIM Rohtak experts conducted a survey by putting a questionnaire to all 14,000 rescuers. They looked at ten states and did a survey asking police, home guards, civil defence and local administration they interact with. The experts also went to three places where victims were either addressed or were taken care of by the NDRF, the

'The idea was to find out how did we (NDRF rescuers) come across to other stakeholders, the victims, what attributes do you bring on board which a victim sees but I am blind to and which we might to need to improve upon," he said.

CBI chargesheets seven in Manipur armoury loot case

The CBI has filed a charge sheet against seven accused in connection with the looting of arms and ammunition from the Bishnupur police armoury during the Manipur ethnic violence last year, officials said on Sunday. The Central Bureau of

The Central Bureau of Investigation (CBI), which is probing cases related to the ethnic clashes in Manipur, recently filed its charge sheet before the court of chief judicial magistrate in Kamrup (Metro) in Assam's Guwahati. The accused named in the The accused named in the charge sheet are Laishram Prem Singh, Khumukcham Dhiren alias Thapkpa, Moirangthem Anand Singh, Athokpam Kajit alias Kishorjit, Loukrakpam Michael Mangangcha alias Michael, Konthoujam Romojit Meitei alias Romojit, and Keisham Johnson alias Johnson. On August 3 last year, a mob looted more than 300 weapons, 19,800 rounds of ammunition and other accessories from two rooms of the 2nd Indian Reserve Battalion headquarters at



Naranseina in Bishnupur. Around 9,000 rounds of bul-Imphal.

lets of different calibres, an AK series assault rifle, three 'Ghaatak' rifles, 195 self-loading rifles, five MP-5 guns, 16 9mm pistols, 25 bulletproof jackets, 21 carbines, and 124 hand grenades, among others, were looted by the mob, the officials said.

Barring Laishram Prem Singh and Khumukcham Dhiren alias Thapkpa, the remaining five have been earlier chargesheeted by the CBI in looting of police armoury at the Manipur Police Training Centre (MPTC) at Pangei in

This incident took place on May 4 last year, the day ethnic clashes between the majority Metei community and tribal Kukis broke out in the northeast state. As alleged in the FIR, a mob stormed into the MPTC complex and looted a huge number of arms and ammunition from the

Moirangthem Anand Singh is alleged to be a former member of the proscribed People's Liberation Army (PLA) of Manipur and the Kangleipak

while the remaining are believed to be overground workers of valley-based banned terror outfits.

They had earlier been arrested by the Manipur Police in September last year when they were allegedly extorting money by wearing police uniform and carrying sophisticated weapons, the officials said. Their arrest had sparked off a protest that continued for two days.

The five were released following a court order but Singh was picked up by the National Investigation Agency (NIA), placed under arrest and brought to the national capital.

Singh was arrested for allegedly having links with Myanmar-based rebel groups and conspiring to wage war against India by exploiting the current ethnic unrest in Manipur. While Singh is in judicial custody, the fate of the other six was not immediate-

The Supreme Court in August last year had transferred all CBI cases from Manipur to Assam.

The tribals, including Nagas and Kukis, who make up 40 per cent, primarily inhabit the hill districts.

The NIA had on February 2 chargesheeted two other persons in the case.

Mishra, also known as Vanbihariji, Doctor Saab, Janardan, Dada and Baba Ji,

NGT seeks Centre response on plea seeking to declare Jim Corbett Park as eco sensitive zone

The National Green Tribunal has sought the Centre's response on a plea seeking directions to declare the Jim Corbett National Park in Uttarakhand as an Eco-Sensitive Zone.

The green panel was hearing a plea underlining that such a declaration is vital for protecting and conserving the ecology, wildlife, biological diversity, and the flora and fauna of the national park.

The National Environment Policy of 2006 defines an Eco-Sensitive Zone (ESZ) as areas or zones with identified environ-

mental resources having incomparable values that require special attention for their conservation because of their landscape, wildlife, biodiversity, historical and natural values. A bench of National Green Tribunal Chairperson Justice Prakash Shrivastava and Expert Member A Senthil Vel said, "The original application (OA) raises a substantial issue relating to compliance with the environmental norms."

"Issue notice to the respondents," it added in an order passed last month.

The respondents in the matter include the Union Ministry of

Environment, Forest and

Climate Change, National Board for Wildlife, National Tiger Conservation Authority, Empowered Central Committee (formed by the Supreme Court), and the states of Uttarakhand and Uttar Pradesh along with their principal chief conservators of forests and the district magistrates concerned. According to the plea by advocate Nandita Bansal, the min-

istry issued the Wildlife Conservation Strategy of 2002, categorically stating that land falling within 10 kilometres of the boundaries of national parks and sanctuaries should be notified as 'Eco-Fragile Zones'.

BJP names 195 in first list; retains some MPs, drops some and moves a few from RS to LS poll arena

he well-oiled poll machinery of the BJP has released its first list of candidates for the Lok Sabha elections, leding to intrigue and speculation across political circles. With this move, the party has not only initiated its electoral process even though the election dates have not yet been announced, it has also sent out strategic messages through its selection of candidates. The decision to retain some MPs, drop others, and move certain members from the States or the Rajya Sabha to the Lok Sabha poll arena carries significant implications. The retention of several incumbents underscores the party's commitment to stability and continuity in its leadership. By fielding sitting MPs or MLAs, the BJP aims to leverage their incumbency advantages, including name recognition, constituency connect and established voter base. he Raisina Dialogue, a conference held annually in New Delhi, is India's flagship conference on geopolitics. One may wonder why Greece's Prime Minister Kyriakos Mitsotakis was the chief guest and what importance Greece play in the larger scheme of things as far as India is concerned. One may recollect that Turkey has been taking an anti-India stance at most of the international forums. A SPOT OF GOOD NEWS

Sir — A recent wildlife survey conducted by India's Ministry of Environment indicates a rise in the national leopard population. This is a significant development for conservation efforts, with estimates suggesting an increase of approximately 1% annually between 2018 and 2022, reaching a total of 13,874 individuals, Madhya Pradesh currently boasts the highest leopard population within the country, with nearly 4,000 residing within its borders. However, it is crucial to acknowledge that some limitations exist within the data. The survey methodology excluded non-forested areas, high-altitude regions, and certain arid environments, which could potentially hold additional leopard populations.

Á critical challenge facing leopard conservation is the increasing human-wildlife conflict. As human settlements expand and encroach upon leopard habitats, these magnificent creatures are forced to venture into populated areas in search of prey and territory. The population increase signifies a positive trend for leopard conservation in Îndia. The success of conservation initiatives within tiger reserves, which also serve as crucial habitats for leopards, appears to be a contributing factor. Continued efforts to address human-wildlife conflict, expand surveys to encompass a wider range of habitats, and focus on habitat protection will be essential to ensure the long-term sustainability of leopard populations nationwide.

The inspiring saga of the Goat Bank



Despite its significant contribution to the economy, the goat sector largely operates in the informal market, underscoring the need for greater recognition

n a remarkable feat of rural innovation, Kalahandi couple Jayanti Mahapatra and Biren Sahu have earned praise from Prime Minister Narendra Modi for their groundbreaking agri-tech startup located in the remote Salebhata village. Their unique Goat Bank, recognised in 'Mann Ki Baat,' breaks traditional banking norms, empowering local farmers and uplifting the community's socio-economic status through innovative rural solutions.

Goats often referred to as the "ATM" or "poor man's cow," play a pivotal role in India's livelihoods and nutritional security. Their popularity stems from factors such as low capital investment, adaptability, early maturity, prolific breeding, superior chevon quality, and steady returns. Amid changing agro-climatic conditions, goats emerge as the 'Future Animal' for national prosperity. Goat meat commands a premium in the market and goat milk offers therapeutic benefits. Despite constituting 27.80 per cent of the total livestock and contribut-ing significantly to the national economy with annual revenue of Rs 38,590 crores, the goat sector often operates in the informal and untaxed market. The goat, however, deserves serious attention and investment. Contributing 3% of milk, 13.8% of goat meat, and 0.18 million tonnes of skin in India, goats have immense economic potential. As goat farmers strive for financial inclusion, recognising and investing in the goat sector can lead to substantial economic upliftment, making it imperative for the goat to take centre stage in national agricultural and economic planning. Traditionally, successful livestock devel-

opment strategies have heavily relied on providing credit to empower underprivileged individuals to acquire or replenish their livestock. This not only marks the initial foray into livestock ownership but also serves as a pivotal step towards breaking free from the shackles of poverty, paving the way for a more secure and prosperous life. In the evolution of livestock development strategies, the traditional reliance on credit to empower underprivileged individuals has given rise to an innovative approach embodied by the Goat Bank.

Welcome to the innovative realm of the Goat Bank, where farming dreams come alive with a unique twist. Instead of conventional cash, the bank offers aspiring farmers a lifeline in the form of a pregnant female goat. It's not a giveaway; a deal is struck. Deserving farmers receive guidance on scientific goat rearing, along with support for vaccinations, deworming, ear tagging, and premium concentrate feed during pregnancy. In return, farmers commit to caring for the goats and returning six to eight kids to the Goat Bank.

The math magic unfolds as goats, with a 7 to 8-month kidding interval, yield two or three kids in each kidding cycle. Over two years, farmers find themselves with an impressive twelve to fourteen kids from just two does. Beyond personal gain, these farmers extend the goat family, nurturing them and, when the time is right, selling them for a lucrative profit. This cycle of goat generosity creates a symbiotic relationship, with benefits flowing from the Goat Bank to the farmers and ultimately reaching the market. It's a win-win scenario, shaping

accountability, propelling a sustainable growth cycle. Women participating in goat rearing anticipate significant profits, enabling investments in land, and education, and celebrating life's milestones. In Salebhata village, Kalahandi

district of Odisha, the Goat Bank, Mahapatra and Biren Sahu, offers needy farmers two adult female goats, hailing from the resilient breeds of native Kalahandi or Black Bengal. During two years, the goats exhibit their prolific nature, birthing impressive 9-10 kids. The bank retains six of these newborns, channelling the rest back to the same families dedicated to goat farming. This sustainable cycle has now woven a network connecting 1,000 farmers across 50 villages.

expanse of western Odisha, encompassing Kalahandi and Nuapada districts, the author's research illuminates a striking reality: 95% of goats thrive as indigenous, hardy, uniquely adapted to endure temperatures soaring up to 48°C.

a pathway for sustainable farm- ings under semi-extensive systems, relying solely on roadside grass and tree leaves as their primary sustenance, achieving impressive average adult body weights of 35 kg for males and 30 kg for females. The elegance of this agricultural practice lies in its simplicity, relying on family labour and minimal investment, mainly directed towards veterinary care. Farmers, with negligible expenditure, witness sub-

stantial profits.
The sale of castrated males after four years commands prices between Rs. 25,000 to 30,000, while females are priced slightly lower. During the Chatar Parab festival (a local festival), prices experience a commendable surge, contributing to an annual income of approximately Rs. 100,000 from goat sales.

Through extensive interviews, the author uncovers a burgeoning interest among landless farmers to engage in goat rearing, signalling a desire for expansion. However, these aspiring farmers articulate a need for essential elements like proper housing, quality feed, and a superior breeding buck to unleash the full growth potential of their goat herds.

While existing state government schemes provide very good assistance to many goat farmers in this zone, the author still posits that pioneering initiatives like a goat bank have the potential to include more landless, downtrodden farmers in the journey. Such innovative concepts could substantially contribute to the financial stability and prosperity of a

ing native goats and enhancing the overall well-being of the farming community in the area. The success stories from Salebhata village in Kalahandi and Sangavi Mohadi village in Maharashtra illustrate how the Goat Bank is not merely an institution but a catalyst for positive change. As Prime Minister Narendra Modi rightfully recognises the transformative power of such initiatives, it becomes evident that the goat, often overlooked, deserves centre stage as a species worthy of serious investment. The Goat Bank model showcases a sustainable cycle of growth, from the bank to the farmers and eventually to the market, fostering economic upliftment and financial inclu-

ing a promising avenue for uplift-

Creating awareness about menstrual rights among men

Menstrual rights encompass not only access to hygiene products but also the eradication of discriminatory practices surrounding this natural biological phenomenon

enstruation, a natural facet of human . **V ⊥** existence, has often been cloaked in stigma and silence. As we delve into the stories from Leh, it is crucial to understand the broader context of menstrual rights and the significance of these conversations. Menstrual rights include access to menstrual hygiene products, comprehensive education about menstruation, and the elimination of discriminatory practices associated with this natural biological process. The lack of awareness has fueled a culture of shame and secrecy. In Leh, the conversation around menstruation has undergone a transformative journey. Traditionally, whispers among friends were the primary source of information



for young girls, making it a taboo subject. However, today, strides have been made, enabling open discussions, particularly between mothers and daughters.

In Leh, the celebration of Menstrual Hygiene Day on May 28th, 2023, is a significant event. The event, exclusively held at a government girl's higher secondary school, reflects a pivotal shift. Surprisingly, on this day, not a words like "periods" in public,

single male presence is noted; only the cameraperson was a man. Why do we think that including men in this conversation isn't important?

In Leh, most of the shopkeepers give pads wrapped in newspapers. Wrapping a pad in the newspaper is not a solution; rather, it perpetuates improper handling of menstrual products. There is a need for a more respectful and informed approach to changing societal norms and practices surrounding menstruation. Mutup Dolma, a 17-year-old from Hanu village, which is approximately 200 kilometres from Leh, shares her story about periods. In her hometown, it's not easy to talk openly about menstruation. People feel uncomfortable saying and asking for pads from male shopkeepers is a challenge.

When Mutup moved to Leh for school, things changed. In Leh, she could buy pads without feeling awkward because people didn't know her. But in her hometown, cultural norms made talking about periods difficult. Mutup thinks it is very important to have an open conversation. "I got scared when I got my first period," recalled Mutup. It was hard for her to understand what was happening until she talked to her mom. She mentioned, "When sometimes my mom isn't home, it is very difficult to ask for money from my father for menstrual products." Moving to Leh for education made it easier for her to buy menstrual products, but she realised the gap in awareness between urban and rural

Hailing from Ibex Colony in Leh, Tsewang Namgyal, a 17year-old boy, noticed something strange in his science class. Whenever their teacher explained the menstrual cycle, his friends would laugh. When he tried to tell them it was a biological process and shouldn't be mocked, they made fun of him. This laughter affected the girls in their class, making them feel embarrassed.

Going back to his village, Tsewang observed that his cousins were hesitant to discuss menstruation due to a lack of awareness. Jigmet Skit, a 19-year-old resident of Skara, Leh, shares her perspective on menstruation. Despite being part of many menstrual awareness programmes in school,

she expresses discomfort due to the segregation of boys from these discussions. Jigmet believes that schools should create an open environment like home, fostering learning and awareness rather than

perpetuating secrecy. According to Jigmet, the awkwardness in society stems from the practice of hiding menstruation, especially in schools. She emphasises that women should openly share information to eliminate discomfort and encourage discussions about menstrual health. In her experience, when she gets her period, she is not able to go out for 3 days because of the pain, and it becomes difficult when they ask why she is not able to go out; it becomes difficult to answer her friends and even her father due to a

hopes that breaking the silence and providing equal awareness will end the societal awkwardness around menstruation. This, she believes, will enable girls to share their problems openly and make it easier for everyone to endure. Abdul Wahid, age 21, a resident of Shenam Leh, reflects on his school days when he and his friends lacked awareness about menstruation. He recalls an incident where they would check girls' bags and laugh at the sight of pads. However, upon moving to Delhi for studies, he noticed a stark difference in people's openness about menstruation. Now, during his visits to Leh, Abdul actively helps his cousin's sister to buy pads, a task he once refused to do dur-

ing his school days. He emphasises the importance of open conversations about menstruation, highlighting that knowledge about periods enables individuals to assist someone in need during menstruation. Stories from Mutup, Tsewang, Jigmet, and Abdul show the changes and challenges in understanding menstruation. Leh is making progress by celebrating Menstrual Hygiene Day and encouraging discussions. Despite this, there's still a need for better education about periods. Changing cultural norms and ensuring menstrual rights are essential for a society free from shame and secrecy. Netanyahu and his top rival clash rocks Israel's war-time cabinet

A top Israeli Cabinet minister headed to Washington on Sunday for talks with US officials, sparking a rebuke from Prime Minister Benjamin Netanyahu, according to an Israeli official, in a sign of widening cracks in Israel's wartime government nearly five months into its war with

The trip by Benny Gantz, a centrist political rival who joined Netanyahu's hard-line government in the early days of the war following Hamas' October 7 attack on southern Israel, comes amid deep disagreements between Netanyahu and President Joe Biden over how to alleviate the suffering of Palestinians in Gaza and create a post-war

vision for the enclave. The US was prompted to airdrop aid into Gaza on Saturday after dozens of Palestinians rushing to grab food from trucks were killed last week. The airdrops circumvent what's been a prohibitive aid delivery system, which has been hobbled by Israeli restrictions, logistical issues within Gaza as well as the fighting inside the tiny enclave. Aid officials say the airdrops are far less effective than the aid sent via

US priorities in the region have increasingly been hampered by Netanyahu's hard-line Cabinet, where ultranationalists dominate. Gantz's more moderate party at times acts as a counterweight to Netanyahu's far-right allies.

An official from Netanyahu's Likud party said Gantz's visit was without authorisation from the Israeli leader. The official said Netanyahu had a "tough talk" with Gantz about the trip and told him the country has "just one prime minis-

An Israeli official said ntz had informed Netanyahu of his intention to travel to the US and to coordinate messaging with him. The official said the visit is meant to strengthen ties with Washington, to bolster support for Israel's ground campaign and to push for the release of

The bundles were dropped in southwest Gaza, on the beach along the territory's Mediterranean coast. The airdrop was coordinated with the Royal Jordanian Air Force, which said it had two food airdrops Saturday in northern Gaza and has conducted several rounds in recent months.

The amount of aid flowing to Gaza is not nearly enough and we will continue to pull out every stop we can to get more aid in," President Joe Biden said Saturday in a post on the social media site X, formerly known as Twitter.

US Central Command said on X that "the combined operation included U.S. Air Force and RJAF C-130 aircraft and respective Army Soldiers specialized in aerial delivery of supplies, built bundles and ensured the safe drop of food aid."The US airdrop is expected to be the first of many. Belgrade (AP): A key vote for control of Serbia's capital, Belgrade — a focal point of widespread fraud reports after last December elections — is to be rerun later this year, officials said Sunday. The announcement follows months of soaring political tensions over claims that the ruling populists of President Aleksandar Vucic orchestrated a fraud in the vote for Belgrade's city assembly. The right-wing Serbian Progressive Party was declared the winner of the December 17 election. But the main opposition alliance, Serbia Against Violence, have insisted they were robbed of a victory in Belgrade and that the parliamentary vote that took place at the same time was also marred by widespread irregularities. The dispute has led to large street protests. It was not immediately clear when the new vote would be held. Sunday marked the formal deadline to form the Belgrade city authorities following the vote in December.

Election for |MQ9-B| drone sales to India enters next step

The sale of 31 MQ9-B SkyGuardian Drones to India is expected to be fast-tracked now that the major hurdle of mandatory 30 days of Congressional potification is Congressional notification is likely to pass without any objection from the lawmakers on Sunday, but for the routine procedural matters posed by the upcoming general elections.

The Defence Security

Cooperation Agency (DSCA) notified the US Congress in February about the determination of the State Department of a possible Foreign Military Sale to India of 31 MQ-9B Remotely Piloted Aircraft and related equipment for an esti-mated cost of USD 3.99 billion.

The 31 MQ9-B SkyGuardian Drones itself cost USD 1.70 billion, while the rest of the services including technology and equipment are estimated to cost USD 2.29 billion. In addition to 31 MQ-9B SkyGuardian Aircraft, the proposed deal includes 161 Embedded Global Positioning & Inertial Navigation Systems (EGIs), 35 L3 Rio Grande Communications Intelligence Sensor Suite.



"This sale is necessary in furtherance of the US foreign policy and national security objectives," the notification

The next step is for the United States to send a letter of offer and acceptance to India, which under normal circumstances should be considered as a mere formality.

Announced President Joe Biden during Prime Minister Narendra Modi's visit to Washington DC in June 2023, all major legal and bureaucratic procedures on the issue have already been cleared from the Indian side including that from the Union Cabinet. After the letter goes out

The announcement of the general election, which brings into force the Model Code of Conduct, is unlikely to pose

any last legal hurdle. "Model Code is not applicable to any matter pertaining directly to the defence forces be it the recruitments/promotions for defence forces, any service matters pertaining to them, defence purchases of any kind, tenders relating to the matter of the defence forces and therefore no reference in such matters need to be sent to the Election Commission," says the Model Code of Conduct issued by the Election Commission of India.

'These instructions shall be treated as standing instructions of the Commission and will be applicable for all elections in future. This may be brought to the notice of all concerned for future guidance," said the Election Commission of India in a letter issued on the issue to the Ministry of Defence on March 27, 2014, in response to a query.

Medical plane carrying Norway's King Harald V departs Malaysia

An airplane carrying Norway's King Harald V departed Malaysia on Sunday, a day after he was implanted with a pacemaker. Europe's oldest reigning monarch was hospitalised for an infection during a private vacation on the northern resort island of Langkawi, the royal house said Tuesday. He underwent surgery at the Sultanah Maliha Hospital on Saturday to implant a temporary pacemaker due to a low heart rate, according to the royal house. Norwegian media outlets said Harald travelled to Malaysia with his wife, Queen Sonja, to celebrate his 87th birthday. A Scandinavian Airlines medical evacuation plane, which took off from Oslo on Thursday, arrived in Langkawi on Friday. The Boeing 737-700 aircraft has king's transport back to

previously been used as a flying ambulance. According to Flightradar24, the same plane departed from Langkawi on Sunday headed for Sharjah in the United Arab Emirates, from where it is scheduled to travel onward to Norway.

The Norwegian royal house confirmed Sunday that the monarch has left Malaysia and the plane is expected to arrive in Oslo early Monday.

"Upon arrival in Norway, His Majesty will be admitted to the (Oslo) hospital Rikshospitalet," the royal palace said, adding that Harald would remain on sick leave for the next two weeks, during which Crown Prince Haakon will assume the monarch's duties.

According to Norwegian news agency NTB, which cited

Norway will cost an estimated 2 million Norwegian kroner (USD 190,000), which will be taken from the defense budget.

The aging Norwegian monarch has suffered from frail health over the past few years, and has been admitted to a hospital for treatment on numerous occasions. Harald who has been seen using crutches, had an operation to replace a heart valve in October 2020 after being hospitalized with breathing difficulties.

Harald has repeatedly said he has no plans to abdicate, unlike his second cousin Queen Margrethe II of Denmark, who stepped down earlier this year. Harald's duties as Norway's

head of state are ceremonial and he holds no political power. He ascended to the throne following the death of his father, King Olav, in 1991.

Satellite data showed the plane deviated from its flight path and was believed to have crashed in the southern Indian Ocean.

But an expensive multinational government search failed to turn up any clues, although several pieces of debris washed ashore on the east African coast and Indian Ocean islands. A private search in 2018 by Ocean Infinity also found nothing but the tragedy sparked moves to bolster aviation safety.

'Extremist preachers from countries like Pak to be blocked from entering UK'

London (PTI): Hate preachers with extremist Islamist views from countries such as Pakistan, Afghanistan and Indonesia will be blocked from entering Britain under new plans being drafted by the government, according to a UK media report on Sunday.

The Daily Telegraph reports that the British government is concerned about a "shocking increase" in extremist activity and officials are being deputed to identify the most dangerous extremists from overseas so they can be added to visa warning lists. Under the new plans, those on the list will be automatically refused entry to the UK. The revelation comes days

after British Prime Minister Rishi Sunak delivered an impassioned speech from the podium at 10 Downing Street in London, warning that the country's democratic and multi-faith values were under threat by extremists.

"We will also act to prevent people entering this country whose aim is to undermine its values," Sunak said in his speech on Friday.

"The Home Secretary has instructed that if those here on visas choose to spew hate on protests or seek to intimidate people we will remove their right to be here," he said.

The British Indian leader had also appealed to demonstrators taking to the streets of the country to protest against the Israel-Hamas conflict to ensure their actions are not hijacked by extremists.

"The time has now come for us all to stand together to combat the forces of division and beat this poison. We must face down the extremists who would tear us apart," he said, warning that "Islamist extremists and the far right feed off and embolden each other".

Thousands took to the streets for another wave of pro-Palestine protests on Saturday, with the Metropolitan Police making 12 arrests for activities in breach of peace in London.

According to 'The Daily Telegraph' report, an official review by Lord Walney, the government's independent adviser on political violence and disruption, calls on ministers to tackle the growing threat posed by fringe, Left-wing groups that have allied with Islamist extremists at such pro-Palestine marches across the

"One of the conclusions of my review is to look at and understand the threat from anti-democratic far-Left groups, alongside that posed by Islamists and the far right... You are seeing an unholy alliance between far-Left groups and some of the Islamist extremism that has been seen on the marches," he told the

Walney's report is with the UK Home Office and is due to be published later this month.

"Extremism has no place in our society and we will not tolerate tactics that set out to intimidate, threaten or cause disruption to the law-abiding majority," a Home Office spokesperson said.

"În recent months, we have also witnessed a small number of protestors display violent and hateful behaviour, and the police have our full support in tackling extremism and hate crime.

We are considering the report's recommendations extremely carefully and will respond in due course," the spokesperson said.

Organised crime attacks on local candidates raise fears Mexico City

 $A^{s\,\,\mathrm{Mexico}}$ prepares for the largest elections in its history, organised crime is once again preying on local candidates across swaths of the country where cartels dominate, raising concerns among experts that these could be Mexico's bloodiest elections ever. Julian Lopez, coordinator for the Citizen Movement party in the southern state of Guerrero, experienced it first hand when rifle-toting gunmen abducted him and two colleagues while they were driving on Feb. 7. The 43-year-old López was beaten, stripped of his possessions, made to kneel near a remote garbage dump and ultimately abandoned in the middle of the night.Two mayoral hopefuls in the town of Maravatio in neighboring Michoacan state were not so fortunate. They were killed by gunmen within hours

of each other Monday. One was from the governing Morena party of President Andrés Manuel López Obrador, the other from the conservative National Action Party. A third mayoral hopeful from that town was abducted and found dead in November. On Feb. 10, a man running for Congress for the Morena party in the sprawling Mexico City suburb of Ecatepec was fatally shot in the street alongside his brother. He had allegedly received threats from a local union. A month earlier, on Jan. 5, the local leader of the Institutional Revolutionary



Shehbaz becomes Pak PM for second time

Vows to rebuild economy

 $P_{\substack{\text{debt-trapped economy and}}}^{\text{ledging to revive Pakistan's}}$ eradicate terrorism, newlyelected Prime Minister Shehbaz Sharif on Sunday said his government would not allow the country to become part of some "great game" and would maintain cordial relations with neighbours based on the principles of equality.


In his victory speech in the National Assembly soon after he was elected as the 24th prime minister and for a second time since 2022, the 72year-old profusely thanked his elder brother and three-time former premier Nawaz Sharif and allies for putting their trust in him and allowing him to head a coalition government after last month's election resulted in a hung Parliament.

While Shehbaz secured 201 votes, his challenger Omar Ayub Khan of jailed former prime minister Imran Khan's Pakistan Tehreek-e-Insaf (PTI) got only 92 votes in the election held at the newly-elected National Assembly

Shehbaz said that as no party secured a clear parliamentary majority, it was "the democratic way" that "likeminded parties may form a coalition government".

Following the February 8 marred by allegations of vote rigging, the Pakistan Muslim League Nawaz (PML-N) headed by Nawaz Sharif, reached a coalition deal with the Pakistan Peoples Party (PPP) led by former foreign minister Bilawal Zardari-Bhutto.

This post-poll deal effectively ensured that jailed former prime minister Imran Khan's PTI party would not return to power though independent candidates backed by it won the maximum number of seats in Parliament. Amidst vociferous sloganeering by the members of Imran Khan's party members against alleged "mandate



thieves," Shehbaz warned that Pakistan was facing an alarming debt crisis where even the expenditures of the National Assembly were being paid by borrowing money.

He said that his govern-

ment would work hard and set a goal to become a member of G20 countries by 2030. The G20 or Group of 20 is an intergovernmental forum of the world's major developed and developing economies.

He said that Pakistan would not become part of any "great game" and his government would increase the number of friends. He pledged to build and improve ties with all leading nations, including its neighbours.

We will keep ties with neighbours on the basis of equality," Shehbaz said.

Shehbaz, however, raked the Kashmir issue and equated it with Palestine. "Let's all come together [...] and the National Assembly should pass a resolution for the freedom of Kashmiris and Palestinians," he added. Shehbaz said that his elder brother has never even thought of harming the country, unlike his opponents.

More than 100 supporters of PTI protesting vote rigging arrested

More than 100 supporters of jailed former prime minister Imran Khan's party have been arrested from different parts of Punjab province of Pakistan for staging rallies against alleged vote rigging, police said on Sunday.

On the call of party founder Imran Khan, supporters of Pakistan Tehreek-e-Insaf (PTI) party held protests across Pakistan on Saturday against the alle-ged "massive rigging" in the February 8 general elections. Most arrests took place in Lahore where newly elect-ed Chief Minister Punjab Maryam Nawaz ordered a clamp down on the protesting PTI supporters. "Police thrashed and arrested 80 workers and leaders in Lahore. Over 20 have been arrested in Guirat city. Protests were held in 38 cities of Punjab and the federal capital Islamabad," a PTI spokesperson said on

Shehbaz a favourite

Shehbaz Sharif, who is known to be an astute politician and a good administrator, has once again donned the mantle of prime ministership of cash-strapped Pakistan by a quirk of fate and his amicable ties with the powerful establishment in the coup-prone country.

The 72-year-old President of Pakistan Muslim League-Nawaz (PML-N), the younger brother of former prime minister Nawaz Sharif, always played the second fiddle to the 74-yearold party supremo, who returned to Pakistan in October last year, in his bid to script history by becoming the premier for a record fourth time in However, the outcome of

the February 8 elections crushed Nawaz Sharif's dream of becoming the prime minister for the fourth time. The PML-N, which was hoping to form a government on its own, won only 75 seats, trailing behind independent candidates backed by jailed former prime minister Imran Khan's Pakistan Tehreeke-Insaf (PTI) in the 336-member National Assembly.

With the election leading to a hung Parliament, the PML-N did not have much of a choice, but to form a coalition government to prevent Khan's PTI from making its bid to return to Nawaz had tasked Shehbaz

to negotiate with other likeminded parties on the formation of a coalition government. However, the PML-N party soon realised that there was opposition to Nawaz Sharif's candidacy. Thus, the elder Sharif was left with no choice but to nominate his younger brother as the consensus prime ministerial candidate of the PML-N and the Bilawal Bhutto-Zardari-led Pakistan Peoples Party (PPP) last month.

Party sources say Nawaz was not comfortable heading a coalition government and abdicated his claim for the premiership in favour of his younger brother, who seemed to have the blessings of the military. Shehbaz reportedly rejected several offers by the powerful establishment on different occasions to become prime minister tion of mega projects, which popularised a new local phrase of 'Shehbaz Sharif speed' for development schemes.

During his two successive tenures as chief minister of Punjab (2008-2013 and 2013-2018), a network of underpasses, overhead bridges and mass transit systems was introduced in the most populous Punjab province and was

completed in record time. Born in September 1951 in Punjabi-speaking Kashmiri family in Lahore, Shehbaz did his graduation from the Government College University, Lahore. His family emigrated from Anantnag in Kashmir for business and settled in the village of Jati Umra in Amritsar district, Punjab at the beginning of the 20th century before moving to Pakistan. Shehbaz, who looked after

the sprawling family business, hit the political scene in the late 1980s when he was elected as a member of the Punjab Assembly in 1988. Shehbaz served as chief minister of Punjab from 1997 to 1999, when his brother was serving his second term as prime min ister but fell out with the military. Following General Pervez Musharraf's coup in 1999 toppling the Nawaz Sharif government, Shehbaz along with the family spent eight years in exile in Saudi Arabia after striking a deal with the then-military

The family returned to Pakistan in 2007. Shehbaz wore the hat of Punjab chief minister for the second term in 2008 and he won the same slot for the third time in 2013. After thenprime minister Nawaz Sharif was disqualified from holding office in 2017 in the Panama Papers case, the PML-N appointed Shehbaz as its presi-

Shehbaz also showed himself as an astute politician when he served as a leader of the opposition from 2018 to 2022 after the PML-N lost to Khan's PTI in the 2018 polls. It was once again quite a tough period for the Sharifs, as the elder Sharif was convicted in two different cases of corruption, along with his daughter, and jailed.

Death toll rises from drone strike on Ukrainian port city

The death toll rose to 10 on ■ Sunday from a Russian drone strike that destroyed an apartment block in Ukraine's southern port city of Odesa the previous day when a local official reported that the body of a third child was pulled from the rubble. Ukrainian President Volodymyr Zelenskyy called on Western allies to boost Ukraine's air defences in the wake of the deadly attack.

Oleh Kiper, the governor of the Odesa region, said on Telegram that rescue workers on Sunday morning retrieved the remains of a woman and her baby, who appeared "not even a year old".

Kiper added that emergency services continue to comb through the rubble. On Saturday, Ukrainian authorities reported that a months-old baby was among those killed

Pak Senate to take up motion seeking permanent ban on social media sites

Amidst serious concerns over the continued disruption of the social media platform X in Pakistan for over a fortnight now, a member of the Senate has demanded a permanent ban on all social media due to its negative impact on the younger generation. Senator Bahramand Khan Tangi, who was recently expelled by the Pakistan Peoples Party (PPP) after he moved a resolution seeking the delaying of the February 8 polls, in the resolution called for a complete ban on all social media platforms, deeming them detrimental to the future of the

SL tourism sector sees 122% growth in Jan '24 compared to last year, says minister PTI ■ COLOMBO

Sri Lankan minister on A Sunday said the country's external sector performance has seen a marked improvement year on year with tourism fetching USD 342 million in January 2024, an impressive 122 per cent jump from last year. Speaking in Ruwanwella, his home constituency, Minister of State for Finance Ranjith Siyambalapitiya was delving into the Central Bank of Sri Lanka's external sector indicators issued mid-week.

Siyambalapitiya said the bank figures show that receipts from tourism had fetched USD 342 million, which is a 122 per cent growth in January 2024 year on year. The inward remittances from Sri Lankan expats in January 2024 had grown by five per cent to USD 488 mil-

lion up from USD 467 million in January 2023. The Sri Lankan rupee, which had seen a massive slump during the unprecedented economic crisis, had appreciated by 14.6 per cent in January of this year.

The foreign reserves had increased to USD 4.5 billion in January up 114 per cent from USD 2.1 billion in January 2023. The economy recorded positive growth in the third quarter of 2023 after six successive quarters of negative growth, Siyambalapitiya said. Sri Lanka in the second quarter of 2022 had declared bankruptcy announcing the island's first ever sovereign default.

Negotiations with the IMF for a bailout began almost immediately and the first tranche of the USD 2.9 billion facility was released in March generating immense wealth from its oil reserves.

Kuwait to hold polls on Apr 4, latest round of voting in years of turmoil

Kuwait said on Saturday it will hold elections for its national assembly on April 4, its latest round of voting after years of political turmoil. The state-run KUNA news agency made the announcement, citing a decree published by the oil-rich country's official gazette. In February, Kuwait's emir dissolved parliament after a lawmaker reportedly insulted the ruler.

Domestic political disputes have been gripping Kuwait for years — including the overhaul of Kuwait's welfare system which prevented the sheikhdom from taking on debt. That has left it with little in its coffers to pay bloated public sector salaries, despite

Parliament has been repeatedly dissolved after failing to move forward, with Kuwait's Constitutional Court in 2023 annulling a 2022 decree overturning another such annulment. India used car market to touch \$100 billion by 2034: CARS24

"According to our internal study, the anticipated growth of the Indian used car market is set to occur at a 15 per cent CAGR, increasing from USD 25 billion in 2023 to USD 100 billion by 2034," Chopra told PTI in an interaction.

The growth trajectory is propelled by various factors unique to the Indian market, including urbanisation and a growing middle class, which is changing consumer preferences and boosting the



affordable demand for mobility solutions, he added. Chopra noted that when CARS24 began its journey eight years ago, the used car market size stood at around USD 10-15 billion.

"I think, in the last 3-4 years, with different kinds of cars coming up, the market has truly accelerated," he stated. The car ownership in the country remains low as various compared developed geographies,

years of purchase, in stark contrast to the patterns observed two decades ago when vehicles were typically held for 10-12 years, he noted. "As millennials increasingly opt for more frequent car upgrades, the market is witnessing a consistent inflow of high-quality, aspirational cars," Chopra said.

Further, he noted that the demand for feature-packed SUVs has also surged in the last four years, experiencing significant growth from 30 per cent in FY19 to 59 per cent in the first half of FY24.

Pucovski had returned after the blow in January to score 131 in their Shield match against New South Wales at the SCG last month.

"If a great sporting leader like Pep has everyone on their toes like that, is it right that an England cricket team that is decent but struggling to crack the next level should be as comfortable as it seems? The whole batting lineup has

"It's a huge week for a number of England's batsmen. When we think of this England team, we think of their wonderfully dynamic batting. But when you look at why they haven't won any of their last three series, it's down to the batting.

"There never seems to be much scrutiny or noise around England's batsmen. Even last week I chuckled. They lost in Ranchi in large part because

in a series at home since 2012, they didn't bat well enough, but there was lots of finger pointing at Ollie Robinson, a bowler who scored an important halfcentury!

"He looked well short of a gallop with the ball and dropped a catch but I thought it was ironic that he became a scapegoat. It's classic 'batsmen vs bowlers stuff." Vaughan feels when it comes to team selection there should be consistency in the batting order.

"Complacency can damaging. As a management team, how you approach selection of batsmen and bowlers is obviously different. Fast bowlers, especially, sit out games and are rightly rotated to preserve their bodies," he wrote.

maximum damage. Sai Kishore (6/97) ran through a chunk of Mumbai's batting line-up, while Shreyas Iyer (3) fell to pacer Sandeep Warrier as Tamil Nadu levelled up with the hosts for

the first time in the game. But Thakur launched a stunning onslaught, putting each of Tamil Nadu bowlers under severe pressure while forging vital partnerships along the way to take Mumbai far ahead in the game.

Thakur teamed up with Hardik Tamore (35) for a crucial 105-run stand for the eighth wicket and took Mumbai further ahead in the company of Kotian, adding another 79 runs for the ninth wicket. Using his blade to perfection, Thakur was adroit



with his hands to pierce gaps at will and did not miss out clearing the field with disdain four times for maximums one of which also brought up his maiden century across
