SC ends immunity for lawmakers who turn into lawbreakers for Bribe

The privileges enjoyed by MPs and MLAs are "tethered intrinsically" to the functioning of the legislature collectively, the Supreme Court said on Monday while holding that lawmakers taking bribe to vote or make a speech in the House are not immune from prosecution.

A seven-judge constitution bench headed by Chief Justice DY Chandrachud said members acting constituents of the legislature

may not claim any privilege or immunity unconnected with the working of the House.

To give any unconnected functioning of Parliament or State legislature by necessity is to create a class of citizens which enjoys unchecked exemption from ordinary application of law, the bench said. "This was neither the intention of the Constitution nor the goal of vesting Parliament and Legislature with powers, privileges and immunities," said the bench, which also comprised Justices A S Bopanna, M M Sundresh, P S Narasimha, J B Pardiwala, Sanjay Kumar and

India bares its fangs at Maldives

 $\begin{array}{cccc} B_{remarks} & \text{aside} & \text{recent} \\ \text{President Mohamad Muizzu} \end{array}$ that no country has the licence to "bully" his country, External Affairs Minister S Jaishankar said, "big bullies don't provide \$4.5 billion aid." This terse response te its came in reply to a question regarding whether India was perceived as a bully in the region. Moreover, these observations, in a veiled dig at Muizzu, were against the backdrop of diplomatic tension between India and Maldives. Jaishankar's remark came

after Muizzu, in an indirect reference to India, stated in January that no country had the licence to "bully us," even though it was a tiny nation. Speaking at an event promoting his book 'Why Bharat Matters,' Jaishankar highlighted India's active role providing timely assistance to its neighbours during crises when asked whether New Delhi was perceived as a "bully" in the subcontinent and Indian Ocean region.

"The big change today in this part of the world is what has happened between India and its neighbours. When you say India is perceived as a big bully, you know, big bullies don't provide \$4.5 billion when the reighbours are in when the neighbours are in trouble. "Big bullies don't supply vaccines to other countries when Covid-19 is

on or make exceptions to their own rules to respond to food demands or fuel fertiliser demands or demands because some war in some other part of the world has complicated their lives," Jaishankar said at the event last week. The Minister's comments

came amid the diplomatic row between India and Maldives that began in January when three Maldivian Ministers were suspended for derogatory remarks against Prime Minister Narendra Modi after he posted pictures of his visit to Lakshadweep and pitched it as a tourist destination.

"You also have to look today at what has actually changed between India and its neighbours. Certainly, with Bangladesh and Nepal, today

you have a power grid. You have roads which didn't exist a decade ago. You have railways which didn't exist a decade ago. There is a usage of waterways. Indian businesses use ports of Bangladesh on a national treatment basis," Jaishankar

He stressed that trade and investment with Nepal, Sri Lanka, Bhutan, Bangladesh and the Maldives have seen a sharp rise over the past few years. "Today, at the connectivity (side), just the volume of people is moving up and down.

The volume of the trade and the investments which are there, it's actually a very good story to tell. Not just with Nepal and Bangladesh, with Sri Lanka as well, I would also say even with the Maldives," the Minister said.

"The BDJS is a pain in the neck for the Hindutva party, as the alliance with the former has not helped the BJP mobilise more votes than what it was getting in the earlier hustings.

The chances of the BDJS polling a respectable number of votes in this election too look remote.

"It would be better if the BJP dumps the BDJS. The earlier it is done, the better," said the senior party leader.

BJP hits troubled waters in Kerala TMC leader Tapas Roy quits Party on Sandeshkhali issue

MLA of the Trinamool Sudip Bandopadhyay, the Congress, on Monday quit the Baranagar MLA said, "At least party "insulted and hurt" by he top party brass and "upset about the rising incidents of corruption and Sandeshkhali land-grab and sexual assault on women.

"Some recent incidents have made me take a very painful decision ... I have been deeply shocked and shaken with the way Sandeshkhali incident was handled ... besides corruption has become a major issue for which there was explanation ... neither there was any attempt to discipline the corrupt," Roy a five-time MLA and a former-Deputy Chief Whip — enjoying the rank of a Cabinet Minister said, adding that he was "deeply upset by the kind of treatment that was meted out to me by the party top brass.

Roy who had won the Baranagar Assembly adjoining North Kolkata seat for three successive times since 2011 on Tuesday resigned as an MLA too. "I had resigned from all the party posts on March 1 ... today I have resigned from MLA ... now I am a free bird," he said.

While the veteran leader's resignation led to fervent speculations on whether he was joining the BJP, he said was in the midst of taking some decisions. "I will take a decision in due time," he said. "Referring to a raid conducted

EC warns **Bengal babus**

The full bench of Election I Commission of India on Monday warned the senior Bengal bureaucrats against playing partisan games ahead of the elections.

In a meeting with the top officials — including SPs and DMs
— of North 24 Parganas, South 24 Parganas, Jhargram, Raiganj and other places the ECI told that their conduct was being closely watched and if required they would be shifted from their position.

The SP of North 24 Parganas of which the Sandeshkhali blocks is a part, the ECI said the way he handled the situation there was deplorable and he would continue to be under close surveillance of the ECI.

Earlier the ECI separately met the representatives of the political parties where the opposition parties including the BJP and the Left complained about manipulation of electoral rolls. "Complaints of bogus names appearing in the voters' list and many genuine names being deleted have been brought to their notice and they have taken cognizance of it," CPI(M);'s Samik Lahiri said.

NC to decide on alliance with JDIA Bloc

All eyes are set on the cru-cial meeting of the National Conference Parliamentary Board (NCPB) in Srinagar on March 5 as it is expected to take a final call on contesting upcoming Lok Sabha polls in alliance with the constituents of INDIA Bloc. In the absence of any consensus during the informal round

of talks between the Congress and the National Conference, the outcome of the Parliamentary board meeting is keenly awaited to chalk out the future course of action.

Last week, Jammu and Kashmir Pradesh Congress Committee Chief Vikar Rasool Wani dropped subtle hints about the possibility of formalizing a seat-sharing formula with the National Conference. The parliamentary board of the party is also expected to finalize the names of the party candidates for the Lok Sabha polls. Former Chief Minister and party Vice President Omar Abdullah's name is being considered for the Srinagar Lok Sabha seat while Aga Syed Ruhullah Mehdi is poised to get a mandate from the party for

the Baramulla seat. If the National Conference relented and agreed to the proposal of the INDIA bloc PDP may be given the mandate to field their candidate from the Anantnag-Rajouri Lok Sabha seat. So far the National Conference was firm on contesting the seats it won during the 2019 Lok Sabha polls.

On the other hand, the top brass of the J&K unit of Bharatiya Janta Party has shifted base to Srinagar ahead of the public rally of Prime Minister Narendra Modi on March 7 at the Bakshi stadium.

Addressing a press conference in Srinagar on Monday J&K BJP unit Chief Ravinder Raina said BJP is confident that the people of Jammu and Kashmir would show their love for Prime Minister Narendra Modi when he arrives for a public rally in Srinagar on March 7. 'For the people of Kashmir, it is a matter of happiness that PM Modi is coming to the val-ley on March 7. When the PM comes to Kashmir, more than two lakh people will participate in the rally at Bakshi Stadium. There is a wave of happiness in Kashmir that PM Modi is coming to Kashmir," he added.

Vacate party office at Rouse Avenue by June 15: SC to AAP

Observing that the Aam Aadmi Party has no lawful right to continue on the land, the Supreme Court on Monday directed the party to vacate its offices at Rouse Avenue in the national capital by June 15, 2024, after noting that the plot was allotted to the Delhi High Court for expanding judicial infrastructure.

Taking note of the fact that Lok Šabha elections are around the corner, a bench of Justice D Chandrachud and Justices J B Pardiwala and Manoj Misra asked AAP to approach Land And Development Office under the Union Housing and Urban Affairs Ministry for allotment of land for its

"In view of the impending general elections, we grant time until June 15, 2024, to vacate the premises so that land allotted to expand the district judiciary's footprint can be utilised on an expeditious basis.

"We would request the L&DO to process the application and communicate its decision within a period of four

Senior advocate Abhishek Singhvi, appearing for the city's ruling party, submitted that AAP is one of the six national parties in the country and it is entitled to land in New Delhi municipal area in accordance with its status.

rmed with approval from Armed with approved. authority, the Archeological Survey of India (ASI) is poised to embark on highly anticipated excavations at a locally acclaimed mound known as Kanhaiya Baba Ka Sathan within the Sohagibarwa Wildlife Sanctuary in Uttar Pradesh. This site located adjacent to vil-

lage Dharmauli in Maharajganj is believed to hold the key to one of the eight great original stupas where relics of Lord Buddha are said to be enshrined. Currently, India is home to the

relics of Lord Buddha excavated at Piprahva, considered a part of the ancient Buddhist site of Kapilavastu, while the relics of the disciples are from a monastery at Sanchi in Madhya

The recent green light from the Standing Committee of the National Board of Wildlife (NBWL), led by Union



Environment Bhupender Yadav, paves the way for yet another significant endeavour to scout for more relics proposed to be kept at hectares of forest land within the sanctuary.

The ASI's upcoming excavation is expected to yield valuable insights into Buddhist heritage, shedding light on the early development and spread of Buddhism across the Indian

Minister subcontinent. Officials from the ASI said the potential of these findings to enrich our understanding of ancient Indian society and culture as well as more artifacts in the treasure trove of the country. The proposal for excavation had already received prior recommendations from various authorities, including the UP

Chief WildLife Warden, the

State Board for Wild Life, and

the State Government. Last year, UP Chief Minister Yogi Adityanath too had pushed for excavation and said, "There are uncovered historical facts that need excavation. The Archaeological Survey of India is also interested in this."

At the meeting of the NBWL held late last month, the UP Chief WildLife Warden justifying the endeavour cited the need to ascertain the historical and cultural significance of the region, particularly in connection to Buddhist texts identifying the site as one of the original stupas housing relics of Lord Buddha.

Despite the sensitive nature of the site and its surroundings within the wildlife sanctuary, the NBWL chairman recommended the proposal, acknowledging the sentiments and demands of the local com-munity while ensuring that legal protections and conservation measures are upheld. The ASI has been instructed to conduct the excavation with

utmost care, ensuring minimal disturbance to the sanctuary and its wildlife.

Located on the border area of Uttar Pradesh, the sanctuary has the international Indo-Nepal border in the North and inter-State UP-Bihar border to the East.

The sanctuary shelters rare and endangered species such as tiger, leopard, cheetal, bear, Indian Civet, giant squirrel, hare, wild cat, wild boar, monitor lizard, neelgai, and Indian python among others. The ASI has also been direct-

ed to ensure employing nondisruptive excavation methods, refraining from the use of blasting materials and ensuring that construction materials do not encroach upon wildlife corridors or environmentally sensitive zones.

The aim is to preserve the sanctity of the site while retrieving India's rich cultural and religious heritage, said an official from the Union Environment

BJP leader withdraws from electoral race amid video row

Upendra Singh Rawat, a BJP Member of Parliament representing Barabanki, Uttar Pradesh, has stirred controversy by withdrawing his candidature from the upcoming Lok Sabha elections in the wake of an alleged obscene video scandal.

Taking to his social media platform, Rawat directly addressed the issue on Monday, stating, "An edited video of mine is being made viral which is generated by DeepFake AI technology, for which I have lodged an FIR. In this regard, I have requested the Honorable National President to get it investigated. I will not contest any election in public life until

I am proven innocent." This development unfolds shortly after the BJP's announcement on February 2 of its initial roster of 195 candidates for the Lok Sabha polls, including 34 incumbent

City Government to strengthen GST administration to boost revenue: Atishi

The Delhi government will strengthen its Goods and Services Tax administration, making it faceless to boost revenue, Finance Minister Atishi said while presenting the annual budget 2024-25, envisaging Rs 76,000 crore outlay on Monday. The government will source Rs 41,000 crore through Goods and Services Tax (GST) and VAT, which will be 70 per cent of the total tax revenue of Rs 58,750 crore estimated in budget 2024-25. In fiscal 2023-24, the GST and value-added Tax (VAT) collections until January 2024 witnessed a growth of 13.96 per cent yearon-year to Rs 31,445 crore, Atishi said. "Now, the next step of the Kejriwal government is to make the IT infrastructure of GST state-of-the-art and the entire GST Tax Administration faceless," the finance minister

The Delhi government is working on data analytics and automation software in collaboration with IIT Hyderabad. This will help in tracking, monitoring and simplifying the refund process through artificial intelligence and data analytics, besides reducing processing time and errors in files, she said.

The budget estimates of Rs 76,000 crore for 2024-25 was 3.7 per cent less than Rs 78,800 crore in 2023-24. However, it was 1.47 per cent higher than the revised estimates of Rs 74,900 crore in 2023-24. "The 74,900 crore in 2023-24. "The budget estimate was a bit higher last year. But, the final (revised) estimate is 74,900 crore for 2023-24, which has been enhanced by Rs 1,100 crore to estimate the budget 2024-25," Atishi said in a press conference, pointing that the conference, pointing that the GST compensation of Delhi stopped in the last two years. There is no other state in the country, which has not taken a loan to manage its budget deficit after scrapping GST compensation.

In an effort to upgrade and beautify roads in the national Capital, Rs 1,768 crore have been earmarked for the year 2024-25. This initiative is part of the 10-year plan with an anticipated budget of Rs 19, 466 crores.

Announcing this during her budget speech, Finance Minister Atishi said apart from the upgradation and beautification of existing roads, the government will also give a major push to the construction of 26 new flyover/underpass/bridge projects that are in the pipeline. Out of these, 10 projects are under construction, 11 projects have been sent to UTTIPEC for design approval and 5 projects are under the process of tendering.

These include some landmark projects such as Barapullah Phase 3 flyover from Sarai Kale Khan to Mayur Vihar, flyover from Punjabi Bagh to Raja Garden, and elevated road at

When completed, these flyovers/underpasses/bridges will substantially shorten the daily commute of lakhs of residents and tourists in the national capital, while also easing traffic congestion and vehicular pollution.

"Usually, we see that when a flyover is constructed in other states, the construction cost increases manifold from the start of the construction work till its completion. But Delhi is the only state in the country where the cost of construction of flyovers has not increased, but by working honestly and efficiently, the government has saved ? 536 Crore of the public," Atishi

Delhi Metro gets ₹500 crore

The Delhi government allocated Rs 500 crore for the Delhi Metro in its 2024-25 Budget tabled on Monday, with Finance Minister Atishi saying in the assembly that more than 60 lakh people commute on the service every day. In 2014, around 24 lakh passengers used the urban transporter daily, Atishi said. Presenting the 2024-25 Budget with a total outlay of Rs 76,000 crore, Atishi said providing good public transportation facilities to every resident of Delhi is the responsibility of the government. Under the guidance of Chief Minister Arvind Kejriwal, "significant improvements" have been made in the public transportation sector in Delhi, she By March 2015, a total 193 kilo-

metres of metro network and 143 stations were established in Delhi. However, in the past nine years, the Delhi Metro network has doubled in length to 393 kilometres while the number of stations has increased to 288, she added. Atishi said in her address that around 24 lakh passengers travelled daily in the metro in 2014. Today, more than 60 lakh passengers use the service every day. The Delhi Metro has now reached every corner of Delhi -- be it the Tikri border, Samaypur Badli, Tikri Kalan, Badarpur border or Shiv Vihar. "In this financial year, I propose an outlay of Rs 500 crore for Delhi Metro," she said.

Minister to inaugurate major piers, residential towers for naval officers: Officials

Defence Minister Rajnath Singh on Tuesday will inaugurate two major piers and seven residential towers comprising 320 houses for naval officers and defence civilian personnel and 149 single officers' accommodation in Naval Base Karwar, Karnataka, navy officials said here on Monday. It is home base of aircraft carrier INS Vikramaditya.

Phase I of Project Seabird as the base is known was designed to accommodate 10 ships and was successfully concluded in 2011. The infrastructure comprised a breakwater, a pier capable of berthing 10 ships, a 10,000-ton ship lift and dry berth, a Naval Ship Repair Yard, logistics and armament storage facilities, accommodation for 1000

Headquarters/Depot Organisation, and a 141-bed Naval Hospital.

The CCS (Cabinet Committee on Security) approval for Phase IIA of the Project was accorded the berthing of 32 ships and submarines, along with 23 Yardcraft. The Phase IIA initiatives are also directed towards constructing buildings and structures that adhere to the current guidelines set by the Ministry of Environment, Forest and Climate Change (MOEF) and the Indian Green Building Council (IGBC). The Phase IIA marine works

include piers designed to accommodate ships/ submarines, providing a berthing space of more than 6 kilometers, technical facilities, electrical substations, switch gears, and support utilities.

The center-piece of Phase IIA Works is an iconic Covered Dry Berth, standing at a height of 75 meters, taller than the Outub Minar in Delhi, and spread over 33000 m2 land area. This dry berth is designed to facilitate simultaneous docking and comprehensive enclosed maintenance of up to four capital ships.

In Phase-IIA, four different townships encompassing residential accommodations, with about 10,000 dwelling units of all types for Officers, Senior and Junior Sailors and Defence Civilian staff is being constructed. The setting up of green field dual-use Naval Air Station with 2700m runway and civil-enclave will provide air support to the aircraft embarked upon various IN ships and facilitate operations of commercial aviation flights. The ongoing construction activities at Naval Base Karwar have directly generated employment opportunities for approximately 7,000 personnel and indirectly led to around 20,000 jobs across the nation. Obesity is a risk factor for stillbirth, especially as the pregnancy advances to term, according to a large study conducted in Canada.

The findings, published in the Canadian Medical Association Journal (CMAJ), suggest that an earlier delivery date may help reduce the risk of stillbirth for pregnant people with obe-

The researchers analysed data from the Better Outcomes Registry and Network on 6,81,178 (over 6.8 lakh) singleton births, 1,956 of which were stillbirths, in Ontario, Canada between 2012 and

2018. After adjusting for other stillbirth risk factors like diabetes and high blood pressure, they found that people with class I obesity -- with body mass we found associated with obe-

index (BMI) 30-34.9 kilograms per square metre (kg/m2) -had double the risk of stillbirth at 39 weeks gestation compared to those with normal BMI (18.5-24.9 kg/m2).

For those in obesity classes II and III (BMI 35-39.9 kg/m2 and BMI 40 kg/m2 and higher, respectively), stillbirth risk at 36 weeks was 2 to 2.5 times that of people with normal BMI, the researchers said.

This risk associated with increased BMI, a measure of body fat based on height and weight, further increased with gestational age, with a more than fourfold risk at 40 weeks, they said.

"For other medical conditions that increase the risk of stillbirth, there are guidelines that recommend delivery at 38 or 39 weeks. Interestingly, the risk thresholds for those conditions are lower than the risks sity," said study lead author, Naila Ramji, an assistant professor at Dalhousie University,

"We worry that implicit biases against people with obesity may be causing the medical community to take the risks they face less seriously," Ramji said in a statement.

The researchers also looked at whether stillbirths occurred before or during delivery and found a higher risk of stillbirths occurring before delivery in people with class I and II obe-

They hope that these findings will improve care for this at-risk population. Pregnant people with obesi-

ty, especially those with additional risk factors, may benefit from timely referral and greater surveillance closer to term, and the presence of additional risk factors may warrant earlier delivery," Ramji added.

Misplaced priorities

Shehbaz Sharif assumes office as Pak PM for a second term, rakes up Kashmir in inaugural address

Ollowing an extended round of negotiations and plotting, Shehbaz Sharif has managed to ascend to the Pakistan Prime Minister's chair for a second term amid serious domestic challenges. A seasoned politician from the prominent Sharif family, Shehbaz wasted no time in his inaugural speech to address the issue that has shaped Pakistan's foreign policy for decades --- Kashmir. It is indeed unfortunate that Pakistan's political elite aways finds it convenient to rake up Kashmir to distract the masses from the real issues dogging the country. Rather than focusing on his Government's tangible plans to spur growth and economy, Shehbaz chose to reiterate Pakistan's stance on Kashmir. His words resonated with the sentiments of many Pakistanis who view the Kashmir issue as central to their national identity. Taking a broader view, the transition of power marks a significant chapter in Pakistan's democratic history. Shehbaz, known for his pragmatic approach and administrative acumen, brings along a wealth of expe-



rience from his previous tenure. However, his ascent to the PM's office is seen as nothing more than stealing the popular mandate. Despite military backing, his party could not register a clear win. His legal tangles notwithstanding, Imran Khan still remains popular and Independents (mostly from his party) rule the roost. Sharif's return to power has sparked both anticipation and scrutiny, with supporters heralding continuity and stability, while critics voice concerns over governance and accountability.

In this scenario, Kashmir is a time-tested formula for Pakistan's political leadership to deflect attention away from the ills plaguing that country. Unfortunately,

Pakistan's volatile domestic politics plays havoc in regional geopolitics; raising tensions and military expenditure for all involved. The mention of Kashmir in Shehbaz's maiden speech underscores the enduring significance of the conflict in Pakistan's foreign policy agenda. For decades, Kashmir has remained a flashpoint between Pakistan and India, fuelling tensions and periodic escalations. Despite various attempts at dialogue and mediation, a lasting solution to the Kashmir issue remains elusive, perpetuating a cycle of violence and instability. And Pakistan's domestic issues are the real reason that this dispute is kept alive; there is a lack of political will on the part of its leaders to resolve the issue. The complex geopolitical dynamics, coupled with India's firm stance on Kashmir as an internal matter, cannot lead to a breakthrough anytime soon. Shehbaz knows this but still uses the ploy to influence popular sentiment in Pakistan. Moreover, with the evolving regional dynamics and global priorities, drumming up international support for Pakistan's position on Kashmir remains an uphill task. As Shehbaz embarks on his second term as the Prime Minister, his handling of the Kashmir issue will undoubtedly be closely watched both domestically and internationally. He would, however, do better to sincerely address Pakistan's domestic issues and help his people lead a satisfied, dignified life.

At least for those who wish to get elected and govern, they should take for granted that identify is important to most and should be prepared to appear to pamper them. The reason is that in the event some adverse incident takes place, it could well take a turn and become an issue of identity, whose flames would then be difficult to douse. By and large, India has managed its many languages and pluralities competently.

However, with the rapidly developing economy and the resultant prosperity expected in due course, one cannot rule out the desire for relative freedom, and the demand for greater regional authority. The current government has been wise not to touch Article 356 act that is viewed as an anti-

Another factor that worked in India's favour was the awareness that Pakistan split into two in 1971 merely on the issue of its national language Urdu. Although much later, the traumatic breakup of the Soviet Union into sixteen republics sent shivers of fear down the spires of many a country. More secession followed in Europe after 1991. There is no danger of this nature on the horizon of India at present. However, precaution is always

For examples, go back to the 1860s and the American Civil War when the northern and southern states fought for years. If the U.S.A. had not remained together and united, there would have been no country to save Europe from the Nazis in WWII, and also WWI between 1914-18.

National political parties should therefore have units of Young people, men and women, who can keep tract of regional peculiarities and systematically learn and practise them so that communication with the regions becomes more effective. No one should as if he or she is outside India or not wanted!

UN's new improved human rights vision



UN High Commissioner for Human Rights, Volker Türk, aims to stimulate dialogue and action to reclaim the integrity and universality of human rights

he 21-page vision, "Human Rights: A Path for Solutions", to protect and promote human rights, unveiled on Monday by United Nations High Commissioner for Human Rights, Volker Türk, offers an interesting yet unsurprising perspective, echoing the institutional failures of a once highly esteemed organisation now plagued by chronic illness and internal politics.

Contextualising this within the current global landscape reveals stark realities: amidst a world where 828 million people face regular hunger and the wealth of the five richest men has more than doubled since 2020, while nearly five billion others experience worsening financial conditions, the persistence of inequality undermines the universality of human rights. Highlighted by reports showing corporations amassing unprecedented profits at the expense of widespread wage cuts and with affluent countries disproportionately owning global wealth, it's clear that addressing systemic inequality is imperative for truly realising the principles of human rights on a global

Seventy-five years after the UDHR, it's evident that the traditional approach to safeguarding these rights has been gravely distorted. Countries investing significant resources in global institutions like the United Nations have often exploited this noble cause to further their own agendas. This exploitation is camouflaged by elaborate narratives crafted to veil the abuse. Consequently, human rights have been commodified, attracting opportunists who profit from others' suffering, turning empathy into economic gain. This pervasive hypocrisy has plunged us into a moral abyse. The essence of upholding human rights lies in fostering collective cooperation among diverse social entities. Collaborative efforts are essential for addressing shared challenges with a unified approach rooted in the defence of fundamental principles. To truly protect human rights, we must first cease treating it as a transactional commodity, devoid of its inherent dignity and worth. There are contradictions evident within, as certain organisations prioritise increasingly self-serving agendas and select topics. A prime example lies in the misuse of veto powers by members of the United Nations Security Council when faced with certain resolutions on common challenges. Instead of collective action for common goals, organisations often prioritise their own interests, overlooking equally important but less visible human rights issues. Consequently, human rights have continually fallen victim to political interests and biased media behaviour. This explains why the death of a political activist in Russia garners global attention while the trial of Julian Assange and the sustained abuses he endures remain overlooked. This is where we need a radical approach to change.

Furthermore, the involvement of various actors such as policymakers, philanthropists, and government officials raises concerns regarding conflicts of interest and power dynamics within the network, potentially leading to the manipulation of human rights discourse to advance individual political or economic agendas and marginalise certain voices and perspectives. Additionally, while the vision calls on governments to protect human rights defenders and uphold freedom of expression and association, many governments perpetrate human rights violations themselves, cast-



ventive measures.
The concept of human rights economics offers promise in prioritising the well-being of individuals and the planet, yet concerns persist about its feasibility and susceptibility to exploitation. Despite states' obligations to fulfil economic, social, and cultural rights, uneven power dynamics and political agendas often obstruct progress. Western nations, self-proclaimed guardians of human rights, criticised for selectively advocating human rights to advance geopolitical interests, may encounter resistance from influential economic entities when proposing strategies to embed human nts in economic frameworks. Efforts to bolster financial self-sufficiency and combat corruption commendably aim to prioritise human rights. However, the influence of multinational corporations and financial institutions, prioritising profit maximisation over human rights considerations, poses significant challenges. Additionally, while allocating resources toward education, healthcare, and social welfare in highly indebted nations is essential for advancing human rights, achieving debt relief and restructuring demands substantial political resolve and international collaboration, often lacking in a global economic paradigm favouring creditor and financial market interests over

ly addresses hurdles posed by

nations resistant to environmental protection agreements. Despite progress in promoting environmental rights, the efficacy of these endeavours is hindered by a lack of global consensus. Moreover, while emphasising strategic prosecution and accountability to drive policy changes, it overlooks the disproportionate burden borne by vulnerable communities, especially in developing nations, facing environmental degradation and climate change impacts despite minimal contribution to the issue. Additionally, while critical, the insistence on meeting climate finance obligations is undermined by historically high-emitting countries shirking responsibility to support less developed nations, perpetuating environmental injustice and hindering global efforts to

address the climate crisis. The vision rightly pushes for the integration of human rights policies into climate action but neglects to hold accountable nations prioritising economic growth over environmental sustainability and disregarding the rights of indigenous peoples, who often bear the brunt of environmental degradation. Despite emphasising participation, ending discrimination, and fosteraccountability, it fails to fully address systemic challenges perpet-uated by certain countries which perpetuate inequalities and sidestep responsibility for human rights violations. Discrimination, often entrenched within governmental structures and powerful institutions, remains pervasive even in Western nations. Despite professed commitments to equality, these countries struggle with deep-seated inequalities and structural barriers that hinder meaningful inclusion and participation.

Furthermore, many member-states prioritise the interests of elite groups and corporations over those of marginalised communities, all while extolling the importance of participatory processes in shaping effective solutions. Monetary influence and institutional sway in politics frequently undermine democratic processes, impeding the implementation of policies that serve the

broader populace. Additionally, although holding governments and corporate entities accountable for human rights violations is paramount, there often exists a notable lack of political will to prosecute perpetrators, particularly when they wield significant power.

Additionally, while it is imperative to address the crisis in education, the vision overlooks the root causes of this crisis, such as underinvestment in public education systems and persistent inequities in access to quality education. According to UNESCO, the number of out-ofschool children surged to 250 million by September 2023, marking a staggering increase of 6 million from 2021. The urgency of the situation is evident, and mere rhetoric cannot suffice without an authentic and transformative approach.

Moreover, while acknowledging

the disproportionate impact of environmental crises on younger generations, the vision lacks concrete proposals to address this pressing issue. Despite the existential threats posed by environmental degradation, governments often prioritise short-term economic gains over long-term sustainability. It's praiseworthy to note that this latest vision acknowledges the neces sity for deeper cooperation and coordination within the human rights system, implicitly recognising the presence of double standards and selectivity in dealing with human rights crises. This recognition is crucial for promoting transparency and accountability.

What's crucial, however, is that while advocating for the expansion and strengthening of human rights mechanisms, it lacks specific proposals to hold states accountable for their actions or address the root causes of double standards in human rights enforcement.

It fails to outline how these mechanisms will ensure fair treatment of all human rights violations. As the old school of thought teaches us, both action without vision and vision without action are deemed

Tackling mental health crises in medical students

In recent years, the mental health challenges faced by medical students have escalated dramatically, requiring immediate intervention

n recent years, the issue of mental health among ▲ medical students in India has reached alarming proportions, necessitating urgent attention and decisive action. The relentless demands of medical education, combined with various external stressors, have led to a concerning rise in suicides and mental health challenges among students pursuing MBBS and postgraduate degrees. According to data from the National Medical Commission(NMC) spanning from 2018 to 2022, a staggering 64 MBBS students and 58 PG students tragically lost their lives to suicide, alongside a significant number who left their educa-

tional programs during this

period.



Yet another exploratory study published International Journal of Social Psychiatry in 2022 using online news portals and Google database spanning 2010 and 2019, puts the staggering number at a total of 358 suicide deaths reported among medical students (125), residents (105), and physicians (128). The majority of these suicides occurred

average age of 29.9 years. Understanding Complexity:

The mental health challenges faced by medical students in India are multifaceted and stem from a combination of academic pressures, familial expectations, financial burdens, and cultural factors. The rigorous curriculum, long hours of study and clintional

ical rotations, and the constant pursuit of academic excellence create a high-stress environment that takes a toll on students' mental and emowell-being. Additionally, the stigma surrounding mental health issues often prevents students from seeking help, exacerbating their struggles. Challenges Faced by before the age of 30, with an **Postgraduate Students:**

Postgraduate medical students face unique challenges that add to their mental health woes. Excessive workload, demanding clinical responsibilities, and inadequate support systems contribute to burnout and emotional exhaustion among PG students. The lack of worklife balance and limited opportunities for self-care compound the problem, leading to increased levels of stress and anxiety. In fact, the relentless schedule imposed on these students not only jeopardizes their mental health but also compromises patient care and safety. The challenging environment in healthcare settings often leads to distressing situations where disgruntled relatives of patients may vent

their frustrations on postgraduate (PG) students who are on duty, even when these students are not at fault. This unfortunate reality underscores the urgent need for improved support and protection for PG students who face such situations.

Inadequate Support

Mechanisms: Despite the growing awareness of mental health issues among medical students, many institutions in India lack adequate support mechanisms and counseling services. This leaves students feeling isolated and unsupported, with few resources to turn to in times of crisis. Moreover, the stigma associated with mental illness often leads to underreporting and a reluctance to seek help, per-

petuating a cycle of suffering in silence. The persistent lack of adequate support mechanisms and counseling services in many Indian medical institutions exacerbates the challenges faced by medical students dealing with mental health issues.

The Role of Advocacy and

Reform: To address the crisis of mental health among medical students, concerted efforts are needed at both institutional and systemic levels. Organizations like the Federation of Resident Doctors' Association (FORDA) are actively advocating for reforms to prioritize student well-being. This includes advocating for reasonable duty hour regula-

mental health support services, and fostering a culture of empathy and support within medical institutions. **Collaborative Solutions:**

By working together to implement comprehensive support systems, raise awareness, and destigmatise mental illness, we can create a more nurturing and supportive environment for medical students to thrive. Haiti's government declared a state of emergency and nighttime curfew late Sunday in a bid to regain control of the streets after an explosion of violence over the weekend saw armed gang members storm the country's two biggest pris-

The 72-hour state of emergency went into immediate effect as the government said it would set out to find the killers, kidnappers and other violent criminals that it reported escaped from the prison.

The police were ordered to use all legal means at their disposal to enforce the curfew and apprehend all offenders," said a statement from Finance Minister Patrick Boivert, who is serving as acting prime min-

The decree capped a deadly weekend that marked a new low in Haiti's downward spiral of violence. Targets included police stations, the country's international airport, even the national soccer stadium.

But the siege on Saturday

night of the National Penitentiary came as a shock even to Haitians accustomed to living under the constant threat of violence. Almost all of the estimated 4,000 inmates fled during the jailbreak, leaving the normally overcrowded facility eerily empty Sunday with no guards in sight and plastic sandals, clothing and furniture strewn across the concrete patio. Three bodies with gunshot wounds lay at the prison entrance.

In another neighbourhood, the bloodied corpses of two men with their hands tied behind the backs lay face down as residents walked past roadblocks set up with burning tires. Among the few dozen that chose to stay in the prison are 18 former Colombian soldiers accused of working as mercenaries in the July 2021 assassination of Haitian President Jovenel Moïse. Amid the clashes Saturday night, several of the Colombians shared a video pleading for their lives.

"Please, please help us," one of the men, Francisco Uribe, said in the message widely shared on social media. "They are massacring people indiscriminately inside the

In the space of less than two weeks, several state institutions have been attacked by the gangs, which are increasingly coordinating their actions and choosing once unthinkable targets like the Central Bank. As part of coordinated attacks by gangs, four police officers were killed Thursday.





Experts rule out immediate improvement in Indo-Pak ties

Bhagat Singh is respected in the subcontinent not only by Sikhs and Hindus but also Muslims. Pakistan founder Muhammad Ali Jinnah

had reportedly twice paid him tribute during his speech in the central assembly, saying there had never been another brave person in the subcontinent like Bhagat Singh.

Qureshi stated Bhagat Singh was a freedom fighter of the subcontinent and gave his life along with his companions for the cause of free-

"It will be in the interest of justice to name Shadman Chowk after Bhagat Singh and also install his statue at the square to inspire the people of Pakistan and the world," he said and added in neighbouring India, there were many roads and thoroughfares named after Muslim rulers such as Akbar Road, Shahjahan Road and Bahadur Shah Road.


The local unit touched a low of 82.91 during intra-day deals. On Friday, the rupee settled 2 paise lower at 82.91 against the US dollar.

Anuj Choudhary, Research Analyst, Sharekhan by BNP Paribas, said the rupee opened higher on weak dollar and positive domestic markets. However, it lost its initial gains on reports of dollar buying by public sector banks.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, remained unchanged at 103.79.

Choudhary said the US dollar eased, extending Friday's losses amid disappointing eco-nomic data from the US and positive global equities.

"We expect the rupee to trade with a slight positive bias with a narrow range on the rise in risk appetite in global markets and weak tone in the greenback. However, the surge in crude oil prices may cap a sharp upside. Any further dollar buy ing by PSU banks or the Reserve Bank of India (RBI) may also weigh on the rupee,"

Google misusing dominant position to exploit small businesses, say app developers

Ashwin always trying to find ways to get you out: Root

Mighty impressed with Ravichandran Ashwin's range, aggressive mindset and relentless pursuit of wickets, senior England batter Joe Root has said that the veteran Indian off-spinner is a constant threat who hardly believes in the concept of wearing the opposition

Ashwin, who recently went past the 500-wicket milestone in the traditional format becoming only the second Indian after Anil Kumble to do so, will play his 100th Test during the fifth match against England, starting on March 7 at Dharamsala.

"Ashwin is always trying to find ways of getting you out rather than trying to wear you down, over long periods of time," Root said on Sky Sports cricket podcast hosted by former England captains Mike Atherton and Nasser Hussain.

Root, who along with his teammates is currently enjoying a break in the series, said the infinite variety that Ashwin has in his bowling keeps the batters

ferently from traditional offspinners. He uses over-spin, side-spin, can get really tight to the stumps, can go wider and he has got the carrom ball, you know, a lot of different tricks.

"So, you will have to be really wary of different threats that he poses and make sure that you have very good skill sets to counter (him) and be on top of him," said the ex-England skip-

Giving an insight into the way Ashwin operates, Root said the Tamil Nadu man often bowls six different deliveries in an over. "Ashwin is making sure that you don't play the previous ball. He is very good at trying to drag you across the crease and get your head to one side of it and beat both edges quite frequently," he

Root said Ashwin poses different threats while bowling with new and old balls.

"There are different things to contend with because of his seam position and how cleverly he can move around the shiny side that has got some



"So, you have to make sure that you are in position a little bit quicker. He can also drift the ball away and bring the slip fielder into play," he explained.

Root also offered a comparison between Ashwin and Nathan Lyon, the other premier off-spinner of this generation. The 36year-old Australian has taken 527 wickets from 128 Tests.

"With Lyon it is all about, I think, especially in the first half of the Test match, to get over the top of the ball, get the bowl bounce, knee roll high, in between and try to bring short

leg and leg slip into the game as

much as he can.
"Then just slowly, get slower with his pace and drift wider into that. There are those footmarks, you know, Mitchell Starc has so kindly done for him for such a long period of time,"

England's much-talked-about 'Bazball' approach has not really worked in this series against India, where the visitors are currently trailing 1-3.

But Root said frustration has not seeped into the England camp as

'Don't think there is too much frustration within the team. Our top order has been far more consistent than it has been for long, long years. Now the pending cases can be resolved with quality in less time with the help of technical assistance. Average 15 to 17 days in cyber tehsilsThis is a significant achievement compared to the 60 days taken in the manual

Every year about 14 lakh mutation cases change registered in the state. Out of this, 8 lakh cases relate to mutation after execution of sale deeds. About 2 lakh undisputed l cases related to purchase and sale of entire

Against this backdrop, Cyber Tehsil has been established for paperless, faceless and online transfer and updating of land records within 15 days.

In this way, I entire 2 will be issued for adverlakh mutation cases related to purchase and sale of Khasra can be resolved through cyber tehsils. Apart from quick disposal of land records updating is done at the same time.

The burden of resolving undisputed cases at the tehsil level will be reduced. For the Cyber tehsil system, the Revenue Department has amended the Madhya Pradesh Land Revenue Code, 1959 and made provisions for Cyber Tehsil in Section 13-Å.

Cyber Tehsil Project started from 01 June 2022 as a pilot project in District Sehore and Datia. How it works?

Cyber Tehsils are operative in all
