these appointments, the Uttar Pradesh Government aims to navigate the electoral landscape effectively, catering to the aspirations of a wideranging populace as the State gears up for the upcoming Lok Sabha elections.

After prolonged anticipation numerous postponements, the muchawaited Cabinet expansion has finally taken place, just ahead of the looming Lok Sabha elections. Speculations had been rife since last year's Diwali festivities, but it was not until now that the expansion materialised.

The BJP has reportedly aimed to honour its commitments to alliance partners, offering Ministerial positions under the "poll deal".

One inclusion in the expanded Cabinet is Omprakash Rajbhar, who previously served as a Cabinet Minister during Yogi's first term in Uttar Pradesh. Rajbhar had defected to the Samajwadi Party (SP) before the 2022 Assembly elections but returned to the BJP fold a few months ago, after falling out with the SP. His re-inclusion in the Cabinet is believed to be part of the pre-election agreement within the alliance.

case. The charge-sheeted accused included T Naseer of Kerala's Kannur, who is serving life sentence in the central prison in Bengaluru since 2013, and Junaid Ahmed alias "JD" and Salman Khan, who are suspected to

The case was originally registered by the Bengaluru City Police on July 18 last year following the seizure of arms ammunition, hand grenades and walkie-talkies from seven of the accused persons. The seizure was made when the seven men were in the house of one of the accused. According to the NIA, which took over the case in October last year, the investigations revealed that Naseer, who was involved in several blast cases, had come in contact with the other

Naseer had managed to get all their potential with a view to radicalise and recruit them into the proscribed terror group, LeT.

### **State Bank seeks more time to** disclose electoral bond details

With the State Bank of India moving the Supreme Court seeking an extension of time till June 30 to disclose details of each electoral bond encashed by political parties, Opposition parties criticise the move, "suspicious apprehensions" and labeling it a "travesty of justice."

In an application filed before the top court, State Bank of India (SBI) contended that retrieval of information from "each silo" and the procedure of matching the information of one silo to that of the other would be a time-consuming exercise.

While former Congress chief Rahul Gandhi slammed the Government over the issue, terming it a "last-ditch attempt" before the Lok

Sabha polls to hide Modi's "real face", CPI (M) general secretary Sitaram Yechury said the SBI's move to seek an extension on disclosing information related to electoral bonds raises "suspicious apprehensions".

The plea submitted that due stringent measures undertaken to ensure that the identity of the donors was kept anonymous, "decoding" the electoral bonds and matching donors to the

donations made would be a complex process. "It submitted that the data related to the issuance of the bond and the data related to the redemption of the bond was kept recorded in two different silos. No central database was maintained. This was done to ensure that

donors' anonymity would be

"It is submitted that donor details were kept in a sealed cover at the designated branches and all such sealed covers were deposited in the Main Branch of the Applicant bank, which is located in Mumbai," the plea said.

In a landmark judgement that delivered a big blow to Government, Supreme Court on February 15 annulled the electoral bonds scheme for political funding, saying it violates the Constitutional right to freedom of speech and expression as well as the right to information. In its verdict months ahead

of the Lok Sabha polls, the apex court ordered the SBI to disclose to the Election Commission the names of the contributors to the sixyear-old scheme.

# People Judge resigns, joins BJP

ustice Abhijit Gandopadhyay Jalso popularly known as "people's judge" for his "exem-plary" and "time-induced" judgments in the cash-forschool-jobs cases sending a bevy of senior Trinamool Congress politicians including ministers, MLAs and top officials to jail on Tuesday resigned and announced his decision to join the BJP.

In what could broaden the smile on the saffron party's face desperately in hunt for a "credible face," the Judge soon after his retirement said he had decided to join the BJP as he thought "Prime Minister Narendra Modi is a good man and the BJP is the only national party that sincerely fights corruption.'

Speaking to the media the Judge said, "I am joining the BJP ... on March 7." When asked to comment on whether he would contest in the Lok Sabha elections he said "I will inform from which seat I will contest (Lok Sabha polls)" adding quickly "or if my party decides to use me in some other way without fielding me I will do accordingly."

Saying that he was responding to the Trinamool Congress'



challenge that "instead of using his Chair for gaining popularity he should contest political-' Justice Gangopadhyay said, as they had challenged me to contest polls I am here and I will contest against them."

On why he chose the BJP he said, "I think he (Prime Minister Narendra Modi) is a good man ... He is trying to do something for our country ... and the BJP is the only national party that is fighting against corruption." About the Left he said "I could have joined the CPI(M) but I would not do that as they are non-believers and I am a believer in God and perform Pujas ... I also did not join the Congress because they are a party that has become the zamindari of a single family." About the TMC he said that party would not last too long as "they are crumbling from within and will not last till 2026."

While the BJP leadership remained largely silent with a few of them like their Rajya Sabha member Samik Bhattacharya welcoming him to the outfit saying his presence would enrich the party, the TMC said the "Tuesday's judgment" only exposed the Judge and "confirmed our argument" that all his judgments were politically motivated.

### PM Modi in | MVA leaders to meet Ambedkar today for seat sharing talks

In an effort to bring about the Opposition unity in Maharashtra, the top brass of the Maha Vikas Aghadi (MVA will meet Vanchit Bahujan Aghadi (VBA) chief Prakash Ambedkar on Wednesday to finalise the seat-sharing arrangement for the Lok Sabha

At the meeting, the MVA leaders -- NCP (SCP) chief Sharad Pawar, Shiv Sena (UBT) head Uddhav Thackeray and and state Congress President Nana Patole --- are expected to dissuade him against going it alone in the Lok Sabha polls and ask him to settle down for a reasonable number of seats to be given by the Opposition

Last week, the VBA had submitted a list of 27 Lok Sabha seats that it intended to contest. However, the MVA leadership was no in mood to agree to such a "high".

Subsequently, Ambedkar had gone on record saying: "I can only say that if the VBA contests independently, we can win a minimum of six seats". A two-time Lok Sabha MP

from Akola and one-term Rajya Sabha MP, Ambekar will in all likelihood contest the polls from Akola in the

Vidarbha region. In addition, the VBA has also requested MVA to field Shivba Sanghatana founder Manoj Jarange-Patil, who is leading the Maratha reservation camfrom Jalna in Marathwada, while it has asked to field Dr Abhijeet Vaidya from the Pune seat.

The VBA, which Ambedkar heads, is a group of Dalits, Tribals, Dhangars, Kolis, Agris, Banjaras, Malis, Kaikadis and other communities.

The VBA has tied up with the Uddhav Thackeray-led Shiv Sena to contest the Lok Sabha

Last month, the MVA leader ship had formally invited Ambedkar to be part of the opposition coalition. However, Ambedkar has not yet conveyed his decision officially to the leadership of MVA, comprising the Congress, Shiv Sena

and NCP (SP). It may be recalled that in the LS polls, Ambedkar had an electoral arrangement with Asaduddin Ŏwaisi-led All India Majlis-e-Ittehadul Muslimeen (AIMIM). The VBA-AIMIM alliance had cut into the traditional vote banks of the Congress and NCP prospects resulting in two parties losing more than a dozen

deployed at railway and metro stations and bus stands.

The police said checking will be intensified at different locations and there may be traffic congestion in the city.

Farmer leaders Sarwan Singh Pandher and Jagjit Singh Dallewal on March 3 gave a call to farmers across the nation to reach Delhi on Wednesday for a protest. They also called for a four-hour countrywide rail roko on March 10 in support of their various demands, includ-

### Modi to launch additional | LG flags poor section of RRTS corridor civic facilities

Prime Minister Narendra Modi will launch the 17km long additional section of the Delhi-Ghaziabad-Meerut RRTS corridor from Duhai to Modi Nagar North on Wednesday, NCRTC officials said on Tuesday.

A Namo Bharat train will be flagged off on the new additional section by the prime minister from Muradnagar Regional Rapid Transit System (RRTS) station remotely through video conference from Kolkata. Union Minister Hardeep Singh Puri will also remain present during the inauguration.

With this, an additional 17km stretch from Duhai to Modi Nagar North on the Delhi-Ghaziabad-Meerut RRTS corridor, beyond the operational priority section, will be ready for operations. The extension encompasses three stations - Murad Nagar, Modi Nagar South and Modi Nagar North.

"With the inauguration of this additional 17-km section, Namo Bharat services

will be seamlessly available on erage of the Delhi-Meerut

34 km of the Delhi-Meerut RRTS corridor, incorporating eight stations from Sahibabad to Modinagar North," the National Capital Region Transport Corporation (NCRŤC) said.

The foundation stone for India's inaugural RRTS corridor, linking Delhi to Meerut, was laid by the prime minister in March 2019. It was started for passenger operations in October 2023.

The newly-added 17-km stretch of the Namo Bharat train service extends the covRRTS corridor beyond its initial operational priority section. This expansion is poised to boost regional connectivity, making commuting within the area more convenient and seamless," the

NCRTC said in a statement.

The RRTS boasts a design speed of 180 kmph and operation speed of 160 kmph. The Delhi-Ghaziabad-Meerut RRTS corridor, stretching over 82 km, is expected to shrink travel time between Delhi and Meerut to less than

After Delhi Lieutenant Governor V K Saxena slammed the city government for depriving the people of basic public facilities, Chief Minister Arvind Kejriwal on Tuesday hit back and said the former is "playing the role of the opposition" despite hold-ing a constitutional post. of garbage and streets filled with stinking sewer water will be in the capital of India. All the concerned departments are completely under the Delhi government and the MCD is also under you. The chief minister is requested to pay attention to the problems," he wrote on another post on X.

Responding to the LG, Kejriwal said he has ordered the chief secretary to remove the shortcomings in all areas mentioned by him within the next seven days.

"I am ordering the chief secretary to remove all these shortcomings within seven days. The work you are doing should have been done by the opposition. It is the job of the opposition to point out the shortcomings of the ruling party," Kejriwal posted on X. "Unfortunately, today all the seven MPs of the opposition (BJP) are busy retiring from politics and the eight MLAs are fast asleep. ### Gangster duo marriage becomes talking point in police circles

A scheduled wedding, taking place between two alleged gangsters — Anuradha Choudhary alias 'Madam Minz' from Rajasthan and Sandeep alias Kala Jathedi from Haryana — is being discussed in police

The gangster duo is going to tie the nuptial knot on March 12 at Sonipat in Haryana after a courtship of about four years. Sandeep will be out on bail for just

six hours for his wedding.

The court has granted parole to Sandeep for his marriage. Anuradha is already on bail. Their marriage invitation card also went viral on social media.

Anuradha, a closed confidante of slain gangster Anandpal Singh, is facing over half-a-dozen cases related to money laundering, abduction, giving threats and arms Act in Rajasthan and Delhi. Sandeep, who is a close associate of jailed gangster

Lawrence Bishnoi, is facing over a dozen cases of robbery, murders, attempt to murder, extortions and arms Act in Delhi, Haryana, Punjab, Rajasthan and Uttar Pradesh, according to Delhi police records.

An officer said both were arrested by a team of Delhi Police Special Cell from near a dhaba on Yamuna Nagar-Saharanpur highway on July 30, 2021. They were staying together at that point in time.

Then, Anuradha was carrying a reward of Rs 10,000 by the Rajasthan Police while Sandeep was carrying a reward of Rs 7 lakh for his arrest, the officer said. The duo's love story began in 2020, when Anuradha met Sandeep in Madhya Pradesh's Indore through a common associate, Vicky Singh, who is also Anandpal's brother, an officer said, adding both were on the run then.

According to Sandeep's dossier, he got married to Anuradha in a temple and stayed in a rented accommodation in Indore for a few months.

The police said in March, 2021, the duo went to Bihar and stayed there for a few months. In June, they left from Bihar and went to Lucknow in Uttar Pradesh. Later, they went to Shirdi in Maharashtra and also visited Mathura in UP. They finally spent a few days in Uttarakhand, Haridwar before getting arrested by Delhi Police, as mentioned in Anuradha's dossier. Another officer said after getting bail, Anuradha would meet Sandeep in jail using legal methods. "We

got to know that Anuradha was taking care of Šandeep's parents in Sonipat," he said. The officer said Anuradha got the title 'Minz' from her first husband, Deepak Minz, whom she married in 2007 but parted ways in 2013.

The police said Anuradha also pursued MBA before joining banking business.

Later, she got involved in money laundering cases and oined hands with Rajasthan's slain gangster Anandpal Singh, who was gunned down in an encounter in

Churu in 2017. A resident of village Jathedi in Sonipat, Sandeep was a student of ITI in Sonipat in Haryana.

While studying, he fell in bad company, according to his dossier shared by a senior officer of Sonipat police. "In 2004, he came to Delhi with his associates. On the same day that he visited Delhi, he snatched a mobile phone of one person in Siraspur area.

"He was caught by the police red-handed on the spot and a first case was registered against him at Samaipur Badli police station," said the senior police

Last year, the Haryana government ordered demo-lition of his house and shops constructed on the gov-

ernment's 'panchayati' land. We had to announce a reward of Rs 7 lakh on his head. At the same time, the Delhi Police imposed

MCOCA on him," a Haryana police officer said.

### Painted storks population soars at Delhi zoo

The population of painted I storks soared at the zoo here this season as their numbers doubled over the last seven months which officials attributed to procreation in the National Zoological Park's waterbodies.

"This year, the zoo has become a nesting haven, with approximately 450 nests established around ponds and in trees," Director of Delhi Zoo Manoj Kumar told PTI.

Painted storks, scientifically known as 'Mycteria leucocephala', comes from the Himalayan foothills and are not migratory birds. However, they make short-distance movements in response to changes in weather, food availability, or Kumar said that around 1,000

Their breeding season begins in

The zoo is one of the few places in Delhi where painted storks nest and breed, making it a prominent birding spot, zoo official Akansha Mahajan said. Mahajan said that around 90 kg fish, from two to four inches,

is provided daily to ensure a

proper diet for the painted storks. Speaking on the unique com-

munication methods of painted storks, officials said that the birds use beaks and wings and chirp until they are fed by their parents.

As the end of March approaches, these migratory birds are anticipated to depart from the capital following their fixed routes.

The zoo official highlighted that storks stay for 6 to 7 months in Delhi every year, undertaking nesting and breeding, which adds to the beauty of the National Zoological Park. "And this year, the number of nests, each housing one to three chicks, has increased," she added.

The National Zoological Park remains open to visitors throughout the week except


### Rajnath: India ensuring no one exercises | UP Congress leader joins BJP ahead of hegemony in Indian Ocean region

#### Inclusion of non invasive tests part of WHO norms for newborns screening

Inclusion of simple tests with Inon-invasive tools that can be integrated within the existing health systems is part of the World Health Organization (WHO) guidelines calling for universal screening of newborns for hearing impairment, eye abnormalities, and neonatal jaundice.

Highlighting the importance of this regional implementation guidance, Saima Wazed, the South-East Asia regional director of WHO said the move aimed to facilitate capacitybuilding for newborn or neonatal screening, focusing on pre-symptomatic detection shortly after birth.

The guidelines follow concerns that the contribution of birth defects to under-five mortality in the region has increased from 4 per cent to 11 per cent during the past two decades (2000 to 2021) as countries successfully addressed other major causes of death.

"By identifying serious treatable conditions early on, such as hearing impairment, eye abnormalities, and neonatal jaundice, healthcare professionals can intervene promptly, potentially preventing longterm disabilities and improving the quality of life for affected infants," she said.

"Backed by referral, diagnosis, management and follow-up for appropriate treatment, these screenings will enable prevention of long-term disability or premature death," she said during the release of the guidance



at a regional webinar on birth

The guidance incorporates simple tests with non-invasive tools that can be integrated within the existing health sys-

These screenings should be done prior to discharge after a health-facility birth or at the first postnatal care contact in an outpatient setting after a home birth, according to the guidance prepared after the exhaustive consultative process with technical experts from member countries of the region. "Focusing on improving care

around the time of birth and the first week of life is important to ensure every child survives and thrives to reach their full potential," Wazed said. She added, persistent collaborative efforts over the years has led to the South-East Asia region witnessing a 45 per cent decline in under-five mortality between 2010 and 2021 -- the steepest among all WHO regions and against the global

reduction of 26 per cent. "Our region is committed to achieving the 2030 Sustainable Development Goal targets for maternal, newborn and child mortality," Wazed said.

The Union Ayush Ministry has issued a set of new guidelines emphasising the need for quality in-patient care and the spread of Ayush hospitals across the country, in line with a bed per population norm according to which one hospital bed per 5,000 population will be deemed "essential," while 1 bed per 2,000 population to be considered "desirable."

However, the proposal looks quite ambitious at least in the near future given that more than 69 per cent of the integrated Ayush hospitals approved under the National Ayush Minister (NAM) are still either under construction or the construction has not started yet. Similarly, only about 65% of the sanctioned Ayush Health Wellness Centres have been established, as per the sources.

Moreover, many hospitals in the sector are grappling with inadequate administrative setup in States/UTs.

Currently, there are 3,844 Ayush hospitals of various categories across the country, managed by both central and state governments, with a collective bed strength of 60,943

The guidelines suggest that the "essential" number of beds can be provided through the public health system, includng medical colleges, district hospitals, and various sizes of Ayush hospitals, as per the Indian Public Health Standards (IPHS) for Ayush healthcare facilities.

To achieve the "desirable"

number of beds, the guideline suggests involvement of the private sector is encouraged while continuing to enhance bed provision at public health facilities. All beds operational for more than 24 hours for patient care are considered inpatient hospital beds. Ayush hospitals are expected

to offer a comprehensive range of essential services aligned with Ayurveda, Yoga, Unani, Siddha, SowaRigpa, and Homoeopathy principles. This includes promotive, preventive, curative, and rehabilitative services for a wide array of health conditions, with an emphasis on integrating traditional and complementary medicine practices with modern healthcare systems.

The guidelines stress the importance of ensuring a continuum of care, establishing referral systems, and facility readiness for managing referred cases. They also highlight the need

for strategic planning for ser-

vice delivery, emphasizing

service categorization and corresponding resource classification.

States and Union territories are urged to conduct Ayushspecific training needs assessments, integrate Ayush and modern medicine training for healthcare professionals as needed, and establish robust grievance redressal mechanisms in Ayush hospitals. Furthermore, an occupational safety and health policy for Ayush hospitals is recommended to ensure the safety, health, and well-being of employees, patients, and vis-

As per guidelines, quality assurance will be deemed crucial, with an emphasis on maintaining standards that meet prescribed criteria independently. Best practices from contemporary systems like National Quality Assurance System and National Accreditation Board for Hospital and Healthcare Providers standards will be consulted and customized for

### El Nino reaches peak, temperature to hit above normal from March to May

he 2023-24 El Nino has The 2023-24 Li Time reached its peak, ranking among the five strongest on among the five strongest on record, and is anticipated to continue influencing global climate patterns in the coming months, despite showing signs of weakening, the World Meteorological Organization (WMO) said on Tracedor (WMO) said on Tuesday.

It reported that above-normal temperatures are expected over almost all land areas from March to May in the current year.

The prevailing El Nino conditions fuelled record temperatures and extreme events the world over, with 2023 being the warmest on record. According to the European Union's Copernicus Climate Change Service, the global mean temperature breached the 1.5-degree Celsius threshold for an entire year for the first time in January.

A permanent breach of the 1.5-degree Celsius limit, specified in the Paris Agreement, however, refers to long-term warming over many years. In its latest update, the World Meteorological Organisation (WMO) said there is about a 60 per cent chance of El Nino persisting during March-May and an 80 per cent likelihood of neutral conditions (neither

El Nino nor La Nina) during April to June. There is a chance of La Nina developing later in the year but those odds are currently uncertain, it said.

Scientists closely tracking the

development in India have said La Nina conditions setting in by June-August could mean monsoon rains would be better this year than in

El Nino -- a periodic warming of the ocean surface in the central and eastern tropical Pacific Ocean -- occurs every two to seven years on an average, and typically lasts nine to 12 months.

It is associated with increased rainfall in the Horn of Africa and the southern US, and unusually dry and warm conditions in Southeast Asia, Australia and southern Africa.

Every month since June 2023 has set a new monthly tem-perature record -- and 2023 was, by far, the warmest year on record.

El Nino has contributed to these record temperatures but heat-trapping greenhouse gases are unequivocally the main culprit," said WMO Secretary-General Celeste

"Ocean surface temperatures in the equatorial Pacific cleary reflect El Nino.

But sea-surface temperatures in other parts of the globe have been persistently and unusually high for the past 10 months. The January 2024 sea-surface temperature was by far the highest on record for January. This is worrying and cannot be explained by El Nino alone," she said. Scientists say El Nino typi

cally has the greatest impact on the global climate in the second year of its development — 2024, in this instance. The continuing, albeit weaker, El Nino and predicted above-normal sea-surface temperatures over much of the global oceans are expected to lead to above-normal temperatures over almost all land areas in the next three months, and influence regional rainfall patterns, according to a Global Seasonal Climate Update issued by the WMO.

### **Probity in public life**

The Supreme Court ruling exposing lawmakers to prosecution for bribery is a welcome step

■ n a landmark judgment that is sure to go a long way in cleaning up the system but making the political class somewhat uncomfortable, the Supreme Court has reversed an earlier decision to rule that the lawmakers are not immune from prosecution for bribery. The verdict, which will indeed help fortify the pillars of Indian democracy, underlines accountability and integrity among elected representatives. The apex court has sent out a resounding message that the rule of law is paramount, even in the highest echelons of governance. The sacrosanct duty of MPs and MLAs, entrusted with shaping policies and laws reflecting the collective will of the electorate, can be undermined if and when corruption seeps in, eroding public trust and subverting the very soul of democracy. Bribery, in particular, poses a grave threat to the purity of political processes, distorting decision-making and skewing priorities. The notion of parliamentary immunity has shielded lawmakers from legal repercussions within the legislative domain,



ensuring uninhibited debate and deliberation. While this immunity serves a crucial purpose in fostering open discourse, it should not be misconstrued as a license for malfeasance or abuse of power. This is about to change with the Supreme Court's recent verdict, which draws a clear line that lawmakers cannot invoke immunity as a shield against allegations of bribery, a practice antithetical to the principles of democracy and justice.

This decision underscores the notion that even the lawmakers are not above the law but are subject to its scrutiny, reinforcing the accountability mechanisms essential for the functioning of a robust democracy.

Moreover, the ruling serves as a deterrent against perversion of political processes through illicit means, safeguarding the integrity of electoral mandates and preserving the sanctity of democratic institutions. In a landscape marred by cynical disillusionment with politics, such decisive action by the judiciary will instil confidence among citizens, reaffirming their faith in the impartiality of the system. However, such judgments find true efficacy when the Government implements these in letter and spirit. More often than not, the political class finds means to subvert the best of laws when it comes to serving their own interests. Moreover, the laws are often selectively applied to harass the rivals rather than to bring a person to book for his misdeeds. The process becomes the punishment. Since investigating agencies are under Government control, the latter often determines which cases to pursue for legal action. That said, the ruling is certainly a step forward as the primary condition for change is a legal framework. This judgment represents a significant milestone; it is imperative to recognise that the battle against corruption is ongoing and multifaceted. Efforts to foster clean politics must extend beyond legal pronouncements to encompass broader reforms in electoral financing, institutional oversight and civic education.

ndia looks back at a year that presented challenges, ▲ particularly in addressing the infrastructural damages resulting from natural disasters. Subsistence in Joshimath incurred a cost of over Rs. 565 Subsequently, rivers surged beyond the danger mark, wreaking havoc on the infrastructure and properties of Uttarakhand, Punjab, Haryana, Himachal and Delhi. The toll was grim, with 208 lives lost, 621 houses destroyed, and over 4,200 houses partially damaged across these states. Heavy rains further exacerbated the situation, causing an estimated 10,000 crores in damages, while under-construction bridge collapses in Gujarat, Mizoram and Bihar claimed numerous lives.

Much like the Silkyara-Barkot tunnel collapse, this incident exemplifies the vulnerability of infrastructure especially in eco-sensitive zones that jeopardise lives. The devastation of infrastructure, loss of lives, and drained resources serve as stark reminders, emphasising that prioritising sustainable infrastructure isn't merely a choice but an imme-



diate imperative. Without this focus, our investments and dreams of advancement risk being swept away or collapsing altogether.

Tackling the Core Issue Crucial to averting such incidents is addressing the core factors that might precipitate them, such as reconsidering the L1 tender bidding system. Adopting more effective practices can contribute positively by promoting quality over solely opting for the lowest bidder. This cost-centric approach often results in compromises on the quality of materials and construction practices which may lead to catastrophic failures.

# WTO deadlock over agricultural subsidies-



At the WTO Ministerial Conference, India stood firm on its stance on public stockholding programme, drawing strong opposition from the developed countries

he 13th ministerial conference (MC) of WTO (World Trade Organisation) held on February 26-29, 2024 in Abu Dhabi has ended in a deadlock. This is because India leads about 80 countries the G33 including India, African, Caribbean and Pacific countries, together called ACP—on - on one hand and the European Union (EU) and the USA representing the developed countries on the other didn't budge from their respective pre-meditated positions.

On the most important issue of finding a permanent solution to the public stockholding (PSH) programme for food security, India's stance was vehemently opposed by the USA/EU. Currently, under India's PSH programme, government agencies like the Food Corporation of India (FCI) buy agri-produce such as wheat, rice/paddy, and coarse cereals from farmers at the minimum support price (MSP) and give it free to India's poor population under the National Food Security Act (NFSA).

The cost of supplying food i.e. MSP plus handling, storage and distribution costs is paid as a subsidy from the Union Budget. This can be bifurcated into two components (a) subsidy to the farmer, which is the excess of MSP of, say, rice over its international price also known as External Reference Price (ERP) and (b) subsidy to the food consumer, being the excess of ERP over 'nil'. The WTO is concerned with (a) branded as "product-specific" subsidies.

The international price/ERP of any commodity is based on global demand-supply forces and is determined competitively. All farmers irrespective of their country of location are expected to receive this price. In case, because of the intervention by the government of a member country say India, the farmers therein receive a price/MSP higher than this, they are presumed to have been subsidised to the extent of excess of MSP over ERP. The WTO is also concerned with subsidies on agricultural inputs like fertilisers, seeds, irrigation, power, etc., referred to as "non-product specific" subsidies.

Termed as 'Amber box' subsidies, under the Agreement on Agriculture (AoA), the total of product and non-product-specific subsidies or aggregate measurement support (AMS) is capped at 10 per cent of the value of agricultural production for a developing country. If a member country gives AMS over 10 per cent, it is a vio-

The AoA came into force in 1995. For India, until 2005, MSP was less than ERP. Thereafter, MSP has been higher than ERP and, in the last decade, this gap widened. During 2019-20, in the case of rice, AMS was 13.7 per cent, exceeding the 10 per cent cap. The big question is:-Does this excess subsidy distorts international trade? The answer is a categorical 'no'. This is because the formula for the computation of AMS is flawed. The ERP used for comparing with MSP (albeit current) dates back to 1986-88. This is bound to "artificially" inflate the subsidy. Besides, AoA calculation doesn't exclude subsidies given to resource-poor farmers. These farmers mostly produce food for self-consumption meaning they don't have a surplus to sell. Both these flaws need to be

However, the peace clause comes with several riders, such as the submission of data on food procurement, stockholding, distribution and subsidies. These also include establishing that subsidies are not "trade distorting." Besides, programmes implemented after 2013 are not covered under the ambit of the 'peace clause'.

India has invoked the 'peace clause' several times for breaching the 10 per cent ceiling in case of subsidy on rice. However, developed countries have objected to such invocation citing it is not transparent and that cereals procured under PSH are 'illegitimately exported. It would appear that charge levelled by Thailand Ambassador to the

WTO Pimchanok Vonkorpon Pitfield (she said, 40 per cent of India's rice exports were stocks diverted from PSH) was made at their behest.

The developed countries have an interest in ensuring that their agri-produce occupies a big space in the international market. This, in turn, will require that Indian exports be discouraged. Therefore, the extant arrangement (read: peace clause with riders) suits them. Hence, they have no interest in finding a permanent solution. It has been deferred for over a decade and they will continue to do so.

Meanwhile, India will do well to ensure smooth sailing with the peace clause. To avoid pinpricks by for a permanent solution." This was modified in the General Council (GC) held in December es by its agencies are synchronized with the requirements of NFSA; that excess stock situations are avoided and that there is no leakage of subsidised food from the PSH programme.

On fisheries subsidies, in sync with the principles of "polluter pays" and "common but differentiated responsibilities," India had proposed that developed countries abolish their subsidies over the next 25 years even while exempting developing countries from over-fishing subsidy prohibition within these 25 years.

In this regard, the MC - 12 held on

June 12-17, 2022 (Geneva) decided that "no subsidies will be given for fishing in areas outside exclusive economic zones (EEZ) or RFMOs (regional fisheries management organisation)". It also agreed to check illegal, unreport-

ed and unregulated (IUU) fishing and mooted "very strict controls" on overfishing so that fish stocks are restored.

India was allowed to give subsidies for fishing in the EEZ - merely a reiteration of its rights under the UN Law of the Sea Convention. However, this was subject to putting in place a regime for managing and monitoring marine fish stocks within two years. If it fails, it will be compelled to stop subsidies for poor fishermen.

In the MC-13, India wanted

unconditional exemption to the poorer nations for the subsidies they give for their small-scale and artisanal fishermen. The developed countries refused to give it. As for the moratorium on customs duty on e-commerce (developed coun tries have been its prime beneficiaries since 1998), India wanted this to go as developing countries are losing billions of dollars in duties foregone. The MC-12 had decided to extend the moratorium till MC -13 or March 2024, whichever is earlier. During the Abu Dhabi Ministerial, India reiterated this demand.

It stuck to its stance till the last moment but had to give up as the majority of the members (including the UAE) decided to continue the moratorium for two more years. Meanwhile, India stalled attempts by China to get through an agreement on 'investment facilitation'. It also opposed efforts by developed countries to bring other non-trade issues such as environment, labour standards, industrial policy etc to the table.

a s a child, I often sat amidst the greenery, gazing at the Himalayan mountains. Returning after many years, the charge in the land the changes in the landscape and my village were striking. The condition of schools has improved significantly, and piped water lines are visible in every home, along with the construction of toilets. Most houses, once with stone roofs, have now transitioned to concrete structures. While the physical infrastructure development was impressive, it lacked the charm that fascinated me during my childhood. The ongoing changes have altered the village's ambience due to moderniza-





Presently, livelihood opportunities at the village level have become scarce, compelling people to leave their homes. This is endangering the existence of the mountains.

Saraswati Devi, 68, from Bhunoli village, recounts significant changes in her lifetime. At 12, she witnessed both men and women singing and laughing together while ploughing

fields with the help of oxen. However, at 35, this practice was limited to a few families. Today, at 68, neither family members nor oxen can be seen in these fields; machines have taken over. The geographical and cultural gap created by modernization is forcing people away from each other. Saraswati Devi states that modern tools and technology have not only taken away rural employment but also distanced village residents from their villages.

Development is not inherently negative. It not only facilitates the acquisition of amenities but also plays a crucial role in the economy. However, the ongoing changes in villages due to modernization pose a dan-

gerous threat. This danger is not only related to social and cultural transformations but also involves the linked peril of losing the identity of the

If not stopped in time, a day is not far when the simplicity of the hills and its culture will disappear into anonymity, and future generations will only see mountains in books or pictures. Development is simultaneously robbing the rural population of their livelihoods, demanding timely interventions and policies that allow both development and local employment in the villages.

### 'Latest talks on Gaza have ended with no breakthrough'

Three days of negotiations with Hamas over a cease-fire in Gaza and the release of Israeli hostages ended Tuesday without a breakthrough, Egyptian officials said, less than a week before the start of the Muslim holy month of Ramadan, the informal deadline for a deal

The United States, Qatar and Egypt have spent weeks trying to broker an agreement in which Hamas would release up to 40 hostages in return for a monthlong cease-fire, the release of some Palestinian prisoners and an influx of aid to address the humanitarian catastrophe in the isolated territo-

Two Egyptian officials said the latest round of discussions had ended. They said Hamas presented a proposal that mediators would discuss with Israel in the coming days.

Hamas has refused to release all of the estimated 100 hostages it holds, and the remains of around 30 more, unless Israel ends its offensive, withdraws from the territory and releases a large number of Palestinian prisoners, includ ing senior militants serving life sentences. Jihad Taha, a Hamas spokesperson, said the negotiations were ongoing but "the ball is in the Israeli court". He said Israel had thus far refused Hamas' demands for people who fled northern

Gaza to be allowed to return and for guarantees of a cease-fire and full withdrawal

"Hamas is open to proposals and initiatives that are consistent with its position calling for a cease-fire, withdrawal, the return of the displaced, the entry of relief convoys and reconstruction," Taha said.

Israeli Prime Minister Benjamin Netanyahu has publicly rejected Hamas' demands and repeatedly vowed to continue the war until Hamas is dismantled and all the hostages are returned. Israel did not send a delegation to the latest round of talks.

An Israeli official said Israel was still waiting for Hamas to hand over a list of hostages who are alive as well the hostage-to-prisoner ratio it seeks in any release deal. It was not clear if that information was included in the latest pro-

The Israeli and Egyptian officials spoke on condition of anonymity because they were not authorized to brief media on the negotiations.

Benny Gantz, a member of Netanyahu's War Cabinet and his main political rival, met with senior US officials in Washington on a visit that drew a rebuke from the prime minister, the latest sign of a growing rift within Israel's

Mediators had hoped to broker an agreement ahead of Ramadan, the

month of dawn-to-dusk fasting that often sees heightened Israeli-Palestinian tensions linked to access to a major holy site in Jerusalem. The month is expected to begin around March 10, depending on the sighting of the moon. The negotiations are sensitive. I can't say there is optimism or pessimism, but we haven't yet reached a point at which we can achieve a cease-fire," Egyptian Foreign Minister Sameh Shoukry said

The war began with a Hamas attack into southern Israel on Oct 7 in which Palestinian militants killed some 1,200 people and took around 250 hostages. More than 100 of them were released during a weeklong cease-fire in

The attack sparked an Israeli invasion of the enclave of 2.3 million people that Gaza's Health Ministry says has killed more than 30,000 Palestinians. Aid groups say the fighting has displaced most of the territory's population and pushed a quarter of the population to the brink of famine. The UN children's agency said Monday that at least 10 children have reportedly died in isolated northern Gaza because of dehydration and malnutrition."There are likely more children fighting for their lives somewhere in one of Gaza's few remaining hospitals, and likely even more children in the north unable to obtain care at all," Adele Khodr, the UNICEF regional director for the Middle East and North Africa, said in a statement. "These tragic and horrific deaths are man-made, predictable and entirely preventable," she added. The Gaza Health Ministry said Sunday that 15 children have starved to death at the Kamal Adwan Hospital in northern Gaza and another six were at risk of dying from malnutrition and dehydration. It was not clear if the children had underlying medical conditions that increased their vulnerability.

Northern Gaza, the first target of Israel's offensive, has suffered mass devastation. The World Food Programme recently suspended aid shipments to the north, citing the breakdown of security. An attempt by the Israeli military to bring in aid ended in tragedy last week when over 100 Palestinians were fatally shot by Israeli forces or trampled to death in a melee.Up to 300,000 Palestinians are believed to remain in northern Gaza after Israel ordered the evacuation of the entire region, including Gaza City, in October. Many have been reduced to eating animal fodder to survive.

The UN says one in six children under 2 in the north suffer from acute malnutrition. The United States and other countries have carried out air drops in recent days, but aid groups say the expensive, last-ditch measure is not enough to address the soaring needs.

#### One Indian killed & two hurt in anti-tank missile attack

Jerusalem (PTI): An Indian national was killed and another two were injured on Monday when an anti-tank missile fired from Lebanon by Hezbollah militants struck an orchard near Israel's northern border community of Margaliot, officials said and condemned it as a cowardly terror attack on peaceful agriculture workers.

All three victims were from Kerala.

The missile hit a plantation in Margaliot, a moshav (collective agricultural community), in the Galilee region in the north of Israel around 11 am on Monday, Zaki Heller, spokesperson for rescue services Magen David Adom (MDA), told PTI.

Patnibin Maxwell, 30, from Kollam in Kerala was killed in the attack. His mortal remains were identified in Ziv hospital, official sources said.

### Gangs in Haiti try to seize control of int'l airport

**AP** ■ PORT-AU-PRINCE

Heavily armed gangs tried to seize control of Haiti's main international airport on Monday, exchanging gunfire with police and soldiers in the latest attack on key government sites in an explosion of violence that includes a mass escape from the country's two biggest

The Toussaint Louverture International Airport was closed when the attack occurred, with no planes operating and no passengers on site.

Associated Press journalists saw an armoured truck on the tarmac shooting at gangs to try and prevent them from entering airport grounds as scores of employees and other workers fled from whizzing bullets.

It wasn't immediately clear as of late Monday whether the attack, which was the biggest one in Haiti's history involving the airport, was successful.

Last week, the airport was struck briefly by bullets amid ongoing gang attacks, but gangs did not enter the airport nor seize control of it.

The attack occurred just hours after authorities in Haiti following violence in which armed gang members overran the two biggest prisons and freed thousands of inmates over the weekend.

"The secretary-general is deeply concerned by the rapidly deteriorating security situation in Port-au-Prince, where armed gangs have intensified their attacks on critical infrastructure over the weekend. said UN spokesman Stephane Dujarric.

A 72-hour state of emergency began Sunday night. The government said it would try to track down the escaped inmates, including from a penitentiary were the vast majority were in pre-trial detention, with some accused of slayings,

It added that it "deplored and condemned the policy of nonchalance" demonstrated by government officials amid the attacks.

#### Top EU officials propose plans to boost bloc's defense in face

Brussels (AP): Top European Union officials on Tuesday outlined ambitious plans to boost its defense industry at an unprecedented pace as the bloc seeks to respond to the threat posed by Russia's war on Ukraine and a trans-Atlantic partner that could be wavering on its commitments to Europe. For decades, EU nations have slumbered under the protective nuclear cover of the United States through the NATO alliance while their defense spending and crisis preparedness withered.

A first warning under Donald Trump's presidency highlighted a lack of coordination and supplies that would be needed if European nations would ever have to defend themselves without Washington's help.

Now, with an increasingly assertive Moscow, the need to beef up defense is becoming ever clearer.

"After decades of underspending, we must invest more on defense, but we need to do it better and together," said EU foreign policy chief Josep Borrell. "A strong, resilient, uropear defense industry is a strategic imperative.

Russia's invasion of Ukraine has exposed glaring weaknesses in Europe's arms manufacturing capacities that were neglected in the wake of the 1989 fall of the Berlin Wall and the promise of a peace dividend in Europe

So when Kyiv was badly in need of the most elementary ammunition to stave off Russian forces, European nations were caught out, unable to deliver what was asked and even promised.

The realization that former President Trump might return to the White House and undermine support for Ukraine has also focused minds in Europe EU heavyweights France and Germany have warned that the bloc must do more to pro-

### Ex-Twitter CEO Parag sues Elon Musk

The lawsuit against the Tesla and SpaceX chief and X Corp was filed in the US District Court, Northern District of California by Agrawal, Gadde Twitter's former Chief Financial Officer Ned Segal and General Counsel Sean Edgett. Musk has a "special ire" toward Agrawal, Segal, Gadde, and Edgett, who in their leadership roles at Twitter "appropriately and vigorously represented the interests of Twitter's public shareholders throughout Musk's wrongful attempt to renege on the deal. For their efforts, Musk vowed a lifetime of revenge," the 38-page



lawsuit said. Agrawal worked at Twitter from 2011 until 2022 and was the platform's Chief Executive Officer from November 29, 2021, until October 27, 2022, a role he took over from the company's founder and former CEO Jack

The lawsuit also notes that as Musk was closing Twitter's acquisition for USD 44 billion in 2022, the billionaire told his

official biographer Walter Isaacson, that he would "hunt every single one of" Twitter's executives and directors "till the day they die."

These statements were not the mere rantings of a self-centred billionaire surrounded by enablers unwilling to confront him with the legal consequences of his own choices. Musk bragged to Isaacson specifically how he planned to cheat

he said. The four former Twitter executives claim in the lawsuit that Musk owes them severance payments totalling about USD 128 million. "Under Musk's control, Twitter has become a scofflaw, stiffing employees, landlords, vendors, and others. Musk doesn't pay his bills, believes the rules don't apply to him, and uses his wealth and power to run roughshod over anyone who disagrees with him," the lawsuit said. It said that Agrawal is entitled to severance benefits amounting to over USD 57 million, which is equal to his one-year salary of one million dollars plus restricted stock units, performance share units and other benefits. Gadde is entitled to severance benefits in the amount of USD 20 million, an amount equal to one year's salary of USD 600,000 plus other benefits.

The lawsuit alleges that severance benefits in order to under Twitter's severance plans nated without cause following a change in control, they are enti-

tled to severance benefits. "Because Musk decided he didn't want to pay Plaintiffs' severance benefits, he simply fired them without reason, then made up fake cause and appointed employees of his various companies to uphold his decision. He claimed in his termination letters that each Plaintiff committed "gross negligence" and "willful misconduct" without citing a single fact in support of this claim," the

lawsuit said.

The four executives highlighted "the Musk playbook", which is "to keep the money he owes other people and force them to sue him.

ed on June 8 and the weekend that follows. The events, annual highlights in the royal calendar, are pomp-filled birthday parades to honour the reigning monarch and usually draw huge crowds each June to watch



the display. The tradition dates back more than 260 years.

The Ministry of Defence said Kate, 42, will inspect soldiers on parade during the June 8 ceremony. Hundreds of foot guards, horse guards and members of military bands will participate in the spectacle at central London's Horse Guards and along The Mall, the prom-enade outside Buckingham Palace. The royal family has been under intense media scrutiny in recent weeks because both

Kate and King Chares III cannot carry out their usual public duties due to their health problems. Royal officials say Charles is undergoing treatment for an unspecified form of cancer, which was discovered during treatment for an enlarged prostate. Kate was discharged from

the hospital on January 29 after two weeks for her undisclosed condition. Palace officials have said she wished her personal medical information to remain private.

Architecture Prize has been awarded to Japan's Riken Yamamoto, who earns the field's highest honour for what organisers called a long career focused on "multiplying opportunities for people to meet spontaneously, through pre-cise, rational design strategies". ings — from residences to museums to schools, from a bustling airport centre to a glass-walled fire station — and prizing a spirit of community in all spaces. "By the strong, consistent quality of his buildings, he aims to dignify, enhance and enrich the lives of individuals — from children to elders — and their social connections," the jury said, in part, in a citation released on Tuesday. "For him, a building has a public function even when it is private."

### Philippine and **Chinese vessels** collide in SCS, 4 crew injured

Chinese and Philippine coast guard vessels collided in the disputed South China Sea, and four Filipino crew members were injured Tuesday in a series of confrontations as Southeast Asian leaders gathered for an Asian summit where alarm over Beijing's aggression at sea was expected to be raised. The Chinese coast guard ships and accompanying vessels blocked the Philippine coast guard and supply vessels off the disputed Second Thomas Shoal and executed dangerous maneuvers that caused two minor collisions between the Chinese ships and two of the Philippine vessels, Philippine officials said. The BRP Sindangan of the Philippine coast guard had minor structural damage from the collision that happened shortly after dawn. Over an hour later, another Chinese coast guard ship first blocked then collided with a supply boat the Philippine coast guard was escorting, the Philippine officials said.

The supply boat, manned by Filipino navy personnel, was later hit by water cannon blasts from two Chinese coast guard ships. Its windshield shattered, injuring at least four Filipino crew members, according to a statement from the Philippine government task force dealing with territorial disputes. The task force said the actions by the Chinese was "another attempt to illegally impede or obstruct a routine resupply and rotation mission". "China's latest unprovoked acts of coercion and dangerous maneuvers" against Philippine ships en route to deliver supplies and fresh troops to the Philippine-occupied shoal "put the lives of our people at risk and caused actual injury to Filipinos," it said. A small Philippine marine and navy contingent has kept watch onboard a rusting warship, the BRP Sierra Madre, which has been marooned since the late 1990s in the shallows of the Second Thomas Shoal

China also claims the shoal lying off the western Philippines and has surrounded the atoll with coast guard, navy and other ships to press its claims and prevent Filipino forces from delivering construction materials to fortify the Sierra Madre in a decades-long standoff. The shoal has been the site of several tense skirmishes between Chinese and Philippine coast guard ships last year. The Chinese coast guard said in a statement that "it took control measures in accordance with the law against Philippine ships that illegally intruded into the waters adjacent to Ren'ai Reef," the name Beijing uses for Second Thomas Shoal.

A Chinese coast guard spokesperson said a Philippine ship deliberately rammed a Chinese coast guard vessel, causing a minor scratch.

The long-simmering territorial disputes in the South China Sea are expected to be discussed at a summit of leaders of the Association of Southeast Asian Nations and their Australian counterpart on Wednesday in Melbourne. On Monday, Philippine President Ferdinand Marcos Jr said in the Australian city that his administration "will do whatever it takes" to manage any threat to his country's territory but stressed that Manila would continue "to tread the path of dialogue and diplomacy" in resolving disputes with



### China hikes defence budget amid rivalry with US

China on Tuesday increased its defence budget by 7.2 per cent to USD 232 billion as it continues with the massive modernisation of its military amid prevailing tensions over Taiwan, the South China Sea, border frictions with India and

increasing rivalry with the US.
China, which is the second highest spender on defence after the US, has allocated 1.67 trillion yuan (about USD 232 billion) for defence spending. The US defence budget for the last year amounted to USD 886 billion. The increase in terms of the percentage of China's defence budget was the same as last year. China last year hiked its

defence budget by 7.2 per cent to 1.55 trillion yuan (about USD 225 billion), marking the eighth consecutive year of increase in its military spending. Like its previous budgets, this year's defence budget of China was almost three times higher than that of India. India's defence allocation this year amounted to Rs 6,21,541 crore (about USD 74.8 billion). While hiking the defence budget,

But the budget is also expected to take into account the risk of an armed conflict triggered by something "unpredictable", with more military encounters in the

Taiwan electing a new independence-leaning president in January, and a possible come-back of Donald Trump (as president) in the US, a report in the Hong Kong-based South China Morning Post said.

The PLA has a target of 2027 - the year of its centenary to achieve its costly modernisation goals, paving the way for it to become a "world-class" military power by 2049. Li said the government will consolidate and enhance the integration of national strategies and strategic capabilities, refine the system and layout of defence-related science, technology, and industries, raise public awareness concerning national defence, and strengthen national defence mobilisation and readiness of reserve forces, he said.

'We in governments at all levels will provide strong sup-port to the development of national defence and the armed forces and strengthen mutual support between civilian sectors and the military, so as to consolidate the unity between the military and the government and between the military and the people," he said.

### China retains 5% growth target for 2024 as economy struggles to shake off slowdown

Grappling with economic slowdown and dwindling business sentiment, China on Tuesday fixed a modest growth target of around five per cent this year with a pledge to create 12 million jobs amid growing concerns over rising unemployment. The country expects to create over 12 million jobs in urban areas and keep the surveyed urban unemployment rate at around 5.5 per cent this year, Chinese Premier Li Qiang said in his maiden work report presented to the opening session of the country's rubberstamp parliament, the National People's Congress (NPC). The week-long NPC annual session at the Great Hall of People was attended among others by Chinese President Xi Jinping besides over two thousand delegates from across the country

to deliberate and legislate on key initiatives needed to strengthen the growth of the second-largest economy, which continued with post COVID-

19 slowdown. A proactive fiscal policy and a prudent monetary poli-cy will be continued, with the ratio of deficit to gross domestic product (GDP) set at three per cent and the government deficit to rise by 180 billion yuan (USD 26 billion) from the 2023 budget figure, Li said in his 39-page work report. This is the first work report by Li who succeeded Li Keqiang last year. As a staunch Xi loyalist, Li Qiang has discarded the decade-old practice of addressing the media at the end of the annual parliament sessions.

Last year China posted 5.2 per cent GDP, exceeding the official target of around five per cent amid mounting market fidence, a protracted property market slump, and a weak private sector progress.

Significantly, last year the government stopped publishing data on unemployment for the first time amid reports of a deepening job crisis.

However, in January the National Bureau of Statistics (NBS) said the jobless rate for the 16 to 24 age group stood at 14.9 per cent in December.

Playing down the concerns over the slowdown of the world's second-largest economy, Li in his work report said, 'We secured a smooth transition in epidemic response following a major, decisive victory in the fight against COVID-19".He said the main goals and tasks for economic and social development in 2023 were accomplished, and the government made steady progress

In March 2023 the court issued an arrest warrant for Russian President Vladimir Putin for war crimes, accusing him of personal responsibility for the abductions of children from Ukraine. ### Unemployment rate dips India services sector growth eases in February to 3.1 per cent in 2023

nemployment rate for persons aged 15 years or above declined to 3.1 per cent in 2023, the lowest in the last three years, as per a report of National Sample Survey Organisation under the Statistics Ministry

According to Periodic Labour Force Survey (PLFS) for calender year 2023, the unemployment rate came down to 3.1 per cent in 2023 from 3.6 per cent in 2022 and 4.2 per cent in 2021.

Joblessness, or unemployment rate, is defined as the percentage of unemployed people in the labour force.

As per the data, employment situation is improving after the pandemic hit the country in March 2020, which forced authorities impose lockdown to curb the spread of deadly coronavirus.

The data also showed the improvement in buoyancy in economic activities after lifting of lockdown by the Centre and states. The survey showed that unemployment rate among females also declined to 3 per cent in 2023 from 3.3 per cent in 2022 and 3.4 per cent in



### Rise in ACL injuries in women soccer highlights gender inequality, UK report says

Arise in anterior cruciate ligament injuries in women's soccer highlights "systemic gender inequality in sports," a UK parliament report said on Tuesday.

The Women and Equalities Committee said there was a "lack of understanding of the health and physiological needs of women and girls across

sport." În its report "Health barriers for girls and women in sport," it cited a lack of footwear specifically designed for the needs of female soccer players address the issue.

"It is symptomatic of gender inequality and sexism in the sports sector that the first football boot in the world designed around female feet came to the market less than four years ago," committee chair Caroline Nokes said. ACL injuries to high-profile players have cast a spotlight on

that specific issue. Chelsea and Australia striker Sam Kerr suffered ACL damage in January. Other leading players Alexia Putellas, Mead and Leah Williamson have

The report said the issues go beyond the professional level and called for schools to "drastically" improve teaching including the menstrual cycle, when it comes to sport and exercise. Again, it was an area of concern.

There is overwhelming evidence that school PE and

"Players are receiving financial grants from the Government of India and the state governments, some have got government jobs in Haryana, Kerala, Odisha. We are expecting government job announcements for some more players," he added.
