NEW DELHI/KOLKATTA

In an apparent heads on with the BJP led Modi regime, TMC supremo and chief West Bengal Chief Minister Mamata Baneriee on Sunday has once again fielded Mahua Moitra, who was expelled from the current Lok Sabha, from Krishnanagar. The move by TMC is seen as a

a cash-for-questions scandal, has been supported by Trinamool despite initial reservations and a open front opened in and out of the Parliament as well as social media platforms by BJP MP Nishikant Dubey.

Mahua is facing multiple investigations led by Enforcement Directorate and CBI in the cash for query matter. In the CBI probe she has sent her response to the questionnaire.

Two election commissioners are likely to be appointed by March 15 to fill the vacancies created by the retirement of Anup Chandra Pandey and the surprise resignation of Arun Goel on Saturday.

Days before the poll panel is expected to announce the schedule for the Lok Sabha polls, Goel resigned and resignation was accepted by President Droupadi Murmu on Saturday and the Law Ministry issued notification to announce it. This leaves Chief Election

Commissioner Rajiv Kumar as the sole member of the poll authority Pandey had demitted office on February 14 on attaining

Because of the disruption of train services, experienced passengers inconvenience. According to railway authorities, nine trains including Ferozepur to Bathinda, Jalandhar City to Hoshiarpur, and Jalandhar City to Pathankot were cancelled and many trains were either shortterminated or short-originated.

TMC announces LS list from public rally, spurns Congress

Marked by a perfect event management, that included a first-of-its kind announcement of party nominees for the Lok Sabha elections from a public rally, and making them walk on a rock-concert-type ramp in the midst of a reported 8-lakh-strong crowd Trinamool Congress chief Mamata Banerjee on Sunday made it loudly clear to a "still-in-the-waiting" Congress Party that she would not ally with

them at the hustings. Having announced TMC candidates from all the 42 seats Banerjee tended to walk her talk that she would "not ally with the Congress in Bengal despite my support for the INDIA alliance elsewhere.'

At the end of a BJP-bashing rally christened Jana Garjan Sabha (Public Outcry Meet) Bengal Chief Minister Mamata Banerjee announced the names of 42 TMC candidates and walked with them on the 320feet blue ramp --- that resembled a huge 'Plus' from a drone's eye view --- right in the midst of the teeming lakhs after declaring that TMC was "introducing its candidates to the public in a fashion no other

party had done before." She said, "Here is a novel thing that we have for you ... you have never seen such a thing before ... after Abhishek



Baneriee announces the names of the candidates I will walk with them down the ramp for you to see them.

Apart from the innovative presentation of a political event Banerjee's outfit had many more surprises for the political fraternity fielding at least two cricketers and three "outsiders" - in the form of Mumbai star Shatrughna Sinha, and former cricketers Kirti Azad and Yusuf

ome May 2024, a fleet of Cfive hydrogen-fuel cell commercial buses shall start operating at a height of 11,500 feet in the eco-fragile Himalayan region of Ladakh. The National Thermal Power Corporation (NTPC) Ltd (NTPC) under its Corporate Social Responsibility (CSR) initiative is going to provide these buses to the Ladakh administration which is already working towards making Ladakh a carbon-neutral region.

A high-level meeting was chaired by the Administrative Secretary of the Transport Department, UT Ladakh Amit Sharma to finalize the draft proposal of a Memorandum of Understanding between the National Thermal Power Corporation (NTPC) Ltd. and the Transport Department, Ladakh.

The UT administration is racing against time to ensure the successful implementation of the zero-emission hydrogen mobility project in Leh.

On ground zero, the UT administration has already started raising the required infrastructure at Changthang to ensure the hassle-free launch of the ambitious pro-

Speaking to The Pioneer over the telephone Amit Sharma said the transport department plans to run these hydrogen



fuel cell buses in Leh and its peripheral areas by May 2024 He said the UT administration is awaiting the fleet of buses to

According to the proposal, these buses can cover a distance of 225 km per day. The seating capacity of each bus is 33 plus drivers.

After the Leh district, the Kargil district with five such buses will be covered in the second phase.

"Since these buses get their energy from hydrogen, there will be no emission of harmful gases, except water vapours and warm air. They are more efficient than conventional internal combustion engine vehicles and produce no harmful tailpipe emissions," said Sharma.

"Hydrogen fuel cell buses in Ladakh would be the first of its kind initiative in India. Since the Prime Minister has accorded top priority to make Ladakh a carbon-neutral region, we are doing everything possible to achieve the objective," he added

Trinamool invokes Bengali asmita as it sounds poll bugle

The Trinamool Congress I once again invoked the Bengali 'asmita' (Bengali pride) and central deprivation of Bengal to attack the BJP ahead of the general elections even as its top leaders Chief Minister Mamata Banerjee and her nephew and party general sec-retary Abhishek Banerjee said that Bengal would never surrender to Delhi.

This, even as they attacked the Centre for withholding the State's dues and through a brief documentary film --prepared by the party's event management team and shown from a giant screen at the historic Brigade Parade Ground -

-- told people how the Bengali icons like Ramakrishna Parmarahansa, Mother Sharada Devi, Rabindranath Tagore and Netaji Subhas Chandra Bose had times and again been insulted by the saffron leaders who had no regard for Bengal and its culture.

Launching a no-holds-barred attack on the saffron government the Chief Minister said how the Centre had despite repeated requests refused to pay the MNREGA wages of the poor 59 lakh people of Bengal. "Modi babu alleges that they had sent the money and we have misappropriated them but I will ask him not to speak whatever his officers tell him ... he should first read and then

In a development that caused strains between the Congress and its alliance partner Shiv Sena (UBT) in the MVA, Nirupam indirectly targeted Uddhav though a post on micro-blogging site "X" in which he wrote: "Yesterday, bachi-kuchi Shiv Sena ke pramukh announced his party candidate for Mumbai northwest seat". Fifty-nine-year-old terms Rajya Sabha and one term in Lok Sabha, is eyeing for the Mumbai north-west seat. What has miffed Nirupam is that Uddhav has announced the name of Amol Kirtikar as the party candidate candidate from Mumbai North West Lok Sabha seat.

The top court subsequently directed the SBI, the authorised financial financial institution under the scheme, to submit by March 6 the details of the electoral bonds purchased from April 12, 2019 till date to the Commission, Election which was asked to publish the information on its official website by March

On March 4, the SBI moved the apex court seeking extension till June 30 to disclose the details of the electoral bonds encashed by political parties.

The SBI contended that retrieval of information from "each silo" and the procedure of matching the information of one silo to that of the other would be a time-consuming exercise.

The application said due to stringent measures undertaken to ensure that the identity of the donors was kept anonymous, "decoding" the electoral bonds and matching the

donors to the donations would be a complex

process. It submitted that the data related to the issuance of the bond and the data related to the redemption of the bond was kept recorded in two different silos.

No central database was maintained. This was done to ensure that donors' anonymity would protected," it said.

'It is submitted that donor details were kept in a sealed cover at the designated branches and all such sealed covers were deposited in the main branch of the applicant bank, which is located in Mumbai," it said. LG, AAP trade charges over civic issues in Delhi

ieutenant Governor V K Leutenam Governo. Government traded charges on Saturday over the city's civic issues as he shared on social media pictures highlighting cleanliness issues in the slum clusters of Tehkhand and Okhla.

Posting pictures captured during his Friday visit to Golkuan in Tehkhand and Sanjay Colony in Okhla, both slum areas in southeast Delhi, Saxena requested Delhi Chief Minister Arvind Kejriwal to take cognisance of it.

In its reaction to Saxena's posts and pictures on X, the Kejriwal government alleged in a statement that three lakh slum-dwellers in Delhi have become homeless due to LG's decisions and directions.

The LG office sent out a strongly-worded reply, saying, "This is typical and blatant lie being peddled, supposedly by Delhi government."

"Not a single Jhuggi has been removed at LG's directions. In fact, on many occasions, the last being at Majnu ka Tila, demolitions were stopped due to LG's intervention," a Raj Niwas official said.

The LG has made four visits to underdeveloped areas like unauthorised colonies and slum clusters in the city in recent days

Previously, he visited Kirari, Burari, Sangam Vihar and shared similar pictures and issued directions for action by the concerned departments. In a series of posts on X on Saturday, Saxena expressed concern that thousands of people were living in these areas with heaps of garbage, overflowing and smelly drains, facing the danger of getting diseases.

He also alleged there was "inaction and insensitivity" of those responsible for taking

corrective steps. "Complaints of lack of public



facilities are being regularly received from each part of Delhi. In this connection, visited Golkuan Tehkhand JJ Cluster and Sanjay Colony, Okhla yesterday and witnessed the ground reality. Nothing could be a bigger example of inaction and insensitivity than this," he posted on X.

In another post with more pictures, he said "It is shameful that our citizen are facing such plight due to years of neglect.

The LG pointed that according to news reports, Rs 5,500 crores were spent on development of these settlements.

He directed agencies concerned -- the Delhi Urban Shelter Improvement Board (DUSIB), Delhi State Industrial and Infrastructure Development Corporation Ltd. (DSIIDC) and the Municipal Corporation of Delhi (MCD) among others -- to immediately ensure sanitation in the settlements and provide necessary facilities

"It is requested to the Chief Minister to take cognizance of this serious issue," he said in another post tagging him with more photos of the areas he visited. The AAP government charged that "Delhiites are aware that since LG Vinai Kumar Saxena took office, in the past approximately one and half years, he has demolished as many 'jhuggis' as never before in Delhi"

It accused the LG for demo-

lition of JJ cluster near Sundari Nagari, and rendering people

homeless in Tughalqabad. It also alleged that an attempt was made to demolish Ghosiya colony near Mehrauli but it was stayed by High Court after the intervention of the Kejriwal government.

"In the last few days, the LG has rendered numerous people homeless. Now, before the elections, he is playing drama and shedding crocodile tears because he knows that people living in unauthorised colonies and slums will vote against the BJP because of the demolitions," the AAP government charged.

It also alleged that the LG ordered the demolition of a slum near Majnu Ka Tila where 800 Hindu refugees from Pakistan were living since 2011, but it was prevented after Chief Minister Keiriwal intervened.

Man dies after falling into 40 feet borewell

 $T_{into\ a\ 40\text{-foot-deep}}^{he\ body\ of\ a\ man\ who\ fell}$ borewell at a Delhi Jal Board sewage treatment plant here was pulled out after a nearly 14hour-long operation on Sunday, police said.

The man is yet to be identified. Sources said the borewell was in a locked room and was abandoned. Delhi Water Minister Atishi

visited the spot to take stock of

the situation while the BJP targeted the AAP dispensation over the incident, calling it "shameful" and demanding compensation for the victim. Later, Atishi directed the Delhi Chief Secretary to conduct a time-bound enquiry and take strong and exemplary action against any officers found responsible for the incident. The chief secretary was also directed to ensure that all abandoned borewells, government and private, are welded and sealed immediately.

Information about the man falling into the borewell at the Delhi Jal Board (DJB) plant in west Delhi's Keshopur Mandi area was received around 1 am. The rescue efforts were led by teams of the National Disaster Response Force (NDRF) and the Delhi Fire Services (DFS). As part of the rescue operation, the NDRF had dug another well parallel to the borewell into which the man had fallen. A senior police officer said the person was brought out from the borewell dead. "It appears that he was aged between 25 and 35 years. Efforts are being made to identify him," he said. According to government offi-



cials, the borewell was inside a locked room. "So whoever entered the borewell room would have done so by breaking the lock and the door," an official said.

Officials said there was a possibility of foul play since it is not easy for an adult to fall in a borewell of 12-inch diameter. "So the victim might have been pushed in," an official said. However, police have not said anything about foul play in the

In a post on X, Atishi shared the news about the death of the man. "How he entered the borewell room, how he fell inside the borewell this will be investigated by the police. I thank the NDRF team who made every possible effort in the rescue operation for many hours," she said in the post. Chief Minister Arvind Keiriwal shared the news of the man's death in a post on X and thanked the NDRF for its res-

cue operation. "Got the sad news that the man who fell into the borewell was found dead. May his soul rest in peace. I would like to thank NDRF whose team made every

possible effort during the 14hour-long operation. The NDRF has supported the people of Delhi in all difficult times," he said on X.

Earlier in the day he said that the DJB has been instructed to carry out a probe into the incident and warned of strict action against officers found responsible for it. He also said that all abandoned borewells, government and private, would be sealed within 48 hours.

Delhi BJP chief Virendra Sachdeva said, "The death of a person after falling into a borewell located on the premises of Delhi Jal Board is painful. The Kejriwal government should give compensation for the accidents caused by the DJB's negligence in Keshopur and Alipur.

'Arvind Kejriwal and Atishi tweeting that the borewell room is safe is a disgusting conspiracy to save their government and DJB officials. The Kejriwal government continuously suppresses not only the scams of DJB but also the accidents because it is an equal partner in the misdeeds happening at board," he alleged.

However, the police are investigating it," she

The minister also sought a compliance report within 48

"A deeply unfortunate incident has taken place in Delhi today where someone has fallen into an abandoned borewell in the Keshopur STP. While this borewell was on land that had been handed over to the Delhi Metro in 2020, nonetheless it is our responsibility to examine if any lapses have taken place on the part of the DJB and to ensure that no such incident takes place in the future," the letter to the chief secretary read.

The minister has also directed the chief secretary to conduct a time-bound enquiry into the incident and take strong and exemplary action against any officers found responsible.

The chief secretary has also been directed to ensure that all government and private abandoned borewells are welded and sealed immediately.

Responding to Atishi's state-ment, the Delhi Metro Rail Corporation (DMRC) said that it did not build the borewell nor make any use of it.

"The pump room inside which this borewell was located belongs to the Delhi Jal Board. The borewell was already installed inside that pump room when the DMRC took over the area around it for construction work," the DMRC said in a statement.

India, EFTA trade deal symbolises shared commitment to equitable trade: Modi

Prime Minister Narendra Modi on Sunday said the signing of the trade agreement between India and the four-nation European bloc EFTA is a "watershed moment" as it symbolises shared commitment to open, fair and equitable trade.

The European Free Trade Association (EFTA) members are Iceland, Liechtenstein, Norway, and Switzerland.

The Prime Minister said India will extend all possible support to these countries and facilitate industry and businesses, not only to achieve the committed targets but also to go beyond them.

In the agreement, the EFTA bloc has committed to invest USD 100 billion in India over the next 15 years.

"The Tenth of March 2024 marks a new turn and a watershed moment in the bilateral relationship between India and EFTA countries," Modi said. He said the global leadership of the four nations in innovation, R&D across diverse areas such as digital trade, banking and

and logistics, industrial machinery, biotechnology, pharma, chemicals, food processing, and clean energy, will open up new doors of collab-

"Heartiest Congratulations and best wishes to the negotiators and signatories involved in the signing of India-EFTA and Economic Trade Participation Agreement (TEPA)," Modi said in a written message

The Prime Minister's statement was read by Commerce and Industry Minister Piyush Goyal here in the presence of ministers and officials of EFTA countries.

"In the last 10 years, India's economy has taken a quantum leap, moving from being the world's eleventh largest economy to the fifth largest. Our next goal is to make India's economy in the world," the Prime Minister said.

The "well-balanced" trade deal reflects the respective developmental aspirations of both sides, he added.

"On the most pioneering free trade agreements ever conTEPA emphasises our steadfast commitment to shared prosperity and our drive to cultivate a stronger, more inclusive partnership," he said.

Despite structural diversities in many aspects, the Prime Minister said, the economies of the two sides possess complementarities that promise to be a win-win situation for all nations.

"With the opening up of enormous trading and investment opportunities, we have reached a new level of trust and ambition...The trade agreement symbolises our shared commitment to open, fair, equitable trade as well as generating growth and employment for the youth," he said.

The European Free Trade Association (EFTA) members are Iceland, Liechtenstein, Norway, and Switzerland.

The agreement was signed after a gap of almost 16 years as negotiations, started in 2008, but were put on hold in resumed in October 2016, and after 21 rounds of negotiations were held before its conclusion.

For the first time in the history of FTAs (free trade agreements), a legal commitment is being made to promoting target-oriented investment and the job creation.

Almost all the domestic industrial goods would get duty-free access in EFTA nations under the agreement, besides duty concessions on processed agricultural products. Switzerland, the major trading partner of India in the bloc, already removed duties from January this year on almost all industrial goods.

On the other hand, India is

offering 82.7 per cent of its tariff lines or product categories, which covers 95.3 per cent of EFTA exports of which more than 80 per cent of imports is

On gold, India has not touched the effective customs duty (which is 15 per cent) but has reduced the bound rate by one per cent to 39 per cent. Bound and applied rates are used in international trade parlance. While bound tariffs or duties refer to the ceiling, the applied tariff is the duty, which is currently in place. India will also provide duty

(production-linked incentive) sectors like pharma, medical devices and processed food. Sensitivities related to these sectors have been kept in mind while extending offers.

Sectors such as dairy, soya, coal and sensitive agricultural products are kept on the exclusion list, which means there would not be any duty concessions on these goods.

In the services sector, the commerce ministry said, India has offered 105 sub-sectors to the EFTA like accounting, business services, computer services, distribution and health.

On the other hand, the coun-

try has secured commitments in 128 sub-sectors from Switzerland, 114 from Norway, 107 from Liechtenstein, and 110 from Iceland. Segments where Indian services will get a boost include legal, audiovisual, R&D, computer, accounting, and auditing.

TEPA (trade and economic partnership agreement) would stimulate our services exports in sectors of our key strength/interest such as IT services, business services, perrecreational services, other education services, and audiovisual services.

Further commitments related to Intellectual Property Rights in TEPA are at the TRIPS (trade-related aspects of IPRs) level.

The IPR chapter with Switzerland, which has high standards for IPR, shows our robust IPR regime.

India's interests in generic medicines and concerns related to the evergreening of patents have been fully addressed, it added.

It also said that the agreement will empower Indian exporters access to specialised inputs and create a conducive trade and investment environment.

This would boost exports of Indian-made goods as well as provide opportunities for the services sector to access more markets.

TEPA would also provide an opportunity to integrate into EU markets. Over 40 per cent of Switzerland's global services exports are to the EU (European Union).

Business Aircraft Operators Association (BAOA) Managing Director Captain R K Bali told PTI that during the Lok Sabha polls, the demand for private chartered planes and helicopters is expected to increase by 30 to 40 per cent compared to the previous elections.

Official data showed that there were 112 Non-Scheduled Operators (NSOPs) at the end of December 2023.

Generally, NSOPs are entities that do not have a particular fixed schedule and fly when there is a requirement.

Since the demand will be high, players are expected to take planes on lease for chartered operations, especially helicopters, Bali said and added that there are around 111-112 NSOPs and out of them, 40-50 per cent operate single aircraft. He said that NSOPs are estimated to have around 450

planes, including choppers.

These operators have aircraft and helicopters, with seating



capacities varying from 3 to 37. The planes include Falcon 2000, Bombardier Global 5000, Twin Otter DHC-6-300, Hawker Beechcraft, Gulfstream G-200 and Cessna Citation 560XL, as per the data available with the Directorate General of Civil Aviation (DGCA).

Most of the aircraft and helicopters have seating capacities of less than 10, the data showed. Mehra said the size of the

chartered fleet will be around 350 and out of them, about 175 are helicopters.

A chartered operator, Club One has a fleet of 5 Falcon

Bombardier CRJ200. "Political leaders will opt for helicopters to travel to small towns and hence more demand is likely for the choppers," Mehra said.

An executive, who has been in the chartered aircraft services business for more than two decades, also said there is a huge demand this time and some players are taking aircraft and helicopters on lease for their clients

On the condition of anonymity, the executive also claimed that the hourly rates for helicopters for the upcoming elections have gone up significantly. While chartered helicopters are hired at a rate of around Rs 1.5 lakh per hour. In some cases, the hourly rates are even touching Rs 3.5 lakh, the executive added.

Broadly, Mehra said the price can range between Rs 4.5 lakh to Rs 5.25 lakh per hour for a chartered aircraft.

The ruling BJP incurred expenses totalling more than Rs 250 crore on aircraft/ helicopters, as per the party's annual audited accounts for 2019-20 submitted to the Election Commission of India (ECI). The amount shelled out by the Congress party towards election travelling expenses in

crore. The party did not mention aircraft/helicopter expenses separately in its annual audited accounts for that financial year.

The last Lok Sabha elections were held in April and May of 2019.

According to veteran elections analyst N Bhaskara Rao, the total expenditure during the upcoming Lok Sabha polls is expected to be around Rs 1.20 lakh crore.

"2024 Lok Sabha poll expenditure alone will involve around one lakh twenty thousand crores, of this Election Commission of India (ECI) is estimated to spend hardly twenty per cent (expenditure on new EVMs is not included)," he said.

He also said the price for hiring a chartered plane has almost remained steady since the pandemic and the players in the segment do not tend to outprice each other.

India's top nuclear scien-**⊥** tists have welcomed the initiation of core loading in the Prototype Fast Breeder Reactor, terming it one of its kind in the world and an important step towards achieving long-term energy security of the country.

Former Atomic Energy Commission chairman Anil Kakodkar, who played a key role in ensuring India's integration into the global nuclear order, termed the Prototype Fast Breeder Reactor a major advancement in terms of technology by global standards.

"China has a small programme on fast breeders. Japan, France, the US had this (fast breeder reactors), but due to anxiety over nuclear energy, several programmes have been shut down," said Kakodkar. Former Atomic Energy

Commission chairman Ratan Kumar Sinha said India's PFBR has taken a long time in the

development stage and was first of its kind to have breeding. Sinha said the fast-breeder reactors use depleted uranium (U-238) and plutonium (Pu-239) to produce energy and more fuel, hence the name breeder reactor.

Asked about Goel's resignation, Congress president Mallikarjun Kharge said one has to wait to see what he does in the coming days. "I was thinking that after the high court judge resigned and joined the BJP the next day and started abusing the TMC. It shows that the BJP has appointed people with such a mindset. "Now the election commissioner has resigned, let us wait for some time to see what he does," he said. Shiv Sena (UBT) leader Sanjay

Raut alleged the Election Commission has become an 'extended branch of the BJP". It is not the same Election Commission that it was during TN Seshan's time, which functioned as a watchdog over the elections and remained impartial, he claimed. "In the last 10 years, the Election Commission has been privatised. It has become a branch of the BJP," he alleged. He said two people have gone and only one remains in the Election Commission.

AIMIM leader Asaduddin Owaisi demanded answers from Goel and the government over the resignation just ahead of the Lok Sabha elections. "It would be better if he (Arun Goel) himself or the government would tell the reason behind the resignation ahead of the Lok Sabha elections," he said. Independent MP Kapil Sibal

said it was a worrying development. "Way cleared to: Pack the Commission with Yes men. This applies to all institutions that are the foundations of our Republic!" he said on X. "To abruptly resign like this at the cusp of the Lok Sabha elections is something we should be worried about, because normally this would not happen. Maybe the reasons cited by him that he has resigned for personal reasons are genuine. But, it is unlike-Sibal said.

Goel resigned on Saturday, days before the expected announcement of the schedule for the 2024 Lok Sabha elections. His tenure was till December 5, 2027, and he would have become Chief Election Commissioner (CEC) after the retirement of incumbent Rajiv Kumar in February next year.

Opposition raises | Himachal Police register case against father of Congress rebel

Police on Sunday regis-The Himachal Pradesh tered a case against an independent MLA and the father of a Congress rebel and others over electoral offences related to the recent Rajya Sabha polls in which six party MLAs voted for the BJP candidate from the state.

The case against Hamirpur's independent MLA Ashish Sharma and Gagret's now disqualified MLA Chetanya Sharma's father and others was registered on the basis of a complaint lodged by Congress MLAs Sanjay Avasthi and Bhuvneshwar

Ashish and Chetanya are among the nine MLAs, including six Congress rebels and three independents who voted in favour of the BJP nominee Harsh Mahajan in the recently held Rajya Sabha polls. However, the alleged role of Chetanya's father, a retired bureaucrat, is not known yet.

This triggered a crisis in the state's Congress government, which appeared to have lost its majority in the assembly. A case of criminal conspiracy, corruption practices and undue influence on election has been registered on the complaint of two Congress MLAs, police said on Sunday.
Adding a new dimension to the current political crisis in Himachal Pradesh, the two Congress MLAs Sanjay Avasthi and Bhuvneshwar Gaur on Sunday filed a complaint with the police seeking investigation into electoral offences, corrupt practices and criminal conspiracy in the whole sequence of events

since the Rajya Sabha polls held on February 27. This development has invoked sharp reactions from

Checking the food bill

The Govt vows to control food item prices during elections, but it had better focus on a long-term strategy

price-sensitive nation that India is, a whole gamut of decisions, including election results, depend on the costs accrued. Obviously, high prices of essential commodities play an important role in deciding voter preferences. Though factors like caste, religion and anti-incumbency do have an impact, essential commodity prices are an immediate concern with the power to tilt election results. Acknowledging this piece of traditional wisdom, Union Consumer Affairs Minister Piyush Goyal has pledged to keep the prices of essential food items stable during the elections. The Government has contributed in the last few years about Rs 28,000 crore to the price stabilisation fund in the fight against food inflation. This commitment highlights the Government's determination to prioritise the welfare of its citizens. The Minister's assurance underlines the significance of food security in our nation's socio-political dynamics. Essential food items form the cornerstone of sustenance for millions of households across India. Any volatil-



ity in prices can have far-reaching implications, particularly for vulnerable populations. Elections, characterised by increased spending and political manoeuvrings, often coincide with fluctuations in commodity prices. Such fluctuations can arise due to various factors, including supply chain disruptions, speculative trading and increased demand. In this context, Goyal's commitment to averting spikes in essential food item prices during elections signals the Government's proactive approach to mitigate potential hardships faced by the populace. Additionally, fostering greater transparency and accountability within the supply chain can help promote fair pricing practices. By fostering partnerships with farmers, traders and retailers, the Government can promote a conducive environment for sustainable agricultural practices and equitable market access. While Govt interventions can play a crucial role in mitigating short-term price fluctuations, addressing underlying structural challenges in the agricultural sector is equally imperative for long-term resilience. Given the fact that the farmers are up in arms and demanding security for their labour and investments, it is not an easy task to balance farmer interests with consumers' need for reasonable pricing. It goes without saying that attempts to artificially control prices do not work in the long run. In all likelihood,

the prices would increase after the elections even if the Government manages to con-

trol them during elections. We need a long-term approach to check inflation.

This adage finds resonance in the recent political developments of Nepal, where former Prime Minister Pushpa Kamal Dahal, popularly known as 'Prachanda,' has forged an unexpected partnership with his longstanding adversary and political rival, KPS Oli, to retain the Prime Minister's chair for the third time within a mere span of 15 months. The Himalayan Kingdom has witnessed a whirlwind of political manoeuvring, with Prachanda showcasing his adeptness in navigating the turbulent and uncertain political landscape to his advantage. While his ability to secure power may appear as a significant achievement on a personal level, it has raised concerns both domestically and internationally, particularly among neighbouring countries like India and the United States.

The current political trajectory in Nepal, with its potential tilt towards China, has set off alarm bells in New Delhi and Washington. Given the pro-China inclinations of the current government in the Maldives and the strained relations with Pakistan, there is a palpable apprehension about Nepal slipping away from India's traditional sphere of influence. This apprehension is further fueled by the ideological commitment of the emerging communist-dominated coalition gov-ernment in Nepal towards

Kerala university under scrutiny for student's death

The death of a Kerala university student sheds light on the alarming state of affairs within Kerala's educational institutes

The recent suspension of PC Saseendran, Vice-Chancellor of Kerala Veterinary and Agricultural Sciences University in Wayanad, by Governor Arif Mohammed Khan marks a significant event in the state's history. This action, prompted by the mysterious death of a second-year BV Sc student, is unprecedented, particularly given the dominant presence of the CPI(M) in Kerala's political landscape. The student in question, JS Sidharth, was described as apolitical and amicable towards his peers. However, his participation in a dance with a Muslim female student on February 14th incurred the disapproval of certain community members. The Students Federation of India (SFI), the university's sole student organisation, conducted a secretive trial during late-night hours, subjecting Sidharth to brutal assault and torture. Tragically, Sidharth was found dead in his hostel's washroom shortly afterward, revealing the harrowing experience he endured.

In the aftermath, the Vice-Chancellor and the Dean

This nexus fosters an environment of religious policing and intolerance, with dissent often met with aggression. Instances of SFI members promoting illicit activities, such as drug use, highlight the erosion of academic values and institutional integrity. Principals who challenge such

behaviour face retaliation, exposing the pervasive influence wielded by SFI leaders. The SFI, once a symbol of student activism, has devolved into a vehicle for promoting vice rather than virtue. Ultimately, the sanctity of the student-teacher relationship and the moral fabric of educational institutions are at

stake. It is imperative to

uphold the principles of edu-

cation and integrity, as espoused in the age-old adage, "Guru Brahma, Gurur Vishnu, Gurur Devo Maheswara, Gurur Sakshaat Parabrahma, Tasmai Shri Guruve Namaha.'

In conclusion, the suspension of Vice-Chancellor PC Saseendran signifies a critical juncture in Kerala's academic and political landscape, underscoring the need for accountability, integrity, and the preservation of educational values.

The situation extends beyond Kerala's borders, infiltrating prestigious institutions. Despite their reputation for academic excellence, these institutions are not immune to political interference and student unrest. This necessitates a concerted effort to root out corruption, nepotism, and ideological bias, fostering an environment conducive to learning, critical inquiry, and academic integrity. Only then can these institutions fulfill their potential as engines of national progress and social transformation.

Embark on a journey of inner equilibrium and embrace the power of sattva



The practice of offering freebies must stop

arely a week before the Election Commission of India (ECI) is set to announce the schedule for the polls for Lok Sabha elections when the Code of Conduct will come into force, the Aam Aadmi Party (AAP) has given yet another dose of mesmerizing voters in Delhi with freebies - an acronym for "something given free of charge" – a bizarre practice it started in the February 2020 elections.In the budget for the financial year (FY) 2024-25 presented by the Delhi finance minister Atishi in the assembly on March 4, 2024, she announced the Mukhyamantri Mahila Samman Yojana (MMSY) under which, the AAP government will give Rs 1000 per month to all the women above the age of 18 in the national capital.

Only registered voters will be eligible for this scheme. Further, she should not be a member of any pension scheme, not a government employee and not pay

The top brass of AAP describes the Scheme as 'revolutionary', aimed at 'empowerment of the women' and ushering in what it terms as 'Ram Rajya' (a euphemism borrowed from the Hindu epic Ramayana where the system of governance ensured 'equal rights alike of prince and pauper'). Shorn of rhetoric, the key question we need to examine is whether MMSY could be justified as a welfare scheme.

A welfare scheme is rooted in three basics viz. the state assistance goes to persons who are poor and primarily focused on bare essentials such as food, fuel, water, housing, education and health; it should be backed by wellorchestrated efforts to garner revenue so that budgetary position is not destabilized; finally, it is given for a 'limited period' after which the beneficiaries should stand on their own. The Scheme isn't about bare essentials; instead, a lump sum amount is given which the beneficiary can spend in the manner she likes. Moreover, it doesn't focus on the poor alone. The eligibility conditions won't rule out financially well-off women also getting the benefit. The requirement of the beneficiary 'not paying income tax'

doesn't mean that they will be excluded. Under the extant IT dispensation, a person having an annual income of Rs 700,000 (or around Rs 60,000 per month) is not required to pay income tax. It makes no sense to make her a beneficiary under the Scheme, but it does. Consider another case where the woman happens to be a housewife. She doesn't earn. a housewife. She doesn't earn. The mismatch between the availability of funds and the requirement will make the Scheme prone to the use of discretion, corruption and nepotism in choosing the beneficiaries. Moreover, considering that a beneficiary only needs to have a voter ID (not an Aadhaar card which is based on biometric details of a person hence, more authentic), this will make it susceptible to fake per-

sons getting payments. Collateral damage will be socioeconomic tensions as some women would get the benefit even as others are left out. To case, the government decides to give assistance to all the 6700,000 women above 18 years sans any rider - as has been the case with electricity subsidy - it will have to spend Rs 8000 crore annually. While handing down the Scheme, the AAP government is unmindful of the implications for its budgetary position which contrary to the claims made by the Chief Minister is not robust. If allowed to continue, this is sure an invitation to economic disaster. Even the Supreme Court (SC) has expressed concern. Hearing a PIL seeking directions against 'freebies' on January 25, 2022, it observed "This is no doubt a serious issue, budget for freebies is going above the regular Budget. This disturbs the level playing field". The way forward is to 'legally' prohibit parties from promising freebies. But, we have a speed breaker erected by none other than the top court itself.

"It shakes the root of free and fair elections to a large degree."

Yet, it held:-"the promises in the election manifesto cannot be construed as 'corrupt practice' under the Representation of People Act (RPA), or any other prevailing law and, hence, distribution of freebies can't be stopped when the ruling party uses public funds for this purpose through the passage of Appropriation Acts in the state Assembly".

Currently, a three-judge bench, headed by the Chief Justice of India (CJI) is hearing a plea to take a re-look at the above stance. The SC should give an order barring poll freebies as political parties who are deeply rooted in this practice left to themselves, won't enact a law to curb it.

¬he feminist movement has been a dynamic sociopolitical reality, evolving to resist oppression in various forms. However, there is a prevailing misconception that its growth and development are primarily influenced by Western and colonial ideals, disregarding the rich tapestry of local history and culture. This oversight fails to recognize the nuanced complexities of traditional concepts and undermines the importance of cultural differences. Culture, as a pervasive force, shapes every aspect of life - from behaviour and relationships to identity and knowledge acquisition. Even after the departure of British colonial rulers, India's policies towards tribal and

local communities continued

to be influenced by Western



ideologies propagated by certain agenda-driven British and Western anthropologists. These ideologies often denigrated indigenous knowledge and epistemologies, labelling tribal communities as "primitive" or "uncivilized." These derogatory stereotypes persist in contemporary media portrayals, fostering a sense of shame and alienation among indigenous peoples towards

Consequently, there is a pervasive sentiment of inferiority towards indigenous culture, instilled to foster gratitude towards foreign religions and

'Netanyahu hurting Israel by not preventing civilian deaths'

US President Joe Biden said Saturday that he believes Israeli Prime Minister Benjamin Netanyahu is "hurting Israel more than helping Israel" in how he is approaching its war against Hamas in Gaza. The US leader expressed support for Israel's right to pursue Hamas after the October 7 attack, but said of Netanyahu that "he must pay more attention to the innocent lives being lost as a consequence of the actions taken. Biden has for months warned that Israel risks losing international support over mounting civilian casualties in Gaza, and the latest remarks in an interview with MSNBC's Jonathan Capehart pointed to the increasingly strained relationship between the two leaders. Biden said of the death toll in

Gaza, "it's contrary to what Israel stands for. And I think it's a big mistake."

Biden said a potential Israeli invasion of the Gaza city of Rafah, where more than 1.3 million Palestinians are sheltering, is "a red line" for him, but said he would not cut off weapons like the Iron Dome missile interceptors which protect the Israeli civilian populace from rocket attacks in the region."It is a red line," he said, when asked about Rafah, "but I'm never going to leave Israel. The defense of Israel is still critical, so there's no red line I'm going to cut off all weapons so they don't have the Iron Dome to protect them."

Biden said he was willing to make his case directly to the Israeli Knesset, its parliament, including by making another trip to the country. He travelled to Israel weeks after the October 7 attack. He declined to elaborate on how or whether such a trip might materialize. The US leader had hoped to

secure a temporary ceasefire before Ramadan begins this week, though that appears increasingly unlikely as Hamas has balked at a deal pushed by the US and its allies that would have seen fighting pause for about six weeks, the release of additional hostages held by Hamas and Palestinian prisoners held by Israel, and a surge in humanitarian aid into Gaza. Biden noted CIA Director Bill Burns is in the region currently trying to resurrect the deal.



Kin lose hope after students' kidnapping

Rashidat Hamza is in despair. All but one of her six children are among the nearly 300 students abducted from their school in Nigeria's northwest, riddled with Islamic extremits and armed Islamic extremists and armed gangs. It has been more than two days after her children ages 7 to 18 — went to school in the remote town of Kuriga in Kaduna state only to be kidnapped by gunmen. She was still in shock Saturday. Authorities said at least 100 children aged 12 or younger

were among the abductees in the state known for violent killings, lawlessness and dangerous roads where people get regularly snatched.

'We don't know what to do, but we believe in God," Hamza told The Associated Press during a visit to the town.

The mass kidnapping in Kuriga was the third in northern Nigeria since last week; a group of gunmen abducted 15 children from a school in another northwestern state. Sokoto, before dawn Saturday, and a few days earlier 200 peo-

ple, mostly women and children displaced by conflict, were kidnapped in northeast-

The kidnappings are a stark reminder of the security crisis plaguing Africa's most populous country. No group claimed responsibility for any of the recent abductions. But Islamic extremists waging an insurgency in the northeast are suspected of carrying out the kidnapping in Borno.

Locals blame the school abductions on herders who are in conflict with the settled communities It's not the first time for a stu-

dent kidnapping in Nigeria to shock the world. In 2014, Islamic extremists

abducted more than 200 schoolgirls from Borno's Chibok, sparking the global #BringBackOurGirls social media campaign. A decade later, at least 1,400 Nigerian

students have so far been abducted from their schools in similar circumstances. Some are still held captive, including nearly 100 of the Chibok

Recalling Thursday's kidnap-ping, Nura Ahmad, a teacher, told the AP that students were just settling into their classrooms at the government primary and secondary school when gunmen "came in dozens, riding on bikes and shooting sporadically."The LEA Primary and Secondary School, one of the few educational facilities in this area, sits by the road just at the entrance of the town, tucked in the middle of forests and savan-

Even with its decaying roof and wrecked walls, it gave parents hope for a better future for their children. "They surrounded the school and blocked all passages ... and roads" to prevent help from coming before kidnapping the children in less than five minutes, Ahmad said.

Fourteen-year-old Abdullahi Usman braved gunshots to escape the captors

Efforts to get aid to Gaza by sea moving ahead

(GAZA STRIP)

AUS Army vessel carrying equipment for building a temporary pier in Gaza was on its way to the Mediterranean on Sunday, three days after US President Joe Biden announced plans to increase aid deliveries by sea to the besieged enclave where hundreds of thousands of Palestinians are going hungry. The new push for aid came in the final hours before the Muslim holy month of Ramadan, which could start as early as Sunday evening, depending on the sighting of a crescent moon. Hopes for a new cease-fire by Ramadan faded days ago with negotiations apparently stalled.

The opening of the sea corridor, along with airdrops by the US, Jordan and others, showed growing alarm over Gaza's deadly humanitarian crisis and a new willingness to bypass Israeli control over land shipments. Israel said that it welcomed the sea deliveries and would inspect Gazabound cargo before it leaves a

staging area in nearby Cyprus.But aid officials say that air and sea deliveries can't make up for a shortage of supply routes on land. The daily number of aid trucks entering Gaza by land over the past five months has been far below the 500 that entered before the war. A ship belonging to Spanish aid group Open Arms and carrying 200 tons of food aid was expected to make a pilot voyage to test the corridor "as soon as possible," said spokesperson Linda Roth with partner organisation World Central Kitchen. The ship remained at Cyprus' port of Larnaca in what Roth called "a quickly evolving and fluid situation." Biden stepped up public criticism of Israeli Prime Minister Benjamin Netanyahu, saying he believes that Netanyahu is "hurting Israel more than helping Israel" in his approach to the Israel-Hamas war in Gaza, now in its

Speaking Saturday to MSNBC, the US president expressed support for Israel's right to pursue Hamas after the militants' October 7 attack on

sixth month.

southern Israel, but said that Netanyahu "must pay more attention to the innocent lives being lost." He added that you cannot have 30,000 more Palestinians dead. The Health Ministry in Gaza

said that at least 31,045 Palestinians have been killed since the war began. The ministry doesn't differentiate between civilians and combatants in its count, but says that women and children make up two-thirds of the dead. The ministry is part of the Hamasrun government, and its figures from previous wars have largely matched those of UN and independent experts.

Palestinian casualties continued to rise. The Civil Defence Department said that at least nine Palestinians, including children, were killed in an Israeli airstrike on a house in Gaza City late Saturday. Footage that it shared showed one rescuer placing the body of a dead infant on a sofa amid the wreckage

Elsewhere, the bodies of 15 people, including women and children, were taken to the main hospital in the central town of Deir al-Balah on Sunday, according to an Associated Press journalist. Relatives said they were killed by Israeli artillery fire toward a tent camp for displaced Palestinians in the coastal area near the southern city of Khan

Israel rarely comments on specific incidents during the war. It maintains that Hamas is responsible for civilian casualties, because the militant group operates from within civilian areas. Meanwhile, US efforts began

to set up the temporary pier in Gaza for sea deliveries. US Central Command said a first US Army vessel, the General Frank S. Besson, left a base in Virginia on Saturday and was on its way to the Eastern Mediterranean with equipment for construction.

US officials said that it would likely be weeks before the pier is operational. The sea corridor is backed by the European Union together with the United States, the United Arab Emirates and other countries. The European Commission has said that UN agencies and

the Red Cross will play a role. The ship in Cyprus is expected to take two to three days to arrive at an undisclosed location. The World Central Kitchen spokesperson said that construction work began Sunday on the jetty for it at an undisclosed location in Gaza A member of the charity said on X, formerly Twitter, that once the ship's barge reaches Gaza, aid would be offloaded by a crane, placed on trucks and driven to northern Gaza which has been largely cut off from aid shipments and was the first focus of Israel's military offensive. Israel declared war on October 7 after Hamas militants killed about 1,200 people, mostly civilians, and took 250 hostages.

Israel's air and ground offensive has devastated large parts of Gaza and displaced about 80 per cent of the population of 2.3 million. The US and regional mediators Egypt and Qatar had hoped to have a sixweek cease-fire in place by Ramadan, but Hamas is holding out for assurances that a temporary truce will lead to an end of hostilities.

Turkish police detain 33 people accused of plotting attacks

Turkish police detained 33 people suspected of ties to the Islamic State group who were allegedly preparing attacks ahead of the country's local elections later this month, Interior Minister Ali Yerlikaya said Sunday. The suspects were "preparing and searching for action before the upcoming local elections," he posted on X, formerly Twitter. Nationwide elections are due to be held on March

Counter-terrorism police in Sakarya in northwest Turkey recovered weapons, cash and "organizational documents" during raids.

"We will not tolerate any terrorists. We will continue our fight uninterruptedly with the superior efforts of our security forces," Yerlikaya

The Netherlands's National Holocaust Museum is opening on Sunday in a ceremony presided over by the Dutch king as well as Israeli President Isaac Herzog, whose presence is prompting protest because of Israel's deadly offensive against Palestinians in Gaza. The museum in Amsterdam tells the stories of some of the 102,000 Jews who were deported from the Netherlands and murdered in Nazi camps, as well as the history of their structural persecution under German World War II occupation before the deportations began.

Sunday's ceremony comes against a backdrop of Israel's devastating attacks on Gaza that followed the deadly incursions by Hamas in southern Israel on October 7. Thousands of pro-Palestinian

Square in central Amsterdam, near the museum and the synagogue, waving Palestinian flags, chanting against Israeli occupation of Palestinian territories and demanding an immediate cease-fire in Gaza.

"Ārmed officers arrested a man at the scene on suspicion of criminal damage. He was taken to hospital.

There were no reports of any injuries. Enquiries are ongoing to establish the circumstances,

the spokesperson said. King Charles III, who had been at Windsor Castle in Berkshire, is not thought to have been in residence at his London palace at the time of the incident.

The 75-year-old monarch has cut down on his public-facing duties while he undergoes treatment for an unspecified form of cancer. Security at Buckingham Palace

has been tightened over the years following incidents of intrusion. Last September, a 25-year-old man was arrested near the stables of the London palace after he climbed the wall to enter the Royal Mews. The Metropolitan Police said at the time that the man did not gain access to the palace grounds at any point.

Asif Ali Zardari sworn in as Pakistan's 14th President

sif Ali Zardari on Sunday Atook oath as Pakistan's 14th President, a day after the veteran politician staged a remark able comeback when he was overwhelmingly elected as the only civilian president of the coup-prone country for a sec-ond time. Chief Justice of Pakistan Qazi Faez Isa administered the oath to the 68-yearold Zardari in a small vet formal ceremony at Aiwan-e-Sadr, the Presidential Palace.

Zardari replaces Dr Arif Alvi, who stayed in office for five months after completing his five-year term in September 2023. The swearing-in ceremony was attended by Prime Minister Shehbaz Sharif, Chief of Army Staff General Asim Munir and Chairman of Joint Chiefs of Staff Committee General Sahir Shamshad Mirza among other senior army and civilian officials and diplomats. The outgoing president Alvi, a senior member of jailed former prime minister Imran Khan's Pakistan Tehreek-e-Insaf (PTI) taking ceremony.

Former prime minister Nawaz Sharif and Zardari's son Bilawal Bhutto Zardari, his daughters Aseefa Bhutto Zardari and Bakhtawar Bhutto Zardari and other family members were present on the occasion. Prime Minister Shehbaz Sharif has congratulated Zardari on his election as the president for the second term. In a message, Shehbaz Sharif

said that the Senate, National Assembly and elected members of all the four provincial assemblies have expressed their confidence in Zardari. He said that the Zardari will be a symbol of the strength of the federation. This is the second time that Zardari has won the presidency, a record for any civilian. Rescuers retrieved six bodies in Pesisir Selatan and three more in the neighboring district of Padang Pariaman, bringing the death toll to 19, the National Disaster Management Agency said on

The agency in a statement said



at least two villagers were injured by the flash flood and rescuers are searching for seven people who are reportedly still missing. It said more than 80,000 people had fled to temporary government shelters after the flood and landslide buried 14 houses, while 20,000 houses were flooded up to the

roof in nine districts and cities

in West Sumatra province. "Relief efforts for the dead and missing were hampered by power outages, blocked roads covered in thick mud and debris," Yusrizal said. Heavy rains cause frequent landslides and flash floods in Indonesia where millions of people live in mountainous areas or near floodplains.

2 killed, 1 hurt during transfer of explosives in Pakistan: Official

ICEA: Mobile phone manufacturing jumps 21 fold in ten years

Mobile phone manufactur-ing in value terms jumped 21-fold to Rs 4.1 lakh crore in India in the last 10 years as government policy measures like PLI played a critical role in attracting global players to boost local production, industry body ICEA said in a statement.

India now produces 97 per cent of its total mobile phone demand locally and 30 per cent of the total production in financial year 2024 is meant for export, the India Cellular and Electronics Association said. "Mobile phone production surged from Rs 18,900 crore in 2014-15 to an estimated Rs 4,10,000 crore in FY'24, registering an increase of 2000 per cent. In 2014-15, mobile phone exports from India were a mere Rs 1,556 crore. The industry expects to end FY24 with an estimated export of Rs 1,20,000 crore. This would mean a 7500 per cent increase in exports over a decade, ICEA said.

According to a note on manufacturing, in the field of smartphones, Apple and Samsung, have played a crucial role in boosting mobile phone exports from the country.

India manufactured devices are being exported in large volumes to the UK, Netherlands, Austria, and Italy besides Middle East and North Africa and South American markets, the note said.

"30 per cent of production in FY'24 will now be meant for exports. The industry expects to end FY'24 with an estimated export of Rs 1.2 lakh crore. bank post-April 1, Agarwa said the highest priority would be to integrate the deposit franchise from a business per-

spective. CBDT starts sending emails for mismatch in tax profile in FY24

The income tax department on Sunday said it has started sending emails and SMSs to assessees whose taxes paid during the current fiscal are not commensurate with financial transactions.

The department is undertaking an e-campaign, which aims to inform such persons/entities of significant financial transactions, through email (marked as Advance Tax e-Campaign-Significant Transactions for AY 2024-25) and SMS, urging them to compute their advance tax liability correctly and deposit the due advance tax on or before March 15.

In a statement, the Central Board of Direct Taxes (CBDT) said the income tax department has received certain information on specific financial transactions undertaken by persons/entities during the Financial Year (FY) 2023-24. "On the basis of analysis of the taxes paid so far during the current financial year, the Department has identified such persons/entities where payment of taxes for FY 2023-24



(AY 2024-25) is not commensurate with the financial transactions made by the persons/entities concerned, during the said period," the CBDT said

This is another initiative of the department towards easing compliance for taxpayers and reinforcing its commitment towards enhancing taxpayer services, it added.

The income tax department receives information on specified financial transactions of taxpayers from various sources. To increase transparency and promote voluntary tax compliance, this information is reflected in the Annual Information Statement (AIS) module and is available to persons/entities for viewing.

exposure to high volumes of noise can result in long-term health issues, including hearing loss or tinnitus. About half of the population between the ages of 12 and 35 is at risk of damaged hearing because of loud sounds, warns the World Health Organization.

"Young children are more vulnerable. Their auditory systems are still developing. Their ear canals are also smaller than intensifying perceived sound," Woolford said.

"Tiny hair cells inside the inner ear pick up sound waves to help you hear. When these get damaged or die, hearing loss is irreversible."

Noise exposure among children can also affect their sleep, academic learning, language, stress levels, and even blood pressure, she

Australia, the reigning

World Test Championship winners are leading the two-Test series following their 172-run victory in Wellington.

India, with 122 rating points, are five points ahead of Australia in the Test ranking, while England are third with 111 rating points.
In ODIs, India have 121

rating points, Australia a close second with 118 points. In the T20Is, India have

266 rating points, with England (256) at the second spot.

India were the world No.1 Test side from September 2023 to January 2024, before they slipped to second spot after a drawn away series against South Africa.

Australia overtook India at the top of the Test rankings, after sweeping the three-Test series against Pakistan at home.

India's five-Test series against England saw them lose the first Test in Hyderabad by 28 runs. But the home team bounced back in style to win the remaining four Tests. Victories

Playing the last first-class game of his career, medium pacer Dhawal Kulkarni bowled his customary late outswingers which had Aman Mokhade (8) and Test triple centurion Karun Nair (0) nicking it to Hardik Tamore behind

stumps.
Mumbai's top guns Rahane and Iyer were both dismissed for identical scores of 7 in a shocking collapse that saw the 41-time champions slipping from 81/0 to 111/6 on either side of the lunch break.

His achievement as a leader notwithstanding, Rahane's miserable run in the Ranji Trophy continued when the Mumbai skipper played one meekly to mid-on to be dismissed at a time when his

team needed him to drop the anchor.

Around the same time last year, Rahane was a contender to earn his spot back in the national team but as things stand, irrespective of the outcome of this final it remains to be seen if Mumbai selectors would persist with the 35-yearold for the next season.

Having lost six wickets for a mere 40 runs, Mumbai also went through a phase in which no boundary was hit for as many as 18 overs.

But the complexion of the game changed drastically upon the arrival of Thakur in the middle, who hit a few fours to put the pressure back on Vidarbha and maintained the

Thakur displayed adroit use of both hands and his feet to inch

closer to what would have been his second consecutive ton, but kept running out of partners. Thakur was the last batter dismissed, caught by the man at deep square leg after a superb 75 off just 69 balls with eight fours and three sixes. The troika of Tanush Kotian

(8), Tushar Deshpande (14) and Shams Mulani (13), which bailed Mumbai on numerous occasions with useful runs also fell cheaply.
