KEJRIWAL KINGPIN OF LIQOURGATE: ED

In a major setback to AAP convener and Delhi Chief Minister Arvind Kejriwal, once revered as an anticorruption crusader, was sent to the Enforcement Directorate's custody till March 28.

The court passed the order on the ED application seeking a 10day custody in the case.

Arguing for his custody, the ED counsel Additional Solicitor General SV Raju, on Friday told the Special Judge Kaveri Baweja at the Rouse Avenue court that Kejriwal is a "key conspirator" and "kingpin" in the liquorgate scam case. "Kejriwal was the kingpin and key conspirator of the Delhi excise scam in collusion with Ministers of the Delhi Government, AAP leaders and other persons," the ED informed the court.

The ED said Kejriwal was directly involved in the formulation of the liquor policy and the subsequent use of the proceeds of the crime. "Kejriwal took advantage of being the Chief Minister of Delhi to facilitate money laundering by the AAP, which is a "major beneficiary" of the proceeds of crimes generated in the alleged liquor scam case," it said.

The ED claimed in its remand papers that "Kejriwal was intrinsically involved in the conspiracy of formulation of the

Appearing for Kejriwal, senior advocate and Congress leader Abhishek Manu Singhvi said

excise policy 2021-22 to favour remand should not be the norm and it should be looked into whether Kejriwal's custody is needed.

Singhvi said there was "no material" or "evidence" to show any wrongdoing in excise policy formulation or receipt of any proceeds by the AAP supremo. While opposing the ED's demand for his custody, Kejriwal's lawyer told the court "that the present case is stitched together only on the basis of statements of co-accused and statements of officers who are working under the control of the complainant herein the

LG of Delhi[†]. "There is no material or

evidence show in policy wrongdoing formulation or any receipt of any proceeds by the arrestee. That despite investigating the matter for over a year and conducting more than 200 raids, no incriminating material showing involvement of the arrestee in any crime or involvement in any process/ activity was found," he contended.

He said to "unleash political vendetta" and for extraneous reasons, powers under Section 50 of the Prevention of Money laundering Act (PMLA) are "misused in malicious manner and people are coerced, forced and pressurised to give unsubstantiated statements" in the case.

In its remand application, the ED told the court it has recorded the statements of various people engaged in the election campaign-related activities of the AAP during the Goa polls and it was found that "cash payments were made to them for work like survey workers, area managers, Assembly managers etc".

"These persons and activities related to the election campaign were overall managed by Vijay (former communications chief arrested in this case) and Durgesh Pathak, AAP MLA," it said. **Continued on Page 2**

Political meltdown in Delhi

→he Aam Aadmi Party (AAP) which made a dramatic entry in the governance of the national Capital by squeezing itself in the political space of bigger national parties — the Congress and BJP almost 10 years ago may see a meltdown post this Lok Sabha polls, as it worst fears have come true after the arrest of its founder, party convener and Delhi Chief Minister Arvind Kejriwal in money laundering case related to the excise policy scam and a pending Delhi Jal Board (DJB)

The AAP is now in a Catch-22 situation about "what and who next", as heir apparent of the party and cofounders — Manish Sisodia, Satyender Jain, Sanjay Singh — all are Satyender Jain, Sanjay Singh — all are in jail and there is a huge gap between Kejriwal and the party at the ground level. Kejriwal's phoenix rise was at the cost of denting the 15 years Congress regime led by Sheila Dikshit. The Congress faced three defeats at the hands of Kejriwal in the national Capital.

The AAP leader also tarnished the image of top BJP leaders like late Arun Jaitley and Union Minister Nitin Gadkari in successive protests

Currently, the real challenge for the AAP is in identifying a dynamic leader who can successfully navigate both the party's affairs and the governance of Delhi in the absence of Kejriwal.

Tamil Nadu to create electoral history

DMK in solo contest against a national party

For the first time in its political history since 1967, Tamil Nadu will see the DMK fighting head on against a national party while the traditional challenger AIADMK is getting relegated to the status of "also rans". No major political parties find

place as a constituent of the AIADMK except some fringe elements while the major players in the State have lined up under the DMK and the BJP. The Congress, the Communists, the Islamic outfits, the Dalits and the regional parties from South west Tamil Nadu are all lined up under the leadership of the DMK while the BJP has regional parties like Tamil Manila Congress (TMC) and the Vanniyar community's Pattali Makkal Katchi (PMK) under its banner.

The surprise element in the formation of alliances was the decision of DMDK founded by late actor Vijayakanth crossing over to the AIADMK camp.



The whole Tamil Nadu had stood in shocked silence when Premalatha, party founder's main driving force, abused

AIADMK supremo Jayalalithaa with the choicest abuses during the 2016 Assembly election. The DMDK was lead

constituent of the People's Welfare Front which had projected Vijayakanth

as the chief ministerial candidate in that polls. The DMDK was wiped out in the poll and Vijayakanth lost his security deposit in the last

election of his life. Since then Vijayakant was bed ridden till he breathed his last in 2023.

How can the AIADMK get along with Premalatha who had insulted and abused Javalalithaa by calling her names is the question being asked all over Tamil Nadu. "She is a robber, dacoit, and corrupt

Highlighting a concerning trend amidst the threat of climate change, a study has said there is a growing probability of temperatures soaring to as high as 40 Celsius during late March, coinciding with the Holi celebration, in at least nine States, including States Maharashtra, Chhattisgarh, and Bihar.

currently Maharashtra the exhibits highest probability at 14 per cent while among the cities, Bilaspur has the highest risk with a 31 per cent chance of reaching 40 degrees Celsius, which is 2.5 times higher than in the 1970s.

Such a scenario, which was once considered rare, underscores the escalating impact of climate change on weather patterns and cultural festivities, particularly during the festival of colours, traditionally celebrated

In a land of great Maratha warrior Chhatrapati Shivaji, not an election passes without his descendent being in fray. This time around, the Opposition Maha Vikas Aghadi (MVA) has nominated Chhatrapati Shrimant Shahu Maharaj — the 12th direct descendent of Chhatrapati Shivaji Maharaj — as its can-didate from Kolhapur Lok Sabha constituency, on a Congress ticket.

The name of Shahu Chhatrapati figured in the first list of seven Lok Sabha candidates that the Congress announced for Maharashtra on Thursday night.

Seventy-six year-old Shivaji scion is the grandson of the great reformer, Chhatrapati Rajarshi Shahu Maharaj, a democrat and an associate of late Dr. B.R. Ambedkar.

Shahu Chhatrapati Maharaj's

candidature came a day after he had decided to enter the electoral fray as the people in Kolhapur wanted him to do so. Earlier, Shahu Chhatrapati's son Yuvraj Sambhajiraje Chhatrapati, the 13th direct descendent of founder of the Maratha Empire - who had earlier wanted to contest the Lok Sabha polls, had bowed out of

the Kolhapur election race.

A former President-nominated Rajya Sabha Member, Yuvraj Sambhajiraje announced that he was withdrawing from the 'revered father', a move that went well with the people and political leaders of different hues in Kolhapur.

Yuvraj Sambhajiraje has announced that he would work hard in tandem with the workers of MVA constituents -Congress, Shiv Sena (UBT) and NCP (Sharad Pawar) for

the victory of his father .Meanwhile, Chhatrapati Udayanraje Bhonsle - the 13th direct descendent of Chhatrapati Shivaji Maharaj --is keen to contest the polls from the neighbouring Satara constituency, where he had been defeated as a BJP candidate in the October 2019 Lok Sabha by-polls.

It may be recalled that NCP chief Sharad Pawar had contributed to the defeat of Udayanraje Bhonsle by campaigning vigorously for his party's bureaucrat -turnedpolitician Shriniwas D Patil who trounced the Shivaji scion by a margin of 87,717 votes. The crucial point in the Satara

Lok Sabha by-poll campaign

was when Pawar addressed a public rally for Patil amid pouring rain last week, a sight that created a lot of sympathy for both the Maratha leader and Patil. The sympathy, coupled with the Udyanraje's unbearable arrogance witnessed on several occasions in the past, worked in favour of Patil. Once a close associate of NCP chief Sharad Pawar, Udyanraje had earlier quit the then united Sharad Pawar-led party, resigned from Lok Sabha and joined the BJP. Later on, Udyanraje contested the October 2019 Lok Sabha bypolls on a BJP ticket.

Udayanraje's defeat came as a huge setback for the BJP which had not only roped him into the BJP ahead of the Assembly Maratha card from the NCP by using him like a trophy in its

The BJP had made it a prestige issue to ensure the victory of Udayanraje. So much so that both Prime Minister Narendra Modi and BJP president Amit had campaigned for

The agency claimed these also were corroborated by one of the candidates of AAP for Goa elections of 2022 who said he received funds for election expenses "in cash" from the AAP volunteers in Goa. The ED, for the first time in the about two year old probe, said the AAP was the "major beneficiary of the proceeds of liquor scam".

It alleged that a part of these proceeds of crime, to the tune of about Rs 45 crore in cash, was utilised in the election campaign of the AAP in Goa Assembly polls. It claimed these funds were transferred to Goa via four 'Agadiya' routes. The 'Agadiya' network is

known to move huge cash funds from one location to the other. "In this manner, the AAP has

committed the offence of money laundering through Kejriwal and the offences thus are covered by section 70 of the PMLA," it said. The agency said as the

The agency said Kejriwal "wilfully disobeyed" nine summonses issued to him to

SC refuses bail to Kavitha in excise case

The Supreme Court on Friday refused to grant bail to BRS leader K Kavitha, who has been arrested by the Enforcement Directorate in the Delhi excise policy scam case. A bench of Justices Sanjiv Khanna, MM Sundresh and Bela M Trivedi asked Kavitha to approach the trial court, saying it is a practice which this court is following and cannot bypass the protocol. The bench said as far as



Kavitha's plea challenging the provisions of the Prevention of Money Laundering Act (PMLA) is concerned, the

court is issuing notice to the ED and seeking its response in six weeks. "The petition challenging the provisions will come up with the pending matters," the bench told senior advocate Kapil Sibal, appearing for Kavitha.

At the outset, Sibal told the bench that he has one request to the court that he should not be asked to go to the High Court. "Please see what is happening

AAP workers protest against BJP over Kejriwal arrest

Road in Central Delhi as mul tiple layers of barricades and a large number of security personnel were deployed to thwart party leaders and workers from marching towards the BJP headquarters. Several protestors were bungled into buses as they gathered at the ITO intersection around 10.30 am to proceed towards the BIP office on the DDU Marg. Paramilitary personnel in anti-riot gear were also deployed to maintain law and

Many AAP workers lay down on the road to resist the police's attempts to detain them. Women police personnel were seen dragging female protesters, many of whom were demonstrating carrying pictures of Kejriwal. According to police, more than 50 protestors have been detained so far and taken to various police stations located far away from Central Delhi. The AAP said that an "undeclared emergency like situation has arrived in the country and

Punjab Minister Harjot Bains was also detained by police Hours after his detention, Bharadwaj released a video on X from the Alipur police station where he along with his party's workers are seen singing "Mera rang de basanti chola". While being detained by police, Bharadwaj alleged that Kejriwal's family members have been put under house and no one is being allowed to meet them.

Meanwhile addressing a press conference, Atishi said the AAP is worried about the security of Chief Minister Arvind Kejriwal in ED custody. Atishi said this is for the first time in India's democratic history that a national party's chief has been arrested before the Lok Sabha polls. "ED has not been able to produce a single evidence. This shows how fearful the BJP is of Arvind Kejriwal," she charged. "They know that only one leader can challenge them which is is why they are making every attempt to trample Arvind Kejriwal and AAP," the minister added. Barricades, closed roads Culprit makes noise to cover up crime: BJP cause heavy traffic jam

Commuters were having a harrowing time at ITO, Rajghat and Vikas Marg here on Friday morning as they were hit by heavy traffic congestion due to closure of roads towards DDU Marg in view of AAP's protest. cal party at DDU Marg Delhi, traffic will remain heavy at IP Marg, Vikas Marg, Minto Road and Bahadur Shah Zafar Marg. DDU marg will remain closed for traffic movement. Kindly avoid these roads and plan your journey accordingly." Many AAP workers and supporters blocked the roads at different places in central Delhi, forcing the police to detain them, which led to massive traffic jams at ITO and Rajghat.

Huge traffic congestion was also witnessed at Geeta Colony and Raighat. As the roads leading to the ED office were also shut, the traffic police advised commuters to avoid Krishna Menon Marg, Motilal Nehru

Marg, Janpath, and Dr APJ Abdul Kalam Road. Following Kejriwal's arrest Thursday evening, the AAP had given a nationwide call for protest against the BJP. Ahead of the protest, police beefed up security with multi-layered barricading on roads where AAP leaders and workers had planned to stage demonstra-

20 CBSE schools

Central Board of Secondary Education (CBSE) has disaffiliated 20 schools, five of them in Delhi, for enrolling dummy students and ineligible candidates, its secretary Himanshu Gupta said on Friday. The board has also downgrad-

ed affiliation of three schools. 'Pursuant to the surprise inspection conducted in CBSE schools across the country to check whether the schools are running as per the provisions and norms contained in affiliation and examination byelaws, it was found that some schools were committing various malpractices of presenting dummy students, ineligible candidates and not maintained records properly," Gupta said. "After thorough inquiry, it has been decided to disaffiliate 20 schools and downgrade three schools," he added.

Five of the disaffiliated schools are in Delhi, three in Uttar Pradesh, two each in Kerala, Rajasthan, Chhattisgarh and Maharashtra, and one each in Jammu and Kashmir, Dehradun, Assam and Madhya Pradesh.

The schools with downgraded affiliation are in Delhi, Punjab

SC junks Centre review plea on

 $T^{\text{he Supreme Court has dismissed the Centre's petition}}$ seeking review of its verdict which said the Enforcement Directorate (ED) is required to furnish the grounds of arrest to an accused in writing "without exception", saying there was no error in its judgement warranting reconsideration.

A bench of Justices AS Bopanna and Sanjay Kumar considered the review petition in chambers and passed the order. "We have carefully gone through the review petitions and the connected papers. We do not find any error, much less apparent, in the order impugned, warranting its reconsideration. The review petitions are dismissed accordingly. Pending application, if any, stands disposed of," the bench said. In its order passed on March 20, the bench also dismissed the Centre's application for an open court hear-

Justice Kumar, who had penned the verdict on behalf of the bench, also questioned the manner of arrest of the Bansals in the case and said the chronology of events "speaks volumes and reflects rather poorly, if not negatively, on the ED's style of functioning". The top court had said if any

sensitive material is mentioned in the grounds of arrest, it would always be open for the ED to redact such sensitive portions in the document and furnish the edited copy of grounds of arrest to the arrested person so as to safeguard the sanctity of the investigation. Basant and Pankaj Bansal were arrested by the ED in connection with the money launder-

ing probe linked to an alleged

bribery case.

The money laundering case in which Basant and Pankaj Bansal were arrested pertained to an FIR filed by the anti-corruption bureau of the Haryana Police in April last year against Sudhir Parmar, a former special judge for ED and CBI cases who was posted in Panchkula, his nephew and a third M3M group director Roop Kumar Bansal.

In its FIR, the ED had alleged that reliable information was received about Parmar showing "favouritism" to the Bansals and real estate firm IREO owner Lalit Goyal in the ED and CBI cases pending against them in his court. Parmar was suspended by the Punjab and Haryana High Court after a case was registered against him by the anti-corruption.

SC reserves order on Kerala plea for interim relief over ceiling on borrowing


The Supreme Court on Friday reserved its order on Kerala Government's plea seeking interim relief in a lawsuit contesting a ceiling on the State's net borrowing. The Kerala Government has

filed a suit in the apex court accusing the Centre of interfering in the exercise of its exclusive, autonomous and plenary powers" to regulate the state's finances by imposing a cap on borrowing. A bench of Justices Surya Kant

and K V Viswanathan reserved the order after hearing two sides.

The Centre had on Thursday told the apex court that the Kerala government has been "over-borrowing" in the recent years which reflected its difficult financial situation.

The Kerala government asserted its finances are "sustainable enough" to bear the burden of over-borrowing in the previous

However, the Kerala govern-ment had said Rs 5,000 crore "does not take us anywhere" and the absolute minimum requirement stood at Rs 10,000

Article 131 of the Constitution, the Kerala government has said the Constitution bestows fiscal autonomy upon states to regulate their finances under various articles, and the borrowing limits or the extent of such borrowings are regulated by state legislation.

Article 131 of the Constitution deals with the original jurisdiction of the apex court in any dispute between the Centre and states.

India braces for water scarcity as storage declines PIONEER NEWS SERVICE NEW DEL LI

As the summer season approaches, India braces itself for a challenging scenario of water scarcity, as evidenced by recent data from the Central Water Commission (CWC) concerning the live storage capacity in the country's primary reservoirs. The figures paint a stark picture, revealing that the current storage levels stand at a mere 38 per cent of their total capacity.

This alarming statistic not only raises immediate concerns but also underscores a worrying trend amid the broader context of climate change which threatens to impact the water resources banks such as glaciers and rivers across the Himalayas range. As per the data, in urban areas

like Bengaluru, the situation is already dire, with water shortages becoming increasingly prevalent. The city is grappling with a substantial daily shortfall of approximately 500 million litres, pitted against a staggering demand of 2,600 million litres per day. Such a deficit places immense strain on the city's water resources and infrastructure, significantly impacting the lives of its residents.

The predicament in Bengaluru is further exacerbated by the drying up of borewells, which serve as a vital source of water for thousands of households. Shockingly, out of the 14,000 borewells scattered across the city, nearly half, amounting to 6,900, have already run dry. This alarming trend reflects the severity of the water crisis unfolding in one of India's



Among the States, Karnataka, along with several others including Himachal Pradesh, Punjab, Madhya Pradesh, and others, have reported lower storage levels compared to the same period last year, as highlighted in the weekly bulletin by

According to the statistics, the total live storage capacity of the 150 primary reservoirs in India amounts to a significant 178.784 billion cubic meters (BCM). However, the current live storage available in these reservoirs paints a different picture, standing at a mere 67.591 BCM, which represents just 38 per cent of their total capacity. This disparity between capacity and actual storage levels raises questions about the efficacy of water management practices and the need for more sustainable solutions.

In the Southern region of India, encompassing states like Andhra Pradesh, Telangana, Karnataka, Kerala, and Tamil Nadu, the situation is particularly grim. Here, the total live storage available in reservoirs is a mere 23 per cent of their total capacity. This dismal figure marks a significant decrease compared to storage levels during the same period last year and falls below the average storage over the past decade.



DGCA fines Air India ₹80 lakh for violation of norms

The Directorate General of L Civil Aviation (DGCA) on Friday imposed an Rs 80 lakh penalty on Air India for violations of flight duty and fatigue management norms, including failure to provide adequate rest to flight crew before and after ultra-long

haul flights. This is at least the third time in less than two months that Tata Group-owned Air India has been fined by the DGCA. The latest penalty also comes at a time when the DGCA has decided not to extend the June 1 deadline for implementing the revised flight duty norms that will provide more rest hours for pilots.

In January, the watchdog conducted a spot audit of Air India to verify the airline's compliance with Flight Duty Time Limitations (FĎTL) and Fatigue Management System (FMS) regulations. During the audit, evidence was collected and fleet-wise random reports were analysed.

"The analysis of reports and evidence revealed that Air India Limited operated flight(s) with both flight crew aged above 60 years flying together in a few instances."...The operator was also found deficient in providing adequate weekly rest, adequate rest before & after ultra-long range flights and adequate rest on layover to the flight crew, which violates the extant provisions of the Civil Aviation Requirements pertaining to FDTL," the DGCA

said in a release.

Generally, ultra-long-haul

flights are those having a duration of more than 16 hours. Air India operates such flights to destinations in Canada and the US.Further, the DGCA on Friday said there were instances of exceeding duty periods, wrongly marked training records and overlap-ping duties. On March 1, the watchdog issued a show cause

notice to Air India with

respect to the violations. "The operator submitted its response to the show cause notice which was not found satisfactory. Pursuant to the non-satisfactory response submitted by the operator, a fine of Rs 80,00,000 has been imposed on the operator," the release said.

Having both cockpit crew members or pilots aged above 60 years in a flight violates Rule (2) of Rule 28 A of the Aircraft Rules, 1937."No person holding a pilot's licence issued under these rules and having attained the age of sixty years shall act as Pilot-in-Command or Co-pilot of an aircraft engaged in commercial air transport operations unless it is operated in a multi-crew environment and the other pilot is less than sixty years of age," as per the rule.

Earlier this month, the DGCA said it would not be extending the June 1 deadline for implementing the revised flight duty norms for pilots.The Federation of Indian Airlines (FIA), comprising Air India, SpiceJet and IndiGo, had written at least twice to the regulator, seeking more time for implementation of the revised Flight Duty Time Limitations (FDTL) norms issued on the pioneer



Fall from grace

With Delhi CM Arvind Kejriwal behind bars in the liquor scam, the future of AAP and allies is in balance

we stories have been as riveting and controversial as that of Arvind Kejriwal, the anti-corruption crusader-turned-politician who took over as the Chief Minister of Delhi with a huge, unprecedented mandate. He rose to prominence as the face of the Aam Aadmi Party (AAP), promising a new era of clean governance. However, events have now taken a dramatic turn, with Kejriwal finding himself embroiled in a high-profile liquor scam, a stark contrast to the clean image he once projected. His political journey began in 2011 with Anna Hazare's anti-corruption movement. Alongside figures like Anna and Kiran Bedi, Kejriwal became a symbol of hope for many disillusioned with the rampant corruption in politics. His activism resulted in the formation of AAP in 2012, with the party making significant inroads in the Delhi Assembly elections the following year and forming the Government. Under Kejriwal's leadership, the AAP Government in Delhi introduced several populist measures aimed at improving the lives of citizens. Initiatives



such as Mohalla Clinics, providing affordable healthcare, garnered praise from across the world. It goes to Kejriwal's credit and that of his deputy Manish Sisodia that Government schools transformed into centres of excellence. The Chief Minister has painstakingly crafted his image as an unblemished and incorruptible leader, cementing his position as a formidable political force and fanning out across the country, forming the Government in Punjab as well. However, his alleged involvement in a liquor scam has cast a shadow over Kejriwal's once-untarnished reputation.

The impact of his arrest on national politics cannot be overstated as it comes weeks before the Lok Sabha

elections. With the Chief Minister embroiled in legal battles and the AAP leadership distracted by the scandal, the administration's ability to effectively govern the Capital is severely compromised. Furthermore, as a prominent figure of the Opposition camp, Kejriwal's arrest could weaken the anti-BJP bloc, of which the AAP is a significant member. The BJP, which has been eager to expand its influence in the Capital, may seek to capitalise on the development. Accused of turning a blind eye to illicit liquor trade in Delhi, Kejriwal now finds himself at the centre of a political storm. The irony of a former anti-corruption crusader being accused of complicity in a corruption scandal has not been lost on observers. That said, it is also true that Kejriwal is one of the biggest eyesores for the BJP as his party has replaced the latter in both the State leguslature and the MCD, though all the seven Delhi MPs belong to the BJP. With the AAP brass -Manish Sisodia, Sanjay Singh, Satyendra Jain and now the Chief Minister himself behind bars, the political vendetta angle cannot be ruled out. Moreover, the conviction rate of the Enforcement Directorate is abysmally low and it has been accused by the Opposition of being a tool to harass the opponents. At this point, it is difficult to say what the actuality is, maybe somewhere between the two extremes.

Shadow of World War III?



The danger is inherent in the continuing conflict in Ukraine

an the war in Ukraine lead to World War III? It can if talk about an event presages its occurrence. The latest mention has been by Vladimir Putin, who said on March 18, 2024, that a direct conflict between Russia and NATO (North Atlantic Treaty Organisation) would mean that the planet was one step away from World War III. He, however, had added that hardly anyone wanted any such scenario. Other Russian leaders have also mentioned the possibility. Alexander Venediktov, deputy secretary of the Security Council of Russia, had said on October 13, 2022, that Ukraine's admission into NATO was guaranteed to escalate the conflict in that country into the third world war. Western countries have also been taking the danger of a wider war with Russia seriously. The German newspaper, Bild, reported on January 15, 2024, that the country's army was gearing up to cope with a Russian attack on the Baltic countries— Latvia, Lithuania and Estonia in the summer of 2025, that would begin with a spring offensive in Ukraine this year.

Russia's talk of World War III may well be a part of a strategy to reduce the United States' and European countries' support to Ukraine. Germany's response mentioned above, however, indicates that such talk is being taken seriously. In fact, the German defence minister, Boris Pistorius, has signed an agreement with his Lithuanian counterpart, Arvydas Anusauskas, for stationing 4,800 German troops and 200 civilians in the latter's country.

With countries preparing for war, speculation about the conflict in Ukraine escalating into World War III is understandable. But then, what is a World War? It can be defined as a large-scale conflict involving a number of countries on both sides, stretching over large tracts of the earth, and affecting even on countries that are not directly involved. As things are, World War III would see the United States-led NATO countries pitted against Russia which may be joined by Belarus, China and North Korea.

While talking about the danger of a third world war breaking out over Ukraine, all important 1961.



In the present instance, people have been hearing of a World War III ever since the end of World War II, when the world came to be divided into two blocs. One comprised countries led by the US and clustered round pacts like the NATO, Central Treaty Organisation (CENTO) and the South-East Asia Treaty Organisation (SEATO), the first two targeting the Union of Soviet Socialist Republics (USSR) and the third one, China. Other bloc comprised countries of East Europe which had come into the USSR's orbit after the end of World War II, and which were members of the warsay Pact led by it. China enjoyed observer status in respect of the pact until it withdrew in

The Cold War that came to prevail between the two blocs was marked by frigid and unfriendly ties. There was no shooting war. The restraining factor was the large nuclear arsenals which both the US and the USSR — and later China — possessed, and the smaller stockpiles of countries like Britain and France. A war between the two blocs, it was felt, would lead to the use of nuclear weapons. The USSR's premier, Nikita Sergeyevich Khrushchev, graphically summed up the horrors of the resultant scenario when he said, "The living will envy the dead." The two blocs came close to

a war on two occasions. On May 1, 1960, a Soviet missile brought down a U-2 spy plane, operated under the aegis of the US Central Intelligence Agency, in Russian territory. Its pilot, Francis Gary Powers, who had parachuted to safety, was taken prisoner. The incident put on hold the thaw in US-USSR relations that had followed a meeting at Camp David, Maryland, between the American President Dwight D. Eisenhower and Prime Minister Khrushchev, in September, 1959. It also scuttled the Paris summit in

United Kingdom, France and USSR after Khrushchev walked out of it following Eisenhower's refusal to apologise for the U-2 mission. The second occasion was the Cuban missile crisis of October, 1962, triggered by the USSR's move to install SS-4 and SS-5 missiles in Cuba which could hit targets in the US. The latter, under President John F. Kennedy, imposed naval quarantine (read blockade) on Cuba,

Shifting alliances and tensions in South Asia

South Asia has experienced a significant transformation marked by notable developments that are redefining the relationships among major stakeholders

¬he geopolitical dynamics of South Asia have undergone a profound transformation in recent years, marked by a series of significant developments that have reshaped the relationships between India, Pakistan, Afghanistan, and the Taliban. What initially appeared to be a strategic win for Pakistan with the Taliban's return to power in Afghanistan has now turned into a complex web of alliances and rivalries, with India and the Taliban exploring new avenues for cooperation, while Pakistan finds itself embroiled in a conflict with its western neigh-

Pakistan's initial support for the Taliban's resurgence in Afghanistan was driven by a desire for a friendly government in Kabul that would be more amenable to Islamabad's interests. The previous Afghan government, led by Ashraf Ghani, was perceived by Pakistan as being too closely aligned with India, Pakistan's historical rival. Therefore, the Taliban's rise was seen as a strategic victory for Pakistan, potentially opening up avenues for increased influence in



Afghanistan. When the Taliban reclaimed power in Kabul on 15th August 2021, the then Pakistani PM Imran Khan expressed optimism, describing it as a "breaking the shackles of slavery moment for Afghanistan. There was a widespread belief among Pakistanis that the Taliban, whom they often referred to as "our brothers," would help Pakistan in its quest to assert control over Kashmir, a disputed region between India and Pakistan. This sentiment was rooted in the belief that a Taliban-controlled Afghanistan would be more sympathetic to Pakistan's stance on Kashmir and would support Pakistan's efforts to wrest control of the

region from India. However, the euphoria of the Taliban's return quickly dissipated as concerns grew over the group's ability to govern effectively and maintain stability. Pakistan's hopes for a from India, its traditional

strategic win in Afghanistan were further dampened by the emergence of the Tehriki-Taliban Pakistan (TTP), a Pakistani Taliban group that found sanctuary in Afghanistan and began launching attacks on Pakistani

The situation took a dramatic turn on 16th March 2024 when Afghan militants attacked Pakistani soldiers at a border killing 7 of them. Pakistan retaliated with strikes against Afghan militants citing concerns over cross-border terrorism and the presence of Pakistani Taliban militants allegedly supported by Kabul.

Meanwhile, India's relationship with the Taliban has evolved, with the two sides engaging in talks for trade and economic cooperation. The Indian delegation, led by J P Singh has met the current Taliban Foreign Minister Amir Khan Mottaqi and the former Afghan President Hamid Karzai in Kabul to discuss humanitarian assistance and trade. This development has caught Pakistan off guard, as it now finds itself on the opposite side of the table

rival. Amidst the ongoing humanitarian crisis in Afghanistan, the US special representative Afghanistan, Thomas West, is set to travel to India in the third week of March 2024 for consultations on working together to support the

Afghan people. This visit follows the Indian delegation's recent stated meeting with the Taliban ministry. West's visit is particularly significant as he engages with the Taliban and mobilises international support for Afghanistan. However, these diplomatic efforts come in the wake of Pakistan launching airstrikes in border regions of Afghanistan, resulting in the tragic deaths of at least eight

As the situation continues to evolve, it remains to be seen how these shifting alliances will shape the future of South Asia. The once-clear lines of allegiance and enmity have blurred, creating a complex and unpredictable geopolitical landscape that will require careful navigation by all parties involved.

Muizzu seeks debt relief from India | Chinese coast guard ships attempt

fter his anti-India rhetoric, Amaldives President Mohamed Muizzu has struck a reconciliatory tone, saying India will continue to remain his country's "closest ally" and urged New Delhi to provide debt relief to the archipelago

The Maldives owed approximately USD 400.9 million to India by the end of last year. Ever since he took oath as the president in November last year, the pro-China Maldivian leader has pursued a hardline stand towards India and within hours had demanded that Indian military personnel operating three aviation platforms be repatriated from his country by May 10

On Thursday, in his first interview with the local media since assuming office, Muizzu said India was instrumental in providing aid to the Maldives and has implemented the "greatest number" of projects.

India will continue to remain the Maldives' closest ally, he said and emphasised that there



was no question about it, Maldives news portal Edition.mv said in a report that carried excerpts of Muizzu's interview to its Dhivehi language sister-publication 'Mihaaru.'

Muizzu's comments praising India came after the first batch of Indian military personnel left the island nation this month as planned. By May 10, Muizzu had demanded that all 88 military personnel, manning the three Indian aviation platforms, should leave the country.India has been providing humanitarian and medical

ple of the Maldives for the last few years using two helicopters and a Dornier aircraft. The Maldives' proximity to India, barely 70 nautical miles from the island of Minicoy in Lakshadweep and 300 nautical miles from the mainland's western coast, and its location at the hub of commercial sea lanes running through the Indian Ocean Region (IOR) gives it significant strategic impor-

During the interview, Muizzu urged India to accommodate debt relief measures for the Maldives in the repayment of "the hefty loans taken over consecutive governments."

Thinese coast guard ships backed by a military helicopter attempted unsuccessful ly to block two Philippine government vessels carrying scientists from reaching two sandbars in the disputed South China Sea, Philippine officials said on Friday. Chinese coast guard personnel blew the horn on one of their ships for half an hour and repeatedly transmitted radio warnings during the confrontation Thursday, but the Filipino scientists managed to complete their four-hour marine and biodiversity research at the barren sandbars called Sandy Cay, the officials said.

The Chinese coast guard gave a different account of the faceoff. A spokesperson, Gan Yu, said in a statement that its law enforce ment officers "boarded" the sandbars, which Beijing calls Tiexian Reef, and dealt with what it called "illegal activities by 34 Philippine personnel who ʻignored China's warnings and

coming from the Chinese coast guard," Philippine coast guard Commodore Jay Tarriela said at a news conference on Friday "For four hours, our marine scientists were able to continue their research?

Journalists who were invited to join the research mission witnessed the incident, Tarriela

It was the latest flareup in increasingly tense territorial disputes that are seen as a potential Asian flashpoint that might bring China and the United States into a conflict if they degenerate into a major armed confrontation. China, the Philippines, Vietnam,

Malaysia, Taiwan and Brunei have overlapping territorial claims that have erupted from time to time into brief confrontations in the South China

Hostilities between China and the Philippines, however, have worsened since last year, resulting in minor collisions at sea and men, sparking a war of words. Washington has no territorial claims in the strategic waterway but has questioned China's claim to virtually the entire seaway. The United States has repeatedly warned that it's obligated to defend the Philippines, its oldest treaty ally in Asia, if Filipino forces, ships and aircraft come

under an armed attack. During the Chinese coast guard's maneuvers, one of its ships crossed the bow of the Philippine fisheries vessel BRP Datu Sanday at a distance of 100 meters (328 feet), Tarriela said. At least 13 suspected Chinese militia vessels tried to help form a blockade, he said.

UN seeks \$4 bn for aid in Syria

Beirut (AP): A UN humanitarian official appealed on Friday for more than USD 4 billion in life-saving aid for more than 10 million Syrians saying that the country's large ly forgotten crisis remains one of the most deadly to civilians in the world.

Adam Abdelmoula, resident coordinator in Syria for the UN Office for the Coordination of Humanitarian Affairs, made the appeal days after Syria marked the 13th anniversary of the conflict that has killed nearly a half million people and left large parts of the country destroyed. "Today, we are facing an unprecedented situation in Syria — one that we cannot afford to ignore," Abdelmoula told reporters in Geneva. "Inaction will be costly for all of us and will inevitably lead to additional suffering?

About 16.7 million people require some form of humanitarian assistance in Syria, an increase from 15.3 million last year, he said. Over 7 mil lion people are internally displaced and nearly as many are refugees in other countries, including neighbouring Jordan, Lebanon and Turkey The war has left 90 per cent of Syria's population below the cuts in food aid because of a funding shortfall. The UN World Food Program ended its main assistance program in the country in January.

"The Syria crisis remains one of the most deadly to civilians in the world. Hostilities continue to plague various parts of Syria and have recently seen a sharp spike, especially in the north," Abdelmoula said.

He suggested that Israel's war against Hamas in Gaza had given cover for more military activity in parts of Syria."We saw the world's attention focusing on Gaza, and that provided some kind of diversion of attention that allowed the significant escalation of hostilities in the northeast without much attention being paid to that situation by the international community, Abdelmoula said

Russia attacks Ukrainian electrical power facilities

Russia attacked electrical power facilities in much of Ukraine, including the country's largest hydroelectric plant, causing widespread outages and killing at least five people, officials said on Friday

Volodymyr President Zelenskyy said more than 60 drones and about 90 rockets were used in the attack. The attack came a day after Russia launched 31 missiles in a single attack on the capital. It was the largest assault on Ukraine's energy infrastructure this year and one of the largest since the outbreak of the war, according to Ukrainian authorities.

"Even last winter, attacks on our energy system were not as large as they were this night," said the head of energy utility Ukrenergo, Volodymyr Kudrytskyi.

Last winter, Russia deliberately targeted Ukraine's energy infrastructure, resulting in frequent blackouts across the country. Many had warned that Russia might repeat this strategy ahead of this winter. But instead, Russia has launched massive missile and drone attacks primarily directed at Ukraine's defense industry. Every large-scale air attack depletes Ukraine's capabilities to repel Russian missiles. Zelenskyy has been urging Ukraine's Western allies for weeks to provide additional air defense systems and ammunition amid delays in aid from

the US. "With Russian missiles, there are no delays, like with aid packages to our state. Shaheds don't have indecisiveness, as do some politicians. It is important to understand the cost of delays and postponed decisions, Zelenskyy said, referring to Iranian-made Shahed drones, which are widely used by Russia in the war. The attacks caused a fire at the Dnipro Hydroelectric Station, which supplies electricity to the Zaporizhzhia Nuclear Power Plant, Europe's largest nuclear

power installation. The main external power line

EU to impose tariffs on Russian grain

Brussels (AP): The European Commission wants to prevent Russia from using farm products as a tool to wreak havoc on the EU market and is moving to impose tariffs on grain imports from Russia and Belarus. The tariffs are also aimed at denying Russia revenue, because they will effectively suppress exports to the EU, the commission said. Imports of cereals, oilseeds and derived products from Russia and its Belarus ally are just about 1 per cent of the overall size of the EU market, with domestic suppliers providing the bulk.

But with angry famers already worried by the increase of cheap Ukrainian imports, the EU fears Russia will be encouraged to take advantage of the tense situation to further destabilize the 27-nation bloc.

"This shortfall in supply will be filled partially by EU's domestic production and, therefore, benefit EU farmers who will be able to sell in the EU," the commission said. "In addition, the shortfall is expected to be partially filled by imports from third countries which traditionally supply the EU market such as the US, Brazil, Ukraine, Serbia, or Argentina." EU impo

imports of cereals, oilseeds and derived products from Russia including wheat, maize, and sunflower meal were 4.2 million metric tons in 2023, worth 1.3 billion euros. In comparison, EU suppliers provide 300 million metric tons per year.

World food prices hit record level as a result of the Russian invasion of Ukraine combined with other factors but have since fallen from record highs

Other attacks were reported in areas of western Ukraine far from the front lines. Two people died in the Khmelnytskyi region, according to the Internal Affairs Ministry.

The power outages left 1,060 miners trapped in the Dnipropetrovsk region and an evacuation was underway, according to private energy company DTEK. "The world sees the targets of Russian ter-rorists as clearly as possible: power plants and energy sup-ply lines, a hydroelectric dam, ordinary residential buildings, even a trolleybus. Russia is fighting against the ordinary life of people," Zelenskyy said Friday on the Telegram messaging app.

Russian officials said Friday that one person died and at least three were injured in Ukrainian shelling of areas near the border.

The governor of the Belgorod region, Vyacheslav Gladkov, said a woman was killed when a shell hit nearby while she was walking her dogs and that two others were injured. The town of Tetkino in the Kursk region was shelled, injuring one person, said Gov. Roman Starovoit. Both regions have been subject to shelling and drone attacks in recent weeks and officials have said that attempts by Ukrainian fighters to cross into Russian territory have been repelled.

EU slaps sanctions on Russian justice officials blamed for jailing Navalny

The European Union on Friday imposed sanctions on the Russian justice and prison officials responsible for imprisoning opposition leader Alexei Navalny before his death last month.

"Alexei Navalny's slow killing by the Kremlin regime is a stark reminder of its utter disregard for human life," EU foreign policy chief Josep Borrell said in a statement announcing the

Borrell said the sanctions, which target 33 officials and two prisons and involve asset freezes and travel bans, "demonstrate our determination to hold Russia's political leadership and authorities to account for the continuing violation of the human rights in

President Vladimir Putin, was serving a 19year sentence when he died. He had been behind bars since January

2021 after returning to Russia from Germany where he had been recovering from nerveagent poisoning that he blamed on the Kremlin

The cause of his Feb. 16 death has been described by officials only as due to natural causes. The EU said that its measures would hit the IK-6 corrective colony and IK-3 maximum security corrective colony, including the official in charge Vadim Kalinin, where Navalny "Both colonies are known for exerting physical and psychological pressure, full isolation, torture and violence on prisoners. Efforts to rescue 13 people trapped in gold mine continue on fifth day

Moscow (AP): Rescue workers laboured for a fifth day on Friday to reach 13 people trapped deep underground in a collapsed gold mine in Russia's far east, news reports said. They said no contact has been made with the miners in the Amur region, about 5,000 kilometres (3,000 miles) east of Moscow. At least 13 miners are trapped, regional officials said Tuesday.

The state news agency RIA Novosti cited emergency officials as saying that powerful pumps have completed taking water out of the mine. The miners were trapped at a depth of about 125 metres (400 feet) when part of the mine collapsed on Monday. The cause of the accident has not been announced.

These plots of land were

released to farmers across five Grama Niladhari Divisions in Jaffna for cultivation purposes. Wickremesinghe symbolically presented the deeds benefiting 408 individuals at a ceremony held in Jaffna's Oddakapulam under the Urumaya national programme, aimed at distributing two million freehold deeds to the deserving public. Officials said some 68 acres had also been released on March 10.

These lands had been cultivated by the military since public access to them had been shut due to the military operations against the Liberation Tigers of Tamil Eelam (LTTE) till 2009. During and after the conflict with LTTE, some 3,500 acres of privately owned lands were taken over by the military to create the high-security zone around the Palaly military base of Jaffna which is also the site for the current Jaffna International Airport.

Since 2015 some of these lands have been released to their private owners in response to pleas after the military defeated the LTTE in 2009

Jaffna holds great significance as it was the region where the LTTE had run a military campaign for a separate Tamil homeland for nearly 30 years before its collapse in 2009 after the Sri Lankan Army killed its supreme leader V Prabhakaran.

Orbán, widely seen as Putin's closest ally in the European Union, sent the letter of congratulations to Putin on Thursday after the release of official election results in Russia, according to his press chief. The Hungarian leader was the only head of a EU country to congratulate Putin on his reelection, which will extend his nearly quarter-century rule of Russia by another six years. Putin's landslide victory was

widely criticised by Western leaders, who characterised the result as preordained in Russia's repressive political system. The EU criticised the election as taking place in a "highly restricted environment exacerbated also by Russia's illegal war of aggression against Ukraine".

"Russian authorities have continued to increase the system-

atic internal repression by cracking down on opposition politipolitically motivated prison sentences," an EU statement said. Orbán's letter said that the cooperation between Hungary and Russia, "based on mutual respect, enables important discussions even in challenging geopolitical contexts".

He also pointed out what he called Hungary's "commitment to peace", which has taken the form of repeated calls for an immediate cease-fire in Ukraine without outlining what such a step would entail for that coun-

try's territorial integrity. Orbán's government has taken a differing approach to the war in Ukraine from its EU and NATO allies since Russia began its full-scale invasion more than two years ago. Hungary has refused to supply Ukraine with weapons or allow their transfer across its borders, and has held up EU efforts to supply Ukraine with badly needed funding.

Hungary has also sought to deepen energy deals with Moscow even as other countries in Europe have decreased their dependency on Russian fossil to significant tensions with Ukraine's government and with his partners in the EU.

Speaking in an interview with Hungarian public radio from Brussels on Friday, Orbán accused EU leaders of taking an increasingly active role in the conflict in Ukraine, something he predicted would be a key issue in the bloc's elections this summer.

"The leaders speak as if they are fighting their own war against Russia. Not like us who say, Look, this is a war between Russia and Ukraine. This is not our war," Orbán said. "We are not at war with Russia, they are at war, and they even speak as if Russia must be defeated." On Thursday, Hungary refused to support a Czech-led effort to acquire ammunition that Ukraine badly needs from third countries outside the EU.

Pak court sentences woman to life for burning Quran pages

Pakistani court in Punjab A province has sentenced a 40-year-old woman to life in of burning pages of Islam's holy book, a court official said on Friday.

Asia Bibi, a Muslim resident of the thickly populated Bedian Road area of Lahore, was arrested by police in 2021 on a complaint by a man of her locality who accused her of burning a copy of the Quran outside her house.

'The Lahore sessions court on Thursday handed down life imprisonment to Asia Bibi on the charges of desecration of the Holy Quran," a court official told PTI. She was subsequently booked under the stringent blasphemy laws of the country. Her counsel advocate Sarmad Ali, pointed out fundamental flaws in the case against Asia saying she did not commit any blasphemy and she was implicated wrongfully by her neighbour to settle a personal score.

The bench concluded the proceedings of the hearing on January 23 and reserved judgment, which was announced on Friday. The bench ruled that Siddiqui's removal was illegal and he would be considered a retired judge of the Islamabad High Court and entitled to all the benefits of a former judge. A day before the hearing concluded, former ISI director general retired Lt Gen Faiz Hameed had submitted his response to Justice Siddiqui's petition. He rejected the allegations of his involvement in the constitution of IHC benches to prolong the detention of former premier Nawaz Sharif and his daughter Maryam Nawaz. The ex-spymaster claimed Justice Siddiqui had dragged him into the case for no reason.

including Justice Aminuddin had been issued to Gen Justice Anwar Khan Kasi and former Supreme Court registrar Arbab Muhammad Arif.

Siddiqui had named seven individuals in his amended plea, however, the court remarked that three others - former Chief of Army Staff Gen Qamar Javed Bajwa, and two retired brigadiers, Faisal Marwat and Tahir Wafai, had no direct connection with the case. During the last hearing, Chief Justice Isa said the court could not punish anyone without conducting an inquiry. "The Supreme Court has to draw a line on the difference between the Supreme Court and the Supreme Judicial Council," he observed.

"If removing a judge is so easy, then this is a threat to the independence of the judiciary," the top judge had further noted, adding that the current matter was public and people had a right to know the truth.

All of the victims were people who had gathered there to collect their monthly salaries,

said Inamullah Samangani, head of the government's Kandahar Information and Culture Department. The Islamic State group's affiliate, a major Taliban rival, has conducted attacks on schools, hospitals, mosques and Shiite areas throughout Afghanistan. The militant group said that the suicide bomber detonated his explosive belt among the Taliban gathered near the bank to receive their salaries.

Government rejects Hindustan Zinc plan to split company

The Mines Ministry has rejected a proposal by Vedanta group's firm Hindustan Zinc Ltd to split the company into different entities, a top official on Friday said.

The government is the largest minority shareholder in Hindustan Zinc, owning a 29.54 per cent stake in the company. "We have not agreed to the proposal," Mines Secretary V L Kantha Rao told reporters on the sidelines of a function Hindustan Zinc had earlier announced

its plans of spinning off business into separate entities, including zinc and



silver, to increase its market capitalisation.

When asked about the reason for the rejection of the proposal, the Secretary said "Whatever report we have in front of us we are not convinced as a shareholder."

Hindustan Zinc had earlier said that it has engaged a leading advisory firm to study its plans to spin off the business. Earlier, Hindustan Zinc had said the company's board has decided to undertake a "comprehensive review of its corporate structure for unlocking potential value".

According to a regulatory filing, the move is aimed at creating separate legal

Despite his music career starting only last year, the American-Chinese artist has swiftly climbed the charts with his acclaimed Heartbreak Trilogy. In an exclusive interview with SAKSHI PRIYA from the Pioneer, Allen shared the story behind his track Closer and his collaboration with Dave Lopez while Dave shared his experience working with Allen

ould you share your experience touring Asia, particularly your recent

Dave and I, we both love people. We are big extroverts. To see so many people are coming here to watch was great. But I have got to say, the traffic is a little unnerving. Cars were driving super close to each other, yet somehow no accidents happened. It was pretty nerve-wracking but also kind of impressive.

Have you had the chance to explore any Indian delicacies, such as the famous Mumbai street food, Vada Pav?



contributions do you think he brings to the industry?

For me, good music is the priority. I always try to do what I like naturally; it is not forced. umbai's crisis man Tanush Kotian, who played a key TV role in their record-extending 42nd Ranji Trophy triumph this season, was on Friday drafted in by Rajasthan Royals as a replacement for Aussie Adam Zampa.

Kotian joined at his base price of Rs 20 lakh, the IPL announced.

Zampa, who picked up eight wickets from six matches for the Royals last season, was retained at his Rs 1.5crore contract but the Australian legspinner pulled out citing heavy workload in the build up to the T20I World Cup in June.

Kotian, an off-spinner and a handy lower-order batter, was expecting an IPL contract in 2023 after playing a

vital role in Mumbai's Syed Mushtaq Ali Trophy triumph but was reported for a suspect bowling action.

But the 25-year-old showed resilience to fight back and become the player-of-the-tournament (502 runs and 29 wickets) in Mumbai's Ranji Trophy triumph this season.

Kotian, who usually bats at No. 8, scored an unbeaten 120 in second innings and followed it up with an 89 not out in the quarterfinal and semifinal games against Baroda and Tamil Naďu respectively.

IPL also announced Karnataka wicketkeeper-batter BR Sharath as a replacement for Robin Minz at Guiarat Titans.

Jharkhand's Minz was ruled out after getting injured in a freak motorcycle accident recently.

STARC VS CUMMINS SHOWDOWN

Shreyas comeback in spotlight

Shreyas Iyer's comeback from a Slong injury layoff will be in focus as IPL's two biggest signings, Australian pacers Mitchell Starc and Pat Cummins, go head to head in Kolkata Knight Riders' opening match against Sunrisers Hyderabad here on Saturday. The Indian batter, after missing the

entire season last year due to a back injury, returns to lead KKR, who have made some tactical additions while keeping the nucleus of the side intact.

Shreyas sparkled with the bat with a 95 in Mumbai's Ranji Trophy triumph recently but it remains to be seen whether he'll be available for all the matches, given his fitness concerns.

KKR's most successful leader Gautam Gambhir is back in his second innings as a mentor. His partnership with head coach Chandrakant Pandit, a shrewd tactician in domestic circuit, will be the key to their revival

"This is your franchise, make it or break it," team principal owner Shah Rukh Khan ĥas told Gambhir. Under the former India cricketer's captaincy, KKR had a golden run from 2011-2017 -- two IPL titles, five playoffs and a runners-up defunct in the now

League tournament.

The biggest signing of this IPL is with KKR, and by acquiring Starc at a record sum of Rs 24.75-crore, the left-arm quick will be under huge pressure to perform.

His spell in power-play and the death overs will be the key. Starc and Andre Russell are the only two experienced pacers in KKR's ranks, and with no like-for-like replacements for them, their workload management will be crucial.

KKR boast of a star-studded toporder batting lineup in Rahmanullah Gurbaz, Phil Salt, Venkatesh Iyer and Shreyas to go with the Russell-Rinku Singh firepower at the death.

But the Gambhir-mentored side will rely heavily on the home conditions to offer some spin so as to give the likes of Sunil Narine, Varun Chakravarthy and Suyash Sharma some assistance.

Starc will have his skipper Cummins leading SRH in the adjacent dug-out as the Australian captain will also have his task cut

Cummins (Rs 20.50-crore) is the second-most expensive buy in this IPL and all eyes will be on him to revive the fortunes of the side that has had two wooden-spoon

finishes in the last three seasons. On paper, KKR with a star-studded batting and spin-heavy attack to complement Starc's pace, will be

overwhelming favourites. But SRH, under the shrewd captaincy of Cummins, will definitely fancy their chances. Travis Head and Heinrich Klaasen's batting firepower in the power-play

and death overs will be vital.

Their bowling also looks balanced with the experienced Cummins and India's veteran death-overs specialist Bhuvneshwar Kumar in the lineup, while the likes of Washington Sundar and Wanindu Hasaranga will be crucial in the spin department.

It remains to be seen whether Hasaranga, the ace Sri Lankan allrounder who has been banned by the ICC for the Tests against Bangladesh, will be available for SRH's opener.

Sathiyan wins first ever WTT Feeder title

Star paddler G. Sathiyan has become the first-ever Indian to win a men's singles trophy at a WTT Feeder Series event in Beirut, Lebanon.

He defeated compatriot Manav Thakkar 3-1 (6-11 11-7 11-7 11-4) on the final day of WTT Feeder Beirut 2024 on Thursday

Seeded No.11, Sathiyan enjoyed a rewarding path to the final in the Lebanese capital, taking down No.5 seed Harmeet Desai (15-13 6-11 11-8 13-11) and top seed Chuang Chih-Yuan (11-8 11-13 11-8 11-9) along the way. But the match Sathiyan will remember most is the final as he overcame an early setback to see off No.9 seed Thakkar in four

games. The result marks Sathiyan's first men's singles success at a WTT event, and his first singles title at an international ranking event since ITTF Czech International Open 2021.

Meanwhile, Xia Lian Ni picked up her second WTT Feeder title in women's singles, producing an excellent display to break down Suh Hyo Won's defensive barrier 11-9 11-5 11-5.

A wildcard entrant for the event, Ni dropped just one game on her way to the semifinal, and was even more clinical at the penultimate hurdle, needing just three games to dispatch No.2 seed Chen Szu-Yu (11-7 11-9 11-4). Appearing in her first international women's singles final since 2018, Suh did everything in her power to try and lay her

can remember in my career and it's absolutely not easy," Sargeant said. "I am, however, completely here for the team and will continue to contribute in any way that I can this weekend to maximize what we can do.' Albon, who was born in Britain

but races under the Thai flag, has consistently outperformed his American teammate in qualifying and races. Albon scored 27 points to Sargeant's one last year. Neither driver has scored a point yet in 2024, though Albon placed ahead of Sargeant in the two races so far in Bahrain and Saudi Arabia.

"I have to be totally honest and say that no driver would want to give up his seat," Albon said. "I would never want anything like this to happen. Logan has always been a consummate professional and a team player from day one, and this won't be an easy one for him to take
