Irrigation Minister N. Uttam Kumar Reddy announced on Friday that the Congress Government would launch criminal proceedings against those responsible for the Medigadda Barrage fiasco and problems in other barrages based on the report submitted by the Vigilance Department.

Centre approves elevated corridors

The Defence Ministry has approved the proposal to construct an elevated corridor on the Hyderabad-Nagpur National Highway along Hyderabad-Karimnagar Rajiv Highway. The Defence Ministry has cleared the construction of elevated corridors across defence lands in Hyderabad.

Chief Minister Revanth Reddy met Defence Minister Rajnath Singh in New Delhi on January 5 and had appealed to the minister to permit the construction of elevated corridors across defence lands.

Responding to the CM's plea, the Centre issued permit orders for the construction of elevated corridors on Friday. The CM thanked Prime Minister Modi. the Defence Minister and officials of the Defence Department for permitting the construction of corridors which would help the development of Hyderabad city.

The CM requested the Defence Minister to allot 83 acres for the construction of a six-lane elevated corridor from Paradise

No appeal on caste or religious basis

O Don't ridicule devotee-deity relation: EC to parties

Ahead of the Lok Sabha polls, the Election Commission on Friday asked parties and their leaders to refrain from seeking votes on the basis of caste, religion and language, and not insult the devoteedeity relation or make any suggestion of a divine censure.

In an advisory warning the parties, candidates and star campaigners of stern action for any violation of Model Code of Conduct instead of the previous practice of only 'moral censure', the poll panel also said that temples, mosques, churches, gurdwaras or any other place of worship should not be used for poll propa-

ganda or electioneering. It said that the star campaigners and candidates who have received notices in past will face stern action



for repeat violation of model code. The advisory comes days before the model code is expected to come into effect with the announcement of the Lok Sabha and four state

assembly polls later this month, Chief Election Commissioner Rajiv Kumar had recently emphasised that political parties should foster ethical and respectful political discourse which inspire rather than divide, promote ideas instead of personal attacks.

It said that the star campaigners and candidates who have received notices in past will face stern action for repeat violation of model code.

The Commission's advisory has now formally set the stage for ethical political discourse and cut clutter in 2024 General Elections, an official said, adding the methodical approach to MCC violations has prepared the ground for civilised campaigning. The EC warned the parties to maintain decorum in public campaigning and put additional responsibility on star campaigners and candidates, especially those who were issued notices in the past.

10 people injured in bomb blast in Bengaluru eatery

A low intensity bomb blast at a popular eatery here on Friday left 10 people injured even as the police invoked the stringent UAPA provisions in the case. Police suspect that an improvised explosive device (IED) fitted with a timer inside a bag

overnment contracts, land, liquor, allocation Jand, Ilquoi, another of public resources, mining and leakages in welfare constitute the primary sources of corruption money for political parties in power worldwide. The siphoning of welfare funds, illegal mining and liquor trades involve many people, thus increasing the risks of exposure and generating wide negative publicity and anti-incumbency. On the other hand, insider trading of land, allocating public resources as part of quid pro quo arrangements, and illegal grants of government contracts deliver high returns with lower risks of

Of the three sources, those at the top of the ruling hierarchy prefer the third source - humongous, centralized grants of public contracts. The preference is easy to understand as it helps those at the top to enjoy the spoils

exclusively, without sharing them with others lower in the hierarchy. It delivers dual benefits -- riches for self and family and financial muscle to sustain political supremacy.

All the parties that have

ruled Telangana - independently or as part of the erst-while united Andhra Pradesh state have mastered the art of large-scale corruption with low risks. Their modus operandi has been similar. There are three essential ingredients to their recipe. Firstly, instead of retail bribery, which is risky, focus on big-ticket items that can deliver hundreds, if not thousands, of crore in returns. Secondly, centralise the decision-making so that only a few are involved, thus reducing the risk of exposure. the region's development and deliver on a long-standing demand of the people.

For a dry state like Telangana, water has been the greatest need. No wonder water has been the core reason for the decades-long separate Telangana agitation. Any project the rulers conceive to deliver on this need receives automatic public support, making it difficult for political opposition to criticise it on its merits. The egregiously corrupt rulers of Telangana, too, understood this very well. Instead of working to solve the

Congress government spent this massive amount without constructing any headworks at Tummidihatti, where the Pranahita river water needs to be stored. The Congress government was well aware that the project, as designed, would cause the submergence of 3,665 acres in Maharashtra. Yet, they went ahead with the expenditure without an agree-

ment with that state. The reason for the Congress government eagerly spending Rs 12,000 crore of public money, which is now down the drain, even before ensuring the project can become possible, is apparent.
The first government of Telangana, after the state's

formation, led Chandrasekhar Rao of Telangana Rashtra Samithi (since renamed Bharat Rashtra Samithi - BRS), outdid even the Congress government. Exploiting the faith the people of Telangana had reposed in a government headed by a Telangana bidda (son of Telangana), the TRS government committed fraud of even greater proportions on the state's unsuspecting population. Instead of negotiating a mutually beneficial agreement with Maharashtra, Chandrasekhar Rao used it as an excuse to redesign the project and escalate the cost to

Rs 1.2 lakh crore.

Vedire, in his presentation, has called out the lie the TRS government resorted to for redesigning the Pranahita-Chevella project. Firstly, he refuted the TRS lie that the Central Water Commission (CWC) estimated the water available at Tummidihatti was 67 TMC and not 165 TMC. He asserted that the CWC had always mentioned that 165 TMĆ of water was available at Tummidihatti. Chandrasekhar Roa govern-



10,392 petitions pending before Information panel

The pending Right to Information (RTI) petitions in the Telangana State Information Commission (TSIC) are 10,392 from January 2022 to February 20, 2024. According to an RTI reply, in the year 2022, TSIC has not disposed of 4,818 petitions, 5,103 petitions in 2023 and 471 petitions in 50 days of 2024.

To monitor or clear all these petitions, the commissioners have not been there for the last one year. According to an RTI reply, the last Chief Information Commissioner (CIC) Buddha Muralli demitted office on September 25, 2022. All other state information commissioners demitted

office on February 25, 2023. RTI activist and project manager of Yourti.in website Kareem Ansari said, "It has been more than one year since the TSIC is working without any commissioners. Yet the

government has not been showing any interest to appoint them. As a result, 10,392 Right to Information (RTI) files are pending since 2022. If it is continuous like this, the recruited commissioner will face a lot of difficulties to clear off the peti-

"In the Bharat Rashtra Samithi (BRS) rule, they have not shown any interest to appoint them. We hope that at least the Congress government will appoint all of them before Parliament election code and clear them off," Kareem said.

According to the Right to Information (RTI) Act, officers should give information to the applicant within 30 days from the application date. But it is not happening. It is not good, if a person gets the information after six months or one year of filing a petition. Also if the files are piling up, how could they clear backlog petitions at a time," he added.

fraudsters cheated innocent people. Mohammed Shoyab Bablu Khan had opened a bank account of shell companies where he put himself and others as proprietors and provided the same to Abdullah Farook Zhunzunya and in turn the accused used to cheat innocent people.

In a single account, total credits were found to be Rs 4.5 crore. Similarly, the accounts were involved in 42 cases in which six cases were registered in Telangana. In Hyderabad, total money defrauded in three cases is Rs 1.2 crore, one in Rachakonda where the amount is Rs 65 lakh and in Cyberabad total two cases of defrauded amount of Rs 10 lakh.

RS 86 LAKH FINGERPRINT CLONING SCAM

Two field staffers nabbed in GHMC

Two field assistants have cheated Greater Hyderabad Municipal Corporation (GHMC) of Rs 86,40,000 for the last two years by claiming the wages of absent sanitation workers. On Friday sleuths of Task Force, Central Zone team, busted the fingerprint cloning racket and apprehended two sanitation field assistants of GHMC of Amberpet Accused P division. Shivaiah Umesh and J Shivaram were claiming the salaries of absent sanitation workers by using their cloned fingerprints.



They hatched a plan to claim the wages of sanitation workers who were absent by cloning their thumb impressions. As per their plan, they prepared fake fingerprints by watching the process through YouTube. The accused persons collected 35 thumb impressions of sanitation workers out of whom 21 workers were under Shivaram with whom they had an understanding to share the wages. The accused revealed that

for last two years they have been daily claiming the wages of 20 sanitation workers who were absent for each shift. The loss to loss to the GHMC was approximately Rs 3,60,000 per month, Rs.43,20,000 for 12 months. Since both the respondents weere doing this mischief for the last two years, it comes to Rs 86,40,000 for two years. There are about 900 sanitation field assistants in 30

Shivaiah Umesh and the GHMC circles in Hyderabad remaining 14 workers under and about 24,000 sweepers and about 24,000 sweepers and public health workers are working under the two field assistants.

In all, 35 seized synthetic fingerprints and two attendance biometric devices were handed over to Amberpet police station. The case has been filed under 467, 468, 471, 419, 420, 409 IPC.

The arrests were made under the supervision of Task Force Deputy Commissioner of Police (DCP) S Rashmi Perumal, by Inspector of Police B Raju Naik, SI Ch Naveen Kumar and staff of the Central Zone Task Force, Hyderabad

Inter-State network busted from a pharma factory

In a major breakthrough on the illegal manufacturing and supply of spurious/counterfeit drugs, the joint operation conducted by Drug Control Administration (DCA), Telangana, Commissioner's Task Force, Hyderabad and Malakpet Police, dismantled an inter-State network operating from a pharma factory named Nectar Herbs and Drugs,

located in Kotdwar, Uttarakhand.

During the raid, DCA officials found three cartons containing a total of 27,200 tablets of the spurious antibiotic "MPOD-200 Tablets" (Cefpodoxime Proxetil and Lactic Acid Bacillus Tablets), worth Rs 7.34 lakh. These tablets were labeled as manufactured by Meg Lifesciences, Khasara No. 47/5, Palli Gaon, Distt. Sirmour, 173 001,' which is a fictitious/non-existent company

A person named Aravapalli Satyanarayana was caught selling the spurious drug stocks to Vangari Naveen near Moosarambagh X Roads.

Upon enquiry, he revealed that he had purchased the spurious medicines from Gandla Ramulu of Meerpet. Officers apprehended Aravapalli Satyanarayana, Vangari Naveen, and Gandia Kamulú.

During interrogation, Gandla Ramulu revealed that the spurious drugs were received from Vishad Kumar of Kotdwar, Uttarakhand. He further disclosed that Vishad Kumar manufactures spurious drugs at his company, Nectar Herbs and Drugs, located at Kotdwar, Uttarakhand, along with a person named Sachin Kumar. Ramulu admitted to placing orders for spurious drugs to Sachin Kumar and Vishad

Kumar through WhatsApp calls. The officers kept vigil on the manufacturing facility of Nectar Herbs and Drugs located at Plot No. B-19, IIE, SIDCUL, Sigaddi, Kotdwar, Pauri Garhwal District, Uttarakhand. A surprise raid was conducted on February 29, during which the manufacturing of counterfeit/spurious Cefixime Tablets IP 200 mg, falsely claimed as Omnicef-O 200 Tablets,' was detected. The drug was falsely labeled as manufactured by Aristo Pharmaceuticals Pvt. Ltd., bearing Batch No. Batch No. BPF232040, Mfg. Date: June-2023, Exp. Dt. May-2025.

The manufacturing of spurious drugs was being carried out by Sachin Kumar of Roorkee, Uttarakhand. He brought fake labels (pre-printed aluminium foils and other packing materials) of reputed companies to Nectar Herbs and Drugs in Kotdwar, Uttarakhand, in his vehicle along with three workers.

Sachin Kumar and Vishad Kumar, who are the prime accused in the spurious drug manufacturing case, were apprehended by the special team.

The top eight international check posts for foreign tourist arrivals in city were Delhi airport, Mumbai airport, Haridaspur land check post, Chennai airport, Bengaluru airport, Hyderabad airport, Cochin airport, and Kolkata airport, the survey revealed. Meanwhile, the rise in the number of domestic tourists visiting the city that started in 2012 continued till 2019 and then saw a dip -- owing largely to COVID

Rise in unauthorised structures due to policy flaws

PNS NEW DELHI

Observing that urbanisation policies have flaws, the Supreme Court has said one of the main reasons for spurt in unauthorised constructions is the government's failure to provide people with affordable houses.

Acknowledging that the right to have a roof over head is a fundamental right, the top court said there is a huge gap in the policies between the requirements of the economically weaker sections and what the government was doing at the ground level.

The observations by a bench of Justices Sanjiv Khanna and Dipankar Datta came while hearing a case relating to demolition of commercial and residential units in Lucknow's Akbar Nagar where it imposed an interim stay on demolitions.

"Let us be clear on housing. There's a difficulty. Our urbanisation policies have flaws. Really speaking, we have not provided for economically weaker sections. Somewhere,

we will have to ensure Everyone knows that migration takes place to the cities. But there is a huge gap in the policies between the requirements and what we are able to do at the ground-level.

"Why are there so many unauthorised colonies in Delhi? Because DDA (Delhi Development Authority) does not even know where 60-70 per cent of the land is. All has been acquired," the bench observed.

33% RS members have declared criminal cases against themselves

■ Their total assets stand at Rs 19,000 cr: ADR

Of 225 Rajya Sabha sitting members analyzed, 33 per cent have declared criminal cases against themselves while the total assets of these sitting MPs stood at Rs 19,602 crore, according to poll rights body

Also, 31 of them or 14 per cent are billionaires.

The Association for Democratic Reforms (ADR) also showed that 18 per cent of these parliamentarians have declared serious criminal cases which include instances of murder and attempted murder.

In an analysis conducted by the ADR and National Election Watch (NEW), two Rajya Sabha sitting members have declared cases related to murder under IPC section 302, while four MPs have declared cases related to attempt to murder under IPC Section 307.

"Out of the 225 Rajya Sabha sitting MPs analysed, 75 (33 per cent) Rajya Sabha sitting MPs

against themselves and 40 (18 er cent) Rajya Sabha sitting MPs have declared serious criminal cases," the report said.

The analysis also delved into the distribution of these criminal cases across different political parties.

The BJP leads with 23 per cent of its 90 Rajya Sabha members having declared criminal cases against themselves.

The Congress follows closely behind with 50 per cent of its 28 MPs facing similar charges. The ADR analysis said five

(38 per cent) out of 13 Rajya Sabha members from TMC, four (67 per cent out of six members from RJD, four (80 per cent) out of five MPs from CPI(M), three (30 per cent) out of 10 MPs from AAP, four (36 per cent) out of 11 Rajya Sabha members from YSRCP and two (20 per cent) out of 10 MPs from DMK have declared criminal cases

against themselves in their affidavits.

LANCET STUDY UNVEILS

From undernutrition to obesity: Double whammy for India

India is grappling with a profound nutritional shift, as highlighted by the latest Lancet study, with nutritionists attributing this "double whammy" of undernutrition and obesity to a dual challenge: inadequate consumption of quality foods and easy access to cheap, unhealthy

alternatives. The Lancet study, published on Thursday, found that in India, nearly 44 million women and 26 million men were obese in 2022, respectively.

The analysis by the NCD Risk Factor Collaboration (NCD-RisC) - a global network of scientists - and the World Health Organization (WHO) also found that about 12.5 million children aged between five and 19 were overweight in 2022. These numbers are up from

2.4 million and 1.1 million in 1990 for women and men, respectively, while for children, the baseline number was about 0.4 million," said study coauthor Guha Pradeepa, from Madras Diabetes Research Foundation (MDRF), Chennai,



told PTI.

Reacting to the study findings, nutritionist Sudha Vasudevan, who was not

involved in the study, noted that while good quality foods are nutrient-dense like fruits and vegetables, unhealthy foods are usually processed, containing high-fat, sugar, salt, and refined carbohydrates.

"We had not vet won the war against undernutrition-related health problems, but now we are additionally burdened by those coming from overnutrition or obesity, and resembling the developed nations in that sense," Vasudevan, Senior Scientist and Head of the Department of Foods & Nutrition Research,

MDRF, told PTI. The findings suggest trends of an "epidemiological and nutrition transition" of India, Vasudevan said.

While the developed countries might be economically equipped to deal with obesity and related healthcare burden, India is not and therefore, we are struggling," she said.

The Lancet study looked at body mass index (BMI) to understand how obesity and underweight have changed worldwide from 1990 to 2022. It analysed the weights and heights of over 220 million people aged five years or older, from across more than 190 countries.

The findings also highlighted a major shift in lifestyle over the past decades, including lack of exercise and healthy food, said Pradeepa.

The study found that the adult obesity rate in India increased from 1.2 per cent in 1990 to 9.8 per cent in 2022 for women, while for men, it rose from 0.5 per cent to 5.4 per

Pradeepa attributed the spike in obesity rate to a combination of biological and social factors.

India's leopard population surges despite facing challenges from humans and Nature

mid rising environmental and human-animal conflict challenges, India's leopard population has recorded an increase to reach the enviable count of 13,874. This rise underscores the resilience of these magnificent creatures and the success of conservation efforts in our country. Leopards in India inhabit diverse landscapes, from dense forests to even urban areas. However, this proximity to human settlements often leads to conflict as leopards venture into villages in search of food or territory, resulting in attacks on livestock and occasionally on humans. Such encounters pose a significant threat to both leopard populations and human communities. Climate change exacerbates these challenges by altering natural habitats and prey availability. Besides, forest fragmentation, loss of biodiversity and other changes contribute to the stress on leopard populations. Besides, poaching is a lucrative business and many influential people engage in it by employing locals while themselves remaining anonymous; they must

be identified and brought to book. Despite these adversities, the surge in India's leopard population can be attributed to various factors, including conservation initiatives and stricter wildlife protection laws.

The Government and non-governmental organisations (NGOs) have been actively involved in habitat preservation, anti-poaching efforts and raising awareness among local communities about leopard conservation. Techniques such as camera trapping and satellite tracking provide valuable insights into leopard behaviour, habitat usage and population dynamics, aiding conservation strategies. Community-based conservation approaches have shown promising results. Engaging

local communities in conservation efforts fosters a sense of ownership and responsibility in them. To ensure the continued growth of leopard populations, there is a need for concerted Government efforts. Though the rise in leopard population is welcome, it cannot be at the cost of human lives. Awareness campaigns must be launched in leopard-inhabited areas about their behaviour, conservation importance and conflict prevention strategies. Low-cost innovative ways can be employed so that human lives are not lost: In Sundarbans, for example, they wear masks at the back of their heads to dodge the Royal Bengal Tigers. Then there is an immediate need to strengthen habitat conservation efforts, including reforestation, establishment of wildlife corridors and curbing human encroachment into natural habitats. There is also a need to dispel the misconceptions that rural communities are hostile towards animals; they have been living with wild animals for centuries. Law enforcement agencies must rigorously enforce wildlife protection laws to combat poaching, illegal wildlife trade and habitat destruction. Collaborating with international organisations and neighbouring countries to address transboundary conservation issues will also help. We need a new wildlife policy that takes into account the prevailing conditions and balances human-animal interests.

CHERISH THE INSTRUCTIONS OF GOD

The verses of the Bhagavad Gita offer profound insights into life's purpose

et me start with verse # 3.8 of the Bhagavad Gita, which is, "You should always do your duty. Because action is superior to inaction. Maintenance of the body will also not be possible through inaction." We all know what our duties are according to time, place and circumstances. We also know that neglecting our duties impacts our maintenance. For example, a student does not pay attention to his studies. What happens subsequently? He finds it hard to maintain himself. For whose benefit was this verse spoken?

Let me take another verse, which is very famous. I am referring to verse #2.47, which goes like this, "You have a right only in action, not ever in predetermining fruits. You should not speculate about the fruit of action; your attachment to inaction also should not be there." For whose benefit was this verse spoken? Do we have any other right except to do our duties? And we must not neglect to do them. As regards the results of our actions, the right to decide them has been kept by God with Himself. The third verse chosen by me is very telling, in which Lord Krishna promises, "People who worship Me with undivided attention, meditating on Me, for these regular practitioners of yoga, I help in getting what one does not have and provide security of what one has." Verse after verse the Lord is cajoling us to do what will fulfil all our desires, which are according to dharma. God couldn't be a party to anything against dharma. Could He? The fourth verse in this connection is: "Where there is yogeshwara Shri Krishna and where there is Arjuna (meaning us), there will be opulence, victory, wealth and morality." (18.78) What are our desires generally? That we should succeed in our endeavours. We would if we were aiming for what is according to morality, i.e. dharma. The same is about



wealth. Don't we need enough resources for our maintenance? Not only wealth, there will be 'saubhagya' (good fortune). Who benefits from all these? We do; God doesn't because He is complete in all respects. (3.22) The next verse is about gaining peace and a perfect destination. Lord Krishna instructs, 'In all respects, take My shelter only. By My mercy, you will achieve supreme peace and the eternal abode.' What is it that we lack after gaining material needs, comforts, etc.? It is peace, which is what God is promising. Not only that, God is also assuring eternal abode, which is free from the defects of this material world. How nice it will be to not be subjected to repeated birth and death? God is pre-

God is always wanting to give. He has so much to give if we become deserving. Isn't that fair? How do we become deserving? Lord Krishna describes, 'Develop My consciousness; become My devotee; make sacrifices for Me; and offer obeisance to Me.' (18.65) One may feel that all these activities relate to God. Yes, they do but do they benefit Him? No, far from it; they only purify our existence. And God had to set some conditions to qualify for His special favour. How else was He to reward anyone? Just focus on how easy they are to do.

I will take up one more verse, which is, 'Having My consciousness, you will cross all impediments by My grace.' (18.58) This is quite an amazing offer from God. Aren't we all struggling with one problem or another throughout our lives? We do, but our ego comes in the way. We are not prepared to accept that somebody can be superior to us and to such an extent that we have to take His shelter and His alone. (18.66) We would rather suffer but won't do as instructed by God. Do we realise that our acts will benefit the world if we obey God's instructions? We will become better persons by following dharma - the rules for proper behaviour. We will fit in the System created by God, which is required for the creation to exist eternally.

MSP methodology and farmer demands



Questions arise about the rationale and implications of adopting Dr Swaminathan's proposed methodology for MSP calculation



o-terminus with the legal guarantee for Minimum Support Price (MSP) for all crops, another demand raised by the farmers relates to how the MSP is fixed. They want it to be calculated based on the recommendations of the National Commission on Farmers (NCF) under Dr MS Swaminathan

All along, the Commission for Agricultural Costs and Prices (CACP) a statutory body under the Ministry of Agriculture & Farmers Welfare – has been setting MSP at the level of the so-called comprehensive cost or C2 cost. C2 is arrived at by adding three components viz. A2 covers all paid-out expenses, both in cash and in kind, incurred by farmers on seeds, fertilizers, chemicals, hired labour, fuel and irrigation; FL is the imputed value of unpaid family labour; and rental value of owned land and imputed cost that would be incurred on owned fixed capital assets (OFCA) call it to return on assets or RoA.

Put simply, MSP is equal to A2 + FL + RoA. It takes care of all the costs incurred by the farmer for growing the crop – both paid out and own - besides including an element of profit i.e. RoA. That is why it is bandied as 'comprehensive'. The formula was used for determining MSP till FY 2017-18. The Government normally accepts recommendations made by CACP.

In its fifth report submitted in October 2006, the NCF recommended that MSP should be "at least 50 per cent more than the weighted average cost of production". The recommendation did not specifically mention what 'measure of costs' would be used. However, Dr Swaminathan clarified: "When we recommended 50 per cent over costs, we meant complete costs called C2, which includes all assumed

Can the clarification given by him many years after the report was finalized and submitted be taken to mean that the Commission had meant it that way? A recommendation emerges from deliberations and is based on consensus among

members. This also applies to a clarification given on an important aspect of the recommendation. That would not have been possible as you can't expect Dr Swaminathan to go back to other members and check. The big members and check. The big question is: Is giving the farmer at least 50 per cent more than the 'C2' costs logical?

The purported rationale for giving 50 per cent extra is that she should get a handsome profit after covering all paid out costs.

Profit as it is understood in business parlance is essentially meant to give a return to the owner for her invested capital. In the case of a farmer, her investment in crop growing business is by way of 'land' and 'OFCA' besides her THE NCF labour. But, remuneration/return RECOMMENDED for all these is already incorporated under C2. To give a feet ed under C2. To give a further sweetener (read: 50 per cent profit) over and above these would be illogical. Let us understand this with the help of an example.

In the case of paddy, the all-India weighted average A2 cost for the 2017-18 Kharif season, as estimated by the CACP, was Rs 840 per quintal; A2+FL cost: Rs 1,117 per quintal and C2 costs: Rs 1,484 per quintal. In the total cost of Rs 1,484 per quintal, the amount going towards the farmer's income was Rs 644 per quintal (1484-840). Of this, Rs 277 per quintal (1117-840) was for FL and Rs 367 per

If one were to go by NCF recom-MENTION WHAT mendation as clarified by Dr 'MEASURE OF Swaminathan, the farmer would COSTS' WOULD BE have to be given Rs 742 per quintal (0.5x1,484) in addition to an income of Rs 644 per quintal already built into C2 thus taking the total to Rs 1386 for each quintal of paddy. This translates to 93 percent of C2 costs. Taken as a proportion of the revised MSP of Rs 2226 per quintal, this will be 62

per cent. Where does one get such a fantastic return? This is happening because the

farmer is being remunerated twice over first under C2 and then a further profit of 50 percent. Furthermore, the way profit is calculated '50 per cent of C2', you end up giving a 'return on return': RoA component under C2 being Rs 367 per quintal, she gets a fortuitous gain of Rs 183.5 (0.5x367). Unequivocally, there is a flaw in

the above method. Either, the government should continue with the extant method of using C2 for fixing MSP. On the other hand, if, it wants to go for 50 per cent profit, then this should be applied only to the paid-out costs namely A2. In other words, MSP should be set at A2+FL plus 50 per cent of A2. On this basis, in the above example, the MSP would be Rs 1537 per quintal (1117+0.5x840).

What did the Modi – government

In its poll manifesto for 2014, the BJP had promised to implement NCF recommendations on MSP. The announcement in this regard was made by the then Union Finance Minister Arun Jaitley in his Budget speech for FY 2018-19. Later, while replying to a debate in Parliament, Jaitley clarified that 'the production cost would be taken as actual paid A2 plus FL'. In other words, it decided to set MSP at A2+FL plus 50 per cent of A2+FL; it comes to Rs 1675 per quintal (1117x1.5).

The formula adopted by the incumbent government also suffers from a flaw to the extent that 'it also adds return on the imputed cost of family labor' which is unjustified. Have received wage/income for the work done on the field, how can a farmer also market reforms which alone can earn a profit on it? In the above help farmers get a good price. example, this fortuitous amount is Rs 138 per quintal (277x0.5).

Moreover, the very approach of the Dr Swaminathan committee of arriving at a profit by taking a percentage of the cost is susceptible to sharp increases in payments to farmers. With every rupee increase in the cost, farmers' profit will increase by 0.5 rupees. At present, most of the agricultural inputs are subsidized. On fertilizers, there is a massive subsidy (urea is sold at about 1/10th of its cost). If the subsidy is slashed leading to a steep rise in the cost of fertilizers, the formula will give an unwarranted bonanza to the farmers by a corresponding increase in profit. At a fundamental level, profit is meant to reward an entity for the capital invested in any enterprise. This is precisely what was being done before the FY 2018-19. That formula (read: C2 for fixing the MSP) ought to have een continued.

The MSP setting exercise suffers from another aberration. The cost of producing a crop varies from place to place depending on the soil conditions, weather, irrigation, price of inputs and so on. However, to arrive at MSP, the CACP takes the 'weighted average' (WA) cost of production. When the price determined in this manner is given to all farmers, those producing at a higher cost stand to lose whereas others with lower cost make a fortuitous gain.

Today, the government is trapped in the vicious cycle of having to procure farmers' produce at everincreasing MSP, now under pressure to pick up 'all of it' at MSP which can denude the exchequer. This, in turn, is because it is trying to substitute the role of the market. It should disentangle from this trap and focus on agri-

GST mop-up grows 12.5% to over Rs 1.68 lakh cr

he GST collection in February grew 12.5 per cent to over Rs 1.68 lakh crore, buoyed by domestic transactions, the finance ministry said on Friday. The total gross GST collection for the current fiscal (April 2023-February 2024) stands at Rs 18.40 lakh crore, 11.7 per cent higher than the mopup for the same period last fiscal.

The average monthly gross collection for the current fiscal stood at Rs 1.67 lakh crore, exceeding Rs 1.5 lakh crore in the last fiscal. "Gross Goods and Services Tax (GST) revenue collected for February 2024 is Rs 1,68,337 crore, marking a robust 12.5 per cent increase compared to that in the same month in 2023." the ministry said in a statement. This growth was driven by a 13.9 per cent rise in GST from domestic transactions and an 8.5 per cent increase in GST from import of goods.



Maruti's total sales rise 15% to 1,97,471 units

aruti Suzuki India on Friday said it has reported a 15 per cent year-on-year increase in total wholesales at 1,97,471 units in February. The company had dispatched a total of 1,72,321 units in the same month last year, Maruti Suzuki India Ltd (MSIL) said in a statement. The total domestic passenger vehicle sales grew 9 per cent at

1,60,271 units as against 147,467 units in the month a year ago, it added. Sales of mini segment cars, comprising Alto and S-Presso, declined to 14,782 units as against 21,875 units in February 2023. Sales of compact cars including Baleno, Celerio, Dzire, Ignis, Swift, Tour S, and WagonR, also declined by 10 per cent to 71,627 units as compared to 79,898 units in the year-ago month. Utility vehicles, including Brezza, Ertiga, Grand Vitara, and XL6, recorded sales of 61,234 units last month, growing 82 per cent.



GDP growth in FY24 likely to be within striking distance of 8%

The GDP growth for the current financial year could be within striking distance of 8 per cent, a study by the State Bank of India (SBI) said on Friday, a day after India posted an 8.4 per cent growth in the December quarter, and revised upwards the estimates for the preceding two quarters.

"The third quarter GDP

numbers jolted the psyche and cognitive framework of most in markets, while sweeping some by a pleasant surprise. Clearly, right policy prisms and perspectives can trump irrational expectations bordering fault lines," SBI said in its research report 'Ecowrap'.

It noted that defying all estimates, the economy grew 8.4 per cent in the third quarter of 2023-24 after exhibiting more than 8 per cent growth in the preceding two quarters.

The buoyancy in indirect tax mop-up (32 per cent year-onyear growth), gap between

Gross Domestic Product (GDP) and Gross Value Added (GVA) growth widened.

"For fiscal 2023-24 GDP growth is expected to increase 7.6 per cent and GVA growth fourth quarter GDP growth at 5.9 per cent, which we believe is an understatement. Thus it is most likely that FY24 GDP growth could be within striking distance of 8 per cent," the SBI study said.

The National Statistical Office (NSO) has revised GDP estimates for the first and second quarters of this fiscal to 8.2 and 8.1 per cent from 7.8 per cent and 7.6 per cent, respec-

With the revisions, the GDP growth during April-December works out to be 8.2 per cent.

The SBI report further said with the government's efforts to ensure quality of life for all citizens and stopping leakage of benefits through direct benefit transfer, for the first time the per capita GDP at current prices crossed Rs 2 lakh mark in 2023-24.

In constant prices, too, per capita GDP has increased to Rs 1.24 lakh in the current fiscal.

Coal-producing states earned a revenue of Rs 1.52 lakh crore in the last nine years from royalty, District Mineral Foundation (DMF) and National Mineral Exploration Trust (NMET).

State-wise and year-wise data indicate that the coal mining sector is a very significant contributor to the revenue of states including Jharkhand, Chhattisgarh, Odisha and Madhya Pradesh, the Coal Ministry said in a statement.

"During 2014-2023, total revenue from royalty, DMF & NMET of all coal-producing states through coal mining sector is Rs 1,52,696 crore," the ministry said.

The compounded annual growth rate (CAGR) of the revenue from coal mining during 2014-2023 was 13.80 per cent, it said. Coal mining sector has proved to be a big booster for economic growth of the states that produce fossil fuel.



State governments are entitled to receive 14 per cent of royalty on the sale price of coal and 30 per cent of the royalty as contribution towards the proposed district mineral foundations (DMFs)-- which is meant to support project-affected people---and 2 per cent of NMET from dry-fuel produced by the coal companies and also the private sector.

FIU imposes Rs 5.49 cr fine on Paytm Payments Bank

Financial Intelligence Unit-India (FIU-IND) has imposed a Rs 5.49 crore penalty on Paytm Payments Bank for violating anti-money laundering rules, the Finance Ministry said on Friday.

FIU-IND initiated a review of Paytm Payments Bank on receipt of specific information from law enforcement agencies in respect of few entities and their network of businesses engaged in a number of illegal acts, including organising and facilitating online gambling.

The money generated from these illegal operations, i.e. proceeds of crime were routed and channelled through bank accounts maintained by

these entities with the Paytm Payments Bank Ltd, the ministry said.

"The Financial Intelligence Unit-India (FIU-IND),... has imposed a monetary penalty of Rs 5.49 crore on Paytm Payments Bank Ltd with reference to the violations of its obligations under the PMLA (Prevention of Money Laundering Act)," the ministry

The FIU passed its order imposing the penalty on February 15.

The FIÚ action follows RBI's January 31 directive barring Paytm Payments Bank from accepting fresh deposits or credits in the accounts of its customers from February 29. The date was later extended to

'Lift export ban on de-oiled rice bran'

Edible oil industry body SEA on Friday demanded the government to lift the export ban on De-oiled Rice Bran (DORB), saying the curb has not brought down milk prices and exporters.

The government imposed a ban on the export of DORB in July 2023 for four months and later extended it till March 31 this year to address inflation in milk prices.

Extractors Association of India (SEA), in

Minister Pivush Goval and Animal Husbandry, Dairying and Fisheries Minister Parshottam Rupala, requested the government to lift the export ban on DORB

"This export restriction on 2023 to ease the milk prices, however, we have seen almost no reduction in milk prices across the country since this ban. This is because the cost component of DORB in milk price is very nominal," the SEA representation said.

"We are still of the view that continuing this ban will not support the reduction in milk prices but will continue to negatively impact the Rice Bran processors and DORB exporters," it added.

Forex reserves jump by US\$ 2.975 bn to US\$ 619 bn

India's forex reserves jumped by USD 2.975 billion to US\$ 619.072 billion for the week ended February 23, the Reserve Bank said on Friday.

In the previous reporting week, the overall reserves had dropped by US\$ 1.132 billion to US\$ 616.097 billion. For the week ending

February 23, the foreign currency assets, a major component of the reserves, increased by US\$ 2.405 billion to US\$ 548.188 billion.

Expressed in dollar terms, the foreign currency assets include the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves. Gold reserves increased by US\$ 472 million to USD 47.848 088 billion during the week, the RBI said.

Delhi per capita income rises by 22% to Rs 4.61 lakh

Delhi's per capita income increased by 22 per cent in two years to Rs 4.61 lakh in 2023-24, Finance Minister Atishi said on Friday while projecting a 9.17 per cent economic growth for

the current financial year. Tabling the Economic Survey for 2023-24 in the Assembly, the Delhi finance minister said the city's economy has grown at a record pace despite hurdles created by the Centre, LG and officers in the work of the Kejriwal government.

Atishi said that the Gross State Domestic Product (GSDP) of Delhi at current prices is likely to reach Rs 11,07,746 crore in 2023-24 with a growth of 9.17 per

"The GSDP of Delhi in 2022-23 was Rs 10,14,000 crore. In post-COVID times, our real GSDP grew at 8.76 per cent in 2021-22

and 7.85 per cent in 2022-23, faster than the rest of the country," she said.

Delhi's contribution to the national GDP is nearly 4 per cent despite its population being just 1.5 per cent of the

'My goal is for motorsport races to arrive in Hyderabad and then spread like wildfire'

ankanala Sports Group was thrilled to announce INDE Racing as a new team for the 2024 FIM E-Xplorer season, after the news that KSG and FIM E-Explorer have inked an exclusive nine-year collaboration to manage races in India. At the recent FIM e-xplorer World Cup, INDE Racing— India's first-ever FIM-licensed team, having its roots in Hyderabad somewhatsoared to unprecedented heights on the global scene. The founder of INDE Racing and Kankanala Sports Group, Abhishek Reddy Kankanala, a *pakka* Hyderabadi, stated that they have always missed a competitive independent team to cheer for, despite the growing interest in motorsports! In an exclusive interview with us for the special weekly column, hoping to innovate, advance sustainability, and foster gender equality in addition to setting new standards for racing in Hyderabad and across the country, everything that the interviewee with Hyderabadi roots has to sav is heard.

In an interview with us, the spokesperson recalled, "With badminton, volleyball, and handball, what I have been doing over the last few years is to bring some kind of attention to overall sports in Hyderabad and across." Much to your surprise, he actually lost his voice while cheering for the team and yet continues to go on, "Better images of sports viewers should be posted on social media and on television! In Hyderabad, we make sure that the volleyball court has over twenty cameras so that the sport appears seductive. I really do mean it. I am attempting to compete with how European volleyball is seen in my mind. This year, I hope our league will be the most watched worldwide. Thus, nothing has transpired overnight; Hyderabad's handball leagues were the starting point. Despite not owning a team, I keep in close contact with every player so that I can now provide them with a global platform. This is the moment when motorsports become relevant?

"I couldn't see any motorsports team representing our country until I arrived," he said in great detail. "Although Hero and TVS are manufacturing teams, their registration is not in India. That, in a way, inspired me to think that we ought to be represented globally as well. Although I was quite active in organising small-scale events in Hyderabad, my goal was to work on a larger scale. We stand for equality as well! I even worry a lot about not being selected

for a factory team, which is why INDE."
He acknowledges, "Most of my synergy, whether it's with the Black Hawks or Telugu Talons, is always in tandem in Hyderabad city. Because I am from Hyderabad, I'll use that connection to host it in my hometown one day. That is what I am anticipating from the first race that will take place shortly. My goal is for these races to arrive in Hyderabad and then spread so that the general public may learn more about them. Let's witness it live, starting with a crowd in Hyderabad. Forget about reading about it in the papers or watching it on television. Even though the state government hasn't given its approval yet, Hyderabad should be the first location to start. Everything also

depends on the government's backing."
With this news, India will have its firstever FIM-licensed squad and participate in its first-ever legally sanctioned international competition. It's so thrilling! "I own this, so we are bleeding Hyderabad," he went on (he grins). "Despite having spent nearly twenty years abroad, I still prioritize I worked in Canada, but despite my success there, my heart was still in Hyderabad. I made the decision to return to the city with my family. I have been living in Hyderabad for almost twelve happy years. It is the best city in the world, and I say this with certainty. Mumbai and Delhi used to be fierce rivals to our city, but circumstances have changed, and Hyderabad is growing in new and interesting ways. The way things have changed has been so great that we are happy to show visitors our city." He adds, "I always feel a con-

nection with the Hyderabadi journalists who show me so much love. I can see that the Hyderabadi media takes great pride in promoting sports around the nation. It is evident in the way people write or talk about my endeavours. I am not sure how, but print media somehow inspires me. However, you also have to appreciate Hyderabad's smalltown charm."

"I have travelled to nearly twelve nations in the past two months. Japan's cultural display, for instance, was breath-taking, but I can only picture myself residing in Hyderabad. I have no reservations about who I am as a Hyderabadi; I totally embrace it," with a warm note, Abhishek Reddy Kankanala concluded the

ashup's have undeniably been a favourite of many and a go-to music lately that just mixes up two different moods, two similar moods, or whatever. And that is where we have the talented musician and mashup artist Gravero onboard with us, sharing his inclination towards music, mashups, and a lot more. Well, there's really interesting news for all the music lovers at the end of this interview. So, keep yourself hooked on your couch and give it a read.

His inclination towards music began at a young age, inspired by a deep appreciation for its ability to create connections. Growing up, he found comfort in various genres, which ultimately led him to pursue a career in music. "I'm drawn to the unlimited creative possibilities music offers, allowing me to express myself authentically and connect with others on a deep level. Whether it's through composing, remixing, or collaborating with fellow artists, music has always been a powerful means of selfexpression and communication for me," shares the talented artist. Before we go ahead, what's it with Gravero—the name we mean? So, picture this: "I started out as 'Master-B'-yes, I know, not the best choice. And it led to some awkward teasing. So, I decided it was time for a change. While brainstorming with a friend, we came up with 'Graver', but then I thought, 'Nah, that's not quite me anymore.' So, I threw in an 'O' and voila, 'Gravero' was born! It doesn't have some deep meaning behind it. I just thought it sounded cool, plus it's a bit of a nod to how my music gravitates towards different genres. I feel like sometimes you just have to go with what sounds

right, even if it's a made-up word."

Interesting one, Gravero! Well, talking about his mashup, he has always focussed on storytelling. Instead of just blending two songs in the same key, he picks tracks that fit together like pieces of a puzzle. It's all about creating a musical saga where each song serves as a chapter in the story. By mixing different elements from each track, he takes his listeners on a journey that keeps them engaged and wanting more.

"My process is pretty organic," says the musician. "I listen to a ton of music, like, all the time. When a track really clicks with me, it's like my brain instantly starts humming along, coming up with melodies that fit with it or are inspired by it. From there, I get into blending these melodies with the original track. If it sounds good together and captures the vibes I'm going for, I move on to the next steps, which are mixing, mastering, and maybe even creating a video to go along with it." But again, here's the thing he's not just about the music. Before I even start working on a mashup, I make sure to watch the movies asso-

You have to match the keys, tempos, and rhythms just right, while still keeping the essence of each song intact. Former England captain Michael Vaughan feels England have discovered a "world-class superstar" in young off-spinner Shoaib Bashir, who has the skills to emulate the success of India's Ravichandran Ashwin.

Despite England's five-wicket loss in Ranchi, 20-year-old Bashir, playing only his second Test, impressed as he returned with a match haul of eight wickets. His magnificent performance included a five-wicket haul in the first innings. Ashwin, on the other hand, is regarded as one of the best off-spinners in the history

of Test cricket. The senior spinner recently became only the second Indian bowler to snare 500

wickets in the longest format and is set for his 100th Test in Dharamsala next

week against England.

Women's red-ball cricket will return to India's domestic calendar after six years when the BCCI conducts a Senior Inter Zonal Multi-Day Trophy in Pune from March 28.

The move comes after the Indian women's team's return to Test cricket. The side has played Tests against Australia and England in the recent years. Domestic red ball cricket for women was last

held in 2018. "It is a welcome step taken by BCCI. The national team has started playing Test cricket again and we need the next generation of cricketers to play red ball cricket at the domestic level," former India pacer Amita Sharma told PTI. "I would also want red ball to be played at the state level and not just zonal level. Back in the day we had both those events," she added.

The Maharashtra Cricket Association will be hosting the tournament which will feature six teams, representing East, West, North, South, Central, and North-East zones.

They will be competing in a series of five matches to be played across three days each, which is a day more than the two-day games played in the 2018 season.

The tournament will begin right after the ongoing Women's Premier League, which ends on March 17. It will start with the

quarterfinals between East Zone and North East Zone and West Zone and Central Zone on March 28 with the semifinals slated on April 3.

They were the 12th and 13th wickets to fall in the day which mostly had not gone New Zealand's way.

First, New Zealand needed more than a full session to claim one wicket and end Australia's first innings. In that time Cameron


