Scientists find new drug to ...

Scientists have found a new way in which Ebola reproduces in the human body, identifying a potential target for drugs to prevent the viral disease. The study also sheds light on how the deadly virus that affects people mostly in sub-Saharan Africa interacts with a human protein called ubiquitin. "We used a combination of experimental and computational (using computers) methods to investigate the interaction between the Ebola virus VP35 protein and ubiquitin chains," said study coauthor Rafael .



Women hiring from campus grows

There has been a 5 percentage points increase in campus hiring of women in 2022-23, compared to the previous year as companies in India are keen on inclusivity and diversity in the workplace, a report said on Monday. In FY23, 40 per cent of the fresh talent hired from college campuses were women, up from 35 per cent in the previous year, AI-powered recruitment automation firm HirePro said in the report. ELECTORAL BONDS Disclose complete details by March 21 APEX COURT DIRECTS SBI

In a third tongue-lashing to the State Bank of India, the Supreme Court on Monday told it to stop being "selective" and make "complete disclosure" of all details related to the electoral bonds scheme by March 21. The apex court said the details to be disclosed include the unique bond numbers that would reveal the link between the buyers and the recipient political parties.

A five-judge Constitution bench headed by Chief Justice of India D Y Chandrachud said there is "no manner of doubt that the SBI is required to make complete disclosure of all the details" which are in

its possession. The bench, also comprising Justice Sanjiv Khanna, Justice B R Gavai, Justice J B Pardiwala and Justice Manoj Misra, said the Election Commission shall forth-

directions. Last Friday, the SC admonished SBI for furnishing incomplete information and issued a notice to the bank to explain the reasons for the non-disclosure of unique alphanumeric numbers







Poll code poses problem for farmers in withdrawing money from banks

The Model Code of Conduct is posing a problem for farmers in withdrawing money deposited by rice millers towards the sale of their farm products.

As the millers credit the money into the farmers' bank accounts, farmers living in remote villages are forced to travel all the way to the towns and cities to withdraw the money.

The farmers should show proof of carrying more than Rs 50,000. There were instances of officials confiscating the amount even after showing proof during the last Assembly elections. Due to the Model Code of Conduct, the millers are prohibited from paying

The farmers have been appealing to the poll officials to accept the bills given by the rice millers and not to seize the money from farmers.





Scientists have found a new way in which Ebola reproduces in the human body, identifying a potential target for drugs to prevent the viral disease.

The study also sheds light on how the deadly virus that affects people mostly in sub-Saharan Africa interacts with a human protein called ubiqui-

tin. "We used a combination of experimental and computational (using computers) methods to investigate the interaction between the Ebola virus VP35 protein and ubiquitin chains," said study co-author Rafael Najmanovich, a profes-

Montreal in Canada.

"Advanced computational modeling by our team predicted the binding interface between a viral protein, VP35, and the ubiquitin chains in human cells, and identified potential chemical compounds that could disrupt this interaction," he said.

Ebola is a type of viral hemorrhagic fever caused by several species of viruses from the enus Ebolavirus. Symptoms of

Ebola start out flu-like but can progress to severe vomiting, bleeding and neurological (brain and nerve) issues.

The finding, published in the journal PLOS Biology, not only deepens our understanding of how the virus works, but also sor at the University of offers a promising avenue for



the creation of more effective the researchers said. therapies, the researchers said.

Understanding the intricate processes by which the virus replicates within the human body is essential for developing effective treatments, they said. The latest study unravels some of the molecular intricacies of Ebola virus replication, process. The researchers were able to clarify structural and functional aspects of viral and human proteins interacting in manner critical for viral replication.

One of the key findings of the study is the identification of one additional interaction for VP35, a multifunctional viral protein which plays a central role in viral replication. The study revealed insights

into the intricate interplay between Ebola virus and the host immune system.

By evading detection and subverting host defences, the virus is able to establish a foothold within the body, leading to unchecked replication shedding light on key proteins and severe disease progresand pathways involved in the sion.

Pursuit of power

The Russian President is anxious to prove that he actually is his people's choice for the top job

he enigmatic Russian President, Vladimir Putin, has a reputation for having a tight hold on power. Beneath the surface of power, meanwhile, is a convoluted web of manoeuvres designed to validate his administration via elections. Putin has consolidated his control and maintained the impression of popular support despite criticism for being an authoritarian and charges of electoral manipulation. A case in point is the latest crowding of polling stations by Russian nationals as a way of protest during the three-day voting which ended on Sunday. Manipulation of electoral laws and institutions is seemingly one of Putin's most favoured instruments. The Russian leadership has put policies into place over time that essentially silence critics and obstruct real political rivalry. Putin and his associates benefit from selective enforcement of electoral restrictions, skewed media coverage and stringent registration requirements. It is possible for the Kremlin to create the appearance of a competitive electoral process while guaranteeing



the intended result by manipulating the narrative and preventing Opposition voices from being heard. In addition, Putin has worked hard to project the image of a powerful, resolute leader who can defend Russia's interests against outside threats. Putin has successfully created a cult of personality by deftly manipulating Staterun media and spreading (mis)information that presents him as essential to the safety and prosperity of the country. Putin has also used external wars and geopolitical crises to his advantage domestically. For instance, the Russian people broadly supported the annexation of Crimea in 2014, seeing it as a return of territory and pride in their country.

Many Russians view Putin as a bulwark against perceived foreign aggression, which has further enhanced his popularity. Putin can gain support and unity from the electorate by portraying himself as a global champion of Russian interests, which will validate his authority in public eyes. In addition, Putin has adeptly appropriated State institutions and utilised his command over the security apparatus to guarantee election results that are advantageous to his Government. Incidents of political persecution, like the detention of well-known activists and opposition figures such as Alexei Navalny, serve as a sobering reminder of what happens when you challenge Putin's authority. Putin aims to preserve control over important State power levers in order to secure his ongoing supremacy in Russian politics. Putin's complex campaign of manipulation, disinformation and pressure is part of his effort to gain legitimacy in the Russian elections. Putin aims to hold on to power and create an air of legitimacy by managing the election process, enhancing his public persona and taking advantage of international crises. Nonetheless, the enduring opposition and the diminishing confidence in Governmental establishments underscore the vulnerability of Putin's governance, implying that the pursuit of legitimacy is a continuous conflict in Russian politics.

To ensure free and fair elections, tackle the menace of muscle power, money power, misinformation and code of conduct violations diligently

he Chief Election Commissioner, Rajiv Kumar, has announced the 18th Lok Sabha election schedule, starting in April. He has identified four major problems that affect India's free and fair elections. These are the 4Ms: Muscle ower, Money power, Aisinformation, and violations of power, Money the Model Code of Conduct (MCC). They are not new. During his campaign in 2014, Prime Minister Narendra Modi promised to end the criminalisation of politics and regulate the use of black money.

However, the question remains whether it is possible to prevent the improper use of the model code of conduct and control the use of money and muscle power. The Association for Democratic Reforms, an election watchdog, has found that several major Indian political parties, including the BJP, Congress, TMC, NČP, RJD, AAP, CPI(M) and YSRCP, have fielded candidates with criminal offences. The current Members of Parliament (MPs) own assets worth Rs 29,251 crores with an average wealth of Rs 38.33 crores. The report found that 44% of Union Ministers in India have a criminal record, and 25% of MPs have serious criminal cases against them. Of the total MPs, 53 are billionaires, and 475 are crorepatis.Increasing use of Money and Muscle power threatens Indian democracy. Politicians began using musclemen for their work, but since the 1980s, these criminals have started running for office.

Political parties also find it easy as they fund their campaigns, and people vote for them out of fear. The nexus between crime and politics is a persistent issue that will not go away soon. This link impacts the country's democracy and governance. The connection between the two factors leads to high-cost elections and voter bribes.

However, companies can still donate to political parties without disclosing the source of funds up to a certain amount. The law does not limit the number of cash donations to enhance transparency. The Supreme Court prohibited the sale of election bonds

this year. The government introduced the bond system in 2018. Individuals or companies can purchase these bonds at a value ranging from Rs 1,000 to Rs one crore, with no limit on the maximum amount. In the last five Assembly polls, electoral bonds worth Rs 6.128 crore were sold, raising concerns about transparency and accountability. Only a few parties benefitted, including the BJP and the Congress, and the BJP had a significant share. The court found that the

bonds lacked transparency and banned them recently. Poll officials seized drugs, cash, and liquor worth over Rs 1760 crores in the five pollbound states, more than seven times the seizures made in previous Assembly Elections worth Rs. 239.15 Crore. Rajiv Kumar has banned Cash transportation in bank vehicles after sunset as part of the new rules for the 2024 polls. The Commission will also monitor Non-scheduled chartered flights for cash, liquor, and drug movement to aid in seizure efforts. Indian democracy has thrived for over 75 years despite various challenges such as illiteracy, poverty, and more. The power has shifted smoothly 17 times, unlike in the neighbouring countries.





On the research front, the ICMR National Institute of Immunohematology (NIIH) and the National Institute of Research in Tribal Health (NIRTH) are researching haemoglobin disorders such as thalassemia, engaging in field investigations, and enhancing diagnostic techniques. Furthermore, Dr Bharati

Pravin Pawar, Union Minister of State for Health and Family Welfare, launched the third phase of the Thalassemia Bal

Sewa Yojana (TBSY) to commemorate World Thalassemia Day. The minister emphasised the importance of increasing awareness, screening, and treatment facilities for blood disorders like thalassemia and sickle-cell anaemia. The launch also included the unveiling of the Thalassemia Bal Sewa Yojana Portal and the release of Standard Treatment Guidelines for Sickle Cell Disease. Thalassemia can be prevented through early detection and intervention. Recognising this potential, the government has prioritised raising awareness and implementing screening programmes to reduce the national burden of the disease.

Women hiring from campus grows

There has been a 5 percentage points increase in campus hiring of women in 2022-23, compared to the previous year as companies in India are keen on inclusivity and diversity in the workplace, a report said on

In FÝ23, 40 per cent of the fresh talent hired from college campuses were women, up from 35 per cent in the previous year, AI-powered recruitment automation firm HirePro said in the report.

The report is based on evaluation of data during FY23, for a sample size of 5,50,000 BTech candidates across all five zones -- central, east, north, south, and west -- of the country.

As per the report, a majority of women participated in campus hiring exams last fiscal for sectors such as IT, banking, financial services and insurance (BFSI) and research and development (R&D).



Further analysing the data, the report said IT services top the chart in women's participation in campus hiring.

The report also revealed that out of the five zones, south India had the highest women participation in campus hiring exams in 2022-23, at 39 per cent.

The east, meanwhile, recorded the lowest participa-

tion at 24 per cent for campus hiring. The west zone saw 34 per cent participation, central zone saw 28 per cent, and

north at 27 per cent, it said. "The data derived from our campus hiring report serves as a tangible testament to India's progress toward achieving gender equality in the workforce," HirePro Chief Operating Officer S Pasupathi added.



More special, in fact! "Pooja's last film as an actor was my first film in Bombay ever," gleefully goes on Nitya, adding, "Again, it is not a coincidence why people rub shoulders in life. When she came to work, I hadn't seen her for so many years—almost 20 years. It was like this instant, like an electric thing happening in the room, because I was extremely impressed when I met her. I was extremely enamoured, and she made me feel so good and so confident about myself. She was the lead actor amidst others, and I was living in town, and we had to go to Chembur every day."

Basically, she shares that she comes from a background where her parents always felt that films were just being made, and who made them was never questioned. Certainly, they were apprehensive of sending her to Bombay, this big city. But "Then you know, which is why it is so important to surround yourself and try and make your way into some spaces where you can look up to people and have the correct role models, and for me, that is what Pooja was. She had a production house, I remember, so I would see her fleeingly get ready, and they'd put me in background action, which means I was very busy in a corner doing things as the film's life was dependent on it. But I just remember her as the boss woman because I remember her being so inclusive of all of us, taking us to the office, and that has not changed to date. You should be noting down everything that she says (we laugh). She is like this walking-talking philosopher, so not much has changed. I have grown up a little bit; she has too, but not really. We were meant to be."





It appears that the film accurately depicted the historical realities of *Nizam's* rule in Telangana both before and after Indian independence. Additionally, one of the film's key actresses concurs.

Anushree Tripathi tells us exclusively over the phone, after concluding all of the media appearances: "I have been performing in theaters for a while, but my theater background wasn't anything that could have helped me play the role of a *Nizam*'s wife. Even though I'm quite opinionated in real life, I had to exercise extreme caution when it came to my character."

The actress disclosed that she went through multiple more preparations, saying, "First, I went to the Chowmahalla Palace. I talked to a few Muslim women and noticed how reserved they are. Then, Harish Chandra Rayala, who is renowned for his technique training, trained me. We took our roles very seriously, and my walk was taken care of as well. I was particularly asked to communicate with my eyes! Additionally, I am quite aware of how the Telugu audiences perceive our eye movements. I experimented with numerous monologues during the course of two to three months of my acting training. I watched the films that had a strong regal theme! Another person I looked up to was Keerthy Suresh from *Mahanati*, especially with her glamorous pose."

More importantly, she said, "Throughout, I solely paid attention to Muslim women. Not mine, but every other character in the film was based on actuality. The scriptwriter, who is also our director, developed one imaginary character for me, and that was mine."

Yes, she did feel complicit in a number of scenes. Anushree tells us, for instance, that she frequently felt as though she was on the wrong side of things. "Maintaining the spark of chemistry between Makarand Deshpande and myself was one of my favourite challenges! I felt like I had icy feet and was incredibly anxious. Mysore Palace setting was equally magnificent, even if everyone else was filming in nearby villages or Ramoji Film City. Everyone used to make fun of me since I was always accompanied by four people while I wandered around in my baggy clothes. I was the center of attention on the *Razakar* sets!"

She even said, quite candidly, "At first, I was worried about the screen space. I truly enjoyed the three additional scenes that aren't in the film! Due to the film's extended running time, the songs had to be cut as well. The producing company suffered a loss of about six crores in those conditions. I was therefore quite interested in learning how they were pairing me with Anasuya, Vedhika, and so on. When I finally saw my sequences carefully placed on screen on the Hyderabad screening night, I was very thrilled."

We also couldn't have missed the following in this interview: "It's encouraging to see local politicians praising our film on patriotism. On the day of the screening, I heard a lot of people from the present generation recollect how their ancestors had fought in this war. OM BHEEM BUSH ISN'T A COMEDIC ADULT FILM'

n March 22, Om Bheem Bush, which also stars Sree Vishnu, Priyadarshi, and Rahul Ramakrishna, will be released in theaters. It is billed as a full-fledged comedic delight. Under the direction of Sree Harsha Konuganti, UV Creations and V Celluloid (co-produced with Sunil Balusu) are bringing out the movie. At the age of 34, my knowledge has only grown. Participating in movies such as Balagam may leave a lasting impression on your character. They are influenced by the books they read. Watching Hi Nanna while dubbing for my role was an entirely different experience. Being a rationalist, he doesn't believe in the existence of God. But "I respect other people's beliefs and don't force mine on them. I have donned amulets for style sake. Near Pune, there is a village called Bhor. There is a magnificent medieval mahal there.
