Mukhtar Ansari dies of cardiac arrest in Banda hospital; Sec 144 clamped in UP

Jailed gangster-turned-politician was rushed for medical aid as health deteriorated again

railed gangster-turned-politician Mukhtar Ansari died of cardiac arrest at a hospital in Banda in Uttar Pradesh on Thursday, its principal said.

Prohibitory orders under section 144 of the Criminal Procedure Code, which bars large gatherings, were imposed across the state and additional security personnel were deployed in the Banda, Mau, Ghazipur and Varanasi districts of the state. districts of the state.

Ansari was brought to the Rani Durgavati Medical College in Banda from the jail in district unconscious state" and, according to its principal Suneel Kaushal, he died at the hospital following cardiac arrest.

Ansari's brother Afzal Ansari on Tuesday alleged that he was subjected to "slow poisoning" in the jail, a charge denied by the authorities.

Ansari, 63, was a five-time MLA from Mau Sadar seat and was behind bars in Uttar Pradesh and Puniab since 2005. He had over 60 criminal cases pending against him.

He was sentenced in eight cases since September 2022 by

Police Force along with the local police deployed in Banda, Mau, Ghazipur and Varanasi. Ansari, who hailed from Mau, was believed to have a strong influence in the adjoining Ghazipur and Varanasi districts as well.

According to a medical bulletin, Ansari was brought to the medical college around 8.25 pm on Thursday in an unconscious state after he had complained of vomiting. A team of nine doctors attended to him but he died of cardiac The Samajwadi Party condoled Ansari's death.

"Sad demise of former MLA Shri Mukhtar Ansari. May his soul rest in peace. May the bereaved family members get the strength to bear this immense loss. Humble tribute," the party said in a post in Hindi on X.

Earlier, Ansari was hospitalised

for around 14 hours on Tuesday after he complained of

Erode MP kills self over denial of ticket

Ganeshamurthi, the 76-Aganesnamurun, die Ayear-old Member of Parliament (MP) belonging to the MDMK who was representing Erode in the Lok Sabha, committed suicide over denial of ticket.

Ganeshamurthi, three-time MP representing Erode, was shattered when he was told by party founder Vaiko that he would not figure in the party's list as a candidate for the upcoming election. Instead, MDMK chief Vaiko nominated his son Durai Vaiko as the candidate from Erode.

Persons close to Ganeshamurthy said though the latter pleaded with Vaiko for one more term, the party founder remained intransigent and this upset the sitting MP.

Ganeshamurthi had allegedly tried to kill himself after consuming some poisonous tablets on March 24 at his home. He was rushed to a hospital here and later referred to another private institute in Coimbatore. Hospital authorities said Ganeshamurthy died of cardiac arrest. Vaiko who rushed to Coimbatore said, "He met me twice. We never expected him to make such a decision. He was in a good mood. I cannot believe that he took such a step and passed away. We pay our deep homage." Expressing shock over the sudden demise of Ganeshamurthi, noted film actress in Tamil and Malayalam Lalitha Sree said, "Political parties should be careful while not granting chances to sitting MPs because some of them are so obsessed with serving the

India, China discuss disengagement in border areas

Tndia and China have agreed to sustain their efforts to resolve the boundary dispute through diplomatic and military channels fresh round of talks between the two sides. The parleys came in the backdrop of persisting tension at the Line of Actual Control (LAC) in Eastern Ladakh for the last four years.

Both sides had an in-depth exchange of views on how to achieve "complete disengagement" and resolve the remaining issues along the Line of Actual Control during the 29th meeting of the Working Mechanism for Consultation and Coordination on India-China Border Affairs (WMCC), Ministry of External Affairs (MEA) said here on



Thursday.

The key meeting was held in Beijing on March 27, it said in a statement. Joint Secretary (East Asia) from the MEA led the Indian delegation. The Chinese delegation was headed by

the Director General of the Boundary and Oceanic Department of the Chinese Ministry of Foreign

Affairs, the statement said. "In the interim, both sides agreed to maintain regular contact through

diplomatic and military channels and on the need to uphold peace and tranquility on the ground in the border areas in accordance with existing bilateral agreements and protocols," it said.

Meanwhile, the Chinese Ministry of Foreign Affairs in a statement on Thursday said, "Both sides positively evaluated the progress made in the management and control of the situation in the China-India border area, and had a candid and in-depth exchange of views on the ideas of work for the next stage."

The two sides "agreed to focus on the relevant issues on the ground along the border, reach a solution acceptable to both sides as soon as possible, and promote the transition of the border situation into a normalised phase of control and management," it said.

terrace after gang-rape

PNS LUCKNOW

In a sensational incident reported from Budaun, miscreants gang-raped a girl and later threw her from the terrace to kill her.

When the family reached the spot after hearing the screams, the girl was found in an unconscious state. She was admitted to the hospital and the incident was reported to the local police. The cops, however, took the incident lightly and did not register a case, the family alleged. The incident took place in Allapur police station area. The family of the girl hails from Delhi and earns their living by working as labourers in Budaun. They had returned from Delhi after Holi celebration on Tuesday morning.

Late Tuesday night, when the girl went for urination, some youths forcibly took her to the terrace of a house where all of them raped her one by one after threatening her with dire consequences. Later, fearing that the girl might reveal their names, the accused threw her from the terrace and escaped. As the girl cried for help, the family members rushed out to enquire about the matter and were shocked to see her lying unconscious in a critically injured state. They took her to the hospital and after admitting her, informed the police about

the incident. The local officials had so far not registered a case, claiming that the family informed them about the incident but had so far not handed over any application in this regard. The police said that action would be taken if the family lodged a report.

The minor girl's father lodged an FIR at Fatehpur police station under Indian Penal Code Section 376 (rape) and the Protection of Children from Sexual Offences (POCSO) Act.

Circle Officer Beenu Singh said the girl was admitted to a hospital and was stated to be out of danger. The accused has been arrested.

In another incident of sexual assault, a 22-year-old Dalit woman was allegedly raped in Ballia, police said on Thursday. Accused Lagandev Yadav was arrested on Wednesday, they said. SHO Dharmveer Singh said the matter came to light when the rape survivor's mother approached the police on Tuesday night.

In her complaint, she alleged that Yadav raped her daughter on March 7. He made casteist remarks against her and threatened to kill her, the SHO said. Based on the complaint, the police registered an FIR under the Indian Penal Code sections 376 (rape), 504 (intentional insult with intent to provoke breach of peace) and 506 (criminal intimidation) and the Scheduled Caste and Scheduled Tribe (Prevention of Atrocities) Act, Singh said.

Meanwhile, a suspect in a petrol pump loot case here was injured in an encounter with police in Motigarpur area in Sultanpur, police said on Thursday. The encounter took place when a encounter took place when a police team stopped a vehicle in which two suspected criminals, Maan Singh and Akhand Pratap, were travelling. Girl thrown off | Stress on transparent, fair election process

To ensure the smooth conduct of Lok Sabha elections, a meeting of master trainers was convened at Dr APJ Abdul Kalam Auditorium of the Collectorate. It was chaired by District Magistrate and District Election Officer Surya Pal Gangwar, who emphasised the importance of mutual coordination in conducting the elections in a free, fair, and transparent manner.

He underscored the responsibility of all attendees to possess comprehensive knowledge of the election process to facilitate transparent and fair elections. He outlined the training programme for master trainers, who will subsequently educate other election personnel and train polling staff on operating EVMs.

He stressed that the training of master trainers would be conducted in multiple phases, covering election procedures, polling booth setup, and other essential aspects of the electoral

process. Urging prompt training for polling personnel, Gangwar emphasised the importance of quality training and instructed officials to ensure basic facilities. ties such as water, electricity, ramps, vehicles, and sanitation facilities are in place at polling stations well in advance.

The district election officer

instructed master trainers to set

up training panels in every room at the venue to disseminate comprehensive information about the Lok Sabha elections to polling officers.

He specified the installation of five EVMs in each room and outlined the training presenta-tion to be divided into three phases: general, EVM operation, and common procedures. Additionally, he directed the appointment of a computer operator in each room. The meeting was attended by several officials, including the additional district magistrates (administration, east, judicial, LA1, LA2, and trans-Gomti), district development officer, basic education officer, district science officer, and representatives from relevant depart-

496 COMPLAINTS REGISTERED ON CVIGI: RINWA

Chief Electoral Officer Navdeep Rinwa said that after the announcement of Lok Sabha election schedule, 496 complaints had been registered on the cVIGIL app in Uttar Pradesh till March 26. He said while 272 complaints were found to be correct, 224 were found to be wrong. He said that all 496 complaints had been disposed of.

So far, the average time for disposal of complaints on cVIGIL app in the whole of Uttar Pradesh is 80 minutes, which is period of 100 minutes.

Chief Electoral Officer of Uttar Pradesh Navdeep Rinwa said that the Election Commission of India had developed cVIGIL mobile app to complain about violation of Model Code of Conduct.

Through this app, citizens can register complaints in various ways. cVIGIL mobile app can be downloaded from Google Play Store or App Store. Photographs, videos or audio related to violation of model code of conduct can be uploaded on cVIGIL mobile app. He said that action would be taken within 100 minutes of filing of complaint and there was no obligation for the complainant to give his/her name and mobile phone number to complain, but if the complainant complains with his name or mobile phone number, then he/she could see the action taken and the status of the complaint.

The chief electoral officer said that usually in the cVIGIL app, apart from complaints of distribution of money, gift coupon distribution, distribution of liquor etc., complaints related to putting up of posters, banners without permission, holding meetings without permission, using vehicles for campaigning without permission, making religious and fanatical speeches are

She said she was apprehensive of a showdown with Aman, who picks fights even at the slightest of provocations. "My apprehensions came even though I had shifted my loca-

tion on the day of Holi. Aman reached there and demanded money for his daily quota of drugs, but I refused. He shouted at me and asked me to give him my gold chain. When I refused, he resorted to violence. He unsuccessfully attempted to snatch my gold chain. He then snatched my earrings, leaving me injured. When my daughters rushed to my rescue, he attacked them with scissors," Saroj stated in her complaint. "Moni suffered grievous injuries and her condition is critical. I could not get time to file a complaint earlier as I was also injured and also because my daughters are hospitalised,"

A sum of Rs 1 lakh, three mobile phones and other valuables were stolen from a house in Indiranagar on March 21 morning. A case was registered in this regard on Thursday. Plans afoot to set up green belts, wetland lakes

Lucknow (PNS): There are plans underway to establish green belts, wetland lakes, and social forestry in Lucknow, particularly on the outskirts, aimed at maintaining a healthy environment with hygienic sur-roundings, according to Development Lucknow Authority Vice-Chairman Indramani Tripathi.

He mentioned that suitable locations have already been identified for these initiatives. One such project involves designing a forest at Janeshwar Mishra Park and Dr Ram Manohar Lohia Park, while another entails the development of a lake in Gomti Nagar Extension. Tripathi said that over five sites

within the city and four on its outskirts have been earmarked for green belts, along with two locations for wetland lakes and four for social forestry. Furthermore, Tripathi mentioned plans to restore several dried ponds by the summer. He acknowledged the challenge of rejuvenating these ponds after prolonged dry spells and ensuring their water quality meets human consumption standards, considering many had become contaminated due to being used as garbage dumps.

Reflecting on past oversights, Tripathi noted the authority's failure to proactively prevent pond drying or illegal encroachments driven by local interests. Chief engineer AK Singh said that the execution of plans for wetland lakes and green belts would commence within the next two weeks.

When asked if he would campaign for SP candidate Ruchi Veera, Hasan told PTI, "I will neither contest the Lok Sabha polls nor campaign in Moradabad." However, the Moradabad MP said he will campaign in the polls wherever SP chief Akhilesh Yaday asks him. "In Rampur, as the party could not announce a candidate suggested by Azam Khan, so Ruchi Veera has been made candidate the from Moradabad at the behest of Khan," he claimed.

4 illegal migrants on way to Delhi from Assam arrested in UP

Lucknow (PTI): The Anti-Terrorism Squad of the Uttar Pradesh Police have arrested four Rohingyas including three women, all of them native of Myanmar, who had entered India illegally, police said on Thursday. The four were identified as Amir Hamza, 21, Meena Jahan, 19, Sakura Begaum, 22, and Onara Begum,

"The Rohingyas were travelling in a train headed to New Delhi from Assam. They were intercepted when the train entered Uttar Pradesh on Mar 27 and taken to ATS headquarters in Lucknow. They were put under arrest at the headquarters," the ATS said in a statement.

"The accused said they were native of Myanmar and had entered into India illegally with an intention to settle here. Fake Indian documents were also recovered from them," it added. The ATS booked the four under IPC section 420 (cheating), 467 (Forgery of documents), 468 (forgery for purpose of cheating) and 471 (using as genuine a forged document).

Left parties accuse BJP of misusing central agencies

The Left parties accused the Bharatiya Janata Party of misusing central agencies like Enforcement Directorate, Central Bureau of Investigation and Income Tax Department to harass its political opponents and send them to jail and demanded the Election Commission of India intervene to ensure level playing field for the opposition in the coming Lok Sabha elections.

CPI state secretary Arvindraj Swaroop and Communist Party of India (Marxist-Leninist) state standing committee member Ramesh Singh Sengar, Forward Block state general secretary Uday Nath Singh, Democratic Janata Dal's state president Zuber Ahmed and CPI(M) state secretary board member Premnath Rai.

Due to holiday on the occasion of Holi, World Tuberculosis Day, which is on March 24, was observed on Thursday as per the guidelines received from the state level. In this sequence, programmes were organised at Sir Sunderlal Hospital (SSH) in BHU, Heritage Institute of Medical Sciences (HIMS) at Bhadwar, SSPG Divisional Hospital at Kabirchaura and other places in the district during the day.

An awareness programme was organised under the joint aegis of Thoracic/TB & Respiratory Disease, IRL, Microbiology Department, MO TB unit and ART Centre /COE in the OPD premises of SSH, a hospital of Institute of Medical Sciences (IMS), BHU. A good number of general public participated in this programme and they were informed about the risk factors for TB infection. The awareness programme was inaugurated by IMS BHU Director Prof SN Shankhwar. The function was also attended by Dean Prof Ashok Chaudhary, Dean (Research) Prof Gopal Nath, Medical Superintendent of SSH Prof KK Gupta, Prof JK Mishra (Department TB & Respiratory Disease), Prof Shampa Anupurva (Nodal IRL, Microbiology), Prof Sangeeta Kansal (MO TB unit) and Prof Iava Chakravarty (Nodal

Officer ART Centre BHU).

Addressing the programme as the chief guest, Prof SN Shankhwar said tuberculosis can be completely cured with timely diagnosis and treatment and appealed to patients to complete the course of medication. Prof JK Mishra and Prof Sangeeta Kansal said between January-March this year, 862 patients are undergoing treatment and 218 patients are of

MDR TB. All TB Patients have been registered on the Nikshay portal. Prof Jaya Chakravarty said HIV patients are at high risk for TB disease. Out of 27,000 HIV patients registered in the ART Centre, 6,453 patients have been dignosed with TB. Prof Shampa Anupurva said in session 2023-24, a total of 7,080 patients were tested for TB out of which 1,224 cases were found positive. A large number of people participated in the

awareness camp, out of which sputum of 66 people were tested. Dr Manaswi Choubey, Dr Anuradha Johri, Dr Archana Singh, Dr Chanchal Jha, and employees and officers of TB Programme and ART Centre BHU were also present. Reports had said a US state department official had said Washington "encouraged a fair, transparent and timely legal process for Chief Minister

The MEA later in a statement said, "We take strong objection to the remarks of the Spokesperson of the US State Department about certain legal proceedings in India".

"In diplomacy, states are expected to be respectful of the sovereignty and internal affairs of others. This responsibility is even more so in case of fellow democracies. It could otherwise end up setting unhealthy precedents," the statement said.

India's legal processes are based on "an independent judiciary which is committed to objective and timely outcomes," the MEA said in the statement while underlining that "casting aspersions on that is unwar-

Government revises wages under MGNREGS

The Government has Trevised wages under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) for unskilled workers, with hikes ranging from four to ten percent across different states. He sarcastically congratulated MGNREGA workers on what he termed as a meager increase of Rs 7 in their daily wages. Gandhi also slammed


AFSPA extended in Arunachal, Nagaland for six more months

The Armed Forces (Special Powers) Act, under which an area is declared as "disturbed" for the convenience of security forces, has been extended in three districts of Arunachal Pradesh, eight districts of Nagaland and some other areas for six more months after a review of the law and order situation in these two northeastern states.

The AFSPA gives armed forces personnel, operating in disturbed areas, sweeping powers to search, arrest and to open fire if they deem it necessary for "the maintenance of public order". An area or district is notified as a disturbed area under the AFSPA to facilitate the operations of the armed

In a notification, the Union home ministry said the central government in exercise of the powers conferred by Section 3 of the Armed Forces (Special Powers) Act, 1958 had declared the Tirap, Changlang and Longding districts in Arunachal Pradesh and the areas falling within the jurisdiction of Namsai, Mahadevpur and Chowkham police stations in Namsai district of Arunachal Pradesh, bordering Assam as "disturbed area" on September 26, 2023. "And whereas a further review of the law and order situation in the state of Arunachal Pradesh has been undertaken. Now, therefore, Tirap, Changlang and Longding dis-tricts in Arunachal Pradesh and the areas falling within the jurisdiction of Namsai, Dimapur,



Mahadevpur and Chowkham police stations in Namsai district of Arunachal Pradesh, bordering the State of Assam, are declared as 'disturbed area' under Section 3 of the Armed Forces (Special Powers) Act, 1958 for a period of six months with effect from 01.04.2024, unless withdrawn earlier," the notification said.

In a separate notification, the home ministry also said that the central government in exercise of the powers conferred by AFSPA had declared eight districts and 21 police stations in five other districts of Nagaland as 'disturbed area' for a period of six months with effect from October 1, 2023. The home ministry said a further review of the law-and-order situation in Nagaland has been undertaken and after that a decision has been taken to declare as 'disturbed area' under the AFSPA for six more months in eight districts of the state and areas falling under 21 police

stations. The districts where the imposition of 'disturbed area' under the AFSPA will continue are

Chumoukedima, Kiphire, Noklak, Phek and Peren districts. The police stations where the law will be applicable are: Khuzama, Kohima North, Kohima South, Zubza and Kezocha police stations in Kohima district; Mangkolemba, Mokokchung-Longtho, Tuli, Longchem and Anaki 'C' police stations in Mokokchung district; Yanglok police station in Longleng district; Bhandari, Champang and Ralan police stations in Wokha district; and Ghatashi, Pughoboto, Satakha, Suruhuto, Zunheboto and Aghunato police stations in Zunheboto

district. Union Home Minister Amit Shah had earlier said the AFSPA has been removed in 70 per cent areas in the northeastern states even though it is in force in Jammu and Kashmir. On March 26, Shah had said the central government would consider revoking AFSPA in Jammu and Kashmir. There have been demands from various organisations and individuals in Jammu and Kashmir and northeastern states to revoke the AFSPA.

NET scores to be used for PhD admissions from 2024-25: UGC

m (NET)\ scores\ will\ be\ used}$ for PhD admissions from 2024-25 eliminating the need for separate entrance tests conducted by universities and higher education institutions, according to the University Grants Commission. The NET is conducted twice a year -- June and December. Its scores are currently used to award Junior Research Fellowship (JRF) and as eligibility for appointment as an assistant professor for those with a Master's degree.

According to University Grants Commission (UGC) officials, the commission had constituted an expert committee to review the provisions of the exam and based on the panel's recommendations, it has decided that from the academic session 2024-25, the score can be used for admission to PhD programmes.

"Starting from the academic session 2024-2025, universities nationwide will have the opportunity to utilise NET scores for admissions to PhD programmes, replacing the need for separate entrance tests conducted by individual universities and higher education institutions (HEIs). This marks an important step in streamlining the admission process and enhancing accessibility for aspiring doctoral candidates. "By leveraging the NET, which is conducted biannually, universities can offer greater flex-

ibility to students, allowing

them to utilise their scores

from either session to apply for

PhD programmes across vari-



Kumar explained that the initiative is poised to benefit students in numerous ways. "Firstly, it eliminates the need for students to prepare and appear for multiple entrance tests conducted by different universities, thereby reducing the burden of exam logistics and expenses. Additionally, the biannual administration of the NET provides students with increased opportunities to secure admission to their desired PhD programmes.

'We strongly encourage all universities to adopt NET exam scores for PhD admissions starting from the 2024-2025 academic session. This will undoubtedly contribute to fostering a more conducive environment for academic pursuit and scholarly advancement in our nation," he said.

In an official notification, the UGC said that from June 2024 onwards, the NET candidates will be declared eligible in three categories -- for admission to PhD with JRF and appointment as assistant professor; for admission to PhD

professor. "Result of UGC NET would be declared in percentile along with the marks obtained by a candidate to utilise the marks for admission to PhD. The JRF-qualified students are admitted into the PhD programme based on an interview as per the UGC (Minimum Standards and Procedures for Award of PhD Degree) Regulations, 2022.

"For students who qualify in categories 2 and 3, 70 per cent weightage will be given for test scores and 30 per cent for the interview for admission to PhD programmes. The PhD admission will be based on the combined merit of NET marks and the marks obtained in the interview or viva voce," the notification said. The marks obtained in the NET by the candidates in categories 2 and 3 will be valid for one year for

admission to PhD. The registration process for UGC NET June 2024 is expected to begin next week.

Households wasted 1 billion meals daily in 2022: UN report

n 2022, every day, house-

holds worldwide wasted over

I billion meals, while a heartbreaking 783 million people struggled with hunger, and a third of the global population faced food insecurity, as per a UN report published just ahead of the International Day of Zero Waste marked on March 30. The economic toll due to waste food is estimated at roughly USD 1 trillion, highlighting the urgent need for action, said the UNEP Food Waste Index Report 2024, prepared by the UN Environment Programme (UNEP),in collaboration with the environmental charity WRAP, which has brought to attention the grave consequences of food waste while underscoring the glaring disparity between

persists worldwide. The report has also highlighted how this issue not only hurts the global economy but also fuels climate change, loss of biodiversity, and pollution. A detailed analysis of the data reveals an alarming scenario: In 2022, a staggering 1.05 billion tons of food waste were generated, equivalent to 132 kilograms per person and nearly one-fifth of all available food. Surprisingly, a significant portion of this waste, 60 per cent, occurred at the household level, with food services responsible for 28 per cent and retail contributing 12 per cent.

Inger Andersen, Executive Director of UNEP said, "Food waste is a global tragedy. Millions go hungry as food is wasted across the world. Not only is this a major development issue, but the impacts of such unnecessary waste are causing substantial costs to the climate and nature. If countries prioritise this issue, they can significantly reverse food loss and waste, reduce climate impacts and economic losses, and accelerate progress on global goals."

At the same time, Harriet Lamb, CEO of WRAP called for more G20 countries to measure food waste and work towards achieving the Sustainable Development Goal. Public-private partnerships were highlighted as a key tool in addressing the complex challenges of food waste.

The report notes that despite efforts to track food waste, many low- and middle-income countries lack adequate systems to monitor progress towards Sustainable Development Goal 12.3, which aims to halve food waste by 2030. Only a few G20 countries, along with the European Union, have suitable estimates to track progress. Interestingly, the report

debunked the notion that food waste is only a problem in wealthy nations. Household food waste levels varied only slightly among high-income, upper-middle, and lower-middle-income countries. Hotter countries appeared to generate more food waste per person, possibly due to higher consumption of fresh foods with inedible parts and limited cold chain infrastructure.

The environmental impact of food waste is substantial, contributing 8-10 per cent of annual global greenhouse gas emissions and causing significant biodiversity loss.

Truth travels freely

Kejriwal's arrest gets international attention; vendetta politics may boomerang on ED

rought to the Rouse Avenue Court amid high drama, Delhi Chief Minister Arvind Kejriwal has described his arrest by the Enforcement Directorate in the excise policy case as a "political conspiracy." Himself making submissions in the court after taking the special judge's permission, he expressed confidence that the public will give a "fitting reply to this injustice". Seeking to establish a link between the Electoral Bond donations received by the ruling party and his arrest, the Delhi Chief Minister said that people were being turned 'approver' in the case and being forced to change their statements. "My arrest by the ED is a political conspiracy ... the approver gave the BJP Rs 55 crore," he said. As a precursor to this setting, Kejriwal's wife, Sunita, broke her silence and hinted at the impending revelation of this crucial piece of information. Kejriwal, known for his anti-corruption stance and vocal criticism of the Centre, was arrested last week on charges of being embroiled in a multi-crore liquor scam. The arrest sparked wide-

spread outcry and protests, with supporters of Kejriwal alleging political vendetta and the BJP's bid to settle political scores with the AAP upon losing the MCD elections after 15 years. Apart from being charged with soliciting kickbacks from liquor traders in exchange for favours, the Delhi Chief Minister is also accused of being the "kingpin and key conspirator" in the nowscrapped policy. The agency has already arrested at least 14 top AAP leaders, including Deputy Chief Minister Manish Sisodia and Minister Sanjay Singh, in connection with the case. Meanwhile, the international community has also been

drawn into the fray, with the US making remarks regarding Kejriwal's arrest that have drawn the ire of Indian officials. The US State Department expressed concern over what it termed as "the apparent suppression of dissent" in India, calling for due process and respect for human rights. However, Indian authorities swiftly responded, asserting that the comments were unwarranted interference in the country's internal affairs. Germany was the first country to speak against Kejriwal's arrest. Whenever a politician is put behind bars, there are consequences to it. The Union Government should be doubly sure that it has a watertight case against the accused person, else there are high chances that it will boomerang. Due to the lack of information on the case in public domain, we shall assume that the authorities have a strong case against the Delhi CM and that due process of law would be followed. But if it is an exercise in haste, Kejriwal's words might prove prophetic as elections are just around the corner. The citizens are discerning enough to read any signs of political vendetta. The outcome of this legal battle and its broader implications remain uncertain, but one thing is clear – the events unfolding around Kejriwal have captured the attention of the nation and the world, highlighting the enduring struggle for transparency, accountability and justice in the corridors of power.

Dandi March: Salt, soul and satyagraha



The Dandi March serves as a reminder that peaceful protest can be a potent weapon against injustice and oppression

he 1980s film 'Mard' immortalised poignant scene that encapsulates the essence of patriotism, rebellion, and sacrifice in Indian cinematic history. In this scene, the protagonist, amidst relentless flogging by the heroine armed with chains, whispers with unyielding spirit, "For this salt, our Mahatma led a revolution." This homage vividly captures the spirit of the Salt Satyagraha of 1930, a pivotal moment in India's quest for independence, led by Mahatma Gandhi.

The Salt Satyagraha, which took place from March 12 to April 6, 1930, galvanised a nation against British colonial rule. Gandhi's symbolic act of picking up salt at Dandi defiantly challenged the salt taxes imposed by the British, symbolising defiance and resilience in India's freedom struggle. Social media often promotes formation of echo chambers and spread of false news

ocial media, a ubiquitous phenomenon in contemporary society, has revolutionised the way people communicate, share information and interact with one another. From its humble beginnings as online forums to the expansive platforms of today like Facebook, Instagram, Twitter, Telegram, Snapchat and many more, the term 'social media' has reshaped human interaction and societal norms to a large extent.

Today, it has become an integral part of everyone's life, especially Generation Z and the impact is complex and multifaceted, encompassing both positive and negative aspects. Social media has fundamentally transformed communication dynamics, making it easier for individuals to connect with others globally. It has transcended geographical barriers, enabled real-time interaction and fostered virtual communities based on shared interests, identities and ideologies. Moreover, social media platforms have become instrumental in political discourse, activism and social movements, empowering voices that were previously marginalised and amplifying diverse perspectives.

Millennials and Generation Z rely heavily on social media as a primary source of news and information which at times can lead to issues such as the spread of misinformation, echo chambers and filter bubbles, where individuals are only exposed to viewpoints that align with their own beliefs. Various studies have also shown that spending too much time on social media, especially before bedtime, disrupts the sleep pattern. Blue light suppresses the production of melatonin, a hormone that regulates sleep, making it more difficult to fall asleep and reducing the overall quality of sleep. Studies also reveal that constant exposure to short-form content and distractions on social media platforms can lead to a decrease in attention span and difficulty concentrating on tasks that require sustained focus. Another major role of social media platforms which is responsible for various disruptions is promoting of unrealistic beauty standards through the use of filters, photo editing tools and the prevalence of influencers with idealised appearances, leading to body dissatisfaction and



Such platforms are designed to be addictive, with features such as likes, comments, and notifications triggering dopamine release in the brain and can lead to compulsive use and dependency which is no less like other forms of addiction. Moreover, the constant exposure to carefully curated images and posts can create unrealistic expectations and foster feelings of FOMO (Fear Of Missing Out) among users. To mitigate the negative effects of FOMO irrespective of the generation gap, it becomes important to promote digital literacy, encourage healthy social media habits and foster offline connections and experiences such as practicing mindfulness, setting boundaries for screen time and cultivating meaningful relationships and activities that are not dependent on social media val-

Additionally, fostering a supportive and inclusive online community can also help alleviate feelings by emphasising authenticity, empathy and acceptance. There is no denying the fact that social media has brought about numerous benefits for Millennials and Generation Z in terms of connectivity, self-expression, and access to information, but at the same time it also poses challenges and risks that require careful consideration and management. Despite its transformative potential, social media presents a myriad of challenges that warrant attention. The addictive nature of social media and its impact on mental health, particularly among young people, raise concerns about excessive screen time, cyberbullying, and negative self-comparison. Balancing the advantages and drawbacks of social media usage is essential to harness its potential while mitigating its negative impacts on their well-being and society as a whole.

Quantifying happiness is perplexing

The World Happiness Report places India at 126th rank, raising legitimate concerns about the methodology and biases inherent in such assessments



appiness is complex and difficult to define, but this in no way implies that we do not know when we are happy. Happiness cannot be a permanent state of euphoria as the mind constantly changes its contours and shades and, by and large, remains an individual experience. Hence any exercise that seeks to generalise the impressions of a large number of individuals like those living within a country and brand them as happy or unhappy people is bound to be fraught with controversies. It will also inevitably reflect the biases of the measurers. When the definition of a variable cannot be agreed upon, its measurement will raise more controversies, but when such rankings are internationally publicised for branding countries and peoples which may influence the decisions of investors and donors, it is no longer a benign exercise without any accountability. On March 20 every year for the last seven years, which date has been marked by the . UN as the International Day of Happiness, a New York-based agency called Sustainable Development Solutions Network has been bringing out an annual World Happiness Report, whose 2024 edition has placed India at 126th rank among 143 countries, much below countries like Saudi Arabia (28), China (60), Russia (72), Venezuela (79), Senegal (99), Iran (100), Palestine (103), Ukraine (105), Pakistan (108) even Myanmar (118).

These countries are either strife-torn or warravaged, where the basic security of human life is not guaranteed, or ruled by autocrats and dictators who ruthlessly suppress the civil liberties of their people, especially of women, countries which are reeling under relentless crises in their democracy, polity and economy.

This raises legitimate questions about the methodology used in the exercise that can produce such weird results. Finland has topped the ranking in each year so far, and the top 10 countries have also remained more or less the same, Finland, Denmark, Iceland, Sweden, Israel, Netherlands, Norway, Luxemburg, Switzerland and Australia. A common thread runs through all of them - high per capita income. Other higher-capita income countries also rank higher in the list, like New Zealand (21), UK

(20), USA (23), Germany (24), or France (27). This is no surprise, because to the materialistic West hung on a culture of conspicuous overconsumption, money remains the primary and often the only source of happiness, unlike in Asian and other continental cultures.

The only Asian country to feature

in the list is Kwait at 13th position,

and the next one is Saudi Arabia at 28th. While Singapore features in 30th position, Japan, which has the largest concentration of longest-living people in the world, at 51st position, below Uzbekistan (47) and Kazakhstan (49). This raises natural questions about whether the index also reflects the inherent civilizational bias of the West against Asia, most of which used to be their colonies once-to treat them as superior or even equal would be an anathema to the West. Bhutan which reckons happiness as a core responsibility of Government and nas adopted its Gross National Happiness (GNH) Index as a development indicator in its 2008 Constitution, was ranked 95th in 2019 and has not been ranked this year. GNH was the first such index and is far broader - having nine parameters, all non-income.

Trying to measure the immeasurable will have its inherent contradictions. Happiness is a state of being, rather than a fixed state like a goal to be achieved that can be quantified and measured. Such measures therefore confuse happiness with "well-being" which is produced by the interplay of numerous extraneous factors like income, health, education, liberties, choices, relationships, physical and social security, etc. But even then, it is a subjective sense of well-being, which is neither measurable nor quantifiable.

The rankings used in the World Happiness Report are based on six parameters of "subjective wellbeing": (1) per capita income, (2) healthy life expectancy at birth, (3) social support, (4) freedom to make

life choices, (5) generosity, and (6) perceptions of corruption. The happiness rankings are based on what the authors say are "life evaluations", on which Gallup World Poll (GWP) provides the data by asking respondents to evaluate their current life on a scale of 0 to 10 (happiest), using a typical sample size of 1000 for each country regardless of its population,

and using a three-year average.

The sample size is too small for a country like India to represent all its diversity and complexity. Data for per capita GDP on purchasing power parity (PPP) are taken from the World Development Indicators (WDI) of the World Bank, and then a natural log that fits the observations better.

Data for healthy life expectancy at birth is provided by the WHO Global Health Observatory data repository. Social support is the national average of the binary responses (0=no, 1=yes) to the GWP question: "If you were in trouble, do you have relatives or friends you can count on to help you whenever you need them, or not?" Freedom to make life choices is again the national average of binary responses to the GWP question: "Are you satisfied or dissatisfied with your freedom to choose what you'do with your life?" Generosity is the residual of regressing the national average of GWP responses to the question: "Have you donated money to a charity in the past month?" on log GDP per capita, while perceptions of corruption are the average of binary answers to two GWP questions: "Is corruption widespread throughout the Government or not?" and "Is corruption widespread within businesses or not?" It does not require superlative intelligence to divine that all these parameters are derivatives of a single parameter, i.e., income or wealth of a nation, and hence will always favour rich nations over the

So, the richer you are, the happier you are; in other words, income is synonymous with happiness, an assumption not validated by facts, just as happiness cannot be equated with success in material terms. The mind is influenced by social and cultural factors; hence how we perceive happiness also depends on these factors. It also depends on the questions asked and the way they have been framed: Just ask "How much time you spend with your parents every week", or "For how long you have been married to your present spouse", and see how the scales turn against the rich western nations.

In collectivist societies in Asia, people reckon happiness more as a shared experience rather than individual satisfaction with life, whereas in individualistic societies, people perceive happiness more in terms of individual satisfaction. Happy people increase the happiness of others around them; hence bonding within social groups and families contributes positively to happiness. Individualistic Western nations would score higher given the way the GWP questions have been framed.

As every Indian knows from experience, we are not unhappy people, having been brought up to regard values and relationships as more important than wealth and to be content to live a simple life with few material possessions, with strong bonds with our extended families and the community. Even though perceptions are changing in a growing economy, these basic values have remained intact. We do not need to feel depressed at our 126th ranking. Instead, we should ignore such a phoney index and go about our lives and business as

Palestinian Authority announces new Cabinet

 $T^{\text{he Palestinian Authority has}}_{\text{announced the formation}}$ of a new Cabinet as it faces international pressure to reform. President Mahmoud Abbas, who has led the PA for nearly two decades and remains in overall control, announced the new government in a presidential decree on Thursday. None of the incoming ministers is a wellknown figure. Abbas tapped Mohammad Mustafa, a longtime adviser, to be prime minister earlier this month. Mustafa, a politically independent US-educated economist, had vowed to form a technocratic government and create an independent trust fund to help rebuild Gaza. Mustafa will also serve as foreign minis-

Interior Minister Ziad Hab al-Rih is a member of Abbas' secular Fatah movement and held the same portfolio in the previous government.

The Interior Ministry oversees the security forces. The incoming minister for Jerusalem affairs, Ashraf al-Awar, registered to run as a Fatah candidate in elections in 2021 that were indefinitely delayed. At least five of the incoming 23 ministers are from Gaza, but it was not immediately clear if they are still in the territory. The PA administers parts of the Israeli-occupied West

Bank. Its forces were driven from Gaza when Hamas seized power in 2007, and it has no power there. It has little popular support or legitimacy among Palestinians, in part because it has not held elections in 18 years. Its policy of cooperating with Israel on security matters is extremely unpopular and has led many Palestinians to view it as a subcontractor of the occupation.Opinion polls in recent years have consistently found that a vast majority of Palestinians want the 88-year-old Abbas to resign. The United States has called for a revitalised PA to administer postwar Gaza ahead of eventual statehood. Israel has rejected that idea, say-

ing it will maintain open-ended security control over Gaza and partner with Palestinians who are not affiliated with the PA or Hamas. It's unclear who in Gaza would be willing to take on such

Hamas has rejected the formation of the new government as illegitimate, calling instead for all Palestinian factions, including Fatah, to form a power-sharing government ahead of national elections.It has warned Palestinians in Gaza against cooperating with Israel to administer the territory, saying anyone who does will be treated as a collaborator, which is understood as a death threat.

US SANCTIONS ONLINE MEDIA SITE GAZA NOW

The US on Wednesday imposed sanctions on online media site Gaza Now and its founder Mustafa Ayash for allegedly supporting Hamas. US Treasury's Office of Foreign Assets Control says that after the October 7 attack by Hamas against Israel — the online entity began a fundraising effort in support of the militant organisation. Gaza Now's Arabic channel has more than 300,000 followers on social media channel X, formerly known as Twitter, and a large following on the encrypted chat platform Telegram.Included in the sanctions are firms Al-Qureshi Executives and Aakhirah Ltd., and their director Aozma Sultana, who are alleged to have partnered on multiple fundraising efforts alongside Gaza Now.The sanctions were imposed in collaboration with the UK's Office of Foreign Sanctions Implementation. \Treasury
Under Secretary Brian Nelson said in a statement that the US and its partners "will continue to leverage our tools to disrupt Hamas' ability to facilitate further attacks."A representative for Gaza Now and Ayash were not immediately available. The sanctions block access to US property and bank accounts and prevent those designated from doing business

Doctors stunned by war's toll on Palestinian children

But the gruesome impact Israel's war against Hamas is having on Palestinian children still left them stunned. One toddler died from a brain injury caused by an Israeli strike that fractured his skull. His cousin, an infant, is still fighting for her life with part of her face blown off by the same

An unrelated 10-year-old boy screamed out in pain for his parents, not knowing that they were killed in the strike. Beside him was his sister, but he didn't recognise her because burns covered almost her entire body. These gut-wrenching casualties were described to The Associated Press by Tanya Haj-Hassan, a pediatric intensivecare doctor from Jordan, following a 10-hour overnight shift at Al-Aqsa Martyrs Hospital in the town of Deir al-

Haj-Hassan, who has extensive experience in Gaza and regu-



larly speaks out about the war's devastating effects, was part of a team that recently finished a two-week stint there. After nearly six months of war, Gaza's health sector has been decimated. Roughly a dozen of Gaza's 36 hospitals are only partially functioning. The rest have either shut down or are barely functioning after they ran out of fuel and medicine, were surrounded and raided by Israeli troops, or were damaged in fighting.
That leaves hospitals such as

Al-Aqsa Martyrs caring for an

overwhelming number of patients with limited supplies and staff. The majority of its intensive care unit beds are occupied by children, including infants wrapped in bandages and wearing oxygen masks.
"I spend most of my time here

ttorneys for Hunter Biden Attorneys for Hunter Bluen asked a judge Wednesday to toss out the tax case accusing him of a four-year scheme to avoid paying USD 1.4 million in taxes while living an extravagant lifestyle. President Joe Biden's son has pleaded not guilty to the nine felony and misdemeanour tax offences. His attorneys argued the prosecution is politically motivated, was tainted by leaks from IRS agents who claimed publicly the case was mishandled and includes some allegations from before he moved to California.

Prosecutors framed the claims as far-fetched during the threehour hearing. Prosecutor Leo Wise scoffed at the idea that the case was tainted by the IRS agents "who I couldn't have picked out of a lineup".

Defence attorney Abbe Lowell, on the other hand, maintained the case was hopelessly contaminated by partisan politics, calling it "the least ordinary prosecution a person could imagine".

US District Judge Mark C Scarsi appeared to be sceptical, telling Lowell the hard evi-dence for some of his claims was lacking. "You cite to a lot of things on the internet," he said.

Scarsi said he would likely rule on motions to dismiss by April 17.

Hunter Biden has also been charged in Delaware with lying on a federal form to buy a gun in 2018 by saying he wasn't using or addicted to illegal drugs, even though he has acknowledged being addicted to crack cocaine at the time. He has pleaded not guilty in that case, which also accuses him of possessing the gun illegally.

Both cases are overseen by special counsel David Weiss and now have tentative trials scheduled for June, though defence attorneys are also trying to get the Delaware gun charges tossed out.

She said one of the people who was wounded remained in critical condition."My heart goes out to the families right now that are suffering a loss," Redd told reporters.

She said the Rockford Police received a medical call at 1.14 pm, followed by additional calls for police and paramedics. "We don't believe there's any other suspects that are on the run or at large at this particu-lar time," Redd said. "Right now, we don't have a clear motive as to what caused this individual to commit such a heinous crime."

NORWEGIANS FACING A SHORTAGE

A shortage of eggs in shops during Holy Week has led Norwegians to flock to supermarkets across the border in Sweden and hoard the traditional Easter food.

Norwegian news outlet Nettavisen said on Thursday that the Nordby shopping cen-tre in Sweden, located just off the border about 100 kilometers (62 miles) south of the capital, Oslo, has been filled by 'desperate" Norwegians try-

ing stock up on eggs.
The centre's Maxi-Mat food store ran out of eggs Tuesday, while the adjacent Nordby Supermarket has had to limit the number of eggs purchased to three 20-packs per household, the news outlet reported. Not only are the Swedish stores better stocked with eggs, a tra-ditional Easter treat needed for many dishes, but the product is also more affordable in Sweden, Nettavisen said.

"It's far cheaper than you get in Norway — if you can get eggs in Norway at all, that is," Stale Lovheim, the head of the Nordby shopping centre, told Nettavisean. "The last time I was in Norway, the store was

empty" of eggs.

A pack of 20 eggs in Sweden sells for a price equivalent to 39.90 Norwegian kroner (USD 3.70), about 30 per cent less than the price in Norway.

Concerns about overproduction of eggs in Norway led to farmers being offered compensation to reduce egg production. That and the effects of bird flu have led to a shortage, according to news reports. Egg prices are at near-historic highs in many parts of the world as Easter approaches, reflecting a market battered by disease, high demand and growing costs for farmers.

Ranked consistently among the most expensive countries in the world, Norway is known for its substantially high cost of liv-

ing, especially in regards to food products and alcohol, which are heavily taxed even when compared to well-to-do Nordic neighbours. Many residents living in southern Norway regularly make

Indian economy can grow at 8 per cent till 2047: Subramanian

Indian economy can grow at 8 per cent till 2047, if the country can redouble the good policies that it has implemented over the last 10 years and accelerate reforms, India's executive director at International Monetary Fund Subramanian said on Thursday.

Subramanian further said that clearly 8 per cent growth target is ambitious, because India has not grown consistently at 8 per cent before, but it is achievable. "So, the basic idea is that with the kind of

growth that India has registered in the last 10 years, if we can redouble the good policies that we have implemented over the last 10 years and accelerate the reforms, then India can grow at 8 per cent from here on till 2047," he said at the Times Now Summit.

India's economy grew at better-than-expected 8.4 per cent in the final three months of 2023, logging the fastest pace in

the past one-and-a-half years.
The growth rate in October-December helped take the estimate for the current

fiscal to 7.6 per cent.

"And if India grows at 8 per cent, India can be a USD 55 trillion economy by 20147," Subramanian added.



He pointed out that historically from 1991 onwards, India's average growth has been slightly more than 7 per cent.

Subramanian emphasised that India needs to strengthen its domestic economy as about 58 per cent of the country's GDP comes from domestic consumption.

Therefore, you know, we do have the potential if we can create enough jobs, you know, that will lead to much higher consumption," he said.

India's IMF executive director stressed on need of encouraging manufacturing sector for job creation.

He also pointed out that reforms are required in land, labour, capital, and logistics sector.

"Reforms are required in the manufacturing sector, but at the same time, we also need reforms in our banking sector to provide credit for manufacturing sector," Subramanian noted



to tackle today's threats, with 59 per cent of organisations falling into the "beginner or formative stages of readiness". Globally, 3 per cent of companies are at a "mature stage", meaning they are prepared handle to cybersecurity risks, it said. Cisco said while companies are

"Progress is being further hampered by critical talent shortages, with 91 per cent of companies highlighting it as an issue. In fact, 59 per cent of companies said they had more than 10 roles related to cybersecurity unfilled in their organisation at the time of the survey," the study noted.

However, businesses are increasing their investments to tackle the issue with 71 per cent planning to significantly upgrade their IT infrastructure in the next 12-24 months, the study added.

The Italian league's sporting judge announced on Tuesday that there wasn't enough proof that Acerbi's insult to Juan Jesus was racist to impose what would have been a lengthy ban on the Italy defender. incident

The alleged incident happened during a match between Inter and Napoli on March 17 and the match was halted for about 90 seconds when Juan Jesus, who is Black, told the referee that Acerbi directed a racial slur at him. "I have read several times and with great disappointment the decision of the sports judge, who felt there was no evidence that I was the victim

of a racist insult during the match," Juan Jesus said in a statement on Wednesday. "While respecting the decision, it is one I find difficult to comprehend and it leaves me feeling very bitter. "Quite honestly I am



crestfallen by such a serious incident in which my only mistake was that I dealt with it as a gentleman, deciding not to interrupt an important game, with all the inconvenience that would game, have caused the spectators watching the match. I did so believing that such an attitude would have been respected, and perhaps taken as an

example." Juan Jesus was visibly upset when he approached the referee during the second half at San Siro and was also pointing at his shirt sleeve which had a Keep Racism Out' badge - as part of the anti-racism league's

campaign. The 32-year-old Brazilian said after the match that Acerbi apologized and seemed to wish to put the matter behind him, adding, "What happens on the field, stays on the field

... he is a good guy." The Italian soccer federation prosecutor questioned the players and witnesses last week and a report was sent to the Italian league sporting judge, who also studied images from the match, as well as audio from the referee and VAR before making the decision not to sanction

"Following this decision, I imagine that anyone else finding themselves in a similar situation to mine will act in a very different manner, in order to protect themselves and to curb the disgrace of racism, which, sadly, we are struggling to rid ourselves of," Juan Jesus' statement Iuan continued.

"I do not feel in any way protected by a decision which both admits that there was certainly evidence of the insult' and maintains there is no certainty that it was of a discriminatory nature, which only I perceived in good faith."

Parag's magnificent 84 sets up RR's 12-run win over DC

Young Riyan Parag showed why he is con-sidered a precocious tal-ent as he struck a stunning 84 not out off 45 balls to set up a 12-run win for Rajasthan Royals against Delhi Capitals in their IPL match here on Thursday.

Sent in to bat, RR were reduced to 36 for 3 in the eighth over but the 22-year-old Parag sin-gle-handedly took the home side to 185 for 5 with a magnificent unbeaten knock studded with seven fours and six sixes. Parag, who was promoted to number 4 by the team manage-ment this season and made 43 in the previous match, took 25 runs off veteran South African pacer Anrich Nortje with scores of 4, 4, 6, 4, 6, 1 in the final over to hit his highest T20

Chasing 186 for a win, DC could only manage 173 for 5 in 20 overs though South African youngster Tristan Stubbs (44 not out off 23 balls) kept them in the hunt till the final over from which they needed 17

Avesh Khan conceded just four runs to help RR win their second consecutive match.

South African pacer Nandre Burger and Yuzvendra Chahal took two wickets apiece to also contribute in the RR win. "Definitely disappointed. The best thing to do from here is to learn from it. The bowlers did

"I think the message was pretty much simple for all the batters in the meeting we had before this match. 'Everyone just go and express yourself'. That's a very positive message if you get it from your captain

and coach. That's really supportive for all the batters." Sharma and Head stitched 68 runs off just 22 balls for the second wicket for SRH.

"I was batting with Travis and he is one of my favourite batters. I really enjoyed batting with him," Sharma said.

Sharma said despite putting a mammoth total on the board, it wasn't a cakewalk for SRH as MI came pretty close.

Tilak Varma (64 off 34 balls) took the game deep with a high-quality knock, comprising half-a-dozen sixes and, towards the end, Tim David (42 not out off 22) tried his best but it was not enough. RCB, KKR eye course correction to add momentum to campaign

Victory in their respective V previous games might have eased the initial nerves but imperfections remain, hence Royal Challengers Bengaluru and Kolkata Knight Riders will eye a quick course correction to add steam to their campaign in an IPL 2024 match here on Friday.

The Royal Challengers defeated Punjab Kings by four wickets, while the Knight Riders elbowed out Sunrisers Hyderabad by four runs to

garner some early points. But entering the points table has not really eased some of the worries -- particularly pertaining to the top and middle-order batting.

The Bengaluru dugout might be a happy space after star batter Virat Kohli made a classy fifty on an unusually gripping Chinnaswamy pitch while chasing 177 against Punjab the other night, but that's only one part of the story. Skipper Faf du Plessis, Glenn Maxwell, Cameroon Green and Rajat Patidar are yet to hit



the overdrive, and for the win against PBKS they had to rely on the last-minute cameos of Dinesh Karthik and 'Impact Player' Mahipal Lomror.

The Kolkatans have a much more capable bowling unit, at least on paper, and such a collectively underwhelming effort by frontline batters might push RCB into deep trapples against them. troubles against them.

Once they iron out that rough edges, RĆB can look at their bowling unit that still needs to fill a couple of unticked boxes despite good outings by pacers

Mohammed Siraj and Yash Dayal against Punjab. Pacer Alzarri Joseph continues

to be profligate and his figures -- 0/38, 1/43 -- might prompt the RCB think-tank to bring in England left-arm quick Reece Topley, who has impressive white-ball skills, in place of the West Indian for this match. The Knight Riders offer a

strikingly similar plot. Their top and middle-order consisting of captain Shreyas Iyer, Venkatesh Iyer, Sunil Narine and Nitish Rana malfunctioned against SRH at

the Eden Gardens. It required a combined effort from impact sub Ramandeep Singh, Rinku Singh and Andre Russell -- the 6, 7, 8 -- for them to post a competitive total. Shreyas, who is central to their batting plans, was dismissed for a two-ball duck, but the return to Chinnaswamy might give him a sense of relief as he had fruitful outings here in white-ball cricket in his last two innings. The elegant righthander made an unbeaten 128 against the Netherlands in last year's World Cup before

making a 53 against Australia in the fifth T20I in December. In bowling, Narine redeemed himself with a frugal spell (1/19) after a modest effort with the bat, but pacer Mitchell Starc, their record buy, and Varun Chakravarthy failed to impress, leaking over 50 runs in their four overs. The KKR think-tank might not be unduly worried as their campaign is still at a nascent stage, but they would like to see the first-choice pacer and spinner finding their range at the earliest.
