rith India battling high inflation, which includes price rise as one of the dominant factors, the prices of food consumables could potentially skyrocket further amidst the Lok Sabha polls. India's wholesale prices rose to a 13-month high of 1.26 per cent in April from 0.53 per cent in March 2024.

Due to an uptick in food inflation fuelled by rising prices of food especially vegetables, food inflation will continue to be a cause of concern in a notable increase in onion prices May and June, as heatwaves are likely to push up prices of perishable commodities. The India Meteorological Department has to a major shortage in onion supply

prices of vegetables and food items ypically increase.

Unemployment and inflation are the primary issues dominating among the voters during the discourse in India's general election 2024. The data released by the Ministry of Commerce highlighted that in the food articles basket, vegetable inflation is 23.60 per cent in April, up from 19.52 per cent in the previous month.

Wholesale food inflation also increased to 5.52 per cent on an annual basis, while food inflation grew 1.94 per cent on a month over month (MoM) basis. The data shows which rose by 59.75 per cent in April, following a 56.99 per cent increase in March. The increase was attributed predicted heatwave conditions until the next kharif crop, which is during May and June, a period when expected to be a reversal from the

current scenario. Inflation in potato jumped to 71.97 per cent in April from 52.96 per cent in March. In onion, it was 59.75 per cent in April, versus 56.99 per cent in the previous

The Wholesale Price Index measures the change in prices of goods traded by wholesale businesses. Unlike the Consumer Price Index (CPI), which tracks prices of goods and services purchased by consumers, WPI tracks factory gate prices.

The Ministry of Commerce and Industry releases WPI data on the 14th of every month, or on the next working day. Under the index, commodities are categorised into three groups — primary articles (which are further divided into food and non-food articles), fuel and power and manufactured products. April marks the sixth successive

month that the Wholesale Price Index (WPI) has risen on a year-onyear basis, after seven months of year basis, after seven months of deflation. On a month-on-month basis, the WPI was up 0.8 per cent with primary articles and food prices rising nearly 2 per cent in April, while manufactured products were up 0.5 per cent. As per the data, inflation in food articles rose to 7.74 per cent in April as against 6.88 per cent in March. In the fuel and power basket, inflation stood at 1.38 per basket, inflation stood at 1.38 per cent in April, up from (-)0.77 per

cent in the previous month.


"Positive rate of inflation in April 2024 is primarily due to increase in prices of food articles, electricity, crude petroleum and natural gas, manufacture of food products, other manufacturing etc," Ministry of Commerce & Industry said in a statement on Tuesday.

As per the data, manufactured products witnessed deflation of 0.42 per cent in April, as against deflation of 0.85 per cent in March.

ICRA Ĉhief Economist Aditi Nayar said WPI inflation is heavily sensitive to global commodity prices which is undergoing an upturn year after year. According to ICRA, the wholesale food inflation, which is at a fourmonth high, will continue to be a cause for concern in May and June as heatwave is likely to jack up prices of perishable commodities.

Although the impact of the high base of last year will play out in July and August, the impact of monsoon will determine the price conditions in the subsequent months. As per data released on Tuesday, the wholesale price index (WPI)-based food inflation was at a four-month high of 7.74 per cent in April.

Retail food inflation also remained stubbornly high at 8.70 per cent in April 2024, as against 3.84 per cent in April 2023. Retail inflation data released on Monday showed that the consumer price index (CPI)-based inflation was at an 11-month low of 4.83 per cent in April, even though the prices of food and vegetables ruled high.



### **AAP** admits to assault, **Kejriwal promises to act**

The political landscape of Delhi is becoming murkier as senior AAP leader and Rajya Sabha MP Sanjay

Singh admitted on Tuesday to accusations of assault by his party colleague and Rajya Sabha MP Swati Maliwal against Chief Minister Arvind Keiriwal's controversial PA, Bibhav Kumar, at the CM's official residence. However, a BJP leader

pointed out that Singh missed the part in the PCR call where Maliwal mentioned that she was assaulted by Kumar at the behest of the AAP chief. In the first reaction from the AAP regarding the incident, which has

added further troubles for the party as it seeks to regain its footing since its chief's release from Tihar jail, Singh confirmed that the incident occurred in the drawing room of Kejriwal's official residence. Kejriwal

is currently out of Delhi. According to sources in the AAP, senior leaders in the party are united to oust Kumar, who is widely referred to as 'Kejriwal's Man Friday', by pinning the blame on him.

While addressing a Press conference, Singh said, "At the residence of Kejriwal an incident of misbehaviour took place with Swati Maliwal by his PA Bibhav Kumar

### **EC** the arbiter resolves 400 of **425 complaints**

The poll watchdog said approximately 170, 95 and 160 complaints were filed by Congress, BJP and other political parties respectively. "Most of these complaints have been acted upon. A few complaints of INC and BJP against each other are pending alleging violation of MCC inter alia broadly in the genre of divisive statements

by top star campaigners on communal, caste, regional language divide, or on sanctity of Constitution of India," it said. "So far, 25 delegations from 16 political parties

have met the commission to lodge their grievances/ complaints on alleged violations of Model code. Apart from this, many delegations have met at the level of Chief Electoral Officer in the States," it said

# It's mostly fake during polls

A mid the rising concern over the proliferation of fake news and the "menace" of social media, a survey conducted on the youths of the national Capital, particularly eligible voters, has found that fake news and social media narratives influence the voting decisions of Gen Z (the second youngest generation, born between 1997 and 2012). A report titled 'Truth be Told,' by

the communication consulting firm The 23 Watts, delves deep into the extent of impact this phenomenon has on the youths of Delhi, particularly Gen Z, revealing that 91 per cent of them say it can influence voting decisions.

Not only that, 90 per cent of Gen Z, which includes first-time voters, observes a surge in the prevalence of "fake news" during national events like elections. What makes this data more concerning is that in the vast world of social media feeds, Gen Z is at the forefront of online news consumption. More than half of those who consume

# Death toll rises to 14 in Mumbai hoarding tragedy

The toll in the collapse of a 100-feet tall illegal hoarding at Ghatkopar in north-east Mumbai during Monday's dust storm rose to 14 on Tuesday, as six more bodies were recovered from under the debris.

At least 80 people were injured in the first of its kind collapse triggered by a massive duststorm that swept through the country's commercial capital on Monday evening.

The hoarding came crashing down on a petrol pump at Ghatkopar's Cheddanagar Junction, trapping scores of people under the debris.

The relief and rescue operations went on through the night. Almost all the persons rescued from the debris were

# Parties assess mood as Modi, Shah applaud voter turnout in Srinagar

day after the Srinagar A Parliamentary constituency recorded over 38 per cent voter turnout, the second-highest so far after the 1996 Lok Sabha polls, several Kashmirbased politicians attempted to interpret the mood of the electorate to fine-tune their poll strategy for the next two rounds of voting in the valley. Meanwhile, both Prime Minister Narendra Modi and Union Home Minister Amit Shah have also applauded the people of the Srinagar parliamentary constituency for the "encouraging turnout" of 38 per cent, which is more than double the 14.43 per cent polling in the 2019 Lok Sabha

Ironically, former Congress leader and Chairman of the Democratic Progressive Azad Party Ghulam Nabi Azad Tuesday claimed the voter turnout in the Srinagar Lok Sabha constituency is not high enough to know whether the people are happy or angry with the abrogation of Article 370 and bifurcation of Jammu



and Kashmir into two union

territories in 2019. Azad said, "I had hoped Kashmir would witness 80 to 90 percent turnout given what has happened in the past seven to eight years. Article 370 was removed, and statehood was snatched. So I thought the turnout would be high, like 90 to 95 percent.

The increase of a few percent hardly matters as it happens in every constituency of India. That way, we can not know whether the people are angry or happy (with the abrogation of Article 370 and snatching of statehood)," Azad told

reporters while campaigning for his party candidate in Kulgam district.

His observation stood in total contrast to the statement made by the Union Home Minister. "The Modi Government's decision to abrogate Article 370 is showing results in the poll percentage as well. It has enhanced people's trust in democracy and its roots have deepened in Jammu and Kashmir," Amit Shah wrote on 'X' (earlier Twitter).

Shah said that through the rise in the poll percentage, the people of Jammu and Kashmir have given a befitting reply to those who opposed the abrogation of Article 370 provisions and are still advocating its restoration. Peoples Democratic Party (PDP) President Mehbooba Mufti Tuesday appealed to the voters to vote en-mass in the remaining two phases of parliamen-

tary elections in Kashmir. Addressing people in Qazigund and Devsar, Mehbooba Mufti emphasized the importance of high voter turnout, warning against efforts by the BJP and its allies to suppress voter par-

ticipation.

The PDP President pointed to the recent elections in the Srinagar constituency, where voters turned out in large numbers, driven by a sense of suffocation and a desire to reject the actions taken on August 5, 2019. She alleged that in areas with strong PDP support, the voting process was deliberately slowed down.

In Srinagar, people who had never voted before participated in the parliamentary elections this time. They came out in droves to tell the BJP-led government that the actions taken in 2019 were unaccept-

# Mammootti is a jihadi, alleges close associate

Mammootti, touted by his fans as the "super mega star" of Malayalam films, is a jihadi working hand in glove with the CPI (M), according to his own friends and associates. It was known for quite sometime that the "super mega star" had close liaison with Islamic fundamentalists working for the disintegration of India.

The star is the chairman of the CPI (M) owned Kairali TV Network which telecasts Marxist news and ideology 24X7. While addressing the all India conference of DYFI, the vouth organization of the CPI (M), held at Chennai sometime back, Mammootti had come down heavily on the then Narendra Modi Government for the Guiarat riots.

"Had there been DYFI in Gujarat, a riot against the minority community would not have happened," Mammootti while delivering the keynote speech, Of late, Islamic fundamentalist had been a subject of discussion in the social media. What spilled the beans recently is the interview given by Mohammed Sharshad, a Chennai based businessman who is also a fellow traveler of the CPI(M) that his wife PT Ratheena, an upcoming movie maker was forced by Mammootti to direct a movie portraying the Hindus in poor

light. The film Puzhu (2022) created some controversy in Kerala but the producer laughed all his way to the bank. What made Ratheena to take up the Puzhu project instead of the script she had completed was the directive of Mammootty. What Ratheena had hoped was to make a lighthearted entertainer starring Mammootti and she was forced to toe the super star's line," said

What Sharshad told an online portal is that Mammootti wanted Ratheena to make this movie, the story of which was written by Harshad whom Sharshad himself describes as a hardcore Islamic extremist

"Puzhu" revolves around an IPS officer by name Kuttan (played by Mammootti) hailing from a high caste Hindu family and his hatred for his sister who eloped with a Harijan youth much against her family's wishes. The movie instead of delivering a social message, concluded with spitting venom and fire over the Sanatana

In Kerala, artists and technicians suspected of any links with Hindu outfits are ostracized from the film industry by the Mattancherry Mafia (a group of Islamists whose only mission is to make use of the medium of cinema to humiliate and tarnish the Sanatana Dharma).

This Mafia was behind the agitation against CAA and is "credited" with the conspiracy to sub-

# BJP has crossed 270 mark, says Shah; Mamata predicts 215 seats for INDIA Bloc End of phase IV elections

Mamata Banerjee and Amit Shah on Tuesday placed their own estimations of Parliamentary seats that their respective Blocs might have clinched till at the end of fourth phase of elections on While the Union Home

Minister on Tuesday said that the BJP had already crossed the 270 mark out of the 380 seats — that went to polls till Monday — the Bengal Chief Minister quoted from her "internal reports" predicting 195 to 215 seats for the Indian National Democratic Inclusive Alliance adding, "the weather is changing.

# AAP to be named as co accused in excise policy scam case: ED informs HC

Enforcement The Enforcement Directorate, probing the excise policy case, told the Delhi High Court on Tuesday that the Aam Aadmi Party (AAP) will be named as a coaccused in the case in its next prosecution complaint.
The submission was made by the ED's special counsel Zoheb

Hussain before Justice Swarana Kanta Sharma this afternoon, during arguments to oppose the bail application filed by AAP leader and former Delhi Deputy Chief Minister Manish Sisodia in the same case.

"AAP is going to be made a coaccused in the next prosecution complaint (charge sheet) to be filed in the case," ED's counsel said before Justice Swarana Kanta Sharma, who is hearing arguments on Sisodia's bail plea while opposing his bail plea. The probing agency further said concerted efforts are being made by the accused to delay trial in the liquor policy case.

The high court, which was hearing arguments on Sisodia's bail pleas filed in the money laundering and corruption cases lodged by the ED and CBI respectively, reserved its orders. It is pertinent to mention that a petition by AAP national chief Arvind Kejriwal contending that a political



anti-money laundering law is pending in the high court.

Recently, the high court while upholding Kejriwal's arrest in the case has held that the rigours of Section 70 of the Prevention of Money Laundering Act (PMLA), which deals with companies, are attracted in this case. The ED had likened AAP to a company and Kejriwal its director. The ED's lawyer further said there are concerted efforts by accused persons to delay the process of framing of charges in the case.

The CBI, which adopted the submissions made by ED, also opposed the AAP leader's bail plea in the corruption case and said the delay was totally attributable to the accused persons. While seeking bail

mitted that the ED and the CBI are still arresting people in the money laundering and corruption case and there is no question of early conclusion of the trial.Senior advocate Mohit Mathur, representing Sisodia, said the trial court judge, while dismissing the bail plea, has not shown how the AAP leader has contributed to the delay. "I had filed an application to physically meet my wife. Thereafter, I moved an application to sign a cheque. How does it delay the trial? How have I contributed to the delay in the proceedings? The trial court has said that out of 38 applications, 13 were filed by Sisodia. But the court has not said how my application contributed to the delay," he

#### "Post dismissal of my earlier bail, three accused have gotten some relief from the Supreme Court. Benoy Babu in ED case. Sanjay Singh, again in ED case and Arvind Kejriwal most recently. There is no threat as far as my running away is concerned. I (Sisodia) have been in custody for 14.5 months," he

argued. Showing the conduct of the accused persons, the ED counsel said 250 pleas have been filed before the trial court despite there being only 17 arrests. The investigation officer needs to be there in the court almost every day, he said. He further argued that the offence of money laundering has been held to be as grave of an offence as terrorism and other serious

building. They will explode in the following hours. This isn't a threat, you have a few hours to disarm the bomb or else the blood of innocent people inside of the building will be on your hands. The group called, "Court", is behind this massacre." This is the

fourth time in two weeks that various places, including schools, have received such threats in Delhi. While searching about the domain 'beeble.com' on google,

one finds himself in a website that offers to provide end-toend encrypted email and states, The Digital privacy, solved. Secured realm for everyone. Our end-to-end encrypted email and cloud storage solution provides the most powerful means of secure communication, ensuring the safety and privacy of your data."

Delhi Fire Śervice officials said that their phone started ringing from 10:45 am regarding bomb threat emails from the bomb threat emails from the GTB Hospital, Dada Dev Hospital, Hedgewar Hospital, and Deep Chandra Bandhu Hospital in various parts of the city. The bomb disposal squad, bomb detection team, fire department and local police rushed to the spot to conduct rushed to the spot to conduct searches, the officials said.

The AAP has claimed that it is entitled to a total area of 1,000 square metres for the construction of offices for its national and state units in view of the policies issued by the Union ministry.

It has, therefore, sought a direction to the Union ministry to take necessary steps in accordance with law to allot a suitable land to it in New Delhi to enable the party to construct offices for its national and Delhi state units at the earliest. It has also sought a direction to the authorities concerned to ensure that the land so allotted is preferably in a centrallylocated area of Delhi and free from encumbrances and encroachments, so that the construction of its offices may be commenced immediately.

# NGOs seek SC listing of PIL for SIT probe into electoral bonds scheme

wo NGOs on Tuesday I urged the Supreme Court to consider listing their PIL seeking a court-monitored probe by a special investigation team into alleged instances of "apparent quid pro quo" involving political parties, corporate entities and officials of investigative agencies in the electoral bonds scheme.

A bench comprising Justices Sanjiv Khanna and Dipankar Datta took note of the submissions of lawyer Prashant Bhushan, appearing for NGOs 'Common Cause' and the Centre for Public Interest Litigation (CPIL), that the plea needed to be listed for hearing at the earliest.

"The CJI's office is seized of it. It will be listed," Justice Khanna told Bhushan.

A five-judge Constitution bench had on February 15 scrapped the electoral bonds scheme of anonymous political funding introduced by the BJP government.

Terming it a "scam", the plea

It has sought a direction for a "court-monitored investiga-tion by an SIT into the instances of apparent quid pro quo between public servants, political parties, commercial organisations, companies, officials of investigation agencies and others, and other offences as highlighted in the present petition, as have been disclosed from the electoral bond data published by the Election Commission of

The petition has also sought a direction for investigating alleged violation of section 182(1) of the Companies Act, donated to political parties through electoral bonds within three years of their incorporation and for penalty to be imposed on such firms in terms of section 182(4) of the

The plea claimed the electoral

bond data showed that the bulk of the bonds purchased by corporate entities appeared to have been donated as quid pro quo arrangements by corporates to political parties for getting contracts, licences, leases, clearances and approvals worth crores of rupees and securing other benefits from governments or authorities controlled by governments which were in turn controlled by political

It alleged that electoral bonds were given in close proximity to action by agencies like the ED, IT or CBI, raising suspicion about the donations being "protection" money to avoid or stall action by or in exchange for regulatory inaction by various regulators like the drug controller etc

offs amount to several thousand crores, they appear to have influenced contracts worth lakhs of crores and regulatory inaction by agencies worth of thousands of crores and also appear to have allowed substandard or dangerous drugs to be sold in the market, endangering the lives of millions of people in the country," it said.

# Will carve separate State of Bundelkhand if come to power, says Mayawati

PTI ■ JHANSI (UP)

Bahujan Samaj Party chief Mayawati on Tuesday said if her party is voted to power, it will carve a separate state of Bundelkhand — the region that straddles the states of Uttar Pradesh Madhya Pradesh.

Addressing an election rally in Jhansi, Mayawati said, "There have been demands for carving a separate Bundelkhand state. If our government is formed (at the Centre), then we will take positive steps in this regard. Bundelkhand will definitely be made a separate state." Bundelkhand is a hilly region

spread across 13 districts in southwest Uttar Pradesh and northern Madhya Pradesh.

Seven districts in Uttar Pradesh — Banda, Mahoba, Hamirpur, Lalitpur, Jhansi, Jalaun, and Chitrakoot — and eight districts in Madhya Pradesh — Datia, Tikamgarh, Chhattarpur, Sagar, Damoh, and Panna — come in this region. The BSP chief also claimed that it "would not be easy" for the current BJP-led NDA to return to power, provided "the elections are free and fair," and the EVMs are not tampered with.

For the past few years, the BJP and its allies have been in power at the Centre in



most of the states. Owing to casteist, capitalist, narrow, and vindictive policies and their style of working, and due to the significant difference in their actions and words, it now seems that it would not be easy for them to return to power at the Centre, provided these elections are

# **Bitter ballot battle**

Poll rivals are rarely known for praising one another, but the current discourse has hit rock bottom

■ f the choice were for selecting the more entertaining option between the ongoing IPL or Lok Sabha elections, the latter — with its innovative taunts, snide remarks, branding family members with dirty accusations, obnoxious campaigning and mudslinging — would win hands down. With this election turning out to be more brutal and bloody than normal, social media is agog with videos of politicos that would put streetside rowdies to shame. A case in point: BJP's Mandi candidate, Kangana Ranaut, took a barrage of abuses, some too explicit to be printed. Disturbingly, even star campaigners are merrily throwing decency to the winds. The recent exchange between Prime Minister Narendra Modi and leaders of the Opposition, particularly the Congress, encapsulates the bitter nature of debate. Modi accused the Opposition leaders of being "cowards, scared of Pakistan", and the Congress shamed him by calling a corporate stooge, besides warning ominously that if he won this time too, India will see no more elections. This



exchange not only underscores the intense political polarisation, but also highlights the alarming decline in campaign standards. Modi's accusation resonates with the BJP's narrative to project itself as the sole guardian of national security. Such remarks, while appealing to a certain segment of the electorate, contribute to toxic polarisation of the polity. By insinuating that the Opposition is soft on Pakistan, Modi attempts to discredit his rivals and consolidate support by tapping into jongoistic sentiments. On the other hand, the Congress response reflects the

prevalent perception of the BJP Government's policies favouring big business owners. The Opposition's strat-

egy of portraying Modi as a representative of corporate interests seeks to appeal to the concerns of the common man. However, such charges, without substantial evidence, contribute to the erosion of trust in democratic institutions and further polarise the electorate. Besides, the Opposition has time and again accused him of being autocratic without any basis. What is particularly disconcerting is the way these accusations are delivered: Personal attack, character assassination and inflammatory rhetoric have become commonplace. Instead of engaging in substantive debates on policy issues and governance, the parties resort to sensationalism and vitriol. The falling standards of campaigning are symptomatic of deeper structural issues plaguing the democratic process. The influence of money power, the proliferation of fake news and misinformation, and the erosion of institutional checks and balances have created an environment conducive to negative campaigning and polarisation. Moreover, the advent of social media has amplified the reach and impact of divisive rhetoric. Unfortunately, the Election Commission has been rather ineffective in controlling these foul-mouthed leaders. That said, it is the responsibility of all of us to ensure that the leaders do not cross the 'Laxman Rekha'. We all can ensure that by pressing the blue button on voting day.



recent newspaper article caught everyone's attention, featuring an elderly woman who initiated a 'Sleep Service Center' for those strug-Ingling to find restful sleep. This compassionate woman would just engage in conversation with the person and sing a lullaby offering comfort akin to a mother lulling her child to sleep. The result? Clients emerged refreshed and rejuvenated after just half an hour of her soothing sessions. Isn't it astonishing that we now seek sleep therapists for what should come naturally? What does this say about our society? If animals and birds can sleep peacefully, why can't humans enjoy this innate gift of carefree slumber?

Sleep is the best form of relaxation, akin to meditation, that's why those who sleep well always keep well & feel well. It's a fact that if we get sound sleep during the night, we get up fresh being more active & feeling more energetic. However, in today's world getting sound sleep has become a rare occasion because today millions of people suffer from sleep disorders like sleep apnea, insomnia, restless leg syndrome, narcolepsy etc. In addition, the number of those who get a very broken, fitful sleep would be many times more. Sadly, many of these individuals resort to sleeping pills and drugs which ultimately make the problem worse. Knowing that tranquilisers are usually prescribed for insomnia and such other disorders as are due to anxiety and mental depression etc., one would say: 'Where are we heading?



Medical science has acknowledged several causes that lead to sleep disorders. The biggest hindrance of all that contributes to sleeplessness is bad mental health. We must understand that not being able to have restful sleep is not only in itself an unhealthy condition but also causes or aggravates many other diseases. For example, it is now recognised that sleep disturbance is one of the factors that lead to coronary heart disease. But most of us would agree subconsciously that tranquillisers are not the answer to the question of sleep disturbance.

They now know well that these drugs represent a purely symptomatic approach, ignoring the underlying problems that cause these conditions. A British medical journal recently published a report about experiments that have shown that sympathy can work well in cases of sleep disorders. It further said that in one trial, the doctors, instead of giving tranquilisers as they would have normally given, spent some time with the patients and talked with them in an open atmosphere. They just had a brief chat with them, with sympathy and also gave them a few words of advice and explained to them why they had those conditions. The results of these informal chats were astounding and the follow-up assessment showed that with this replacement of allopathy by sympathy, depression in those patients dropped from a level of 80 per cent to 40 per cent. The other fact being realised is that mental depression, anxiety, etc. are mainly due to certain lifestyles, behavioural patterns and personality traits. It was also felt that the pattern of behaviour, designated as type 'A' which is characterised by competitiveness, impatience, etc., predisposes a person to coronary diseases, hypertension, etc. As a result of these new findings, doctors all over the world are now increasingly advising such patients to practise meditation and to have proper dietary patterns. It's a medically proven fact that mental ill health adversely affects one's eating habits, which in turn, drastically influences our sleep and health. Under such a medical condition, proper meditation techniques can be of great help if practised regularly. In the hustle and bustle of living a modern life, we tend to forget that it is the quality of life that matters the most & not the quantity. Hence if we jeopardise our sleep for silly reasons, we are knowingly undermining our health

# Stopping thieving through DBT

A lot of pilfering from fertiliser subsidies is happening due to policy flaws. This can be curbed if only the subsidy is given under Direct Benefit Transfer



n January 22, 2019, addressing NRIs and Indian-origin peoole at the inauguration of the 15th Pravasi Bharatiya Divas convention in Varanasi (Uttar Pradesh), Prime Minister Narendra Modi recalled what Rajiv Gandhi had Stated "Of the funds the Central Government sends, only 15 per cent of that reaches the people. If one rupee is sent from Delhi, only 15 paise reaches the villages, 85 paise disappear. Even as the country's middle class kept giving tax honestly, this "loot" of 85 per cent also continued". Modi added "I also want to tell you today's truth as well. We used technology to end this loot of 85 per cent completely. Elaborating on this theme, he explained: In the last four-and-a-half years, about Rs 580,000 crore, our Government, through various schemes viz. for a home, for education, for scholarship, for gas cylinder and to other such ends etc directly gives to the people, transferring it in their bank accounts. Now, just consider that if the country was being run through the old system, then even today from this Rs 580,000 crore, about Rs 450,000 crore would have disappeared or leaked. If we would not have brought a change in the system then this amount would have been looted like the former Prime Minister had accepted...," Modi

That was before the 2019 General Elections. Today, when the 2024 General Elections are underway, the same discourse reverberates in the air even as the PM cites a figure that is nearly seven times. The amount spent on welfare schemes during the last ten years under the Modi - regime has gone up to a gargantuan of around Rs 4000,000 crore. Had the old system (read: before 2014) continued, the amount disappearing from the distribution pipe would have been Rs 3400,000 crore (4000,000x0.85). What do the facts say?

The Union Government executes a plethora of welfare programs aimed at providing basic and necessary amenities and upliftment of the most disadvantaged members of society. It does so mainly through "Central Schemes" (CS) which are fully

funded and implemented by it. A total of

740 CS schemes are currently under imple-

mentation. During FY2022-23, the CS

spending was Rs 1208,000 crore In addition, there are "Centrally Sponsored Schemes" (CSS) designed to supplement the efforts of the States in achieving various socioeconomic goals and implementing national priorities. These are funded by the central Government and the States in varying proportions viz. 90:10, 60:40, 50:50 and so on depending on the scheme. These schemes are implemented by the States. During FY2022-23, the spending on a total of 50 CSSs was Rs 412,000 crore. Put together, the total expenditure of the Central Government on CS and CSS schemes during the year was Rs 1620,000 crore.

Now, if we were to apply the 85 per cent magic formula dished out by the then Prime Minister Rajiv Gandhi, the amount pilfered while on the way to the beneficiaries would have been Rs 1377,000 crore. Only Rs 243,000 crore would have reached. Under the Modi - model, the entire Rs 1620,000 crore has been reached; courtesy of, the use of technology to transfer the money to their bank accounts.

How does it work?

Under its flagship Digital India pro-

gram, the Modi - Government has been implementing what is popularly known as DBT (Direct Benefit Transfer) for transferring the cash benefits and subsidies 'directly' to the Aadhaar-linked bank accounts of individual eligible beneficiaries. Launched by the erstwhile UPA -Government on January 1, 2013, its use has picked up pace under Modi since January 2015. As of date, DBT is used in 314 CS schemes.

The JAM trinity (Jan Dhan, Aadhar, Mobile) is a DBT enabler the 'mover and shaker' behind its successful implementation. Today, there are around 520 million Jan Dhan Accounts, more than 1.39 billion Aadhaar cards and 1.15 billion mobile connections. With this, the money can be 'instantaneously'

transferred at the click of a mouse to tens of millions of beneficiaries spread all over the country. The DBT is free from the delays corruption and associated pilferage that was germane to the earlier arrangements under which there was human intervention, a host of intermediaries/mediators and the money was flowing through multiple layers in administrative offices. To improve transparency, the Government has put in place the

Central Plan Scheme Monitoring System (CPSMS) which ensures that all transfers to bank accounts are made strictly as per the list of eligible beneficiaries. The persons included in the list are authenticated with the use of an Aadhaar card that contains their biometric details thus removing any scope for fictitious claimants. The provision for such checks and balances has helped hugely in preventing bogus claims. As per the latest update on the DBT portal, the total savings by way of plugging leakages in the schemes aue to the implementation of DB1 during FY2022-23 was Rs 63,000

However, if we look at the food subsidy (the excess of the cost of procurement, handling and distribution of food over the price paid by the beneficiary/consumer), during FY2022-23, the Government was able to save over Rs 50,000 crore which works out to around 18 per cent in the total food subsidy bill of Rs 272,000 crore. This was made possible because of the "deletion of over 50 million duplicate and fake/non-existent Ration Cards".

Likewise, under the Pradhan Mantri Kisan Samman Nidhi or PM-KISAN (, the Union Government provides income support of Rs 6,000 a year to farmers with a valid enrolment, paid in three equal cash transfers of Rs 2,000 every four months; the money is credited to

it was able to save over Rs 10,000 crore during FY2022-23. This is about 17 per cent of the total payment of Rs. 58,000 crores during the year. The savings were due to the deletion of over 21 million ineligible beneficiaries.

According to the DBT portal, the Government has been able to generate a cumulative saving of Rs 348,000 crore by plugging leakages since the inception of the DBT. Of this, more than half or Rs 185,000 crore are savings in the distribution of food subsidies alone.

Notwithstanding the above, there remains a huge untapped potential for garnering more savings. This is because in the initial years, neither States used Aadhaar for validation nor the Centre made it compulsory even as the latter's efforts in this regard were hamstrung due to protracted litigation in the top court. In such circumstances, a large number of 'ineligible' persons making their way to the beneficiary list was inevitable. While the Government got rid of them in some schemes like PM-KISAN, it has a long way

Meanwhile, Modi also needs to focus on areas where technology intervention alone won't help. For instance, in fertilisers, the Government asks manufacturers to sell fertiliser at a low price to farmers. The excess of the cost of supply over it is claimed by the latter from the former as a subsidy. Since the subsidy is embodied in the MRP (albeit low), the subsidised fertiliser product must reach the farmer and be used only for growing the crop. If it doesn't reach, then the benefit of subsidy is enjoyed by the person who grabs it. A lot of pilferage from fertiliser subsidies is happening due to this flaw in policy. This can be curbed if only the subsidy is given 'directly' to the farmers under DBT.

For filmmakers, the choice of which festival to submit their work to often depends not only on the esteem and reputation of the event but also on its alignment with their artistic vision and career goals. A filmmaker seeking international recognition may gravitate towards Cannes or Berlinale, while those championing a wide and diverse range of filmography might find a home at Venice or TIFF. In this way, the branding of film festivals becomes a crucial factor in shaping the trajectory of filmmakers' careers and the cultural nuances of movies as a whole.

# **Ex-Indian Army officer with UN killed in Gaza**

#### **First international casualty** since Israel-Hamas conflict

former Indian Army offi-Acer working with the United Nations was killed in Gaza when the vehicle he was travelling in came under attack in strife-torn Rafah, becoming the "first international casualty" for the world body since the Israel-Hamas conflict started

The United Nations has called for a full investigation while Israel has ordered a separate investigation into the attack. Col Waibhav Anil Kale, 46, who took premature retirement from the Indian Army in 2022, joined the UN as a Security Coordination Officer in the United Nations Department of Safety and Security (DSS) two months ago, officials in New Delhi said on Tuesday

Kale, who had served with the 11 Jammu & Kashmir Rifles, was travelling along with

another DSS staffer to the European Hospital in Rafah when their UN vehicle was struck on Monday morning. The other person, not identified, was seriously injured. According to Kale's LinkedIn

profile, he had joined the Indian Army in April 2004 and had also served as Contingent Chief Security Officer with the United Nations between 2009 and 2010. He did his B.A. from the Jawaharlal Nehru University in New Delhi and had degrees in Behavioral Science and International Humanitarian Law and had studied at, among other institutions, the Indian Institute of Management at Lucknow and

Secretary-General Antonio Guterres was "deeply saddened to learn of the death a United Nations Department of Safety and Security (DSS) staff member and injury to another DSS



A statement by Farhan Hag Deputy Spokesman for the Secretary-General, said that Guterres condemned all attacks on UN personnel and called for a full investigation. Guterres sent his condolences to the family of the fallen staff member.

### Indonesian rescuers search through rubble after floods kill 50

Tanah Datar (AP): Rescuers on Tuesday searched in rivers and the rubble of devastated villages for bodies, and whenever possible, survivors of flash floods that hit Indonesia's Sumatra Island over the weekend. Monsoon rains and a landslide of mud and cold lava from Mount Marapi caused rivers to breach their banks. The deluge tore through mountainside villages in four districts in West Sumatra province just before midnight

Saturday. The floods swept away people and 79 homes and submerged hundreds of houses and buildings, forcing more than 3,300 residents to flee to temporary government shelters, National Disaster Management Agency spokesperson Abdul Muhari

Muhari said 50 bodies had been pulled from mud and rivers by Tuesday, mostly in worst-hit Agam and Tanah Datar districts, while rescuers are searching for 27 people who are reportedly missing. Television reports showed rescue personnel using jackhammers, circular saws, farm tools and sometimes their bare hands, digging desperately in Agam district where roads were transformed into murky brown rivers and villages covered by thick mud, rocks, and uprooted trees.

Scores of rescue personnel were searching through a river around the Anai Valley Waterfall area in Tanah Datar district where tons of mud rocks and trees were left from flash floods.

Rescuers were focused on finding four people from a group of seven that were swept away with their cars. Three other bodies were pulled out on Monday, said Abdul Malik, who heads the Search and Rescue Office in Padang, the provincial capital.

# Palestinians mark 76 years of dispossession as even larger catastrophe unfolds in Gaza

 $P^{\text{alestinians on Wednesday}}_{\text{will mark the 76th year of}}$ their mass expulsion from what is now Israel, an event that is at the core of their national struggle. But in many ways, that experience pales in comparison to the calamity now unfolding

Palestinians refer to it as the "Nakba," Arabic for "catastro-phe." Some 700,000 Some Palestinians — a majority of the prewar population - fled or were driven from their homes before and during the 1948 Arab-Israeli war that followed Israel's establishment.

After the war, Israel refused to allow them to return because it would have resulted in a Palestinian majority within its borders. Instead, they became a seemingly permanent refugee community that now numbers some 6 million, with most living in slum-like urban refugee camps in Lebanon, Syria, Jordan and the Israeli-occupied West Bank

In Gaza, the refugees and their

three-quarters of the popula-

Israel's rejection of what Palestinians say is their right of return has been a core grievance in the conflict and was one of the thorniest issues in peace talks that last collapsed 15 years ago. The refugee camps have always been the main bastions of Palestinian militancy. Now, many Palestinians fear a repeat of their painful history on an even more cataclysmic

All across Gaza, Palestinians in recent days have been loading up cars and donkey carts or setting out on foot to already overcrowded tent camps as Israel expands its offensive. The images from several rounds of mass evacuations throughout the seven-month war are strikingly similar to black-andwhite photographs from 1948. Mustafa al-Gazzar, now 81, still recalls his family's monthslong flight from their village in what is now central Israel to the southern city of Rafah, when he was 5. At one point they were

bombed from the air, at another, they dug holes under a tree to sleep in for warmth.

Al-Gazzar, now a great-grandfather, was forced to flee again over the weekend, this time to a tent in Muwasi, a barren coastal area where some 450,000 Palestinians live in a squalid camp. He says the conditions are worse than in 1948, when the UN agency for Palestinian refugees was able to regularly provide food and other essentials

"My hope in 1948 was to return, but my hope today is to survive," he said. "I live in such fear," he added, breaking into tears. "I cannot provide for my children and grandchil-

The war in Gaza, which was triggered by Hamas' October 7 attack into Israel, has killed over 35,000 Palestinians, according to local health officials, making it by far the deadliest round of fighting in the history of the conflict. The initial Hamas attack killed some 1,200 Israelis

The war has forced some 1.7

million Palestinians — around three quarters of the territory's population — to flee their homes, often multiple times. That is well over twice the number that fled before and during the 1948 war.

Israel has sealed its border. Egypt has only allowed a small number of Palestinians to leave, in part because it fears a mass influx of Palestinians could generate another long-term refugee crisis. The international community

is strongly opposed to any mass expulsion of Palestinians from Gaza — an idea embraced by far-right members of the Israeli government, who refer to it as "voluntary emigration." Israel has long called for the refugees of 1948 to be absorbed into host countries, saying that calls for their return are unrealistic and would endanger its existence as a Jewish-majority state. It points to the hundreds of thousands of Jews who came to Israel from Arab countries during the turmoil following its establishment, though few or them want to return

### Georgian parliament approves divisive 'foreign influence' bill

The Georgian parliament on Tuesday approved in the third and final reading a divisive bill that sparked weeks of mass protests, with critics seeing it as a threat to democratic freedoms and the country's aspirations to join the European Union. The bill requires media and

nongovernmental organisations and other nonprofits to register as "pursuing the interests of a foreign power" if they receive more than 20 per cent of their funding from abroad. The government says the bill is necessary to stem what it deems as harmful foreign influence over the country's politics and to prevent unspecified foreign actors from trying to destabilise it. The opposition has denounced

the bill as "the Russian law,' because Moscow uses similar legislation to crack down on independent news media, nonprofits and activists critical of the Kremlin. Mass protests against the law in recent weeks have swept the South Caucasus



nation of 3.7 million.European Council President Charles Michel on Tuesday spoke of Georgia in Copenhagen, at a conference on democracy, and said that "if they want to join the EU, they have to respect the fundamental principles of the rule of law and the democratic principles.

The bill is nearly identical to one that the governing Georgian Dream party was pressured to withdraw last

year after street protests. Renewed demonstrations have rocked Georgia for weeks, with demonstrators scuffling with police, who used tear gas and water cannons to disperse the crowds.

Georgian President Salome Zourabichvili, who is increasingly at odds with the governing party, has vowed to veto the law, but Georgian Dream has a majority sufficient to override a presidential veto.

#### 2 French officers killed, 3 injured in convoy attack

Paris (AP): Two French prison officers were killed and three others seriously injured when their prison convoy was attacked Tuesday in Normandy, officials said. The attack occurred as the convoy was returning to Évreux jail after a court hearing in Rouen, according to French outlet

Justice Minister Eric Dupond-Moretti said he would join a crisis unit to address the emer-

gency.

#### **Aussie army** whistleblower sent to jail

Melbourne (AP): An Australian judge sentenced a former army lawyer to almost six years in prison on Tuesday for leaking to the media classified information that exposed allegations of Australian war crimes in Afghanistan.

David McBride, 60, was sentenced in a court in the capital, Canberra, to five years and eight months in prison after pleading guilty to three charges including theft and sharing with members of the press documents classified as secret. He had faced a potential life sentence. Justice David Mossop ordered McBride to serve 27 months in prison before he can be considered for release on parole. Rights advocates argue that McBride's conviction and sentencing before any alleged war criminal he helped expose reflected a lack of whistleblower protections in Australia McBride's lawyer Mark Davis said he planned to file an appeal against the severity of the sentence.

#### Biden hiking tariffs on Chinese EVs, solar cells, steel, aluminum The Biden administration **▲** announced plans to slap new tariffs on Chinese electric vehicles, advanced batteries, solar cells, steel, aluminum and medical equipment — an election year move that's likely to increase friction between

economies. The tariffs come in the middle of a heated campaign between President Joe Biden and his Republican predecessor, Donald Trump, in which both candidates are vying to show who's tougher on China. The tariffs are unlikely to have much of an inflationary impact because of how they're structured. Administration officials said they think the tariffs won't escalate tensions with China, yet they expect China will explore ways to respond to the new taxes on its products. It's uncertain what the long-term impact on prices could be if the tariffs contribute to a wider trade dispute.

over the next three years, with those that take effect in 2024 covering EVs, solar cells, syringes, needles, steel and aluminum and more. There are currently very few EVs from China in the US, but officials worry low-priced models made possible by Chinese government subsidies could soon start flooding the U.S. market. Chinese firms can sell EVs for as little as USD 12,000. Their solar cell plants and steel and aluminum mills have enough capacity to meet much of the world's demand, with Chinese officials arguing their producwould aid a transition to the green economy

Lael Brainard, director of the White House National Economic Council, said the tariffs will raise the cost of select Chinese goods and help thwart Beijing's efforts to dominate the market for emerging technologies in ways that pose risks to US national security and economic stability.

"China is simply too big to play by its own rules," Brainard told reporters on a Monday call previewing the announcement. Administration officials have stressed the decision on tariffs was made independently of November's presidential election. But Brainard noted in her remarks the tariffs would help workers in Pennsylvania and Michigan, two of the battleground states that will decide who wins the election.

Under the findings of a fouryear review on trade with China, the tax rate on imported Chinese EVs will rise to 102.5 per cent this year, up from total levels of 27.5 per

en under Section 301 of the Trade Act of 1974, which allows the government to retaliate against trade practices deemed unfair or in violation of global standards.

Under the 301 guidelines, the tariff rate is to double to 50 per cent on solar cell imports this year. Tariffs on certain Chinese steel and aluminum products will climb to 25 per cent this year. Computer chip tariffs will double to 50 per cent by

For lithium-ion EV batteries, tariffs will rise from 7.5 per cent to 25 per cent this year. But for non-EV batteries of the same type, the tariff increase will be implemented in 2026. There are also higher tariffs on ship-to-shore cranes, critical minerals and medical prod-

The new tariffs, at least initially, are largely symbolic since they will apply to only about USD 18 billion in imports. A new analysis by Oxford Economics estimates the tariffs will have a barely noticeable up inflation by just 0.01 per

# **EU** agrees on a new migration pact

 $E^{uropean\ Union\ nations}_{endorsed\ sweeping\ reforms}$ to the bloc's failed asylum system on Tuesday as campaigning for Europe-wide elections next month gathers pace, with migration expected to be an important issue. EU government ministers

approved 10 legislative parts of The New Pact on Migration and Asylum. It lays out rules for the 27 member countries to handle people trying to enter without authorisation, from how to screen them to establish whether they qualify for protection to deporting them if they're not allowed to stay. Hungary and Poland, which have long opposed any obligation for countries to host

migrants or pay for their upkeep, voted against the package but were unable to block it. Mainstream political parties believe the pact resolves the issues that have divided member nations since well over 1 million migrants swept into Europe in 2015, most fleeing war in Syria and Iraq. They hope the system will starve the far right of vote-winning oxygen in the June 6-9 elections. However, the vast reform

package will only enter force in 2026, bringing no immediate fix to an issue that has fuelled one of the EU's biggest political crises, dividing nations over who should take responsibility for migrants when they arrive and whether other countries should be obligated to

Critics say the pact will let them EU members. It means

nations detain migrants at borders and fingerprint children. They say it's aimed at keeping people out and infringes on their right to claim asylum. Many fear it will result in more unscrupulous deals with poorer countries that people leave or cross to get to Europe. Europe's asylum laws have not

# Blinken: US arms to aid Ukraine amid new Russian offensive

US Secretary of State Antony Blinken said Tuesday that American military aid on its way to Ukraine will make a "real difference" on the battlefield, as the top diplomat made an unannounced visit to reassure an ally facing a fierce new Russian offensive In increasingly intense attacks along the northeastern border in recent days, Moscow's troops have captured around 100 to 125 square kilometres (about 40 to 50 square miles) of territory that includes at least seven villages, according to open source monitoring analysts. Though most of those villages were already depopulated, thousands of civilians in the area have fled the fighting. Analysts have called this moment one of the most dangerous for Ukraine since Russia's full-scale invasion in February 2022 - and Volodymyr President Zelenskyy asked Tuesday for



fire in the northeast. "We know this is a challenging time," Blinken said in the Ukrainian capital where he met with Zelenskyy. But he added that American military aid is "going to make a real dif-

ference against the ongoing Russian aggression on the battlefield?

The visit comes less than a month after Congress approved a long-delayed foreign assistance package that

for Ukraine, much of which will go toward replenishing badly depleted artillery and air defense systems. Some of that "is now on the way," Blinken said, and some has already arrived in Ukraine.

Moscow's renewed offensive in the northeastern region of Kharkiv is the most significant border incursion since the early days of the war — and comes after months when the roughly 1,000-kilometre (620-mile) front line barely budged. More than 7,500 civilians have been evacuated from the area, according to authorities. The Kremlin's forces are also expanding their push to the northern border regions of Sumy and Chernihiv, Ukrainian officials say, and Kyiv's outgunned and out-numbered soldiers are struggling to hold them back.

Troops fought street to street on the outskirts of Vovchansk, which is among the largest towns in the Kharkiv area, regional Gov. Oleh Syniehubov said on national television.

Two civilians were killed in Russian shelling Tuesday, he said. The UN human rights office said the battles are taking a heavy toll.

"We are deeply concerned at the plight of civilians in Ukraine," Liz Throssell, spokeswoman for the office of the UN High Commissioner for Human Rights, said in Geneva. "In the Kharkiv region, the situation is dire." Zelenskyy thanked Blinken for the US aid — but added that more is necessary, including two Patriot air defense sys-

spokesperson Matthew Miller. The US diplomat and the Ukrainian president also discussed long-term security arrangements and Ukraine's economic welfare.

Blinken was due to give a speech later Tuesday extolling Úkraine's "strategic successes" in the war. It is intended to complement a Blinken address last vear in Helsinki, Finland, deriding Putin for Moscow's strategic failures in launching the war. Since the Helsinki speech, however, Russia has intensified its attacks, most noticeably as the US House of Representatives sat on the aid package for months without action, forcing a suspension in the provision of most US assistance. Those attacks have increased in recent weeks as Russia has sought to take advantage of Ukrainian shortages in manpower and weapons while the new assistance is in transit. Meanwhile, Russian President Vladimir Putin plans to make a two-day state visit to China this week, the Chinese Foreign Ministry

said. Beijing has backed Moscow politically in the war and has sent machine tools, electronics and other items seen as contributing to the Russian war effort, without actually exporting weaponry. "A strong, successful, thriving, free Ukraine is the best possible rebuke to Putin and the best possible guarantor for your future," Blinken told Zelenskyy in Kyiv. The senior US official said despite some recent setbacks, Ukraine could still claim significant victories. Those include reclaiming some 50 per cent of the territory Russian forces took in the early months of the war, boosting its economic standing and improving transportation and trade links, not least through military successes in the Black Sea. Days after being sworn in for a fifth term, Russian President Vladimir Putin will travel to China on Thursday on a two-day state visit to discuss with his close friend and Chinese counterpart Xi Jinping the future course of their strategic alliance amid mounting pressure on Beijing to scale down its support to Moscow's continuing war in Ukraine.

At the invitation of Xi, Putin will pay a state visit to China from May 16 to 17, the first state visit since his new term as president began, Chinese Foreign Ministry spokesperson Wang Wenbin told a media briefing here on Tuesday.

Both leaders will exchange views on bilateral relations, cooperation in various fields, and international and regional issues of mutual interest in light of the 75th anniversary of China-Russia diplomatic relations, he said.

During his visit, Putin, who was sworn in for his fifth Presidential term on May 7,



will travel to two cities: Beijing and Harbin.

Putin's visit to China, the second in about eight months, follows Xi's just concluded European Union tour to France, Serbia and Hungary. In his talks with French President Emmanuel Macron and EU Commission chief Ursula von der Leyen, Xi pledged that China would not sell arms to Russia and would control the flow of dual-use goods to its military.

The US too is mounting pressure on China not to sell arms to Russia to further its war in Ukraine.

While Xi, 70, regards his ties with Putin, 71, as counter to the US' increasing hostility towards China, which Beijing says is aimed at countering its rise, there is unease here over Putin's continuation of the Ukraine war.

Though Beijing has not publically supported Russia's inva-sion of Ukraine, the "no lim-

partnership has come under intense scrutiny from the United States and its allies, who have imposed sanctions on Moscow and repeatedly called Beijing to use its leverage to bring the war to an end. Ahead of Putin's visit, Russian Foreign Minister Sergey Lavrov said Russia and China have many allies and will have many more in the future, Russia's state-run Tass news agency reported on Tuesday."We have many allies, and their number will continue to grow, I have no doubt. And, of course, all this will be for the benefit of democratisation of international relations, when everyone will take his place in world affairs by right, according to the real contribution to the development of the world economy, world politics, world security, and not through blackmail, threats, ultimatums," Lavrov said. Lavrov stressed that Moscow

order, he said. "China has become the leader of global development. Additionally, they will "determine the key directions of the further development of Russian-Chinese practical cooperation" and exchange opinions on the most pressing international issues.

# Another top Russian official held amid Kremlin shake-up

A second senior Russian defence official was arrested on bribery charges, officials said Tuesday, days after President Vladimir Putin replaced the defence minister in a Cabinet shake-up that fuelled expectations of more

such purges.
Lt. Gen. Yury Kuznetsov, the 55-year-old chief of the Defence Ministry's main personnel directorate, was arrested in a raid early Monday on his suburban Moscow villa, Russian media reported. He was detained on charges of bribery and jailed pending an investigation and trial, according to the Investigative Committee, Russia's top state criminal investigation agency. Kuznetsov is accused of accepting an "exceptionally large bribe," a charge punishable by up to 15 years in prison. The committee alleged he received the bribe in his previous post as head of the military General Staff's directorate in charge of preserving state secrets, a posi-

tion he held for 13 years. In the raid, agents of the Federal Security Service, or FSB, broke down the doors and windows of his home while he was asleep, the reports said, seizing gold coins, luxury items and over 100 million rubles (just over USD 1 million) in

cash.

His wife, who previously worked in several Defence Ministry structures, was also reportedly interrogated.

On Sunday, Putin reshuffled his Cabinet as he starts his fifth term in office, replacing Sergei Shoigu, who served as defence minister for 11 1/2 years, with Andrei Belousov, an economics expert and former deputy prime minister. Putin named Shoigu the secretary of Russia's Security Council, a role roughly similar to the US national security adviser, replacing Nikolai Patrushev. Patrushev, a hawkish and pow-

erful member of Putin's inner circle who held the job for 16 years, was appointed a presidential aide. Alexei Dyumin, the governor of the Tula region

and often mentioned as a potential Putin successor, also was named a presidential aide. Patrushev will oversee Russian shipbuilding industries in his new job, but may later also deal with other duties, Kremlin spokesman Dmitry Peskov said Tuesdav.

He rejected notions that Shoigu's reshuffle represented a demotion, describing his new role as a "very senior job with broad responsibilities."

While Shoigu, who had personal ties with Putin and accompanied him on vacations in the Siberian mountains over the years, was given a new senior position, the future of his close entourage in the Defence Ministry appeared in doubt under Belousov.

Shoigu's deputy, Timur Ivanov, was arrested last month on bribery charges and was ordered to remain in custody pending an official investiga-

His arrest was widely interpreted as an attack on Shoigu and a possible precursor to his dis-

# Pakistan, IMF start talks for fresh bailout package

 $\mathbf{P}^{akistan}$  and the IMF have started negotiations for a fresh bailout package to address the cash-strapped country's fiscal challenges and implement crucial reforms, media reports said on Tuesday.

On Monday, the International

Monetary Fund's (IMF) mission chief to Pakistan, Nathan Porter, called on Finance Minister Muhammad Aurangzeb to "kick start the discussions on further engagement with the Fund," the Ministry of Finance said in a statement. "The finance minister welcomed the IMF team and thanked them for the successful completion of the Stand-By Arrangement (SBA)," said the ministry statement. Aurangzeb also "apprised the

IMF team about the improvement in the macroeconomic indicators over the course of the SBA and underscored the government's commitment to continue with and expand upon the reform agenda". Last month, Pakistan completed a short-term USD 3 billion programme with the IMF, which bailed the country out of any default. It was unclear whether the IMF mission would end with a formal staff-level agreement for the next bailout package, according to The Express

Tribune newspaper. The duration, instrument, and size of the next IMF programme were open to discussion, the report said, quoting

# Significant percentage of Indian firms hit by ransomware attacks in 2023: Sophos

PTI ■ NEW DELHI

Nearly 64 per cent of Indian organisations surveyed were hit by ransomware attacks in 2023, a latest report by Sophos said on Tuesday, noting that while the attack rates fell year-on-year, the impact on victims actually intensified. The average ransom demand was USD 4.8 million, with 62 per cent of demands

exceeding USD 1 million. The median ransom paid was USD 2 million, the report by the global cybersecurity solutions

provider said. Put simply, ransomware refers to malicious software or malware that seizes files on a computer, network share, backups, and server, and encrypts them, following which the attacker exhorts the user to cough up money to unlock the files.

Typically, ransomware attacks come with a timeline, threatening users that if ransomware demands are not fulfilled, the users will lose files. According to the 'State of Ransomware in India 2024' report by Sophos, there has been a decrease in the rate of

ransomware attacks against Indian organisations from the 73 per cent reported in last study (2022) to 64 per cent in 2023. Notably though, "the impact on victims has intensified, with higher ransom demands and recovery costs compared to the previous year".



The findings are derived from an independent survey of 5,000 IT decision makers countries. including 500 respondents in India. Conducted in January February and respondents were asked to answer based on their experiences in the previous 12 months.

For the first time, Indian organisations were found to be more likely to recover data by paying the ransom (65 per cent) than using backups (52 per cent). The report revealed that 44 per cent of impacted computers an average were encrypted in attacks against Indian victims.

Palm oil accounted for 52 per cent of India's total edible oil imports of 13,04,409 tonnes in April, the trade body said in a statement, adding that sunflower and soybean oils import stood at 6,20,315

Including non-edible oils, overall vegetable oil imports rose 26 per cent in April 13,18,528 tonnes compared to 10,50,189 tonnes a year ago, it

Bearish global prices encouraged higher imports of bleached and refined, deodorized (RBD) palmolein and crude palm oil (CPO), which declined by nearly USD 100 a tonne last month, SEA said.



Soybean oil prices fell USD 40 For soft oils, soybean oil per tonne globally, while the sunflower oil rate dropped just USD 15 a tonne over the last month, it added.

Among palm oils, RBD 1,24,228 tonnes as against 1,12,248 tonnes in the year-

ago period. CPO (crude palm shipments increased 36 per cent to 5,36,248 tonnes over 3,93,856 tonnes, while crude palm kernel oil imports jumped nearly 6-fold to 23,618 tonnes from 3,990

The Union of European Football Associations is offering a communications deal between referees and teams at the European Championship - we will do more to explain decisions, you let only captains approach to discuss them. UEFA has this week gathered

# NADA needs enhanced budget to conduct more tests at junior level, says expert

**PTI** BHUBANESWAR

The Increase in doping violations by minors in India is a cause of concern and NADA needs an enhanced budget to at least keep the menace in check as complete eradication would be tough, feels noted sports medicine expert PSM Chandran.

Chandran, who is currently heading Sports and Exercise Science at the Khelo India State Centre of Excellence at Kalinga Stadium here, said roping in celebrities to propagate the harmful effects of doping could be a good way to reach out to youngsters.

"First of all, let's make it clear, those who dope constitute 2.5 to three per cent of all the athletes, the other 96.5 to 97

per cent are clean. In sports, there always will be doping, it's a matter of how best you can keep it under control and not about eradicating it," Chandran told PTI in an interview.

"Since the minors are also competing, some of them will do doping, whatever may be the reason. It (doping by minors) is a cause of concern but is not something unexpected. Just like adult sportspersons, they (minor athletes) also think they can get admission (to educational institutions) or get jobs if they


get a medal. Moreover, dope testing at junior levels is minimal because of lack of funds (for NADA) and they might be thinking that the chance of Chandran, who has served as

getting caught is less." In a report published by World

Anti-Doping Agency (WADA) in January, India was named as the second worst country in a 10-year global study of positive doping cases by minors. Russia topped the list, followed by India and China.

Last month, in another WADA report, India registered the highest percentage of failed dope tests among countries which tested more than 2000 samples, based on the figures of 2022. India tested 3865 samples

(urine, and blood combined) during the recorded period, of which 125 returned adverse analytical findings. amounted to 3.2 per cent of the samples

# Shastri, Ashwin back Impact Player rule

The "Impact Player" rule might have come in for sharp criticism in the ongoing IPL, but former India coach Ravi Shastri and senior spinner Ravichandran Ashwin have backed it, stating that it leads to more close finishes.

The rule, implemented in the competition last season, has been a topic of debate this edition, with some experts and current players saying that it will make all-rounders redundant.

When any new rule comes in, there will be people who will try to justify why that's not right," Shastri said.

"But with time, when you see the scores — 200 and 190 and then, individuals grabbing that opportunity and making the most of it, people will start re-looking at how they think about it."

Shastri vouched for the rule, saying that the game has to evolve with time.

'The Impact Player (rule) is good. You have to evolve with the times. It happens in other sports as well. It's got tighter finishes," he said on Ashwin's YouTube channel.

"I think it's a good rule. You saw the number of tight finishes we had in last year's IPL. So, it has made a big

difference." BCCI Secretary Jay Shah had recently said that the rule is not permanent.
"Impact Player is like a test

case. We have implemented it slowly. The biggest advantage of it is that two Indian players are getting a chance (in each game), which is the most important," he told the media in Mumbai last week.

We will consult with the franchises, players, broadcasters (and take a call). This is not permanent, (but) I am not saying that it will go.

"(We'll see) if it's making the game more competitive or not. Even then, if a player feels that this is not right, then we will talk to them. But no one has told us anything yet. So, it will be decided after the World

Cup."
India skipper Rohit Sharma and Delhi Capitals' Axar Patel and Mukesh Kumar, also expressed their displeasure

with the rule. "I genuinely feel it is going to hold back the development of all-rounders because eventually cricket is played by 11 players, not 12," Rohit had said a couple of weeks back.

"So, I am not a big fan of the Impact Player rule because you are taking so much from the game just to make it a little more entertaining for the people around you.

India will put to test its best strategies and combinations during the European leg of the FIH Pro

League as it would be the last opportunity to shortlist the final squad for the Paris Olympics, said men's hockey team captain Harmanpreet Singh on Tuesday.

The team left for Antwerp, Belgium on Tuesday for the challenging league, where the winner of this season will be determined. India, currently third in the points table, behind the Netherlands and Australia, will play Belgium and Argentina in Antwerp between May 22 and 26. It will be followed by matches against Germany and Great Britain from June 1-9 in

London. "We are trying out the best combinations before the final squad is selected for the Olympics. Hence, the Pro League outing is crucial in our preparations for Paris as well as for players to make it to the 16-member squad for Paris," said drag-flicker Harmanpreet in a Hockey India release before the team left for Europe.

Last month, India, the Tokyo Olympics bronze medallists, lost all their five matches in Australia, raising doubts about their preparations for the Paris Games

Harmanpreet said the team will focus on eliminating any chinks in its armour ahead of Paris.

'The team is quite excited to get back on the road again for yet another challenging outing where we will take on world's best teams in the Pro League. We will be travelling on the back of a very intense training camp over the past few weeks where we focused on our conditioning and played intra-squad matches regularly. The team is shaping well and the Pro League is an important event for us to



iron out the flaws in our execution ahead of the Olympics," said

Harmanpreet. The skipper said the Pro League will not just help him asses his team's

preparations but also provide cues into the rivals' strategies.

"We have Belgium and Argentina in our pool at the Olympics along with Australia, Ireland and New Zealand. We play Belgium and Argentina both in Antwerp. Harmanpreet hoped that after

finishing third in the last few seasons of the Pro League, his team would stake claim to the title this time around.

'In the past few seasons of the Pro League, we have finished at third position. It will be great to finish on top this time and we are quite optimistic about it," Harmanpreet

# Paddler Manika Batra reaches career high ranking of world number 24

Ace women's table tennis Player Manika Batra rose to a career-best singles ranking of 24 following her success in the Saudi Smash, becoming the first Indian woman paddler to break into the top-25 in world rankings.

The 28-year-old Khel Ratna awardee, who was in 39th spot the tournament, before jumped 15 spots following her run in Jeddah, where she reached the quarterfinals.

Manika, the 2018 Commonwealth Games gold medallist in individual and team categories, had shocked multiple-time world champion and Olympic gold medallist China's Wang Manyu (seeded second) on her way to the last-



eight in the Saudi Smash. It was also the first time an Indian women advanced that far in the tournament. Manika's rise through the draw finally earned her 350 points. In an Instagram post, Manika,

who had made history by becoming the first Indian

paddler to reach the women's

singles quarterfinals at the Hangzhou last year, wrote that the ranking boost had come at the right time as she aims to secure a Paris Olympics berth. "An extreme confidence boost on the road to Paris 2024. Breaking into the Top-25 and achieving the best rank ever achieved by an Indian in women's singles of the ITTF Ranking," wrote Manika. Manika also thanked her coach

Aman Balgu and sparring partner Kirill Barabanov of Belarus for her success.

# Manu, Vijayveer win final 25m pistol Olympic Selection Trials

Olympian Manu Bhaker and Paris quota winner Vijayveer Sidhu won the fourth and final Olympic Selection Trial (OST) in 25m pistol events here on

Tuesday.
At the M P State Shooting Academy, Manu, coached by the legendary pistol shooter Jaspal Rana, shot a world record-equalling 42 in the women's 25m Pistol OST T4 final, while Vijayveer shot 34 in the decider of the men's 25m rapid-fire pistol OST T4 to emerge triumphant.

Manu displayed complete dominance in the trials, winning two and coming second in the other two.

She was also the only shooter among the selected five to not score below 580 in the qualification round even once. Abhidnya Patil (35) was second, while Simranpreet Kaur Brar



(30) took home the final podium point. Esha Singh and Rhytĥm Sangwan were

rapid fire, Vijayveer took the lead after the second five-shot series and held on to it till the eighth and final series to

register his first outright victory in the trials. Anish Bhanwala was second with 30 while Adarsh Singh was third with 25. Ankur Goel (20) and Bhavesh Shekhwat (18) took the minor places. Anish, however, was the most successful of the five in the event, having won two trials and coming second in the other two.

Bhavesh had won the second trial. Vijavveer, on the other hand, had come second twice in the three earlier trials.

Wednesday will see the qualification rounds in men's and women's 50m Rifle 3 Positions event with local hopes Aishwary Tomar and Ashi Chouksey set to participate.
