Suspended DSP Praneeth Rao sion report that with a team of nine members he reportedly tapped the phones of 1,200 persons. "We had developed about 1,000 to 1,200 profiles of persons for monitoring, Praneeth Rao reportedly said in the confession report.

Praneeth Rao allegedly took 17 systems, a laptop and several pen drives and other electronic gadgets for himself and his team. Further, he reportedly used to request CDRs, IMEI, locations of targets and data through an official mail id of the Telangana police.

"During election period, my team monitored several phones of supporters of the contested candidates of the Opposition parties and also those who financially supported such candidates.



'191 BJP, 143 Cong LS poll candidates face criminal cases'

Out of the 440 BJP candidates contesting the Lok Sabha polls, 191 have declared criminal cases in their election affidavits, according to an analysis by a poll rights body.

For the Congress, out of its 327 candidates, 143, or 44 per cent, have declared criminal cases, the Association for Democratic Reforms (ADR) said in a report based on data compiled from the affidavits on the Election Commission's website.

The cases, it said, include those related to murder, attempted murder, crimes against women and hate

speech.
The ADR said the data obtained from the poll panel's website reveals that a "significant portion of candidates contesting in the elections have self-declared criminal cases against

number of candidates facing serious criminal cases.

One hundred and thirty of the total BJP candidates in the poll fray (43 per cent) of candidates who have have declared serious criminal cases, while for the Congress it is 88 candidates (27 per cent of the total candidates it has fielded), according to The report also delves into the the report.

breakdown of candidates with declared criminal cases partywise, it said. The report stated that among the major parties, the Bharatiya Janata Party has 191 (43 per cent) of candidates who have declared criminal cases, while the Congress has 143 (44 per cent) of such candidates.

The Samajwadi Party has 71 candidates in the elections and 40 have declared criminal cases, with 30 of them named in serious crimes.

Thirty-three of the 52 candidates of the Communist Party of India (Marxist) have declared criminal cases, with 18 facing serious charges, and in the Trinamool Congress, 20

of 48 candidates have declared criminal cases with 12 facing serious charges. The state-wise analysis also pro-

vides insights into the prevalence of candidates with criminal backgrounds. For instance, in Maharashtra, 266

of the 1,119 contesting candidates have declared criminal cases, with 183 names serious crimes. Tamil Nadu has 137 out of 945 candidates with criminal cases, with 83 facing serious charges.
In Uttar Pradesh, 213 out of 851

candidates have declared criminal cases against themselves with 179 of them being registered against serious offences.In Telangana it is 104 of 524 candidates, 112 of 507 candidates in West Bengal and 115 of 496 candidates in Bihar. For Jharkhand it is 69 of 242 candidates, Odisha it is 52 of 207 candidates and Kerala it is 67 of 189 candidates.

India successfully testfires Rudra missile

India on Wednesday successfully test-fired a Rudra air-to-surface missile from a Su-30 fighter jet of the Indian Air Force (IAF) off the coast of Odisha.

The defence ministry said the flight-testing of the RudraM-II missile met all the trial objectives.

RudraM-II is an indigenouslydeveloped solid-propelled airlaunched missile system meant for air-to-surface role to neutralise several types of enemy

A number of state-of-the-art indigenous technologies developed by various DRDO (Defence Research and Development Organisation) laboratories have been incorporated in the missile system.
"The DRDO successfully

BRS leaders staged a protest at Kakatiya Thornam opposing Telangana government's move to remove it from the State logo to remove it from the State logo on Wednesday. The BRS is like-ly to proceed legally. "We will file case in High Court if the logo is changed," said former MP Boianapalli Vinod Kumar. He said that Chief Minister A Reyanth Reddy spoke about

A Revanth Reddy spoke about removing the Kakatiya arch and Charminar symbols from the State emblem, referring to them as two symbols of colo-

He stated that during their 11-12 years of Kakatiya rule, Kakatiya rulers protected South India from the feudal system and clarified that the Kakatiyas were not from the colonial administration but rather worked for the welfare of the people. He mentioned



the development of irrigation projects like Ramappa, Pakhal, Laknavaram, Ghanpur, Singur and Nallagonda districts along with the construction of the Panagal reservoir and canals as evidence of their contribution to Telangana's agriculture.

He further credited KCR, former Telangana's chief minister, for spearheading the development of reservoirs and canals through the Mission Kakatiya initiative.

Regarding the proposed changes to the State emblem, Vinod Kumar criticised the Chief Minister's comments, stating that removing the Kakatiya arch and Charminar symbols would not serve as a signal of independence but

rather erase historical symbols. He questioned whether the government had the authority to make changes to national symbols without Central government approval, suggesting that he would file a case in the High Court if modifications were made

He emphasised the need for Chief Minister Revanth Reddy to focus on preserving Telangana's history rather than making such controversial statements. He also hinted at someone advising the Chief Minister to change his course of action and noted the signs of Telugu Desam Party's influence on Revanth Reddy.

BRS demands probe into Som Distilleries scam

Slams Jupally for his statements

PNS HYDERABAD

The BRS demanded a sitting judge inquiry into giving permissions to Som Distilleries. Manne Krishank, official spokesperson, Bharat Rashtra Samithi said, "Excise Minister Jupally Krishna Rao's claim of ignorance about the notorious fake liquor company Som Distilleries entering Telangana is irresponsible."

The BRS pointed out that while Jupally initially threatened legal action for defamation, he later admitted to being unaware of the permits granted to the company. Adding to the controversy, the BRS high-lighted that the Madhya Pradesh government had issued notices to Som Distilleries on February 26, 2024, for selling illicit liquor. Krishank said, "The company's chairman, Jagdish Arora, was charged under Sections 420, 467, 468, 471, and 120B, and was imprisoned. This signifi-



cant detail was not addressed in Minister Jupally's letter."

The BRS questioned if the Telangana Congress government was unaware of these serious allegations when grant-

ing permits to Som Distilleries. He said, "We cited an incident in Morena, Madhya Pradesh, where 24 people died after consuming illicit liquor linked to Som Distilleries, resulting in the sealing of 20 spirit and receiver tanks by that government. Additionally, the BRS accused the Congress of accepting donations from Som Distilleries, creating a potential conflict of interest.

CSIR-CCMB, Aganitha sign MoU to apply AI in therapeutic design

Combining the power of Deep Science and Deep Tech to bring novel medicines to market faster, the Centre for Cellular and Molecular Biology (CCMB) under the Council of Scientific and Industrial Research (CSIR) and Aganitha, a new generation in silico solutions provider, have signed an umbrella memorandum of understanding (MoU) to apply generative Al solutions for designing novel therapeutics and research tools addressing needs in multiple disease areas on Wednesday.

This strategic collaboration is designed to translate discoveries from the globally acclaimed research labs of CCMB into therapeutic candidates through the application of Aganitha's Generative Al solutions for biopharma R&D. Initial areas of collaboration include target analysis, small

nanobody engineering for addressing Malaria, Tuberculosis (TB) and neurological disorders.

The victim had received a video call on May 26, The caller told him that a parcel could not be delivered by Fedex. He opted to speak to a Fedex employee and was con-

nected to a someone. The name of the Fedex employee was given as Jason Thomas. He was informed that the parcel had been confiscated by airport customs due to the presence of illegal drugs. He was instructed to file a FIR at the nearby Mumbai Police Station. However, he mentioned his location in Hyderabad and expressed his inability to go to the police station. Subsequently, an individual identifying himself as Pratash Kumar, from the Mumbai Cyber Crime Branch, recorded the statement over Skype. During the Skype conversation, he was interrogated about his activities in Mumbai, acquaintances, and the possibil-

ity of his identity being stolen. The victim offered to visit the local police station in

Hyderabad, but he was informed that the investigation would be conducted online as an FIR had been lodged with the CBI. Allegations were made that his Aadhaar Card had been activated in multiple states and used for money laundering. He was warned that the victim was a primary suspect, and an arrest warrant could be issued against him. With the promise of issuing

a NOC and removing his name and Aadhaar from all records associated with illegal bank accounts. Furthermore, he was instructed to maintain continuous audio and video communication with the authorities until the investigation concluded. Any attempt to communicate about the case externally would result in immediate arrest. Subsequently, he was coerced into transferring Rs 20,00,000 to a specified account under the guise of running a software check on his account for fraudulent activities.

After the victim understood that he was deceived, he filed a complaint in the Cyberabad Cyber crime police station. The case was registered under sections of 170,420,464, 468,467,471 IPC, and 66-C IT act.

Quack's 'clinic' raided; medicines worth Rs 8,000 seized

Drug Control Administration (DCA) on Wednesday raided a clinic operated by a quack and seized medicines worth Rs 8,000.

The quack was identified as K Swarupa who operated the clinic under the name 'Swarupa First Aid Centre' at Gachibowli and practised without qualification. During the raid, DCA officials detected medicines stocked on the premises with-

out any drug license. A total of 17 varieties of medicines, including antibiotics,

analgesics, etc. were found stocked at the premises. The DCA officials found several antibiotics at the clinic during the raid. Indiscriminate sale of antibiotics by unqualified persons may have disastrous consequences on the people's health, including the emergence of 'antimicrobial resistance'.

The samples were lifted for analysis. Further investigation will be carried out, and action will be taken as per the law against all the offenders, said VB Kamalasan Reddy, Director General Drug Control Administration.

Hence, the maximum retail price (MRP) should not be more than Rs 24.77 for one capsule.

In a separate event, the Drug Control Administration seized certain medicines due to misleading advertisements. The medicines were P-Mycetin

ointment, an allopathic medicine which claimed to treat 'diseases of eye', and Mahasudarshan Kadha, an Avurvedic medicine which claimed to treat 'fever.'

Stocks of 'P-Mycetin ointment 'were seized during the raid carried out at the medical shop in Kapra, Medchal-Malkajgiri district. Stocks of 'Mahasudarshan Kadha' were seized during the raid at a medical shop in Khammam.

55RMPs and PMPs booked for violating NMC Act

Telangana Medical Council Members, in a move aimed at safeguarding public health, conducted surprise inspections in various districts to address the growing concerns over counterfeit medical practices.

Identifying the pressing needs of the rural population, especially in areas lacking qualified medical practitioners, the council is rigorously enforcing the provisions of the National Medical Commission (NMC) Act, registering cases against unauthorised practitioners. Under the purview of the Telangana Medical Council, 55 individuals practicing as Registered

Medical Practitioners (RMP) Practitioners (PMP) have been found to be in violation of Section 34, 54 of the NMC Act, with cases being registered against them.

These unauthorised practitioners were found administering antibiotics, steroid injections, distributing contraceptive tablets in some centres, and performing procedures in clandestine operation theaters, highlighting the gravity of the situation. Present during the inspections were dignitaries including Dr G Srinivas, Vice-President of the Telangana Medical Council, Dr Sheshu Madhav, Legal Affairs Coordinator; Dr Shrikant,

Chairman of the FMG, Dr Naresh Kumar, Chairman of the Public Committee; Dr Ravi Kumar, Chairman of the Finance Committee; along with EC members Dr Vishnu, Dr Imran Ali, co-opted members Dr Rajeev Nayak, HRDA leaders Dr Santosh Reddy, and IMA state president Dr. Pulla Rao.

As a result of these inspections, several RMP/PMP unauthorized practitioners have been forced to shut down their centers. Notable senior physicians

Pularao, Daivadheenam, Dr Ramesh, and Dr Phani Kumar actively participated in the enforcement drive.

riorating health condition. 'It has been worsening over the last one year. Is there a conspiracy behind this? Is the lobby that is currently running the Patnaik government on his behalf responsible for it? If the BJP forms the government in Odisha after the ongoing

assembly elections, it would constitute a special committee to ascertain the reason behind the deterioration of Patnaik's health," Modi said.

The court had on February 28 granted bail to Prasad's wife and former Bihar chief minister Rabri Devi and their daughters Misa Bharti and Hema Yadav in the case.

The CBI has alleged that several people were appointed to Group "D" positions in various zones of the Indian Railways from 2004 to 2009.

eight game zones, including a water park, and registered cases against their owners for operating without any permission, police said, adding FIRs were



registered under section 336 (Act endangering life or personal safety of others) of the IPC and under provisions of the Gujarat Police Act.

In Ahmedabad, police sealed four such illegal game zones and filed cases against their owners on Tuesday, said police commissioner GS Malik.

"As per the law, game zones are first required to take various NOCs regarding fire safety as well as electrical and mechanical safety. They need to get permission from the

police by showing these NOCs. None of these four game zones had acquired our permission before starting their operations," said Malik. In Surat, a total of six game

zones situated in Rander, Pal, Umara and Vesu areas were sealed and complaints were for running these facilities without valid permissions, police said.

The Rajkot fire incident is being probed by the Special Investigation Team set by the state government and the city police, who have arrested five persons so far.

'Exposure to air pollution linked to poor mental health' for vulnerable groups, includ-

Children exposed to air pollution could be at higher risk of experiencing mental health problems, including depression and psychosis, as youths,

a new research has found. The study examined the long-term effects of children being exposed to air and noise pollution while in mother's womb, early childhood and

teenage. The effects on three common mental health problems were analysed -- anxiety, depression and psychosis, a mental state in which an individual loses touch with reality and can experience halluci-

Researchers, led by those at the University of Bristol, UK, found that for every 0.72 micrograms per cubic metre increase in PM2.5 pollutants in the air during pregnancy, the chances of experiencing psy-chosis increased by 11 per cent, while those of experiencing depression increased by 10

per cent. For the same exposure during childhood, the chances of psychosis were found to

increase by 9 per cent. The findings are published in The Journal of the American Medical Association (JAMA) Network Open.

"This is a major concern,



because air pollution is now such a common exposure, and rates of mental health problems are increasing globally,"

the study said. "Given that pollution is also a preventable exposure, interventions to reduce exposure,

could potentially improve mental health," said lead author Joanne Newbury from the University of Bristol.

Exposure to pollution could be rapidly reduced by making targeted interventions available

ing pregnant women and children, Newbury said. For the study, the researchers analysed the data

of over 9,000 participants from the Children of the 90s birth cohort, founded in Bristol. The cohort includes more than 14,000 pregnant women, recruited in 1991 and 1992, and were subsequently fol-lowed-up, along with their

children. The researchers compared the participants' mental health reports when they were 13, 18 and 24 years old against outdoor air and noise pollution in Bristol at those points in time. "An increase of 0.72 micro-

PM2.5 levels during pregnancy and during childhood were associated with elevated odds for psychotic experiences. Pregnancy PM2.5 exposure was also associated with depression," the authors wrote. Further, being exposed to

higher noise pollution in childhood and teenage was linked with raising the chances of anxiety by 19 per cent and 22 per cent, respectively.
"Childhood, adolescence,

and early adulthood are critical periods for the development of psychiatric disorders: worldwide, nearly two-thirds of those affected become unwell by the age of 25.



Heed caution

All may seem lost in the Israel-Palestine war, but there is still time to save humanity in Gaza

he city of Rafah, which translates into wellbeing or prosperity in Urdu, experienced the trauma of seeing at least 45 people — including children — killed at a refugee camp in its midst following an Israeli airstrike in Gaza. Understandably, the act caused international indignation and further isolated Israel over the war with Palestine, coming only days after the International Court of Justice ordered the Jew nation to cease its operation in Rafah. Although the top UN court ordered Israeli forces last week to stop their operations, they persisted in their assault on the border town, which was long thought to be the last remaining shelter in the territory. Meanwhile, as international solidarity poured in for the Palestinians impacted by the Israeli strikes, the slogan "All Eyes On Rafah" has become popular on social media. The expression alludes to the continuous slaughter occurring in Gaza city, and several famous people have posted condolences along with the hashtag #AllEyesOnRafah. The cry for awareness of the ongoing battle has



gained traction with the use of this slogan. Prior to Israel intensifying its military operation on the Gaza side of the border earlier this month and seizing control of the crossing, Rafah served as a primary port of entry for humanitarian aid. Over one million Palestinians have fled the fighting in Rafah; the majority of them were already displaced due to the conflict between Israel and the Hamas. Meanwhile, US President Joe Biden does not seem to be changing his stance on Israel, according to the White House, because the incident "did not cross a red line" that would require adjustments in US support.

This is despite the fact that Israeli tanks have been seen rolling down central Rafah for the first time since the war began on October 7 last year. In another setback to Israel globally and perhaps as part of a larger signal for it to stop bloodying the Gaza Strip with the murder of innocent people — nobody actually minds if only the Hamas terrorists are annihilated — Spain, Norway and Ireland have acknowledged Palestine's independence. The three countries did not recognise the existence of a State; they just acknowledged its potential. As a result of the change, the Palestinian Authority and the three nations will have closer diplomatic ties. Everyone has declared that they will acknowledge Palestine based on its pre-1967 borders, with East Jerusalem serving as its Capital. Already, 143 of the 193 members of the UN General Assembly have recognised Palestine. The latest acknowledgments are the most compelling proof to date that the concept might be gaining support in the economically and diplomatically powerful western European States. The West Bank, which Israel has occupied, and the Gaza Strip, which is under siege and where Israel is conducting a war that has claimed more than 36,000 lives, make up what is left of ancient Palestine. However, it must be recorded to his credit that Israel Prime Minister Benjamin Netanyahu has said the Rafah incident was a "tragic mishap".

So too have the premises of the Bharat Sevashram Sangh (BSS) at Beldanga in the district of Murshidabad suffered the ire of the ruling party's roughnecks. One of the BSS monks Kartik Maharaj has drawn Mamata Banerjee's ire as he is thought to be working towards influencing voters in favour of the BJP. Banerjee also believes that the ISKCON is playing a similar

The Ramakrishna Mission or RKM, as it is also known, headquartered in Kolkata's Belur Math was founded in 1897, by the great Ramakrishna Paramahansa's most renowned disciple, Swami Vivekananda. The latter was truly a global icon of modern Hinduism and planted the flag of Sanatana Dharma in the West, beginning with his spiritual conquest in Chicago in 1893 at a conference of the World Parliament of Religions. Though the International Society for Consciousness (ISKCON) was founded in New York, its founder Bhaktivedanta Swami Prabhupada or Srila Prabhupada was born in Calcutta and ventured to the US only in his old age, at 69, to spread the message of Krishna to America and the rest of the world. To vandalise such highly regarded institutions such as the venerable Ramakrishna Ashram and the internationally respected ISKCON, which has over 160 temples across the globe and that too by some citizens of a country that is predominantly Hindu, is unthinkable and unpardonable. It is possible that the perpetrators of these attacks are not



Hindus but people belonging to another religion. Nevertheless, the message that comes out from these recent episodes of temple vandalism is of the Hindus as a people being religious-suicidal.

This is all the more unfortunate for two reasons. The Ramakrishna Mission is world famous since it was Swami Vivekananda who singlehandedly informed the world of the wonder that Hinduism is. It is ISKCON that enables so many countries, with its magnificent temples, to worship in the Hindu way of "Hare Rama, Hare Krishna". Secondly, it has been only a few years since the image of Hindu Índia began to shine, after centuries of suppression. We now have the sordid spectacle of temple and ashram premises being attacked by goons with guns, in West Bengal of all places. It was just over a century ago that Congress leader Gopal Krishna Gokhale had said, "What Bengal thinks today, India thinks tomor-It signified the province of Bengal was a leader. Is this what leaders do and that too for winning some seats in four or five constituencies? Just look back at the Renaissance, which in many ways, was comprehensively

Furthermore, it has been higher for seven out of eleven years of the Wheebiz India Skills Reports. However, there has been a persistent gap between female and male labour force participation, indicating a clear bias against employing women over men. This bias is diminishing as female labour force participation has risen over the years, but substantial improvement

is still necessary. The Indian Government has implemented various initiatives to foster gender-inclusive employment, aiming to bridge the gender gap in the workplace, making employing female labourers more lucrative while also ensuring it does not come at the cost of pay disparity. One significant legislation is the

Equal Remuneration Act of 1976, designed to eliminate the wage gap between genders by ensuring equal pay for equal work. However, the act faces challenges, such as the narrow interpretation of the same work or work of a similar nature and the onus on employees to prove discrimination, which is difficult due to workplace power dynamics and legal complexities.

Additionally, the Government has launched schemes like Mission Shakti and the Deendaval Antyodaya Yojna-National Rural Livelihoods Mission(DAY-NRLM), focusing on women's skill development and employability. These initiatives include exclusive training institutes for women, industry-oriented courses and partnerships with private sector bodies and NGOs. To encourage female participation in skill development, 30 per cent of seats in ITIs and ITCs are reserved for women.

These measures represent a comprehensive and assertive approach to promoting gender equality in employment, highlighting the crucial importance of legislative support, skill development and financial empowerment in achieving a more inclusive workforce. These unwavering steps will guarantee the complete realisation of the Indian economy's potential and the equitable distribution of the benefits of skills development.



Centre to enlist dairy, fishery co-operatives

The government is planning to launch a nationwide programme to rope in dairy and fishery cooperative societies as banking correspondents to expand financial services in rural areas, a top official said on Wednesday. Ministry of Cooperation

Secretary Ashish Kumar Bhutani said the programme would leverage the existing network of dairy and fishery cooperatives to act as "bank mitras" or banking agents by offering services such as

micro-ATMs and lower-interest farm loans. "The pilot has been rolled out at the state level in Gujarat. We intend to nationally roll out shortly," Bhutani said while addressing a cooperative summit organised by PHDCCI here.

The plan follows a pilot project launched in two districts of Gujarat where members of dairy and fishery cooperatives were able to access banking services closer home, including doorstep delivery of microloans and facilitating other transactions.

Under the nationwide pro-

gramme, these cooperative societies will be engaged as banking correspondents of district and state cooperative banks, official sources said.

To enable delivery of branchless banking services, the cooperatives will be provided with micro-ATMs with support from the National Bank for Agriculture and Rural Development (NABARD), the state agency tasked with development of rural India. Cooperative members will also be issued Kisan Credit Cards, which typically offer farm loans at lower interest rates.

Preserving the dying tradition of the Lambani community

one-of-a-kind community effort known throughout the country that showcases the beauty of the Lambani community to metropolitan audiences, Banjara Kasuti is winning over fashionistas and others' hearts. People in the country refer to them as a mix of trending fashion and tradition with ecological ethics! Most importantly, during an exclusive chat with the founder, we learn that their objective is not just to preserve the dying tradition of the Lambani ladies but also to uplift them financially and socially.

"I've always been captivated by the Lambani community (*Banjaras*). As a child, the extensive use of mirrorwork, along with brilliant hues in harmony with nature, as well as the distinctive artwork on the outfits worn by the Lambani women, was oftentimes the highlight of my day. However, when I returned to



own art form. Furthermore, huge seasonal migratory patterns in recent years have brought a gradual end to the Lambani artform, with them fleeing to cities for better prospects," Asha Patil thinks back on. In light of this, Seema and Asha decided to start Banjara Kasuti, an effort aimed at reviving the art form while also strengthening the community, particularly Lambani women!

Our interview allowed us to shed light on how, for the past seven years, they have supported the entire ecosystem while also empowering Lambani ladies and khadi weavers through their fashion industry initiative. The founder continued, "We advance the trend by combining current fashion with local culture through the use of Lambani embroidery on organic textiles. We place a strong emphasis on combining traditional artistry and contemporary designs to not only promote the use of handwoven materials but also to ensure financial security for local artisans without sac-

rificing their identity. In fact, we have proudly empowered over 120 women since its beginning, and we hope to empower another women too."

You may call it an initiative that not only seeks to provide dignity, social security, and financial independence to Lambani women but also to maintain their clothing customs by instilling their legacy! Moreover, "While empowering the these women to rediscover their love and admiration for their art form, the initiative also promotes financial stability for both the them and local cotton and

khadi weavers by providing a consistent monthly income, as well as access to banking services, education, and healthcare for all community members. Several ladies from the

community have come out to share their experiences with us. One example of perseverance and empowerment is Leela (name changed), a young woman who would do odd jobs as needed—even if it meant working at 40°C to help her family's finances. However, as a result of the COVID-19 outbreak, Leela's husband lost his job as well, forcing her to bear the full burden alone. Leela gained a second chance at life after being introduced to our community initiative by her community members. With a set monthly income, Leela was finally able to leave her odd occupations and establish a stable foundation for her family, ensuring that her children's education continued. Such incidents continue to motivate us to work tirelessly for the benefit of the 'Banjaras' and to alter their lives.'

Asha Patil, who lives with the large Lambani population, saw that the women in this community were abandoning their traditional garb in favour of synthetic saris. She then established the goal of reviving the magnificent lished the goal of reviving the magnificent Lambani handwork while also uplifting the women's community. At the same time, the founder had been doing the following: "In the organisation, there is a practice of incorporating Lambani community members in the design decision-making process. We connect with them in an open and mutually respect-ful manner, valuing their diverse culture and knowledge. We collaborate with participants to create one-of-a-kind designs that honour their cultural history while also reflecting artis-tic traditions. This means that by work-

ing together, we want to accurately depict this community."

They currently provide regular monthly wages to more than 60-80 women from the Lambani community. It only utilises handwoven fab-

community. As a result, the communities are gradually becoming self-sufficient, and the members are proud of their newly acquired weaving and embroidery skills. With this effort, they hope to reach 120 women by mid-2023 and ensure that all families in the Lambani neighbourhood have access to banking, education, and healthcare.
What more? "Beyond financial support, our

initiatives aim to empower individuals to become responsible, self-sufficient members of the community. A closer look at Sarcomas!

Sarcomas are a rare group of cancers that begin in the bones or soft tissues of the body. It accounts for about 1% to 2% of all cancers that affect children, adolescents, and even adults. Although bone cancer can develop anywhere in the body, it mostly develops in the arms

Since it develops deep in the body and becomes evident after the appearance of a lump, one might not be able to see any significant signs or symptoms. This makes, early diagnosis of sarcoma very crucial.

How bone sarcoma is diagnosed?

Sarcoma of bone is a type of cancer that requires various tests for accurate diagnosis, although not all tests are necessary for every individual. When selecting diagnostic tests, doctors take into account several factors such as the suspected type of cancer, the patient's signs and symptoms, age, general health, and the results of previous medical tests.

Here are the tests commonly used to diagnose and determine the stage of bone sarcoma:

Bone scan: A bone scan aids in determining the stage of a bone sarcoma. A small amount of radioactive tracer is injected into a patient's vein, which collects in areas of the bone. A special camera detects the radiation emitted by the tracer, creating images. Healthy bone appears lighter, while areas affected by cancer cells or fractures stand out.

Blood tests: Laboratory blood tests alone cannot diagnose sarcomas. However, in some cases of osteosarcoma or Ewing sarcoma, elevated levels of alkaline phosphatase and lactate dehydrogenase may be present. It's important to note that these substances can also be elevated due to noncancerous causes.

such as normal growth in children or healing broken bones.

X-ray: Xrays use a s m a l l amount of radiation to create images of the body's internal structures. They provide a visual representation of the bones and can help identify any abnormalities or tumors.

Computed tomography (CT or CAT)

scan: CT scans utilise x-rays taken from different angles to create detailed 3-dimensional images of the body. They can measure tumor size and identify abnormalities or tumors. Contrast medium, a special dye, may be administered to enhance the image's clarity.

Magnetic resonance imaging (MRI): MRI employs magnetic fields instead of x-rays to produce detailed body images. It can measure tumor size and detect involvement of nearby soft tissues. Contrast medium may or may not be used to enhance the image's quality

Positron emission tomography (PET) or PET-CT scan: A PET scan is often combined with a CT scan to determine the stage of a bone sarcoma. A radioactive sugar substance is injected into the body, which is absorbed by cells that actively use energy, including cancer cells. The scanner detects this substance, producing images of organs and tissues.

Biopsy: A biopsy involves the removal of a small tissue sample for microscopic examination. While other tests may suggest cancer, only a biopsy can provide a definitive diagnosis. A pathologist analyzes the sample to confirm the presence of cancer. Biopsies can be performed through a needle or by making a small incision, depending on the tumor's location. It is crucial to undergo the biopsy process in a specialised center, as the procedure is

important both in diagnosis and proper treatment outcome. Additionally, an expert pathologist should review the tissue sample to ensure an accurate diagnosis of sarcoma. After conducting the

necessary diagnostic tests, the doctor will discuss the results with the patient. In the case of a cancer diagnosis, these results assist in describing the cancer and determining its stage and grade. Staging and grading help guide the appropriate treatment approach. It is crucial for individuals with bone sarcoma to seek care at a sarcoma specialty center, where experts can ensure accurate diagnosis and provide

I wanted to be real. Through this movie, I got the opportunity to show a good story paired with good emotions. From production to the whole cast and crew, everyone supported my story. The entire story is fic-

He added, "Gangs of Godavari unfold the saying, 'You are your own enemy,' I made this film within the limits of the liberty I had. Personally, this story is very close to mine. Everyone can take action, but emotions can be shown only if you feel them. In this film, the last 20 minutes will be an emotional rollercoaster. It will hit people hard, and I am very confident about it. This movie will be

very emotional."

The director further reveals that he didn't make any changes to the story of the film after Vishwak came on board. The only apprehension he had was the accent. He further goes on: "Vishwak speaks Telangana, and our story was set against an Andhra backdrop. So I told him to focus a little more on the dialect. We hired a tutor. He learned for 15 days, and within a month, Vishwak did a good job. On this occasion, I also want to clarify that this movie has so many gangs in it, but this is not a gangster story, and I request that people not consider it a gangster film. There are no gangsters in this movie."

While there are rumours that this film will have a sequel, the director clarified that he wants to make a sequel for this movie; however, nothing has been finalised yet. "If this movie turns out to be a hit, then I will write the sequel story in a month and make the film. I write stories very quickly, good or bad.
The only advantage with it was that there was no delay because of me in any way. I am not here to please people. I do what I like, but I will be accommodating," he laughed.





FINAL CHANCE FOR KOHLI, ROHIT TO GIVE INDIA ICC TROPHY AFTER 13 YEARS

Tt's tough to find two cricketers who are so different from each other yet so closely intertwined by the same thread of fate as Virat Kohli and Rohit Sharma.

Rohit's initiation into top-flight cricket came at the idyllic Belfast in 2007 and Kohli's a year later at the more conventional Dambulla. Dambulla. Another intriguing chapter of this journey toegther will potentially come to an end next month in the stunning Caribbean Isles.

The next T20 World Cup is in 2026, to be jointly hosted by India and Sri Lanka, but Rohit would be touching 40 then and Kohli would be 38. The 50over version is a further one

year away.
It's hard to see them playing in any of those, considering the increasingly strike-rate oriented nature of the game. So, both Rohit and Kohli will want to leave the stage with the winner's medal around their neck next month. Should they achieve that, it would be their second each after the 2007 T20 World Cup (Rohit) and the 2011 50-over showpiece

(Kohli). And it will be a perfect send off for two players who have had an immeasurable impact on India's white-ball fortunes in the last 17 years.

However, the Kohli-Rohit story is not one of bromance. It's based more on mutual respect and the awareness that they should not step into each

other's space. Kohli has talked about the admiration he has had for Rohit since the very beginning of their careers.

"I was filled with curiosity about a player. People kept on saying - This is one player who is rising rapidly. I used to wonder that even though I am a young player, no one talks about me, then who is this

player. "But when he (Rohit) stepped out to bat, I was all quiet. It was amazing to watch him play. In fact, I haven't seen a player time the ball better than him," Kohli had said in 'Breakfast With Champions'.

Contrasting in nature, their batting has been high art for the masses to which they added a dash of modernity

Of the two, Kohli is the more all-format batter, who has adapted more fluently with the

changing face of the game. He has scored in every corner of the cricketing world in a show of consistency that was rarely witnessed after the halcyon days of Sachin Tendulkar.

While Rohit built his own edifices in white-ball formats, the Mumbai-man remained a



reluctant visitor in Test cricket's elite corridors for the better part of his career.

A move up to the opener's role helped Rohit unshackle himself a bit in Tests in the

later part of his career. But for now, Kohli and Rohit will have to lean on their vast experience in T20 cricket to fuel India's run in the World

Cup.
Rohit will certainly open and if
his approach in last year's
World Cup and in the justconcluded IPL can be taken as
a sign, the skipper will
continue his selfless, aggressive approach. Herein, Rohit has an inherent

advantage. His natural big-hitting abilities will help him pursue his batsmanship without many improvisations. That one-legged pull of his is a cosy meeting point between elegance and malevolence. elegance and malevolence. But Kohli's game is slightly different. He can pull off those occasional big hits - a swat-flick six or a flat-bat smash over bowler's head. A quick rewind to his pick-up shot off Pakistan pacer Haris Rauf during the 2022 T20 World Cup will vouch for that. Still, there is a sore point.

Kohli has often struggled to score off spin, especially against the left-arm variety. His career strike-rate against slow bowlers hovers around midSeveral times, it has impeded his progress in the middle innings but during this year's IPL, he seemed to have found a solution.

He brought out the slog-sweep against spinners, and it had a healthy influence on his strikerate as Kohli made 260 runs from 188 balls and struck 15

sixes against them. His strike-rate against spin touched 139, a marked improvement from his overall IPL strike-rate of 124.

"It was me mentally putting myself in that situation. I did not practice that at all," he explained.

"I know I can hit it because I have played that shot a lot in the past. So, I just felt like I needed to take a bit more risk," Kohli said of his new approach against spin.

This might come in handy for him in the T20 World Cup where the pitches are expected to progressively increasingly bringing spinners into the game. Beyond the realm of cricket,

Legendary Australia speedster Brett Lee feels apart from Jasprit Bumrah, pacers are failing to nail yorkers effectively in the death overs and he wants them to master the pivotal delivery.

Bumrah is one of the most complete bowlers in world cricket at the moment. He can bowl wicket-taking deliveries without leaking runs but the most lethal weapon in his armoury is his toe-crushing yorker, which he, more often that

not, executes perfectly in the death overs. "On a general rule, other than Bumrah, we haven't seen enough fast bowlers nailing their

yorkers recently.
"I want to see fast bowlers bowl more yorkers. I still don't reckon they execute enough yorkers at the death," Lee said at the launch of the Legends

Intercontinental T20 league recently.
With the recently concluded IPL featuring scores in excess of 200 regularly, Lee believes the fast bowlers would be more economical had they nailed yorkers.
"If you look back at 17 years of Indian Premier

League, on average a yorker goes for a strike rate of less than 100. Which tells me that one run or ess per bowler that's executed

"Now, when you bowl a yorker and you've got guys who can go down and scoop you over the head, well that puts pressure on you as a bowler. "You've got to set in the right field and put two men back, third man fine and back and then bowl," Lee added.

As T20 cricket progresses, the game is tilting more and more towards the batters. With the 'Impact Player Rule' and flat decks, bowlers struggled in the IPL.

Lee, like several other former players, called for a balance between bat and ball.

"I'm all for batters smoking the ball all over, but there has got to be something for the bowlers too. I'm not asking for a green top, where teams bowled out for 110, because that's not good for cricket either.

"You want a good total, I think. Anywhere around that 185 mark to 230 is a good score. We've seen scores now of 265, 270, 277.

"It's really hard because most bowlers now are going for 45 to 50 off their four overs." he said WARNER HAS EARNED THE RIGHT TO GO ON HIS OWN TERMS: Australia's charismatic young batter Jake Fraser-McGurk set the stage ablaze in his debut IPL season with many calling for his inclusion in Australia's T20 World Cup squad.



However, the selectors decided to go with veteran opener David Warner, who is set to retire after the tournament, Travis Head and Mitchell Marsh in the top-order.
McGurk, who is a top order batter and Warner's

Although Warner did not have a particularly great IPL as he missed several matches due to an injury, the Southpaw has scored 834 runs in T20 cricket since 2021 at a strike rate of around 150. He was woefully out of form ahead of the 2021 T20 World Cup but ended up being the player of the tournament, playing a vital role in Australia's maiden World Cup win in the shortest format. On the other hand, 22-year-old McGurk, who was called in as a replacement for Lungi Ngidi at Delhi Capitals, gave an excellent display of explosive batsmanship, smashing four halfcenturies in nine games at an astronomical strike rate exceeding 234.

"I think if you go over there as a reserve batsman, you definitely have a chance to get an opportunity.

That happened this year with the Delhi Capitals, he wasn't even picked in the squad. "Ricky Ponting rang him up late night and said come in and had a few injuries. So right time, right place.

"But the advice to him, and he articulated it beautifully to say that he's only 22 years of age (araam se araam se) . He's got time. There's no point rushing it," Lee said.

India getting used to cooler temperatures, playing white ball games in morning

After two months of intense competitive cricket under night lights, the Indian cricket team, sans Virat Kohli, began its preparations for the T20 World Cup with a morning training session here, keeping in mind the 10.30am starts for all its

preliminary games. Kohli took a break for personal work after RCB's IPL ouster and in all likelihood, he will join the squad by Friday.

But it is not clear if he would be able to take part in the only warmup game against Bangladesh on

Saturday after a long flight.

Having played 90 per cent of the matches under lights in the scorching Indian summer, the idea would be to adjust to pleasant mornings where temperatures will hover between 25 to 27 degree

celsius with very less humidity. A white kookaburra in slightly windy mornings could be a challenge and to be prepared for that, the severely jet-lagged bodies need to get used to morning conditions.

And this is why the support staff, before initiating the skills training (net sessions) on the practice pitches at a ground on the outskirts of the city, have decided to help the players acclimatise with the conditions.

With 14 players checking in, there was light jogging, routine shuttle runs, and a bit of foot volley to get into the groove.

"They have been away two and half months from us and getting to know where they stand and what needs to be done before the World Cup is the goal. The (first) goal is to spend 45 minutes in the heat to get going," Strength and Conditioning coach Soham Desai told bcci.Tv.

"We came in the day before yesterday and we just eased into our routines here, the players are just getting used to the time zone. Today we are having our first ground session," he added.

As far as the players are concerned, there is an element of curiosity about playing cricket in New York. The Indian teams, over the years, have played primarily in Florida at the Fort Lauderhill ground during
