With India battling high inflation, which includes price rise as one of the dominant factors, the prices of food consumables could potentially skyrocket further amidst the Lok Sabha polls. India's wholesale prices rose to a 13-month high of 1.26 per cent in April from 0.53 per cent in March 2024.

Due to an uptick in food inflation fuelled by rising prices of food especially vegetables, articles. wholesale food inflation will continue to be a cause of concern in May and June, as heatwaves are likely to push up prices of perishable commodities. The India commodities. India Meteorological Department has prices of vegetables and food items typically increase.

Unemployment and inflation are the primary issues dominating among the voters during the discourse in India's general election 2024. The data released by the Ministry of Commerce highlighted that in the food articles basket, vegetable inflation is 23.60 per cent in April, up from 19.52 per cent in the previous month.

Wholesale food inflation also increased to 5.52 per cent on an annual basis, while food inflation grew 1.94 per cent on a month over month (MoM) basis. The data shows a notable increase in onion prices which rose by 59.75 per cent in April, following a 56.99 per cent increase in March. The increase was attributed to a major shortage in onion supply predicted heatwave conditions during May and June, a period when until the next kharif crop, which is during May and June, a period when

current scenario. Inflation in potato jumped to 71.97 per cent in April from 52.96 per cent in March. In onion, it was 59.75 per cent in April, versus 56.99 per cent in the previous month.

The Wholesale Price Index measures the change in prices of goods traded by wholesale businesses. Unlike the Consumer Price Index (CPI), which tracks prices of goods and services purchased by consumers, WPI tracks factory gate prices.

The Ministry of Commerce and Industry releases WPI data on the 14th of every month, or on the next working day. Under the index, commodities are categorised into three groups — primary articles (which are further divided into food and non-food articles), fuel and power and manufactured products. April marks the sixth successive

Index (WPI) has risen on a year-onyear basis, after seven months of deflation. On a month-on-month deflation. On a month-on-month basis, the WPI was up 0.8 per cent with primary articles and food prices rising nearly 2 per cent in April, while manufactured products were up 0.5 per cent. As per the data, inflation in food articles rose to 7.74 per cent in April as against 6.88 per cent in March. In the fuel and power basket, inflation stood at 1.38 per cent in April, up from (-)0.77 per cent in the previous month.

"Positive rate of inflation in April


2024 is primarily due to increase in prices of food articles, electricity, crude petroleum and natural gas, manufacture of food products, other manufacturing etc," Ministry of Commerce & Industry said in a statement on Tuesday.

As per the data, manufactured products witnessed deflation of 0.42 per cent in April, as against deflation of 0.85 per cent in March.

ICRA Chief Economist Aditi Nayar said WPI inflation is heavily sensitive to global commodity prices which is undergoing an upturn year after year. According to ICRA, the wholesale food inflation, which is at a four-month high, will continue to be a cause for concern in May and June as heatwave is likely to jack up prices of perishable commodities.

Although the impact of the high base of last year will play out in July and August, the impact of monsoon will determine the price conditions in the subsequent months. As per data released on Tuesday, the wholesale price index (WPI)-based food inflation was at a four-month high of 7.74 per cent in April.

Retail food inflation also remained stubbornly high at 8.70 per cent in April 2024, as against 3.84 per cent in April 2023. Retail inflation data released on Monday showed that the consumer price index (CPI)-based inflation was at an 11-month low of 4.83 per cent in April, even though the prices of food and vegetables ruled high.



AAP admits to assault, **Kejriwal promises to act**

in the drawing room of Kejriwal's official residence. Kejriwal is currently out of Delhi. According to sources in the AAP, senior leaders in the party are united to oust Kumar, who is widely referred to as 'Kejriwal's Man Friday', by pinning the

Prime Minister Narendra Modi filed his nomination papers as Bharatiya Janata Party (BJP) candidate for the Lok Sabha elections-2024 here on Tuesday, seeking a third term from the Varanasi Lok Sabha constituency. The event was attended by several NDA leaders, including Union Ministers and Chief Ministers in a

show of strength.
The PM submitted papers during the PM submitted papers during the auspicious pushya nakshatra on the day of Ganga Saptami before the Returning Officer, S Rajalingam. Sporting a white kurta-pajama and a blue sadri, Modi reached the district collectorate after a busy morning, which included an aarti on the banks of the Ganga at the Dashashwamedh ghat and prayers

EC the arbiter resolves 400 of **425** complaints

 \mathbf{I}^{n} a rare feat aimed at swiftly resolving issues, the Election Commission of India has claimed to have addressed and resolved 400 grievances and complaints in record time out of a total of 425 major complaints received since the Lok Sabha élections began almost a month ago.

The poll watchdog sa approximately 170, 95 and 160 complaints were filed by Congress, BJP and other political parties respectively. "Most of these complaints have been acted upon. A few complaints of INC and BJP against each other are pending alleging violation of MCC inter alia broadly in the genre of divisive statements by

top star campaigners on communal, caste, regional language divide, or on sanctity of Constitution of India," it said.
"So far, 25 delegations from 16 political parties

have met the commission to lodge their grievances/ complaints on alleged violations of Model code. Apart from this, many delegations have met at the level of Chief Electoral Officer in the States," it said

A mid the rising concern over the proliferation of fake news and the "menace" of social media, a survey conducted on the youths of the national Capital, particularly eligible voters, has found that fake news and social media narratives influence the voting decisions of Gen Z (the second youngest generation, born between 1997 and

A report titled 'Truth be Told,' by the communication consulting firm The 23 Watts, delves deep into the extent of impact this phenomenon has on the youths of phenomenon has on the youths of Delhi, particularly Gen Z, revealing that 91 per cent of them say it can influence voting decisions.

In a tragic incident on the Delhi-Lucknow highway in Lucknow highway in Garhmukteshwar police station area of Hapur district, a car lost control, crossed the divider, and collided head-on with a truck, resulting in the death of six individuals on the spot. One person sustained injuries and has

been admitted to the hospital. Chief Minister Yogi Adityanath expressed condolences to the deceased and directed officials to extend all possible assistance to the victims' families.

The incident involved Vipin Soni (35) of New Vikas Nagar in Ghaziabad's Loni area, who was travelling with six friends in an Ertiga car on Monday night to visit Baba Neem Karauli Ashram in Nainital.

Near Garh area Allahbakshpur in Hapur district, the car veered out of control, leading to the collision with an oncoming truck. The impact was severe, resulting in the deaths of six occupants of the car. Passersby alerted the police upon witnessing the accident. Garhmukteshwar police station in-charge Vinod Pandey promptly reached the scene with a police team, assisting in the extrication of individuals trapped in the car wreckage. Senior officials also reached

there to oversee relief operations. The deceased were identified as Vipin Soni, Rohit Saini (driver, 33), Anoop Singh (38), Sandeep (35), Nikki Jain (33), and Raju Jain (36). The injured individual, Sachin, received initial treatment and was referred to Meerut for further medical care.

Superintendent of Police Abhishek Verma confirmed that the accident occurred around 12:30 am near Brajghat toll on the Delhi-Lucknow highway, resulting in the tragic loss of life. The bodies have been sent for postmortem examination, and the families have been informed.

Chief Minister Yogi Adityanath expressed sorrow over the road accident and directed officials to expedite relief efforts and ensure proper treatment for the injured.

In another incident in Jalaun, five teenagers drowned while bathing at Betwa river during a picnic.
The victims, identified as Aryan

(16), Anubhav Bundela (17), Shiva (16), Mahendra Pratap (17), and Hemant (17), were residents of Bagaura locality of Orai Kotwali area. The incident occurred at Salaghat in the Kotra area when the boys slipped into deep water and drowned. The bodies were recovered by the National Disaster Response orce and sent for autopsy

Jhansi: Congress leader Rahul Gandhi and Samajwadi Party chief Akhilesh Yadav Tuesday accused Prime Minister Narendra Modi of working for "arabpatis" and ignoring farmers and unem-

Addressing a joint rally near the Rani
Jhansi fort here, the alliance partners said they would work for the youths and farmers if the INDIA bloc government comes to power.

The Congress and the Samajwadi Party (SP), both part of the opposition INDIA bloc, are contesting the Lok Sabha election as allies in Uttar Pradesh. The joint rally was held to campaign for the Congress' Jhansi candidate Pradeep Jain and the SP nominee from neighbouring Hamirpur Ajendra Rajput.

In a scathing attack on Modi, Gandhi said the prime minister had promised to make 100 'smart cities' in the country but "did nothing in this direction". He further said that the prime minister asked people to beat thalis to ward off COVID-19 when hundreds were dying due to the deadly disease. Yadav claimed that trends of the four phases of parliamentary polls were proof that the "BJP's graph is going down" and the party is certain to lose.

Gandhi claimed that if the BJP came to power again, it would

Lucknow: A man, who claimed to be a cleric at a 'dargah' in Budaun, has been booked after a woman alleged that he raped her multiple times on the pretext of "curing" her mental ailment, police said on Tuesdav. Deputy Superintendent of Police Alok Mishra said that the woman, a resident of Bijnor, who has been coming frequently to the famous Dargah of 'Bade Sarkar' on Budaun-Delhi road in Sadar Kotwali for "treatment", has given an application Senior to Superintendent of Police Alok

Priyadarshi alleging that one Maulvi Rahat lured her in the name of treatment and took her to his room, where she was raped. The accused also made objectionable videos, she alleged. Rahat, she claimed, ran a shop selling offerings like 'chunni' and 'chadar' on the Dargah premises. The Dargah Management Committee did not respond to media queries on the issue. According to Mishra, the woman has alleged that Rahat used to "take her to his room every day in the name of treatment and raped her". A purported video of one such incident has appeared online, the police said. He said an FIR has been registered in this connection against Rahat and a probe is on. Meanwhile, three youths

died on Tuesday after their motorcycle hit a tanker truck in Hathinala police station area in Sonbhadra, police said. Party candidates for protecting the constitution. He termed the Constitution as

a "life-giver" and said as long as the Constitution remains safe, "our honour, self-respect and rights will remain safe". He said the ongoing Lok Sabha election is between people who want to "change the constitution and those protecting it."
"On one side are the people who want to change the Constitution and on the other side are the people of INDIA bloc, SP and Congress who want to protect it," Yadav said while addressing the rally. "The electorate have taken matters into their own hands and are not going to spare those who talk about running the double-engine government," Yadav said. "The way the people of Bahujan Samaj are continuously coming forward to support us after our direct appeal has given new strength to our fight against the BJP in saving the Constitution and reservation," Yadav said, adding: "People are contacting Samajwadi Party workers and our Babasaheb Vahini across the state and extending their support." While attacking the

BJP-led Central government for inflation and bringing "black farm laws", the SP chief said: "These people brought farm laws to snatch the lands of the poor farmers and give to the big industrialists."

Akhilesh Yadav said that after coming to power, the INDIA bloc government would ensure guaranteed minimum support price for the farmers' crops. He dubbed the ruling Bharatiya

Janata Party government at the Centre as "a government of lies and loot", saying, "The BJP that claimed to be the world's largest party had told the

world's biggest lie that it would double the income of farmers." Attacking the BJP, Yadav said: Those who claimed to double farmers' income brought three anti-farmer laws due to which farmers of Uttar Pradesh-Haryana-Punjab had to strug-gle till the same were repealed." When the INDIA bloc forms the government, it will provide iustice and relief to these farmers," he added.

Akhilesh accused the BJP government of disappointing farmers by waiving loans worth Rs 16 lakh crore of big industrialists and not of farmers.

"The country can become prosperous and happy when farmers are prosperous and happy," he added. Akhilesh criticised UP Chief

Minister Yogi Adityanath over the recent paper leaks leading to cancellation of the competitive examinations for recruitment to government jobs, saving: "Despite its tall claims, the Yogi government failed to identify the source of paper leaks." He also raised the issue of electoral bonds and accused the BIP of receiving funds through bonds by misusing investigation agencies.

NGOs seek SC listing of PIL for SIT probe into electoral bonds scheme

 T^{wo} NGOs on Tuesday urged the Supreme Court to consider listing their PIL seeking a court-monitored probe by a special investigation team into alleged instances of "apparent quid pro quo" involving political parties, corporate entities and officials of investigative agencies in the electoral bonds scheme.

A bench comprising Justices Sanjiv Khanna and Dipankar Datta took note of the submissions of lawyer Prashant Bhushan, appearing for NGOs 'Common Cause' and the Centre for Public Interest Litigation (CPIL), that the plea needed to be listed for hearing at the earliest.

Khanna told Bhushan.



The petition has also sought a direction for investigating alleged violation of section 182(1) of the Companies Act, donated to political parties through electoral bonds within three years of their incorporation and for penalty to be imposed on such firms in terms of section 182(4) of the

The plea claimed the electoral bond data showed that the bulk of the bonds purchased by corporate entities appeared to have been donated as quid pro quo arrangements by corporates to political parties for getting contracts, licences, leases, clearances and approvals worth crores of rupees and securing other benefits from governments or authorities controlled by governments which were in turn controlled by political

It alleged that electoral bonds were given in close proximity to action by agencies like the ED, IT or ĆBI, raising suspicion about the donations being "protection" money to avoid or stall action by or in exchange for regulatory inaction by various regulators like the drug controller etc favourable policy changes.

"Though these apparent pay offs amount to several thousand crores, they appear to have influenced contracts worth lakhs of crores and regulatory inaction by agencies worth of thousands of crores and also appear to have allowed substandard or dangerous drugs to be sold in the market, endangering the lives of millions of people in the

country," it said.
"That is why the electoral bonds scam has been called by many astute observers as the largest scam in India so far, and perhaps in the world," it claimed.

It said data also showed that various loss-making companies and shell companies were donating huge sums to political parties through electoral bonds.

41 civil servants from Sri Lanka undergo training in India

Over half million displaced due to floods, earthquakes, storms in 2023 in India

Deadly floods last year left behind a trail of destruction in the Himalayan states of Himachal Pradesh and Uttarakhand last year while glacial lake outburst flood in Sikkim led to the collapse of a hydroelectric dam, killing more than 100 people, and affecting more than 88,000. In Delhi, identified as a "flood displacement hotspot",

the Yamuna River overflowed after heavy rains on July 9, 2023, leaving at least 27,000 displaced, according to a report by the Geneva-based Internal Displacement Monitoring Centre (IDMC) said around 27,000 displacements in the national capital, according to a global report released on Tuesday.

India experienced over half a million internal displacements due to floods, storms, earthquakes, and other disasters in 2023, a sharp dip from around 2.5 million displacements in 2022. On July 9, Delhi recorded 153 mm of rainfall in just 24 hours, the highest singleday rainfall since July 25, 1982. Overall, South Asia reported around 3.7 million internal displacements in 2023, with disasters causing 3.6 million, the lowest figure

since 2018. Researchers attributed the decline in displacements due to disasters partly to the El Nino event, which brought below-average rainfall during the monsoon and a weaker cyclone season.

However, floods and storms continued to displace people, often in the same areas.

At 3,52,000, India's flood displacement figure was the lowest since 2008, with the largest event triggering about 91,000 displacements in Assam in June, affecting 20 districts. Cyclone Biparjoy, which formed in the Arabian Sea in

early June, led to widespread flooding across Gujarat and Rajasthan, causing 105,000 displacements as it moved inland. Cyclone Mocha, the largest disaster displacement event of

2023 in South Asia, triggered 1.3 million displacements in Bangladesh, mainly in Cox's Bazar district. Forecasting and early warn-

ings allowed authorities to initiate emergency procedures before Mocha's landfall, aiding pre-emptive evacuations from densely populated areas.

The IDMC said South Asia's cyclone season was less intense in 2023 than in previous years because of El Nino, but storms still triggered 1.8 million movements, about half of the region's disaster displacements.

Government-led pre-emptive evacuations accounted for at least three-quarters of this figure.

According to the report, disasters triggered 26.4 million displacements in 2023, the third highest annual total in the last 10 years.

No country is immune to disaster displacement, said Alexandra Bilak, the director of IDMC.

Bitter ballot battle

Poll rivals are rarely known for praising one another, but the current discourse has hit rock bottom

If the choice were for selecting the more entertaining option between the ongoing IPL or Lok Sabha elections, the latter — with its innovative taunts, snide remarks, branding family members with dirty accusations, obnoxious campaigning and mudslinging — would win hands down. With this election turning out to be more brutal and bloody than normal, social media is agog with videos of politicos that would put streetside rowdies to shame. A case in point: BJP's Mandi candidate, Kangana Ranaut, took a barrage of abuses, some too explicit to be printed. Disturbingly, even star campaigners are merrily throwing decency to the winds. The recent exchange between Prime Minister Narendra Modi and leaders of the Opposition, particularly the Congress, encapsulates the bitter nature of debate. Modi accused the Opposition leaders of being "cowards, scared of Pakistan", and the Congress shamed him by calling a corporate stooge, besides warning ominously that if he won this time too, India will see no more elections. This



exchange not only underscores the intense political polarisation, but also highlights the alarming decline in campaign standards. Modi's accusation resonates with the BJP's narrative to project itself as the sole guardian of national security. Such remarks, while appealing to a certain segment of the electorate, contribute to toxic polarisation of the polity. By insinuating that the Opposition is soft on Pakistan, Modi attempts to discredit his rivals and consolidate support by tapping into jongoistic sentiments.

On the other hand, the Congress response reflects the prevalent perception of the BJP Government's policies favouring big business owners. The Opposition's strat-

egy of portraying Modi as a representative of corporate interests seeks to appeal to the concerns of the common man. However, such charges, without substantial evidence, contribute to the erosion of trust in democratic institutions and further polarise the electorate. Besides, the Opposition has time and again accused him of being autocratic without any basis. What is particularly disconcerting is the way these accusations are delivered: Personal attack, character assassination and inflammatory rhetoric have become commonplace. Instead of engaging in substantive debates on policy issues and governance, the parties resort to sensationalism and vitriol. The falling standards of campaigning are symptomatic of deeper structural issues plaguing the democratic process. The influence of money power, the proliferation of fake news and misinformation, and the erosion of institutional checks and balances have created an environment conducive to negative campaigning and polarisation. Moreover, the advent of social media has amplified the reach and impact of divisive rhetoric. Unfortunately, the Election Commission has been rather ineffective in controlling these foul-mouthed leaders. That said, it is the responsibility of all of us to ensure that the leaders do not cross the 'Laxman Rekha'. We all can ensure that by pressing the blue button on voting day.

Though initiatives like Atal Tinkering Laboratories (ATLs) by the Government of India foster curiosity, creativity and imagination in young minds, most of our schools still put more stress on the traditional mode of rote learning. Rote memorisation and standardised testing prioritise conformity over creativity, relegating innovation to the sidelines. Furthermore, the fear of failure and the pressure to excel academically discourage risk-taking and experimentation. As a result, many children are discouraged from pursuing their innovative impulses, losing their untapped potential.

This compassionate woman would just engage in conversation with the person and sing a lullaby offering comfort akin to a mother lulling her child to sleep. The result? Clients emerged refreshed and rejuvenated after just half an hour of her soothing sessions. Isn't it astonishing that we now seek sleep therapists for what should come naturally? What does this say about our society? If animals and birds can sleep peacefully, why can't humans enjoy this innate gift of carefree slumber?

Sleep is the best form of relaxation, akin to meditation, that's why those who sleep well always keep well & feel well. It's a fact that if we get sound sleep during the night, we get up fresh being more active & feeling more energetic. However, in today's world getting sound sleep has become a rare occasion because today millions of people suffer from sleep disorders like sleep apnea, insomnia, restless leg syndrome, narcolepsy etc. In addition, the number of those who get a very broken, fitful sleep would be many times more. Sadly, many of these individuals resort to sleeping pills and drugs which ultimately make the problem worse. Knowing that tranquilisers are usually prescribed for insomnia and such other disorders as are due to anxiety and mental depression etc., one would say: 'Where are we heading?



Medical science has acknowledged several causes that lead to sleep disorders. The biggest hindrance of all that contributes to sleeplessness is bad mental health. We must understand that not being able to have restful sleep is not only in itself an unhealthy condition but also causes or aggravates many other diseases. For example, it is now recognised that sleep disturbance is one of the factors that lead to coronary heart disease. But most of us would agree subconsciously that tranquillisers are not the answer to the question of sleep disturbance.

They now know well that these drugs represent a purely symptomatic approach, ignoring the underlying problems that cause these conditions. A British medical journal recently published a report about experiments that have shown that sympathy can work well in cases of sleep disorders. It further said that in one trial, the doctors, instead of giving tranquilisers as they would have normally given, spent some time with the patients and talked with them in an open atmosphere. They just had a brief chat with them, with sympathy and also gave them a few words of advice and explained to them why they had those conditions. The results of these informal chats were astounding and the follow-up assessment showed that with this replacement of allopathy by sympathy, depression in those patients dropped from a level of 80 per cent to 40 per cent. The other fact being realised is that mental depression, anxiety, etc. are mainly due to certain lifestyles, behavioural patterns and personality traits. It was also felt that the pattern of behaviour, designated as type 'A' which is characterised by competitiveness, impatience, etc., predisposes a person to coronary diseases, hypertension, etc. As a result of these new findings, doctors all over the world are now increasingly advising such patients to practise meditation and to have proper dietary patterns. It's a medically proven fact that mental ill health adversely affects one's eating habits, which in turn, drastically influences our sleep and health. Under such a medical condition, proper meditation techniques can be of great help if practised regularly. In the hustle and bustle of living a modern life, we tend to forget that it is the quality of life that matters the most & not the quantity. Hence if we jeopardise our sleep for silly reasons, we are knowingly undermining our health.

Stopping thieving through DBT

A lot of pilfering from fertiliser subsidies is happening due to policy flaws. This can be curbed if only the subsidy is given under Direct Benefit Transfer



n January 22, 2019, addressing NRIs and Indian-origin peole at the inauguration of the 5th Pravasi Bharatiya Divas convention in Varanasi (Uttar Pradesh), Prime Minister Narendra Modi recalled what Rajiv Gandhi had Stated "Of the funds the Central Government sends, only 15 per cent of that reaches the people. If one rupee is sent from Delhi, only 15 paise reaches the villages, 85 paise disappear. Even as the country's middle class kept giving tax honestly, this "loot" of 85 per cent also continued". Modi added "I also want to tell you today's truth as well. We used technology to end this loot of 85 per cent completely. Elaborating on this theme, he explained: In the last four-and-a-half years, about Rs 580,000 crore, our Government, through various schemes viz. for a home, for education, for scholarship, for gas cylinder and to other such ends etc directly gives to the people, transferring it in their bank accounts. Now, just consider that if the country was being run through the old system, then even today from this Rs 580,000 crore, about Rs 450,000 crore would have disappeared or leaked. If we would not have brought a change in the system then this amount would have been looted like the former Prime Minister had accepted...," Modi

That was before the 2019 General Elections. Today, when the 2024 General Elections are underway, the same discourse reverberates in the air even as the PM cites a figure that is nearly seven times. The amount spent on welfare schemes during the last ten years under the Modi - regime has gone up to a gargantuan of around Rs 4000,000 crore. Had the old system (read: before 2014) continued, the amount disappearing from the distribution pipe would have been Rs 3400,000 crore (4000,000x0.85). What do the facts say?

The Union Government executes a plethora of welfare programs aimed at providing basic and necessary amenities and upliftment of the most disadvantaged members of society. It does so mainly through "Central Schemes" (CS) which are fully funded and implemented by it. A total of 740 CS schemes are currently under implementation. During FY2022-23, the CS

spending was Rs 1208,000 crore In addition, there are "Centrally Sponsored Schemes" (CSS) designed to supplement the efforts of the States in achieving various socioeconomic goals and implementing national priorities. These are funded by the central Government and the States in varying socioeconomic goals and implementing national priorities. ing proportions viz. 90:10, 60:40, 50:50 and so on depending on the scheme. These schemes are implemented by the States. During FY2022-23, the spending on a total of 50 CSSs was Rs 412,000 crore. Put together, the total expenditure of the Central Government on CS and CSS schemes during the year was Rs

1620,000 crore. Now, if we were to apply the 85 per cent magic formula dished out by the then Prime Minister Rajiv Gandhi, the amount pilfered while on the way to the beneficiaries IMPLEMENTING would have been Rs 1377,000 crore. Only Rs 243,000 crore would have reached. Under the Modi - model, the entire Rs 1620,000 crore has been reached; courtesy of, the use of technology to transfer the money to their bank accounts.

How does it work?

Under its flagship Digital India program, the Modi - Government has been implementing what is popularly known as DBT (Direct Benefit Transfer) for transferring the cash benefits and subsidies 'directly' to the Aadhaar-linked bank accounts of individual eligible beneficiaries. Launched by the erstwhile UPA -Government on January 1, 2013, its use has picked up pace under Modi since January 2015. As of date, DBT is used in 314 CS schemes.

The JAM trinity (Jan Dhan, Aadhar, Mobile) is a DBT enabler the 'mover and shaker' behind its successful implementation. Today, there are around 520 million Jan Dhan Accounts, more than 1.39 billion Aadhaar cards and 1.15 billion mobile connections. With this, the money can be 'instantaneously'

to tens of millions of beneficiaries spread all over the country. The DBT is free from the delays corruption and associated pilferage that was germane to the earlier arrangements under which there was human intervention, a host of intermediaries/mediators and the money was flowing through multiple layers in administrative offices. To improve transparency, the

Government has put in place the Central Plan Scheme Monitoring System (CPSMS) which ensures that all transfers to bank accounts are made strictly as per the list of eligible beneficiaries. The persons included in the list are authenticated with the use of an Aadhaar card that contains their biometric details thus removing any scope for fictitious claimants. The provision for such checks and balances has helped hugely in preventing bogus claims. As per the latest update on the DBT portal, the total savings by way of plugging leakages in the schemes due to the implementation of DBT during FY2022-23 was Rs 63,000

crore. However, if we look at the food subsidy (the excess of the cost of procurement, handling and distribution of food over the price paid by the beneficiary/consumer), during FY2022-23, the Government was able to save over Rs 50,000 crore which works out to around 18 per cent in the total food subsidy bill of Rs 272,000 crore. This was made possible because of the "deletion of over 50 million duplicate and fake/non-existent Ration

Cards". Likewise, under the Pradhan Mantri Kisan Samman Nidhi or PM-KISAN (, the Union Government provides income support of Rs 6,000 a year to farmers with a valid enrolment, paid in three equal cash transfers of Rs 2,000 every four months; the money is credited to their account via the DBT mode),

transferred at the click of a mouse it was able to save over Rs 10,000 crore during FY2022-23. This is about 17 per cent of the total payment of Rs. 58,000 crores during the year. The savings were due to the deletion of over 21 million ineligi-

ble beneficiaries.

According to the DBT portal, the Government has been able to generate a cumulative saving of Rs 348,000 crore by plugging leakages since the inception of the DBT. Of this, more than half or Rs 185,000 crore are savings in the distribution of food subsidies alone.

Notwithstanding the above, there remains a huge untapped potential for garnering more savings. This is because in the initial years, neither States used Aadhaar for validation nor the Centre made it compulsory even as the latter's efforts in this regard were hamstrung due to protracted litigation in the top court. In such circumstances, a large number of 'ineligible' persons making their way to the beneficiary list was inevitable. While the Government has got rid of them in some schemes like PM-KISAN, it has a long way to go.

Meanwhile, Modi also needs to focus on areas where technology intervention alone won't help. For instance, in fertilisers, the Government asks manufacturers to sell fertiliser at a low price to farmers. The excess of the cost of supply over it is claimed by the latter from the former as a subsidy. Since the subsidy is embodied in the MRP (albeit low), the subsidised fertiliser product must reach the farmer and be used only for growing the crop. If it doesn't reach, then the benefit of subsidy is enjoyed by the person who grabs it. A lot of pilferage from fertiliser subsidies is happening due to this flaw in policy. This can be curbed if only the subsidy is given 'directly' to the farmers under DBT.

Death toll rises to 14 in Mumbai hoarding tragedy


 $T^{\text{he toll in the collapse of a}}_{100\text{-feet tall illegal hoard-}}$ ing at Ghatkopar in north-east Mumbai during Monday's dust storm rose to 14 on Tuesday, as six more bodies were recovered from under the debris.

At least 80 people were injured in the first of its kind collapse triggered by a massive duststorm that swept through the country's commercial capital on Monday evening.

The hoarding came crashing down on a petrol pump at Ghatkopar's Cheddanagar Junction, trapping scores of people under the debris.

The relief and rescue operations went on through the night. Almost all the persons rescued from the debris were

As many as 43 injured persons are undergoing treatment in various hospitals, including the Brihanmumbai Municipal Corporation (BMC)-run



Rajawadi Hospital Ghatkopar, HBT hospital, Mahatma Jyotiba Phule Hospital at Vikhroli and Prakruti Hospital at Kalwa. Maharashtra Chief Minister Eknath Shinde, who had rushed to the mishap site, announced an ex gratia of Rs 5 lakh to each of families of the deceased.

The Mumbai police have registered a case under 304 (culthe BMC and Central Railways over the ownership of the mishap site.

Mumbai Municipal Commissioner Bhushan Gagrani declared the collapsed hoarding as illegal and said the BMC had not given any approval to the hoarding.

"The collapsed hoarding was illegal. There are four heard.

illegal. There are four hoardings at the location where the mishap took place. All four of them have been erected on the Railway land. Of the four hoardings, one collapsed yesterday," Gagrani said. On his part, the Chief

Minister has ordered a structural audit of all hoardings across the country's commercial capital. "I have directed the BMC to carry out a special audit of all the hoardings in Mumbai and remove all the illegal ones," he said, while talking to media persons at the mishap site on Monday

Parties asses mood as Modi, Shah applaud voter turnout in Srinagar

Aday after the Srinagar Parliamentary constituency recorded over 38 per cent voter turnout, the second-highest so far after the 1996 Lok Sabha polls, several Kashmirbased politicians attempted to interpret the mood of the electorate to fine-tune their poll strategy for the next two rounds of voting in the valley. Meanwhile, both Prime Minister Narendra Modi and Union Home Minister Amit Shah have also applauded the people of the Srinagar parlia-mentary constituency for the "encouraging turnout" of 38 per cent, which is more than double the 14.43 per cent polling in the 2019 Lok Sabha

Ironically, former Congress leader and Chairman of the Democratic Progressive Azad Party Ghulam Nabi Azad Tuesday claimed the voter turnout in the Srinagar Lok Sabha constituency is not high enough to know whether the people are happy or angry with the abrogation of Article 370 and bifurcation of Jammu

and Kashmir into two union

territories in 2019. Azad said, "I had hoped Kashmir would witness 80 to 90 percent turnout given what has happened in the past seven to eight years. Article 370 was removed, and statehood was snatched. So I thought the turnout would be high, like 90 to 95 percent.

"The increase of a few percent hardly matters as it happens in every constituency of India. That way, we can not know whether the people are angry or happy (with the abrogation of Article 370 and snatching of statehood)," Azad told reporters while campaigning for his party candidate in Kulgam district.

His observation stood in total contrast to the statement made by the Union Home Minister. . The Modi Government's decision to abrogate Article 370 is showing results in the poll percentage as well. It has enhanced people's trust in democracy and its roots have deepened in Jammu and Kashmir," Amit Śhah wrote on

X' (earlier Twitter). 

Hearing in 2018 defamation case against Rahul on May 27

Hearing in a 2018 defamation case against Rahul Gandhi over his alleged objectionable remarks targeting Union Home Minister Amit Shah has been fixed for May 27 following the appointment of a new judge to the special court.

The defamation complaint against Gandhi was filed by BJP leader Vijay Mishra six years ago.

The plaintiff's advocate, Santosh Pandey, said the matter would be heard on May 27. Gandhi's lawyer Kashi Prasad Shukla said the case could not be taken up during the day due to the nonappointment of a judge of the MP/MLA court. The judge was transferred a month ago and a new judge is yet to be appointed.

Last December, the court issued a warrant against Rahul Gandhi. Subsequently, Gandhi halted his Bharat Jodo Nyay Yatra in Amethi on February 20, appeared in the court and was granted bail.



The complaint was filed here

on August 4, 2018, against Rahul Gandhi for his alleged obiectionable comments against Shah made at a press conference in Bengaluru in May of that year during the Karnataka elections. The complainant referred to Gandhi's comment that the BJP claims to believe in honest

and clean politics but has a party president who is an "accused" in a murder case. Shah was BJP president when Gandhi made the comment. About four years before Gandhi's remark, a special CBI court in Mumbai discharged Shah in a 2005 fake encounter case when he was a minister of state for home in Gujarat.

Gangster-turned-social activist Lakha Sidhana, who is testing political waters from the Bathinda parliamentary constituency, claims that his rivals are shying away from speaking about real issues like the drug menace and

are only happy slinging mud. Forty-five-year old Sidhana, who is the Shiromani Akali Dal (Amritsar) candidate, says he is getting an overwhelming response and the people have told him they would be giving him a chance, having tried all other major political parties.

Popularly known as Lakha Sidhana, Lakhvir Singh hails from Sidhana village of Bathinda district.

He had unsuccessfully contested the 2022 assembly

Ex-Indian Army officer with UN killed in Gaza

First international casualty since Israel-Hamas conflict

A former Indian Army offi-cer working with the United Nations was killed in Gaza when the vehicle he was travelling in came under attack in strife-torn Rafah, becoming the "first international casualtv" for the world body since the Israel-Hamas conflict started last year.

The United Nations has called for a full investigation while Israel has ordered a separate investigation into the attack. Col Waibhav Anil Kale, 46, who took premature retirement from the Indian Army in 2022, joined the UN as a Security Coordination Officer in the United Nations Department of Safety and Security (DSS) two months ago, officials in New Delhi said on Tuesday.

Kale, who had served with the 11 Jammu & Kashmir Rifles, was travelling along with another DSS staffer to the European Hospital in Rafah when their UN vehicle was struck on Monday morning. The other person, not identified, was seriously injured. According to Kale's LinkedIn profile, he had joined the Indian Army in April 2004 and

had also served as Contingent Chief Security Officer with the United Nations between 2009 and 2010. He did his B.A. from the Jawaharlal Nehru University in New Delhi and had degrees in Behavioral Science and International Humanitarian Law and had studied at, among other institutions, the Indian Institute of Management at Lucknow and

Indonesian rescuers search through rubble after floods kill 50

Tanah Datar (AP): Rescuers on Tuesday searched in rivers and the rubble of devastated villages for bodies, and whenever possible, survivors of flash floods that hit Indonesia's Sumatra Island over the weekend. Monsoon rains and a landslide of mud and cold lava from Mount Marapi caused rivers to breach their banks. The deluge tore through mountainside villages in four districts in West Sumatra province just before midnight

Saturday.
The floods swept away people and 79 homes and submerged hundreds of houses and buildings, forcing more than 3,300 residents to flee to temporary government shelters, National Disaster Management Agency spokesperson Abdul Muhari said.

Muhari said 50 bodies had been pulled from mud and rivers by Tuesday, mostly in worst-hit Agam and Tanah

Datar districts, while rescuers are searching for 27 people who are reportedly missing. Television reports showed rescue personnel using jackhammers, circular saws, farm tools and sometimes their bare hands, digging desperately in Agam district where roads were transformed into murky brown rivers and villages covered by thick mud, rocks, and uprooted trees.

Scores of rescue personnel were searching through a river around the Anai Valley Waterfall area in Tanah Datar district where tons of mud, rocks and trees were left from flash floods.

Rescuers were focused on finding four people from a group of seven that were swept away with their cars. Three other bodies were pulled out on Monday, said Abdul Malik, who heads the Search and Rescue Office in Padang, the provincial capital.

Palestinians mark 76 years of dispossession as even larger catastrophe unfolds in Gaza

 $P_{\text{will mark the 76th year of}}^{\text{alestinians on Wednesday}}$ their mass expulsion from what is now Israel, an event that is at the core of their national struggle. But in many ways, that experience pales in comparison to the calamity now unfolding in Gaza.

Palestinians refer to it as the "Nakba," Arabic for "catastro-Some 700,000 Palestinians — a majority of the prewar population — fled or were driven from their homes before and during the 1948 Arab-Israeli war that followed Israel's establishment.

After the war, Israel refused to allow them to return because it would have resulted in a Palestinian majority within its borders. Instead, they became a seemingly permanent refugee community that now numbers some 6 million, with most living in slum-like urban refugee camps in Lebanon, Syria, Jordan and the Israeli-occupied West Bank.

In Gaza, the refugees and their

descendants make up around three-quarters of the popula-

Israel's rejection of what Palestinians say is their right of return has been a core grievance in the conflict and was one of the thorniest issues in peace talks that last collapsed 15 vears ago. The refugee camps have always been the main bastions of Palestinian militancy. Now, many Palestinians fear a repeat of their painful history on an even more cataclysmic

All across Gaza, Palestinians in recent days have been loading up cars and donkey carts or set-ting out on foot to already overcrowded tent camps as Israel expands its offensive. The images from several rounds of mass evacuations throughout the seven-month war are strikingly similar to black-andwhite photographs from 1948. Mustafa al-Gazzar, now 81, still recalls his family's monthslong flight from their village in what is now central Israel to the southern city of Rafah, when he was 5. At one point they were

bombed from the air, at another, they dug holes under a tree to sleep in for warmth.

Al-Gazzar, now a great-grand-father, was forced to flee again over the weekend, this time to a tent in Muwasi, a barren coastal area where some 450,000 Palestinians live in a squalid camp. He says the conditions are worse than in 1948, when the UN agency for Palestinian refugees was able to regularly provide food and other essentials.

'My hope in 1948 was to return, but my hope today is to survive," he said. "I live in such fear," he added, breaking into tears. "I cannot provide for my children and grandchil-

The war in Gaza, which was triggered by Hamas' October 7 attack into Israel, has killed over 35,000 Palestinians, according to local health officials, making it by far the deadliest round of fighting in the history of the conflict. The initial Hamas attack killed some 1,200 Israelis.

The war has forced some 1.7

million Palestinians — around three quarters of the territory's population — to flee their homes, often multiple times. That is well over twice the number that fled before and during the 1948 war.

Israel has sealed its border. Egypt has only allowed a small number of Palestinians to leave, in part because it fears a mass influx of Palestinians could generate another long-term refugee crisis. The international community

is strongly opposed to any mass expulsion of Palestinians from Gaza — an idea embraced by far-right members of the Israeli government, who refer to it as "voluntary emigration." Israel has long called for the refugees of 1948 to be absorbed into host countries, saying that calls for their return are unrealistic and would endanger its existence as a Jewish-majority state. It points to the hundreds of thousands of Jews who came to Israel from Arab countries during the turmoil following its establishment, though few of

Georgian parliament approves divisive 'foreign influence' bill

The bill requires media and nongovernmental organisations and other nonprofits to register as "pursuing the interests of a foreign power" if they receive more than 20 per cent of their funding from abroad. The government says the bill is necessary to stem what it deems as harmful foreign influence over the country's politics and to prevent unspecified foreign actors from trying to destabilise it. The opposition has denounced

the bill as "the Russian law," because Moscow uses similar legislation to crack down on independent news media, nonprofits and activists critical of the Kremlin. Mass protests against the law in recent weeks have swept the South Caucasus

Aussie armv whistleblower sent to jail

Melbourne (AP): An Australian judge sentenced a former army lawyer to almost six years in prison on Tuesday for leaking to the media classified information that exposed allegations of Australian war crimes in Afghanistan.

David McBride, 60, was sentenced in a court in the capital. Canberra, to five years and eight months in prison after pleading guilty to three charges including theft and sharing with members of the press documents classified as secret. He had faced a potential life sentence. Justice David Mossop ordered McBride to serve 27 months in prison before he can be considered for release on parole. Rights advocates argue that McBride's conviction and sentencing before any alleged war criminal he helped expose reflected a lack of whistleblower protections in Australia. McBride's lawyer Mark Davis said he planned to file an appeal against the severity of the sentence.

Biden hiking tariffs on Chinese EVs, solar cells, steel, aluminum **AP** WASHINGTON The Biden administration announced plans to slap

new tariffs on Chinese electric vehicles, advanced batteries, solar cells, steel, aluminum and medical equipment — an election year move that's likely to increase friction between the world's two largest economies.


The tariffs come in the middle of a heated campaign between President Joe Biden and his Republican predecessor, Donald Trump, in which both candidates are vying to show who's tougher on China. The tariffs are unlikely to have much of an inflationary impact because of how they're structured. Administration officials said they think the tariffs won't escalate tensions with China, yet they expect China will explore ways to respond to the new taxes on its products. It's uncertain what the long-term impact on prices could be if the tariffs contribute to a wider trade dispute. The tariffs are to be phased in officials arguing their produc-

European Union nations endorsed sweeping reforms to the bloc's failed asylum system on Tuesday as campaigning for Europe-wide elections next month gathers pace, with migration expected to be an important issue.

EU government ministers approved 10 legislative parts of The New Pact on Migration and Asylum. It lays out rules for the 27 member countries to handle people trying to enter without authorisation, from how to screen them to establish whether they qualify for protection to deporting them if they're not allowed to stay. Hungary and Poland, which have long opposed any obligation for countries to host migrants or pay for their upkeep, voted against the package but were unable to block it. Mainstream political parties believe the pact resolves the issues that have divided member nations since well over 1

expert PSM Chandran. Chandran, who is currently heading Sports and Exercise Science at the Khelo India State Centre of Excellence at Kalinga Stadium here, said roping in celebrities to propagate the harmful effects of doping could be a good way to reach out to youngsters.

"First of all, let's make it clear, those who dope constitute 2.5 to three per cent of all the athletes, the other 96.5 to 97

per cent are clean. In sports, there always will be doping, it's a matter of how best you can keep it under control and not about eradicating it," Chandran told PTI in an interview. "Since the minors are also


competing, some of them will do doping, whatever may be the reason. It (doping by minors) is a cause of concern but is not something unexpected. Just like adult sportspersons, they (minor athletes) also think they can get admission (to educational institutions) or get jobs if they

get a medal. "Moreover, dope testing at junior levels is minimal because of lack of funds (for NADA) and they might be samples. Chandran, who has served as

getting caught is less."
In a report published by World Anti-Doping Agency (WADA) in January, India was named as the second worst country in a 10-year global study of positive doping cases by minors. Russia topped the list, followed by India and China.

Last month, in another WADA report, India registered the highest percentage of failed dope tests among countries which tested more than 2000 samples, based on the figures

India tested 3865 samples (urine, and blood combined) during the recorded period, of which 125 returned adverse analytical findings. This amounted to 3.2 per cent of the



hurdle in conducting tests at junior level competitions. "It costs around Rs 25,000 per

test, this includes cost of the kits, transportation and laboratory charges as well as courier charges. But where is the money and how many tests vou can do from the budget, these are the questions to be asked.

"With the limited resources, how many tests can NADA do? Can they do testing for all sports? So, NADA has to go for sports like weightlifting and athletics (where doping is more rampant) and leave 22.30 crore to NADA, a slight increase than the 2023-24 amount of Rs 21.73 crore.

Chandran also said that more than highlighting the moral aspect of doping, the focus should be on its harmful effects on health, especially on youngsters.

"How it effects health, that should be highlighted. You talked about the moral side and the violation of the spirit of playing sports. That does not help," he said.

Talking about innovative ideas on how to control doping, he said, "I always tell NADA people that they should spend health through mass media like during live telecast of big sporting events. For example, during Indian

Premier League (cricket) live telecast, celebrities from all walks of life, including sportspersons, can spread messages in a 10 or 20 second slot on the harmful effects of doping on health, especially on the youth. NADA can earmark money for doing this.

"The message will reach millions of people, including parents. We have to reach out to more people, telling them that doping is injurious to health," said Chandran who has been a member of the NADA Anti-Doping Panel for many years.

Shastri, Ashwin back Impact Player rule

The "Impact Player" rule might have come in for sharp criticism in the ongoing IPL, but former India coach Ravi Shastri and senior spinner Ravichandran Ashwin have backed it, stating that it leads to more close finishes.

The rule, implemented in the competition last season, has been a topic of debate this edition, with some experts and current players saying that it will make all-rounders redundant.

"When any new rule comes in, there will be people who will try to justify why that's not right," Shastri said.

"But with time, when you see the scores — 200 and 190 and then, individuals grabbing that opportunity and making the most of it, people will start re-looking at how they think about it."

Shastri vouched for the rule, saying that the game has to evolve with time.

"The Impact Player (rule) is good. You have to evolve with the times. It happens in other sports as well. It's got tighter finishes," he said on Ashwin's YouTube channel.

"I think it's a good rule. You saw the number of tight finishes we had in last year's IPL. So, it has made a big difference." BCCI Secretary Jay Shah had recently said that the rule is not permanent.

"Impact Player is like a test case. We have implemented it slowly. The biggest advantage of it is that two Indian players are getting a chance (in each game), which is the most important," he told the media in Mumbai last week.

"We will consult with the players, franchises, players, broadcasters (and take a call). This is not permanent, (but) I am not saying that it will go.
"(We'll see) if it's making the

game more competitive or not. Even then, if a player feels that this is not right, then we will talk to them. But no one has told us anything yet. So, it will be decided after the World

India skipper Rohit Sharma and Delhi Capitals' Axar Patel and Mukesh Kumar, also expressed their displeasure with the rule.

"I genuinely feel it is going to hold back the development of all-rounders because eventually cricket is played by 11 players, not 12," Rohit had said a couple of weeks back.

"So, I am not a big fan of the Impact Player rule because you are taking so much from the game just to make it a little more entertaining for the people around you.
