# MALIWAL'S NIGHTMARE

→he First Information Report (FIR) lodged by AAP leader and Rajya Sabha MP Swati Maliwal against Delhi Chief Minister Arvind Kejriwal's Personal Secretary Bibhav Kumar has revealed shocking details of the assault.

Maliwal alleged that Kejriwal's aide Kumar "slapped" her "at least seven to eight times" while she "continued screaming" and "brutally dragged" her while "kicking" her on the "chest, stomach, and pelvis area", and threatened with dire consequences. "When I called 112 (emergency

number) after the assault, Kumar said do what you have to do. You can't spoil anything for us. We'll bury and dump you in such a place that no one will even know," read the FIR.

In a related development, Maliwal on Friday went to Tis Hazari court to record her statement before a magistrate about the alleged assault on Metropolitan magistrate Katvavini Sharma Kandwal recorded Maliwal's statement in her chambers. Under section 164 CrPC, a judicial magistrate is empowered to record any statement or confession made before him during the course of an investigation.

The medico-legal case report also confirmed that she has suffered internal injuries to her face.

Maliwal underwent a four-hour-long medical check-up at AIIMS Delhi in the wee hours of Friday. A Delhi Police team reached AIIMS with the AAP MP at around 11 pm and left at around 3:15 am.

Delhi Commission for Women (DCW) member Vandana Singh also accompanied Maliwal. During this medical examination, an X-ray and CT scan were done.

According to the FIR, on May 13, Maliwal visited Kejriwal's camp office at his Civil Lines residence where she called and messaged Kumar, but

couldn't reach him. As she waited for the CM in the drawing room, Kumar "suddenly barged in, screamed at her without provocation and abused her", before allegedly assaulting her, it states.

The FIR based on Maliwal's complaint, recorded on Thursday, three days after the incident, states that as Kumar was not present at the CM's house, she went inside the residential area "through the main door, as she has always done in the past year", and told the CM's staff that she was there to meet him.

The FIR reads, "I went inside the camp office and called Kumar, but I could not go in. I then sent a message to his mobile number (through WhatsApp). However, there was no response. I then went inside the residential area through the main door as I have always done in the past year. Since Kumar was not present, I entered the residence area and informed the staff present there to tell the CM that I was there to meet him."

She said a staff member informed me that the CM would meet me shortly, and suddenly, the PS of the CM, Bibhav Kumar, barged into the room. "He started screaming without any provocation and even resorted to verbal abuse. I was stunned by this sudden outburst and reacted by telling him to stop talking to me in such a manner and to call the CM. He said, "How dare you not obey us? How can you not obey us? Your status is so low that you won't refuse us. You're a lowly woman, we'll teach you a lesson," she claimed in the FIR.

Maliwal said while uttering these words, he came and stood right in front of me. "Without any provocation on my part, he started hitting me repeatedly," she said.

"He slapped me at least 7-8 times while I continued to scream for help. I felt absolutely shocked and kept screaming for assistance.


## Caste a big factor in Ram Janmabhoomi

The grand inauguration of The grand mangarethe Ram Mandir by Prime Minister Narendra Modi on January 22 has thrust Ayodhva into the international spotlight However, the electoral dynamics in this Lok Sabha constituency, still commonly referred to as Faizabad, are far more complex, deeply influenced by intricate caste equations alongside temple politics. In this high-stakes seat, the BJP's Thakur candidate Lallu Singh faces stiff competition from SP's Dalit candidate and sitting MLA Awadhesh Prasad, and BSP's Brahmin candidate Sachhidanand Pandey. Pandey, who recently switched allegiances from the BIP to the BSP, aims to capture the Brahmin vote bank.

"Ayodhya is synonymous with Lord Ram. But when it comes to elections, invoking Ram's name is not enough. The caste of the candidates also matters," observed political analyst Rajesh N Bajpayee.

He highlighted that while outsiders might see Ayodhya as a BJP bastion due to its long-standing advocacy for the Ram Temple, the reality is more nuanced. Since 1989, there have been eight Lok Sabha elections, and the BIP has won only four of them. Lallu Singh and Vinay traffic jams and crowds of remain crucial in the



Kativar each won twice, while Mitrasen Yadav won three times-twice on an SP ticket and once as a CPI candidate. The SP also clinched the seat in 2009.

During the peak of Ram Lahar following the demolition of the Babri Mosque in 1992, the BJP faced defeat in the 1993 Vidhan Sabha election due to a strategic alliance known as social engineering. Kanshi Ram and Mulavam Singh Yadav joined forces, leading to the formation of

SP and BSP. Locals attest to Ayodhya's transformation following the consecration of Lord Ram. The city now bustles with

pilgrims from across the country. The once tranquil 13-km road connecting Ayodhya with Faizabad, now renamed Ram Path, has become the city's bustling hub, reminiscent of

Connaught Place in Delhi. "This Ram Path has become the city's lifeline. with

prominent eateries, big merchandise shops, and business centers emerging. Quaint souvenir shops have transformed into modern establishments adorned with Ram Temple models, saffron flags, and other Hindu memorabilia," said BP Singh, a local resident.Despite the prominence of saffron politics, caste dynamics

Faizabad Lok Sabha seat, which votes on May 20 in the fifth phase.

Modi underscored the BJP's focus on this constituency with a roadshow on May 5, supporting Lallu Singh's bid for a third consecutive term. Dalits constitute 26 per cent of the constituency's population, mainly from the Rawat, Chamar, and Kori of communities. SP candidate Awadhesh

Prasad, a seasoned politician and the party's Dalit face, is contesting from here. Prasad, the SP MLA from the Milkipur Assembly constituency, has had a long political career since his first Assembly win in 1977. After losing the 2017 Assembly election, Prasad reclaimed the Milkipur seat in 2022.

Meanwhile, former BJP leader Sachhidanand Pandey is the BSP's candidate, representing Brahmin interests.

"This contest is likely to be interesting because caste plays a significant role," said Das a local journalist "The upper castes predominantly support the BJP, while Dalits and Muslims are likely to back the INDIA Bloc candidate."

Veteran BIP leader Lallu Singh is relying on a unified Hindu vote to secure his seat. Singh's campaign, led by Kamla Kant, is based out of the party's office on Ram Path.

Despite his strong local connections and presence at community events, Singh is actively canvassing to retain his position.

The caste composition of the Faizabad constituency includes 26 per cent Dalits (Rawat, Chamar, Kori), 14 per cent Muslims, 12 per cent Kurmi, 12 per cent Yadav, 12 per cent Brahmin, 6 per cent Rajput, 4 per cent Vaish, 5 per cent Kewat/Mallah/Nishad, and 12 per cent other OBCs. This diverse demographic will play a critical role in the upcoming election.

As Ayodhya continues to evolve, the intersection of religious significance and electoral politics makes the Faizabad Lok Sabha seat a focal point in the 2024

On the day the people of 58 parliamentary constituencies in six States and two Union Territories, including Delhi, Haryana, and Uttar Pradesh, go to the polls for the sixth phase phase of the 2024 Lok Sabha elections, the hottest nine days of the year, also known as Nautapa, will begin.

Nautapa, which will continue until June 2, is also considered the birth time of the southwest monsoon. During Nautapa, the Sun is closest to the Earth, resulting in intense heat. The maximum temperature is expected to range from 42 degrees Celsius to 45 degrees Celsius, which may feel like 50

astrologer Dr SN Vajpayee, Nautapa will begin from May 25, the day people of Delhi will cast their vote and will continue till June 2. 'It is believed that due to the

heat of the Sun and the water element of Rohini, this is the birth time of the monsoon and due to this reason Nautapa is considered to be the birth time of the monsoon," he said.

According to astrologers, during the nine days of Nautapa, a large portion of the earth experiences severe heat when four planets — Sun, Mars, Mercury and Saturn are at the same place in the horoscope.

planets is called Samasaptaka Yoga. The conjunction of the Sun, Mars, Mercury and Saturn is observed annually during Nautapa. It is believed that rain during Nautapa indicates less rainfall

Political experts predict that Defence Minister Rajnath Singh, the BJP candidate for Lucknow Lok Sabha constituency, is heading for a win, though it would not be a

walk for Rajnath. "Lucknow Lok Sabha constituency will not be a cakewalk for Rajnath Singh because Samaiwadi Party candidate Ravidas Mehrotra will put up a good fight. There are people dissatisfied with the BJP. The youth are questioning why exam papers are consistently leaked. It's understandable when it happens once or twice, but not repeatedly. The issue isn't that Rajnath Singh is a towering personality and Ravidas Mehrotra is no match; it's that people want to see the BJP lose. Ravidas Mehrotra

may not win, but he is in the

contest," he said. He added that He also suggested that the Mohanlalganj seat might see a victory for the Samajwadi Party candidate.

Regarding the BSP, he noted it is largely absent. "The BSP has a vote bank among the Dalits. Reservation issues resonate with the Dalits, who believe the BJP will tamper with the Constitution, and they may vote for the Samajwadi Party this time," he said.

A political expert from a university in Lucknow pointed out that while the BJP has traditionally dominated the Lucknow Lok Sabha constituency, this election would not be a walkover.

"The Samaiwadi Party has their voters, and there is also an anti-BJP vote going to them. In the Party crossed 30 per cent vote share, which is significant in Uttar Pradesh's electoral politics. Ravidas Mehrotra has been an MLA and has a presence that will challenge Rajnath Singh. However, Rajnath Singh's stature and the respect he commands, even among some Muslims, give him an edge," he explained.

He further remarked that Kaushal Kishore is facing a tough fight due to family controversies. "Kaushal Kishore has been embroiled in controversies regarding his family, making his race a tough one," he said

About OP Srivastava, he noted that ruling parties generally have an advantage in by-elections. "Since the seat was with the BJP, they have an upper hand," he added. Another political expert from

a prominent university in the city predicted a clear win for Rainath Singh.

"Rajnath Singh has been here for a long time and has support from several castes and professions. He is well-connected and grounded, familiar with the Lucknow setup," she said. She also noted that Srivastava from the Lucknow East Assembly constituency enjoys significant support due to the Kayastha lobby. "Caste dynamics play a crucial role, and Srivastava has substantial back-

ing," she added.
Addressing the opposition parties' claims that the BJP would alter the Constitution, she dismissed it as propaganda. "Most parties are addressing similar issues like inflation. Caste will influence votes, and the SC/ST communities are unlikely to vote for the BJP due to reservation concerns," she added.

King George's Medical University has become the first centre in the state to provide pulmonary palliative care. On

the occasion, head of the respiratory medicine department Prof Surya Kant said that pulmonary palliative care is a boon for patients with severe and chronic respiratory diseases. "When such a patient comes to us, our first objective is to treat them, the second is to control the symptoms of their disease, the third is to provide relief from the disease, and the fourth is to manage the severity of their disease. If we are unable to stop it, this is where pulmonary palliative care begins," he explained. Pulmonary palliative care is a multi-dimensional medical approach that includes subtle exercises, yoga, pranayama, pain treatment, counselling, diet, humane compassion, oxygen nebulisation, and other supportive medical therapies.

#### **Probe begins** into suicide by **LESA** worker

Lucknow (PNS): An investigation has been initiated into the case involving LESA contractual employee Gulab Kumar, who allegedly ended his own life by jumping in front of a train near Sitapur road police station crossing on Thursday.

The bereaved family members alleged that Gulab committed suicide due to harassment by the JE and SDO posted at Kathwara power house, who threatened to file an FIR against him for electricity theft.

The family members, who staged a protest at the power house demanding the registration of an FIR against the JE and SDO in question, also managed to forcibly switch off the feeder. The victim was employed at Kathwara power station in the area.

In a complaint filed with the police on Thursday evening, Gulab's wife Bitti alleged that SDO Raikumar, IE Ajay Kumar, and SSO Rahul Gautam threatened to file a case against him for allegedly tampering with his house meter and pilfering electricity. Furthermore, the bereaved family members claimed that Gulab was transferred to Ahibaranpur subcentre two days ago following an alleged conspiracy against him. Itaunja SDO Kajkumar stated that JE Ajay Kumar had asked Gulab to report to the power house on Wednesday night regarding an 11KV break-down. When Gulab did not comply, Ajay Kumar visited Gulab's house and allegedly found evidence of power theft, resulting in an FIR being lodged against Gulab. He was the sole breadwinner for the family. Executive engineer DP Singh reached the scene and assured the family of Rs 6 lakh in compensation. He added that the SDO and JE would be removed from their positions due to opposition from family mem-

The villagers, meanwhile, heard the screams of Saif, who had become unconscious by the time they reached to help him. The villagers saw Saif struggling for life in a pool of blood and immediately took him to the hospital and informed his

Rahul struck an emotional chord while addressing an election rally in Amethi, the constituency that sent him to the Lok Sabha for three consecutive terms before electing Smriti Irani in the 2019 general elections.

While speaking at the rally, Rahul asserted that he continues to "belong" to Amethi even though he is not contesting the seat this time.

He is in the process of purchasing a new flat in Lucknow as recently he visited a couple of apartments." Akhilesh Yadav reminded the people about the unfulfilled promise made by the Prime Minister Narendra Modi during the 2022 UP assembly election regarding the stray cattle menace.

External Affairs Minister S Jaishankar said here on Friday Asia is witnessing new tensions in land and sea as agreements were dishonoured and rule of law disregarded while terrorism has started to consume those who have long practised it. These assertions came in the backdrop China's military continuing posturing along the frontier in eastern Ladakh and Pakistan's support to cross-border terrorist activ-

In an address at an event hosted by the Confederation of Industries(CII), Jaishankar also talked about the power of currency and how "threat of sanctions" are deployed in the "toolbox" of global diplomacy, in remarks that came days after the US warned of punitive measures after India and Iran sealed a deal on the Chabahar port.

Jaishankar extensively delved into the consequences of the Ukraine conflict, escalation of violence in West Asia and disruption of logistics in view of the geopolitical tensions, sanctions, incidents of drone attacks in the Red Sea and climate events.

"The world is experiencing a 3F crisis of fuel, food and fertilisers. In Asia, new tensions have emerged in land and sea as agreements are dishonoured and rule of law disregarded," he said at the annual general meeting of the CII.

This will be even more so as 'Make in India' gathers more steam in domains like defence, semiconductors and digital," he said.

"An economy with India's prospects also has to look at accessing global resources more seriously if we are to fuel our growth," Jaishankar said.

For long, we have looked at Russia from a political or security perspective. As that country turns eastwards, fresh economic opportunities are presenting themselves," he said. Jaishankar said the world is today "paradoxically rebuilding" itself even as it is being disrupted. "As new production and consumption centres emerged in the last few decades there is an accompanying compulsion to create commensurate logistical corridors," he said.

## Government's proposal to sell over the counter medicines in general stores opposed

The Government's proposal to sell over-the-counter (OTC) drugs, including antibiotics and other habit-forming medications, in general stores and grocery stores has sparked significant opposition from retail chemists and pharmacists associations across the States.

They are vehemently opposing the move, expressing concerns about the potential risks associated with easier access to these medications. Bengal Chemists and Druggists Association (BCDA), under the All India Organisation of Chemists & Druggists (AIOCD) a leading



association of pharmacists in India, said the move will pose significant public health risks due to the lack of pharmacist oversight and potential for misuse of drugs.

Sankha Roy Chowdhury and Sajal Gangopadhyay, President and General Secretary respectively of the BCDA said, "Approximately 400 compositions in general stores and gro-

cery stores including antibiotics, other habit forming drugs, nasal spray and others will be on the OTC at traditional grocery shops. "Such a move would flout the existing drug and cos-metics laws of India, pharmacy regulations and pertinent legal charters including directives from the supreme court."

The Associations asserted that India's existing network of nearly 12.40 lakh retail chemists and 13.5 lakh pharmacists is sufficient to meet the population's needs for OTC drugs. They urged the government to consider these concerns and involve all stakeholders in discussions before implementing any policy changes regarding OTC drug of the AIOCD too criticised the move. It has submitted a memorandum to the Centre apprising the authorities about the adverse effects of selling medicines to the common man by unqualified persons.

"Drug sale is a regulated area, and all the common medicines need to be regulated by authorized officials as per drug rules and monitored by qualified pharmacists," he asserted and equated the move with like unlicensed permission to sell grocery shop owners medicines to the common man because it will affect the health of the people. "This will affect the credibility of the whole medicine traders also," he added.

## EC issues notice to former Judge turned BJP candidate for remarks against Mamata

The EC in its notice noted that Gangopadhyay's comment has been found to be "improper, injudicious, beyond dignity in every sense of term, in bad taste" and prima facie violative of the provisions of the Model Code of Conduct and its advisory to political parties.

'Now, therefore, you are hereby called upon to show cause by 17.00 hrs of 20.05.2024 as to why appropriate action for violation of Model Code of Conduct should not be taken against you. In the event of no response from your side within the stipulated time, it will be presumed that you have nothing to say in the matter and the Election Commission will take appropriate action or decision in the matter without making any further reference to you, the EC said The TMC on Thursday moved

the Election Commission and BJP candidate, Abhijit Gangopadhyay, for allegedly making "misogynistic" remarks against West Bengal chief minister Mamata Banerjee.


## Climate change worsens patients' neuro diseases: Study

Living with neurodegenerative diseases such as Parkinson's and Alzheimer's disease has its daily struggles, but climate change is all set to add another layer of difficulty to people with such conditions, a study published in The Lancet Neurology has warned.

Following a review of 332 papers published across the world between 1968 and 2023, the team, led by Professor Sanjay Sisodiya (UCL Queen Square Institute of Neurology), said they expect the scale of the potential effects of climate change on neurological diseases to be substantial. The team underscored the urgency of comprehending the impact of climate change on this vulnerable population to mitigate adverse health outcomes and prevent exacerbating existing health disparities.

They considered 19 different nervous system conditions, chosen on the basis of the Global Burden of Disease 2016 study, including stroke, brain diseases included They considered 19 different



analysed. Professor Sanjay Sisodiya, who is also Director of Genomics at the Epilepsy Society and a founding member of Epilepsy Climate Change, said: "There is clear evidence for an impact of the climate on some brain conditions, especially stroke and infections of the nervous

The climatic variation that was shown to have an effect on extremes of temperature (both low and high), and greater temperature variation throughout the course of day - especially when these measures were seasonally unusual. "Night time temperatures may

be particularly important, as higher temperatures through the night can disrupt sleep. Poor sleep is known to aggravate a number of brain conditions." The researchers found that there was an increase in admissions, disability or mortality as a result of a stroke in higher ambient temperatures or heat waves which are becoming more frequent and intense due to climate change

that people with dementia are susceptible to harm from extremes of temperature (e.g. heat-related illness or hypothermia) and weather events (e.g. flooding or wildfires), as cognitive impairment can limit their ability to adapt behaviour to environmental changes.

"Reduced awareness of risk is combined with a diminished capacity to seek help or to mitigate potential harm, such as by drinking more in hot weather or by adjusting clothing.

"This susceptibility is compounded by frailty, multimorbidity, and psychotropic medications Accordingly, greater temperature variation, hotter days, and heat waves lead to increased dementia-associated hospital admissions and

Heat stress can exacerbate symptoms such as cognitive impairment, fatigue, and motor dysfunction, leading to increased morbidity and mortality among this population. Moreover, disruptions in healthcare services and access to essential medications and treatments resulting from extreme weather events, such as hurricanes, floods, and wildfires, can further compound the challenges faced by individuals with neurodegenerative conditions.

Yet another review on studies investigating climate change and neurodegeneration has found evidence that a 1.5°C increase in mean ambient temperature correlated with more hospital admissions for dementia of Alzheimer's type (DAT) disease patients. Higher temperatures may accelerate Tau phosphorylation, a characteristic of Alzheimer's disease, serving as a potential explanation for increased disease severity, said the review published in StressMarq Biosciences plat-

## **Hot as Hades**

The Indian Meteorological Department has forecast severe heatwave, leading to high health risk

s if the scorching sensation on the skin and mercury's validation of the heat and humidity were not enough, the Weatherman has issued a stark warning for northwest India, forecasting a severe heatwave with a high health risk over the next week. The announcement comes as temperatures continue to soar, posing significant challenges to people's wellbeing and safety. With temperatures likely to reach alarming levels, the Indian Meteorological Department (IMD) advisory underscores the urgency for residents, authorities and healthcare providers to take proactive measures to mitigate their impact. Heatwaves are characterised by prolonged periods of excessively high temperatures, often accompanied by high humidity levels, which can exacerbate the risk of heat-related illnesses and even fatalities. Northwest India, comprising States such as Rajasthan, Gujarat, Punjab, Haryana and parts of Uttar Pradesh and Madhya Pradesh, is particularly susceptible to extreme heat events due to its geographical location. Prolonged



exposure to high temperatures can lead to various ailments, including exhaustion, heatstroke, dehydration and cramps. Vulnerable populations – such as the elderly, children, pregnant women and those with pre-existing health conditions – are at heightened risk during such extreme weather conditions. Heat-related illnesses can manifest swiftly and escalate rapidly, necessitating prompt medical attention. Symptoms such as dizziness, nausea, rapid heartbeat, confusion and fainting should not be taken lightly. Of course, one cannot fight Nature but one can always be prepared to minimise its ill effects.

To mitigate the adverse effects of the IMD forecast, it is essential to launch comprehensive public awareness campaigns to educate residents on the risks and preventive measures of heatwaves. As a thumb rule, those living on pavements and in shanties are at bigger health risk. Establishing cooling centres with air conditioning, fans and hydration facilities will provide critical relief to the vulnerable population. Encouraging people to stay hydrated and seek shelter in cool, shaded areas during peak heat hours is vital. The old system of piyaus is long gone; instead, now only bottled water is available. The Government must set up water kiosks so that people can get free, clean drinking water on the go. Additionally, urban planning strategies that incorporate green spaces, tree cover and reflective surfaces can mitigate the urban heat island effect and enhance thermal comfort in urban environments. During summers, water scarcity and power cuts turn things worse. The authorities must ensure that load shedding is kept to a minimum and clean drinking water is available; otherwise the chances of outbreak of waterborne diseases are high. As northwest India braces for a severe heatwave, prioritising public health and safety is paramount. The IMD forecast serves as a crucial reminder to remain vigilant, stay informed and make concerted efforts to mitigate the risks. We have braved many adversities; this too will pass!

# Assault most foul for kindness to animals



The man who savagely assaulted a young girl who was feeding stray dogs in Delhi must receive exemplary punishment

ccording to a report in the Free Press Journal, a young girl, Manisha Solanki, who feeds 150 stray dogs daily, was abused, harassed, beaten with a stick and left bleeding and crying in pain in Raghubir Nagar in North Delhi on May 14, 2024. The man, who reportedly attacked her, works in a roadside shop. He is also said to have savagely attacked the dogs who were quietly and peacefully eating the food she had brought. At least one dog was severely injured as the stick had nails attached to it. The police, who have lodged an

FIR following a complaint by the girl's father, need to follow up the matter vigorously and ensure that exemplary punishment is handed out to the culprit. The report that the stick had nails attached to suggest indicates that the intention was not just to hit but cause the maximum amount of pain. Also, the report that Manisha Solanki was doing no more than pleading with the man not to attack the dogs who were just peacefully eating, suggests that the person is utterly vicious by disposition. Such men are a threat to society and have to be regarded as such by the police. This is not the first incidence of its kind. In July, 2021, a 28-yearold woman was assaulted in East of Kailash by a mother-daughter duo. For the same reason, a woman was savagely beaten in Delhi's Sunlight Colony May, 2018. These are just two examples; others can be cited. Besides being assaulted, those who feed and care for stray dogs in India are also abused and harassed. It is often argued that this is because stray dogs bite and feeding ensures that their numbers grow. What is not realised is that there has been a steep fall in the number of dog bites in recent years. According to a report in The New Indian Express (datelined December 3, 023), by litendra Choubey, over 75 lakh cases of dog bites were reported in India in 2018; the figures were over 72 lakh in 2019, 46 lakh in 2020. It was over 17 lakh in 2021 and 21.8 lakh in 2022. Another report by Nikhil



(datelined March 27, 2024) cites data tabled in Parliament by the Ministry of Health and Family Welfare showing an increase to 27.8 lakh in 2023. Despite being higher than the preceding two years, the figure of 27.8 lakhs marks a massive decline from that of of over 75 lakh recorded in 2018.

Besides, the accuracy of these figures has been a subject of scepticism. A report (datelined March 19, 2024) by Shainu Mohan in The New Indian Express cited N. Jayachandran, an animal rights activist and a former member of the Kerala State Animal Welfare Board, as describing the figures of dog bites as inaccurate and saying that there were no specific details and even scratches by cats were recorded as dog bites. Doubts about the reliability of

the existing figures of dog bite cases, is implied in the communication dated March 7. 2024, from the Union Government's Directorate-General of Health Services (DGHS), Governments asking them to provide quality data on animal bites from all public health centres, community health

centres, district hospitals and tertiary care facilities with inclusion of specific details regarding bites by pet and stray dogs. Of particular significance is the directive to avoid multiple entries of the same animal bite victims by maintaining separate records for new and follow-up patients in the animal bite exposure reg-

The suggestion is clear: there have been duplications.

In many cases, pet and not stray, dogs have been responsible. Reliable figures for the whole of India do not exist. The ones that are available clearly underline this point. According to a report by Anuradha Kher in *The Times* of India of May 24, 2004, Sassoon Hospital at Pune had recorded as many as 3,185 dog bite cases until May that year. She quoted Namdeo Patil, the hospital's medical officer, as himself to man." Lorenz, ethsaying that pet dogs were nologist and ornithologist responsible for 70 per cent of the cases.

That the percentage of bites by stray dogs continues to be very high and one needs accurate statistics regarding their involvement, is clearly reflected in the DGHS's communi-

cation directing that the cases of pet dogs biting people be separately recorded.

Unfortunately, people who assault, abuse and harass those who feed and care for stray dogs do not realise this. They are emotional cripples brimwith ming Notwithstanding their aggression, the number of people looking after stray dogs is increasing all over India. Twenty years ago, one rarely saw people feeding them or vaccinating them on the

Today, one sees them in most neighbourhoods. This is hardly surprising given the nature of dogs. Konrad Lorenz (1903-1989) wrote in Man Meets Dog, "The whole charm of the dog lies in the depth of the friendship and the strength of the spiritual ties with which he has bound and recipient of the 1973 Nobel Prize in Physiology or Medicine along with Nikolaas Tinbergen and Karl Von Frisch, should know.

# Reflections on the end of a 30-year war



Amidst scenes of unspeakable horror and relentless violence, the echoes of past atrocities resonate, urging a deeper understanding of the human cost of conflict

ifteen years ago, on a day like today, the final bullet was fired, bringing an end to the 30-yearlong war in Sri Lanka. The harrowing memories we witnessed have become a thing of the past, but their echoes still reverberate in our minds. However, I don't intend to offer a political analysis; instead, I aim to reflect on the unimaginable suffering endured by fellow human beings in this troubled land. Pain was not unique to the location where this brutal war took place, nor was any specific community singled out for oppression. The entire country, in various ways, was haunted by enemies in different forms. In my memory, there's a chilling scene that's deeply ingrained, a moment of unspeakable

horror from my childhood innocence. At just six years old, I held tight to my mother's hand, driven by morbid curiosity like the others in our village who gathered hasti-ly. Together, we witnessed the grim sight of a half-charred corpse, a stark reminder of the darkness plaguing our land. The over-powering smell of death overwhelmed us, defying our feeble attempts to shield ourselves from its grip. By the roadside, where our community thrived, lay the lifeless body of a man, his agonising death a haunting echo of the brutality lurking in the shadows. As the fire consumed his flesh, the echoes of his cries pierced the night, mourning a future stolen by merciless hands. To this day, the identity of his attackers remains a mystery, their cruelty matched only by their cowardice. In their relentless pursuit of violence, they showed no regard for the family he left behind, extinguishing life with a cold indifference that sends shivers down the spine.
That fateful day remains a solemn reminder

of the darkness within the human heart, a stark acknowledgement of life's fragility in a world torn by chaos and despair. The sight of a skull, once full of life, now a grotesque symbol of agony, serves as a testament to the depths of human cruelty. Its gaping maw and charred teeth tell of the unspeakable suffering endured by its unfortunate owner — a chilling reminder of the atrocities committed by those in power. Illuminated by a burning tyre, this macabre scene exposes the brutality of oppressors who sought to crush dissent with an iron fist.

Yet this is just one episode in the cha engulfed Sri Lanka during the second uprising of the Janatha Vimukthi Peramuna (JVP). The horrors of that time still linger in my mind, a grim reminder of the generation born into a world besieged by violence and despair. For the parents of this generation, survival was the sole pursuit, each day a desperate struggle against the spectre of death. To stand with the State was to invite the wrath of revolutionaries who lurked in the shadows, waiting to mete out their brand of justice in the dead of night. Conversely, to align oneself with the revolutionaries was to invite swift and merciless retribution from the State apparatus, which spared no effort in its quest to crush dissent with utmost brutality. This was the grim reality that defined an era — a reality where horror knew no bounds and mercy

was but a distant memory. In the Sinhalese-dominated areas of the country, flames of rebellion raged unchecked, while in the north and east, where Tamils and Muslims held sway, the spectre of terror loomed large, casting a pall of fear over all who dared to defy the status quo. In this fractured landscape, where lines of ethnicity and ideology blurred in



the face of unrelenting violence, the suffering of innocent lives knew no

In the crucible of my high school years, the Tamil Armed groups, notably the Liberation Tigers of Tamil Eelam (LTTE), cast a long shadow over the land, their reign of terror reaching its zenith. Following the peace talks convened in Thimpu, Bhutan, the LTTE embarked on a ruthless campaign to assert their dominance, ruthlessly eliminating rival Tamil factions that dared to challenge their authority. Even those groups previously supported by the central Government under the leadership of Indira Gandhi and the State Government of Tamil Nadu were not spared from their wrath, as the LTTE sought to establish itself as the sole arbiter of Tamil interests.

TERROR Concurrently, amidst this bloody power struggle, the LTTE unleashed a wave of terror aimed at forcibly displacing Sinhalese and Muslim communities from the Northern peninsula, affording them scant ours to abandon their homes and livelihoods. Many Muslims scrambled to escape the impending violence, seizing whatever means of transportation they could find to flee to Government-controlled territories, where they hoped to find sanctuary from the chaos engulfing their homeland. Among these displaced individuals emerged tales of resilience and triumph, as some managed to rebuild their lives, ultimately ascending to positions of prominence as successful businesspersons and influential politicians. Yet, these stories of triumph are tempered by the grim reality of displacement and loss, serving as poignant reminders of the human cost exacted by the unrelenting tide of conflict and upheaval.

The reign of terror orchestrated by the LTTE unfolded with chilling precision, sparing none who dared to oppose its fascist ideology. Beginning with the systematic elimination of rival armed factions, the LTTE's campaign of violence soon expanded to target not only other ethnic communities but also Tamil intellectuals who dared to advocate for political solutions and the right to self-determination. Rajani Thiarangama, a revered intellect and champion of Tamil rights, met a tragic end at the hands of LTTE militants in Jaffna-stark evidence of their ruthless intolerance of dissenting voices.

In my discussions with her father, A Rajasingham, years later in Colombo, the heartbreaking tale of his daughter's untimely demise offered a glimpse into the insidious tactics employed by the LTTE to silence its critics. This chilling account serves as but one example of the lengths to which the LTTE would go to impose its will upon the Tamil people, resorting to violence and coercion to enforce compliance. As the ranks of Tamil intellectuals dwindled, the LTTE turned its sinister gaze towards a new target: the recruitment of children into its ranks. Thousands of innocent youths were forcibly torn from their families, subjected to relentless indoctrination and thrust onto the not been wisely utilised to address battlefield, their tender frames bearing the weight of weapons far

beyond their years. Tragically, some would be groomed as suicide bombers, indiscriminately targeting politicians and unarmed civilians alike in a twisted bid for supremacy. As a war reporter, I witnessed the grim reality of child soldiers within the LTTE and its breakaway faction; some of them were even unable to hold their weapons properly. Many of them were malnourished, their skeletal frames visible and for them, attending school was a dream that

never came true. The horrors unleashed by the LTTE knew no bounds, wreaking havoc upon innocent lives while lining the pockets of those who profited from the chaos. Even in distant Western nations, Tamil communities were subjected to extortion and intimidation, coerced into financing the LTTE's reign of terror under threat of violence or retribution against their loved ones back home. Despite damning reports by organisations

like Human Rights Watch exposing these atrocities, the truth was often overshadowed by pro-LTTE propaganda, whitewashing the brutality of their so-called "liberation struggle." Consequently, those who fought against this unimaginable terror of tyranny were blamed. That is why, understanding this brutal reality and the plight Tamils were forced to endure is essential homework before succumbing to preju-

War came to an end in May 2009, after a prolonged conflict that lasted for over three decades. Since then, numerous discussions have been held regarding the identification and condemnation of those actively involved. In the aftermath, countries have rapidly developed, logistics have been enhanced and connectivity has tremendously improved. Simultaneously, thousands of ex-LTTE members have been rehabilitated and reintegrated into society, with some even marrying Sinhalese individuals. However, the victory over terror has systemic issues within the State structure. Excessive politicisation and the exploitation of this "victory" for personal gain by certain parties have undermined social responsibilities.

The Government's failure to effectively respond to false allegations regarding casualties and mission details has had lasting repercussions. Many misconceptions and fabricated stories, propagated by vested interests aiming to distort the true nature of this brutal period, have further complicated matters. Regrettably, there is a glaring absence of discussions on safeguarding peace and averting the recurrence of past atrocities. There is no meaning in celebrating 'victory' over the loss of human lives, but rather in building a national conscience to unite everyone towards a common goal, where peace is a precious gem cherished by all, to safeguard for generations to come.

Ámit & Archana Chandra, Ashish Dhawan, Ajit Isaac, Harsh Gopalakrishnan, Romesh and Sunil Wadhwani, Desh Deshpande and Vikrant Bhargava are a few of the great examples of new-age philanthropists, developing a portfolio of philanthropic initiatives including institution building and systemic change projects. This trend is only going to accelerate.

Another key trend to emerge is the gradual reduction in the average age of philanthropists. These younger and newer donors, representing both current family benefactors and first-generation wealth creators, are breaking through traditional barriers with innova-

ves substantial systemic tive and disruptive approaches to giving and are branching out to address issues beyond the historically favoured domains of healthcare, education and livelihoods. The emerging tribe of NextGen philanthropists coupled with the next generation of grassroots organisations-driven by young, committed and techsavvy professionals-is set to transform the giving landscape in the coming years. The proportion of technology

entrepreneurs is also increasing and these philanthropists have given more generously when compared to other sectors. While they account for about 8 per cent of overall wealth in the space, their philanthropic contribution makes up nearly 35 per cent of all giving-Azim Premji, the Infosys founders, Rohini Nilekani, Shiv Nadar, the Kamath brothers, Subroto Bagchi and Sanjeev Bikhchandani are great examples of new age Philanthropists from the Tech

There's also a growing sensitivity to privilege among the younger generation of family donors and they are increasingly putting that privilege to work. Some of them are also carving out professional paths dedicated to philanthropy. However, despite the many positive trends in UHNI giving in India, challenges remain. First, there's an urgent need for India's UHNIs to increase the relative proportion of their giv-

2023 India Philanthropy

Report by Bain & Company indicates that excluding contributions from Wipro's founder Azim Premji, UHNI donations fell by 5 per cent in fiscal year 2022 even as their wealth increased by over 9 per cent. Also, when compared to their peers in the United States, the UK and China, Indian UHNIs contribute significantly less relative to their wealth, in some cases, giving is lower by as much as a 10x factor.

Second, philanthropic causes are becoming more diverse and varied, as some causes become more urgent like climate change and humanitarian crisis while traditional causes-education, healthcare, poverty alleviation and livelihoods-remain at the top of the agenda. Philanthropic capital is also increasingly being tapped to address newer and often neglected causes in India such as sports, arts and culture and mental health amongst many others. Therefore, prioritising and allocating appropriate philanthropic capital to causes becomes crucial.

Third, UHNIs need to engage themselves more in philanthropy by giving more time and effort. They also need to collaborate more with other philanthropists to pool their resources-money, time and effort-and take on more ambitious projects, create greater institutions and experiment with newer models to make a difference. They also need to experiment to see how technology can be leveraged to transform and scale services and service delivery in almost all areas, particularly in education, healthcare, skilling and climate change.

This transformation will also be aided by a new compact between the donor and the donee that is based on greater mutual respect and sees greater participation by all stakeholders in the decision-making processes for where, how and when resources get deployed and how the impact is measured. We can expect 2024 to be a milestone year for the philanthropic movement in India with More, Sooner and Better Giving than ever before. # Refrain from interfering in ongoing electoral process in JK: Mufti

Hours after the Union Home Minister Amit Shah returned to New Delhi after meeting several delegations including J&K unit Bharatiya Janta Party (BJP) leaders in Srinagar, Peoples Democratic Party (PDP) President Mehbooba Mufti Friday issued a formal appeal to the Union Government and the Home Minister to refrain from interfering in the ongoing electoral process in

Jammu and Kashmir. The surprise visit of Amit Shah ahead of the fifth phase of polling on May 20 raised many eyebrows in the valley. Speculations were also rife in the corridors of power over the agenda of the close-door meetings the Union Home Minister was scheduled to

chair during his brief stay. Meanwhile, Mehbooba Mufti while addressing campaign meetings called on the Union Government and the Home Minister to ensure that the elections in Jammu and Kashmir are conducted with the same fairness and integrity as in other regions of India. PDP chief also stressed the

need to avoid pre-poll rigging and to cease intimidating the electorate and officers involved in the election process. "Today, the situation is that the proxy parties of the BJP, which are coercing people, threatening people, and spending huge sums of money, are misinforming the Union Home Minister", Mehbooba alleged.

On his arrival in Srinagar late Thursday evening Shah met



several delegations including Gujjars, Bakerwals, Paharis

In the end, Shah met the BJP delegation and directed the party functionaries to ensure a healthy mobilization of voters in the next two rounds of polling on two Lok Sabha seats of Baramulla and Anantnag. While Baramulla goes to the

polls on May 20, voting for

the Anantnag-Rajouri con-stituency is scheduled for May 25 after it was deferred from its earlier schedule of May 7 due to bad weather. In the absence of a BJP candidate the Union Home Minister reportedly directed the party men to ensure that the vote of every single BJP worker, leader, and activist goes against NC, PDP, and

based BJP leader, Shah also clearly stated during the meeting that BJP will contest all seats of J&K in the upcoming Assembly polls slated in September this year.

Reflecting on past electoral issues, Mehbooba recalled the 1987 elections, where rigging undermined public trust in the democratic process. She warned that any repeat of such manipulation could have disastrous consequences similar to the violence and turmoil that followed the 1987 elections.

She criticized the BJP's proxy parties for using coercion, threats, and financial incentives to influence the election outcomes, particularly highlighting reports of the Union Home Minister's meetings with Pahari officers to sway parties.

During a series of roadshows in north Kashmir's Watrgam, Rafiabad, Kralgund, Poshpora, Trehgam, Kawari, Awoora, and several other areas, the PDP President said that the active participation of people in the elections is a strong message to New Delhi, opposing the August 2019 decision that revoked Jammu and Kashmir's special status. She pointed out the high levels of unemployment, exorbitant power tariffs, and overcrowded jails filled with Kashmiri youth as indicators of the prevailing misgovernance.

She asserted that voting is the most powerful tool available to the disenfranchised people of Jammu and Kashmir to challenge this misrule.

## Three cornered fight in Kerala for lone RS seat

Come July and the State will see three sitting members of Rajya Sabha retiring as they complete their six-year tenure. Elamarom Kareem, the Islamic face of the CPI(M), popularly addressed as Kareemikka, Jose K Mani of the Kerala Congress (Mani) faction and Binoy Viswam, intellectual and the global face of the CPI are retiring on 1

Based on the current strength of the Legislative Assembly, the LDF will be able to nominate two candidates while the third seat would go the UDF. The Congress has announced that the lone seat has been given to Muslim League. There is a big fight between the constituents of the LDF for the two seats, The CPI(M), the big brother, has declared that it will keep



one seat for its nominee leaving the third seat for the other constituents.

The CPI(M) wants to re nominate Kareemikka to the Rajya Sabha. Though he is a candidate from Kozhikode Lok Sabha constituency, chances of him winning the seat look bleak because he is pitted against the Congress strongman M K Raghavan who has endeared himself to the electorate. In the eventuality of Kareemikka losing from Kozhikode, he would be the automatic choice of the

CPI(M) for the Rajya Sabha seat as he has the backing of the powerful Muslim lobby in the

That leaves the lone remaining seat as the bone of contention between the CPI and the Kerala Congress (Mani). "It is important for Jose K Mani to get nominated as Rajya Sabha member because there is no possibility of him winning a direct election. He is not accustomed to fight an election suffering the scorching heat and mixing with the party workers belonging to the downtrodden

sections," said P C George, veteran Kerala Congress leader who switched over to BJP earlier this year. Jose K Mani, son of late K M Mani, former finance minister of Kerala and chairman of the Kerala Congress faction named after him lost the 2021 assembly election against Mani C Kappen, a former Kerala Congress leader from the former's home constituency of

Pala.

This led to Roshi Augustine, representative of the party getting sworn in as a minister in the Pinarayi Vijayan led Government. If Jose Mani does not get nominated, he will be left without any option to serve the people. For politicians in Kerala, a membership in parliament or legislative assembly is a must to serve the poor. But what bothers Mani Junior is the cold shouldering of him by Augustine.

The UDF of which the KCM was one of the constituents till the 2019 Lok Sabha election has sent feelers to Jose K Mani to return to their camp. But ingenious Roshi Augustine feels that this is a golden opportunity given to him by Saint Alphonsa of Bharananganam and it is cer-

tain that he would continue with the LDF leaving Jose K Mani high and dry.

The CPI is no mood to part with the seat which it claims to be its own. "Comrade Binoy Viswam's presence in New Delhi is a must as the global Communist movements look towards him more than anybody for guidance and directives in this era of turmoil. Moreover, he is a poet and intellectual of international repute which further strengthens the party's claim," said P Sujathan, author and political commentator.

Yet another claimant for the seat is RJD leader and planter M V Shreyams Kumar, who is also a major shareholder of a Malayalam daily. He has been singing paean to the chief minister through his newspaper. As on Friday, it is a three horse race for the lone June

**▼**ndia on Friday said a "narrow view" should not be taken on the long-term agreement between New Delhi and Tehran on the Chabahar port project as it would benefit landlocked Afghanistan, Central Asia and the entire region.

The remarks by Ministry of External Affairs spokesperson Randhir Jaiswal came days after the United States warned of sanctions following India and Iran sealing the deal. India and Iran on Monday signed a 10-year agreement that provided for Indian operations at the Chabahar port.

"India's commitment towards the Chabahar port is to realise its potential as a connectivity hub for Afghanistan and Central Asian countries, which are landlocked," Jaiswal said at his weekly media briefing. He said an Indian company India Ports Global Limited --

has been operating the port since 2018 on an interim lease. 'Now, we have concluded a long-term agreement which is essential for port operations," Jaiswal said.

Since then, we have provided humanitarian assistance, including 85,000 metric tons of wheat, 200 metric tons of pulses and 40,000 litres of pesticide Malathion, to Afghanistan through this port," he said. Located in the Sistan-Balochistan province on the energy-rich Iran's southern coast, the Chabahar port is being developed by India and Afghanistan to boost connectivity and trade ties.

## Fight of heavyweights in Sambalpur where farmers, weavers hold the key

Unemployment and distress sale of paddy are the pressing issues in Odisha's Sambalpur Lok Sabha constituency, where Union Dharmendra minister Pradhan of the BJP and influential BJD general secretary (organisation) Pranab Prakash Das are poised for a showdown. The candidates' attention is

squarely on farmers and weavers, who are crucial in a region that encompasses the catchment area of the Hirakud reservoir and has a thriving handloom industry. The majority of Sambalpur's population, concentrated in five of its seven assembly constituencies, relies either on agriculture or the harvesting of Kendu and Sal leaves for their livelihoods.

Pradhan, who is a Rajya Sabha MP from Bihar, is contesting elections after a gap of 15 years. He had last unsuccessfully contested assembly elec ons from Parlahara assembly segment in 2009.

Das, on the other hand, is the sitting MLA of Jajpur seat in the coastal region. He is known to be an influential

organiser of the party.
The prestigious Sambalpur parliamentary constituency was represented by the BID during its alliance with BJP three times in a row in 1998,



1999 and 2004.

In 2009, 2014 and 2019, however, voters of the constituency elected Congress, BJD and BJP candidates respectively. Pradhan, a resident of Talcher

town in Angul district and son of former Union minister Debendra Pradhan, has been a central minister since 2014 and is banking on the initiatives of the Union government to register a victory.

"We are optimistic that people will vote on the lotus symbol. The BJP-led Centre has established IIM Sambalpur and people are happy with the developmental work of the Union government," he said. Das, a three-term Jajpur MLA and son of former Janata Dal state president Ashok Dash, claimed that people love Chief Minister Naveen Patnaik and have been benefited from the BJD

governments' schemes for farmers, weavers, students, youths and women.

"The BJD government's Kalia scheme for farmers is very popular in this region," Das Although a total of 14 candidates are in the fray, the

contest is directly between Pradhan and Das. Congress has nominated former BJD MP and ex-

minister Nagendra Pradhan, who quit the ruling party in the state and joined the grand old party a few days before filing his nominations. The Congress had first named

Dulal Chandra Pradhan from the seat but later changed its candidate to Nagendra Pradhan, who had won from the constituency in 2014 on a BID ticket, after he joined the grand old party. Aggrieved by the party's decision, Dulal Chandra Pradhan later joined the BIP.

### Lalu's daughter seeks to wrest back her father's stronghold Saran

Acharya, 47, happens to be the sixth member of her family, and fourth among her siblings to enter politics, yet, in more than one respect, she stands out as an atypical politician.
Rudy, 62, had made his

debut in parliamentary elections in 1996 from Chhapra, as Saran was known before the 2008 delimitation. In 2004, Prasad wrested the seat in a contest marred by large-scale electoral violence that had necessitated a repoll in the entire constituency.

# In Mumbai North, Piyush challenges outsider tag against bhoomi putra Bhushan

As BJP leader Piyush Goyal faces the challenge of overcoming the "outsider" tag, Congress's Bhushan Patil is riding on the badge of being a "bhoomi putra" (son of the soil) in Mumbai North

Goyal is pitted in a straight fight with Patil for the May 20 election.

Shiv Sena (UBT) leader Sanjay Raut and Congress leader Varsha Gaikwad called Goyal an "outsider" earlier this month. Slamming the opposition

labelling him as an outsider, Goyal said, "There can be nobody more Mumbaikar than me." "That is a very ridiculous

argument. Not even worth responding to. I am a born Mumbaikar. Lived in Mumbai all my life, worked in Mumbai all my life," Goyal told PTI during a roadshow. The Rajya Sabha MP, who started his career as a chartered accountant, is the son of former BJP minister Vedprakash Goyal and Chandrakanta Goyal, threeterm BJP MLA from Matunga.

Goyal said he was born in Mumbai, studied in H R College and Government Law College, and started his Chartered Accountancy practice in Lalbaug and worked as an investment banker on Nepean Sea Road. banker on Nepean Sea Road. The opportunity of proving his salt as a Mumbaikar comes with the challenge of matching up to the big winning margin of 4.65 lakh votes recorded by BJP's Gopal Shetty in the last election. Of the 9.88 lakh votes polled in 2019, Shetty got 7.05 lakh while actor and Congress nominee Urmila Matondkar

polled 2.41 lakh. Meanwhile, Congress' Patil is

asserting his identity as a local resident and a "Maharashtrian" to garner maximum votes for his party. The Congress leader is also attempting to tap the BJP's traditional vote bank, the Gujarati community, by involving his wife, a Gujarati Jain, in his campaign.

Patil enjoys the support of Shiv Sena (UBT) leader Vinod Ghosalkar whose son, former corporator Abhishek Ghosalkar, was killed in Borivali earlier this year during a Facebook Live

Patil said he is a "bhoomi putra" (son of the soil) who would continue to live among his voters in Borivali and would be approachable 24x7 to resolve their grievances. Goyal's candidature was declared much earlier than that of Patil, so the BJP leader has had an early mover advantage, holding rallies and crisscrossing the constituency much before

## French police fatally shoot suspect in synagogue arson

 $F^{\text{rance's Interior Minister said}}_{\text{Friday that a man who was}}$  shot and killed by police after a suspected arson attack on a synagogue in the Normandy city of Rouen was an Algerian national who'd sought medical treatment in France and wasn't flagged as a suspected extrem-

he minister, Gerald Darmanin, praised the 25-year-old police officer who shot and killed the man, saying he will be decorated for his "extremely courageous, extremely professional" behavior faced with the suspected attacker who rushed at him with a kitchen knife early Friday after the blaze broke out at the

synagogue. Earlier the French police shot and killed the man armed with a knife and a metal bar who is suspected of having set fire to a synagogue in the Normandy city of Rouen early on Friday, the latest apparent act in a storm of antisemitism roiling France amid the Israel-Hamas war. Fire services were alerted early Friday morning to a blaze at the synagogue. Police officers who deployed discovered the man on the roof of the building, clutching the metal bar in one hand and the kitchen knife in the other, and smoke rising from the synagogue's windows, Rouen prosecutor Frederic Teillet said at a brief news conference.

He said the man hurled abuse

and threw the metal bar at the police before jumping off the roof and then running at one of the officers with his knife raised. The officer fired five shots, hitting the man four times, fatally wounding him, the prosecutor said. He said authorities are seeking to verify the man's identity. The prosecutor took no questions. Interior Minister Gerald Darmanin posted on the social media site X that the man was "clearly wanting to set fire to the city's synagogue."He congratulated officers for "their reactivity and their courage." Tensions and anger have grown in France over the Israel-Hamas war. Antisemitic acts have surged in the country, which has the largest Jewish and Muslim pop-

ulations in western Europe. Rouen Mayor Nicolas Mayer-Rossignol said the man is thought to have climbed onto a trash container and thrown "a sort of Molotov cocktail" inside the synagogue, starting a fire and causing "significant dam-

When the Jewish community is attacked, it's an attack on the national community, an attack on France, an attack on all

French citizens," he said.
"It's a fright for the whole nation," he added.

Photos taken inside the synagogue and seen by The Associated Press showed that walls and the ceiling were charred and blackened.

In Paris, Yonathan Arfi, head of the main French Jewish umbrella group, expressed fury at what he described as the "climate of terror" facing Jews in France. This week, a Paris memorial honoring people who distinguished themselves by helping to rescue Jews in France during the country's Nazi occupation in World War II was also attacked. defaced with painted blood-red

Slovak Prime Minister Robert Fico has undergone another operation two days after being shot multiple times and remains in serious condition, officials said Friday. Fico, 59, was attacked as he was greeting supporters after a government meeting in the former coal mining town of Handlova. A suspected assailant has been arrested.

Miriam Lapunikova, director of the University F D Roosevelt hospital in Banska Bystrica, where Fico was taken by helicopter after he was shot, said Fico underwent a CT scan and is currently awake and stable in an intensive care unit. She described his condition as "very serious."

She said the surgery removed dead tissues that had remained inside Fico's body.

"I think it will take several more days until we will definitely know the direction of the further development," Robert Kaliniak, the defense minister

Earlier Friday, the man charged with attempting to assassinate Fico was escorted by police to his home. Local media reported that it was part of a search for evidence.

Markiza, a Slovak television station, showed footage of the suspect being taken to his home in the town of Levice on Friday morning, and reported that police had seized a computer and some documents. Police did not comment.

Prosecutors have told police not to publicly identify the suspect or release other details about the case. The suspect's detention will be reviewed at a hearing Saturday at Slovakia's Specialized Criminal Court in Pezinok, outside the capital Bratislava.

Unconfirmed media reports suggested he was a 71-year-old retiree who was known as an amateur poet, and may have previously worked as a security guard at a mall in the country's southwest.

## Israel denies genocide charges Insists it's protecting Gaza civilians

I srael strongly denied charges of genocide on Friday, telling the United Nations' top court tit was doing everything it could to protect the civilian popula-tion during its military opera-tion in Gaza.

The International Court of Justice wrapped up a third round of hearings on emer-gency measures requested by South Africa, which says Israel's military incursion in the southern city of Rafah threatens the "very survival of Palestinians in Gaza" and has asked the court to order a cease-fire.

Tamar Kaplan-Tourgeman, one of Israel's legal team, defended the country's conduct, saying it had allowed in fuel and medication to the beleaguered enclave. "Israel takes extraordinary measures in order to minimise the harm to civilians in Gaza," she told The Haguebased court.

## Akshata's wealth rises in 2024 Rich List

British Prime Minister Rishi Sunak and wife Akshata Murty, who made their debut in the annual 'Sunday Times Rich List' two years ago, have moved up the ranks in the 2024 edition released on Friday thanks to the Murty's lucrative Infosys shareholding. The couple, both 44, have risen from 275th last year to 245th with an estimated wealth of GBP 651 million, making them the "wealthiest people to call 10 Downing Street home". Murty's earnings are said to far exceed that of her husband as financial statements published in February are quoted to say Sunak made GBP 2.2 million in 2022-23 compared to Murty's estimated GBP 13 million in dividends over the past year. "The couple's most valued asset is Murty's share-

holding in Infosys, a Bangalore-based IT company co-founded by Murty's father [Narayan Murthy]," reads the newspaper's analysis. "Over the past year, the shares have grown in value by GBP 108.8 million to nearly GBP 590 million.

The latest annual report suggests that Murty received about GBP 13 million in divabout GBP 13 million in dividends during that time—adding to the more than a million pounds she has been paid in previous years.

She is poised to receive another GBP 10.5 million

## Rishi Sunak and wife Vatican updates norms for evaluating US military: First aid Mary's vision to tackle internet hoaxes

rhe Vatican on Friday radi-Cally reformed its process for evaluating alleged visions of the Virgin Mary, weeping stat-ues and other seemingly supernatural phenomena, putting the brakes on making definitive declarations unless the event is obviously fabricated.

The Vatican's doctrine office overhauled norms first issued in 1978, arguing that they were no longer useful or viable in the internet age.

Nowadays, word about apparitions or weeping Madonnas travels quickly and can actually harm the faithful if hoaxers are trying to make money off people's beliefs or manipulate them, the Vatican said. The new norms make clear that such an abuse of people's faith can be punishable canonically, saying, "The use of purported supernatural experiences or recognised mystical elements as

a means of or a pretext for exerting control over people or carrying out abuses is to be considered of particular moral gravity".

The new norms reframe the Catholic Church's evaluation process by essentially taking off the table whether church authorities will declare a particular vision, stigmata or other seemingly divinely inspired event supernatural. Instead, the new criteria envisages six main outcomes, with the most favourable being that the church issues a noncommittal doctrinal green light, a so-called "nihil obstat".

Such a declaration means there is nothing about the event that is contrary to the faith, and therefore Catholics can express devotion to it.

The Catholic Church has had a long and controversial history of the faithful claiming to have had visions of the Virgin Mary, of statues purportedly weeping tears of blood and stig-mata erupting on hands and feet mimicking the wounds of

When confirmed as authentic by church authorities, these otherwise inexplicable signs have led to a flourishing of the faith, with new religious vocations and conversions. That has been the case for the purported apparitions of Mary that turned Fatima, Portugal, and Lourdes, France, into enormously popular pilgrimage destinations. Church figures who claimed to have experienced the stigmata wounds, including Padre Pio and Pope Francis' namesake, St. Francis of Assisi, have inspired millions of Catholics even if decisions about their authenticity have been elusive.

### Abu Dhabi opens first brewery as UAE relaxes alcohol laws importing almost everything

In 2018, Chad McGehee Opened Side Hustle Brews and Spirits, an Abu Dhabibranded brewery and distillery with funky camels on its cans and playful names familiar to anyone living in the United Arab Emirates. The only problem was it was illegal to produce alcohol in the country, so his company made its hoppy India pale ale in the United States and then imported it to the UAE for sale.That's all changed as Abu Dhabi has overhauled its laws to allow for the micro and craft breweries that have taken the rest of the world by storm, part of a wider reconsideration of alcohol policies in the Islamic nation increasingly drawing tourists. And McGehee's dream of IPAs



in Arabia became a reality though it took hard work as they were the first to open. "The government had created a regulation around fermentation, but the steps of getting a permit, the steps of inspection,

all of these things were not put on paper yet. So that had to be built out as we were going through this process," McGehee said on a recent afternoon at his brew pub on Abu Dhabi's Al Maryah Island. Abu Dhabi long has been considered by those living in the UAE to be more buttoned-up than the rambunctious neighbouring emirate of Dubai, home to night clubs, beach bars and pubs drawing tourists and residents to imbibe. In the seven emirates of the UAE, Sharjah outright bans the sale and consumption of alcohol, like neighbouring Saudi Arabia, as well as Iran and Kuwait. But beginning in 2020, Abu Dhabi changed its policies. It eliminated its licensing system

for alcohol purchases for drinkers to boost sales and tourism during the coronavirus pandemic. Eliminating the licenses allowed Muslims, if they chose, to drink, as well as decriminalised alcohol possession for those without a

"I think progression in this country is par for the course, they're always moving things forward," said Nadeem Selbak, one of the partners at Craft, which is Side Hustle's brew pub. The Emirates still maintains a strict no-tolerance policy on drunken driving and public intoxication. Islam also considers alcohol consumption as "haram", or forbidden. But alcohol sales long have been a major driver of tax revenue and a moneymaker for the UAE. Dubai Duty Free, for instance, sold 6 million cans of beer last year, as well as 3.8 million bottles of liquor and 2.3 million bottles of whiskey for thirsty travellers.

But despite that demand, there was no local equipment available to open a brewery in the UAE. McGehee ended up

for the brewery, nearly all of it coming from the US. Abu Dhabi represents a completely untapped market for Side Hustle. "The idea for me was like going back in time, when I started almost 20 years ago, said Mitchell Dougherty, Side Hustle's brewmaster.

At any given point, Craft has 14 beers on tap. So far this year they have brewed 34 and aim to reach up to 100 by the end of the year.

The names of the beers include some winking reminders of life in the UAE, including one called "Massage Card Ninja" a nod to business cards showing scantily clad women that appear under car windshield wipers in some Dubai neigh-

# India likely to lose Olympic boxing quota as WADA suspends Parveen for three whereabout failures

orld championship bronze medallist boxer Parveen Hooda is likely to lose her Paris Olympic quota after being suspended by World Anti-Doping Agency (WADA) for three whereabout failures in 12 months.

Parveen, who fetched an Olympic quota in the women's 57kg weight class during the Asian Games last year, failed to file her whereabouts in the period from April 2022 to March 2023 as per the WADA

"She has been suspended by WADA for 1.5 years. The suspension starts this month. It will go on till November 2025," Parveen's coach Sudhir Hooda told PTI.

Athletes included in the Registered Testing Pool (RTP) must provide full address for their overnight location, the name and full address of each location where they train, work or conduct other regular scheduled activities, as well as the usual time-frames of each

RTP athletes must also identify a 60-minute window and



location for each day of the quarter, during which they must be available for testing. Failure to comply with whereabouts and testing obligations will result in a

whereabouts failure. According to WADA rules,

"any combination of three whereabouts failures (filing failure and/or missed test) within a period of 12 months constitute an anti-doping rule violation, for which the applicable sanction is 2 years' ineligibility subject to a

reduction to a minimum of 1 year depending on your degree of fault."

Lawyer Vidushpat Singhania, who is handling Parveen's case, they correspondence with the International Testing Agency (ITA) and are pushing to get the sanction removed or shortened.

## Team captain, two other players arrested over alleged soccer match fixing in Australia

Australian professional soccer was rocked Friday by accusations that the captain of A-League club Macarthur FC paid two younger teammates up to 10,000 Australian dollars (\$6,600) to deliberately receive yellow cards in a scheme set up by a South American gambling connection.

The player were identified Macarthur team leader Ulises Davila and fellow players Kearyn Baccus and Clayton Lewis as the players arrested over their alleged involvement in the match-fixing scheme, which police say led to hundreds of thousands of dollars being paid out in winnings.

All three players were formally charged and granted bail on Friday afternoon, with Davila scheduled to appear in court on June 24.

Authorities still want to interview a fourth player allegedly involved in the scheme, threatening to extradite him if he does not return to New South Wales state to face questioning.

Investigators allege yellow cards were manipulated during games played on Nov. 24 and Dec. 9. They also allege unsuccessful attempts were made to do similar during matches on April 20 and May 4. Macarthur played out a 1-1 draw with Melbourne Victory on Nov. 24 before beating Sydney FC 2-0 on Dec. 9. All three players were given yellow cards in the Dec. 9 game

against Sydney.
The team beat Sydney 1-0 on
April 20 before being beaten 4-0 by Sydney FC in a playoff elimination game on May 4. Macarthur finished in fifth place during the regular season.

## My records not under threat for now: Usain Bolt

Usain Bolt is going to be back at the Olympics after eight years.

But competitors need not worry, the world's fastest man will be in Paris to merely watch the action and feel chuffed about his phenomenal records which, he believes, are "not under threat" in the foreseeable

In a telephonic interview with PTI from New York, where he is currently promoting next month's ICC T20 World Cup as its ambassador, Bolt spoke about life after retirement, the nagging itch to compete, especially when he watches his sport, and also a desire to visit India some time in future.

His superhuman effort of 9.58 seconds (100m) and 19.19 seconds (200m) at the 2009 World Championships in Berlin have not been threatened ever since.

"Well, for me, I don't think so. Not right now. I think there's a long way to go. You understand, I don't see anybody really break the record. So I think I still have a few more years to go (laughs)," said Bolt, the only sprinter to have won both the 100m and 200m gold medals in three consecutive Olympics..

"No, I don't think the world record will be under threat. For me, I'm watching what's going on now when it comes to the race, it's picking up a few times," he added. Five sprinters, including USA's Christian Miller and Kendal Williams (both 9.93), have hit the sub-10 second mark this season, but Bolt's time remains way out of reach. The fastest time in 200m this season was set by USA's Kenneth Bednarek (19.67).

"A few of them have run under 10 seconds. So I'm just observing now. I think by July we'll see who will be out in front and we can definitely see where the race will go. But for now, we're still just watching and see. The leads are progressing," said Jamaican, who has been nicknamed 'Lightening Bolt'.

Bolt is now a family man and varied commercial commitments continue to take him around the world but at times, he does miss the adrenaline rush of sprinting.

"Definitely, you know, it's been

good. I can't complain," he said when asked about life after retirement. "I try to stay busy. I have a family now so I try to... Figure out the time and stay home sometimes, spend some time with the family. But I do miss competition, especially when I watch it. "I know I'm going to be itching when I get to the Olympics this year. For me, that should be interesting. I'm also excited to be there first time to actually watch a championship. So that should be good," said the Olympic legend.

Among a host of track and field stars in Paris, Bolt is also keen to track the performance of India's path-breaking javelin thrower Neeraj Chopra, who in Tokyo, became the first Indian to win an Olympic gold in athletics.

Bolt too remembers that iconic moment for Indian sport. "Of course, of course," responded Bolt when asked if he was aware of Chopra and

his stellar achievements.

"When I saw that, the first thing I said, it must have been really exciting for him. So that's a big, big deal for a country. To win the Olympic gold medal, you know what I mean?

'He must have been proud of the work that he put in. Because I understand the effort and the time it takes to really work hard and to dedicate to your craft," he said.

Bolt last visited India close to a decade ago and hopes to return in the near future. "I know I have a lot of Indian

fans and I get a lot of tags (on social media) so I just want to say thanks for the support. I look forward to coming there

again in the near future. 'I've not been there in a while. So I'm excited to get a chance to come there and spend a lot more time than just a few days. So thanks for everything and just all love," added the legendary sprinter.

due to a knee injury she suffered during the Asian Championships last year and fears that putting her body under pressure so close to the Games may spoil her preparations.

"We have to be very, very careful with every little thing we do. We are cautious in every single step we take from here on. I have competed at a recent past, international events, nationals, trials and then the Qualifiers, so I am not required to be assessed on fitness through trials," Anshu told PTI from Tokyo where she is training these days.

"We need mental peace before the Olympics. Already two months is too less a period to prepare. At this stage, every single day counts. We plan our training on a weekly basis and if I am called to India for trials, it will disrupt plans and affect



"I also want to go to Europe for an international training camp from June 10 but I can't finalise that because of uncertainty around the trials. We need to strategise bouts with rivals but how will I do that if I prepare for the trials and not for the Olympics?" she asked.

The Wrestling Federation of India (WFI) has called its selection committee meeting on May 21 in Delhi to decide on the trials criteria. Nisha Dahiya (68kg) and

Reetika Hooda (76kg) are among the five women wrestlers who have secured

quotas for India. "I am still recovering from the weight-cut at the qualifiers, if again we undergo trials, it will affect our body. We have to complete with elite wrestlers and need to plan well, but if keep thinking about trials, how will we strategise," said Nisha, who trains at Satywan's akhada in Rohtak.

I will qualify in Istanbul. I am competing in 68kg for many years now, so I knew who my rivals could be and wrote down around 20-22 rivals, who I was expected to clash with and started watching their bouts. "I was well-prepared. I expected China to win, for me China is the strongest rival,
