EC shifts focus to urban voters today

A mid the sweltering heat and high-pitch political rhetorics and promises by contestants in the Fray, over 8.95 crore voters in 49 Parliament constituencies spread in Bihar, Jammu and Kashmir, Ladakh, Jharkhand, Maharashtra, Odisha, Uttar Pradesh, and West Bengal will cast their vote in the fifth phase of polling on Monday. On the eve of phase five of Lok Sabha polls, the Election Commission on Sunday pointed out that Mumbai, Thane and Lucknow have shown apathy towards voting in the past and asked these city dwellers to turnout in higher numbers.

Low turnout of voters is expected on Monday due to extreme heat wave conditions in some States including Bihar, Jharkhand, Odisha, Uttar Pradesh, and West Bengal.

The poll authority noted that in the past these cities have "suffered" from urban apathy in voting. "The Commission specially calls upon these city dwellers to erase the stigma by turning out in higher numbers," it said. So far, the last four phases have registered a voter turnout of 66.95 per cent.
On May 3 too, while referring to

voter turnout in phase two, the Commission had said it was "disappointed" with the turnout level in some metropolitan cities.

The EC had last month assembled many metro Commissioners here to work out a strategy fight urban apathy.

Sadhvi Niranjan Jyoti (from Fatehpur, UP) and Shantanu Thakur (Bangaon, WB); LJP (Ram Vilas) leader Chirag Paswan (Hajipur, Bihar), Shiv Sena's Shrikant Shinde (Kalyan, Maharashtra), and BJP's Rajiv Pratap Rudy and RJD president Lalu Prasad's daughter Rohini Acharya (both Saran, Bihar).

Uttar Pradesh, which sends the largest number of MPs to Parliament, will see 14 seats voting in the fifth phase with the fate of five Union Ministers at stake.

YouTube happy hunting ground for wildlife traffickers

In a crackdown on wildlife trafficking, the Wildlife Crime Control Bureau (WCCB) has removed 1,158 videos associated with the illegal trade, poaching, hunting, and cooking of protected animals, as YouTube becomes a favorite hub for tech-savvy wildlife smugglers. Sources in the WCCB said that this platform has been found to be facilitating the advertising and sale of contraband such as parakeets, rare turtles, and pangolins.

More such videos are under the scanner, said a senior official from the country's top wildlife crime control agency

Ministry. October 2023, India is the biggest market for YouTube with approximately 462 million active users followed by USA, Brazil and other countries.

Little wonder that many wildlife smugglers have started using this platform in a big way to earn easy money

Talking about the modus operandi, the official said that often, WCCB volunteers go over the comments for clues in the posts uploaded on the You Tube that may lead to the identity of potential buyers. Sometimes, it doesn't take much - buyers and sellers leave their numbers in comments.

"Till date in the last one year, WCCB has successfully around 1300 removed YouTube videos related to poaching, hunting, cooking and selling of wildlife on the basis of inputs shared by these Wildlife Cyber Warriors by

notice to YouTube Legal Support Team under Section 50(7) read with Section 52 of Wild Life (Protection) Act, 1972," said the WCCB official. The wildlife crime control body has also launched "WILD NET", a program designed to track and check illegal animal trading online. Any suspicious activity online would send alerts to enforcement agencies in the country. In 2019, TRAFFIC in

collaboration with the Union Environment Ministry had held a meeting with online platforms like Google, Facebook, YouTube and ecommerce sites like IndiaMart and Flipkart to ensure that their platforms are not used for trading protected species.

YouTube, in an official statement, said, "We take the safety of our online community very seriously. YouTube's policies prohibit graphic violence and animal abuse and we will quickly remove flagged content and terminate channels of repeat offenders."

INDI Alliance a union of anarchy, corruption and curfew: Yogi

s the parliamentary elec-A tion inches closer to the final phase, campaigning has gained momentum across the country despite the scorching heat. On Sunday, Uttar Pradesh Chief Minister tion inches closer to the Yogi Adityanath blasted a spectacular 'Superhit Six' of rallies for party candidates contesting from Azamgarh, Lalganj, Jaunpur, Pratapgarh, Phulpur and Allahabad Lok Sabha constituencies.

He urged people to defeat
Samajwadi Party and Congress,
which were opposed to Lord
Ram and closer to Ravana in
terms of deeds. He alleged that Congress and SP wanted to destroy Hindus. The chief minister mocked the SP, noting that 273 seats were needed to form the government, while the SP was contesting only 62-63 seats. He remarked that they won't be able to form the government, but would keep thumping their chests in the background.

Seeking support for Azamgarh MP and Bharatiya Janata Party candidate Dinesh Lal Yadav 'Nirahua', Chief Minister Yogi said that Azamgarh was considered a centre of terrorism

during the SP regime. He noted that Azamgarh used to be associated with terrorist blasts across the country, but there have been no such incidents in the last 10 years. He added: "We still have to give

a lot to Azamgarh and make it an 'industrial city'. Azamgarh will become the centre of Film City, from where many 'Nirahuas' and 'Amrapali

Dubeys' will emerge."
Criticising the SP, Chief Minister Yogi said that they were just visiting for a picnic and would head to England after the elections. He taunted that it is now the SP members, not Azamgarh, who are viewed with suspicion. "People believe that an SP supporter is likely to be a goon and a troublemaker, prompting searches to prevent potential trouble," he remarked. Chief Minister Yogi Adityanath said in the public meeting organised for Neelam Sonkar, the BJP candidate from Lalganj Lok Sabha constituency, in Phulpur Pawai, Azamgarh, that the INDI Alliance was a union of anarchy, corruption and imposing curfew.

The Samajwadi Party and Congress governments do not empathise with the poor, Dalits,

women and youth. Their sympathies lie with the mafia and terrorists," he said.

Chief Minister Yogi said that Pakistan was unable to protect its own country, with continuous agitation, chaos and arson in Pakistan-occupied-Kashmir. He urged voters to give Prime Minister Narendra Modi a third term, promising that PoK would become part of India. The chief minister also mentioned that "goon-mafia leaders are complaining about Yogiji's use of bulldozers". He assured that after the elections, the properties of the remaining goon-mafia would also be bulldozed.

Seeking support for BJP candidate Kripashankar Singh in Jaunpur, Chief Minister Yogi said that the demon of Ravana was still present in the form of SP and Congress and their actions resembled that of Ravana. "Lord Ram is not blessing them. Whatever Ram Lalla desires, is bound to happen and Ram Lalla has decided to hand over power to his devotee Modi for the third time," he stated.

The UP chief minister stated that the SP and mafia were closely connected and could



not be separated. He criticised the SP president for mourning the death of a notorious Purvanchal mafia leader. He vowed to eliminate Ram traitors, anti-India elements, and the mafia from Uttar Pradesh. The UP chief minister warned that the alliance between SP and Congress was a cause for concern, comparing it to a pair of troublemakers. He

assured that the BJP will not

allow property surveys, the imposition of the Jizya tax, or any changes to the reservations for backward classes, Scheduled Castes, and Scheduled Tribes. Addressing a public meeting in Rampur Khas in favour of Pratapgarh MP and BJP candidate Sangamlal Gupta, the chief minister said that more than 400 seats for the National Democratic Alliance were a must to make Pakistan-occu-

pied Kashmir a part of India. Congress and SP are becoming uncomfortable with slogans like 'Fir Ek Baar Modi Sarkaar', 'Abki Baar 400 Paar' as their goons in Prayagraj and Ghazipur have been reduced to dust. SP is a party friendly to terrorists," the chief minister said, adding that the INDI Alliance had no agenda of development. "Anyone who betrays Ram also

betrays the nation. They all share the same DNA, spreading anarchy and inciting riots like Tadka, Marich, and Subahu," he remarked.

Addressing a public meeting in Soraon in support of Phulpur MLA and BJP candidate Praveen Patel, Chief Minister Yogi stated that threats to the security of common people, daughters, businessmen, Dalits, and backward classes had been eradicated from Uttar Pradesh. While the state and country are pleased with this progress, the SP is mourning, he remarked. He criticised the SP's dark history, recounting an incident where the mafia killed a woman's husband from the Maurya family in Phulpur and seized 10 bighas of her land. He noted that their pleas were ignored until his administration restored their land.

He further accused SP chief Akhilesh Yadav of supporting the shooting of Ram devotees while simultaneously withdrawing cases against terrorists. By proposing an inheritance tax, he argued, Congress and SP have shown their intent to destroy Hindus by reviving the spirit of Aurangzeb. However, he assured that the

Bahujan Samajwadi Party chief Mayawati's nephew Akash Anand broke his silence on Sunday after ten days. He attacked the Congress along with targeting the Bharatiya Janata Party.

It is a coincidence that a day earlier Samajwadi Party chief Akhilesh Yadav had praised Akash Anand. On Sunday, Akash Anand kept silent on SP but attacked BJP and Congress. Mayawati had taken action against Akash Anand on May 7. Akash Anand remained completely silent for 48 hours after the action, but on May 9, while expressing his feelings on social media platform X, he praised his aunt and wrote:
"You are our unanimously accepted leader and your orders are acceptable to me. I will keep fighting for Bhim Mission and my society till my

Akash Anand was neither seen in any public event nor did he post anything on social media. Now, after ten days, his first post has come on X on Sunday. He reiterated the promises made by the Congress and appealed to vote for the party's candidate.

Rahul Gandhi said that "Narendra Modi has made 22 people billionaires. So now we are going to make crores of lakhpatis. A list of crores of people will be made. The name of one woman will be selected from every poor family. We will put one lakh rupees a year in the accounts of crores of women in a quick manner". Rahul said, "We are going to pay the farmers of India for their grains, sugarcane, cotton. We are going to give Rs 8,500 per month in the account of unemployed and graduate youths."

Union Home Minister Amit Shah on Sunday asserted Pakistan-occupied that Kashmir (PoK) belongs to India, and "we will take it back".

Shah was addressing an election rally in Prayagraj to seek votes for BJP candidate Neeraj Tripathi.

"Farooq Abdullah and Mani Shankar Aiyar say give respect to Pakistan because it has atom bomb... Rahul baba, today from the sacred land of Prayagraj I will say this PoK is ours, will remain ours, and we will take it back," he said while referring to Aiyar's atom bomb remark that has sparked a political row. Shah also said that the opposition alliance has been wiped out in the four phases of Lok Sabha polls.

"Four phases of polling have been completed. In these four phases, the INDI Alliance has been wiped out and Modi ji is rapidly moving towards crossing 400 (Lok Sabha seats)," he The main contest in Allahabad

is between BJP's Neeraj Tripathi, son of former Governor of West Bengal and Speaker of UP Legislative Assembly Keshari Nath Tripathi, and Ujjwal Ram Singh, son of former Samajwadi Party leader and Rajya Sabha MP Reoti Raman Singh.

UP ATS arrests ISI agent

 $T_{\text{Squad (ATS) of Uttar}}^{\text{he sleuths of the Anti-Terror}}$ Pradesh Police claimed to have arrested an agent of Pakistan's Inter-Services Intelligence who was leaking confidential and sensitive information and documents related to the Indian Navy to his Pakistani counterparts. According to an official communiqué, the UP ATS was receiving intelligence that under a conspiracy, agents of Pakistani intelligence agency ISI were obtaining confidential and sensitive information and documents related to the Indian Navy by luring Indian Navy employees and private persons working in shipyards under pseudo names. The ISI agents were luring them with money and sending money through various means.

When this intelligence was developed by the ATS, it came to light that Ram Singh, son of late Jai Singh and resident of village Ramvapur under Pipraich police station of Gorakhpur, was in contact with a Pakistani woman spy.

tinuously depositing money in Ram Singh's bank account and Ram Singh had provided money to the associates of Pakistani agents who were giving confidential information about the Indian Navy and Army to Pakistani agents. Ram Singh was arrested after interrogation on Sunday. During interroga-tion, Ram Singh disclosed that for almost three years he was in touch with the so-called Pakistani female spy, Kirti Kumari (pseudonym), through Facebook and WhatsApp. Ram Singh, as a part time worker at Goa Shipyard Naval base, used to work on applying insulation to Indian Navy's warships. Many Navy warships like INS Vikramaditya, INS Vikrant and others used to come to the shipyard. Ram Singh sent the photographs of Indian Navv's warships to the Pakistani agent. Kirti Kumari deposited a huge amount of money in Ram Singh's bank account and he transferred the deposited money to the bank accounts of agents working for ISI on the instructions of the Pakistani agent.

STF busts gang duping medical aspirants

Lucknow (PNS): With the arrest of two miscreants, a team of STF Uttar Pradesh claimed to have busted a gang involved in duping innocents for admissions in MBBS and other medical studies course at different medical colleges of country and abroad.

The accused identified as Sachin Mani Tripathi of Deoria and Shivanand Verma of Gudamba were arrested on a tip off from near Pharmacy Council Lekhraj Market on Saturday.

The team recovered Rs 22,000 in cash, a luxurious car, a smart watch and a heap of documents on adhaar card, PAN card, laptops, three mobile phones and counterfeited marksheets, certificates and degrees issued from different colleges.

As per reports, the STF was working on a gang involved in preparing fake certificates on D Pharma, B Pharma and academic marksheets/certificates which they used in facilitating admis-

sion to gullible in medical colleges of the country and in abroad.

On Saturday the team was tipped off about the presence of miscreants at a place near the pharmacy council office and a team laid the trap. Soon as the miscreants passed the trap, the team netted them.

They confessed to their crime and said they also extracted money from gullibles for facilitating them to open drug store or clinics ran by quacks. They disclosed that they were

members of a gang which was in this crime for a long time and their job was to trap the innocents and realise the money from them. They said some employees of Pharmacy Council of India were involved in the crime of fleecing innocents for admissions in medical courses including the MBBS.

They said one Hari Shanker of Bareilly used to prepare marksheet and certificates of D Pharma and B Pharma and get it attested with the help of Employee of Pharmacv Council of India and later this helped the 'customers' to get licenses for opening drug stores issued to them. They said Harishanker charged Rs 5 lakh for the above said work and gave them Rs 1 lakh only as their share.

Hamirpur, Banda, Fatehpur, Barabanki, Kaushambi, Faizabad, Kaiserganj and Gonda.

Each polling station should have at least the minimum necessary facilities available and there should be arrangements of shade for voters queuing up at the polling stations. He said there should be no disruption in power supply on the day of polling so that the voting process is not affected.

Furthermore, to protect people from heat stroke, each polling station should have paramedics and ASHA workers with enough ORS and medical kits available. The sector team should also have a paramedic available for use if needed. Additionally, all polling stations should have cool drinking water, toilets, and facilities like wheelchairs and chairs for the

elderly and disabled.

Groundbreaking research paper awarded

Agroundbreaking research paper titled 'Study on the Metallurgical Characteristics of Seasonal Goods Recovered from Bihar and Jharkhand in India' has been honoured as an outstanding paper at the Spring Academic Conference, 2024 held in Korean Institute of Metals and Materials. The prestigious award was presented by the institute's Chairman, Dr Ju Se-Don, highlighting the exceptional quality and significance of the research.

This remarkable study is a collaborative effort between researchers from India and South Korea, spearheaded by Dr Sachin Tiwary of the Department of AIHC and Archaeology at Banaras Hindu University (BHU) and Prof Nam-Cheol Jo of National Kongju University, Seoul, South Korea. The research team includes Ji-Su Shin (National Kongju University), Min-Soo Han (Korea National University of Cultural Heritage), Yong-Hyun Yoon (National Science Museum) and Yong-Jun Kim (Korea University). The research focuses on the ancient iron smelting techniques practiced in northern India, particularly in Bihar and Jharkhand. By analysing the metallurgical characteristics of artefacts from these regions, the study provides invaluable insights into the technological advancements and cultural practices of early iron-smelting communities. This project is part of the ongoing research granted under the scheme 'Potential Geoheritage of Eastern Kaimur: Insights

Archaeometallurgical Approach,' funded by the Scheme for Promoting Trans-Disciplinary Research in BHU under Institute of Eminence (IoE).

In January 2023 the research team visited BHU, where they collaborated with Dr Sachin Tiwary and Dr Virag G Sontakke to organise a workshop at the Indian Knowledge Systems (IKS) Centre of IIT- BHU. Dr V Ramanathan, the coordinator of the IKS Centre hosted the lecture there. The workshop, titled 'Scientific Research on Traditional Iron Smelting and Archaeological Materials of Early Iron Age in Northern India, gathered experts to explore the historical and scientific aspects of

ancient iron smelting.

During their visit, the team also studied the Asur tribe in Jharkhand, known for preserving ancient iron smelting techniques. The Asur tribe continues to practice traditional iron smelting on special occasions, offering a living link to historical methods and enriching the research context. This recognition underscores the importance of international collaboration and the profound impact of studying ancient technologies to understand human history and cultural heritage. The award highlights the dedication and innovative approach of the research team, setting a benchmark for future

CISF to take over counterterrorism role at Parliament as CRPF withdraws

m sonnel\,will\,take\,over\,the}$ complete counterterrorism and anti-sabotage security duties at the Parliament complex from Monday following the withdrawal of over 1,400 CRPF staff from the country's most important symbol of democracy, official sources said.

The parliament duty group (PDG) of the CRPF wound up its entire administrative and operational paraphernalia -vehicles, weapons and commandos -- from of the complex on Friday and its commander, a deputy inspector general (DIG)-rank officer, handed over all the security points in the complex to the incoming

CISF group, the sources said. A total of 3,317 Central Industrial Security Force (CISF) personnel are being inducted for securing both the old and new Parliament buildings and the associated structures in this complex located in central Delhi after the govern-

task from the CRPF following the December 13 security breach incident of last year, a senior officer told PTI. In a major security breach on

the anniversary of the 2001 Parliament terror attack, two persons jumped into the Lok Sabha chamber from the public gallery during Zero Hour on December 13, 2023, released yellow smoke from canisters and shouted slogans before being overpowered by MPs. Outside the Parliament premises around the same time that day, two other persons sprayed coloured smoke from canisters while shouting slogans. Following this incident, a com-

mittee under the chairmanship of CRPF DG was setup to look into the overall security issues of the Parliament complex and make suitable recommenda-

The CISF counterterrorism security unit will take over the full charge of the Parliament complex from 6 am on Monday, May 20, the officer



It has deployed its staff to guard all the flap entry gates of the complex, posted canine squads, fire fighting personnel along with fire tenders, manpower at CCTV monitoring control room and communication centre apart from the pass section, watch towers apart from specialists to undertake anti-sabotage checks and other operations at the Parliament complex, he said. With this, the CRPF PDG, Delhi Police (about 150 personnel) and the parliament security staff (PSS) who jointly secured the Parliament till now, stand withdrawn, a senior

CISF officer said.
He said the CISF personnel have been undertaking familiarisation exercise of the complex for the last 10 days and the men and women personnel of the force who will man reception areas have been given light blue full sleeved shirts and brown pants apart from safari suits as their new uniform. The first officer quoted above

expected to be merged with the six battalion strong VIP security wing of the CRPF, while the PSS staff could be tasked afresh for rendering security and protocol duties at other central government installations.

Some PSS staff could be retained for manning the lobbies of the house for marshal duties but a final decision is yet to be taken, he said. The CISF contingent, accord-

ing to sources, has been deployed on a temporary manner called the 'internal security duty pattern' and it is expect-ed that it will be granted a full-fledged sanction as new gov-ernment assumes office after the ongoing general elections,

Ladakh at receiving end for past ten years, alleges Congress

Aday before polling for the Ladakh Lok Sabha constituency, the Congress on Sunday alleged that over the last 10 years, the Union Territory has been at the receiving end of the Modi Government's "malicious and step-motherly treatment". Congress chief spokesman Jairam Ramesh said Ladakhis have been protesting in freezing temperatures over the lack of control over their land and water. the Modi government's Anyay Kaal - from complete apathy to malicious and step-motherly treatment".

"In August 2019, the Modi government stripped all representation from the people of Ladakh by downgrading them to a Union Territory without

a legislature," he said.
"The greed of the Modi Sarkar and its crony corporate friends is threatening Ladakh's fragile ecosystems. Corporates in sectors like mining have their eyes set on Ladakh's natural resources, and if the Modi Sarkar is allowed back into power, receiving end of the worst of there is nothing stopping taking away 26 out of 65

them from extracting wealth from the land and the people," Ramesh claimed.

The entire region is being "remote-controlled" from Delhi through a lieutenant governor, he alleged. 46th Antarctic Treaty Consultative Meeting to begin in Kochi from today

The 46th Antarctic Treaty Consultative Meeting begins in Kochi on Monday under the shadow of the Ukraine-Russia conflict, an issue that has been affecting the discussions for the past two years.

The 10-day deliberations among signatory nations to the Antarctic Treaty are expected to focus on collaboration between parties on research and exchanging information on plans for sustainable management of resources in the icy continent. Also on the agenda for the Antarctic Treaty Consultative Meeting (ATCM) is the development of a framework for regulating tourism in Antarctica, given the pris-tine and delicate nature of the continent, and applications by Belarus and Canada for consultative status at the deliberations.

The latest findings from the Global Burden of Disease Study (GBD) 2021, published in The Lancet, forecast that global life expectancy will increase by 4.9 years in males and 4.2 years in females between 2022 and 2050. Increases are expected to be

largest in countries where life expectancy is lower, contributing to a convergence of increased life expectancy across geographies.
The trend is largely driven by

public health measures that have prevented and improved survival rates from cardiovascular diseases, COVID-19, and a range of communicable, maternal, neonatal, and nutritional diseases (CMNNs), said the study.

It indicated that the ongoing shift in disease burden to non-communicable diseases (NCDs) – like cardiovascular diseases, cancer, chronic obstructive pulmonary disease, and diabetes - and exposure to NCD-associated risk factors - such as obesity, high blood pressure, non-optimal diet, and smoking - will have the greatest impact on disease burden of the next generation. As the disease burden continues to shift from CMNNs to NCDs and from years of life lost (YLLs) to years lived with disability (YLDs), more people are expected to live longer, but with more years spent in poor health.

Global life expectancy is forecasted to increase from 73.6 years of age in 2022 to 78.1 years of age in 2050 (a 4.5year increase).

Global healthy life expectancy (HALE) - the average number of years a person can expect to live in good health - will increase from 64.8 years in 2022 to 67.4 years in 2050 (a 2.6-year increase).



To come to these conclusions, the study forecasts cause-specific mortality; YLLs; YLDs; disability-adjusted life years (DALYs, or lost years of healthy life due to poor health and early death); life expectancy; and HALE from 2022 through 2050 for 204 countries and territories. "In addition to an increase in life expectancy overall, we have found that the disparity in life expectancy across geographies will lessen," said Dr. Chris Murray, Chair of Health Metrics Sciences at the University of Washington and Director of the Institute for Health Metrics Evaluation (IHME).

'This is an indicator that while health inequalities between the highest- and lowest-income regions will remain, the gaps are shrinking, with the biggest increases es anticipated in sub-Saharan Africa.

Dr. Murray added that the biggest opportunity to speed up reductions in the global disease burden is through policy interventions aimed to prevent and mitigate behavioral and metabolic risk likely) scenario."

This accompanying study found that the total number of years lost due to poor health and early death (measured in DALYs) attributable to metabolic risk factors has increased by 50% since 2000."

The study also puts forth various alternative scenarios to compare the potential health outcomes if different public health interventions could eliminate exposure to several key risk factor groups by 2050. "We forecast large differences in global DALY burden


between different alternative scenarios to see what is the most impactful on our overall life expectancy data and DALY forecasts," said Dr. Stein Emil Vollset, first author of the study who leads the GBD Collaborating Unit at the Norwegian Institute of Public Health.

"Globally, the forecasted effects are strongest for the 'Improved Behavioral and Metabolic Risks' scenario, with a 13.3% reduction in disease burden (number of DALYs) in 2050 compared with the 'Reference' (most

An intricate puzzle

Kejriwal aide's arrest sparks AAP-BJP war of words amid Maliwal's assault allegations

he alleged assault case involving former Delhi Commission for Women chief and AAP Rajya Sabha MP Swati Maliwal, in which she has named Chief Minister Arvind Kejriwal's PA Bibhav Kumar, keeps getting murky. The development came within days of Kejriwal's return to campaigning from Tihar Jail, where he had been incarcerated for his alleged role in the Delhi excise policy case. Now the arrest of Bibhav Kumar for the alleged assault has sparked a series of protests and political manoeuvres. The case centres around Maliwal who, interestingly, herself has been under scrutiny by the Anti-Corruption Bureau for alleged appointment irregularities in DCW. After first admitting to the assault, AAP now alleges that Maliwal was blackmailed with the fear of arrest in the case. Bibhav's arrest is linked to this ongoing investigation, adding fuel to an already volatile situation. In response to his aide's arrest, Kejriwal — accompanied by AAP MPs, MLAs and supporters — led a protest march to the BJP headquarters to show solidar-



ity with Bibhav and "expose" the BJP's political vendetta. In a video message to the Prime Minister, Kejriwal asked the latter to arrest all top AAP leaders at once instead of doing that one by one. Kejriwal also emphasised that the action against Bibhav and Maliwal were attempts to stifle AAP's efforts to combat corruption and improve governance. On the other hand, the BJP has asserted that the law against corruption is being followed diligently. Its leaders argue that investigation is a necessary step in ensuring transparency and accountability in public offices. Interestingly, the Congress has chosen to remain silent on this issue. This non-committal stance could be seen as a strate-

gic decision to avoid getting embroiled in the confrontation between AAP and BJP, both of whom are its political rivals in Delhi.

Timing is everything in politics; the cauldron is coming to a boil with less than a week to go for voting in Delhi on May 25. Meanwhile, the ongoing tussle between AAP and BJP is emblematic of the larger power struggle between the parties. This incident is likely to have ramifications beyond immediate political dynamics, potentially influencing voter perception and future elections. It would not be wise to assign motives to Maliwal at this point; besides, the case is now sub judice but one can safely say from experience that several of her past statements have been rather awkward. Once she tweeted she was a "proud daughter" and, on another occasion, said she was sexually abused by him when she was a child. The situation also brings to the fore issues of misuse of investigative agencies and the limits of political accountability. As both parties continue to trade barbs, the people of Delhi watch closely, hoping for resolutions that prioritise effective governance and justice over political expediency. As Buddha once said, three things cannot be hidden for long - sun, moon and the truth! We would know soon whether it was a political conspiracy or really a assault by her own party members!

India tactfully manages US-Iran tensions

As India forges a vital partnership with Iran through the Chabahar port agreement, it must adeptly balance its regional interests against the backdrop of American concerns

ran has had an unwarranted grip on the sensibilities of the US administrations, irrespective of their parti-san divide. The moment for the bilateral fracture in American imagination starts from the Iranian Revolution in 1979 and the subsequent US Embassy hostage drama. The wounded memory for the Iranians is deeper and traced to the CIA-aided coup against the popular Prime Minister, Mosaddegh, in 1953. Undoubtedly, the religious puritanism of Ayatollah Khomeini's regime after the revolution pitted it ideologically against the 'West', but the public memory of the US support to Saddam Hussein (later ousting him) in the decade-long Iran-Iraq war, is now conveniently forgotten by the duplicitous American regimes. Later, Americans linked Iran to 9/11 and the birthing of Al Qaida/ISIL, even though Iran didn't have anything to do with either. If anything, Iran and its proxies fought ISIL in Syrian-Iraqi swathes and were instrumental in decimating the same, though later the Americans killed the Iranian General Qasem Soleimani.

Because sectarian undercurrents and the chessboard of American 'allies' (Israel and Arab Sheikhdoms) have a checkmate from Iran and its proxies in Syria, Lebanon and Yemen - the unjustified demonizing of Iran continues. While countries like Saudi Arabia and Pakistan have contributed far more towards religious extremism and terror, they continue to receive American support, while the Iranians face crippling sanctions. Americans had unilaterally reneged on the Iran Nuclear Deal even when all other signatories i.e., P+1 countries and the UN watchdog agency IAEA (International Atomic Energy Agency) had confirmed that Iran had complied with all provisions. Pressure from Israel and Sheikdoms ensured that Iran continued getting conflated with everything going wrong in the Middle East, even if Iran did, or did not have any role in the same. While the Hamas group was supported by Iran (as indeed by Saudia Arabia and others, till recently), there is no credible evi-

Today, Biden is trying to outdo Donald Trump in 'taking on' the Iranians, with The White House issued a Statement, "Less than a week ago, Iran launched one of the largest missile and drone attacks the world has ever seen against Israel. Together with our allies and partners, the United States defended Israel. We helped defeat this attack. And today, we are holding


controls on Iran". The import of the same goes beyond the USA as it now seeks to potentially sanction any country dealing with Iran e.g., India, which has recently signed a 10-year contract to manage the strategic Chabahar port in Iran. This gateway to Afghanistan and Central Asian Republics bypasses Pakistani land routes, offers an invaluable Indian footprint on the other side of Pakistan (counters China-developed, Gwadar Port, in Pakistan) and strengthens Indian ties with the civilisational land of Iran. With the Taliban in Afghanistan tiring of Pakistan and the Iranians signing this deal, Delhi is justifiably excited about the evolved prospects of countering the Sino-Pakistani assertions in the

theatre. While India needs to maintain its relations with the US to countenance the Chinese threats, it also has its regional concerns which require de-hyphenation from US conas it has its own bilateral and regional imperatives that warrant 'strategic independence' in decision-making, as was done by buying Russian oil and maintaining cordial relations with Moscow, whilst nuancing concerns for

Ukraine. To be fair, the Americans have recognised the Indian positions and compulsions which are not aimed at diminishing the US interest, but only towards protecting its own, hence the restrain in actuality, even as the war of words persists. In any case, the Biden administration will be at its voluble worst and indulge in sabre-rattling (especially on matters about Iran) and therefore important to understand their compulsion of tonality.

It is with this backdrop that the Statement of the US official must be understood, when pressed about the Indian agreement with Iran, 'You've heard us say this in several instances, that any entity, anyone considering business deals with Iran, they need to be aware of the potential risk that they are opening themselves up to and the potential risk of sanctions". The Americans will say what they have to and the Indians will do what they have to, as cerns with Iran. India cannot it is a well-understood posibe a blind minion of the US tion on both sides. India's strategic equation with Iran is not designed to diminish the US interest.

Harnessing the potential of mind is the key to true happiness







In sharp contrast, in 2021-22, PSU employment reduced to 8.61 lakh. And it is gradually reducing. According to official statistics, employment in the organized sector is now a mere 8.34 per cent, of which the public sector accounts for 5.77 per cent and the private sector only 2.58 per cent in the total employment generated.

The Government's massive infra investment of Rs 11 lakh crore this fiscal may have added some jobs in the construction sector but these short-term jobs are not considered quality work. Apart from infra investments are subject to erosion in many ways, right from excess cost estimation to longer gestation.

So the promise of reservation is a dream. According to CMIE, employment in India increased by a mere 5.8 million till March 2023. An additional 119 million people were not added to the potential labour force during the same. ndia faces multitudes of challenges arising from different quarters. It is tempting to think of these problems as belonging to society, polity, economics etc. But essentially all problems have their roots in the mind of the human being and arise from a lack of adequate understanding of the self. The solutions therefore have to be both in the external and the internal domain. Let us look at the five major conflicts and challenges plaguing India. A vision for the future would involve constructively responding to these problems.

1. Climate Change It is well-established that climate change is an anthropogenic phenomenon. Ladakh

Close to 50% of all living species on the planet have gone extinct in the last 50 years. Most of it is because of violent human action. 100-1000 species go extinct every day. Also, this is 100 to 1000 times faster than the natural extinction rate.

As Indians and as humans, we can survive either physically or spiritually with the kind of carpet 'speciecide' we have launched against the entire planet. In its scale and brutality, it exceeds any act of violence the Earth has ever seen. It is especially lamentable to see that India, with its Ahimsa, is among the worst perpetrators of atrocities towards lifeforms. Be it meat exports, the expansion of the dairy industry, or the organised destruction of animal habitats through so-called developmental activities, it only augurs doom for

In the next 5 years, I wish to see direct and strong action on this front, which can only result from an arousal of public consciousness.

3. Education

Public statistics on the State of India's education portray the

deep waters that the country is in. There are startling revelations on the basic quantitative and linguistic abilities of school students, not to mention the unemployability of college passouts. Compared to the developed world and the mass of developing countries, this highlights the utter lack of importance that Indian society places on education. The problems of today can

have only spiritual solutions and we have kept the young population oblivious of spirituality. Our education has become very dangerously antilife. A human being is alive only if he can reflect and understand. There is a need to urgently ramp up the basic education infrastructure of the country and also to prioritize the integration of life education into the modern education system.

In the next $\dot{5}$ years, we need to see an education system that places deep emphasis on both Vidya(knowledge of the self) and Avidya (knowledge of the world).

4. Protection of rights of the marginalised communities

More than half of the world's wealth resides in the hands of less than 1% of individuals. The situation in India is no different. When national resources are commanded by just a few individuals, the outcome is that much of the world is plagued by poverty, even starvation. The glamorization of wealth and the promise of pleasure has made the middle classes disconnected and indifferent to the stark realities of the world.

In the next few years, the rights of the vulnerable sections must be defended in all ways - through education, legal frameworks and socioreligious reform.

5. Creative and dignified employment for the youth Work is not something that you can choose as per the prevailing norms in your academic institution family or community. I would want to see, in the next 5 years, the creation of an academic, social and economic environment that brings creative vocation to the youth, not just as a means of livelihood but as the fulfilment of life itself.

Former BJP sarpanch shot dead in Shopian

n ardent follower of Prime An ardent follower of Francisco and a former Bharatiya Janta Party (BJP) Sarpanch, who himself sowed seeds of peace and tranquillity and saw democracy flourishing in the areas which remained a 'hotbed of militancy', was shot dead from a close range by 'unidentified terrorists' inside his village home in the Heerpora area of Shopian late Saturday night. The deceased has been identified as Aijaz Ahmad Sheikh. Kochi Port turns green as LNG powered carrier sails across

The Vallarpadom Container Terminal at Kochi, one of the biggest ports in Asia "turned green" on Sunday as 365 meter long container career sailed into the jetty to unload giant containers. Airstrike kills 27 in central Gaza

n Israeli airstrike killed 27 An Israell arrentee Energy Apeople in central Gaza, mostly women and children, and fighting with Hamas raged across the north on Sunday as Israel's leaders aired divisions over who should govern Gaza after the war, now in its eighth month. Prime Minister Benjamin Netanyahu faces criticism from the two other members of his War Cabinet, with his main political rival. Benny Gantz, threatening to leave the government if a plan is not created by June 8 that includes an international administration for postwar Gaza. US national security adviser Jake Sullivan was expected to meet with Netanyahu and other Israeli leaders on Sunday to discuss an ambitious US plan for Saudi Arabia to recognise Israel and help the Palestinian Authority to govern Gaza in exchange for a path to eventual statehood.

Netanyahu opposes Palestinian statehood and has rejected those proposals, saying Israel will maintain openended security control over Gaza and partner with local

Palestinians reported more airstrikes and heavy fighting in northern Gaza, which has been largely isolated by Israeli troops for months and where the World Food Programme says a famine is underway. The Civil Defence said the strikes hit several homes near Kamal Adwan Hospital in Beit Lahiya, killing at least 10 people. Footage released by rescuers showed them trying to pull the body of a woman out of the rubble as explosions echo in the background. In the urban Jabaliva refugee camp nearby, residents reported a heavy wave of artillery and airstrikes. "The situation is very difficult," said Abdel-Kareem Radwan, 48. He said the whole eastern side has become a battle zone where the Israeli fighter jets "strike

Defence, said rescuers had recovered at least 150 bodies, more than half of them women and children, since Israel launched the operation in Jabaliya last week. He said around 300 homes have been completely destroyed. Israel launched its offensive after Hamas' Oct 7 attack, in which militants stormed into southern Israel, killing around 1,200 people, mostly civilians, and abducting some 250.

The war has killed at least 35,000 Palestinians, according to Gaza's Health Ministry, which doesn't distinguish between combatants and civilians. Around 80% of the population of 2.3 million Palestinians have been displaced within the territory, often multiple times.

"We need a decent life to live," said Reem Al-Bayed, who left Gaza City and is sheltering with thousands in the gritty coastal Muwasi camp in the south without basic facilities like wells. "All countries live a decent life except us." She gave herself a quick mouthful of bread before tearing the rest into pieces for half a dozen

Houthi rebels strike oil tanker in Red Sea with missile

Dubai (AP): Yemen's Houthi rebels hit an oil tanker in the Red Sea with a ballistic missile early on Saturday, damaging the Panama-flagged, Greek-owned vessel in their latest assault over the Israel-Hamas war in the Gaza Strip, officials said. Though the Houthis did not immediately claim the assault, it comes as they claimed to have shot down another US military's MQ-9 Reaper drone over Yemen and have launched other attacks on shipping, disrupting trade on a key maritime route leading to the Suez Canal and the Mediterranean Sea.

The attack around 1 a.m. struck the oil tanker Wind, which recently docked in Russia and was bound for China, the US military's Central Command said. Both China and Russia maintain ties over military equipment and oil to Iran, the Houthis' main benefactor.

The missile strike "caused flooding which resulted in the of loss propulsion and steering", Central Command said on the social platform X. "The crew of M/T Wind was able to restore propulsion and steering, and no casualties were reported. M/T Wind resumed its course under

its own power." The British military's United Kingdom Maritime Trade Operations centre and the private security firm Ambrey similarly acknowledged the attack earlier Saturday. Ambrey said it caused a fire aboard the Wind. It can take the Houthis hours or even days - to claim their attacks. The Houthis have launched attacks on shipping in the Red Sea and Gulf of Aden, demanding Israel ends the war in Gaza, which has killed more than 35,000 Palestinians there. The war began after Hamas-led militants attacked Israel on October 7, killing 1,200 people and taking some 250 others hostage. The Houthis have launched more than 50 attacks on shipping, seized one vessel and sunk another since November, according to the US Maritime Administration.

Helicopter carrying Iran pres crashes, rescue underway

Ahelicopter carrying Iranian President Ebrahim Raisi suffered a "hard landing" on Sunday, Iranian state media reported, without elaborating. Some began urging the public to pray for Raisi and the others on board as rescue crews sped through a misty, rural forest where his helicopter was believed to be. The likely crash comes as Iran

under Raisi and Supreme Leader Ayatollah Ali Khamenei launched an unprecedented drone-and-missile attack on Israel just last month and has enriched uranium closer than ever to weapons-grade levels. Meanwhile, Iran has faced years of mass protests against its Shiite theocracy over an ailing economy and women's rights making the moment that much more sensitive for Tehran and the future of the country as the Israel-Hamas war inflames the wider Middle East. Raisi was traveling in Iran's East Azerbaijan province. State TV said the incident happened near Jolfa, a city on the border with with the nation of Azerbaijan, some 600 kilometers (375 miles) northwest of the Iranian capital, Tehran. Later, state TV put it farther east near the village of Uzi, but details remained contradictory. Traveling with Raisi were Iran's Foreign Minister Hossein Amirabdollahian, the gover-

Neither IRNA nor state TV offered any information on Raisi's condition in the hours afterward. However, hard-liners urged the public to pray for him. State TV later aired images of the faithful praying at Imam Reza Shrine in the city of Mashhad, one of Shiite Islam's holiest sites, as well as in Qom and other locations across the country.

'The esteemed president and company were on their way back aboard some helicopters and one of the helicopters was forced to make a hard landing due to the bad weather and fog," Interior Minister Ahmad Vahidi said in comments aired on state TV. "Various rescue

teams are on their way to the region but because of the poor weather and fogginess it might take time for them to reach the helicopter."

He added: "The region is a bit (rugged) and it's difficult to make contact. We are waiting for rescue teams to reach the landing site and give us more

information."

Rescuers were attempting to reach the site, state TV said, but had been hampered by poor weather conditions. There had been heavy rain and fog reported with some wind. IRNA called the area a "forest" and the region is known to be mountainous as well. State TV aired images of SUVs racing through a wooded area.

A rescue helicopter tried to reach the area where authorities believe Raisi's helicopter was, but it couldn't land due to the heavy mist, emergency services spokesman Babak Yektaparast told IRNA.

Raisi had been on the border with Azerbaijan early Sunday to inaugurate a dam with Azerbaijan's President Ilham Alivey. The dam is the third one that the two nations built on the Aras River. The visit came despite chilly relations between the two nations, including over a gun attack on Azerbaijan's Embassy in Tehran in 2023, and Azerbaijan's diplomatic relations with Israel, which Iran's Shiite theocracy views as its main enemy in the region.

President Joe Biden's national security adviser met early Sunday with Saudi Arabia's Crown Prince Mohammed bin Salman to discuss what the kingdom described as the "semi-final" version of a wideranging security agreement between the countries.

The announcement by the state-run Saudi Press Agency comes as the strategic deal had been upended after Hamas' October 7 attack on Israel that killed 1,200 people and saw 250 others taken hostage back to the Gaza Strip.

In the time since, a punishing Israeli airstrike campaign and ground offensive there has killed over 35,000 Palestinians, endangering the security deal that had included Saudi Arabia diplomatically recognising Israel for the first time since its founding in 1948.

Saudi Arabia has long called for an independent Palestinian state to be created along Israel's 1967 borders, with east Ierusalem as its capital. However, that likely may be untenable for Israeli Prime Minister Benjamin Netanyahu, support from hard-liners who oppose a two-state solution and support Israeli settlements on lands Palestinians want for that state.

The White House had acknowledged Sullivan's trip and that he would later head on to Israel, where he's scheduled to meet Netanyahu on Sunday. However, there was no immediate statement from the US on the discussions, other than to say they would be "including the war in Gaza and ongoing efforts to achieve a lasting peace and security in the region."

Saudi Arabia has long relied like other Gulf Arab nations on the US to be the security guarantor for the wider Middle East as tensions over Iran's nuclear program in recent years have spilled over into a series of attacks. The proposal now being discussed likely would deepen that, and also reportedly includes access to advanced weapons and possibly trade

Slovak PM's condition serious

Slovakia's populist prime min-ister, Robert Fico, remained in serious condition on Sunday but has been given a positive prognosis four days after he was shot multiple times in an assassination attempt that has sent shockwaves across the deeply polarised European Union nation, the defence minister said. "The worst of what we feared has passed, at least for the moment. But his condition remains serious," Robert Kalinak told reporters outside the hospital where Fico is being treated. "His condition is stable with a positive prognosis." Kalinak added that the hospital

health status.

Fico, 59, was shot in the abdomen as he greeted supcultural centre in the town of Handlova, nearly 140 kilometres (85 miles) northeast of the capital, Bratislava. 
Kinshasa (AP): Congo's army says it has "foiled a coup" early Sunday morning and arrested the perpetrators, including several foreigners, following a shootout between armed men in military uniform and guards of a close ally of Congo's president that left three people dead in the capital, Kinshasa. At first, local media identified

the armed men as Congolese soldiers but then reported they were linked to self-exiled opposition leader Christian Malanga who later posted a video on Facebook threatening President Felix Tshisekedi. Tshisekedi was reelected as president in December in a chaotic vote amid calls for a revote from the opposition over what they said was a lack of transparency. The Central African country has witnessed similar trends of disputed elections in the past.

Congolese army spokesper-son Brigadier General Sylvain Ekenge said on state television Sunday that the around 4:30 am.

attempted coup d'état was "nipped in the bud by Congolese defence and security forces (and) the situation is under control." He did not give further details.

Musk launches Starlink in Indonesia

Elon Musk travelled to Indonesia's resort island of Bali on Sunday to launch Starlink satellite internet service in the world's largest archipelago nation. Wearing a green Batik shirt, Musk was greeted with a garland of flower petals at a community health clinic in Denpasar, the provincial capital of Bali, where he launched the Starlink service alongside Indonesian ministers.

Indonesia, a vast archipelago of 17,000 islands sprawled across three time zones with a population of more than 270 million, has been trying for years to secure deals with Musk's Tesla on battery investment and for Musk's SpaceX to provide fast internet for the country's remote regions.

During the ceremony, Musk took a speed test of the Starlink internet service with several health workers in Indonesia's remote regions, including in Aru, one of Indonesia's unserved and outermost islands in Maluku province. "This can make it really a lifesaver for remote medical clinics, and I think it could be a possibility for education as

well," Musk told reporters.
"If you can access the internet and then you can learn anything and you can also sell your business services worldwide. So, I think it's going to be incredibly beneficial," he said. He also signed an agreement on enhancing connectivity in the country's health and education sectors. Details about the agreement between the Indonesian government and Musk's SpaceX, the aerospace company that operates Starlink services, were not provided. Launching the service at a health clinic aligns with Starlink's broader mission of providing affordable access to

high-speed internet services, particularly in underserved and remote regions, said Coordinating Minister of Maritime and Investment Luhut Binsar Pandjaitan.

"Our remote regions need Starlink to expand high-speed internet services, especially to help with problems in the health, education and maritime sectors," Pandjaitan, a close ally of Indonesia's President Joko Widodo, told reporters. He held separate talks with Musk on Sunday.

Communication and Informatics Minister Budi Arie Setiadi said earlier that local internet providers, which rely on base transceiver stations to transmit signals, are unable to reach outer islands because they have limited coverage. Starlink's satellites, which remain in low orbit, will help them deliver faster internet with nationwide coverage. Health Minister Budi Gunadi Sadikin said of the more than 10,000 clinics across the country, there are still around 2,700 without internet access. "The internet can open up bet-

ter access to health services as communication between regions is said to be easier, so that reporting from health service facilities can be done in real time or up to date," he said. During his first in-person visit to Bali, Musk is also scheduled to participate in the 10th World Water Forum, which seeks to address global water and sanitation challenges.

KEEPING HYPERTENSION AT BAY

Hypertension or High Blood Pressure is on the rise, posing a significant public health challenge. Despite its prevalence, many cases go unnoticed and untreated with fatal risks. ARCHANA JYOTI highlights the urgent need for comprehensive measures to address this silent epidemic

orty-five-year-old Dhawan works a desk job with long hours and minimal physical activity. He has a highstress lifestyle, often skips meals, and when he eats, his diet consists mainly of fast food and highsodium snacks. He drinks several cups of coffee a day and smokes a pack of cigarettes daily. He feels his life is normal except that he experiences frequent headaches, occasional dizziness, and feels fatigued most of the time.

After a routine check-up, his doctor diagnosed him with hypertension. His blood pressure was consistently measured at

Prema Sharma(70) has a family history of hypertension. She has been managing her blood pressure for the past 20 years. She leads a relatively active lifestyle for her age, enjoys gardening, and walks her dog daily. However, she tends to indulge in salty snacks and has a sweet tooth.

Prema doesn't exhibit many overt symptoms due to her long-term management of the condition, but she occasionally experiences shortness of breath and mild swelling in her ankles. During her regular follow-up, her blood pressure was recorded at 160/100 mmHg, indicating controlled hypertension. poorly

Similarly, Naveen Shukla (28) who is a healthy young adult recently started experiencing frequent severe headaches and blurred vision. He has no family history of hypertension and maintains a balanced diet and regular exercise routine. Upon investigation, Naveen's blood pressure was found to be consistently high at 145/90 mmHg. Further tests revealed that he has a kidney condition causing secondary hypertension.

Doctors are increasingly noticing a large number of such cases of hypertension among diverse age groups. @These cases illustrate how hypertension can affect individuals differently based on their age, lifestyle, and underlying health conditions, highlighting the importance of personalized management plans,@ said Dr Tarun Kumar, Professor of Cardiology at Delhi-based central government RML Hospital. He rings alarm bell as he said, hypertension or high blood pressure leads to 10.8 per cent of all deaths in India. Left unchecked, hypertension can result in severe health issues such as heart attacks, strokes, kidney failure, and premature death.

Hypertension is defined as having systolic blood pressure (SPB) =140 mmHg or diastolic blood pressure (DPB) = 90 mmHg.


It is considered controlled when the systolic blood pressure (BP) is maintained below 140 mmHg and diastolic BP below 90 mmHg, with medications and lifestyle modifications.

Dr. Vivek Tandon, Additional Director of Interventional Cardiology at Fortis Hospital Greater Noida, too emphasized the need for increased awareness and accurate diagnosis. "Hypertension is a silent killer that affects a significant portion of the population, yet many remain

unaware of their condition." Dr Tandon cites studies that say that approximately 33% of urban residents suffer from hypertension, while about 25 per cent of the rural population is affected. Only 40 per cent of the urban population and 25 per cent of the rural population are aware of their hypertensive status.

Just 38 pe cent of the urban and 25 per cent of the rural population receive treatment. Among those treated, only 20 per cent in urban areas and 10 per cent in rural areas achieve adequate control, he said. "Accurate measurement and consistent management are vital in preventing the severe health consequences associated with high blood pressure," said Dr Tandon.

Dr Tarun agreed as he pointed out that even the theme of the World Hypertension Day on May 17, say 'Measure Your Blood Pressure Accurately, Control It, Live Longer. For instance, one should never check BP while crossed legs(it can adds 2-8 mm Hg), placing the cuff over your clothes (adds 5-50 mm Hg), unsupported arm (adds 10 mm Hg), using a small sized cuff (adds 2-10 mm Hg), unsupported back/feet (adds 6.5 mm Hg), talking during measuring BP (adds 10 mm Hg) and last but not the least with full bladder prior to measuring BP that can add up to 10 mm HG). The normal blood pressure is 120/80 mm/Hg or slightly lower.

Dr Tarun also said they recommend DASH (Dietary Approaches to Stop Hypertension (high blood pressure). The diet is

But by then, SRH just needed seven runs from 10 balls and Sanvir Singh sealed the issue with a four in the first ball of the final over.

Earlier Arshdeep gave SRH an early blow, cleaning up the dangerous Travis Head for a golden duck.

After losing a wicket of the first ball, SRH showed little sign of panic with Rahul Tripathi seizing the momentum in a 18-ball 33. Playing only his second match of the season, Tripathi took Rishi Dhawan to clearners


