sort of history will be created when the national Capital votes in Lithe Lok Sabha elections on Friday. Firstly, the voting will occur while the Delhi Chief Minister is out on interim bail after serving 50 days in judicial custody and is set to return to Tihar Jail on June 2. Secondly, it will be for the first time that Congress and AAP have united to challenge BJP's dominance in Delhi. In the last two Lok Sabha elections — 2014 and 2019 — the BJP retained all seven seats in Delhi.

So far there used to be a direct fight between the Congress and BJP with Aam Admi Party (AAP) being the third entrant but the 2024 general elections will give chance to the electorates to vote for BJP candidates or combined candidates of Congress and AAP. Interestingly AAP had dislodged the 15 years of Congress Government-led by late Sheila Dikshit on charges of corruption and the incumbent Kejriwal-led AAP Government is facing charges in multi-crore liquor scam. Since 2013, AAP has replaced Congress as a major political force in Delhi.

A total of 1.52 crore voters, including 82 lakh male and 69 lakh female voters as well as 1,228 third gender, are eligible to cast their votes at more than 13,000

# Poll preparations reach fever pitch

 $W^{\rm ith}$  urban apathy continuing through the first five rounds of polling, the Election Commission (EC) on Friday reminded urban voters of their right and duty to vote urging them to break this trend despite the extreme heatwave and high humidity.
Over 11.13 crore voters, including

5.29 crore women, will cast their votes for the 58 Parliamentary constituency seats in six States and Union Territories on Saturday.

The commission has called upon voters to turn out in greater numbers at polling stations and to vote with responsibility and pride. Voters of Parliamentary constituencies in urban centres like Delhi, Gurugram and Parliamentary Faridabad are specially reminded about their right and duty to vote and break the trend of urban

apathy.
After the five rounds of voting on May 20, the EC lamented the lower voter turnout in urban cities such as Mumbai, Thane, Jaipur, Lucknow, Chennai, Jhansi, Thiruvananthapuram, Howrah, and Madurai compared to the 2019 Lok Sabha elections, calling it

urban apathy.
An analysis of turnout shows that of the 409 seats where data can be compared with 2019, nearly two-thirds, or 258, have witnessed a lower percentage turnout this year and 88 (more than one in five) have seen even the absolute number of votes drop

from five years ago.
The EC had noted that in the past, these cities have 'suffered" from urban apathy as far as voting is concerned. On May 3 too, while referring to voter turnout in phase two, the commission had said it was "disappointed" with the turnout level in some metropolitan cities.

Last month, the EC assembled many

metro commissioners here to devise a strategy to combat voter apathy. Urban and youth apathy is described as a phenomenon when young voters and those living in metros fail to turn up at polling stations on the election

day.
Besides urban apathy, heatwave in poll bound States and UTs are major concerns to the authorities to improve voter turnout. According to the weather department, the maximum temperature is expected to be around 44 to 45 degrees Celsius which is likely to give feelings of over 50-52 degrees Celsius.

In a statement issued on Friday,



the poll panel said the India Meteorological Department has predicted "no adverse impact" of cyclone in poll-going constituencies. But it gave no details.

Polling for the Anantnag-Rajouri seat in Jammu and Kashmir will also be

held on Saturday. The election there was postponed from phase three to six due to logistical issues owing to adverse weather conditions. Among the key contestants are Dharmendra Pradhan from Sambalpur (Odisha), Manoj Tiwari (BJP) and Kanhaiya Kumar (Congress)

In the corresponding phase during the 2019 polls, a voter turnout of 64.16 per cent was recorded as 51 seats across seven States went to the polls. The Congress did not win even one of these 58 seats in the 2019 elections. In contrast, the BIP's stakes are high as it had won 40, securing a vote share of more than 40 per cent on 47 seats in the last elections. This clearly shows Congress doesn't have any strongholds in this phase. What makes this phase particularly interesting is that all seven seats in Delhi and all the 10 seats in Haryana will go to polls.

Of the 58 Parliamentary constituencies, the BJP has a stronghold in five, Biju Janata Dal on four, and Trinamool Congress on two. The BJP is a strong contender in 30 seats. This means the party won the seat at least twice in the last three elections.

There are six seats where the victory margin was more than 35 per cent in the 2019 election, and the BJP won all of them.

The other four seats with less than one per cent victory margin in the last election are Shrawasti in UP, Rohtak in Haryana, Sambalpur in Odisha, and

Ihargram in West Bengal. In West Bengal, voting will be held in the tribal belt JangalMahal region, spanning five districts. A hotspot for identity politics, the region sends eight representatives to Lok Sabha from Tamluk, Kanthi, Ghatal, Jhargram, Medinipur, Purulia, Bankura, and Bishnupur seats. Out of the eight seats, the BJP won five and TMC bagged three in the 2019 polls.

The seats going to the polls in Uttar Pradesh are Sultanpur, Pratapgarh, Phulpur, Allahabad, Ambedkar Nagar, Shrawasti, Domariyaganj, Basti, Sant Kabir Nagar, Lalganj, Azamgarh, Jaunpur, Machhlishahr and Bhadohi. From Sultanpur, BJP candidate Maneka Gandhi is seeking her ninth entry into the Lok Sabha.

The former Union Minister is up against the Samajwadi Party's Ram Bhual Nishad and the Bahujan Samaj Party's (BSP) Uday Raj Verma. In Azamgarh, incumbent MP Dinesh Lal Yadav Nirahua will be hoping to retain the seat for the BJP against the Samajwadi Party's Dharmendra Yadav.

# Youth offer a distinct outlook

During the election season, The Pioneer spoke with youngsters from various parts of the country, who flock to the national Capital, to study at the prestigious Delhi University. Filled with hopes and aspirations, these students express concerns that surprisingly dif-fer from those of their elders. Education, sports facilities, and rising communal tensions were the primary issues they want their Government to address. Moreover, unlike traditional responses, when asked about their favourite leaders, youngsters mentioned Minister of External Affairs S Jaishankar, Minister of Road, Transport, and Highways Nitin Gadkari, and Railway Minister Ashwini Vaishnaw." Ankit, a 20-year-old boy from Ramjas College, said he likes Jaishankar's personality and fearless attitude

Puja, a specially-abled 23-year-old girl from Prime Minister Narendra Modi's said while Varanasi developmental projects have taken place under the BJP's rule in her hometown, she would want places to be accessible for people like her. Elaborating on the development projects, she said, "Roads have been a lot better. Kashi corridor was a

really great project undertaken by Modi. The infrastructure of our primary level schools has become better and education of girls is being promoted by decreasing their fees." She also talked about steps she wants the Government, which coined the term divyang for

"As a woman I think while our society wants us to pursue our studies and work keeping us at par with men, the burden of home falls on us alone. I also feel that politics based on Hindu Muslim should be contained. Communalism in the country has gone up I believe."

# **Allahabad University Students' Union** a missing factor in LS polls

S tudent politics, which once formed a key element of any election in and around Prayagraj, is no longer an attraction.

The reason, many feel, is the Allahabad University discontinuing its students' union in 2018, citing a slew of violent events ahead of the university polls even though the demand for its revival comes

across groups.
The Allahabad University Students' Union (AUSU) was established in 1923 and it was actively involved in the Quit India Movement (1942) against the British rule so much so that the Empire even had the AUSU dissolved but it was revived again in 1945-46, Shyam Krishna Pandey noted in his book 'Youth's Initiative: Struggle and India's Freedom'.

Social activist and Allahabad High Court lawyer KK Roy, who led the Allahabad University Students' Union as the president from 1988 to 1991, said the AUSU worked like a primary school for future parliamentarians and to establish a permanent voice assessing the government of the day.

"Several youth organisations not only here but in other parts of North India established a culture of progressive vouth politics. Student politics is like primary school of democracy which produced politicians, thinkers, civil servants, journalists and luminaries in many other walks of life," Roy told PTI.

"But ever since 2014, all such institutions which voiced any opposition and criticism. were ended in the country

significant changes were brought in the labour laws also. The existence of students' union in Uttar Pradesh has been eliminated," the former student leader alleged. Roy recalled that students during that era felt familial relations with former prime ministers, particularly VP Singh and Chandra Shekhar, who even visited the university to meet them.

'The brunt of not having the students union is being bore by the youth. Today, unemployment is a major issue. Had the students union been there, then from 2017 to 2023, there would not have been paper leaks. The boys would have knocked on the doors of Lucknow's Vidhan Sabba and Delhi's Sabha and De Parliament," he added. Veteran Congress leader Abhay 'Baba' Awasthi, who

was the union's vice-president from 1988-91, said inflation, unemployment and corruption were today issues of discussion and not issues of voting, adding that these issues do not have any reflection on election and that is because of lack of any student politics. "It was a whole workshop on developing a thought, mobilising people and organising agitation on issues. When that idea was validated, it attracted youth for people's movements. Today when you see laws like Right to Information, Right to Education, these all are result of people's move-ments," Awasthi said.

The students' union had such an influence that Chandra Shekhar visited the university when he was the PM soon after his government was formed and assured the stulike trade unions and four dents of central support, he versity student and now asso-

Abhinav Mishra, a fourth

year BA LLB student at the university and associated with the RSS' student wing Akhil Bharatiya Vidyarthi Parishad (ABVP), said the student union was like a nursery not only for politics but also for comprehensive development of the students. "Student union provides the students with a platform through which they put forth their thoughts on any issue. Today, like we are here at the Allahabad University in Prayagraj, we can see there are several issues concerning the students that do not reach the management and it gets buried," Mishra said.

"Administrative arbitrariness peaks in places that do not have students' union and a live example of it can be seen here," he added.

Mishra said the student unions were very important as they helped not only the students but the entire country because when educated people entered politics and had some experience, it helped them work better.

The students' union here has been closed since 2018 and there is a state of no dialogue between the students and the university administration. Small issues like library should be opened 24 hours. A notification was issued that it will stay open till 9 pm, but right now the students are turned away at 6

pm only," Mishra said.
"Students grievances are not being heard and that is because they do not have any platform like the students' union which could take up such cause," he added. Sunil Mourya, a former uni-

ciated with Revolutionary Youth Association, the youth wing of CPI (Marxist-Leninist), said student politics was earlier known for producing leaders not only in Allahabad but across the country.

There are no student union elections largely in UP's universities, and its not only student groups, students but entire society has to bear its consequences because student unions had a role in expressing issues and leading movements. All this has stopped now since the students' union no longer exists," he said. Mourya said Prayagraj hosts a large number of youth and students who come here for education and unions have always taken up their cause to the extent that some student leaders even faced police cases and spent time behind bars.

"Had there been a student union, the administration would have to face its pressure over issues like unemployment and perhaps some students who died by suicide might not have taken the extreme step," he added. On impact of student politics in electoral politics, Mourya

said that earlier the parties kept an eye on youth leaders who could help them. "Student leaders used to be a force in Lok Sabha and

Vidhan Sabha candidates, they had a major influence on the society. All that has collapsed now," he added. Prayagraj, which is spread across two parliamentary con-

stituencies of Allahabad and Phulpur, goes to Lok Sabha polls on May 25. Both seats were won by the BJP in 2014 and 2019. The election results are due on June 4.

# Gangster sells his car from jail, probe on

In a strange case of how criminals are freely operating from jail, a gangster, Vikas Sinha, who is in jail in a case of forgery in Gorakhpur, sold his luxury car while in prison. Now in this entire investigation, along with the act of the gangster, the regional transport office is also under question. At present, the investigation of the case is still going

on. According to information, hospital operator Vikas Sinha was arrested by the police in October 2023 on charges of forgery and extortion. He had grabbed Rs 63 lakh from eight people. Victim Imtiaz's wife Shaiba had filed a complaint against him. As soon as he went to jail, the accused realised that the police could

confiscate his property. Even after going to jail, his forgery did not stop. In a hurry to avoid seizure, he sold his Fortuner car while he was

in jail. Shaiba has complained about this to Gorakhpur's Senior Superintendent of Police Dr Gaurav Grover. The SSP has handed over the investigation of the case to CO GIDA.

Now after many more facts have come to light, the police have sought information from the RTO. SSP Dr Gaurav Grover said that CO GIDA was investigating the entire case and action would be taken on the basis of investi-

# Nurse found dead in hotel room, family alleges rape, murder

A<sup>22</sup>-year-old nurse was found dead in a hotel room in Shahjahanpur, with her family alleging that she was raped and then strangled, police said on Friday. The body of the victim, who worked at a private hospital, was found inside the room by a hotel staff on Thursday evening, Superintendent of Police Ashok Kumar Meena said.

An FIR has been registered and the police are investigating the incident.

According to the FIR, the deceased arrived at the hotel room with Shubham Shukla, who later left the room.

"It has been alleged by the family members of the deceased that she was raped and then strangulated to death by Shubham Shukla. Based on the complaint, we have registered a case of murder (302 IPC) and rape (376 IPC) against Shukla," a senior police went missing late Thursday night. The villagers launched a hunt and found their bodies tered a case of murder (302

The body of the victim was sent for post-mortem. Three teams have been formed to arrest the accused, according to the police.

Meanwhile in another incident reported on Friday morning, two teenage lovers ended their lives. Their bodies were found hanging and both were holding each other's hand. When the villagers saw the bodies, they alerted the fami-

lies. As soon as the information was received, the police reached the spot. The police have gathered information by interrogating the family members.

The incident took place in Majra Trilokpur of Mudousi gram sabha under Kishani police station of Mainpuri. Ankit Kumar (20) son of Charan Singh Yadav and Nidhi (18) daughter of Indrapal Yadav, both local residents,

hanging from an acacia tree outside the village only on Friday morning.
The villagers claimed that the

love affair between the two was going on for about two years. The family members were also aware of this. The girl's family was not ready for marriage. The lovers had also put a story on Facebook at around 12 o'clock in the night on Thursday. It also has photos of both of them. Nidhi's family had gone to a hospital in Mainpuri as their elder daughter Madhu was in labour pain. Nidhi was alone in the house

Ankit returned home driving a tractor from somewhere in the night. After that, both of them committed suicide by hanging themselves from an acacia tree outside the village.

On receiving the information, Inspector-in-charge Anil Kumar Singh reached the spot along with a police team. The police brought down both the bodies and sent them for postIn Mathura, two teenagers and a woman died after they were hit by a train on Friday morning. Police reached the spot and

sent the bodies for post-

mortem. The incident happened near Bajna bridge on Mathura-Agra railway track. The victims could not be identified. Police said that they appeared to be mother and daughters and for some reason, they have committed suicide together. Efforts are being made to identify the

deceased. According to the gangman team working on the railway track, a woman and two teenagers came walking from Bhuteshwar. They stood on the track near pillar number 1402/5A ahead of Bajna bridge. At the same time a goods train came and all three were hit. The woman is about 35 years old. The age of one teenager is 12 years and the age of the other is about 14 years.

### 'Constitution never allows reservation on basis of religion'

Chief Minister Yogi Adityanath, on Friday, welcomed the decision of Calcutta High Court regarding OBC-Muslim reservation, saying that the Constitution of India never allows reservation on the basis of religion. ### DGP orders stern action against human trafficking, begging

PNS LUCKNOW

Strict action will be taken against the anti-social elements running human trafficking and begging rackets in the state. Director General of Police Prashant Kumar, in a circular on Friday, has instructed police officials to identify such criminal elements and take stern action against them.

In the instructions issued to the subordinates in this regard, the DGP said that attempts were often made to deploy children to clean the glass of vehicles and sell small items at the intersections. He said in many cases, it had come to light that these children were kidnapped in an organised manner and put to work like begging. "Taking incidents like human trafficking and kid-napping of children seriously,

disclosure, arrest and recovery should be made. Interrogation reports should be prepared under the leadership of gazetted officers, so that information can be obtained about the methods of such incidents, money trail, gangs etc. Hot spots of such incidents should be identified and CCTVs should be installed," the instructions say. The DGP said that the pattern

of incidents that happened in the last 10 years should be analysed. He said to stop child begging, the public should also be made aware along with taking cooperation from District Child Protection Unit, Child Line, NGOs, voluntary organisations etc. He said authorised voluntary organisations and individuals doing excellent work in preventing begging should be honoured.

Three drug peddlers of a gang active at international level were nabbed by a team of Special Task Force which was trailing the gang and its members.

# **Stage set for sixth phase** polling in UP today

ll arrangements are in A place to conduct free and fair elections in 14 Lok Sabha constituencies going to polls on Saturday in the sixth phase in Uttar Pradesh. Elaborate security is in place with around two lakh security personnel, including over 230 companies of Central forces, deployed on election duty for this phase.

The Elections Commission of India will hold the by-election to Gansadi assembly constituency in Balrampur district along with the polls in 14 Lok Sabha constituencies.

The 14 constituencies going to polls on Saturday in the sixth phase include Sultanpur, Pratapgarh, Phulpur, Allahabad, Ambedkar Nagar, Shravasti, Domariyaganj, Basti, Sant Kabir Nagar, Lalganj, Azamgarh, Jaunpur, Machhlishahr and Bhadohi. Uttar Pradesh's Chief Electoral Officer Navdeep Rinwa said here on Friday that elaborate arrangements were in place to conduct free and fair polls. He said polling parties had already started reaching their polling

- over 1.43 crore male and 1.27 crore female voters and 1,256 third gender voters - were expected to exercise their franchise in the sixth phase of polling. Sant Kabir Nagar has the highest number of voters and Allahabad the lowest.

To keep vigil on the voting, the ECI has deployed three special observers, 14 general observers, eight police observers and 18 expenditure observers. Besides, 2,192 sector magistrates, 282 zonal magistrates, 24 static magistrates and 2,833 micro observers have also been deployed.

Live webcasting has been arranged at more than 50 per cent of polling places (14,480 polling places) and it will be supervised at three levels – district election officer, chief electoral officer, and the Election Commission of India. Apart from the above, arrange-

ments for videography have also been made at 5,057 polling places. There are 162 candidates in the fray - 146 male and 16 female

candidates –in the sixth phase elections. In the sixth phase election, maximum 26 candidates are

contesting from Pratapgarh Lok Sabha constituency and lowest six candidates in Domariyaganj. For the sixth phase polling, 17,113 polling stations have been set up. The number of polling booths is 28,171 of which 3,978 booths have been identified as critical. In Sultanpur, the electoral contest features Maneka Gandhi from the Bharatiya Janata Party, Bhim Nishad representing the Samajwadi Party and Udiraj Verma. Pratapgarh witnesses a

The Azamgarh Lok Sabha constituency in Uttar Pradesh has a unique electoral dynamic, prominently featuring an alliance between Muslims and Yadavs, known as the M-Y combination. This alliance has been a winning formula in 17 out of the last 20 elections held in this constituency, underscoring its effectiveness in the region.

candidate from Gorakhpur constituency Ravi Kishan is also seen.

In the current election, scheduled for May 25, this proven strategy is again at play. Two Yadav candidates are the primary contenders: Bharatiya Janata Party's Dinesh Lal Yadav, popularly known as Nirahua, and Samajwadi Party's Dharmendra Yadav, cousin of SP chief Akhilesh Yadav. Adding to the competition, the Bahujan Samaj Party has fielded Mashood Ahmed, making it a triangular contest among nine candidates. Yadav. In the previous by-election, Guddu Jamali's significant vote bank played a crucial role in the outcome. This time, his support for the SP could disrupt BJP's calculations. Meanwhile, BSP's Mashood Ahmed aims to attract both Muslim voters and the

BSP's traditional vote base. for its literary figures like The Azamgarh Lok Sabha constituency, after the 2009 delimitation, includes Azamgarh Sanskrityayan and Kaifi Azmi, Sadar, Gopalpur, Sagdi, has also faced infamy for its Mubarakpur and Mehnagar

assembly segments, all currently represented by SP MLAs. Despite the strong BJP wave in other parts of Uttar Pradesh, the M-Y alliance helped the SP win all ten assembly seats in Azamgarh in the 2022 elections. The district is divided into two Lok Sabha constituencies -Azamgarh and Lalganj.

Historically, the Congress was a dominant force in Azamgarh until 1984, after which the rise of 'Mandal-Kamandal' politics shifted the landscape. The BSP first won this seat in 1989, followed by a series of victories for the SP and BSP until the BJP's breakthrough in 2009. Mulavam Singh Yadav reclaimed the seat for the SP in 2014, and his son Akhilesh Yadav won it in 2019 before vacating it, leading to Nirahua's victory in the subsequent by-election.

Unemployment remains a significant issue in this election. Both Akhilesh Yadav and Nirahua have made notable contributions to the district's development.

The constituency's caste demographics include 24 per cent Dalits, 20 per cent Yadavs and 12 per cent Muslims.

"Loud speeches and abundance of lies, this is how the Modi government was for 10 years", he alleged while talking to reporters at party's election office here on Friday, along with chief of UPCC media department and former minister Dr CP Rai, AICC media coordinator Garima Mehra Dasouni, state spokespersons Sanjeev Singh and Shailendra Kumar Singh, Abhimanyu Tyagi, Rahul Rajbhar and Dr Nripendra Narayan Singh. "Ten years ago, when Modi (the PM) came to Varanasi to contest his first election in 2014, his first sentence was that Maa Ganga has called him, making big promises of cleaning Ganga river. Then Modi claimed that he

would convert Kashi into Kvoto and build a port in Varanasi which would provide employment to thousands of people," Dubey said adding that all these claims of the PM proved

Varanasi on Friday The Congress spokesman further said the PM adopted many villages under the Adarsh Sansad Gram Yoiana and made many 'lofty' promises like providing water, roads, toilets, housing to all etc there but their condition themselves reveal the reality. "Now after 10 years as Modi is again contesting elections from Varanasi so the people should

know the gap between promises and reality of the PM", he said. According to him, to convert Kashi into Kyoto, the PM visited Japan in August-September 2014, where a Partner City Affiliation Agreement was signed between Kashi and Kyoto with the Government of Japan in which claims were made to beautify the art, culture, education and heritage of Kashi and to modernise the city. "It was said that with the help of Japanese experts and technology for water, waste and traffic management and sewerage system, Kashi will be transformed into Kyoto", Dubey said and added that the Modi government made a lot of headlines in the name of converting Kashi into Kyoto but now it is surprising that the PM does not even take the name of Kyoto. "Recently, the Allahabad High Court has made serious comments on the BJP government regarding the cleaning of Ganga. Even before

this, the Supreme Court had made a serious comment saving that not even a drop of Ganga has been cleaned, he said, adding that before the last Magh Mela, the government itself told the court that 40 per cent of sewer water is still released directly into the Ganga. According to him, when recently some journalists visited the villages adopted by the PM, they found that the people of the villages were facing drinking water crisis and many of them have no roof on their houses and after the publication of the report, the local body officials constituted an inquiry committee in this direction. "The unfortunate thing is that the PM increased the MNREGA wages in Uttar Pradesh from ₹230 to ₹237 whereas the Parliamentary Committee had asked to increase it to ₹375 per day", Dubey said, adding that the Congress has promised to give ₹400 per day in its Nyay Patra.

The Ministry of External Affairs (MEA) has served pended JD(S) MP Prajwal Revanna asking why his diplomatic passport should not be cancelled as sought by the Karnataka government in view of allegations of sexual abuse against him, it was learnt here on Friday.
Official sources on Thursday

had said the MEA is processing the Karnataka govern-ment's request to cancel Prajwal's diplomatic passport. Currently, he is believed to be in Germany.

The show-cause notice has been served on Prajwal as part of the process initiated to cancel his passport, they said. It is learnt that the show-cause notice was served through

Prajwal, the grandson of former prime minister H D Deve Gowda, is at the centre of a mass sexual abuse case and the Hassan MP left India on April 27, a day after voting for the Lok Sabha elections took place in his constituency.

The MEA is undertaking the process to cancel Prajwal's diplomatic passport under the provisions of the Passports Act of 1967 as well

If the passport is cancelled, then Prajwal's stay abroad will be illegal and he may face legal action by concerned authorities in the country he is staying, a person familiar with the matter said.

On Wednesday, Karnataka Chief Minister Siddaramaiah wrote a second letter to Prime Minister Narendra Modi urging him to take "prompt and necessary" actions to cancel Prajwal's diplomatic passport. The chief minister sent a similar letter to the prime minister on May 1.

Nikkei Asia Future of Asia Forum, he said the challenge of supply chain and the use of economic coercion by states have put a premium on resilience, in comments that came amid China's attempt to become an economic hegemon. Jaishankar said the world is undergoing a flux, driven by geopolitical, geo-economic and geo-technological developments and that the global order today is visibly under stress, with Asia and the Indo-Pacific very much part of this transformation.

"But it is not just change we are seeing; there is also much greater risk-taking. It is visible in the conflict in Ukraine, in violence in the Middle East and the disregard for international law and agreements in Asia and the Indo-Pacific," he said. This has economic facets, per-

The Indian students, particularly those from Kashmir in Kyrgyzstan's capital city, Bishkek, were "caught unaware of the mob violence" and are "desperate to return home", it

"Given the gravity of the situing the safety and well-being of our fellow citizens, we earnestly request the Ministry of External Affairs to take immediate steps to facilitate the evacuation of Indian students stranded in Kyrgyzstan. Their safe return home should be a priority to prevent any further distress or potential harm," the letter said.

"We trust in the prompt and decisive action of the Ministry in safeguarding the interests and security of Indian citizens Jammu and Kashmir in Kyrgyzstan. We request that

proactive measures be taken immediately to ensure the wellbeing of these students," it added.

# India would have progressed at much faster pace had borders been more secure: NSA Doval

National Security Advisor (NSA)Ajit Doval said here on Friday India would have progressed at a much faster pace if its borders had been more secure, defined and not in "adversarial dispossession.' He also underlined that the country's power has grown immensely in the last 10 years. Delivering the Rustamji Memorial Lecture organised by the Border Security Force (BSF) on its 21st investiture ceremony, Doval said India's economic progress would have been much faster if "we had more secure borders".

"In the foreseeable future, I don't think our borders are going to be as secure as we will require for our fast economic growth. So, the responsibility on border guarding forces has have got to remain on alert 24X7 in perpetuity. They have got to see that our national interests and country are protected," he said.

Borders are important because that is the limit which "defines our sovereignty", he said. "Jameen par jo kabja hai wo apna hai, baki to sab adalat aur kachehri ka kaam hai, usse farak nahi padta (The land which is in our possession is ours, the rest is the matter of courts and that is immaterial),"

# Its criticism of Agnipath scheme within MCC: Congress

Days after the Election Commission (EC) asked the Congress not to "politicise" the armed forces, the party Friday said its criticism of the Agnipath military recruitment scheme was within the Model Code of Conduct, and alleged that Prime Minister Narendra Modi was "taking the support" of the poll watchdog.

Congress' ex-Servicemen Department chief Colonel (refired) Rohit Chaudhry said the model code states that the "criticism of other political parties when made shall be confined to their policies, programmes, past records and work". The armed forces are doing a great job in protecting the country, and the Congress was only talking about the policy of the government when it made statements on the Agnipath scheme, Chaudhry told a press conference at the

AICC headquarters here. He said the Modi government has weakened the army by introducing the Agnipath scheme. "We are challenging the scheme which is not in the interest of the country, the

army and the soldiers.' Chaudhry said the Election Commission has written to retain 25 per cent of them for Congress President 15 more years.

Mallikarjun Kharge that the party's star campaigners should not talk about the operational matters of the defense

"Whenever Modiji gets into trouble, he looks for some support. Earlier, he used to hide behind the defence forces. Now he is taking the support of the Election Commission,' the Congress leader said. "If our government is formed, the Agnipath scheme will be scrapped." This scheme has created discrimination in the Army and is also weakening the security of the country, Chaudhry alleged.

The EC has asked the party not to politicise defence forces and make potentially divisive statements regarding the socioeconomic composition of the armed forces. The Commission was referring to remarks made by top Congress leaders on the Agnipath scheme.

The government rolled out the Agnipath recruitment scheme in June 2022 for short-term induction of personnel with an aim to bring down the age pro-file of the three services. It provides for recruiting youngsters between the age bracket of 17-and-half years and 21 for four years with a provision to

# At least 20 per cent cancer patients in India below age of 40, says study

Indicating a significant rise in cancer diagnoses among the younger generation in the country, a study has said at least 20 per cent of cancer cases in the country are detected in patients below the age of 40 years, with 60 per cent being male and 40 per cent female.

The study was conducted by the Cancer Mukt Bharat Foundation's National Cancer across 1368 cancer patients who reached out to the Cancer Helpline Number. It pointed out that this shift in demographics mirrors a global trend highlighted by the American Cancer Society, showing a rising number of cancer diagnoses among middle-aged individuals.

The study also sheds light on the prevalence of different cancer types, with head and neck cancer being the most common (26 per cent), followed by GI cancers (16 per cent), breast cancer (15 per cent), and blood cancers (9 per cent).

Alarmingly, 63 per cent of cases are diagnosed in stage 3 or 4, underlining the urgent need for early detection and intervention.



The launch of the National Cancer Helpline Number, offering free consultations with leading oncologists, has emerged as a crucial support system for cancer patients across India, said Dr. Ashish Gupta, Principal Investigator of the Cancer Mukt Bharat Campaign.

He emphasised on the importance of education and early detection in combating cancer. Lifestyle modifications, vaccinations, and regular screenings are vital in preventing and detecting cancer at an early stage, he added. The study also highlighted the

diverse treatment landscape in India, with 67% of patients seeking treatment from private hospitals and 33% from government hospitals. This inclusive approach ensures that patients from all socioeconomic backgrounds have access to crucial support and guidance.

Dr. Gupta underscored the need for lifestyle changes to curb the rising cancer rates, emphasizing the importance of a healthy lifestyle, avoiding tobacco and alcohol, and promoting physical activity. According to reports, in 2020, India reported an estimated 1.39 million cases of cancer which rose to 1.42 million and 1.46 million in the years 2021 and 2022, respectively.

Studies have estimated a 12.8 per cent increase in the number of annual cancer cases by the year 2025, which would be around 1.57 million.

# of lives globally, says Lancet study

Antimicrobial resistance (AMR) threatens millions of lives annually, with bacterial infections claiming one in every eight global deaths, said a study published in The Lancet, painting a grim picture of a world where 50 lakh lives are lost each year due to bacteria resistant to antibiotics. It said up to 7.5 lakh AMRrelated deaths annually in low middle income countries could be prevented by improving infection prevention measures, including hand hygiene, sanitation, and vaccination, said the authors and have called for support in providing sustainable access to antibiotics to be central to ambitious and actionable targets for tackling

"Access to effective antibiotics is essential to patients worldwide. A failure to provide these antibiotics puts us at risk for not meeting the UN sustainable development goals on child survival and health ageing," said series co-author, Iruka Okeke of the University of Ibadan, Nigeria. Okeke said that effective

antibiotics prolong lives, reduce disabilities, limit healthcare costs and enable other lifesaving medical actions such as



"However, antimicrobial resistance is on the rise - accelerated by inappropriate use of antibiotics during the COVID-19 pandemic - threatening the backbone of modern medicine and already leading to deaths and disease which would have once been prevented," said Okeke.

Existing infection prevention methods can prevent AMRassociated deaths, according to modelling analysis undertaken for putting together the series

of papers.
Up to 3.37 lakh deaths a year could be saved by improving infection prevention and control in healthcare facilities while around 2.5 lakh deaths could be avoided yearly by providing universal access to safe drinking water and effective sanitation in community set-

Further, 1.82 lakh deaths a year could be saved by expanding the rollout of some paediatric vaccines, such as pneumococ-cal vaccines which help protect against pneumonia and meningitis, along with introducing new ones, such as RSV vaccines for pregnant women, the researchers found. "Our findings highlight how

public health actions to prevent infections in the first place should be prioritised as a strategy to tackle AMR as these methods have the potential to drastically reduce the number of deaths from AMR-associated infections," said co-author Yewande Alimi of Africa Centres for Disease Control and Prevention (CDC). "If we can focus on improving

infection control methods, water and sanitation and vaccination in LMICs then it should be possible to reduce the number of deaths linked with AMR by 10 per cent by 2030," said Alimi. Along with preventing infections in the first place, the authors also looked at evi-

dence for preventing resistance emerging in bacteria.

Antibiotic stewardship (reducing the use of antibiotics when the benefit to patients is limited) is thought to reduce the selection pressure on bacteria to develop resistance, however, there is a lack of research in

# Market's thumbs-up

t is not every day that the market breaches new records just days ahead of the Lok Sabha poll results. Both Sensex and Nifty are shooting northwards, especially since the Reserve Bank of India (RBI) declared a huge dividend bonanza for the Government. # Ambedkar's warning on democracy rings true

India backslides on global democracy indexes and exhibits resistance to internal party democracy, starkly contrasting with the political culture of the UK

∎n 1936, Dr BR Ambedkar wrote an undelivered speech, Annihilation of Caste, where he forewarned, Constitutional morality is not a natural sentiment. It has to be cultivated. We must realise that our people have yet to learn it. Democracy in India is only a topdressing on an Indian soil which is essentially undemocratic." This sharp but sage observation was well before the Constitution of India was formally framed and adopted under his leadership. Eighty-eight years since the speech that was considered too controversial to be delivered, the issues of caste, constitutional impropriety and his controversial but astute insistence that "Democracy in India is only a top-dressing on India soil which is essentially undemocratic" resonates loud and clear with the proceedings (rather, regressions) in the ensuing Lok Sabha elec-

Amongst the most invoked, galvanising and feared concerns in the ongoing election pitch are still, caste and religion. Beyond the trumpeting label of 'world's largest democracy' which we proudly accept and acknowledge, is the damning backsliding on various Democracy 'indexes' - which we equally readily slam as vested, unfair, or even 'anti-national'. An unmistakably think-skinned spirit and hypersensitivity about the unflattering reportage abounds, which does not help build credentials of a mature, confident and progressive democracy. The mother of democracy' simply cannot be selectively entertaining of all praise and simultaneously small-spirited against criticism. However, beyond the multiple and well-known afflictions like dynastic tendencies, majoritarianism, ethnic-casteist-regional assertions, muscle power, money power et al, lies yet another serious curse of the complete lack of, or even any pretence of an 'internal democracy' in any political party, national or regional. We seem to be partaking in the exercise of democracy with a rather regrettable set of undemocratic

Beyond the obvious threats of the 'carrot-and-stick' nature (with murmurs of the infamous 'wash-



ing machine' phenomenon) that may have made many opposition politicians jump ships - there is yet another loud concern expressed of unapproachability, remaining essentially unheard, or even of inaccessibility attributed to political leadership that leads to members to leave political parties for greener pastures. All Indian political parties have their exclusive leadership cocooned, isolated and protected from lesser leaders - this seemingly helps build leadership aura, mystique and even fear of the respective 'high commands'. The top leadership is only for taking the 'final call' and all others must robotically comply with the same, as described in the uniquely Indian expression of sub-servience, "as disciplined soldiers of the party". Such obsequious and diktat-filled frameworks are more suggestive of autocracies rather than participative democracies.

This suffocating, intolerant and illiberal normalcy of Indian political culture is in stark contrast to that of its progenitor, British-Westminster politics. In the UK, there have always been divisions within party ranks (on issues), expressed ambition for top roles and public expression of dissenting positions e.g., Brexit.

All these individualistic or non-conformist positions do not warrant the automatic

of an individual from party The ruling Conservative Party has many active and known 'camps' that may or may not agree with the policies and decisions of their Partyman as the Prime Minister, Rishi Sunak. It has always been so with divides amongst social liberals and social democrats, modernisers and traditionalists and Brexiteers of various sides and shades etc., Therefore, even though the Conservative Party has ruled uninterrupted since 2010 (then by David Cameron), it has since had five different Prime Ministers i.e., David Cameron, Theresa May, Boris Johnson, Liz Truss and now, Rishi Sunak. Even now the jostling within the Tories continues with apparently Boris Johnson planning a comeback to David Cameron having staged a dramatic comeback as the Secretary of State for Foreign, Commonwealth Development Affairs, under

Rishi Sunak! It is the same concept of 'internal democracy' that has change in the principal opposition party i.e., the Labour Party. Since 2010 under Gordon Brown, it has seen a constant change in leadership Harriet Harman, Ed Miliband, Jeremy Corbyn to now Sir Keir Starmer. Each of

these individual leaders has

reflected the topical preference of the party cadres and leaders. Now with Keir Starmer sure to get elected as the Prime Minister of the UK, he couldn't be more unlike his party predecessor, Jeremy Corbyn, both in person and policies. Starmer continues to consult both the former Labour Prime Minister i.e., Tony Blair and Gordon Brown, though neither has any outsized political relevance. In short, there are no permanent Gods in British political parties, unlike the Indian context where a few individuals rule the roost without getting subjected to any internal challenge, questioning or change. The rules and circumstances for leadership can be made to change overnight to suit certain individuals or dynasties which essentially seek to perpetuate the leadership composition, that has existed for

As Winston Churchill once said, "The opposition occupies the benches in front of you, but the enemy sits behind you" implying in his party ranks that such internal competition seen a similar leadership can never be a sign of weakness but of ensuring that only one with the most competitive compelling and winning credentials leads the party.



municate with voters. The experience of using social media depends largely on the user, as the platform's algorithms tailor the consumer experience to CHANNEL IN THE each user. This leads to each person seeing more like-minded people due to increased digital social behaviour. In addition, social media changed politics because it gave politicians a direct way to inform their constituents and people to speak directly to politicians. This unofficial nature can lead to misinformation because it is not subject to the same "factchecking processes as institutional journalism". Moreover, social media platforms serve as democratising agents, empowering individuals to participate in political conversations irrespective of geographical or socio-economic barriers. Citizens can voice their perspectives, amplify marginalised narratives and mobilise collective action, thereby enriching the democratic fabric of society. Concurrently, social media's interactive nature engenders heightened transparency and accountability within political institutions, as public scrutiny intensifies and feedback mechanisms prolif-

### AI Deepfakes: A new era

Technological implications are increasingly becoming imperative in the current election in India about political communication. This election season, misinformation has a new face. This time, India smiles, talks and woos the voters with a wisdom that is hard to start and harder to regulate. The 2019 election was no stranger to hate and misinformation cam-

paigns, but the technology that enables this ecosystem has changed the rate of misrepresentation. The fraud pulse has found a new, more enthusiastic channel in the last five years. Law enforcement agencies are warning louder than ever that the average Indian voter in 2024 is most at risk of being misinformed about the election. There are gaps in people's ability to distinguish between real and artificial intelligence, leaving them vulnerable to fraud and unauthorised access. Social media companies struggle to curb fake news and propaganda; The Indian Government is updating existing legislation to better address the spread of online counterfeiting. The 2019 election took place on social media. Researchers identified sophisticated campaigns that used WhatsApp messaging and massive deployment of IT bots to distribute cropped photos, post coordinated content and publish fake videos on Facebook during the 2024 general elections. The pressing question now is how digital platforms tag, identify and contextualise such media. Even in the era of generative AI, such enforcement measures were nascent or seasonal at best. Now, cheap or free tools allow even amateurs to create deep fakes without content filters to prevent fake or illegal content from

spreading. This means that technology platforms have to act stronger against criminals and break the chain of disinformation faster than they do. One of the biggest changes in social media after the 2019 elections in India is the absence of Twitter (Now X), the platform used by India's controlled politicians and Government agencies to broadcast official information to the countrv's media.

### A way forward

In today's world, understanding politics means delving into how political actors communicate and navigate various media channels. These channels not only reflect but also shape political messages and images. Just as political systems influence media through policies and decisions, media structures profoundly impact political communication processes.

Easy-to-make AI videos with near-perfect shadows and hand gestures can sometimes confuse even the digitally literate. But the risks are greater in a country where many of its 1.4 billion people are technologically challenged and where manipulated content can easily stoke sectarian tensions, especially during elections. The Election Commission of India recently warned political parties against using artificial intelligence to spread misinformation, issuing seven provisions of IT and other laws that carry up to three years in prison for offences including forgery, rumour hostility.Looking forward to a free and fair election this time!

A Kashmiri Pandit Piyare Lal Handoo won the seat on IKNC ticket in 1989. Mohd Maqbool Dar won the seat on Janta Dal ticket in 1996.

The NC won the seat in 1999, 2009 and 2019, PDP emerged winner in 2004 and 2014. In the last Lok Sabha election,

the Anantnag Lok Sabha constituency had recorded a low voter turn of 9 percent voting while the Rajouri-Poonch area, which was part of Jammu Lok Sabha seat, recorded over 72 percent voting. In 2104, the Anantnag Lok Sabha seat saw a turnout of 28 percent.

While the polls in Baramulla and Srinagar were peaceful, authorities have a security challenge in the Anantnag-Rajouri Lok Sabha constituen-

cy. Last week terrorists carried

out two back-to-back attacks in south Kashmir in which a former sarpanch associated with the BJP was shot dead and a tourist couple was wounded in a separate attack.

# Modi: Talabaaz sarkar in HP shut recruitment commission

Polling in the 10 Lok Sabha constituencies in Haryana and for the Karnal assembly bypoll will be held on Saturday that will decide the fate of 223 candidates, including big guns like former chief minister Manohar Lal Khattar and Congress' Kumari

A total of 223 candidates — 207 men and 16 women — are in the fray in the sixth phase of the Lok Sabha polls and more than 2 crore people are eligible to vote in the state.

Khattar, the BJP candidate from Karnal, is facing Haryana Youth Congress Divyanshu president . Budhiraja. Haryana is witnessing a direct

fight between the ruling BJP opposition Congre most seats. However, seats like Hisar are witnessing a multicornered contest. From Hisar, Power Minister

Ranjit Singh Chautala, an Independent MLA who joined the BJP ahead of the polls, is pitted against two members of the Chautala clan -- JJP's Naina Chautala and INLD's Sunaina Chautala. Congress' Jai Prakash is also in the fray.

Jannayak Janta Party (JJP), Indian National Lok Dal (INLD) and Bahujan Samaj Party (BSP) have also fielded their candidates in the Lok Sabha polls. JJP's 10, BSP's nine and INLD's seven candidates are contesting the

A few sitting MLAs are also in the fray, including INLD's Kurukshetra candidate Abhay Singh Chautala. Congress' sitting MLAs Varun

Chaudhary and Rao Dan Singh are contesting from Ambala and Mahendragarh respectively.
BJP MLA Mohan Lal Badoli is

Saini, who is also the state BJP chief and the sitting Kurukshetra MP, was sworn in as the chief minister on March 12, replacing Khattar. He contesting the Karnal assembly bypoll.

There are nine candidates in the fray for the bypoll which was necessitated by Khattar's resignation as MLA. There are 2,00,76,768

registered voters in the state, including 94,23,956 women and 467 transgender voters, Haryana's Chief Electoral Officer Anurag Agarwal said. A total of 45,576 EVMs will be used in the state for the Lok Sabha elections and the assembly bypoll. Along with this, 24,039 control units and 26,040 VVPAT machines will be used, Chief Electoral Officer Anurag Agarwal said. A total of 20,031 polling stations have been set up in Haryana, including 19,812 permanent and 219 auxiliary. While 5,470 polling stations have been set up in urban areas, 14,342 have been set up in rural areas, he said

As many as 99 polling stations will be operated entirely by women stations aff. Apart from this, 96 polling stations will be manned by youth employees and 71 by PwD (Persons with Disabilities) employees, he said. Agarwal said polling parties in the state will depart for their respective polling stations on Friday.

# SC refuses to direct EC to upload voter turnout data amid LS polls

PTI ■ NEW DELHI

The Supreme Court on Friday refused an NGO's plea to issue the Election Commission directions to upload polling station-wise voter turnout data on its website during the Lok Sabha polls, saying a "hands-off approach" needs to be adopted during the

A vacation bench of Justices Dipankar Datta and Satish Chandra Sharma said it cannot issue any such directions at the moment as five phases of polling have concluded and two remain and it would be difficult for the poll panel to mobilise manpower.

The top court adjourned the interlocutory application (IA) filed by the Association for Democratic Reforms (ADR) to be listed before the regular bench after the elections and pointed out that prima facie it appears the prayers in the application are similar to the main petition pending since 2019 on the issue. "This (IA) has to be taken with the pending writ petition because in between the elections, a hands-off approach has to be adopted," it said and pointed out that it would be difficult for the EC to mobilise manpower for uploading the voter turnout data on its

"Granting any relief in IA will amount to granting relief in the main petition which is pending," the bench said. It said it needs to understand the ground reality and not overburden the poll panel by changing the process midway.

On May 17, the top court had sought within a week the EC's response on the NGO's plea seeking a direction to upload polling station-



wise voter turnout data on its website within 48 hours of the conclusion of polling for each phase of the Lok Sabha elections. The ADR has filed an interim application in its

2019 PIL seeking directions to the poll panel that "scanned legible copies of Form 17C Part-I (Account of Votes Recorded)" of all polling stations be uploaded immediately after the

In its affidavit, the poll panel opposed the NGO's demand, stating that it will "vitiate" the electoral space and cause "chaos" in the poll machinery in the midst of the general elections.

The poll panel has said that there is no legal mandate to provide Form 17C to any person other than the candidate or his agent.

It has said that public posting of Form 17C which gives the number of votes polled in a polling station — is not provided in the statutory framework and could lead to mischief and vitiation of the entire electoral space as it increases the possibility of the images being morphed.

# UN court orders Israel to halt Rafah military op 'More aid getting

 $T^{\text{he top United Nations}}_{\text{court ordered Israel on}}$ Friday to immediately halt its military operations in the southern Gaza city of Rafah. While Israel is unlikely to comply with any such order, it will ratchet up the pressure on the increasingly isolated country. Criticism of Israel's conduct in the war in Gaza has been growing — even from its closest ally, the United States, which warned against an invasion of Rafah, where hundreds of thousands of Palestinians have sought shelter from fighting elsewhere. And this week alone, three European countries announced they would recognise a Palestinian state, and the chief prosecutor for another UN court requested arrest warrants for Israeli leaders, along with Hamas officials.

Israeli Prime Minister Benjamin Netanyahu is also under heavy pressure at home to end the war, which The court's president, Nawaf

was triggered when Hamas-led militants stormed into a small group of pro-Israel, killing 1,200 people, most civilians, and taking some 250 captive. Thousands of Israelis have joined weekly demonstrations calling on the government to reach a deal to bring the hostages home, fearing that time is

running out.
While the ruling by the
International Court of Justice is a blow to Israel's international standing, the court does not have a police force to enforce its orders. In another case on its docket, Russia has so far ignored a 2022 order by the court to halt its full-scale invasion of Ukraine.

Israel signalled it, too, would brush off an ICJ order to stop its operations. "No power on earth will stop Israel from protecting its citizens and going after Hamas in Gaza," Avi Hyman, the government spokesperson, said in a press briefing

Palestinian protesters demonstrated outside. Fears expressed earlier "with respect to the developments in Rafah have materialised and that the humanitarian situation is now to be characterised as disastrous," the ruling said. The court did not call for a full cease-fire throughout Gaza as South Africa had requested at hearings last week. The cease-fire request is part of a case filed late last year by South Africa accusing Israel of committing genocide during its Gaza campaign. Israel vehemently denies the allegations. The case will take years to resolve, but South Africa wants interim orders to protect Palestinians while the legal wrangling continues. six-day-old U.S. pier pro-A ject in Gaza is starting to get more aid to Palestinians in need but conditions are challenging, U.S. officials said Thursday. That reflects the larger problems bringing food and other supplies to starving people in the besieged terri-

The floating pier had a troubled launch, with crowds overrunning some of the first trucks coming from the new U.S.-led sea route and taking its contents over the weekend. One man in the crowd was shot dead in still-unexplained circumstances. It led to a two-day suspension of aid distribution.

The U.S. military worked with the U.N. and Israeli officials to select safer alternate routes for trucks coming from the pier, U.S. Vice Admiral Brad Cooper told reporters Thursday.

As a result, the U.S. pier on Wednesday accounted for 27 of the 70 total trucks of aid that the U.N. was able to round up from all land and sea crossings into Gaza for distribution to civilians, the United States said.

That's a fraction of the 150 truckloads of food, emergency nutrition treatment and other supplies that U.S. offi-cials aim to bring in when the sea route is working at max-

imum capacity. Plus, Gaza needs 600 trucks entering each day, according to the U.S. Agency for International Development, to curb a famine that the heads of USAID and the U.N. World Food Program have said has begun in the north and to keep it from spreading south. Only one of the 54 trucks that came from the pier Tuesday and Wednesday encountered any security issues on their way to aid warehouses and distribution points, U.S. officials said. They called the issues "minor"

but gave no details.

A deepening Israeli offensive in the southern city of Rafah has made it impossible for aid shipments to get through the crossing there, which is a key source for fuel and food coming into Gaza. Israel says it is bringing aid in through another border crossing, Kerem Shalom, but humanitarian organizations say Israeli military operations make it difficult for them to retrieve the aid there for distribution.

The Biden administration last week launched the \$320 million floating pier for a new maritime aid route into Gaza as the seven-month-old Israel-Hamas war and Israeli restrictions on land crossings have severely limited food deliveries to 2.3 million Palestinians.

For all humanitarian efforts, "the risks are manifold," Daniel Dieckhaus, USAID's response director for Gaza, said at a briefing with Cooper. "This is an active conflict with deteriorating conditions.

Dieckhaus rejected charges from some aid groups that the pier is diverting attention from what the U.S., U.N. and relief workers say is the essential need for Israel to allow full access to land crossings for humanitarian shipments. For instance, Jeremy Konyndyk, a former USAID official now leading Refugees International, tweeted that "the pier is humanitarian the-

"I would not call, within a couple of days, getting enough food and other supplies for tens of thousands of people for a month theater," Dieckhaus said Thursday when asked about the criticism. At maximum capacity, the pier would bring in enough food for 500,000 of Gaza's people. US officials stressed the need for flow through open land crossings for the remaining 1.8 million.

# SIA to continue review safety processes after turbulence incident

Singapore (PTI) In-flight meal services will now be suspended when the seatbelt sign lights up on a Singapore Airlines plane to better manage turbulence in the air, an airline spokesperson has said, days after severe weather forced a flight to make an emergency landing in Bangkok with one dead and 60 injured.

Singapore Airlines (SIA) said it will continue to review inflight security processes, giving utmost importance to the safety of passengers and crew following last Tuesday's incident. "The SIA will continue to review our processes as the safety of our

passengers and crew is of utmost importance," The Straits Times quoted a spokesman for the flag carrier as saying on Thursday. In-flight meal services will now

be suspended when the seat-belt sign lights up on a Singapore Airlines plane as part of efforts to take a more cautious approach to managing turbulence in the air, the spokesperson said.

Cabin crew will also sit down and fasten their seat belts when the seat-belt sign is lit, the SIA said on May 23.

Unlike in the past, hot drinks would be cut off dur-ing turbulence, the new mea-sures would require all meal and drink services to stop when the

ride gets bumpy.
Other existing safety measures that kick in during poor weather conditions, including getting crew members to secure loose items in the cabin, advising passengers to return to their seats and buckle up, and monitoring,

will remain in place. On May 21, Flight SQ321, which was heading to Singapore from London, experienced sudden severe turbulence over the Irrawaddy Basin in Myanmar during the breakfast service. One passenger — 73-year-old Briton Geoffrey Kitchen died, and dozens were injured. The pilot declared a medical

emergency and diverted the Boeing 777-300ER carrying 211 passengers and 18 crew members to Bangkok's Suvarnabhumi Airport, where the plane made an emergency landing at 3.45 pm (4.45 pm Singapore time) Singapore time).

It is the first SIA aviation accident involving a fatality since the SQ006 crash in Taiwan in

October 2000. Meanwhile, SIA has apologised to the injured passengers who say they had no information from the airline. Keith Davis, an Australian passenger, on May 23 complained to the media that he had not heard from any SIA staff since he was hospitalised, according to local reports.

Another Singaporean, who was previously in the Intensive Care Unit at a Bangkok hospital, has been discharged while 48 passengers from Flight SQ321 remain warded.

According to an update from Samitivej Srinakarin Hospital, 34 passengers remain warded in its premises as of noon on May 24, with another 12 at the Samitivej Sukhumvit Hospital and two at the Bangkok Hospital.

The 34 warded at Samitivej Srinakarin Hospital - comprising 14 males and 20 females are from countries such as Australia, Britain, Malaysia, and the Philippines, according to media reports. Singapore Transport Minister

Chee Hong Tat said on Friday he was relieved that passengers who were injured when the Singapore Airlines plane encountered severe turbulence were recovering and that some had already been discharged from the hospital and returned

He said investigators from Singapore's Transport Safety Investigation Bureau (TSIB) were going through data from the cockpit voice recorder and the flight data recorder. "We await the investigation findings to understand what happened during those moments," the Singapore Daily quoted

Chee as saying.

# More than 100 people believed killed by landslide in PNG

More than 100 people are believed to have been killed Friday in a landslide that buried a village in a remote, mountainous part of Papua New Guinea, and an emergency response is underway, the South Pacific island nation's leader and news media said. The landslide hit Kaokalam village in Enga province, about 600 kilometers (370 miles) northwest of ters (3/0 miles) northwest of the capital, Port Moresby, at roughly 3 am, Australian Broadcasting Corporation (ABC) reported. Residents said estimates of the death toll were above

100, although authorities have not confirmed that figure. Villagers said the number of people killed could be much higher. Prime Minister James Marape said authorities were responding and he would release information about the destruction and loss of life when it was avail-

"I am yet to be fully briefed on the situation. However, I extend my heartfelt condolences to the families of those who lost their lives in the landslide disaster in the early hours of this morning, Marape said in a statement. "We are sending in disaster officials, PNG Defense Force, and the Department of Works and Highways to ... start relief work, recovery of bodies, and reconstruction of infrastructure," he added.

Australia, a near neighbor and Papua New Guinea's most generous provider of foreign aid, said the government stood ready to help. "We send our heartfelt symmetric to the state of the stat pathies to the people of PNG following the landslide at Kaokalam village," Australian Foreign Minister Penny Wong posted on social media ."The loss of life and destruc-tion is devastating," she added. Videos on social media showed residents pulling out bodies buried under rocks

and trees. Elizabeth Laruma, who runs a women's business association in Porgera, a town in the same province near the Porgera Gold Mine, said houses were flattened when the side of a mountain gave

"It has occurred when people were still asleep in the early hours, and the entire village has gone down," Laruma told the Australian Broadcasting Corp. "From what I can presume, it's about 100-plus people who are buried beneath the ground."

The landslide blocked the road between Porgera and the village, she said, raising concerns about the town's supply

of fuel and goods.
Village resident Ninga Role,
who was away when the landslide struck, expects that at least four of his relatives

"There are some huge stones and plants, trees. The build-ings collapsed," Role said. "These things are making it hard to find the bodies." Belinda Kora, a Port Moresby-based ABC reporter, said helicopters were the only way of accessing the village, which is in the mountainous interior region

mountainous interior region known as the Highlands, with the main road closed. Papua New Guinea is a diverse, developing nation of mostly subsistence farmers with 800 languages. There are few roads outside the larger cities. With 10 million people, it is also the most populous South Pacific nation after Australia, which is home to some 27 million. Telecommunications are poor, particularly outside Port Moresby where government data show 56 per cent of the nation's social media users reside. Only 1.66 million people across the country use the internet and 85 per cent of the population lives in rural areas.

office manager of the Hong Kong Economic and Trade Office in London. A third suspect, Briton Matthew Trickett, was also charged in the case, but he was found dead Sunday in a park under what police said were unexplained circumstances.

Prosecutor Kashif Malik said during an earlier hearing that Trickett, reportedly a UK immigration enforcement offi-cer and a former Royal Marine, had attempted suicide after being charged. He was also the director of a security company. Justice Jeremy Baker set a trial date for February 10, set to last for about five weeks. The judge said the men were granted bail on condition that they observe a set curfew and other restric-

The three men were charged under Britain's National Security Act after an investigation by the Metropolitan Police Counter Terrorism Command. Prosecutors allege that the suspects also forced entry into a UK residential address. They were arrested earlier this

month in London and Yorkshire in northern England by counterterrorism police, using provisions of a new law that allows suspects in national security and espionage cases to be detained without warrant. The case drew strong criticism from officials in Beijing and Hong Kong, a former British colony that returned to Chinese control in 1997. Chinese Foreign Ministry spokesman

Wang Wenbin said Friday that the charges were "an act of political manipulation in the name of national security". "It seriously infringed on the legitimate rights and interests of Chinese nationals in the UK, gravely undermined China-UK relations, seriously violated the principles of international law and the basic norms of international relations and badly harmed the image of the UK," he told reporters. The Republican caucus allowed only registered Republicans to vote, and they had to be at least 18 at the time of the caucus. Former President Donald Trump won all of Idaho's 32 GOP delegates at the March 2 event. Biden will face a steep hill to climb for Idaho's general election. The Republican presidential candidate has won the deep-red state in every election since 1968. Democrats in Idaho utilized caucuses for years but switched the presidential contest to a primary for 2020. Biden won with about 49% of the vote, compared with roughly 42% that went to US Sen. Bernie Sanders of Vermont. Both the Republican and the Democratic parties had to caucus this year, however, after state lawmakers inadvertently scrapped the state's primaries during the 2023 legislative session. The error happened when lawmakers were trying to change the date of the state's primary from March to May, but the new date wasn't included in the bill. AP

# India should impose tax on ultra wealthy to tackle wealth inequality: Study

Iper cent tax on net wealth exceeding Rs 10 crore and a 33 per cent inheritance tax to deal with the problem of rising inequality in the country, a new research paper co-authored by economist Thomas Piketty has suggested.

The paper titled 'Proposals For a Wealth Tax Package to Tackle Extreme Inequalities

in India' propose a comprehensive tax package on the ultra-wealthy to tackle the massive concentration at

the very top of the wealth distribution and create valuable fiscal space for crucial social sector investments.

"Raise phenomenally large tax revenues while leaving 99.96 per cent of the adults unaffected by the tax. "In a baseline scenario, a 2 per cent annual tax on net wealth exceeding Rs 10 crore and a 33 per cent inheritance tax on

estates exceeding Rs 10 crore in valuation would generate a massive 2.73 per cent of Gross Domestic Product (GDP) in revenues," paper

The paper said that the taxation proposal needs to be accompanied by explicit redistributive policies to support the poor, lower castes, and middle classes.

"For example, the baseline scenario would allow nearly doubling the current public spending on education, which has stagnated at 2.9 per cent of GDP over the past 15 years, well below -- less than half -the 6 per cent target set by the government's own National Education Policy 2020 (NEP 2020)," it said.

The paper noted that the taxation proposal needs to be

extensively debated, with a consensus on specific details of the design emerging from a broader democratic debate on tax justice and wealth redistribution in India.

The paper has been authored by Thomas Piketty (Paris School of Economics and World Inequality Lab), Lucas Chancel (Harvard Kennedy School and World Inequality Lab) and Nitin Kumar Bharti (New York University and World Inequality Lab).

"By 2022-23, top 1 per cent income and wealth shares (22.6 per cent and 40.1 per cent) are at their highest historical levels and India's top 1 per cent income share is among the very highest in the world, higher than even South Africa, Brazil, and the US," the paper had said.

# Zee seeks USD 90 million termination fee from Sony for calling off merger

It has sought termination fees from two Sony Group entities — Sony Pictures Networks India (SPNI), now known as Culver Max Entertainment, and Bangla Entertainment (BEPL), according to a regulatory filing from Zee Entertainment Enterprises Ltd (ZEEL) on Thursday.

ZEEL has, on account of Culver Max's and BEPL's breaches under the Merger Cooperation agreement (MCA), terminated the MCA by issuing a letter dated May 23, 2024.

"Culver Max and BEPL have failed to comply with their obligations under the MCA. Therefore, the company has terminated the MCA and called upon Culver Max and BEPL to pay the termination fee i.E. The aggregate amount equal to USD 90 million in accordance with the MCA," it

Earlier on January 22, 2024, Sony Group Corporation (SGC) had said that ZEEL did not satisfy the merger conditions and initiated arbitration proceedings before the Singapore International Arbitration Centre (SIAC) claiming USD 90 million as termination fee. This was contested by ZEEL before the SIAC, which denied any interim relief to

ZEEL had moved the National Company Law seeking Tribunal implementation of the proposed merger and later withdrew its plea.

"We hereby wish to inform you that the company has, on account of Culver Max's and BEPL's breaches under the MCA, terminated the MCA by issuing a letter dated May 23, 2024, and sought a termination fee from Culver Max and BEPL in accordance with the provisions of the

MCA," the filing said. ZEEL and SPNI had entered into an agreement to merge on December 22, 2021.

Netherlands are leading the charts with 26 points (12 matches), while Australia are on 20 points (8 matches).

"To achieve both these targets (doing well ahead of Olympics and secure direct qualification for 2026 World Cup), we will strive to give our all on the pitch and win all our matches," the skipper added.

Besides Argentina, the Indian men's team will also test their



Olympic preparations against Belgium, Germany and Great Britain. The Indian women, currently placed sixth on the Pro League table, have a chance to climb up the table when they take on world No.7 Argentina on Wednesday.

The world No.6 side has earned eight points from an equal number of games in the Pro League home leg, registering victories against the United States and Australia.

Newly-appointed Salima said the friendlies against South Africa in India earlier this month had helped her team prepare for the European leg of the Pro League.

"We played practice matches against South Africa (in India) to prepare for these Hockey Pro League matches. The point difference between us and second-placed China is just seven points," said Tete in a Hockey India release.

"We (will) aim to close this gap in the remaining matches against Argentina, Belgium, Germany, and Great Britain in a bid to finish as high as we can," she added.
