In a gut-wrenching incident, a prominent doctor allegedly took his own life after killing his entire family of four at their residence in Patamata here on Tuesday. The deceased have been identified as Dr D Srinivas (40), a well-known orthopaedic surgeon, his mother Ramanamma (65), wife Usha Rani (38), and their children, daughter Sailaja (9) and son Srihan (8).

According to Patamata police, Dr Srinivas was battling financial difficulties after reportedly facing losses at his orthopaedic hospital in Mogalrajapuram. The hospital recently underwent a manage-ment change, which is believed to have exacerbated his financial

The APCC chief made this assertion against Jagan, her elder brother, at Ravulapalem in Konaseema district as part of her electioneering tour across the State.






# 'Jagan govt's policies hit Polavaram works'

The nomination of MLC Ch Vamsikrishna Srinivasa Yadav of the Jana Sena Party (JSP) for the Visakhapatnam South Assembly constituency has caused unhappiness among members of the alliance parties, particularly the TDP and BJP. Even within the JSP, some sections expressed reservations about his candidature, citing concerns over his suitability for a con-

comprising fishermen. However, despite initial mistrust, Vamsikrishna's grassroots campaign has gathered momentum, swaying opinion in his favour. Through rigorous door-to-door canvassing, frequent interactions with party workers, and engaging programs with diverse community groups, he has managed to rally support.

Of late, Vamsikrishna has gained support from important people like TDP's Gandi Babjee, former Brahmin Corporation



Chairman Sitharamaraju Sudhakar, and powerful business leaders. This surge in support has strengthened his electoral

Visakhapatnam-South constituency, one of seven in the Visakhapatnam Lok Sabha region, holds crucial political importance. Historically, it has been

a TDP stronghold, with Vasupalli Ganesh Kumar winning consecutively in 2014 and 2019. However, Kumar's recent switch to the YSRCP has created an opening for rival parties to challenge TDP's dominance.

In a bid to reclaim lost ground, TDP appointed seasoned politician Gandi

Babjee as the constituency in-charge, hoping to mobilise grassroots support. Despite these efforts, the seat was ultimately allocated to the JSP as part of the alliance's seatsharing agreement. The electorate of

Visakhapatnam South

comprises diverse communities, including fishermen, Muslims, Vaishvas, Brahmins, and long-standing migrant people. Notably, voters in this constituency prioriality and local reputation over party affiliations, making it a unique electoral battleground. Incumbent MLA Vasupalli Ganesh Kumar, renowned for his strong grassroots presence and effective implementation of YSRCP initiatives, remains a formidable opponent.

While YSRCP initially promised Rs 12,500 annually to farmers, it increased the amount to Rs 13,500 upon assuming power and now pledges Rs. 16,500 annually for the next five years.

# **32,43,537** total number of voters in combined Krishna

While NTR dist accounts for 17,04,077 voters, the size of the electorate in Krishna district is 15,39,460

In the recently proposed final Special Summary Revision (SSR) released on April 25, a combined total of 32,43,537 voters were identified across the Krishna and NTR districts. Among these, Krishna accounted for 15,39,460 voters, while NTR district recorded 17,04,077 voters.

The largest electoral constituency within these districts was Penamaluru, boasting 2,94,928 electors. Meanwhile, Mylavaram claimed the highest number of voters in the NTR district and the secondhighest in the erstwhile Krishna district, with a tally of 2,81,732 voters. Conversely, the Pedana assembly constituency had the smallest electorate, with 1,67,564 electors.

Officials reported that Krishna district's electorate stands at 15,39,460, with 7,93,332 females, 7,46,071



voters. A comparison with previous voter publications reveals an increase of 21,205 voters in Krishna district. However, there were 38,422 additions and 17,217 deletions since the last publication.

Penamaluru teeters close to the 3 crore voter milestone, situated on the outskirts of Vijayawada. It's anticipated to soon surpass this mark. Out of

2,94,928 voters, 1,52,577 are female, and 1,42,349 are male.

Similarly, the Gannavaram assembly segment boasts 2,79,054 voters (Male-134,226, Female-1,44,816), Avanigadda-2,12,331 (M-1,04,568, F-1,07,745), Gudivada-2,04,271 (M-97,710, F-1,06,550), Machilipatnam-1,96,680 (M-94,788, F-1,01,8810), Pamarru-1,84,632 (M-89,433, F-95,207), and the Pedana segment has a

## 'Implementation of law only after land re-survey'

Advisor to Chief Minister YS Jagan Mohan Reddy, Ajeya Kallam, addressing a round table meeting on the Land Titling Act on Tuesday, assured that the Act will only be implemented after the land re-survey is complete and following consultations with all stakeholders. Kallam highlighted the gov-

Rallam expressed disappointment over opposition to the Act, claiming it could delay progress for 50 years. He reiterated the government's commitment to protecting land ownership rights and creating a clear land registry.

The candidates can get permission for all events related to election campaigns like the use of vehicles, holding meetings, rallies and advertisements through the Suvidha app. The permits have to be submitted 48 hours in advance. Permissions are granted within 24 hours to 48 hours of application.

Regarding expenditure, the expenses should be recorded in a separate register with vouchers and bills, he said, adding the district committee has fixed the prices for each item regarding the expenditure incurred by the candidates in the elections. Candidates

should verify their election expenses in three instalments on May 3rd, 7th and 11th in District Election Expenditure Scrutiny Cell, he told the candidates.

Collector Pranna Venkatesh said that 917 voters who are above 85 years of age are being provided voting from home through a secret mode. The distribution of voter's slips began in the district. He said that there are 1744 polling stations in the district of which 414 were identified as problematic and elaborate security is being made for the polling stations.



# 'Self-reliance key to deal with future security challenges'

PNS NEW DELHI

Warfare has transcended into new domains, such as space, cyber, electromagnetic spectrum and information systems, and India must develop indigenous capabilities to deal with future security challenges, Army Chief Gen Manoj Pande said on Tuesday.

The Army chief especially underlined the importance of "technology infusion" and "selfreliance" in the armed forces, saying both are distinct yet interconnected.

Gen Pande said India must develop its indigenous military capabilities as no country will share the latest, advanced and critical technology with it.

"Warfare has transcended into new domains, such as space, cyber, electromagnetic spectrum and information. Consequent to these developments, conventional force ratios, which was the measure of military strength and superiority in the past, stand blunted today," he said.

Gen Pande made the remarks at the fourth Gen K Sundarji



The Army chief especially underlined the importance of "technology infusion" and "self-reliance" in the armed forces, saying both are distinct yet interconnected. Gen Pande said India must develop its indigenous military capabilities as no country will share the latest. advanced and critical technology with it.

He highlighted the need for embracing technology in order to maintain a competitive edge on the battlefield.

"The imperative of technology infusion into warfighting systems and to keep pace with technological progression, remains

enduring to this day," he said. "The impact of external dependency for critical components, supply chain disruptions and weaponisation of denial regimes came to the fore, during the (Covid-19) pandemic and also from the lessons of the ongoing Russia-Ukraine conflict," he

"We need to recognise that no country will share the latest, advanced and critical technology with us," he said.

The Army chief said being import dependent for critical technologies entails the risk of remaining behind in niche areas.

"The answer, therefore, lies in being self-reliant and achieving self-sufficiency in critical technologies through indigenous research and development," he said. Gen Pande said the growing centrality of cyber domain in critical infrastructure has resulted in it emerging as a new bat-tleground of digital confronta-

tion. "Information operations today have gained new dimensions," he said. "When we talk about digitisation of the battlefield, we are witness to a manifold increase in the lethality and accuracy of kinetic instruments and increased proliferation of technologies such as artificial intelligence, quantum computing, robotics and nano-technology," he said. The Army chief said disruptive and dual use technologies and their proliferation at unprecedented scale are transforming the character of modern wars.

"A suite of digital technologies, encompassing electronic warfare, micro-electronics, drones, precision attack systems, loiter munitions and star link terminals are challenging traditional force multipliers," he

"Swarming is contesting surging, surveillance and precision are scoring over fire and manoeuvre, and the light and small are prevailing over the large and heavy," he added.

Gen Pande said his force has been focusing on developing indigenous capabilities.

# SC questions ED on timing of Kejriwal's arrest, seeks its reply

"Life and liberty are exceedingly important. You can't deny that," the bench told Raju and sought his reply, saying, "the last question is with regard to the timing of the arrest, which they have pointed out, the timing of the arrest, soon before the general elections."

The bench also flagged the long time gap between initiation of adjudication proceedings in the case and the action of arrest, saying the section 8 of the

# Healthy lifestyle could counter genetic risk of shorter life, says study

Adopting a healthy lifestyle could counter the effects of life-shortening genes by more than 60 per cent, according to new research published in the British Medical Journal Evidence-Based Medicine.

Researchers found four factors to make up the most favourable lifestyle combination -- not smoking, regular physical activity, adequate nightly sleep, and a healthy

team, including The

University School' Medicine, China, found that while genes and lifestyle together impact a person's lifespan, an unhealthy lifestyle could heighten the risk of dying prematurely by 78 per cent, regardless of their genetic inclinations.

However, "the genetic risk of a shorter lifespan or prema-ture death might be offset by a favourable lifestyle by approximately 62 per cent", the authors wrote.

The researchers analysed

the data of more than 3.5 lakh adults, recruited to the UK Biobank between 2006 and 2010, and whose health was tracked up until 2021. Each participant's genetic predisposition to a longer or shorter lifespan was arrived at using a polygenic risk score (PRS).

Lifestyle factors including diet and sleep habits were also studied. The authors found that starting a healthy lifestyle at the age of 40 years could enhance life expectancy by roughly 5.5 years in those

having a high genetic risk of a shorter lifespan.

They added that given how lifestyle habits tend to be cemented before middle age, measures taken to address the effects of life-shortening genes

are needed before then. The researchers also found that regardless of lifestyle, individuals having genes favouring a shorter lifespan were 21 per cent more likely to die early than those having genes favouring a long life.

Further, the combination of life-shortening genes and an

unfavourable lifestyle could place an individual twice as likely to die compared to one having both long-life genes and a favourable lifestyle.

"This study elucidates the pivotal role of a healthy lifestyle in mitigating the impact of genetic factors on lifespan reduction," the authors wrote.

The team acknowledged that European ancestry of the participants could limit applying the findings to a wider population. Further, being an observational study, no causal links could be established, they said.

# Repeat offenders

Pro-Khalistan slogans raised again at Toronto event in front of Trudeau; India hits back

et another event which saw pro-Khalistan slogans being raised, this time in Toronto, has triggered diplomatic tensions between India and Canada. Canadian Prime Minister Justin Trudeau was also present in the programme, which made it look like the Canadian Government was condoning the act. It prompted India to summon in New Delhi a Canadian diplomat and express strong disapproval. The event, celebrating cultural diversity and inclusivity, took an unexpected turn when a group of individuals began chanting slogans in support of Khalistan, a separatist movement. The unfortunate incident is indeed a setback to ongoing discussions between the countries on various issues. For India, the incident struck a sensitive chord as it perceives the Khalistan movement a threat to its sovereignty and territorial integrity. Indian authorities view any display of support for Khalistan, especially in the presence of heads of State, with utmost seriousness. The Indian Government, therefore, wasted no time in



conveying its concerns to Canadian authorities. The summoning of their diplomat serves as a clear signal of India's displeasure and underscores the gravity with which it views the matter. Meanwhile, in Canada, the incident has sparked discussions about the limits of freedom of expression and the implication of such incidents on diplomatic relations.

While Canada may uphold the principles of free speech and assembly, the chanting of pro-Khalistan slogans on its soil in the presence of its Prime Minister raises questions about the appropriateness of such actions, particularly in a diplomatic context. Trudeau, who has been an advocate for multiculturalism and

diversity, has yet to publicly comment on the incident. However, it is expected that he will address the matter in due course, considering the diplomatic ramifications and the need to maintain constructive relations with India. Given the history of the roots of Khalistanis in Canada, it was a foregone conclusion that something of this sort might come up. The Canadian Prime Minister should have ensured in advance such a thing would not happen as it reflects badly on his Government and strains relations with India. Indeed, pampering Khalistanis on its soil is going to be a problem for Canada as history repeats itself and all those regimes that once harboured such elements have paid a heavy price for it. The incident also underscores the complexities of managing diaspora politics, particularly when it intersects with sensitive geopolitical issues. Canada is home to a significant Sikh population, many of whom have strong ties with India and hold varying views on the Khalistan movement. Ultimately, the Toronto incident highlights the interconnectedness of global politics and the need for vigilance in safeguarding the principles of sovereignty, unity and respect for diverse perspectives. It is a stark reminder that actions and words uttered in one corner of the world can have far-reaching implications, shaping the course of international relations for years.

# Why is the BJP avoiding China in campaigning?



The BJP's election focus has shifted away from recent China tensions, opting instead to highlight Nehru's actions during the 1962 conflict

hina has been generally missing from election manifestoes and campaigning so far. Former Army Chief Gen Naravane at a literary festival in Ajmer recently called China India's primary threat adding confrontation along LAC was a good thing as it exposed this ground reality that Delhi was shy to admit. EAM S.Jaishankar and especially Defence Secretary Giridhar Armane have made unkind references to Beijing. In his book Four Stars of Destiny Naravane has written extensively about the India-China confrontation which started under his watch. It was a serious failure of intelligence which allowed the Chinese PLA to occupy nearly 2000 square km of territory on the Indian side of LAC corresponding to their 1956 claim line. The avoidable tragedy at Galwan and the refusal of the Chinese to restore the status quo ante April 2020 even after 21 rounds of military dialogue (the last round on 21 February) place India at a serious disadvantage. In 1998 India gave China as the reason for conducting nuclear tests which incensed the Chinese, requiring then foreign minister Jaswant Singh to travel to Beijing to "untie the knot". I was witness to the repair exercise in Beijing even as then our Army was retaking Tololing Heights, Kargil. Singh had to say that China was not a threat. Later then defence minister George Fernades called China the number one threat though it was misreported as No 1 enemy". This caused a diplomatic furore as China is acutely sensitive to being seen as or worse a threat by any country. The Government is careful in its articulations on China as it hopes to secure full disengagement diplomatically. But the gloves came off Feb /Mar. Jaishankar speaking at the Raisina dialogue said that China should not be allowed to play mind -games to other means (implying US help) to seek better equilibrium. His comments came a day after Armane at the INDUS-X FORUM in Delhi unprecedently called Beijing a bully adding

#### **A PICTURE IS WORTH A THOUSAND WORDS**

Visual storytelling can promote sensitivity and empathy

scared figure crouching in a corner, a large hand covering a mouth trying to muffle a scream, outstretched arms pleading for help, Atattered clothes. More often than not, images like these accompany media reports of sexual violence against women. As a survivor of sexual harassment, Ankita Anand felt insulted looking at these images. She didn't want to be depicted this way.

What upset her most were drawings meant to represent the survivors and create awareness that served to titillate. She decided to take matters into her own hands. The activist-turned-journalist started a campaign with a Change Org petition and directed her attention to one of the major news channels to set an example by not using disrespectful images of women in sexual violence reporting. What was needed to transform the way society perceived women was images that were not about helplessness but about the rage that challenged the oppression. Pictures that showed that women are "doers," not always the "done upon-s." were shared by Anand in her piece about her innovative campaign for the Network of Women in Media, India.

While her 2018 petition garnered over 47,000 signatories and also helped to spotlight an earlier Redraw Misogyny campaign by Breakthrough, an organisation working to end violence against women, many media platforms continue to churn out images that strip the victim of agency and perpetuate shame and stigma attached with rape and sexual harassment, creating a biased perception of women who have experienced sexual

But now Anand and the many survivors in India and the region, no longer have to be depicted in this disempowering way thanks to the just-launched free-to-use image bank reframing visual narratives around women and sexual violence in South Asian media.



Conceptualised by the Hri Institute for Southasian Research and Exchange, Kathmandu and developed with the help of a team of artists and photographers from India and Nepal, the image bank re-imagines visual depiction of women and sexual violence to address the wide spectrum of women's experiences. It is an outcome of a unique collaborative effort to explore the role images play in forming perceptions around sexual assault, women and gender equality. The project 'Challenging Visual Depiction of Women and Sexual Violence in Southeast Asia' led by Laxmi Murthy and Pawas Manandhar united researchers, activists, filmmakers, and artists to redefine visual portrayals of gender-based violence in cinema, media, and popular culture across Bangladesh, India, Nepal,

The one-year project focused on challenging problematic imagery and promoting more meaningful depictions of violence and trauma. South Asian artists utilised textiles alongside illustrations and photos to narrate stories of injustices against women. It is an important artistic medium of expression, especially for those who have suffered violence, repression and discrimination as textiles are inextricably linked to the lives of people, particularly women. "I Never Ask For It," a campaign by Blank Noise, a Bengaluru-based volunteer-led project, has been working to generate awareness of gender-based violence and end victim shaming/blaming by building testimonies of clothing. Images from this campaign can also support survivors of violence to feel heard and believed.


A picture is worth a thousand words. It can transform the way sexual violence against women is framed in the media when used sensitively and appropriately. It just needs the will to do it.

India's talent, resources and infrastructure position it to excel in the semiconductor sector and becoming a global leader



s our lives become increasingly reliant on technology, semiconductors have become the essential foundation of society. These tiny chips are the powerhouses behind our electronic devices, communication systems and even the functioning of our agricultural implements medical equipment and vehicles. India has recognised the enormous socio-economic potential and strategic importance of this silent revolution of technology and is taking the lead in building a robust semiconductor ecosystem and developing a talented workforce. India's goal of becoming self-sufficient and

a global leader in semiconductors is supported by the fact that the semiconductor industry is expected to generate over one million job opportunities for semiconductor design engineers, manufacturing engineers, R&D scientists, operators, technicians and skilled workers in chip design and semiconductor fabrication, packaging and sales facilities over the next five year "Around 30 per cent of the new global capability centres established in India during the December quarter of last year were in the semiconductor space, indicating a growing interest in leveraging the local talent pool in areas such as front-end design, performance testing and post-silicon validation", according to the National Association of Software and Service Companies (Nasscom) and Zinnov latest report. The world's leading chip design companies, including Intel, Texas Instruments, AMD, Nvidia and Qualcomm, have design and R&D centres in India. AMD recently inaugurated its largest global design centre in Bengaluru. In March, an event- 'India's Techade: Chips for Viksit Bharat, witnessed the foundation stone of three semiconductor projects worth Rs 1.25 lakh crore.

Tata Electronics in partnership with Taiwan's Power Chip Semiconductor Manufacturing Corporation (PSMC), set up the country's first semiconductor fab plant in Dholera (Gujrat) with an investment of Rs 91,000 crore and another plant in Morigaon(Assam) with investment of Rs 27,000 crore, with the first chips to

begin coming off the production line in 2026. US-based semiconductor manufacturer Micron India plant with an investment of Rs 22,500 crore in Sanand(Gujarat), is expected to roll out the first "Made in India" memory chips by December. It is contributing its bit to the Chandrayaan-3 mission Semiconductor Corporation of India(SCL) proposed to update and expand its chip facility in the Mohali plant with an investment of INDIA'S Rs 20,000 crore, to enhance its contribution to ISRO and other space research organisations globally.

95 Percent Import Dependency:

Despite the upward trajectory of VALUED AT AN India's current semiconductor chip ecosystem, the country remains dependent on the US, Taiwan, China, Japan, Malaysia, Singapore and South Korea, with over 95 per IS EXPECTED TO cent of semiconductors imported from these countries

To reduce this dependency on imports, India recognised the strategic importance of a robust domestic semiconductor industry. It unveiled the India Semiconductor Mission (ISM) offering 50 per cent capital expenditure support to new entrants, production-linked incentive (PLI) and design-linked incentive (DLI) schemes with an outlay of Rs 76,000 crore, as well as state Government incentive support, international partnerships and a focus on talent development. The Electronic and IT Ministry plans to train over 85,000 engineers in chip design over the next five years to address the skill gap. Such focused efforts aim to steer the ecosystem through nurturing policymaking to develop a self-suffi-

cient ecosystem. Moreover, the geopolitical uncertainties involving the China-US trade war have compelled companies to seek alternative production bases or sourcing locations outside

China. Amid this relocation in the industry, India and Southeast Asian nations like Malaysia, Singapore, Thailand, Vietnam and Indonesia have been preferred for front-end manufacturing in the future. We expect many of them to come back to participate in India's high-tech manufacturing revolution".

Road Ahead: The future of the semiconductor industry in India holds immense promise. It will play a crucial role in shaping the counape, driving economic growth and positioning India as a global leader in innovation. The semiconductor industry will also generate opportunities for an entrant and Indian talent working in this sector globally, many of whom wish to return to their roots.

India's ambition to become a selfreliant and dominant player in the semiconductor industry is clear. With the talent, resources and infrastructure in place, India is poised to make significant strides in the semiconductor sector and establish itself as a global leader in the years to come.

# Driving innovation: Role of intellectual property in India

India can emulate Japan's post-Meiji transformation by harnessing innovation, embracing change and cultivating a risk-taking culture

n the 76th Independence Day speech on August 15, 2022, the Prime Minister called for innovation with a focus on indigenous innovations highlighting "Jai Anusandhan". Innovation is the key to India realising a self-reliant, competitive and USD 30 trillion economy by 2047. Innovation has the potential to unlock major productivity gains and will allow the nation to leapfrog towards higher value-added products and

services across sectors. In the last few years, globally we have witnessed a fundamental and rapid shift from a knowledge economy to an era of artificial intelligence (AI) and virtuality. During the same time, the unprecedented nature and ferent approach to innovation

scale of the pandemic affirmed the importance of having an innovation ecosystem for finding new cures – vaccines, medicines and diagnostics.

For a country with a legacy of scientific and technical knowledge base, the private sector in India has previously made modest investments in research and development (R&D). India has taken a difto meet its unique challenges. The transformational digital public infrastructure, starting with the Aadhar platform, is a case in point.

"Gold prices continued to weaken... as this sell-off was attributed to the anticipation of a hawkish stance from the US Federal Reserve in the upcoming interest rate policy announcement scheduled for May 1.



#### **GMR Airports Infra to buy stake in WAISL for Rs 57 crore**

MR Airports Infrastructure on Tuesday announced acquiring an 8.4 per cent stake in WAISL, which provides digital infrastructure services at airports, as the company looks to strengthen its presence in airport-related businesses. The company has entered into an agreement to buy 4,60,000 shares or an 8.4 per cent stake of WAISL from Utthishta Virat Fund for Rs 56.66 crore, according to a regulatory filing on Tuesday. Incorporated in 2009, WAISL is into the business of delivering digital infrastructure at airports and operates as an exclusive partner for IT services at airports. In the filing, GMR Airports Infrastructure said it has been "exploring opportunities of investing in entities engaged in airport adjacencies/ airport related businesses etc. to strengthen its

presence in all aspects of airport related / airport adjacent businesses". GMR Airports Infrastructure operates through GMR Airports Ltd (GAL), which operates various airports, including at Delhi, Hyderabad, Goa and the Philippines. Shares of the company declined 2.75 per cent to Rs 85.19 apiece in late afternoon trade on the BSE.



#### **UCO Bank aims to bring down govt** stake to 75 per cent: MD

CO Bank on Tuesday said it aims to reduce the government's stake in the bank from the current 95.39% to 75% in several tranches by fiscal 2024-25, to comply with the minimum public shareholding norms set by SEBI. The lender has time until August to comply with this but it hopes to receive a further extension, a top bank official said. Four other public sector banks have also laid out plans to pare down government holdings to meet SEBI regulations. "We don't need equity for growth as our capital adequacy is at 16.98%. However, we must reduce the government's stake to 75% to meet listing regulations, and we aim to do so within this fiscal year. The board has approved the issuance of 400 crore equity shares for this purpose. We will execute this in tranches," said UCO Bank MD & CEO Aswani Kumar. He said various options will be explored as issuance plans get firmer. "To comply, the issuance of 330-340 crore equity shares at Rs 10 each would have been sufficient, but we have allowed some additional headroom," he said at a post-earnings

interaction. Speaking about the credit growth outlook, Kumar mentioned that the bank is targeting a growth of 12-14%, and corporate lending is expected to remain robust with a growth target of 3-4%

# Aluminum industry requires additional Rs 2.2 L cr

PNS NEW DELHI

The Indian aluminium industry would require an additional capital expenditure of nearly Rs 2.2 lakh crore (USD 29 billion) to achieve net-zero carbon emission, according to a new study.

The study by independent think-tank Council on Energy, Environment, and Water (CEEW) said renewable energy power sources could abate 49 per cent of the total emissions from the industry.

However, fully switching to renewable energy is not feasi-



ble right now because it is not always available. So a backup plan is needed, it added.

India has committed to achieving net-zero emissions (a

gases emitted and removed from the atmosphere) by 2070 and 50 per cent cumulative electric power installed capacity from non-fossil fuel-based balance between greenhouse energy resources by 2030.

Aluminum is widely used, especially in the power sector, and it is one of India's fastestgrowing industries. But achieving net-zero emissions could make it 61 per cent more expensive, with a yearly operational cost of about Rs 26,049 crore (USD 3.5 billion).

Even though India does not use a lot of aluminum per person (2.5 kilogrammes) compared to the global average (11 kilogrammes), the industry emitted a whopping 77 million tonnes of CO2 in 2019-20. Most of this comes

from electricity used by the

The study suggests that improving energy efficiency in aluminum production and using waste heat recovery can help cut emissions without making aluminum more expensive. However, most other ways to cut emissions, like using more renewable energy or capturing carbon, will make aluminum produc-

tion more costly. CEEW also launched a study on what it would take for the fertiliser industry to achieve net-zero emissions.

# 'NH construction to decline by 7-10 pc to 31 km/day'



DC co-head. The director was even dubbed a liar by some.







# Jamming through jazz-laced rhythms and tunes

had an exclusive interview with Indian Ocean, a rock band that was founded in 1990 and is largely credited with starting the fusion rock movement in our nation. Before Asheem Chakravarty passed away on December 25, 2009, the band's members included Susmit Sen, Rahul Ram, Amit Kilam, and Himanshu Joshi. Tuheen Chakravorty and Joshi were formally admitted into the band as Chakravarty's heirs. Rahul Ram is the only original member who was featured on the band's debut album, Indian Ocean, since Susmit Sen left in 2013!

Fusion has advanced significantly, as the band members asserted in a recent interview with *The Pioneer*. "People are singing and performing linguistic fusion with confidence these days. Agam is a fantastic band that performs fusion Carnatic music. Bollywood is now incorporating fusion rock into some of its films, which is a big thing. We have performed fusion rock in a few movies." Jazz fusion is the most appropriate genre to describe the band's sound.

But, we were told, "We really don't set out to do some specific instruments. We get together and jam, and the various genres of music we grew up with have become a part of who we are. Additionally, as the band has developed over time, new members have added character-

istics of their own. For instance, Himanshu is well-versed in ancient Punjabi and Uttrakhandi folklore, as well as Ghazal and Urdu poetry. Former heavy metal guitarist Nitin Rao is now interested in jazz and carnatic music. You will have to sit with us and experience the music for yourself to gain any further insight into how we truly came up with it."

The band has been defying record labels' policies since 2010. Their most recent album, 16/330 Khajoor Road, was made available for free online. This decision was mostly motivated by unhappiness with contract negotiations with record labels and legal disputes around copyright! The band members don't seem to be phased, though, and go on, "We didn't want to engage with music companies because of how terrible their con-

tracts operate. We therefore made the decision to record the music ourselves and only grant them distribution rights following Black Friday. These businesses are no longer relevant; their primary role now is to distribute your music across several channels. However, other factions have taken control of even that. Since music firms have been exploiting musicians for so long, it's about time they realise that's not the way to make money, so it's not a bad thing that they are slowly but surely becoming obsolete."

Instead of playing to record labels, they are now making money through concerts and sponsorships. Johnnie Walker briefly provided sponsorship for them!

"After Asheem's death and Susmit's retirement, the current line is devoid of any members from the 1990s. In 1991, I became a member. However, Nikhil Rao has had a fantastic impact. He is humorous and full of life, but more significantly, he is interested in a wide range of genres, which has greatly increased the band's diversity. In terms of both creativity and interpersonal dynamics, the band is in fantastic shape. The solos are incredible. Ultimately, Susmit's leaving is beneficial for both him and the band," said band member Rahul Ram.

As one of the five featured artists, they are also members of the world's first music personalisation initiative, called *DRP*. "Every song, with the exception of the title tune, revolves around the environmental problem. Iadu Mava and Iss Tan Dhan's music, for example, speaks to resisting materialism. A major element of revolution or protest music is there aside from that. Actually, Asheem contributed to a few of the tracks on 16/330. And the incomplete work we made with Asheem is the second CD of 16/330, which most people have never heard of. Asheem had left by the time it was released, but he was still very much a part of it. After Asheem and Susmit parted ways, the album *Tandanu* was released. We had moved on at that point, and a lot of time had passed. We speak lovingly and affectionately about Asheem and miss him every single day. We tell everyone about him, and we cherish our memories of him. We were fortunate to have spent nearly two decades with him."

Sen's father proposed the name Indian Ocean back in 1990. As the new drummer, Shaleen Sharma was joined by bassists Anirban Roy and Indrajit Dutta. Sen sold his electric guitar to help the band acquire the necessary funds, and together they recorded a demo. The seven tracks on the 45-minute recording were all recorded in a single day. The demo tape was recorded in a hurry, but its quality pleased HMV, and they were offered an album deal. It has been a major pleasure working with lyricist Sanjeev Sharma for the whole band. Could you give more details on the band's collaborations with the lyricist? Well, one of the team members says, "It was at a music rehearsal for a play that we truly first got together. He told us, when we sat down with him, that lyrics are not poetry, and it's true that he's created so many lovely songs for us. Every

chance we have, we attempt to collaborate with him. We begin with the music and then turn it over to the lyricist after providing a quick synopsis of the song. The song came together over a few conversations and idea sharing. The focus is on giving the lyrics significance, as evidenced by other Indian Ocean tunes."

A song's creation for *Masaan*, starring Vicky Kaushal, involved the input of multiple parties, including the director, producer, and lyricist he chose. In addition, there are time constraints, such as the length of songs for motion pictures, which place a strong emphasis on the words and less emphasis on the music, which is typically the focus of the Indian Ocean. But in spite of all of these difficulties and limitations, they managed to produce a respectable quantity of work that is really engaging!

"That was the difference. The

"Rana committed a Level 1

accepted the Match Referee's sanction. For Level 1 breaches of the Code of Conduct, the Match Referee's decision is final and binding," the IPL said in a statement.

"The player was earlier penalised under the same level and article of the IPL Code of Conduct," it added.
