# EC did not release controversial video: CEO

Meena stresses stepping up of security at strongrooms

PNS VIJAYAWADA

Chief Electoral Officer (CEO) Mukesh Kumar Meena has disclosed that eight police teams, comprising Superintendents of Police (SP) and Deputy Superintendents of Police (DSP), are actively pursuing the arrest of YSRCP Macherla MLA candidate and incumbent MLA Pinnelli Ramakrishna Reddy. This development comes in the wake of a video surfacing depicting Reddy purportedly vandalising an Electronic Voting Machine (EVM) at the Palvai Gate polling station.

Meena clarified that while the video footage did not officially leave the custody of the Election Commission (EĆ), it may have been leaked during the investigative process. Furthermore, the Presiding Officer (PO) and Assistant Presiding Officer (APO) on duty were suspended for failing to furnish accurate information regarding the EVM damage incident.

Speaking at a press briefing on Thursday, Meena underscored the EC's commitment to expeditiously apprehending Ramakrishna Reddy. He cautioned leaders of the Telugu Desam Party (TDP) against visiting injured activists in the Macherla constituency, urging them to refrain from exacerbating tensions as the situation gradually stabilises. Meena also announced plans for a state visit on May 25 to personally inspect the strong rooms where EVMs are securely stored.

# HC grants interim bail to Pinnelli till June 5

PNS VIJAYAWADA

In a temporary relief to YSRCP MLA from Macherla, Ramakrishna Reddy, the AP High Court granted him interim bail. The court stipulated conditions for the bail, ensuring that no legal action could be taken against Pinnelli until June 5, 10 am. The case is adjourned to June 6.

On Thursday, Pinnelli Ramakrishna Reddy approached the AP High Court seeking antic-ipatory bail. A motion petition was swiftly filed by the MLA, leading

to the court's decision to grant bail.

The hearing on the anticipatory bail petition of Macherla MLA Pinnelli Ramakrishna Reddy was conducted by the AP High Court. Advocate Niranjan Reddy, representing MLA Pinnelli, argued that if the alleged incident indeed occurred on May 13, an FIR would have been lodged by May 15.

Reddy contested the Election Commission's actions triggered by a video released by opposition leader Nara Lokesh on Twitter, pointing out that the FIR mentioned unidentified individuals. Questioning the authenticity of

the Twitter video, Reddy suggest-

ed it might have been doctored. Emphasizing the severity of the charges, Reddy cited guidelines from the Supreme Court's Arnesh Kumar case, noting that in cases carrying sentences of up to seven years, 41A notices should be served.

The Election Commission's counsel requested time to prepare a counter. Justice Jyotirmayi, presiding over the single bench, temporarily postponed proceedings due to an ongoing inquiry in another court. Subsequently, arguments were presented on behalf of the police, leading to Justice Jyotirmayi granting conditional bail to MLA Pinnelli Ramakrishna Reddy until June 5th.

# Thunderstorms forecast in AP

The India Meteorological Department (IMD) on Thursday forecast thunderstorms accompanied by lightning and gusty winds in parts of Andhra Pradesh for five days between May 23 and 27.

Rainfall is likely in parts of North Coastal Andhra Pradesh (NCAP), Yanam, South Coastal Andhra Pradesh (SCAP) and Rayalaseema, while heavy rains are predicted in some places in NCAP on Friday.

Additionally, they have formally petitioned for the filing of cases and legal proceedings against individuals implicated in unlawful

# CLAP workers face hardship due to unpaid wages

PNS VISAKHAPATNAM

garbage using Clean Andhra Pradesh (CLAP) vehicles have faced severe financial hardship due to unpaid wages. Despite numerous complaints, neither the contractor nor the Greater Visakhapatnam Municipal Corporation (GVMC) officials have taken steps to address the issue.

The GVMC allocated a total of 650 CLAP vehicles, one for each secretariat, to handle household garbage collection. Each vehicle, complete with a driver, is provided by a contractor at a monthly cost of Rs 65,000. Additionally, the public health department officials of GVMC hired outsourced sanitation workers to accompany these vehicles and collect garbage door-to-door. Initially, two loaders were assigned per vehicle, but due to a shortage loaders were reassigned, and 650 daily wage workers were recruited to fill the gap.

A tender was issued for supplying these workers at a rate of Rs 450 per day, and the contractor who won the tender provided the workers to GVMC less than three months ago. These workers diligently go door-to-door collecting garbage. However, they have

not been paid for their work since they started. The workers, when inquiring with GVMC officials, were informed that the contractor had not yet submitted a bill. Despite the GVMC billing issue, the contractor is responsible for paying the workers at the end of each month and then claiming reimbursement from GVMC. However, the contractor has refused to pay processes the bill, leaving the workers in financial distress and unable to support their families.

It has come to light that workers performing these daily wage jobs had to pay up to Rs. 50,000 to the contractors and middlemen. The workers were promised that their positions would eventually become permanent, prompting them to

April 30. On April 16, security forces had gunned down 29 Naxalites during an exchange of fire in Kanker district, according to

police. On May 10, they said, 12 Naxalites were eliminated in a gunbattle with security personnel near Pidia village in

Bijapur district. However, local villagers and activists had claimed that those killed near Pidia were not Naxalites and that the encounter was staged.



On Wednesday, they inspected the Medigadda and Annaram barrages of the Kaleshwaram Lift Irrigation Project (KLIP) in Jayashankar Bhupalpally district. The NDSA had suggested certain steps before the rainy season to maintain the status quo at the distressed barrages.

# Tribal development scheme faces setback due to official negligence

A central government scheme aimed at promoting tribal economic development has hit a roadblock in Visakhapatnam due to alleged official negligence. The Vana Bandhu Kalyana Yojana, launched to provide infrastructure and support selfemployment in tribal areas, saw a project in G. Madugula mandal failing to take off.

A floriculture unit built in Kullupadu village for Rs 43 lakh lies defunct, raising concerns about the utilization of funds allocated for tribal development. The central government had earmarked special funds under the Vana Bandhu Kalyana Yojana for Visakhapatnam's G. Madugula mandal, known for its low literacy rates. In 2016, Rs. 10 crores was released to establish a floriculture unit aimed at empowering tribal women with self-employment opportunities. The project involved conoffice for the unit, and a storage building. Plants were procured from Bangalore, and tribal women from Vanjangi Panchayat in Kullupadu village received training in flower cultivation. However, despite the initial investment and infrastructure setup, the project failed due to a lack of follow-through from the Integrated Tribal Development Agency (ITDA) officials. The officials, entrusted with ensuring the project's success and the women's self-sufficiency, allegedly abandoned the initiative after the initial setup.

The negligence resulted in complete loss of the Rs. 43 lakh investment. The plants have withered, the poly houses have deteriorated, and the constructed buildings stand unused. Local tribal communities are disheartened by the squandered resources and blame the ITDA officials for their apathy and mismanage-

# Sedentary lifestyle leading to diabetes in mega cities: Doc

**MOHAMMED BALEEGH** HYDERABAD

In all, 75% of people in nation's mega cities today suffer from diabetes due to sedentary lifestyle, said Doctor Viswanathan Mohan, a diabetes specialist.

Speaking of the trends in diabetes and the reason for the high number of diabetic patients in India despite advancements in science. Dr Mohan said, "It (Diabetes) is only 2 % of urban Indians and 1 % of rural Indians suffered from diabetes. Till India opened its economy in 1991 there was a single digit rise in diabetic patients. The moment the economy opened up, prosperity and affluence began. Before this, malnutrition was prevalent in pockets of India. Then the economy started booming due to the IT industry's gradual rise. As people started affording better, diabetes rates shot up due to mechanisation, greater income and the rise in obesity due to reduced physical activity," he added.

According to an ICMR study in 2023, in some states, the whole state recorded 26% of adults suffering from diabetes, which is 1 in 4 people above 20 years. 40% of people above 50



years in cities like Hyderabad, Chennai, Delhi, Mumbai, Kolkata and Bengaluru have diabetes. Another 35 % of people in these cities suffer from traces of diabetes. Moreover, 3 out of 4 persons irrespective of socioeconomic backgrounds suffer from diabetes and 101 million people in India have confirmed diabetes while 136 million are at the pre-diabetes stage.

Speaking of symptoms and precautions against diabetes, Dr Mohan said,"Diabetes is largely an asymptomatic disorder; if 100 million in India are diabetic, 50 million of them may not even be aware that they have diabetes. If people wait for symptoms to get tested, they are not acute in chronic diseases like diabetes. Hence, they are at high risk. The symptoms include excessive thirst, urination, feeling tired, loss of white itching in the genital region in both men and women, numbness in the feet, blurring of vision and wounds that don't heal. These symptoms are detected very late. The only way is to keep screening people reg-ularly. A free blood test camp will be conducted in Hyderabad on Saturday.'

With regards to children being vulnerable to diabetes, the doctor said, "Now, youngsters below 20 years are also affected by diabetes. Modification of lifestyle can help postpone the disease. However, most people aren't aware of this.'

The Election Commission on Wednesday told the Supreme Court that "indiscriminate disclosure" of polling stationwise voter turnout data and posting it on website will cause chaos in the election machinery which is already in motion for the ongoing Lok Sabha elections.

The poll panel said that public posting of Form 17C - which gives the number of votes polled in a polling station - is not provided in the statutory framework and could lead to mischief and vitiation of the entire electoral space as it increases the possibility of the images being morphed.

#### Phase 5 turnout now at 62.2%; women outnumber men in casting vote

he voter turnout in the fifth phase of Lok Sabha polls held on May 20 has now climbed to 62.2 per cent, the Election Commission said on Thursday with women outnumbering men. According to an EC statement, 61.48 per cent of the registered male voters turned up at the polling stations as compared to 63 per cent of female electors. In phase 5, 49 seats across six states and two union territories went for polling where over 8.95 crore people, including 4.69 crore men, 4.26 crore women and 5409 third gender were eligible to vote. The participation of women in voting was higher as compared to men in Bihar, Jharkhand, Ladakh, Odisha and

The male-female turnout gap was wide in Bihar and Jharkhand. While in Bihar, the male turnout was 52.42 per cent, the female turnout was 61.58 per cent. Similarly, in Jharkhand, the male turnout was registered at 58.08 per cent, while the female turnout was 68.65 per cent. A maximum of 38.22 per cent of voters registered in the third gender category turned out to vote in West Bengal EC noted that repolls at two polling stations in the Kandhamal in Odisha will be concluded on Thursday and the figures "may change accordingly, once the data is updated for post-repoll. In the corresponding phase in the 2019 polls, the turnout was registered at 64.16 per cent.

#### **NORTH BLOCK BOMB HOAX**

#### Delhi Police writes to Google, seeks IP address details

A day after the North Block received a hoax bomb threat email, the Delhi Police on Thursday wrote to Google seeking details of its IP address, an official source

said. The Internet Protocol (IP) address is a unique identifying number assigned to every device connected to the inter-

bomb threat on Wednesday sent alarm bells ringing in the North Block, which houses the office of the Ministry of Home Affairs (MHA), but was declared a hoax after nothing suspi-

cious was found. A letter has been sent to Google to provide the IP address of the email which was sent to the MHA office, an official source said.

The Delhi Police Special Cell and the local police are investigating the case. A case may be registered at Kartavya Path police station for further investigation, an officer said.

# 'Early brain network differences in infants with autism-risk'

Six-week old infants with high chances of developing autism showed distinct patterns in brain connections, which researchers said likely emerge much earlier than autism-related behaviours can be noticed.

The researchers focussed on the brain's salience network, a group of regions crucial to identifying information in the environment that is worthy of one's attention and enabling

appropriate responses to them. In babies with high chances of developing autism -- a disorder marked by repetitive behaviour and impaired social interaction -- the researchers found stronger connections between the salience network and brain regions processing sensory information and movement, or the sensorimotor regions.

The team, co-led by the researchers at the University of California Los Angeles (UCLA), US, further found that infants with stronger connections to sensorimotor regions in the brain had weaker connections with prefrontal ones, which are important for social interactions.

This suggested that paying more attention to basic sensory information comes at the cost of paying attention to socially relevant cues, thereby possibly playing a role in people with autism displaying an impaired social behaviour, the



researchers said.

"An emerging theory in autism research is that differences in sensory processing may precede the more classic social and communication symptoms of autism, and this data supports that theory in showing that very early brain differences related to how attention is allocated may predict both sensory and social behaviours in toddlers." Shulamite Green, an assistant professor at UCLA, said.

"In other words, more attention to extraneous sensory stimuli in the environment could make it difficult to attend to social cues, and this difference in attention could really affect how the brain develops

across the first year of life and beyond," Green, corresponding author of the study published journal Communications Biology, said.

The researchers also found that the brain patterns observed in six-week-old babies could predict their

behaviour at age one.
Infants with stronger connections with sensory regions were found to show "overresponsivity" when they were a year old, a trait known to be characteristic of autism in which individuals show extreme responses to typical environmental sounds or sen-

In contrast, the researchers found that babies having stronger connections with pre-

frontal regions in the brain showed a better ability to share attention with others at age one, an important stage preceding the development of social and communication skills that are often impaired in autism.

The observed patterns could help explain the reduced social attention and unusual sensory processing commonly seen in people with autism, the authors

For the study, the researchers analysed 53 infants, 24 of whom had a higher likelihood of developing autism because at least one older sibling had a diagnosis -- a factor known to enhance the risk of autism. The remaining 29 had no family history of autism or any other developmental disorder.

# **EC** stirs a bit

The poll panel's latest directive to parties for a honest fight is a classic case of too little, too late

ith the Lok Sabha elections approaching the final phases, the Election Commission (EC) has issued a stern directive to the Congress and the BJP against creating false narratives and making communal utterances. Interestingly, this directive comes after five of the seven poll phases are over. Also, the timing and impact of this intervention raise critical questions: Is the EC's directive aimed more at ensuring a free and fair election or at salvaging its image which has taken a dip? Though it is an independent, autonomous constitutional body, several events have raised doubts about its impartiality and functioning. There have been accusations of Government interference, from influencing the timing of elections to being lenient towards the BJP while being overly strict with the Opposition. Savour this: Since 2019, three Opposition parties registered 27 complaints against PM Modi but the EC took no action. A scrutiny of these complaints and the EC's response shows the poll body's 'reluctance' to act against



the Prime Minister. The Congress has accused the panel of being "super, super cautious" regarding plaints against Modi, following the EC's request to the BJP to respond to the allegations of Modi's divisive speech in Rajasthan. The EC also asked the Congress to address the BJP's complaints against Mallikarjun Kharge and Rahul Gandhi. The EC's letters mark the first such action against a Prime Minister. But will any real action ever be taken?

According to the poll panel, approximately 425 major complaints, excluding those related to canvassing or requiring clarification, have been filed by various parties and candidates. Action has been taken or the mat-

ter resolved in 400 of these cases. Interestingly, in most cases, the punishment was so mild that it did not matter much; like abstaining from campaigning for two days, and so on. Now, with only two phases of polling left, the directive is not likely to achieve much since the electoral narrative has already been set, with party rhetoric having saturated media channels and influenced public opinion. The late issuance of this warning suggests only an attempt to curb last-minute escalations in divisive rhetoric. By waiting until the tail end of the election cycle, the EC has allowed political parties ample time to embed their narratives into the electorate's psyche, with an extra long rope for the ruling party. Besides, for such a warning to be effective, it needs to be backed by the possibility of tangible consequences. While the directive emphasises the need for a respectful and fact-based campaign, it lacks clear punitive measures for violations. Political parties might calculate that the benefits of inflammatory and polarising rhetoric outweigh the potential repercussions. To ensure future elections are fairer and more respectful of democratic principles, the EC should adopt a more proactive stance involving faster interventions and stricter penalties for violations. It can draw inspiration from its own history when TN Seshan first empowered the institution.



# Child development as a fundamental right



In the pursuit of a more equitable society, the universalisation of early childhood development should be recognised as a fundamental right, not a gratuitous freebie

hat early childhood development (ECD) should be treated as a fundamental right rather than a gratuitous freebie is paramount for fostering an equitable society. The 2024 general elections offer a significant opportunity to advocate for the universalisation of ECD from birth to 18 years. Ensuring access to quality early education and care is crucial for the holistic development of children and the broader advancement of soci-

ECD as a Fundamental Right India's commitment to social welfare is enshrined in its Constitution. The Directive Principles of State Policy mandate the Government to secure adequate means of livelihood, equitable distribution of resources and special protection for children nd vulnerable sections. Early childhood is a critical period for cognitive, emotional and social development. The National ECCE Policy 2013 underscores the importance of providing quality health, nutrition, early learning and protection for children under six. Recognising ECCE as a justiciable entitlement under the RTE Act would ensure that all children receive the foundational support necessary for their development. Challenges in Providing ECD

After 13 years of implementation of the RTE Act 2009, only 25.5 per cent of schools across the country are RTE compliant. 8.4 lakh teacher positions are vacant and there is a constant shift towards contractual teachers. 19 per cent of schools in India are estimated to have teacher vacancies and one school in seven is run by a single teacher. While the quality of education cannot be ensured without professionally qualified and motivated teachers, 44 per cent of all teachers across the country work without job contracts, many fail to receive social security benefits and all are pressured with non-academic worl which is estimated to account for 20-25per cent of teachers' working hours. The average expenditure is 8,997 per annum for preprimary, 9,913 for secondary and 13,845 for higher secondary. Costs are significantly higher in

The promise of crèche for promoting women workers is a welcome in political parties' agendas, however without universalisation and adequate public provisioning of childcare services they may again leave behind the most marginalised children and serve only a selected few. A public manifesto collated by

four national-level networks working for children's rights spotlights the need for reiterating the constitutional provision to ensure rights, entitlements and the overall wellbeing of children. The manifesto calls for extending the Right to Education (RTE) Act to cover children from birth to 18 years, aligning with the internationally recognised definition of childhood. The manifesto further calls for drafting, implementing and enforcing a national regulato-

ry framework for private schools and ECCE centres to combat the increasing commercialisation and privatisation of education. This framework should regulate fees, ensure compliance with quality norms and address social segregation. The Government must take immediate steps to ensure that all private schools adhere to the conditions under which recognition is granted and that no unrecognised schools are allowed to operate.

The State must be held accountable for its enforcement to guarantee that all children receive quality education. Strengthening School Management Committees (SMCs) and community participation in education is vital for the successful execution of policies. educational Additionally, it is critical to strengthen the Anganwadi system. Critical positions such

as AWWs and AWHs must never be left vacant. The capacities of Anganwadi centres and workers should also be enhanced.

Way Ahead

Investing in ECD has significant long-term benefits. Studies indicate that quality early childhood programs yield a high return on investment, contributing to better health, education and economic outcomes. Children who receive adequate early care and education are more likely to succeed in school, secure better jobs and contribute positively to society. Therefore, ECD should be

recognised as a fundamental right, not a discretionary freebie. Its universalisation must be backed by adequate funding and robust policies, to ensu equitable access to marginalised children. There is a clear roadmap for achieving this goal.

## **NEW CHALLENGES FOR INDIA'S FOREIGN POLICY**

The global geopolitical landscape grows more complex with Russia-China ties

he gruelling Indian elections, one of the largest democratic exercises in the world will be over in a week or so. A hectic flurry of pending policy decisions is likely to start immediately. If the current party comes back, a hundred days action-packed agenda would be rolled out by most major Government departments, going by PM Modi's Stated objective of not wasting a minute after polls are over. However, the geo-political space, which existed when the elections were declared, has become far more complex refusing to wind down any time

To be fair some of the changes are driven by elections happening all across the globe during 2024, including in key European Union and US. This will ensure that almost all multilateral forums, where these key constituents and India are major contributors, would be subject to pressures of domestic politics and issues. Meanwhile, India's long-standing partner Russia, finished their election nearly a month back and upon reelection President Putin undertook his first State visit to China last week. Russia and China have emerged as the key UN Security Council permanent members, whose interests and policies are not likely to align with the US-led block any time soon.

The joint Statement released after President Putin's visit to China highlighted the importance of his visit to China. It was a message to the wider Western block of countries opposed to Russia's invasion of Ukraine, coming at a time when the Chinese president had just come back after meeting every senior leader from the European Union, the French President and reaffirmed firm support from a couple of East European countries. The European Union and recently the US have expressed grave concerns



and taken some tariff measures regarding China's non-competitive trade practices, especially regarding State-subsidised cheap Electric vehicles flooding their markets. Apprehensions have been raised by Indian trade associations that the loss of the lucrative US market for Chinese Electric vehicles could lead to, these automotive products being dumped in India leading to a situation similar to Europe and the US. In this context Russia seems to have come out in full support of the Chinese automotive sector, perhaps also sending a strong message to Europe and the US. In the media Statement released during Mr Putin's State visit to China, he mentioned "Regarding bilateral industrial cooperation, we are pleased to witness the proactive expansion of Chinese automakers and household appliance manufacturers in the Russian market. As discussed during our talks and as the President said, we acknowledge the detrimental effect of any unlawful actions, sanctions, or restrictions. We wholeheartedly embrace collaboration with our Chinese counterparts.."

China has refrained from overtly criticising Russia over its war in Ukraine and has in the past been accused of supplying military equipment stealthily. Even though Ukraine found mention in both Statements by President Putin and President Xi Jinping, it was velvet-gloved, under larger international foreign policy issues and overall commentary on geo-political matters. On foreign policy matters Russian president's Statement read "We are working together to create a fairer and more democratic multipolar world order based on the central role of the UN and its Security Council, international law, cultural and civilizational diversity, as well as a calibrated balance of interests of all members of the international community. We believe that the creation of such alliances is extremely harmful and counterproductive." Reforming multilateral institutions, especially the UN and a permanent membership has been a long-term foreign policy goal for PM Modi. In the wake of geopolitics, the new Government will have its task cut out on foreign policy.

# Elder abuse is far more rampant than assumed



Despite respect for the elderly, many seniors face abuse from family members. This hidden crisis demands urgent action to protect their dignity and wellbeing



he culture in India over the past few decades has significantly transformed. As the 21st century unfolded with developments and advancements in science, technology, communication etc. the values upon which cohesion and amicable environment at family to global level can be built have been hit hard. The world has never been wealthier or possessed greater knowledge and technological prowess than it does today but sadly, inequality, poverty, food insecurity, violence, exploitation and discrimination continue to escalate unchecked. Among the victims of exploitation are the elderly population across the globe. And this issue becomes more worrisome for India where the culture of respect and care for the elderly has always existed and was deeply rooted. Given the cultural norms, the value system of filial piety and residence with the children, more often than not the elders in the family seem protected but on closer and deeper investigation, it is not so. The prevalence of elder abuse and neglect is evolving as a pressing and distressing hidden reality. As the person ages, his or her ability to engage in productive/ remunerative work gradually decreases, further their physical ailments, diseases etc demand care and specific needs to be looked after, this worsens and complicates the problem. As dependency grows and contribution declines, the elders in the family become subject to abuse, isolation, neglect, humiliation and harassment. The increased rate of urbanisation, transborder migration, inflation, technological advancement and the scale and extent of dependency add to the vulnerability of the elderly being exploited and neglected. In most cases, the perpetrators of abuse-physical, psychological, financial and verbal are their children whom they have raised by sacrificing their comforts and basic needs. According to the United Nations policy brief titled The Impact-of-COVID-19-on-Older-Persons (2020), the cases of elder abuse have grown worldwide during and after the pandemic, making it a worrisome issue. Life expectancy and life longevity have enor-

mously improved, given the advancements in diagnostic, medical and therapeutic science but for the ageing population support

services from family, community and the Government are also cru-cially needed for dignified life and death. In the present-day neo-liberal world order, access to State-ofthe-art health and care facilities burns a big hole in the pocket of those wanting to access them. In addition, inflation, job crunch, financial crisis and the burgeoning household budget for education, basic needs, recreational, health care services etc are largely responsible for the elders and their needs being pushed to the periphery. Lack of timely care and preventive measures compounds their problem and vulnerability to the extent of extreme dependency. The State of complete/ partial dependency makes them subject to neglect, harassment and humiliation, abrogating their human rights. With intra and transborder migration of PRESSING AND young and productive age groups, he threat to survival. well-being of the ageing population is rising across the globe including India. In the past few decades, the migration from rural to urban areas and from urban to distant lands has been considerably growing, the dearth of resources, harsh iving conditions and tough competition faced by the young population a reason although indirect, for elder abuse and in absence of dear ones (son/grandchildren), adjustment to new settings also drains the elder population mentally, financial-

ly and emotionally and risks their wellbeing and safety. Further, as senior citizens are seen as a liability, apart from the conflict over their care and responsibility, the conflict over inheritance and property share also traumatises them. It is estimated that more than 90 per cent of elder abuse cases emerge from property-related matters. Thus physical, verbal, sexual, mental and

emotional abuse can occur within

these dynamics, causing immense

suffering to the elderly. The sadden-

ing part about elder abuse is that the perpetrators of violence and hardship against them are their family members, it could be their son/ daughter-in-law/ daughter/ son-in-law/niece/nephew/ grandchildren among other close relatives as a result of the instances of violence either don't come in the public domain or if at all it comes, it isn't given attention stating that it is a personal/family matter. Due to a lack of intervention, the concerns of the elderly being abused and harassed most often go unattended and cared for.

In most cases the abuse is subtle and  $% \left\{ 1,2,\ldots ,n\right\}$ persistent, so is perceived as normalised by victims and is difficult to label as abuse, however, badly harms the victims and their wellbeing. In some cases, senior citizens suffering from dementia or other cognitive impairments are unable to understand that they are being illtreated and abused or at time find it difficult to effectively communicate the reality and seek intervention. The absence of timely and appropriate intervention discourages the victims from reporting their abuse. It is also out of fear of offending the family members/ agonising them that the victims are reluctant to report or discuss the instances of violence and humiliation meted out by them. There is also a stigma around abuse and the concern that society may perceive them to be weak/incapable and also that it might bring the family in a bad light is a reason that discourages senior citizens from speaking about their vulnerability and abuse. Moreover, the elderly either don't have awareness about the legal mechanism that they can take recourse to or do not have trust in the system and the law designed to protect them.

As most cases remain unreported, the exact figures associated with violence against elder persons cannot be provided. This however can-

not be taken as a reason to escape and deny the grim reality. The issue indeed is important and the laws enacted in the recent past to save the elders from abuse and violence, the growing number of old age homes and the increase in property-related disputes where the elders in the family are either as plaintiff or the defendant are a testimony. Globally, a very good proportion of the population is growing older, India mirrors this trend too. According to the United Nations Population Fund's India Ageing Report 2023, the population above 60 years will double from 10.5 per cent or 14.9 crore (as of July 2022) to 20.8 per cent or 34.7 crore by 2050. There is a dire need to understand that this population is neither small nor are their issues insignificant that can be ignored. It is important to understand that the elderly population which isn't engaged in productive work were once the ones who shouldered responsibilities and looked after the needs of the children. They had been once a very potential workforce in nation-building. They are a reservoir of knowledge and experience and should be valued for their sacrifices, pains and contributions made during their lifetime. As reasons are multiple behind elder abuse so are the ramifications, it is therefore important to have solutions at different levels ranging from sensitising the society at large to spreading awareness among elders, formulating policies, emboldening social security measures to robust monitoring and judicial mechanism to deal with the perpetrators of violence. Concrete measures need to be taken so that elder abuse, albeit hidden, is not perceived as normalised.

There is a concerning pattern of political leaders forsaking their party affiliations in pursuit of personal gain, but voters are giving them a run for their money

Presently, its political landscape appears adrift and devoid of purpose. Those in positions of authority seem driven solely by personal gratification. Both ruling and opposition parties fervently urge the public to cast their votes in their favour. As the electoral process unfolds, leaders umph or defeat, often shift-

# NSE listed companies' market capitalisation surpasses US\$ 5 trillion

The market capitalisation of listed companies on the NSE surpassed US\$ 5 trillion (Rs 416.57 trillion) on Thursday on a day when the Nifty 50 index touched an all-time high of 22,993.60. The Nifty 500 index also touched an all-time high of

21,505.25 on Thursday indicating that growth in the equity market is not restricted to only the large capitalised stocks, a statement by NSE said. The journey of market capitalisation of listed companies from US\$ 2 trillion (July 2017) to US\$ 3 trillion (May 2021) took about 46 months, US\$ 3 trillion to US\$ 4 trillion (December 2023) took about 30 months and the latest US\$ 1 trillion addition took only about 6 months, the exchange said. The top five companies by market capitalisation on the exchange are Reliance Industries, Tata Consultancy Services, HDFC Bank, ICICI Bank and Bharti Airtel.

Growth in market capitalisation is not restricted to the top companies but is observed across stocks, it added. The resource

mobilisation by corporates, including the small and medium enterprises in the primary market, has been encouraging and provided an effective alternative mechanism in addition to the traditional methods of fundraising, the statement said.

Liquidity in the secondary market has also improved significantly in the capital market segment. The equity segment's daily average turnover has increased by over 4.5 times from Rs 17,818 crore in FY15 to Rs 81,721 crore in FY24.

# 'India to get rating support if it uses RBI dividend to reduce fiscal deficit'

PNS NEW DELHI

India can get 'rating support' over time if it utilises the highest-ever dividend of over Rs 2 lakh crore received from the Reserve Bank to reduce fiscal deficit, said an S&P Global Rating analyst on Thursday.

The RBI board has decided to pay a record Rs 2.1 lakh crore dividend to the government for the fiscal ended March 2024, more than double of what was budgeted expectation of Rs 1.02 lakh

"The additional dividends from the RBI are around 0.35 per cent of GDP. Whether it would support the narrowing of the fiscal deficit in fiscal 2024-25 would really depend on the final budget that would be passed after the June election results," S&P Global Ratings Analyst YeeFarn Phua

The interim budget presented in Parliament earlier in the year targets a fiscal deficit of 5.1 per cent of the GDP.

The additional dividend from the RBI may not necessarily lead to a full decrease in the deficit due to potential revenue shortfalls in areas like divestment receipts or additional allocation to expenditures in the final budget, Phua said in an email interview from Singapore

However, "if it does lead to a full decrease of the deficit, we believe it will lead to a faster path of fiscal consolidation that, in turn, will provide rating support over time", Phua added.

The government expects to bring down the fiscal deficit to 5.1 per cent of GDP in the current fiscal, down from 5.8 per cent in 2023-24. As per the fiscal consolidators roadmap, the deficit -- the difference

between government expendi-

ture and revenue -- would be brought down to 4.5 per cent by 2025-26.

In May last year, S&P Global Ratings affirmed India's sovereign rating at 'BBB-' with a stable outlook on growth but flagged weak fiscal performance and low GDP per capita as risks.

'BBB-' is the lowest investment grade rating.

All three global rating agencies -- Fitch, S&P and Moody's -- have the lowest investment grade rating on India with a stable outlook. The ratings are looked at by investors as a barometer of the country's creditworthiness and impact

#### For fleet operators, revenue growth to double

Revenue growth of road transport fleet operators is expected to double to 9-11 per cent this fiscal, riding on better domestic demand amid tepid exports, CRISIL Ratings said on Thursday.

per cent women.
"The sector has a huge socio-

request.
This includes any non-disclosure agree-ments the Maleficent star has signed. The judge has granted Jolie one month to comply with the rul-


ing. A source from Pitt's camp has described the ruling as a "crushing blow" to Jolie, who had previously contended that fulfilling such a request would be "expensive," "wasteful," "unreasonable," and

Jolie's lawyers had continued to indicate that the unveiling of the NDAs infringes on the privacy of other individuals involved.

These data are most likely comprised of important contracts with various Hollywood entities, such as employers, brands, and employees; the contracts may contain "contracts that include Jolie's compensation or compensation she paid to third par-

Now, Jolie's team is scheduled to produce a list of documents they believe are private, allowing Pitt's attorneys to "evaluate the merits of Jolie's assertions of privilege." Earlier this year, the Bullet





We live in an era where there is a strong emphasis on global health awareness campaigns, and Anti-Tobacco Day serves as a timely reminder of the ongoing issues faced by rising tobacco smoking among individuals. While the dangers to respiratory health are well-known, the impact on vital organs like the kidneys remains less discussed yet is equally concerning.

## UNDERSTANDING THE IMPACT OF TOBACCO ON KIDNEY HEALTH

Tobacco is a significant risk factor for chronic kidney disease (CKD). The World Health Organisation (WHO) helps to point out the direct link between smoking and an increased risk of CKD and end-stage renal disease (ESRD). A report by the National Kidney Foundation further reveals that smokers are more susceptible to proteinuria, a sign of potential kidney damage. The relative risk of proteinuria and CKD-ESRD with smoking ranges from 2.0 to 3.2, which is alarming. Further, smoking is not only an independent risk factor but also a risk amplifier for CKD in patients with diabetes and hypertension. Interestingly, cessation of smoking reduces the risk of progression to end stage kidney failure. Thus, raising awareness about this issue is crucial.

# INDIA'S TOBACCO PRODUCTION AND DIVERSIFICATION EFFORTS

In addition to being a major consumer of tobacco, India stands as the second-largest producer globally, manufacturing 761,335 tons. The majority of this production is concentrated in three states, employing nearly 25 million people across the production value chain.

Recognising the health and economic implications, the Indian Ministry of Agriculture, Cooperation, and Farmers Welfare introduced a crop diversification scheme under the Rashtriya Krishi Vikas Yojna program. The government reported a diversion of 67,512 hectares, or 8.7% of designated tobacco-growing land, since 2015–2016. In 2022, India's unmanufactured tobacco production stood at approximately 2 thousand tons, representing 13.4% of the global production of 5.78 million tons. This marks an 11.9% increase from the 690.0 thousand tons produced in 2010. Moreover, India utilised an estimated 3 thousand hectares for tobacco cultivation in 2022, a 4.3% decrease.

#### THE NEED FOR ANTI-TOBACCO

Despite increasing awareness, tobacco-related illnesses, including kidney diseases, continue to rise. A WHO report on the global tobacco epidemic in 2023 exposed the tobacco industry's tactics to undermine smoke-free regulations. From discrediting evidence on

second-hand smoke to promoting Electronic Nicotine Delivery Systems (ENDS) as "clean" alternatives, these tactics demand vigilance from policymakers and the public alike. The industry also influences policy-making through lobbying, aiming to weaken tobacco control measures and undermine existing laws by promoting ENDS (Electronic Nicotine Delivery Systems) through traditional and social media. Regulators must remain vigilant against these tactics to protect public health.

### DRIVING CHANGE THROUGH AWARENESS AND EDUCATION

In the last 15 years, there has been significant progress in implementing smoke-free measures globally. In 2007, only 15 countries were believed to have 100% smoke-free cafés, pubs, and bars, a number that rose to 88. Despite this, these venues remain the least protected under national laws. Meanwhile, 81 countries had smoke-free healthcare facilities, and 78 had smoke-free educational facilities. These numbers increased to 142 and 149 countries, respectively. This significant increase underscores the growing global commitment to creating healthier environments by reducing exposure to second-hand smoke in crucial public spaces.

Sensitisation about the ill effects of smoking in schools and colleges is pivotal. Manufacturers of cigarettes and tobacco products need to be more explicit in displaying the hazards of smoking.

#### **EMBRACING A SMOKE-FREE FUTURE**

There's a growing trend to extend smoke-free laws across various public venues and outdoor spaces globally. We must empower people with information on the ill effects of smoking and the benefits of quitting. Hence, by providing accessible and effective smoking cessation support services such as counselling, medications, and hotlines, one can ensure that these materials are widely available and cheap to all those who want to quit smoking

to quit smoking.

Therefore, it is essential to create a smoke-free world that demands collaborative efforts and robust policies. As we mark Anti-Tobacco Day this year, we can renew our commitment to safeguarding public health and fostering a tobacco-free environment for future generations.

# 'When a woman runs a show, there's a different perspective'

Actress Sai Tamhankar, who has created her niche in the Hindi and Marathi film industries, speaks with *The Pioneer* as she speaks of her much-anticipated *Dabba Cartel* and more insights on her working style.

Sai Tamhankar has been in the film industry for 16 years, yet she is still relatively new to Bollywood. How, you wonder? Well, every time that she's on screen, she certainly brings a new face and new life to every character that she plays. For instance, her upcoming project, *Dabba Cartel*, has been creating quite a buzz ever since its announcement. Her character brings us a never-seen-before avatar of the talented actress.

With the immense anticipation for the series Dabha Cartel, Sai herself has also been very excited. Basically, it was the story that inspired her. And then, of course, she says, "Shibani Dandekar is the showrunner of the show. I think when a woman runs a show, it brings a different perspective, and also, this entire thing is led by women. I really like when women drive something; it becomes multi-dimensional." Dabba Cartel is a riveting tale that propels five ordinary women from their routine existence in a quiet colony of Thane into the murky, unpredictable life of the underworld. A woman-led crime drama is not something that we generally get to see, and that was something that intrigued her pretty much. Sai had also gained much traction for her role as Shama, Kriti Sanon's friend, in the award-winning film Mimi, which was about a surrogate mother. While in the film she played her friend, it was in Anubandh that she herself played the character of a surrogate mother. She feels that it has certainly changed her perspective on motherhood and children over the years. "Earlier, I would love only children who would smile and be happy children, but after doing Anubandh, I started admiring and

appreciating seeing children in a different light. If there is a human unconditional love, it is motherhood. There is nothing else in the world. Mujhe aisa lagta hai ki Maa apne bacche ko pyar karti hai woh unconditional hota hai (I feel that a mother's love for her child is unconditional), and we don't see such unconditional love in human form. I think the human race is very selfish, and we think about ourselves and never think of how challenging it is for the person who is the mother. At some point, they just lose their self-identity and only look after their family. It isn't something forced; it happens naturally. That's something magical."

magical."
She's always been someone who says 'what's next' and does not delve into the glory of time. "I am always curious and want to work; I cannot sit still. If I am sitting at home for more than four days, I get really restless. I love my work from the bottom of my heart, and I am the happiest person when I am on the set. So, sometimes my friends and my loved ones have to make me realise that, Listen, girl, slow down, take a deep breath, let it sink in, appreciate a little how far you have reached."

reached."
In fact, she's someone who is rarely pleased with herself! "These are rare moments, but there are. These moments come once in a blue moon, and I like the fact that it is hard to please myself. It's only about me. Dusro ko appreciate karne ki bari tho fatt se hota hai khud ko appreciate karne mein bahut time lagta hai (Appreciating others happens quickly, but it takes a lot of time to appreciate

yourself), and when that moment comes, it is really satisfying, it is reassuring, and it is self-motivation does not come every day, but when it comes, it's really nice."

She even recalls a time when she literally thought of giving up and leaving everything to pursue her MBA degree. However, her destiny had different plans. And she says it's very important for one to accept their sadness, just as one accepts happiness and explores the different colours

Going ahead, she recalls a time when she was extremely frightened of being typecast. "I was extremely scared after *Hunter* because I was being offered similar kinds of roles. Thankfully, I waited until I got something different than that role, and that was *Love Sonia*. So yes, it's a natural fear, and you should be able to maneuver these things or carve your own paths among these difficulties." As an actor, she's someone who has no fixed process for choosing a project. It could be due to its story, set-up, director being your friend, or a script that is challenging and brings you a different part than the ones played in the past. However, over the years, Sai, who has *Agni, Ground Zero*, an untitled web series on Hotstar, *Dabba Cartel*, and a few Marathi projects, says on a concluding note, "Over the years, what I have realised over time is that it is very important to what phase you are in in your life. Sometimes you choose projects as per your mental space, and what you are going through in life can also sometimes determine the choices."

Also, the experienced duo of Bhuvneshwar Kumar and Cummins have a lot to deal with as the former has been wicket-less in his last two

SRH's problems lie in not having two quality spinners. Mayank Markande is mediocre at best and Shahbaz Ahmed's primary skill is willow-wielding, not bowling slow left-arm orthodox tweakers.
As for RR, the side finally ended its five-game winless streak, thanks to its all-round

show against RCB. In batting, the top-order displayed some positive signs, especially Yashasvi Jaiswal, and he would love to continue the form ahead of the T20 World Cup in the Americas next



month. However, skipper Sanju Samson will have to do better, given that he hasn't crossed the 20-run mark in the last three contests.
In the middle order, Dhruv

While RCB had a brilliant run at the back-end with six straight wins and qualified for the 'Eliminator', the team lost most of its games at the Chinnaswamy with none of the pacers — Mohammed Siraj (ER 9.18), Lockie Ferguson it absolutely. Now there's an (ER 10.62), Yash Dayal (ER extra Indian playing and that's 9.14), Recce Topley (ER 11.200, Karn Sharma (ER 10.58) haven't exactly set the stage on fire.

"You certainly need highly skilful bowlers at (M) Chinnaswamy (Stadium). Simply pace is not going to be the answer there. You need skilful, intelligent bowlers and people that can bowl to really

a good thing for Indian cricket. It has catalysed the batsmen," Flower said.

Even if you took the impact player rule away, I believe batsmen will still retain that very aggressive game that they're playing at the moment because they've proved to themselves that they can play that aggressively and stay in," Flower said.

Dinesh Karthik's international career was a classic case of what could have been after the arrival of Mahendra Singh Dhoni but on Wednesday, when he said goodbye to the game at the end of his team's IPL campaign, it was from a stage he made his own over the past 17 years. The Eliminator between his Royal Challengers Bengaluru and Rajasthan Royals ended up being Karthik's swansong, bringing down curtains on a 20-year-old career marked by a series of comebacks across formats. Twenty six Tests, 94 ODIs and 60 T20s over two decades don't make for eye-popping numbers but the forever fidgety 38-year-old managed to stay relevant till the very end despite spending more time in the commentary box than on the field

over the past couple of years. Ahead of the T20 World Cup squad announcement, Karthik forced himself into the selection debate for the wicket-keeper batter's role with head-turning performances for RCB but that one final comeback wasn't meant to be as selectors rightly went for younger talent.

While he was commentating on the India-England Test series in February-March, Karthik had made up his mind on retirement but the world only got to know when Michael Atherton let it slip in a podcast with the Tamil Nadu stumper.

Having played for as many as six

teams in the IPL since the tournament's inception in 2008, Karthik can be proud of his record in the world's premier T20 league.

He finished as an IPL winner with close to 5000 runs over 17 seasons besides taking 145 catches and effecting 37 stumpings.

He batted at various positions all these years but his days at the RCB as a finisher over the past three seasons stood out.

In a format increasingly ruled by power-hitters, Karthik relied on his experience, game awareness and touch to find the boundaries at will. His 330 runs at a strike rate of 183 in 2022 earned him a recall to the Indian team for the T20 World Cup but that happened to be his last time in national colours.

He scored at an even higher clip this season but despite making himself available for the upcoming World Cup, he deep down knew his comeback saga with Indian cricket had come to an end.

KARTHIK HAD HIS MOMENTS IN STOP-START INDIA CAREER: The Chennai-born cricketer was only 19 when he made his India debut in an ODI against England at Lord's in September 2004.



He announced his arrival on the big stage with a spectacular stumping of opposition skipper Michael Vaughan. Three months later, he made his Test debut against Australia but his international career could never really take off due to middling performances and rise of Dhoni. With Dhoni a certainty in the playing eleven, Karthik was asked to open the batting on the tour of England in 2007 and he made a standout contribution in the team's rare Test series win away

Between 2010 and 2017, Karthik remained sought after in the world of

from home.

IPL but his stock fell sharply in the national team. He got back in the scheme of things

following India's loss to Pakistan in the 2017 Champions Trophy final. Between 2017 and 2019, Karthik regularly played for India in the white-ball formats. His memorable knocks included the iconic last ball six that helped India seal the 2018 Nidahas T20 Trophy in Colombo. Couple of months later, he made a Test comeback after eight years but

that was short-lived. Karthik was seen as a certainty for the 2019 ODI World Cup but by his own

Ashwin has also hailed Rivan Parag's maturity and said the Assam batter has come a long way since making his debut as an 18-year-old in IPL 2019.

"It's important to give batters, especially junior batters, role clarity. Riyan came into the team as a 17-year-old child and he's matured over the years, getting role clarity for the first time this season.

"I never doubted his ability. The shot he hit over the covers tonight, not many batters can hit that. Based on his talent and how his season has gone, I think he can reach wherever he wants to," he

# Avesh Khan Way: Sleep well, eat well and bowl well

Eat, sleep. Bowl and repeat. Avesh Khan has simplified the mantra of success and it is paying dividends as one saw his performances during key games for Rajasthan Royals in this year's IPL.

With 16 wickets from 15 matches, mostly played on flat decks, an economy rate of 9.81 is praiseworthy and his control at the death has made him look a different bowler this time around.

"I have simplified my cricket -I have to sleep (well), I have to eat (well) and I have to bowl (well) and there is nothing else to it," said Avesh, who took a three-for to help Rajasthan Royals reach Qualifier 2 in IPL here on Wednesday.

"The more you would think... cricket is like a circle, the smaller you keep it, the better it will be. You expand this circle more and you will find (more and more) gaps," he added.

"This has changed my life too and also impacted my cricket,"he said. The 27-year-old, who is

among India's reserve players for next month's T20 World Cup in the Caribbean and the USA, on Wednesday revealed that analysing his strengths and weaknesses after a heavy domestic season followed by IPL last year helped him find the better version of himself. 'Last year when I played for LSG, I had played 10 matches of Ranji Trophy wherein I bowled about 320 overs. The body was not responding to the efforts I was putting in," he said.

He also needed to be aware that playing too much can cause wear and tear.

"It happens, sometimes as a bowler you just end up playing so much. Even in the IPL, you may think that it's a four-over game or a 20-over



game but still, there is a lot of effort that goes in. The body starts giving up and there are mental and physical fatigues too," he added.

"Your execution could go off the mark, but if you are mentally and physically fresh vou will be able to execute better. I was not fresh last year so I did not have a successful IPL. I (also) realised later that there is no good in taking so much tension," he added.

Avesh said going back to the drawing board and working with his coach in order to work on his bowling action and setting up right routines for training and recovery have helped him immensely.

"I could not find the answers back then, but after the IPL last year, I analysed that there were some technical changes in my bowling. I worked with my coach Anand Rajan and I did well with him," he said. "I played in the Deodhar Trophy and Duleep Trophy

which was followed by my comeback into the Indian team."

Avesh said leaving LSG for Rajasthan Royals also had specific benefits for him as a bowler.

"I understood my body and

when the trade was made this year, I was also happy because anything can happen to you at any time in IPL," said Avesh. 'The trade was not in my hands, but I took it positively, and Rajasthan's (home) ground is also quite big, the team is also good... as a bowler you need such margins," he said.

While acknowledging that various methods help player develop mental toughness, Avesh said there is no better teacher than going through

the grind regularly.
"I get up only at 2:00pm on match days so there is no time to think that much," Avesh replied when asked what he does to develop mental

"You can do whatever you can to build mental toughness but until vou are not in a position to have faced the challenges repeatedly, you cannot them. overcome acknowledge all that, but

when (as a batter) you need 10-12 runs in an over, you forget everything and focus on execution," he added. The pacer acknowledged RR's

dugout was tense during a close finish against RCB in the Eliminator here but he said the team perhaps remembered head coach Kumar Sangakkara's message before the game.

"The talk was simple — either we would win or go back home. We had to give it our all," he said.


