# 27 killed in Rajkot game zone fire

At least 27 persons, including children, were killed in a massive fire that swept through a game zone teeming with people enjoying a summer vacation outing in Gujarat's Rajkot city on Saturday evening, officials said.

Relief and Rescue operations have been underway at the affected TRP game zone for more than five hours after the blaze erupted at a fibre dome constructed for gaming activities at around 4:30 pm, officials said, adding that the structure collapsed due to the huge fire.

"So far we have confirmed the death of 22 persons in the fire incident. The bodies are completely charred and it is difficult to identify them," said Assistant Commissioner of Police (ACP) Vinayak Patel.

In a landmark move, nearly six lakh Class X students in Andhra Pradesh's state board and CBSE-affiliated state government schools will receive NCERT textbooks for the first time this academic year.

The state's education department has initiated this change as around 1,000 state schools have recently obtained CBSE affiliation. Despite this shift, students from non-CBSE-affiliated schools will continue to take state board exams during the 2024-25 academic year, while those from the newly affiliated schools will appear for CBSE exams.

The distribution of textbooks has already begun, with approximately 4.2 crore textbooks printed for free supply to students across all classes. This substantial effort marks a

significant increase from 2021, Consequently, students from these 1,000 schools will take the CBSE board exams for the when only around 350 CBSE schools existed in Andhra Pradesh, primarily comprising first time in 2025.

NTPC Simhadri Project head Sanjay Kumar Sinha said, "We utilise flue gas to desalinate seawater from the Bay of Bengal, providing IIPE with 10-20 tonnes of desalinated water daily. This water is then demineralized for hydrogen production through electrolysis, with the hydrogen stored at 200 bar pressure in vessels with a total capacity of two tons. Producing one kilograms of demineralized water or 12-13 kilograms of normal water.

Demineralised water for electrolysis offers numerous advantages, including reduced carbon intensity in desalination, minimal chemical usage, no reliance on fresh water, and waste flue gas heat. Currently, India's hydrogen demand stands at six million metric tons per year, primarily for fertilizers, refineries, and steel. By 2030, this demand is projected to reach 11 million metric tons annually, necessitating 110 billion litres of demineralized water per year. "The Government of India is focusing on hydrogen production technologies," Srivastava said.

"IIPE aims to lead in green energy technologies, and this green hydrogen project, supported by NTPC Simhadri, could be a game changer.'

# 59.06 per cent polling, Bengal's Jangal Mahal region logs 78.19

An approximate voter turnout of 59.06 per cent was recorded in the sixth phase of Saturday in 58 constituencies across six states and two Union territories with the polling percentage in the Jangal Mahal region of West Bengal touching 78.19.

Incidents of minor clashes and protests were reported from West Bengal while there were instances of EVM malfunctioning at some places, including Delhi.

Jharkhand recorded a turnout of 62.74 per cent, Uttar Pradesh 54.03 per cent, Bihar 53.30 per cent, Jammu and Kashmir 52.28 per cent, Haryana 58.37 per cent, Odisha 60.07 and Delhi 54.48 per cent, according to the figures released by the Election Commission (ÉC) as of 7.45 pm. The EC said polling percentage in the Anantnag-Raiouri seat in Iammu and Kashmir is the highest in many decades.

With the conclusion of this phase, polling is now complete in 486 seats in 28 states and Union territories. The last of the seven phases



of polling is scheduled on June 1 and counting of votes will be taken up on June 4.

With large parts of India sweltering under a heatwave, arrangements for cold water, coolers, fans and tents were made at several polling stations. Wheelchairs were also kept for the assistance of elderly voters.

According to eyewitnesses, several people, including children were playing games at the game zone, located on Nana-Mava Road, when the tragedy struck. Rajkot Collector Prabhav Joshi said the Fire Control Room received a call at around 4:30 pm regarding the blaze at the game zone. "Fire tenders and ambulances rushed to the spot to douse the flames. The fire caused the collapse of the structure, and debris is being cleared," Joshi added. However, the exact cause of the massive fire is not known. The state government has assigned the investigation to a Special Investigation Team (SIT). Prime Minister Narendra Modi has expressed

PNS VIJAYAWADA

For the first time in Andhra Pradesh, a patient who suffered from Cardiogenic Shock and Pulmonary Edema, was given a new lease of life through VA-ECMO (Extracorporeal Membrane Oxygenation) at Aster Ramesh Hospital, Guntur.

A 35-year-old software engineer experienced severe chest pain after a morning temple visit in Mangalagiri. Initially mistaking it for gas pain, he took an antacid. When the pain intensified, he visited a local nursing home in Mangalagiri, where an ECG confirmed a heart attack. He was referred to a hospital with cardiac specialisation. Consulting a family physician in Guntur, more tests confirmed a severe heart attack, prompting a referral to Aster Ramesh Hospital for Emergency Primary

Angioplasty. The patient was swiftly examined by a cardiac team led



by senior cardiologist Dr Ramarao. Diagnosed with cardiogenic shock and pulmonary edema, he was put on a ventilator and transferred to the cath lab. An intra-aortic balloon pump was inserted, and an angiogram revealed a 100% blocked main artery.

Emergency angioplasty was

performed to remove the clots. Despite these efforts, the patient showed signs of multiorgan failure, including rapid heart rate, low blood pressure, reduced urine output, inadequate oxygen levels and heart

pumping was low as it was a massive heart attack and he was in cardiogenic shock. The medical team suggested ECMO (Extracorporeal Membrane Oxygenation) as a last resort. With family consent, the patient was connected to the ECMO machine.

Dr. Ramarao stated that the patient's life was saved through emergency angioplasty, intra-aortic balloon pump, and ECMO support. This marked the first time such a procedure was performed in Andhra Pradesh at Aster Ramesh Hospitals.

## VMC leaves three-wheeler garbage disposal vehicles in state of disrepair

#### CPM LEADER EXPRESSES CONCERN AND URGES CIVIC AUTHORITIES TO ACT

Member of the CPM State secretariat, Ch Babu Rao, has expressed concern over the neglect of three-wheelers used for garbage removal in the Vijayawada Municipal Corporation (VMC), citing their prolonged state of disrepair. He said that the vehicles have been left idle at various locations across the city, placing an undue burden on sanitation workers due to what he perceives as negligence on the part of VMC officials.

Following the conclusion of election polling, Babu Rao, who ran for the Vijayawada Central Assembly constituency under the CPM banner, conducted inspections across several VMC divisions in the vicinity. During his visits to



Rajiv Nagar, Vaddera Colony, New Rajiv Nagar, and other places, he observed the dismal condition of the unused threewheelers designated for waste collection. Rao noted the apparent lack of initiative from VMC authorities in addressing the maintenance needs of these

vehicles, which exacerbates the workload of sanitation per-

Babu Rao pointed out widespread issues such as deteriorating tyres and vehicle body damage among the neglected three-wheelers. He said that these vehicles were procured

under the Swachh Bharat and Swachh Survekshan initiatives, yet their upkeep has been severely overlooked. Despite complaints from sanitation workers to VMC officials, Rao lamented the absence of reme-Moreover, Babu Rao high-

lighted the financial burden placed on sanitation workers, who reportedly foot repair bills while VMC officials remain unresponsive to their grievances. He alleged that although VMC disburses payments to contractors managing CLAP vehicles for waste collection, no corresponding allocation is made for three-wheel-er repairs. Babu Rao urged VMC authorities to address the matter earnestly and allocate funds for the necessary repairs without further delay.




#### Salary hiked for ACA match officials

# Seeing through 'expiry' and 'use by' dates and those who determine them

Barring alcoholic drinks like whiskey, brandy, wine, except beer, and fresh fruits, vegetables, coconuts etc., perhaps every edible consumer item these days has an 'expiry' or 'best before' date stamped on it, indicating longevity of the finished product in terms of its quality and efficacy. Using a product beyond the date so stamped not only diminishes its quality or efficacy, but also exposes the consumer to risks springing from ingredients that may have gone bad. A 'use by' or 'expiry' date often ranges from a couple of days (in the case of say bread or milk) to case of say bread or milk) to a maximum of six months. Durable life is the period a food item will retain its normal wholesomeness, palatability, and nutritional value, starting from the day a food item is packaged for retail sale to the use by or expiry date stamped. Characteristically, food items may be safe to eat

refrigerated properly, according to some experts.

Most of the 'shelf-stable foods' that can be stored at room temperature in a sealed container are safe indefinitely. These include processed and refrigerated ones, so that they can be safely stored at they can be safely stored at room or ambient temperature for a usefully long shelf life. In fact, canned goods will last for years, as long as the can itself is in good condition (no rust, dents, or swelling). Packaged foods (cereal, pasta, cookies) will be safe past the 'best before' or 'use by' date, though they may eventually become stale without flavor.

stale without flavor. Experts say that 'durable life dating' is critical to safe food handling by the consumer. Again, such durable life date is valid only for unopened products. Once opened, the product should be consumed at once. Foods susceptible to spoilage should not be consumed if the 'best before' or 'use by' has passed. For, even

Most of the 'shelf-stable foods' that can be stored at room temperature in a sealed container are safe indefinitely. These include processed and refrigerated ones, so that they can be safely stored at room or ambient temperature for a usefully long shelf life. In fact, canned goods will last for years, as long as the can itself is in good condition (no rust, dents, or swelling). Packaged foods (cereal, pasta, cookies) will be safe past the 'best before' or 'use by' date, though they may eventually become stale without flavor

if a food shows no signs of spoilage, it can harbor organisms capable of causing foodborne diseases known as 'pathogenic microorganism.' Foods that are not susceptible to spoilage may be consumed past their 'best before or 'use by' date' though they may have lost their original flavor and nutritional value. Consumers need to use their senses (sight, smell) and com-

such food item is appropriate

Likewise, the 'drug expiration date' is the last day before which the finished product remains stable, retaining its strength, quality, and purity, subject to storage stipulations. Medicines after the 'expiry date' may not be either safe or efficacious, which makes it obligatory for users to check it

The paradox is that only

manufacturers and retailers determine the 'durable life of foods' they sell. That is, the dating information' they provide just indicates 'quality but not food safety. Even the instructions for proper storage are the choice of the manufacturer, who ties them to specified storage conditions. Granting we have appropriate authorities to track and regulate these aspects of food and drugs, there is a woeful lack of

consumer education and awareness on this front.

Fascinatingly, there is no 'expiry date' for any hard liquor. The reason could be that 'alcohol is a preservative,' and most liquors like whiskey, and most liquors like whiskey, rum, brandy, gin, and vodka are generally 40 per cent alcohol (or 80 proof), and do not have a high enough sugar content in them to kick-start oxidation. This is good enough to preserve it indefinitely. Their high-alcohol levels keep bacteria from growing in the unopened bottles and if stored properly, they will be good for years to come. be good for years to come. Liquor lasts the longest, whereas wine and beer are less shelf-stable.

Curiously, in good old days, food stuff like chutneys (mango, tamarind, amla, lemon etc) and pickles (predominantly mango) made at home by grandmothers lasted far longer with quality and taste intact. People used to releven more than a year. In fact, 'tamarind chutney' used to become tastier after a year would last for about two years. The oil (sesame or groundnut, cold-pressed) as well as condiments and spices used then made all the difference, perhaps. Of course, grandma knew the right proportions in which they need to be used. Marshall Allen, an

Marshall Allen, an American journalist, investigating the cost and quality of health care, in an article in Jul 25, 2017, 'Are Expiration Dates on Medicines Just a Myth' cited an instance and expressed his view that if some drugs remain effective some drugs remain effective well beyond the date on their labels, why has not there been a push to extend their expiration dates? He had noticed a box of prescription drugs, 30 to 40 years past their expiration dates, possibly toxic, probably worthless, which were forgotten in a back clos-

et of a retail pharmacy!

Clinical Pharmacy, Dr Lee Cantrell, commenting on this, said that the cache was an opportunity to answer an enduring question about the actual shelf life of drugs. When referred for the opinion of Roy Gerona, another Californian researcher, who saw people recover from sickness by taking expired drugs with no apparent ill effects, meaning, 'expiration date' was a misnomer, his prompt response was 'This was very cool. The dates on drug and food labels are simply to guarantee their effectiveness, and do not necessarily mean they are 'Ineffective immediately after they expire?

The significance or insignificance of expiry dates as well as the potential mischief of manufacturers need to be better handled by the authorities concerned, presuming they are properly manned and fully

## **UDF** demands resignation of excise, tourism ministers

After the accident, the driver gave a statement at the Yerawada police station that he was at the wheel....But it was revealed that a teen was driving the car," police commissioner

Amitesh Kumar told reporters. After the driver left the Yerawada police station, the teenager's father, realtor Vishal Agarwal and his grandfather whisked him in a car to his house on the premises of their bungalow, confiscated his phone and confined him there,

the senior police official said. "He was pressured to give a statement to police as per their directions," Kumar said, adding that the driver was offered gifts and cash for owning up the crash of the Porsche driven by the teenager, and also threatplace the next day and freed nim, said the commissioner.

The driver was frightened. He was summoned and his statement was recorded on Thursday (May 23). After corroboration of facts, an offence was registered against the juvenile's father and grandfather (on the driver's complaint)," Kumar said.

Vishal Agarwal and his father were booked under Indian Penal Code sections 365 (kidnapping) and 368 (wrongfully concealing or keeping in confinement).

cerned including the Interpol to ensure justice to our parliamentarian's family. We have already arrested three persons including a woman. Two of them have criminal backgrounds and we are checking woman," he said.

Asked about the motive behind the murder, the home minister said, "We will reveal

Repeated attempts to contact Shahin in the US went in vain, but his brother Md Shahiduzzaman, mayor of Kotchandpur municipality in Bangladesh's Jhenaidah, demanded stern action against his brother if found guilty.

Speaking to PTI from Jhenaidah, Shahiduzzaman said, "We grew up together and it is hard to believe that he is involved in such a heinous crime. If he is at all indulged in the crime, he should be punished.

He said, "I spoke to him two weeks ago over phone and he sounded happy...I believe he is in the US now.

Shahiduzzaman, however, claimed that he had no knowledge of his brother's business dealings or his relationship with the murdered MP.

"All I know is that my brother is very rich...But I have no clue about his business," he said.

Meanwhile, a senior police officer in West Bengal said, "Bangladesh does not have any extradition treaty with the US government but India has. We are planning to extradite Shahin to India because the crime occurred in

Shahin, a close friend and reportedly a business partner of Anar, is believed to be in New York City, where he holds US citizenship.

Suresh Katlami alias Kachlami and Sanker Nureti alias Shanker, it said. In its charge sheet filed before a special court in Jagdalpur, the NIA charged the trio under various sections of Indian Penal Code and the Unlawful Activities (Prevention) Act. They were actively involved in the conspiracy of abducting and killing of three innocent civilians and promoting and propagating the terror agenda of CPI(Maoist) operating in that area through various fronts including Krantikari Kishan Committee, Mahila Mukti Manch, Revolutionary People's Council (RPC), Jantana Sarkar etc., the probe agency said.

Members of Geneva-based World Intellectual Property Organization (WIPO) have concluded an agreement under which it will be mandatory for patent applicants to disclose country of origin or source of genetic resources if the claimed invention is based on those materials or associated tradi-

tional knowledge.
The treaty will provide additional protection for Indian genetic resources and traditional knowledge. Although these are currently protected within India, they are prone to misappropriation in countries, which do not have disclosure obligations.

The current patent legislation does not have a mandatory provision requiring patent appli-

### **I-T deptt notifies cost inflation** index for current fiscal



department has notified the Cost Inflation Index beginning April 2024, for calculating long-term capital gains arising from sale of immovable property, securities and iewellery. The Cost Inflation Index (CII) is

used by taxpayers to compute gains arising out of sale of capital assets after adjusting inflation. The CII for financial year 2024-25, relevant to assessment year 2025-26, stood at 363, as per a notification of the Central Board of Direct Taxes (CBDT). The CII number for last fiscal was 348 and for 2022-23 financial year it was 331. Moore Singhi Executive Director Rajat Mohan said the CII reflects the inflation in the economy, which causes the prices of goods and services to increase over time. For the financial year 2023-24, the CII was set at 348. The index for the following financial year, 2024-25, has been updated to 363, marking an increase of 15 points, which corresponds to an annual inflation rate of approximately 4.3 per cent. 'This is consistent with the retail inflation rate of 4.83 per cent recorded in April 2024.

#### **Bengal govt plans new AI and ML-focused data centre**



he state government is setting up a powerful, highcapacity data centre that will allow 2,300 concurrent users to run artificial intelligence (AI) and machine learning (MI) applications an official said on Friday. This

facility will enable the practical application of data science by providing infrastructure to support advanced data analysis, the official said requesting anonymity on the sidelines of the Data Science 2024 Conference. "Our state is already equipped with advanced infrastructure, supporting over 5,000 users in real-time," the official noted. One more data centre with a focus on AI and ML is being built with a capacity of 2,300 concurrent users, he said. "To address capacity and growing demand, we are establishing this new data centre with greater capacity Once operational, the data load will be split between the two centres, the official said. While the primary beneficiary of this new facility will be the government, there are plans to offer some startups access to the infrastructure for advanced data analytics, he said.

## **Busy Bee Airways withdraws** bid for Go First

It could not be immediately ascertained whether Ajay Singh will be pursuing the bid since the joint bidder Busy Bee Airways has opted out.

#### Al's Mumbai-San Francisco flight takes off after inordinate delay

ince childhood, I dreamed of visiting Darjeeling. Nestled in the Himalayan foothills in West Bengal, India, it captivates with lush tea gardens stretching over rolling hills, set against snow-capped mountains. Perched high at 6,710 feet, towering above its neighbouring regions. I imagined myself enjoying tea amidst the mountains, enveloped by the serene beauty of nature. After a two-hour flight and a two-hour drive from steamy Delhi, I find myself in Ghoom, where staff dressed in charming smiles graciously serves me delightful tea besides breath-taking views of the Kanchenjunga, India's loftiest peak at 28,169 feet (8,586 meters) at this lavish 6.4-acre haven aka The Sterling Darjeeling, just steps from Yiga Choeling Monastery, making it a dreamy retreat for my getaway. To my surprise, Darjeeling's history wasn't always intertwined with tea.



Back in 1835, the British obtained the lofty ridge, standing tall at 7,000 feet (2,134 meters), from the rulers of Sikkim. Initially intended as a sanctuary to rejuvenate weary colonialists fatigued by the plains' sweltering heat, this haven quickly transformed into a popular destination for the elite British community from Kolkata (Calcutta), seeking respite and breath-taking views of Kanchenjunga. The infusion of tea culture didn't grace Darjeeling until the 1840s, thanks to the efforts of Dr. Campbell, a Scottish physician who introduced tea bushes from China to the region.

# GENESIS OF GROWTH FROM BUD TO BRANCH

s you stand beneath the towering majesty of a tree, your gaze is naturally drawn upwards, captivated by the intricate network of branches that crisscross the sky. Each branch, unique in pattern and structure, defines the tree's character and beauty. Yet, behind this awe-inspiring spectacle lies a more fascinating tale of growth and transformation.

The narrative unfolds with the emergence of a bud from the tree's trunk. Given the right balance of sunlight, water, and nutrients, this bud slowly grows and develops into a mature branch. The genesis of a bud, or bud set, is initiated in regions of the plant rich in meristematic cells. These cells, found at the tips of stems and roots, have the unique ability to divide and differentiate into various types of plant cells, leading to the formation of new organs such as leaves, flowers, and branches. When these meristematic cells, or apical buds, are exposed to sunlight, they initiate

This is where the plant hormones auxin and cytokinin come into play. Auxin, originating from the shoot apex, inhibits the outgrowth of axillary buds, allowing the apical bud to grow faster and taller. This phenomenon, known as apical dominance, ensures that the central stem of the plant grows more strongly than the side stems. Cytokinin, on the other hand, which is stimulated by the removal of the shoot apex, promotes the atgrowth of axillary buds by providing them w more nutrients.

This tug-of-war between auxin and cytokinin is crucial for the plant's growth strategy. It allows the plant to adapt to its environment, growing taller to reach for sunlight or spreading out its branches to occupy more space. As the bud grows, the meristematic cells divide and differentiate, giving rise to different types of cells that constitute the branch. Some cells form the outer layer, transforming into bark cells, while others form the wood, turning into the xylem and phloem. As the cells continue to divide and differentiate, the bud gradually elongates, evolving into a twig. Over time, the twig undergoes lignification, a process involving the deposition of lignin, a complex organic polymer that provides rigidity to the plant's cell walls. This process gradually transforms the flexible, green twig into a hard, brown branch. Lignin is a key component of the plant's defense mechanism. It forms a physical barrier in the cell walls that protects the plant against pathogens and pests.

This barrier also makes the plant resistant to decay, thereby increasing its lifespan. Moreover, lignin is essential for the plant's water transport system. It makes the plant's vascular tissues waterproof, preventing the leakage of water and nutrients, and facilitating their upward movement from the roots to the leaves. This waterproofing property also prevents the absorption of excess water, protecting the plant from waterlogging and associated diseases.

The anatomy of a branch reveals a marvel of plant architecture. At its very base lies the branch collar, a swollen area where the branch attaches to the main trunk. This specialized structure houses tissues that are instrumental in wound healing and act as a protective shield against the invasion of pathogens.

Progressing from the branch collar, we come across the branch junction. This crucial juncture signifies the point where the branch diverges from the trunk, paving the way for the branch's outward expansion. From this

point, the branch unfurls, giving rise to lateral shoots known as secondary branches or twigs. These offshoots,

Branching patterns in trees are an intriguing aspect of plant biology, reflecting both the genetic makeup of the species and the environmental conditions in which they grow. One such pattern is 'alternate branching', seen in certain species. In this arrangement, branches are staggered along the main stem, reducing overlap and creating spaces between branches. This results in a more open canopy structure, which is not only an architectural marvel but also a strategic adaptation.
The open structure allows sunlight to penetrate evenly, reaching the lower branches and the forest floor. This not only benefits the tree itself by ensuring all parts receive adequate sunlight for photosynthesis but also nurtures the understory plants with filtered light. However, this strategy is not without its

The staggered arrangement of branches creates a less rigid framework, which, while potentially allowing for more movement during wind events, might also increase the tree's susceptibility to structural damage in severe storms.

On the other hand, some species showcase 'opposite branching', with pairs of symmetrical opposition. Trees with opposite branching patterns often experience higher levels of shading within their canopies due to the symmetrical arrangement of branches. This leads to a denser and overlapping canopy structure, akin to a natural umbrella that provides shade and conserves moisture. The increased density results in shading between opposite branches, limiting the penetration of sunlight to lower branches and the interior of

the canopy. However, this denser structure often provides increased mechanical stability against wind or storms. Branches inherently exhibit negative geotropism, meaning they grow in the opposite direction of gravity, reaching upwards and outwards for sunlight. This strategic adaptation enables them to maximise their exposure to sunlight and secure their place in the fierce competition for resources. In dense forests, where sunlight is scarce, trees adopt a different strategy known as 'selfshading avoidance'. They grow more vertically to minimize the shading of their lower leaves and reach toward the scant light available in the canopy. Wind, the invisible sculptor, also plays a significant role in shaping tree growth. In windy environments, trees often adopt narrower branching angles, resulting in a more streamlined shape that reduces wind resistance.

These branches, often perceived as mere offshoots, are in fact, the vital lifelines of trees. Much like arteries in the human body, branches serve as crucial conduits within the arboreal world, playing an indispensable role in the survival and well-being of the tree. They perform the critical function of transporting water and nutrients from the roots to the leaves, while also carrying back the sugars produced during photosynthesis from the leaves to the rest of the tree. They also provide habitat and support for a diverse range of organisms. Birds build nests on them, insects and lichen find refuge on the bark and leaves, and mammals use branches for shelter and as a pathway for movement. This biodiversity creates a miniecosystem within the branches themselves, contributing significantly to the overall health of the tree and the complex web of life that surrounds it.

Many trees have flowers and fruit on their branches, which are essential for reproduction. Flowers attract pollinators, and fruits, containing seeds, are eaten by animals who then disperse the seeds in their droppings, aiding in the spread of the tree species. Some seeds are even equipped with wings or fluff, enabling them to be carried by the wind, thus allowing plants to disperse their offspring over a wide area. In some remarkable instances, branches themselves become the genesis of new life. This is observed in the process of vegetative propagation, where fragments of branches can give birth to entirely new trees. This form of asexual reproduction results in a new tree that is genetically identical to the parent tree. Trees, in their wisdom, are active architects of their growth. They strategically shed lower branches that are no longer efficient at photosynthesis. This calculated act of self-pruning allows trees to channel their energy and resources toward the higher branches, which are better positioned to capture more sunlight. But how does the tree accomplish this?

When a branch becomes unproductive, the tree gradually severs its supply of water and nutrients. The branch then loses its bark and becomes frail and susceptible to fungi. Eventually, the branch falls off, leaving behind a stump that is sealed by resins or gums. This seal protects the tree from harmful pathogens that could infect the wounded area and jeopardize its health. As the fallen branch decomposes, it bestows its accumulated nutrients back into the soil, a final act of nourishment for the tree that once gave it life. This process enriches the surrounding ecosystem, fostering new life and affirming that in every ending, there is a new beginning. This ongoing cycle of growth and retreat mirrors life's profound truth: Change is the only constant. It serves as a reminder that life isn't merely about relentless growth, but also about the wisdom of knowing when to let go. Much like a tree that sheds an unproductive branch to conserve energy for new growth, we too should find the courage to let go of what no longer serves us. As we navigate life's twists and turns, we can draw inspiration from this timeless wisdom from nature to embrace the changes that come our way, always making room for new growth and





# At His Majesty's Service

Chander Lall's book offers a panoramic view of the Constitution, the history of India's Independence movement, and the social milieu of that era in an inimitable style, writes KUMAR CHELLAPPAN

Government Lestablishments for close to a decade and a half, this writer has come to the conclusion that a Government job is a safe haven for those with an IQ below par. Apart from the obvious security and regular salaries that accompany such a job, it also leads to some individuals barely doing any work worth its name. In fact, it is this sense of security that draws countless aspirants to seek a position in State/Central Government departments. Recently, I came across the case file of a driver employed with the Andaman Lakshadweep Harbour Works whose service was terminated following unauthorised absence from duty for a period of eight years. It took years for the Central Administrative Tribunal to concur with his superiors that his continuous absence from duty for such a long period was devoid of any justification and uphold their decision to terminate his services. This is just one such instance of the freedom enjoyed by Government servants who are blissfully unaware of the landmine-paved paths of the private sector. While modern-day Government employees are fortunate to enjoy complete freedom at their work places, things were not as smooth

during the tenure of the British administration. Anyone, including officers of the high profile and elite Indian Civil Services, could be relieved of their responsibilities for the most innocuous of reasons. It took a daredevil ICS officer like Inder Mohan Lall to take on the British administration by the horns and tutor them on the fact that there is due procedure to be followed in taking disciplinary

action against any errant Government officer or lower staff. The Civil Service Regulations had given enough power to the then Federal Public Service Commission as well as the Government of India's Home Department under the Government of India act 1935 to "fire" anyone accused of misconduct while in service. The draconian rule did not have any provision to furnish the accused with a chargesheet, his version of the story holding no relevance. This rule was challenged by Lall, taking on His Majesty's Government from 1939 to 1948. The case culminated in Lall's victory as the Court ordered that the Government of India Act should have Article 311 which ensures that "no person who is a member of the civil service of the Union or an all India Service or a civil service of a State shall be dismissed or removed by an authority subordinate to that by which he was appointed." No such person as aforesaid shall be dismissed or removed or reduced in rank except after an enquiry in which he has been informed of the charges against him and given a reasonable opportunity of being heard in respect of those charges, the Court ordered. Lall had faced a series of charges for his decision to appoint Sundar Das, his wife's nephew, as a subordinate staff in the court where he worked as district judge of the Hoshiarpur district. This antagonized some of the junior staff members who had eyed the post for themselves. Lall had taken stringent action against many Government employees for their


corrupt practices so they were

back. Šundar Das came served as

the right opportunity for them to take it up with the Secretary of

State. The latter appointed two commissions of enquiry, one after another, to foist cases on Lall in order to get rid of him from His Majesty's Service. The enquiries and the ensuing legal battle form the plot of his book. What author Chander M Lall has done is to chronicle the events in a reader-friendly manner. He commences with his family history that includes Lall's life as a soldier in the British Indian Army during the First World War and how he made it to the ICS from where he was removed, based on the reports submitted by the enquiry commissions. We seldom go into the details of a new legislation enacted by law making

bodies like the Parliament or legislative assemblies. However, each and every law enacted addresses a specific concern. The first time the Constitution was amended was to address certain difficulties arising out of rulings by the Supreme Court. Famous cases like Golak Nath versus State of Punjab or Keshavananda Bharati versus State of Kerala were a follow up to the restrictions placed on the land ownership of individuals. Henry and William Golak Nath, two brothers, owned hundreds of acres of prime land in Jalandhar. But the Punjab Government declared that each brother could own only 30 acres of land and declared the rest as surplus land. The brothers challenged the Act and the apex court upheld the decision of the State of Punjab. Similarly, Keshavananda Bharati, the pontiff of Edneer Mutt, challenged the Kerala Government's move to take over vast stretches of land owned by the Mutt (monastery) as per the Land Reforms Act. A constitutional Bench in a split

verdict upheld the Kerala Government decision but ruled that Parliament cannot amend the basic structure of the Constitution while making such legislations. The Kerala Government's action was a specific move against Hindus as it left untouched thousands of acres of plantations belonging to other communities. # **Efforts to draft a pandemic treaty falter as countries disagree**

global treaty to fight A pandemics like COVID is going to have to wait: After more than two years of negotiations, rich and poor countries have failed — for now — to come up with a plan for how the world might respond to the next pandemic.

After COVID-19 trig-gered once-unthinkable lockdowns, upended economies and killed millions, leaders at the World Health Organization and worldwide vowed to do better in the future. In 2021, member countries asked the U.N. health agency to

Addressing a sullen final day of negotiations, the WHO chief insisted, "This is not a failure."

"We will try everything believing that anything is possible — and make this happen because the world still needs a pandemic treaty," he said. "Because many of the challenges that caused a serious impact during COVID-19 still

accord's aim was to set guidelines for how the WHO's 194 member countries might stop future pandemics and better share resources. But experts warned there were virtually no consequences for countries that don't comply.

The co-chairs of the treaty-drafting process didn't specify what caused the logjam, but diplomats have said vast differences remained over sharing of information about pathogens that emerge and the sharing of technologies to fight them.

## Rio de Janeiro bay reforestation shows mangroves' power to mitigate climate disasters

the rear of Rio de A Janeiro's polluted Guanabara Bay, thousands of mangroves rise as tall as 13 feet (about 4 meters) from a previously deforested

The 30,000 trees, planted by non-profit organization Instituto Mar Urbano over four years in the Guapimirim environmental protection area, stand as an example for cities seeking natural means to improve climate resilience.

Such ecosystems are vital for protection against floods that have become increasing-ly frequent around the world. Brazil's southern state of Rio Grande do Sul is still reeling from a devastating flood earlier this month that wreaked havoc and took lives, with vaters far from subsiding to normal levels.

Mangroves slow sea water's advance into riverbeds during storm surges by soaking it up, and protects the land by stabilizing soil that otherwise could be washed away. They also act as a carbon sink. The reforestation in Rio's bay

improved the cleanliness of water that's a breeding ground for marine species. Crabs have returned, providing extra income for the local crab pickers who helped plant

Since 2000, flood-related disasters across the planet have increased by 134% over the two previous decades, according to a 2021 report by the World Meteorological Organization.

Environmentalists say the loss of natural vegetation due to agriculture and cattle ranching in Rio Grande do Sul state amplified the flooding. A recent study by MapBiomas, a network that includes nonprofit organizations, universities and start-ups, says the Brazilian state lost 22% of its native vegetation between area greater than the U.S. state of Maryland.

Parents and teachers often say they have problems controlling children with ADHD, and it could be that when the children can't express themselves well -- when they hit emotional difficulties -- they may not be able to control their emotions and have an outburst rather than communicating with the parent, teacher or the other child, author Barbara Sahakian from the University of

Cambridge said. For the study, the researchers included data from the Adolescent Brain Cognitive Development (ABCD) study, tracking brain develop-

ment and mental health of children and adolescents across the US. The researchers developed an ADHD-symptom score, based on data avail-

able for over 6,000 individuals from the ABCD study. The score indicated an individual's chances of having the disorder. Of the group, the team also

identified 350 participants having high symptom scores that met the clinical criteria for ADHD.

By responding to questionnaires, parents or guardians had previously provided information on how well or not their children coped when feeling upset, the

researchers said. The responses were evaluated to score participants on their emotion dysregulation. The authors found that more than half of those in the

high-symptom group (51 per cent) showed signs of emotion dysregulation, regardless of problems with their cognition and motivation. Emotion dysregulation was also found to be a strong risk factor for developing more ADHD symptoms. Of all the participants, children showing low symptoms of ADHD at ages 12 and 13 but having high emotion dysregulation at age 13.
