## Hundreds reported dead as Israel, Iran trade strikes for third day

Israel unleashed airstrikes across Iran for a third day Sunday and threatened even greater force as some Iranian missiles evaded Israeli air defences to strike buildings in the heart of the country.

Planned talks on Iran's nuclear programme, which could provide an off-ramp, were cancelled.

Israel's strikes have killed at least 406 people in Iran and wounded another 654, according to a human rights group



that has long tracked the country, Washington-based Human Rights Activists. Iran's government has not offered overall casualty figures.

The region braced for a protracted conflict after Israel's surprise bombardment Friday of Iranian nuclear and military sites killed several top generals and nuclear scientists. Neither side showed any sign of backing down.

Iran said Israel struck two oil refineries, raising the prospect of a broader assault

### Trump says he can end Middle East war too Repeats his claims on India, Pak ceasefire

US President Donald Trump on Sunday claimed that he could secure a deal between Iran and Israel just as he had done between other arch-rivals, as he repeated his claim that he stopped the war between India and Pakistan last month by "using trade".

In a post on Truth Social, Trump also claimed that "many calls and meetings are now taking place" on the issue.

"Iran and Israel should make a deal, and will make a deal, just like I got India and Pakistan to make, in that case by using TRADE with



the United States to bring reason, cohesion, and sanity into the talks with two excellent leaders who were able to quickly make a decision and STOP!" Trump claimed.

The Indian government has maintained that India and Pakistan reached an understanding on May 10 to end the conflict after four days of intense cross-border drone and missile strikes without any third-party involvement.

A helicopter carrying pilgrims from the Kedarnath shrine crashed early Sunday in the forests of Gaurikund amid poor visibility, killing all seven people on board, the fifth helicopter accident on the Chardham Yatra route since the pilgrimage started on April 30.

The Civil Aviation Ministry suspended the operations of the helicopter operator and issued a slew of safety directions after the tragedy, which came just days after one of the deadliest air disasters where an Air India flight to London crashed in Ahmedabad just after takeoff, killing 241 people on board and several others on the ground.

the Bell 407 helicopter, operated by private firm Aryan Aviation Pvt Ltd, included a two-year-old child and the pilot. They hailed from Maharashtra, Rajasthan, Uttarakhand and Uttar Pradesh.

Civil Aviation Ministry said it has suspend-

ed the operations of Aryan Aviation for the Char Dham Yatra and has directed the Directorate General of Civil Aviation (DGCA) to immediately post officers from airworthiness, safety and operations to actively oversee all helicopter activity in the Kedarnath Valley.

Preliminary indications suggest that the probable cause may be Controlled Flight into Terrain (CFIT), with the helicopter reportedly airborne despite poor visibility and extensive clouding at the valley entry area, the ministry said in a statement.

The exact cause will be determined through a detailed investigation by the Aircraft Accident Investigation Bureau (AAIB), it added. CFIT occurs when an air-

worthy aircraft under the complete control of the pilot is inadvertently flown into terrain, water or an obstacle. Uttarakhand Chief Minister

Pushkar Singh Dhami also ordered a high-level inquiry and suspension of helicopter operations on the Chardham Yatra route for two days.

## People expect dignified governance, not arrogance

Porty-eight years ago, in 1977, India was much poorer and illiterate than it is now. But in the general elections that year, the people of India revolted against the emergency imposed by the then Prime Minister, Indira Gandhi, on June 25, 1975, and its excesses that continued for around two years, that led to the formation of the first ever non-Congress Central Government after almost 30 years of Independence. But Índira Gandhi did not call the voters 'backstabbers.'

After the assassination of Indira Gandhi, her son Rajiv Gandhi was elected Prime Minister in 1984 with a neverbefore-and-never-after majority of over 400 seats in the Lok Sabha But he lost control over the ship of governance and lost badly in the 1989 elections. He did not call voters who defeated him backstabbers.

After having been Chief Minister twice in 1995 and 1999, Nara Chandrababu Naidu lost the elections in 2004, but he did not blame the people. The late Dr NTR also lost the third election he contested in 1989.

But YS Jagan Mohan Reddy is different. Having become the Chief Minister with a huge people's mandate with 153 Assembly seats in 2019, he was decimated and reduced to just 11 seats in 2024. Like no other leader before, Jagan dared to call the people who defeated him backstabbers. What could be the reasons for this?

### People do not live by bread alone

Jagan's case study warrants close examination in the context of his oft-repeated claims and their messages. Endlessly, while in office and later, he left no opportunity to stress the Rs 2.70 lakh crore that he claimed to have placed in the hands of the people through DBT during 2019-24. He firmly believed that this largesse would return him to power by all means. So he built a palace for his family at the Rishikonda Beach in Visakhapatnam, spending Rs

500 crore of tax money. But the people had different plans for him. So, Jagan now stays in

his Bengaluru palace. The point of this analysis is what do people want from the governments they vote for and defeat after five years? Why did Jagan get so disoriented after his 2024 defeat? Why is he seeking to hold the people by their collars and ask why he was backstabbed by them even after giving them Rs 2.70 lakh crore? What do the people want?

The 1977 verdict against Indira Gandhi and the one against Jagan in 2024 are the closest comparable case stud-

ies for drawing logical inferences. Mrs Gandhi thought she was the darling of the poor and the masses, and so did Jagan. The events that led to the imposition of the emergency and its two-year-long excesses draw a parallel with the rule of former CM Jagan and his ultimate decimation.

Both Mrs Gandhi and Jagan brazenly subverted the Constitution. They both ruled as they liked and misused the official machinery to cling on to power, come what may. In doing so Jagan thought that the public money he dispensed through DBT would act as a shield against the unchecked

corruption through the devious liquor sale and even in the housing scheme for the poor and the Tirupati laddoo, the looting of precious natural resources like mines, sand and public lands across the state, the targeting and victimisation of political opponents by misusing the police machinery like the imprisonment of former CM, Chandrababu Naidu, fleecing businesses and forcing them to run away from the

In a nutshell, the public message that Jagan sent during those dark five years is that he is above the Constitution, beyond the rule of law, that he was born to rule, the poor would be happy with some regular free doles, the future of the people and their children do not matter and only that of his family matters, the people do not expect and need to live with dignity and that people do not deserve and care for their fundamental rights like the right to free speech and also right governance does not interest people and they don't bother about it. It's an echo of Indira Gandhi's style during the events that led to the 1975 emergency.

The message that came out of the 1977 and 2024 verdicts is that the people have needs beyond bread. They want to live with dignity, free speech, freedom of political action and free association. They look at social welfare schemes as their right and entitlement. Another important message of these two electoral verdicts is that

the people expect dignified governance, conduct and public messaging from the governments of the day. People don't like the arrogance and self-centeredness of the individuals they voted to power.

Jagan suffers from this 'deficit of understanding of democracy and the public mind. This deficit made him call the people who did not vote for him backstabbers, digging his own grave.

### **Health sector case study**

Another folly of Jagan was that he believed that people could be misled by grand announcements without follow-up actions. Public health is a case study in that. He announced Medical Government Colleges, but spent only 14% of the sanctioned cost during his tenure. Likewise, only 17% was spent on the hyped Nadu-Nedu programme meant for the development of healthcare infrastructure. He claimed 'zero vacancy' recruitment, but there was a shortage of staff. Arogyasri was turned into a den of corruption. Recruitment lists came from the homes of YSRCP leaders instead of the offices of Collectors. Indiscipline ruled the roost during those five years. Doctors going on unauthorised absence for years was the order of the day. Those at work simply mark attendance and go. Political interference severely dented accountability. Government hospitals were marked by the stink of corruption of all kinds. This is not the way a Chief Minister should have handled the public health sector, which matters the most to the poor. The NDA government inherited such a legacy a year ago and has endeavoured to address such legacy issues. Change has begun, and we still need to do more and are committed to delivering a 'Happy, Wealthy, Healthy' Andhra Pradesh as per the vision of Chief Minister Nara Chandrababu

### WHISPERS IN THE WOODS: SUREKHA VS

All is not green in Telangana's Forest Department. Forest Minister Konda Surekha is fuming — and not without reason. Files aren't moving, decisions are being delayed, and bureaucratic hurdles seem to be growing thicker by the day. The buzz is that Forest Secretary Ahmad Nadeem is at the centre of this standoff. A little bird told said that the minister has finally put pen to paper — a strongly worded three-page letter to Chief Minister Revanth Reddy, detailing how the secretary's actions are hampering the department's work. And it's not just about official matters. Within her circles, there's growing chatter that this is a deeper issue - an attempt, some say deliberate, to sideline a Backward Class Woman minister by wielding bureaucratic power. Whether the CM intervenes or lets the trees rustle for a while longer, the friction is no longer behind closed doors. The tension is out in the open, and insiders suggest this is only the beginning.

### CM'S MISS WORLD QUIP TRIGGERS **IPS EXIT FROM TOURISM**

The transfer of Sangareddy Collector Valluru Kranthi as the new MD of Telangana Tourism Development Corporation raised some eyebrows — but it's what led to the exit of outgoing MD N Prakash Reddy IPS that has bureaucratic circles buzzing. On the surface, it looked like a routine reshuffle. But brewing ever since the run-up to the Miss World event. The friction between the Tourism Secretary and Prakash Reddy, a 2010 batch IPS officer, had been evident from the start with the past and present secretaries sidelining him. But The turning point? A closed-door meeting where Prakash Reddy suggested inviting common citizens in Miss World celebrations, which was met with resistance. What followed was a cheeky jibe from the Chief Minister, aimed squarely at the Tourism Secretary: "Not everyone has travelled the world like an IAS officer." That oneliner changed the tone in the room — and possibly sealed the IPS officer's fate. Insiders say the moment that joke landed, it became clear that IPS officers were no longer welcome in tourism's inner circle. To avoid drawing media attention, the transfer was tucked neatly into a wider reshuffle. But let's be honest nothing slips past gossip radar. For now, the message has gone out loud and clear: Tourism is an IAS-only lane.

### **COLLECTOR HOPES CRASH AS 'MASSIVE'**

**REJIG YIELDS JUST FIVE CHANGES** After all the hype around a major shakeup in the Telangana bureaucracy, the final list has left many officers underwhelmed — and some outright disappointed. A large-scale overhaul of district collectors was widely anticipated, but when the orders dropped, only five districts saw new appointments: Hyderabad, Sangareddy, Khammam, Hanmakonda, and Siddipet. Whispers had been growing louder, with hopefuls polishing CVs and lobbying through the right channels. But as the dust settles, it's clear that the so-called 'massive rejig' was more of a teaser. Still, all hope isn't lost. Another round of reshuffling could be on the cards once a few more political pieces fall into place. Until then, it's a game of wait and watch.

### AROGYASRI'S REVOLVING DOOR SPINS AGAIN WITH SEVENTH CEO APPOINTMENT

The Rajiv Arogyasri Trust has a new name at the top — again. P Uday Kumar, a 2016 batch IAS officer, has been posted as the new CEO, formally relieving S Sangeetha Satyanarayana from her additional charge. With this, Uday Kumar becomes the seventh officer to occupy the post in just 17 months, cementing Arogyasri's reputation as one of

the most unstable bureaucratic postings in Telangana. What was once a prestigious role tied to the State's flagship healthcare scheme is now widely seen as a thankless assignment riddled with pressure, ambiguity, and constant churn. Meanwhile, the consequences of this instability are starting to show. Hospital payments under the scheme have hit delays, operational issues are mounting, and murmurs are growing louder about the scheme's long-term credibility. Unless the government steps in with clarity and continuity, the only thing consistent about Arogyasri might be the

### **CONGRESS PRO CHAOS: JOURNALISTS REGRET TAKING THE JOB**

It's official — the CM's new PRO, G Malsur, hasn't impressed the media fraternity. The moment his appointment was out, the grumbling began. Journalists are openly saying what many have been whispering for months that being a PRO in the Congress government is more punishment than privilege. Almost everyone, including CM Revanth Reddy, Ministers Sridhar Babu, Komatireddy and Konda Surekha, have changed their PROs already. Only Seethakka's PRO seems to be holding up better. The rest? Disappointed, sidelined, and calling it quits — some say they were more powerful as journalists than they ever felt as PROs. Israel, the sole though undeclared nuclear-armed state in the Middle East, said it launched the attack to prevent Iran from developing a nuclear weapon. The two countries have been adversaries for decades.

Explosions shook Iran's capital, Tehran, around noon and again around 3:30 p.m. Semiofficial news agencies close to Iran's Revolutionary Guard reported one strike in the area of Vali-e Asr Square downtown and another in a neighborhood named for the air force, which is headquartered there.

Sirens went off across much of Israel again around 4 p.m., warning of what would be Iran's first daytime assault since the fighting began. There were no immediate reports of casualties.

US President Donald Trump has expressed full support for Israel's actions while warning Iran that it can avoid further destruction only by agreeing to a new nuclear deal.

Iranian Foreign Minister Abbas Araghchi said Sunday that if Israel's strikes on Iran stop, then "our responses will also stop." He said the United States "is a partner in these attacks and must take responsibility."

Mosques as bomb shelters Israel said 14 people there have been killed and 390 wounded. Iran has fired over 270 missiles, 22 of which got through the country's sophisticated multi-tiered air defences to make impact,

according to Israeli figures. The country's

main international airport and airspace

remained closed for a third day. Israeli strikes targeted Iran's Defence Ministry early Sunday after hitting air defences, military bases and sites associated with its nuclear programme. The killing of several top generals and nuclear scientists in targeted strikes indicated that Israeli intelligence has penetrated Iran at the highest levels.

Araghchi said Israel targeted an oil refinery near Tehran and another in a province on the Persian Gulf. He said Iran targeted "economic" sites in Israel, without elaborating.



## **Employee of cash replenishment** agency flees with Rs 40 lakh

A sensational scam has come to light in Nizamabad district. An employee of a private agency responsible for replenishing Automated Teller Machines (ATMs) has absconded with a whopping Rs 40.50 lakh in cash. This incident has caused a stir in the city. from the group entered the river to perform a ritual bath. The water level reportedly rose sudden-

ly, sweeping the boys in the strong current. Rescue teams later recovered the bod-

ies and shifted them to a nearby government hospital, where doctors confirmed that all five died before arrival.

The deceased have been identified as Rakesh (17), Vinod (18), Madan (18) Ruthvik, and Bharath (24), all residents of Chintalbazar in Dilsukhnagar, Hyderabad.

The victims were part of a group of 20 people from three families who had travelled to Basara for a weekend visit to the ancient Sri Gnana Saraswathi Devasthanam. The tragedy occurred when the five youths ventured into a deep section of the river. None of them were skilled swimmers, which contributed to the drowning.

After being alerted by family members, police immediately responded to the scene. Expert divers were deployed, and the bodies were retrieved from the river.

## Five injured due to 'negligence' of electricity officials

PNS WARANGAL

Two serious incidents involving negligence by electricity department officials have raised serious concerns about safety protocols and coordination failures in high-voltage maintenance work in Nallabelli mandal of

Warangal district. On Saturday, Neelam Srinivas, an distributor worker at the Mooduchekkalapalle substation, was severely injured while conducting transformer repair work. Farmers from Line Thanda had reported issues with a malfunctioning transformer, prompting Srinivas to seek Line Clearance (LC) from the concerned Assistant

Engineer (AE), Haribabu. After receiving confirmation, he proceeded with the repairs. However, without verifying whether the LC was in place, junior lineman (JLM) Ramesh, who was on duty at the substation, restored power to the line. As a result, Srinivas suffered a severe electric shock while working on the transformer. He was immediately rushed by local farmers to a private hospital in Hanamkonda.

In a separate incident on the same day, a borewell drilling operation was underway at a rice mill in Nallabelli mandal centre. Power supply had been temporarily switched off for safety during the drilling.

However, power was unexpectedly restored without confirmation, leading to an electric shock that injured four workers. Sadukumar, one of the workers, sustained 60 per cent burns and is reported to be in critical condition. Ilayaraja suffered 40% burns, while Ajith Kumar and Selvakumar received minor injuries. All four, who are reportedly from Tamil Nadu, were admitted to private hospital in Hanamkonda.

Responding to the situation, Divisional Engineer Pendota Tirupati from the Electricity Department confirmed that a formal investigation would be conducted into the incident.

### Woman constable shot at by male colleague in Bihar

**A**woman constable was allegedly shot at by a male colleague in Bihar's Kaimur district on Sunday, officials said. The victim has been identified as Sarita Kumari (28). The accused Ajay Paswan, also a constable, is absconding. Both are relatives also and posted as constables in Supaul district. According to a statement issued by the Police headquarters in Patna, "The incident took place at 4.30 am on Sunday in the Kudra locality. The victim was riding pillion on a motorcycle with her husband when she was shot at by Ajay Pasawn. The accused fled away from the spot. Immediately after receiving the information, police reached the spot and took the victim to the nearest hospital." On the basis of her statement, a case has been registered against Ajay Paswan. The injured constable has been referred to Varanasi in Uttar Pradesh for better treatment, Sub-Divisional Police Officer (SDPO), Mohania, Pradeep Kumar told PTI. "Prime facie it appears a money dispute might be the reason behind the incident. Further investigation is on and a manhunt has been launched to nab Ajay Paswan," he said.



### **UP's Dussehri mango** goes global

Utar Pradesh's push towards boosting farm exports has achieved a key breakthrough, with 1,200 kg of Dussehri mangoes (400 boxes, each weighing 3 kg) airlifted to Dubai, an official statement said on Sunday. Dispatched from Lucknow's Mango Pack House to Dubai-based importer Vergro Trading LLC, the USD-2,992 consignment signals a new global opportunity for the state's mango growers, it said. The consignment was flagged off by Dinesh Pratap Singh, Minister of State (Independent Charge) for Horticulture, Agricultural Marketing, and Agricultural Foreign Trade. Under the Indo-German AMD Project, three Farmer Producer Organisations (FPOs) from the Lucknow region were trained and empowered for agricultural export. Among them, Irada Farmers Producer Company Limited and Malihabad Farmer Producer Company Limited have secured direct export orders for Dussehri mangoes from Dubai. For the first time both the FPOs are independently exporting mangoes, making it a historic milestone for the state's mango growers.



### **Assets of smugglers bulldozed** in **Punjab**

Illegally acquired properties of two notorious drug smugglers were demolished by the authorities in Punjab's Ludhiana on Sunday, as part of the state's crackdown on the narcotics network, officials said. The operation was carried out by the Municipal Corporation Ludhiana with the support of Ludhiana Commissionerate Police. According to an official statement, Puniab's Special Director General of Police (law and order) Arpit Shukla said the action was part of the intensified drive to ensure drug smugglers not only face arrest but also lose assets acquired through illegal means. With demolition of these two properties, a total of 126 properties such illegal construction linked to drug smugglers have been razed since March 1, 2025, he said. In the first operation, a bulldozer was used to demolish the house of a notorious drug smuggler, identified as Gurpal, at street number 2 in Amarpura, Ludhiana, the statement said.

## AAP corners BJP govt over water crisis in Delhi

The Aam Aadmi Party (AAP) on Sunday hit out at the BJP government over water crisis in Delhi and questioned the ruling dispensation over the steps taken to address the situation.

There was no immediate reaction from the ruling BJP to the AAP's claims.

"There is water shortage across the national capital. There is water crisis in Deoli. Ambedkar Nagar, Model Town, Hari Nagar. People have also protested over the situation, but the government is sleeping," AAP Delhi state not able to reach the governconvener Saurabh Bharadwaj told a press conference.

Questioning the government over the steps being taken to address the issue, Bharadwaj said, "There is four

engine government in the BJP. want to ask -- how many tubewells have been installed by the government. I am not talking about the tubewells installed by the MLAs using their funds, but the ones installed by the government."

The AAP leaders use the "four-engine" term to refer to the BJP, which is at the helm at the Centre, in Delhi, in the MCD and also "controlling" the lieutenant governor's office.

"When we were in power, the LG and the BJP used to say that there is a problem in water management. Is the LG ment water management?" he asked. Echoing similar views, former party MLA Akhilesh Pati Tripathi said the "fourengine" government had completely failed.

### DNA tests identify 47 victims, including Rupani 24 bodies handed over to kin

Three days after the tragic crash of Air India flight AI-171 in Ahmedabad, which has so far claimed 270 lives, hospital authorities confirmed on Sunday the identification of 47 victims through DNA matching, including that of former Gujarat Chief Minister Vijay

Authorities have handed over 24 bodies to the victims' families, offi-

cials said on Sunday. Rupani was the

242 passenmembers on board Londonbound Air India flight AI-171 that

crashed on Thursday. The Gujarat government

has announced a state mourning for Rupani on Monday. A funeral procession will be

held in Rajkot in the evening. Boeing 787-8 Dreamliner crashed into a medical college complex moments after taking off from Sardar Vallabhbhai Patel International Airport at 1:39 PM on Thursday.

So far 29 people are reported to have died in the disaster on the ground which includes five MBBS students. Only one person from the aircraft miraculously survived.

Due to the severe condition of many bodies—burnt or disfigured—authorities are relying on DNA matching for identi-

"A total of 47 plane crash victims have been identified so far through DNA matching. Of these, the bodies of 24 victims have been handed over to their respective families.

These deceased were from Rajasthan and different parts of Guiarat." Additional Civil Superintendent Dr. Rajnish Patel told reporters.

He added that 14 of the identified victims were from Udaipur, Kheda, Mehsana, Ahmedabad, and Botad districts. Of the 51 people injured in the

incident, 38 have been discharged, while 13 are still undergoing treatment, said

Dr. Patel, a professor of surgery at the government-run B Medical College. According to Dr. Dhaval Gameti, president of the BJ

### Teen witness who filmed tragic plane crash grapples with trauma

What began as a simple curiosity to see an aeroplane up close turned into a trauma for 17-year-old Aryan Asari, whose mobile phone video of the ill-fated Air India flight AI-171 became a viral sensation. Shaken and deeply disturbed, Aryan

spoke to reporters before returning to his

home village in Gujarat's Aravalli district, 130 km from Ahmedabad, and expressed hope that he would escape the images of the crash he accidentally recorded. After reaching his father's rented house in Meghaninagar around 12:30 pm on Thursday, located between the airport and

the crash site, he learned that aircraft often flew low overhead. Intrigued, he headed to the terrace, eager for a never-before-seen perspective. Aryan, a Class 12 student from Shamlaji

taluka, arrived in Ahmedabad on June 12 to buy textbooks for the upcoming school



"I had just reached my father's house around 12:30 p.m. and went up to the rooftop after learning that planes fly low," Aryan, who spoke in broken Hindi and Gujarati, said.

"I was recording a video of a plane flying low out of curiosity because I had never seen one from such a close distance," he added.

His recording turned into a horrifying eyewitness account.

"When the plane started descending, I

thought it was going to land on the other side of the airport. Then it crashed and burst into flames

right in front of my eyes. It was terrifying," he told reporters, the memory clearly affecting him. The tragic incident saw 241 of the 242 lives on board the London-bound Boeing

787-8 perish, along with 29 people on the

ground as the aircraft plunged into a medcal college campus shortly after takeoff. Aryan's father, who retired from the

Army, had recently taken up a security guard job with the Ahmedabad Metro, which led him to this rented accommodation in Meghaninagar - a location where the tragedy took place.

House owner Kailashba confirmed Aryan's account, adding, "He had come to Ahmedabad for the first time and within hours of his arrival, he ended up witnessing such a horrific event. The video he captured was initially sent to his father and later went viral".

## Despite SC nod, HCs not keen on appointing retired judges

PNS NEW DELHI

Despite the Supreme Court clearing the idea nearly five months ago, the high courts seem not to be keen on appointing ad-hoc judges to tackle pending criminal cases, details available with the government showed.

According to people aware of the procedure to appoint Supreme Court and high court iudges, none of the high court collegiums have so far recommended names of retired judges to be appointed as ad-hoc

There are 25 high courts in the country. Till June 11, no high court collegium sent any such proposal to the Union Law

Considering a backlog of over 18 lakh criminal cases, the



Supreme Court on January 30 allowed the high courts to appoint ad-hoc judges, not ceeding 10 per cent of the court's total sanctioned strength.

Article 224A of the procedure, the respective high Constitution allows the court collegiums send recomappointment of retired judges mendations or names of candias ad-hoc judges in high courts dates to be appointed as HC to help deal with pendency. judges to the Department of According to the laid down Justice in the law ministry.

The department then adds inputs and details of the candidates before forwarding the same to the Supreme Court Collegium.

The SC Collegium then takes a final call and recommends to the government to appoint the selected persons as judges.

The president signs the 'warrant of appointment' of the newly-appointed judge.

The procedure to appoint ad-hoc judges will be the same except that the president will not sign the warrant of appointment. But the assent of the president will be sought for appointing adhoc judges.

Except in one case, there is no precedence of appointing retired udges as ad-hoc HC judges,

officials had earlier pointed out. In a judgement dated April 20, 2021, on the appointment of the top court imposed certain conditions. However, later a special Supreme Court bench comprising then Chief Justice Sanjiv

Khanna, Justices B R Gavai (incumbent CJI) and Surya Kant relaxed certain conditions and kept some in abeyance. The verdict, which was authored by former chief justice S A Bobde, directed retired

that ad-hoc judges cannot be appointed if a high court was working with 80 per cent of its sanctioned strength, the other said ad-hoc judges could sit separately on benches to deal with





### Middle East on the brink of war

Israel's attack on Iran's nuclear installations and Iran's retaliation could be detrimental to the world peace n a dramatic escalation of long-standing tensions, Israel launched two massive waves of airstrikes on Iran, targeting key military and nuclear installations. In retaliation, Iran unleashed a barrage of ballistic missiles, marking the most intense direct military confrontation between the two nations in modern history. As both countries trade blows with unprecedented ferocity, fears are mounting of a full-scale war that could engulf the entire Middle East and destabilise the global geopolitical balance. The Israeli strikes - reportedly involving over 200 aircraft - targeted more than 200 Iranian sites, including major nuclear facilities in Isfahan and Fordow, as well as military command centres.

At least two high-ranking military officers and six nuclear scientists of Iran were killed, including Gen Hossein Salami, head of the Islamic Revolutionary Guard Corps (IRGC), and Gen Mohammad Bagheri, Iran's

Iran responded by launching hundreds of ballistic missiles, with explosions reported over Tel Aviv and Jerusalem, Israeli air defences intercepted many of the projectiles, but the scale of the attack shook the nation. The risk of the conflict spiralling into a broader regional war is high. Iran's allies, including Hezbollah in Lebanon, the Assad regime in Syria, and various armed groups in Iraq and Yemen, are likely to jump into the fray. If they do, Israel could be forced to open multiple fronts, dragging other regional powers such as Saudi Arabia, the UAE, and Turkey into a widening conflict. In such a scenario, oil shipping routes in the Strait of Hormuz could be jeopardised, sending global energy markets into turmoil. Moreover, any direct or indirect involvement by the United States or NATO members could trigger a wider confrontation involving Russia and China, both of which maintain strategic ties with Tehran. The Middle East, already a fragile and volatile region, could become the epicentre of a new and devastating global conflict. US President Donald Trump has openly supporting Israel's actions, though he declined to comment on US actively participating in the conflict - fuelling speculation about behind-the-scenes American support. Trump's statements could embolden Israeli leadership while further alienating Iran, complicating any prospects for de-escalation.

This escalation occurs against the backdrop of ongoing Israeli military operations in Gaza. With global attention now shifting to the Iran-Israel crisis, humanitarian issues in Gaza may receive less international scrutiny, potentially allowing Israel to intensify its campaign there with reduced diplomatic pressure. The Israel-Iran conflict has shifted from proxy skirmishes to direct confrontation, shaking the foundations of Middle Eastern stability. With powerful militaries on both sides and no signs of deescalation, the potential for a regional or even global war looms large. World leaders must act swiftly and decisively to prevent a catastrophic war . Diplomatic channels must be reopened, ceasefires negotiated, and a broader vision for regional peace revisited. The world cannot afford to let the flames of war spread unchecked — too much is at stake, not just for the Middle East, but for humanity at large.

## Odia cuisine: Steeped in history, legacy and flavour!

From the humble kitchens of agrarian homes to the grand Mahaprasad served in the Jagannath Temple, Odisha's culinary heritage is a gentle yet powerful testament to balance, subtlety, and soulful nourishment

disha, formerly known as Kalinga and Útkal, has a rich history dating back to ancient times. It begins in the Lower Palaeolithic era, also called Early Stone Age, as Acheulian tools dating to the period have been discovered in various places in the region. The state also finds mention in writings found in ancient texts like the Mahabharata, Maha Govinda Sutta, and some Puranas. The Kalinga War (261 BCE), a conflict between the Mauryan Empire (led by Ashoka) and the independent kingdom of Kalinga, was a pivotal event in ancient Indian history — it led to Ashoka's conversion to Buddhism and the subsequent shift in his policy toward peace and Dharma. The Ashoka Chakra, also known as the Dharma Chakra, which is found in the centre of our national flag, was introduced by Emperor Ashoka after the Kalinga War. The war had a deep impact on the emperor, leading him to embrace Buddhism and pursue a policy of peace and nonviolence called Dhamma.

Therefore, the history and heritage of the state is indeed a testimony to India's historical depth — it is immense, significant, and second to no other! This spectacular range of the state completes a full circle through its most impressive culinary repertoire. Kalinga was famous for its prosperous trade routes and cultural exchanges, and as a result, the food is a treasure trove of flavours, a symphony of simplicity, centuries of outstanding traditions, and a most exquisite deployment of aromatic flavours. It is the balance of the cuisine that stands out full of flavour, and yet, no overpowering ingredients — it's subtle, it's nuanced, and it is this innate feature that makes the Odia cuisine — one of a kind! It's now time to dive into the food offerings from the state — after all, the proof of the pudding is in the eating!

The state's cooking uses the Pancha Phutana — a five-spice blend consisting of cumin, fenugreek, mustard, aniseed, and onion seeds — in this, the level of spice and oil is on the lower side. Interestingly, the snacks have higher spice levels, and this is seen in the very popular Gupchup — semolina or wheat-fried balls filled with sweet and tangy water and known in many parts of India as Pani Puri. An ode to simplicity and mild flavours can be found in Santula — vegetable curry or stew cooked with minimal spices — it can be prepared in two ways, fried (bhaja santula) or boiled (sijha santula). The versatility of the cuisine is exhibited through Pitha — rice pancakes or dumplings — filled



with sweet or savoury mixtures, they can be pan-fried, deep-fried, steamed or baked and have numerous variations that include Kakara Pitha, Chakuli Pitha, Manda Pitha, Poda Pitha and so on, and then there is Besara — a tangy vegetable of fish curry that is thickened using a distinctive mustard paste or masala. The vegetable Besara (a popular variant) is often

included in the Chhappan Bhog, or 56 dishes, offered as Mahaprasad at the Puri Jagannath Temple. Odisha's deep connection with the agrarian communities is showcased through Pakhala Bhata, a culturally significant dish made from cooked rice soaked in water and is often fermented; it is the state's answer to the scorching summer months. Dalma

 considered the heart and soul of Odisha's everyday meal (eaten for breakfast and/or dinner) is made using lentils and vegetables, mildly seasoned with spices and topped with grat-

The eastern coastal state's splendid contrast of textures is displayed through Badi Chura - a crunchy delight made from crushed dried lentil dumplings (badi) mixed with spices, and often served with plain rice or Pakhala (fermented rice). The humble Khichdi (rice cooked with lentils), is called Khechudi in Odia cuisine — the state has several variations of it, like Ada Hengu Khichdi, Nabagraha Khichdi, Nikura Khichdi, Dala Khichdi these are wholesome and nourishing and are common in households across the state. Fish is one of the undisputed stars of Odia cuisine, and dishes like Machha Ghanta — fried fish head in an onion, potato, and garlic curry is a household favourite and a Durga Puja delicacy. Another variety is the Mahura Fry a fried fish preparation, specifically using hilsa or Indian herring, and then there is Machha Mahura, a traditional Odia fish curry made with steamed, deboned, and then fried fish, along with vegetables.

Prawns too are consumed generously and recipes like Chingudi Kasa, a dried version of the jhol or prawn curry made with prawns fresh from Chilika Lake, is a regional gem and a good example of the state's unique culinary identity. A cuisine being spoken of and the sweet element missing? Inconceivable! And in the case of Odia cuisine, a formidable line-up is visible — it is reflected through dishes like Chhenna Poda, made from fresh paneer (Indian cottage cheese) and baked until it develops a caramelised crust and a soft and sweet interior. It is known for its distinctive burnt appearance and bold taste. Another delight is Kanika (an aromatic sweet rice dish), prepared during festivals and pujas and a staple in the 56 dishes (Mahaprasadas) offered at the Jagannath temple in Puri. It is known for its mild sweetness and flavourful aroma and incorporates basmati rice, ghee, dry fruits, turmeric, sugar, and whole spices.

Khiri Payesh is Odisha's comfort dessert and is made using jaggery or sugar, roasted dry fruits, and cow ghee, all of which undergo a boiling process. Some of its variations also use saffron, cardamom, and nuts to add flavour. A sweet that looks similar to the iconic Malpua is called Rasabali; however, its main ingredient is only chhenna (fresh curd cheese). It is a thin, doughnut-shaped fresh chenna patty that is deep-fried in rice bran oil an important source of unsaturated fats, vitamin E, and other beneficial compounds like oryzanol. Another flavour bomb from the state is Khasta Gaja — a dish exhibiting a crispy texture on the outside and a soft and juicy texture on the inside, it is made by frying diced pieces of dough in oil and soaking them in sugar syrup; the dish is often prepared

during marriages, festivals, and various other celebrations. Odisha's twist to the famous Rasamalai is found in Khira Sagara — tiny semi-flat marble balls of chhena boiled in sugar syrup, then soaked in thick skimmed milk, and seasoned with sugar, saffron,

And finally! There is one, the most famous and divine offering (literally) from the state — the Rasagola. In fact, it is Odisha where it originated and travelled to different parts of the country. The journey began in the 11th century and is associated with a story of Lord Jagannath pacifying an angry goddess Laxmi with a sweet — any guesses? Yes — the Rasagola, whose delicious versions are found in different parts of the state like Salepur, Pahala, and Behrampur. Today, there is a trend among the youth to consume fad foods — it is therefore critical that our regional chefs take the mantle of converting their cuisines, along with their prolific art forms. They have to be mindful of keeping the original ingredients and their nutritional values intact, but at the same time, modernising their cuisines to attract our youth. I believe this will nudge them to consume, and increasingly benefit from, the rich heritage of our interminable regional cuisine

## Why India's forest investments need carbon MRV



rndia is witnessing an unprecedented scale of investment in ecological restoration, particularly through Government programmes like the Compensatory Afforestation Fund Management and Planning Authority (CAMPA) and the Green India Mission (GIM). These initiatives aim to restore millions of hectares of degraded forests and increase forest and tree cover as a part of India's commitments under the Paris Agreement and Nationally Determined Contributions (NDCs). However, while financial allocations under these programmes have been substantial — amounting to over

₹30,000 crore in CAMPA alone — the real question is: Are these investments delivering measurable outcomes in terms of forest health, biodiversity conservation, and climate resilience?

Conventionally, the success of afforestation projects has been assessed through basic indicators such as the number of trees planted or hectares covered. These metrics, though easy to report, often fail to reflect the actual ecological quality of restored forests. Ground truthing remains inconsistent, and survival rates are poorly tracked. This disconnect highlights the urgent need for modern, science-based moni-

toring systems that can accurately measure the impact of forest investments. Enter the Monitoring, Reporting, and Verification (MRV) systems designed for carbon credit pro-

national standards such as Verra and Gold Standard, provide a rigorous framework for tracking forest growth, carbon seques tration, and co-benefits.

What makes these MRV systems particularly useful for public forest programmes is their ability to combine remote sensing technologies, GIS mapping, and permanent sample plots (PSPs) for accurate field measurements. In addition, socioeconomic indicators - such as employment generated, participation of women, and income from non-timber forest produce — can also be embedded into the monitoring framework. Beyond providing transparent and verifiable data, carbon

MRV systems also enable participation in carbon markets. The data generated can be used to quantify the amount of carbon sequestered, which in turn can be converted into tradable carbon credits. These credits can be sold on voluntary or compliance markets, attracting corporate ESG investments and climate finance. This creates a unique opportunity: the same system used to monitor ecological performance can also unlock financial value, ensuring the sustainability of operations and long-term maintenance of restored forests. To explore the applicability of this approach, a pilot deployment of carbon MRV is proposed in

selected CAMPA and GIM sites. The pilot would begin by establishing ecological baselines through a combination of satellite imagery and field sampling. This would be followed by

jects under ARR (Afforestation, Reforestation, and periodic assessments to track tree growth, canopy recovery, involve monitoring carbon sequestration along with the associated socioeconomic benefits. To ensure transparency, publicly accessible dashboards would be developed and maintained. The costs of Monitoring, Reporting, and Verification (MRV) would be funded through a share of the carbon credits generated. Overall, this pilot could serve as a proof of concept for integrating MRV into mainstream forest governance.

For successful integration, policy guidelines must evolve to formally recognise MRV as a standard component of afforestation projects. Capacity building at the forest division level, investment in digital tools, and partnerships with technical agencies will be key enablers. States like Karnataka, Madhya Pradesh, and Odisha — where large tracts of afforestation have been undertaken — can emerge as leaders in deploy-

ing MRV-based impact monitoring.

Moreover, convergence with CSR programmes and international climate funds like GCF can amplify resources. India has both the ambition and the ecological necessity to scale up forest restoration. However, ambition without accountability risks inefficiency. By adopting Carbon MRV systems, India can transition from input-based to impact-based forestry. The dual benefit of accurate monitoring and carbon finance makes MRV a game-changing tool for forest governance.

### **ISRAEL AND IRAN IN FULL-**SCALE CONFRONTATION

he most dangerous and very serious war has broken out as Israel launched blistering attacks on the heart of Iran's nuclear and military structure on Friday, June 13, deploying warplanes and drones previously smuggled into the country to assault key facilities and kill top generals and scientists — a barrage it said was necessary before its adversary got any closer to building an atomic weapon. Iran retaliated late on Friday with full force by unleashing scores of ballistic missiles on Israel, where explosions flared in the skies over Jerusalem and Tel Aviv.

A hospital in Tel Aviv treated many people wounded in the second Iranian barrage; Israel's Fire and Rescue Services said they were injured when a projectile hit a building in the city. Iran's Supreme Leader Ayatollah Ali Khamenei said in a recorded message on Friday: "We will not allow them to escape safely from this great crime they committed." Iran's UN ambassador said 78 people were killed

and more than 320 wounded in Israeli attacks. Israel's paramedic services said 34 people were wounded in the barrage on the Tel Aviv area, including a woman who was critically injured after being trapped under rubble.

In Ramat Gan, east of Tel Aviv, an Associated Press journalist saw burnedout cars and at least three damaged houses, including one where the front was nearly entirely torn away. US ground-based air-defence systems in the region were helping to shoot down Iranian missiles, said a US official who spoke on the condition of anonymity to discuss the measures. Israel's ongoing airstrikes and intelligence operation and Iran's retaliation raised concerns about an allout war between the countries and propelled the region, already on edge, into even greater upheaval. With this, the world is heading for World War III with destruction and heavy casualties



## **Empowering State Public Universities** to Power the Vision of Viksit Bharat

ndia is home to the second largest higher education ecosystem in the world, with 4.33 crore students and nearly 15 lakh faculty across 1,168 Universities, 45,473 Colleges and 12,002 Standalone Institutions. While 'Institutions of National Importance' and 'Central Universities' have made their mark in frontier areas of knowledge and dominate national priorities, it is the nearly 500 'State Public Universities (SPUs) and their over 46,000 affiliated institutions that are the backbone of its higher education system. They currently cater to over 80 per cent of students. Technically, SPUs are established or incorporated by a Provincial or State Act, funded by the State Governments, and under their realm of control. However, given their phenomenal reach and hence their vital role in grooming talent across the country, their transformation is a collective national responsibility.

By 2035, the NEP 2020 target is to achieve a GER in higher education of 50 per cent. This implies doubling enrolment in our higher education institutions to nearly 9 crores over the next decade, with almost the same proportion of students continuing to study in SPUs. There are several outstanding SPUs, but the quality of higher education being imparted in many SPUs is hampered by a plethora of challenges. The primary one is the lack of high-quality physical and digital infrastructure. Limited funding negatively impacts the quality of research. Shortage of faculty adversely affects the pupil-teacher ratio. Above all, students' employability is a major concern.

Published research has also observed that increased devolution of funds to States under the 14th and 15th Finance Commission cycles has not led to a consequent increase in several State Governments' funding of social sectors, especially higher education. A fall in average growth rates in higher education expenditure in States during 2015-20 is evident, with median value coming down to 6.6 per cent compared to 10 per cent during 2005-10 and 2010-15. There are States with negative growth rates in spending on higher education.

While India's higher education sector has witnessed remarkable growth over the last seven decades, the pressing challenge now lies in ensuring high quality. NITI Aayog's recent report on Expanding Quality Higher Education through States and State Public Universities' focuses on this and attempts to bring higher education to the centre of India's development and policy discourse. An outcome of extensive consultations across 20 States and UTs and with over 50 SPUs, it makes nearly 80 policy recommendations across 12 sub-themes to address major systemic and institutional challenges. Many interventions around internationalisation, governance and financial autonomy are geared towards 'Leading' SPUs, those that feature in the top 50 SPUs in NIRF 2024 Rankings, given that they



are likely to possess in-nouse technical, managerial, and financial capacities to implement the suggested reforms. We provide a snapshot of policy recommendations and action pathways across four key themes.

The establishment of Research Hubs and Centres of Excellence in clusters of SPUs to leverage their core competencies and provide solutions to regional challenges can be a transformative step. Institutionalising holistic education including environment, human values and global citizenship education in the curricular and co-curricular domains of SPUs is a much-needed reform to create students with high levels of intelligence, and emotional and spiritual quotients. Handholding 'Leading' SPUs in each State to transition to MERUs (Multidisciplinary Education and Research Universities), creating career pathways in research, and encouraging student and faculty-led research commercialisation and start-ups can bring research centre stage in SPUs. 'Leading' SPUs can also promote internationalisation through long-term partnerships for joint research projects, and faculty and student exchange programmes.

State Higher Education Councils and State-level NITI Aayogs can play an important role in preparing State-level Higher Education Vision and Implementation Roadmaps for 2047 by identifying priority areas. At the institutional level, a shift towards a 'regulator-facilitator' model for SPUs and granting greater autonomy to 'Leading' SPUs in areas like governance, curriculum development, and faculty recruitment is crucial. This must be combined with capacity building of faculty and administrators to ensure that academic and research standards are upheld. Given the scale of students that need to be provided higher education over the next decade, an all-hands-on-deck strategy is essential to mobilise funding and financing from all quarters including Governments, industry, and civil society. 'Leading' SPUs must be empowered to devise

internal revenue generation strategies by expanding self-financed programmes in high-demand areas, establishing consultancy units, leveraging CSR funds, encouraging alumni and philanthropic contributions, and exploring innovative PPP models for infrastructure development and research. Enhancing autonomy to 'Leading' SPUs in financial decision-making including inflation-adjusted fee setting must be balanced with a robust system of merit-cummeans scholarships such that no deserving student is deprived of access to higher education.

Faculty must be encouraged to design and deliver industry-relevant courses to align with national needs. Promoting internships, apprenticeship-embedded degree programmes, and workbased learning opportunities is of equal importance to ensure employability. This requires strengthening collaborations with Sector Skill Councils, industry partners and trade associations to bridge the education-employability gap. It is equally essential that SPUs transition from a job-seeking to a job-creation mindset. Impetus must also be provided to physical education and wellness courses, language proficiency and lifelong learning programmes, to contribute to holistic and continuous student development. Many SPUs possess spare infrastructural facilities. In evening hours, these may be utilised to deliver short-term skilling programmes and generate additional revenues.

Given the prime importance of SPUs in India's higher education ecosystem, their transformation into becoming institutions of excellence providing high-quality education is a sine qua non for reinforcing our position as a global hub of knowledge and talent. Above all, this transformation of SPUs is vital for our endeavour to emerge as a Viksit Bharat by 2047.

Modern psychology recognises this dual nature of anxiety. Experts suggest a two-pronged strategy to manage such mental states: monitoring

to manage such mental states: monitoring and blunting. Monitoring involves conscious awareness and proactive action, while blunting refers to tactical distraction or redirection of energy. Monitoring begins with preparation-a form of tapasya or dedicated effort. One must cultivate a disciplined, resilient mind through regular practice. Just as Arjuna honed his archery, we must rehearse for the challenges life presents. Visualisation, too, plays a crucial role-mentally enacting success helps clear mental clutter and dispel fear.

success helps clear mental clutter and dispel fear.

Another useful approach is the inoculation technique, which involves repeated exposure to stressors in a controlled environment, thereby building resilience. Alongside this, it is wise to conduct a self-inventory: What are my weaknesses? How can I overcome them? What resources-internal and external-can I rely on? Ca Support from family, friends, peer groups, and motivational reading can reinforce this internal effort, nurturing a positive and constructive mindset.

On the other hand, blunting strategies help in decompressing the mind. Immersing oneself in physical activity-be it walking, swimming, gym workouts, sports, or yoga-releases endorphins and alleviates mental stress. Programs like the Art of Living's Happiness Program, with techniques such as Sudarshan Kriya, teach breathing patterns that synchronise body and mind, ushering in calm and clarity. But let us not forget the value of focused micromanagement. Detail-orientation is often the hallmark of high performers, whether they are spiritual seekers, relentless politicians, meticulous writers, creative artists, or legendary athletes. Take for example, Aamir Khan, an actor known for his perfectionism and innovative approach to every role. His dedication to craft isn't accidental; it is the product of relentless

effort and conscious refinement.

Consider also the political strategist whose calculating gaze is both feared and admired. With a mind steeped in Kautilya's Arthashastra, and a passion for chess, such a figure exemplifies mental preparedness and strategic foresight.

Or think of Sunita, a modest young woman from a remote town in Bihar. Raised in turbulent surroundings, she carved her path into India's esteemed Civil Services through sheer determination and hard workmotivated by the reverence accorded to bureaucrats in her region.

Then there's Hemant Sharma, a soldier who lost his limbs in a terrorist attack while serving in Kashmir. Refusing to be confined by tragedy, he trained to embark on a spiritual expedition to Mount Kailasa. His radiant smile masks his pain, embodying the triumph of the human spirit. What drives such individuals? Motivation. Psychologists describe a motivation cycle: a perceived need triggers a drive, which leads to arousal, goal-directed behavior,

achievement, and finally, a reduction in arousal. This cycle repeats, sustaining human activity. Our motives are broadly cate-

activity. Our motives are broadly categorised into physiological and psychological. Physiological motives arise from our biology-hunger, thirst, and sex-all regulated by neural and hormonal signals. Hunger may be stimulated by glucose levels or stomach contractions. Thirst is triggered by cell dehydration and reduced blood volume. Sexual desire, influenced by hormones, is shaped by both biology and cultural conditioning.

Psychological motives, on the other hand, stem from our environment, relationships, and aspirations. These include the desire for achievement, recognition,

affiliation, power, and the pursuit of knowledge or self-actualisation. Such motives often transcend survival-they shape the very meaning of our existence. Can one transcend the endless loop of motivation and desire? Ancient wisdom points the way. Sage Ashtavakra spoke of the stillness of the human mind as the ultimate goal. He taught that everything-every act, every emotion-arises and fades, and none of it should disturb our inner peace. Liberation lies in mindfulness and detachment — not as indifference, but as awareness without entanglement. Thus, the human mind is both the battlefield and the charioteer. It can be overwhelmed, like Arjuna's, or it can rise, illuminated by awareness and anchored in inner steadiness. Motivation, then, is not just a drive-it is a sacred responsibility. When channelled mindfully, it enables us not just to achieve-but to evolve. Let us strive, not merely to act, but to act with clarity, awareness, and purpose.

### **Hero FinCorp garners Rs 260 cr from investors**

ero FinCorp, the financial services division of two-wheeler manufacturer Hero MotoCorp, has raised Rs 260 crore in a pre-IPO placement round. This fund mobilisation led to a reduction in fresh issue size to Rs 1,840 crore from the earlier planned Rs 2,100 crore. The total IPO size now stands at Rs 3,408 crore, which includes a Rs 1,568 crore offer-for-sale (OFS) by existing investors. This marks a reduction from the earlier planned Rs 3,668 crore. Those selling shares in the OFS are -- AHVF II Holdings Singapore II Pte. Ltd, Apis Growth II (Hibiscus) Pte. Ltd, Link Investment Trust (through Vikas Srivastava) and Otter Ltd. In the pre-IPO round executed on June 5, Hero FinCorp entered into investment agreements with 12 investors, allotting 18.57 lakh shares at Rs 1.400 per share on June 13, raising Rs 259.99 crore, according to a public announcement by the company. Under this, the company allotted shares worth Rs 69 crore to Shahi Exports, RVG Jatropha Plantation (Rs 50 crore), Mohan Exports (Rs 25 crore), and AP Properties (Rs 22 crore).



### **Madhvani Group plans** Rs 10,000 cr investment

Madhvani Group, a large Ugandan conglomerate with diversified investments spanning several sectors across Africa, the Middle East, and North America, has said it plans to invest Rs 10,000 crore in Inida over the next five years. Madhvani Group's promoter Shrai Madhvani called on Prime Minister Narendra Modi on Saturday and during the meeting he apprised the prime minister about the Group's various initiatives including its acquisition bid of Hindustan National Glass & Industries Ltd (HNGIL), a leading container glass manufacturer. He informed that the Group is exploring investments of up to Rs 10,000 crore over the next five years, which is expected to generate substantial employment and contribute to industrial growth, Madhvani Group said in a statement on Sunday. Commending Prime Minister Modi's visionary policies such as Ease of Doing Business, Make in India, and the government's pro-business outlook, Madhvani acknowledged that these initiatives played a vital role in the Group's decision to invest in India.



### Kolkata port records strong cargo growth

Syama Prasad Mookerjee Port (SMP), Kolkata, on Sunday said it began FY26 on a strong note, recording a 27.56 per cent year-onyear growth in cargo handling during April-May 2025, despite global geopolitical tensions. The port handled 11.252 million metric tonnes (MMT) of cargo in the two-month period, up from 8.821 MMT during the same time last year, officials said. Of the total cargo handled, Haldia Dock Complex (HDC) accounted for 8.139 MMT, while Kolkata Dock System (KDS) handled 3.113 MMT. This represents a 27.45 per cent increase at HDC and 27.84 per cent at KDS over April-May 2024, the port said in a statement. The Kolkata-based riverine port had a robust growth across multiple cargo segments, officials added. HDC saw higher volumes of petroleum products, other liquids, vegetable oil, various categories of coal, fly ash, and containers. KDS also posted increased handling of finished fertilizers, pulses, foodgrains, timber, and container cargo, it added.

## **G7** leaders gather in Canada amid Middle East crisis, Trump's tariffs

Leaders of some of the world's biggest economic powers will arrive in the Canadian Rockies on Sunday for a Group of Seven summit overshadowed by a widening war across the Middle East and US President Donald Trump's unresolved trade war with allies and rivals alike. Israel's strikes on Iran and Tehran's retaliation, which appeared to catch many world leaders unawares, is the latest sign of a more volatile world as Trump seeks to withdraw the US from its role as world policeman.

Speaking on a flight to Canada to attend the summit, British Prime Minister Keir Starmer said he had discussed efforts to de-escalate the situation with Trump and Israeli Prime Minister Benjamin Netanyahu, as well as other world leaders. Britain is sending Royal Air Force jets and other military reinforcements to the Middle East.

"We do have longstanding concerns about the nuclear program Iran has. We do recognise Israel's right to selfdefense, but I'm absolutely clear that this needs to de-escalate. There is a huge risk of escalation for the region and more widely," Starmer said,



adding he expected "intense discussions" would continue at the summit.

Trump is summit's wild card As summit host, Canadian Prime Minister Mark Carney has decided to abandon the annual practice of issuing a joint statement, or communique, at the end of the meeting. With other leaders wanting to talk to Trump in an effort to talk him out of imposing tariffs, the summit risks being a series of bilateral conversations rather than a show of

Trump is the summit wild card. Looming over the meeting are Trump's inflammatory

threats to make Canada the 51st state and take over Greenland. French President Emmanuel Macron is making a highly symbolic stop in Greenland on his way to Canada, meeting the Arctic territory's leader and Denmark's prime minister aboard a

Danish helicopter carrier. Macron, who is one of the very few leaders to have known Trump during his first term, was the first European leader to visit the White House after Trump took office, emerging unscathed from the Oval Office encounter. But despite the two leaders' sporadic bromance, Macron's approach to Trump

has failed to bear major results, with France caught up in the president's planned tariffs on the European Union.

Nor did it bring any US security guarantees for Ukraine despite Macron's efforts, together with Starmer, to build a coalition of nations that could deploy forces after any ceasefire with Russia, with the hope it would convince the Trump administration to provide backup. Trump is scheduled to arrive late Sunday in Kananaskis, Alberta. Bilateral meetings between other leaders are possible Sunday, but the summit program does not get underway until Monday.



### Iran-Israel war could hurt exports; increase freight rates: Exporters

The Iran-Israel conflict has further increased global economic uncertainties, impacting world trade, including India's exports, as it is expected to drive up both air and sea freight rates, exporters say.

They said that India's exports to Europe and counters like Russia may get impacted due to this war. If the conflict continues for long, the movement of merchant ships through routes such as Strait of Hormuz between Iran and UAE, and Red Sea would be affected.

"The war will further hurt global trade. The situation was gradually improving but now again the trade will be impacted. Our exports to Europe and countries like Russia may get hurt. Freight rates and insurance are expected to increase," Federation of Indian Export Organisations

President S C Ralhan said.

Indian export consignments gradually started moving through the Red Sea route but now again it would get impacted, he said. The immediate fallout of

the conflict that started on early Friday or June 13 will be freight and insurance charges going up after a period of calm as Red Sea routes were slowly coming back to normal, Mumbai-based exporter and Technocraft Industries Ltd Founder Chairman S K Saraf said. If Iran-Israel war would continue for a week then the situation will be difficult for global trade, Saraf said, adding, Iran and Israel too are our big trading partners".

Cargo ships had gradually returned on Red Sea routes, saving them 15-20 days while moving to US and Europe from India and other parts of

### Govt must urgently review energy risk scenarios due to Iran-Israel war: GTRI

With the Israel-Iran conflict intensifying, the government must urgently review energy risk scenarios, diversify crude sourcing, and ensure strategic reserves are sufficient, think tank GTRI said on Sunday.

Due to the war, India is increasingly at risk of collateral economic fallout, with energy security, trade routes, and key commercial interests facing growing uncertainty, the Global Trade Research Initiative (GTRI) said.

"The escalating hostilities and rising regional tensions are posing direct threats to India's strategic and economic links with West Asia," GTRI Founder Ajay Srivastava said, adding India has significant trade

In 2024-25, India exported goods worth USD 1.24 billion to Iran and imported USD 441.9 million in return. Trade with Israel was even more substantial, with USD 2.15 billion in exports and USD 1.61 billion in imports.



### Markets to track Iran-Israel conflict, crude oil, US rate decision: Analysts

Stock investors will track the ongoing conflict between Iran and Israel, Brent crude oil prices, inflation data and the US Fed interest rate decision for further cues this week, analysts said.

Tariff-related news would also dictate trends in the equity market, experts noted. Stock markets faced height-

ened volatility last week and ended in the r ing geopolitical tensions, which sparked a risk-off sentiment. Investor sentiment was hit hard on surging oil prices as fears of supply disruptions resurfaced.

"Indian stock markets are likely to follow the global trend, following rising tension in the

Middle East amid the Israel-Iran conflict, which could fuel further pessimism and prompt investors to flee riskier assets. Also, traders will exercise caution ahead of the US Federal Reserve interest rate decision on Wednesday, coupled with other central banks of Japan and the UK announcing their interest rates separately," Ketan Vikam, Head of Sales at financial services provider Almondz Institutional Equities, said.

Equity ben Sensex and Nifty tumbled nearly 1 per cent on Friday last week as weak global markets and a spike in Brent crude oil prices weighed on investor sentiment.

Looking ahead, investors are expected to remain cautious amid premium valuations and geopolitical risks.

## AC makers lower sales projection to 10-15%

Unrelenting heatwave across north and east regions has spiked sales of room air-conditioners (RAC) in June, but intermittent rains in several part of the country amid peak demand season have forced the industry players to lower sales projections to 10-15 per cent for this year. The summer, which is the

peak season for sales of room air-conditioners, has disappointed AC makers this time, though there are some silver lining in June with impulse purchases happening due to the heatwave. RAC makers said after having an encouraging numbers in February and March, helped by an early arrival of summer, they digit volume growth of around 25 per cent from the last year, and had also built up inventory. "We all had planned for a 25 to 30 per cent growth, which is not going to take place. This is a disappointing summer; that is the truth. It is part and parcel of the game," Blue Star Managing



Director B Thiagarajan said. "We have to manage the situation and move forward," he said, adding that now the RAC industry will end up with 10 to 15 per cent growth this year, despite a good start in February and March.

Department (IMD) had last week said that temperatures are likely to have a gradual drop from the mid of June as a western disturbance is expected to move in, bringing cooler winds, rain, and thunderstorms.

According to Thiagarajan, the current June quarter will be

bad for the RAC industry. However, he expects a bounce back in the September quarter. He expects some recovery in the festive season and also in the quarter when the energy label changes, as makers offer discounts to liquidate the old takes place whenever energy label changes are there. People will end up buying in that quarter," he said.

Voltas MD & CEO Pradeep Bakshi said in the last two months, there has been hardly any growth for the industry in comparison to 2024 sales.

Capital markets regulator Sebi resolved 4,493 investor complaints through its online grievance redressal platform SCORES in the month of May.

The regulator received 4,793 fresh complaints in the month and a total of 4,563 complaints remained unresolved at the end of May, slightly higher than the 4,263 complaints that were pending as of April 30, the Securities and Exchange Board of India (Sebi) said in a public notice on Friday. The regulator also highlighted that the average resolution time taken by the entities to submit the Action Taken Reports (ATRs) in May was eight days, while the average time taken for complaints under First Level Review was five days. SCORES, or Sebi Complaint Redressal System, is an online platform which facilitates investors in lodging and tracking complaints against listed companies and regis-

Under the SCORES 2.0 mechanism, complaints are automatically forwarded to the respective entities, which are required to respond within 21 days.

## **'REPRESENTING CRAFT ISN'T LIMITED TO A** SPECIFIC EVENT—IT'S SIMPLY PART OF WHO I AM'

halini Passi didn't just walk the red carpet at the 77th Cannes Film Festival—she carried a story, a legacy, and a vision stitched into every thread of her ensemble. Representing Longitude 77, her debut on the iconic steps wasn't about spectacle; it was about substance. A longtime patron of Indian art and design, Shalini arrived not merely as a guest but as a cultural envoy—graceful-

ly merging India's rich heritage with a modern, global sensibility. In a space known for glamour, she stood out for her intention, turning fashion into a narrative and the red carpet into a canvas for storytelling rooted in identity, artistry and pride.

"It felt surreal but, in all honesty, my first reacti feit surreal but, in all nonesty, my first reaction wasn't the typical jump-for-joy moment. I had so much going on at the time that my mind immediately went into planning mode. I started thinking: What date is it? How do I make this work? What needs to be done next?" Though she later realised the moment deserved more celebration, that initial response speaks volumes about the artist, collector and philanthropist she is—someone deeply grounded, organised and

thoughtful about her presence and purpose.

Known for standing at the unique intersection of fashion and art, Shalini's look for Cannes wasn't just about glamour—it was a carefully curated statement. "Design and architecture have always been deep passions—some times even more so than traditional art," she shares. Her Cannes ensemble, designed in collaboration with the celebrated couturier Manish Malhotra, was conceived as a story rather than just a garment.

Rooted in the concept of Longitude 77, the meridian that runs through the heart of India, the gown was symbolic of geographical identity and cultural richness. Indigo, a historically significant color associated with India's colonial past and creative legacy, took center stage in her ensemble, complemented by earthy camel tones

ensemole, complemented by earthy camel tones representing Indian soil and roots.

"I could have chosen a Western silhouette off the rack," she explains, "but I felt strongly about wearing something that was created just for me—something that reflected my personality, my aesthetic, and most importantly, my intention." For Shalini, this red carpet moment was a celebration of India's artistic soul, interpreted through fashion, and shared on one of the world's most international stages.

Having walked high-fashion carpets before, Shalini is no stranger to the grandeur of such events. But Cannes was different. "It's a truly international stage where art, cinema and creativity from around the world come together,"

This time was no exception. "For this trip, I packed a mix: beautifully crafted Indian sarees alongside couture gowns from some of the best designers. It's a blend of tradition and modernity, and that balance really reflects who I am." Her longstanding creative relationship with Manish Malhotra made him the natural collaborator for Cannes. "He truly understands my sensibilities, how I like a garment to fit, and the kind of impact I want it to create," she says. The designer's shared love for art made the process even more seamless and meaningful. Their goal was clear: to create a look that was steeped in heritage but expressed in a contemporary way—"rich in heritage, yet contemporary in its expression," as she puts it.

Indian textiles were not just included—they were highlighted. "We showcased unique Indian crafts and textiles, blending traditional techniques with contemporary styling," she says. Her efforts didn't go unnoticed. The international press responded with appreciation, acknowledging the authenticity and depth of the narrative behind her look.

### **TYPES OF MALE FERTILITY TESTS**

hen couples begin the journey of anatomical issues that might be complicating the fertility process. This can also involve a varicocele, swelling of veins in the scrotum and this will disrupt sperm production. Solutions for these can, at times, be re-established by treating these problems through surgery or any other form of intervention.

Hormonal testing

picture of sperm health and are considered critical in determining the chances of natural conception. Additionally, the semen analysis should be at least done twice within a span of two weeks; only then is it considered to be a problematic test, as it cannot be determined in a single test.

Early treatment

If the fertility problems are detected at an early age, then relevant treatment may be initiated and time would not be wasted. In some cases, small adjustments such as an improved diet, reduced intake of liquor, smoking cessation and stress management can enhance sperm quality to a significant extent.







## Rishab Shetty & crew narrowly escapes boat accident on Kantara Chapter 1 sets

ishab Shetty's much-anticipated film *Kantara* Chapter 1—a prequel to his critically acclaimed and award-winning Kantara—has once again encountered a serious setback. The latest incident, involving a near-fatal accident during the shoot, forced a sudden halt in production activities.

event:

According to multiple reports, a boat carrying Rishab Shetty and nearly 30 members of the crew capsised during a shoot sequence in the Mani reservoir, located in Karnataka. The vessel reportedly overturned in a shallow section of the reservoir, leading to a brief moment of panic among the team. Fortunately, all individuals onboard, including Shetty, escaped uninjured.

A crew member, speaking to the press, shared that the situation

turned chaotic after the boat unexpectedly flipped. "Everyone was scared when the boat toppled in the middle of the reservoir. But the water was shallow enough for everyone to get out quickly and safely reach the shore," the source

While no human injuries were reported, the mishap caused significant damage to the production's filming equipment. Key gear, including high-end cameras, is believed to have been lost underwater. The full extent of the damage is still being assessed.

Following the accident, the local police from Thirthahalli were promptly informed. Officials reached the location to conduct an initial inquiry and evaluate the circumstances that led to the mishap. A formal investigation has since been initiated to determine liability and examine safe-ty protocols on set.

Kantara Chapter 1 had been the

subject of speculation regarding a potential delay in its scheduled October 2 release. While rumours of postponement gained momen-tum due to the lack of recent updates from the production team, the filmmakers had reiterated on multiple occasions that the project remained on track for its planned theatrical debut.
This latest disruption has once

again raised concerns about possible delays, though there has been no official word from the production team regarding a change in schedule following the accident.

This is not the first time the production has faced turbulence. Previous reports have noted a series of unfortunate incidents during the shoot, making Kantara Chapter 1 a film that's been in the spotlight not just for its cinematic promise but also for the series of challenges it's facing behind the

"So yeah, he called me when the news broke out, I think a couple of days before. But I knew sometime before (the news flashed), but I didn't tell him because I wanted to tell him when it's official. But we had a very heartfelt conversation once he got to know that I've been named the captain,"

## Sam Burns holds steady on soggy Oakmont to lead US Open

**¬**he closest Sam Burns has come to a major championship is sharing a house with a close friend who already has three of them. He has been inspired by Scottie Scheffler the last few years. The next step is to join him as a major champion.

Burns held steady after missing a short par putt late Saturday in the US Open, responding with a beautiful pitch for a tap-in birdie and two scary putts down the hill from inside 60 feet to save par on the 18th hole at rainsoaked Oakmont for a 1under 69. That gave him a one-shot lead over majortested Adam Scott and JJ Spaun, with Viktor Hovland not far behind as the only four players to survive par.

Burns was at 4-under 206. He has five PGA Tour titles, the last one more than two years ago, and is coming off a playoff loss last week in the

Canadian Open. At stake for Burns is a chance for the 28-year-old from Louisiana to become the sixth American at 30 or under to capture his first major since 2020. Scheffler has won 19 times worldwide the

last three years, including three majors, most recently last month at the PGA Championship. "Scottie's obviously an incredible player. I don't think I need to say that," Burns said with a laugh. "We obviously spend a lot of time together and being able to talk to him and just kind of learn from him and ask him questions, it's been really cool."

Scheffler has won his three majors in what turned out to be blowouts. Sunday at Oakmont was shaping up to be anything but that.

Scott, who only climbed back into the top 50 in the world less than a year ago and hasn't seriously challenge in a major in nearly seven years, became only the third player at par or better for the opening three rounds in a US Open at Oakmont. He birdied three of his last six holes for a 67, getting into the final group when JJ Spaun made bogey from the bunker on the 18th hole and shot 69. Scott is the only player

among the top 10 who has won a major. That was 12 years ago at the Masters. No one has ever gone more than 11 years between their first and second major titles. "Putting ourselves in these

positions doesn't just happen by fluke," Scott said. "I really haven't been in this kind of position for five or six years, or feeling like I'm that player. But that's what I'm always working towards. It's not that easy to figure it all out.
