A high-intensity explosion ripped through a car parked near the Red Fort metro station on Monday evening, gutting several vehicles and killing at least eight people, officials said.

Twenty-four people were injured in the blast that took place on a busy evening when the area was milling with people. The injured were taken to the LNJP hospital a few kilometres away.

Videos shared by the Chandni Chowk Traders' Association showed the magnitude of the blast. A body could be seen lying on a vehicle. Another video showed a body lying on the

He said that the State is set to become a hub for quantum computing companies, technology experts, and component manufacturers. The minister stated Quantum that the Computing Mission aimed to attract investments worth

\$ 1 billion and that a large number of start-ups are expected to come to the state.

After reviewing the agenda, the Chief Minister interacted with the ministers on various issues. He appreciated everyone for being on the ground and ensuring immediate assistance to people during Cyclone Montha. He said the coordination with officials helped speed up relief operations, and constant monitoring through RTGS helped reduce loss of life and property. Cyclone Montha damage revised to Rs 6,384 cr

■State seeks urgent aid of Rs 900 crore

The Andhra Pradesh government on Monday revised the estimate of damage caused by Cyclone Montha to Rs 6,384 crore and sought an immediate relief of Rs 900 crore after a central team visited the state to assess the loss.An eight-member Inter-Ministerial Central Team (IMCT) led by Pasumi Basu, Joint Secretary, Ministry of Home Affairs, and K Ponnuswamy, Director, Ministry of Agriculture and Farmers' Welfare, visited the state on Monday.

The state earlier pegged the preliminary loss at Rs 5,265 crore.

"The total estimated loss stands at Rs 6,384 crore, and the state has sought immediate interim assistance of Rs 901.4 crore from the Centre," said an official release.

CM reviews preparations for visit of President, PM to Puttaparthi

The State Government has intensified arrangements for the centenary celebrations of Sri Sathya Sai Baba at Puttaparthi. Prime Minister Narendra Modi is scheduled to visit on November 19 and President Droupadi Murmu on November 22. Chief Minister N Chandrababu Naidu has directed officials to ensure foolproof arrangements and leave no scope for lapses in hospitality, safety, and logistics.

Chairing a high-level review meeting at the Secretariat on Monday, the Chief Minister, along with Ministers, Chief Secretary, DGP, and senior officials, reviewed ongoing preparations for the event.

The Chief Minister emphasised that the government is officially organising the cen-



tenary celebrations and that meticulous coordination among departments is crucial given the presence of the nation's top dignitaries. He instructed the ministers' committee to personally visit Puttaparthi and oversee arrangements at the ground level. "The town should be beautifully decorated, clean, and welcoming for devotees and dignitaries alike," Naidu said, adding that no compro-

itation and public amenities. Highlighting that lakhs of devotees from across India and abroad are expected to visit Puttaparthi for darshan at the Maha Samadhi, Naidu directed officials to make comprehensive arrangements for crowd management, accommodation, drinking water, food, and medical facilities. Telangana has achieved a new milestone in paddy procurement, with 8.54 lakh metric tonnes (LMT) purchased so far during the Kharif 2025–26 season - more than twice the 3.94 LMT recorded at the same time last year.Irrigation and Civil Supplies Minister Capt. N. Uttam Kumar Reddy, along with Agriculture Minister Tummala Nageswara Rao, on Monday reviewed the progress with district collectors and civil supplies officials through a video conference held by Chief Secretary S. Ramakrishna Rao from the Dr B.R. Ambedkar Secretariat. The ministers directed the officials to stay vigilant in view of any adverse weather conditions and to counter misinformation about procurement. Another witness said, "I was at the gurdwara when I heard a strong sound. We couldn't make out what it was, it was that loud."

"Several vehicles nearby were completely damaged," he added.Sanjay Bhargaw, president of the Chandni Chowk Traders Association, whose shop is about 800 metres away from the incident site, said the entire building shook due to the blast.There was chaos in the market as people started running, he shared. The blast came hours after the recovery of around 360 kg of suspect-

tion from a Kashmiri doctor's rented accommodation in nearby Faridabad Haryana Police, in coordination with their Jammu and Kashmir counterparts, arrested Dr Muzammil Ganaie from Faridabad's Dhaui area and recovered explosive materials, weapons, and timers from his rented house. BBC chairman Samir Shah was expected to issue an apology for the actions of the publicly funded national broadcaster on Monday.

The BBC has faced a storm of criticism for misleading editing of a speech Trump made on January 6, 2021, before a crowed of his supporters stormed the Capitol

Washington.Its "Panorama" documentary programme spliced together two sections of the speech, delivered almost an hour apart, into what appeared to be one quote in which Trump urged supporters to march with him and "fight like hell." Among the parts cut out was a section where Trump said he wanted supporters to demonstrate peacefully.In a letter to staff, Davie said

"In public life leaders need


Driving licences straightaway in these training centres

PNS Amaravati

Government-recognised driving training centres will be established in Andhra Pradesh. These centres will provide training to those who wish to obtain a new driving license. Currently, many private driving schools lack proper facilities, training tracks, and quality instruction. Hence, the Central government has decided to set up centres that provide training as per official standards.

It is decided to establish one driving training Centre (DTC) for every 10 lakh people. The Ministry of Road Transport and Highways (MoRTH) has sanctioned 53 DTCs for Andhra Pradesh. Additionally, five regional driving training centres (RDTCs) have also been approvéd. Of these five RDTCs, three

are proposed for the coastal region, one for North Andhra, and one for the Rayalaseema region. To set up each RDTC, at least three acres of land are required. The Central Government will provide financial assistance of Rs 5 crore per centre, and proper driving tracks will be established there. Those who complete training at these centers can apply for and receive their driving license directly at the same location. In the case of DTCs, each

Horror: Man stabs mother, brother to death

Land-for-job scam: Court defers order on framing of charges against Lalu, others



A Delhi court on Monday deferred pronouncement of its order to December 4 on framing of charges in the alleged land-for-job case involving RJD chief and former Railway Minister Lalu Prasad Yadav, his family members, and several others. Special CBI Judge Vishal Gogne was hearing the case filed by the agency against Lalu Yadav and others over their alleged involvement in the case. The matter will now be taken up on December 4.

The CBI has filed chargesheets against Lalu Yadav, his wife and former Bihar Chief Minister Rabri Devi, their son Tejashwi Yadav and others in connection with the alleged scam. The prosecution has alleged appointments in Group-D category of West Central Zone of the Railways based in Jabalpur, Madhya Pradesh, made during Lalu Yadav's tenure as railway minister from 2004 to 2009, in return for land parcels gifted or transferred by the recruits in the name of the RJD supremo's family or associates. The CBI has alleged that the appointments were made in violation of norms and that the transactions involved benami properties, amounting to criminal misconduct and conspiracy.

Delhi HC protects actor-MP Jaya Bachchan's personality rights



In a significant order, the Delhi High Court (HC) on Monday protected the personality rights of actor-turned Rajya Sabha MP Jaya Bachchan to prevent websites and online platforms from using her name, image, dialogues and likeness for commercial gains without her consent. The Samajwadi Party MP joined her husband Amitabh Bachchan, son Abhishek Bachchan, daughter-in-law Aishwarya Rai Bachchan and grand daughter Aaardhya in moving the Delhi High Court for safeguarding their personality rights.

Besides the Bachchan family members, the High Court has already protected the personality rights of other popular figures, including Hrithik Roshan, Kumar Sanu and Karan Johar. Personality rights protect celebrities against unauthorised use of their persona, including the creation of fake content which could cause financial and reputational harm. A bench of Justice Manmeet Pritam Singh Arora was hearing Jaya Bachchan's plea, saying several social media accounts, YouTube channels and websites were misusing her name and persona for commercial gains.

The defendants in the matter included Google, Amazon, eBay and Meta.

Her counsel said that attributes of her persona, including her images, were being misused without any authorisation from her and that merchandise featuring her pictures were being sold. The counsel said that technological tools such as Artificial Intelligence were used to create videos having a likeness to her client.



Supreme Court to hear pleas challenging SIR

The Supreme Court (SC) is scheduled to commence hearing pleas challenging the Election Commission's decision to conduct pan-India Special Intensive Revision of electoral rolls on Tuesday.

A bench of Justices Surya Kant and Joymalya Bagchi, which is scheduled to commence hearing pleas challenging the poll panel's decision on the pan-India Special Intensive Revision (SIR) exercise, said any fresh matter needs to be mentioned for listing before Chief Justice of India BR Gavai.

"We are only seized of Bihar SIR matters and any fresh petition with regard to other states needs to be mentioned for listing before the Chief Justice of India.

"We don't know whether other matters will also be allocated to us. It all depends on the CJI," the bench told the counsel appearing for the West Bengal unit of Congress seeking urgent listing of a plea filed by the party. The West Bengal Congress and leaders of other political parties in the state have moved the Supreme Court challenging the Election Commission's decision on SIR of electoral rolls.

Sources said Trinamool Congress MP Dola Sen has also challenged the decision to conduct the SIR exercise in Bihar.

On Tuesday, the Supreme Courtis also scheduled to hear a plea of the DMK challenging the decision of the Election Commission (EC) to conduct the exercise in Tamil Nadu.



The CPI-M has also moved the Supreme Court challenging the constitutional validity of the EC's directive to conduct the SIR exercise in Tamil Nadu, terming the process "arbitrary, illegal and unconstitutional"

Meanwhile, the AIADMK has filed an application supporting the poll panel's decision to conduct the exercise in Tamil Nadu, calling it a "legitimate and necessary" exercise to uphold the sanctity of elections and prevent voter fraud.

On November 7, the Supreme Courtagreed to hear pleas challenging the EC's decision to conduct pan-India SIR of electoral rolls on

November 11. A bench headed by Justice Surya Kant said it will start hearing the pleas from November 11 onwards. Advocate Prashant Bhushan, appearing for the NGO Association of Democratic Reforms (ADR), had sought urgent hearing in the matter, saying the issue goes to the root of democracy.

The Supreme Courtis already hearing pleas challenging the validity of the poll panel's decision to conduct the SIR exercise in Bihar.

On October 16, the EC termed the Bihar SIR "accurate" and told the Supreme Court that the petitioner political parties and NGOs are merely content with making "false allegations" to discredit the exercise. The poll body also told the Supreme Courtthat not a single appeal has been filed by any voter against name deletion since the publication of the final electoral roll for Bihar. It denied the allegation of the petitioners that there was a 'disproportionate exclusion of Muslims" from the final electoral roll of the state prepared after the months-long SIR exercise.

On September 30, the EC, while publishing the final electoral list for poll-bound Bihar, said the total number of electors has come down by nearly 47 lakh to 7.42 crore in the final roll from 7.89 crore before the

increased by 17.87 lakh from 7.24 crore electors named in the draft list issued on August 1, which removed 65 lakh voters from the original list on various accounts, including deaths, migration and duplication of voters.

While 21.53 lakh new electors were added to the draft list, 3.66 lakh names were removed, resulting in a net increase of 17.87 lakh.

The first phase of elections in Bihar on 121 seats was held on November 6, while the remaining 122 constituencies will go to polls on Tuesday. The counting of votes will take place on November 14.

On October 27, the Election Commission announced the conduct of phase two of the SIR exercise in 12 states and Union territories between November and February next year. The states and UTs are: Andaman

and Nicobar Islands, Lakshadweep, Chhattisgarh, Goa, Gujarat, Kerala, Madhya Pradesh, Puducherry, Rajasthan, Tamil Nadu, Uttar Pradesh and West Bengal.

Among these, Tamil Nadu, Puducherry, Kerala and West Bengal will go to the polls in 2026.

The poll panel said that for Assam, where polls are due in 2026, the revision of electoral rolls will be announced separately.

Phase two of the SIR exercise began on November 4 and will continue till December 4. The EC will release the draft electoral rolls on December 9, and the final electoral rolls will be published

CJI highlights perils of AI, agrees to hear plea to frame guidelines

Highlighting the perils of artificial intelligence, Chief Justice of India BR Gavai on Monday said he was aware of a morphed video circulating on social media that falsely showed a shoe-throwing incident in his courtroom.

The remarks were made as a bench comprising the Chief Justice of India (CJI) and Justice K Vinod Chandran agreed to list for hearing after two weeks a plea that sought framing of guidelines to regulate the use of artificial

intelligence (AI) tools within the judiciary. During the proceedings, a counsel for the petitioner cautioned against the unchecked adoption of AI tools in court processes, saying, "Even this court is using AI, but the ills are such..." "We are aware of it; we have seen the morphed video of us (two)," the CJI said while referring to the fabricated clip circulating online.

plea, through advocate Abhinav Shrivastava, seeks a policy to govern the use of AI in judicial functions, warning that generative Al systems can



embed "systemic biases" and operate as "black boxes" whose internal logic remains opaque even to their creators. According to the petitioner, the use of generative AI is problematic as it entails a complex process of datafication, which may generate words and images not meant by the user. The plea stated that AI integrated into the judiciary and judicial functions should have data that is free from bias, and data ownership should be transparent enough to ensure stakeholders' liability.

It argued that one of the

biggest red flags of such integration is data opaqueness and warned that the use of generative AI within judicial work may lead to higher risks of cyberattacks.

On October 6, 71-year-old Rakesh Kishore, a lawyer, attempted to hurl a shoe towards the CJI in his courtroom, which prompted the Bar Council of India to suspend his license with immediate effect. The incident sparked widespread condemnation.

Prime Minister Narendra Modi, while condemning the incident, also spoke to the CJI.

NIA urges Delhi HC to hold in-camera hearing on plea seeking death penalty

The National Investigation Agency (NIA) on Monday asked the Delhi High Court (HC) for in-camera proceedings while hearing the agency's appeal seeking death penalty for Kashmiri separatist leader Yasin Malik in the 2017 terror funding case. A bench of Justices Vivek Chaudhary and Manoj Jain said the plea would be considered after NIA's counsel, Special Public Prosecutor Akshai Malik, requested to conduct the proceedings in-camera and provide a private virtual link.

Yasin Malik, who appeared through video conferencing from Tihar jail, said he was subjected to psychological torture because of the protracted delay of around three years in deciding the appeal. The bench has posted the matter to January 28 for hearing

the arguments. In September, Yasin Malik, in an 85page affidavit submitted before the high court, claimed that he spent nearly three decades as a key figure in a statesanctioned "backchannel" mechanism, working with a succession of prime min-

SC mulls appointing retired HC judges to oversee State bar council elections

The Supreme Court (SC) on Monday indicated that all state bar council elections will be held under the supervision of retired high court judges to ensure a free and fair poll process.

Pelting of stones not very ordinary action: Supreme **Court to Shabir Shah**

Pelting of stones in Jammu

and Kashmir is not a very ordinary action, the Supreme Court on Monday remarked while asking Kashmiri separatist leader Shabir Ahmed Shah to approach the Government for obtaining his detention order. A bench of Justices Vikram Nath and Sandeep Nath granted the NIA three weeks to respond to Shah's fresh affidavit after Solicitor General Tushar Mehta pointed out newly mentioned facts and stressed his links with Pakistan-based terror networks. Senior advocate Collin Gonsalves, appearing for Shah, submitted that his family was not given the detention order and he seeks series of detention

orders passed since 1970. Mehta opposed the submission and said the issue was not raised before the

Delhi High Court. "You ask the Government to provide you the details. Why ask in bail proceedings? It's over a 50 years," the bench observed.

Gonsalves argued that Shah has been in jail for 39 years on a common charge namely speeches followed by stone pelting.
Justice Mehta then said,

The Supreme Court had earlier refused to grant interim bail to Shah in a terror funding case.

It however, issued notice to the National Investigation Agency (NIA) seeking its response within two weeks on Shah's plea challenging the Delhi High Court's June 12 order denying him bail in the case. The high court had refused to grant him bail in the case, observing the possibility of him carrying out similar unlawful



activities and influencing witnesses couldn't be ruled out. Shah was arrested by the NIA on June 4, 2019. In 2017, the NIA registered a case against 12 persons on allegations of conspiracy for raising and collecting funds for causing disruption by way of pelting stones, damaging public property and conspiring to wage war against the Government of India.

Shah was alleged to have played a "substantial role" in facilitating a separatist or militant movement in Jammu and Kashmir by inciting and instigating the general public to sloganeering in support of the secession of J&K; paying tribute to the family of slain terrorists or militants by eulogising them as "martyrs"; receiving money through hawala transactions and raising funds through LoC trade, which were allegedly used to fuel subversive and militant activities in J&K.

The high court had said the Constitution provides for a right to freedom of speech and expression, but it also places reasonable restrictions such as public order, decency, morality or incitement to an offence.

"This right cannot be misused under the garb of carrying out rallies wherein, a person uses inflammatory speeches or instigates the public to commit unlawful activities, detrimental to the interest and integrity of the country," the high

Jawaharlal Nehru Stadium to be dismantled, rebuild as 102-acre Sports City

In a major development for Indian sports infrastructure, the iconic Jawaharlal Nehru Stadium, located in the national Capital, will be "dismantled", to boost India's sports infrastructure as the sports ministry is planning to build a 102-acre Sports City, that will cater to all major disciplines and include lodging facility for athletes.

The project aims to introduce world-class sporting facilities as India continues to push for the hosting rights of the 2036 Olympic Games. Besides sporting events, the stadium is also used for nonsporting commercial activities, with concerts by Indian and international singers held regularly.

Top sources said sports cities in Qatar and Australia are being assessed to finalise the modalities. Sports Minister Mansukh Mandaviya was in Doha recently and it is reliably learnt that he visited the Sports City there. The Doha Sports City is spread over 617 acres. It has facilities

besides an academy. It also houses a specialised orthopaedic and sports medicine hospital. Australia's multi-purpose facilities include the Docklands Stadium in Melbourne that can host cricket, Australian rules football, rugby, cricket and soccer.

Ahmedabad's Sardar Vallabhbhai Patel Sports Complex is an example closer home, having facilities for cricket, aquatics, tennis and athletics among others. It is spread over 250 acres and was built at a cost of

₹4,600 crore. The city is currently bidding to host the 2036 Olympic Games and is set to be awarded the 2030 Commonwealth Games later this month.

"The JLN project will also be big in scale. This project will ensure that existing infrastructure, that was crumbling inside JLN, will get rebuilt," sources added.

The Stadium, originally built for the 1982 Asian Games and later renovated for the 2010 Commonwealth Games, has long been one of India's most iconic multisport venues. With a capacity of nearly 60,000, it has hosted major athletics events, football fixtures, large-scale concerts, and national ceremonies, includ-

ing Independence Day functions. The stadium has historically served as the home venue for the national athletics team and has been a key landmark within India's sporting history for over four decades. The stadium was refurbished in 2010 at a cost over ₹961 crore.

The stadium recently hosted the World Para-Athletics Championship for which it underwent another facelift, leading to the laying of the renowned MONDO track, which is considered a faster surface that reduces risk of injury. Besides being a prime athletics venue, the stadium has a football pitch where national and international-level games have been held. It has hosted a couple of cricket ODIs as well in 1984 and 1991 before the ICC found it unsuitable for the sport due to technical reasons.

The Sports Authority of India (SAI) had recently hiked the booking price for such events and introduced a clause for penalties if the stadium was not handed back to it in good condition at the conclusion of such







Delhi chokes as citizens cry for breath

As Delhi's skyline blurs into smog, one question looms large: how many more years will the capital wait for its leaders to act?

It may shock outsiders, but for Delhiites this is an annual recurrence. The air is thick with smog, and breathing it is a daily torment. What would be declared a medical emergency in many countries has, in Delhi, become the 'new normal'. With the Air Quality Index (AQI) crossing 600 in parts of the national capital - a level classified as severe - the city has turned into a gas chamber where each breath feels like inhaling poison.

The annual cycle of smog, blame, and silence has returned but this year something is different. Delhiites have decided to take no more. For a change, they are protesting in large numbers. They are no longer silent spectators. Over the weekend, hundreds gathered at India Gate, demanding immediate action and accountability from those in power.

The protest, led by concerned citizens and joined by an AAP leader, was not a display of political posturing but an expression of desperation. Residents held placards, coughed through masks, and spoke with a mix of anger and anguish. Their message was simple yet powerful: stop denying the crisis and start acting. As one protester put it succinctly, "No matter whose government it is, common people are dying."

The sentiment captures the essence of Delhi's tragedy – a political blame game that has bred dangerous inertia. For over a decade, Delhi's pollution crisis has worsened year after year smog-choked skies, emergency meetings, and token gestures such as water sprinkling, the odd-even traffic scheme, or failed experiments like cloud seeding. What Delhi needs are permanent solutions, not cosmetic fixes.

The root causes - unchecked construction dust, vehicular emissions, stubble burning, and poor waste management remain largely unaddressed. Meanwhile, data manipulation and denial only deepen the mistrust between citizens

Contrast this with global examples. Beijing, once infamous for its pollution, implemented a comprehensive clean-air policy combining industrial relocation, strict vehicle-emission norms, and large-scale public transport reform. Within five years, its PM2.5 levels fell by nearly 50 per cent. In London, the introduction of Ultra-Low Emission Zones (ULEZ) and incentives for electric vehicles brought significant improvement in air quality. Even Los Angeles, once synonymous with smog, succeeded through sustained investment in clean energy, public transport, and civic accountability.

Delhi needs similar political will - not crocodile tears. It requires a unified regional strategy that brings together Delhi, Haryana, Punjab, and Uttar Pradesh under a single clean-air mission. A long-term plan must address urban planning, greencover restoration, renewable energy transition, and agricultural reform to curb stubble burning. Technology can help, but transparency and enforcement are essential.

Equally vital is civic participation. The protest at India Gate should serve as a wake-up call not only for politicians but also for citizens. Clean air is not a privilege; it is a fundamental right - and Delhi must have it.

Bridging the gaps, making headway

The India-Israel partnership is no longer merely a diplomatic success story; it has become the testing ground for a new Asian order. Whether this alliance will make the region more secure or simply more heavily armed remains uncertain

IN Dixit, India's former National Security Adviser and one of the country's most seasoned diplomats, once wrote that the establishment of relations "with South Africa and then with Israel" was the most significant achievement of his tenure at the Ministry of External Affairs. Few comments capture so neatly the quiet shift in India's moral compass during the early 1990s. What had once been a foreign policy anchored in solidarity with the Palestinian cause and the Non-Aligned Movement was now tilting towards the emerging strategic triangle of Washington, Tel Aviv, and New Delhi. Three decades later, that tilt has hardened into one of Asia's most consequen-

The historical roots of the India-Israel connection reach far deeper than the 1992 establishment of formal diplomatic ties. Jewish communities have lived in India for over two millennia. The Cochin Jews of Kerala, who trace their lineage to ancient traders arriving after the destruction of the Second Temple, built some of the oldest synagogues in the Commonwealth and enjoyed relative security unknown to lews in most of the world. Further east, the Bene Israel settled along the Konkan coast, while smaller Baghdadi Jewish communities flourished in Kolkata and Mumbai. Even in India's far northeast, the Bnei Menashe of Manipur and Mizoram - who claim descent from one of the Lost Tribes of Israel - have, in recent decades, re-established religious and cultural links with Israel. These intertwined legacies gave both nations a foundation of shared memory long before geopolitics bound them together.

When India formally recognised Israel in 1950 but withheld full diplomatic relations, it was acting within the logic of post-colonial solidarity. Support for Palestinian self-determination was considered integral to India's moral standing in the developing world. Yet by the early 1990s, that posture had lost its strategic utility. The end of the Cold War, the collapse of the Soviet Union - India's principal defence supplier - and the global turn towards liberalisation forced New Delhi to rethink. Establishing relations with Israel thus became not only a matter of diplomacy but also a statement of intent: India was entering the world economy and aligning with its new security architecture.

The years that followed saw a steady deepening of the defence relationship. During the 1999 Kargil conflict with Pakistan, Israel's rapid supply of surveillance drones and precision-guided munitions filled a critical gap left by other hesi-

tant powers. Israeli firms soon became integral to India's military modernisation, supplying radar, missiles, and electronic warfare systems. Cooperation later extended into counter-terrorism and intelligence sharing after the 2008 Mumbai attacks, in which Jewish targets were explicitly struck. Israeli expertise in homeland security, border surveillance, and cyber technology found eager clients in India's expanding security apparatus.

The relationship, however, is not merely about weapons. It is also about ideas — about two nations that see themselves surrounded by threats and justified in adopting extraordinary measures of self-defence. Israel's militarised ethos and its narrative of technological resilience have appealed to successive Indian governments. For the Hindu nationalist right, Israel represents a model of a small but assertive nation that defends its majority identity against perceived existential enemies. What was once discreet military cooperation has thus evolved into an open political fraternity.

India's silence on Israel's controversial actions has grown louder over time. After backing a UN inquiry into Israel's conduct during the 2014 Gaza war, New Delhi abstained from a similar vote in abstained from a similar vote in a simi 2021. By then, "strategic neutrality" had become a convenient cover for

convergence. Israel's defence industry now ranks among India's top three suppliers, while Indian corporations such as the Adani Group have invested heavily in Israeli infrastructure, including the Haifa Port - a clear symbol of trust.

Last week, the Israel-India Joint Working Group on Defence Cooperation met in Tel Aviv, co-chaired by Defence Secretary Rajesh Kumar Singh and Israeli Defence Ministry Director-General Major-General (Res.) Amir Baram. It ended with a Memorandum of Understanding to expand industrial and technological cooperation. Though details were limited, reports indicate India will acquire medium-range

surface-to-air missiles worth about \$3.75 billion and convert six commercial aircraft into refuelling tankers for nearly \$900 million.

In New Delhi, Israel's Foreign Minister Gideon Sa'ar called India a "global superpower" and thanked it for promptly condemning the 7 October 2023 Hamas attacks. He noted that Prime Minister Narendra Modi was among the first leaders to call Benjamin Netanyahu - a gesture Israel says it will not forget. The symbolism was clear: both now see themselves as partners in a shared fight against "terror".

This alignment carries wider implications. The United States, wary of China's rise and keen to contain Russia, views India as a democratic counterweight in the Indo-Pacific and Israel as its most dependable outpost in West Asia. The emerging West Asian Quad" (I2U2) — linking India, Israel, the UAE, and the US — embodies a new order where human rights concerns yield to strategic and commercial interests.

Yet contradictions persist. India still depends heavily on Russian arms and energy, and avoids criticising Moscow despite its

closeness to Israel and the West. This balancing act underscores civilisational states entitled to secure their interests by any

means necessary. What began as cautious diplomacy in 1992 has become a test case for Asia's future alignments. The partnership is neither pure modernisation nor moral decline but a mirror to a continent where nationalism, technology, and security define power. For Israel, it brings a vast market and a non-Western ally; for India, advanced technology, intelligence, and a partner

adept at survival in a turbulent region. The distance between Tel Aviv and New Delhi has never been shorter - and the space for moral hesitation, once a hallmark of Indian diplomacy, has almost disappeared.

AI CHATBOTS SHOW PROMISE, BUT **HUMAN THERAPISTS ESSENTIAL**

OpenAI, an American artificial intelligence research and deployment organisation, has recently reported that it has enhanced ChatGPT's responses. enabling the chatbot to more reliably recognise mental health issues during sensitive conversations.

AI-based tools may offer a promising supplement for addressing mental health concerns, but they cannot replace the human touch essential for emotional wellbeing. F AI applications may also provide inaccurate or potentially harmful advice and raise privacy concerns, underscoring the need for caution and the continued importance of the human-therapist relationship.

A recent Stanford Universityled study indicates that AI therapy chatbots are

significantly less effective and, in some cases, potentially harmful compared with human therapists. The study found that licensed human therapists responded correctly to crisis scenarios in 93 per cent of cases, whereas AI bots managed fewer than 60 per cent. This highlights that mental health care requires not only clinical problem-solving but also human understanding, empathy, and the ability to navigate interpersonal relationships. Therapy is fundamentally about building trust and human connections, which AI, regardless of its sophistication, cannot fully replicate. While AI may support mental health initiatives, it should be viewed as an adjunct rather than a substitute for professional human care.

Physics Nobel Prize 2025: Quantum computing is the future

The work of three Nobel laureates marks the dawn of a new computational era — one that merges physics, technology, and imagination to push the limits of what humanity can calculate, communicate, and comprehend


Century old Quantum Mechanics can explain how a single sub-atomic particle cross the energy barrier through tunneling, be located at multiple places simultaneously, occupies discrete energy levels and emits energy in quanta as it moves from higher energy level to lower energy level.

Three US Physics Professors; namely John Clarke, University of California Berkeley, Michel H Devoret Yale University, New Haven CT and University of California, Santa Barbara and John M Martinis University of California Santa Barabara, were awarded this year's Physics Nobel Prize. Quantum mechanics has advanced from single particle to macroscopic level, and during 1984 and 1985 these Professors have conducted experiments wherein quantum behavior has been observed at macroscopic level, where billions and trillions of Cooper particles (two electrons closed system) are involved.

The Professors had discovered macroscopic mechanical tunneling and quantized energy level in a system large enough to be kept in hand. When they made this discovery in 1984 and 1985, Martinis was a PhD candidate, Devoret was a postdoctoral fellow and Clarke was their professor and supervisor. Two of the three Laureates have links with Google. Besides his professorship Devoret, is Chief Scientist of Google Quantum AI, while Martinis headed Google's Ouantum AI lab till 2020.

How Quantum Mechanics is different from Classical Mechanics? We have seen in our day today life that when a ball is thrown against a wall, it rebounds on the same side and never crosses to the other side of the wall. In sharp contrast to this, atomic particles under quantum mechanical principles cross the barrier through tunneling, located at multiple positions simultaneously and can occupy discrete energy levels.

In 1973 Physics Nobel Prize was won by Brian Josephson for discovering the flow of electric current between two superconductors separated by an insulator. This has been a very useful finding and superconductorinsulator-superconductor junction has been used in various experiments like measurement of fundamental physical constants and

These discoveries have far reaching consequences and have been providing breakthroughs in many fields of medicine, chemistry and environment etc. The quantum behavior in superconducting circuits has led to the creation of superconducting qubits, the building blocks of quantum computers and can perform intricate calculations far beyond the reach of a classical computer, marking the

The implications extend far beyond computing. In cybersecurity, quantum technology challenges current encryption models, driving innovation in postquantum cryptography to safeguard credentials, financial data, and national digital infrastructures. If appropriate innovations are not done, our personal data, bank accounts etc. can be hacked using quantum computers. Quantum key distribution (QKD) further enhances data privacy, allowing secure communications based on unbreakable principles of Quantum Physics.

In industrial applications, quantum enhanced sensors can detect minute changes in temperature, magnetic fields or vibrations, revolutionising areas like predictive maintenance, manufacturing quality control and energy management. These sensors could form the backbone of quantum secure industrial networks, protecting critical systems from cyber threats while improving performance and efficiency. We are aware that information is stored in any normal computer as bits, which are either 0 or 1. Quantum computer uses qubits that can be understood to be behaving like a spinning coin in air with 0 and 1 at the same time. Group of qubits can become linked indicating that when we learn about the one we get to know something about the other too. The two traits are utilised in a quantum machine and bring out several possibilities in parallel.

Google's quantum AI team has recenly reported that its 'Willow Superconducting chip' has run a new test and obtained 13,000 times faster result as compared to the result from top supercomputer. This test is called Quantum Echoes and can be repeated and checked using other quantum machines. Google calls it as 'ver-

ifiable quantum advantage'. Earlier quantum advantage demos produced one off random results and thus, were not verifiable. Quantum Echoes, however, measure the number called 'out of time order correlator' (OTOC), which would again emerge when another quantum computer follows the same step. Thus the number is specific irrespective of the quantum computer used. The similar output can be obtained after redoing/ rechecking and hence it is 'verifiable'.

We encounter chaos in natural processes, which is generally characterized by the high sensitivity of a system towards small perturbations. The notable examples being weather patterns, wherein a small change in initial conditions leads to different outcomes over time and population dynamics where a small shift in local population can affect the entire ecosystem. Chaos is also found in quantum systems, like dynamics of magnetisation in atomic nuclei subjected under magnetic field varying with time and flow of electrons on high temperature superconductors. Quantum computers are ideal for simulating such chaotic systems.

A quantum computer simulating OTOC signals from a physical system in nature such as molecules, whose system parameters are not fully known can be compared with OTOC signals against the real world data about the physical system and observe when they best agree. A more precise estimation of system parameter can be made as compared to any other technique. The echo number thus, can track any small disturbance spreading through the material and has tremendous scope in guiding the design of alloys, cleaner catalysts and zero-in on a chemical battery that can last longer.

The physics of Nuclear Magnetic Resonance is being extensively used in Medical Science especially in MRI. Google has shown that how Echoes paired with NMR data can act like a molecular ruler. Structural features of real molecule can be compared to find how a drug might bind to a protein making a clear scope for quick discovery of drugs. It opens the way for examining the complex quantum behavior and possibilities of breakthrough in climate technology, environment, elec $tronics \, and \, Chemistry. \,\, Quantum \, precision$ measurement is advancing medical imaging, environmental monitoring, and even space exploration, opening new frontiers in scientific discoveries.

India's entry into international carbon market: A defining moment for the country





While the COP 30 discussions are underway to resolve some of the complex global challenges of climate change, exploiting the international carbon market as a source of climate action is also going to be a key source of climate action. India's signing of the Memorandum of Cooperation (MoC) with Japan under Article 6.2 of the Paris Agreement marks a pivotal step in India's engagement with international carbon markets. Article 6.2 provides a broad, decentralised cooperative approach that allows countries to trade Internationally Transferred Mitigation Outcomes (ITMOs), thereby driving technology transfer,

climate finance, and innovation. For India, the signing of Article 6.2 has turned out to be a propitious moment in driving the highly desired technology transfer and muchneeded climate financing.

A robust institutional framework

India moved early to establish the institutional framework for such cooperation. On May 30, 2022, the Government of India notified the National Designated Authority for Implementation of Article 6 of the Paris Agreement (NDAIAPA), the body responsible for approving projects eligible for ITMO transactions. This was followed, on 17 February 2023, by a public announcement listing the activities India would initially consider eligible for trading under Article 6.2. Most recently, in August 2025, the NDAIAPA was amended to reflect evolved decisions under Articles 6.2 and 6.4.

The eligibility list spans green hydrogen and ammonia, sustainable aviation fuel (SAF), compressed biogas, high-efficiency industrial technologies, renewables with storage (stored component), offshore wind, solar thermal, HVDC lines linked to renewables, ocean energy, and carbon capture, utilisation and storage (CCUS). These activities were strategically chosen to catalyse technology transfer and mobilise much-needed international finance, with an initial three-year scope and provision for revision and expansion.

However, since developing countries already have targets under their NDCs, establishing a robust institutional framework becomes crucial to ensure transparency and integrity in international transfers. Though India has created the institutional framework, the next critical phases involve strengthening processes for project

authorisation, monitoring and verification (MRV), as well as the allocation and transfer of ITMOs within agreed timelines. Establishing these mechanisms, supported by a Project Implementation Agency (PIA) and a steering committee to oversee synergies across domestic and international carbon markets, will be essential to ensure readiness for full-scale cooperation and transparent ITMO transfers under Article 6.2.

Besides, speed matters because bilateral pipelines are forming now. Global activity is narrow but deep. Hence, it is an opportune time for India to become an integral part of such evolving bilateral pipelines.

Where do opportunities sit?

India's eligibility list under Article 6.2 opens distinct avenues for sectors positioned to deliver high-integrity, internationally transferrable mitigation outcomes (ITMOs). In clean-energy carriers, green hydrogen and green ammonia can serve as financing bridges to scale electrolyser capacity and decarbonise export-oriented value chains. Developers that align early with partner-

country measurement, reporting, and verification (MRV) standards can secure premium pricing and longterm offtake agreements. Sustainable aviation fuel and compressed biogas provide complementary routes,

enabling incremental abatement beyond domestic demand by supplying ITMO-linked volumes to countries pursuing aviation decarbonisation targets. For the private sector, this framework presents early-mover advantages. Industries such as steel, cement, chemicals, and refineries can integrate best-available technologies and enter cooperative agreements that de-risk upfront capital expenditure through bilateral ITMOlinked arrangements. Renewable energy players combining storage and HVDC infrastructure can position projects for system-level emission reductions verified by international buyers. Carbon-removal ventures using CCUS technologies offer an additional frontier, where private developers securing storage-site assessments, robust monitoring plans, and long-term buyer commitments can anchor India's first wave of

removal-based ITMOs from industrial clusters. Beyond technology deployment, each cooperative agreement must be evaluated through four lenses — contribution to India's Net Zero commitment, promotion of technology transfer along with intellectual property rights, assurance of sustainable climate finance, and acceleration of local sustainable development. These priorities ensure that India's participation in international carbon markets strengthens both climate and socio-economic objectives.

What lies ahead?

As India moves from readiness to implementation under Article 6.2, the focus must shift to

strengthening institutional processes for authorisation, registry, and ITMO transfers, while fostering technology transfer and innovation in sectors like hydrogen, CCUS, and offshore wind. With the NDAIAPA, the Carbon Credit Trading Scheme (CCTS), and the Japan MoC in place, success now depends on how effectively India mobilises regulators, industries, financiers, and project developers to turn readiness into credible international cooperation and measurable climate outcomes. The following areas require strategic policy thrusts to reap optimum bene-

fits from the international carbon market: Strengthening governance and institutional architecture: India must operationalise a clear governance structure by constituting Project Implementation Agencies (PIAs) for each bilateral mechanism to oversee project authorisation, MRV, and ITMO transfers. The Article 6.2 registry should be embedded within the CCTS, enabling unified credit tracking and direct transfers to buyer-country registries. This system can maintain a "knowing-basis" link with the international registry for transparency while preserving national control. Countries lacking domestic registries may temporarily rely on the international platform, but India's design should prioritise sovereignty and traceability.

 Building a pipeline of bankable projects: The NDAIAPA should curate a strong pipeline in sectors where India holds an edge - green hydrogen, compressed biogas, offshore wind, and CCUS. Fast-tracked feasibility studies, pre-approval templates, and a dedicated facilitation cell can help developers meet buyer-country expectations and streamline MRV compliance.

Catalysing private-sector participation: The private sector shoulders the key responsibility for driving implementation. Early adopters in steel cement, refineries, fertilisers, and transport should be encouraged to form consortia with financiers and technology providers. A blendedfinance or guarantee window under the CCTS can reduce risk, while clear ITMO pricing norms - via benchmarks, auctions, or bilateral formulas - will create predictability and investor confidence.

 Expanding and deepening bilateral partnerships: Beyond Japan, India should deepen partnerships with Switzerland, Singapore, the UAE, and South Korea to broaden market access and technology collaboration. Regular inter-ministerial coordination and proactive negotiation of new MoCs can strengthen India's position as both a supplier of high-integrity credits and a shaper of global carbon-market norms.

The quiet revolution on the field: Let every girl play

"Start them young." The phrase echoes in playgrounds, on gym floors, and at kitchen tables where parents debate the next move for their child. But all too often, it's implicitly aimed at boys; boys in cleats, boys on courts, the boys who wear the hero's jersey. And when girls do slip into shoes and gear, the question persists: "Is sport really for me?" That quiet hesitation has cost generations of girls an experience that builds not only strength but also self-belief. The good news? That tide is finally turning.

The Moment That Moved a Nation

When the Indian women's cricket team lifted the World Cup, the celebration wasn't just about victory; it was about rewriting perception. Among the most touching stories was that of Amanjot Kaur, whose father, a carpenter, carved her first bat by hand because they couldn't afford one. That simple act of faith became a symbol of possibility, proof that equality often begins with a parent's belief. Every such story is a quiet revolution in a society that still needs reminding that girls belong on the field too.

A Foundation
I was fortunate — both my parents

SINCE 1865 served in the Indian Army. In our household, discipline and fitness weren't optional; they were part of everyday life. That early structure became the foundation that led me to be a kettlebell sport world champion, a field most in India barely know exists. Kettlebell lifting isn't about machines or mirrors; it's about rhythm, precision, and the endurance to keep going when your body says stop. It's a test of willpower measured not in weight but in minutes of unbroken focus. Those lessons shaped me far beyond the platform. They taught me resilience, patience, and the quiet confidence that only effort can buy. That's what sport gives every girl — strength that spills into every part of her life.

The Hidden Power of Play

Research from the Women's Sports Foundation (WSF) shows that girls who participate in sport perform better academically, report higher selfesteem, and build stronger leadership skills than those who don't. These gains go far beyond physical fitness; they're about mental agility and emotional maturity. Sport sharpens reflexes, strengthens focus, and teaches teamwork. It encourages young girls to make decisions under pressure and

to find balance between ambition and discipline. In a world obsessed with instant validation, sport offers something lasting — character. Despite progress, India still faces a wide participation gap. Studies show that girls are more likely to drop out of sport during adolescence, citing safety issues, social expectations, and lack of facilities. The Sports and Society Accelerator and Dalberg report Active Equity found that many girls are discouraged from outdoor play by age 14, while boys are urged to compete longer and harder. Bridging that divide requires more than policy; it needs a mindset shift. Schools and parents must see sport as essential

education, not a luxury. If inspiration had faces, they would look like Mary Kom and PV Sindhu. Mary Kom — mother of four, Olympic medallist, and six-time world champion — has shown that motherhood and mastery can coexist. Sindhu's grace and ferocity on the badminton court redefined what Indian femininity in sport looks like. They didn't just win medals; they won mindshare. They made it possible for young girls to imagine a life where sport isn't a rebellion — it's a right. Across cities and towns, a new generation of Indian women is redefining what it means to be an athlete. They are engineers who run marathons, teachers who box before school, and professionals who lift weights after work. They are the hybrid athletes, balancing work, family, and sport without apology. This generation isn't waiting for perfect conditions. They're creating their own spaces, founding local clubs, and mentoring the next line of girls

who will one day take their place. They represent the India that's coming - fast, fearless, and inclusive.

Why It Must Begin Early

Every child is born with potential, but it's what we nurture early that shapes it. When girls play sport young, they learn to trust their bodies, to compete, to lead, and to fail gracefully. They discover that strength isn't masculine — it's universal. Sport teaches equality long before society does. On the field, a good pass or a strong finish earns respect, not gendered judgement. That's how you build confident women and balanced men - by letting every child play without bias.

The Final Whistle

India has proved its daughters can lift, run, punch, swim, and shine on the world stage. Now the responsibility lies with us - parents, educators, and policymakers — to give them that start earlier, stronger, and freer. Every time a girl steps onto a field, she does more than play. She shifts the narrative, inspires others, and when girls play, they win twice: once in sport, and once in life.

Sarkozy to be released

Former French President Nicolas Sarkozy will be released from prison and placed under judicial supervision, a Paris appeals court ruled Monday, less than three weeks after he began serving a five-year sentence over a scheme to finance his 2007 election campaign with funds from Libya. Sarkozy, 70, was expected to leave Paris' La Santé prison in the afternoon. He will be banned from leaving the French territory and from being in touch with key people including codefendants and witnesses in the case, the court said. Two men and a woman died in the shooting Saturday at the business on the city's north side, according to the San Antonio Police Department. Other employees ran from the scene when the gunfire erupted around 8 a.M., KSAT-TV reported. Police responded and secured the area, and hours later they found the gunman with a self-inflicted gunshot wound, officials said. He was identified by police as Jose Hernandez Galo. Fung-wong displaces 1.4 million people in the Philippines

Typhoon Fung-wong blew out of the northwestern Philippines on Monday after setting off floods and landslides, knocking out power to entire provinces, killing at least eight people and displacing more than 1.4 million others. The typhoon was forecast to head northwest toward Taiwan.

Fung-wong lashed the northern Philippines while the country was still dealing with the devastation wrought by Typhoon Kalmaegi, which left at least 224 people dead in central provinces on Tuesday before pummeling Vietnam, where at least five were killed.

Fung-wong slammed ashore in northeastern Aurora province on Sunday night as a super typhoon with sustained winds of up to 185 kph (115 mph) and gusts of up to 230 kph (143 mph).

The 1,800-kilometre (1,100mile)-wide storm weakened as it raked through mountainous northern provinces and agricultural plains overnight before blowing away from the province of La Union into the South China Sea, according to state forecasters.

One person drowned in flash floods in the eastern province of Catanduanes, and another died in Catbalogan city in eastern Samar province when her house collapsed on her, officials said. In the northern Province, according to offi-

Tropical cyclones with sustained winds of 185 kph (115 mph) or higher are categorised in the Philippines as a super typhoon to underscore the urgency tied to more extreme weather disturbances.

The Philippines has not called for international help following the devastation caused by Kalmaegi, but Teodoro said the United States, the country's longtime treaty ally, and Japan were ready to provide assistance. Authorities announced that schools and most Government offices would be closed on Monday and Tuesday. More than 325 domestic and 61 international flights were cancelled over the weekend and into Monday, and more than 6,600 commuters and cargo workers were stranded in ports after the coast guard prohibited ships from venturng into rough seas.

The Philippines is hit by about 20 typhoons and storms each year.

'Two miscreants on a motorcycle arrived and hurled the crude bomb in front of the road of the Grameen Bank at around 3.45 am," a police official said. "Nobody has been arrested yet, but by now we have launched a campaign to track down the miscreants," the officer-in-charge of

reporters. The attack was one of the many instances of sporadic violence that have hit Dhaka amid brewing tensions in Bangladesh's political land-scape. Early on Monday, unidentified men also exploded improvised bombs in front of a business outlet of one of Yunus' advisers and set two buses ablaze in the capital. Police said no casualty was reported in the attacks in front of Grameen Bank, and the Prabartana a business owned by fisheries and livestock adviser Farida Akhter.

Yunus, who is currently the Chief Adviser of the Government. interim founded the Grameen Bank in 1983 and won the Nobel Peace Prize in 2006 for his work in poverty alleviation and the empowerment of poor women through it.

According to police, the explosions in Prabartana at the Mohammadpur area occurred around 7:10 am, when two motorcycle-borne miscreants "hurled the crude bombs in front of the establishment, both of which exploded with loud bangs.' One of the crude bombs also landed inside the premises of city's posh Dhanmondi area.

Motorcycle riders detonated two bombs near Ibn Sina Hospital, said to be run by Jamaat-e-Islami, and another two in front of a major crossing. Separately, a 50-yearold man, "listed gangster", was shot down in front of a hospital in the old part of Dhaka hours later.

Police said they were looking for clues to identify his assailants.

He had narrowly escaped an attack in 2023, three released on bail after spending 26 years in prison, The Daily Star newspaper reported. WORKERS PROTEST OVER UNPAID WAGES

Dhaka: About 100 Bangladeshi workers who were employed by Malaysian companies rallied Monday to demand unpaid wages, fair compensation and an end to alleged abuse by Malaysian employers. The Migrant Welfare Network, a Bangladeshi migrant group based in Malaysia and Bangladesh, organised the protest at the Ministry of Expatriates' Employment in Bangladesh's capital said the event was organised to protest what they say is widespread mistreatment of migrant workers in Malaysia, one of Southeast Asia's richest nations. They demanded unpaid wages and compensation for 431 Bangladeshi workers they said were exploited by two Malaysian companies, Mediceram and Kawaguchi Manufacturing. The Associated Press could not immediately reach the companies for comment.

Malaysia and other **Southeast Asia countries** rely on migrant workers, often from Bangladesh, Myanmar and Nepal, to fill labour-intensive jobs in manufacturing. plantations or construction. Local workers usually avoid such jobs because of their poor conditions and low wages. The Migrant Welfare Network urged Bangladeshi and Malaysian authorities and international buyers to take immediate action to ensure workers receive wages already owed, fair compensation and "justice for systemic abuses."

Mexico to send more troops after mayor's killing

Mexico President Claudia Sheinbaum and her security Cabinet said on Sunday that the Government is sending more troops to the western state of Michoacan and will invest more than \$3 billion to try to quell the state's persistent violence. The announcement came a week after a 17-year-old gunman shot and killed a popular mayor during Day of the Dead festivities, spurring protests in towns across the state and demands that the federal Government take action. Sheinbaum recognized the pain and indignation expressed after the assassination of Uruapan Mayor Carlos Alberto Manzo. "His cowardly murder hurts, not only his family and his community, but all of Michoacan and the country," the president said at the National Palace Sunday.



Zelenskyy seeks Patriot systems from US

Volodymyr President Zelenskyy said on Monday he wants to order 25 Patriot air defence systems from the United States, as Ukraine desperately tries to fend off relentless Russian aerial attacks that have brought rolling blackouts across Ukraine on the brink of winter. Zelenskyy acknowledged that the Patriot systems are expensive and that such a large batch could take years to manufacture. But he said European countries could give their Patriots to Ukraine and await replacements, stressing that "we would not like to wait.

Combined missile and drone strikes on the power grid have coincided with Ukraine's frantic efforts to hold back a Russian battlefield push aimed at capturing the eastern stronghold of Pokrovsk. Meanwhile, international peace efforts appear to have dissipated, nearly four years after Russia invaded its neighbour. Zelenskyy said Ukraine recently received more Patriot systems from Germany. It is not known



how many Patriot systems are in Ukraine. But on the whole, air defences remain stretched thin across wide expanses of Ukrainian territo-

European allies and Canada are buying much of the equipment from the United States. The Trump administration is not giving any arms to Ukraine, unlike the previous Biden administration. Meanwhile, the two sides were locked in a battle for control of Pokrovsk, in Ukraine's eastern Donetsk region, where Zelenskyy says Russia has assembled 170,000 troops for a renewed push. There has been a relative lull in fighting in recent days, according to reports gathered by the Institute for the Study of War.

Five Indian nationals were abducted in Mali last week in an "unfortunate incident", the Indian mission here has said. The kidnapping took place on November 6 in the West African nation, the Indian embassy said in an X post on Sunday. "The Embassy is aware of the unfortunate incident of kidnapping of five of our nationals in Mali on 6 Nov 2025," it said. The embassy has been "working closely with the authorities and the company concerned to secure their safe release as quickly as possible," it added. while other hand Some fuel stations in Mali's capital opened Monday for the first time since an al-Qaida affiliate imposed a fuel blockade on the West African nation, as supply convoys made their way through the

landlocked nation while under fire. Schools also managed to open in Bamako for the first time since the JNIM fighters' blockade began two weeks ago."The children went to school this morning, but I remain concerned," one parent in Bamako, Salif Traoré, told The Associated Press. "Many petrol stations are still closed due to a lack of fuel, and I don't know how long the fuel availability in the city will last." More than 100 fuel tankers have been destroyed, with several people killed and drivers taken hostage.

On Sunday, the African Union called for "urgent international action" to combat extremism in Mali. Its statement also condemned the abduction of three Egyptian nationals there. Several countries, including France and the US, have advised their citizens to leave Mali immediately.



Pakistan's Senate passes 27th **Constitutional Amendment**

Pakistan's Senate, the upper house of parliament, on Monday gave a nod to the controversial 27th Constitutional Amendment to create a new post of Chief of Defence Forces and set up a constitutional court. The bill, which had stirred controversy for weeks, was presented in the Senate by Law Minister Azam Nazeer Tarar, while Senate Chairman Yusuf Raza Gilani presided over the proceedings. The government and its coalition partners secured a two-thirds majority of 64 in the vote after it received the support of two opposition members. Under the amendment bill, the President will appoint the Army Chief and the Chief of Defence Force on the advice of the Prime Minister. It also Chairman of the Joint Chiefs of Staff Committee will expire

Chief of Army Staff, who will also be the Chief of Defence Forces, will appoint the head of the National Strategic Command in consultation with the Prime Minister, and the head of the National Strategic Command will be from the Pakistan Army. The government will be able to promote individuals from the armed forces to the ranks of Field Marshal, Marshal of the Air Force and Admiral of the Fleet. The rank and privileges of Field Marshal will be for life, meaning that Field Marshals will remain Field Marshals for life.The bill also proposes to set up a Federal Constitutional Court to deal with matters related to the constitution, while the existing Supreme Court would deal only with traditional civil and criminal cases. China, Japan embroil in major diplomatic row over Taiwan

A Chinese diplomat's aggressive comments threatening Japanese Prime Minister Sanae Takaichi for her remarks about Tokyo's potential involvement in any Chinese action over Taiwan have stirred up a major diplomatic row between the two countries.

Japan on Monday lodged a stern protest with China over Chinese Consul General in Osaka Xue Jian's social media post in which he threatened to "cut off dirty neck without a moment of hesitation" while citing a news article on Takaichi's remarks in parliament. "We must say that the post is extremely inappropriate for a Chinese diplomatic mission head," Japan's government spokesman Minoru Kihara was quoted as saying by the Japanese news agency, Kyodo.

The post, however, had been deleted, he said. The flare-up occurred after Takaichi told a parliamentary committee on Friday that a Chinese military attack on Taiwan could be a "survival-threatening situation" for Japan, which could exercise its right to collective self-defence. Responding to the

Chinese diplomat's comments, China's Foreign Ministry spokesperson Lin Jiao told the media here Monday that Takaichi's remarks are Takaichi's remarks are "a gross interference in China's internal affairs" and Beijing has lodged a protest with Tokyo. Declining to comment on the Chinese diplomat's comments, Lin said it was in response to Takaichi's remarks on Taiwan, a "red line" for China. "I hope Japan will stop creating confusion and shifting blame," he said.

Since she took over power in Japan last month, becoming the first woman Prime Minister of the country, Takaichi, who is regarded as a hawk in China, is stirring up the Taiwan pot, riling Beijing.

"The situation regarding Taiwan has become serious. We must assume the worst-case scenario," Takaichi told the parliamentary session, highlighting recent aggressive actions by China, which has deployed warships and fighter aircraft in defence drills around Taiwan, closely located near Japan. Lin said Takaichi's remarks are "seriously damaging bilateral and challenging international order" Lin continued.

US to press forward Israel-Hamas ceasefire

Israel on Monday returned the remains of 15 Palestinians to Gaza in the latest step forward for a US-brokered ceasefire, as a top White House envoy met with Israeli leaders to discuss the next stages of the fragile agreement.

Israel returned the bodies after Palestinian militants released the remains of a hostage Sunday. With the latest exchange, only four bodies of hostages remained in Gaza. As the first stage of the agreement reached its waning days, US President Donald Trump's son-in-law, Jared Kushner, met on Monday with Israeli Prime Minister Benjamin Netanyahu in Jerusalem, according to a photo released by the premier's office.

The last ceasefire agreement in January 2025 fizzled after the exchange of hostages for Palestinian pris-



a wave of airstrikes over Gaza. At the time, mediators were unable to bring Hamas and Israel to the table to negotiate troop withdrawal and future governance of the strip. They face a similar challenge now, as the next stage of the agreement calls for the implementation of a governing body for Gaza and the deployment of an international stabilisation force. It is not clear where either stands.

The Gaza Health Ministry said the Red Cross handed over the Palestinian bodies Monday, raising the total number received to 315. For each Israeli hostage returned, Israel has been releasing the

remains of 15 Palestinians. The ministry, part of the Hamas-run government and staffed by medical professionals, maintains detailed records viewed as generally reliable by independent experts. Only 91 of the bodies

identified, the ministry said. Forensic work is complicated by a lack of DNA testing kits in Gaza. The ministry posts photos of the remains online, in the hope that families will recognise them.

The handover came after Israel on Sunday confirmed it had received the remains of Hadar Goldin, a soldier killed in the Gaza Strip in 2014, closing a painful chapter for the country.

The 23-year-old was killed two hours after a ceasefire took effect in that year's war between Israel and Hamas. Goldin's family waged a public campaign for 11 years to bring home his remains. Earlier this year, they marked 4,000 days since his body was taken. Israel's military had long determined that he had been killed, based on evidence found in the tunnel where his body was taken, including a blood-soaked shirt and prayer fringes



Indonesia declares late Suharto national hero

Indonesia declared the former dictator Suharto a national hero on Monday, provoking outrage from rights groups who said the move was an attempt to whitewash decades of human rights abuses and corruption that took place during his 32 years in power. Suharto was a US ally during the Cold War who presided over decades of authoritarian rule, during which up to a million political opponents were killed, until he was toppled by protests in 1998. He was one of 10 people recognised by President Prabowo Subianto in a televised ceremony held at the presidential palace in Jakarta to mark National Hero Day. Minister of Culture said that Suharto played a key role during the struggle for independence against the Dutch colonial rulers, and later served as commander of a military operation.



Rescuers searching for missing migrants

Malaysian rescuers searching for dozens of people still missing after a boat carrying migrants from Myanmar capsized last week recovered five more bodies on Monday, bringing the death toll to 12. The bodies of two men, two women and a boy were found in waters off northern Langkawi island, close to the Thailand border, the Malaysian Maritime Enforcement Agency said. First Adm. Romli Mustafa said in a statement that an estimated 70 people were on board the capsized boat, based on survivors' account. Of those, 13 have been rescued over the past two days, with dozens still missing. Officials said a larger vessel carrying some 300 people departed from the town of Buthidaung, in Myanmar's Rakhine state.





BLASÉ CAPITAL BANKS IN BLACK



According to a recent research report by Motilal Oswal Mutual Fund, banking stocks continued to show strength, with the Bank Index rising 5.75 per cent in October, and posting 3.24 per cent, 4.88 per cent, and 12.24 per cent growth across the 3-month, 6-month, and one-year periods, respectively. The trend indicates that the banking sector is in a visibly stronger phase. Credit and deposits are growing, regulators are loosening liquidity constraints, the Government and central bank are talking about consolidation, and top banks (led by the State Bank of India) are aiming for global scale.

However, there are immediate concerns. According to some experts, the pressure on net interest margins will continue in the next quarter due to "intense competition for deposits, and potential interest rate cuts." In terms of regulation, there are hints of higher scrutiny in areas such as cybersecurity, Al governance, and consumer protection. But compared to the private counterparts, the public sector banks seem poised to counter margin contractions. Large state-owned banks have posted good results in the second quarter this year, and are positive about the future.

Over the medium term, the potential and actual policy and regulation shifts, which include talks about privatisation and dilution, mergers among the larger banks, liquidity reforms, and faster retail growth are collectively reshaping how capital flows inside the economy. Finance Minister Nirmala Sitharaman publicly signalled how privatisation of state-run banks can enhance financial inclusion, and why the past nationalisation did not deliver the expected outcomes. She framed the former as compatible with investors and public interest. This sparked protests among the unions, and Civil Society due to worries about job losses and rural access. Yet again, as in the 1990s, privatisation is a live policy debate, rather than an area of settled merit.

Why this matters is that privatisation changes "governance incentives, capital access, and risk allocation in large banks potentially speeding efficiency but raised distributional questions." According to media reports, the government and the Reserve Bank of India wish to consolidate the large state-owned banks, after merging the smaller and weaker ones with the bigger and stronger ones earlier, to create larger, globally competitive institutions. The next phase may use M&As to build scale, reach and bigger balance sheets.

Larger banks, at least theoretically and according to a media report, improve funding depth, diversify loan books, and increase the ability to underwrite big projects, critical for infrastructure and industrial growth. Macro data and industry reports show that deposits and credit grew in 2025 (double-digit deposit growth and credit growth depending on the series). The RBI's regulatory nudges will free up capital to support further lending. Many analysts see this as a concrete tailwind for

margins and loan growth.

Several signals support such claims. These include the improving asset quality trends in big banks, rising retail and SME lending, digital adoption lifting low-cost deposit acquisition, and rising market valuations for major private and public banks. Industry and credit agencies have upgraded near-term credit expectations on the back of these dynamics. Stronger banks can underwrite growth, widen financial inclusion (if managed efficiently and properly), and support capital markets through issues, and

The State Bank of India (SBI) has set a target of being among the world's top-10 most-valued banks by 2030. It crossed the ₹100 lakh-crore business milestone; management pointed to stronger capital buffers, and international expansion as levers to reach the targeted scale. This is part-prestige and part-strategy. It signals that India's largest bank, which claims to be among the top 10 in terms of market capitalisation, wishes to aim for global competitiveness.

If SBI (and a couple of large private banks) enter the top 10 globally, it will change perceptions about India's financial system, attract global investors, and make largeticket domestic financing easier. SEBI chief Tuhin Kanta Pandey emphasised that capital market reforms, deeper domestic savings deployment, and simplified capital raising are central to financial ambitions. Hence, the regulators and market architects are pushing for reforms to make markets faster, more inclusive, and more efficient. While Pandey's remarks stop short of a prediction that "without reforms we cannot reach \$30 trillion GDP," his message is that structural reforms and deeper capital markets are prerequisites to sustain large-scale targets.

Policymakers and ministers have outlined the longterm vision of a \$30-trillion economy by mid-century. Officials and analysts warn that meeting such targets requires complementary reforms across finance, infrastructure, taxation, and labour. According to some, "India's pathway to any very large nominal GDP target will be easier with deeper capital markets, larger banks, and operting reforms."

ating reforms."
India's banking sector is on an upward trajectory backed by tangible policy moves, and stronger macro metrics. But the shift from "good" to "transformational" depends on policy follow-through. Careful privatisation or consolidation need to preserve inclusion, continuing liquidity/capital reforms, and parallel capital-market deepening. SEBI and bank leadership are explicit that without them the scale-up will be harder. Policy action over the next 18–60 months will matter. The Government, according to media reports, has prepared immediate blueprints, and several decisions may be unleashed over the next few months, including in next year's Union Budget. The banks, investors, and customers are excited. So are the foreign investors, who have already queued up for action, which includes buying stakes in lucrative M&A deals on



Lenskart under the market lens

It is one of the most-viewed, and highly-crazed companies that will be listed this week on the exchanges after its IPO (Initial Public Offering). As expected, the listing gains were minimal, as Lenskart's stock opened on the National Stock Exchange (NSE) at a nearly two per cent discount, and closed a rupee above its offer price, or 0.25 per cent higher. During the day, after cofounder Peyush Bansal feverishly waited for the bell, the share price dived to below ₹363 on the NSE, or a drop of nearly ₹40, or 10 per cent, within two minutes. It recovered fast, ruled above the offer price for almost four hours, dipped down, and stayed afloat above the issue price.

Before the listing, in the grey market, the price was quoted at ₹390, or more than ₹10 below the offer price. Ambit Capital, a brokerage house, gave a 'Sell' rating, and estimated a target price of ₹337, which indicated a potential downside of 16 per cent. According to the brokerage, Lenskart's was a capital-intensive model, with "limited free cash flow generation, and modest return on capital employed (RoCE) of around nine per cent," which made its "lofty valuation hard to justify." The institutional investors were bullish. "The business is great. The runway is great. The lead over the rivals is very good," Kunal Shroff, managing partner. ChrysCapital.

told a website.

For weeks before the IPO, and during the period till the listing, there was a debate on Lenskart's valuation. Some analysts said that the company's worth, based on the offer price, was highly-stretched. Questions were asked about IPOs to SEBI officials, who wavered between allowing the market to decide the worth of new shares, and a view that valuations need to be fair and genuine. Other experts said that the eyewear company, which is now into smart Aldriven glasses, has a huge future potential, and the investors are paying for it. Despite the so-called high price, the issue was

oversubscribed by more than 28 times, with the institutional figure being 45 times.

Bansal, the co-founder, said that he had no idea about a listing bell when he launched the company with others, but he realised that his vision was 20/20 from the reaction of one of his early customers. "She was a teacher who gave up reading notebooks because of her eyesight, and started crying when she wore our glasses. It reminded me that our business is not about eyesight, but dignity, pride, and possibilities," he said at the listing event.

Lenskart, according to him, transforms how people see, and wows customers

Bansal's business became an obsession even as the founders discussed building Indian institutions on the lines of Microsoft, and provide vision at global standards. Bansal said that they dreamt about a time when everyone in a crowded cricket stadium would wear their glasses. They were rattled when mall owners repeatedly said that the ground floor space was meant for the foreign brands, and Indian ones could go lower, or higher. They were heckled for owning a 'chasma ka company.' Bansal had to convince his co-founder's prospective father-in-law that it was fine to marry his daughter to his partner. "Profit is oxygen, but purpose is breath for us. Every customer we serve is like an IPO, as the stock market rings the bell once, and customers ring it every day," he added.

every day," he added.
On the first day, the expert views, as we mentioned earlier, remained mixed. Shivani Nyati of Swastika Investmart maintained a 'Neutral' view, and cited "stretched valuations even though the company's business fundamentals remain solid." Another analyst, Siddharth Maurya of Vibhavangal Anukulakara felt

that with a "potential valuation of around ₹70,000 crore, Lenskart's omni-channel presence, and aggressive international expansion stand out as key differentiators." But he wanted the investors to do their due diligence, and look at the sustainability of margins. According to NSE data, on the first day, more than 131 million shares were traded, with a value of ₹522 million, and a market cap of ₹70,184 crore.

According to a media report, "The eyewear platform entered the market with a valuation of around ₹70,000 crore. Yet, just before its listing, its grey market premium slid from ₹108

at its peak to zero. The drop reflected a sharp pullback in appetite, suggesting investors were no longer willing to pay a premium even before the shares hit the exchange." Several factors can explain it. The val-

uation metrics put Lenskart higher than competitors like Titan, Trent, and Nykaa. Brokerages stated that while revenue growth is robust, margins have not kept pace. The market mood changed in terms of valuation despite the huge and mighty response to the IPO.

Several analysts drew some positivity from the price trend. One of them said that the investors expected miracles. The fact that the listing price, and closing price did not waver too much from the offer price indicates that the IPO pricing was almost-perfect. In such a scenario, even a great company can disappoint a little. Future share price will be determined less by sentiments, and listing expectations, and more by performance. If Lenskart can deliver on the promises, and show financial results, the price will go up. If not, it will be one of those momentary sparks, and go down the way of other IPOs, which were either issued at aggressive prices, showed awesome listing gains, and then fizzled out to quote at huge discounts.

This explains why a few analysts advise patience to the shareholders, and potential buyers. The ones who have the shares do not need to rush to sell. Ones who do not do not need to rush to buy. Existing investors can hold-and-wait for things to happen. The same is true for the buyers-in-waiting. The next few quarters, says an analyst, will prove to be the key to understanding what to do. The company, which has spread its looks in the Middle East and Asia, now seeks to zoom in on Europe. The international presence, and the growing share in India will help. Margins, though, will be a challenge.

According to another report, Lenskart is an oddity in the booming IPO space. Its weak debut can be contrasted with other high-profile ones that rewarded investors on listing days. LG Electronics, for instance, gained 50 per cent, which was one of the strongest debuts. Anthem Biosciences shot up by 27 per cent, and National Securities Depository opened 10 per cent above the issue price. The IPO market will continue to sizzle with several known companies hitting the market to raise massive sums. But Lenskart may provide a new valuation lens to decide a company's worth. Investors too will check their vision through new non-tinted glasses, hopefully.



Some of the farmers in North India are crossing state borders to 'illegally' sell their Kharif produce. Apart from better prices in terms of the government-decided MSPs (Minimum Support Prices), the growers are lured by reliable procurement, better policies, and efficient infrastructure across the borders. What this implies, and what evidence proves, is that the cultivators get as much as a third less than MSPs in their own states. Thus, at present, as the Kharif produce hits the market, both the trends are in play.

It is akin to a game of Chinese Checkers, as the farmers from Uttar Pradesh and Rajasthan allegedly enter the adjoining districts in Haryana and Punjab to market their produce. However, unlike the board game we mention, the on-ground "adversaries" in the states where the crop is sold do not intend to enter the "intruder-farmers" areas. All that the former wish to do is to "defend" their incomes. "When the Rajasthan farmers tried

to sell their crop in Punjab, the local authorities jailed them, and confiscated the produce," alleges Thakur Guni Prakash of the Bharatiya Kisan Union (Mann).

The main reason why the growers need to resort to such cross-state sales is because their state governments are absent, inactive, or lackadaisical, or they are forced to sell at muchlower-than-MSP prices

to the middlemen. Prakash is incensed that farmers take on other cultivators in this cross-border dispute. "What is disgraceful is that the so-called leaders of the farmer union in Punjab help the police to get their own people arrested," he claimed.

Let us look at how the official paddy procurement (and sales) proceeded from mid-September till now in North India. Due to efficiencies or inefficiencies, different states follow different procurement schedules. During the period under question, due to the early arrival of the paddy crop, Punjab rolled out the official Kharif procurement on September 16, and Haryana commenced the MSP operations on September 22. In both cases, the dates were earlier than Uttar Pradesh, which started MSP-based buying on October 1 in the western districts, and November 1 in the eastern ones.

Generally, the rice-marketing of the Kharif crop in North India starts in October, and dif-

ferent states follow schedules based on the cropping patterns, monsoons, and other factors unique to their respective states. Farmers in Punjab and Haryana, as in the other states, structure growing patterns around crops that are backed by MSPs. Although the Centre offers such prices for 22 crops, the subsidy-incentive-protection system principally favours wheat and rice, which are the major crops sold to government agencies.

While the government buyers in Punjab and Haryana were ready to take the crops at MSPs earlier, Uttar Pradesh lagged. The actual procurement in the latter state took a few more days in certain districts due to the bureaucratic processes involved. Thus, due to the early arrival of the paddy, the farmers in Uttar Pradesh faced two choices: Either cross the border into Punjab to

sell the crop, or dispose of it at below-MSP in their own state.

Reports from Lucknow indicate that some middlemen, and others, in Uttar Pradesh offered ₹1,600-1,800 per quintal, against the prescribed MSP of ₹2,369 (common paddy), or one-third lower. It was a no-brainer for the courageous and savvy growers among the sellers. They crossed the borders. Obviously, the Punjab farmers were peeved, and put up a stiff resistance against the 'outsiders,' who dared to intrude, and cut into their MSP pie. State gov-

ernments have seasonal targets, and stop the purchases once these levels are reached. It is a first-come, first-bought regime.

The problem is not from the neighbouring states only. Growers from the adjoining areas, and with means (money, transport, and logistics) to carry the crop to the "mandis" (agricultural markets) in the border states to sell as quickly as they can. But the middlemen too play this game. Retailers and wholesalers from far-off Bihar allegedly carry crops to Punjab and Haryana during the procurement seasons despite the protests from the administration and local peasants.

"The condition of the farmers in Bihar remains the worst in the country. Their average household incomes are half of the national average, and one-fourth of the states like Punjab," claims a recent state-

ment from the Samyukt Kisan Morcha (SKM). The Morcha was formed as an umbrella agency to represent several farm unions, and protest jointly against the aled three farm laws. In Ribar the

now-repealed three farm laws. In Bihar, the procurement is through the State Food and Civil Supplies Corporation, and there is no official mandi, which offers MSPs. Since most farmers cannot approach the Corporation's warehouses, or purchase points, this provides an opportunity for the middlemen to buy cheaper, and later sell expensively in

"In the last 10 years, only 25 per cent of the paddy produce was procured by the government. Wheat has averaged less than one per cent. Bihar farmers get 30 per cent less price than the MSP," alleges SKM. "The percentage of farmers who can avail MSP comes to less than 10 per cent of the total," says the organsation secretary of the RSS-affiliated Bharatiya Kisan Sangh (BKS), Dinesh Dattatraya Kulkarni. He points at the farmers' apathy, and asks, "Do the brother-farmers in Assam, Odisha, and West Bengal, get any-

thing?"
Bihar runs a State Crop Support Scheme, which supplements MSP, and provides additional financial security. However, limited infrastructure and logistical issues affect timely procurement, and not all the farmers are aware of it, or are able to access the stipulated digital registration systems. This game of Checkers is complex. The Centre cannot force the states on MSP since agriculture is a state subject under the Constitution, and the MSP implementation requires changes in the state-level laws and rules.

Since farm price control is in the concurrent list of the Constitution, the Centre can announce MSPs, and fund procurement through the agencies like the Food Corporation of India (FCI). But it cannot unilaterally enforce MSP compliance across states. This means the states have legislative and administrative control over agricultural markets, and procurement mechanisms. This explains why the farmers demand a central legal guarantee to ensure that no crop is sold below MSP, but this will require a new law that either overrides state laws, or mandates state compliance.

In addition, many states do not have the financial capacity, or political will to procure crops at MSP. A few oppose central mandates due to ideological and political differences, or concerns about market distortion and fiscal burden. The BKS contends that the issue is not about higher procurement, MSP, or the amount spent in purchases. The concern is about how many farmers access the benefit. While India protects the growers from foreign sellers, the former, especially the small and marginal ones, need to access a wider market.

India's leading Grandmasters Arjun Erigaisi, R Praggnanandhaa and P Harikrishna will look to continue their impressive run when the fourth round of the FIDE World Cup gets underway here after the first

Arjun, the country's highest-rated player, will start as the favourite against veteran Hungarian Peter Leko, while Praggnanandhaa faces the inventive Daniil Dubov, who is playing under the FIDE flag. Harikrishna, the most experienced of the trio, takes on Sweden's Nils Grandelius as he aims to stay firmly in contention.

Leko, a formidable force about 20 years back, is showing signs of his prime but may not find things easy against Arjun, who likes to go for extreme complexities.


The 46-year-old defeated Bobby Cheng of Australia and Kiriil Alekseenko of

Austria without any tiebreak games which speaks volumes about his quality of play. Incidentally, Leko is a semi-retired player and his protégé Vincent Keymer of Germany is also in the fourth round, making it a rare case of Guru and Shisya going deep in a knockout competition.

Arjun won both his matches without any tiebreak. The Indian has won three out of his four games thus far under the classical time control and has shown the exit door to Martin Petrov of Bulgaria and Shamsiddin Vokhidov of Uzbekistan in the process.

Crowd favourite R Praggnanadhaa, meanwhile, is set to meet Dubov, known for his work as a theoretician. The Russian is also a dangerous opponent in the faster time control. He came through two tiebreak marathons against Bai Jinshi of China and Georg Meier of Uruguay, excelling due to speed and accuracy.

Praggnanadhaa was close
